### FIR against cops, doctor for rape, abortion

Rourkela, June 24: A 13-year old girl was impregnated after being allegedly raped over a period of time by the head of Biramitrapur police station and other police officials, a report said.

The survivor was housed in the upper floor of the police station and coerced into physical relationship by the IIC. Later, the IIC hurriedly took the minor to the nearby public health centre and aborted her pregnancy with the help of a doctor.

Raiboga police registered a case against the accused police officials under various sections of IPC and POCSO Act after the district child protection officer (DCPO) lodged complaint against five persons including two police officials, a doctor, the step-father of teh girl and another person. The government doctor is absconding after reports surfaced. Sundargarh SP Saumva Mishra

visited the spot, Wednesday.

The issue dates back to March 25 when the girl had come to witness a fair at Biramitrapur which had been cancelled due to the lockdown. She failed to return back to her village and was roaming near the bus-stand when a police patrolling team noticed her and brought her to the police station.

The IIC took the girl to upper floor and raped her. The police officials dropped the girl at her home the next day. The girl was then regularly called to the police station and raped by the IIC and other police officials.

# India reinforces flashpoint region

Leh, June 24: Indian fighter jets roared over the flashpoint Himalayan region Wednesday as part of a show of strength following a violent clash between the two armies in Galwan valley in eastern Ladakh. Chinese forces have held onto a chunk of land covering several square kilometres (miles) at the mouth of the Galwan, Indian military sources said.

The two sides publicly declared they would pull back following the clash, which saw 20 Indian soldiers killed in a battle involving rocks and nail-studded batons.

But both have maintained troops around the valley, with India deploying more forces and trying to project military might. Indian jets regularly took off Wednesday from a military base in Leh and headed towards the mountainous border 240 kilometres (150 miles) away. There were also checkpoints on main roads and a frenzy of military activity around the main town, which lies at 3,500 metres (11,500 feet).

Residents reported long lines of military trucks and artillery on roads near Leh. "We now have a good strength present in the area," an official of the Indian Army's Northern Command said on condition of anonymity, referring to the reinforcements.

The Chinese army started its build up along the LAC in Eastern Ladakh sector on May 4 and deployed more than 10,000 troops along with heavy artillery, armoured regiments and defence batteries.

#### TALKS SIGNAL DE-ESCALATION

### Blue Wheel hosp shut after 27 staff infected

Bhubaneswar, June 24: Bhubaneswar Municipal Corporation (BMC) Wednesday sealed a private hospital here for violating COVID-19 guidelines that led to the transmission of the infection to 27 persons, an official said.

The cases were detected from Blue Wheel Hospital at Mancheswar in the city. Authorities of the hospital had admitted a coronavirus positive patient instead of shifting him to a dedicated COVID-19 facility. While 11 persons had been detected with COVID-19 in the facility in Mancheswar area Monday, 16 employees of the hospital tested positive Wednesday, the official said.

All the 16 employees had come in contact with the patient who had been admitted to the hospital, he said. The state government had earlier asked all hospi-

tals, both private and gov-

ernment, to shift COVID-19

patients to dedicated hospitals instead of treating them in their facilities. Despite the advisory, the hospital violated COVID-19 norms and admitted the coronavirus positive patient

New Delhi, June 24: The Centre has decided to bring urban and multi-state cooperative banks under the direct supervision of the Reserve Bank of India to protect depositors in these financial institutions. The Union Cabinet, in a meeting held Wednesday, decided to initiate the move via the Ordinance route.

The move will bring 1,482 urban and 58 multi-state cooperative banks under the supervisory powers of the RBI. In terms of regulatory power, the central bank had limited control over these institutions, thereby, increasing the risk

### Space assets open for all

New Delhi, June 24: The Cabinet Wednesday approved participation of the private sector in the entire range of space activities, including planetary exploration missions, Union minis-

ter Jitendra Singh said. The newly-created Indian National Space Promotion and Authorisation Centre (IN-SPACe) will provide a level playing field for private companies to use Indian space infrastructure, Singh, who is the Minister of State in the Prime Minister's Office, said.

This centre will also hand-hold, promote and guide the private industries in space activities through encouraging policies and a friendly regula-

tory environment, Singh added. The New Space India Limited (NSIL), a PSU under the Department of Space, will endeavour to re-orient space activities from a 'supply driven' model to a 'demand driven' model, thereby ensuring optimum utilisation of our space assets, the minister said. The Cabinet decisions come weeks after Finance Minister Nirmala Sitharaman announced opening up of the space sector for private entities.

Some of the planetary exploration missions will also be opened up to private sector through an 'announcement of opportunity' mechanism, a government statement said.

'This will not only result in an accelerated growth of this sector but will enable Indian Industry to be an important player in global space economy. With this, there is an opportunity for large-scale employment in the technology sector and India becoming a global technology powerhouse," it said. The proposed reforms will enhance the socio-economic use of space assets and activities, including through improved access to space assets, data and facilities.

These reforms will allow ISRO to focus more on research and development activities, new technologies, exploration missions and human spaceflight programme, Singh said.

Space applications have, in fact, entered every household of the country. However, the PM felt that these initiatives are not enough. Therefore, the decision has been taken to open the space sector for all," Singh said.







Bhubaneswar, June 24: Scores of skilled and semi skilled workers from Ganiam district are contemplating to migrate to other states in search of better livelihood options after the Covid-19 situation im-

Since May 3 this year, the district has been witnessing return of more than 2 lakh migrant workers. A large number of them are skilled workers who were working in the textile industries of Gujarat and Maharashtra.

All those who had registered with the government and successfully completed their quarantine in institutional centres in rural areas will be paid their dues, but not others.




The website will have number of inmates, both convict and undertrials, in all the 90 jails of the state

### BJP moves OHRC for justice to Malkangiri 'rape' victim

Bhubaneswar, June 24: The general Secretary of the state unit of BJP, Lekhashree Samantasinghar, and other party leaders Wednesday met Odisha Human Right Commission (OHRC) chairman seeking justice for a tribal woman who died after she was allegedly raped in Malkangiri district.

Samantasinghar alleged that the gruesome incident had taken place in Malkangiri district headquarters police canteen. The tribal woman was raped May 7 this year. The woman subsequently succumbed to her injuries.

As per the complaint, the tribal  $\,$ woman was working as a help in the police canteen. A lady police officer reportedly informed the woman's husband that the victim was taken ill and admitted to the Malkangiri district headquarters hospital (DHH) May 7. The woman's husband rushed to the DHH and found her in an unconscious state. The victim's husband also found several injuries on her body and suspected it to be a case of rape.

The victim was later shifted to Sahid Laxman Nayak Medical College and Hospital at Koraput. However, her condition didn't improve and she died while being taken to MKCG Medical College and Hospital in Berhampur May 11.

The victim's husband lodged an FIR with police in Malkangiri May 9 and alleged that the woman had been raped. He sought a proper inquiry into the incident. But, police didn't take any step. Soon after the woman's death, po-

lice hurriedly formed a special team to probe the incident. Malkangiri Superintendent of Police told the media that the woman was undergoing treatment for various ailments and the allegation of rape would be investigated, said the complaint.

The victim's husband alleged that his thumb impressions were taken on plain papers by the police and his mobile phone was also taken away by the cops. Besides, he was forced to cremate his wife's body on the day of her death. Till now, the victim's husband has not been given the postmortem report, it is alleged.

Notably, the OHRC directed the Malkangiri SP May 12 to conduct an inquiry into the incident and submit a report.


Abdur walked out of prison amid tight security. He was taken to Paschimakachha village in Jagatpur with large posse of policemen accompanying him.

It was later learnt that Abdur had provided shelter in Cuttack to a Pakistani terrorist involved in the Kandahar plane hijack case. The terrorist belonged to Pakistanbased Harkat-ul-Mujadhideen (HeM) that was involved in the hijacking of the Delhi-bound Indian Airlines Flight IC 184 from Kathamandu. Abdur was working at a

Madrassa in Tangi, where he was teaching students. Most of the students were from Jharkhand.



# 282 fresh cases take Covid tally to 5,752

Bhubaneswar, June 24: Covid-19 cases continued to rise in various districts of Odisha as 282 fresh cases were reported across the state Wednesday, with Ganjam becoming the first district to report over 1.000 cases

With this, the total number of coronavirus cases in the state has reached 5,752. While 4,123 patients have recuperated from the disease, 17 persons have lost their lives due to the disease so far, according to the data released by the Information and Public Relations (I&PR) department. Out of the total 282 fresh cases reported from across 17 districts of Odisha, 256 were detected from quarantine centres while the remaining 26 are local cases.

Gajapati continues to report severe spike in Covid-19 cases with 76 new cases, the highest in the state Wednesday followed by Ganjam with 75 cases, said the I&PR de-



### 25% quota sought in pvt schools

Bhubaneswar, June 24: The Odisha Abhibhabak Mahasangha (OAM), Wednesday, wrote to Chief Minister Naveen Patnaik seeking 25 per cent reservation for students belonging to poor and disadvantaged sections in private English medium schools, as per the Right to Education (RTE) Act.

Basudev Bhatt, chairman of OAM, said, "The School and Mass Education department has issued an order, bearing Letter No 8059. dated 05.06.2020, regarding admission of elementary and secondary students for session 2020-21 from 15th July 2020 in all government, aided and unaided schools in Odisha. This order is only meant for govt/aided and unaided recognised schools, Madrasas and Sanskrit Toles etc under the department during the lockdown period."

vious order and issued another order with SOPs for admission of students in elementary and secondary students only affiliated to BSE and CHSE boards. It was a welcome step to not call parents and students to schools during lockdown," Bhatt added

The CBSE, ICSE and other affiliated English medium schools should comply with the Act.

The department should issue a specific order as per RTE Act and ensure the admission of students belonging to Economically Weaker Section (EWS) and Disadvantaged Groups (DG) in private English medium Schools. These schools should allow reservation of 25 per cent seats for these students under RTE Act, he added.

"Now we request your special in-

tervention and instructions to the department to come up with an order without students and parents in all private English medium schools and issue an SOP. Further. the private schools should not collect fees arbitrarily and unnecessarily in the name of admission and readmission. We believe your kind intervention will solve this problem and we will get justice from you. In the present circumstances, we request your kind intervention and immediate order to stop this violation by private English medium schools in Odisha in the name of admission and readmission. We also request your kind order to implement RTE Act failing which the OAM will go for an agitation from July 1," Bhatt stated.

### Animals for forests

istrict forest officers and rangers are not trained in ecology. Ecology means the interrelationship of all things – what happens to the whole when one part is affected. They don't know about plants or animals. In fact, this entire service should be disbanded because all they do is an illiterate kind of policing. And for the most part they don't do that either. Many of them are the fences that eat the grass: they use their positions to cut trees illegally and many are involved with animal killing mafias

All the bureaucrats of the forest department are generalists: one day they are secretaries of steel and another they head the forest and wildlife department. The chief wildlife wardens come by attrition to their jobs. One of them has just suggested that we take all the tigers out of the forest and put them into zoos. Another had all the wild boar in Chandrapur shot and then took out killing warrants against the hungry tigers. Yet another has recommended that all the fallen trees of the forest be removed manually. All of them agree that the forest floor should be burnt annually "to prevent fur-

The ones in Kerala and Tamil Nadu see nothing wrong in a Schedule One animal like the elephant being beaten to death by the temples. The teachers in the so-called forest and wildlife institutes are chosen from these wor-

thies and so they teach what they know -nothing. The number of animals killed by this service would probably be equal to the damage that poachers do. Unfortunately, since most of the forest ministers are joyously self-proclaimed illiterates in this field, they bring nothing to the table except more misery - simply rubber stamping the diversion of huge tracts of forest for unnecessary and outdated technologies like dams.

I am yet to meet a minister who even understands what an elephant corridor is. In fact, the "most loyal" politician is usually made the forest minister - because he puts up no resistance to any "development" project, like a cement factory or a five star hotel, in the heart of the forest. To all of them, a natural forest can easily be replaced by mono cultural plantation, and the animals in the forest can be replaced by a zoo.

The day the rain controls us – in either its fury, as in Kolkata, or in stopping totally, is the day we will realize that we needed a specialist service. But by then it will be too late. The favourite targets of these politicians, bureaucrats and forest service "time-passers" are wild boar, nilgai and rhesus monkeys. So, let me tell you what will happen if you

The single most important animal to the forest is the wild boar. He is a major seed and fungi spreader and, through his constant rooting, he increases the forest and provides biodiversity. He reduces insect

pests and carrion. He is the only species that eats the large fern, called bracken, which otherwise would not allow seeds to come up. All the studies on the impact of wild boar on the ecosystem (soil, water, plants, fungi and fauna) show that the species has very high ecological importance and they significantly contribute to the characteristics, as well as development, of terrestrial and aquatic ecosystems. He is a major food source for large carnivores. All these benefits are overlooked, and the wild boar is treated as a pest species for no reason except that farmers want to kill and eat wild pork. When all the wild boars have been hunted down, the forest and all the large cats in it will disappear. It is time for someone sensible in the forest hierarchy to objectively evaluate the importance of this animal.

Nilgai is the largest Asian antelope, found all the way from the Himalayas  $\,$ to the state of Karnataka in the south. Nilgai eats grass, leaves, flowers and fruits, surviving long periods without water. They are mixed feeders, even eating the woody plants in the dry tropical forests of India. The nilgai can tolerate interference by livestock and degradation of vegetation in its habitat, better than deer possibly because they can reach high branches and do not depend on surface vegetation.

When a species becomes threatened or extinct, this removes a check and balance in the food chain. If Nilgais are removed, the area of grassland, on which they graze, will increase hugely. A 1994 study drew attention to the ecological value provided by the Nilgai in ravines lining the Yamuna River. In summer, the faeces of the antelope contain nearly 1.6 percent nitrogen, enhancing the quality of the soil to a depth of 30 centimetres. Seeds in their droppings germinate easily and assist in afforestation.

States like Himachal Pradesh are extremely brutal in their treatment of monkeys and have, in fact, killed thousands in the last ten years. Monkeys are prey, predator, and mutualist species in food webs, and influence ecosystem structure, function, and resilience. Their evolution, feeding ecology, and geographic distribution are closely linked to the diversification of flowering plants, herbaceous plants, shrubs, grasses, and most trees, a principal source of food for many animals and humans.

Monkeys are highly frugivorous, and their relatively large size enables them to disperse small and large seeds over long distances, enhancing forest regeneration. In the absence of their seed dispersal, plant populations and their genetic heterozygosity will decrease. For example, Madagascar lemur's gradual extinction is causing certain Malagasy tree species to disappear. The population collapse in the heavily hunted forests of Amazonia has severely degraded forest dynamics and the sustainability of many hardwood tree species. with implications for their carbon-storing potential.

In a study published in February in the journal Oryx, researchers found that many tree and plant species in the Congo rely exclusively on monkeys for seed dispersal. In the LuiKotale forest, where the study was conducted, 18 plant species were completely unable to reproduce if their seeds did not first travel through a monkey's guts. According to the paper, if the monkey

disappeared, the plants would also likely go extinct. The research, by biologist David Beaune of the Max Planck Institute for Evolutionary Anthropology, found that monkeys eat for about 3.5 hours every day and travel a mean of 1.2 kilometres from meal sites before defecating and depositing the seeds that have passed through their systems. The monkey has two major functions here. First of all, many seeds will not germinate well unless they have been "handled" (as scientists call it) by another species. Stomach acids and intestinal processes weaken a seed's tough external coating, making it more able to absorb water and

Secondly, many seeds won't succeed if they remain too close to their parental trees. Beaune found that the seeds that fell to the ground near their parents either did not germinate, or the seedlings did not survive. According to Beaune, no other species in LuiKotale have travel patterns sufficient to serve the same dispersal service as monkeys.

Unfortunately, monkeys face a constant threat of poaching and official killing. If monkeys disappear from any of its habitats, this will create a cascading extinction cycle. Not only will the trees disappear, but so will many of the other species that rely on the trees for food or shelter. It's a condition known as "empty forest syndrome"—the forest itself may still exist, but its biodiversity levels will crash, leaving it a pale shadow of its former self. There are so many forests like that in India - Brindavan, for example, in which the monkeys have disappeared and so has all other life.

### **HIT WHERE IT HURTS**

hile the jury is still undecided on China's role in spreading the COVID-19 epidemic, there can hardly be any doubt that the Chinese Communist Party (CCP) has used this health crisis as a smokescreen to challenge and remake the international world order with it as the most dominant power. This would include redrawing the existing world map in their favour.

By stepping up its oppression of Hong Kong, CCP has practically gone back on its agreement with the United Kingdom and the assurances they gave to the world. China stepped up its actions near the Senkaku Islands, violated Taiwanese airspace and claimed territory from 23 countries when it has land borders with only 14. The total area being claimed by China in the South China Sea is more than the land area of China itself. Then there is the intrusion in Galwan.

Ever since his elevation as General Secretary of the CCP and Chairman of the CPC Central Military Commission (CMC) in 2012, Xi Jinping is no doubt the most powerful leader since Mao Zedong who last held absolute power and has surrounded himself with those from Fujian, Shanghai and Zhejiang provinces.

It would be naïve to think that these actions by the PLA are taken by the local commanders. The PLA is comprehensively top-driven where the field and unit commanders hardly have any discretionary power. With so much at stake, CCP can hardly afford to leave it to local commanders with a chance to blunder in what is plainly a hazardous policy terrain.

While exploiting the disjunctions in a COVID-19 ravaged world to advance its geopolitical goals, the CCP does not want a situation where the world allies together to contain its hegemonic tendencies. The building of infrastructure at a rather fast pace along its borders with China after years of neglect by India as well as joining the Quadrilateral Security Dialogue (QUAD) has certainly rattled China.

Nonetheless, President Xi believes that China can take India down a notch or two in the subcontinent and show it up as a political lightweight to its smaller neighbours and would tie down India, thus making it unable to provide any meaningful support when things heat up in the South China Sea.

The other aspect is the fallout of the COVID pandemic which has resulted in a halt to the world economy - the Great Lockdown which has had a major adverse effect on Chinese production factories. The workers for these units come from the hinterland and do not enjoy adequate protection under labour laws. The present pandemic has resulted in many factories closing, which resulted in large scale redundancies. Unconfirmed reports indicate that this has given rise to frustration and discontent among the rural population within China.

The CCP as well as all authoritarian regimes are mortally scared of any situation where they are not able to control the narrative. So how do they control the narrative? One needs to look at George Orwell's (a disillusioned Communist) books, Animal Farm and 1984. 1984 describes a dystopia where the state follows a brutal policy of draconian control by propaganda, surveillance,

disinformation, denial of truth (double think), and manipulation of the past. It also states that power is into tearing down the human mind to pieces and putting them together in new shapes of your choosing.

Therefore, we need to reset our China policy to deal with both situations in an assertive but not aggressive manner with long and medium term prospectives. The first being China's desire to be the most dominant power in the post-COVID world order. The second being China's need to control the masses by diverting attention from its domestic challenges to raising the bogey of external threat.

In politics, there are no permanent friends or permanent enemies, only permanent interests where every country promotes its own interests. While doing so, one should bear in mind that while the earlier strategies may have served us satisfactorily, we should not be held hostage to them.

Ever since the 1972 meeting between Mao Zedong and Richard Nixon, the world has accepted a One-China policy. This is the Achilles Heel for China. It would be appropriate for India to openly court a more cooperative diplomatic relationship with Taiwan for mutual benefits. It is plausible that Taiwan could symbolically

accept the official Indian

In consonance to our Look East Policy, our diplomats need to aggressively court all the countries in the South China Sea rim to safeguard each other's economic and territorial interests

In cooperation with other QUAD members, expand its membership to include countries whose territory is being claimed by China and hold joint naval exercises and form our own Garland of Coalition. Increase patrolling in the Indian Ocean region to not only be a deterrent to Chinese navy but also increase surveillance on China's energy requirements which passes through the Malacca Straits.

India needs to augment its assets on the ground for collection of intelligence. This has taken a backseat ever since the Guiral Doctrine In this context, we should include Tibet and Xinjiang – area which we have neglected over years.

Another issue that has been plaguing India is that it is considered a soft negotiator -- willing to bend backwards to conclude agreements without assertive negotiations – perhaps a result of a lack of long-term strategy as well as political need for short-term headline results. This always gives the other party an upper hand. Time and again, India has been saddled with agreements and treaties that are a millstone around its neck. It is time that India showed some spine and stood up for its interests rather than be temporarily be appreciated as the good boy.

Without undermining the present efforts to defuse the present standoff in Eastern Ladakh and the prospects of an evolving new world order post COVID-19, it is imperative that India needs to reset its long-term and medium-term strategies and find its rightful place in the new world order. Together with other Asian countries we can usher in the Asian Century. Let's do it.

Whether in the case of to have an overestimation of our ence experiment, a sample of randomly selected people is asked whether they understand how a bicycle worked. An overwhelming majority would say they do! Yet, on asking to draw a rough sketch of the bicycle, most would get it wrong! This phenomenon applies equally well to most subjects and most groups of people irrespective of their background.

The well-known theory in social psychology, known as the Dunning-Kruger effect, was first introduced in 1999. It relates to the human tendency to over-estimate one's own knowledge and competence. A cognitive bias, this is generally corrected as we learn more about the subject. This theory was further generalised into what was later termed as the Illusion of Explanatory Depth or IoED by psychologists Leonid Rozenblit and Frank Keil in 2002.

As per this theory, most people feel they understand the world with far greater detail, coherence, and depth than they really do. This goes a long way in explaining the predicament we face with the avalanche of information we encounter all the time, which makes us feel we know a lot. Such a cognitive bias leads to

and rancorous debates online on most subjects. The sooner we realize the truth about the shallowness of our knowledge, the better. This would help us better appreciate the opinion of others. One of the major challenges

today is of holding a civilized discussion on any topicparticularly on social media -- without it degenerating into partisan bickerings. Lies and half-truths are traded. The world is more divided than ever before with leaders taking advantage of social divisions for partisan and populist political interests. Such tendencies are visible most prominently on social media platforms like Twitter and FB. The avalanche of fake information mostly in the guise of legitimate news is worrisome. Such misinformation can range from innocent pranks to deliberate campaigns that are politically motivated.

The emergence of the paid trolls armies and bot factories has made it easy for political parties and others to control the narrative however incredible it might be. Unfortunately, the impact of these trends is no longer limited to online conversations only but frequently spilling over to real-life with deadly conrecent communal riots in Delhi or the ongoing COVID-19 pandemic, the threat of fake news and misinformation campaigns has proven to be lethal. Notably, even national elections as important as the presidential in the US have been manipulated by third party actors with vested interest

Traditional sources of authentic information have come under deadly fire as they are the biggest threat to those who stand to benefit from the spread of fake news. Ironically, powerful leaders take the lead in destroying the reputation of the mainstream media by questioning their credibility. A recent report suggested that more than 50 journalists have been booked by Indian police on one pretext or the other since the COVID-19 outbreak.

Allowing the system to prosecute important voices that stand up for human rights, for the environment. for probity in public life has had a chilling effect on civil society. Numerous non-profit NGOs have been harassed in the name of national interest. The war between truth and falsehood seems to be raging and the outcome will have a decisive impact on our future as a society.

ability to understand issues and thereby underestimate voices of sanity and reason, goaded by populist leaders, is turning out to be a deadly cocktail! Understanding this conundrum and explaining complex ideas in simple terms without loss of its essence will be a crucial skill in the future in order for the wise to be heard over the cacophony of ongoing discourse. One of the redeeming features of a genuine expert or an intellectual with a certain depth of expertise in any field is his humility. As the Sanskrit saying goes - 'Namranti Falina Vrikhsya', which means 'trees full of fruits tend to bend down'.

Bangalore, June 24: Allaying fears and defying calls to defer them, Karnataka is all set to conduct the Covid-hit rescheduled Secondary School Leaving Certificate (SSLC) board exams for Class 10 students across the southern state from Thursday, an official said Wednesday.

"Elaborate arrangements have been made to hold the SSLC exams from Thursday to July 4 for 8.5 lakh students in 3,179 centres across the state as per the lockdown guidelines to ensure the safety and welfare of the wards," Karnataka Secondary Education Examination Board Director V. Sumangala told IANS here.

Of the 8.5 lakh students registered to appear for the exams, 4,48,560 are boys and 3,99,642 are girls.

Of the total centres, 2,879 are main and 300 in block, set up to accommodate students spilling over from other centres to ensure social distancing.

Though the 3-hour exam will commence daily at 10.30 a.m., the students have been told to report at their respective centres by 9 a.m. or 90 minutes earlier for thermal screening, wearing mask and washing hands with sanitizer before entering the centre, said Sumangala. A whopping 86,000 people, in-

cluding 63,000 state-run school teachers and 23,000 from other departments like health, police and social welfare will be on duty for the smooth conduct of the exams in 6 subjects, including English. Kannada, third language, natural science, social science and mathematics.

About 200-250 students will sit for the exam at each centre, with about 200 in the centres located in the containment centres, said Sumangala.

Each exam centre has also been equipped with sanitizer dispensers to wash hands before and after the

Students who shifted to their home town during the prolonged lockdown have been allowed to write exams from the nearest centre, where they are staying.

### **Asymptomatic patients'** discharge rules relaxed

In Karnataka, asymptomatic patients can be released in case of no fever, saturation above 95 pc and respiratory rate less than 24 per min

Bangalore, June 24: The Karnataka Health Department has revised rules on the discharge of Covid-19 patients, mandating that asymptomatic patients can be released in case of no fever, saturation above 95 per cent and respiratory rate less than 24 per minute, said an official Wednesday.


"Asymptomatic individuals with corona positive report, who continue to remain asymptomatic during hospital stay, shall be discharged 10 days after the positive test," said Additional Chief Secretary Jawaid Similarly, there is no require-

ment for an RT-PCR, CBNAAT or True-NAT test for an asymptomatic case before discharge but will be advised home-quarantine and selfmonitoring for a fortnight.

In case of mild and moderate cases, the patient should not exhibit any symptoms such as fever for three days before discharge, without using antipyretics.

They should also maintain uration above 95 per cent for four consecutive days before discharge without oxygen support. Breathlessness, clinical signs and symptoms should also be resolved.

"Repeat inflammatory markers (S. Ferritin, S. LDH, D-Dimer and CRP) at the time of discharge. These should be in normal range and decreasing trend," said Akhtar.

Thiruvananthapuram, June 24: Kerala Chief Minister Pinarayi Vijayan Wednesday said the state recorded 152 coronavirus positive cases in the last 24 hours, which is highest ever on a single day so far.

"Of this, 98 people came from abroad, 46 were those who came from within the country and there were eight local infections. At present there are 1,691 positive patients, while in all 3,603 got this disease," said Vijayan.

Vijayan said starting Thursday all those arriving from the Middle East have to follow new guidelines and if anyone has a Covid negative certificate it should not be beyond 72 hours of departure.

"Those arriving from Kuwait and Saudi Arabia have to wear PPE kit besides N95 mask, face shield and gloves. Those coming from UAE have to carry the certificate (facility is available for testing there) while those from Qatar should have green status on the App which is valid in their country. Those from Bahrain and Oman should





The statement assumes significance as China has been in occupation of the autonomous region of Tibet, an area of around 2.5 million sq km, since 1951 and the Tibetan government has been in exile in India. New Delhi refers its border with Tibet in Arunachal Pradesh as the LAC.

China disputes India's sovereignty over Arunachal Pradesh, which has an area of around 84,000 sq km and population of around 1.5 million. India's boundaries were defined by the British before Independence. But China occupied Aksai Chin in Jammu & Kashmir and raised dispute over the boundary of Arunachal Pradesh in the 1962 war with India.

Around 1,00,000 Tibetans (73 per cent of all Tibetans), including the Dalai Lama, their spiritual leader. are in exile in India.

But in the last few years, the central government seemed to be distancing itself from the community. In 2018, the government prohibited its officials and leaders from attending the events to mark the 60th anniversary of Tibetan exile. The prohibition came on the eve

### 'Custodial death' sparks outrage in TN

personnel in the station. Meanwhile, Palaniswami detailed the chain of events leading to the deaths, and said the duo were picked up on June 19 after a case was filed against them for not heeding police'

direction to close their cellphone shop as it was functioning beyond stipulated hours.

They were later arrested and lodged in the Kovilpatti sub-jail. June 22, Fennix complained of breathlessness and

was admitted to a local gov ernment hospital where he died around 9 pm after failing to respond to treatment, the Chief Minister said in a statement. The next morning, Fennix's father Jayaraj was admitted to the hospital after he complained of illness, but died, he added. Subsequently, a case was filed in this connection. When the relatives of the deceased moved the Madurai bench of the Madras High Court, it ordered video recording of the post-mortem. even as it took up the case on its own today.

### Ramdev in soup over Covid medicine claim

Wednesday. AYUSH Minister Shripad Naik Shripad Naik said Patanjali coming with the medicine was a "good initiative" but due process has to be followed. Hours after the launch of "Coronil" on Tuesday, the Union AYUSH Ministry had asked the

firm to provide details on the research and the product's composition, telling it to stop advertising it till the issue is examined.

Naik said Patanjali Ayurved has submitted the documents. "The reports which were sent to the ministry on Tuesday will be examined,' he said. "At a time when everybody is grappling for a cure for COVID-19 such an initiative is definitely good but then the due process has

to be followed," the minister said. Apart from the notice from the Uttarakhand government, the Haridwar-based herbal products firm could also face litigation in Bihar. A complaint has been filed against it in a Muzaffarpur court



over its claim.

Uttarakhand's Ayurved department's licence officer Y S Rawat said the notice is being issued to the firm to explain from where it got the permission to launch a "corona kit" as a cure for the virus.

"Patanjali Ayurved Ltd had the licence only for manufacturing an immunity booster against cough and fever. There was nothing in their application related to the treatment of coronavirus," the official

"We did receive an application from Patanjali on June 10. The application was approved after examination by a panel on June 12 but the firm had the permission to manufacture only two or three drugs as immunity boosters against cough and fever, and not a drug for coronavirus," he added.

He said the notice will be sent to the firm under Rule 170 of the Drugs and Cosmetics Act, 1940, which

makes it mandatory for companies to seek permission from the licensing authority before advertising a product in print or the electronic media

In Muzaffarpur, a complainant has approached the court seeking the registration of an FIR against Ramdev and company chairman Acharya Balkrishna, alleging that they put at risk the lives of lakhs of people by claiming to have developed a COVID-19 cure.

Chief Judicial Magistrate Mukesh Kumar posted the matter for hearing on June 30. At the "Coronil" launch, the company had claimed that its medicine can cure the con-

tagious disease within seven days.

## **US slams Pak for not acting** against anti-India terrorists

Washington, June 24: Pakistan took "modest steps" in 2019 to counter terror financing and restrain India-focused militant groups from conducting large-scale attacks following the Pulwama attack in February, but it remained a "safe harbor" for regionally focused terrorist groups, the US said Wednesday.

The suspension of US aid to Pakistan, which was announced by President Donald Trump in January 2018, remained in effect throughout 2019, the State Department said. "Pakistan took modest steps in 2019 to counter terror financing and restrain India-focused militant groups from conducting large-scale attacks following the February attack on a security convoy in the Indian state of Jammu and Kashmir linked to Pakistanbased Jaish-e-Mohammed (JeM),"

In its Congressional-mandated annual report 2019 Country Reports on Terrorism, the State Department said Pakistan took action against some externally focused groups, including indicting Lashkar e-Taiba (LeT) founder Hafiz Saeed and associates in three separate terrorism financing cases. "However, Pakistan remained a safe harbor for other regionally focused terrorist groups," the State Department said.

It allowed groups targeting Afghanistan, including the Afghan Taliban and affiliated Haqqani

### Strong quake rattles Mexico

Mexico City, June 24: A powerful earthquake measuring 7.5 on the Richter scale hit the southern Mexican state of Oaxaca, killing four people and injuring four others, the National Civil Protection Coordination (CNPC) said Wednesday.

A tsunami warning was sounded on the Oaxaca coast. The country's seismological service recommended that residents move away from the coastline.

The epicentre of the quake, which hit at 10.29 a.m. here on Tuesday, was located 23 km south of La Crucecita, a Pacific Coast village in southern Oaxaca state, the National Seismological Service (SSN) said via Twitter.

Two men and a woman were among the dead in separate incidents as a result of damage to roofs and walls. The fourth victim was a male employee of the state oil company Pemex, who fell from a structure during the quake and died from his injuries in the hospital, Xinhua news agency reported.

The strong quake was felt in 12 south and central states, and by 2.30 p.m. over 447 aftershocks had been reported. Some structures, including houses, markets, schools, churches and four hospitals at different locations, sustained damage, according to the CNPC. In Mexico City, 32 buildings in the downtown area, near the National Palace, sustained damage to their facades, but only one already condemned building had structural damage, the CNPC said.

### NK suspends military action plans against SK



Seoul, June 24: North Korea is suspending military action plans against South Korea, the official KCNA news agency reported Wednesday, as a report from Seoul suggested North Korean troops were taking down loudspeakers reinstalled at the fortified border.

Political tensions between the rival Koreas had been rising over Pyongyang's objections to plans by defector-led groups in the South to send propaganda leaflets into the North. Stalled negotiations regarding economic sanctions imposed because of the North's nuclear weapons programme had also fuelled tensions.

It was not immediately clear why North Korea had softened its position, which came after it blew up a liaison office last week and cut off communication hotlines with the South. North Korean leader Kim Jong Un presided over a video conference meeting of the ruling

party's Central Military Commission Tuesday, where members "took stock of the prevailing situation" before deciding to suspend the military plans, KCNA said, without elaborating.

The committee also discussed documents outlining measures for "further bolstering the war deterrent of the country," KCNA reported. Late Wednesday, KCNA issued another statement by Kim Yong Chol, a senior Pyongyang official, criticising the South Korean defence minister's remarks to parliament that the North's actions must be withdrawn, not suspended.

Kim called the comment "foolish and inappropriate", warning Seoul should "think and behave wisely" not create a greater crisis.

South Korea's Yonhap news agency, citing unnamed military sources, said North Korea's military was seen removing about 10 loudspeakers near the demilitarised zone (DMZ) Wednesday, just days after they were seen reinstalling around 20 of the devices

#### First COVID-19 vaccine trial in SA

Johannesburg: Africa's first participation in a COVID-19 vaccine trial started Wednesday as volunteers received injections developed at the University of Oxford in Britain, while officials said the continent of 1.3 billion people cannot be left behind. The large-scale trial is being conducted in South Africa, Britain and Brazil. South Africa has nearly one-third of Africa's confirmed cases with more than 106,000, including more than 2,100 deaths. ### The Arctic is on fire

Russia's Arctic regions are among the fastest warming areas in the world

Moscow, June 24: The Arctic is feverish and on fire — at least parts of it are. And that's got scientists worried about what it means for the rest of the world.


The thermometer hit a likely

record of 38 degrees Celsius (100.4 degrees Fahrenheit) in the Russian Arctic town of Verkhovansk on Saturday a temperature that would be a fever for a person — but this is Siberia, known for being frozen. The Meteorological Organization said Tuesday that it's looking to verify the temperature reading, which would be unprecedented for the region

north of the Arctic Circle. "The Arctic is figuratively and literally on fire — it's warming much faster than we thought it would in response to rising levels of carbon dioxide and other greenhouse gases in the atmosphere, and this warming is leading to a rapid meltdown and increase in wildfires," University of Michigan environmental school dean Jonathan Overpeck, a climate scientist, said in an email. "The record warming in Siberia is a warning sign of major proportions," Overpeck wrote. Much of Siberia had high tem-

peratures this year that were bevond unseasonably warm. From January through May, the average temperature in north-central Siberia has been about 8 degrees Celsius (14 degrees Fahrenheit) above average, according to the climate science non-profit Berkeley Earth. "That's much, much warmer than it's ever been over that region in that period of time," Berkeley Earth climate scientist Zeke Hausfather said.

Siberia is in the Guinness Book of World Records for its extreme temperatures. It's a place where the thermometer has swung 106 degrees Celsius (190 de grees Fahrenheit), from a low of minus 68 degrees Celsius (minus 90 Fahrenheit) to now 38 degrees Celsius (100.4 Fahrenheit). For residents of the Sakha Republic in the Russian Arctic, a heat wave is not necessarily a bad thing. Vasilisa Ivanova spent every day this week with her family swimming and sunbathing.

London, June 24: A second coronavirus wave is a real risk for the United Kingdom and local flareups are likely, major health bodies said Wednesday, in one of the strongest warnings yet to Prime Minister Boris Johnson as he eases

### **PIA AIRCRAFT CRASH** Pilots were 'overconfident'

Islamabad, June 24: The pilots of the Pakistan International Airlines (PIA) plane that crashed last month were not focussed and they were discussing coronavirus during the flight, the country's aviation minister told Parliament on Wednesday as he pointed out their "overconfidence and lack of concentration" as some of the reasons for the tragedy that killed 97 people on board.

The domestic flight from Lahore to Karachi crashed in a residential area near the Jinnah International Airport in Karachi

The Airbus A320 aircraft of the national carrier had 91 passengers and a crew of eight when it crashed into the Jinnah Garden area near Model Colony in Malir on Friday minutes before its landing. One girl died on the ground after suffering burn injuries.

Two passengers miraculously survived the crash.

Federal Minister for Aviation Ghulam Sarwar Khan presented the interim investigation report on the PIA plane crash in the National Assembly, saying that the pilots were not focused and their lack of concentration had caused the crash. Human error by the pilots and air traffic control caused the crash of the Pakistan International Airlines (PIA) plane, he said.



Washington, June 24: The IMF Wednesday projected a sharp contraction of 4.5% for the Indian economy in 2020, a "historic low," citing the unprecedented coronavirus pandemic that has nearly stalled all economic activities, but said the country is expected to bounce back in 2021 with a robust 6%

The International Monetary Fund (IMF) projected the global growth at -4.9% in 2020, 1.9 percentage points below the April 2020 World Economic Outlook (WEO) forecast.


"We are projecting a sharp contraction in 2020 of -4.5%. Given the unprecedented nature of this crisis, as is the case for almost all countries. this projected contraction is a historic low," Indian-American Gita Gopinath, IMF's Chief Economist, told PTI as she released the World Economic Outlook Update here.

The COVID-19 pandemic has had a more negative impact on activity in the first half of 2020 than anticipated, and the recovery is projected to be more gradual than previously forecast. In 2021, global growth is projected at 5.4%, the re-

For the first time, all regions are projected to experience negative growth in 2020. In China, where the recovery from the sharp contraction in the first quarter is underway, growth is projected at 1.0% in 2020, supported in part by policy stimulus.

Depression," Gopinath said.

Over 75% of countries are now reopening at the same time as the pandemic is intensifying in many emerging markets and developing economies. Several countries have started to recover. However, in the absence of a medical solution, the strength of the recovery is highly uncertain and the impact on sectors and countries uneven, she added.

In a blog post, Gopinath said that this global crisis like no other will have a recovery like no other.

"First, the unprecedented global sweep of this crisis hampers recovery prospects for export-dependent economies and jeopardises the prospects for income convergence between developing and advanced economies," she said.





### KANE INSPIRES SPURS WIN

London, June 24: Harry Kane had to watch helplessly while recovering from surgery as Tottenham's Champions League qualification hopes slipped away. It looked like Kane's season was over — until the Premier League was suspended for three months.

Now, at a time when the striker expected to be playing for England at the European Championship, he is back scoring for Tottenham.

On his 200th Premier League appearance, Kane scored his first goal of 2020 — after Tomas Soucek's own goal — to complete a 2-0 victory over West Ham Tuesday, moving Tottenham within a point of the Champions League places.

"When you have been out for over six months it's just getting

that feeling back on the pitch," said Kane, who moved to 137 league goals overall. "You can train as much as you want but being out here is totally different.

So very different, these days. For one, there were no fans in the stadium due to the coronavirus pandemic. Group celebrations are also prohibited. So there was only a solo slide across the field, and Erik Lamela briefly going to jump on Kane's back before withdrawing.

It was Lamela who gained possession inside his own half to launch the counterattack that ended with Son Heung-min releasing the ball and Kane racing through the porous defense before striking into the net in the 82nd minute.

Only Manchester City striker Sergio Aguero has scored more goals in his first 200 Premier League games — 138 — than Kane. "It goes so quick," the 26-year-old Tottenham academy graduate said.

Leicester goalkeeper Kasper Schmeichel saved a first-half penalty from Neal Maupay during a 0-0 draw against Brighton, which moved six points clear of the relegation

#### A DAY AFTER BEING DECLARED COVID-19 **POSITIVE, PAK CRICKETER TESTS NEGATIVE**

### Hafeez positive for only a day!

Karachi, June 24: Former Pakistan captain Mohammed Hafeez has tested negative for COVID-19, a day after the PCB found him positive for the deadly virus ahead of the team's much-anticipated tour of England. Hafeez and Wahab Riaz were

among the 10 Pakistan players, who tested positive for COVID-19 Tuesday. The team is due to leave for England Sunday for a Test and T20 series in August. Hafeez, Wednesday, took to twit-

ter and clarified that he and his family members have tested negative and also posted the medical report to back his claim.

"After Tested positive COVID-19 acc to PCB testing Report yesterday, as 2nd opinion & for satisfaction I personally went to Test it again along with my family and here I along with my all family members are reported Negetive (sic) Alham du Lillah. May Allah keep us all safe," Hafeez tweeted.

Fakhar Zaman, Imran Khan, Kashif Bhatti, Mohammad Hasnain, Mohammad Rizwan, Shadab Khan, Haider Ali and Haris Rauf are the other eight players who tested positive as per PCB Chief Executive Wasim Khan.

PCB had earlier said all who have tested positive did not report any symptoms prior to testing. "The PCB medical panel is already



in contact with these players and the masseur, who have been instructed to observe strict quarantine at their homes for their and their families' wellbeing," the PCB

said in a statement Tuesday. Khan had said that players testing positive for the virus is a warning for the general public. He also revealed that a support staff member, masseur Malang Ali, had also tested positive for COVID-19.

Khan said that the players and officials would now assemble in Lahore and another round of tests would be carried out Thursday and a revised squad would be announced the next day. "It is a matter of concern but we shouldn't panic at this time as we have time

on our hands," Khan said. The players and officials would be retested on reaching England. Despite the developments over two days, Khan said the tour is on track.



### Djoko's parents defend son ASSOCIATED PLAYER Belgrade, June 24: Novak

Djokovic's parents defended their son Wednesday and blamed another tennis player for spreading the coronavirus at a series of exhibition matches hosted by the topranked player.

Djokovic and his wife tested positive for the virus Tuesday. The 17time Grand Slam champion then apologized online for organizing the Adria Tour events, which brought together professional players from various countries to play matches in Serbia and Croatia. Thousands of spectators attended the matches and no social distancing was observed.

Djokovic's outspoken father

blamed the cancellation of the tour on Grigor Dimitrov, one of the three other players to test positive in the last few days. There is no evidence to suggest Dimitrov spread the virus to others.

'Why did it happen? Because that man probably came sick, who knows from where," Srdjan Djokovic told RTL Croatia TV. "He didn't test here, he tested somewhere else .. I think that's not fair. He inflicted damage to both Croatia and to us as a family in Serbia," Srdjan Djokovic said. "Nobody is feeling

well because of this situation." Dimitrov, a three-time Grand Slam semifinalist from Bulgaria, was the first Adria Tour participant to test positive for the virus. He was followed by Borna Coric ঽ and Viktor Troicki.

Dimitrov reportedly arrived in Serbia from the United States and his native Bulgaria. He did not immediately respond to this agency's request for comment while recovering from the infection in Monaco.
