■ 3-day shutdown in parts of Gajapati

Gajapati: In view of the sudden rise in COVID-19 cases, Gajapati district administration Friday announced a complete shutdown in several blocks and one gram panchayat of the district. Auto, pharma firms not ready to wean off China

New Delhi, June 26: Days after a border clash with China this month in which 20 Indian soldiers were killed. New Delhi told firms to find ways to cut imports from China. But two big industries, automobiles and pharmaceuticals, say this is easier said than done.

Like many countries, India relies on China for products such as electronic components and drug ingredients because it cannot make them or source them elsewhere as cheaply, company and industry figures say. Thus any moves to curb imports or make them costlier without developing alternatives will hurt local businesses.

India imported around \$70.3 billion of goods from China in the fiscal year to March 2019, and exported just \$16.7 billion - its widest trade deficit with any country.

The government is now consulting with companies on tightening curbs on 1,173 non-essential products, a trade body official said on condition of anonymity. They include toys, plastics, steel items, electronics and specific auto components - which feed vehicle manufacturing. "If things do escalate, then India stands to lose a lot more than

No scheduled int'l flights till July 15: DGCA

New Delhi, June 26: The aviation regulator DGCA said Friday it is extending the suspension of scheduled international passenger flights in the country till July 15 but added that some international scheduled services on selected routes may be permitted on a case to case basis.

Scheduled international passenger flights were suspended in India on March 23 due to the coronavirus pandemic.

The competent authority has decided that scheduled international commercial passenger services to or from India shall remain suspended till 2359 hrs IST of July 15, 2020, said the DGCA circular.

However, international scheduled flights may be allowed on selected routes by the competent authority on a case to case basis, said the circular by the Directorate General of Civil Aviation (DGCA).

Air India and other private domestic airlines have been operating unscheduled international repatriation flights under the Vande Bharat Mission, which was started on May 6 by the Central government.

India resumed scheduled domestic passenger flights on May 25, after a gap of two months.



Bhubaneswar, June 26: All roadblocks have now been cleared to relocate tigress Sundari from Satkosia Tiger Reserve to Madhya Pradesh with the National Tiger Conservation Authority (NTCA) allaying fears of the Madhya Pradesh government.

Few days back, the state had raised apprehensions against the relocation of tigress Sundari and wrote their reservations against the move to the NTCA after the Odisha government decided to send the tigress back to MP.

"We had received the letter from the MP government raising their specific concerns against the relocation. We have now had our communication with them and the matter has been sorted out. We have told them that they can relocate the tigress anywhere in the state as per their local assessment of habitat and safety," a senior member from NTCA told Orissa POST.

Woman finds out she is a 'man'

Her chromosome complement was found to be 'XY' and not 'XX', as found in a woman

Kolkata, June 26: For thirty years she led a normal life with no complications, until recently, when doctors, while treating her for abdominal pain, discovered that she was a 'man' suffering from testicular cancer.

Surprisingly, her 28-year-old sister, who underwent necessary tests following the revelation, was also diagnosed with 'Androgen Insensitivity Syndrome' - a condition in which a person is born genetically male, but has all physical traits of a woman.

The 30-year-old Birbhum resident. married for the last nine years, had visited city-based Netaji Subhas Chandra



Bose Cancer Hospital with severe pain in lower abdomen, following which clinical oncologist Dr Anupam Dutta and surgical oncologist Dr Soumen Das conducted her medical tests, and found out her true identity.

From her appearance, she is a woman. Starting from her voice, developed breasts, normal external gen-

italia, everything is that of a woman. However, uterus and ovaries were absent. She has also never experienced menstruation, Dr Dutta said.

It's a very rare condition, and can be found one in every 22,000 people, he said. We conducted clinical examinations, after she complained of abdominal pain, and found out she has testicles inside her body. A biopsy was conducted, following which she was diagnosed with testicular cancer, also called seminoma, Dr Dutta explained.

It was learnt, that the couple had tried for babies a number of times but failed. The patient's two maternal aunts were also diagnosed with Androgen Insensitivity Syndrome in the past.



"During COVID-19, 89 per cent of people have used video to communicate. Video chat is most popular in India, where the majority of people (65 per cent) use it multiple times a day. A whopping two-thirds (64.3 per cent) of Indian consumers had their first esports experience during the pandemic. With other live events cancelled as well, more than two-thirds (68.8 per cent) of Indian respondents also attended their first

virtual concert. Exercising is also going virtual as athletic facilities remain closed. Yoga has also been popular in India as it helped people to maintain physical fitness during the lockdown. In line with this trend, 55.6 per cent Indians said that they had participated in an online fitness class and another 26.8 per cent plan to so in the next six months," Limelight Networks said in its How Video is Changing the World report.

"After the relaxation in lockdown conditions and opening up of economic activities in Bhubaneswar, people have started coming from other districts to work and they mostly reside in slum areas. It is observed that few returnees from other hotspot districts (districts having more number of positive cases) to Bhubaneswar have been found positive for COVID-19," a notification from BMC said.

It added, "Such returnees, if asymptomatic, can affect many others as social distancing is practically not possible in slum areas because of small houses and high population density. Therefore, in larger public interest, the returnees from these districts to slum areas of BMC will be kept in institutional quarantine for the specified period of 14 days from the date of return from other district," The BMC said the infor-

mation of such returnees will be captured by active slum surveillance teams on a daily basis. The zonal deputy commissioners of BMC shall obtain this from the slum surveillance teams and take steps to shift them to the institutional quarantine centres.

"The zonal deputy commissioners shall obtain such information from slum committees also about the returnees from these districts.

As soon as reports of such returnees come to the notice of ZDCs from any other source also, they should shift them to the quarantine centres,"

The BMC Commissioner in a press conference said till now the city has seen 274 infection cases out of which 138 have recovered while three have died. "Close to 8681 people have returned to the city post lockdown curbs. At present, 2,791 are under quarantine in the city while many others have completed their home quarantine as per norms," he said.

Labour Commissioner Anu Garg meanwhile asked people in the city to ensure they take preventive measures to tackle COVID 19. "Cases are rising but the preventive measures are going down. Please continue to do this. I want to request all private hospitals that please abide by the norms issued by the health department. You have to ensure that you train your staff in infection control and prevent the infections," she said.

Bhubaneswar, June 26: The state's COVID-19 tally crossed the 6,000-mark Friday with 218 more people, including seven NDRF personnel, testing positive for the infection, a health department official said.

With these fresh patients, the total number of coronavirus cases in the state has gone up to 6,180, he said. Of the fresh cases, 191 were reported from quarantine centres where returnees have been staying for preliminary observation.

Seven National Disaster Response Force (NDRF) personnel, who had returned from cyclone Amphan restoration work in West Bengal, were also in quarantine facilities and tested positive for COVID-19, while the remaining cases were detected during the contact-tracing exercises, the official said.

A total of 289 personnel of disaster response teams of NDRF, Odisha Disaster Response Force (ODRAF) and Odisha Fire Services and nine Border Security Force jawans have been infected with the virus in the state, he said.

The highest number of fresh cases excluding NDRF personnel was reported from Ganjam district at 49. Jagatsinghpur (29), Gajapati (27), Bhadrak (25), Khurda (17), Sundargarh (11) and Puri (10) were among the districts where new cases were found.

Ganjam is the worst-hit district with 1,137 cases, and the local ad-

ministration has declared a four-day shutdown in Berhampur Municipal Corporation (BMC) area beginning Saturday, the official said. The shutdown will be imposed to carry out contact tracing and door-to-door survey, District Collector VA Kulange said, adding that 70 teams have been formed for these purposes. They will examine the health condition of cit-

izens and take stock of the home

The 16th Board of Directors Meeting of Bhubaneswar Smart City Limited (BSCL) held here, Thursday, on the eve of the fifth anniversary of the Smart Cities Mission discussed the same. Among discussions , the board ap-

Among discussions, the board approved budget for the financial year 2020-21, draft accounts, HR and accounts policy were also passed for the SPV in BSCL.

Following this, the BSCL in its meet with Board of Directors approved extension of nine months to IBI Group as project management consultant (PgMC) with the Smart City for smooth execution of technology-based projects. Panned under 'Pan City Smart Solution' some of these projects include Intelligent City Operations and Management Centre (ICOMC); Common Payment Method and Traffic Management Project.

"We have directed the BSCL to expedite its work with various ongoing projects during post Covid-19 situation and to complete

infrastructure projects including Smart Parks so that it may be put to efficient public use," stated BSCL Chairman, Suresh Chandra Mahapatra.

Housing and Urban Affairs Minister Hardeep Singh Puri advised smart cities quickly implement cyclingfriendly initiatives in response to Covid-19. Floating 'Cycles4change Challenge,' the ministry suggested the SPVs to explore low-cost interventions such as pop-up cycle lanes, nonmotorised zones and community-led cycle rental schemes. The meet thus saw BSCL Chairman directing the Capital Region Urban Transport authorities to deploy more cycles across all the cycle docking stations across the city so that people can use them as means of transport, physical exercise and last mile connectivity and reduce dependency on overburdened public transports.

Greens seek scrapping of EIA draft note 2020

Bhubaneswar, June 26: Environmental activists in the state have opposed the latest EIA (Environmental Impact Assessment) draft notification-2020 issued by the ministry of environment, forest and climate change (MoEFCC), saying it goes against the country's stance on biodiversity and militates against the agreements India signed as part of the Paris Climate Accord.

Several green activists and experts have sent their objections to the ministry, stating that the draft proposes to fundamentally alter India's current environmental rules and regulations, assessment and public participation and goes against the legal conventions under environmental laws. While the draft EIA will encourage violations, if implemented it will result in an exponential increase in GHG emissions and other pollutants released by industries. The deadline for objection ends on June 30, 2020.

According to the latest draft, the rules will be relaxed to ease work-



ing of ongoing projects and other 191 projects which are set for approval in near future.

However, the ministry has instead decided to relax norms on clearances and simultaneously has initiated the 'Unleashing Coal' campaign, auctioning 50 more new coal blocks to private players in the heart of the country. Such coalbearing regions in Odisha, Maharashtra, Chhattisgarh and Madhya Pradesh are rich in biodiversity and home to indigenous communities.

communities. Archana Soreng of Khadiya Tribe in Odisha, research officer at Vasundhara Odisha, said, "A flurry of environmental clearances will have catastrophic effects on wildlife corridors and well-being and tenurial rights of adivasis and forest dwellers in India. Forest and nature are the source of life and identity of adivasis and forest dwelling communities. Unlike others, who see forest and nature as commercial

commodities."

Ashish Birulee, photojournalist and a co-founder of Adivasi Lives Matter, said, "EIA will affect adivasi community because all the proj-

ects will be built after displacing adivasis from their land on which they have been living for long. The adivasi community has been dependent on resources from forests. They go foraging for fruits, firewood, leafy vegetables and medicines. Their self-reliant livelihood will be completely ruined."

Meher Abadian, a veterinarian, said "I am not sure what message the government is trying to send to us through this shoddy draft. This will result in a huge loss of biodiversity, damage ecosystems and aggravating man-animal conflict and pushing wildlife towards extinction."

Shweta Agrawal, an environmentalist, said #DraftEIA2020 relies on self-compliance - it assumes that violators will report themselves, this is an upside-down logic! This draft is a mockery to the process of environmental protection. It must be revoked. We've had 63 football fields' equivalent forest land being chopped everyday for three consecutive years (2014-17) in the name of #development due to industry-friendly clearances. We don't want history to repeat itself, she added.

5 cyber frauds of around ₹15L

Bhubaneswar, June 26: The capital city witnessed a sharp increase in cyber frauds. The rise in such cases followed imposition of a nation-wide lockdown to stem the spread of coronavirus. The fraudsters also followed different types of tactics to fleece their targets.

Five cyber frauds worth over Rs 15 lakh came to notice in the city over past seven days. Pradipta Kumar Mishra of Pokhariput area under the Airport police limits was duped by cyber criminals to the tune of Rs 15 lakh. The miscreants called Mishra through a customer care number of Paytm, an Indian e-commerce payment system, and told him that the bank account linked to his Paytm account had expired due to the non-submission of KYC details.

They asked him to give them all the details related to his bank account. Subsequently, they withdrew Rs 9.80 lakh from the account of Mishra who gave his bank account details. Another victim identified as Sanjeeb Kumar Biswal of Sailashree Vihar under



Chandrasekharpur area was also duped by cyber fraudsters in a similar manner. Biswal lost around 2 lakhs after he shared his PAN, Adhar and bank account details with the miscreants.

Two other persons in Khandagiri area have lost Rs 46,000 and Rs 37,000 respectively. They sent the KYC details of their bank accounts to the fraudsters after the latter fooled them by saying that Paytm accounts have expired.

Meanwhile, cyber fraudsters duped a woman of around Rs 60,000

on the pretext of winning some coupon for the use of her credit card. The lady was identified as Madhumita Pattnaik of Jaydurga Nagar under Laxmisgar police station. The conmen asked the lady to send them her 16 digit credit card number, CVV and the OTP which she sent accordingly Later, she was shocked to receive shopping bills worth Rs 60,000 while the transaction was conducted through her credit card. Police have been investigating the three cases by registering cases in this regard.

Middlemen traffic returnee migrants to Andhra Pradesh

WITH COVID-19 INFECTIONS SURGING DAY BY DAY THE TRAFFICKING OF **WORKERS HAS BECOME** A CAUSE OF CONCERN **FOR MALKANGIRI ADMINISTRATION**

Malkangiri, June 26: Migrant workers from Odisha who returned to the state from various parts of the country in the wake of the coronavirus outbreak are being trafficked by labour contractors to neighbouring Andhra Pradesh.

This has been happening even as the administration is yet to identify the returnees and map their skills for their employment in the state, a report said.

The administration has spent lakhs of rupees for transportation of the stranded migrant workers from other states.

With COVID-19 infections surg-

ing day by day the trafficking of migrant workers has become a cause of concern for the administration. Surprisingly, the labour trafficking has been going on without the knowledge of the labour department and local sarpanchs.

Some families of Sindhiguda village in Mathili block alleged told media persons that two middlemen forcibly took away seven youths from the village June 19 to Andhra Pradesh where they will be engaged in a bore well company. The health condition of the youths is not known, the villagers said.

The seven youths were identified as Purna Durua, Surya Durua, Lakh Durua, Sitaram Madkami, Kuduku Madkami, Smaru and Pardeshi of Kasarbhata and Sindhiguda villages.

Despite opposition by the family members of the youths, the middlemen took them and assured that they will come back soon.

Locals alleged said if the vehicle in which they were transported to the neighbouring state had been checked, the middlemen and the workers could have been caught.

Mahupadar outpost police said the matter will be investigated and the youths will be brought back.

Sarpanch Shivshankar Durua said the youths were taken without his knowledge. Now, projects worth Rs 50 lakh under MGNREGS are being executed, he added.

PMGSY road on forest land riles locals

Coastal farmers in fear after release of Hirakud floodwater

Kendrapara, June 26: Farmers in Kendrapara district are a worried lot after the year's first floodwater was released from Hirakud dam

From past experience, they say the floodwater released into Mahanadi will reach Mundali in Cuttack by Saturday and then it will reach their district. This season, they fear, the embankments that have gone weak may not stand the floodwater. If the embankments gets breached somewhere, huge damage to farmlands and open areas in the lower end is inevitable, they apprehend.

There are seven rivers and 27 distributaries in Kendrapara district. These rivers and rivulets get water from the Mahanadi and Brahmani systems as well as from the Baitarani

Once the water flowing in the Mahanadi system reaches the district, rivers like Mahanadi, Luna, Chitratpola, Paika, Birupa and Gobari, and canals like Kendrapara canal, Gobari canal, Pattamundai canal will swell.

The farmers' rough estimate says the floodwater will affect 50, 000 hectares of agricultural land where kharif cultivation has just started.

According to Laxmikant Swain, farmer of Mahakalapara block after cyclone Amphan and monsoon rain farmers have already prepared beds for kharif paddy. At some places, farmers have even begun paddy transplantation. At the same time, some riparian farmers give importance to growing vegetable At this time if floodwa-

ter comes, it will damage the crops. Swain alleged that at places there are no embankments and at places the embankments are not strong enough to withstand the force of floodwater. If the farmlands get inundated, in the absence of any facility to drain out the accumulating water, it will stand for days

"Most farmers have taken loans. And they are now worried about how they will repay the loans incase their crops go waste," Swain

According to environmentalist Hemant Kumar Rout, various reasons have pushed this animal to near-extinction. Starting from sea coast erosion to infiltration, encroachment and illegal construction in BNP area have widely been responsible for bringing down their numbers.

In the last 10 years, prawn gheries have extensively damaged rivers, rivulets

and the environment. The chemical gas emitted from these gheries has played a major role in reducing the number of aquatic animals. In 2018, as many as 307 dolphins were sighted here. The last census put their number at only 62. "If the biodiversity of the BNP is not protected, our next generation will find them only in pictures," Rout

When contacted, divisional forest officer (DFO) Bikash Ranjan Dash said globally the population of this animal is abysmally low. If the surrounding atmosphere of BNP delta is considered, their number must have been more.

Fishing cats are great hunters. They prefer catching fish in water. Their paws and sharp teeth make them potent hunters. The state government has recently emphasised on its conservation, Dash said.

Fishing cats are double the size of common house cats. Apart from fish, they also prey on snakes, frogs, birds and feed on carcasses of other ani-

They are good swimmers. They breed all year round and spend most of the time in dense vegetation areas close to water bodies.

Urjit is back, Rajan likely

The COVID-19 pandemic has made friends of erstwhile foes! Urjit Patel, who left 18 months ago after a fractious tenure as RBI Governor, is back as chairman of the National Institute of Public Finance and Policy (NIPFP). In 2018, he had resigned barely four days before a crucial meeting of the board of RBI that would have discussed the central bank's simmering differences with the Modi sarkar. Patel replaces former bureaucrat Vijay Kelkar who helmed NIPFP for six years and will have four-year tenure.

Why has the government brought back an economist with whom it had major differences, and whose tenure at the RBI was marked by a running battle between Patel and the Finance Ministry on various issues? Clearly, much has changed since then. The economic slowdown coupled now with the havoc wreaked by the coronavirus outbreak has limited the options of the government. Its present set of advisers on matters economic has not been able to chart a new course. So, the government has been forced to fall back on those people who it had once forcefully ejected because their ideas did not match those of the ruling dispensation, or they were unwilling to do the government's bidding.

It appears that the Modi sarkar is now trying to make the best out of an unhappy situation. Clearly, the Centre wishes to draw upon Patel's experience as it navigates policy in these turbulent times. Apparently,

there is also mounting pressure to bring back Raghuram Rajan, Patel's predecessor at the RBI who too had guit because he couldn't get along with the powers that be, most notably on the issue of demonetisation. Hopefully, Patel's second innings with the Modi sarkar will be a smoother affair.

NITI Aayog hires domain experts

Prime Minister Narendra Modi's vision of adding domain experts to the bureaucratic mix is alive. After last year's hiring of eight domain experts as joint secretaries through the UPSC, not much was heard about lateral entry

The NITI Aayog, the premier government think tank, has reportedly recruited 38 experts through lateral entry at the level of director and deputy secretary. Their expertise ranges from economics and finance, trade and commerce, and data management and analysis, to rural development and infrastructure connectivity. Letters of appointment were issued to the appointees in March. While 20 appointees have already joined NITI Aayog, the coronavirus outbreak has delayed the joining of the rest

Interestingly, unlike the lateral entrants hired through UPSC and who have the same privileges as career civil servants, the officers appointed on contract basis will not be entitled to residential accommodation, official transport, leave encashment or any other allowances/facilities as admissible to a regular government employee.

No foreign training for babus

The coronavirus pandemic is affecting all sorts of activities. Facing a financial crunch during the raging coronavirus pandemic, the Modi sarkar has decided to discontinue foreign training for bureaucrats the current financial year. The government has removed the international component from the training programme, citing financial austerity in the wake of the pandemic.

According to sources, the Department of Personnel and Training (DoPT) issued a circular directing all cadre-controlling authorities and central training institutes to not conduct foreign training in FY 2020-2021. Besides the tight fiscal situation, the government also felt that the decision was necessary from the health and safety points of view as well.

The circular further states that if there is "an urgent need to send civil servants overseas, the authorities will need to seek permission from the DoPT" With the COVID-19 pandemic showing no sign of a let-up, the government has a huge task on its hand and clearly needs to use its straitened resources for fighting the deadly virus.


Steganography

Steganography derives from the Greek steganos, hidden or covered, plus graphein, to write. Someone who uses this technique is a steganographer. This is the art or technique of creating and transmitting hidden messages. The dictionaries — those few that include it, for it has been in the past an uncommon word — say this is connected with cryptography. But those in the spy business make a careful distinction between the techniques of cryptography and steganography, although both are aspects of the art of secret communication. Cryptography is the technique of scrambling a message in a systematic way so that (hopefully) it can be read only by its intended recipient. Steganography, on the other hand, keeps the message secret by hiding the fact that it exists, a technique that cryptographers sometimes sniffily refer to as "security through obscurity". So the microdot of the Cold War spy novels - in which a document is photographically reduced to the size of a pinhead and stuck to an otherwise innocuous typescript - is an example of steganography. Invisible ink is another example. You can, of course, combine the two techniques if you believe in the braces-and-belt approach to life. The word has become more common in the digital age, since it is now relatively easy to hide messages within otherwise innocuous-looking images.

elhi-based Observer Research Foundation has said that today China is leading the world in a number of technologies such as in genetics, hypersonics (faster than sound), 5G Internet and facial recognition though Artificial Intelligence. In coming times, the technologies of 5G, Artificial Intelligence, Internet of Things (self-operation of machines through internet such as self-opening of a door after recognising face of the person), 3D Printing (manufacture of clone of an object such as a chocolate) and robotics will determine which country will dominate the world.

Here, China is fast attaining ascendancy. Inventors file applications for the grant of patents before the World Intellectual Property Organisation (WIPO). The inventor gets the global right on the said technology after such filing. The numbers of patents filed by China exceeded those filed by the US for the first time in 2019.

The US had been leading in this since inception of the WIPO. China had filed merely 300 applications in 1999. This has increased to 59,000 in 2019, surpassing the 58,000 applications filed by the US. In parallel, the Chinese company Huawei has filed the highest number of patents filed by a company for the third year in a row. China has already become the technology guru of the world.

A paper published in the Harvard Business Review of March 2014 has said that this technological progress of China is built upon the two legs of financial support by the government and political determination. Although the authors have expressed doubt that China will be able to become the world leader in technology because of political intervention, the record of the last 20 years clearly shows that political intervention has had a beneficial and salutary impact on China's technological advancements. It should be obvious that the political intervention will have a negative impact if that leads to harassment of honest researchers for not toeing their ideological line; but will have a positive impact if



The average salary of government servants in China is about 1.5 times the per capita GDP of China, which is about 4.6 times in India. My assessment is that our government has had little money left for research or for other necessary expenditures such as defense after the Fifth Pay Commission

it leads to the removal of inefficient researchers. The question is not of the fact of political interference but of the nature of political interference.

How should we then deal with China's technological prowess? A number of Indian companies, especially startups like Ola, are riding on Chinese investments. These companies are remitting profits to China. Tencent is a major Chinese investor in India. Some 47 per cent of its profits come from India. We can certainly stop taking these investments. But that will not solve anything.

The impact of such a move will depend on our nerves. Taking Chinese investments can be beneficial if Ola can absorb the technology and develop an indigenous clone that then threw Ola out. On the other hand, Indian economy will suffer if we become perpetually dependent on Chinese aggregation technology. The Chinese experience illustrates the matter. The Harvard study says: "In 2002, the [Chinese] government launched an open bidding process for wind farm projects to encourage competition among turbine makers. Foreign imports soon flooded China's fledgling market... The government then required stateowned enterprises to source 70 per cent of their components from domestic firms. By 2009, six of the top 10 wind turbine firms were Chinese." So, the question is not

whether we take Chinese investment or not. The question is how we ride upon them.

Trade is similarly placed. Our cost of production of, say, auto parts is higher than China. We can stop these imports. In that case, if we are unable to upgrade, our auto manufacturers will have to buy more expensive home-made parts. The cost of cars in India will increase and become a burden on our consumers. We will also be thrown out of the world market. On the other hand, if we upgrade and make parts as cheap as China, then we will win. So, once again, the question is not whether to trade with China or not. The question is whether we can reduce our cost of production and compete with China.

We will have to solve the underlying issues. We must have the nerve to put Chinese investments on their head just as China did with wind turbines; and we reduce our cost of production.

Facing the technological challenge will require action both on financial and political fronts. The Economic Survey published by the Ministry of Finance noted that India's expenditure on Research and Development has remained flat at 0.7 per cent of GDP while Korea and Israel are spending 4.6 per cent and China 2.1 per cent. The total expenditure by China becomes 15 times that of India once

5 times that of India. The main reason for our low investment is the consumption by our government. Our government revenues are being used to pay hefty salaries to the government servants. The average salary of government servants in China is about 1.5 times their per capita GDP of China while it is about 4.6 times in India.

My assessment is that our government has had little money left for research or for other necessary expenditures such as defense after the Fifth Pay Commission. I daresay that the government servants are eating away the sovereignty of the country by capturing government revenues and preventing investments in research and defense. I am cognizant that large numbers of government servants, especially in the armed forces, are honest and diligently serving the country. However, that does not obviate the collective impact of the high salaries paid to them in comparison to the GDP per capita of the country.

The second cause of our technological backwardness is the decadent state of governmentfunded universities and research institutions. A few years ago, I had the occasion to ask a university professor how he spent his time after retirement. He replied, "I have got used to not working for the last 40 years. The time just passes by." Remember that American lead in technologies is substantially supported by their universities. Chinese universities are also playing the same role. Our universities, however, are mainly busy distributing certificates so that the students get government jobs and get used to "not working" like themselves.

India needs to wake up. This is not the time to shout about the arm-twisting and manipulations by China. That is geopolitics. We have to set our own house in order. The government will have to stop pandering to the government servants and increase outlay in research; and enforce accountability in the government-funded universities and research institutions.

Rule of Law in season of pandemic

ROL IS NOT JUST A WEAPON AGAINST UNQUESTIONABLE STATE DOMINATION OR AGAINST THE WHIMS AND **FANCIES OF THE RULING GROUPS; IT IS ALSO A SHIELD PROTECTING THE CIVIL SOCIETY**

The Supreme Court has asked the government to treat a writ petition filed in the court seeking setting up of expert panels to find ways of enhancing India's rank in the Rule of Law Index as a "representation" and respond within six months. For, it is not a judicial issue, but a matter for government consideration.

In the Rule of Law Index 2020 prepared by the World Justice Project (WJP), India is given THE 69th rank among 128 countries and jurisdictions. WJP is an independent, multidisciplinary organisation working for promoting the Rule of Law (ROL) worldwide. It is a quantitative assessment tool designed to provide a detailed and comprehensive picture of the extent to which those who govern various countries are bound to act according to laws and regulations and prescribed procedures and adhere to the rule of law in practice. An independent judiciary, individual freedom, and free press are considered essential ingredients of ROL.

Effective Rule of Law prevents arbitrary decisions, and can reduce corruption and protect people from injustices. Whether it can combat poverty as claimed by its advocates may be disputed by welfare theorists. But, it is to be accepted as the foundation for justice, equal opportunity and peace underpinning development, and fundamental rights for all citizens. It guarantees an accountable government that holds law as supreme.

Rule of Law is being discussed from the days of Plato and Aristotle. As a political concept, it can be traced to 16thCentury Britain as a right of subjects against the divine right of kings. Its originator was Sir Edward Coke, Chief Justice in the reign of James I. To John Locke, freedom in society means being subject only to laws made by a legislature that apply to every one equally. British jurist AV Dicey popularised the concept of Rule of Law as the corner-stone of parliamentary democracy.

Under Rule of Law, all members of a society, including the governing group, are considered equally subject to existing law of the land the contents and processes of which are publicly disclosed. Equality and openness are two essential characteristics of the Rule of Law. The term is closely associated with

"constitutionalism" – a political situation and not any specific law.ROL is not just a weapon against unquestionable State domination or against the whims and fancies of the ruling groups; it is also a shield protecting the civil society. It has grown in various forms apart from legal and procedural codes like permitting judicial activism, public interest litigation, suomoto iudicial intervention on press reports and so on thus making justice more easily available and accessible to the citizens.

WJP index is based on the results of a survey of over 130,000 households and 4,000 legal practitioners and experts to measure how the Rule of Law is perceived and experienced worldwide. Countries covered have different political and juridical systems, economic standing, ethnic-social characteristics, historical background, population complexion, and domestic and international problems. But, these are not taken into account in the preparation of the index as in any such global index which goes by scores given on the specific indicators used in the project.

Denmark, Norway, Finland,

Sweden, Netherlands, Germany, New Zealand, Austria, Canada, and Estonia are the top 10 while Zimbabwe, Pakistan, Bolivia, Afghanistan, Mauritania, Cameroon, Egypt, Democratic Republic of Congo, Cambodia, and Venezuela are the bottom 10 countries in the index, repeating the 2019 record. Noteworthy is the removal of the US from top 20 and Spain getting an elevation. France declined from 17 to 20 in rank. The UK stands at rank 13.On the whole, the global trend is found to be declining in the past three years. Last year, the fall was in fundamental rights, absence of corruption, and particularly on constraints on gov-

ernmental power. The question whether the pandemic may be used as an excuse for restrictions on personal freedom and economic activities has arisen as a political issue in some countries. The foundations of the ROL are strong enough in our country to survive the threats from the pandemic which are temporary.

With surge in virus cases, Hyderabad traders go for voluntary 'lockdown'

Hyderabad, June 26: In view of the continuing surge in Covid-19 cases in Telangana and especially in hotspot Hyderabad, traders in different commercial clusters in the state capital have voluntarily announced a 'lockdown'.

Though the government has already ruled out re-imposing lockdown, traders' associations decided to close the shops for a period ranging from one to two weeks.

While traders in Begum Bazaar, a major trading centre in the city, had reduced the business hours a few days ago, businessmen in several other areas decided to down shutters as a precautionary

Some of the commercial centres either fall in containment zones or are close to the worst-affected areas.

Textile traders of General Bazaar in Secunderabad voluntarily decided to shut down the business for few days to help contain the spread of coronavirus. Their as-



sociation voiced concern over the increasing number of cases and said the decision was taken in the interest of people.

The Hyderabad Kirana Merchants Association and the Hyderabad and Secunderabad Sanitary Association have announced that their members will keep the shops closed for next few

A similar decision was taken by traders in Troop Bazaar, a key commercial hub. Traders in historic mous for bangles and bridal wear also decided to shut the shops. Traders in Patthargatti, also near Charminar, shut the shops from

The decision by the trade bodies came amid growing public concern over the spread of Covid-19. With every passing day, the state and Hyderabad are witnessing a new high in cases.

The state recorded 891 cases Wednesday, the highest single-day jump. As many as 719 of these cases were reported from Greater Hyderabad. The total number of Wednesday. Greater Hyderabad Municipal Corporation (GHMC) accounted for 5.883 cases.

More than 4,000 cases were recorded in the last week alone and 80 per cent of them were from Hyderabad and adjoining districts.

Meanwhile, Hyderabad MP Asaduddin Owaisi welcomed the decision by the traders of Lad Bazaar and other areas in Hyderabad. He appealed to people to ensure social distancing, avoid large gatherings, wear masks and not to step out unless it is absolutely essential.

"Do not panic. Immediately seek medical help in case you have symptoms of COVID-19-Protect senior citizens & folks with chronic illnesses," tweeted Owaisi.

The All India Majlis-e-Ittehadul Muslimeen (AIMIM) President appealed to all to get themselves and their families tested for Covid-19 as soon as possible.

Notice to hospital for conducting 'Coronil' trial on COVID patients

Jaipur: June 26: Rajasthan's Health Department has served a notice to NIMS hospital here seeking an explanation on conducting trials of Patanjali Ayurved's drug Coronil on coronavirus patients, an official said Friday.

'We served notice to the hospital Wednesday evening seeking explanation in three days. The hospital did not inform the state government nor sought permission," Chief Medical and Health Officer, Jaipur, Dr Narottam Sharma said

He said the reply from National Institute of Medical Science (NIMS), Jaipur is awaited. The launch of the drug by voga guru Ramdey Tuesday triggered a debate after which the Ayush Ministry sought all information on its trial and put a ban on advertising it as a drug to cure coronavirus. The Rajasthan government has clarified that the drug cannot be not used as a medicine in the state without the permission of the Ministry of AYUSH.

State Health Minister Raghu Sharma had said Wednesday that

the seller as per the rules in case of sale of any drug as a medicine to treat the coronavirus infection.

At the Coronil launch, the company had claimed that its medicine can cure the contagious disease within seven days. It said Coronil, taken along with another product developed by it, had shown a 100 per cent success rate in clinical trials on infected patients, except those on life support.

Ramdev said the medicines were developed by Patanjali Research Centre, Haridwar in association with privately-owned National Institute of Medical Science (NIMS), Jaipur. The Uttarakhand government will serve a notice to Patanjali Ayurved for launching a drug claim-

it had only applied for a licence to manufacture an immunity booster against cough and fever.

Hyderabad, June 26: The health authorities in Telangana Thursday decided to pause the ongoing mass testing for Covid-19 in Hyderabad and surrounding districts in view of the piling-up of samples in test-

With 8,235 samples still pending in the labs for testing, the authorities said collection of more samples without testing the pending ones will create problems.

Director, Public Health and Family Welfare, G Sriniyasa Rao said collection of samples by conducting special camps has been stopped for two days so that the testing of pending samples is completed and labs and collection centres are sanitised.

Telangana Chief Minister K Chandrashekhar Rao had announced June 14 that 50,000 Covid-19 tests will be done in 30 Assembly constituencies in Greater Hyderabad Municipal Corporation (GHMC) limits. Till June 16, the health authorities collected 36,000

The official said in a statement that each sample has to be tested within 48 hours and till then it has to be preserved in controlled temperature. "If there is delay in testing the samples, it may show false positive result," he said.

The director said collection of samples through special camps was paused but tests in hospitals would continue uninterrupted Those with suspected symptoms of Covid-19 can get themselves tested in hospitals

He said that people should not have any fears as the process of testing for those in need would

The mass testing in the hotspot had led to a big surge in positive cases during the last one week. The total number of cases in Telangana mounted to 10,444 Wednesday with 891 cases, the highest single-day jump.

Dalit activists want Manu statue removed from Raj HC premises

New Delhi, June 26: In a letter to interim Congress president Sonia Gandhi, nearly 600 Dalit activists, scholars and well-wishers have urged her to remove Manu's statue from the premises of the Rajasthan High Court, saying the statue is an 'insult to the Indian Constitution and Dalits'.

"We are writing this letter because we believe that as the president of the Indian National Congress, which has the government in power in Rajasthan, you have the required power to take a step which would prove historic in strengthening the Dalit movement for equality," said the letter written by Martin Macwan, founder of Navsarjan Trust, a grassroots Dalit organisation hased out of Gujarat.

He said the statue of Manu is 'an insult to the Indian Constitution as well as Dalits, women and all those who believe in equality and justice'.

According to Hindu mythology, Manu is the progenitor of mankind and the author of 'Manusmriti', which codifies the rights and duties of various social groups

Macwan wrote that the statue is a symbol of an oppressive past and harks to the reality of Dalits and women in India, whose lives are still affected by the discriminatory laws put down by Manu in Manusmriti. The text is known to have formalised regulations around the caste system and the patriarchal values often propagated in Hindu tradition.

"Moreover, the law of Manu stands in total contradiction to what the Indian Constitution has committed itself to, while the latter upholds equality and fraternity, social justice and freedom, the former indulges in archaic teaching about inequality and social segregation, hierarchy and divi-

Man video-calls wife before suicide bid, cops come to rescue

Hyderabad, June 26: A video call made by a man to his wife besaved his life as she alerted the Hyderabad Police which acted swiftly to stop him from taking the extreme step.

Ramakrishna was found between Nampally and Lakdikapul railway stations in the heart of the city Thursday evening, waiting for a train to jump under it.

"Technology saves life. Man made a video call to his wife about his plan to commit suicide. Wife informed Tappachabutra Police which swung into immediate action and traced him on the railway track and saved him from getting run over by a train. Felt so satisfied about the family,' Hyderabad Police Commissioner

Anjani Kumar tweeted Friday. According to police, the medical representative was depressed over not receiving the salary for the last three months.

Resident of Markunday Nagar under the Tappachabotra police station Ramakrishna, 34, had left his house with a decision to end his life and reached the railway track. He made a video call to his wife Sailaia informing her that he is committing suicide. Shocked over this, the

woman immediately dialed 100. The police swung into action and traced Ramakrishna's location from the mobile phone signals. Tappachabutra Additional Inspector Prasad Rao sent a constable with Sailaja to the railway track and they stopped him from taking his life. Minutes later a train passed through the track.

The woman heaved a sigh of relief. The police counselled Ramakrishna, who confessed that he was depressed due to no work and no salary for three months and decided to end the life after consuming liquor.

Udaipur Film City turning into reality

Jaipur, June 26: Negative comments in Rajasthan Board of Secondary Education textbooks regarding legendary warrior Maharana Pratap and his father Udai Singh II have riled not only the erstwhile Mewar royals, but also politicians and common people who have voiced their strong disapproval for the 'twisting of historical facts'. While the Maharana has been

described as someone who 'lacked control and was impatient due to which he lost the Haldighati battle to Akbar', his father and Mewar ruler Maharana Udai Singh has been dubbed a 'murderer'. The Class XII textbook claims on

page number 101 that Maharana Pratap lost the Haldighati battle as he was impatient and lacked moderation and control. The chapter entitled 'Muslim Invasion, Aim and Impact' further claims that the army head should always adopt patience even in adverse situations, something which Maharana Pratap lacked.

Also, facts related to the Haldighati battle have been removed from the social science textbooks. In the Class X textbook 'Rajasthan ka Itihaas aur Sanskriti', Maharana Udai Singh II has been termed as a man who murdered one Balvir to capture the Mewar kingdom. Many history books on the

other hand point out that Balvir had died somewhere in Maharashtra after he fled Mewar.


Mahendra Singh Mewar of the erstwhile Mewar royal family said that 'attempts to tarnish the image of Raiput warriors Maharana Pratap and Udai Singh will not be tolerated'.

"Who are these people who want to change the history of Haldighati," he questioned.

The Haldighati battle was fought between Moghul emperor Akbar's army led by Man Singh of Amber and Maharana Pratap's Rajput warriors in June 1576.

Another Mewar family scion, Vishvaraj Singh, condemned the changes in historical facts. "History distorted to an absurd extent and included in textbooks for schools Abundant display of ignorance and crass, boorish mentality of the decision-making authority(s) in peddling distortions to suit their own agenda. History itself will not be kind to them, nor to those who accept their ways," he said.

Meanwhile, state Education Minister Govind Singh Dotasara said. "Our committee will review the facts which are being argued upon. As per my knowledge, no new facts have been introduced in the book. I appeal to everyone to let me know what is wrong in the book and where and why it is wrong. Our committee of secondary education board will review them.'



The textbook also claims that Haldhighati was not named so due to the yellow colour of the soil but because many newly-wed brides Education Department, which was jumped into the battleground dressed as warriors with turmericsmeared faces. This claim has been taken from Mahendra Bhanawat's

book 'Ajooba Bharat Ka'. It further claims that the Moghul army was led by Jagannath Kachwaha though historians say it was Man Singh. Kachwaha arrived in Mewar eight years after the epic battle in 1576, say historical records.

Union Minister Gajendra Singh Shekhawat also criticised the 'misleading information' on Maharana

Pratap in school textbooks and said that the history of Marudhara has been insulted by the Rajasthan

unacceptable Rajsamand's BJP MP Diya Kumari criticised the development and claimed that the 'Congress government's historians' had insulted Maharana Udai Singh II, Maharana Pratap, and the Haldighati battle.



Life term for K'taka serial killer in 20th murder case

Mangalore, June 26: A local court in Karnataka's coastal city sentenced serial killer Mohan Kumar to life imprisonment after he was convicted for raping and murdering his 20th victim 11 years ago, police said Thursday. 'Sessions Judge Sayeedunnisa,

who found June 20 Kumar guilty of killing his 20th victim in Bangalore in July 2009, sentenced him to life imprisonment under Section 302 of the IPC," Sullia police inspector MR Harish told this news agency. The 25-year-old victim, who hailed

from Sullia, near this port city in Dakshina Kannada district, was a cook in a women's hostel at Kasargod in Kerala, when she got acquainted with Kumar, a teacher then, who promised to marry her.

Mohan Kumar is lodged at Hindalga central jail at Belagavi, after he was convicted and sentenced to death in four murder cases and life imprisonment in 15 similar cases over the last decade.

The judge also slapped a fine of ₹25,000 on him, 10 years and ₹5,000 for feeding poison, 7 years and ₹5,000 for rape, 5 years and ₹5,000 for robbing the victim's jewellery and destroying evidence.

In all, the court cross-examined

uments and 31 assets.

Mohan Kumar was arrested in this case in October 2009 after the victim's family recognised him when his photo was published in a local newspaper following a missing complaint her younger sister filed in the Sullia police station over a decade ago.

According to the charge sheet, the victim left Kasargod 'July 8, 2009 to visit a temple at her home town Sullia from where Mohan took her to Bengalore on the pretext of marrying her and had physical relationship with her in a city lodge where he kept her for three days.

'When the family members enquired about the victim three days later, Mohan told them that they both were married and would return to Sullia soon. He did not, however, allow them to speak to the victim." the charge sheet said.

"Kumar took the victim to the bus stand for returning to Sullia and gave her a cyanide tablet saving it was a contraceptive pill to prevent pregnancy. She collapsed in a toilet near the bus stand soon after consuming it while Kumar vanished from the spot. A constable rushed her to a hospital where she was declared brought dead," Harish

Autopsy of the victim revealed traces of cyanide in her body.

60 GST listings linked to Chinese national from Wuhan unearthed

Bangalore, June 26: The commercial taxes department in Karnataka has unearthed 60 GST registrations linked to a Chinese national from Wuhan and seized Chinese goods worth ₹4 crore from an undeclared warehouse here during a raid.

A total of 25,446 Chinese made electronic and Fast Moving Consumer Goods (FMCG) were seized from the warehouse on Old Airport Road during the recent raids, a department press release said. The man had obtained the premises on lease, and over 60 registrations had been made, both under central and state jurisdictions of the GST Act, in the name of a number of persons for online

trading of Chinese made goods. Most of the registrations were



found irregular in filing of returns and payment of tax and a majority of firms either filed nil returns or did not file returns, the release said. The registration data showed that one business was registered in 2017-18, 43 in 2018-19, 14 in 2019-20 and 2 in 2020-21, the department said.

Most of the 60 firms were private limited companies and 24 persons were interchangeably directors in 58 firms. During the raid, neither

the Chinese national nor any of the other 59 registered taxable persons were available at the premises and none came forward to participate in the proceedings in spite of sufficient time being provided, the department said.

"It is learnt that the Chinese national is operating the business from Wuhan City since January 2020 with the assistance of some of his agents or employees in Bangalore. It is also learnt that multiple registrations are being taken for better rating on E-commerce platforms," Commissioner of Commercial Taxes MS Srikar said in the release

The warehouse has been sealed and an investigation initiated to ascertain the genuineness of the existence of all 59 registered persons, their transaction and tax compli-

the raids were carried out at Hussain's Khaiuri Khas residence and at companies allegedly controlled by his wife and children. The source had also disclosed that the four-storey building in Khajuri Khas is owned by Hussain and houses the office of Show Effect Advertisement Private Limited.

According to the ED, the suspended AAP leader is also the director of two more companies -Show Effect Worldwide Private Limited and Essence Cellcom Private Limited. The ED action comes almost three weeks after it registered a case of money laundering against Hussain, who is currently in judicial custody. The ED had registered a case against Hussain and the Popular Front of India for money laundering.

A special TADA court had sentenced him to life imprisonment. Yakub Memon, another Memon

brother who was arrested in the case, was hanged in 2015. At least 250 persons were killed

New Delhi, June 26: When Pradeep Kumar's wife was admitted to a government-run hospital in New Delhi for treatment of COVID-19, it took two days before she was able to see a doctor.

"There are six other women in her room and everyone is frustrated," he said outside New Delhi's LNJP Hospital. "They're behaving like they're leprosy patients.

Kumar's wife had just given birth when she found out she had the virus. She was told she would have to change hospitals and be admitted at one set up to handle coronavirus patients, an exhausting process that took hours.

Though leaders have promised coronavirus testing and care for all who need it, regardless of income, treatment options are as stratified and unequal as the country itself.



Since then annual rains have either covered India around June 15 or later than expected. Monsoon rains arrived on the southernmost Kerala coast on June 1. The Monsoon delivers about 70% of India's annual rainfall and waters nearly half of the country's farmland that lacks irrigation.

India is likely to receive above average monsoon rains for the second straight year in 2020, the IMD said in its revised forecast on June 1. IMD defines average, or normal, rainfall as between 96% and 104% of a 50-year average of 88 cm for the entire four-month season. Farmers plant crops such as rice, corn, cane, cotton and soybeans in the rainy months of June and July, with harvests from October.

BANK 'FRAUD' CASE

More trouble for Nath's nephew

New Delhi, June 26: Spelling more trouble for former Madhya Pradesh Chief Minister Kamal Nath's nephew Ratul Puri, the Central Bureau of Investigation (CBI) Friday carried out raids at multiple locations in Delhi and Noida in connection with the alleged fraud with the Punjab National Bank and other consortium of banks worth ₹787 A CBI official said, "Multiple

teams of the agency are conducting searches in Delhi and Noida at the premises of the accused, including Moser Baer Solar Ltd (MBSL) Directors Dipak Puri, Ratul Puri and others in a case related to alleged loss of ₹787.25 crore to PNB and other consortium of banks.'

The official said that the raids came in the wake of a case being registered on a complaint by PNB against MBSL and others, including its Directors and other un-



known persons and bank officials. In August 2019, the CBI had registered a case against Moser Baer India Limited (MBIL) and conducted raids at six places to nab its current and former officials for cheating the Central Bank of India to the tune of ₹354.51 crore.

According to the CBI, Deepak Puri, Managing Director of MBIL, his wife Nita Puri, whole-time director of MBIL, son Ratul Puri, former Executive Director of MBIL, Sanjay Jain, Director, Vineet Sharma, Director, and other unidentified public servants and private persons were booked on charges of criminal conspiracy for cheating, forgery and criminal misconduct.

Nita Puri is the sister of Madhya Pradesh Chief Minister Kamal Nath and Ratul Puri is his nephew. Ratul Puri was arrested by the Enforcement Directorate (ED) in connection with money laundering involving the ₹354 crore fraud with the Central Bank of India.

The ED had reregistered the case on the basis of the CBI FIR. Ratul Puri is also under scanner for allegedly receiving kickbacks in the AgustaWestland deal through his companies. The ED has alleged that accounts associated with firms owned and operated by Ratul Puri were used to receive kickbacks and launder money in the ₹3,600 crore VVIP helicopter deal. Ratul Puri was granted bail December 2, 2019.

RESCUE CALLS MULTIPLY

SNAKE CATCHERS ON THEIR TOES

Agra, June 26: As temperature rises, snakes, big and small, are coming out of their safe hideouts and entering urban space that is cooler and comfortable.

Expert snake catchers of the NGO Wildlife SOS have been busy answering distress calls almost on a daily basis. Multiple sightings of reptiles in Agra city has kept them on their toes. In June alone, the team has responded to over 30 reptile rescue calls, including a 4foot long monitor lizard that was found inside an air cooler.

The rising temperature has forced reptiles and other wild animals to venture out of their natural habitat in search of cooler places to seek respite from the



excessive heat. Earlier this week, the Wildlife SOS team rescued a 5-foot-long rat snake which was found coiled up on top of a car's spare tyre in Nikhil Garden, Taj Nagari Phase-2.

As chaos spread after the reptile was spotted, a team of rescuers from the NGO immediately rushed. After ensuring that all potential hiding places and escape routes were blocked off, the team carefully transferred the snake into a safe

In another incident, a 4-footlong monitor lizard was discovered resting inside an air cooler in a house in Friends Vihar, Dayalbagh. This was followed by the rescue of a python that was found wandering in the C-Impact Institute premises located behind Gokulam Water Park in Agra.

Wildlife SOS also rescued a King Cobra from a house in Hblock, Kalindi Vihar and a Wolf snake from Gayatri Vihar colony Sikandra. Kartick Satyanarayan, Co-founder and CEO of Wildlife SOS, said, "Snakes are cold-blooded animals so their body temperature varies with that of the environment. They are unable to selfregulate their temperature if it gets too warm and have to seek out cooler places to retreat to during daytime.'

Baiju Raj M.V, Director Conservation Projects, Wildlife SOS, said, "In this month alone, we have rescued more than 30 reptiles and the number is still on a rise. We are glad to see people taking the right measures and considering the well-being of these highly misunderstood reptiles by calling our helpline.

Jawan, minor boy killed in militant attack

Srinagar, June 26: A CRPF jawan and a minor boy were killed when militants attacked a security forces team in Anantnag district of Jammu and Kashmir Friday, police said.

The militants fired upon a road opening party of the CRPF 90 battalion near Padshahi Bagh bridge in the Bijbehara area of the south Kashmir district around 12 noon, a police official said.

He said a CRPF personnel and an eight-year-old boy were injured in the attack. The injured were taken to a hospital in Bijbehara where both of them succumbed, the official said.

The CRPF personnel has been identified as constable Shamal Kumar, while the boy has been identified as Nihan Yawar, a resident of Yaripora area of the neighbouring Kulgam district, he said. He said the security forces have cordoned off the area and a hunt has been launched to nab the attackers.

This UP man grows apples in guava land

Prayagraj (UP), June 26: Prayagraj, for as long as one can remember, has been known for its white and pink

But this year, a driver-turnedfarmer Rudra Pratap has accomplished a feat by growing in a climate not known to be favourable for the fruit. Rudra's apple orchard is located in Rampur village in Prayagraj and has about 35 apple trees that are bearing fruit for the first time.

Rudra Pratap said that he decided to have an apple orchard about five years ago when he inherited some land in the village. "I wanted to build a house here and have an apple orchard next to it. However, when I discussed it with others, in-



cluding my father, Keshav Bahadur Singh, a seasoned farmer, everyone made fun of me. They said that it was impossible to grow apples in this climate because the fruit needs a cold climate," he said.

Rudra was working in Mumbai as a driver when he met another driver from Shimla who gave him tips on apple farming. "Three years ago, I got 200 apple tree saplings of Hariman-99 variety and planted

them on my farmland but they failed to flourish and the trees wilted away. I did not give up and took the advice of an apple grower from Kashmir: We decided to cross breed by grafting with an apple variety called 'Anna'. "This clicked instantly and the grafts flourished within a year," he said.

Explaining how he protects his apple trees, Rudra said, "To protect the trees from moths, mites and other pests, I spray a safe pesticide procured from the local Jari market once a month. I irrigate the trees once every three days to ensure that they have adequate water and humidity using a submersible pump. To protect the trees from the hot winds that blow during summers, I have planted banana trees all

around the orchard and it seems to be working perfectly." His father, aged 75 years, helps him

in tending to the orchard. Rudra Pratap is now settled in Prayagraj while his sons are working in Mumbai and daughter is pursuing her MBA there. Meanwhile. Krishna Mohan Chaudhary, chief horticulturist at the Horticultural Experiment and Training Centre in Kushrubagh, said, "Rudra Pratap's efforts are praiseworthy. We have low chilling varieties of apples and efforts are on to grow them in plains, including UP. The quality of apples is judged by taste, texture and fragrance and only after checking these apples on those parameters, will we be able to determine the commercial value of the fruits."

Islamabad: Pakistan's COVID-19 patients will be around 225,000 by the end of June as compared to the estimated 300.000, a senior minister said Friday, as the country recorded 2,775 infections, the lowest single-day spike in coronavirus cases in about a month. Carlo Manuel said the 20 protesters staged a march and rally at a historic bridge near the presidential palace without a permit and defied orders when they tried to flee after being accosted. About 30 other protesters managed to flee, he said.

IS militant jailed

London: An Islamic State militant who encouraged mass murder in Germany has been sentenced to at least nine years in prison in Britain. Fatah Abdullah, 35, had been charged under Britain's terrorism laws with encouraging another person to plow a car into crowds, attack people with a meat cleaver and detonate bombs, "with the aim of killing and/or causing serious injury." The incitement took place between April 9 and December 11, 2018.

Bhutan rejects reports on water stoppage to Assam

"It is a deliberate attempt by vested interests to spread misinformation and cause misunderstanding between the friendly people of Bhutan and Assam," Bhutan's Foreign Ministry said

Thimphu, June 26: Bhutan Friday rejected media reports claiming that it has stopped the supply of irrigation water to farmers in Assam, terming them "totally baseless" and a "deliberate attempt" by vested interests to cause misunderstanding with India.

In a statement, Bhutan's Ministry of Foreign Affairs said that since June 24, 2020, there have been several news articles published in India alleging that Bhutan has blocked water channels that supply

irrigation water to Indian farmers in Baksa and Udalguri districts in Assam adjoining the country's Samdrup Jongkhar district.

Bhutan's statement came hours after Assam Chief Secretary Kumar Sanjay Krishna, in a late night tweet, termed the media reports as incorrect and said that the actual reason was natural blockage. "Recent media reports about Bhutan blocking water supply to India has been incorrectly reported. The actual reason being the natural blockage of informal irrigation channels

into Indian fields! Bhutan has been actually helping to clear the blockage," Krishna said.

His comments came in the backdrop of reports that hundreds of farmers from 25 villages of Assam's Baksa district along the India-Bhutan border alleging that the Bhutan government was not allowing farmers from the Indian side to channelise water from the Bhutanese side for irrigation.

The people of Bhutan, especially those living along the borders of India, "deeply value their age-old ties of friendship and cooperation with the people of India, particularly their close neighbors across the borders in Assam and West Bengal", it said, adding that such ties of friendship, cooperation and support must continue and be reinforced during these difficult times.

Since the lockdown in India and the closure of Bhutan's borders due to the COVID-19 pandemic, the Assamese farmers are unable to enter Bhutan to maintain the irrigation channels as was done in the past, it said.

sets qualities of these sectors." She also mentioned that the bank is regularly communicating to MSME units in state so that they can't miss any disbursement scheme. "We have written letters to 48,168 eligible existing MSME customers. In first phase, around 20,182 customers have already been benefitted," the CGM added.

SBI has achieved reasonable success under the e-Mudra scheme in the state. The bank has already disbursed ₹70 crore to 14, 603 customers.

To mark the MSME day June 27, SBI has planned to hold six etown hall meetings in the state to interact with the units. E-town hall meetings will be held in Bhubaneswar, Sambalpur, Berhampur and other cities.

SBI has also organised 24 webinars for MSMEs to create awareness about various schemes. Around 400 people participated the webinars.

According to its website, Microsoft has 83 stores worldwide, including 72 stores in the US, and several others abroad where they showcase and sell laptops and other hardware. Friday's announcement reflects what the company calls a "strategic change" for its retail business as sales increasingly shift online. Microsoft said it would "reimagine" the physical spaces at its four high-profile Microsoft Experience Centers in New York, London, Sydney, and at the company's headquarters in Redmond, Washington. Microsoft Corp. said the closures would result in a pretax charge of about \$450 million, or 5 cents per share, taken in the current quarter ending June 30. The company didn't say if the

Adani Power gets shareholders' nod to raise up to ₹2,500 cr

New Delhi, June 26: Adani Power Friday said it has got shareholders' approval for raising up to ₹2,500 crore in one or more tranches to sustain business growth and finance expansion plans. The company sought the ap-

proval at its annual general meeting (AGM) on Thursday.

All the resolutions proposed in the AGM were passed with requisite majority, the company said in a regulatory filing.

One of the resolutions sought authorisation of the board members to raise funds "to the extent of ₹2,500 crore or its equivalent in any one or more currencies, in one or more tranches, in such form, on such terms, in such a manner, at such price and at such time as may be considered appropriate by the board", it added

Manchester City's loss to Chelsea helps Liverpool claim Premier League title making an end to a 30-year drought

Liverpool, June 26: The 30-year wait is over. Liverpool are champion of England again. Liverpool clinched their first league title since 1990 Thursday, ending an agonizing title drought without the players even having to take the field.

Instead, the Premier League crown was secured when Chelsea beat second-place Manchester City 2-1, a result that means City can no longer catch Liverpool with seven games remaining.

For the city of Liverpool, this has been a party three decades in the making, and even the restrictions caused by the coronavirus failed to prevent fans from gathering to celebrate outside Anfield.

Only a few dozen supporters were outside the stadium as the final whistle blew at Stamford Bridge. But hundreds more quickly arrived, setting off flares and fireworks, waving flags and singing 'Allez, Allez, Allez' on the steps of

"It is such a big moment, I am completely overwhelmed," said Liverpool manager Jurgen Klopp, who was almost in tears as he spoke to broadcaster Sky Sports via video link. "I never would have thought it would feel like this. I had no idea."

After a dominant campaign that was interrupted by the coronavirus pandemic, Liverpool became England's earliest-ever champion – and the latest. No team since the inception of the country's league system in 1888 has clinched the title with seven games remaining. And no team has been crowned Premier League champion in June.

The title itself had hardly been in doubt since December, with Klopp's team quickly building a massive lead with a rampant attacking style of play that has earned 28 wins in 31 games so far.

"The world has watched the fierce determination of this club on the field for every single match," said John Henry, Liverpool's Americanbased owner. "The preparation, the resolve and the talent of those who put together perhaps the greatest league performance ever in any country's history.'

For a while, though, it seemed the coronavirus could still prevent Liverpool from ending its drought. The club was 25 points clear when the league was abruptly halted in March as the country was forced into lockdown to contain the spread of COVID-19

"Null and void" became the dreaded term in the red half of Liverpool amid fears the season could be canceled completely as the coronavirus death toll soared and clubs struggled to agree on a strategy to restart the league during

the country's gravest emergency since World War II.

After Liverpool finally returned to the field Sunday, a 0-0 draw in the Merseyside derby against Everton delayed the crowning moment. But

The team quickly rediscovered its scintillating attacking form as it swept aside Crystal Palace 4-0 Wednesday inside an empty Anfield.

Chelsea then put Liverpool over a winning line that had proved so elusive for a team accustomed to dominating English football in the 1970s and 80s.

After waiting so long to win a 19th English title, the pandemic left an anticlimactic cloud over celebrations on the hottest day of the vear so far.

Fans couldn't even gather in pubs, which have been shut since March, to watch Chelsea clinch the title for them. Gatherings of multiple households are also still banned inside.

The only communal viewing experiences allowed are for groups f up to six people to meet outside. Photos of garden viewings spread on social media. A few fans watched on phones outside Anfield.

Klopp, the German manager who has restored a winning mentality to Liverpool with his brand of "heavy metal" football, already led the club to the Champions League title last year. But this will widely be regarded as the moment he truly brought Liverpool back to the pinnacle of English football.

The last time Liverpool won the league, it was still called the First Division and the club held the English record for most titles with 18. But the inception of the Premier League in 1992 transformed the landscape of the English game.

Liverpool faded as a force, to be eclipsed by Manchester United. Sweeping to 13 Premier League titles, United manager Alex Ferguson succeeded in his mission of knocking Liverpool "off their perch" by helping the Mancunians become 20-time English champions and one of the wealthiest sports teams in the

financial survival in 2010 when the crucial moment – was hard to re-American ownership of Tom Hicks cover from. and George Gillett Jr. plunged the club into heavy debt.

The club was rescued — via High Court action — by new American investors from the Fenway Sports Group led by Henry, who added Liverpool to an investment portfolio that included the MLB's Boston Red Sox. It has been on a steady rebuilding path since.

The experiment of bringing back 1990-title winning manager Kenny Dalglish was short-lived, as its eighth-place finish in the league in 2012 was the club's lowest in 18

Within two years, the team was on the ascent again under Brendan Rodgers, finishing within two points of champion Manchester City in 2014. The anguish of coming so close to the summit before slipping up-literally, as then-captain Steven

Liverpool was even in a fight for Gerrard slipped on the field at a

A slump in form fired in 2015, which ushered in the arrival of Klopp. After a slow start, and another eighth-place finish, Liverpool regained its swagger.

Not even the sale of Philippe Coutinho to Barcelona in 2018 derailed Liverpool's ambitions. Instead. that money was reinvested wisely to ensure that the entertaining attack unit had a robust barrier at the back with then world-record fees paid for goalkeeper Alisson and center back Virgil van Dijk.

More frustration was to come, though. After leading the league for much of the campaign, Liverpool finished just one point behind winner Man City last season following one of the closest and most entertaining title races in history.

There was no stopping Klopp's team this time.

Bhuvneshwar said he always had the ability to bowl yorkers but delivering in crunch moments is something that he learnt after joining the Sunrisers squad back in

"I always had the ability to bowl yorkers but then I lost it. At Sunrisers Hyderabad, they wanted me to bowl at the start of the innings as well as at the end. The 14 matches I played in 2014, I learnt to handle pressure and that was a turning point," Bhuvneshwar told Deep Das Gupta 'Cricketbaazi' show. "I learnt new things, especially handling pressure at death bowling (during Sunrisers stint)," he said.

Bhuvneshwar, who has taken 132 ODI and 63 Test wickets, said he has been most successful whenever he has managed to detach himself from the outcome of the games like former India skipper MS $\,$

"Like MS Dhoni, I try to detach myself from the result and focus

on small things, which I also refer to as process. And this helps in getting the desired outcome. During IPL when I had a couple of good seasons, I was in this zone. I was so focused on my process, that the result had become secondary. And results were positive.

Talking about how is he keeping himself motivated while being away from the game due to the COVID-19 pandemic, Bhuvneshwar said it hasn't been easy.

"I was very motivated for the first 15 days of the lockdown. No one knew how long it would last and I didn't have any equipment to exercise at home either. We thought things would get better in a couple of months," he said.

"But after 15 days, I started finding it difficult to motivate myself. I then ordered equipment at home and things have improved since...I am working on coming out of this lockdown as a better version of myself. On-field performance is different, but I can work on my fitness, or my athletic ability, or gaining more strength," he added.

Davis Cup Finals in 2021

London: The Davis Cup Finals, which was to be held in November this year, has been postponed to next year due to the coronavirus pandemic, the International Tennis Federation (ITF) announced Friday. The venue for the tournament remains Madrid and will now be held from November 22, 2021. "The decision to postpone the event comes following a three-month review of the considerable logistical and regulatory challenges that have arisen as a result of the pandemic and all potential hosting scenarios with the health and safety of all involved of paramount importance," said ITF in a statement.

Fed Cup Finals in next April

London: This year's Fed Cup Finals have been rescheduled for 2021 because of 'challenges' related to the coronavirus pandemic. The International Tennis Federation says the women's team competition will take place April 13-18 in Budapest, Hungary. The 2020 event was originally scheduled for April but was postponed because of the pandemic. Officials had hoped to squeeze the competition in this year. The ITF says there are "significant logistical and regulatory challenges" to holding "an indoor mass gathering" at the Laszlo Arena. The tennis body says "guaranteeing the health and safety of all involved will not be feasible." The Fed Cup finals feature 12 national teams competing in a new format.
