## Cong taunts renegade

Jaipur, July 15: Claiming to have the support of 106 MLAs, Rajasthan CM Ashok Gehlot took an apparent dig at Congress rebel Sachin Pilot Wednesday. He said, "Speaking good English and being handsome are not everything in politics."

The Congress has sought the disqualification of Sachin Pilot and 18 other dissident MLAs from the state assembly even as it repeated that the party has not closed its doors on him.

Rajasthan Assembly Speaker C P Joshi confirmed that disqualification notices have been sent out Tuesday on the basis of the complaint made by the party. The dissidents have to reply by Friday.

Chief Minister Ashok Gehlot also talked tough, accusing the former deputy chief minister of being directly involved in the alleged horse-trading with the opposition BJP to bring down his government.

He did not refer to Pilot by name but spoke about the "deputy chief minister" and the "PCC president", both posts held by the leader before he was stripped of them Tuesday as he tussled with the more senior Rajasthan leader for power. **DOORS STILL OPEN** 

But, amid this tough posturing, the Congress said the dissident MLAs can still return to the Congress fold.



Avinash Pande the AICC in-charge of Rajasthan indicated this in a tweet in the morning and party spokesperson Randeep Surjewala followed that up while interacting with the media in the afternoon.

### **Resort housing rebels** turns quarantine centre

**NEW DELHI:** A resort in Haryana's Manesar near Delhi is claiming to be a 'quarantine centre' for coronavirus after Rajasthan's rebel Congress leader Sachin Pilot shifted there with MLAs supporting him. Its overnight transformation drew attention as the Congress challenged Sachin Pilot to "come out of the security cover" of the BJP government in Haryana and return to Jaipur. Mr Pilot, who set off a huge crisis for the Congress government in Rajasthan with threats of split - has denied any plan to join the BJP. The status update of the Best Western resort can be seen at its entrance, where the 'Quarantine Centre' sign has been put up. No visitors are being allowed inside.

## 52% identified public services go online

Adhere to timeline, do not ask people to run to office, Chief Secy tells senior officials

Bhubaneswar, July 15: Following Chief Minister's direction, several departments have so far made 52 per cent of 223 identified public services available online.

Chief Secretary Asit Tripathy Wednesday reviewed the online delivery of services in 21 major departments.

According to sources, five services of Steel & Mines department have gone online while all the 12 identified services in Social Security and Empowerment of Persons with Disability have been made available online. Similarly, all the three identified services in Women and Child Development department have been made online.

Similarly, in Panchayati Raj and Drinking Water department 13 out of 19 services have been made online while 9 of Excise department, 24 of Revenue & Disaster Management and 14 of Housing and Urban Development departments were made available online.

While complimenting the departments for the priority they have attached to adopt technology in governance. Tripathy directed the departments to complete the task well before the decided timeline.

He also directed the departments to ensure online delivery of all payments and benefits so that people are not required to run to government offices at different levels.

The issues relating to e-muster

roll application for tracking online payment of wage and entitlements to labourers by the contractors in different infrastructure as well as development projects of the government were discussed in the meeting.

Works Secretary Krishan Kumar informed the meeting that e-muster roll application has already been developed. It was decided that some projects under Works, Water Resources and Rural Development would be taken up on pilot basis for tracking through this new application to assess its effectiveness in real time monitoring.

The Chief Minister had earlier asked all the departments to make identified services online by October 2, 2020.

## Investigation sought into Nayagarh starvation death

Bhubaneswar, July 15: A petition has been filed with the National Human Rights Commission (NHRC) seeking its intervention in the alleged starvation death of a tribal woman in Nayagarh district.

Rights activist Pradipta Nayak has filed the petition alleging violation of human rights and right to food of Dukhi Jani, 46, a resident of Kaliamba village in the district who died June 24, 2020.

It was alleged she died after three days of starvation. To buttress his allegations, Nayak cited the report of a fact-finding team which visited the spot to enquire into the matter.

The petitioner stated that the tribal woman was deprived of benefits under several government schemes due to administrative apathy and also due to non-posses sion of an Aadhaar card.

"Her access to subsidised food was limited and irregular. Although

the victim had an Annapurna card sanctioned in March 2016, she had got the rice last November 2018. She was deprived of free rice since November 2018," the petition said.

"She was entitled to get pension as single woman but could not get it in spite of applying for it several times to local Panchavat and block officials out of administrative negligence's and apathy, the village people complained," it added.

It was also alleged that the deceased neither had a job card under MGNREGS nor had Jan Dhan account which could have helped her with direct cash support provided by the Union government during Covid-19 lockdown. 'She also did not get the rice and

dal provided under PM Garib Kalyan Yojana. She presumably did not have a ration card. The factfinding team members who spoke to the villagers said in spite of approaching panchayat and block officials, the woman could not get a ration card under Antyodaya Anna Yojana as she did not possess an Aadhaar card," the petition said.

The petitioner has sought an enquiry by the district administration in this regard and sought stringent punishment to the officials whose lapses caused deprivation

Bhubaneswar, July 15: Almost 67 per cent of the state's total coronavirus infected have recovered, data from the state government

Bhubaneswar, July 15: The state government Wednesday fixed maximum price of ₹450 (excluding GST) for conduct of one antigen test in private healthcare facilities.

"The upper price cap of ₹450 (plus GST as applicable) as specified by the Indian Council of Medical Research (ICMR) for each standard Q COVID-19 Ag kit of the vendor, SD Bio Sensor must be adhered to by all private facilities complying to the prevailing ICMR norms," Health and Family Welfare department said in a notification.



The government has asked all private healthcare facilities, which will conduct the rapid antigen test or the TrueNat tests, to strictly follow protocols prescribed by ICMR.

A rapid antigen test is a rapid diagnostic test suitable for pointof-care testing that directly detects the presence or absence of an antigen. This distinguishes it from other medical tests that detect antibodies (antibody tests) or nucleic acid (nucleic acid tests), of either laboratory or point of care types.


## ₹15L worth mobile testing van to Ganjam from NY with love

## NGT ORDERS PROBE BY JOINT PANEL SAUBHAGYA YOJANA FLOPS

Jajpur/Balichandrapur, July 15: Even as illegal sand mining continues at several river ghats under Vyasanagar tehsil in Jajpur, the National Green Tribunal (NGT) has ordered formation of a special squad to look into the ilelgal sand mining at Madhupur ghat of Kharasrota river, a report said.

Locals are strongly opposed to unauthorized sand mining at the ghat. They had repeatedly approached the tehsildar, but to no avail. Upset over inaction against the sand mafia, locals had moved the NGT a few days ago.

The NGT registered a case (48/2020/EZ). A division bench comprising Justice SP Wangdi and expert member D Nagin Nanda ordered a probe by a special committee into alleged illegal sand mining in Kharasrota river.

As per the directive, the committee will comprise the District Collector, the deputy director of mines, and a representative of Odisha State Pollution Control

The committee has been asked to investigate unlawful sand mining in the river and submit a report to NGT within two months, i.e., August

The NGT observed that if the allegations on illegal sand mining stand verified during the probe, the committee should initiate necessary action on illegalities and seize the machinery and vehicles ILLEGAL SAND MINING IN KHARASORTA RIVER

The Bench said, "We deem it essential to constitute a committee comprising Jaipur Collector, and Odisha State Pollution Control Board (OSPCB) and the deputy director of mines who shall jointly inspect illegal sand mining, verify the factual aspects and submit a

It may be noted here that the NGT had earlier issued a similar order regarding the alleged illegal sand mining at Sanla ghat pf Baitarani river.

This is the second order of the

NGT on illegal sand mining in the district within a month.

Locals alleged the regulatory authorities have failed to curb the illegalities and violations of pollution norms, conditions of environmental clearance for sand mining at Madhupur ghat.

Pinak Ranjan Das, a resident of Madhupur, has moved the case in NGT though his counsel Shankar Prasad Pani.

Das in his petition alleged that due to rampant illegal mining of sand, the state government has been suffering huge revenue loss while it has affected the natural flow of water

in the river, thus disturbing the ecological balance in the area.

Moreover, transportation of sand in heavy vehicles has left roads of the riparian villages in bad shape, due to which locals have to face commuting woes.

The embankments have weakened due to operation of sand-laden heavy vehicles. The next hearing of this case was fixed September 2,

Conctacted, Vysanagar tehsildar Sarat Chandra Mohapatra said he has not yet received the NGT order and is not aware of sand mining at Madhupur ghat.

All preliminary works like installation of a transformer, utility poles and drawing wires have been completed but the residents reel under darkness at night in the absence of power. The residents have repeatedly drawn the attention of power officials to their plight but their pleas are yet to be addressed. In the absence of power supply, the villagers have to live in darkness after evening and had to manage with oil lamps to perform their household works.

Village women Lakshmi Pradhan, Jira Pradhan and other villagers alleged that the power department of-



ficials visited their village in 2017 and informed them about their names being included under Saubhagya Yojana for power supply to their households.

Soon, a new transformer and poles were installed and wires drawn for power supply to the households. Even meters were installed and consultancy agency collected ₹300 from each household for power supply. Since then, three years have passed but their houses are yet to get power supply.

The villagers alleged as their village is in a forest area they rush indoors after evening descends. The worst-hit are the children who find it hard to study in the absence

of power supply. The villagers have run out of their patience waiting for power supply over last three years. They have warned an agitation if their houses are not connected with power supply at the earliest.

Sarpanch Nabkishore Sahu said both the junior engineer and the consultancy agency have been informed in this regard. When contacted, Umakant Majhi, junior engineer, said the consultancy agency has completed 90 per cent of the works and the households will get connected with power supply as soon as the rest of the work gets com-

## Good campaign, bad campaign

ne of the silliest things on the internet is an international site called change.org. The owners have offices in a number of countries and the mandate seems to be that anyone who has a grievance, and wants it redressed, can list an issue and get signatures on it. These will be sent to a bureaucrat/politician through email.

When change.org reached its peak some years ago, I received hundreds of emails ranging from "India should not be violent on women" to "Sanitary towels should be tax-free" and, of course, many animal issues. Every three days, the issues would change and very often they were complaints of a generic nature which no one person or system can deal with.

Very often they were sent to the wrong target. When I was new in office, I responded to one of these campaigns and the end result was that the head of change.org got awards for being one of India's best change-makers - even though she had nothing to do with it at all, except stand with me for photo ops. No research ever went into any issue. Just one line complaints which died out in a few days and were replaced by another. After a while, I started erasing them as soon as they appeared on my email and now I don't receive them anymore. I was the only minister/bureaucrat who ever read a change.org email. The site had no impact on policy change or action. But it did have a really bad impact on the average computer user: everyone who signed these petitions - and it was often the same people signing every petition on the computer – felt they had done their bit for the world. By merely clicking a link, to send an electronic signature somewhere, one got the feeling of having done something

Unfortunately, change.org has become institutionalised in many forms by animal welfare sites. 'Maneka: sign this to save the dolphins in the Faroe Islands; sign this to save the wild hares in Scotland; sign this to stop monkey export from Mauritius...' I must have signed thousands of these. What happened to the issues and where these signatures went - no one knows. The only difference, between me and perhaps others who signed, is that I do many other things on the ground to save animals, and the only reason I sign is because I feel a deep need to keep up the spirits of animal welfare organisations, by making them believe that someone is looking at their sites!

Kerala is perhaps the worst state when it comes to elephant torture and killing. And the forest department is completely indifferent to any complaint. Kerala elephants attract the most attention from signers. Every time someone highlights an elephant being tortured, hundreds of emails from desk jockeys pour in to me. They probably go to the officials in Kerala but, I believe, till today no officials read their emails. And, of course, no

politician does. It is going to take at least another five years for anyone in government to read, and respond, to anything a citizen has emailed about. There is complete institutional indifference to the general/generic email.

And organisations that host these petitions on their site are simply using this to collect names for fundraising appeals.

So, what can you do to actually save an animal and bring about change? How do you become an actual animal advocate and expose cruelty, corruption, and incompetence? How do you save an animal in your area, or change a policy creatively and seriously?

Find out and keep the phone numbers, and personal emails, of all the local administrators: DMs, SDMs, the head of the police, the local thana, the MP, the MLA, the corporator, the zilapanchavat member, the local veterinary officer. the forest office, and the three main press reporters, and use these numbers liberally when you need help. You can follow this up with calls and emails directly to the person.

Make a group. This means finding people in

to the world your area who want to help animals. Go to schools. colleges, your neighbourhood, the local lawyers and teachers. Put small handmade flyers up, asking people to contact you. Take this group to see the officials, and the press, regularly. You want an SPCA and animal ambulance in your district? You need to keep hounding everyone in the local administration till you get it. It may take months, but the results will be permanent. You need a temple to stop using elephants? Keep complaining to the temple and the administration – and, of course, the press, with photos and write-ups. Picket it, stand outside the house of your MP and MLA, and don't let go till they respond. A small determined group can bring about a change. The police are the worst. They take crime against animals lightly and most policemen don't even know the laws. This allows criminals, smugglers, pet shops, breeders, animal beaters, to carry on – especially since the police often use the complaint to extort money from them. If the thana does not listen, go to the SP. If he doesn't go to the local court, get an order. If this doesn't work, go back to the court and file for contempt. If you can make a noise in just two cases, no matter how much time it costs you, you will automatically be heard in the third.

For instance, khokhas (roadside cages), holding chickens for slaughter. are illegal under the Municipal Act. Get them removed in your area. An SPCA and animal hospital/ambulance is mandatory by law. Get it made. All pet shops are now illegal unless they are licensed by the Animal Welfare Board. Get them closed. All bird markets are illegal, no matter which birds they sell. Picket them – as I did the local bird market in Nakhas, Lucknow – and got them closed down. A single girl of ours, Swati Dikshit, has been doing all this in Bhopal and, within two years, the bird markets have reduced substantially and the police are helping her. The birds come in illegally from West Bengal-now the railway authorities are stepping in with her to stop this trade.

Go viral locally. Collect emails of local people all the time. This is your wealth. If a local or national company does something that you know is cruel. get on to your net and Facebook and Twitter/Instagram, and condemn them to the world. This will get back to them. Use your social media liberally so that when you speak, people listen. Since the government has destroyed Veterinary Council of India over last five years, there is no institution of redressal against vets that don't know their jobs and cheat on medicines, misdiagnose and often kill animals. I know one vet who inserted a steel rod inside a pregnant cow's uterus to get the baby out. Another who gave a dog 11 injections, for a skin problem, and killed it. Both were sacked. Start shaming them on internet and write to everyone you know in your district.

The last thing that companies, institutions, and prominent individuals, who are heavily dependent upon maintaining a positive public image to sell their product, want is bad publicity that often goes viral. Keeping the spotlight on them is an effective approach to reducing animal suffering. But don't make up stories. Donate, donate and donate all the time. The money you get from the Kabari (the person you sell old newspapers to), the money you save from not going to a movie or not eating a snack, a tenth of your income. Give it first to the people in your area who feed animals. Or, give them food: grains for birds and rotis for dogs and cows. They will feel so much better at being supported that they will get more courage to face the wicked people who abuse them daily. Then donate to people who run shelters. Even though you may feel alone, a student living in PG digs in an alien city, you know at least six people and, if you follow these steps, your words can have a ripple effect that bring about change. Look at how the vegan movement has suddenly spread. In the words of Animals 24-7 "The word 'vegan' went within the space of just one generation from being completely unfamiliar to most consumers to becoming one of the most-used product descriptions in supermarkets. It was not multi-million-dollar mass media ad campaigns that made plant-based diets fashionable. The food industry, fixated on marketing meat, dairy, and egg products, did not jump on the vegan bandwagon until it was already rolling down the aisles, emptying shelves of vegan food items with nothing more than the momentum of word-of-mouth, friend to friend."

## **NINE OR TEN DASHES**

HISTORICALLY, **CHINESE MAPS GAVE LITTLE IMPORTANCE TO THE SOUTH CHINA SEA. THIS CHANGED IN 2009 WHEN CHINA ATTACHED A MAP WITH THE INFAMOUS NINE-DASH LINE IN ITS SUBMISSION TO** THE UN, **RELATED TO A DISPUTE WITH VIETNAM** 

The United Nations Convention on the Law of the Sea (UNCLOS) defines the rights and responsibilities of nations with respect to their use of the world's oceans, establishing guidelines for businesses, the environment, and the management of marine natural resources. It replaced the quad-treaty 1958 Convention on the High Seas. This is by far the best codification of customary international law.

During the UNCLOS negotiations, China was still finding its feet in the international theatre. At that time, the brief given to the Chinese delegation consisted of three principles: support antihegemony (i.e. be against US and USSR), support the Third World and protect the national interest. During the negotiations, China being grateful to the Third World for their support in deciding its membership in the United Nations put its national interest temporarily in the backburner.

Now, China sees itself as the big loser in UNCLOS due to its unfavourable geographic location. Earlier, China used to emphasise its advantage due to its long boundaries and coastlines as well as its large natural resources. Lately, it has realised that notwithstanding its approximately 18,000-km coastline, China's geography inhibits it from achieving its maritime hegemony. As China's coastline opens into four seas (the Bohai, Yellow, East China, and South China Seas) which are enclosed by island states and not oceans, China's maritime space is inhibited due to lack of breadth. As a result, in accordance with the provisions of UNCLOS, China would have to share its maritime space with these littoral states. Among these, the South China Sea offers more space, but it is enclosed by nations with their own sovereignty claims in that maritime space.

Historically, Chinese maps gave little importance to the South China Sea. This changed in 2009 when China attached a map with the infamous nine-dash line in its submission to the UN, related to a dispute with Vietnam. They are so pedantic about this that, now, Chinese passports are emblazoned with a map with nine dashes through the South China Sea which

further includes a tenth dash to include Taiwan. These dashes hug the coasts of other Southeast Asian nations more closely, giving China an even more expansive claim to the waterway. This is the heart of the South China Sea dispute and China claims almost 90 per cent of this area. Interestingly, the line runs almost 2000km from the Chinese mainland and within a few hundred kilometres of the Philippines, Malaysia, and Vietnam. In addition, China insists that it owns all land or features contained within the line through its vague "historical maritime rights".

If, in today's world, China's claims are considered valid, then what prevents other countries including India (from Kalinga, Pallava and Chola times, or even earlier) from digging into history to do the same? This would result in utter chaos and anarchy.

While being a signatory to UN-CLOS, China has never defined the legal meaning of the nine-dash line or what its "rights" are within the boundary. This ambiguity, probably intentionally, is to fool the ordinary Chinese people into believing that the line marks China's maritime boundary. This is not surprising as China of today is well-known for its duplicity and deceit.

In 2013, the Philippines petitioned an international tribunal within the Permanent Court of Arbitration, in The Hague, to rule on the legality of China's ninedash line under UNCLOS. The tribunal ruled that China's nine-dash line claim and accompanying claims to historic rights had no validity under international law. The tribunal also concluded that. China's historic rights to resources in the waters of the South China Sea were extinguished as they were incompatible with the exclusive economic zones provided for in UNCLOS. In addition, the tribunal ruled that Chinese reclamation activities of building artificial islands were illegal under UNCLOS. Notwithstanding the ruling, China immediately clarified that it does not accept the result or legitimacy of the tribunal's award and would continue its activities in South China Sea unhindered.

China's negotiation of UNC-LOS and its present implementation of the provisions thereof provide a good case study to understand its foreign policy making and its attitude toward international laws and treaties. In contrast, the United States which was the original architect, while not yet being a party to UNCLOS, has accepted and complies with nearly all the treaty's provisions.

After abrogating term limits for a leader, President Xi Jinping at the National People's Congress in 2018 outlined his vision for a rejuvenated China leading the world order as a superpower rivalling the United States by 2049. Here, one cannot help but recall Deng Xiaoping's definition of a superpower as an imperialist country which every-

where subjects other countries to its aggression, interference, control, subversion, or plunder and strives for world hegemony. He also went on record at the United Nations in 1974: "If one day China should change her colour and turn into a superpower, if she too should play the tyrant in the world, and everywhere subject others to her bullying, aggression and exploitation, the people of the world should identify her as social-imperialism, expose it, oppose it and work together with the Chinese people to overthrow it."

As China turns the script of 'peaceful rise' on its head, it has forced nations into strategic reversals. Vietnam and the Philippines have criticised China that the military drills in the South China Sea were a violation of sovereignty and could be detrimental to Beijing's relationship with ASEAN. Considering the foregoing, the question that comes up is, how the world, and India in particular, will deal with this situation?

Bearing in mind that China has been acquiring various maritime assets around India popularly known as Garland of Pearls, the time has come for India to cooperate with the littoral states in the South China Sea and form its own Garland of Coalition to assist them reclaim their due maritime jurisdiction in accordance with established customary international law.

Furthermore, reciprocity is synonymous with diplomacy, where there always is a give-and-take. For far too long, India has towed the Chinese line relating to the 'One China Policy' without get ting anything in return. It needs to be conveyed that if they expect India to accept the 'One China Policy', then it must reciprocate with 'One India Policy' -ie, accept POK and Gilgit Baltistan as an integral part of India and return the annexed area of Aksai Chin.

Finally, the world should unite in making China aware that there is space for peaceful coexistence but not submissive behaviour as a Middle Kingdom's tributary and that it probably has bitten off more than it can chew.

## Scary predictions far from realities

A PREDICTION ON **COVID-19 SPREAD WILL HAVE SOME MEANING IF IT IS MADE FOR TWO WEEKS AT A TIME** 

wo MIT professors along with a doctoral student have calibrated Covid-19 data on testings, reported cases, reported deaths, and overall mortality from 84 nations. The team included India, but not China, while making a projection vis-à-vis the pandemic's spread by February next year. As per this, there will be a daily addition of 2.87 lakh infections in India by February next year; and 249 million infections and 1.8 million deaths by March, 2021. Prima facie, these are sensational projections.

Granted that there is a chance of a serious worsening of the Covid scenario, people are well-advised to take care, observe norms like social distancing, mask-wearing, stay-athome, and frequent washing of hands. Yet, while we respect MIT, its projections cannot be taken at its face value. There obviously are lacunae in the way figures were

The team made the prediction conditional to a situation wherein there is no vaccine or drug till date. But, several labs and nations are actively striving to come up with both. India too has its works ongoing in labs. India has marketed two/three drugs by now for moderate attacks. Plasma therapy is coming up as suggested by India.

The researchers did the work through Mathematical Modeling by taking S (Susceptible) E (Exposed) I (Infectious) and R (Recovered) as basic parameters. Mathematical Modeling can be accepted if several parameters are taken into account, but they ignored the other parameters like how the governments would respond to the situations and how the community would behave.

The team has not relied on parameters like concentration of Covid-19 cases in some countries,

The same model cannot be applicable to such different scenarios. For instance, Dharavi and less-affected areas cannot be bracketed together. Also, the effect of the lockdown and shutdown would need to be considered. The higher average immunity of Indians is a major aspect that was ignored in this study. The researchers stated that the

infections could stand at 60 crore if the contact rate is taken as 8 per infected. The usual contact rate, however, is accepted as 2.58. This itself will bring down the team's global infection projection to only a few crores, and much less than the predicted 25.5 crore. The team has accused governments of all countries of hiding the actual figures, and saying that, otherwise, the cases by now could be 11.48 times more than the reported infections and an additional of 50 per cent more deaths. In India, for instance, such a hiding is not possible as the media and other agencies are closely tracking the ground situations.

The researchers said that by increasing testing by 0.1 per cent every day, the cases will decline from 1.55m to 1.37m. This is a marginal decrease. Some 0.1 per cent of the population for India would mean 13 lakh. Now India is doing around 3 lakh tests per day. By increasing the tests to 13 lakh to reduce infection by 2 lakh is, of course, one way. No country can do testing on such a massive scale.

Usually, Covid predictions are going haywire. A March prediction by an international team of scientists, including from the Johns Hopkins University, was that India could be saddled with between 1 lakh and 13 lakh confirmed cases of the novel coronavirus by mid-May. But, by May, India had only 2,000-4,000 cases. Another prediction was of 5.5 lakh infections for Delhi in July, though in reality this figure now stands only around 1 lakh.

A prediction on Covid-19 spread will have some meaning if it is made for two weeks at a time. The complicated variations depending on several parameters cannot be drawn at a time for longer term.

### Online study, problems

Sir, A long-awaited speculation on online education for schoolchildren is about to settle down soon. Since the closure of schools from March 16 due to the Covid-19 pandemic, classroom teaching has been halted in schools, colleges and universities. And immediate switch-over to online education was not possible in India. Undoubtedly, through trial and error method, various schools, state governments, colleges and universities are maximising their efforts to provide online classes. ## Clamour grows for national park tag to 'Amazon of the East'

Guwahati, July 15: The Assam government's decision to upgrade the Dehing Patkai Wildlife Sanctuary into a national park has enthused environmental conservationists and activists but with this the long-standing demand to encompass the entire 500 sq km of the contiguous rainforests, known as Amazon of the East, within its ambit has gathered momentum.

Conservationists have been demanding that the government include the adjoining reserved forests connected with the existing wildlife sanctuary like Joypore reserved forests, Upper Dehing East Block and the Upper Dehing West Block to the proposed national park.

Prominent personalities of the state like actor Adil Hussain, singer Papon, musician Joi Barua, former Axom Xahitva Xabha chief Parmananda Rajbongshi, author and journalist Anuradha Sarma Pujari and artist Dadul Chaliha have also been appealing to the government to include the reserve forests within the proposed park.

Ethnic communities of the villages surrounding the reserve forests has also extended their unstinted support to this entire movement.

Last week, Assam Chief Minister Sarbananda Sonowal issued a directive to upgrade the sanctuary into a national

### Call of conservationists

The process has just begun and all factors will be considered before the final notification is issued.

Sonowal had directed the forest department to prepare an action plan for upgrading the sanctuary into a national park in consultation with the Union Ministry of Environment and Forests.

Dutta said measures must be initiated immediately to bring in infrastructural development within the forests by setting up sufficient protection camps, construction of bird watching towers, employment of more forest guards and strengthening the manpower required, upgrading the Digboi and Dibrugarh wildlife forest division, among others.

He also said that the stretch declared as a elephant corridor instead of including it as a part of the sanctuary is also not secure as elephant reserves do not enjoy legal sanctity similar to a wildlife sanctuary.

He demanded that the draft of the Dehing Patkai Wildlife Sanctuary Ecosensitive Zone prepared by the Union Ministry of Environment, Forest and Climate Change and notified in May 2019 should be immediately scrapped and a fresh one be drafted following the chief min-

Soumyadeep Dutta, director of environmental organisation Nature's Beckon. It is imperative that the entire stretch

is included within the proposed national park territory to save it from further destruction, he said. "We welcome the chief minister's ini-

tiative but area expansion is a must and a concerted campaign has been launched through various media, including the social media, to highlight the need to include the entire stretch of the three reserved forests within the proposed national park,"

Nature's Beckon along with the people of the villages surrounding the forests has spearheaded the movement for the protection of rainforests since the late 80s and has been emphasising the need to include the entire stretch within the wildlife sanctuary to protect the surviving patches of forests, he said.

'Tea gardens, village settlements, de forestation, oil and coal exploration had irreversibly destroyed the previously contiguous rainforests and most of the sur viving patches existed in isolation from each other, therefore slowly and progressively losing the extraordinary characteristics that define a rainforest. A glimmer of optimism has now emerged and we now hope that the entire stretch will be included," he said.

These reserved forests though separated by different administrative divisions, are in reality, one undivided and continuous stretch of rainforest and the species diversity of this entire stretch is so overwhelming that we have to preserve this pristine rainforest from the clutches of the exploiters, Dutta said.

Bibha Talukdar, secretary general of another conservation group Aaryanak has also called for inclusion of the three reserved forests within the proposed national park area.

## 50 days on, gas well fire likely to be doused

Guwahati/Dibrugarh, July 15: Energy major Oil India Limited (OIL) Wednesday said the blaze at the damaged Baghian gas well in Assam has continued unabated for 50 days and the final push to extinguish the fire will begin soon.

A senior official of the PSU told PTI that the fire is expected to be doused by Friday.

Major debris from the well plinth area has been cleared and a detailed inspection was undertaken jointly by experts from OIL, ONGC and Singapore's Alert Disaster Control to decide the next course of action.

"The main operation for capping and killing the well is yet to begin. The well continues to be on fire," the oil exploration major said on its official Twitter handle.

Describing a report published in an English daily that the fire has been extinguished as "factually incorrect", the company said the debris has been removed from the well site and preparations are on for the well capping operation.

Well number 5 at Baghjan in Tinsukia district has been spewing gas uncontrollably since May 27 and it caught fire on June 9, killing two firefighters of the OIL at the site.

Giving an update of its efforts to put out the massive flame, the OIL said, "Equipment being placed at Kill Pump area at the site... activities are on for carrying out the well capping and killing operation."

Later, the company said in a statement that the water reservoirs are



being filled up periodically and three heavy duty pumps of the ONGC and OIL are ready for use.

Meanwhile, protests and blockades were being staged by locals leading to heavy production loss in the last few months, the company said.

## India conveys strong message to China

New Delhi, July 15: The Indian military conveyed a "very clear" message to the Chinese army during a nearly 15-hour-long talks that status quo ante must be restored in eastern Ladakh and it will have to follow all mutually agreed protocols for border management to bring back peace and tranquility along the Line of Actual Control, government sources said on Wednesday.

During the course of the intense and complex negotiations between senior commanders of the two armies that ended at 2 am on Wednesday, the Indian delegation also apprised the Chinese PLA about the "red lines" and conveyed that the onus was largely on China to improve the overall situation in the region, the sources said.

The two sides agreed on certain modalities for rolling out the next phase of disengagement and are expected to get in touch with each other after discussing agreed points with the higher authorities of both sides, the sources said.

The fourth round of Lt Generallevel talks began around 11 am Tuesday at a designated meeting point in Chushul on the Indian side of the LAC, they said. There was no official word on the outcome of the talks.

The Indian delegation was led by Lt Gen Harinder Singh, the Commander of the Leh-based 14 Corps, while the Chinese side was headed by Major General Liu Lin, Commander of the South Xinjiang military region.

Army Chief Gen MM Naravane was apprised about the details of the negotiations following which he

During this round, both sides agreed on an "expeditious, phased and step wise" de-escalation as a "priority" to end the standoff.

The sources said the main focus of the latest round was on finalising a framework for a "time-bound and verifiable" disengagement process from all the friction points like Pangong Tso and Depsang and pulling back large numbers of troops and weapons from rear bases along the LAC as part of modalities for further de-escalation

### **ARMED FORCES GET SPECIAL POWERS**

New Delhi, July 15: In view of the border row with China in eastern Ladakh, the defence ministry on Wednesday granted special powers to the three services for individual capital procurement programme worth Rs 300 crore to meet emergent operational requirements, officials said.

They said there was no cap on the number of procurement programmes and that each acquisition under the emergency requirement category should not cost more than Rs 300 crore.

The decision was taken at a meeting of the Defence Acquisition Council (DAC) headed by Defence Minister Rajnath Singh.

"The DAC delegated the powers for progressing urgent capital acquisition cases of up to Rs 300 crore to the armed forces to meet their emergent operational requirements," the defence ministry said in a statement.

The decision, it said, will shrink the procurement timelines and ensure placement of orders within six months and commencement of deliveries within one year.

It said the special meeting of the DAC was convened considering the prevailing security environment along the northern borders and the need to strengthen the armed forces for the defence of the country's borders.

The three services have started buying a range of military equipment, weapons and platforms in the last few weeks in the midst of the tense border row with China

## Police botch up rescue op

"However, the police are now saying that they are clueless about the whereabouts of the kidnappers as well as my son," Singh said. A video

Senior Superintendent of Police (SSP) Dinesh Kumar Prabhu, said: 'I am looking into the investigation of this alleged kidnapping case registered at Barra police station. Our priority is to rescue the hostage.

He further said that separate teams have been formed and further investigations were on to trace the criminals and rescue the victim. SSP also assured to investigate the role of the police and said that if found guilty, they will face strict action.

### IIT Delhi develops most affordable Covid test kit

New Delhi, July 15: Claimed to be the world's most affordable diagnostic kit for coronavirus, a low-cost test kit developed by the Indian Institute of Technology

(IIT) here was launched Wednesday.

According to IIT officials, the base price of the RT-PCR assay developed by IIT Delhi is Rs 399. Even after adding the RNA isolation and lab-

oratory charges, the cost per test will go upto Rs 650 and will be considerably cheaper compared to currently available kits in the market. It can deliver results within three hours.

HRD Minister Ramesh Pokhrival 'Nishank' launched the test kit named "Corosure" which will now be available for use at authorised testing labs. "The Corosure Kit has been developed indigenously and is much cheaper

than other kits. The country requires cheap and reliable testing for the country which can help control the pandemic. The kit has received ICMR approval with the highest score and DCGI approved with a very high sensitivity and

specificity,' he said at the launch.

The airline's board of directors have authorised its Chairman and Managing Director Rajiv Bansal to send employees on LWP "for six months or for a period of two years extendable upto five years, depending upon the following factors - suitability, efficiency, competence, quality of performance, health of the employee, instance of non-availability of the employee for duty in the past as a result of ill health or otherwise and redundancy", the order said on Tuesday.

The departmental heads in the headquarter as well as regional directors are required to assess each employee "on the above mentioned factors and identify the cases where option of compulsory LWP can be exercised", stated the order dated July 14.

"Names of such employees need to be forwarded to the General Manager (Personnel) in headquarter for obtaining necessary approval of CMD," the order added. In response to queries regarding this matter, Air India spokesperson said, "We would not like to

make any comment on the issue. Aviation sector has been significantly impacted due to the travel restrictions imposed in India and other countries due to the coronavirus pandemic. All airlines in India have taken costcutting measures such as pay cuts, LWP and firings of employees in order to conserve cash flow.

For example, GoAir has put most of its employees on compulsory LWP since April. India resumed domestic passenger flights from May 25 after a gap of two months due to the coronavirus pandemic. However, the airlines have been allowed to operate only a maximum of 45 per cent of their pre-COVID domestic flights. Occupancy rate in Indian domestic flights has been around 50-60 per cent since May 25. Scheduled international passenger flights continue to remain suspended in India since March 23.

## Delete FB account or quit Army, Delhi HC tells officer

New Delhi, July 15: A division bench of the Delhi High Court has refused to grant relief to a senior army officer, who had pleaded against the order of the Indian Army to ban its officers from using social networking platforms.

"If Facebook is so dear to you, then put in your papers. You'll have to make a choice," said the division bench presided over by Justices Rajiv Sahai Endlaw and Asha Menon on Tuesday.

The officer had approached the court on Monday against the Indian Army's order banning the army officers from using social networking platforms like Facebook, Instagram,

The court said he has to take a decision and also asked the army official to delete his FB account as the policy to ban the use of social net-

working platforms for army personnel was initiated keeping in view the national security of the country.

"The question of granting any interim relief does not arise, especially when the matter has the potential of concerning the safety and security of the country," the bench said.

The observations came in while the court was hearing a petition filed by Lieutenant Colonel P. K. Choudhary which sought the court's direction to the Director General of Military Intelligence (DGMI) to withdraw its policy which had ordered the officials of the Indian Army to delete their accounts from social networking platforms like Facebook and Instagram.

During the hearing, Choudhary contended that once deleted all the data, he would loose all his friends and contacts which are there on MATTER OF CHOICE

Keeping in mind the new work culture and the new nature of jobs, the country's youth are increasingly adopting new skills, Modi said in his video address.

"Several people ask me that in today's time, business and markets change so fast that they do not understand how to remain relevant. In this time of corona (virus), this question has become even more important. "I have only one answer. The mantra to stay relevant is -- skill, re-skill and upskill," the prime minister said. Modi was of the view that skill is

something which we gift to ourselves, which grows with experience. "Skill is timeless, it keeps getting better with time. Skill is unique, it makes you different from others. Skill is a treasure that nobody can take away. And, skill is self-reliance, it not only makes one employable but also self-employable," he noted. "Whenever any complaint was received, we took action against the accused leaders and party workers. We have either suspended or asked them to return money. We have zerotolerance towards corruption," a senior TMC leader said. Several local

level TMC leaders were recently expelled from the party for their alleged involvement in corruption and nepotism, he said.

West Bengal Chief Minister and TMC president Mamata Banerjee recently said that her government was rectifying the "lapses" which might have occurred in its effort to pay the compensation to the cyclone-hit victims quickly.

She had earlier warned a section of the party leaders of stern administrative action for being involved in corruption over the distribution of relief materials to the cyclone- affected people and said the party wouldn't stand by the wrongdoers. ## Kashmir's carpet industry facing decline

Srinagar, July 15: The iconic carpet industry of Kashmir is facing a sharp decline forcing most carpet weavers to take up odd jobs for earning their livelihood.

At Gada-khud village in Bandipore, 30 kms from Srinagar, the majority of the 400 households are carpet weavers. But with most handlooms shut the carpet weavers have taken up menial jobs. The weavers say demonitisation, abrogation of Article 370 and the economic downturn due to ongoing pandemic has dealt a big blow to Kashmir's multicrore carpet industry.



For years Nazir Ahmad with five of his family members have been weaving carpets at a handloom in their house. But with hardly any buyers during the last one year they have stopped making carpets.

'We are facing major losses and not able to earn anything. We haven't made a single carpet in the last one vear." Nazir Ahmad said. "We don't get good rates for carpets, so we have stopped making carpets."

The acute financial crisis has forced Nazir Ahmad's son Mohammad Hussain to move to Srinagar to work as a labour. "There is no other option for me. I earn ₹400 daily as a labour which is barely enough to meet the expenses

of the family," says Hussain. According to estimates one lakh people were associated with carpet making in Kashmir. "The COVID-19 induced lockdown following the abrogation of Article 370 caused a sharp decline in the number of

tourists coming to Kashmir, which also impacted the carpet business,' said Ghulam Mohammad, a carpet trader. "The exporters are also telling us that there are no buvers for carpets. But we are hoping that the things will improve," said Mohammad.

### Punjab plans to expand social media outreach

Chandigarh, July 15: Amid the growing global importance of the social media in battling the COVID-19 crisis, the Punjab government Wednesday decided to expand its social media outreach by setting up 15 expert teams on an outsourced model. The Cabinet approved an annual budget of ₹7 crore for the teams, which will be constituted by engaging professionals and experts in the field, an official spokesperson said.

## Smuggling of cigarettes, liquor surges amid Covid

INDO-ASIAN NEWS SERVICE

New Delhi, July 15: Gold, cigarettes and liquor were among high tax items which topped the list of smuggled goods across India amid the current coronavirus crisis that has led to economic distress.

Smuggling of these goods not only registered a sharp spike amid the pandemic but also smugglers, interestingly, used innovative measures like ferrying illegal cigarettes in COVID-19 special trains.

Revealing the fact based on a study of seizure of such smuggled items, FICCI's Committee Against Smuggling and Counterfeiting Activities Destroying the Economy (CASCADE) said Customs officials had two major seizures of smuggled cigarettes at the New Delhi railway station where the smugglers were using COVID-19 special trains for



ferrying these products in less than a week. These seizures come on the back of two other major busts of foreign cigarette smuggling rackets, the first in Mumbai and second one in Hyderabad, said the study, adding the combined value of the seizures is over ₹15 crore. Earlier this month, the study

said, seizures of smuggled gold

worth ₹1.5 crore and ₹15 crore were also made by the Kerala Airport Authority and customs at Thiruvananthapuram Airport re-

Not only does the smuggling dent the government exchequer by creating opportunities from tax arbitrage, but also threatens local industries on which livelihoods of many depend, the study said. The study estimates that over 16

lakh jobs were lost in India in five industry sectors alone in 2017-18 due to smuggling. "Besides unemployment and massive financial losses, it also creates large scale destabilisation by fomenting crime and funding insurgency and terrorism."

In order to create large-scale awareness of this menace, FICCI CASCADE has been conducting several interactions with government and enforcement agencies to mitigate this challenge. Applauding enforcement agencies for recent seizures, FICCI, an association of business organisations in India established in 1927, has urged the government to keep up the vigi-

lance on smuggling of goods. "Illicit trade has emerged as one of the most formidable challenges before our nation, especially during the current pandemic which has led to economic distress. This comes in the wake of several cases of smuggling of goods such as gold, cigarettes, liquor, which have been reported amid the COVID-19 pandemic," the organisation said.

Anil Rajput, Chairman, FICCI CASCADE said: "The perpetrators of illicit trade are always looking at innovative ways to deceive the system to carry out their activities. "This deeply harms the economic interests of the nation and the society ends up paying a huge cost. While the recent efforts of enforcement officers are laudable, we cannot afford to let the guard down. At a time when the country is already dealing with the coronavirustriggered financial stress, it is important that the government maintains a strict vigil to ensure that these offenders are kept at bay."

### **Biden vows to** rejoin Paris deal

Washington: Democratic presidential nominee Joe Biden has unveiled a \$2 trillion proposal to boost investment in clean energy and combat the global warming as he pledged to rejoin the historic Paris agreement on climate change if elected in the November elections. US President Donald Trump in 2017 withdrew the United States, the world's No 2 emitter of greenhouse gases behind China, from the 2015 Paris Climate Agreement that brought countries together to mitigate global warming, saying it was too costly.

### **Indonesia flood** toll rises to 21

Jakarta: The death toll from a flash flood in Indonesia's South Sulawesi province rose to 21 Wednesday with two people still missing, an official said. National **Disaster Mitigation Agency** said search and rescue operations were hampered by thick mud covering roads and houses, and rain was continuing to fall.

### **Covid red alert** situation in Tokyo

Tokyo: Tokyo raised its coronavirus alert to the highest "red" level Wednesday, alarmed by a recent spike in daily new cases to record highs, with Governor Yuriko Koike describing the situation in the Japanese capital as "rather severe".

### 3 ships on fire at Iranian port

Iran: At least three ships are on fire at the Bushehr port in southern Iran, the official IRNA news agency reported Wednesday. There have been several explosions and fires around Iranian military, nuclear and industrial facilities since late June.

### **Judge halts** execution

Terre Haute (US): A judge Wednesday halted the execution of a man said to be suffering from dementia, who had been set to die by lethal injection in the federal government's second execution after a 17-vear hiatus. Wesley Ira Purkey, convicted of a gruesome 1998 kidnapping and killing, was scheduled for execution Wednesday at the US Penitentiary in Terre Haute, Indiana, where Daniel Lewis Lee was put to death Tuesday after his own 11th-hour legal bids failed.

## **China vows retaliation against US**

Washington, July 15: President Donald Trump Tuesday ordered an end to Hong Kong's special status under US law to punish China for what he called "oppressive actions" against the former British colony, prompting Beijing to warn of retaliatory sanctions.

Citing China's decision to enact a new national security law for Hong Kong, Trump signed an executive order that he said would end the preferential economic treatment for the city.

"No special privileges, no special economic treatment and no export of sensitive technologies," he told a news conference.

Acting on a Tuesday deadline, he also signed a bill approved by the US Congress to penalise banks doing business with Chinese officials who implement the new security law.

"Today I signed legislation, and an executive order to hold China accountable for its aggressive actions against the people of Hong Kong, Trump said. "Hong Kong will now be treated the same as mainland FRUMP ENDS PREFERENTIAL STATUS FOR HK



China," he added. Under the executive order. US property would be blocked of any person determined to be responsible for or complicit in "actions or policies that undermine democratic processes or institutions in Hong Kong," according to the text of the document released by the White House. It also directs officials to "revoke license exceptions for exports to Hong Kong," and includes revoking special treatment for Hong Kong passport holders.

China's foreign ministry said Wednesday Beijing will impose

retaliatory sanctions against US individuals and entities in response to the law targeting banks, though the statement released through state media did not reference the executive order.

"Hong Kong affairs are purely China's internal affairs and no foreign country has the right to interfere," the ministry said.

Critics of the security law fear it will crush the wide-ranging freedoms promised to Hong Kong when it returned to Chinese rule in 1997, while supporters say it will bring stability to the city after a year of sometimes violent anti-government protests. The security law punishes what Beijing broadly defines as subversion, secession, terrorism and collusion with foreign forces with up to life in prison.

US relations with China have already been strained over the global coronavirus pandemic, China's military buildup in the South China Sea, its treatment of Uighur Muslims and massive trade surpluses.

"Make no mistake. We hold China fully responsible for concealing the virus and unleashing it upon the world. They could have stopped it, they should have stopped it. It would have been very easy to do at the source, when it happened," he said.

Asked if he planned to talk to Chinese President Xi Jinping, Trump said: "I have no plans to speak to him." Analysts say that completely ending Hong Kong's special treatment could prove selfdefeating for the United States.

Hong Kong, July 15: Young activists and localist candidates dominated Hong Kong's unofficial pro-democracy primaries over the weekend, with hundreds of thousands of people voting despite warnings the election could violate the territory's new security law imposed by Beijing.

Candidates who topped the polls were in their 40s or younger in every constituency and included prominent pro-democracy activists Joshua Wong and Jimmy Sham, who helped organise many of last year's anti-government protests that had alarmed the central government in Beijing.

Incumbent lawmakers such as Ted Hui and Eddie Chu, known for their vocal and outspoken criticism in legislative meetings, also took top spots. The polls were held to whittle the pro-democracy camp's

candidates to field a unified slate in a legislative election in September in hopes of achieving a "35-plus" majority in the 70-seat legislature.

The pro-democracy camp has

pledged to vote down the budget if they attain majority.

Under Hong Kong's mini-constitution, known as the Basic Law, the city's leader — currently Carrie Lam — must resign if an important bill such as the budget is vetoed twice.

Wong also said at the pro-democracy camp's news conference Wednesday that President Donald Trump's signing of the Hong Kong Autonomy Act — which paves the way for sanctions to be imposed on Chinese officials in retaliation for the national security law — has shown that Beijing's actions will backfire on them.

Lam Monday warned organisers and candidates of the primary that the event could be considered subversive under the city's tough new national security law if the objective is to resist every policy initiative of the government.

The sweeping law Beijing enacted June 30 in response to last year's often violent protests calling for greater democracy and police accountability outlaws secessionist, subversive and terrorist activities, as well as collusion with foreign forces to intervene in the city's affairs. ### Trump says he will soon sign new immigration act

Washington, July 15: US President Donald Trump has reiterated his pledge to soon sign a "very strong" merit-based immigration act that will also take care of the immigrants brought to the country illegally as children, many of whom are of Indian or South



Trump, who is seeking re-election in November, has long sought to overhaul the US immigration system to be based on merit rather than family ties. Immigration remains one of Trump's signature campaign issues. "We are going to be signing an immigration act very soon. It is going to be based on merit, it is going to be very strong," Trump told reporters at a Rose Garden press conference at the White House Tuesday. "We are going to work on DACA (Deferred Action for Childhood Arrivals) because we want to make people happy and I will tell you even conservative Republicans want to see something happen with DACA," he said.

The DACA programme provides for work permits and other protections for people brought to the US as children by undocumented parents. It affects an estimated 700,000 young people, many of whom are of Indian or South Asian descent. President Trump had tried to cancel the Obama-era programme, but the Supreme Court last month said it could stay in place.

### Tanker off UAE sought by US 'hijacked'

Dubai, July 15: An oil tanker sought by the US over allegedly circumventing sanctions on Iran was hijacked July 5 off the coast of the United Arab Emirates, a seafarers organisation said Wednesday. Satellite photos showed the vessel in Iranian waters Tuesday and two of its sailors remained in the Iranian capital. It wasn't immediately clear what happened aboard the Dominica-flagged MT Gulf Sky, though its reported hijacking comes after months of tensions between Iran and the US.

David Hammond, the CEO of the United Kingdom-based group Human Rights at Sea, said he took a witness statement from the captain of the MT Gulf Sky, confirming the ship had been hijacked.

Hammond said that 26 of the Indian sailors on board had made it back to India, while two remained

in Tehran, without elaborating. Hammond said that he had no other details on the vessel. TankerTrackers.com, a website tracking the oil trade at sea, said it saw the vessel in satellite photos on Tuesday in Iranian waters off Hormuz Island, Hormuz Island,

near the port city of Bandar Abbas, is some 190 kilometers (120 miles) north of Khorfakkan, a city on the eastern coast of the United Arab Emirates where the vessel had been for months. The Emirati government, the US Embassy in Abu Dhabi and the US Navy's Bahrain-based 5th Fleet did not respond to requests for comment. Iranian state media did not immediately report on the vessel and Iran's mission to the United Nations did not immediately respond to a request for comment. In May, the US Justice Department filed criminal charges against two Iranians, accusing them of trying to launder some \$12 million to purchase the tanker, then named the MT Nautica, through a series of front companies.

## Virus resurgence forces countries to reimpose curbs

Promachonas (Greece), July 15: Countries around the world are reimposing lockdowns and implementing new health checks at their borders in an effort to curb a resurgence of the coronavirus before it spins even further out of control.

Starting Wednesday, all travellers arriving in Greece from a land border with Bulgaria were required to carry negative coronavirus test results issued in the previous 72 hours and translated into English. The new rules, which follow an increase in tourism-related COVID-19 cases, triggered an immediate drop in arrivals compared to recent days.

Residents of Australia's secondlargest city. Melbourne, were warned Wednesday to comply with lock-



down regulations or face tougher restrictions. Melbourne's 5 million people and part of the city's semi-rural surroundings are a week into a new, six-week lockdown to

contain a new outbreak there. The developments come with

Masks were also made mandatory in public spaces where there is no opportunity for 1.5 metres of distancing, such as in lines to enter shops and bus stations.

Renewed restrictions took effect in Hong Kong Wednesday, with public gatherings limited to four people, restaurants restricted to takeout after 6 pm, and a one-week closure for gyms, karaoke bars, and selected other businesses.

Masks were mandated on public transit for the first time, with the non-compliant being fined.

After a surge in daily infections beginning last month, Israel moved last week to reimpose restrictions, closing events spaces, live show venues, bars and clubs. It has imposed lockdowns on areas with high infection rates, which in some cases sparked protests from resi-

South Africa, Africa's most developed country, is already showing signs of being overwhelmed by the pandemic — an ominous outlook for the rest of the continent of 1.3 billion people. In Spain, authorities in the northeastern Catalonia region made fresh attempts to stem the spread of new coronavirus outbreaks as health experts warned that more and better contact tracing is needed.

### **US COVID VACCINE ENTERS FINAL STAGE** TRIAL THIS MONTH

Washington, July 15: The US biotech firm Moderna said it would enter the final stage of human trials for its COVID-19 vaccine on July 27, after promising early results were published in an influential journal.

The Phase 3 trial will recruit 30,000 participants in the US, with half to receive the vaccine at 100 microgram dose levels, and the other half to receive a placebo.

It is designed to show whether the vaccine is safe and can prevent infection by the SARS-CoV-2 virus, or -- if people still get infected -whether it can prevent the infection progressing toward symptoms.

### Tea production likely to dip 13% this year: Report

Mumbai, July 15: Tea production in the country is likely to decline 13% in the current calendar year due to restrictions on labour deployment amid the ongoing COVID-19 pandemic and adverse weather conditions, which will result in an increase in production cost, according to a report.

Factors like restrictions on labour deployment due to the coronavirus pandemic have impacted the bulk tea players in northern India in an unfavourable manner during March, April and May 2020, according to the report by rating agency ICRA.

While there were expectations of production returning to normal levels from June, inclement weather conditions and flooding in Assam in June witnessed crop losses ranging from 15% to 25%.



Some impact of the adverse weather conditions on production is likely to be felt in July as well, the report noted. On the other hand, the South Indian production witnessed only a marginal loss during the lockdown period,

The report also said that as tea is a fixed cost-intensive industry, a decline in the crop will substantially increase the cost of production for the NI bulk tea in-

New Delhi: The exports of coir and its products stood at ₹2,757.9 crore in 2019-20, registering an all-time high record, the government said Wednesday. The



products in 2018-19 were ₹2,728.04 crore. "9,88,996 MT of coir and coir products were exported during the year 2019-20 from the country as against 9,64,046 MT exported during the preceding year," the Ministry of Micro, Small and Medium Enterprises said. While the exports of coir pith, tufted mats, coir Geo-textiles, coir rugs and carpets, coir other sorts, coir rope and power-loom mats registered growth both in terms of quantity and value, products like hand-loom mats, coir yarn, rubberized coir and power-loom matting showed decline in terms of quantity and increase in terms of value.

### OPEC+ meets to decide on oil cuts easing

London/Dubai: OPEC and allies such as Russia meet on Wednesday to decide oil output policy from August amid broad market expectations the group will ease supply curbs as the global economy slowly recovers from the coronavirus pandemic. The Organization of the Petroleum



Exporting Countries (OPEC) and allies, known as OPEC+, have been cutting output since May by 9.7 million barrels per day, or 10% of global supply, after the virus destroyed a third of global demand. After July, the cuts are due to taper to 7.7 million bpd until December. A panel involving key ministers and known as the Joint Ministeria Monitoring Committee (JMMC) meets Wednesday after 12 GMT to recommend the next level of cuts. Five OPEC+ sources have said no recommendations have been made to prolong record cuts into August.

The common equity tier-1 (CET1) ratio of public sector banks (PSBs) was 10.1% as of December 31, 2019, higher than the regulatory requirement of 8% (including a capital conservation buffer).

Similarly, PSB' tier-1 capital adequacy ratio was 11.1%, higher than the regulatory requirement of 7%, it said. The agency expects that government-owned banks in India in aggregate will be able to absorb the estimated credit losses without breaching the regulatory minimum, but these banks need capital to grow.

"In our base case where we have factored in 4-5 per cent credit growth for government-owned banks in the current fiscal year, we estimate these banks need additional capital of ₹35,000 crore-Rs 40,000 crore this year," it said.

Some finance companies are also looking to bolster capital adequacyto address asset quality issues and improve liquidity, it said.

London, July 15: An underwhelming Chelsea boosted their chances of a spot in next season's Champions League (CL), overcoming a slow start to beat relegated Norwich City 1-0 at Stamford Bridge Tuesday.

Olivier Giroud scored with virtually the last touch of the first half as Chelsea consolidated third place in the Premier League and moved four points above Leicester City and Manchester United in the battle for a top four finish.

It was an eighth successive league defeat for Norwich, who were already condemned to relegation after losing to West Ham United Saturday.

Chelsea struggled to convert their overwhelming possession into goals, failing even to fire a shot in anger before Christian Pulisic hit one into the side netting in the 27th minute.

The US international, who has been a revelation for Chelsea since the league returned after its COVID-19 hiatus, then showed some sharp

skill nine minutes later. His first touch allowed him to bring the ball down with his back to goal and he then swivelled to shoot on target, forcing Norwich goalkeeper Tim Krul to tip the ball over the top. Kurt Zouma then headed the resultant corner nar-

Pressure from Chelsea, who made five changes after losing at Sheffield United Saturday, eventually paid off three minutes into first half stoppage time when Pulisic's cross was met by a diving Giroud to head home from point-blank range.

Norwich were more adventurous after the break but Chelsea still had the lion's share of possession, without creating too many chances.

Pulisic forced another save out of Krul in the 75th minute as he got a touch onto the end of a ball over the top of the defence from Giroud and the visiting keeper also pushed out Willian's 89th-minute free-kick.

Chelsea will now turn their focus to the FA Cup where they meet Manchester United in Sunday's semifinal at Wembley. Norwich will complete their season in the top flight at home to Burnley this weekend and away at Manchester City next.

### EPL transfer window to run from July 27 to Oct 5

"Frankly speaking, it is impos sible to resume camps now because Bangalore is under complete lockdown till July 22. The cases are increasing everyday and there is a possibility that the lockdown would be extended till the end of this month."

Although the SAI headquarters here is yet to take a formal decision on the matter, Hockey India's derecognition by the Sports Ministry, along with 53 other National Sports Federations (NSFs), as per the Delhi High Court's order, has made the situation complex.

Tokyo, July 15: The Tokyo again if the novel coronavirus mutates into a stronger pathogen, Kivoshi Kurokawa, a prominent Japanese government adviser, said Wednesday. However, a recent spike in cases in Tokyo is due to a failure to stick to guidelines to prevent contagion, he said.

A physician who served as a science adviser to the Japanese cabinet from 2006-2008, Kurokawa also headed an independent probe into the 2011 Fukushima nuclear disaster. Currently, he is advising the government on the pandemic.

"I think the virus is mutating all the time ... it may be a much stronger virus that triggers a second wave." Kurokawa told 'Reuters'. "The Olympics may be postponed again, but I can't predict.' "I think it's small incidents hap-

pening in Tokyo ... new cases are because people are not abiding by recommendations." Kurokawa said of the current spike in infections. "But if there are some mutations, that is a completely different story. That

could happen anywhere in the world." Tokyo Governor Yuriko Koike told Reuters Monday the Olympics,

originally scheduled to start this

month but put off to 2021 because of the pandemic, must go ahead next year as a symbol of world unity in overcoming coronavirus.

The spike in infections in Tokyo, which accounts for more than onethird of Japan's more than 23,000 cases, has prompted a backlash against a planned campaign to promote domestic tourism. Kurokawa said authorities were trying to balance priorities.

"I think one of the concerns of this pandemic is how to prevent the spreading out of this corona infection. The other side of this issue is ... how to promote the economy. Many people are losing their jobs," he said. He added that he thought the government was "care-

fully balancing" the two priorities. Kurokawa was appointed last month to head a new panel to examine how to use artificial intelligence to fight the spread of the virus. His appointment to the fourperson group including a Nobel Prize winning geneticist came after Economics Minister Yasutoshi Nishimura abruptly announced he would dissolve a panel of scientific experts and remake it with

### Vettel could join Aston Martin in 2021: Reports

London, July 15: Four-time Formula One (F1) World Champion Sebastian Vettel has been reportedly in talks with new Aston Martin team. German newspaper 'Bild' has reported that Vettel has reached an agreement with Racing Point, which is being rebranded by

Lawrence Stroll to Aston Martin. Vettel is expected to replace Sergio Perez, who currently races for Racing Point and has a lengthy contract with the team. Perez last year announced a long-term deal with Racing Point until 2023. But, it appears that his team would be using an exit clause to make way for Vettel.

The German will end his five-year association with Ferrari at the end of this season, as announced by the driver and the team earlier this year.

However, Racing Point team principal Otmar Szafnauer had played down the suggestion of approaching the four-time World Champion after he had announced his availability, the report added. "You're absolutely right, we have long contracts with both our drivers, so it would only be logical that we don't have space," Szafnauer told Autosport.



### **Hamilton aims for** another F1 record

Mogyorod (Hungary): Red Bull's Max Verstappen will be doing all he can to stop six-time World Champion Lewis Hamilton completing a Mercedes hat-trick and matching another of Michael Schumacher's Formula One records in Hungary this weekend. Verstappen has lined up on the front row for the first two races of the season in Austria, won by Mercedes' championship leader Valtteri Bottas and Hamilton respectively, and the rivalry is hotting up. Hungary is a favourite for Hamilton, who has won there seven times and can equal Schumacher's feat of winning the same Grand Prix eight times.

A key member of the 1975 world champion team and a bronze-medallist at the Munich Olympics can't help but wonder whether the Manpreet Singh-led team would shape up as nicely next year, as it did this year after a stellar 2019.

"If the Olympics were held this year, we definitely had some chance. We had shown improvement and we could have got some good results there," Kumar, who scored the winning goal against Pakistan in the 1975 World Cup final, told PTI in an exclusive interview.

"Definitely, there is a break in momentum and it will really make a big difference. You can't say now (that we will win medal). We will talk about it next year seeing how they perform in the build up to

the Olympics. In fact, Kumar feels that coach

Graham Reid will also be a bit circumspect due to the forced break caused by the COVID-19 pandemic.

"Even (head coach) Graham Reid will have a big question mark going on his head now. Coaching is going on inside closed doors. Unless you see them in real matches, how will you assess... He's not a machine."

India's best show came against world's top ranked team Belgium, beating a full strength side 2-1 in a Pro League encounter. India also had a commendable 2-2 draw against the formidable Australia in their final Pro League game before world came to a standstill due to the pandemic.

The 70-year-old further said the women's team was also in great shape and would have done well had

the Olympics been held this year.

'Even our women's team were in the peak of their form and they too had bright chances but now we never know. We will talk about the Olympics only next year," he said, remembering the 5-1 win over the

USA in the first leg Olympic Qualifier. The men's team will have a packed calendar when it resumes as it is slated to play in the Asian Champions Trophy in November before a tour to Malaysia followed by a Four-Nation tournament in New Zealand early next year.

The team will then resume the Pro League against Argentina with back-to-back matches till end of May in the build up to Tokyo 2021. India, who lost to Belgium in Rio



2016 quarterfinals, have not won an Olympic medal since Moscow 1980 where they won a gold medal.

"It depends how they regroup and how they keep the spirit high. They have to stay motivated, it's purely an individual thing," the star dribbler of yesteryears said.

Kumar, however, believed that India have improved a lot in the recent past by bolstering their defence. 'We have a balanced squad at the moment. We have plugged the hole of leaking goals at the last minute. Our defence is much better now."

"We have some good drag-flickers in Rupinder Pal Singh and Simaranjeet Singh. The forwards just need to combine a bit more and show ball anticipation.'
