Celebrities Kanye West and his wife, Kim Kardashian West, were also hacked. The fake tweets tweets offered to send \$2,000 for every \$1,000 sent to an anonymous Bitcoin address.

There is no evidence that the owners of these accounts were targeted themselves. Instead, the hacks appeared designed to lure their Twitter anonymous Bitcoin account.

few minutes of the breach and removed the related tweet." The FBI said it was aware of Twitter's security breach, but declined further comment.

In a tweet, Twitter noted that it was aware of a "security incident imquests for comment.

The apparently fake tweets were all quickly deleted, although The Associated Press was able to capture screenshots of several before they disappeared. The security problem was severe enough for Twitter to warn that many of its more than 166 million daily users might be unable to tweet or reset their passwords while the company tried to lock things down.

Among the political figures targeted, the hack mostly appeared to target Democrats or other figures on the left, drawing comparisons to the 2016 campaign. US intelligence agencies esordinated attempts to interfere in those US elections through social media cluding targeting the various campaigns and major party organisations. The hack might also be a simple demonstration of Twitter's weak security controls as the US heads into the 2020 presidential election, a contest in which the service is likely to play an influential role.

The Bitcoin account mentioned in the fake tweets appears to have been created Wednesday. By the end of the day, it had received almost 12.9 bitcoins, an amount currently valued at slightly more than \$114,000. At some point during the day, roughly half that sum in bitcoin was withdrawn from the account. Bezos, Gates and Musk are among the 10 richest people in the world, with tens of millions of followers on Twitter. The three men are worth a combined \$362 billion.

Sachin Pilot takes Congress to court

Jaipur, July 16: Sachin Pilot and 18 other dissident leaders Thursday moved the high court, challenging the notices from the Rajasthan Speaker over a Congress move to disqualify them from the state Assembly.

division bench. Congress chief whip Mahesh Joshi, who had written to the Speaker seeking the MLAs' disqualification, also approached the court, asking to be heard before it passes any order. The 19 MLAs were sent notices Tuesday by the Speaker after the Congress complained that they had defied a party whip to attend two Congress Legislature Party meetings.

The Pilot camp, however, argues that a party whip applies only when the assembly is in session.

Bhubaneswar, July 16: In view of the rising cases of COVID-19 in certain areas of the state, the Odisha government Thursday re-imposed 14-day lockdown in four districts of the state and Rourkela Municipal limits to contain the spread of the disease. Addressing a press meet through video-confer-

encing, Chief Secretary Asit Tripathy announced the government's decision. The lockdown has been imposed in Ganjam, Khurda, Jajpur and Cuttack districts. The lockdown will come into effect from 9 pm July 16 and will remain in force till July 31 'We decided to impose the lockdown to contain the

disease and use the opportunity to do enhance monitoring and surveillance of the cases. During this lockdown, all shops, commercial establishments, offices and institutions shall remain closed, while mobility of people will be restricted," Tripathy said, seeking cooperation from one and all.

The Chief Secretary said that only essential services such as grocery shops, medicine shops and healthcare institutions will be allowed to open. People in emergency services will be allowed to venture out during the period.

The government has allowed goods vehicle to move freely during the period, but barred public transport - except those ferrying passengers from rail-



way stations, airports and bus stations.

"Please carry a copy of the authorisation letter from the office while traveling during the lockdown, as the enforcement authorities will scrutinize the documents during checking," Tripathy said.

The government said that those violating the norms will be penalised, "Any person violating these norms will be liable for prosecution in accordance with the provisions of the Disaster Management Act, 2005. Besides legal action under Section 1BB of the IPC and other legal provisions such as Epidemic Diseases Act, 1897 can be initiated against the violators," Tripathy said.

Telemedicine service at 41 hospitals soon

Bhubaneswar, July 16: With a view to provide doctor consultation without visiting hospitals, the state government has decided to start telemedicine service at 41 government-run hospitals from July 20, Health Minister Naba Das told the media here Thursday.

In view of the COVID-19 pandemic, various government hospitals have closed down their OPD units causing immense sufferings to the patients who have been forced to go to medicos sitting under trees or elsewhere.

The facility will start in all 30 district headquarters hospital (DHH), seven government medical colleges, Ispat General Hospital in Rourkela, Capital Hospital in Bhubaneswar, Acharya Harihar Regional Cancer Centre in Cuttack and Sishu Bhawan also in Cuttack, Das said.

Plasma Therapy commences

Meanwhile, the state government Thursday commenced plasma therapy for the treatment of COVID-19 patients at a hospital in Cuttack, an official said.

The procedure was conducted on a 48-year-old patient at the Ashwini Hospital for the first time in the state, technical advisor to the health department Dr Jayant Panda said. "The patient has been administered B-positive plasma," he said.

The state government had earlier announced that the plasma therapy would also be introduced in the SUM Hospital and the Kalinga Institute of Medical Sciences in Bhubaneswar.

India announces air travel bubbles with US, France

New Delhi. July 16: India has es tablished individual bilateral bubbles with France and the US that will allow airlines of each country in the pact to operate international flights, Civil Aviation Minister Hardeep Singh Puri said on Thursday, adding that similar arrangement with Germany and the UK will soon be permitted.

Air France will be operating 28 flights between Delhi, Mumbai, Bangalore and Paris from July 18 to August 1, the minister said at a press conference, adding that American carrier United Airlines will be flying 18 flights between India and the US from July 17 to July 31.

"They (United) are flying a daily flight between Delhi and Newark and a thrice-a-week flight between Delhi and San Francisco," Puri noted. The minister said India is planning to establish a bubble with the UK soon under which there would be two flights per day

between Delhi and London. "We have got a request from Germans also. I think the arrangement with Lufthansa is almost done...We are processing that request," Puri said. "Now we have many demands for air bubbles, but we need to be careful. We should permit that many only that

New Delhi, July 16: China and India are committed to "complete disengagement" of troops, and the process is "intricate" that requires "constant verification", the Indian Army said Thursday after the fourth round of marathon military talks on de-escalation of the situation in eastern Ladakh.

The Army said senior commanders of the Indian and Chinese military reviewed the progress on implementation of the first phase of disengagement and discussed further steps for "complete disengagement".

The Corps commanders held 15-hour-long negotiations in Chushul on the Indian side of the Line of Actual Control (LAC) from 11 AM Tuesday to 2 AM Wednesday, covering various aspects of the complex disengagement process including withdrawal of thousands of troops from the rear bases within a specific time frame.

"The senior commanders reviewed the progress on implementation of the first phase of disengagement and discussed further steps to ensure complete disengagement," Army



spokesperson Col Aman Anand said in a statement.

"The two sides remain committed to the objective of complete disengagement. This process is intricate and requires

constant verification. They are taking it forward through regular meetings at diplomatic and military level." he added.

INTERNATIONAL JUSTICE DAY

Art 224 can help clear pendency

New Delhi, July 16: Justice would remain a far cry for many if the judiciary and the government continue to show a laidback attitude, especially when there is a staggering 3.33 crore cases pending in the lower courts.

It is high time the government thought about appointment of retired judges of district courts and High Courts as ad hoc judges to clear the pending cases, said a Supreme Court judge.

As per official data, over 3.33 crore cases have been pending in the lower courts across the country. Out of these, around 1.86 crore criminal cases are more than one-vear old.

In Odisha, the courts have a backlog of over 14.5 lakh cases. The Orissa High Court has as many as 1,28,252 cases pending for more than one year while 8,884 criminal appeals are pending for 10-20 years. Significantly, the HC has been functioning with around 60 per cent strength of

> Taking cognisance of the pendency of the cases in the high

courts, the Supreme Court said that the backlog of cases poses a challenge to the judiciary, inasmuch as to speedy disposal of appeals of the convicted.

In order to deal with this huge backlog, Supreme Court judge Justice

DY Chandrachud emphasised on adopting out-of-the-box thinking. During an event earlier, Justice Chandrachud had said that retired district judges could be appointed as ad hoc judges in the high courts to clear the pending cases.

It's pertinent to mention here that the Constitution does provide for appointment of ad hoc judges to mitigate the problem of pending cases.

The judiciary can invoke Article 224 of the Constitution which allows appointment of retired judicial officers as additional judges in the courts.

Article 224-A says, "...the Chief Justice of a High Court for any State may at any time, with the previous consent of the President, request any person who has held the office of a Judge of that Court or of any other High Court to sit and act as a Judge of the High Court for that State.

Article 127 of the Constitution has similar provision for appointment of ad hoc judges in the Supreme Court too.

Causes of pendency

While poor infrastructure and staff crunch are believed to be the reasons behind the backlog of cases across the country, frequent strikes by lawyers in some parts of Odisha overburdened the judiciary in the state.

Moreover, many litigants file anticipatory bail applications in the High Court directly under Section 438 of CrPC, bypassing the district courts. This has been resulting in pendency of bail pleas in the HC.

The outbreak of Covid-19 pandemic has handicapped the judiciary across the country. The courts switched to virtual mode amidst the virus spread in order to make justice accessible to citizens. But due to technical snags, the move does not make a big difference. The number of daily cases taken up for hearing has taken a nosedive in virtual mode too. Other than appointment of ad hoc judges, the judiciary can also consider setting up of holiday benches while the lawyers can refrain from taking frequent adjournments to mitigate pendency issue.

The social media post claimed that a road near the West Gate of Srimandir was sealed by the police to facilitate the burglary. Some servitors and police personnel reportedly threatened the devotee concerned and asked him not to reveal the incident to anyone. The post also sought a high-level

probe to find out the servitors, officials and police personnel involved in the incident.



"Rs 3 crore as financial incentive for medals won at Asian Games 2018. Rs 30 lakh for training and financial support during 2015-19. Rs 50 lakh for training support for Tokyo Olympics (released in two instalments August 2, 2019 and December 27, 2019)," the



statement read.

"The state government appointed Dutee Chand as Group-A level officer in Odisha Mining Corporation (A Gold Category PSU). She is currently drawing gross salary of Rs 84,604 (June 2020 salary) per month. She is not required to come to office so that she is able to concentrate full-

Accordingly, since her appointment in OMC, no official work has been allotted her. OMC provided Rs 29 lakh for training and financial incentives," the statement

On Wednesday, Dutee had said that she sold her sedan to get some 'breathing space'. "I took to social media to sell my car. I don't have the resources to maintain luxury cars, though I love them. I never expressed that I am selling it to fund my training," Dutee said in a statement on her Twitter

"Odisha Government and my own KIIT University have always supported me. This does not deny the fact that my training is very expensive, especially for the 2021 Olympics. I just wanted to make a point that this money could be diverted for my training and a car can be bought post Covid once I receive the money from the state government," the ace sprinter said.



6 HELD FROM NAYAGARH WITH BLOOD-STAINED SHIRT, CRIME WEAPON

Khurda, July 16: Blowing the lid off the sensational murder of a bar employee here July 14, the district police claimed to have ar rested six persons from near Ranpur forests in Nayagarh and recovered weapons 'used in the killing' from their possession. Thursday.

According to Khurda superintendent of police (SP) Ajay Pratap Swain, Mrutyunjay Nayak (29), his brother Dhananjay Nayak (28), Amit Kumar Pradhan (23) and Nandan Behera (20), Rakesh Sahoo (23) of Daleiputa and Debakanta Das (25) of Lokeswarpur under Khurda Town police limits here have been taken into custody for killing Amiya Barik, an employee of a bar under Khurda Town police limits here, July 14 evening. The SP, in a media briefing, said that the footage from the CCTV installed near the crime scene and a few eyewitnesses helped crack the case. The accused are history-sheeters as they have multiple criminal cases registered against them with Nayapalli police.

"We tracked the mobile phones of the accused to track them. We've recovered a blood-stained shirt and

murder weapons as well. The luxury car in which they had come to the bar and fled as well besides a motorcycle has also been recovered

from them," Swain said. The incident took place when Nayak, along with a few of his friends, had come to booze at the bar July 14.

"While parking the car, they had a heated exchange of words with a security guard at the parking lot. Soon after, they left the place to buy some sharp weapons from a nearby hardware store. On return, they failed to find the security guard and instead attacked Barik who was standing near the parking lot with one of his colleagues. Barik's colleague, however, managed

to flee the scene," the SP informed. Barik suffered multiple stabbing injuries and succumbed at the spot. Soon after, a case (243/20)was registered in this regard and five special teams were formed to track the culprits.

Swain said, "After the incident, the accused initially fled to Kandhamal and then to Brahmapur via Boudh. On being informed by the Navagarh police, we nabbed them from near Ranpur forests. Chargesheet will be filed within a month.'

Elephant casualties in Keonjhar on rise

THE FOREST DIVISION HAS REPORTED DEATHS OF 51 PACHYDERMS FROM 2010 TILL DATE

Keonjhar, July 16: The forest department spends cores of rupees on protection of elephants in Keonjhar, but casualties of the animals are on the rise in the mineral-rich district, a report said.

Lapses in monitoring of the movement of elephants under Keonjhar forest division recently came to light. The department suspended a forester and a forest guard June 18 for negligence in duty after two elephants were found electrocuted by poachers in Joda section of Champua range June 14.

The killing raised serious questions on the field intelligence and patrolling as forest officials of Joda section were clueless about the incident till locals informed them.

Apart from poaching, accidents and electrocution, the animals have been facing a threat from the shrinking of the forest cover and loss of habitat owing to mining.

The report said over last two

months, five elephants were found dead in Champua and Barbil ranges where the animals are said to be unsafe for various reasons.

Statistics have it that since 2010 till date, Keonjhar forest division alone has reported 51 elephant deaths. In 2010-11, the district saw deaths of nine elephants while four died in 201-12.

Nine elephants died in 2012-13; four each in 2013-14 and 2014-15; six in 2015-16; two each in 2017-18 and 2018-19; six in 2019-20 and five in 2020-21(till date).

According to official data, there are 92 elephants in the Keonjhar division. To track the movement and ensure their safety, the department has engaged 110 people while 19 vehicles are pressed into

Range officers, foresters and forests guards are also on the act.

According to official data, there are 92 elephants in the Keonjhar division. To track the movement and ensure their safety, the department has engaged 110 people while 19 vehicles were pressed into service

Trenches have been dug around forests to prevent intrusion of animals into human habitations.

Environmentalists expressed concern over the growing casualties of the elephants. They pointed out that despite all preventive and protective measures, elephants still face dangers due to various factors.

Concerned over elephant casualties, environmentalist and hon-

wildlife warden ourarv Harekrushna Mohant said. "Unabated mining, and declining forest cover resulted in loss of habitat and shortage of fodder. Increasing movement of mineral-laden vehicles, encroachment of forests, infrastructure development like roads and railways and industrial units in the forested pockets have posed serious threat to the elephants. With the habitat loss, the animals stray out of forests and enter villages. leading to man-elephant conflicts.

Experts suggested that underpasses, overpasses, check gates and bridges should be incorporated into a development plan in the forested pockets to mitigate elephant casualties. DFO Santosh Joshi said for protection of elephants, special squads have been formed for 24X7 monitoring while local people are being sensitized to the need for elephant safety so that man-elephant conflict can be avoided.

"Each elephant herd is being tracked by a team," he added.



Blood goes waste as HIV-testing machines conk out



Dhenkanal, July 16: Even as there is a spurt in the number of COVID-19 cases in the state, blood donors in the district are in low spirits.

They allege that blood units they are donating can no longer be administered to patients because the HIV testing machine at the blood bank has gone out of order. The blood bank has three HIV

testing machines. The rule is that the collected blood units undergo an HIV test and then allowed for transfusion. But as of now, two of the three machines have developed problems and stopped functioning. Similarly, another machine procured a year ago has also been lying dysfunctional

According to volunteers, organising blood donation camps is very difficult during the pandemic. Yet, they organize such camps so that patients should not die due to paucity



of blood. However, their efforts go down the drain as HIV test of the collected blood units cannot be performed as the machines are out

"The recently procured machine has a warranty period. Yet, no step is being taken to get it repaired, alleged irate volunteers.

When contacted, the staff of the blood bank said though the mechanics have been contacted, they fail to turn up due to prevailing COVID-19 situation.

A mug's game

The state government last week announced a slew of austerity measures in view of the falling revenues and to pool resources for meeting contingency spending arising out of multiple anti-Covid-19 programmes launched by the government. Expenses of every department barring the Health and Family Welfare have been stopped. All air travel and first class train journey by officers have been disallowed. A complete ban has been put on purchase of new vehicles. Officers have been told to reduce travelling and monitor programme implementation through video-conferencing instead. All expenditures for renovating government buildings and guest houses and re-furnishing of offices have been stopped. Expenditures beyond ₹5 lakh for repair and renovation of government office buildings and over ₹2 lakh for repair and renovation of government residential quarters would not happen without special approval. There has been a complete ban on meetings, seminars, workshops and holding of official lunch and dinner in hotels with government funds. Officers have been told to go for video-conferencing mode instead. A ban has been put on leave travel allowance of government employees. No new state scheme or projects to be taken up by the administrative department except for Health and Family Welfare department. A complete freeze has been put on fresh recruitment while permission has been given for hiring for existing posts.

The cost-cutting measures announced in the wake of the pandemic are only a repetition of an extant policy that the government had brought in to tamp down spending in 2001 – years after the Biju Janata Dal government came to power. In fact, checking the runaway expenses leading to a mounting debt burden was a priority area for the new government. Even though the memorandum was still in force, the government allowed every department to splurge money on luxuries. Scores of populist schemes were introduced without statutory monitoring for political considerations. Thousands of crores of rupees were spent on unplanned programmes. The government allowed itself to violate its own circular. The Finance department is responsible for such gross financial indiscipline. The department allowed wasteful expenditures by senior bureaucrats who spent big on their tours, foreign jaunts and remodeling of office chambers, among others. The Finance department approved proposals for purchase of costly vehicles when there were curbs on purchase of luxury cars. Bureaucrats were allowed to blow money on office decorations and fancy furniture as if these were their rights. All such wasteful expenditures would not have taken place without the consent of the Finance department. The result was the total debt burden of the state shot up from below ₹20,000 crore in 2001 to above ₹1lakh crore now. The per capita debt load has gone up to ₹20,000.

India has been going through an unforeseen economic recession. Countries across the world are jacking up public spending to create opportunities and employment. The Centre on is part has earmarked ₹20 lakh crore to be spent under different welfare programmes and to help people overcome the crisis triggered by the pandemic. The coronavirus has exasperated the contemporary economic slump. Millions of people have lost jobs. The rate of unemployment is at a record high. The general despondency among public is not going to go in near future, at least until the discovery of a vaccine. In such times, a blanket ban on state spending on schemes and development programmes may not make much economic sense. A ban on wasteful government expenditure is welcome. But banning all expenditures regardless of their implications for the poor could have been avoided. A public announcement banning all government spending will exasperate the depression. Cutting down the flab is welcome, but extending the ban across all spending including welfare and development may be a mug's game.



TIME TO SPEND, NOT SAVE

ith shrinking revenue, the Union government hasreprioritized its spending and taken a slew of new austerity measures to contain the fiscal deficit and overcome the mounting debt burden. The current fiscal, the government banned new public-funded schemes and freezed creation of new posts. Various states including Odisha

have also taken similar steps as the Centre had imposed limits on states' borrowing capacity in contravention of the principles of cooperative federalism. While the Centre has allowed states to increase fiscal deficit from 3 percent to 5 per cent of the GSDP, fact is also that out of this 2 per cent, an additional borrowing space of 1.5 percent is conditional.

In reality, austerity measures will effect a contraction of the economy, while the Covid-linked lockdown scenario would require perusal of an expansionary policy through higher spending. Since private spending got subdued due to supply disruptions, restriction of people's movement and business activities, an increase in government spending, more of job creation and new schemes are vital for a revival of the economy facing recessionary trends.

While the world has announced a\$1100 billion package for revival, India has come up with around \$226 billion, of which fiscal outgo is around \$27 billion. Monetary measures like liquidity infusion and lower interest rates are aimed at addressing supply-side problems or supply disruption. But problems are from the demand side, especially a compression of demand. Supply disruption can be eased only when people move around freely.

The present situation is demanding more of expenditure, as opposed to austerity, and has linkages with the concept of the "paradox of thrift" popularised by John Maynard Keynes. The theory has it that if households decide to save more and consume less during a slowdown or recession, then the resulting reduction in aggregate demand will aggravate the economic decline.

In the present Covid-induced recession, people are forced to save more due to uncertainty about the future and the ban on free movement, economic activities and business transaction. As a re-

sult, aggregate demand has come down, leading to a further decline in growth. As such, the correct policy response is to increase government spending, and not resort to austerity measures.

No investment will come and no industry will function if there is no demand for products. Hence, spending is vital. Each spending, whether public or private, creates job opportunities. While public expenditure leads to equitable growth, private sector expenditure is inequitable in nature. The government must spend money or have it spent in large quantities to create the demand needed to fuel economic growth.

Hence, steps like a ban on recruitment as also stalling new schemeswill have potentially catastrophic consequences. Any spending cut or job squeeze would hurt the economy, hinder recovery, undermine long-term growth, and increase inequality and discrimination.

A major question is whether the implementation of immediate fiscal austerity during a fragile economic recovery is justified and whether it will help in deficit reduction. According to Paul Krugman, Nobel Prize-winning economist and columnist, cutting spending in a depressed economy is a had idea

Past experience shows that austerity measures in times of demand compression or recession have backfired or boomeranged.

Amid the 2007-08 financial crisis in the US that later spread to Europe, the principle of austerity as a cure was adopted by central banks and encouraged by economists. They believed that a tough fiscal policy was the only treatment for excessive debt and any easing would spell disaster. As countries started to act this way, many realised that such policies were self-defeating and counterproductive. Economies already hurt by the crisis were condemned to perpetual stagnation and shoulder even larger debt burdens. The IMF report reveals that the belt-tightening by the European governments has had a negative effect on the economies of these countries and unemployment scenario became more acute.

An examination of how states fared during and after the economic downturn a decade ago hints that states which preserved or expanded their public sector workforce weathered the recession better and came out with fewer job losses, fewer private sector job cuts, and saw lesser growth in unemployment and faster job growth during the recovery.

It is argued that a country wading in a sea of debt needs to tighten its expenditures. Although the austerity strategy can lead to deficit reduction and prevent insolvency in the case of an indebted individual, this may not necessarily be the outcome in the case of national indebtedness. The

problem is accentuated when aus terity measures are replicated by other countries or by various

It is argued by fiscal hawks that an increase of expenditure without generating commensurate revenues will led to a rise in fiscal deficit; and that large fiscal deficits will cause high interest rates, larger government debts, and inflation. Even if the deficit doesn't spark high interest rates and inflation, they erode business con-

There are also those who argue that deficit should be contained as it hurts the welfare of future generations through a rise in debt. A nation that is heavily indebted needs to implement more borrowings to pay back its lenders. But the problem is not a rising debt.Problem is that beneficiaries of debt-driven growth are not the masses but rich and corporate honchos. This needs to be reversed first.

In general, drastic cuts in government spending increase unemployment and may drag the economy down to a degree that the government's tax revenues fall. The GDP also declines and as a result fiscal deficit and borrowing as percentage of GDP also rise. This outcome defeats the intention of lowering government debt. It would be equally bad for the government, as a shrinking economy also means shrinking tax receipts.

If the government is reluctant to borrow from market beyond a certain limit, it should resort to monetization of spending through monetization of some parts its deficit or through resort to spread of helicopter money. Central government should provide adequate funds to state governments so that they need not have to cut any spending and schemes, and can sustain jobs and growth momentum.

Does austerity at this point make any sense? This may well be the issue of the moment, but right now a resort to austerity would be a huge mistake. There is need for developing a workable recovery programme. Otherwise, the Great Shutdown' could take the nation, and the world, to another Great Depression, with enduring low growth and high rates of unemployment. A depressed economy would be a disastrous proposition.

Hell in uniform, killer cops on the prowl

N Secretary-General Antonio Guterres has stressed that every death in police custody with signs of torture should be investigated. Two incidents- one in Tamil Nadu in a place notorious for custodial violence and the other in Uttar Pradesh – involving police handling of accused person(s) in their custody have rocked the entire nation in recent days. The first related to the death of a father and son in police custody for interrogation and the other to encounter killing of an arrested person. The TN case is entrusted to an eight-member CBI team for investigation.

The Tamil Nadu case apparently arising from a minor offence of violation of lockdown rule on closing time of shops led to arrest of a shop owner and his son and shutting them in police lock-up. The

allegation is about merciless torture of the traders in police custody to the extent of causing their death. The irony is that the incident happened close to the International Day in Support of Victims of Torture observed on June 26. The offence in this case is not grave by any stretch of imagination to require excessive use of police force. The UP case is a clear case of police excessafter murder of eight cops by the accused.

It is for the government and legal and judicial authorities to deal with the cases. They will do it with reference to existing laws and regulations and prescribed procedures. For the society, more important is the criminal law and procedure and the role, responsibility, and authority of the police including methods of investigation and treatment of the accused and witnesses. Union Home Minister Amit Shah has categorically asserted a few days back that the age of third degree torture is over. He had been saving that the central government has "zero tolerance on custodial deaths, extra-judicial deaths, and police atrocities". A Member of Parliament has

pointed out to the Home Minister that during 2019, the National Human Rights Commission recorded 1,723 cases of death of persons in judicial and police custody across the country. Though there could be many reasons for death, the number, if accurate is a cause for concern and remedial action. NHRC has registered over 400 cases of alleged death in police custody and over 5,000 cases of death in judicial custody. The MP has also referred to an analysis by the National Convention Against Torture for the period 2005-2018 which revealed that of the 500 deaths in police custody, only 281 cases were registered and 54 policemen were charge-sheeted and no one has been convicted.

The UN Convention Against Torture was adopted by the UN General Assembly on 10 December 1984 and came into force in 1987. India became a signatory in 1997, but has not yet ratified the Convention by a comprehensive law. By June 2020, the Convention

had 170 state parties. Prohibition of torture has long been established as a universal code or jus cogens that all countries have agreed to abide by. The Committee Against Torture (CAT) is a body of human rights experts that monitors implementation of the Convention by State parties.

To ratify the convention, the Prevention of Torture Bill was introduced in the LokSabha in May 2010, but it lapsed. Its main provision was to make torture a punishable offence. The bill was again brought in the LokSabha in 2017 and 2018 as a Private Member's Bill, but could not be passed. Some MPs are now demanding promulgation of an ordinance to curb custodial violence and police brutality.

Under NHRC Guidelines of 1993, every incidence of custodial death or rape must be reported to the Commission by the concerned State within 24 hours, and should be followed by post-mortem report, a video report, and a magisterial

MP politics heats up over Guna's Dalit beating

Bhopal, July 16: The case of police atrocity on members of a Dalit family in Guna district has heated up the politics of Madhya Pradesh.

The Congress has gone belligerent on the Shivraj Singh Chouhan government accusing it of persecuting Dalits and the poor, even as the administration in a strong move removed the IG of Gwalior division, the Guna Superintendent of Police and the District Magistrate.

The Dalit family was brutally beaten up by the police during an anti-encroachment drive. Videos on social media showed a man, his wife and two children at the receiving end of the police action. The man was seen being dragged by the police after being beaten up as the woman and the children begged and grovelled in the dust of the open field, where he was en-

gaged. The man faced the brunt of police action for occupying the piece of land meant for college building in Cantt area of Guna. This incident dates back a few days ago. The Dalit couple had then consumed insecticide. The video of the incident went viral on the social media and now, the matter has taken on political hue with the Congress targeting the state government for being anti-Dalit.

The government also swung into action and removed the administrative staff after ordering an in-

Political analysts say that the incident happened in the area from where Jyotiraditya Scindia, who moved to the BJP in March after toppling the Congress government, has been MP and the assembly bypolls are going to be held in 16 constituencies in the Gwalior-Chambal division soon

It is for this, the Congress has started training guns at the Shivraj government. Former Chief Minister Kamal Nath, who is also the MPCC president, has questioned the excesses that were inflicted to the Dalit family and asked, "Will Shivraj government show such courage to redeem thousands of acres of government land occupied by the socalled public servants and influencers in these areas? Such an incident cannot be tolerated. Immediate action should be taken against the culprits, otherwise the Congress will not remain silent."

Retweeting a tweet of the Congress party, the former chief minister said, the Congress has always supported the poor and farmers in their fight against injustice. "This inhuman act of the Shivraj government has exposed the dictatorship in him. This is the beginning of the end of the Shivraj government in Madhya Pradesh,'

Jyotiraditya Scindia, now Rajya Sabha MP from the BJP, quickly damage controlled with the statement that Guna SP and Collector have been removed, and the incident is being investigated. "I am confident that action will be taken against all those responsible for this heinous crime," he said.

No causality has been reported so far due to the fire." said a senior police officer.

Militant killed

Srinagar: An unidentified militant was killed when troops foiled an infiltration bid along the Line of Control (LoC) in Kupwara district of Jammu and Kashmir on Thursday, an Army official said. He said the alert troops eliminated the intruder when they noticed suspicious movement across the LoC in Keran sector. "Terrorists tried to infiltrate but were intercepted by our troops. One terrorist was killed," the official said, adding an AK rifle was recovered. The operation was in progress when the last reports came in, he added.

Woman found dead in Shimla

Shimla: A 23-year-old woman working as an assistant to a high court lawyer was found dead at her rented accommodation here Thursday, the police said Prima facie, it seemed that she died due to electric shock. they added. The woman is a resident of Solan district and lived at a rented house here. An expert team from the state forensic science laboratory (SFSL) has been asked to visit the spot for inspection, they said. The additional superintendent of police (ASP) and the Sadar SHO visited the spot and the body has been sent to IGMC hospital for postmortem, the police added.

Gap in cured and active Covid cases quadruples in 30 days

New Delhi, July 16: India remains the third worst COVID-19 affected country in the world after the US and Brazil with over 9.68 lakh confirmed cases and the gap though between patients who have recovered and those still infected by the virus has almost quadrupled in the last one month

The trend was noted from June 16 and July 16 (Thursday) by the Ministry of Health and Family Welfare (MoHFW). As per the data, a total of 63.25 per cent COVID-19 patients have recovered so far while the active cases are 34.18 per cent.

Accordingly, in the one month, there is a gap of 29.7 per cent between the recovered patients and active novel coronavirus cases. There were a total of 52.47 per cent recovered cases on June 16 while the active cases were 44.65 per cent. It showed a gap of around 7.82 per cent then.

As per MoHF graph, from mid-June 2020 after crossing the 50 per cent mark in recovery rate, there is a steady increase in the recovered patients and decline in the number of active cases. Simultaneously, there has been a steady dip in the active cases

As on date, the actual caseload of COVID-19 patients in the country is only 3,31,146. These contribute to a little more than a third (34.18 per cent) of total cases detected so far.

The data further shows that only two states-- Maharashtra and Tamil Nadu-- constitute 48.15 per cent of the country's total active case load. Maharashtra remained the worsthit state, with 2,75,640 cases and 10,928 casualties followed by Tamil Nadu with a total 1,51,820 cases, including 2,167 deaths.

Of the total 36 states and Union Territories (UTs), the data says, only 10 states constitute 84.62 per cent of the total active case load.

States with more than 10,000 cases included Gujarat (44,552), Uttar Pradesh (41,383), Rajasthan (26,437), Madhya Pradesh (19,643), West Bengal (34,427), Haryana (23,306), Karnataka (47,253), Andhra Pradesh (35,451), Telangana (39,342), Assam (18,666), and Bihar (20,612).

LJP targets Bihar govt

New Delhi, July 16: The Lok Janshakti Party Thursday joined the opposition in attacking the Bihar government over the collapse of a road in floods, saying it raises questions on the claim of "zero corruption" and demands action against the "guilty"

The state government has insisted that it is an approach road to a new bridge connecting Gopalganj to East Champaran which has been washed away, and not the bridge itself as alleged by opposition leaders like Rashtriya Janata Dal's Tejashwi Yadav. In a tweet, LJP president Chirag Paswan targeted the Bihar government headed by Chief Minister Nitish Kumar.

"Part of a bridge built at the cost of ₹264 crore has collapsed today. Any work done with public money should be carried out maintaining quality standards. Incidents like this raise questions in the public eye over zero corruption. The LJP demands a high-level probe to punish the guilty quickly," he said.

Incidentally, the department is a part of the ministerial portfolio of senior BJP leader Nand Kishore Yadav in the state government.

2 killed, 15 rescued as buildings collapse

Mumbai. July 16: Two persons were killed and 15 others rescued from debris of two buildings that crashed in the city and its suburbs Thursday afternoon, the BMC Disaster Cell said. A few others could also be trapped, it added.

In the first case, two persons were killed and 13 others were dug out of debris of a three-storied tenement that crashed due to heavy rains at Malvani in Malad West. Four-five persons are feared to be trapped there. The Mumbai Fire Brigade and disaster teams are trying to rescue them.

The victims have been identified as 23-year-old woman Anjum S. Shaikh and an 18-year- old Faizal W. Sayyed. The rescued people were treated for minor injuries and discharged by Hayat Hospital nearby. In the second accident, the rear part of a five-storied Bhanushali Building collapsed at the Fort in South Mumbai due to rain, which lashed the city since the past four days.

No postal ballot for voters above 65 yrs

New Delhi, July 16: After criticism from various political parties, the Election Commission Thursday said that it has decided not to extend the facility of postal ballot to electors above 65 years of age in the coming Bihar Assembly elections and in bypolls due in near future.

The Commission, in a statement, said that it "has been constantly monitoring the electoral preparedness" for the coming byelections and the Bihar polls "in view of this unprecedented environment".

"The Commission has already limited the number of electors to one thousand for each polling station for ease of voting, especially for elderly and vulnerable sections of electors, in Covid-19 situations." However, facility of optional postal ballot to electors who are above 80 years of age, disabled voters, the electors engaged in essential services and voters who are Covid-19 positive/suspect in quarantine will be extended, it said.

The commission said in view of its restrictions on number of voters at a polling station. Bihar is creating approximately 34,000 additional polling stations (45 per cent more), which will increase the total number of polling stations to around 1,06,000.

"This would entail formidable logistical challenges of mobilizing 1.8 lakh more polling personnel and other additional resources including requirement of much larger number of vehicles in the state of Bihar, Similar challenges would be there for the coming byelections also," it said.

Dubai hosp waives ₹1.52 cr Covid bill of Indian worker

Hyderabad, July 16: A hospital in Dubai has waived the ₹1.52 crore bill of a labourer from Telangana, who was treated there for Covid-19.

The 42-vear-old was admitted to Dubai Hospital on April 23 and had tested positive for Covid-19. Assam flood situation grim

Guwahati, July 16: Amid the rising COVID-19 cases, the flood situation in Assam remained grim Thursday, as five more deaths were reported from four districts, taking the death toll due to the deluge to 71, while around 40 lakh people across 27 of the state's 33 districts have been affected.

According to officials of forest department and Assam State Disaster Management Authority (ASDMA), at least 76 animals were killed. while 121 animals were rescued as 95 per cent of the world-famous Kaziranga national park, home to more than 2,200 one-horned Indian rhinoceros, was inundated

An ASDMA official said that over the past more than a month, 71 deaths due to the floods were reported from Sonitpur. Biswanath. Tinsukia, Lakhimpur, Bongaigaon, Kamrup, Golaghat, Sivasagar, Morigaon, Tinsukia, Dhubri, Nagaon, Nalbari, Barpeta, Dhemaji, Udalguri, Goalpara and Dibrugarh districts, while 26 others have been killed in separate landslides since May 22.

The officials said that more than seven rivers, including the mighty Brahmaputra, are flowing above the danger mark in many places in more than 12 districts

Quoting reports from the districts, they said that the floodwater has submerged 3,218 villages, affecting around 40 lakh people and 131,368 hectares of crop area in 27 districts

The District Administrations have set up 748 relief camps and distribution centres in 25 districts. where around 50,000 men, women and children have taken shelter.

Girl raped outside Covid ward

Patna, July 16: A security guard of Patna Medical College and Hospital (PMCH), the largest hospital in Bihar, has been arrested for allegedly raping a minor girl outside a Covid ward in the hospital, police said.

A police official said Thursday, that July 8, the minor girl was seen wandering at Barh railway station. The child helpline rescued the 15-year-old girl and handed

over to the PMCH for Covid test. It has been alleged that on the night of July 8, the ward's secu-

rity guard Mahesh Prasad (40) took the victim to the bathroom and raped her.

The victim did not reveal this to anyone out of fear. When the members of Child Helpline came to see her on Wednesday, she narrated the ordeal. Aarti Jaiswal, in-charge of Patna Mahila Police Station, said an FIR has been lodged in this connection on the basis of victim's statement and the accused has been arrested. She said that the victim has been medically examined, the report of which is vet to come. Police is investigating the entire case, she added.

Incubation Cell and has a vision to revolutionise housing through modular prefab structures. They have re-purposed their designs to support the fight against Covid-19.

The outcome of this pilot project in Kerala will help in proving the applicability of the technology and advantages of micro hospitals, with MediCAB as an instant infrastructure solution. It can be easily assembled in eight hours by four people. When folded, our collapsible cabins are reduced five-fold, making it very cost-effective for transportation," Shreeram Ravichandran, Chief Executive Officer said.

"Health infrastructure is crucial in fighting any pandemic. With a contagious disease such as Covid-19, it is essential to have smart health infrastructure to screen, contain and treat people. Unlike urban areas where there is plenty of existing infrastructures that can be converted to hospitals, rural areas do not have a lot of infrastructure. It is difficult to construct buildings from scratch as the requirement is immediate. As the rural population density is relatively low, more micro hospitals help greatly in tackling COVID-19 cases.

Modulus is working on a dual design where these can be rapidly launched as Covid-19 isolation wards. Post Covid-19, these can be transformed into micro-hospitals/clinics in rural India where the medical infrastructure needs to be augmented. Modulus Housing has set up its manufacturing unit at Chengalpet (located about 35 kms from Chennai).





Haryana gears up for intense locust attack

Chandigarh, July 16: The Harvana government has stepped up efforts to control locust swarms and crop damages in view of warning about potential intense attacks in several districts after July 22.

Additional Chief Secretary Sanjeev Kaushal said, here Thursday, arrangements had been made to stock additional quantities of pesticides. The locust swarms in the region had become resistant to the commonly used pesticide Chorpyriphos, he added.

To prevent homogeneity in use of pesticides during repeated spraying, arrangements are being made to stock 20,000 litres of Lamda Cyhalothrin in addition to existing stocks of pesticide.

Three drones were being purchased for aerial spray of pesticide, he said.

According to Kaushal, 66 fire-tenders are available along with 3,540 tractor-mounted spray pumps. The state would also acquire fogging machines being bought by the Centre from the UK for use on trees.

The Locust Warning Organisation has warned of high intensity attacks in Nuh, Rewari, Mahendragarh, Bhiwani and Charkhi Dadri districts after July 22 as large-scale locust breeding was observed in the Jhunjhunu district in Rajasthan.

These attacks are likely to be far more severe than the previous ones over 13,038 acres in Jhajjar, Charkhi Dadri, Palwal, Sirsa, Nuh, Rewari, Bhiwani and Narnaul districts between June 26 and July 16.

Kaushal said farmers in Jhajjar, Palwal and Nuh didn't report any losses due to locust swarms

The bench, also comprising justices R S Reddy and B R Gavai, asked the Centre and Jammu and Kashmir administration to file affidavits detailing the setting up of the committee and also the decisions taken by it.

The apex court was hearing a plea seeking initiation of contempt proceedings against the Union home secretary and chief secretary of Jammu and Kashmir administration for their alleged "wilful disobedience" in complying with the court's May 11 order for setting up a "special committee" to consider restoration of 4G internet serv-

ices in the Union Territory. On May 11, the top court had ordered setting up of a "special committee" headed by the Union home secretary to consider pleas for restoration of 4G internet services in Jammu and Kashmir, saying national security and human rights needed to be balanced in view of the fact the union territory has been "plagued with

Thakur, DCP South Delhi. The deceased was identified as RajMani Patel, a resident of district Satna in Madhya Pradesh. The deceased underwent intestinal surgery at the AIIMS Hospital in July 2019. In continuation of his treatment on July 15, he came for further treatment in the AIIMS Trauma. His admission was made at about 11.30 p.m. on Wednesday. In the meantime, the deceased went missing from the admission area. Thereafter, he was found hanging in the bathroom at Yellow Zone, AIIMS Trauma Centre.

The deceased was rushed to the emergency area where doctor declared him brought dead.

'REAL TOURISM' YET TO BEGIN

Fresh lockdown in Goa to affect tourist sentiment

have crossed 1,000, in India's smallest state with a population of just 1.5 million. Most of the cases have been reported over the last one month. Sawant had said the state could be heading towards peak numbers, especially in view of the monsoons, when he said there was a tendency for viral infections to increase.

Shah said that despite the state government opening up the state for tourism on July 1, "real tourism" had not started. "Generally speaking, tourism hadn't really picked up in the state with only 5-7 per cent hotels having some occupancy and that too was only people of the younger, more care-free generation," Shah said.

"The real tourism in which people travel with their families has yet to begin and with bars and swimming pools closed that will take some time to restart," he added. The official also said that the industry stakeholders were awaiting a formal notification from the district administration explaining further details about the lockdown.

"We are awaiting the notification from the (District) Collectors which will tell us what exactly will be opened and closed. But we understand that flights will not be affected. So tourists already in the state may not be affected a great deal," Shah said.

30 killed in flash floods

Indonesia: Flash floods and landslides killed at least 30 people on the Indonesian island of Sulawesi and left hundreds displaced, authorities said Thursday. Fifteen people remain missing, Indonesia search rescue agency spokesman Yusuf Latif said in a statement. The flash floods struck the North Luwu district of South Sulawesi province after heavy rain on Monday caused three nearby rivers to burst. More than 4.000 residents were affected.

Netanyahu's popularity drops

Jerusalem: Israeli Prime Minister Benjamin Netanyahu's popularity has dropped as he is facing a criminal trial, the coronavirus crisis and an economic setback, according to a new poll. The poll, issued Wednesday by Israel's Radio 103fm, the popularity of the embattled leader has been decreasing even among voters of his right-wing Likud party, reports Xinhua news agency. Some 41 per cent of the Likud voters said that they believe the government has failed in handling the crisis.

Iran faces shortage of medics

Teheran: Hospitals in Iran face acute shortages of medical personnel and beds as the country tackles a powerful second wave of the COVID-19 pandemic, a senior official of Tehran's anticoronavirus task force said Thursday, Iran, the Middle East country hardest hit by the pandemic, began relaxing its lockdown in mid-April.

India gets second 'consular access'

Islamabad, July 16: Pakistan Thursday provided consular access to Indian prisoner on death row Kulbhushan Jadhav, days ahead of a deadline to file a review petition in a court here against his conviction by a military court. This was the second consular access to Jadhav. The first consular access was provided by Pakistan on September 2, 2019, the Foreign Office said in a statement.


Jadhav, the 50-year-old retired Indian Navy officer, was sentenced to death by a Pakistani military court on charges of "espionage and terrorism" in April 2017. Weeks later, India approached the ICJ against Pakistan for denial of consular access to Jadhav and challenging the death sentence. The Hague-based ICJ ruled in July last year that Pakistan must undertake an "effective review and reconsideration" of the conviction and sentence of Jadhav and also to grant consular access to India without further delay.

"Two consular officers of the Indian High Commission in Islamabad were provided unimpeded and uninterrupted consular access to Commander Jadhav at 1500 hours," the FO said in the statement on Thursday.

It also recalled that the mother and wife of Jadhav were allowed to meet him on December 25, 2017.

"Pakistan remains committed to fully implementing the International Court of Justice (ICJ)'s judgment of 17 July 2019. It is hoped that India will cooperate with the Pakistan court in giving full effect to the said judgement," the statement said.

Oxford University Covid-19 vaccine raises hopes

London, July 16: Researchers at the University of Oxford believe they may have a breakthrough in their search for a Covid-19 vaccine after the team discovered that the jab could provide "double protection" against the deadly coronavirus following early stage human trials, according to media reports in the UK.

Blood samples taken from a group of UK volunteers given a dose of the vaccine showed that it stimulated the body to produce both antibodies and killer T-cells, a senior source from the trial was quoted by The Daily Telegraph' as saying. The discovery is promising because separate studies have suggested that antibodies may fade away within months while T-cells can stay in circulation for years. However, the source cautioned that the results, while extremely promising, did not yet prove that the Oxford vaccine provides long-lasting immunity against the deadly virus.

The vaccine development, by the university's Jenner Institute, is being supported by the UK government and AstraZeneca, which will support the production phase.

Chinese executives get 'pre-test' injections in nCoV vaccine race

Beijing, Jul 16: In the global race to make a coronavirus vaccine, a state-owned Chinese company is boasting that its employees, including top executives, received experimental shots even before the government approved testing in people. "Giving a helping hand in forging the sword of victory," reads an online post from SinoPharm with pictures of company leaders it says helped "pre-test" its vaccine. Whether it's viewed as heroic sacrifice or a violation of international ethical norms, the claim underscores the enormous stakes as China competes with US and British companies to be the first with a vaccine to help end the pandemic a feat that would be both a scientific and political triumph.

"Getting a COVID-19 vaccine is the new Holy Grail," said Lawrence Gostin, a global public health law expert at Georgetown University. "The political competition to be the first is no less consequential than the race for the moon between the United States and Russia.' China has positioned itself to be a strong contender. Eight of the nearly two dozen potential vaccines in

various stages of human testing worldwide are from China, the most of any country. And SinoPharm and another Chinese company already have announced they're entering final testing.

Both China and SinoPharm have invested heavily in a tried-and-true technology—an "inactivated" vaccine made by growing the whole virus in a lab and then killing it, which is how polio shots are made. Leading Western competitors use newer, less proven technology to target the "spike" protein that coats the virus.

That protein is "a good place to make our bet," Dr Gary Nabel, chief scientific officer of the French

pharmaceutical company Sanofi, said at a US biotechnology industry meeting. But "it's good to have some diversity. I like the fact that there is an inactivated, whole vaccine. That provides an alternative in case one of these should fail." SinoPharm's claim that 30 "special volunteers" rolled up their sleeves even before the company got permission for its initial human study raises ethical concerns among Western observers. The company's post cites a "spirit of sacrifice' and shows seven men in suits and ties - a mix of scientists, businessmen and one Communist Party official with a background in mil-

Oli-Prachanda meeting ends without progress

Kathmandu, July 16: With embattled Prime Minister K P Sharma Oli refusing to resign or give up his position as chairman of the ruling Nepal Communist Party talks aimed to strike a new power-sharing deal between him and former premier Pushpa Kamal Dahal 'Prachanda' failed to make any headway Thursday on the eve of a crucial meeting of the party.

Prime Minister and party chairman Oli, executive chairman 'Prachanda' and former premier Madhav Kumar Nepal held an informal meeting at the PM's official

residence at Baluwatar on Thursday, ahead of the meeting of the party's 45-member powerful Standing Committee. However, the three leaders failed to reach a deal after Oli and Prachanda, who is leading the dissident group, stuck to their demands, said Standing Committee member Ganesh Shah.

The trio tried to sort out differences between Oli and the dissident group. But, as the Prime Minister didn't accept their condition of a one-man-one-post, the talks failed, he said. Oli and Prachanda have failed to reach a power-sharing deal even after at



least eight rounds of talks in recent weeks. Thursday's talks took place just ahead of the Standing Committee meeting on Friday which is expected to determine the political future of the 68-year-

old prime minister who has pre viously alleged that his detractors were trying to remove him with India's help. Top party leaders, including 'Prachanda', have been demanding Prime Minister Oli's resignation, saying his recent anti-India remarks were "neither politically correct nor diplomatically appropriate." 



What's behind rising tensions in the SCS? TROUBLED WATERS

Hanoi, July 16: The United States this week hardened its position on the South China Sea, where it has accused China of attempting to build a "maritime empire" in the potentially energy-rich waters, despite regional concerns.

The rivals have accused each other of stoking tension in the strategic waterway at a time of strained relations over everything from the new coronavirus to trade to Hong Kong.

A statement from U.S. Secretary of State Mike Pompeo on July 13 was the first time the United States had called China's claims in the sea unlawful and accused Beijing of a

"campaign of bullying". But heated rhetoric has also been on the rise in the region, where

Brunei, Malaysia, the Philippines, Taiwan and Vietnam challenge China's claim to about 90% of the sea.

REGIONAL TENSIONS

Vietnam, frequently at loggerheads with China over the issue, is this year chairing the 10-member Association of South East Asian Nations (ASEAN).

At a June 26 summit in Hanoi, Vietnam and the Philippines -China's most vocal challengers over the sea - warned of growing regional insecurity amid concern that Beijing was advancing territorial claims under the cover of the COVID-19 pandemic. As China held military drills in the South China Sea this month, Vietnam said Beijing's actions were "detrimental" to its relationship with the Southeast Asian bloc. The United



States simultaneously deployed two aircraft carriers to the area for what it said were pre-planned ex-

In a blustery response to the Chinese drills, Philippine Foreign Minister Teodoro Locsin said China "will be met with the severest response, diplomatic and whatever

China illustrates its claims with a vague, U-shaped "nine-dash line" that includes swathes of Vietnam's exclusive economic zone, or EEZ, as well as the Paracel Islands and Spratly Islands. It also overlaps the EEZs of Brunei, Indonesia, Malaysia, the Philippines, Taiwan and Vietnam

A tribunal at The Hague, based on a suit brought by the Philippines, ruled in 2016 that China has no "historic title" over the waters, and that its line was superseded by the 1982 U.N. Convention on the Law of the Sea.

Last year, Chinese and Vietnamese vessels became embroiled in a months-long standoff in Vietnam's EEZ where a Chinese research vessel conducted a sweeping seismic survey of waters overlapping Vietnamese oil blocks.

Russian news agency RIA cited spokesman Dmitry Peskov as saying the Kremlin rejected London's allegations, which he said were not backed by proper evidence.

In a separate announcement Britain also accused "Russian actors" of trying to interfere in its 2019 election by trying to spread leaked documents online. Russia's foreign ministry said those accusations were "foggy and contradictory". Britain is expected to publish a long-delayed report into Russian influence in British pol-

New Delhi, July 16: As the deadline for submitting the Expressions of Interest (EoI) for 52.98 per cent stake in the Bharat Petroleum Corporation Ltd (BPCL) nears, big names in the global oil market are showing interest in picking up the majority stake in the state-run oil company.

According to official sources Saudi Aramco, Abu Dhabi National Oil Co (Adnoc), Rosneft of Russia and Exxon Mobil intend to participate in the bidding process for the PSU. The deadline for submitting EoIs has been postponed twice and the current deadline ends on July 31.

Indian oil majors are not behind their global counterparts and are also actively pursuing the prospects of bidding for BPCL. Oil-to-telecom major Reliance Industries is understood to have shown interest for the bid.

The disinvestment in BPCL involves the government selling its entire 52.98 per cent stake in the company to a strategic investor with transfer of management control.

The Centre has allowed prospective bidders with a minimum net worth of \$10 billion to present their bids. Another condition pertains to a maximum of four members are permitted in a consortium, and the lead member must hold 40 per cent in proportion. Other members of the consortium must have a minimum \$1 billion net worth.

The EOI allows changes in the consortium within 45 days, though the lead member cannot be changed. The Indian government proposes

to disinvest its entire shareholding in BPCL comprising 1,14,91,83,592 equity shares held through the Ministry of Petroleum and Natural Gas. which constitutes 52.98 per cent of BPCL's equity share capital, along with the transfer of management control to the strategic buyer (except BPCL's equity shareholding of 61.65 per cent in Numaligarh Refinery Ltd (NRL) and management control

Arsenal break Reds' hearts ending newly-crowned champions' bid for 100 points in Premier League

London, July 16: Liverpool will have to settle for just lifting the Premier League trophy next week. It won't be accompanied by a recordbreaking points total after losing 2-1 at Arsenal.

Having ended the club's 30-year title drought, Liverpool has eased up and the bid to match or overhaul Manchester City's 100-point record

Arsenal scored from their first two shots on target — to cancel out Sadio Mane's opener — and Liverpool provided the assists through carelessness Wednesday.

'We are all human," Liverpool manager Jurgen Klopp said. "I cannot make a negative out of something so positive — becoming champions so early in the season. These boys have played an exceptional season and no one can take that away from them.'

Under pressure from Arsenal forward Reiss Nelson on the edge of the penalty area, Virgil van Dijk opted for an ill-judged back-pass. Alexandre Lacazette intercepted the ball and rounded goalkeeper Alisson before tapping in Arsenal's equaliser in the 32nd minute.

Alisson was at fault for Arsenal's winner by clearing the ball straight to Lacazette, and Nelson applied the finish in the 44th.

"The goals we gave them were a present," Van Dijk said. "Until the first goal it was totally us and we were dominant. But if you give goals like that away, including myself, you get what you deserve.

"Goals like that shouldn't happen and it happened twice tonight. Until I make the mistake, we did nothing wrong. I take the blame for it, of course, I take it as a man and we move on.

It had initially been Arsenal's defending that was providing gifts. Mane was left unmarked to meet Andrew Robertson's cross and put Liverpool in front in the 20th minute.

But Liverpool now has just one point from its last two games after being held 1-1 by Burnley at Anfield, ending a bid to become the first team to finish a Premier League season with a perfect record at home. This was only Liverpool's third loss of the season but it means it can only finish with 99 points by winning its remaining two matches.

KLOPP'S MEN TO GET TROPHY ON THE KOP

LONDON: Liverpool's players will be presented with the Premier League trophy on a special podium built on the iconic Kop stand at Anfield after the team's match against Chelsea next week. The league is describing it as a 'unique' ceremony that has been designed because fans won't be able to celebrate the moment with the team, as matches are being held in empty stadiums during the pandemic. Jordan Henderson will be the first Liverpool player to lift a league championship trophy in 30 years, and for the first time since the Premier League era began in 1992. The specially erected podium will be surrounded by fan banners in the Kop at the July 22 match. Players have been involved in the planning of the ceremony, with club great Kenny Dalglish - the last manager to lead Liverpool to a league title - among the trophy presentation party. The match against Chelsea will be shown on free-to-air TV in Britain, and Liverpool and the Premier League are urging fans to stay at home to watch it rather than congregate at Anfield

The title was sealed in record time three weeks ago, with seven games to spare after a three-month pandemic-enforced break in the

The trophy will be presented to Liverpool players after final home match of the season next Wednesday

against Chelsea. With no fans allowed into Anfield

due to the coronavirus, a podium will be built in the iconic Kop stand for Jordan Henderson to become the first Liverpool player since 1990 to lift a league championship trophy.

Arsenal has won the Premier League four times since then, but not since 2004. The north London club is way off the pace this season, 40 points adrift. This win only lifted Mikel Arteta's side to ninth place, but it remains in the hunt for Europa League qualification.

A route into Europe also remains through the FA Cup with Arsenal playing defending champion Manchester City in the semifinals Saturday.

"We've been working hard and getting the win here against the leaders is good for us," Nelson said, 'and we will take it into the next

Manchester, July 16: The highlight reel of David Silva's decade at Manchester City is getting some top-quality bonus material from his last games with the club.

Silva scored from a direct freekick for the second straight home match to lead City to a 2-1 win over relegation-threatened Bournemouth in the Premier League on Wednesday.

The former Spain playmaker also set up Gabriel Jesus for the second goal in City's first match since winning its appeal against a two-year ban from European com-

Silva will leave City at the end of the season after a 10 year spell that will see him go down as one the club's greatest players, if not the best.

His display against Bournemouth had other Premier League players taking to social media to praise Silva, whose curling free-kick from the right edge of the penalty area in the sixth minute touched the crossbar as it went in.

'Sorry," Leicester midfielder James Maddison wrote on Twitter after Silva scored his free-kick, but David Silva is a true Premier League great. Have so much respect for him. Admire his character and ability. Genius at work and will miss watching him, won't miss playing against him whatsoever."

City fielded a heavily rotated side in view of the FA Cup semifi-nal match against Arsenal on Saturday but still just about had too much for Bournemouth, which grabbed its goal through David Brooks in the 88th minute and more

In fact, the visitors had two great chances to equalize in stoppage time through Callum Wilson and Sam Surridge. Bournemouth stayed in third-to-last place and three points adrift of safety with two matches remaining. West Ham and Watford, the teams directly above Bournemouth, have a game in hand.

Bournemouth had a second-half goal by Josh King ruled out for a narrow offsides — a VAR review backed up the on-field decision while City goalkeeper Ederson Moraes tipped a free-kick from Junior Stanislas onto the post in the first half. Jesus has now scored in three straight games for City and is thriving as the replacement for injured first-choice striker Sergio Aguero.

His improved confidence was highlighted in the way he took his goal, receiving a short pass from Silva just inside the area before cutting inside past Jack Stacey and Steve Cook and driving a low shot into the corner in the 39th minute.

It was Silva's 10th assist of the Premier League season, the fourth time he has reached double figures for assists in a single campaign.

Milan, July 16: Juventus were held to a 3-3 draw at Sassuolo in Serie A. although that will do little to slow its seemingly unstoppable march to a record-extending ninth straight league title.

Juventus are seven points ahead of Atalanta, which beat Brescia 6-2 Tuesday, and eight points ahead

of Lazio five games remaining after the capital side also drew — 0-0 at relegation-threatened Udinese. Fourth-place Inter is nine points behind Juventus and visits Spal Thursday.

It was Juve's third straight match without a win after a 2-4 loss against AC Milan — after going 2-0 up — and

a 2-2 draw against Atalanta. Juve seemed to be cruising early

as it went 2-0 up within 12 minutes following goals from Danilo and Gonzalo Higuain. However, Filip Duricic pulled one back in the 29th minute and Sassuolo had the better of the chances at the end of the first half.

Sassuolo turned things around shortly after the break as Domenico Berardi equalised with a free-kick and set up Francesco Caputo three minutes later.

Alex Sandro headed in a corner for Juventus to level in the 64th and Bianconeri goalkeeper Wojciech Szczesny pulled off a number of important saves throughout the match to leave the Bianconeri ultimately grateful for a point. Lazio has struggled since the

restart and was somewhat fortunate not to lose against Udinese. Rodrigo De Paul hit the post in stoppage time for Udinese, which inched seven points clear of the relegation zone. Lazio came into the match on

the back of three successive defeats and had only won two of its previous six matches since Serie A resumed following the break because of the coronavirus pandemic.

AC Milan boosted their chances of qualifying for Europe as it came from behind to beat Parma 3-1. Milan moved level on points with sixth-place Napoli, which drew 1-1 at Bologna. Roma is four points ahead after beating Hellas Verona

Elsewhere, Sampdoria beat Cagliari 3-0 to move eight points above the drop zone and 18th-place Lecce, which lost 3-1 at home to Fiorentina.
