TAX DEPT WILL NOW KNOW MORE ABOUT YO

Financial transactions will be shown in 26AS *only if taxpayers cross* the specified limit in an FY

AGENCIES

New Delhi, July 18: The income tax (IT) department has come up with a new Form 26AS. The objective is to prevent suppression of information by taxpayers. The IT department will seek full details of the taxpayers' financial transactions such as sale and purchase of stocks, real estate transactions and payment details of credit card bills.

The taxpayers' tax passbook or the form 26AS contains details of taxpayer and compliance details along with other financial transactions. From this year, its format has been changed to include specified financial transactions of taxpayers that will be presented on the form of Statement of Financial Transactions (SFTs).

Taxpayers' other details such as Aadhaar number, date of birth, mobile number, email ID and address will also be present in the new form.

now being shown in Part E of Form 26AS to facilitate voluntary compliance, tax accountability and ease of efiling of returns so that the same can be used by the taxpayer to file her or his income tax return (ITR) by calculating the correct tax liability in a feelgood environment. This would also bring in further transparency and accountability in the tax administration," the statement read.

The IT department used to receive

information like cash deposit/withdrawal from saving bank accounts, sale/purchase of immovable property, time deposits, credit card payments, purchase of shares, debentures, foreign currency, mutual funds, buy back of shares, cash payment for goods and services, among others under Section 285BA of Income-tax Act, 1961 from 'specified persons' like banks, mutual funds, institutions issuing bonds and registrars or subregistrars, with regard to individuals having high-value financial transactions since the Financial Year 2016 onwards. Now, all such information under different SFTs will be shown in the new Form 26AS.



AYUSH doc beats father to death in Capital, held

Bhubaneswar, July 18: The Commissionerate Police arrested an AYUSH doctor on charges of killing his father, here Saturday. He was produced in a court.

The incident took place at Jagamohan Nagar in Jagamara area under Khandagiri police limits, July 16. The deceased has been identified as Rajkishore Mishra (73) and the accused as Ranjan Mishra.

According to Khandagiri police station IIC Rashmi Ranjan Mohapatra, the family comprised of Rajkishore, his son, daughter-in-law, two grandsons and one spinster daughter. They lived at Jagamohan Nagar. Ranjan worked as an AYUSH doctor at Banapur CHC.

For the last couple of

months, Ranjan had been accusing his father of having illicit relationship with his wife. Due to the frequent quarrels between father and son, Ranjan's wife along with their two sons had left the house a month ago and been staying at her parents' house.

According to a source, like any other day, Ranjan picked up a quarrel with his father on the issue July 16. Sources added that Ranjan sought to know if he was indeed the biological father of the two sons he has with his wife.

Soon Ranian lost his cool and became violent even though his sister, who intervened, could not calm him. Rajkishore was rushed to Capital Hospital here where he was declared brought-dead. Ranjan's sister has registered a case against him, accusing him of killing their father.

Bhubaneswar, July 18: They are ensuring that the citizens adhere to the Covid guidelines; they are making sure that the hoodlums cannot bank on this occasion and our streets remain safe, but are they safe? According to the Indian Police

Foundation (IPF), an independent think tank, "So far, 22,925 personnel of state police and Central police forces in the country have tested positive and 149 lost their lives in the pandemic so far."

Around 30 policemen have died while 2,200 others have tested positive for the novel coronavirus infection in Maharashtra alone, the worst-hit state.

Meanwhile, several officials of the Odisha Police were also tested positive for the virus and many more have been sent for quarantine. Around 40 policemen have been found infected with the coronavirus in Odisha, till date and five have succumbed. With the re-imposition of lock-

down in four districts including the Commissionerate Police, the police force has also been burdened with two tasks: ensure the citizens adhere to the guidelines and keep themselves safe while maintaining law and order even though it is impossible for them to follow social distancing norms while dealing with knuckleheads.

Many policemen were found not following safety measures while checking commuters at the important junctions in the city. The cops, who have been accompanying



the accused persons to the hospital for medical examination or to the courts for deposition before magistrates, were seen holding the accused persons' hand without wearing gloves; forget social dis-

HAVE PPE BUT UNFEASIBLE

Additionally, checkpoints in the capital city do not have adequate sanitisers for the police personne there. A sub-inspector on the condition of anonymity told Orissa POST, "The personnel have been supplied with PPE kits to wear during duty but it is quite difficult to stand under the scorching sun covered with the PPE kits. Similarly, many personnel approaching retirement have been deployed on law and order duty endangering their lives.

Some personnel also expressed their fear of getting infected while on-duty. One Havildar, Shrichandan Das, stationed at Acharya Vihar square here, said, "We aren't feeling comfortable while checking the commuters but it is our duty. People should help us by staying indoors and not roam in the streets."

Meanwhile, many home guards and constables in the Commissionerate Police are residing in slums where new Covid cases have sprung up.



Amid the lockdown and pandemic, Richa has started reading again, and she says the experience feels new.




ticipation. Attending the digital meet, Khurda Collector Sitanshu Kumar Rout said, "We all need to work together in these difficult hours.







SOP issued for 2 hospitals in Cuttack POST NEWS NETWORK

Cuttack, July 18: The state government Saturday stressed strict observance of the standard operating procedure (SOP) in the SCB Medical College and Hospital and Acharya Harihar Post Graduate Institute of Cancer (AHPGIC) to contain the spread of coronavirus in Cuttack.

The matter came to the fore during a review meeting at the district collectorate, Saturday. Collector Bhabani Shankar Chayini presided over the meeting attended by observers Saurav Garg, principal secretary, agriculture and Susant Mohapatra, additional secretary, general administration.

The development came after a number of patients and staffers of the SCB Medical College and Hospital and Acharya Harihar Post Graduate Institute of Cancer (AHPGIC) tested positive for

Garg said the SOP has been issued to strictly adhere to Covid-19 guidelines so that patient care and treatment does not get hit on the pretext of coronavirus. He asked all including the hospital

authorities to abide by the SOP in indoor and outdoor wards and shift patients to the Covid hospitals if they test positive for the virus during the antigen test. He further said steps have been

taken for door-to-door surveillance by special health teams in the city during the lockdown period to contain the spread of virus.

The observers asked the Collector and municipal commissioner to strictly adhere to SOP in all government and private hospitals. They also said that tele-medicine facilities will be launched in the hospitals so that patient care does not get hit and to avoid overcrowding in the hospitals. Police commissioner Sudhansu

Sarangi stressed on strict implementation of restrictions during the 14-days lockdown period. He asked the CMC authorities to work in coordination with police and CDF (enforcement) to avoid crowding and ensure observance of social distancing in vegetable and fish markets. The meeting had a thorough discussion on making the 14day lockdown effective and ensurand on awareness. A report on testing of people and tracing of suspected persons was presented by the district administration. The BDOs will supervise these operations through formation of Covid management committees in rural areas, the Collector said.

Moreover, the enforcement squad of BMC-BDA, health officials and Commissionerate Police continues to conduct surprise checks at hospitals/clinics and other places to ensure strict compliance of the norms.

Keonjhar village in darkness as 'Saubhagya' short-circuits

Patna, July 18: Years after electric poles were erected in their village and wires connected to their homes. residents of Saradhapur village under Chakundapal panchayat in Patna block of Keonjhar district continue to live under darkness amid administrative apathy.

The ambitious Pradhan Mantri Sahaj Bijli Har Ghar Yojana (Saubhagya), which was rolled out in the district with an eye to provide electricity to backward people like these, has failed to achieve what it set out for in Keonihar district.

There are about 24 families in this village who have been deprived of Saubhagya benefits despite having been included in it two years back.

According to villagers, a transformer has already been installed,

electric poles have been planted and electric wires have been drawn in the village. That said, despite running from pillar to post, the energy department authorities are yet to electrify the village.

"We have been managing with earthen lamps and kerosene lamps for past two years. Our concerns should be addressed immediately,' said a villager Kirtan Bihari Nayak.

As the village is located close to a forested area, residents panic to come out of their respective houses at night for the fear of wild animals. Their children study amid utter difficulties, another villager Sukanta Behera added.

On being contacted, Patana subdivisional officer (Electrical) Kartik Chandra Sahu said, "Electrification work of Saradhapur village was taken up under 'Saubhagya'. Almost 90 per cent of the work has already been completed. As soon as the contractor firm hands over possession after completing the remaining work, power supply will be commissioned".

Man killed for 'infidelity', wife among 8 held

Pabitranagar, July 18: Police cracked the Sunanda Pradhan murder case that took place at Shiling village under Samal police limits in Angul district last Wednesday and arrested eight accused including his wife. Sunanda was murdered over suspected infidelity.

All the accused were court forwarded and remanded to judicial custody as their bail pleas were rejected. The verbal duel then took an ugly turn when the accused lost their cool and started attacking Sunanda with wooden planks They continued beating him up till he collapsed on the ground and died. Bharati and her two daughters surrendered at the police station the same night while others fled from the spot.

After a thorough investigation, authorities came to know what had happened Wednesday night and arrested all the eight accused.

Local farmers failed to sell their produce owing to improper road connectivity and lack of marketing facilities, they alleged.

'Taking advantage of the simplicity of tribal farmers, the traders buy a pineapple for just Rs 5 to Rs 7 each; as against this, the traders of Chhattisgarh and Andhra Pradesh sell it for Rs 50 to Rs 70. Even to sell pineapples in local markets, we have to walk a distance of about 15 to 20 kilometres from Niyamgiri hill," a farmer lamented.

Besides, the farmers here face distress sale as there is no food processing and food preservation unit in this region. There are over 20 tribal villages around Niyamgiri hill. Usually, local farmers cultivate crops like mango, banana, orange, lemon, turmeric, ginger, jackfruit, tamarind, black pepper and ragi.

During the months of May and June, farmers here cultivate pineapple. The climatic condition of Kalahandi district is conducive for pineapple cultivation. Local tribal farmers sale their pineapple in Chatikana, Bissamkatak, Muniguda, Ambadola markets in Rayagada district and Lanjigarh, Biswanathpur, Bhawanipatna markets in Kalahandi district respectively.

Decision-making, Modi style

he news agency ANI reported a story this week with the headline: "PM" Moditaking input from top 50 officials to revive economy." The meeting was 90 minutes long and would have finance and commerce ministry officials making presentations on the situation.

What would such a meeting have looked like? If all 50 got a chance to give an input and nobody else spoke or asked questions, they would get less than two minutes each. But it is likely that there would have been someone doing some sort of introduction to the meeting and setting up the agenda so it's unlikely that the per person time was two minutes. Perhaps many of them did not get the opportunity to speak at all. The headline says that the PM was looking to receive input from them so many would have said their piece. What can be communicated in a couple of minutes?

Modi likes this sort of meeting. The first time I met him, with Dileep Padgaonkar (who was editor of Times of India) and BG Varghese (who was editor of Hindustan Times), both now dead, for an Editors Guild report on the violence in 2002. At that meeting, Modi called in all his secretaries, there were two dozen and perhaps more men sitting in rows to respond to us. There were no ministers. That was and apparently still is Modi's style.

The question is what happens at such large meetings for input and what is taken away from them. You would have a series of men saying extremely

concise things. And they would have to be prescriptive. The problem is already known: the ANI story says that the meeting would find means of a "speedy recovery of the economy which has witnessed a slowdown in recent quarters due to falling consumer demand.'

What would a two-minute prescription be? It would be something like: "The black money problem can be permanently solved by eliminating high value currency notes. We can force everyone to exchange their notes for smaller denominations and identify the black money sources. This will also end counterfeiting and reduce terrorism.

Such a presentation would lack nuance and it would not contain detail. It may or may not get into the problems that could come about because of such an action and it may or may not list the things that could go wrong in execution. There would not be enough time for this. It would merely present some sort of solution, and if the solution looked like a permanent fix and particularly if it sounded original and innovative, it would meet approval.

This is the problem of decision making

that is done on the basis of short and rapid input. But when one asks 50 people to gather and give a series of short and sharp inputs it is clear that this is the preferred style of functioning.

I have written before about this manner of Modi's governance. He has said in a very fine interview with Madhu Kishwar that he doesn't read files because he cannot govern through academic studies. He wants his people to reduce the substance of issues to a two minute synopsis which he will digest and then decide.

The problem here is that some things cannot be reduced to a short presentation because they are very complex. Many things are not clear. They are grey. Many details are not precise because there is not enough information or data. Many times what the possible consequences of decisions will be cannot be understood without very thorough analysis.

The issue of black money was such a matter. China relations is another as is Covid. The effect of a two-month lockdown is also complex. What it could do to the economy needs to be examined with great care and caution must be exercised before using such a blunt weapon as demonetisation or a total

My intent here is not to be needlessly critical or to be contemptuous. What Modi decides affects all of us and we must see what can be done in the best interest of our nation and its people at this time.

However, the decision making style needs to be examined and there is no running away from that. Let me quote another report, this time from Saturday July 18 in the Indian Express. The headline "Manufacturers fret as sudden lockdown hits logistics of production."

The story tells of the problems. One is that at 8 pm on July 13, Karnataka ordered a lockdown from the following day and told industries to shut. Companies including automobile manufacturers like Toyota told their workers to go home, informed vendors and issued a statement. But the next evening, the government sent another circular saying manufacturers were exempt from the lockdown. But the workers had already gone by then. One

week's production has been lost. Another problem was supply chains. Auto manufacturing does not all happen in one place. It is only assembled at the main factory but the components come from around the country. There was a lockdown in some of the states meaning that even if the main assembly plant was exempt from lockdown or in a state with no lockdown, production would slow or stop.

There are lockdowns in Tamil Nadu, Maharashtra, Bihar, Bengal, Karnataka, Uttar Pradesh, Odisha, Assam and elsewhere. There was no coordination to ensure that supply chains be kept going.

Similarly, companies could not access warehouses some of which were in lockdown. Another problem was workers who were reluctant to return given the problems that they had faced during the first lockdown.

These are issues of detail and complexity. They do not require decision making. They require governance, meaning the hard work of making the state function efficiently. It is true that India has always been a hard place to govern because it is chaotic and anarchic. The government doesn't follow its own rules often. It will not be easy for us to undo the damage that has been done to the economy by the lockdown and the solution will not come from two-minute

NO CARE FOR CARE WORKERS

¶hose who thought that a pandemic would make everyone realise the crucial role of care workers should think again. With the coronavirus still spreading rapidly, frontline workers are more essential – and at greater risk – than ever, yet public attention has shifted elsewhere.

Worse, as economies collapse and labour-market conditions deteriorate, employers in the private and public sector alike have grown more cynical in their treatment of essential workers. Far from instilling a deeper appreciation for their employees, the pandemic-induced surge in unemployment has enabled employers to exploit workers even more.

Capitalism has always had an uneasy relationship with care work. Although capitalist production relies heavily on unpaid and underpaid labour performed by women, migrants, and other disadvantaged social groups, it has historically pushed that work off the books and underground. into informality. As a result, all the varied tasks associated with social reproduction are barely recognised, much less rewarded or remunerated. Because so much care work is performed for free by women and girls within families and communities, it is simply taken for granted and, because it is outside the market, not counted

as economic activity. Unpaid work performed by women who have no other choice thus creates a vicious cycle of devaluation. When women do enter labour markets, their wages tend to be lower than those of men, not only because they are willing to work for less, but also because so much of their work is available for free. Hence, occupations dominated by women - such as in the care sector - tend to be lower paid; even men doing similar work suffer a wage penalty.

In the case of healthcare, there are additional occupational hierarchies to navigate, from highly paid 'professionals' like specialist physicians down to nurses, ward attendants, and cleaners.

Unsurprisingly, the gender balance within each occupation changes as one goes down the pecking order. with women concentrated in the lower-status, worst-paid positions.

Globally, women hold 70 per cent of all health-care jobs. But they are more likely to be nurses. midwives, and community health workers, while men comprise a disproportionate share of betterpaid occupations like surgeons, physicians, dentists, and pharmacists. Community health workers are perhaps the most exploited of all health workers, especially in developing countries. Often, they are not recognised as workers at all, but rather as 'volunteers' (as is true in India). As such, they rarely benefit from formal contracts that provide job security and a fair wage, let alone protections like healthcare.

Women healthcare workers are also more at risk in the current pandemic, because they are more likely to be involved in activities that require close physical contact with patients. For a brief period after the pandemic first erupted, these workers were widely recognised for their critical contributions to society. Around the world, political leaders and members of the public applauded essential workers, singing their praises from balconies and leaving

flower bouquets outside hospitals. But while healthcare workers at all levels were rightly described as "heroes," that seems to have represented the extent of their reward. The public acclaim has not translated into better working conditions or higher wages, and certainly not systematic efforts to ensure their physical safety during the pandemic.

For example, in the United States, a brief period during which some companies offered their frontline workers slightly higher wages was soon followed by reversion to the norm: wages returned to their previous lows -

and sometimes went lower. Similarly, in the United Kingdom, Prime Minister Boris Johnson thanked the immigrant nurses -"Jenny from New Zealand." "Luis from Portugal" - who saved his life when he was hospitalized with COVID-19. But then he had no problem trying to slap a surcharge on immigration fees (ironically for the purpose of funding the National Health Service).

The situation in developing countries is even worse. Governments faced with falling tax revenues are practicing austerity in the midst of a health emergency and recession, slashing non-COVID-19 health spending, forcing pay cuts and longer hours on health workers, and avoiding the expense of procuring personal protective equipment.

So blatant is the official disregard for essential workers that doctors and nurses in India have threatened to resign, while health workers in the Democratic Republic of the Congo have gone on strike after months of working without pay. Likewise, the needs of underpaid and vulnerable sanitation workers have been systematically ignored.

Decades of public neglect and underspending have brought us to the point that even an unprecedented global health emergency and economic collapse are not enough to make mistreatment of low-paid essential workers socially and politically unacceptable. If our societies are to survive at all, something will have to shake us from our complacency. Essential care workers deserve real pay and protections, not mere lip service. Our applause is no longer enough to keep them safe.

Pandemic & plight of women migrants-

THE INVISIBILITY

OF WOMEN FROM OFFICIAL STATISTICS AND POLICY **DISCOURSE HAS MARGINALISED** THEM FROM THE LIMITED STATE-SUPPORT. THE **POST-PANDEMIC ECONOMIC SITUATION IS LIKELY TO MARGINALISE** and their families, captured through horrifying images, brought out their rights to the centre stage. Partly as a response to this, state agencies and NGOs tried to provide some help to stranded workers. However, the problems faced by women workers, particularly from less developed states like Odisha,

remained largely invisible. Mobility of workers is not a new phenomenon though its frequencies have increased in recent decades. The latest data, which is almost 10 years old, provides a glimpse of changing patterns of inter-state migration. As per Census 2011, there were 54.3 million inter-state migrants in India, of which 30.4 million were females. Nearly 1.3 million migrants from Odisha reside outside the state, out of which 53 per cent are females. The top five destinations for women migrants from Odisha are Chhattisgarh, Andhra Pradesh, Jharkhand, West Bengal and Gujarat.

The main causes of migration of women are marriage and movement of families. Hence, there is a tendency to neglect women migrants in policy-making. However, women are increasingly migrating out for employment. Census

The coronavirus-induced lock-data reveals that out of the total out-information about migrant work-grammes like NREGA and Garib of women have migrated for employment. Besides, many women start working to supplement their family income after reaching their destinations, even if the initial cause is marriage. Even those women migrants, who are not part of the labour-force, contribute to the household economy through their unpaid and care work. Without their labour, a substantial section of the migrant labour would not be able to survive with meagre wages. Similarly, the left-behind women of migrant households, in the absence of men, shoulder major household responsibilities. However, women migrants remained largely invisible in the policy response towards the Covid-19 crisis

Women workers are mostly found in low-paid, vulnerable employment. They suffered immensely during the lockdown. Lack of income, inability to pay house rents and lack of savings added to their miseries.

In recent years, migration scenario from Odisha has undergone substantial changes, and it is valid for women as well. However, official statistical systems are blind to such changes. We simply do not have enough reliable

down severely affected many migrants from Odisha for a duraers from Odisha. Field surveys Kalyan Yojana was limited. many women migrants were recruited through labour contractors. Those who worked in sectors such as garments, brick kilns, construction and live-in domestic work faced restrictions on mobility. Women workers were subjected to coercion, confinement, and, in some cases, mental and physical violence by employers and associates. Digital divide across genders

leads to systematic exclusions. The government's efforts to provide relief through cash transfers to Jan-Dhan accounts, Building and Other Construction Workers' Welfare Board and Aadhaar are likely to have excluded many women workers Further health rights of women seem to have taken a back seat during the crisis. When stranded workers and their families tried to return, the special needs of pregnant and sick women were ignored.

After reaching their homes, migrants, especially women faced additional problems, such as hostility of local population, lack of adequate facilities for quarantine. Incidents of caste and gender discriminations were reported in some places. Besides, the access of women to livelihood generation pro-

attempt to survive the crisis, the role and condition of women within the households deserve particular emphasis. During a crisis, it is typically the health and nutrition of women of the household that suffer disproportionately. Also, a typical household survival strategy is to substitute purchased products by home-made and unpaid goods and services, the burden of which falls largely on women. The National Commission of Women has recorded a sharp rise in domestic violence against women

amid the lockdown. The invisibility of women from official statistics and policy discourse has marginalised them from the limited state-support. The postpandemic economic situation is likely to marginalise women further. There is an urgent need to examine the gender sensitivity of short and medium-term programmes that have been announced. The specific vulnerabilities of women migrants have to be taken into account in designing and implementing livelihood support programmes.

Who's next in Kerala gold smuggling case?

Thiruvananthapuram, July 18: As the four-year-old Pinarayi Vijayan government in Kerala was winning applause in the management of COVID-19, out of the blue came a gold smuggling case and a week later, two top officials in the Chief Minister's Office were booted out. The million dollar question now is who will be the next to fall?

observing a four-

month-long 'Chaturmasva Deeksha' since Sunday last, so he preferred to remain here and get treatment, Reddy said.

The pontiff's health condition is, however, stable, the chairman said.

Since the temple was re-opened for devotees June 11. about 160 TTD staff members, including 16 'archakas' (priests) were infected by the virus so far. he said.

Nevertheless, the devotees can

still visit the shrine, he added. A row erupted over the temple's honorary chief priest AV Ramana Dikshitulu raising concern over the temple remaining open despite the growing number of Covid-19 cases among priests. He even warned of "a disaster".

He had tweeted Thursday that I out of 50 archakas (priests) tested positive while results of 25 others are awaited. Tagging Chief Minister Y.S. Jagan Mohan Reddy, he wrote that the TTD Executive Officer and Additional Executive Officer refused to stop 'darshan' and alleged that they are following "anti hered itary archaka and anti-Brahmin policy" of Telugu Desam Party (TDP) and its chief Chandrababu Naidu. "Disaster if this continues. Please take action," he wrote.

TTD chairman Y.V. Subba Reddy, however, differed with the honorary chief priest and claimed that the situation does not warrant closure of the temple for darshan. Subba Reddy told reporters after

a meeting with priests that Ramana Dikshitulu

should have conveyed his opinion to the TTD board instead of making a comment in social media.

He said it was not proper to give political colour to priests testing positive. "Making such comments bemedia is not good. After our government came to power, the honorary chief priest pointed and

he is being paid the honorarium," said Subba Reddy, who is the maternal uncle of the Chief Minister.

The TTD Chairman said 60 of those tested positive are the security personnel who were drawn from the Andhra Pradesh Special Police (APSP) battalion. Those who contracted the virus also include 16 employees who prepare 'prasadam'. Subba Reddy said 70 of the affected employees have re covered, living a normal life and have even resumed duties. He claimed that none of the pilgrims visiting the temple was infected by the virus.

AP records all time daily high of 3,963 new cases

Amaravati, July 18: Andhra Pradesh Saturday reported the highest single day spike in COVID-19 infections with 3.963 new cases. taking the overall tally to 44.609 in the state, health officials said.

Also, the state reported 52 fatalities, the highest single day toll so far, pushing the death toll to 586. This is the fourth successive day

that Andhra Pradesh has reported record Covid numbers The officials said that all the thirteen districts returned Covid cases in triple figures. Almost a quarter of the new cases reported

Saturday morning are from East Godavari district which reported the highest tally of 994 positive cases. Kurnool followed with 550 cases, while West Godavari with 407 cases, Chittoor with 343 cases were the other districts that reported high numbers. Some of the other districts that reported high Covid numbers in the last 24 hours include Nellore with 278 cases, Prakasam with 266 cases, Anantapur with 220 cases, and Guntur with 214 cases

Srikakulam on the other hand reported 182 cases, Kadapa 145 cases, Krishna 130 cases, Vizianagaram 118 cases, and Visakhapatnam 116 cases, the districts with low incidencein the last 24 hours.

As per the latest update, Covid deaths were reported in 11 of the 13 districts in the state. The day's high of 12 deaths were reported from East Godavari district, while eight deaths each were reported from Guntur and Krishna districts.

On the other hand, Anantapur reported seven, West Godavari reported five. Prakasam reported four, Nellore reported three deaths and Visakhapatnam reported

At the bottom of the list, Chittoor, Kadapa and Vizianagaram districts reported one death. With 1,411 persons discharged from hospitals and covid treatment centres over 24 hours, there are 22,260 active cases while 21,763 persons have been declared as cured and discharged in Andhra Pradesh.On the brighter side, not a single positive case was detected among returnees from other states to Andhra Pradesh.

Till date, 2,461 cases have been identified as covid positive among persons who returned from other states. The active cases tally in this

State doubles mobile testing infrastructure

Amaravati: With the stakes continuously rising in the war against Covid-19, the Andhra Pradesh government has deployed 52 new buses to supplement the present vehicles for testing samples positioned across all high risk areas in the state. A total of 102 buses are now stationed in various districts, collecting samples from across 95 locations. The intelligent monitoring analysis services quarantine (iMASQ)system provides a contactless digitised swab sample collection system, and tracking and tracing in all containment zones. Health Commissioner Katamaneni Bhaskar said: "102 special buses have been deployed only for mass testing purposes which them survey 10-12 people at the same time, to avoid a crowd gathering." Bhaskar added that multiple testing counters in the buses will facilitate a zero contact procedure. Each bus has 10 counters, with three officials deployed at each counter. "The swab samples will be collected and sent to the ICMR laboratories for further testing. Officials at the border check posts verify the details of people entering the state by road with the help of Aadhaar numbers. Each person's swab sample is collected and he/she is either directed to undergo institutional or home quarantine. Those at quarantine camps are tracked to ensure that no procedure is skipped." Apart from deploying the modified buses, the state government has also issued notifications for recruiting more medical professionals to be assigned to different districts in the state. Bhaskar stated that to improve the health system from the primary to the tertiary level, a total number of 9,700 medical staff will be hired for further requirement.

In 2016, Srinivas fled home and reached the Vijayawada railway station. From there, the railway police rescued Srinivas and shifted him to a child care centre in Vijayawada and he has been there ever since. During the course of



Operation Muskaan, Srinivas finally revealed that he is a native of Palakollu in the West Godavari district. The authorities then sprung into action and facilitated the reunion of Srinivas with his mother.

DGP Gautam Sawang said, "It is very heartwarming to be able to facilitate the reunion of a motherson duo after almost four years. Things like these give us immense satisfaction and keep us going. Each kid who has been rescued has a heart wrenching story. It is to make this kind of difference in the lives of the vulnerable that this initiative was launched.' Police officials said that the

Centre identifies Chinese firms with PLA links operating in India

New Delhi, July 18: The Union government has identified a number of China-based companies having links to the People's Liberation Army (PLA) and operating in India soon after it banned 59 Chinese mobile applications, including TikTok.

The government believes that the Chinese firms operating in India have been involved in intelligence activities overseas.

As per the China's 2017 Intelligence law, the Communist government in the country has power to monitor suspects, raid premises and seize vehicles as well as devices. The US Secretary of Defence, Mark Esper's annual report

to the American Congress titled 'Military and Security Developments involving the People's Republic of China 2019' has put this on record. Chinese firms like Huawei, ZTE,

TikTok and others have been entrusted with the job to support, provide assistance, and cooperate with China's national intelligence undertakings, wherever they operate according to this law. Article 7 of the law states "Any organisation or citizen shall support, assist and cooperate with the state intelligence work in accordance with the law. The state protects individuals and organisations that support, assist and cooperate with national intelligence work."

It is worth mentioning here that this law has direct security impli-



cations for all overseas FDI that originate from China.

Some of the Chinese companies identified by the Indian government having direct/indirect links with the PLA and operating in India include Xindia Steels Ltd, Xinxing Cathay International Group, China **Electronics Technology Group** Corporation (CETC) and Huawei.

Xindia Steels Ltd: This company is among the largest joint ventures between India and China and has recently commissioned a 0.8 MTPA iron ore pelletisation facility in

total cost of over Rs 250 crore. The primary investor in Xindia Steels Lts is Xinxing Cathay International Group Co Ltd (China). According to the latter's website, it is reorganized, reconstructed and unhooked from previous Production Department and subordinate enterprises and institutions of the General Logistics Department of the PLA.

Xinxing Cathay International Group: This group set up a manufacturing facility in Chhattisgarh with an investment of Rs 1,000 crore on the invitation of the Chhattisgarh government to physically examine the state and position of iron ore in the state. With a turnover of almost Rs 3,000 crore, so far Xinxing has supplied close to 30,000 tonnes of ductile iron pipes to India.

China Electronics Technology Group Corporation (CETC): In 2018, the CETC announced a \$46 million investment in a 200 MW PV manufacturing facility in Andhra Pradesh's Sri City. A leading military electronics manufacturer. CETC also produces Hikvision CCTV cameras. The US government has added several CETC research institutes and subsidiaries to its entity list and restricted exports on national security grounds.

Huawei: Founded by Ren Zhengfei, a former deputy director of the PLA engineering corps, in 1987 in Shenzhen, Huawei is a popular brand in India.

PLA troops non-committal about retreat

New Delhi, July 18: Chinese troops have not moved back from the Line of Control (LAC) in eastern Ladakh in line with the consensus arrived at during the disengagement talks between India and China, sources said Saturday.

Seeing the "non-committal approach" of the People's Liberation Army troops, India maintains that the process of disengagement is "intricate and requires constant verification".

The sources in the Indian security establishments said that the Chinese retreat a bit and then return; so there is a need for "constant verification" of the consensus achieved during the meetings between Indian and Chinese military delegates.

In Galwan Valley, which is called Patrolling Point 14, distance between Indian and Chinese troops is three km. At Patrolling Point 15, the distance between troops is around eight km.

But in Hot Springs, that is Patrolling Point 17, 40-50 troops on

both sides are just 600-800 meters apart. The Chinese Army had retreated as per the consensus but again returned.

Indian Defence Minister Rajnath Singh Friday, during his visit to Ladakh, said that India wants peace but there is no guarantee of the final outcome of talks with China. Singh also reviewed the ground situation in the hostile border areas.

India and China are engaged in military and diplomatic deliberations to de-escalate the tense situation in the border areas in Ladakh The countries are locked in a 10week-long stand-off at multiple points, hitherto unprecedented along the border.

The Indian Army said on July 16 that the disengagement process on the LAC with China is "intricate and requires constant verification". The armed force said that India is taking the de-escalation process forward through "regular meetings at the diplomatic and military level"

During 15-hour-long deliberations spread over July 14 and July 15. India and China military dele gates reviewed the progress on "implementation of the first phase of disengagement and also discussed further steps to ensure complete disengagement" in eastern Ladakh. The Indian delegation's main agenda at the meet was the complete PLA pullback from the Pangong Lake, Depsang and other areas in eastern Ladakh.

Centre asks 4 states to strengthen efforts to combat nCoV

New Delhi, July 18: With a surge in coronavirus cases in Bihar, West Bengal, Assam and Odisha, the Union Health Ministry has asked these states to make renewed efforts to contain transmission of the virus and keep case fatality rate below one per cent.

With these states imposing lockdown anew, the Health Ministry emphasised that the restrictions should be utilised to focus on containment, surveillance and testing in containment and buffer zones as the key strategy for early detection of cases and fatality management.

In a letter to Principal Secretaries (Health) and Secretary (Health) of these states, Joint Secretary in the Ministry of Health Lav Agarwal asked them to ensure that at least 80 per cent of the new cases have their close contacts traced and are in quarantine within 72 hours of case confirmation.

The letter underlined that containment and buffer zones should be suitably delineated based on the mapping of cases and contacts, and

essary support and guidance. According to the letter to the Principal Secretary (Health & Family Welfare), Bihar, cases in the state are rising with almost 450-500 cases being reported daily and 80 per cent of the total active cases in the state were reported in the last seven days.

Districts like Patna, Bhagalpur, Muzaffarpur, Nalanda, Begusarai and Munger are reporting higher number of cases while Saharsa, Gaya, Paschim Champaran, Jamui, Arwal, Saran and Khagaria are the emerging hotspots.

The overall testing is very low in the state vis-à-vis national average and an increasing trend in case positivity rate on weekly basis is also

a cause of concern, the letter said. In the letter to the Secretary

(Health and Family Welfare), West Bengal, Agarwal said the state is reporting almost 1,600 cases daily and 93 per cent of the total active cases in state were reported in the last four days.

"Kolkata, Howrah, North 24 Parganas and South 24 Parganas as well as emerging hotspots in Jhargram, Purulia, Nadia, Midnapur East, Hooghly and Nadia need immediate attention.'

Patna, July 18: Conducting the upcoming Assembly elections in Bihar is likely to be a 'more than usual' expensive affair due to certain challenges and difficulties that have emerged following the coronavirus-triggered crisis across the globe.

To ensure social distancing and other necessary precautionary measures, over one lakh personnel would be pressed into election duties - mainly to look out for physical distancing among the people that would turn up to exercise franchise.

The term of the Bihar Legislative Assembly expires in November and it is believed that elections will be held on time if everything goes well. Sources said the Election Commission (EC) is considering all the challenges, and poll preparations are being constantly reviewed.

The EC has made it clear that this time, only 1,000 voters will vote at a particular polling station. Therefore, it has been decided to set up additional polling booths.

Sources in the Election Commission said that due to the proposed formula of allowing 1,000 voters at a polling centre, preparations are underway to come up with around 34,000 additional

Woman, daughter self-immolate near UP CM's office, 3 cops suspended

Amethi/Lucknow, July 18: The Amethi police suspended three policemen after a woman from the district and her daughter set themselves on fire outside the Chief Minister's office in Lucknow alleging inaction in a land dispute case, officials said Saturday.

The Lucknow police, however, said the women were instigated by Congress leader Anoop Patel to set themselves on fire as part of a "criminal conspiracy" and a case has been filed against him and three others.

Meanwhile, the BSP and the SP attacked the UP government over the immolation bid, saying it should take the incident seriously and act against the officers responsible for it.

According to Lucknow civil hospital authorities, the woman suffered 90 per cent burns and is on life support, while her daughter is stable.

"Three policemen including the in-charge SHO of Jamo police station in Amethi have been suspended. The matter is being probed by the additional superintendent of police and action will be taken once the report comes," Amethi Superintendent of Police Khyati Garg said.

No suicide note was recovered from Safia or her daughter Gudia,



she said. Garg and Amethi District Magistrate Arun Kumar said Safia (55) had a dispute with her neighbour over a drain and the two had even exchanged blows in the past.

Safia and her daughter set themselves on fire outside Chief Minister Yogi Adityanath's office in the state capital Friday evening, police said.

The police personnel posted there swung into action when they saw the women engulfed in flames and rescued them. The two were taken to the civil hospital for treatment, they said.

A video of the incident has gone viral on social media.

Dr. Ashutosh Dubey, medical superintendent of Shyama Prasad Mookerji Civil Hospital, Lucknow, told this news agency, "The mother has suffered 90 per cent burns and is in a serious condition. Her daughter suffered 15 per cent burns and is stable. The mother has been put on life support.'

From machines to N-95 masks, cartels use all to smuggle gold, drugs

A confidential note of the Indian Customs suggested all preventive teams deployed at the airports and sea ports to keep an eye on all types of gadgets and hi-tech tools

New Delhi July 18: From automatic iron presses to hand held drilling machines and from COVID-19 protective suits to N-95 masks, smuggling cartels are using every possible item under the sun to secretly peddle contraband drugs

and gold into India. A confidential note of the Indian Customs suggested all preventive teams deployed at the airports and sea ports to keep an eye on all types of gadgets and hi-tech tools even if they have minimum cavity space.

While the gold smuggling cartel of Kerala, recently busted by the Customs, used diplomatic consignments to smuggle large quantities of gold, other syndicates preferred to use home appliances to push drugs and yellow metal through green channels.

An alert Customs superintendent at the Amritsar airport got suspicious when four passengers, carrying juicers-grinders and automatic iron presses, tried to skip through the green channel on the night of July 16. The official also noted a set of hand held drilling machines brought by the passen-



gers who landed from flight IX 1192 from Dubai. The reports of the Amritsar Customs reviewed by the this news agency said that

once the drilling machines were unscrewed and all its parts were knocked down, the officials discovered gold concealed in small

Two sets of Sanford auto-irons were also dismantled. In the base plates, concealed yellow metal was found. Juicer-grinders, a common home appliance item brought in from flights arriving from Dubai, were also unboxed. The report said that more than 8 kg gold, concealed in these appliances, was recovered from the passengers who were later arrested. The drug cartels are eying COVID care ma-

terials to smuggle cocaine, marijuana and other contraband drugs. Early this week, Delhi Customs had seized a large quantity of marijuana being smuggled from the US. The marijuana was concealed in a packing declared as consignment for N-95 face masks.

On June 17, Delhi Customs had recovered contraband narcotics worth over Rs 30 lakh brought from the US. This time the drugs were concealed inside computer

In Kerala, a gang of gold smugglers peddling gold paste was unearthed at the Kannur Airport, which used to conceal the precious metal in paste form in clothes, mostly jackets and jeans.

Smuggling gold in "paste form" is a new way adopted by the crime syndicates to clear X-ray machines installed at various international airports and seaports in India, a Customs Commissioner said.

According to him, smugglers first convert gold into powder and then produce its compound in paste form. Around 700 gm gold can be retrieved from 1 kg of paste through a chemical procedure. The smuggled gold in pure form is later sold in the market.



Jakarta: Sixty-seven people have been reported missing, while more than 14,000 others were displaced due to flash floods in Indonesia's Sulawesi province, authorities said Saturday, adding that search and rescue operations were underway. So far, rescue teams have retrieved a total of 36 bodies, reports Xinhua news agency. The rescuers focused their efforts in the villages of Sabbang, Baebunta, Pontaden, Meli, and Masamba city, the hardest-hit areas in Luwu Utara district, said a provincial official.

■ 15 Pak pilots suspended

Islamabad: Pakistan's **Aviation Division has** suspended 15 more pilots for having dubious licences, raising the overall tally to 93, as verification continued, it was reported Saturday. The 15 are among the 262 pilots possessing suspicious licences, reports Dawn news. Friday, Abdul Sattar Khokhar, spokesman for the Aviation Division, said a total of 262 pilots were identified as possessing suspicious licences by the Board of Inquiry and grounded immediately after identification on the instructions of the government.

Kuwait's ruler hospitalised

Dubai: Kuwait's 91-year-old ruler has been admitted to the hospital for a medical checkup, the oil-rich nation's state-run news agency reported Saturday Sheikh Sabah Al Ahmad Al Sabah was in "good health." the KUNA news agency said. citing a statement from the country's diwan minister. The brief report did not elaborate. However, the visit comes as the tiny nation fights the coronavirus pandemic which has seen over 58,000 cases and 400 deaths in the country of 4.1 million.

Bangla hospital owner arrested

Dhaka: A hospital owner in Bangladesh has been arrested on charges of fraud to a tune of about \$350,000 for allegedly issuing thousands of fake Covid-19 test results to deceive people. Mohammad Shahed, the hospital owner, was arrested on July 15, nine days after he managed to evade the authorities, when he was trying to cross a river to escape to India, wearing a burqa -- to hide himself from the public and police, officials said.

Trump says no US mandate for masks

Washington, July 18: President Donald Trump has said he would not order Americans to wear masks to contain the spread of the coronavirus, saying people should have a "certain freedom."

His comments came after Dr Anthony Fauci, the top US infectious diseases expert, appealed to state and local leaders to be "as forceful as possible" in getting people to wear masks in public places.

In a 'Fox News Sunday' interview, Trump said, "I don't agree with the statement that if everybody wears a mask, everything disap-

Commenting on the initial comments from top health officials, Trump said: "Hey, Dr Fauci said don't wear a mask. Our Surgeon General – terrific guy – said don't wear a mask. Everybody who is saying don't wear a mask – all of sudden everybody's got to wear a mask, and as you know masks cause problems, too.'

Trump, who has been seen wearing a face mask only once, said, I'm a believer in masks. I think masks are good." But Fauci, the director of the National Institute of Allergy and Infectious Diseases, said social distancing, an important factor in blunting the spread of the coro-

navirus, can be difficult with more people going out.

'When you're living your life and trying to open up the country, you are going to come into contact with people. And for that reason, we know that masks are really important, and we should be using them everywhere," he said during a US Chamber of Commerce virtual

Americans are actually slowing down the re-opening the country by not wearing a mask, CNN quoted Fauci as saying during a US Chamber of Commerce event."If we could get more people to understand that, hopefully we'll get more people who'd be willing to wear masks," he said.

He said he would "urge the leaders - the local political and other leaders -- in states and cities and towns to be as forceful as possible in getting your citizenry to wear masks.' The country needs to concentrate on the problems at hand and not worry about a second wave, he said.

"When you're having up to 70,000 new infections ... that's something you need to focus on right now, as opposed to looking at what's going to happen in September or October, he said. There were 77,255 new cases reported on Thursday, crossing a previous record set two days ago, according to Johns Hopkins University.

About 1.8 million people have been evacuated and direct losses attributed to flooding are estimated at more than 49 billion vuan (\$7 billion), according to the Ministry

US civil rights icon Lewis dies

Washington, July 18: US civil rights icon and Democratic Congressman John Lewis has passed away, House Speaker Nancy Pelosi confirmed in a statement. He was 80.

In the statement posted on her website and social media on late Friday confirming Lewis's death, Pelosi said he "was a titan of the civil rights movement whose goodness, faith and bravery transformed our nation", and that as a Congressman he was "revered and beloved on both sides of the aisle and both sides of the Capitol", the BBC reported.

"Every day of John Lewis's life was dedicated to bringing freedom and justice to all," she said. "As he declared 57 years ago during the March on Washington, standing in the shadow of the Lincoln Memorial: 'Our minds, souls, and hearts cannot rest until freedom and justice exist for all the people.' "How fitting it is that even in the last weeks of his battle with cancer, John summoned the



strength to visit the peaceful protests where the newest generation of Americans had poured into the streets to take up the unfinished work of racial justice," Pelosi added. Lewis was one of the "Big Six" civil rights leaders, which included Martin Luther King Jr. and helped organise the historic 1963 March on Washington for Jobs and Freedom at which the latter delivered his historic "I Have a Dream" speech. Lewis was the last surviving speaker from the March. As a Congressman he was a Georgia Democrat, and represented an area which covered most of its capital Atlanta.

Arson suspected in Nantes cathedral fire

Nantes, July 18: French officials launched an arson inquiry Saturday after a fire broke out in the Gothic cathedral of the western French city of Nantes, shattering stained glass windows and sending black smoke spewing from between its towers.

Residents and tourists watched aghast, and emergency workers cordoned off the area around the St Peter and St Paul Cathedral, in the historical center of this city on the Loire River. A City Hall official said the fire broke out Saturday morning inside the cathedral, and the cause is unclear. The official is not authorized to be publicly named. No injuries have been reported. The local firefighter service said the roof is not affected by the fire and was"under control." They brushed aside comparisons with Notre Dame cathedral in Paris whose lead roof and spire burned down in April 2019. The Nantes fire for many will bring back memories of that devastating blaze that threatened to topple the medieval monument.

London, July 18: A Scotland Yard officer has been suspended after an "extremely disturbing" footage emerged that appears to show him kneeling on the head and neck of a Black man during an arrest here.

The video recorded in Islington area of the UK capital shows two officers holding the handcuffed suspect on the pavement. A second Metropolitan Police officer has been removed from operational duty following the arrest on Thursday evening.

The UK has seen widespread Black Lives Matter protests following the death of 46-year-old African American George Floyd in Minneapolis in the US on May 25 while he was in police custody. Deputy Met Police commissioner Sir Steve House said the footage was "extremely disturbing" and had been referred to the police watchdog—the Independent Office for Police Conduct (IOPC).

The video recorded in Islington area of the UK capital shows two officers holding the handcuffed suspect on the pavement. A second Metropolitan Police officer has been removed from operational duty following the arrest on Thursday evening

"The video footage that I have seen today and is circulating on social media is extremely disturbing. Some of the techniques used cause me great concern — they are not taught in police training," he said.

"One officer has been suspended and another officer has been removed from operational duty, but not suspended at this time. This decision will be kept under review,' he added. The Met Police confirmed it had charged a 45-year-old man with possession of a knife in a public place. Marcus Coutain will appear in custody at Highbury Corner Magistrates' Court on Saturday.

London Mayor Sadiq Khan said: "I'm deeply concerned about this distressing incident and we have raised this with senior officers at the Met Police as a matter of urgency. "I welcome the fact the incident has been reviewed quickly by the Met and it's right that they have referred it to the IOPC.

In the footage, one of the officers appears to be using his knee to control the suspect and has his hand on the man's head. He is eventually released from the ground and continues to talk to officers after they sit him up. Several police cars arrive at the scene after the arresting officers are confronted by onlookers, who drew parallels with the police custody death of Floyd that triggered Black Lives Matter protests.

Global virus numbers show normal life still far away

Johannesburg, July 18: South Africa was poised on Saturday to join the top five countries most affected by the coronavirus, while breathtaking numbers around the world were a reminder a return to normal life is still far from sight.

Confirmed virus cases worldwide have topped 14 million and deaths have surpassed 600,000, according to Johns Hopkins University data, a day after the World Health Organisation reported a single-day record of new infections at over 237,000. Death tolls in the United States are reaching new highs, and India's infections are over 1 mil-

Iran's president made the startling

announcement that as many as 25 million Iranians could have been infected, the state-run IRNA news agency reported Saturday. Hassan Rouhani cited a new Health Ministry study that has not been made publicly available. Iran has seen the worst outbreak in the Middle East with more than 270,000 confirmed

Experts believe the true numbers around the world are higher because of testing shortages. And as countries try to ease lockdowns, new ripples of cases follow. South Africa Saturday could join the US, Brazil, India and Russia as the most badly hit countries as its cases near 350.000. Current case trends show it will surpass Peru.

That comes as the world marks



Mandela Day, remembering South Africa's first Black president and his legacy of fighting inequality. The country, however, remains the world's most unequal, and health officials

have warned that the pandemic will lay that bare.

'The simple fact is that many South Africans are sitting ducks because they cannot comply with

World Health Organisation protocols on improved hygiene and social distancing," the foundation of former South African archbishop and fellow Nobel Peace Prize winner Desmond Tutu and his wife, Leah, said in a statement. South Africa's new epicenter, Gauteng province, is home to one-quarter of the country's population, with many poor people living in crowded conditions.

The country's cases make up roughly half of all on the African continent. Its struggles are a sign of trouble to come for less-resourced nations there. In India, a surge of 34,884 new cases was reported as local governments continue to reimpose focused lockdowns in several parts of the country, only allowing essential food supplies and health services. In the US, teams of military

medics have been deployed in Texas and California to help hospitals deluged by coronavirus patients. The two most populous states each reported roughly 10,000 new cases and some of their highest death counts since the pandemic began. In China, the number of confirmed cases in a new COVID-19 outbreak in the far western region of Xinjiang has risen to 17. In Bangladesh, confirmed cases surpassed 200,000 but experts say the number is much higher as the country lacks adequate labs for testing. Most people in rural areas have stopped wearing masks and are thronging shopping centers ahead of the Islamic festival Eid al-Adha later this month.

"The food sector has shown 27% growth. The major markets that have responded well are the US and Canada," TPCI Chairman Mohit Singla said at the Indo-Canadian virtual "buyer-seller meet (BSM) on food & beverages.

He said exports in June against yearago month had declined by only 4%.

Recently, official data showed India emerged as a net exporter in June. The country recorded \$0.79 billion trade surplus in June against \$15.28 billion deficit during the same period of 2019.

On the Indo-Canadian food trade, Singla said. "Canada can be an important market for the Indian F&B industry as it has a large population (approx 2.4 million) of Indian diaspora. Outreach to the mainstream market is the biggest challenge for the Indian F&B industry.'

With the support of fellow buyers and the High Commission we would be able to perform better, he added.

India's High Commissioner to Canada Ajay Bisaria said, "The Mission was part of a number of business conferences, but it's the first virtual BSM during the lockdown. It's a positive sign that we are looking beyond the pandemic to go into a recovery phase for business.

SPECTATORS ALLOWED BACK INTO SPORTS EVENTS IN ENGLAND FROM NEXT WEEK

FAN FEST SETTO RETURN

London, July 18: Spectators will be allowed back into some sports events in England from next week as coronavirus prevention measures are tested ahead of a planned wider reopening of stadiums in October.

Domestic cricket July 26-27 is set to be the first sport that fans are allowed to watch in person since March. Some spectators will also be allowed into the world snooker championship in Sheffield from July 31, and the Glorious Goodwood horse racing festival August 1 is also part of a government scheme piloting the return of fans.

"From October we intend to bring back audiences in stadia ... in a COVID-secure way subject to the successful outcome of pilots," British Prime Minister Boris Johnson said in Downing Street Friday.

Prof. Susan Michie, who advises the government on the pandemic response, fears reopening sports to fans — particularly indoor venues — could lead to a rise in virus cases and another lockdown.

"We've gone too far, too fast already," Michie said in an interview. "I think the data will begin to show that. I don't think we should have opened indoor pubs, much as I like pubs. And I think to begin opening up mass sporting events is not a good idea."

Stadium capacities will still be restricted, and staggered entry times, social distancing measures and one-way systems will be required. Barriers or screens will have to be installed where social distancing cannot be maintained when buying food and merchandise or betting. Fans will be time?

Kapil's advice 'helped' Dravid

New Delhi, July 18: Batting great Rahul Dravid says legendary allrounder Kapil Dev's advice helped him to explore options after his retirement before eventually taking up the coaching job of India A and U-19 sides.

Dravid said he was also 'a little fortunate' that at the back end of his career, he was already in a captaincum-coach role of IPL side Rajasthan Royals.

"After I finished (playing), there were quite a few options and I was not sure what to do. It was Kapil Dev who gave me this advice actually when I was coming to the end of my career," Dravid told India women's team coach WV Raman on his Youtube channel 'Inside Out'.

"I bumped into him somewhere and he said 'Rahul, don't commit to doing anything straightaway, go out and spend a few years just exploring and doing different things and see what you really like'. I thought it was good advice."

The former captain said initially he liked doing commentary, but later found 'a little disconnect' from the game

"...the thing that gave me the most satisfaction was really being involved in the game and being connected with the boys. I really liked the coaching side of things and I got sort of involved in that when the opportunity came up to do some coaching with India A and U-19," Dravid said.

"I thought it was a good place to start and and took it up and I've really enjoyed it since. I just feel a lot more satisfying to be involved in the coaching side of things," said the legendary batsman, who piled up 13288 runs from 164 Tests

Talking about choosing cricket over academics, he said, "Growing up as a young cricketer in India is not easy. In the time that I grew up there was only Ranji Trophy and revenue was so poor. I had to forgo a CA or MBA to pursue cricket so there was insecurity."

Leeds back in EPL after 16-year exile

Marcelo Bielsa's side secured promotion from the second-tier Championship with two games to spare Friday after West Bromwich lost to Huddersfield 2-1. Bielsa was filmed in a tracksuit celebrating with fans near his home.

A return to the world's richest football league comes a year after a late collapse saw the northern English team drop to third place and have to go through the playoffs where it was beaten.

"Our club, our fans and our play-

ers have sacrificed so much—we've been in the doldrums for 16 years," captain Liam Cooper said.
"To be part of this team and to lead this team to promotion back to where we know we've always belonged is unbelievable."

Seen as a sleeping giant of English soccer, Leeds won the last of its three English league titles in 1992 — the final season before the inception of the Premier League and was a Champions League semifinalist in 2001.

A financial implosion led to Leeds being relegated from the Premier League in 2004, with debts rising to more than 100 million pounds (now -USD 125 million) and fears the club could go out of business.

Vaughan backs Sibley despite criticism

Manchester, July 18: Dominic Sibley maybe facing criticism for scoring one of the slowest Test cen-

turies but former skipper Michael Vaughan says he is just the kind of player England needed.

player England needed. The 24-year-old scored a 312-ball century in the second Test against West Indies. It was the slowest hundred in Test cricket since November 2014, when Bangladesh's Tamim Iqbal also required 312 balls to reach three-digit mark against Zimbabwe.

Sibley played 372 deliveries in his 120-run knock. "England is a funny team to follow because we criticise them when they play flamboyantly and there were so many on social media criticising the way that Dom Sibley was playing," Vaughan was quoted as saying by 'Wisden'.

"He is absolutely right for this England team. That is exactly what England have required for a long period of time. Someone that just wants to stay in, value their wicket, bat a period of time," he added.

Vaughan, who featured in 82 Tests and 86 ODIs for England, said Sibley should not change his game and the youngster deserves a lot of credit for setting the foundation for the side's flamboyant players to play their game.

"Give the likes of Ben Stokes, Jos Buttler, Ollie Pope, these flamboyant players the foundation to go and play their way. So Dom Sibley deserves a lot of credit for just sticking to his game, I don't think he should change.

"I don't think there is too much wrong with him, maybe he could bring in an off-side game or two just to try and put more pressure on the bowlers when he is set and he gets in," he added.

After losing the series opener by four wickets at Southampton, England took control of the second Test with Sibley (120) and vice-captain Ben Stokes (176) putting forth superb performances with the bat.

"England have played the right game here. They've played with patience, they have put up a score on the board, and now it is down to the West Indies. I believe there is a bit of rain around Saturday, the third day. "The West Indies, to me, looks like they are going to have to bat twoand-a-half days to try and draw,"-Vaughan said.
