

STATE TO GO FOR **CREDIT LIFELINE**

Bhubaneswar, July 22: Amid shortfall in revenue collection, the state government has decided to go for massive borrowing to mobilise funds required in the battle against COVID-19, Chief Secretary Asit Tripathy said here Wednesday.

This decision was taken at the Council of Ministers meeting held under the chairmanship of Chief Minister Naveen Patnaik

Briefing media persons about the decisions, Tripathy said that at this time, the most important priority of the government is to save lives. Finance department has presented a detailed proposal titled 'Life before Everything Else' before the council.

'The revenue collection has gone down and the fund flow from Centre will also be affected due to the pandemic. Therefore, the state government has decided to go for market borrowing to meet the capital requirement," Tripathy said.

While allowing the states to borrow up to 5 per cent of the gross state domestic product (GSDP) for this fiscal year instead of the existing 3 per cent, the Centre has set certain conditions for the states. The state government has started work-

ing for implementation of the reforms to enhance the limit, he said, adding, "Now, we can borrow upto 3.5 per cent of the GSDP as there is no restriction and government will go for it." The state has so far borrowed nearly ₹95k crore including ₹4830 crore in this fiscal.

During the meeting, the council was apprised of the present Covid situation in the state and steps taken in this effect. The state government has so far utilized over ₹1.900 crore for Covid management. While ₹624 crore was spent from

State Disaster Response Fund (SDRF), ₹340 crore from Chief Minister Relief Fund (CMRF), ₹875 crore by Panchayati Raj Institutions (PRIs) and ₹73 crore from MLA LAD fund.

The council also prepared a roadmap to augment revenue collection. It was decided to mobilise public money sanctioned under different schemes and remained idle at various levels. The state has also planned to go for out of court settlement for revenue dues pending due to litigations.

Disengagement in Ladakh slows down

New Delhi, July 22: China has not pulled back troops from all the areas that it had intruded into Ladakh near the Line of Actual Control (LAC) in May, government sources said Wednesday.

After several rounds of military talks, the Chinese have not held up their part in the disengagement process in eastern Ladakh, where 20 Indian soldiers were killed in a clash with the Chinese on June 15. China's troops are still present in the Depsang Plains region, Gogra and the Fingers region along the Pangong Lake where India and China had started a mutual disengagement by creating a buffer zone between both sides.

"The Chinese have not shown any signs of deescalation as they continue to maintain their heavy troop deployment of almost 40,000 troops supported by heavy weaponry like air defence systems, armoured personnel carriers and long-range artillery in front and depth areas," news agency ANI quoted sources as saying.

The last round of military talks between the neighbours was on July 14-15 with both sides agreeing to mutually monitor the disengagement process. There has been no major progress since then.



China's consulate general in 43 CASES REPORTED FROM Houston within a short period of time is an unprecedented escala-



tion of its recent actions against China," Wang said at a daily news briefing. There was no immediate confirmation or explanation from the US side.

Media reports in Houston said that authorities had responded to reports of a fire at the consulate. Witnesses said that people were burning paper in what appeared to be trash cans, the Houston Chronicle reported, citing police.

China is considering ordering the closure of the US consulate in the central city of Wuhan, a person with direct knowledge of the matter said on Wednesday, after Washington told China to shut its consulate in the city of Houston.

China's foreign ministry did not immediately reply to a request for comment, but at a media briefing earlier on Wednesday warned of possible retaliation over the US decision.

Both the US and China were locked in a political and strategic conflict in recent months on a host of issues including the origin of the coronavirus, China's decision to implement its national security law in Hong Kong and deepening trade frictions.





AIR, FM shows on but revenue dips

Bhubaneswar, July 22: Radio broadcasts in Odisha continue to reach the audience even though the production process at the radio stations across Odisha has been badly hit due to the Covid-19 pan-

With restricted movements due to lockdowns, the radio stations across the state have devised alternate strategies to ensure content production and broadcasting. The All India Radio (AIR), Cuttack

has been badly hit by the health crisis, but the undeterred broadcaster continues the broadcasting.

"Most of us chipped in to run the show. The announcers recorded their voices and con-

tents from their home while the producers produced the content through their computers at home. Our well-coordinated approach helped us to continue radio broadcasting," a senior official from AIR, Cuttack told **Orissa POST** requesting anonymity.

He said that radio has always been a powerful means to reach out to people during disasters. "We started broadcasting programmes on Covid prevention and awareness since February. We have aired more than 100 interviews of 'Corona Warriors' from Odisha and from across the country to inform the audience correctly to ward off the disease," he said

The official said that at a time when several FM channels and community radio stations have forayed into the sector, AIR has carved its own niche through its global presence.

The AIR stations are now available through mobile apps-AIR Live and AIR News-which enable the audience to listen to it from anywhere in the globe. While FM Gold is serving the metropolitan cities. FM Rainbow has been trying to cater to the recreational needs of the radio lovers in states like Odisha. The availability of AIR programmes through Medium Waves also increases its penetration in remote areas

The private FM channels, on the other hand, also had been working hard to target their audience and design their contents to cater to the needs of Covid awareness. "We used our RJs to talk more on disease management and tried interviews of celebrities and popular figures to spread awareness. We also designed several digital contents to bridge the gap," said Saubhagya Behera, Station Head, Big FM, Bhubaneswar.

He also admitted that revenue of private FM channels across the



state has dipped

owing to the lockdowns. "It was heavily hit during March and April but improved a bit since then. However, we continued broadcasting. Most of us worked from home and continued productions to serve the masses," he added. While the public broadcasters

are benefited from government ad-

vertisements more, reduced ad-

vertisement flow from private play-

ers has hit the revenue of private FM channels, it was learnt.

People working in the sector also claimed that joblessness and salary cuts have marred radio broadcasting. "A number of radio broadcasters of Odisha working in other states have now returned to their own state after losing jobs while in Odisha several private FM channels have deducted salaries of the broadcasters," said Subrat Kumar 'At a time when several FM channels and community radio stations have forayed into the broadcasting sector, AIR has carved its own niche through its global presence'

Pati, an independent announcer of an FM channel and founder of Radio Bhubaneswar (online radio) said.

He said that the government has failed to fully understand the potential of radio broadcasting during such a health crisis. "Radio broadcasting during natural and health disasters has been properly harnessed in foreign countries but here we are vet to use its full potential. For example, several education and training related programmes could be aired at this uncture," he added. An official from state I&PR department, however, said the radio stations are aided through government advertisements especially in the form of jingles related to awareness against

Community radios bridging info gaps

t a time when Covid-19 restrictions are in force making it tougher for the mainstream media like newspapers to reach out to people in remote areas, community radio stations seem to be doing it by reaching out to the last man standing.

Radio Swayamshakti, a community radio station at Khariar in Nuapada district, has been broadcasting programmes in Kosali language, a local dialect of Odia to help the local population.

"We use mostly Kosali to help the Kosali speakers. However, we also mix Odia as many government officers are not used to the dialect and they speak Odia. We keep the local community informed with the latest local happenings and developments in their own language, dialect. This is the beauty of community radios," said Biswajit Padhi, Station CEO of Radio Swayamshakti.

This radio station serves the local population with a reach of around 50 km and covers four blocks of Nuapada, two of Bolangir and one of Kalahandi district.

The story of Radio Bulbul from Bhadrak is also admirable. This community radio station has been broadcasting in Odia as well as Hindi. Hindi language has been

"Our radio station proved a vital point of authentic information during lockdown. We often roped in the district Collector and other government officials who used our medium to reach out to the public

and informed them about important government announcements besides our own programmes," said Sk Md Niyaz, Director, Radio Bulbul,

Sisir Das, Station Head of Radio Surabhi from Daspalla (Nayagarh) said that community radio stations could be a vital alternative to reach out to the people during natural and other disasters.

"It is a hyper-local mode of broadcasting where we try to reach out to the population in our locality in the language they speak. Such stations can play a key role in disaster management by empowering them with authentic and useful information when other communication channels are compromised," he said.

NA Shah Ansari, Station Head of Radio Namaskar, Konark, cited examples on how their productions were used by the vigilant citizens to put a curb on the unhealthy practices of the villagers who did not pay heed to lockdown rules earlier.

"We kept on broadcasting imrtant information relating to Covid 19 in the last few months. Many of the frontline workers and villagers found it a good source to gather information. In many villages in Puri district we are able to make dedicated listeners

Plasma therapy at Rourkela IGH soon

Bhubaneswar, July 22: After successful implementation of plasma therapy at Cuttack and Ganjam, the state government is going to start the treatment at Ispat General Hospital (IGH) in Rourkela.

The decision was taken at a high-level meeting presided over by Chief Minister Naveen Patnaik here Wednesday.

Plasma therapy is effectively working in treating critical Covid patients. To provide better treatment to Covid patients of western Odisha, Naveen announced to open a plasma bank at IGH in Rourkela. He also announced that the number of beds in Rourkela's Covid Care Centres (CCCs) would be increased from 700 to 1,700.

He lauded Sundargarh and Jaipur district teams for achieving the high recovery rates of 85 per cent and 86.5 per cent respectively.

Sundargarh has spent ₹20 crore from DMF for Covid management. Further, ₹15 crore will be spent in the next three months for strengthening of dedicated Covid Hospital and CCCs, he said.

The situation is under control in spite of more than 26,000 migrants coming back to Jajpur district. The district will be spending ₹13.5 crore from DMF for strengthening Covid care system. Additional 250 beds will be operationalised at the CCC in Jajpur, the Chief Minister said. Naveen sanctioned ₹5 crore from the Chief Minister's Relief Fund (CMRF) to each district.

New Delhi, July 22: Four newlyelected Rajya Sabha MPs from Odisha took the oath of office at Rajya Sabha chamber in Parliament House here, Wednesday, while adhering to physical distancing norms.

Four Biju Janata Dal (BJD) MPs -Subhash Singh, Muzibulla Khan, Sujeet Kumar and Mamata Mahanta - are among 45 parliamentarians, who were administered oath by Rajya Sabha Chairman M Venkaiah Naidu in the House chamber. The leaders from Odisha took oath in Odia language.

The Rajya Sabha elections were held for 61 seats between March and June, of which 42 members were elected unopposed, including

28 first-timers, and elections were held for 19 vacancies and 15 other first-timers won a berth in the Rajya Sabha. As many as 49 MPs were elected to the upper house for the first time while 12 were re-elected. The BJD MPs had been elected to the Upper House unopposed March 18, 2020. Significantly, due to Covid-19 pandemic, the oath taking ceremony was held inside Rajya Sabha chambers during inter-session for the first time. Other MPs who were

Plight of senior citizens amid Covid pandemic

fter the nationwide lock- a hospital's Intensive Care Unit down imposed in March. calls from lonely elderly citizens from different parts of Bhubaneswar flooded Helpage India's helpline number. There were requests ranging from delivery of daily essentials to support for health checkup. However, some requests sounded unreal. "We have everything, but no one to interact with. Please find someone with whom we could, at least, talk, everyday," pleaded some

"It not only surprised me, it stirred my emotion," says Helpage India's Odisha head, Bharati Chakra.

Even for Chakra who has been dealing with issues facing senior citizens for two decades, it was an unusual experience. She spent some time with some of these people; her colleagues also chatted with them at regular intervals. "Covid has shaken the lonely elderly ones, mentally," puts Chakra.

Incidentally, the cases Chakra is referring to are not isolated ones. With the children chasing their career, in some other parts of the country or abroad, scores of such lonely aging parents are experiencing a different type of old age blues. For, the pandemic has further stretched the existing widening physical distance, between such parents and their children.

A case in point is Dibakar Tripathy, 75, a retired government servant. Days before the lockdown was imposed, Tripathy who was in Mumbai with his wife to attend a family event, fell seriously ill. As Tripathy was wheeled straight into

(ICU), his worried septuagenarian wife desperately dialed their US based son. The son, cajoling his mother, told not to worry.

Dutifully, he forwarded details of the health insurance policy so that his father's hospitalisation costs are taken care of. However, what the mother was hoping for - someone by her side to attend to her husband - couldn't be realised. Post recovery, the elderly couple is back in Odisha, thanks to the support of relatives. However, even four months after, the wait for their son's visit continues.

"Covid has aggravated the emotional vulnerability of the elderly couples living alone, they never felt more helpless, before," puts ex English professor, Chinmay Jena.

Jena's colony in Bhubaneswar's Old town locality has many such senior citizens like ex-reader. Kamala Prasad Mohapatra. He says, "Once one is over 65, a sense of insecurity creeps in and the absence of children is felt more. If vour child is around, it gives the mental strength.'

While a majority of such 'living alone' elderly parents say their children, who are regularly in touch with them through mobiles, other gadgets, social media or digital mediums, also concede that the pandemic has erected a wall of uncertainty. When could they meet their children or play with the grand

kids, worries them. Forget about daily essentials, they can't step out even for a leisurely walk as they are prone to Covid infection. Result: Many are feeling



claustrophobic. It's an issue in almost every city in India.

"The government should ensure delivery of daily provisions for senior citizens," intones an ex-soldier, Col. Suranjan Bhuyan of Bhubaneswar.

"The government is doing that in many areas and it may extend the services to other places as well," Chakra argues. "But, what about those needs, like going to banks, withdrawing cash from ATMs or regular health check-ups which the elderly have almost stopped in Covid era," she asks.

Chakra suggests, "The need of the hour is to develop a localised, police verified, volunteer base. These volunteers can respond quickly to emergencies. Also, we must promote digital literacy among the senior citizens. As per a June 2020 study titled

'The Elder Story: Ground Reality'

by Chakra's organisation, during

Covid-19, a disturbing 62% of the

elder respondents reported suffering from chronic diseases: asthma, hypertension, diabetes, cancer etc. Of these, 53% were from rural and 47% from urban areas.

According to the 2011 Census, those above 60 years of age constitute 8% of India's population. A 2016 report by the social statistics division of the Ministry of Statistics and Programme Implementation puts the number of elderly at nearly 104 million: Rural (73 million) and urban (31 million). India is the second largest populated country in the global population of elderly citizens. According to WHO estimate, the elderly population is increasing by 3.5% per year and by 2050 around

20% of our country will be seniors. Sociologist Navaneeta Rath thinks the lonely parents have reconciled that they have to stay alone. They understand that after all, the children have the right to pursue their own career and live the way they wish. "With the growing threat of

denly," thinks Rath. However, psychologist Basant Das, well versed with the different facets of human behaviour, says, "During counselling sessions, he advised those parents complaining against the apathy of children or other related issues, that they must live a life with dignity. And they shouldn't hold on to the early idea that their children would look after them forever.

"Instead of being liabilities on their children, the parents should take care of themselves and try to be an asset for the children," Das, says adding. "The children are also grappling with a lot a stress in their professional life.'

A lonely father residing in Bhubaneswar's Nayapalli area says,

"The children know parents are silent sufferers... wouldn't complain and so can easily be dispensed

Experts say due to factors like a fiercely a competitive life, professional stress, fast lifestyle, changing attitude, ambition to climb up in career, strive for materialistic comfort and peer pressures, children lack the time and energy and so are unwilling to shoulder more responsibility (of parents).

However, Rath believes, today, there is still some amount of consciousness among the children about their parents. "We are about to step into a more individualistic world governed by the 'let alone and leave alone' principle," she

According Rath, till the end of 1980's, it's believed that the nearer was the child the dearer he became to the parents. Today, it's different. "Each parent is enveloped with sky touching aspirations. In our pursuit to pitch the child in the global market from school days, not only we put tremendous stress on the young minds, alienate them from family culture but in the process kill the value system," Rath explains.

Also, for most parents, a cosy job for the child in a global entity with a fat pay package, ensures them a better stock value in the social stock market or among peer groups.

According to a 2019 Helpage India study, Elder Abuse in India-Role of Family in Care giving - challenges & responses - conducted across 20 Indian cities, 29% care givers in the family (mainly son, daughterin-law, daughter, son-in-law) felt the

'burden of care giving of an elder' was moderate to severe, for 15% it was severe. And 35% though 'never' felt happy looking after the elderly.

Perhaps that's created a space and also market for old age care providers. In Bhubaneswar alone there are at least over a dozen agen cies offering home nursing facility. Like Orange cross, a professionally run, start-up.

'There's a growing demand for this kind of service in Bhubaneswar and other cities," agrees Ajay Bhanja, CEO, Orange Cross. Bhanja an IIT (ISM Dhanbad) alumnus with an advanced management course from Kellogg School of Management, Chicago, has entered the sector, after a 25-year stint at the global corporate arena. Besides transforming Orange Cross into a 360 degree chronic care provider for the elderly people, Bhanja intends to branch out the service to some other cities in the country. The potential of the market is easily un-

derstandable. However, Covid-19 has brought some positive changes too. As Rath says, "Job loss and income loss has brought a 'home reversal mood to many children' staying away from parents. The lockdowns also helped create a new bondage as elderly parents have got their home confined children to play games (chess and ludo) with them, through digital

connections, though. Perhaps it's Covid's way of main-


Bhubaneswar, July 22: Fresh Covid infections have taken the state's virus count to 19,835, of which 5,944 cases are active and 13,749 people have recovered so far, said an official.

Ganjam, the worst-hit district in the state, reported three fresh fatalities, while Gajapati and Kandhamal registered one death each, added the official; all the deceased were suffering from

"A 40-year-old woman and two men, aged 61 and 60, died due to Covid-19 in Ganjam. Two men, aged 72 and 86, died in Gajapati and Kandhamal districts respectively,



the official pointed out.

"Regret to report the demise of five COVID positive patients while undergoing treatment in hospital," the H&FW department said in a statement.

Ganjam accounted for 62 of the 108 Covid-19 deaths reported in the state so far, while other districts that registered a high number of such fatalities are Khurda (14), Cuttack (nine) and Gajapati (six). Deaths due to the coronavirus were also reported in 11 other districts, the official said.

Another 59-year-old Covid-19 patient died in Ganjam district due to chronic liver disease, taking the toll of coronavirus patients dying due to other ailments in the state

to 31, the official said.

As many as 721 fresh cases were detected from quarantine centres while a record number of 357 people tested positive for the infection during local contact tracing, said the official.

Ganjam district reported the highest number of new cases at 371, followed by Khurda (121), Rayagada (96), Malkangiri (66) and Cuttack (57), said the official.

The Koraput district administration, in a statement, said two BSF personnel are among the 15 new cases reported in the district, taking the number of jawans of the paramilitary force testing positive for the infection in the state

lected ₹96 crore in June this year while it had collected around ₹112.70 crore in the same period last year. There is a dip of around 14.8 per cent in revenue collection, the official said, adding that amid lockdowns and shutdowns, Odisha did fare well in June

as compared to other states. The Centre and the state have been imposing lockdowns across the country since March 22. Along with other commercial establishments, vehicle showrooms also kept their shutters down to comply with the governments' bid to break the virus chain.

"Although vehicles' sale was allowed from the first week of May, showrooms remained mostly dry. The state usually registers sale of around 75,000 vehicles a month. Around 15,000 vehicles were sold in May. June, however, saw a sale of around 43,300 units of vehicles. The STA had regis-

tered a sale of around 64,000 vehicles in June 2019," said the of-

Apart from poor sale of vehicles due to closure of showrooms, suspension of driving and learning licence services, rebate on bus tickets and poor penalty collection during lockdowns have also dealt a blow to the revenue collection of STA, said the official, hoping for some better days ahead.

ROAD FATALITIES DOWN BY 65 PC DURING LOCKDOWN

Bhubaneswar, July 22: With vehicular traffic reduced during the Covid-induced lockdown, Odisha has registered a sharp decline in deaths due to road mishaps, an official said.

The number of such deaths fell by 65 per cent between March 25 and May 31, a senior official at the State

Transport Authority (STA) said. Noting that during the lockdown period, 384 persons died and 722

persons were injured in 836 road ac-



cidents, the official said, in the corresponding period of 2019, as many as 1,087 persons had died and 2,175 people were injured in 2,107 road

In April this year, the number of

deaths due to road accidents stood at 118, against 485 in the same peiod in 2019, registering a decline of about 74 per cent. Total 231 road mishaps were reported in April, 2020 against 877 in April last year, he pointed out.

During the month of May, 2020, the number of deaths stood at 243, against 494 in May 2019, thereby recording a decline of about 51 per cent. Total 551 road accidents were reported in May this year against 953 in the same month last year, the official said.

PEOPLE FOR THE ETHICAL TREATMENT OF ANIMALS WRITES TO DGPs OF ALL STATES TO CHECK ILLEGAL TRANSPORT AND KILLING OF ANIMALS IN THE LEAD-UP TO BAKR-EID

Bhubaneswar, July 22: People for the Ethical Treatment of Animals (PETA) India has written to the director generals of police of all state governments including Odisha and union territories to keep an eye on illegal transport and killing of animals in the lead-up to Bakr-Eid.

It requested the DGPs to take all possible precautionary measures to stop the activities in the lead-up to Bakr-Eid (July 31) - "which was also advised by the Animal Welfare Board of India earlier.'

PETA India Advocacy Associate Pradeep Ranjan Doley Barman. "The state governments have a duty to uphold and enforce India's animal

In its letters, PETA India pointed out that on two matters regarding the sacrifice and killing of animals for meat: "the Supreme Court ruled that animals can be slaughtered only in officially licensed slaughterhouses and that municipal au-

The laws regarding preventing cruelty to animals and the food safety and standards guidelines permit the slaughter of animals for food only in registered or licensed slaughterhouses equipped with species-specific stunning equipment and do not permit killing camels for meat, a common practice during Bakr-Eid." Laws on the transportation of animals are also frequently violated during this festival, it added.

This is so because the owners of the farmlands around Rani Bakhri have refused to part with their land for providing entrance to the site. row lane near the Pataneshwari temple. Senior IAS Arabind Padhee welcomed the renovation of Rani Bakhri with a tweet.

Moreover, the file relating to sanction of Rs 70 lakh by the state government suddenly missing has raised doubts in the minds of people. The fund was sanctioned by then tourism minister Ashok Kumar Panda. Panda had assured to acquire the vacant land in front of

the structure but it is to be done yet. Rs 70 lakh was sanctioned for grass-laying work at the entrance, construction of a compound wall and beautification works.

The Indian National Trust for Art and Cultural Heritage (INTACH) recently completed the restoration and structural conservation of the structure at an expenditure of Rs

The Rani Bakhri was constructed by Raja Baliar Singh, the fifth Chouhan king of Sambalpur between 1660 and 1670 on five decimals of land. The Rani Bakhri, built in Rajasthani architectural style, is constructed near the Pataneshwari temple in the town.

Notably, the three-storied Rani Bakhri also known as Jemadei Mahal has now acquired bridal look after renovation. It has a total of 15 rooms comprising seven rooms on the ground floor, six on the first floor and two beautiful rooms on the



The structure was in a dilapidated condition when the state government roped in INTACH for its restoration. Prior to that, only the palace's roof was rebuilt in 2001 with funds from the Centre.

INTACH experts used traditional techniques for the restoration work without affecting the original structure. A mixture of lime, gum of Bael (wood apple), Reetha (soap nut) and jaggery was used for plastering the monument.

Motifs inside the palace have been uniformly coloured while damaged paintings were restored and pathways created. The old plaster moved and fresh plastering undertaken in the entire structure, informed Director of Intach Conservation Institute, INTACH Mallika Mitra.

The INTACH officials before the restoration work cleared the encroachment of the monument by a saw mill. The adjoining land behind Rani Bakhri was developed into an amphitheatre with required illumination and landscape for future use of the premises for revenue generation purposes, INTACH Sambalpur chapter member and historian Deepak Panda said.

Amenities for visitors like toilets, drinking water supply and ticket counter have also been set up on the premises. INTACH plans to hand over the monument to the tourism department later this month. When contacted. Hemant Kumar Pradhan, district tourism officer, said the landowners have refused to leave their land for which there is no proper entrance

Fish production hit in Kandhamal dist

Phulbani, July 22: The district administration had plans to scale up fish production in Kandhamal this year by roping in self-help groups (SHGs) under the Odisha Livelihood Mission (OLM). However, fish farming at several panchayat ponds has exhibited very poor output

The total production, it has been learnt, was even less than the annual demand in the district. Local denizens have been de-

pending on Andhra Pradesh to meet their fish demands. Supply from Boudh district also feeds into the district fish markets to a large extent.

Kandhamal administration claims that it has been providing ample funds including costs for training in fish farming. There are three fish production centres at Phulbani, Phiringia and K Nuagaon areas.

Nearly 292 kg of fishlings are fed into the ponds at Phulbani centre. After fish seeds grow bigger, they are shifted to Tandrigaon centre of



Phiringia and Sirtiguda centre of K Nuagaon for further processing.

It is alleged that, inadequate government assistance and poor working knowledge have resulted in low fish production. In addition, six posts of assistant fishery officer (AFO) remain vacant as against the sanctioned number of nine posts under 12 blocks in this district.

On being contacted, local assistant fishery officer Gyanaranjan Sethy said, "There is acute shortage of staff in fishery department. Moreover, we are getting insufficient grants for fish farming in Kandhamal district.

Angul high-tech bus terminal project falters

TWO CONTRACT FIRMS ASSIGNED THE WORK ARE DELAYING THE PROJECT

Angul, July 22: A hightech bus terminal project at Angul town the foundation stone of which had been laid seven years back has eluded the local denizens. The ambitious project has allegedly made little progress since then. Two contract firms

namely Angul Bus Terminal Company Pvt Ltd and Milan Developers and Builders Pvt Ltd who had signed a memorandum of understanding (MoU) with Talcher- Angul-Meramundali Development Authority (TAMDA) in this regard have delayed the progress and the district administration is staying

indifferent. Even as the contract firms have already taken seven years, there is no progress in the bus terminal construction work. The time mentioned in the MoU for completion of the project was two years. Moreover, the firms have written to the state government for an extension of six month's time.

setting up of bus terminals at Angul, Dhenkanal, Cuttack, Bhubaneswar and Sambalpur July 13, 2011 Following the CM's order, tendering process for Angul bus terminal was initiated and the MoU was signed April 9, 2012. The estimated cost of the high-tech project was Rs 56.31 crore.

As per the MoU, the proposed bus terminal was to be constructed on 9.72 acres. Accordingly, Rs 13.95 crore was sanctioned for the terminal on 5.83 acres and Rs 42.36 crore was sanctioned for a commercial complex on 3.89 acres.

The contract firms were required to start construction within six months, monitor maintenance work for the next 15 years and posses the commercial complex on lease for a period of 99 years.

The district administration has conducted several review meetings in this regard, but nothing concrete has so far materialized, a source said.

month ago, I received distress calls from people in Mumbai that the municipal commissioner had suddenly swooped down on a 20-yearlold feeding platform (chabutra) for pigeons, which was on the side of the road in Khar, had covered it with plastic sheets and posted police people so that no one could feed the birds. The pigeons left inside died of starvation as they were not allowed out. The pigeons outside, who had been fed for years, had nowhere else to go so they stayed on the road waiting to be fed. Hundreds were run over by cars. Anyone who tried to feed them was made to sit in a police station. In the meantime, the municipal commissioner had got several completely untrue articles published in local papers about how dangerous pigeons are to human health.

I talked to the commissioner and this is the reason he gave me: "Pigeons lay eggs. The eggs are eaten by crows. We don't want crows. So, if we get rid of pigeons, the crows will leave.

There is no scientific proof of any link between pigeon eggs and crow breeding. Crows are scavengers. They will continue to breed as long as humans

We need to know why pigeons are in the cities. Thousands of people feed them – in Delhi there are designated feeding areas and people come in scooters and cars to throw feed. My hospital has over a thousand pigeons that have been hurt by cats, dogs and cars.

There are no pigeons in the wild any more. How did they become city creatures like dogs and cats?

As far back as 10,000 years ago, people in Mesopotamia and Egypt began coxing them with food and encouraging them to feed and breed near human dwellings. These birds were then caught and eaten. People started breeding them like chickens to eat. And the breeding and domestication led to the subspecies in our cities today. Over time, people started breeding them as a hobby.

Pigeons were transported all over the world by ship to feed the pigeonbreeding hobby. Obviously, many escaped and began to breed freely in the cities. They had been bred over time to be comfortable with humans and so they took up nesting on building ledges, window sills: anything that looked like a cliff edge. People realised that pigeons had a talent for navigation, and sailors used

them to point lost ships towards land. They became valuable as airborne messengers and even armies started using them. Pigeon posts were recognised all over the world. Genghis Khan used pigeons

as daily messengers both to enemies and allies. They were used widely in both World Wars.

America alone used 200,000 of them in the Second World War. Medals for bravery were given to pigeons. The last messaging service using pigeons in the world was disbanded in 2006 by the police force in the state of Odisha. By then, pigeons had also adapted their appetites

from berries, insects and seeds to anything that humans would feed them - from grain to ice cream and biscuits – and they became expert trash hunters. There is a lovely film on You Tube about a pigeon in Canada that steals a bag of chips from a shop every day!

What is there to hate in pigeons? They are goodlooking with iridescent necks and so many colours. People who have adopted injured pigeons who cannot fly any more say that they are beloved members of the household

Charming, affectionate, sociable with individual personalities. When they live indoors, they keep themselves very clean and love bathing! They are easy to potty train. Pigeons are important to the cleanliness of a city. Crows are still too shy to walk around with people. But pigeons eat all the trash that we throw on the sidewalk. They are smart with complex social systems. I

think that they think they are people too.

What is their importance? We need hawks, eagles, falcons and kites, and pigeons are a food for them. Pigeon compost is considered the best of all manures. In early history, perhaps, the domestication of pigeons led to advances in the ability to grow the best possible crops. Pigeon faeces were so valuable that armed guards were hired to protect dovecotes from thieves.

In the Middle East, where eating pigeon flesh was forbidden, dovecotes were built simply to provide manure for growing fruit and this practice continued for centuries. In France, Italy and Spain guano was used extensively on hemp crops and for the fertilisation of vineyards. It is nitrogen-rich. There are ads on the net advertising pigeon manure which sells for twice the price of other manures. Their compost is unsurpassed for fertilising tomatoes, watermelon, eggplant, roses, and other plants that like a rich soil.

Who hates them? The same people who drove out sparrows, wrens, warblers, blue jays, cardinals, egrets, and everything else. The same people who choose sterile joyless streets as a representation of "cleanliness" and "development" over human happiness.

And they make up these stories about disease-spreading.

Do pigeons spread disease? No. If they did, they would not have been eaten for centuries without a single case of disease reported. In the 19th Century, the American government urged people to collect pigeons and eat them

Ironically, the pigeon is now wrongly perceived as a disease-carrier as a result of commercial propaganda pumped out by the pest control industry. In reality they pose little or no risk at all. I have a staff of people who look after diseased and sick pigeons. Not one person – and they work without gloves and face protectors - has ever fallen sick in the last 40 years.

Do pigeons, or their excrement, transmit diseases to human beings? The answer is, no. How to reduce pigeon numbers in the city? The answer is very simple. Making pigeon chabutaras and designated feeding sites, and using pigeon lofts where eggs can be removed, has been proven to be successful in every city where it has been tried. If the Mumbai Municipal Commissioner wants to reduce pigeons, it can only be done by establishing chabutaras, not

n Canada, a driver's assistant is called a swamper. Why so? The Oxford English Dictionary has all the details. It seems it was originally applied to workmen who cleared roads for the fellers of trees in a swamp or forest. The word uses swamp in its old sense from the American colonies of an area of rich soil having trees and other vegetation, but too moist for cultivation, not necessarily an area that always contains standing water. The usage goes back at least to 1857. The job was unskilled labouring and later the word moved over to refer to other jobs of similar kind — a man-of-all-work in a liquor saloon, an assistant to a cook, then an assistant to a driver of horses

mother can never be evaluated in terms of money. is tree, which provides us all the motherly care throughout our lives. This includes clean air to breath, pure water to drink, nutritious food to eat and keeping the environment and ecology wholesome and healthy.

According to a report from the US Department of Agriculture, one acre of forest absorbs six tonnes of carbon dioxide annually, thereby reducing greenhouse effect and limiting climate change. It also generates four tonnes of oxygen, enough to meet the requirements of 18 humans. Trees, shrubs and turfs filter air by removing dust and absorbing pollutants like carbon monoxide, sulphur dioxide and nitrogen dioxide. making the environment healthy These also control the devastating effects of climate by moderating the heat of the Sun, heavy rain and strong winds. Properly placed around buildings, trees can reduce the need for air-conditioning by 30 to 50 per cent.

A sound ecosystem is heavily dependent on trees, which includes preservation of rain water and ground water recharge, maintenance of soil health as well as providing food and shelter to various species. Those also cause rain, the primary source of pure water.

Besides, trees appeal to our aesthetic sense and generate peace in our mind, similar to what we feel in the presence of our mother. It is said living among the greenery provides the comforts of a mother's lap, ensures good health and long life. The services rendered by trees.

quiet as they are, are uncountable.

Usually, we calculate the conventional market value of a tree by taking into consideration its total weight and quality of timber or fruits or the biomass it produces. Scientists view it from a totally different angle. They evaluate it, considering the importance of the services it renders, which may be a few thousand times more. Some of them quantify those in terms of money in order to make us, the materialists, to realise it. The pioneer among them is Prof TM Das

of Calcutta University. In a paper published in the journal Indian Biologist in 1979, he had calculated that the value of various environmental benefits and services derived from a tree with an average life span of 50 years could be \$1,96,250 at the market rate prevailing then. At the 68th session (1981) of the Indian Science Congress held at Varanasi, he elaborated his views. It attracted worldwide attention and found a place in UN documents. In those, the Indian currency was converted into dollar, pound, yen etc. In 1983, the Films Division produced a documentary film titled "Service of a Tree" based on the theme.

The value of a tree (\$1, 96,250) as stated in the original paper of Prof Das in 1979 has been changing from time to time in accordance with the new experimental data and the price index. Therefore, it has been revised to \$7, 09,760 in 2011-2012. The values of different inputs calculated in these two years respectively are: a) oxygen production (31,250 and 10,500); b) conversion to animal flesh and bone (3,000 and 3,000); c) controlling soil erosion and soil fertility (31,250 and 10,000); d) water recycling, control of humidity and air temperature (37,500 and 1,54,560); e) shelter to birds, squirrels and insects, beneficial to ecology (31,250 and 1,29,700); f) removal of SPM-- suspended particulate matter, carbon dioxide, sulphur dioxide etc from air (62,000 and 4,02,000). One may multiply these by 75 to con-

The most precious contribution of a tree to humans is oxygen. As per a calculation, the amount of oxygen a human inhales a day is equivalent to three cylinders of oxygen available in hospitals for critical care. One cylinder of oxygen costs nearly ₹700. So, a person consumes oxygen worth 700 x 3 = ₹2,100 per day, generated free by plants. The average life-span of a human is 65 years. In his life time, he gets a share of 2100 x 365 x 65, which is approximately ₹5 crore worth of oxygen from the plants. It has been calculated that two trees (about 32ft tall) produce the oxygen required for one person. India has more than 130 crore people. We may calculate how much the cost of oxygen that trees provide us.

Again, the animals and birds, do mesticated as well as wild, essential for our day-to-day life and which keep our ecology wholesome, need much more oxygen to breathe. Besides, the combustion of fuels in our homes, industry and transport also consume oxygen, whose cost can be astounding.

All tress are not equally capable of producing oxygen. However, those like peepal, mango, jackfruit, neem and arjun, which grow to an average weight of six tonnes in 50 years, produce nearly 7.5 to eight tonnes of oxygen.

The other benefits of trees have also been evaluated, which can be briefly stated as follows: a) Dry leaves, twigs and branches provide 40 per cent of the cooking fuel to rural India (Environment Review, 2008); b) Mangroves boost

fishery yields by an average of about \$37,500 per year per hectare (University of California, San Diego, 2016); c) A tree (about 32 ft tall) generates 260 lbs of oxygen a year, more than half of the requirement (386 lbs/year) of a human (The Economist, 2012); d) One acre of forest absorbs 6 tonnes of carbon dioxide and puts out four tonnes of oxygen per year (US Department of Agriculture); e) An urban tree gives 53 to 67 times return to every dollar spent on it, which is in terms of storm management costs, waste water treatment, improving air quality reducing energy requirement for cooling etc (Christian Science Monitor, 2006); f) Trees act as buffers and absorb noise (nearly 50 per cent), thereby reducing noise pollution (US Department of Energy/Environment News, 2020); g) The evaporation from a single large tree can produce the cooling effect of a 10-room size air conditioner operating 20 hours a day (US Department of Agriculture); h) Trees are said to reduce criminal mentality and induce self-discipline and greater mental health.

On the other hand, people living in areas without trees, experience more deaths due to heart and res piratory problems (Earthshare.org). For a wholesome environment and balanced ecology, at least 30 per cent of the Earth's land area should be covered with trees and forests However, in many parts of the world, those are much below this critical limit; and to make matters worse, those are declining

fast @ 15 billion trees a year. The time has come to under stand the real value of tree and pro tect it. Otherwise, increasing global warming and climate change along with various kinds of environmental pollution and ecological disaster will continue taking their ever-increasing tolls.

The worst preys of pandemic

ruption to normal life, the world is busy fighting to check its spread. While the pandemic has pushed millions of people into economic hazards, we are yet to fathom the extent of damage that this challenge on the humanitarian front will indirectly inflict on children. According to UNICEF, the pan-

demic and the lockdown have impacted 247 million children enrolled in elementary and secondary schools in India. The reasons are lack of school infrastructure, the digital divide between rural and urban children and the absence of a policy that carries the very spirit of ensuring "Education for All".

Online education in India causes inequality, creates a divide among students and estranges the most marginalised and underprivileged ones. Though classroom-based learning has shifted to virtual model of education, a National Sample Survey (NSS) report for 2017-18 had said only 23.8 per cent of households had access to internet.

While the students from the upper strata have coped with the shift, the unprivileged ones are left behind. With no access to internet and even to computer or smartphone, these children enof learning. Lack of digital infrastructure and the rural-urban divide will keep millions of children at the periphery of the education system during Covid-19 shutdown, the NSS report states.

The Minimum Levels of Learning (MLL) approach usually refers to a set of desired competencies to be achieved by all children. Recently, the Atmashakti Trust, an NGO, undertook a study on the learning level of government school children, covering over 4.000 heads across the country. The findings showed that in Class-VIII, only 49.79 per cent, 54.35 per cent and 79.14 per cent passed the test in English, Math and regional language respectively. In Class-V, only 41.04 per cent, 48.72 per cent and 71.12 per cent passed the test in English, Math and regional language respectively. Similarly, 43.42 per cent and 27.64 per cent students in Class-III did not meet the expected learning levels in Math and regional language.

According to the Annual Status of Education Report (ASER) 2019, only 16 per cent of children in Class I in 26 surveyed rural districts were in a position to read the school texts at the prescribed level. Almost

deprived of the alternative mode understand letters and only 41 per cent of these children could read two-digit numbers.

Lack of school infrastructure poses another challenge during the pandemic, which will affect the education of children from poor backgrounds studying in government schools. Numerous studies suggest that students in schools with poor infrastructure can have lower scores than those with access to better infrastructural facilities. An overcrowded classroom with a chaotic learning environment can adversely affect students' learning capabilities. A NITI Aayog report states that 93 per cent of government schools are running without a computer, 23 per cent without a ramp, 79 per cent without a playground, 81 per cent without electricity, two per cent without boys' toilets, one per cent without girls' toilets and 0.4 per cent without proper buildings. The same abvsmal situation prevails in several states that were covered under the survey.

In states, where the basic infrastructure of the school is in a bad state, the government will require to provide immediate attention to the betterment of students' learning. A report of the World Economic

ity of sacrifice during an epidemic that is unreasonably hurting the poorest and the most vulnerable of the populations. Therefore, underprivileged and disadvantaged children will be the worst preys of the pandemic.

With the existing digital divide, relying only on online education will push the have-nots out of the education system as well as compel them to work to support their families. Moreover, schools are more than a teaching-learning place for underprivileged children. For them, the school remains the centre of social protection, health and nutrition.

In this situation, a question is, what solution can state governments offer to ensure children's 'right to education' during the pandemic. Experts say governments should use the lockdown as an opportunity to provide remedial classes for weaker students so that they shall be on par with the other students once regular school starts. And, if we address the issue in a serious manner, especially during the pandemic, cases of drop-out and the like will significantly come down.

Assam flood situation grim

Guwahati, July 22: The flood situation in Assam deteriorated Wednesday with two more persons losing their lives, even as the number of people affected rose to over 26 lakh across 26 districts, an official bulletin said.

According to the daily flood report of the Assam State Disaster Management Authority (ASDMA), one person each died at Baghbor of Barpeta and Morigaon revenue circle in Morigaon district. With this, the total number of people losing their lives in this year's flood and landslide has gone up to 115 across the state -- 89 were killed in flood-related incidents and 26 in landslides.

The ASDMA said over 26.31 lakh persons are hit by the floods in Dhemaji, Lakhimpur, Biswanath, Darrang, Baksa, Nalbari, Barpeta, Chirang, Bongaigaon, Kokrajhar, Dhubri, South Salmara, Goalpara, Kamrup, Kamrup Metropolitan, Morigaon, Nagaon, Hojai, Golaghat, Jorhat, Majuli, Sivasagar, Dibrugarh, Tinsukia, West Karbi Anglong and Cachar districts.

Goalpara is the worst-hit district with over 4.68 lakh people suffering, followed by Barpeta (3.82 lakh people affected) and Morigaon (3.08 lakh people). The National Disaster Response Force, the State Disaster Response Force, district administrations and local people have rescued 452 persons since Tuesday by deploying 80 boats across the state.

Till Tuesday, more than 24.19 lakh persons were suffering due to the deluge across 24 districts. At present, 2,525 villages are

of crop areas have been damaged across Assam, the ASDMA said.

It further said authorities are running 391 relief camps and distribution centres across 20 districts, where 45,281 people have taken shelter. A total of 3,383.81 quintals of rice, dal and salt, and 606.10 litres of mustard oil along with other relief materials such as tarpaulin, baby food, candle, matchbox, mosquito net, biscuit, soap, drinking water, cattle feed, mask and wheat bran have been distributed.

The Brahmaputra is flowing above the danger marks at Dibrugarh, Dhubri and Goalpara cities, besides at Nimatighat in Jorhat and Tezpur in Sonitpur districts. Its tributaries Dhansiri at Numaligarh in Golaghat, Jia Bharali at NT Road Crossing in Sonitpur, Kopili at Kampur and Dharamtul in Nagaon, Beki at Road Bridge in Barpeta, Kushiyara at Karimganj town and Sankosh at Golokoganj in Dhubri are also flowing above the danger levels. Embankments, roads, bridges, culverts and many other infrastructure have been damaged at various places in Lakhimpur, Chirang, Nagaon, Jorhat, Údalguri. Biswanath, Barpeta, Bongaigaon, Morigaon, Karimganj, West Karbi Anglong and Dibrugarh districts.

Massive erosion have been reported from different places of Biswanath, Majuli, Baksa, Udalguri and Kokrajhar districts, the ASDMA said. The bulletin said that a total of 131 camps out of 223 at Kaziranga National Park, 18 out of 40 camps at Rajiv Gandhi Orang National Park and 24 out of 25 camps at Pobitora Wildlife Sanctuary have been affected by the deluge.

The deluge has so far taken away the lives of 120 animals, while 147 others were rescued in Kaziranga National Park, the bulletin said auoting the forest officer of the Eastern Assam Wildlife Division.

The flood has also affected 23,89,401 domestic animals and poultry across the state, it added.

Blast near oil well on fire for a month

Tinsukia/Dibrugarh, July 22: A massive blast occurred near the Oil India Limited's Baghjan well in Assam's Tinsukia district Wednesday, injuring three foreign experts involved in the dousing of the well fire raging for over a month.

The experts have been rushed to a hospital at Dibrugarh, Oil India Limited's senior manager, public affairs, Jayanata Bormudoi, said.

The experts have been identified as Anthony Steven Reynolds, Doug Dallas and Craig Neil Duncan, he said

The blast occurred when the experts were on their way to open the spool of the well before putting up the blow out pre venter (BOP) that finally douses the fire, Bormudoi said.

The well has been spewing gas since May 28 and a fire has been raging in the area since June 9 in which two firefighters lost their lives.

The dousing operation has been called off at Baghjan after the blast. The cause of the blast, its scale and nature are being ascertained, the official said.

The oil well at Baghjan, 500 km from Guwahati, had a blowout May 28 and has been leaking gas since, causing damage to the region's wetlands and biodiversity. The well had caught fire last month while clearing operations were going on. Two firefighters of Oil India Ltd were last month found dead at a wetland near the site. The fire was so intense that it could be seen

Lucknow, July 22: The Congress in Uttar Pradesh is gradually turning into a battleground for Rahul Gandhi's loyalists and his sister Priyanka's supporters.

What began as a covert standoff. is now turning into an open battle. "It all began in October last year when Ajay Kumar Lallu was appointed UPCC president and he arrived in Lucknow to take charge. The UPCC office reverberated with 'Sonia Gandhi zindabad', 'Privanka zindabad' and 'Ajay Kumar zindabad' but no one said 'Rahul Gandhi zindabad'. The speakers at the function also avoided mentioning the name of Rahul. That was the day we realised that this Congress had turned into Privanka Congress. said a veteran leader.

According to party insiders, all Rahul loyalists in the party have been completely sidelined. "There is no room for us in the present dispensation where Priyanka's men - including her personal secretary Sandeep Singh and UPCC president Ajay Kumar Lallu - call the shots. Priyanka meets only those partymen whose names are cleared by these two and we cannot even get our views across to the party lead-

ership," the leader said. An example of this is the 10 senior Congress leaders who were expelled in November last year for 'anti-party activities'. Expelled party leader and former MLC, Haji Siraj Mehdi, said, "Some of us had decided to meet on Nehru Jayanti November 14 and pay our tributes to the nation's first Prime Minister because we had not been informed or invited to the function at UPCC. Four days after the meeting, we

Jitin Prasada. on the other hand, is busy with his own outfit, the Brahmin Chetna Parishad, and is charting his own course in Brahmin politics.

Nadeem Ashraf Jaisi, a senior party leader from Rae Bareli, who quit the Congress to join Aam Aadmi Party a few months ago, said, "Those who have worked with Rahul Gandhi are now being sidelined and ignored. If someone like Chaudhary Zile Singh (Noida) who has worked with late Rajiv Gandhi, is forced to quit the Congress, those at the helm of affairs should do some introspection.

Former Congress MP, Santosh Singh -- one of those expelled from the party-- said that apart from pushing out dedicated party workers, the party was now 'importing' youth from other parties and Leftist outfits like AISA and Rihai Manch.

"Priyanka should learn to recognise Congress leaders and develop leadership from within the party instead of importing leaders for outside. If this trend continues, the Congress may not win even a single seat in the next Assembly elec-

'CORONA WARRIORS ARE EXHAUSTED

Agra, July 22: The daily average of new coronavirus cases in Agra in July works out to almost 15, compared to eight in June. Opening of markets and increased public mobility are feared to have led to the increase in infections.

"The reality is that all corona warriors, including police, are tired -- doctors, paramedics, sanitation workers are all exhausted and feel drained," a private medical practitioner claimed. A private doctor advocated more active role of the private hospitals at this stage, so that public health sector could take a breather. Agra reported 19 new coronavirus cases in the last 24 hours till Wednesday morning, taking the total tally to 1,536, including 94 deaths. The recovery rate is 82.68 per cent with 172 active

cases in the district. Neighbouring districts too are reporting corona cases in double figures on a daily basis. A health activist said private facilities should be allowed to conduct antigen tests to detect coronavirus infections and

the kits should be made available at chemist shops.

"The government's whole approach so far seems to be to keep the coronavirus figures in check and present a positive profile of the country at the international level. It's a strange fix - people are not satisfied with governmental efforts but it won't let the private sector play its role. For over three months now, most private clinics have remained closed and doctors gone on holiday, depriving the common man of prompt medical treatment," social activist Shravan Kumar Singh said.

This is a part of an exercise to cut the annual syllabus by 30 per cent in view of the disruptions in the academic session due to the pandemic. As per the curtailed syllabus for all subjects for Classes 9 12, the deleted chapters include 'Ninda Ras' by satirist Harishankar Parsai and Kaikeyi's repentance

song by Maithili Sharan Gupt. Challenges of the Congress system and political party dominance in independent India; Harappan civilisation; and Partition: History and nationality, sectarianism and division of 1940 in 'division based on physical sources' have also been dropped.

In the 'Contemporary World Politics' section, the deleted chapters include the US hegemony in world politics, security in contemporary world, and globalisation. UPSEB Secretary Divya Kant Shukla said the syllabus has been shortened to make up for the academic loss caused due to COVID-19.

"We have only deleted the topics from the examinations and not from textbooks. So, if students want, they can still study the dropped topics," Shukla said and added that the Board has done its best to retain relevant and important topics

"For instance, if there were four



poems of Suryakant Tripathi 'Nirala' in the Hindi textbook, we have kept two and dropped the other two from this year's syllabus, he said. The 30 per cent of the top-

ics removed from Class 10 civics syllabus includes content on democracy, caste, religion and sexual issues. In mathematics, chapters like circle, probability, some trigonometry applications, parallel series and polynomials have been dropped.

In English syllabus for Class 10, Torch bearers and our Indian music; poem 'The Nation Builders' by R.W. Emerson have been removed. Supplementary reading, 'My Greatest Olympic Prize' by Jesse Owens, too, is omitted.

From Class 10 social science syllabus, information about major national parties and regional parties of India have been removed.

In science course for Class 10, topics such as properties of metals and non-metals; classification of elements into the periodic table, electromagnetic effects, electrical effects, natural resources and ourenvironment have also been dropped.

Kolkata: A suspected COVID-19 patient, his pregnant wife and child were allegedly beaten up by their neighbours at Patuli in the southern part of the city, police said Wednesday. An investigation has been initiated into the case after a complaint was lodged at the local police station by the man. "My three-year-old son, my wife who is three months' pregnant and I have been assaulted physically by our immediate neighbours on Tuesday afternoon. They pushed my wife and beat me with shoes. Our neighbours are opposing our stay at our home though we are staying strictly inside our flat and have not violated any quarantine protocol," the man said.

Woman saves 4-year-old son

New Delhi: A woman resolutely held out against two motorcycle-borne men who tried to kidnap her fourvear-old child in Shakarpur area of east Delhi, forcing them to flee without their bike. The whole incident, on Tuesday, was captured on CCTV camera in which the two helmet-wearing kidnappers are seen forcibly trying to grab the child. However, the mother pounced on the bike like a lioness. making them panic and lose balance. While the woman snatched back the child, one of the men ran away on foot while the other tried to flee on the bike. Hearing the shrieks of the woman, area residents gathered at the spot, and an alert man among them blocked the passage of the bikers with a two-wheeler. After a brief scuffle, the criminals managed to flee. leaving their vehicle behind.

GEHLOT'S BROTHER RAIDED, CONGRESS **QUESTIONS TIMING**

New Delhi, July 22: As the Enforcement Directorate (ED) carried out searches Wednesday at over a dozen locations in Delhi. Rajasthan, Gujarat, and West Bengal in the fertiliser scam case, including the house of Rajasthan Chief Minister Ashok Gehlot's brother Agrasain Gehlot, the Congress questioned the timing of the action.

Following the ED raids, the Congress flayed the Modi government and maintained that when the Centre's attempts to topple the party's state government failed, the ED had conducted raids, including at the premises of Gehlot's brother. "Whenever the BJP is in trouble,

when the BJP fails to topple any government, then they take the support of the ED, CBI and the Income Tax," Congress spokesperson Randeep Singh Surjewala told reporters in Jaipur. The ED searches are being car-

ried under the Prevention of Money Laundering Act (PMLA), 2002. The ED has filed a case under the PMLA based on a Customs Department complaint and charge sheet in the alleged fertiliser scam case.

A top ED official said: "The ED $\,$ is conducting searches at 13 locations across the country -- four in Gujarat, six in Rajasthan, two in West Bengal and one in Delhi."

The official said that the financial probe agency is also carrying out searches at the premises of Agrasain Gehlot, whose firm Anupam Krishi held authorised dealership of Indian Potash Ltd (IPL). An ED source claimed the company owned by Agrasain Gehlot was involved in exporting Muriate of Potash (MoP) fertiliser, which is banned for exports. MoP is imported by IPL and distributed among farmers at subsidised rates.

The source further said that Agrasain Gehlot is facing a Rs 7 crore Customs penalty in the fertiliser case. According to the source, Agrasian Gehlot was an authorised dealer for IPL and between 2007-09, his company bought MoP at subsidised rates and instead of distributing to farmers sold it to few other companies, who in turn exported it to Malaysia and Singapore in the guise of industrial salt.

The searches comes in the backdrop of a political crisis in Rajasthan after the rebellion by then Deputy Chief Minister and PCC President Sachin Pilot, who was sacked from these posts on July 14. The case was unearthed by the Directorate of Revenue Intelligence in 2012-13. The BJP had raised the issue in 2017.

ED joins Kerala gold smuggling probe

THE ED HAS POWERS TO ATTACH THE IMMOVABLE AND MOVABLE ASSETS OF THE ACCUSED UNDER THE PMLA

New Delhi, July 22: The Enforcement Directorate (ED) has filed a money laundering complaint in connection with the Kerala 'diplomatic baggage' gold smuggling case, officials said Wednesday.

They said the agency has registered an Enforcement Case Information Report (ECIR), equivalent of a police FIR, after studying the NIA complaint filed in the case recently. The ED case has been booked under the Prevention of Money Laundering Act (PMLA) and the agency will record the statement of the accused, they said.

The central agency will investigate if proceeds of crime were generated by the accused by laundering of funds that were earned through the alleged gold smuggling racket. The ED also has powers to attach the immovable and movable properties of the accused under the PMLA. The case emerged on

July 5 when gold, weighing over 30 kg, was seized by the Customs department from the "diplomatic baggage" that had landed by air cargo at the Thiruvananthapuram international airport from the Gulf. The seized gold is stated to worth nearly Rs 15 crore. The ED is the fourth central agency that is probing the accused involved in the case after the Customs, NIA and the Income Tax Department. The NIA had arrested the prime accused in the case, Swapna Suresh and her associate Sandeep Nair, from Bengaluru on July 11. The NIA had told a special court

in Kochi on Tuesday that Suresh, Nair and others conspired to damage the country's monetary stability by smuggling large quantity of gold from abroad. In a report submitted to the court, the NIA also said it is suspected that the accused had used the proceeds of smuggling for financing terrorism through various means.

The accused deliberately used the diplomatic baggage of UAE as a cover to transact illegal business and it may have serious repercussions in India's diplomatic relations with the UAE government and it is prejudicial to the monetary

and economic security of India as well, the NIA said. The NIA has interrogated Suresh and Nair who are in its custody till July 24. It has booked Suresh, Sarith P S, Nair and Fasil Fareed under the Unlawful Activities (Prevention) Act. Suresh was working in the Information Technology department and her contractual service terminated after her name cropped up in the gold smuggling case.

IAS officer M Sivasakar was removed as Principal Secretary to Chief Minister Pinarayi Vijayan and the state IT Secretary over his alleged links with Suresh and other accused in the case. She is also stated to be a former employee of the UAE consulate Thiruvananthapuram.

Sarith P S, also a former employee of the UAE consulate in Kerala, was arrested by the Customs department after the gold was seized. Dubai-based businessman Fareed is still at large.

SC nod for judicial probe panel

New Delhi, July 22: The Supreme Court Wednesday approved Uttar fication for appointing former apex court judge Justice (retd) B S Chauhan as chairman of the 3member inquiry commission on the killing of eight policemen and the subsequent encounter killings of gangster Vikas Dubey and five of his alleged associates.

A bench headed by Chief Justice S A Bobde directed that the inquiry commission should start functioning within a week and the probe be concluded within two months. The other two members of the inquiry commission would be - former high court judge Justice (retd) Shashi Kant Agarwal and retired Director General of Police of Uttar Pradesh K L Gupta.

The bench, also comprising Justices A S Bopanna and V Ramasubramanian, cleared the draft notification and asked the Uttar Pradesh government to notify it. "We direct that the notification constituting the Commission and incorporating the Terms of DUBEY ENCOUNTER



Reference as approved by us, shall be issued immediately. The Commission shall sit at Lucknow, Uttar Pradesh and start functioning within a period of one week from today," the bench said in its order.

"It is made clear that the secretarial assistance for the Commission shall be provided by the Central Government, from such services/Departments as may be directed by the Chairman of the Commission," the bench said. The apex court was hearing a batch of petitions which have sought court-monitored probe into encounters of Dubey and five of his alleged associates.

Some of the pleas have also sought probe into the killing of eight policemen, including DSP Devendra Mishra, who were ambushed in Bikru village in Chaubevpur area of Kanpur when they were going to arrest Dubey and fell to bullets fired from rooftops shortly after midnight on July 3.

In its order, the bench said that commission shall submit a report to the apex court and the state government "in accordance with the Commissions of Inquiry Act, 1952, within a period of two months from the date on which the Commission starts functioning." "Needless to mention that any party to the present petitions may apply to the inquiry commission for being heard,"

The bench also directed that the Special Investigation Team (SIT), which has already been constituted by the Uttar Pradesh Government, "will be free to inquire into any of the related incidents which are the subject matters of the case". "List the matter thereafter along with the report of the Commission," it said

Widow of Colonel killed in clash appointed Dy Collector

KCR, as the Chief Minister is popularly known, had lunch with 20 of the family members of Santoshi who accompanied her to Pragathi Bhavan. He enquired about their well-being and assured that the governSantosh Babu's family.

It was exactly a month be fore that KCR had visited the family of Santosh Babu in Survapet town to console his parents and other family members and handed over Rs 5 crore as ex gratia. He had also handed over to Santoshi the letter of her appointment to Group-1 job and documents on the allotment of a house site measuring 711 square yards in Banjara Hills, Hyderabad.

Meanwhile, officials were busy making arrangements to handover the land to the family. Hyderabad Collector Shweta Mohanty and other officials inspected the land which is to be handed over to the martyr's family. Santosh Babu and 19 other other soldiers were killed in the clashes with Chinese troops in Galwan Valley of Ladakh on June 15. The Colonel is survived by his wife, a nine-year-old daughter and a four-year-old son.

CORONA BACKLASH

Maha villagers defy Covid tests

Raigad (Maharashtra), July 22: Hundreds of angry Bodni villagers, including at least 2 Covid-19 patients, trooped out on the road to defy the government, police and medical teams coaxing them to undergo Covid-19 tests, officials said Wednesday.

The ire of the villagers was such that one of them allegedly attempted to spit on a PPE-clad medico, ostensibly to prove that nothing was wrong with them and they didn't require Covid tests. The ruckus was witnessed in the small coastal fishing hamlet of Bodni in the Alibag sub-district of Raigad district, where around 60 families, among whom at least 72 persons have tested positive so far, created a huge health scare among the district medical, police and administration teams.

This was unexpected. The villagers seemed to be under some misunderstanding and we sent our Tehsildar and other officials to convince them. But they remained adamant," a top official in the Alibag Collectorate said,

requesting anonymity.

The official added that the particular fishing hamlet in Bodni has already been declared as a containment zone, but the people there have been noticed flouting all norms routinely. "From tomorrow, we plan to clamp stringent containment measures as per the laws. Nobody will be allowed inside or outside the area and other rigorous protocols shall be implemented, besides testing all the residents," the official cautioned.

The incident came almost simultaneously with a huge commuters' protest and train blockade which was witnessed in Nala Sopara town in Palghar district where irate commuters demanded resumption of public transport services.

At Bodni, two ambulances carrying a medical team arrived to carry out swab tests on the locals, but were stunned to find themselves blocked at the hamlet entrance by a menacing crowd, booing and screaming at them to go back.

Combat readiness sent a strong message: Rajnath

THE DEFENCE MINISTER SAID THE NATION'S RESOLVE TO DEFEND ITS SOVEREIGNTY STAN

New Delhi, July 22: Defence Minister Rajnath Singh Wednesday complimented the Indian Air Force for its rapid deployment of assets at forward locations in response to the border row with China in eastern Ladakh, saying its Balakot strike and the current combat readiness have sent a strong message to "adversaries"

In an address to the top commanders of the IAF on the opening day of a three-day conference, the defence minister said the nation's resolve to defend its sovereignty stands firm and that the people of the country have full confidence in the capability of its armed forces.

Singh also talked about the "professional manner" in which the IAF conducted the air strikes deep inside Pakistan's Balakot last year and appreciated the force for its proactive response in bolstering its operational capabilities over the past few months.

"He stated that the professional manner in which IAF conducted the air strikes in Balakot as well as rapid deployment of IAF assets at forward locations in response to the prevailing situation in eastern Ladakh has sent a strong message to the adversaries," the defence ministry said in a release.

He said the nation's resolve to defend its sovereignty stands firm on the faith its people have in the



capability of its armed forces. Singh also mentioned the ongoing efforts to de-escalate tension along the Line of Actual Control and urged the IAF to stand ready to handle any eventuality.

Chief of Air Staff Air Chief Marshal RKS Bhadauria said that the IAF was well prepared to counter short term as well as strategic threats and the units were "evenly poised" to counter any aggressive action by the adversary.

He said the response by all commands in ensuring deployment and readiness of forces was prompt and laudable. He also emphasised on the need to focus on the ability to handle situations at a short notice for ensuring a robust response. In his address, the defence minister also acknowledged the IAF's role in adapting to changes in technology.


He also talked about adopting emerging capabilities like nano technology, artificial intelligence, cyber and space domains. He assured the commanders that all requirements of the Armed Forces, whether financial or otherwise, would be fulfilled, the ministry said.

In the conference, the IAF commanders will carry out an in-depth review of the country's air defence system which will include deployment of the first batch of Rafale fighter jets in the Ladakh sector.

The main focus of the commanders' conference will be to deliberate on the overall situation in eastern Ladakh and enhance the IAF's combat prowess over the country's air space in all sensitive sectors along the de-facto border with China including in Arunachal Pradesh, Sikkim and Uttarakhand, the sources said.

The commanders are expected to specifically deliberate on deployment of first batch of around six Rafale jets in the Ladakh sector by early next month as the aircraft are set to join the IAF's fighter fleet by July 29, the sources said. In a demonstration of its aerial prowess, the IAF has been carrying out night time combat air patrols over the eastern Ladakh region in the last few weeks, in an apparent message to China that it was ready to deal with any eventualities in the mountainous region. The IAF has deployed almost all its frontline fighter jets like Sukhoi 30 MKI, Jaguar and (Mirage 2000 aircraft in key frontier air bases in eastern Ladakh.

Mathura, July 22: All 11 former policemen from Rajasthan, convicted for killing Raja Man Singh of the erstwhile Bharatpur royal family and his two colleagues over 35 years ago in Deeg area of the state, were awarded life sentence by a court here Wednesday.

The convicts, who were sentenced to life term by Mathura District Judge Sadhna Rani Thakur, include former Deeg Dy SP Kan Singh, 82, and local police station in-charge, sub-inspector Virendra Singh, 78, who had led a police team in killing the Bharatpur royal scion and his two colleagues Sumer Singh and Hari Singh on February 21, 1985.

The other policemen sentenced

and former constables Sukh Ram, Jeevan Ram, Jag Mohan, Bhanwar Singh, Hari Singh, Chhatar Singh, Sher Singh, Daya Ram and Ravi Shekhar, all above 70 years of age.

The encounter had taken place in Deeg grain market a day after Raja Man Singh, then contesting the state Vidhan Sabha election as an independent candidate, had allegedly banged his jeep into former Rajasthan's chief minister Shiv Charan Mathur's helicopter.

According to the prosecution, he was also accused of damaging some publicity material and a stage set up for Mathur to address an election rally in favour of the Congress candidate Brajendra Singh, a retired IAS officer, the prosecution had told the court. Days after the killings of the royal family chief and his two col-

leagues, the case was transferred by the then central government to the CBI on February 27, 1985. The trial was later shifted from a Jaipur special court to Mathura in Uttar Pradesh by the Supreme Court in November 1989 on the plea of complainant Vijay Singh, a son-in-law of the slain chief of the erstwhile riyasat.

"Besides undergoing life imprisonment, all the eleven convicts will have to furnish a fine of ₹10,000 each failing which they will have to undergo additional imprisonment of two months each," District & Session Judge Thakur announced in a jam-packed courtroom.

Besides being held guilty of murder, all 11 former policemen were also convicted for "committing riots armed with deadly weapons" and being part of the unlawful assembly committing an offence with common objective under sections 148 and 149 of the IPC respectively. For these two offences, all 11 convicts were sentenced to two years and six months respectively in jail and were imposed fines of ₹2,000 each. All sentences would run concurrently, the court said.

The court also ordered payment of ₹30,000 to the next of kin of each of the deceased and ₹2,000 to the four injured persons, Vijai Singh Chandan Singh, Nawab Singh and

New Delhi, July 22: Rajya Sabha Chairman M Venkaiah Naidu urged 45 newly-elected members of the House who took oath Wednesday to uphold rules and procedures while discharging their duties as lawmakers and not fall prey to disruptions.

The 45 members, including 36 first-timers, took the oath of office in the Rajya Sabha chamber while following physical distancing norms. In total, 61 members have been elected to the House of which 43 are first-timers.

Twelve sitting Rajya Sabha members who have been re-elected, including Sharad Pawar, Harivansh, Ramdas Athawale, Digvijaya Singh, Bhubaneswar Kalita, Prem Chand Gupta and Biswajit Daimary, also took oath.

BJP leader Jvotiraditya Scindia and Congress' Mallikarjun Kharge are among the first-time members of the House who took oath. Scindia, who has been elected to the Raiva Sabha from Madhva Pradesh, greeted his arch-rival Digvijaya Singh, and Kharge before his oath-taking.

Scindia and Singh had huge differences and this was one of the reasons of Scindia quitting the Congress. Scindia also greeted Leader of Opposition in Rajya Sabha Ghulam Nabi Azad. Those members who could not take oath Wednesday will do so during the ensuing Monsoon Session.

After the oath-taking ceremony, Naidu urged the MPs not to fall prey to the temptation of disrupting the proceedings of the House for "short-term gains". The chairman suggested the members to question themselves if they had acted to enhance the dignity of the institution at the end of each day during the session and whether their conduct was ethical during the inter-session period.

"Answers to these simple questions would guide you on the right path," he said. "Ensuring rule of law is the spirit of our law of the land (Constitution). It shall begin with your compliance with the rules and procedures of this House," Naidu said.

SC NOTICE TO BHUSHAN

New Delhi, July 22: The Supreme Court Wednesday issued notice to advocate Prashant Bhushan over the alleged contemptuous remarks made on Twitter. The court also asked the Attorney General to assist it in the case. A Bench, comprising Justices

Arun Mishra, B.R. Gavai and Krishna Murari, asked Bhushan and Twitter to file reply by August 5. "We are, prima facie, of the view that the aforesaid statements on Twitter have brought the administration of justice in disrepute and are capable of undermining the dignity and authority of the institution of the Supreme Court in general and the office of the Chief Justice of India in particular, in the eyes of public at large," the court said.

Senior advocate Sajan Poovayya, representing Twitter Inc, USA, contended that he would advise his client to delete the offensive tweets.



The Bench questioned Twitter why it couldn't disable the tweets on its own even after a contempt case had been initiated. The

counsel for Twitter said he understood it and would convey the court's intent to his client. He also submitted be-

fore the Bench to direct it to disable tweets by Bhushan, and insisted that Twitter couldn't delete tweets without the court di-

rection. "We take suo motu cognizance of the aforesaid tweet also, apart from the tweet quoted above

and suo motu register the proceedings. We issue notice to the Attorney General for India and to Prashant Bhushan also," the court said referring to Bhushan's two tweets. The Supreme Court initiated suo motu contempt proceedings against

Bhushan for allegedly making derogatory comments against the top court on Twitter. The first tweet, posted on June 27, alleged the last four Chief Justices had played a role in the "destruction of democracy" during undeclared "emergency' for the last six years.

GOA LEADERS BACK ONLINE 'PUJA' IN CORONA TIMES

Panaji, July 22: With public movement restricted due to the Covid-19 pandemic and "pujaris" (priests) reluctant to visit homes out of caution, a new online "puja" initiative started on the eve of the festivalheavy Shravan month by a local religious centre, has found backing across political lines.

The initiative started by the Shree Datta Padmanabh Peeth based in South Goa's Ponda sub district, offers online puja solutions for several festivals like Nag Panchami, Shravan Somvar, Satyanarayan Puja, Narali Poornima, etc. These are held during the Hindu calendar month of



Shravan (beginning on July 23) which winds up with the culmination of Ganesh Chaturthi.

"Whatever the severity of the pandemic, it cannot be allowed to wean us away from God. So we have to take support of technology for worship. You can now offer prayers from the comfort of your home. Look at this as an opportunity and not an impediment," Sadguru Brahmeshanandacharya, spiritual head of the peeth said Wednesday.

The peeth, also referred to as the Tapobhoomi is a politically sensitive entity with a mass following among the state's Bahujan Samaj (a non Brahmin caste grouping) in Goa.

According to Chief Minister Pramod Sawant, the online puja service would do away with the need for pujaris, who are reluctant to visit homes due to fear of contracting the dreaded viral infection during the pandemic. Goa currently has more than 1,400 active Covid-19 cases and has reported 25 deaths.

"All of us in Goa are facing several kinds of problems due to the pandemic. Pujaris who would frequent homes in Goa for purpose of puja are now reluctant to pay such visits. In view of this, I welcome initiative taken by the Padmanabh sampraday to the start online puja service," Sawant said in a video

message. "Even in absence of pujaris, the online puja service will make us feel that there is a pujari by your side to help assist with all rituals and observances," Sawant said.

Union Minister of State for Defence and AYUSH Shripad Naik has also backed the initiative. "Puja by video conference simplifies the process of worship for users, especially in these times," Naik said. Leader of Opposition and former Chief Minister Digambar Kamat has also backed the online puja service. "There are Covid-19 cases increasing in Goa. Shravan is a holy month with many religious festivities. The online puja service will encourage social distancing," Kamat said.

The change to immigration rules was introduced after China imposed a new sweeping national security law on Hong Kong.

Najib to pay \$400mn tax bill

Kuala Lumpur: A Malaysian court Wednesday ordered former Prime Minister Naiib Razak to settle 1.69 billion ringgit (\$397.41 million) in unpaid taxes over seven years while he was still in office, according to a report by national newswire Bernama. Defeated in the 2018 general election amid widespread outrage over allegedly rampant graft in his government, Najib is facing multiple charges of corruption and abuse of power linked to billions of dollars Malaysian prosecutors say was siphoned off from state fund 1Malaysia Development Berhad (1MDB).

Two men, baby killed in shootings

Canton (US): An infant was killed and his twin brother was wounded when someone fired several shots into an Ohio home early Wednesday, authorities said. The shooting came just hours after two other separate shootings in the same city, Canton, left two men dead and two others wounded. The 1-year-old twins, Ace and Arcel Lucas, were sleeping on a couch inside the home when several shots rang out shortly before 2:30 a.m., authorities said. It wasn't clear how many shooters may have been involved or if they were on foot or in a vehicle. Both children were taken to hospitals but Ace was pronounced dead a

short time later.

Pak journalist freed; top court expresses alarm over abduction

Islamabad, July 22: A top Pakistani court Wednesday expressed alarm at the abduction of a prominent journalist Matiullah Jan, who was later freed, noting that kidnappers wore police uniforms and wanted to "scare" other people too.

The Islamabad High Court Chief Justice Athar Minallah heard the habeas corpus petition against Jan's abduction filed by his family Tuesday. The court took prompt action and ordered Secretary Interior, Commissioner, Islamabad and Inspector General, Islamabad to produce the journalist on Wednesday or personally appear before the court.

Jan, who is highly critical of the government and the security institutions of the country, was freed on Tuesday, hours after he was abducted by plainclothes and uniformed personnel in the national capital Chief Justice Minallah noted that CCTV footage showed that some kidnappers were in police uniforms.



"Someone has the nerve to do such a thing in police uniforms... What impression will the public get that people are roaming around freely in police uniforms," he said. He further said the vehicle used in the incident had police headlights and the kidnappers wanted to "scare" other people also.

When Islamabad Police Deputy Inspector General for Operations Wagar ud Din told the court that an FIR was registered, the Chief Justice said it was a test case for police. "If there is no rule of law, there will be nothing here except chaos." Justice Minallah said and wrapped up the case. Earlier, he refused to monitor the follow up by police by saying that the police should do its duty to investigate the incident and take action.

India next to US in Covid testing: Trump

Washington, July 22: The US is leading the world in terms of COVID-19 testing and India is second, President Donald Trump has said while warning Americans that the pandemic may "get worse before it gets better."

Over 140,000 Americans have died due to the coronavirus and 3.8 million have tested positive in the country. While the US economy is slowly coming back to normal, the pandemic is now spreading in many Sun Belt states, including in Arizona, Florida, Texas and parts of California.

"As one family, we mourn every precious life that's been lost. I pledge in their honour that we will develop a vaccine and we will defeat the virus. We're doing very well with vaccine development and therapeutic development." Trump said at a White House news conference Tuesday, his first on coronavirus after several weeks.

His daily news conferences ended soon after he suggested in April that the virus might be treated by injecting disinfectant into people, for which he was scorned by doctors, scientists and political rivals. to accept any new patients.

Trump insisted the American response to the pandemic was "much better" than in other places. But he also warned that the disease could get worse in the coming days.

"It will probably unfortunately get worse before it gets better," he said. Cases are surging in several US states, particularly in southern states that were initially reluctant to enforce lockdowns or mandate the wearing of masks.

Florida is currently the epicentre of the US epidemic. In recent weeks, hospitals across Florida warned that their ICUs were at capacity and that they were unable

Replying to a question, Trump said the US is "leading the world" in terms of COVID-19 testing. "We're going to be over 50 million tests,' he said, adding that "second country is India with 12 million (tests). Then you have seven million, six million, and four million. The House passed the National Defense Authorisation Act for Fiscal Year 2021 by a vote of 295 to 125 Tuesday. There is no guarantee yet that the ban will become an act as the Senate is expected to pass its version of the bill later this week and thereafter the two chambers will sort out their differences before sending it for the President's signature.

Quake jolts Alaska towns, produces small tsunami


Anchorage, July 22: A powerful earthquake off Alaska's southern coast jolted coastal communities late Tuesday, and some residents briefly scrambled for higher ground over fears of a tsunami.

There were no immediate reports of damage in the sparsely

populated area of the state, and the tsunami warning was canceled after the magnitude 7.8 quake off the Alaska Peninsula produced a wave of a less than a foot.

According to the US Geological Survey, the earthquake struck Tuesday at 10:12 pm local time and was centered in waters 65 miles

(105 kilometers) south-southeast



of the tiny community of Perryville, at a depth of 17 miles (28 km). Because of the temblor's location, nearby communities along the Alaska Peninsula did not experience shaking that would normally be associated with that magnitude of a quake, said Michael West, Alaska State Seismologist.

That doesn't mean they slept through it, West said residents in small towns within a hundred miles (160 kilometers) of the quake reported very strong shaking. Some shaking was also felt more than 500 miles (805 kilometers) away in the Anchorage area, West said.

The tsunami warning prompted coastal residents to evacuate to higher ground, with social media posts showing long lines of people fleeing towns like Homer and Kodiak as tsunami sirens wailed in the

A study published in the US Centers for Disease Control and Prevention (CDC) July 16 looked in detail at 5,706 "index patients" who had tested positive for the coronavirus and more than 59,000 people who came into contact with them.

The findings showed just two out of 100 infected people had caught the virus from non-household contacts,

while one in 10 had contracted the disease from their own families.

By age group, the infection rate within the household was higher when the first confirmed cases were teenagers or people in their 60s and 70s. "This is probably because these age groups are more likely to be in close contact with family members as the group is in more need of protection or support," Jeong Eunkyeong, director of the Korea Centers for Disease Control and Prevention (KCDC) and one of the authors of the study, told a briefing.

Children aged nine and under were least likely to be the index patient, said Dr. Choe Young-june, a

Mumbai, July 22: Citing the yet to be stabilised infection curve and the COVID-19 caseload in economically key states, Singaporean brokerage DBS Wednesday forecast deeper distress for the country which will lead to a 6% growth contraction in FY21.

In its earlier forecast, the brokerage had penciled in a minus 4.8% growth for the current fiscal.

According to the report, just 7% of the districts in economically key states of Maharashtra, Tamil Nadu and Gujarat, accounting for 30.5% of the national economic output, and in Karnataka and Andhra Pradesh account for as much as

New Delhi, July 22: Driven by Huawei and new Apple iPhones which are set to join the ranks, the 5G handset production is expected to reach 235 million units at an 18.9 per cent penetration rate by the end the year, according to

Led by Huawei, Chinese brands are expected to occupy four out of the top six spots of 5G smartphone brands ranked by production volume, said marker research firm TrendForce. Huawei has shifted its focus to the

domestic Chinese market under the impact of US sanctions and in preparation for China's active 5G commercialization efforts. The company is expected to pro-

duce about 74 million 5G smartphones this year.

Apple's yearly 5G smartphone production is expected to total about

70 million units in 2020, which lands the iPhone maker in second place.

"However, 5G functions will increase the production cost of smartphones accordingly. If Apple decides to directly reflect this added cost on the retail prices of the iPhone 12 series, it may lower its consumers' willingness to purchase, in turn affecting the sales performances of the new iPhones," said the report.

Samsung's 5G smartphone production this year is forecasted at 29 million units, placing the company in third place globally.

Vivo, OPPO (including OnePlus, OPPO, and Realme) and Xiaomi are tied for fourth place

Vivo, OPPO and Xiaomi's yearly 5G smartphone production volumes are projected to reach about 21 million, 20 million, and 19 million units, respectively. 5G remains a hot topic in the smart-

phone market this year, as smartphone brands and mobile processor manufacturers, such as Qualcomm and MediaTek, strive to expand their shares in the 5G market

"As such, Chinese brands, which were ahead of their competitors in 5G strategies, occupied a 75 per cent share in the global 5G smartphone market in the first half of 2020," said the report.

The report predicted that an aggressive push by mobile processor manufacturers will lead to the rapidly increasing presence of 5G chipsets in the mid-to-low end market, driving 5G smartphone production to surpass 500 million units in 2021, which will potentially account for about 40 per cent of the total smartphone market.



Ibra brace lifts AC Milan

It was Milan's seventh victory in the nine games since Serie A resumed following the pandemic-enforced shutdown and moved the team up to fifth. They drew the other two matches.

It was confirmed after the match that Milan coach Stefano Pioli had signed a two-year extension to his contract, keeping him at the club until June 2022.

Ibrahimovic rejoined Milan in December on a six-month contract with an option for next season. "Will I stay? There are still three matches, 10 days and no one has said anything else," the Swedish forward said. "But I'm working, we are doing good things and if we take the table since I arrived I think we would be second or third.

Milan has lost just two matches since Ibrahimovic's arrival. "We will talk with him immediately after the end of the season, he is also completely focused on these matches and he is doing so in an excellent manner, as always," Milan sporting director Frederic Massara said.

Ibrahimovic gave Milan the lead in the 19th minute with a diving header at the back post following a cross from Hakan Calhanoglu.

Calhanoglu redeemed himself moments later with a second as $sist-a\,through-ball\,for\,Ibrahimovic$ to run onto, round the goalkeeper and place into the back of the net.

WADA extends suspension of NDTL by 6 months

New Delhi, July 22: In a massive jolt to India's Olympic preparations, the World Anti-Doping Agency (WADA) has extended the suspension of the country's National Dope Testing Laboratory (NDTL) by another six months citing non-conformation to international standards.

The WADA first suspended NDTL in August last year for a period of six months. A fresh round of inspection by the world body, much to the embarrassment of country's sporting establishment, showed that non-conformities still existed.

"The World Anti-Doping Agency has suspended the accreditation of the NDTL in New Delhi, India, for a second period of up to six months," WADA said in a statement.

The suspension prohibits the NDTL from carrying out any antidoping activities, including all analyses of urine and blood samples.

Sports minister Kiren Rijiju said that technical problems are being addressed. "WADA served suspension notice before I took over as Chairman of NDTL. The rules of revoking its accreditation after 6 months suspension is avoided by extending the suspension period because all technical problems are being addressed no," Rijiju tweeted.

The 29-year-old had pulled himself out of the attack midway through his 15th over in West Indies' second innings but later insisted that there was 'absolutely nothing to worry about'.

Silverwood said Stokes will have to 'rein' him in during training as he is always looking push himself. "He'll keep pushing himself,

is," said Silverwood.

But from a training perspective we try and rein him in where possible and keep him as fit as a fiddle because I know we're a better team with him out there... We've got to look after him the best we can.'

Following the third Test against the West Indies, England will play another three-Test series against Pakistan starting August 5.

England had picked James Anderson, Jofra Archer and Mark Wood for the opening Test, while including Stuart Broad, Chris Woakes and Sam Curran in the second match.

With six to seven seamers at his disposal. Silverwood will face a selection headache but he said he is determined to pick the 'strongest attack' to win the third Test.

"We've got to put out the strongest attack out that's available to us. It's very difficult to keep everybody happy all the time. But if you do things for the right reason, I think there's an understanding there,'

the 45-year-old said. "Everyone wants to play all the time and I'd probably be more disappointed if they didn't. When you're leaving out world-class players, from my point of view it's a very good place for English cricket to be. It's never easy and you're always going to get pushback. But you try to be as honest as possi-

ble," Silverwood added.
