

Bhubaneswar, July 23: Adding to the woes of the people already suffering due to the COVID-19 pandemic, retail prices of vegetables have witnessed a sharp in the state. The government, on the other hand, is a mute spectator doing virtually nothing to alleviate the burden.

While the retail price of potatoes in the state stood at ₹32 a kg Thursday, tomatoes were selling for ₹60 a kg, up from ₹25 and ₹30 respectively, July 1. However, the price of kitchen essential onion is somewhat stable at ₹20 a kg.

The prices of other vegetables including brinjal, pointed gourd, cucumber, bins, cauliflower, carrot and cabbage have also spiraled upwards. In Bhubaneswar markets, the retail price of brinjal sold at ₹50 per kg, cucumber at ₹40, beans at ₹80, drum stick at ₹120 a kg, cauliflower at ₹35 per piece, carrot at ₹40 a kg, bitter melon at ₹40 and cabbage at ₹50 a kg. Bhubaneswar, July 23: The state government Thursday said that the spike in COVID-19 cases across the state during the last few days is the outcome of more testing and better surveillance and that there was no

need to panic. Kumar Pradipta Mohapatra, Additional Chief Secretary, Health Department, told the media that the state created a record of holding 11,000 sampletesting on a single day (Wednesday), besides amplifying their surveillance.

There is no need to panic. The more number of COVID-19 cases in the recent few days were an outcome of more testing done by us. The frontline workers, at the same time, expedited field visits and put more suspects under testing," he said.

The official also said that the state is now has 19 government COVID-19 testing centres while more such centres will come soon. "Right now we have 19 government COVID testing centres while in the next 10 days we will have six more such facilities," he said.

He further said that the COVID scenario in the state is likely to improve soon if the government tests more symptomatic persons and isolates

All traffic on SH-42 was disrupted as rain waters above four feet overflowed on the highway while vehicles were seen submerged in water at many places.

Properties worth several lakhs were damaged as the rain water entered the houses leaving people confined to their homes all through the day. People termed the water-logging in the town as manmade and held the NAC authorities responsible for the disaster. New Delhi, July 23: The ruling Communist Party of China has taken yet another step to reboot the stature of its General Secretary Xi Jinping at par with Mao Zedong, the founding father of the Party State, whose tempestuous rule, marked by loss of millions of lives,

brought China to the brink of collapse around the time of his death

On Tuesday, a book on Xi Jinping 'Thought on Diplomacy' was released in Beijing. The publication amplified a key dimension of Xi Jinping Thought for a "new era", unveiled in October 2017 during the 19th party congress of the CPC.

During that twice-a-decade assemblage, Xi was elevated to Mao's stature, as he became the only Chinese leader after PRC's founding patriarch, whose Thought was enshrined in the party's constitution. Even the status of the architect of China's reforms, Deng Xiaoping, compared to Xi, was symbolically dwarfed. The party constitution has only recognised the contribution of Deng's Theory-a rung below that of Mao and Xi's Thoughts. In 2016, Xi had also been desig-

nated as "core" leader-a title that was reserved only for select Chinese leaders with near absolute power in-

cluding Mao and Deng. Yesterday, the mandarins in Beijing decided that reaffirming Xi's unchallenged authority on top of the China's ruling tree, at par with Maothe unrivaled strongman

People's Republic of China (PRC) has produced so far-had become urgent, following the COVID-19 pandemic.

China has been facing a tsunami of accusations that it had either deliberately or inadvertently spread the COVID-19 pandemic,

forcing the CPC to make a fundamental choice. The party could either dig into the trenches or defend against the global onslaught. Conversely, it could go on the offensive, by demonstrating its raw military power as a deterrent, backed by a demonstra-

tion of com-

plete political

cohesion under Xi.

Faced with the dilemma, Beijing decided to mount a raging-bull approach. It began flexing its muscles in two geographic theaters simultaneously. The People's Liberation Army (PLA), headed by Xi as the commander-in-chief, intruded into Ladakh in a face-off with a resurgent India. In the West Pacific, the PLA Navy (PLAN) began to show the flag to enforce its maritime claims in resource rich South China Sea.

In the back-and-forth play, the Chinese decided to institutionalise Xi Jinping Thought on Diplomacy, with the formation of Xi Jinping Diplomatic Thought Research Center. This was to let the world know that current CPC leadership under XI was

rock solid-perhaps even stronger after the onset of COVID-19.

During the inaugural of the Center, Chinese Foreign Minister and state councilor Wang Yi also made it astonishingly transparent that Xi's China continued to harbour ambitions of a Middle Kingdom 2.0. Under the refurbished doctrine, Beijing, as in imperial China, aspired to become the principal "universal" hegemon, replenished by several tributary states which, in turn, will be offered protection by the

"suzerain" residing in Beijing. "China today is approaching the realization of the dream of the great rejuvenation of the Chinese nation as never before, and approaching the center of the world stage as never before," Wang said.

Similarly, the minister said that Gorakhpur, Sindri and Barauni fertiliser plants have achieved 88.10 per cent, 77.80 per cent and 77.60 per cent of overall progress respectively. It is expected that Gorakhpur, Barauni and Sindri plants will be commissioned by 2021

He stated that with a view to becoming self-sufficient in urea production, the government has started reviving the closed fertiliser units of FCIL at Ramagundam, Talcher, Gorakhpur & Sindri and HFCL unit at Barauni. This is a joint venture of nominated public sector undertakings (PSUs) to set up gasbased fertiliser plants of 1.27 MMTPA capacity each.

of taxpayers? ■ Forms like 'Saral' and 'Sahai' have been formulated to ease I-Treturn filing. Employees with salaries, income from one property and interest can use one of the options. Frankly speaking, I-T returns for other assessees are quite voluminous and too complicated for a taxpayer to understand and fill the forms on his own. Simple I-T return forms will be possible only when the taxation law is simplified.

■ Do you think the I-T dept has evolved to better manage tax evasion?

■ I-T department is now fully computerised and many of the processes now take place on emode. A large volume of financial transactions are now received and analysed with the help of analytical tools based on computers. The department is keeping constant vigil on cash transactions and introduced TDS on big cash withdrawals so that the same may be kept track of. We are fast approaching a tax evader free regime. The cost of tax evasion has been made much heavier than the tax evaded.

Aditya wrote his suicide note: SFSL

Bhubaneswar, July 23: Although the reason behind the death of social activist Aditya Kumar Dash is still shrouded in mystery, experts at the handwriting bureau of State Forensic Science Laboratory (SFSL) here have confirmed that the suicide note collected from his diary was written by Aditya himself.

The Additional Director General (ADG) of Police for Railways, Pranabindu Acharya, revealed this while speaking to media persons here Thursday.

In another development, the Government Railway Police (GRP) officials have mailed a letter to Facebook, the popular social media site, seeking the details regarding the person who had posted the last message on Aditya's timeline on the social media platform. The GRP officials are hopeful of getting the response from the Facebook soon.

The cops are also finding it difficult to expedite the investigation as many, who were asked to be interrogated, are yet to turn up due to the lockdown, a source in GRP said. The cops are able to record the statements of around 25 persons including Aditya's wife and in-laws out of the 40-odd people directed to appear for interrogation. Biswa Mohan Bhoi, one of the closest friends of Aditva, from Boudh district has sought more time to appear before the investigating officers due to lockdown.

Sources also claimed that Aditya was under severe mental stress due to the drying up of funds for his NGO since the imposition of lockdown

Union minister Paratap Sarangi has recently requested Chief Minister Naveen Patnaik to direct the Commissionerate Police to initiate a joint probe into Aditya's

death with the GRP team. Notably, the body of Aditya was found from the railway track near Lingaraj Temple Road railway sta-

tion July 7, 2020. Police have been looking into the murder angle by registering a case (81/20) under sections 302 and 34 of the IPC.

Aditya, popularly known as 'Manab Premi Aditya Dash', was aresident of Talasarada village in Boudh district.

COVID-19 death toll reaches 114

Bhubaneswar, July 23: State's COVID-19 caseload Thursday breached the 21,000 mark as the state reported its highest singleday spike of 1,264 new cases, and the death toll increased to 114, with six more patients succumbing to the disease, an official of Health department said.

With cases, the number of cases in the state rose to 21,099. A total of 540 cases were reported from the coronavirus hotspot Ganjam district followed by 137 in

Khurda. Five of the six fatalities were reported from Ganjam. With this, state's death toll has mounted to 114, the official

"Regret to in-Khurda at 15, Cuttack nine form the demise of six COVID positive patients while under treatment in hospitals," the Health de-

partment tweeted. The victims from Ganjam were identified as a 51-year-old woman and four men between the ages of 41 to 69. All the Ganjam victims were suffering from either diabetes or hypertension, the official said.

The victim from Khurda district was an 86-vear-old woman also suffered from the comorbidities.

Of the 114 fatalities, Ganjam reported the highest of deaths at 67 followed by Khurda at 15, Cuttack nine. Gajapati at six, two each from Angul, Jagatsinghpur, Kendrapara, Puri, Rayagada and Sundargarh, while one casualty each was recorded in Nayagarh, Bargarh, Bhadrak, Jajpur and Kandhamal.

DEVELOPED ANTIBODIES POST NEWS NETWORK

Bhubaneswar, July 23: In the conclusive study of the first phase of serial sero-survey conducted by ICMR-RMRC, the capital city reported that only 1.4 per cent of all the persons have developed anti-bodies for the Covid-19 infection.

As per the Bhubaneswar Municipal Corporation (BMC), that assisted RMRC **REPORT** in the ongoing survey, a total 951 samples were collected at community level for the study in the first phase. "It has been found that community level exposure to SARS Cov 2 virus is relatively low with a pooled Sero-prevalence of 1.4 per cent. This implies that largescale transmission has probably not occurred

in the city," a BMC official said. However, the civic body cautioned citizen against the infection and stated that large majority of the population is still at high risk

of exposure unless preventive methods are not followed. "Every citizen has a role to play in the fight against Covid-19," said Municipal

Rural Areas across the State," the notification said. It added, "The order will be enforced with immediate effect provided that the person concerned opts for home isolation and satisfies the conditions as mentioned in the said order. The notification said that the Sarpanch(es) of Gram Panchayats or any other officer notified by the Collector of the respective districts shall be the Nodal Officer for this purpose.

Haridaspur-Paradip railway route sparks hopes of industrialisation

Kendrapara, July 23: Hopes for establishment of a thermal power plant in this district soared after completion of works on Haridaspur-Paradip new broad gauge rail route, a report said.

The completion of work on the Haridaspur-Paradip rail route has opened up fresh avenues in Kendrapara, a predominantly agricultural district.

Establishment of a thermal power plant has now acquired prominence as the new rail route will play an important role in transporting coal to be used as raw material by the power plant.

The Chennai-based M/s SPI Port Pvt Ltd (SPIPL) which agreed to establish the plant also has come forward. The company had planned to export coal from Indonesia and Australia through Paradip Port and the new route for transportation of coal from inside the country.

The rail route has been examined by running a tower car. Reports said that goods train will start plying on this route by August end.

Observers claimed that the rail route would pave the way for establishment of a thermal power plant as promised by the state gov-

ernment. The state government had promised to establish two 660 megawatt-based thermal power plant in Mahakalapara tehsil in

Later, the state energy secretary signed a memorandum of understanding (MoU) with the director of Chennai based-M/s SPI Port Pvt Ltd (SPIPL) in this regard. The MoU was signed as per the Company Act-1956, January

As per the agreement, the plant will be constructed on 875 acres provided by the state government within a period of 60 months. The plant outlay was initially pegged raised to Rs 8,845 crore.

The plant after completion will produce electricity from which 12 to 14 per cent of power will be purchased by the state energy department at a rate fixed by the Odisha Electricity Regulatory Commission (OERC).

Meanwhile, the district administration has acquired 875 acres in the revenue villages of Alailo, Bilipada, Nachhipada and Niyamatpur villages under Mahakalapara tehsil and handed it over to SPIPL. Out of the acquired land, 840 acres are farmlands which are lying unutilised after acquisition.

As per the MoU, the company will use 565 acres for establishment of the plant, 125 acres for the rail route and laying of water pipelines while a township will come up on 50 acres and green cover on 260 acres.

Residents Sibashis Mohanty, Alaya Samantray, Pratap Chandra Padhi, Banambar Sahu and Rashmi Ranjan Mohapatra have demanded that the state government intervene and speed up the establishment of the thermal power plant following completion of the rail route. They said the power plant will draw more industries to the district.

Dr Sachidananda Pandey, Dr Lagendra Kumar Singh, Dr Bipin Kishore Kulu, Dr Sanjay Kujur, Dr Sitanshu Kumar Meher and Dr Mahendra Kumar Ekka were shortlisted by the two committees.

Sources said Dr Ekka did not de serve promotion, as he was lacking adequate experience and was pretty junior to several others doctors. Reacting to this, VIM-SAR Director said, "This was pending which I approved. After I realised that Dr Ekka's promotion was improper, I had to cancel this office order'

As per norms, the promotion list and approval thereof can be cancelled only after one year. The doctors' community is taken aback as to how the promotion was given and was cancelled again without consent of the managing committee and the selection committee.


District Collector Saraoj Kumar Samal said the new rule is mandatory for all residents of the district and returnees from the eight hotspot

Shun obduracy

iesel prices have outstripped petrol prices in major metros of the country. In Odisha also, diesel is costlier than petrol – a never seen before scenario. Over last few days, state-run oil marketing companies have hiked diesel rates even as petrol prices remained more or less steady. The runaway rise in diesel price has squeezed its demand. State-owned refiners, who between them own over 90 per cent of the country's fuel outlets, reported a drop in sales in the first half of July from the same period last month. Gradual shrinking of economic activities and renewed lockdowns in parts of the country have put paid to the demand for diesel - a major transport oil. The demand for diesel, which accounts for two-fifths of the overall refined fuel sales in India, has fallen by 18 per cent to 2.2 million tonnes in the first half of July from the same period in June and by about 21 per cent from a year earlier. Consumer sentiments are subdued. In an atmosphere of uncertainty triggered by the pandemic and massive job cuts and loss in wages, people think twice before taking out their four-wheelers. Spiraling fuel rates over last one month have further dampened the public spirit. The spike in rates is playing negatively on the minds of people who are shying away from buying new cars. The impact is much harsher on the two-wheeler front where fuel price is very sensitive and determines the footfalls in outlets. The price jab by the state owned oil firms has worsened the already sluggish automobile markets in the country. Consumption of petrol in financial year 2020 dropped to 6 per cent from a double-digit growth over last four five years. Similarly, diesel usage came down by over one per cent in FY20 against a three per cent rise last year. With the number of Covid-19 infections galloping with every passing day, the government seems readying to further extend the lockdown. In the current scheme of things, the situations look extremely precarious until we have a vaccine.

Lower demand for fuel bodes ill not only for the automobile sector, but for the entire economy. The government makes tall claims about its intentions to do everything possible to kick-start the economy. It took a few major economic steps to provide grist to the economic revival. The Reserve Bank of India on its part has also played ball with the Centre. The central bank has taken a lot of initiatives to cushion the financial hardship on consumers. However, the obstinate stance of the government with regard to fuel prices has torpedoed all these measures. One hand of the government is negating the possible gains that the other hand may be achieving. A bulk of the pump price of fuels comprises taxes. Centre and state levies make up 66 per cent of cost of fuel. The balance 34 per cent comprises basic fuel including refining and its freight cost including the dealer margins. From this it is evident that two thirds of the value of fuel goes towards the state and Centre's exchequers - making Indian retail prices among the highest in Asia and almost double that in Pakistan. Therefore, this is the government, both the Centre and the state government, should explore if there is any headroom available to cushion the fuel rates. Let alone thinking about a solution, the government allows oil companies to go on jacking up the prices. There has been a fivefold increase in taxes since 2014 when Narendra Modi became Prime Minister. A soft fuel regime will have a domino effect on the economy. The government should shun obduracy. Swan song

n ancient legend - it goes back to classical Greece - holds that swans Are silent throughout their lives but sing once, beautifully, just before they die. Figuratively, the swan song is the final performance or activity of a person's life or career. When Tony Blair announced his plans for resignation, the speech was called his swan song. It isn't quite accurate in this context, since he hasn't got around to telling anybody exactly when he planned to go. But it was his final speech to the Labour Party Conference and the speech was by all accounts a cracker, so in that sense it's fair. The legend is all nonsense. The ancient Greeks and Romans believed it, however, and it's mentioned in the works of Euripides, Aristotle, Plato, Seneca, and Cicero. Plato said that Socrates had explained it as a song of gladness because the swan, sacred to the god Apollo, was shortly to join the god it served. In AD77 Pliny said it was untrue ("olorummortenarraturflebilis cantus, falso, utarbitror, aliquot experimentis", "observation shows that the story that the dying swan sings is false"). He had no effect on the popularity of the fable; the idea was eventually taken into English in the medieval period, being alluded to by Chaucer and Shakespeare. It's in the latter's The Merchant of Venice: "Let music sound while he doth make his choice; / Then, if he lose, he makes a swan-like end, / Fading in music." But the term itself was created as recently as 1831, in a book by Thomas Carlyle: "The Phoenix soars aloft ... or, as now, she sinks, and with spheral [sphere-like] swan-song immolates herself in flame." He took it from the German Schwanenlied or Schwanengesang with the same sense, which derives of course from the same legend. As the final collection of songs by Franz Schubert was published in the year he died (1828), it is known as his Schwanengesang. That was probably what put the idea for the English word in Carlyle's mind.

Swanning around

he Brits are thoroughly conversant with peacocks and find them to be an excellent analogy for ostentation. If we say that somebody is swanning around we may indeed be implying that they're doing it to impress, but the key idea we're trying to express is that they're being irresponsible or carefree, doing exactly as they like. Envy or disapproval often lies at the back of it - they're a useless drone, the thought goes, and wouldn't it be nice to be like that? But the main point of buying one of these things [bus passes] is to get to school and back, not to swan about the further reaches of the West Country. The early examples are from the end of the nineteenth century and simply refer to swimming like a swan. Since swans glide through the water without any apparent effort, seemingly aimless and laidback, the idiom "swan about" came to mean ambling about without a care in the world or travelling idly or purely for pleasure. Curiously, the evidence suggests this was initially military slang of the Second World War. The first example in the Oxford English Dictionary dates from 1942.

Panicked, he rushed to the bank. Since no bus was available at that time, he walked for 15 km in a hilly terrain to reach the bank. At the bank, he was told to pay ₹3.46 of the pending loan amount.

This story is a grim reminder of the double standards the banks have in place when it comes to treating their customers. While the poor who fail to repay loans often receive inhuman treatment, forcing many of them to either land in jail or commit suicide, the rich are treated with kid gloves and are allowed to get away with their act, with the bank itself taking the blow. Take the case of the lead bank, the State Bank of India (SBI). According to a news report, the bank had written-off ₹1.23lakh crore of corporate bad loans in the past eight years. We are told that, technically speaking, a bank write-off is not a loan waiver, and the recovery process continues. However, all that the bank has been able to recover in these eight years is ₹8,969-crore which comes to a little over 7 per cent of the outstanding credit.

The biggest defaulters in this particular case were Bhushan Power & Steel Ltd with an outstanding loan of ₹7,705-crore and Videocon Industries Ltd with pending dues of ₹3,411-crore. As per an RTI reply, both the companies had failed to pay back even a single penny. In fact, out of the 56 borrowers in the list that was made available, the recovery from 36 companies was zero. For a balance of ₹3.46, a farmer was asked to come to the bank and pay it up, but what happened to the 36 companies from whom SBI failed to recover even

Another news report, based on an RTI reply, had revealed that only 10 per cent of the bank loans written-off in four years, between 2015-16 and 2018-19, have been recovered. Out of a total of ₹4,32,584 crore written-off in these four

years, public sector banks could recover only ₹45,659-crore. If 7 to 10 per cent of the total amount is what eventually the banks are able to recover, the question is, why are banks trying to give an impression that the write-offs of corporate debt is in any way different from the farm loan waiver?

Using the 'technical' difference between a write-off and waiver, banks have always maintained that writing-off bad loans does not mean that the recovery proceedings have stopped, but this is simply a clever smoke-screen to cover up the massive corporate defaults.

Strangely, this 'technical' cover up became a banking tradition over a period of time. Prior to that, the RBI had in a circular issued to banks advised them to refrain from the practice. "Banks are required to explore all available means of recovery before writing off any account fully or partly. It is observed that some banks are resorting to technical write-off of accounts, which reduces incentives to recover. Banks resorting to partial and technical write-offs should not show the remaining part of the loan as

Probably to cover its own lapses, banks have routinely been claiming that the write-off is simply a

shift of the accounts from one ledger to another while the recovery goes on. But many banking experts say, when bad loans are written-off, banks actually remove the assets from the balance sheets, knowing well they have lost all hope of recovering anything.

This brings up a question. Why the banks should not be asked to first clear all options of recovery before announcing a write-off? Why deliberately create confusion in the minds of the people (as well as policy makers) by presenting a misleading picture of bank profits position by pushing the losses in a separate ledger? This is a mischievous practice and needs to be discontinued.

The RBI mustact heavily against banks for such deliberate cover-up. Instead, banks are exerting pressure to set up a bad bank that takes care of the bad loans. Which means instead of addressing the fundamental reasons behind the malaise of increasing bad loans, banks are wanting another cover-up. Setting up a bad bankis a bad idea.

In April, RBI stated that ₹68.067 crore which was due from 50 wilful defaulters over the years has been written-off by nationalised banks. Many absconding businessmen, including the diamond merchant Mehul Choksi, are

among them. Wilful defaulters are those who have the ability to pay back but don't do so. Many banking experts have been seeking criminal proceedings against such defaulters, but the government is simply not listening.

All India Banking Employees Association general secretary CH Venkatachalam recently stated: 'It is known that bulk of these bad loans are attributable to big businesses and the affluent. Many cases of default are found to be deliberate, wilful and on account of diversion of funds. Unfortunately, bank loan default is still a civil offence and hence criminal proceedings are not being instituted against them."

Launching criminal proceedings against the wilful defaulters should be the first step to stop banks being duped heavily by the rich and the powerful. Farmers continue to be penalised for petty loan defaults, while the rich get away so easily. If banks can take 'haircut' for thousands of crores of company defaults, why banks can't in general and in this case Canara Bank in particular, take a 'haircut' of ₹3.46? Why make a poor farmer travel all the way, spend a day's hard labour, for just depositing a petty amount? When will the banks become a little sensible?

Vaccine, health-infra push as priority

ccording to projections, India will have 35 lakh Covid-19 cases by September. The daily nationwide testing of 27 lakh is proving to be inadequate with positivity rate - total confirmed cases per 100 tests -- reaching the double digit mark for the first time at 10 per cent in the first two weeks

Adding to the research into the pandemic, around 239 scientists from 32 nations wrote to the WHO. saying there is evidence that the corona virus is airborne and even smaller particles can infect people -- a significant departure from its claim so far that it is spread primarily through cough and sneezes. Last month, ICMR Director Generalstated that an August 15 vaccine-launch plan eroded the agency's credibility. As per WHO report, 18 candidate vaccines against Covid-19 are in clinical trials while over 120 others are undergoing lab or animal studies.

The Indian Academy of Sciences, a body of 1100-odd scientists, stated that while administrative approvals could be expedited, clinical trials process and data analysis have a natural time span that cannot be hastened. In fact, scientists across the globe believe a vaccine is unlikely to be made available by early next year. Prof. Francis Collins, a top American biomedical researcher, testifying before the US Senate, stated: "We're optimistic that the goal we have set to have a vaccine that works and is safe by the end of 2020 will be met by one of the vaccines"

Independent researchers say no one expects a vaccine to be available for routine public use any where before early 2021. The ICMR authorities are expected to grasp the complexity of assessing a brand new medicine or vaccine - something that typically takes years. Thus, it naturally follows there was pressure from the government.

The neglect of health infrastructure over the years is wellknown.Successive governments have done little to ensure the barest minimum health facilities for the poor and economically weaker sections. The situation has become worse with the invisible enemy.

India has 519 medical colleges that can admit over 80,000 MBBS students a year. But the requirement of doctors is several times more, especially in sub-divisions and blocks. Moreover, the number of beds is much less, 40 per centless than is required. As a result, many patients are dying without getting admission in government hospitals.

As regards doctors' poor strength, there is a growing concern. These could be specialists who have completed or are on the verge of completing training in clinical specialities in medical colleges. Also those who have undergone a fellowship programme for 2-3 years after internship could too be requisitioned, besides those who are trained in Russia and China but couldn't clear the Indian exit exam. Final year nursing students, who finished training and are set to appear for the final exam, is another area that could be looked into.

On another front, there are reports that the Centre is not extending adequate financial help to states, some of whom are fighting the pandemic with scarce resources. As the situation is expected to deteriorate, the health infrastructure needs to be scaled up. Thus, requirement of beds, ventilators, ICU beds etc. need to be beefed up.

With accommodation in government hospitals bursting at the seams, there is need for strict vigilance of private nursing homes to ensure they don't charge the common man in access for beds, ventilator or medicines

While there is no denying that doctors and nurses in states are doing a splendid job, inadequate health infrastructure is putting them at greater risk and a number of them have succumbed to the virus in the line of duty. It's critical to give them the additional support.

The challenge is daunting, the central government, instead of seeking mileage for an early discovery of a vaccine, may assist states by setting up 150-bed Covid hospitals for, say, six months under the Central Govt. Health Scheme (CGHS) in affected metros.

The nagging question persists — whether the situation shall improve, how soon, and will health infrastructure be given the requisite boost? Will the growing number of patients get adequate treatment? As a matter of priority, the Union Health Ministry may extend infrastructural support to the states.

About six and a half lakh people have been badly affected by the floods. Doo said that relief camps are being run in Supaul, West Champaran, two each in East Champaran, three in Gopalganj and one in Khagaria.

Apart from this, 134 community kitchens are being run in the floodaffected areas.

The Gandak river has caused much havoc in Gopalganj this year. Many villages in Sadar block have been submerged. Some children trapped in a madrasa were evacuated with the help of the district administration.

The same situation is there in Darbhanga. Flood water has entered 81 panchayats in 10 blocks of Darbhanga.

A water resources department official said Thursday that the water level of the Gandak river is decreasing. There was 2.12 lakh cusecs of water discharge at the Valmikinagar Gandak barrage at 8 am.

The water level of the Kosi is also coming down rapidly. The water flow in the Kosi river near the Veerpur barrage was 1.77 lakh cusecs at 6 am Thursday, which had come down to 1.73 lakh cusecs at 8 am.

According to the Water Resources Department, except the Ganga, the Bagmati, Budhi Gandak, Kamla Balan, Punpun, Mahananda and Ghaghra are flowing above the danger mark in most places in the state.

HP health official terms Covid spike 'temporary'

Official says the positivity rate in Himachal is 1.3 per cent which is much less than the norm of below 5 per cent set by the WHO and the Centre

Shimla, July 23: Himachal Pradesh is doing much better in handling the Covid-19 pandemic compared to other states, a top health official has claimed, terming the recent spike in its cases "temporary."

The current situation arising out of the recent spike will stabilise soon, Additional Chief Secretary (Health) RD Dhiman told reporters Wednesday evening, seeking to assure people that the cases would reduce soon.

Attributing the recent spike in cases to the arrival of migrant workers, a marriage function in Sirmaur district and movement of the central armed police forces (CAPF) after Indo-China clash in Ladakh's Galwan valley, he said the testing rate is higher and death rate lower in the hill state.

The recent positive cases of around 160 migrant workers of industrial town Baddi-Barotiwala-Nalagarh in Solan district, 80 persons of a marriage party at Gobindgarh in Nahan of Sirmaur district and several ITBP and army jawans are isolated ones, he said adding they have nothing to do with the people of the state in general.

The loopholes have been plugged by making quarantine for incoming industrial labourers mandatory a few days ago while the ITBP and Army jawans found positive were already quarantined with their cases having no chance of affecting locals, he added.

Dhiman said the death rate in the state is 0.84 per cent as compared to 2.45 per cent at the national level.

Elusive snow leopards caught Amid Covid, Patna AllMS' nursing staff go on strike on camera in Kullu sanctuary

Manali, July 23: For the first time, snow leopards — an adult and two cubs — have been documented on camera in the Great Himalayan National Park (GHNP) of Himachal Pradesh's Kullu district. The elusive snow leopards, the state animal of Himachal Pradesh, were spotted multiple times last winter in Lahaul-Spiti district along human habitations and their videos recorded by residents of Hikkim village had gone viral on social media early



this year. They are generally found above the altitude of 4,000 metres in summers and descend a bit lower during the winter season.

There have been multiple claims of sightings of snow leopards in the national park, but their presence has been recorded on cameras for the first time. Now, similar cameras have captured a grown-up snow leopard at 19 locations in Kullu's Great Himalayan National Park, a World Heritage site, and it is accompanied by cubs at two locations. This is the first documented sighting of a snow leopard at multiple spots in the national park, leading to confirmation that the endangered big cat is breeding safely not only in Lahaul-Spiti district but also in Kullu.

"With the switch from classroom teaching to online education, teachers are putting pressure on us that if you want to pursue education for your children, you have to buy a device. With no means of getting a smartphone with our meagre means, we finally decided to sell a

cow," he said.

Now, he has the lone cow to support his family. His struggle now is that the smartphone cannot simultaneously support the education of two children.

He foresees constant fights between them to attend classes. Kumar is deprived of getting the benefits meant for the poor. He is entitled to get government privileges meant for BPL families or under the IRDP.

"I have applied for financial assistance for the construction of a house and inclusion of my name in the IRDP and the BPL schemes, but failed to get due to red-tapism," he rued.

The digital divide

NEW DELHI: The government has been touting online classes as a viable alternative, but unequal and patchy access to the internet has meant the experience is vastly different depending on location and household income.

With more than 630 million subscribers, India is home to the world's second-largest internet user base. But connectivity is still an issue, especially since mobile data - rather than fixed line internet - is the main source. The signal is often uneven, making it hard to stream videos smoothly, and electricity supply is erratic, which means devices often

run out of charge.

All of this was recently flagged by state representatives to the federal ministry of human resource development, which oversees education in India. A newspaper quoted senior officials warning that almost 30 per cent of the central state of Jharkhand had poor connectivity, while similar complaints had been made in Arunachal Pradesh in the north-east

There are other issues too. The internet device most Indians use is a mobile phone - so many students follow classes on cheap phones rather than laptops. Many poor households have only one phone, and access to it is unreliable.

And then there are those who

cannot afford any device at all. In the southern state of Kerala, for instance, a teenager killed herself, allegedly because her family could not afford a mobile phone or a television (lessons are being aired on a special educational channel). Her father told local journalists that he was a daily-wage earner and could not afford either.

"She was very worried that she would not be able to attend the classes. I had told her that some solution will be found by the teachers, but she was very upset,"

Besides these eight seats, bypolls for 49 more Assembly seats are to be held in the country for which the commission has clarified that the polls will be conducted as per the provisions of the law.

Shekhawat in trouble

Jaipur, July 23: Four days after the Special Operation Group (SOG) sent a notice to Union minister Gaiendra Singh Shekhawat in connection with the purported audio clips indicating his alleged involvement in horse trading of MLAs in Rajasthan, a city court has directed the Rajasthan police to probe a complaint alleging Shekhawat's role in a credit society scam worth Rs 840 crore. The additional district judge

Pawan Kumar, on Tuesday, directed the additional chief judicial magistrate's court to send the complaint against Shekhawat to the SOG. Shekhawat, his wife and other partners have been named in the complaint in the Sanjivani Credit Cooperative Society scam in which around 50,000 investors allegedly lost about Rs 840 crore.

The Jaipur unit of the SOG has been probing the scam since last year after an FIR was registered on August 23, 2019.

Now, Jaipur ADJ Court-8 ordered a fresh inquiry in the case against Gajendra Singh accepting the revised application filed by Lagu Singh and Guman Singh and said that "this is a serious matter and hence SOG should investigate



a huge amount in Sanjivani credit cooperative society. It is alleged in the complaint that a multi-storey building has been built with the money instead of a theatre which was proposed earlier and many properties were also bought in Ethiopia with the money.

An SOG investigation also reveals that a large amount of money has been deposited into accounts of Shekhawat and his wife at different time spans, said sources. Earlier, Shekhawat was not mentioned in the chargesheet filed by the SOG in connection with the case. Later, a magistrate's court also rejected the application to include him in the chargesheet. Babri demolition case: Joshi pleads innocence

the prosecution evidence against him. After Joshi completed his deposition to the court, Judge Yadav asked his office to send a copy of his statement to the CBI in New Delhi. The CBI will then get the Joshi's statement signed by him in New Delhi and send it back to the court

Jolted by quakes, many spending nights in tents

Aizawl, July 23: Many people in Mizoram's Champhai district bordering Myanmar are spending nights outside their homes in makeshift tents after a series of earthquakes hit the northeastern state in a month, an official said.

So far, at least 22 earthquakes have rocked four districts -Champhai, Saitual, Siaha and Serchhip since June 18. The tremors ranged from 4.2 to 5.5 in magnitude. Champhai was the hardest-hit

Champhai district Deputy Commissioner Maria CT Zuali said that makeshift tents were set up at several villages by people and the district administration provided tarpaulins, water barrels, solar lamps and first-aid kits to them.

She said that biscuits and sorazo (food supplements) were also provided to old people. According to the deputy commissioner, at least 20 earthquakes have hit Champhai district in a month. She said that more than 16 villages have been affected by the earthquakes and over 170 houses, including churches and

community halls were damaged. At Dungtlang, one of the worsthit villages in Champhai district, at least five makeshift camps have been set up, Dungltang Young Mizo Association (YMA) Assistant Secretary John Zothanmawia Fanai

Monday, the government sent three teams of doctors that con-

sisted of psychiatrists, clinical psychologists and medical specialists to the quake-hit areas to assist the people, who developed mental trauma following the quakes.

The teams are currently touring affected villages in Champhai district. Dr C Lalhrekima, a psychiatrist in a government hospital, leading one of the teams, said that many people have anxiety due to frequent earthquakes.

"We are giving counselling to the panic-stricken people apart from giving medical care," he said.


Kamegowda's family, including his two sons and daughters inlaws, have also given their swab samples for testing.

Covid tally crosses 12-lakh mark Jadhav case: India

New Delhi, July 23: With the highest single-day spike of 45,720 cases, India's COVID-19 tally crossed the 12-lakh mark on Thursday, while the death toll mounted to 29,861 with a record 1,129 fatalities in a day, according to the Union Health Ministry data.

The country crossed the 12-lakh mark, just three days after it went past the 11-lakh milestone. The coronavirus caseload in the country surged to 12,38,635 on Thursday, while 7,82,606 people have recovered so far in the country, the data updated at 8 am showed.

There are 4, 26,167 active cases of coronavirus infection presently in the country. Around 63.18 per cent people have recovered so far. Maharashtra (10,576), Tamil Nadu (5,849), Karnataka (4,764), Uttar Pradesh (2,300), West Bengal (2,291), Telangana (1,554), Bihar (1,417), Assam (1,390), Delhi (1,227), Odisha (1,078), Kerala (1,038) and Gujarat (1,020) contributed to around 75 per cent of the total single-day spike of

New Delhi, July 23: India Thursday said Pakistan has once again exposed its "farcical" approach by denying available legal remedies to Kulbhushan Jadhav against his death sentence which is also in contravention of the International Court of Justice (ICJ) verdict, and asserted that it will explore further options in the case.

External affairs ministry spokesperson Anurag Srivastava said India appointed a Pakistani lawyer as advised by Islamabad to help Jadhav file a review petition in a court but it could not be done in the absence of a Power of Attorney and supporting documents related to the case. He said Pakistan has blocked all the avenues for an effective remedy available to India in the case, while noting that New Delhi has so far requested consular access to Jadhav

"The whole exercise of not providing documents related to the case even after repeated requests, not providing an unimpeded consular access and some reported unilateral action of approaching the High Court on part of Pakistan

for 12 times over the past one year.

again exposes the farcical nature of Pakistan's approach," he said. The MEA spokesperson said Pakistan is not only in violation of the judgment of ICJ, but also of its own Ordinance.

"Pakistan has completely failed to provide the remedy as directed by the ICJ and India reserves its position in the matter, including its rights to avail of further remedies," Srivastava added. It is believed that India will seek legal advice on its next possible step in the case which could include again approaching the ICJ on the ground that Pakistan did not comply with the tribunal's order.

congest jails across the state after 535 inmates tested positive for COVID-19, an official said on Of the 376 prisoners to be released, 111 are presently lodged in Guwahati Central Jail, he said.

The rest of the prisoners are now lodged in the district jails of Nalbari, Dhubri, Karimganj, North Lakhimpur, Golaghat, Diphu and Udalguri, he added. Assam Inspector General of

Prisons Dasarath Das told PTI that 535 prisoners in 10 jails across the state have been affected by the_ pandemic. The highest number of 435 is from Guwahati. Das said the authorities were releasing prisoners at regular intervals according to the direction of the Supreme Court to decongest the jails and another set of inmates will be released soon.

"The High Powered Committee formed after the SC set the guidelines met yesterday. We have sent a proposal to release 376 prisoners from eight overcrowded jails. This includes 111 inmates from Guwahati Central Jail." he said.

Covid prompts farmers to use machines

THE DSR MACHINES ALLOW FARMERS TO GROW MORE THAN 30 SAPLINGS PER SQUARE METRE AGAINST THE USUAL 15 TO 18 SEEDLINGS, SAID NARESH GULATI, A STATE GOVERNMENT FARM OFFICIAL IN PUNJAB

Raipur Jattan, July 23: For more than two decades, farmer Ravindra Kajal cultivated rice the way his forefathers had - every June he flooded his fields with water before hiring an army of farmhands to plant paddy seedlings

But a scarcity of workers this year because of the coronavirus forced Mr Kajal to change. He irrigated the field just enough to moisten the soil and leased a drilling machine to directly sow seeds on his 9-acre plot.

"Since I was more than comfortable with the tried-and-tested way of growing rice, I opted for the new method with some trepidation,' said Mr Kajal, 46, looking over his field, green with rice saplings, in Raipur Jattan village in Haryana.



"But I've already saved around ₹7,500 per acre because I hardly spent on water and workers this year." he said. India is the world's biggest exporter of rice and the world's second-biggest producer after China. Across the country's grain bowl states of Haryana and neighbouring Punjab, thousands of farmers like Mr Kajal have been forced by the coronavirus to mechanise planting.

They are still wary of the technology and overturning the timehonoured use of manual labour.

But Kahan Singh Pannu, Punjab's Agriculture Secretary, is convinced a historic change is underway that could dramatically increase India's rice output, which in turn could impact world markets.

"It is no less than a revolution in Indian agriculture," he told Reuters. Government officials say the socalled direct seeding of rice (DSR) method could increase yields by about one-third and slash costs on workers and water.

The DSR machines allow farmers to grow more than 30 saplings per square metre against the usual 15 to 18 seedlings, said Naresh Gulati, a state government farm official in Punjab.

Punjab is the home of the 1960s Green Revolution that led to a spike in crop yields. This year, farmers there have used seed drilling machines to sow rice on more than half a million hectares, a big increase compared with less than 50,000 hectares in 2019, growers and gov-

ernment officials said. Mr Pannu expects DSR use to

jump again next year.

"More and more farmers are using the DSR technology which seems to be so promising that the entire 2.7 million hectares of Punjab's rice area could come under it next year, which will be a watershed for India's rice production," he said.

Avinash Kishore, a research fellow at the Washington-based International Food Policy Research Institute (IFPRI), said if this year's crop was good, DSR would be the way forward. "The scale of this year's shift to the DSR is a momentous change in rice cultivation in India," he said.

Sudhanshu Singh, a senior agronomist at the International Rice Research Institute in the Philippines, said the shift to DSR was "one of the rare positive fallouts from COVID."

MONKEYS WREAK HAVOC IN T'GANA

Hyderabad, July 23: Monkeys wreaked havoc, killing around 30 lambs in a village in Telangana's Suryapet district Wednesday, officials said.

The incident occurred in Shobanadrigudem village, notorious for monkey menace. A group of about 20 monkeys attacked the lambs in a shed left behind by a shepherd while taking the herd of sheep for grazing in agriculture fields. no one was present in the house, the simians attacked the hapless lambs which were about 30 days old. Some neighbours tried to chase away the monkeys but failed. All the lambs died of being bitten by monkeys.

Survapet is one of the districts in the state facing monkey menace. Hordes of monkeys enter homes, raid business establishments and harass people. Shopkeepers in some villages in the districts keep huge stuffed tiger toys to keep away the monkeys. There are thousands of monkeys and they attack the homes and shops in hordes, steal eatables and even bite the villagers.

Districts like Peddapalli in north Telangana have come out with a novel solution. They have developed Vanara Vanams (monkey sanctuaries) in the worst affected districts. Fruit bearing trees are being grown to ensure that the monkevs don't venture into human habitations



India, Israel to jointly develop Trump hints at closure of rapid COVID-19 testing tools more Chinese consulates

India and *Israel* will join forces for research and development of rapid testing tools for Covid-19 that can detect the virus under 30 seconds

Jerusalem, July 23: Merging Israel's technological expertise with India's mass production capabilities, experts from the two countries have joined hands to develop rapid testing for COVID-19 in under 30 seconds.

Israel will soon send a high level research delegation to India to conduct a series of "final stages of testing" as part of the joint effort to develop the rapid testing kits for COVID-19.

A high ranking team from the Directorate of Defence Research and Development (DDR&D), in the Ministry of Defense, which has been working with India's DRDO to develop rapid testing for COVID-19 in under 30 seconds, is to leave from Tel Aviv to New Delhi on a special flight in a few days, Israel's Ministry of Defence said in a statement Thursday, Israel's Ministry of Foreign Affairs (MFA) and Ministry of Health are also involved in this unprecedented cooperation between the two countries which aims at "merging Israeli technology with Indian development and production capabilities to allow a swift resumption of normal life alongside the virus"

The DDR&D team will conduct a series of "final stages of testing" to determine the effectiveness of a number of rapid diagnostic solutions with their Indian counterparts. Since the start of the pandemic, the DDR&D has tested dozens of diagnostic technologies. Some of them have matured and passed initial trials in



Israel, however in order to complete testing and prove their effectiveness, these must be tested on a

wide range of patients, IMoD said. The four tech systems that will be tested are - voice test, breathalyzer test based on terra-hertz waves. isothermal test, and polyamino acids test. "What they all have in common is the ability to detect the presence of the virus in the body quickly- usually within minutes. Developing diagnostic capabilities is a goal for the State of Israel and of many additional countries around the world. It is the most effective way to cut off 'chains of infection', prevent prolonged quarantine and enable the reopening of the global economy," the statement said.

"We hope that the research and development led by the DDR&D together with our excellent industries and academic institutions, will lead to a breakthrough that will change the way we diagnose and fight the virus, while giving the boost

Defense Minister Benny Gantz said. Foreign Minister Gabi Ashkenazi

noted that this cooperation provides a unique opportunity for scientific and technological cooperation that can assist Israel, India and the world in coping both with the pandemic and with the economic crisis that came with it. The cooperation between Israel and India will enable the delegation and its Indian counterparts, to collect tens of thousands of samples in just ten days, and analyze them using computer systems based on artificial intelligence. This massive sampling will shorten processes and advance the approval of effective technology. All tests will be validated using PCR tests.

The flight will be carrying some breakthrough emerging Israeli technologies for combatting COVID-19, which have been donated by the Israeli foreign ministry and the private sector, in order to bolster India's response to the virus outbreak.

China launches first Mars mission

China aims to catch up with India, the US, Russia and the European Union to reach the red planet

Beijing, July 23: China successfully launched its first Mars probe Thursday, aiming to complete orbiting, landing and roving in a single mission, taking an ambitious step towards planetary exploration of the solar system.

A Long March-5 rocket, China's largest and most powerful launch vehicle, carrying the spacecraft with a mass of about five tonnes, soared into the sky from the Wenchang Spacecraft Launch Site on the coast of southern China's island province of Hainan, the official Xinhua news agency reported.



About 36 minutes after the launch, the spacecraft, including an orbiter and a rover, was sent into the Earth-Mars transfer orbit, embarking on an almost seven-month journey to the red planet, according to the China National Space Administration (CNSA).

The Chinese Mars probe named Tianwen 1 or Quest for Heavenly Truth 1, will fulfil three scientific objectives: orbiting the red planet for comprehensive observation, landing on Martian soil and sending a rover to roam the landing site. It should arrive in orbit around the red planet in February. The Long March 5 rocket will transport the robotic probe to the Earth-Mars transfer trajectory before the spacecraft begins its self-propelled flight toward Mars' gravity field.

According to China Aerospace Science and Technology Corp, a State-owned space conglomerate, the probe will travel for about seven months before it reaches Mars, which at the farthest point of its orbit is about 400 million kilometres from Earth and 55 million kilo-

metres at the nearest point. It said the probe consists of three parts - the orbiter, the lander and the rover -and they will separate in Mars orbit. The orbiter will remain in the orbit for scientific operations and to relay signals while the lander-rover combination makes an autonomous descent and landing.

The rover has six wheels and four solar panels and carries six sci-

N Korea ranks worst in nuclear material security

Seoul, July 23: North Korea's handling of nuclear materials remains the worst in the world, a nonprofit group said Thursday.

According to the report by the Nuclear Threat Initiative (NTI), a Washington-based group working to curb the threat of nuclear terrorism and accidents, North Korea ranked the last among the 22 countries reviewed in terms of the security of its nuclear materials, scoring just 19 points out of a total of 100, reports Yonhap News Agency.



North Korea has ranked last on five consecutive reports since the group created the index in 2012. The NTI conducts the index on countries with 1 kg or more of weapons-usable nuclear materials to assess their level of security based on several indices, including the amount of nuclear materials and sites.

North Korea was also among the four countries that are increasing the quantity of their weapons-usable nuclear materials, the report said.

'Wear a mask even at home'



Madrid, July 23: Face masks should be worn even at home if you are with people you do not live with, an official from the Madrid region said Thursday, even though he conceded there was no way to enforce such a recommendation.

In Madrid they are mandatory everywhere in public unless people are outdoors and can keep a 1.5 metre distance. In most of the country, they must be worn in public regardless of safe distances, but with no rules on wearing them at home.

'We recommend, as a precaution, the wearing of masks in private spaces when there are meetings or gatherings of people who don't live together." Enrique Ruiz Escudero, the health chief of the Madrid region, told a news conference.

"We feel it is important since the majority of outbreaks happen in family or friends meetings or celebrations gathering people who don't live together.

The official said it was up to each citizen to wear a mask in private gatherings, adding that most people in Madrid were already wearing one outdoors even without it being mandatory.

Madrid was one of the hardest-hit regions at the peak of the pandemic, but has over the past weeks reported far fewer cases than Catalonia and Aragon, where most of the new clusters have been reported.

The Canary islands region popular with tourists, the only other area in Spain where masks are not mandatory outdoors if people can keep a safe distance, has issued a video with a simi-

A surge of new users for Twitter

London, July 23: The global pandemic and US protests are forcing a pullback by advertisers on Twitter, but it's also led to an_ unprecedented surge of users.

Average daily user growth spiked 34 per cent in the second quarter, the company said Thursday, the largest jump in users ever recorded by the company. In an earnings call, CEO Jack Dorsev addressed an embarrassing hacking incident last week that compromised the accounts of high profile users, saying he felt "terrible" about it.



Shares of Twitter surged more than 6% before the opening bell. But the company took a huge tax hit to earnings, posting a net loss of \$1.2 billion, or \$1.56 per share, in the April-June period, compared with profit of \$1.1 billion, or \$1.43 per share, a year earlier.

Twitter's advertising business was hit harder than its larger rivals Google and Facebook, and analysts had expected the bleeding to continue in the second quarter.

UNGA MEET TO GO VIRTUAL FOR FIRST TIME IN 75 YEARS

The landmark 75th session of the UN General Assembly is expected to begin September 15 and the first day of the high-level general debate is likely to be held September 22

United Nations, July 23: World leaders will submit pre-recorded video statements for the United Nations General Assembly session in September, the 193-member organisation has decided, as heads of state and government will not be physically attending the annual gathering due to the coronavirus pandemic and the high-level session goes virtual for the first time in the UN's 75-year history.


The landmark 75th session of the UN General Assembly will begin September 15. The General Debate is held at the beginning of each session of the General Assembly and usually runs for over a week when

leaders and ministers from the 193 UN member states address the world from the iconic lectern in the General Assembly hall.

The General Assembly adopted a decision Wednesday that "each Member State, observer State and the European Union can submit a pre-recorded statement of its Head of State, Vice-President, Crown Prince or Princess, Head of Government, Minister or Vice-Minister, which will be played in the General Assembly Hall during the general debate of the Assembly at its seventy-fifth session, the highlevel meeting to commemorate the seventy-fifth anniversary of the United Nations and the high-level meetings after introduction by their representative who is physically present in the Assembly Hall.'

The new format will mean that it will be for the first time in the world organisation's 75-year history that global leaders will not gather here for the high-level week that annually brings thousands of diplomats, government officials, civil society members and media persons from around the world to New York City. Telecommuting arrangements have been in place at the UN headquarters here since mid-March as coronavirus spread rapidly across New York, making the state the epicentre of the pandemic in the US.

The UN headquarters began its first phase of re-opening July 20, under which no more than 400 peo-



ple will be allowed to be present at the premises on any given day, in order to minimise the risk of exposure to the virus and to allow for physical distancing. Those present in the premises will have to follow

strict social distancing guidelines. The General Assembly meeting

to commemorate the 75th anniversary of the United Nations will take place September 21 and the Declaration will be formally adopted at the meeting. The General Debate of the 75th session of the Assembly will commence from September 22.

Along with the General Debate and 75th anniversary commemoration, key sessions will also be held virtually at the UN, the Assembly decided.

The summit on bio-diversity will be held September 30, meeting of the General Assembly on the 25th anniversary of the Fourth World Conference on Women on October 1 and the meeting to commemorate and promote the International Day for the Total Elimination of Nuclear Weapons October 2.

Member states will submit their pre-recorded video statements for these meetings as well.

GOVT TO OFFER OUTPUT LINKED INCENTIVES

New Delhi, July 23: The government is working on offering production linked incentives for up to five sectors to boost domestic manufacturing, a top finance ministry official said Thursday, bolstering efforts to attract new investments in the coronavirus-stricken economy.

This would be in addition to the ₹20 lakh crore economic package announced by the government recently to help different sectors of the economy, tide over the crisis due to the outbreak of COVID-19.

Asia's third-largest economy: India, is expected to contract by as much as 10% in the current fiscal year beginning April, some private economists' estimate, after the outbreak crippled business and consumer activity since late March, compared to the government's earlier target of about 6% growth.

The government has announced a raft of measures including direct food subsidy to nearly 810 million people and credit guarantees of ₹3 trillion (\$40.17 billion) on loans to small businesses.

LIVERPOOL PLAYERS RECEIVE PREMIER LEAGUE TROPHY

30-year wait ends

Liverpool, July 23: Standing on the Kop that should have been filled with Liverpool's most ardent supporters, Jordan Henderson did what no captain of the team had done before: Lift the Premier League trophy.

As fireworks exploded from the roofs of the mostly empty Anfield stands, red smoke filled the void. Not since 1990 — two years before the inception of the Premier League has Liverpool been crowned champion of England.

Only a late government reprieve ensured players at least had a few family members inside the stadium to witness the crowning moment of a season like no other in the history of English football.

Top-flight football trophies are never handed out in July in England, but the chilly weather inside Anfield felt more like winter when Liverpool started to run away with the championship, Only the pandemic—no opponent — put glory in doubt.

For three months, players and fans agonized whether the season would even resume. The only way it could was with fans shut out of the stadiums. No exemptions, even for a title party.

Instead seats in the center of the Kop were removed and replaced by the purple podium where manager Jurgen Klopp followed by his coaching team and players went up to collect their winners' medals.

"I was never on the Kop before, it was pretty special," Klopp said. "It makes sense in the moment

when the people are not in that we use the Kop to celebrate it with them together in our hearts.'

Mohamed Salah, whose goals have transformed Liverpool into English, European and World Champions, was wrapped in an

Trent Alexander-Arnold, the 21year-old Liverpool-born defender, peered down as he inspected his medal. He really was a Premier League champion, achieving what hometown greats Steven Gerrard and Jamie Carragher had been unable to as the drought persisted.

In the Main Stand, Kenny Dalglish - wearing a red face mask featuring a club crest — sipped champagne. He was manager in 1990 when Liverpool won what was then

Now Liverpool is finally a 19time champion of England, one behind the record held by Manchester United, which usurped the Reds by collecting the Premier League trophy 13 times from 1993 to 2013.

Not even a police order to disperse from outside Anfield could deter Liverpool fans from getting as close as possible to the trophy lift. They couldn't see it but they made their presence felt by setting off pyrotechnics in nearby streets that boomed around the stadium.

"Everything would be better with fans," Klopp said. "It would be perfect with the stadium full. But you cannot change it."

The players even delivered an explosive performance on the pitch



before the trophy lift. In the last home game of the season, Liverpool beat Chelsea 5-3 to record an 18th win in 19 league matches at Anfield. There were five different scorers: Naby Keita, Alexander-Arnold, Georginio Wijnaldum, Roberto Firmino and Alex Oxlade-Chamberlain.

"I am surprised," Klopp said. "How can you put a shift in like this when everyone thinks you want to be partying afterwards?"

As his players did eventually party around him on a field covered in confetti, they gathered for a rendition of "You'll Never Walk Alone."

Usually it would be the fans on the Kop most vocal in singing the club anthem. "I don't know when this (expletive) virus is gone," the German said in a message to fans from the pitch. "Then we will have a party all together. Make sure you are all ready then.'

Liverpool's 19th title was clinched the earliest of any time in English top-flight football history stretching back into the 19th century, by winning with seven games to spare.

The expectation is so high," Henderson said. "It's been a process, it's been a journey. It hasn't happened overnight.' And they don't want the jour-

ney to end. The motivation now is to defend the title so they can celebrate next year with fans inside Anfield.

All the round-robin games are best-of-four game contests. Legends of Chess is a unique event where Carlsen, Liren, Nepomniachtchi and Giri, semifinalists at the Chessable Masters (part of the Magnus Carlsen Tour), received an automatic invite.

They are up against six legends aged 40-52, who have been at the top of world chess at various points in their career.

The tournament is part of the Magnus Carlsen Chess Tour. The winner of this event will qualify for the USD 300,000 Grand Final scheduled from August 9 to 20.

ICC postpones two qualifying events

The ICC has postponed September's Men's Cricket World Cup League 2 series to be hosted in Namibia and the U-19 Cricket World Cup Regional Qualifier Division 2 due to take place in August in Tanzania. The World Cup League 2 series, which was to be hosted in Namibia in September, was part of the qualification for the 2023 World Cup - involving Namibia, Papua New Guinea and the United States, the ICC said in a statement. The U-19 World Cup Regional Qualifier Division 2 in Africa was due to take place in Tanzania between August 7 and 14, involving Botswana, Kenya, Mozambique, Rwanda, Sierra Leone and the host country.
