

New Delhi, July 24: The Income Tax Department will share PAN and bank account details of any entity with 10 investigative and intelligence agencies, including the CBI and the NIA, under the integrated counter-terrorism platform NATGRID, according to an official order. The Central Board of Direct Taxes,

which frames policy for the I-T Department, said in a July 21 order that information like permanent account number (PAN), Tax Deduction and Collection Account Number (TAN), bank account details, summary of IT Returns and tax deducted at source (TDS) and "any other information as mutually agreed" will be shared with the 10 agencies.

The "furnishing and receiving of information to and from" these central agencies will be done through the National Intelligence Grid (NATGRID), a robust mechanism envisaged to track suspects and prevent terrorist attacks with realtime data and access to classified information like immigration, banking, individual taxpayers, air and train travels.

THE 10 AGENCIES ARE: CBI, Directorate of Revenue Intelligence, Enforcement Directorate, Central Board of Indirect Taxes and Customs, Cabinet Secretariat, IB, Directorate General of GST Intelligence, Narcotics Control Bureau, Financial Intelligence Unit and the NIA

The 10 agencies are: the Central Bureau of Investigation, Directorate of Revenue Intelligence, Enforcement Directorate, Central Board of Indirect Taxes and Customs, Cabinet Secretariat, Intelligence Bureau, Directorate General of GST Intelligence, Narcotics Control Bureau, Financial Intelligence Unit and the National Investigation Agency.

These agencies are already authorised to obtain real-time NATGRID data as part of a legal arrangement made in the past. "While furnishing the information,

the specified income-tax authority shall form an opinion that sharing of such information is necessary for the purposes of enabling these agencies/bodies to perform its functions under their respective laws," the CBDT order said.

The CBDT and the NATGRID will sign a Memorandum of Understanding to finalise the latest information-sharing mechanism, it said.

The tax department and the NAT-GRID already have an agreement for sharing PAN-related information since

2017 and the new measure is a step forward for better and confidential sharing of the data between all the probe and intelligence agencies so that they are better enabled to analyse and counter any armed, financial or cyber threat to the country, a senior officer said.

The necessity for the NATGRID came after the 2008 Mumbai terror attacks exposed the deficiency that security agencies had no mechanism to look for vital information on a real-time basis.


Lack of quick information was considered to be one of the major hurdles in detecting US terror suspect David Headley's movement across the country during his multiple visits between 2006 and 2009.

Headley had provided key information and videos of terror targets to Pakistan-based terrorist group Lashkare-Taiba that carried out the attacks in Mumbai that killed 166 people including foreigners. The Cabinet Committee on Security had given approval to the ₹3,400crore NATGRID project on April 8, 2010 but its work slowed down after 2012. However, Prime Minister Narendra Modi later directed for its revival.

State's COVID-19 tally mounted to 22,693 with a record of 1.594 fresh cases in a single day even as the death toll surged to 120 as six more people succumbed to the disease Friday, an official of the Health and Family Welfare (H&FW) department said.

The state's coronavirus hotspot Ganjam district accounted for the maximum number of 732 new cases, followed by Khurda (320) and Cuttack (136),



As many as 1,067 fresh cases were reported from quarantine centres, while the remaining 527 were local contact cases, the official pointed out, adding that contact-tracing and followup action was underway.

"Regret to inform the demise of six COVID patients while under treatment in hospitals," the H&FW department said, adding that three deaths were recorded in Ganjam and one each from Ravagada, Gajapati and Bhadrak districts.

IPL TO START SEPTEMBER 19

New Delhi, July 24: The eagerlyawaited Indian Premier League (IPL) will start September 19 in the United Arab Emirates with the final slated November 8, wellplaced BCCI sources have told this



While the IPL Governing Council will meet next week to chalk out the final details and approve the schedule, it is understood that the BCCI has informally intimated the franchises about the plan.

"IPL, in all likelihood, will start September 19 (Saturday) and the final will be held November 8 (Sunday). It is a 51-day window which will suit the franchises as well as the broadcasters and other stakeholders," a senior BCCI official said on conditions of anonymity Thursday night.

The IPL has been made possible by the ICC's decision to postpone the October-November T20 World Cup in Australia owing to the COVID-19 pandemic due to which the host country expressed its inability to conduct the event.

While there was speculation that the IPL will start from September 26, the BCCI decided to advance it by a week in order to ensure that the Indian team's tour of Australia is not jeopardised. P12

The High Court said that the petition is maintainable, but the matter is under the consideration of the Supreme Court, Assembly Speaker CP Joshi had served the disqualification notices to the rebel MLAs, including Pilot, on the charge of "anti-party activities" soon after they skipped two Congress legislative party meetings in July.

The Speakers was first asked to defer

action in the matter by three days last week, when the High Court began hearing the case in which the petitioner MLAs challenged Para 2(1)(a) of the Schedule X of the Constitution. The Pilot camp got another three-day

breather Tuesday from the High Court after it finished hearing the arguments and reserved the judgment for July 24. The rebels had argued that no whip can be in issued when the Assembly is not in session and maintained that they had no plans to quit the ruling Congress but wanted a change in its Rajasthan leadership.

Meanwhile, Speaker Joshi Wednesday filed a CLP in the Supreme Court, and its hearing is scheduled Monday.

Meanwhile, Congress MLAs, who sat on a dharna outside the Raj Bhawan, were Friday assured by the Governor that he would call the Assembly session shortly. Following this, the dharna was lifted.

Ineligible recipients told to refund money

Bhubaneswar, July 24: At a time when the farmers are reeling under the impact of COVID-19 pandemic, the state government has asked all ineligible beneficiaries who received money under the KALIA Yojona to refund the money.

Prior to the 2019 general election, the BJD government had launched Krushak Assistance for Livelihood and Income Augmentation (KALIA) scheme and, in a hurry, distributed financial assistance of ₹5,000 each to over 51 lakh farmers. Later, during scrutiny, the government found that 2 per cent (nearly 1 lakh) people are ineligible to receive financial aid under the scheme.

Now, the government is asking all in-**Opposition slams** eligible beneficiaries govt, demands to refund the entitlement given to them action against under the scheme. erring officials

Speaking to the media here Friday,

Agriculture Secretary Saurabh Garg said, "We have sent request letters to all ineligible beneficiaries of KALIA scheme who have not refunded the amount on their own. They have been informed about the bank account number through which they can refund the

Garg said that out of 51 lakh beneficiaries who have availed assistance under the Kalia scheme, 98 per cent were eligible.

He further said that many inel-

igible beneficiaries like farmers with large holdings, income tax payers and government employees have refunded the assistance transferred to them voluntarily.

However, nearly 50,000 others have not refunded the amount they received, the secretary added.

Rakesh Kumar Meena, a beneficiary of the scheme said,

"I have utilised the amount given by government. Now, during this

pandemic, the government asked to refund. How can I repay it now?" Meanwhile, Opposition BJP and Congress have slammed the move

of the government and demanded action against the officials responsible for inclusion of the ineligible people in the beneficiary list. Terming the government as anti-

farmer, state BJP farmer wing president Pradip Purohit demanded roll-back of the decision.

1st COVID patient given plasma therapy recovers

Bhubaneswar, July 24: In a major achievement for the doctors in the state, the first COVID-19 patient, a 48-year-old woman, from Odisha who was administered plasma therapy has not only recovered, but also discharged from the hospital.

"Happy to share that a 48year old female COVID patient in Cuttack who was the first to be treated with plasma therapy (at Ashwini COVID hospital) has recovered and is being discharged today," the State Health and Family Welfare de-

The state government claimed that following the commencement of plasma therapy in the state, they reached out to 13 critical patients. "So far, 13 patients have received plasma therapy in the state and most are recovering well," the department said in a statement

The State Health department further said that the therapy has worked well on patients and most of them have seen progress on their health. The government now plans to set up plasma banks in other areas to encourage plasma donations from the cured patients of COVID-19.

'The technical team of doctors claims that the therapy has worked well on COVID 19 patients. Keeping in mind the power and potential of the therapy, we have planned to start two more plasma banks in the state,' Pradipta Kumar Mohapatra, Additional Chief Secretary, Health department had said Thursday.

The department has appealed to the cured COVID patients to come forward to donate plasma. The Health department said that the donors will be given certificates of appreciation for their noble gesture.

Cong takes pride in Narasimha Rao's feats: Sonia Gandhi


GUILTY OF IGNORING THE FORMER PRIME MINISTER, CONG PLANS TO CELEBRATE HIS LEGACY

BHUBANESWAR: Over-the-top (OTT) video services are the future of home entertainment in India and their consumption can grow 10 fold in next five years, a number of studies predicted in 2018. Multiple factors such as new technologies, dropping data charges, universalisation of entertainment and most importantly sudden spike in active smartphone users had a lot to do with this prediction. At that time, only web series used to get released on these platforms but not the mainstream films. However, shutting down of theatres has put the OTT industry on an unprecedented growth trajectory. Several big ticket movies like

Gulabo Sitabo, Angrezi Medium and Ghoomketu are now streaming online while quite a few biggies such as Shakuntala Devi, Laxmi Bomb, Yaara, Bhuj, Gunjan Saxena: The kargil Girl have got their release dates. OTT market with its millions of users is growing steadily and the streaming services are set to rule the entertainment scene like never before. While the pre-existing major OTT platforms like Netflix, Amazon Prime, Zee5 or Disney Plus Hotstar have geared up to woo local users churning out quality content, some regional language OTT services such as Hoichoi in Bengali and Sun NXT in Tamil, Telugu and Kannada have also managed to take their slices of this pie.

However, with only a couple of Odia movies like Tulasi Apa and Khyanika being released on OTT platforms, that too for a brief period,



the entertainment industry back home appears to have failed to catch up with the OTT boom in India.

This is what people from Odia entertainment industry had to say about the poor presence of Odia content on digital format.

Siddhartha Mohapatra, vice-president of Aao TV, a new homegrown OTT platform, says, "The big players have so far ignored Odia language content. We took this as an opportunity to come up with a platform that can offer fresh Odia shows and movies to the users. We are also in talk with a few Odia producers and makers to stream their content on our channel. Even as

they are little apprehensive to commit anything at the moment, we will soon catch up with the national

Aao TV is planning to release multiple web shows in coming days, added Sidharth.

Joyeetya Roy, a media expert and owner of Signature 24 Productions, says "Most of the leading OTT platforms are thriving due to users' demand and wider base of viewership. Unfortunately, they don't get quality content in Odia language and this could be a reason they are shying away from releasing Odia films on their platforms. They won't take Odia shows and films seriously unless we produce good content" Regional OTT platforms in state like West Bengal, Bihar and

Maharashtra are giving tough competition to the big players because they produce content which attracts the users. But it is yet to happen in Odisha, she added. Echoing similar sentiment, actor

Partha Sarthi Ray said, "Most of the films produced here are poor remakes of big budget movies of other regional languages. There is no reason why a user would subscribe a channel to watch substandard stuff when he has option to watch the orig-

Actress Prakriti Mishra, whose

award winning movie Hello Arsi will soon stream online, said, "Big OTT players always need content in bulk to retain their users. But unfortunately, we don't have a healthy pool of content to choose from. They want enough good Odia movies in their buckets which we, unfortunately, don't produce these days.'

Prolific filmmaker Akshaya Parija whose Hindi and Bengali films are streaming in Netflix, Hotstar and Hoichoi, said, "Odia film industry should create more original content rejecting the ongoing 'copypaste' formula to get the films released in big OTT platforms.

Regional OTT platforms in state like West Bengal, **Bihar and Maharashtra are** giving tough competition to the big players because they produce content which attracts the users. But it is yet to happen in







Govt to pump in ₹1K cr for livelihood support

Bhubaneswar, July 24: The state government has decided to spend around Rs 1,000 crore for creating sustainable livelihood opportunities under Odisha Forestry Sector Development Project (OFSDP). Phase-II in a bid to boost economic activities in hilly and forest regions during Covid-19 pandemic.

The decision was taken at a meeting presided over by Chief Secretary Asit Tripathy recently. Sustainable livelihood and income generating activities have been taken up in 12 territorial forest divisions on joint forest management (JFM) mode with direct participation of Vana Surakshya Samitis (VSSs) and self help groups (SHGs) under OFSDP

It was decided to identify forest divisions with specific 'product clusters' and scale up those through interdepartmental convergence in terms of resources, technical support, skill building and marketing.

Tripathy directed the officials to maximise convergence of resources from OSFDP, Mahatma Gandhi National Rural Employment

Guarantee Scheme (MGNREGS), Odisha Livelihood Mission (OLM), Orissa Tribal Empowerment & Livelihoods Programme (OTELP) Plus and other similar activities.

Forest and Environment department additional chief secretary Mona Sharma suggested to take up farm, non-farm and non-timber forest produce (NTFP) based on livelihood interventions through

community-level institutions.

The state will set up product clusters like sal seed involving 435 VSSes, tamarind involving 242 VSSes, harida with 260 VSSes, bahada with 258 VSSes, char with 333 VSSes, cashew with 121 VSSes, mango with 223 VSSes, mahua with 395 VSSes, and neem seed cluster involving 187 VSSes. Around 88,000 households would get additional income from these clusters, the source said.

Development Commissioner Suresh Chandra Mohapatra, who was also present in the meeting, has ordered for establishment of livelihood resource centres to provide technical input, required skill, training and, linking to financial institutions. He instructed the officials to provide continuous handholding support for product development, branding and marketing linkages.

OFSDP director Sudarshan Panda said 778 VSSes covering around 50,000 households in the project villages of 12 forest divisions have been linked with respective departments for carrying forward the livelihood activities

Seven sal leaf making clusters have been set up at the forest divisions of Baripada, Rairangpur, Karanjia, Keonjhar, Baliguda and Phulbani involving 4,645 households organised under 460 SHGs, Panda said. Apart from this, 497 community development projects estimated to be around Rs 11.38 crore have also been approved which will be implemented in convergence with MGNREGS

Man kills wife in 4 more RRTs to counter nCoV surge

Bhubaneswar, July 24: Observing the rising cases of Covid-19 in the Capital city, the Bhubaneswar Municipal Corporation (BMC). Friday stated that it would add four new Rapid Response Teams (RRTs) to its fleet to expedite contact trac-

ing process. As the city saw a massive spike of 248 fresh cases Friday, the civic authority held a detailed review meeting in this regard under the chairmanship of Covid observer, Anu Garg, Labour Commissioner Thirumala Nayak and BMC Commissioner, Prem Chandra Chaudhary, who were also present at the meeting, held discussions about a holistic and effective Covid management strategy as the cases

continue to rise. "It can be mentioned that prior to this 10 RRTs were working with



the BMC. Out of these 14 RRTs, six are at zonal level while the remaining teams are at the Central Covid Control Room at BMC. With the addition of four more teams. these 14 dedicated teams will specifically focus on contact tracing and assisting in shifting of patients to across various hospitals, Covid care centres and home isolation," Chaudhary mentioned.

Sources at the BMC also said

that more teams are likely to be added as the city is witnessing a rise in positive cases every day. Meanwhile, as the testing for the novel coronavirus is being scaled up, the city is likely to see further rise in Covid-19 cases.

The RRTs which mostly consist of healthcare experts from Community Medicine and AYUSH will have additional numbers to combat the sudden surge of cases.



Pandemic getting worse in City

Bhubaneswar, July 24: The Capital city Friday reported the highest single-day spike of 248 Covid-19 cases, taking the total virus tally in Bhubaneswar to 1,717.

Of 248 new confirmed cases of COVID-19, 207 were detected from quarantine centres and 41 are the local contacts, the Bhubaneswar Municipal Corporation (BMC) said in a tweet, adding that 29 persons who had earlier tested positive for the disease recovered Friday.

With this, the Temple city has 870 active cases. Bhubaneswar has so far lost 11 lives to the viral infection, said the civic body.

According to sources, slums in the city have become a major concern for the authorities as 45 cases were detected from a slum at BJB Nagar and 20 in a slum in Nayapalli area here.

As per information shared by BMC, all the cases in two slums have link with earlier positive cases.

Healthcare facilities in the Capital city are no more safe zone as 27 woman employees of a private hospital linked with an earlier positive case were found to have been infected with the Covid-19, said a source. The BMC, meanwhile, sealed a flour mill at Mancheswar in the state capital here after 61 of its employees tested Covid positive during the past couple of days.

Tracking virus from cough sounds

Awing of Indian Council of Medical Research (ICMR) and a healthcare initiative formed by Indian and Norwegian governments have launched a study to detect coronavirus infection from cough sounds of people using artificial intelligence (AI), an official said.

A mobile app has been developed by Norway-India Partnership Initiative, in which people who are not infected by the virus are recording their cough sound, while researchers have collected such sounds from COVID-19 patients.

An analysis using AI will be conducted on the mixed database of cough sound samples to find out a coronavirus infected person, Regional Medical Research Centre (RMRC) director Sanghamitra Pati said Friday. The RMRC of Bhubaneswar is a

City-based med scientists contribute in virus analysis

E ven as the country's battle against SARS-CoV-2 pandemic still continues, scientists from the ICAR-Central Institute of Freshwater Aquaculture, Bhubaneswar have jumped to the fray. To enable so, they are deputed phase-wise for analysing the clinical samples collected from COVID succumbed and suspected patients by Govt of Odisha employing RT-PCR technique at organization of ICAR-International Centre for Foot and Mouth Disease (ICFMD), Jatani, Bhubaneswar.

The RT-PCR is one of the most widely used laboratory methods for detecting the COVID-19 virus. While many countries have used real time RT-PCR for diagnosing other diseases, such as Ebola virus and Zika virus, many need support in adapting this method for the COVID-19 virus, as well as in increasing their national testing capacities.

It is a nuclear-derived method for detecting the presence of specific genetic material in any pathogen, including a virus. This technique allows scientists to see the results almost immediately while the process is still ongoing, whereas conventional RT-PCR only provides results at the end of the process.

Manamunda, July 24: Even as things have gone from bad to worse owing to Covid-induced shutdowns and lockdowns, poor rainfall has added to the worries of farmers in many parts of Manamunda block of Boudh district.

The area saw scanty rainfall in June and July while paddy sapling transplantation has not been carried out as yet. All agricultural activities were affected for lack of rain in Manamunda, Gudvelipadar, Bilashpur, Bargochha, Sundhipadar, Jogindrapur, Khatakhatia, Ghikundi, Similipadar, Dapala, and Palasgola panchayats.

Farmers alleged that rain has done a vanishing act while agricultural activities have lagged behind in most areas, except for irrigated areas.

"Farmlands are almost dry, making it difficult for us to raise paddy saplings and transplantation. Without sufficient water, farmlands can't be cultivated and processed for the transplantation

A drought-like situation can't be ruled out in the region if the area doesn't have rains in next few days, rued some farmers.

They also pointed out that the rain is playing hide and seek at this time when agricultural activities could have been carried for-


Fearing a drought situation and crop damage, farmers are in a hurry to seek coverage under Pradhan Mantri Fasal Bima Yojana.

"But, concerned websites for crop insurance are not opening at Jana Seva Kendras. The final date for depositing premiums for the insurance coverage is July 31," they pointed out.

With websites not opening up, farmers are in a fix as to how to submit their premiums in the next

When contacted, Mayurbhanj deputy director of agriculture Damodar Sethy said, "Weather condition these days has been precarious for farming activities. We advise local farmers to make use of KALIA yojana assistance money to buy pump sets and irrigate their farmlands by lifting water from nearby resources." The department gives a subsidy of 50 per cent to farmers for pump sets, Sethy added.



"We once again appeal to Maoists operating in Kandhamal and elsewhere in Odisha to lay down arms. They should join the mainstream as the state government has a very generous surrender and rehabilitation policy for them," Abhay told reporters after holding a meeting with senior police offi-

The DGP said that the police are determined to make Kandhamal a Maoist-free district as done in five other districts recently. "Our aim is to Left Wing eliminate Extremism (LWE) from the entire state," he said.

If the Maoists fail to surrender, they will have to face tough action as anti-Naxal operations will be stepped up



to eliminate the LWE menace from the state, the DGP said. The police chief's call comes a day after two Maoists, in-

cluding a woman, were gunned down during an exchange of fire with security personnel in a forest in Tumudibandh area.

A fortnight ago, the state government had approved a proposal of the state police to exclude Angul, Boudh, Sambalpur, Deogarh and Nayagarh districts from the areas that are entitled to benefits under a central scheme for LWE-hit places.No Naxal activities had been reported from the five districts.

This season farmers in Jahara Nathuabara, Sribantpur, Singhapur, Odisho, Barabati, Badakainchi, Bhotaka, Rasulpur and Rahamba panchayats have grown vegetables like lady's fingers, various types of gourds, cucumbers, and beans. Besides selling to traders, the farmers also sell the vegetables in local daily and weekly markets.

"We welcome the steps taken to stop the spread of coronavirus. But at the same time we feel bad that there is no government scheme for us. During lockdown, the government should buy our produces. After fixing a price, it should allow registered traders to procure our produces on behalf of the government. We sirge the government to set up cold storages near the markets to preserve the vegetables, some farmers said.

Kerala babu's fall from grace

The gold-smuggling racket unearthed in Kerala has created a major controversy and a senior IAS officer staring at the abrupt end of his once brilliant career in the civil service. At the centre of the episode is M Sivasankar, principal secretary to Chief Minister Pinarayi Vijayan as well the state Information Technology Secretary

Perhaps sensing that the scandal could be used to undermine his office, Vijayan was the first to demand an inquiry into the case, and promptly removed Sivasankar from the two posts that the babu held in the government. The accused babu now faces a probe into his connection with the main accused in the smuggling of 30 kgs of gold.

According to sources, Sivasankar wielded immense clout in the government and is widely credited with pitching Kerala as an ideal destination for investment. Known as a no-nonsense and hands-on babu, Sivasankar played a crucial role in the government's flagship projects such as providing highspeed internet connectivity in the state and the Startup Mission, among others. This makes his fall even harder to comprehend for many of his colleagues.

Nagaland move irks Centre The Nagaland government landed itself in a soup when it posted non-IAS officers as district magistrates or deputy commissioners in six of its 11 districts, in contravention of the All India Service Rules. The



Centre has come down on the state government like a ton of bricks for "misgovernance".

According to sources, the Department of Personnel and Training (DoPT) has written to Nagaland Chief Secretary Temjen Toy pointing out the contravention and also observing that there was no dearth of suitable IAS officers for the state government to take such a step. It is said that nine active IAS officers have been posed to ex-cadre or subordinate posts instead of as deputy commissioners.

Apparently, Rule 9 of the IAS Cadre Rules states that cadre posts shall not be filled by a non-IAS officer barring a few exceptions, and it shall only be a temporary solution that requires the state government to take prior approval of the Centre.

Interestingly, the state Governor RN Ravi too has written to Chief Minister Neiphiu Rio about initiating transfers only after prior approval of the Governor. Seems like the start of a political battle, with babus as pawns. **EC Lavasa named ADB Vice-President**

The appointment of Election Commissioner Ashok Lavasa as Vice-President of the Asian Development Bank (ADB) has clarified several things. Lavasa who was next in line to become Chief Election Commissioner after the retirement of Chief Election Commissioner Sunil Arora in April 2021 will now resign to take up his new assignment. He will be the first sitting EC to get another appointment before completing his term. The other EC Sushil Chandra will now be a natural claimant for the next CEC. The move also clears the deck for the government to appoint another ex-babu to the poll panel.

Curiously, Lavasa apparently wasn't aware of his new appointment although many international institutions do not announce appointments unless the respective government is on board with the decision.

A former Haryana cadre IAS officer who also led Finance, Environment, Forests and Civil Aviation ministries, has had a rocky relationship with the government once he became EC. He was the lone dissenter in the poll panel when it gave clean chits to Prime Minister Narendra Modi and Home Minister Amit Shah for alleged poll violations in last year's general elections. He and his family had to face a slew of IT notices for alleged misdemeanours.

The new appointment will likely make Lavasa a relieved man. It may also come as a relief for the government to see a "dissenter" exit the poll panel at a time when critical state elections are coming up next year.



Swan upping

It was reported in the Washington Post in July 2010 that the Queen was considering how to reduce the cost of running the British monarchy, one suggestion being to lay off her official Swan Marker. The British media didn't mention this; perhaps the idea of the Queen having one in the first place to get rid of didn't seem so strange to them as it does to Americans. The report came a week before that official took part in an annual ceremony on a 70mile stretch of the River Thames upstream from London; swan-upping. It's not as rude as it sounds: it's an annual census in which the mute swans and their cygnets are upped — taken up from the river to be inspected and marked. The census - it takes five days - is operated by the Swan Marker and the Swan Uppers of two of the ancient trade guilds of London, the Vintners' and Dyers' livery companies. The census is said to date from the 12th Century, at a time when the sovereign claimed ownership of all swans (they were valuable birds that were served up at banquets and feasts). These days, royal ownership is claimed only on the Thames and some tributaries and — you may be pleased to learn — the Queen doesn't actually eat any of her swans. The birds used to be tagged by nicks on their beaks — which is why the Swan Marker has that name — but these days are ringed on their legs. As a side-note, there are several pubs in Fnoland that have the name Swan With Two Nicks. Two nicks put on a swan's bill at the time of swan-upping signified that it was owned by the Vintners, hence the connection with pubs. The link has often puzzled people. Down the centuries several such pubs changed their names to Swan With Two Necks, in the toponymic equivalent of popular etymology.

LIVING WITH FLOODS

hina is facing the worst 'floods in hundred years though it made the largest numbers of dams in the world. India too is facing floods in Bihar despite having arrested floodwaters in the Tehri Dam. Assam is regularly facing severe seasonal floods. The reason is that we consider rivers only as carriers of water and ignore their role as the carriers of sediments.

We forget that the land mass from Haridwar to Kolkata has been made by the sediments brought by the Ganga. The water of the Ganga has been spreading all around for thousands of years and depositing the sediments. These sediments have become the states of Uttar Pradesh, Bihar and West Bengal. Yet, floods also cause human suffering. Question is how should we deal with this?

Ganga has the highest load of sediments among the major rivers. She deposits sediments in her channel every year. Then, these sediments are pushed to the sea during major floods that come every five or ten years and the channel is restored to its earlier depths and high capacities to carry water. However, we have stopped such major floods by making the Tehri Dam and removing much water from the Haridwar and Narora barrages for irrigation.

As a result, the sediments being deposited in her channel every year are no longer being pushed to the sea; the level of the channel is gradually rising; the Ganga's capacity to carry the floodwaters is getting reduced; and even a 'small' flood now inundates the banks and causes huge damage as is seen in Bihar today. We have actually increased the flood fury by making the Tehri Dam.

The Farakka Barrage has made the problem worse. Hydrologists tell us that even making the pillars of a bridge causes serious obstruction to the flow of the river and reduces its velocity and ability to carry the floodwaters. It follows that the velocity of the Ganga is reduced even if all the gates of the Farakka Barrage are opened.

The reduced velocity leads to the river depositing more of sediments upstream of Farakka. This

leads to a double-reduction of the capacity of the Ganga to carry the floodwaters. The reduction in velocity directly reduces the extent of water that she can carry to the sea; and a reduction in the depth of the channel further reduces the extent of water she can carry. As a result, the floods in Bihar are increasing

Some scientists believe that the flow of the Ganga has been reduced from Barh to Farakka while others say the flow has been reduced from Buxar onwards. The capacity of the tributaries like Kosi and Gandak has been reduced in tandem because the Ganga cannot accept the water brought by them just as it is difficult to enter a Second Class railway coach that is already full. No wonder. Chief Minister Nitish Kumar has been seeking a reassessment of the relevance of Farakka Barrage.

Two studies got done by the Tehri Hvdro Development Corporation found that the reservoir of the dam will get completely filled up in 140 to 170 years. Thereafter, we will not be able to hold any water and the major floods will be restored. However. by that time, the sediments deposited in the riverbed would have got stabilised and hardened and the major floods may no longer be able to push the sediments to the sea as they can do today. In this way, we are putting our future generations in peril by our penchant for controlling the floods today.

Another fateful consequence of arresting the sediments in the Tehri Dam is that the sediments that would have reached the Sunderbans are no longer reaching there. This is resulting in huge erosion. The sea has a natural hunger for sediments and it begins to eat the land if its hunger is not met. The erosion of the Sunderbans is partly due to the rise in sea level due to global warming but also partly due to the deprivation of the inflow of sediments from the Ganga. It can be said that the Tehri Dam and Haridwar and Narora Barrages are 'eating' away the sacred land by opening the path for the sea to eat our land.

Indeed, the Tehri Dam is providing drinking water to Delhi and these barrages are providing irrigation and enhancing our food security-but at the cost of loss of the sacred land.

The engineers of Bihar are not behind. They have made a number of embankments on the sides of the rivers. They wanted to restrict the flow of the river to her channel so that the floodwaters did not spread and create havoc. The people were

surely helped. But, for how long? The sediments brought by the rivers got deposited between the embankments and that is leading to the rise in the level of the riverbeds.

The engineers raised the height of the embankment in parallel. Soon, the level of the riverbed became higher than the surrounding land. The river now flows above the ground like the Metro Rail. And when the embankments break, as they necessarily have to sooner or later, then the water gushes out and inundates much larger area because the land between two rivers becomes like a bowl and the flood waters cannot now flow to the sea since their pathways are obstructed by the raised river courses.

We will have to learn to live with the floods. I had an occasion to study the floods in Gorakhpur in the 90s. Local people told me that previously the floods were welcome. Villages were made on raised lands and people lived safely in their houses during the floods The floodwaters used to flow like a sheet of water. They brought sediments that fertilised the soil. They used to grow certain varieties of paddy that increased in height as the floodwaters rose. The floods would soon recede and they got not only paddy crops but floods fer-

tilised soil for their rabi crop. We will have to revert to this approach of 'living with the floods.' We will have to remove the dams, barrages and embankments. We can still obtain drinking water for Delhi and irrigate our fields by undertaking groundwater recharge in the plains of Uttar Pradesh. We can store about 76 billion cubic meters (cumecs) of water in the ground water aquifers of UP. The 2.6 billion cumecs stored in the Tehri Dam is a pittance, by comparison.

Insurance cover in times of pandemic

hield Yourself Against the Rising Medical Expenses due to Covid-19'. This is the slogan displayed on the website of an insurance company. This is about the new insurance policy it is offering, styled as 'Corona Kayach'. In fact, all the 30 general and health insurance companies across the country are highlighting the need to purchase this policy on their websites after the mandate was given by the Insurance Regulatory Development Authority of India (IRDAI).

The treatment cost of the Covid-19 patients is leaving the general public stunned. It is beyond the reach of the common man. In government hospitals, treatment is given freely but the corporate hospitals are charging as high a ₹25,000 to ₹1,50,000 a day for patients. Some state governments caped the rates for Covid treatment in private hospitals. The Karnataka government fixed rates ranging from ₹5,200 to ₹25,000, depending on the condition and severity of the case. The Punjab government fixed the treatment cost from ₹8,000 to ₹18,000 on the basis of severity of the symptoms and the category of hospital. The Telangana government capped

the fee for conducting a Covid-19 test in private lab at ₹2.200 and the fee for treatment of patients in private hospitals from ₹4,000 to ₹9,000 a day. Apart from this, the cost of some antiviral injections is around ₹40,000 to ₹50,000; which will be charged separately.

These figures speak volumes about the financial burden on the family of patients admitted to these private hospitals. In order to overcome this risk, IRDAI has designed a common Covid-19 health insurance product, addressing basic health insurance needs of the people with common policy wording across the industry. IRDAI mandated the 30 general and health insurance companies to offer the Individual Covid Standard Health

Policy, 'Corona Kavach' On July 10, the authority issued clearance to these companies to market this policy. A day later, it issued another advisory allowing a five percent discount in premium to Covid warriors like doctors, nurses and other healthcare workers as a token of recognition of their services in fighting the pandemic. Further, the authority released another press release on July 21, extending the coverage of 'Corona Kavach' policy to groups. The statement revealed that the group policy can provide protection to a large number of workers employed in manufacturing, services, MSMEs, SMEs, and migrant workers.

The basic features of the policy are that this is available on individual or family floater or group basis and that the base cover will be on indemnity basis(Covid hospitalisation cover) or optional cover on benefit basis (hospital, daily cash); a 15-day waiting period; three categories of time-period -- three and a half months, six and half months and nine and half months' waiting period; people between the age group of 18 to 65 years can avail the policy for themselves; spouse, parents, parents-in-law and dependent children up to the age of 25 can be covered; medical expenses of hospitalisation on diagnosis of Covid shall be admissible from 15 days prior to hospitalisation and 30 days post hospitalisation; cost of treatment incurred by the person on availing treatment at home on positive diagnosis up to 14 days per incident; ambulance charges ₹2.000 per hospitalisation; optional cover of hospital daily charges at 0.5 per cent of the sum insured per day, subject to

a maximum of 15 days in a policy period for every insured member; any set up designated by the government as hospital for the treatment of Covid shall be considered as a hospital; a single premium policy; and any co-morbid condition triggered due to Covid 19 shall be covered during hospitalisation.

IRDAI has instructed all insurance companies to educate policy holders by disseminating information on the precautions to be taken by them to protect them-

selves from the infection. This, in sum, is a right kind of health insurance policy introduced at the right time. Insurance companies should market it in the interest of the society at large, as Covid-19 is affecting the lives of millions, physically, mentally, and financially. The individual and family policies help in providing peace to the family members. When the lockdown restrictions are eased. business organisations will operate as usual and the group insurance will provide them necessary protection. As this is a new one, many of us are not aware of it.

Bangalore, July 24: Shantharam Budna Siddi, a 55-year-old African-origin Siddi tribal, is elated on being nominated as a Karnataka Legislative Council (MLC) member by Governor Vajubhai Vala.

"It is an honour to represent our tribal community in the legislative council but to serve everybody. Service to people is service to God,' a beaming Siddi told IANS on phone in Kannada and Hindi from his village Hitalahalli near Yallapur taluk in Uttara Kannada coastal district. Yellapur is 425 kms northwest

of Bangalore in the southern state. Siddi is among five persons nominated Wednesday to the Upper House to fill vacancies caused after the term of the incumbents lapsed

Scavengers risk health to sift coronavirus debris

New Delhi, July 24: Mansoor Khan and his wife Latifa Bibi have been collecting scraps of plastic and other items at an enormous landfill site on the outskirts of New Delhi for nearly 20 years.

Their \$5 daily earnings each keep their three children at school in search of a better future than their parents' lives amid the stench of rotting garbage. But over the past few months, increasing amounts of biomedical waste have been arriving at the dump - a result, experts say, of the novel coronavirus pandemic and a huge risk for those who work there.

Spread over 52 acres and rising more than 60 metres, the site is littered with used, plastic coronavirus test kits, protective gear and cotton stained with blood and pus-among hundreds of tonnes of waste coming daily from across the Indian capital, including small hospitals and nursing homes

Outrage over sealing of corona patient's flat

Bangalore, July 24: In a shocking incident a Covid-19 patient's flat in the city's eastern suburb along with that of her neighbour's was sealed with metal sheets, leading to an uproar and forcing Bruhat Bengaluru Mahanagara Palike (BBMP) Commissioner N. Manjunatha Prasad to express regret and promise action against the erring staff.

"The commissioner has regretted the civic body staff's action in sealing the home-quarantined patient's flat and that of her neighbour's with metal sheets and assured of action against those found guilty," the official told IANS here

The metal sheets were removed Thursday night after a video clip went viral on the social media and sparked protests by owners of other flats in the residential building. The incident came to light after

the victim's neighbour tweeted pictures of metal sheets nailed to the wall across the main doors of the two flats, preventing their residents from coming out. "It's unfortunate that instead of

advising the victim to stay home under quarantine and not to allow anyone to enter her flat, the overzealous staff sealed the flats in violation of the standard operating procedure," the official maintained.

Though a 9-day lockdown was lifted on Wednesday, containment zones across the city remain sealed

to prevent the virus spread, while asymptomatic patients are strictly told to be remain in home quar-

According to the coronavirus patient, the civic body's health officials came to the flat and told her that they would seal the floor to check the virus spread.

"Instead, the civic staff sealed the two adjacent flats by clamping metal sheets across their main doors," the official admitted.

As Karnataka's epicentre of the pandemic, Bangalore reported 2,207 new cases on Thursday, taking its Covid tally to 39,200, including 29,090 active cases. As many as 9,326 patients have been cured and discharged, including 1,038 in the last 24 hours. A total of 783 patients have succumbed to the infection since March 9.

Unfounded fears keep plasma donors away

New Delhi, July 24: The response to a call for donating convalescent plasma for COVID-19 patients in Delhi has been 'lukewarm', doctors said Friday and attributed it to unfounded apprehensions about associated health risks and the tendency to put off donation for any future need of family members.

Just about 320 people have donated plasma in Delhi since the initiative began July 2, whereas more than 1,00,000 COVID-19 patients have recovered till July 23, according to officials.

Chief Minister Arvind Kejriwal Thursday said the government would provide plasma for free and people do not need to buy or sell it.

The chief minister and other senior members of the government have repeatedly appealed to people, who have recovered from COVID-19, to donate plasma to other patients. But the response to the calls has been muted at the first-of-its-kind 'plasma bank', inaugurated by Kejriwal at ILBS here July 2, and another one opened a week ago at LNJP Hospital, a dedicated coron-



avirus facility.

"At ILBS, while on the opening day, 10 donors had come, mostly the hospital staff who had earlier been infected with COVID-19, now the daily average is about 15, which makes it around 300 donations in total till date, a rather lukewarm response," a senior official of the facility told PTI. This is despite the fact that to-and-fro transportation facilities and food are provided to the donors at the Institute of Liver and Biliary Science (ILBS).

"The main reason behind this low response...is that people are

still feeling apprehensive even though there is no risk involved,'

the official, also a doctor, said. At LNJP Hospital's plasma bank 30 donors have volunteered till July 23. but 11 were rejected, as they could not fulfil the eligibility guidelines. "So, effectively, we are left with 19 donations which is not a very encouraging number, and some of which have been used already. But it is heartening that young people, mostly in the age group of 20-40, are donating their plasma," Medical Director, LNJP Hospital, Dr Suresh

Asked why such a low response despite the chief minister and his colleagues urging people to donate plasma, Kumar said there seem to be multiple factors.

"Though there are no side effects as such, but still many have apprehensions that something will

happen if they donate plasma. who have recovered, are apparently putting off donation so that they can offer it to their family members. in case they get infected, and the fear of near and dear ones getting infected is very palpable," he said.

For donors, there are some strict criteria and counselling and screening is done for them before actual donation process begins, so, about two to two-and-a-half hours is the total time per donor.

"Also, we do TTI (Transfusion Transmissible Infections) tests. So, the donor should not have HIV, hepatitis B or C, syphilis among other ailments. The donor also should not have any co-morbidities like diabetes, hyper tension or renal problems," a senior doctor at the ILBS said. "Each person can donate 250-500 ml of plasma. We give first dosage of 250 ml to the recipient, and if needed second dosage of 250 ml after 24 hours," Kumar said.

Kumar said that when he takes a round in wards and ICU, "some patients, who are serious, and their relatives, ask us as to when will be they be getting plasma.'

Powerlifter does his bit for burial of virus victims

Bangalore, July 24: For someone who has lifted 295 kg without breaking a sweat, famed powerlifter Mohammed Azmathulla feels the pain of carrying the bodies of COVID-19 victims, as he goes about

giving a dignified burial to them. 'The pain I experience while carrying the body of someone who has died due to coronavirus can't be explained," the champion powerlifter said. As coronavirus now carries a stigma borne out of public fear, many people avoid touching victims' bodies, protest against their cremation or burial in the vicinity and look at the relatives of the deceased with fear.

Azmathulla, fondly called Azmat, has taken up the task of giving a

dignified burial to coronavirus victims and has associated himself with the Mercy Mission for the purpose. A programme manager in

DXC Technology, an IT firm, Azmat works for five days and reserves the weekends for this social cause. He said he has rostered himself

"I was part of the drive for relief work during the lockdown and when I saw people dying in huge numbers in July, I decided to associate myself with the Mercy

for this work Saturdays and Sundays.

Mission," Azmat told PTI. The challenge those at Mercy Mission face is that the last rites is a time-consuming process, right from the procedures involved at the hospital and at burial grounds. Besides, volunteers also have to confront protests, which further

delays the procedure. The deaths due to COVID are rising but that has not scared the powerlifter. "Death is certain, so there is no need to be bothered much about it. But I do take the utmost precautions, which is multi-layered because I too have a family," Azmat said.

About coronavirus, he said almost 90 per cent of those who died due to the pandemic and those he had buried were those who had never ventured out of their houses.

"If you have to get the disease, you will certainly get it even if you have caged yourself in the house. I have seen young people in their twenties without any comorbidities dying of coronavirus and also seen elderly people with comorbidities escaping from it. It's a very tricky disease," Azmat added.



New Delhi, July 24: Al-Qaida in the Indian Subcontinent (AQIS) is planning retaliation operations and an Indian ISIS affiliate -- Hind Wilayah -- has 180 and 200 members present in Kerala and Karnataka, as per the United Nations Security Council.

The revelation was made in the 26th report of the Analytical Support and Sanctions Monitoring Team which was released Thursday. The report stated that "ISIS Indian affiliate -- Hind Wilayah -- which was announced on May 10, 2019, has between 180 and 200 members. According to the report, there are significant numbers of ISIS operatives in Kerala and Karnataka.

The report also states that AQIS is planning retaliation operations in the region to avenge the death of its former leader Asim Umar. About AQIS, the reports point out that the terror outfit operates under the Taliban umbrella from Nimruz, Helmand and Kandahar Provinces. It reportedly has between 150 and 200 members from Bangladesh, India, Myanmar and Pakistan.

"The current leader of AQIS is Osama Mahmood, who succeeded the late Asim Umar. AQIS is plan-



ning retaliation operations in the region to avenge the death of its former leader," the report stated.

ISIS and al-Qaida remain active on social media, using platforms and messaging applications to share information and communicate with followers for the purposes of recruitment, planning and fundraising, the report stated. Although the Europol operation in November 2019 to remove extremist content from Telegram appears to have had some impact on the ability of IS to disseminate its message, the group has found ways to mitigate the clampdown.

To achieve a wide dispersal of video and audio messages in April and May 2020, IS used several smaller platforms and file-sharing services, including Dropbox, Files.fm, Internet Archive, Microsoft OneDrive, Nextcloud, Ok.ru, Rocket.Chat and Vimeo. For messaging, ISIS and al-Qaida are looking for tenable alternatives to

In a May 2020 issue of Ibaa' magazine, ISIS affiliate Hei'at Tahrir al-Sham had actively urged its followers and other militant groups in the Syrian Arab Republic to move permanently away from Telegram, Facebook Messenger and Viber and instead use other end-to-end encryption applications such as Conversations, Riot, Signal and Wire.

The Ministry of External Affairs (MEA) said the two sides agreed at the Friday talks that another meeting of their senior army commanders may be held soon to work out further steps to ensure complete disengagement "expeditiously".

"They agreed that early and complete disengagement of the troops along the Line of Actual Control (LAC) and de-escalation from India-China border areas in accordance with bilateral agreement and protocols and full restoration of peace and tranquility was essential for smooth overall development of bilateral relations," it said in a state-

The MEA said the two sides noted that this was in accordance with the agreement reached between the two Special Representatives during their telephonic conversation on July 5.

National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi held

LAC ROW a nearly twohour-long telephonic conversation on July 5 to bring down tension between the armies of the two countries in eastern Ladakh.

Both sides commenced the disengagement process from July 6 following talks between Doval and Wang who are Special Representatives for the boundary question. Haryana man held for killing his children

Chandigarh, July 24: A 38-yearold man has been arrested in Haryana's Jind district after he confessed to killing his five children in the last four years, including two of them recently, a senior police official said Friday.

The man, identified only as Jumma, is a labourer and belongs to a village in Safidon in Jind, he said, adding that his wife is pregnant with the sixth child. The bodies of two of his daughters, ages 11 and 7, were recovered from the Hansi-Butana Link canal near his home in Didwara village on July 20, five days after the accused had lodged a police complaint stating the duo had gone missing. However, during the course of

investigation, Jumma kept changing his statements which raised suspicion, Jind ASP Ajit Singh Shekhawat said.

The police presumed that he was under mental stress due to the death of his children and did not subject him to sustained questioning at the moment. The village panchayat was later involved in the investigation, and the man confessed before them and later, the police, that he killed his five children. Jumma admitted that he drugged his two minor daughters and threw them in the canal a few days ago, the ASP said. "We arrested him on Thursday evening, and he has been charged with murder," said Shekhawat. Earlier, Jumma's three children, all below 11, had also died mysteriously.

At that time, he had told his neighbours that one of his sons died in sleep, a daughter died while playing and another son started vomiting and died

Phase-I human clinical trial of potential Covid vaccine begins

New Delhi, July 24: The phase-I human clinical trial of India's first indigenously-developed vaccine against novel coronavirus, Covaxin, began at the AIIMS here on Friday with the first dose of the injection given to a man, who is in his 30s.

Already, over 3,500 volunteers have registered themselves for the trial at AIIMS since last Saturday, of whom the screening of at least 22 people is underway, said Dr Sanjay Rai, Professor at the Centre for Community Medicine at AIIMS and the principal investigator of the study.

"The first volunteer, a resident of Delhi, was screened two days ago and

all his health parameters were found to be within the normal range. He also does not have any co-morbid conditions. "The first dose of 0.5 ml intramuscular injection was given to him around 1.30 pm. No immediate side-effects have been observed so far. He was under observation for two hours and will be monitored for the next seven days,'

Few more participants would be given the vaccine on Saturday after their screening reports come. AIIMS-Delhi is among the 12 sites selected by the Indian Council for Medical Research (ICMR) for conducting phase I and II randomised, doubleblind, placebo-controlled clinical trials of Covaxin.



In phase I, the vaccine would be tested on 375 volunteers and the maximum of 100 of them would be from AIIMS. The second phase would include around 750 volunteers from all 12 sites together, Rai said. Phase I of the vaccine trial will be done on healthy people aged 18-55 years having no co-morbid conditions. Women with no pregnancy will also be selected to be a part of the trial in the first phase.

In the second phase, 750 people will be recruited between 12-65 years, AIIMS Director Dr Randeep Guleria had said. Already, around 1,800 volunteers have registered themselves for the trial at AIIMS, he had said.

"In the first phase we see the

safety of the vaccine which is of primary importance and the dose

range is also calculated," he said. There are three formulations of the vaccine, and each subject will be given any one of the formulation in two doses two weeks apart. The first 50 will get the lowest strength dose of the vaccine. If it is found to be safe in them, then it will be given to another 50 patients in high doses, according to Rai.

COVID-19 vaccine candidate Covaxin, developed by the Hyderabad-based Bharat Biotech in collaboration with the ICMR and the National Institute of Virology (NIV), had recently got the nod forhuman clinical trials from the Drugs Controller General of India (DCGI).

IAF draws roadmap for enhancing aerial prowess

New Delhi, July 24: At the end of a three-day brainstorming conclave, top commanders of the Indian Air Force Friday drew up a broad roadmap for next 10 years to significantly enhance the country's aerial prowess to confront emerging threats including from the adversaries on the northern and western fronts, officials said.

The IAF commanders held detailed deliberations on the border row with China in eastern Ladakh, key short-term and long-term security challenges facing the nation and on the complex geo-political power play in India's neighbourhood, they said.

In his closing remarks, Chief of Air Staff Air Chief Marshal RKS Bhadauria emphasised on the need for rapid capacity building, increase in serviceability of all assets and dedicated work towards effective integration of new technologies in the "shortest timeframes".

An IAF spokesperson said the Chief of Air Staff talked about the vision 2030 for the force and laid down milestones for transforming it in the coming decade. He stated that it was important to recognise the nature of emerging threats in a rapidly changing world. The official said the commanders held a series of discussions and carried out reviews on operational preparedness and strategies for countering se-



curity threats envisaged across the entire spectrum.

"They discussed the current situation and thereafter carried out a thorough review of the IAF's transformation roadmap for the next decade," spokesperson said. In his address on the opening day of the conclave, Defence Minister Rajnath Singh complimented the IAF for its rapid deployment of assests at forward locations in responding to the border row with China, saving its Balakot strike and the current combat readiness have sent a strong message to the "adversaries"

Chief of Defence Staff Gen Bipin Rawat, Chief of the Naval Staff Admiral Karambir Singh and Chief of the Army Staff Gen MM Narayane too addressed the conference and interacted with the commanders as well as the principal staff officers (PSOs) at Air headquarters.

The interactions covered a wide range of subjects including ways to ensure of jointness and ensuring integrated war fighting. The spokesperson said the IAF chief underlined the need for work on the IAF's long term goals for building sustainable capability, employment of niche technologies and development of indigenous platforms and weapons.

"The chief stated that since human resource was the most valuable asset of the IAF, recruitment, training and motivation strategies should keep pace with the changing times," he said. Officials said the commanders also deliberate on deployment of first batch of around six Rafale jets in the Ladakh sector by early next month as the aircraft are set to join the IAF's fighter fleet by July 29.

Kidnapped Kanpur lab techie killed: Cops The man's family claimed

Five people, including a woman and two friends of S Yadav, were arrested in connection with the case, the police said. Five people including a woman and two friends of the deceased have been arrested in the case so far, the SSP said.

The SSP said several police teams, including crime branch and surveillance, have been directed to find the victim's body and arrest all those involved in the crime, the SSP said. Efforts are also being made to trace the victim's motorcycle and mobile phone which have been missing since he was kidnapped, the SSP said.

The family had earlier appeared before the media and claimed that they had thrown a bag containing ₹30 lakh from a flyover to railway tracks in the presence of police and also did whatever the kidnappers demanded, but the accused did not free the victim. Circle Officer Vikas Pandey said that no ransom money was paid for his release in the presence of police and the allegation was not true.

Delhi minor held for smuggling

One of the accused has been identified as Imran, 23, who is a tailor in Kailashpuri area, but originally belongs to Hooghly. West Bengal. The second accused is Seema, 21, who is a school dropout and is the friend of the minor.

"Seema and Imran claimed that they do not know each other, but had a mutual contact, identified as Rahul, who lives in Delhi. For every successful delivery of the cannabis consignment from Rajahmundry via Visakhapatnam to the national capital, the individual was paid ₹5,000 to ₹15,000," a GRP official said.

Covid: Fatality rate at 2.38%; recovery 63.45%

New Delhi, July 24: For the third day in a row, the number of COVID-19 recoveries in a 24-hour span saw another record high, with 34,602 patients having recuperated pushing the recovery rate to 63.45 per cent, the Union health ministry said Friday. The case fatality rate has further declined to 2.38 per cent, it said. According to data updated at 8 am, the total recoveries have climbed to 8, 17,208, while there are 4.40.135 active cases of coronavirus in the country at present, the ministry said as the COVID-19 tally surged to 12.87 lakh. India also saw a record single-day

spike of 49,310 cases while the deathtoll mounted to 30.601 with 740 new fatalities, the data said. The ministry said as a result of constantly growing number of recoveries, the recovered patients outnumber the active cases by 3, 77,073. "This difference is showing a progressively growing upward trend.

Further, a cumulative total of 1, 54, 28,170 samples have been tested for COVID-19 up to July 23. On Thursday, 3, 52,801 samples were tested. "This translates to 11179.83 tests per million (TPM) for India, which has seen a steady increase since the adoption of the 'test, track and treat' strategy," the ministry

The rise in TPM has been achieved with a steady rise in the number of labs (1290 so far), and efforts by the Centre and state governments and union territory administrations to facilitate wide-spread testing through an array of options, it


However, this order is not applicable on those shops which are located within containment zones. UP started implementing restrictions over weekends, from July 10 in view of the rising number of Corona cases in the state.

Migrant labourer sells newborn to make ends meet

Kokrajhar (Assam), July 24: Driven by extreme poverty and lack of work during the COVID-19 crisis, a migrant labourer in Assam sold his 15-day-old daughter for ₹45,000 but police rescued the baby, officials said Friday.

The man and two women have been arrested on the charge of human trafficking. Dipak Brahma, a resident of Dhantola Mandaria, a forest village in Kokrajhar district, had recently returned from Guiarat, where he worked as a labourer. He was jobless and find-



ing it hard to support his family, according to an official of an NGO working against human traffick

After his return, the family started living at the house of his in-laws in Kochugaon Patakata village in the same district. The family still lived

a hand-to-mouth existence, neighbours said. During these tough times, Brahma's wife gave birth to the girl, their second daughter. Their elder daughter is a year old, Nedan Foundation Chairman Digambar Narzary said.

"Brahma tried to find a job during the pandemic but it was hard to come by. With almost all doors to earn a living closed, Brahma decided to sell the newborn," he added. The man sold his daughter to two women for just ₹45,000 on July 2 but kept his wife in dark, Narzary said.

Brahma's wife and villagers lodged a complaint at Kochugaon po-

lice station after they came to know about it later. "On receiving the complaint, police swung into action and rescued the baby from the two sisters. We also arrested the man (Brahma)," police said.

During interrogation, the two women claimed that they had bought the baby for a childless couple related to them. "We are really thankful to the police for rescuing the baby. But the issue is of very serious nature. Because of the lockdown, poor people do not have any work. The situation is getting worse for those living in forest villages." Narzary said.

Lakhs of labourers returned to

their homes in Assam from large cities outside the state after they became jobless during the lockdown. Though the state government had announced that it will create job opportunities for them through various initiatives, including under the Mahatma Gandhi National Rural Employment Guarantee Act (MGN-REGA), the COVID-19 outbreak has badly hit most economic activities in the state. People are facing the double whammy of the pandemic and floods which have created havoc in the state. A total of 28.32 lakh people in-26 of the state's 33 districts have been affected by the deluge.

Wildfires rage in Arctic, sea ice melts

Geneva, July 24: The UN weather agency warned Friday that average temperatures in Siberia were 10 degrees Celsius (18 Fahrenheit) above average last month, a spate of exceptional heat that has fanned devastating fires in the Arctic Circle and contributed to a rapid depletion in ice sea off Russia's Arctic coast.

"The Arctic is heating more than twice as fast as the global average, impacting local populations and ecosystems and with global repercussions," World Meteorological Organisation Secretary-General Petteri Taalas



noted that Earth's poles influence weather conditions far away, where hundreds of millions of people live. WMO previously cited a reading of 38 Celsius in the Russian town of Verkhoyansk June 20, which the agency has been seeking to verify as a possible recordhigh temperature in the Arctic

Circle. It comes as fires have swept through the region, with satellite imagery showing the breadth of the area surface.

The agency says the extended heat is linked to a large "blocking pressure system" and northward swing of the jet stream that has injected warm air into

WHO chief scientist sees no coronavirus herd immunity yet

Herd immunity is usually achieved through vaccination and occurs when most of a population is immune to a disease, blocking its continued spread

London, July 24: The chief scientist of the WHO, Dr Soumya Swaminathan, Friday warned that the concept of "herd immunity", or a large section of the population developing antibodies against COVID-19, is still a long way off and can be sped up by a vaccine.

In a social media live event organised by the World Health Organisation from Geneva, the scientist said that more waves of the infection would be required to get to a stage of natural immunity.

Therefore, she warned, that at least for the next year or so, the world needs to be "geared up" to do

everything possible to keep the novel coronavirus at bay while sci entists work on vaccines.

Meanwhile, therapeutics will help keep death rates low and allow people to get on with their "For this concept of herd immunity, you need 50 to 60 per cent of the population to have this immunity to be actually able to break those chains of transmission," explained Swaminathan.

'That's much easier to do with a vaccine; we can achieve it faster and without people getting sick and dying. So, it is much better to do it that way, to achieve herd immunity through natural infection. We would have several waves [of infection] and unfor-



"Concerted efforts have been made in recent years, in India, to strengthen the business climate and encourage investment in trade, and these have helped to attract investment and improve the current account financing mix and also help to contain external vulnerabilities," Rice told reporters at a news conference here.

"Relevant reforms have included the new bankruptcy code, the National Goods and Services Tax. These have helped to gain in India's doing business ranking, moving up rapidly in the World Bank's Ease of Doing Business index, up to 63 in 2020, from 100 in 2018, significant progress there, indeed," Rice said.



"Nonetheless, further economic reforms, including labour, product mixed land, and others, and additional infrastructure investments are necessary, in our view, to attract even more investment, and to ensure sustainable and more inclusive growth in India," he said in response to the question

Recently, the IMF in its update to the World Economic Outlook projected India's growth rate at -4.5 per cent, and then six per cent recovery, for the fiscal year 2020-21 and fiscal year 2020-22, respectively, he said.

"Our projection for fiscal year '20-2021 was revised down, as was the case for most countries driven by the impact of the pandemic,' Rice said. "On balance, I think we would say the risks to the economic outlook remain," he said.

Despite gradual recovery in activities and a solid agricultural performance, the downside risks remain. "The main downside risk is, of course, the continued spread of the pandemic," he noted, referring to the coronavirus pandemic.

"Further outbreaks could require additional lockdowns, and concerns about the virus could also dampen consumer confidence and delay the economic recovery. Again, this is the case not just in India, but in many countries. Rice said.

Apex court notice to Centre over plea on 'country of origin'

New Delhi, July 24: The Supreme Court Friday issued a notice in a petition seeking direction to the Union government to formulate policies to ensure that e-commerce companies must disclose the 'country of origin' of the products on their sites.

The Bench headed by CJI SA Bobde and comprising justices AS Bopanna and V Ramasubramanian sought Union government's response in the plea filed by Advocate Divya Jyoti Singh.

In his petition, Singh sought for the 'country of origin' for products, should be made available to customers so that a decision can be made. The petitioner challenged that a wave of anti-Chinese sentiment is flowing in the country and that people have been boycotting Chinese products since the Indo-Chinese military standoff at Galwan Valley. Ecommerce companies like Amazon and Flipkart, by not revealing the 'Country of Origin' on their web-portals, are playing with the nationalistic sentiments of Indians. This, in a way is creating hindrance in promoting the local manufacturers and brands; as called for by Prime Minister



Narendra Modi, in his efforts towards making India 'self-reliant' (Atmanirbhar Bharat) which is the need of the hour. The petition has been filed in

the Supreme Court with an aim to further fuel the anti-Chinese movement. The petitioner said that revealing the 'country of origin' for products will help in boycotting Chinese goods.

Singh also called for an amendment to the Section 2(9) of the Consumer Protection Act which states that a consumer's rights include "the right to be informed about the quality, quantity, potency, purity, standard and price of goods, products or services, as the case may be, so as to protect the consumer against unfair trade practices."

He urged that the Consumer Protection Act to include the right of a consumer to know the 'Country of Origin' in the e-commerce portals.

Mumbai, July 24: Gross non-performing assets of all banks may jump to 12.5% by the end of this fiscal under the baseline scenario, from 8.5% in March 2020, according to the Financial Stability Report (FSR) released by the Reserve Bank of India (RBI) Friday. The resilience of Indian banking

"The stress tests indicate that the GNPA ratio of all scheduled commercial banks (SCBs) may increase from 8.5% in March 2020 to 12.5% by March 2021 under the baseline scenario. "If the macroeconomic environment worsens further, the ratio may escalate to 14.7% under the very severely stressed scenario," the report showed.

The baseline scenario is derived from the forecasted values of macroeconomic variables such as GDP growth, combined gross fiscal deficitto-GDP ratio and CPI inflation

US-China conflict to impair global trade: Ex-RBI Guv

New York, July 24: As the US presidential election draws near, the conflict between America and China will escalate, impairing global trade which is "extremely important" for emerging markets like India and Brazil that are reopening amidst COVID-19 pandemic, according to former RBI Governor Raghuram Rajan.

Cautioning that there will be "deeply damaged firms" in the economy, Rajan said the post-pandemic recovery has to be accompanied by a process of repair.

"This creates an enormous amount of uncertainty because businesses don't know whether there'll be fresh lockdowns and how difficult they will be. Some states in the US are talking about fresh lockdowns, some states in India are talking about lockdowns and have actually sort of implemented some of those right now," he said. Rajan also spoke about some of the trends that may emerge post-pandemic.

SACHIN, SHASTRI TIPS 'TRANSFORMED' VIRAT

New Delhi, July 24: The lesson of 'forward press against fast bowlers' from Sachin Tendulkar and a tip from head coach Ravi Shastri to stand outside the crease led to his transformation as a prolific Test batsman after a disastrous England tour in 2014, feels India captain Virat Kohli.

Kohli had a nightmare of an England tour where he failed in 10 successive innings but came back later in the year against Australia scoring four tons in four games, including two in Adelaide.

In a chat with Mayank Agarwal for 'bcci.tv', the Indian skipper decoded his technical changes post that England tour. "The 2014 (tour) will be a milestone in my career. Lots of people take good tours as a milestone in their careers but for me 2014 will be a milestone," Kohli told Agarwal in the show 'Open Nets with Mayank'.

"I came back from England and spoke to Sachin Paaji and had a few sessions with him in Mumbai. I told him that I am working on my hip position. He made me realise the importance of big stride, a forward press against fast bowlers," Kohli explained.

"The moment I started doing that with my hip alignment, things started falling in place nicely and then the Australia tour happened," said Kohli.

He explained what went wrong in England and how he realised it. "My hip position was an issue during that England tour. It was basically not adjusting to the conditions and doing what I wanted to do. So being rigid doesn't take you anywhere. It was a long and painful realization but I realized it," he said.

The opening of hip limited his shot making ability, Kohli realized. "One thing stood out, right hip opens or closes too much you now you are in trouble. Keep that hip po-

sition nice and side-on and bal-

control is very important," he said.

Anderson was taking him out mainly with outgoing deliveries. "I was too worried thinking about the ball that might come in. I was opening up a bit too early so the ball that was going away I was getting out to it every time. I just couldn't get past

There was another interesting little chat with Shastri which was an example of Kohli's determination. "Ravi bhai asked me that if I was scared of short ball," Kohli laughed. "I said I am not scared and I don't mind getting hurt but I don't want to get out," the India skipper added.

England stumble to 131/4 at tea

The England midfielder also played an important role behind the scenes during the suspension of the league during the pandemic, leading an initiative that saw players team up with a charity to raise money for the National Health Service.

Fabinho's home burglarised while Reds celebrating title

Liverpool, July 24: The home of Liverpool midfielder Fabinho was burglarised while he and his teammates celebrated their Premier League title.

The burglary occurred in the town of Formby, north of the city, either late Wednesday or early Thursday while Liverpool hosted Chelsea, Merseyside police said.

Jewelry and an Audi RS6 were stolen, although the car was later recovered 20 miles away in Wigan, police said. The occupants discovered the burglary when they returned home early Thursday.

Police said they are collecting security footage and have forensically examined the 26-year-old Brazil international's home and car.

Liverpool beat Chelsea 5-3 at Anfield — their final home game of the season — before lifting the Premier League trophy to end a 30-year title drought. The team had clinched to title with seven games

Nine of the estimated 3,000 fans who gathered outside the stadium were arrested on charges ranging from assault to disorderly conduct,

police said Thursday.

Fans were urged to stay home because of the coronavirus pandemic. Police said the "vast majority of the crowd were good natured and had dispersed by 2 am."

Fabinho is the latest star athlete to be victimized. Tottenham player Deli Alli was held at knifepoint by burglars who stole jewelry from his London home during coronavirus lockdown in May.
