
#### **BSE Class X exam** results by July 31

CUTTACK: The results of the annual Matriculation examination conducted by the Board of Secondary Education (BSE) in Odisha for Class X is likely to be published by the end of this month. a senior official said Saturday.

"The exact date and time of the publication of results would be announced in a day or two," said BSE President Ramshis Hazra here Saturday. The results will be uploaded in the board's official website www.bseodisha.nic.in. sources said.

Around 5.6 lakh candidates appeared for the examinations held in February and March.

After completion of the examinations March 2, evaluation of answer sheets had begun from March 18. However, it was stopped after two days following the outbreak of Covid-19.

#### **ODISHA RECORDS** 10 DEATHS, 1,320 **NEW CASES**

BHUBANESWAR: Odisha reported 10 more Covid-19 deaths, highest in a single day, taking the state's total death toll to 130, informed the health department Saturday.

The deaths have been reported from Ganjam (3), Balasore (2), Sundargarh (2), Rayagada (1), Jharsuguda (1) and Gajapati (1) districts. The positive tally also mounted to 24,013 with a huge spike of 1,320 new cases in the last 24 hours.

While 887 cases have been reported from different hotspot areas, the remaining 433 are local contacts, said the department.

Hotspot Ganjam district recorded 560 cases followed by Khurdha (174), Gajapati (90), Puri (90) and Rayagada (65).

The number of active cases in the state rose to 8,650 while 15,200 patients have recovered so far.

New Delhi/ Bhubaneswar, July 25: Though the scientific minds are working 24/7, toiling hard, to develop a vaccine for the Covid-19, it seems the microbial forces are nowhere retreating.

A Reuters' analysis shows: countries where officials eased social distancing lockdowns are experiencing a second peak more than a month after recording their first.

In India, 48,916 fresh cases were reported Saturday after 49,310 Friday taking the total to 98,226 – touching almost a lakh in less than two days. In the last 24 hours, 787 people succumbed to the deadly virus, as there is a huge surge in cases in the hinterlands.

According to the latest data available on the website of the Ministry of Health and Family Welfare, total number of cases in India reached 13,36,861 of which 31,388 people have lost their lives while 8.49.432 have recovered. The total number of active cases are 4.56.071 cases.

New Delhi/Bhubaneswar, July 25: Oil companies Saturday increased the price of diesel by 15 paise per litre. Diesel now costs ₹79.93 in Bhubaneswar.

The hike comes after a gap of four days. Diesel price was last hiked by 12 paise Monday, July 20.

The price of a litre of diesel is now inching towards ₹82-mark in the national capital. It now stands at ₹81.79 per litre. It has now increased the gap with the price of petrol by ₹1.36 per litre in Delhi.

Petrol price has remained stable since June 29 when PETROL- **₹80.99** (no change) (IN BHUBANESWAR)

# Pak Air Force conducts drills in Gilgit-Baltistan

Speculations are rife in Pakistan and China that the two allies may attack India from two fronts – J&K and Ladakh, respectively

New Delhi/Gilgit, July 25: As the India-China face-off along the Line of Actual chief claimed that India was making mas-Control (LAC) in Ladakh remains unresolved; Pakistan is carrying out military exercises at its air force base at Qadri in Skardu of occupied Gilgit-Baltistan region.

Top official sources told IANS that Pakistan's Chief of Air Staff, Air Chief Marshal Mujahid Anwar Khan visited the base Friday to hold some important meetings and oversee the military ex-

However, Pakistan's state radio claimed that Khan visited PAF Base Qadri at Skardu in Gilgit-Baltistan Saturday and not Friday. "The Air Chief witnessed various operational activities at the base including rapid deployment of fighter aircraft and combat support elements. He was also briefed about the ongoing development works at the base," Pakistan radio said.







# In pursuit of fat-pay job, City man loses ₹20L to fraudsters

Bhubaneswar, July 25: Cocking a snook on cyber security, the tricksters have duped a general manager (GM) of a big company of more than Rs 20 lakh on the pretext of providing him a better job.

There is a surfeit in cybercrime cases amidst the pandemic which has turned a headache for the Odisha Police. The crooks have been following different tactics like online sale of liquor, expiry of Paytm KYC to trick the gullible netizens into their trap.

Sources said the victim, identified as Pankaj Kumar Das, 52, is a resident of KIIT Square at Patia under Infocity police limits here. The complainant is currently employed as the GM of a big company. Recently, unknown fraudsters have duped him of Rs 20 lakh on the pretext of availing him a high-paying job in a reputed multinational company. Das was dissatisfied with his job and had started searching for a better opportunity like vice president or chief executive officer (CEO) in a reputed company.

Eventually, he found a website www.reccruitmentzone.in and registered with the site by submitting all the educational and job experiences related documents. Subsequently, the accused persons identified as Uday Shankar, Arav Raghuvansmi, Dinesh Nair, Prakash Mehra and Ayat Quereshi contacted Das claiming them-

After receiving Rs 20, 30, 000 from Das, the cyber crooks ignored his phone calls and

also stopped making any contact

Das sought the help of Infocity police who asked him to approach cyber police station at the police headquarters in Cuttack.

Additional director general (ADG), Crime Branch, Soumendra Privadarshi said, "I am aware of online job fraud cases during the pandemic. We have been seriously investigating into the cases. The fraudsters have been operating outside the state and country too. Cybercrime cases have increased manifold during the pandemic and we will shortly begin awareness drive to aware people about

Bhubaneswar, July 25: With the schools remaining shut till end of August in view of Covid-19 pandemic, the state government has decided to distribute food security allowances to students covered under Mid Day Meal (MDM) scheme till August end.

School and Mass Education (S&ME) department has asked the MDM state nodal officer to provide food security allowance including dry ration and cooking cost for 57 days starting from June 14 to August 31, 2020, to the eligible students. Earlier, the government had distributed such allowance to the school students for the March 16-June 13 period.

"While headmasters of schools will look after the distribution of rice to the students, payment of cook-

ing cost for the 57 days will be transferred to their parents' or guardians' bank accounts," the letter read.

The government has also asked the headmasters to explore options to sell the MDM rice to quarantine centres at Rs 32 per kg and deposit the money with the District Education Officer (DEO)

In case of schools having MDM

rice for more than 57 days, the excess rice will be diverted to the nearby schools having deficit MDM rice.

As the school buildings were being used as quarantine centres, the government instructed the concern officials to sanitise the vacated building and use it as a distribution centre of food security allowance.

In case the building has not been vacated so far, proper arrangements should be made to take away the MDM rice to the nearby school or community centre and use the same as food security allowance distribution centre, the department said.

The government further instructed the officials to follow all Covid-19 safety norms like face masking, hand sanitising, social distancing during the transportation and dry ration rice distribution.

# State Covid tally tops 24K-mark; toll 130

Bhubaneswar, July 25: Odisha's COVID-19 tally crossed 24,000 Saturday as 1,320 more people tested positive for the disease, while the death toll rose to 130 with a record single-day spike of 10 fatalities, a health department official said.

Three out of the 10 new fatalities were from Ganjam, the worst-hit district by the pandemic, two each from Balasore and Sundargarh, and one death each was reported from Gajapati, Jharsuguda and Rayagada, he said.

"Ten people, including a woman, died due to COVID-19 while undergoing treatment in hospitals. This is the highest single-day spike in the death toll. Six of them had comorbidities. The deceased were aged between 30 and 61," the health official said.

With 1,320 new cases, the total number of infections rose to 24,013, he said. A total of 887 new patients have been detected in different quarantine centres, while 433 were found through contact-tracing exercises, the official said.

There has been a steep rise in the death toll during the current month, as the number of fatalities due to

the coronavirus infection was at 25 by the end of June, he said.

#### **Two separate test** reports spark fear

Buguda: Two separate test reports of a man on Covid-19 infection have sparked consternation among the residents here in Ganjam district, Saturday. Reports said Brahmachari Bisoyi, residing on Main Road in Buguda, got himself tested for coronavirus fever. He visited the testing centre at Buguda People's College and got himself tested for the virus July 16. The next day he visited Bhubaneswar and got himself tested for the virus at KIMS hospital after his fever failed to recede. However, he was surprised after he received two different test reports Saturday. In the reports he received at Buguda he was pronounced positive while the report received from KIMS hospital declared him negative.

# 'Israel's real time Covid screening to aid India'

Bhubaneswar, July 25: Experts here claimed that technologies developed by Israeli scientists to carry out real time screening of COVID-19 could empower the country and the state in faster testing of the pandemic. They include four breakthrough technologies. Two are related to tests which use saliva samples (using polymine acids and inexpensive biochemical isothermal testing) to screen

# Locals allege admin apathy towards Covid-hit areas

Angul, July 25: The district administration allegedly is not showing as much interest to attend to Covid-19 cases in local areas as it is showing in district headquarters. This allegation was leveled by town dwellers.

According to locals, a couple from Hemasurapada tested positive a few days ago. Between their test and the arrival of the report, they had visited many local areas and came in contact with several people.

After coming to know that the couple was infected, the administration must have taken immediate steps to disinfect the area. But that did not happen, locals alleged, adding that the administration does not hesitate to take efficient measures in case staff of any office tests

There are many areas like Hemasurapada that recently reported positive cases including Amalapada and Gujuratipada in Angul town, Sanatibrida and Arkil panchayat of Kaniha block, Chhendipada and Machhakuta area of Chhendipada block, areas on Nalco's outskirts in Banarpal block and Paikasahi and Thakurgarh panchayat of Athmallick block.

Patients infected with coronavirus were detected from these areas but the administration did not take steps to sanitise the areas, increasing the fear of local transmission. As a result the residents are constantly in a state of panic.

A fire department official on the condition of anonymity said, "We can't go on our own to any area to sanitise them. We are visiting the areas or offices as per the direction of the district administration."

A BJP leader here, Pratap Chandra Pradhan, also alleged that the administration is not taking any steps to sanitise the areas that report positive cases.



Similarly, district Congress president, Biplab Jena said, "The district administration not taking steps to sanitise affected areas is indeed a cause of concern. We will take the matter up with the district collector. And at the same time the sarpanchs can also take steps by utllising the collector's power conferred upon them."

District Collector Manoj Kumar Mohanty was not available for his comments in this regard.

Neighbouring Pakistan has appeared to flatten its curve of growth in positive cases. It has fallen consistently from a high of 6800 cases on June 14 to 4000 cases on June 28 to 1200 cases on July 24. India has gone from 11,000 cases on June 14 to 20,000 cases on June 28 to almost 49,000 cases on July 24. Till about a short time ago, Pakistan had half the number of cases as India though their population is only a fifth of ours. Now they seem to have got things under control in a way that India has not. Cases in Bangladesh have also been dropping in the same period. Having made his grand announcement, Modi has moved on. The announcement that he was most enthusiastic about, the 8 pm bombshell of November 8, 2016 has gutted the Indian economy. The government has tried to hide its damage by fudging GDP data. Two weeks ago, the former Reserve Bank of India Governor C Rangarajan said that the government should end the controversy over its

manner of calculating GDP. This government's former economic advisor Arvind Subramanian himself has calculated that India is reporting 2.5 per cent higher GDP growth figures than actual ones. A report in Mint on Saturday said that all economic indicators showed

that the government was bluffing. Growth in factory output has fallen from 9 per cent before 2011 to 2 per cent. The Modi government's own National Sample Survey showed that rural consumption grew at minus 1.5 per cent, meaning it actually declined in the Modi years. Even urban consumption fell from 3.4 per cent to 0.3 per cent.

Corporate investments went from 23 per cent growth to minus 1.8 per cent. Bank credit growth fell from 14 per cent to 4 per cent, but the GDP growth figures remain the same: 7 per cent before Modi and 7 per cent after, which is unbelievable given all the other data. Unemployment remains at levels it has never touched in history, over 8 per cent. On Friday the RBI said that non-performing assets with banks (meaning dud loans) would rise from the current 8.5 per cent to 12.5 per cent by March and perhaps even higher.

The finance minister keeps babbling on about seeing green shoots in the economy, a phrase meaning that there are signs of life. Nobody believes her of course or takes her seriously

Having made his grand announcement on Make in India, Modi has lost interest there as well. Manufacturing share of GDP in India has fallen from 15 per cent before the announcement to 14 per cent after. Vietnam and Bangladesh have gone up in this time.

Other than announcements it has to figure what this government is good at doing. The Citizenship Amendment Act was passed with great bombast about how Modi would protect the persecuted minorities of South Asia. But the Act's rules have still not been written by the government meaning it is not in force and cannot protect anyone.

On the frontier with China, there is trouble. But Modi has solved it with a stirring speech delivered from Ladakh. There is no action after that. By October, the passes that we use to supply that area will be snowed in. Our soldiers, some 2 lakh of them now, will have to manage without proper habitats. The Chinese built habitats for their forces in the last three years after the incident at Doklam, which Modi took lightly. The Chinese are sitting on our territory and pointing out to Modi's own statements where he says there is no intrusion, as proof that they are right and we are wrong. What was the need to make that statement? It is not clear, but he has moved on from there to the next exciting thing.

I look forward to his speech next week. It will be entertaining and stirring and make lots of promises that he most likely will not be able to keep. But at least he can guarantee us more speeches and announcements.

#### Swashbuckling

swashbuckler these days is somebody who engages in romantic and Adaring piratical adventures with ostentatious flamboyance. People who have fun with the word, as a writer in the Guardian did recently, usually talk about some film hero buckling his swash. A nice try, but there's no verb buckle hidden in it — the verbal bit is actually swash. You should really say that the hero swashes his buckler, but it's not as good a joke.A member of this breed centuries ago actually did little more than that. A buckler was a type of small shield, held by a handle at the back, whose main purpose was to deflect blows from the sword of one's opponent. Its name is from Old French (escu) bocler, literally "(a shield) with a boss" (this last word, for a protrusion at the centre of something, is itself from French). Someone who swashes is dashing about violently or lashing out with his sword, often in pretend fights. It seems to have been an echoic term from the sound of swords clashing or banging on shields. In the sixteenth century swashbuckler was created from these two words to convey the idea of a swaggering, bullying ruffian or undisciplined lout, who made a lot of noise but to little practical purpose.

# **CASE FOR CIRCULAR ECONOMY**





IN RECENT TIMES, **IT HAS BECOME INCREASINGLY CLEAR THAT A FREE MARKET-DRIVEN OPEN-ENDED GROWTH MODEL IS UNSUSTAINABLE AND IS THE PRIMARY DRIVER OF GLOBAL HEATING LEADING TO THE ECOLOGICAL BREAKDOWN AND CLIMATE CRISIS** 

ahatma Gandhi said almost seventy-five years ago - "Earth provides enough to satisfy every man's need, but not every man's greed." This was at a time when the world was not vet faced with the threat of sixth mass extinction. Gandhi was driven by the idea of Leo Tolstoy (The Kingdom of God is Within You) and John Ruskin (Unto This Last) who were deeply affected by the allpervasive inequalities in human existence leading to untold miseries. They were inspired by spirituality in a deeply secular non-religious sense as was Gandhi.

The Nobel prize-winning economist Milton Friedman famously said - "The only corporate social responsibility a company has is to maximise its profits." When such an approach drives much of the capitalist world's business, the natural outcome is a greed-driven, consumerist society that results in fast depletion of natural resources, pollution, environmental degradation, and eventually the accumulated damage that has brought humanity to the verge of extinction. Such an economic model has been based on the so-called linear economy comprising of 'Take, Make, Use, and Dispose'. In such a model, the true cost of goods and services is hidden due to a lack of accounting for the cost of pollution caused to the air, water, land, and sea as well as the remaining value of the product when discarded.

The idea of Circular Economy (CE) goes back to the nineteen sixties when the concept of the open economy, as opposed to the closed economy, was talked about by Kenneth Boulding. The use and throw model of the 'Linear Economy' was replaced by 'Make, Use and Re-use' model for the first time in the report by Walter Stahel and Genevieve Reday for European Commission in 1976. The best way to understand what CE is by examining a real-life case study. Take lighting for instance. It has always been known that a light bulb could be designed to last a lifetime but was never profitable to do so for obvious reasons. However, the current trend is to lease lighting as a service rather than lights as a product which is phrased by the light-

ing company Phillips as - 'Circular Lighting'. Such an approach vastly reduces the huge amount of discarded lights from going to landfill. It incentivises the manufacturer to build the product to last as long as possible, design it for easy re-cycling and also take responsibility for the entire life cycle of the product. Apple is another good example. The company announced in 2017 that they will be making all new iPhones, iMacs, and other products from 100 per cent recycled materials. The company has been known for collecting back all its products at the time of an upgrade.

Modern lifestyle dependent on the linear or open industrial processes, uses finite natural resources to create products with a limited service life, that finally end up in landfills or in incinerators. On the other hand, CE is inspired by living systems like organisms that process nutrients that can eventually be fed back into the production cycle. Bio-mimicry, 'cradle to cradle' instead of 'cradle to grave', closed-loop, or regenerative are some of the other terms usually associated with it. The World Economic Forum, World Resources Institute, Philips, Ellen MacArthur Foundation, United Nations Environment Programme, and 40 other partners launched the Platform for Accelerating the Circular Economy (PACE) in the year 2018 to scale up circular economy innovations. Global corporations like IKEA, Coca-Cola, Alphabet Inc., and DSM (company), along with governments of Denmark, The Netherlands, Finland, Rwanda, UAE, China are members of PACE. The British Standards Institution (BSI) developed and published the first standard for CE - "BS 8001:2017 Framework for implementing the principles of the circular economy in organisations" in 2016. A report by McKinsev titled "Towards the Circular Economy: Economic and Business Rationale for an Accelerated Transition" has identified the potential for significant benefits across the EU including net materials cost savings worth up to \$630 billion annually only in the manufacturing sector. Most importantly, CE can contribute to meeting the emission reduction goals of COP 21 Paris Agreement. Since, greenhouse gas reduction commitments made by signatory countries, are not sufficient to limit global warming to 1.5 degree C, it is estimated that half of the additional emissions reductions of 15 billion tonnes CO2 per year needed can be delivered by CE.

While CE can serve as a great model for a progressive economic and business framework, the world needs a broader approach that integrates complex socio-political ideologies that often drives the preference of economic models. In recent times, it has become increasingly clear that a free market-

driven open-ended growth model is unsustainable and is the primary driver of global heating leading to the ecological breakdown and climate crisis. In 2012, Kate Raworth, a senior research associate at Oxford University, introduced the idea of a Doughnut economy in order to make human welfare the basis of economic policy rather than the all-pervading pursuit of growth in GDP. Economic welfare was defined as per the Sustainable Development Goals (SDGs) that provide for a set of minimum living standards by the United Nations that should be treated as a matter of right for every human being. She extended the basic circular flow of money and goods model of economics by adding the nine planetary boundaries on the outside and social boundary consisting of SDGs on the inside - thus forming the doughnut. In this model, the economic progress was to be measured in terms of the balance between human wellbeing and protection of life support systems provided by the planet, thus mitigating global warming, ecological breakdown, and climate change. Since its introduction, this post-growth economic thinking has attracted the attention of a range of actors ranging from the UN General Assembly to the Occupy London movement. As many communities, cities, states, and countries start re-examining prevalent strate gies and economic policies in light of the current pandemic, the doughnut model is being explored as an alternative and even adopted by cities like Amsterdam for its future.

Gandhi was a lifelong proponent of 'Gram Swaraj' or the 'village republic' which he discussed in his seminal book 'Hind Swaraj'. In it, he had promoted the idea of self-reliance and living within one's means and in harmony with nature. The ideas of CE and Doughnut model seem to be imbued in that spirit of each person taking only as much as required and organising society into self-sufficient communities with a deep concern for our planet.

# A Marshall Plan for planetary health

he pandemic has heightened awareness of significant flaws in our urban infrastructure, and highlighted our lack of attention to how human health, natural systems, and the built environment interact to determine planetary health. It is now clear our economic system increases food insecurity, our streets prioritise motorised traffic over physical exercise, and our houses increase the risk of disease transmission.

The near-universal focus on health prompted by the pandemic presents an opportunity to mobilise all sectors of society toward embracing proactive approaches to inclusive wellbeing. Building resilient and sustainable systems for health, particularly in the context of cities and urban development, will

be key in this regard. At best, the failure fully to address the adverse implications of today's built environments represents a missed opportunity to enable healthy communities. At worst, it actively contributes to disease risk and transmission. In the UK, for example, the higher COVID-19 mortality in poor people has illustrated the short-sightedness of housing policies that fail to place health and ecological considerations at their center. One positive feature of the current crisis has been the rapid adoption of innovative measures (including versions of universal income) to mitigate the pandemic's immediate economic impact. This shows that we can address systemic failures quickly when the will exists.

Likewise, we must radically reimagine our built environments so that they both strengthen the immediate pandemic response and serve as vehicles for improving long-term health. And while cities will be the primary testing ground for reforms to promote health and wellbeing, it will also be necessary to overhaul existing health governance systems.

Although global philanthropic initiatives have sought to improve urban health and resilience, undoubtedly with positive results, today's flawed systems need more fundamental disruption. Simply put, the world needs a new Marshall Plan for planetary health-akin to a New Deal for a postpandemic recovery. Such a scheme would require the agreement and participation of national and local governments, private developers, investors, and multilateral organisations, which will take time. Governments and private-sector actors will need to address three issues in particular. For starters, policymakers should not regard resilience only as an end result. Many of the shocks and stressors that drive acute and protracted health emergencies stem from intentional choices by local and global actors. Beyond adaptation to cope with these shocks and stressors, building resilience must therefore involve confronting the decisions that weaken systems by fostering ecological disruption and disease. In addition, policymakers must tackle the "problem blindness" that results from temporal and spatial distance between exposure to health risks and subsequent outcomes, especially for diseases with a long arc.

Finally, policymakers will need to address the "wrong pocket problem," whereby the sector benefiting from an intervention may not be the one that bears the cost of implementing it. This poses a challenge to promoting health through urban development, particularly in the context of siloed public-sector budgets, and will necessitate a redesign of health financing.

Alternatives to the current GDPbased approach to economic development already exist. Bhutan has developed a Gross National Happiness index to guide its policymakers, while the Wellbeing Economy Alliance advocates for a

wellbeing-based economic system and is being embraced by the governments of New Zealand, Iceland, Scotland, and Wales. But addressing the three issues noted above will require finance and investment in systems for health.

The devastating impact of COVID-19 has highlighted the urgent need for ambitious, all-encompassing reforms rather than incremental, piecemeal measures. A global Marshall Plan for planetary health would constitute a radical new approach, and would be an important step toward health-proofing the future of fast-growing cities. In addition to finance and investment from public and private sectors, it will require a social movement (led by the young) to drive the unremitting demand for a healthy post-COVID recovery, supported by research across the sciences, arts, and humanities. Preventing toxic decisions in urban planning and infrastructure development is essential to reduce vulnerability to disease, lessen the need for healthcare, and bring about better cities and better health for all.

# Highway plan altered to save 400-year-old banyan tree

Mumbai, July 25: Following a sustained campaign by villagers and support from Tourism Minister Aditya Thackeray, the Centre has bowed down to save a four-centuries old banyan tree and a crucial tiger corridor in Maharashtra from various developmental projects, officials said here Saturday.

Thackeray had written to Union Minister Nitin Gadkari, Union Environment Minister Prakash Javadekar and the Union Coal Ministry for the twin objectives of saving the old tree from a highway project in Western Maharashtra and a commercial mining project that would hit a tiger corridor in Vidarbha region.

The Union Coal Ministry was planning to auction the Bander coal mine in Tadoba Tiger Sanctuary, Chandrapur district, which would have destroyed



more than 1,200 hectares of prime forest land, plus the tiger corridor linking the reserve with sanctuaries in Wardha and Amravati districts.

Bowing to a plea by Aditya Thackeray, Chief Minister Uddhav Thackeray, Forest Minister Sanjay Rathod, former union minister Jairam Ramesh and others, July 21, the Centre said the Bander Coal Mine auction was withdrawn since the region (Bander) falls in an eco-sensitive zone declared by the Union Ministry of Environment. The massive banyan tree with a shady spread of over 400 sq. metres, standing beside the famed Yellamma Temple in Bhose village, Sangli district was threatened by the expansion of the Solapur-Sangli-Kolhapur-Ratnagiri Expressway.

The Yellamma Temple Trust, Bhose villagers and environmentalists led by Bandu Dhotre recently organised a protest by hugging the banyan tree and sought intervention of Aditya Thackeray in their mission.

Aditya Thackeray wrote a letter to Union Transport Minister Nitin Gadkari July 16, urging that the highway could be realigned to save the tree which is not only historical but also a natural home for many rare birds, mammals, monkeys and insects.

Last Wednesday, a team from National Highways Authority of India visited the spot for a survey and to discuss the issue in detail with Bhose villagers, the temple trustees and environmentalists.

NHAI officials concluded that it would not be necessary to cut off the banyan tree but trim its branches a bit for the highway to run beside without causing any obstructions to the traffic and realign the service road to save the tree.

In tweets on the two issues, Aditya
Thackeray expressed gratitude to the
central ministers and the CM and others for their gesture which had helped
save the tiger corridor and the banyan

tree in the state.

Last week, CM Uddhav Thackeray wrote to the Centre on the gauge conversion of the 176-km long Akola-Khandwa line passing through India's oldest Melghat Tiger Reserve, and sought a realignment of the project.

In late June, the state government issued a notification declaring 29.53 sq.km in Dodamarg sub-district of Sindhudurg as the Tillari Conservation Reserve which houses many wild animals and also is a tiger corridor for reserved in Maharashtra, Goa and Karnataka.

# WHY MAHA CM DOESN'T WANT TO LIFT LOCKDOWN

Mumbai, July 25: Maharashtra Chief Minister Uddhav Thackeray Saturday said that he was not in favour of complete lifting of the coronavirus-induced lockdown in the state only to address the economic concerns.

He said there was a need to strike a balance between the issues related to health and economy considering the challenge posed by the pandemic.

"I will never say that the lockdown will be lifted completely. But I have started reopening a few things gradually. Once reopened, it shouldn't be shut again. Hence, I prefer taking steps in phases. You can't just think about economy or health. There needs to be a balance between the two," he said.

Thackeray made this statement in an interview published in Shiv Sena mouthpiece 'Saamana' on Saturday.

After the assembly polls last year, the Shiv Sena, NCP and Congress came together to form

the government in the state.

Thackeray said the six-month period has been full of challenges like the coronavirus pandemic and Nisarga cyclone, which hit the coastal parts of the state on June

"I am not bothered about the political challenges. People have faith in me," he said.

Talking about the coronavirus situation in Mumbai, he said, "There was never a need to call the Army in Mumbai. I am proud of the administration which rose to the challenge and set up jumbo field hospitals for treatment of coronavirus patients in the city."

Speaking about the criticism that he has not been to the Mantralaya, the state secretariat, during the pandemic, the chief minister said that technology helps people in doing all the work and there was no need to travel.

"I can be at home and cover the entire state with help of technology and take quick decisions. I am not saying one shouldn't move out. But when you go

out, you are at one place only while through videoconference you can go everywhere," he said.

"I am not bothered what critics say till people trust me. I am honest with my work," he added.

On starting the pandemic, Thackeray said e-learning was the only option. When asked about Leader of Opposition Devendra Fadnavis's recent visit to Delhi, Thackeray said sarcastically that he might have gone there to take stock of the coronavirus situation in the national capital.

"He goes to Delhi and speaks about Maharashtra's COVID-19 situation since he has given his MLA funds in Delhi," the CM said in an apparent reference to BJP MLAs donating to PM Cares Fund and not to the Chief Minister's Relief Fund.

"Recently, a survey listed Maharashtra chief minister as the best CM in the country. This caused stomach pain to many," he said.

"Coronavirus has many symptoms. Stomach ache may be one of them. Loss of taste is also a symptom," he said sarcastically when he was asked if life has become tasteless for some since the MVA government came to power.

Thackeray also rejected the criticism that his government had hidden the number of coronavirus

"The WHO and Washington Post have taken note of the state government's efforts," he said.

# Is New Delhi re-negotiating with NC?

THAT DELHI IS KEEPING ITS 'HOTLINE' ALIVE WITH THE NC GAINS CREDENCE BY THE FACT THAT SO FAR IT HAS REMAINED IN ONE PIECE AND NONE OF ITS LEADERS HAS DESERTED THE PARTY

Srinagar, July 25: Although Assembly elections in Jammu and Kashmir are unlikely to be held any time soon, the lack of a powerful alternative to regional players is worrisome for supporters of "the new political dawn in Kashmir".

There had been talk of "a new political dawn in Kashmir" after the abrogation of Article 370. Badly bruised and battered, the two main regional political parties, the National Conference (NC) and the Peoples Democratic Party (PDP), initially seemed to have reached the end of their road after they failed to achieve any of their poll promises. The NC claimed it would get internal autonomy and the PDP promised self-rule. For Kashmiris, the two slogans were alike, but both promised to keep the already existing Articles 370 and 35A beyond negotiation. Instead of getting what they promised, the NC and the PDP were left dumbfounded when the state was bifurcated and down-

graded into two Union Territories and Articles 370 and 35A thrown into the dustbin by the Parliament.

The going could just not have been better for new faces with honest backgrounds and intentions to come forward and fill the void, while semi-separatism could no longer work as the separatists had already lost the plot. Those who

had joined or remained in the mainstream political camp by opposing the NC and the PDP had a future, or at least, believed that they had one.

Would Delhi be forced to re-negotiate its political terms with the NC without going back on Article 370's abrogation? Would grant of statehood be good enough for the NC to stand up to its promise of upholding the singularity of Kashmir in the eyes of its supporters? Both these look far-fetched, but politics has always been the art of the possible.

# J&K sees increase in COVID recovery rate

Jammu, July 25: The COVID-19 recovery rate in Jammu and Kashmir increased to 53.10 per cent while the positivity rate stood at 3 per cent as against the national average of 8.3 per cent, officials said Saturday.

The testing rate in the Union Territory has also improved to 44,744 sample examinations per million population as against the national average of 12,742, they said.

"The COVID-19 recovery rate in Jammu and Kashmir has touched 53.01 per cent in 20 days, starting from July 3 till July 23," an officer said.

He said coronavirus infection cases per million in the Union Territory stood at 1,339, though it is far low in Jammu division at 623 as against 1,899 in Kashmir division.

"The overall positivity rate in the Union Territory is 3 per cent as against 8.3 per cent in the country. It is 1.3 per cent in Jammu and 4.7 per cent in Kashmir," officer said.

Jammu and Reasi districts have recorded the lowest 0.8 positivity rate in the Union Territory, while south Kashmir's Shopian district has



witnessed the highest positivity rate at 8.3 per cent followed by Baramulla at 5.3 per cent.

In Kashmir division, Bandipora and Ganderbal districts recorded the lowest 2.3 per cent positivity rate, while in Jammu region, Ramban district had the highest 3.7 per cent positivity rate followed by 2.1 per cent in Rajouri.

The Union Territory also has a considerably low mortality rate of 1.7 per cent as against 2.4 per cent in the whole country. The mortality rate in Jammu is at 0.6 per cent as against 2 per cent in Kashmir.

#### 43 cows die of suffocation

Bilaspur: At least 43 cows died of suffocation in a small room of a panchavat building where they were allegedly locked in Chhattisgarh's Bilaspur district, a senior official said Saturday. The deaths came to light this morning when villagers experienced a foul odour emanating from the room, and found that some of the cattle had died, said Bilaspur collector Saransh Mittar.

#### Jaish hideout **busted in Pulwama**

Srinagar: Security forces Saturday busted a Jaish-e Muhammad (JeM) terror group hideout in Jammu and Kashmir's Pulwama district. Police said that acting on specific intelligence input security forces including Police, Rashtriya Rifles (RR) and the Central Reserve Police Force (CRPF) launched a search operation in forest area of Chinphadi Machama (Tral) in the early hours of Saturday. On convening the Assembly session, the Raj Bhavan said a letter had been sent to the Rajasthan Parliamentary Affairs Department, raising some points, like the date from which the session was to be convened as it was not mentioned in the Cabinet note and no approval had been given by the cabinet.



# India's COVID tally zooms past 13 lakh

New Delhi, July 25: India's COVID-19 tally zoomed past 13 lakhs Saturday, just two days after it crossed the 12 lakh mark, while the recoveries mounted to 8,49,431, according to the Union Health Ministry.

With 48,916 fresh cases, the country's coronavirus infection tally surged to 13,36,861, while the death toll rose to 31,358 with 757 more people succumbing to the disease in the last 24 hours, data updated by the ministry at 8 am showed.

There are currently 4,56,071 active cases of COVID-19 in the country. Thus, around 63.54 per cent people have recovered so far.

This is the third consecutive day when COVID-19 cases increased by more than 45,000.

Of the 757 deaths reported, 278 were from Maharashtra, 108 from Karnataka, 88 from Tamil Nadu, 59 from Uttar Pradesh, 49 from Andhra Pradesh, 35 from West Bengal, 32 from Delhi, 26 from Gujarat, 14 from Jammu and Kashmir, 11 from Madhya Pradesh

and eight each from Rajasthan and Telangana.

Assam, Chhattisgarh and Odisha have reported six fatalities each, followed by Punjab five deaths. Kerala and Haryana four each, Bihar and Jharkhand three each, and Puducherry, Tripura, Meghalaya and Nagaland one fatality each.

According to the Indian Council of Medical Research (ICMR), a cumulative total of 1,58,49,068 samples have been tested up to July 24 with 4,20,898 samples being tested on

Of the total 31,358 deaths reported so far, Maharashtra tops the tally with 13,132 fatalities, followed by Delhi 3,777, Tamil Nadu 3,320, Gujarat 2,278, Karnataka 1,724, Uttar Pradesh 1,348, West Bengal 1,290, Andhra Pradesh 933 and Madhya Pradesh 791.

So far, 602 people have died of COVID-19 in Rajasthan, 455 in Telangana, 382 in Haryana, 296 in Jammu and Kashmir, 282 in Punjab, 220 in Bihar, 120 in Odisha, 76 in Assam, 70 in Jharkhand, 60 in Friday, the highest conducted in a Uttarakhand and 54 in Kerala.

#### **Copious monsoon** rains spur summer crop sowing

New Delhi, July 25: Indian farmers have planted 79.9 million hectares with summer crops so far, according to the Ministry of Agriculture & Farmers' Welfare, up 18.3% from last year as robust monsoon rains spurred sowing in the world's leading producer of farm goods.

Farmers generally start planting rice, corn, cotton, soybeans, sugarcane and peanuts, among other crops, from June 1, when monsoon rains typically arrive in India. Sowing usually lasts until July or early August.

Monsoon rains play a crucial role in agriculture, which employs 50% of India's 1.3 billion people, as nearly half of the country's farmland lacks irrigation.

The farm ministry provides updates on the provisional sowing figures as it gathers information from state governments. The planting\_ figures are also subject to revision depending on the progress of the June-September monsoon season. As of Friday, planting of rice, the key summer crop, was at 22 million hectares, against 18.7 million hectares at the same time last year. Corn planting was at 7.1 million hectares, up from 6.6 million during the same period last year.

The area planted with cotton totalled 11.8 million hectares against 9.6 million hectares a year earlier. Sowing of soybeans, the main summer oilseed crop, stood at 11.4 million hectares, compared with 9.7 million hectares at the same time in 2019. Soybean output is set to jump by at least 15%. Planting of the protein-rice pulse was at 9.9 million hectares, higher than 7.9 million hectares last year. Sugar cane sowing was unchanged at 5.1 million hectares. India has received 6% above average rainfall since June 1.

# India to purchase 6 more Poseidons

New Delhi, July 25: In a shopping spree for defence equipment amidst the military stand-off with China, India has officially begun the process to acquire six more longrange Poseidon-8I aircraft from the US. At the same time, India plans to fast-track procurement of six Predator-B armed drones.

Already, India is making use of the naval P-8I patrol planes, equipped with radars and electro-optic sensors, in addition to Harpoon Block-II missiles and MK-54 lightweight torpedoes, for surveillance over the Indian Ocean and also eastern Ladakh. Earlier, the Navy had inducted eight Boeing-manufactured P-8I aircraft under a \$2.1 billion deal. Four of these aircraft will be delivered from this December onwards under another \$1.1 billion contract.

According to top defence sources, the "letter of request" for six more P-8Is for around \$1.8 billion has been issued to the US for the government-to-government deal under Pentagon's foreign military sales (FMS) programme. "In turn, the US will soon send the 'letter of acceptance' after congressional approval. The contract may be signed early next year," sources revealed.

At the same time, the armed forces are considering "emergency procurement" of six Predator-B or weaponised Sea Guardian drones from the US in wake of the ongoing confrontation with China along the 3,488-km long Line of Actual Control, particularly in eastern Ladakh.

"While the original plan to acquire 30 Predators will take some more time, the utilisation of the fast-track procurement (FTP) route for acquiring six of these drones -



two each for the three Services - is now under consideration," sources added. Once India acquires these aircraft and drones they will provide a quantum leap in unmanned lethal capability for the armed forces.

The inking of the bilateral military pact with the US called COM-(Communications, Compatibility and Security Arrangement) in September 2018 has paved the way for greater access to advanced military technologies with encrypted and secure communications and data links from

that over 2.6 lakh applications have been received, over 64,000 have been sanctioned and over 5,500 have been disbursed.

The Prime Minister expressed satisfaction on the use of end-toend IT solution through a webportal and mobile application for administration of the scheme to ensure transparency, accountability and speed, an official statement said.

While noting that the Ministry of Housing and Urban Affairs is working on a complete IT solution, including mobile application, for seamless implementation of the scheme, the prime minister said that its design should incentivise use of end-to-end digital transactions by the street vendors.

# More measures likely to check China re-routing goods into India

New Delhi, July 25: India is looking at ways to restrict inward shipment of goods from China which are being re-routed through other countries such as Singapore and Malaysia with which New Delhi has trade agreements. Experts have suggested that India must make it mandatory for companies that are supplying goods to India to disclose their ownership pattern in detail.

New Delhi has already imposed stringent measures including the 'rule of origin', which implies that all global suppliers of goods will have to mention the country of origin to restrict cheap imports from other countries including China, However, authorities said that there is "enough evidence" to suggest that the dragon nation has conveniently circumvented the rule book. Based on the country of origin, goods either attract tariff concessions or duties

Sample this. Chinese manufacturer Xinyi Glass is one of Malaysia's largest flat glass producers, which is also into exporting to other countries. It also has a plant in Canada. The Malaysia plant has a total installed capacity of 3,200 tonnes per day. Industry experts said that Malaysia's requirement a day is about 400

According to Glass Worldwide Official Journal, Malaysia exported \$240.2 million worth of flat glass products in 2018-a jump of 149.7 per cent over the previous year. Kibing Glass Malaysia, also a Chinese company, has set up manufacturing facilities in the southeast Asian country.

It is no secret that finished imported goods are priced less compared to those made in India due to the skewed trade agreements goods from China which are being re-routed through

While New Delhi's imports of glass products increased - Malaysia being one of the countries which exported to India-domestic manufacturers have been complaining of oversupply. This is severely hurting glass manufacturers.

"Xinyi Glass began investing in Malaysia in 2014. Its phase-I project, which started commercial production in May 2017, included a 1200 tonnes/day line for float glass at Malacca," the journal

India and Malaysia signed the Comprehensive Economic Cooperation Agreement (CECA) in 2011. Imports from Hong Kong, especially for electric and electronic items, too have been steadily increasing

'We need to have a well thoughtout mechanism to curb dumping. We must boost our manufacturers. Due to lopsided trade policies of the past, the manufacturing sector has been systematically destroyed, Swadeshi Jagran Manch national co-convener Ashwani Mahajan said, adding that Make in India and Atmanirbhar Bharat must be the

thrusts to generate jobs and become self-reliant.

Nirupama Soundararajan, senior fellow and head of research, Pahle India Foundation, said that it is critical for India to reduce its dependence on China. "Indian manufacturers have the required capability but due to the cost factor-imports from China are cheaper - the manufacturing sector has suffered," Soundararajan said. She underlined the need for bringing in measures which will strop indirect trade between India and China.

It is no secret that finished imported goods are priced less compared to those made in India due to the skewed trade agreements. Most experts have acknowledged that the free trade agreements have not benefited India and that they need to be revisited.

Even before the government put in place stringent measures to restrict imports from China, the dragon had started using other countries such as Singapore and Malaysia besides Hong Kong to ship goods into India.


# Varavara's family approaches NHRC seeking his health status

Hyderabad, July 25: Family members of poet Varavara Rao, accused in the Elgar Parishad case, have moved the National Human Rights Commission (NHRC) seeking a direction to a Mumbai hospital, where he is being treated for COVID-19, and prison authorities to provide "transparent" updates on his health status.

The petition filed Friday stated that the family was compelled to approach the rights body as they were denied any information about his condition or his treatment at the Nanavati Hospital in Mumbai.

"Today, we are compelled to write this letter to you, as we are denied



or his treatment at the Nanavati Hospital," the petition read.

From the time he was shifted out of Taloja Jail to St Georges hospital to Nanavati hospital, the only official information provided positive for the COVID-19, they said. Denial of any information on

to the family was that he had tested

Rao's health is a direct violation of NHRC's July 13 order, whereby it had specifically directed the prison authorities to provide all the necessary medical care and assistance to the poet with intimation to his family members, they added.

Seeking NHRC's intervention, the family sought official updates on his health and line of treatment every six hours.

Rao, 80, was undergoing treatment in Mumbai hospitals since July 16 after being tested for coronavirus positive.

He is behind bars for about 22 months and had approached the special NIA court, seeking bail on medical grounds and the prevailing COVID-19 situation.

### Dalit family in MP forced to live in toilet

Tikamgarh (MP), July 25: Promise of providing housing to the poor has been made by both Centre as well as state governments but a Dalit family in Tikamgarh district of Madhya Pradesh is forced to live in a toilet for the last several years.

However, the administration denied that the family is living in the toilet. Maganlal Ahirwar, his wife and four children live in Keshavgarh Gram Panchayat of Mohangarh area of Tikamgarh district. All of them have been living in the toilet for four years. Ahirwar's wife Phula Devi said she told the authorities several times

that her family didn't get house under the Pradhan Mantri Awas Yojana, but no one listened. The couple even got their daughter married in the same toilet.

They even got an electricity connection and gas connection under the Ujjwala scheme.

Mohangarh tehsildar Dr. Abhijeet Singh told this news agency, "I got to know about the case and have asked for the report. Maganlal Ahirwar came to the office two-three days ago and denied that he was living in the toilet with his family. He has an ancestral house in the village.

He might have lived in a toilet earlier but currently he is not living there, Dr. Singh added.

### **Sub-inspector** kills senior, self

New Delhi, July 25: A Central Reserve Police Force sub-inspector allegedly shot dead his senior with his service weapon before killing himself at a bungalow allotted to the Home Ministry in Lodhi Estate area of Delhi, officials said Saturday.

They said an argument had broken out between Sub-Inspector Karnail Singh (55) and Inspector Dashrath Singh (56), both from the 122nd CRPF battalion. The SI first shot dead his senior in their room and later killed himself near the main gate around 10:30 pm Friday. The SI hailed from Udhampur in Jammu and Kashmir and the inspector was from Rohtak in Haryana.

Senior officials of the paramilitary force and local police reached the spot soon after the incident, the officials said. 'We received information re-

garding the incident around 10.40 pm. Karnail was found near the main gate of the bungalow while Dashrath was found dead inside their room." Deputy Commissioner of Police (New Delhi) Eish Singhal said. "The incident at 61, Lodhi Estate is an aberration which seems to have been committed in the spur of the moment. An inguiry has been ordered to establish the facts and will be taken to its logical end," CRPF spokesperson Deputy Inspector General Moses Dhinakaran said.

## IN A FIRST, PONDY **ASSEMBLY MEETS** UNDER NEEM TREE

Pondicherry, July 25: In an unng prompted after a legislator tested positive for coronavirus, the Puducherry Assembly Saturday held its Budget session under a tree and later adjourned sine die after approving budgetary allocations to the tune of ₹9,000 crore without discussion.

The House had its session under a neem tree as the main hall was shut for sanitisation following opposition AINRC MLA NSJ Jayabal testing positive for the virus and being hospitalised on Friday night.

The session, which began July 20. had been an eventful one with Lt Governor Kiran Bedi staying away from delivering her customary address to the House to mark the session.

She had said the budget did not have her approval, but the Chief Minister presented it the same day, after the House kept her address at abeyance. However, she addressed the members Friday in the midst of an ongoing session, another unprecedented development, even as Health Minister Malladi Rao and three ruling Congress MLAs boycotted it for Bedi pulling up senior doctors and health staff over COVID-19 management.

On Saturday, official sources said this was the first time the House held its meeting at an improvised site. The House passed before adjournment, the Appropriation Bill earmarking ₹9,000 crore for the government tabled by Narayanasamy. All the demands for grants to more than 30government departments for the fiscal 2020-2021 were passed without discussion by the members.

The Chief Minister and his Cabinet colleagues moved the demands for grants to their respective departments. The Speaker VP Sivakolundhu, who presided over the day's proceedings, later adiourned the House sine die.

Earlier, the Speaker and the CM were in a virtual hot search for an appropriate alternative venue to hold the day's proceedings after the main hall of the House was shut as a precautionary measure following a legislator testing positive for coronavirus.

Initially, the committee hall on the top floor of the Assembly's annexe campus was sought to be chosen for the day's meeting.

However, the Speaker found the space insufficient to accommodate all the Members and officials, and finalised the open space available outside the main building.

# Cinemas may reopen in Aug: I&B Ministry

New Delhi, July 25: The Information and Broadcasting Ministry has recommended to the Union Home Ministry that cinema halls all over the country be allowed to reopen in August.

I&B Secretary Amit Khare indicated this at a close-door industry interaction with the CII Media Committee Friday. He said his opposite number in the Home Ministry, Ajay Bhalla, will take the final call.

Khare said that he has recommended that cinema halls may be allowed to reopen all over India as early as August 1 - or at the latest, around August 31.

The formula suggested is that alternate seats in the first row and then the next row be kept vacant and proceeding in this fashion

Khare said that his ministry's recommendation takes into consideration the two metre social

distancing norm, but tweaks it gently to two yards instead. The Home Ministry, however, still has to revert on the recommendation.

Cinema owners, present in the interaction, however, pushed back and said this formula is unwise and merely running films at 25 per cent auditorium capacity is worse than keeping the cinemas shut.

The attendees at the meet included media CEOs like NP Singh of Sony, Sam Balsara (Madison), Megha Tata, (Discovery), Gauray Gandhi (Amazon Prime), Manish Maheshwari (Twitter), S. Sivakumar (Bennett Coleman and Co Ltd), and K. Madhavan, Star & Disney, and also Chairman, CII Media Committee.

# Uniform country-wide COVID cases peak will not happen: Expert

Each state has its own trajectory based on when people there were *exposed* to the infection

Hyderabad, July 25: There cannot be a uniform peak in COVID-19 cases in a large country like India and each state has its own trajectory based on when people there were exposed to the infection, a public health expert said.

The peak could be witnessed in states like Delhi by this month end or early August while it may be

around September in others such as Tamil Nadu, Maharashtra and Karnataka, Director of the Indian Institute of Public Health (IIPH) here Prof. GVS Murthy said. IIPH was set up under the aegis

of the Public Health Foundation of India (PHFI). In states such as Jharkhand it

may take longer time as the spread has started only after the return of the migrant labourers, he said. 'So, each state has its own tra-

jectory based on when people were exposed to the infection in that particular state. There is not going to be a uniform peak for the country. There is going to be a number of peaks in the country," he said.

For example, Bihar seemed to



be reporting a large number of cases suddenly after all those who migrated to other cities, specifically Mumbai and Delhi, started

It takes about 10-14 days for a COVID-19 person to infect others in their families and then the next wave of cases will happen, Murthy, who established and headed the

first Community Ophthalmology Department in the public sector in the country at the All-India Institute

of Medical Sciences till 2010, said. Governments need to continue with measures to deal with the virus and the community also should strictly adhere to preventive guidelines such as washing hands and maintaining physical distancing, he said and stressed on taking intense

steps in densely populated areas. States like Jharkhand (present total cases 7,564), Chhattisgarh (6,819) and parts in eastern Uttar Pradesh too had reported fewer cases earlier but the spread would

start occurring as the migrants have returned now to their homes. "There, the peak will take much

longer. It would be somewhere towards the end of September or October that those states which had low reporting earlier, will have a peak," he said.

But, states like Haryana, Telangana, Karnataka, Andhra Pradesh and Tamil Nadu should be able to achieve the maximum number of cases by mid-September, he said. All these states which were reporting very high numbers now should not be getting the same numbers beyond mid-September

Some states should achieve the peak by mid-August also. For example, Delhi seems to be on a path where, by the end of this month or early August, it can be said that

the peak has been crossed, he said. The same could be the case with Raiasthan and Punjab, and other states, including Maharashtra, Karnataka, Telangana and Andhra Pradesh may reach the peak in

September, he said. He said the governments need to continue with measures to deal with the virus as the health system would be overwhelmed if there was a sudden rise in cases and if the states are unprepared.

"Kerala, you have seen now. They 🗦 thought they had seen the end of COVID. Suddenly, in the last over 10 days, Kerala has had a much larger number of cases than before," he said. The three Ts Test, Track and Treatment were important to reduce the infections and slipping

into serious complications, he noted.

#### Former Trump lawyer released

Washington: US President Donald Trump's former lawyer Michael Cohen has been released from prison after a judge ruled that he was sent back to jail in retaliation for writing a tellall book. Cohen was convicted last year of crimes including tax evasion, lying to Congress and facilitating illegal payments to silence two women, adult film star Stormy Daniels and former Playboy model Karen McDougal, who claimed they had affairs with Trump, the BBC reported. After his May release, authorities this month said Cohen violated the terms of his release.

#### Russia clears air

Moscow: Accusations from the US and UK that Russia recently tested anti-satellite weaponry in space are "distorted", Russia's defence ministry said. "Tests carried out [on July 15] did not create a threat for other spacecraft," the ministry said, adding that it had not violated international law, the BBC reported. Moscow said earlier that it had been using new technology to perform checks on Russian space equipment. But the US and UK said they were concerned about the satellite activity.

#### **Curbs** eased

Washington: The US government has announced updated export restrictions on unmanned aerial systems (UAS), a move long sought by the country's defence industries. "The President has decided to invoke our national discretion to treat a carefully selected subset of MTCR Category I UAS, which cannot travel faster than 800 km per hour, as Category II," Xinhua news agency quoted the White House as saving a statement Friday.

#### Gyms reopen

London: Swimming pools and gyms in England are reopening for the first time since the UK went into lockdown as public health officials extol the benefits of exercise in fighting COVID-19. The government has announced a fresh attack on obesity as part of the move, hoping that a fitter nation might be able to minimize the impact of future waves of the virus. But Jane Nickerson, chief executive of Swim England, says that there had been financial pressure on pools even before the pandemic and that without government support many won't open this year - or ever.

According to the Vienna Convention on Consular Relations and the Sino-US Consular Treaty, the US must not infringe on the premises of the Chinese Consulate in Houston in any way, it said.

# Singaporean admits to spying

Washington, July 25: A Singaporean national Friday pleaded guilty to charges of being a spy of China, the US Department of Justice said.

Jun Wei Yeo, also known as Dickson Yeo, entered a plea of guilty to one count of acting within the United States as an illegal agent of a foreign power without first notifying the attorney general. The Chinese government uses

an array of duplicity to obtain sensitive information from unsuspecting Americans," said US Assistant Attorney General for the Justice Department's National Security Division John C Demers.

'Yeo was central to one such scheme, using career networking sites and a false consulting firm to lure Americans who might be of interest to the Chinese government. This is yet another example of the Chinese government's exploitation of the openness of American society," he said.

The guilty plea underscores the ways that the Chinese government continues to target Americans with access to sensitive government information, including using the Internet and non-Chinese nationals to target Americans who never leave the US, said Michael R Sherwin, Acting US Attorney for the District of Columbia.

Yeo admitted that he not only pro-

vided valuable information to Chinese intelligence but also that he knowingly recruited others in the US to do the same, said FBI Washington Field Office Assistant Director in Charge Timothy R Slater. "The tactics Yeo used to target cleared individuals on professional networking social media sites are just one facet of the full court press China employs on a daily basis to obtain nonpublic US government information.

As per the guilty plea, Yeo began working with Chinese intelligence officers as early as 2015, initially targeting other Asian countries, but then focusing on the US.

In response to taskings from his Chinese intelligence contacts, Yeo allagedly worked to spot and assess Americans with access to valuable non-public information, including US military and government employees

with high-level security clearances. After Yeo identified American

targets he solicited them for nonpublic information and paid them to write reports. Yeo told these American targets that the reports were for clients in Asia, without revealing that they were in fact destined for the Chinese government, the Department of Justice said.

At the direction of Chinese intelligence operatives, Yeo targeted US government employees and an Army officer to obtain information for the government of China.

He admitted he set up a fake consulting company to further his scheme, looked for susceptible individuals who were vulnerable to recruitment and tried to avoid detection by US authorities, said Alan Kohler, Assistant Director of the FBI's Counterintelligence Division.

#### **US** court rejects Rana's bail

Washington, July 25: A US court has rejected the USD 1.5 million bail application of Pakistani-origin Canadian businessman Tahawwur Rana, who has been declared a fugitive by India for his involvement in the 2008 Mumbai terror attack case, describing him a flight risk.

Rana, 59, a childhood friend of David Coleman Headley, was re-arrested on June 10 in Los Angeles on an extradition request by India for his involvement in the 2008 Mumbai terror attack in which 166 people, including six Americans, were killed. He is a declared fugitive in India.

US District Court Judge in Los Angeles Jacqueline Chooljian, in her 24-page order dated July 21, denied bail to Rana arguing that he is a flight risk.

Describing Rana as a flight risk, the US government opposed his release on bail, arguing that if he were to flee to Canada, he may escape the possibility of a death sentence in India. "Given the stakes, an allowance of bail in any amount would not guarantee Rana's presence in court. Granting bail would invite the possibility of embarrassing the United States in the conduct of its foreign affairs, straining its relationship with India.' Assistant US Attorney John J Lulejian had told the court

### Indian woman files lawsuit against US

Washington, July 25: An Indian woman has filed a lawsuit against the US Citizenship and Immigration Services for the alleged delay in issuing work permits, accusing the authorities of sitting on a backlog of at least 75,000 unprinted Employment Authorisation Documents.

Ranjitha Subramanya, who is on an H-4 dependent visa and her husband Vinod Sinha on H-1B work visa, in a lawsuit filed before a federal court in Ohio said that while her application to extend her H-4 status and Employment Authorisation Document (EAD) was approved on April 7, she did not receive the work authorisation card till date.

As a result, she was forced: working for her employer after her initial EAD expired on June 7, 2020."To date, she has not received her EAD and remains unable to work. Worse, her employer has notified her that she will lose her job if she does not provide proof of employment authorisation by August 9, 2020," said her lawyer Robert H Cohen in the lawsuit.

An H-4 visa is a visa issued by the US Citizenship and Immigration Services (USCIS) to the immediate family members of the H-1B visa holders. Spouses on an H-4 visa can apply for an EAD. The lawsuit alleges that the USCIS is sitting on a backlog of at least 75,000 unprinted EADs.

"By delaying or refusing to provide EADs to plaintiffs and class members, defendants have abused their power in an outrageous manner, without any reasonable justification in the service of a legitimate governmental objective, and with either an intention to harm plaintiff and class members or deliberate indifference," the lawsuit said.

### US announces new policy The US immigration authority has issued a new policy stating that freshly

enrolled foreign students who are seeking only-online study this fall will be barred from entering the country

Washington, July 25: The US immigration authority has issued a new policy stating that freshly enrolled foreign students who are seeking only-online study this fall will be barred from entering the country; days after the Trump administration dropped its controversial plan to expel international students if their universities switch to online-only classes due to the COVID-19 pandemic.

The new policy was announced Friday by the US Immigration and Customs Enforcement, which said that its guidance granting visa flexibility to nonimmigrant students only applies to those who were actively enrolled at American schools on March 9.

Students and Exchange Visitor



Program (SEVP) and Immigration and Customs Enforcement of the Department of Homeland Security, in a revised guideline for Fall 2020, asked universities not to issue the necessary visa paper work for those international students who are fully enrolled in online courses.

The designated Dean of Students ffice or DSOs should not issue a Form I-20, "Certificate of Eligibility for Nonimmigrant Student Status," for a student in new or Initial sta-

tus who is outside of the United States and plans to take classes at an SEVP-certified educational institution fully online," said the revised guidelines, which was initially issued on March 9.

"As a result, new or initial nonimmigrant students who intend to pursue a full course of study that will be conducted completely online will likely not be able to obtain an F-1 or M-1 visa to study in the United States," said the guidelines issued jointly by SEVP and ICE.

"If a nonimmigrant student was enrolled in a course of study in the US on March 9, 2020, but subsequently left the country, that student likely remains eligible for a visa since the March 2020 guidance permitted a full online course of study from inside the United States or from abroad," it said.

### China's SCS claims unlawful: Aus

Melbourne, July 25: Australia has joined the United States in stating that China's claims in the South China Sea do not comply with international law in a declaration likely to anger China and put more strain on their deteriorating relations.

The United States this month rejected China's claims to offshore resources in most of the South China Sea, drawing criticism from China which said the U.S. position raised tension in the region.

Australia, in a declaration filed at the United Nations in New York on Friday, said it too rejected China's maritime claims around contested islands in the South



China Sea as being inconsistent with the UN Convention on the Law of the Sea.

"Australia rejects China's claim to 'historic rights' or 'maritime rights and interests' as established in the 'long course of historical practice' in the South China Sea," it said. Australia also said it did not accept China's assertion that its sovereignty over the Paracel Islands and the Spratly Islands was "widely recognised by the international community", citing objections from Vietnam and the Philippines.

China claims 90% of the potentially energy-rich waters but Brunei, Malaysia, the Philippines, Taiwan and Vietnam also lay claim to parts of it.

# UK experts call for anti-obesity action to cut Covid risk

The report comes as UK Prime Minister Boris Johnson is said to be finalising Downing Street plans for an anti-obesity drive

London, July 25: Supporting people to move towards and maintain a healthier weight may reduce the serious effects of COVID-19, UK experts have concluded in a new report released

Public Health England (PHE), the executive body linked to the government's Department of Health, conclude in their findings that being obese or excessively overweight increases the risk of severe illness and death from the novel coronavirus. The report summarises findings from evidence published during the pandemic on the effects of excess

weight and obesity on COVID-19. PHE notes that UK and international evidence suggests that being severely overweight puts people at greater risk of hospitalisation, Intensive Care Unit (ICU) admission and death from COVID-19. with risk growing substantially as body mass index (BMI) increases. "The current evidence is clear

that being overweight or obese puts you at greater risk of serious illness or death from COVID-19, as well as from many other life-threatening diseases," said Dr Alison Tedstone, Chief Nutritionist at PHE. "It can be hard to lose weight and even harder to sustain it, which is why people cannot easily do it on their own. Losing weight

The report comes as UK Prime Minister Boris Johnson is said to be finalising Downing Street plans for an anti-obesity drive. In an interview recently, he asked the British public to make losing weight a goal for the year as part of efforts to combat the deadly

coronavirus. 'Losing weight is, frankly, one of the ways that you can reduce vour own risks from COVID." said Johnson, who himself has lost over six kilograms in weight since his own hospitalisation with coronavirus earlier this year.

The PHE report notes that current evidence does not suggest that having excess weight increases

people's chances of contracting COVID-19. However, the data does show that obese people are significantly more likely to become seriously ill and be admitted to intensive care with COVID-19 compared to those with a healthy BMI. which is under 30. Excess fat can affect the respi-

ratory system and is likely to affect inflammatory and immune function. This can impact people's response to infection and increase vulnerability to severe symptoms of COVID-19. Obese people may be less likely to access healthcare and support, and it is also thought that the novelcoronavirus affects other diseases associated with obesity.

London, July 25: UK manufacturing witnessed a record slump\_ in the three months to July due to significant impact caused by the coronavirus pandemic, according to an industry report.

Released Thursday, the Confederation of British Industry's (CBI) quarterly industrial trends survey showed that output dropped in 14 out of 17 sub-sectors in the quarter to July, with the headline fall being led by "motor vehicles & transport, food, drink & tobacco, and mechanical engineering", reports Xinhua news agency.

According to a survey of 356 manufacturing firms, the total new orders in the period fell "at their fastest pace since October 1980", said the survey.

"Manufacturers continue to face extreme hardship due to the COVID-19 crisis," said Rain Newton-Smith, chief economist at the CBI, adding that "output volumes continued to decline at a record pace, while total orders have fallen at their fastest rate since October 1980".

However, firms expected output to begin to recover in the next quarter.



# Mentality matters, says Reid
