

Doctored 'OCMR' approvals to fore

Bhubaneswar, July 27: The Odisha Council for Medical Registration (OCMR), a state government body responsible for regulation of medical practice in the state, has stumbled upon a racket involved in supplying fake registrations to medical practitioners across the country.

The registrar of OCMR, Kamal Kanta Das, has written a letter to Additional Director General of Police, Crime Branch, seeking action against the people behind the racket. The cyber cell at the Crime Branch in Cuttack has registered a case and started a probe.

The OCMR is the official body to issue statutory permissions such as registration certificates, NOC and other testimonials necessary for practicing doctors. It also frames rules and keeps a watch on any mischief in connection with the medical practice in the state.

The OCMR discovered the fraud after Dr Shritosh of AIIMS- Bhubaneswar informed the body about a fake website. It is learnt that somebody is operating a fake website naming www.ocmr.org.in. It was informed to us by Dr. Shritosh from AllMS. Bhubaneswar who sent the detail papers after facing the problem. (The related papers attached herewith).

Another set of papers sent to us by the Dy. Registrar, Uttarakhand Medical Council attaching a fake M.B.B.S. Registration Certificate issued from such fake council having address as Odisha Council of Medical Registration, Nandankanan Road, Bhubaneswar-17. The letter of Dy. Registrar, Uttarakhand Medical Council along with the fake medical registration Certificate are also attached berevisib.

O.C.M.R. had developed a website long back named www.ocmr.org during 2004-2005 without on-line application facility for registration. It was abandoned due to fund crunch, non availability of human resource to handle the data and expensive A.M.C. Now our new website is under construction by N.I.C., Bhubaneswar and till now we have not started on like On-line

An F.I.R. may kindly be registered and the fake website may kindly be stopped along with preventing collection of fees to issue fake certificates.

istration certificate issued by the bogus council. He also sought action from his counterpart in Odisha to bust the racket.

Sources claimed many people have secured fake certificates from the bogus council and are carrying out practice in other states. The fake website mentioned the office of OCMR at Nandankanan instead of the original location of OCMR at Unit-IV of the city. The fraudsters recently claimed on the fake site that doctors can apply for registration /renewal /transfer process online in view the pandemic.

Meanwhile, Das informed the crime branch that the council had developed a website back in 2004-05 'www.ocmr.org' which has been lying defunct now. The OCMR is currently working along with NIC to develop a new website to provide online registration facilities to medical practitioners.

BSE Class X results July 29

Bhubaneswar, July 27: Results of the annual matriculation examination conducted by the Odisha Board of Secondary Education (BSE) will be announced July 29, a minister said Monday.

The Class X results will be declared through videoconferencing at 9 am and students can check their scores from 11 am on the board's website, School and Mass Education (S&ME) Minister Samir Ranjan Dash said.

SMS option for obtaining the results will also be available, BSE president Ramashis Hazra said. As many as 5.60 lakh

students appeared for the annual Class X board examination in 2,888 centres from February 19 to March 2. The declaration of re-

sults was delayed due to cyclone Amphan and the coronavirus-induced lockdown, officials said.

PLUS II RESULTS

he results of annual Plus II examinations conducted by the Council of Higher Secondary Education (CHSE) will be declared by the third week of August, the S&ME Minister said. While the results of examinations in Science and Commerce streams will be out by third week of August, the result in Arts stream will be announced by end of August, added the minister. The evaluation process was delayed due to COVID-19 pandemic. Teachers assigned to carry out evaluation of answer sheets faced complications in discharging their duty due to shutdown in 20 districts. The S&ME department had written to the Chief Secretary to ensure evaluation to be conducted properly without obstruction so that the results can be declared at the earliest

47 MORE CHINESE APPS TO BE BANNED

New Delhi, July 27: The government has banned 47 more Chinese apps, taking the total number of mobile applications banned for being prejudicial to sovereignty, integrity and defence of the country, to 106, according to a source.

The source privy to the development said that the 47 additional Chinese apps that have been banned now were clones and variants of the apps which were blocked earlier. An order to this effect was is-

sued on Friday, the source said. The list of additional apps that have been banned was not immediately available, and there is no official word on the matter yet.

Earlier on June 29, the government had banned 59 Chinese apps, saying they were prejudicial to sovereignty, integrity and security of the country.

It has been reported that the announcement would take place officially shortly. The government earlier banned apps including CamScanner, SHAREit, Tik Tok, and UC Browser, among others. That ban was announced under



the provisions of Section 69A of the Information Technology Act. A media report, citing govern-

ment sources, said the government had also prepared a list of over 250 apps that would be examined for any user privacy or national security violations. It is believed that some top gam-

ing Chinese apps including PUBG Mobile would be part of the new list of banned apps. However, the government is yet to release the details pertaining to the development.

The government had ordered telcos to block access to all those apps as well as their related websites shortly after announcing the decision publicly through a press release. It also directed Apple and Google to remove the banned apps from their respective app stores in the country.

mission of the Collector, Deogarh. The District Collector had relieved him from duties June 3. 2020 due to indiscipline and negligence in duty. The government Sunday had suspended Kalahandi deputy collector Anisha Das on

charge of dereliction of duty. He will be entitled to the payment of subsistence allowance in accordance with Rule-90 of Orissa Service Code, the order added. The action against Das was taken based on a report submitted by project director of DRDA in Subarnapur district.

5 Rafale jets take off from France for India

New Delhi, July 27: The first batch of five Rafale jets Monday took off from France for India, officials said. The multi-role fighter aircraft are scheduled to arrive at Ambala air force station Wednesday, nearly four years after India signed an inter-governmental agreement with France to procure 36 Rafale iets for the Indian Air Force under a ₹59,000-crore deal.

The fleet is expected to significantly boost the IAF's combat capabilities at a time when India is locked in a tense border row with China in eastern Ladakh. Indian Ambassador to France Jawed Ashraf interacted with IAF pilots before they took off from France.

"Bon Voyage: Indian Ambassador to #France interacts with the Indian pilots of the Rafale. Congratulates and wishes them a safe flight to India with a single hop," the Indian Embassy in Paris tweeted. The first squadron of the Rafale jets will be stationed at Ambala air base. The five Rafales are scheduled to

be inducted into the IAF on Wednesday afternoon. However,



an IAF spokesperson said a formal induction ceremony will be held in mid-August Official sources said the Rafale

jets are likely to be deployed in the Ladakh sector as part of the IAF's efforts to enhance its operational capabilities along Line of Actual Control (LAC) with China in view of the border row with the country. The aircraft is capable of car-

rying a range of potent weapons. European missile maker MBDA's Meteor beyond visual range airto-air missile and Scalp cruise missile will be the mainstay of the weapons package of the Rafale jets. Meteor is the next generation

of BVR air-to-air missile designed to revolutionise air-to-air combat. The weapon has been developed by MBDA to combat common threats facing the UK, Germany, Italy, France, Spain and Sweden.

BJP MLA Madan Dilawar's petition in the Rajasthan High Court against the merger of six Bahujan Samaj Party MLAs into the Congress in Rajasthan was dismissed on Monday, providing relief to the Gehlot camp which, even by its own admission, has only a bare majority in the House.

Don't lower guard against Maoists, warn experts

Bhubaneswar, July 27: The rement to remove five districts from the list of Security Related Expenditure (SRE), a central scheme exclusively meant for capacity building in Maoist-hit districts, is an indication of the waning Mao activities in Odisha. Once the Ministry of Home Affairs (MHA) approves the state's proposal, the number of districts under SRE will come down to 10 from 15. Earlier, six districts, Jajpur, Dhenkanal, Keonjhar, Mayurbhanj, Gajapati and Ganjam had been knocked off from the list by the Centre in 2018.

Experts, however, warn against complacency creeping in the government, arguing that the districts



so removed were mainly extended Maoist zones and the government should continue to zero in on ultras

Noted Left Wing Extremism (LWE) expert and Assistant Professor of Political Science at the Sambalpur University, Rajat Kumar Kujur, said "Though the removal of Angul, Boudh,

Sambalpur, Deogarh and Nayagarh from SRE list is a significant achievement for security forces, the Maoists still have a strong presence in the border areas of Malkangiri and Bisra, Jereikela, Birmitrapur in Sundargarh. Now it is the duty of the government to convert these short-term gains into long-term successes by continuing developintensifying operations by the security forces. Maoist outfits in Sundargarh

had extended their activities to the neighbouring areas of Sambalpur while the Reds in Keonjhar had extended their grip to Deogarh, Angul and Dhenkanal







e-Commerce platforms boon for organic farming

Bhubaneswar, July 27: Online sale of organic farming products has proved a boon for many like Balabhadra Naik, a farmer from a small village of Kalahandi district. Buoyed by the government support, he has joined the e-commerce sites and is now able to sell his organic paddy at ₹80 per kg.

Similar is the experience of other farmers who have adopted the method and started reaching out to the customers through online.

Many of them have registered themselves with the Union government's online platform, www.market-jaivikkheti.in, where they get orders. As per government sources, a total of 16,868 organic farmers from Odisha are now selling their produce online. Many farmers belonging to Kalahandi, Rayagada, Koraput and other districts have joined the market of organic food which is growing in the state with time.

Organic farming in the state is gradually expanding with the Union as well as state governments emphasising on natural way of raising crops and vegetables.

According to data given by the Agriculture Ministry in Lok Saha

What is organic farming?

t is defined by the use of fertilisers of organic origin such as compost manure, green manure, and bone meal and places emphasis on techniques such as crop rotation and companion planting. Biological pest control, mixed cropping and the fostering of insect predators are encouraged under this method of cultivation.

in March 2020, altogether 95,312 hectares of land in the state are under organic farming under different state and central schemes. The government also claims that more than 65,000 farmers from Odisha are registered with the government as organic farmers.

People associated with organic farming claim that the farmers are not only selling their produce online but also exporting them.

"A number of organic produce like mangoes and cashew nuts are being sold to other states like from Koraput to Delhi and others. Recently, many farmers exported mangoes to the dairy giant Mother Dairy in New Delhi while some went to Hyderabad firms. Links

The Union government has been encouraging organic farming through clusters in selected districts under 'Paramparagat Krishi

Vikas Yojana' (PKVY). In Dashwantpur block of Koraput district, 1,000 farmers in six panchayats are working hard to shun chemical fertilisers and adopt organic farming as a natural way to boost farming in the region.

The government has been giving financial assistance to each cluster for input costs, training. branding and other areas to give an impetus to organic farming in Odisha. The state government has also been working through state policies and schemes to give an impetus to organic farming and helping in market linkage.

There is a good scope for organic farming in Odisha. There are some forest areas in Kalahandi and Kandhamal districts where organic farming is practiced for growing turmeric and ginger for the last 8-10 years with government support. Also, they have a good marketing network there," an official from the National Centre of Organic Farming, Ghaziabad told **Orissa POST**.

The Centre, through its regional centre in the state, has also been working to boost organic farming and train the farmers to avoid use of chemical fertilizers and pesticides and adopt sustainable farming methods through organic farming.

TREATMENT OF COVID PATIENTS

SC seeks compliance reports from states

New Delhi, July 27: The Supreme Court, Monday, directed the states to file compliance reports with respect to the directions issued by the apex court regarding treatment of Covid-19 patients and dignified handling of bodies at the hospi-

A three-judge bench of SC comprising Justices Ashok Bhushan, R Subhash Reddy and MR Shah granted two weeks' time to the state governments to file the compliance reports.

The bench observed that an affidavit filed on behalf of the Union government does have the details of compliance of the directions.

'Mere direction to comply with the directions is not enough. The steps taken towards compliance of the directions have to be brought on the record," the bench said.

The apex court asked the chief secretaries of the states to file an appropriate compliance report.

"The state governments/ Union

Territories have not filed affidavits giving details of compliance of various directions issued by this court June 19, 2020. We are of the view that the Chief Secretaries of the states have to take steps to ensure that directions issued by this court

> in order dated June 19, 2020 are complied with. An appropriate compliance report be filed. We grant two weeks' time to the states/UTs to file an appropriate compliance affidavit," the bench said. The SC also asked the

Centre to file a detailed affidavit within two weeks giving the details of the compliance of the directions issued by the court.

Notably, the apex court had June 19 directed the Centre to constitute an expert committee to inspect and supervise all the government hospitals. The court had also asked the governments to prescribe reasonable fees for Covid-19 treatment and also install CCTV cameras in all Covid dedicated hospitals. The apex court had issued 11 directions regarding treatment

of Covid-19 patients.

4 MEMBERS OF **TITO GANG HELD**

Cuttack, July 27: Chauliaganj police Monday claimed to have foiled a robbery bid by arresting four criminals belonging to the gang of Sayed Usman Ali alias Tito from near Gandhi Square here.

'Somnath Sahu and Jitendra Sahu of Chauliaganj Matha Sahi, Ramchandra Nanda of Fakirpada in Jagatpur and Rashmi Ranjan Swain of Kurutunga in Kendrapara have been taken into custody while they were hatching a conspiracy to rob commuters on the national highway late Sunday night," said a police official confirming the arrests.

A country pistol and a few sharpedged weapons were recovered from them. The four were historysheeters and had been working at the behest of Tito, the official said.

The official said that they were tipped off about the assembly.

The four along with two others had gathered at a ground on the rear side of the fuel station near Gandhi Square late Sunday night to hatch robbery plans. A team of Chauliaganj police, led by its inspector in-charge Tapas Pradhan, raided the ground and nabbed the criminals. Taking advantage of the darkness, two others managed to escape. While Somnath has six cases pending against him, Jitendra has 13 and Ramachandra has 3 cases against him with Chauliagang police. Rashmi Ranjan has multiple cases registered against him with several police stations across state," said the official who was also the part of the team.

Efforts are on to track the absconders, the IIC said. A case (248/20) has been registered under Sections 399, 402 of the IPC and 25 of the Arms Act.

Food, lodging soon for plasma donors

Bhubaneswar, July 27: With the novel coronavirus infections rising each passing day, the state government has asked the district Collectors to redesign their strategy to better fight the disease.

Talking to Collectors and chief district medical officers (CDMOs) over a video-conference Monday evening, Chief Secretary Asit Tripathy asked them to make advance arrangements in all these matters keeping in view the scenario till end of August.

The Collectors were asked to enhance per day sample collection at least to 1.000 per day in hotspot district and up to 500 per day in other districts for early detection and treatment.

They were asked to utilise the antigen test kits and upload the test results in Indian Council for Medical Research (ICMR) portal on daily basis.

Additional Chief Secretary Health & Family Welfare PK Mohapatra said, "We have sufficient stock of testing kits and medicines. Around 1, 16, 000 antigen test kits have already been supplied to the districts. More kits will be supplied as per their demand."

The Collectors were advised to encourage and support plasma collection in all possible ways. Since plasma collection requires two days' activity (one day for different tests and other day for collection), the government has decided to provide food and accommodation facilities to the donors at the plasma

WORLD HEPATITIS DAY 'Hepatitis B, C leading causes of liver cancer'

Bhubaneswar, July 27: Amid the novel coronavirus pandemic, the World Hepatitis Day is being observed this year with an aim to create awareness about the viral infection on the theme 'Hepatitis-free future'.

It may be noted that Viral Hepatitis are of five types - A, B, C, D and E – of which A & E spread through fecal-oral contamination whereas Hepatitis B & C are transmitted through blood and blood products.

Interacting with **Orissa POST**, Dr Sushant Kumar Sethi, senior con-Gastroenterology and Hepatology of Apollo Hospital, Bhubaneswar, said "Hepatitis B and C virus are the leading causes of liver cancer in the world. However, it is a con-



VIRUS CASELOAD SHOOTS UP TO 26,892

WHILE THE STATE REPORTED 1,503 FRESH CASES, SEVEN MORE DEATHS TOOK TOTAL MORTALITIES TO 147

Bhubaneswar, July 27: State's COVID-19 tally shot up to 26,892 with 1,503 fresh cases, while the death toll rose to 147 as seven more people succumbed to the virus, an official of the Health and Family Welfare (H&FW) department said Monday.

Three deaths were reported from Ganjam and a fatality each was recorded in Sundargarh, Bhubaneswar, Cuttack and Malkangiri, said the official, adding that most of the deceased were also suffering from other health conditions such as diabetes and hyper-

Apart from 147 COVID-19 deaths, as many as 34 COVID patients have also died in the state but the authority attributed their deaths as 'other than COVID'.

Out of 1,503 new cases reported form 28 districts, 1,002 were from various quarantine centres while the rest 501 are local contact cases.

Ganjam district, Odisha's coronavirus hotspot, also accounted for the highest number of 491 fresh cases, followed by Khurda (223), Cuttack (136), Gajapati and Kandhamal 73 each, Rayagada (68), Sundargarh (57) and Jajpur (51).

Ganjam district continued to be in the top with 9,169 positive cases followed by Khurda (3,620), Cuttack (1,825), Sundargarh (1,110) and Gajapati (1,056).

Meanwhile, 581 persons recovered Monday.

The Capital city's COVID-19 tally breached 2,100-mark with detection of 159 fresh cases in Bhubaneswar Monday.

Of the fresh cases, 118 were detected from quarantine centres and 41 were local contact cases, the Bhubaneswar Municipal Corporation (BMC) said.

The civic body claimed to have detected a maximum of 44 cases from Trinath slum in Nayapalli area, followed by 20 from Aiginia area, on the outskirts of Bhubaneswar, and 13 from Unit-III in Kharavela Nagar

Meanwhile, 102 persons in City who had earlier tested positive for the viral infection recovered from the disease Monday, the civic body said.

With this, Bhubaneswar has 1,125 active virus cases while 1011 have so far recovered from the disease. The Temple City has so far seen 2,150 COVID-19 cases and 12 deaths due to the viral infection.

The Cuttack Municipal Corporation (CMC), meanwhile, detected 65 COVID-19 cases Monday.

While 59 were quarantine cases, six were local contact cases, said the CMC, adding that it also recorded eight recoveries.

The Silver City has 423 active cases while 304 have recovered from the infection. The Millennium city has so far seen 736 COVID cases

Bhubaneswar, July 27: Aditya Ashwini Hospitals Chandrasekharpur was Monday added to the list of Dedicated COVID Hospitals (DCH) in the city making total seats in the DCHs to 1,175 and the total ICU beds 115. The new hospital has 150 beds including 30 ICU beds and 21 high dependency

It can be mentioned here that while KIMS COVID Hospital in the city has 500 beds including 45 ICU beds, the IMS-SUM Hospital has 525 beds with 25 ICUs with it. These two also come under the DCH category. The DCH category healthcare facilities are meant to treat serious and critical COVID patients.

Currently, the COVID Health Centre (CHC) at Urban Community Health Centre, Patia, is having 60 beds



for the treatment of mildly symptomatic individuals. Another 50 will be added soon to UCHC at Dumduma area under this category.

Similarly, the city has COVID Care Centres (CCC) for asymptomatic and very mild symptomatic patients. While the High-Tech Medical has 550 beds under this category, the SIDBI Jaydev Vihar has 40 beds under its belt to treat patients.

Interestingly, COVID Care Homes (CCHs) are being planned for three administrative zones of the Bhubaneswar Municipal Corporation (BMC) area and these

tribution from the MLA Local Area Development (MLALAD) Fund of the respective MLAs of the city. These CCHs will have 50 beds each.

Sources in BMC also informed that various resident welfare associations, non-government organisations and religious bodies have also given proposal to come forward with COVID Care homes in near future.

Summing up, all the seats at the DCH, CCC, CHC and CCH combined will be 3,521 and the number of ICU beds will be 115 and 21 HDU beds respectively to serve the growing number of COVID patients.

It can be mentioned here that with the city aiming for 1,400 tests in a day, more and more cases are being detected from various healthcare centres and mobile testing centres across the State Capital.

Women risk lives fishing in croc-infested rivers

Kendrapara, July 27: The coronavirus pandemic has created an unprecedented situation for the people residing in the remote corners of this district. The situation has become acute with the return of migrant workers to their homes.

In such a situation, people are mortgaging their lives and taking up dangerous jobs like fishing in crocodile infested rivers and creeks to earn a living due to lack of any alternative means of livelihood, a report said. As a result, they often fall prey to crocodiles. The awareness programmes conducted by the forest department have gone

These people could be seen in rivers and creeks inside Bhitarkanika National Park catching fish as soon as the tide recedes in the sea. These people catch fish and prawns from the rivers inside the park and sell them in the market. However, what they earn in return is far less than the hard work they put in and the life risk involved in the job. A fisherwoman Seeta Maiti alleged that the fish traders gain the most from the fish catch. The fisherwomen catching fish sell prawns at Rs 70-80 per kg, while the fish traders sell the same at Rs 200-800 per kg depending on the market conditions.

Alarmingly, more women and minor girls could be seen catching fish and prawns from these water

According to a report by the forest department 16 persons have died in crocodile attacks during the last 10 years. However, locals claimed the number of deaths in crocodile attacks could be more

than 40 during this period. Moreover, several persons have been injured in crocodile attacks. Some of them have been discharged after recovery while a lot more are still undergoing treatment.

A woman Kalpana Mandal, 32, of seaside Talachua village said catching prawns from the water bodies inside the sanctuary is a daily affair for her as the male members of her house work outside of the state. The money sent by them is insufficient to manage a large family of hers for which she and other women in her village catch fish and prawn from the water bodies inside the sanctuary to boost their family income. She however sounded a word of caution stating that one has to be fearless, vigilant as well as skilled while catching fish from the crocodile infested water bodies inside the sanctuary.

Another woman Parbati Maiti said, that three types of methods are adopted while catching prawns from the rivers. May use traditional fishing nets like 'Jhumpa' and 'Munduli' while snare and fishing nets are used in some other places.

A piece of chicken meat or a small fish is used as bait in a snare to catch fish and prawns, she said.

Prawn is caught in large numbers during night. Villagers get inside the rivers at night holding lanterns, torches and emergency lights to catch prawns.

Narayan Haldar, president of Odisha Fishermen Association said over 3,000 fishermen families are residing in the seaside villages and earn their living by catching fish and prawns. He lamented that at least five fishermen and women die every vear in crocodile attacks but they hardly get adequate compensation from the forest department.

Debashis Bhoi, forest range officer, said there are lots of crocodiles in the water bodies inside the sanctuary. These reptiles become violent during their breeding season and end up killing humans who enter the water bodies to catch fish. The forest department is regularly conducting awareness programmes and arresting people illegally catching fish but these measures have failed to deter violators, Bhoi added.

16-YEAR-OLD, BATHING IN RIVER, KILLED BY CROCODILE

KENDRAPARA: A 16-year-old boy was killed by a crocodile in Kendrapara district, officials said

The incident happened on Sunday when the boy, Rudra Narayan Behera, was taking bath in the Kharasrota river in Parimukundpur village, they said.

The crocodile came out of the river and pounced on him, a forest official said. The mutilated body was later fished out by fire brigade personnel, he said.

His family will be given Rs 4 lakh compensation as per the state government's scheme related to the death of a person due to attack by protected wild animals, he added. Lethal assault by crocodiles

and consequent retaliatory attack by human beings have become a regular affair in this part of the state, the forest official said.

About a dozen people and hordes of domestic animals lose their lives each year as a result of the conflicts, he said.

These are most frequent during the monsoon and winter months. the nesting season of the estuarine crocodiles, the forest official said. It has been observed that adult crocodiles, under normal circumstances, do not leave their territory to chase human beings on land, unlike terrestrial predatory animals such as tigers.

Most often, the mishaps occur when the victims intrude into their habitat, for illegal fishing, poaching, firewood collection and honey collection, he said.

The crocodiles, in the wake of depleted food reserves in the river system, also stray into nearby rivulets and nullahs.

The number of saltwater crocodiles, the species which are not found in any other river system in Odisha, stood at 1,757, as per the census conducted in January in the Bhitarkanika Wildlife

Boinda, July 27: For the people living in 15 panchayats close to Handapa forest range in Angul district, sleepless nights have become the 'new normal'. They alleged that a marauding herd of elephants coming from Rairakhol forest is constantly terrorising them. Hence they cannot sleep at night fearing attack by the herd.

The villagers said that a tusker in the herd has so far killed eight people and the animals have destroyed standing crops on 1,017 farmlands in the last seven years

Panic has affected the villagers to such an extent that even a rumour about the herd entering the area prevents them from venturing out after dusk. "We are living in constant fear. The farmers are losing their hard-grown crops to these pachyderms. The tusker which has so far trampled eight villagers to death should be tranquilised and relocated to Nandankanan zoo," observed Pati Sahu, a resident

of Kanteikulia village. According to some villagers, the Handapa range, stretching over an area of 18,894 hectares, has 15 panchayats on its fringes. It has been a common practice for elephants to sneak into Handapa range from

Sources said the herd has also destroyed 127 thatched and asbestos houses. During the same period, the elephants have damaged 592 acres of paddy crops and 265 acres of vegetables. The pachyderms have also caused extensive damage to mango, banana and jackfruit trees planted in 160 acres.

Sujit Mohapatra, a resident of Rajanpal village, alleged the forest department officials are not patrolling regularly. "This apart, most of the villages have poor mobile network. So the villagers have problems in informing the officials about the movement of the elephants," he said.

"The forest department is providing compensation to the affected families and farmers. However, that is not being done in a proper manner with many left out," alleged the villagers.

Since the forest department has failed in protecting the lives and properties of the villagers, resentment is brewing among the residents of the affected areas.

When contacted, Handapa ranger, Chaitanya Behera said, "As people are destroying jungles, they are damaging the habitats and corridors of the elephants. So, in search of food, they often sneak into the villages. We are taking steps to drive away the elephants. We have dedicated teams for the job and we are also providing compensation.'

How this village became a bird paradise

Kamakhyanagar, July 27: To understand how closely nature, birds and human beings are related to each other, Nua Rekula village under Kamakhyanagar block in Dhenkanal district will be a perfect destination. As one enters Nua Rekula, he will

be welcomed with a continuous vet pleasant chirping of about 10,000 birds. They have nested in 10 large trees in the village If you think these birds are native to this area, you are mistaken. This

time every year these winged guests come here for mating and laying eggs. And the huge trees in the village provide them with a perfect place for having their nests. This season, these winged guests

arrived at Nua Rekula in June itself. Presently they are laying eggs. They will return to their natural habitats in October when the chicks come out of eggs.

These birds come to this village from faraway places every year not so much for the huge trees but for the love and care they get from the villagers.

The villagers treat them as their guests. During these four to five months, they make it a point not to disturb or cause any harm to the birds. Besides feeding them all through this period, they take great care of chicks if they fall off trees.

Meanwhile, Nua Rekula has already earned a name for itself as a bird paradise. The hunters of nearby villages know better than

to hunt birds here.

According to the villagers, the birds had been flocking onto a huge tree close to the famous 'Hadajoda Kendra' (a fractured bone care centre) for 40 years. It has been four to five years that they have started flocking onto the other trees in the village.

Over the years, people have begun to believe that the birds bring good luck to the village. They believe, more the number of visiting birds, more prosperous their village will be. All the villagers take great care of these winged

"Forget our belief about these birds being the harbinger of prosperity. The scenes these colourful birds offer us in mornings and evenings when they fly from the trees fluttering their wings in flocks are real and precious," a villager said.

'Seeing them flying in flocks is indeed a feast for the eyes. The scene is

to be seen to be believed," they added. "Beauty apart, the avian guests help the ecosystem thrive as they keep the number of insects to a minimum level. It helps the farmers of our village immensely," an-

other man said. Tehsildar Sanjay Kumar Rout, also an ornithologist, says, "The seasonal guests mostly include six to seven varieties of birds. Cattle Egret, Little Egret, Middle Egret and Pond Heron are the most noticeable ones. During their stay here, they get plenty of food. Small fish and insects are their favourite food.'

"The female birds change their colours at the time of mating and this offers a scene out of any of famous avian lands in foreign countries. They play a significant role in maintaining

the ecological balance," he added. According to Kamakhvanagar west ern region range officer Bibhudananda Mishra, these birds have turned the area into heaven, literally. "The forest department is taking all measures to protect these guests from hunters. We are getting all supports

from the villagers," he added An Ayurveda practitioner Sarveshwar Patra says, "The entire area is filled with a distinct stench for four to five months owing to the droppings of these birds. That said, the vilagers never drive them away."

opefully, the long standing dispute over Ram Mandir-Babri Masjid will come to some kind of calming down on Wednesday, 5 August 2020. The issue of Ram Lala has been dragging for over a century and it has always taken the garb of politics more than religious devotion. Undoubtedly, the persona of Ram is only mythical and definitely not historical. When emotions run high, then the issue of proof does not matter. It would also be improper on our part to comment about the veracity of any given particular geographical location as the birthplace of a mythical Perfect Man. The Ramayana has been an integral part of Hindoo beliefs and as the protagonist of that war based religious story, Ram has invoked the sense of perfection of human existence. There are of course contrarians who believe that many acts of Ram as husband, brother or king do not necessarily embody the best that is expected from a male in an ever evolving world.

The Bhoomi Pujan or foundation stone laying ceremony has been long awaited with bated breath by many Hindoos. Prime Minister Narendra Modi must have been blessed for some good deeds for which he has been ordained to be the lucky one to lay this foundation stone. Here too, people have piped up with views that do not deserve too much attention. There are those who draw a parallel to the 1951 inauguration of the newly built Somnath temple in Gujarat by the then President Dr Rajendra Prasad. Citizens have to be told, over and over again, that the spectre of the disease is not imaginary and nor is the terrible damage to the nation's economy. It is an admitted fact that Indians are most stubborn with their bad habits. They are people who love to be in the midst of crowds. Unlike many other nationalities where people prefer to be left alone, we, as a race, always want physical proximity to others. It is these habits that could damage India in the long run. t wasn't the earliest mention of this curious hybrid, the first having been in the Harrison Times of Arkansas in 1911, though it, too, referred to a bird accidentally bred in Norfolk. The name must have been fairly widely known by 1920, since a horse named Swoose was racing then. The Daily Mail mentioned the birds several times that year, reporting that the young sweese were terrorising the farmyard and killing ducks. "Of late," the paper noted, "their character has been relapsing into such savagery as may prove their ruin." News of the birds spread widely. If we are to believe this American report, their name briefly became part of the vernacular: "Much public interest is evinced in these queer birds and nowadays when an illtempered husband rouses his wife to the point of retaliation, she gives vent to her feelings in the culminating insult: "You swoose!," as stated in Wisconsin State Journal, 5 September, 1920. A few other sweese appeared in the 1920s and 1930s as crosses between various breeds of goose and swan that were kept together on farms. The word reached the hit parade in 1941 when Alexander the Swoose, a song performed by the Kay Kyser band, reached number 3 in the charts. This led directly to the most famous swoose a B-17 bomber that American forces based in Australia had created by cannibalising other aircraft and nicknamed the Swoose because of its hybrid character. It was piloted by Frank Kurtz, who in 1944 named his daughter after the plane. Swoosie Kurtz has become a well-known actress. She was once asked whether she had thought of changing her name: "Change it to what - Tiffany? It's been an advantage. It's unforgettable. I'm the only one."

Synaesthete

This word is moderately common in the psychological and artistic fields. It refers to a person who has some kind of cross-wiring in the brain, so that things which ought to be perceived by one sense are instead felt in another. The most common form is for language, sounds and tastes to be sensed as colours. For a synaesthete, the words on this page might have colour associations; many musicians say that different keys evoke characteristic colours; or those affected may experience the sense of taste as hues. For any one individual, the transfer between senses is always the same, but there seems to be no accord between affected individuals about what sensation evokes what effect. COVID BUSTS MYTHS

The economy is in a bad shape. Everyone knows and experiences the adverse impacts of a fall in growth. In a way, all reference points have disappeared like they do in a tsunami. We don't know if the sea is on the land or the land is in the sea. Marooned in such a situation, official economic indicators have little meaning.

Yet, some pointers are available on the extent of the collapse though the government has cautioned the people against any comparisons with the past. Factory output as measured in the Index of Industrial Production (IIP), which tracks manufacturing, mining and electricity, is in a free-fall. The IIP for April and May, the first two months of lockdown, reports a 45 per cent fall from the same period last year. The collapse, not unexpected, comes on the back of negative numbers that began showing up pre-pandemic in the last fiscal. For example, IIP was down 4.3 per cent in September 2019, with mining down 8.5 per cent, manufacturing down 3.9 per cent and electricity down 2.6 per cent.

The national economy is hit hard by the pandemic at a time it was already weak. The numbers quantify one part, but they also point to what can't be measured the yet-to-come cascading impact on investments, spending patterns and overall attitudes and behaviour that could dramatically alter some basic constructs.

Take the example of cement, in which India has the second highest installed capacity in the world with some one million people employed therein. The industry shut shop during the lockdown and opened up as the lockdown eased. But, it still has unused stocks that reflect the weak off-take in construction, which reflects the collapse of demand. This scenario is likely to worsen as more companies in IT services space take to working from home and dramatically lower their office space usage.

So, even if there is a pick-up in IIP, it will run into show stoppers of the kind that will emerge from several quarters as businesses and citizens adjust to changing paradigms. Clearly, it is too early to read 'green shoots' (a term used

five times in the government's Macroeconomic Report, June, 2020) into numbers even when they indicate a pick-up.

Consider, then, the "crucial cushion to external shocks" in the nature of forex reserves at \$475.64 billion as on July 10. This looks robust by itself till one appreciates the fact that the total external debt stood at \$558.5 billion (March-end, 2020 figures). Total reserves can finance only about 85 per cent of external debt; and short-term residual maturity (maturing in less than 12 months) of external debt accounts for some 50 per cent of total reserves. This was fine in a stable world. In a geopolitical climate brimming with volatile hotspots, this should not offer comfort. Accretion to reserves was high in 2019-20 at \$59.3 billion but as economist Dr. RK Pattnaik has noted, it contains an unusually high "other capital receipts" portion of \$18.4 billion, which includes forex that came in but was in all likelihood not deployed as the market turned messy and the pandemic spread across the globe. This tells us of the huge gaps that now stand between plans, investments and execution. again an indication of uncertainty that points to dangers in the external sector in a world where globalisation is in retreat.

India's current account balance may generate a small surplus in the first quarter of this fiscal but this will be because the economy has stalled, leading to a collapse in imports. That isn't good news either.

India weathered the 2008 financial crisis rather well but that came at a time the nation had recorded a five-year period of growth in the region of 8 per cent. For a crisis like the pandemic that is far worse, India enters with an economy that is far weaker than we have known for a long time. In the January-March quarter of 2019-20, growth was down to 3.1 per cent-taking India back to the socalled Hindu rate of growth of the pre liberalisation days. For the full year, growth was 4.1 per cent,

the lowest recorded in 11 years. At the same time, inflation is up and has crossed the upper limit of 6 per cent in April-May-June quarter, telling us that prices have risen beyond tolerance level, just when incomes have fallen drastically RBI has lowered rates repeatedly (cumulatively 225 basis points from February 2019 to date), but the classical argument that this would lower rates to retail borrowers and businesses, making it easier to buy and invest more, remained a mythical story.

There is clearly an immediate crisis but the Indian economy also faces a larger crisis of vision, direction and integrity. Numbers can't tell us about this crisis and indeed a crisis like Covid-19 conceals inherent weaknesses. It is the inherent weaknesses that do not allow the nation to look up almost three decades after liberalisation promised to unshackle India and unlock its entrepreneurial energies.

Instead, we have had one worse - an unresponsive public sector

of the past replaced by a post-lib eralisation private sector that continues to pull privilege, comfort and support of public institutions and stays far less answerable to people and to Parliament. The story of rising NPAs that have led to a fall in trust in banking sector tells us not only of the collusion between crooked bankers and businesses but also of the failure of the sector to regulate, appraise and take a call on what should be its fundamental activity - whetting ideas and proposals, giving out loans and monitoring their use. It tells us of the cover that the system offers to those who take public money and misuse it or divert it with impunity, and of a regulatory system that holds none of this to account. On July 19, it was the All India Bank Employees Association that released a list of willful defaulters - the term itself is an oxymoron but it is so legitimised that we don't stop to think how it might look if the crime were a little different-like willful murderers, or willful dacoits. Yet it is the AIBEA that wants an ordinance to go after these people, not the government. All of this is pre-Covid stash but it will determine

It is said that a time of crisis tests mettle, resilience and character. The Indian economy and its key drivers are likely to come out poor on these fronts. The way businesses pushed or coerced the government while a majority of the "leaders' and Twitterati CEOs fell silent when labour laws were suspended by many states tells us again that India may have opened up and liberalised three decades ago but the license-quota-permit Raj did not go away. The 'yes-man' culture lives on. The loot continued. The looters changed. In a vibrant economy, downturns can come and go. Disruptive change opens opportunities for new players who drive innovation, new products and services as some of the entrenched vacate space. In an economy oiled by high order graft, downturns expose grimy layers. Nothing happens. The poor suffer even more.

ndian agriculture is a complex mix. It has myriad problems and the solutions suggested are often not practical. Interestingly, the largest beneficiaries of the food dole to the 80 crore poor are the producers of the food grains!

It is a dichotomy. Often, in terms

of agriculture, privatisation, private investment and handing it over to private hands become the policy plank. The more this is discussed and "reformed" through ordinances, the government is getting more enmeshed in it by direct benefit transfers - ₹6,000 pension for farmers and dismantling their mandis (local wholesale markets) under the agriculture produce committees (APMC), easing Essential Commodities Act and facilitating contract farming.

The policy confusion is apparent. The first major agriculture reform was the Green Revolution, creation of mandis and setting up the FCI for procurement, creating buffer stock and distribution. It has its pluses and some minuses too. Except at purchasing level, the government is not involved.

Farmers still are making their own investments, may be now through bank support extended by

the kisan credit card or simply bank loans. Government institutions selling seeds, fertilizer or other support do it at commercial rates and a bogey had been created that the farmers are dependent on the government. The mandis, despite many flaws, served them well and assured payments. The mahajan (moneylender) system found their roles limited, but not eliminated.

The Sukhis are still there for smaller tillers who do not find it easy to have bank support. The new ordinances are euphoric about a pan-India market – a complex and expensive system, "larger" involvement of private sector, a euphemism for multinational involvement in the farm sector, which is operating for almost two decades through various "cash and carry" wholesale trade. Some Indian firms too have entered the scenario. In Kashmir, some companies have monopolised apple trade through their leased orchards; in other places, motley groups manage partially grape, orange, mango and spices trading.

Many have emerged as parallels of FCI. But, farmers have a concern. They become their pawn and alternative support is difficult once a contract is signed. The ordinances for demolition of this alternative are a concern for many farmers' organisations. Again it is all private investment that most official functionaries take pride in. That is the plus and minus. The nlus is "investment". The minus is it creates a larger chunk of farmers looking for direct government support for survival.

The lockdown has opened up the chinks. The government is trying to correct it through enormous stock it built in FCI warehouses through the years of toil. It is distributing food grain worth ₹1.5 lakh crore for free till at least November 2020, from April onwards for over 60 per cent of the population.

Despite years of deliberations, the nation has got into the same quagmire of government support to farming instead of promoting individual farmer's capabilities. The APMC mandis have flaws though it is a robust system. Since it is still an ordinance, the policymakers need to relook at this for removing the flaws but prevent its demolition. The ordinance should for now not be enacted into statutory law.

Over the years, corporate cartels have created lobbies to control the base of Indian economy agriculture. It is profit-oriented. but at the cost of sustenance of the farming community. The farmers need monetary support all through the year. They need small credits. This is provided by buyers at mandis and adjusted against final sales. The payments to farmers are assured in the system. Yes, this creates a kind of bondage too. There are instances of it being exploited as well.

The pan-India market is there in mandis as well. Many farmers have taken their produce from Punjab to sell at Bihar mandis for better price. The present ordinances try to legalise that but creating monolith of large corporate players. Politically it suits various operators as election funding in bulk is assured. Practically, the nation is creating a convoluted system, where the involvement of the government at micro level would increase.

There is another apprehension. Sizeable sections of the farmers may be controlled through Vikas Dubey-type goons creating severe law and order issues - in short perpetuation of more powerful Sukhis and dumping more costs on the state.

Bangladesh & India

properties make them useful in aerospace, automobile and construction industries," Haridoss

"Carbon nanotube-reinforced polymers combine the viscoelastic properties of the polymer with the interfacial properties of the CNT, resulting in enhanced vibration damping," he added.

Thus, CNT loaded polymers can conceivably give you a smoother

ride on your car, but the team decided to find out why.

They used MWCNTs synthesised by different techniques and loaded them into Epoxy polymers. MWCT's are made of concentric tubes of carbon, and the slide between the layers is believed to damp vibrations. Naturally, the efficacy of damping would depend on the nature of the MWCNTs.

"In order to visualize the damping effects of the two types of MWCNTs, the researchers performed computational simulation studies," Haridoss said.

"Our simulation studies have shown beyond doubt that the vibration damping properties in MWCNTs arise from the interaction between atoms that constitute the inner and outer tubes rather than the inter-tube frictional energy

Set up committee on **OBC** reservation in medical courses: HC



Chennai, July 27: After a long battle, the Madras High Court has directed the Centre to implement OBC reservation in the All India Medical Quota seats. The Court asked the Central government to form a panel comprising of Tamil of implementation of reservation in the all India quota seats.

The High Court Monday ordered the central government to set up a committee within three months to decide on the issue of 50 per cent reservation for Other Backward Classes (OBCs) in admissions to medical courses under the all-India quota.

Disposing of a batch of petitions filed by the ruling AIADMK, DMK, PMK and others to demand 50 per cent reservation for the OBCs in the medical college seats surrendered to the all-India quota, the First Bench comprising Chief Justice AP Sahi and Justice Senthilkumar Ramamoorthy said the Centre can also pass a law on the matter.

The court said the committee should have representatives from the central and Tamil Nadu governments and the Medical Council of India (MCI).

'The High Court rejected the contentions of the MCI and the Centre. The court did not agree

that only the Supreme Court can decide on the issue," P.Wilson, Senior Advocate and DMK's Rajya Sabha member, told IANS.

"The High Court also did not agree that reservation will dilute the merit since the merit list is prepared first and reservation is applied only later," Wilson said.

According to him, the proposed committee will have representatives from the Health Ministry, MCI and the Tamil Nadu Health Department. "This will have an impact other states as well," Wilson added.

Earlier, the Supreme Court declining to hear the pleas of various political parties and asked them approach the High Court on the matter. The central government had refused to grant 50 per cent reservation for OBCs as per the Tamil Nadu law in medical seats for 2020-21.

During the hearing, the Centre told the court that the state can follow its own law with regard to reservation in admissions, but it cannot exceed 50 per cent of the total seats.

On their part, the petitioner parties said that the Centre can decide on the subject only when a state government has not enacted a law on reservation. Only the state government has the power to decide on the reservation, it was

With mounting debts, fiscal commitments, survival continues to be at stake, say Tamil Nadu hoteliers

Chennai, July 27: No profit in takeaways, mounting debts and fiscal commitments, including salaries, have made survival of hotels and restaurants in the state difficult in these pandemic times, according to

Hotels in Chennai and those in the Tier-II and III cities which offer takeaway menus, find the response from the people to be slow and unprofitable, owing to the pandemic.

As part of its efforts to curb the spread of coronavirus in Tamil Nadu, the state government has allowed hotels and restaurants only takeaway services.

There are an estimated 50,000 hotels and restaurants in Tamil Nadu and they have been allowed to provide takeaway services of food items but not dine-in.

Some hotels even launched takeaway menu options which can be ordered over phone, allowing people to enjoy a sumptuous meal sitting in the safety and comfort of

"Lodges and hotels are suffering due to lack of business and the parcel (takeaway) service has seen only 25 per cent business and is least profitable," M Venkada Subbu, president, The Tamil Nadu Hotels Association, said

Uncertainty continues to shadow the sector and the hoteliers are not sure when the conditions would improve and pave the way for usual business activity, he said.

"Even if the hotels reopen in a big way from August 1, there will be no business for the next two months. Thereafter, it may pick up," Venkada Subbu told PTI.

R Rajkumar, secretary, Chennai Hotels Association, expressed concern over the revenue loss in the business ever since the lockdown came into force March 24.

Body of Covid victim cremated after locals' hour-long protests

Kottayam, July 27: The body of a Covid-19 victim, whose cremation was marred by protests Sunday, was finally cremated here under tight police security late in the day, officials said Monday.

The police also booked a municipal Councillor of the BJP and 30 persons for preventing the cremation of the 83-year-old man at a public crematorium at Muttambalam, after locals raised fears of the spread of coronavirus.

Amid protests by local residents Sunday evening, public representatives including Kottayam MLA Thiruvanchoor Radhakrishnan intervened and the cremation of the elderly person who died due to coro-

navirus infection was put on hold. However, the body was cremated at around 11.15 pm Sunday as per the Covid-19 protocol, officials said

the Covid-19 victim, a number of local residents had prevented the cremation, saying they feared contracting the infection.

The protesters had blocked the entrance of the crematorium run by the Kottayam Municipality, alleging the body was brought to the common crematorium after a Church refused to allow burial of its dead follower's body in its cemetery.

The incident happened on a day when Vice-President M Venkaiah Naidu expressed anguish over stigmatising Covid-19 patients and denial of a dignified farewell to those who succumb to the contagion.

The parents of the boy flew him to Chennai for consultation with K R Balakrishnan, chairman and director of Cardiac Sciences and director of the Heart and Lung Transplant and Mechanical Circulatory Support Programme.

The boy was initially treated

with medications for around two months, but unfortunately his condition started worsening. He became critically ill and was admitted to MGM Healthcare.

According to the hospital, the boy's condition continued to deteriorate and he suffered cardiac arrests twice, where the heart stopped beating and had to be resuscitated

with manual compressions.

The only option possible for such a small child was an artificial heart pump and since both the right and left side of his heart were affected, he needed two heart pumps.

Small pumps for such a small child known as Paediatric Biventricular pumps are made only in Germany by a company called Berlin Heart, the statement said.

However, the challenge was to fit the cannula needed for the pump inside the boy's small chest cavity. Additionally, managing anaesthesia and surgery on such a small child wearing the mandatory personal protection equipment called for the best of clinical expertise.

Experts from multiple backgrounds and countries joined via tele-conference to support the team in Chennai.

Commenting on the treatment, Dr Balakrishnan said, "This was a huge challenge, given the prevailing circumstances. Berlin Heart will support the circulation of this child till the heart recovers or he gets

a transplant. The implant procedure was performed May 25.

SC reserves verdict on PM CARES Fund

THE PETITIONER SOUGHT ORDER FOR TRANSFER OF FUNDS FROM PM CARES FUND TO NDRF

New Delhi, July 27: The Centre Monday strongly defended the PM CARES Fund in the Supreme Court saying it's a public trust meant to receive "voluntary contributions" to fight COVID-19 pandemic and the budgetary allocations for NDRF and SDRF are not "being touched".

The statement was made by the Solicitor General Tushar Mehta, appearing for the Centre, before a bench headed by Justice Ashok Bhushan which reserved its order on one of the prayers of the PIL, filed by NGO 'Centre for Public Interest Litigation (CPIL)', seeking a direction that all the money collected under the PM CARES Fund for the COVID-19 pandemic should be transferred to National Disaster Response Fund (NDRF).

The Centre March 28 had set up the Prime Minister's Citizen Assistance and Relief in Emergency Situations (PM CARES) Fund with the primary objective to deal with any kind of emergency situation like the one currently posed by the COVID-19 outbreak and provide relief to those affected.

The Prime Minister is the ex-officio chairman of the fund and the defence. Home and Finance ministers are its ex-officio trustees.

During the hearing, the Solicitor General told the bench, also comprising Justices SK Kaul and MR

Shah, that the PM CARES Fund is a "voluntary fund" while funds to the NDRF and SDRF (State Disaster Response Fund) are made available through budgetary allocations.

"It is a public trust. It is a body where you can make voluntary contributions and no budgetary allocations to the NDRF or SDRF are being touched. What has to be spent will be spent," the law officer said, adding that no law has been violated.

Senior advocate Dushyant Dave, appearing for the petitioner NGO, said they are not doubting the bona fide of anyone but the creation of the PM CARES Fund is allegedly in contravention of provisions of the Disaster Management Act.

He claimed that an audit of the NDRF is being conducted by the Comptroller and Auditor-General (CAG) but the government has said the audit of the PM CARES Fund will be done by private auditors.

Dave questioned the validity of the PM cares fund and alleged that it was a "fraud on the Constitution".

Senior advocate Kapil Sibal, appearing for another party, said that all CSR contribution benefits are given to the PM Cares Fund and they are denied to the state disaster relief funds and "these are very serious issues which need to be looked into"

Mehta said that a national plan was prepared in 2019 and that had included the ways to deal with the 'biological disaster.'

'That time no one knew of COVID. It is biological and public health disaster plan which is part of national plan. So this contention that there was no plan is factually wrong," he said, adding that the plan to tackle such disasters changes with the need. "We cannot have a constant and static plan and needs to be updated from time to time," the law officer said.

Dave, however, said a "special plan" must be brought for the COVID to ensure a coordinated approach to deal with its challenges.

On June 17, the apex court had asked the Centre to file its response on the plea, which has sought a direction that all the contributions made by individuals and institutions for the COVID-19 pandemic should be credited to the NDRF, rather than to the PM CARES Fund.

Will not contest polls till J&K is a UT: Omar

New Delhi, July 27: Former Jammu and Kashmir Chief Minister and National Conference (NC) leader Omar Abdullah, who was released from a prolonged detention some time back, has said that he will not contest Assembly elections till the time J&K remains a Union Territory

In an opinion piece published in a newspaper, Omar Abdullah has written that he will not be contesting Assembly elections in Jammu and Kashmir. He has written. "As for me. I am verv clear that while J&K remains a Union Territory I will not be contesting any Assembly elections. Having been a member of the most empowered Assembly in the land and that, too, as the leader of that Assembly for six years, I simply cannot and will not be a member of a House that has been disempowered the way ours has." Omar Abdullah has also writ-

ten about a meeting he attended with Prime Minister Narendra Modi ahead of the abrogation of Article 370 August 5, 2019 when Jammu and Kashmir was stripped of its special status and bifurcated into two Union Territories.

'Some of us, senior office-bearers of the J&K National Conference, had a meeting with the PM just days before the August 5 develop-



ments. It's not a meeting I will for get in a hurry. One day I may write about it but propriety precludes me from saying more than that we left the meeting with a completely different impression about what was going to unfold in the next 72 hours. In one fell swoop, everything we had feared came to pass,'

said Omar Abdullah in his article. The former Chief Minister, in his article has also said that the promises made to Jammu and Kashmir were not fulfilled and the removal of Article 370 was "not the right thing to do"

"J&K participated in democratic processes, shared in nation's development but the promise made with it wasn't kept. Removing 370 may have been the popular thing to do, but going back on a nation's sovereign commitments was not the right thing to do," the NC leader has said.

He also said. "After the re-election of Prime Minister Modi, rumours started to float about the intentions of the BJP to use its absolute majority in the Lok Sabha to implement its poll promise of abrogating Article 370."

SC seeks UGC's response on holding final year exams amid pandemic

New Delhi, July 27: The Supreme Court Monday sought a response from the University Grant Commission (UGC) over its guidelines mandating universities across the country to hold their final year exams by September 30

A three-judge bench of the apex court comprising Justices Ashok Bhushan, R Subhash Reddy and MR Shah issued the notice in a batch of petitions filed in the court against the UGC guidelines.

The bench asked the UGC to file its response by July 31 – the next date

During the hearing, Justice Ashok Bhushan asked Solicitor General Tushar Mehta if he required time to seek instructions.

Mehta submitted that the UGC is only concerned with final year exams. He said that there are 818 universities in the country and out of these, 35 have not conducted final year exams. He appraised the court that 209 universities have completed the exams and 394 are in the process of conducting the exams. The Solicitor General further submitted that students have been given the option to take the exams online, offline, or a merger of both.

However, senior advocate Abhishek Manu Singhvi, appearing for the petitioner, called the decision of the UGC unrealistic. He submitted in the court that the decision to hold final year exams amid the COVID-19 pandemic was "unrealistic and remarkable". He further argued that states have been given no discretion on the issue, despite expressing their objections.

Meanwhile, the Solicitor General submitted that the UGC would file a common reply to the batch of the petitions filed in the Supreme Court.

It is to be mentioned here that several petitions have been filed by the students from universities across the country challenging the UGC guidelines as being arbitrary, given that it would compel students to appear in exams during the COVID-19 pandemic, thereby posing a risk to their health.

He had kidnapped the 20year-old woman from Dhar district, said Superintendent of Police Vipul Shrivastava, "Rehmat is a history-sheeter with nine cases against his name. He also has three cases of kidnapping and rape. He has already served a jail sentence in one rape case," the official said.

By boat and on foot, Assam hunts for plasma for COVID patients

Guwahati, July 27: When doctors in flood-ravaged Assam urgently sought plasma of a particular blood type for a COVID-19 patient this month, health officials sent a boat for a marooned donor who had recovered from the disease weeks ago.

With coronavirus cases surging in Assam and critical medicines running low, local authorities are rolling out the red carpet for nowcured patients - all for their blood plasma believed to be rich in virus antibody, although research on its efficacy has not been conclusive.

Assam says that symptomatic patients who donate plasma four

weeks after recovery will get preference in government jobs and housing. For example, a donor may get extra marks if he or she is tied in any test or interview for a job.

It is also offering to cover travel and other expenses for donors from outside the state, and has been making its frontline workers scour the state - sometimes wading through flood waters - to bring willing participants to plasma donation centres.

The success of the overall effort is crucial for Assam, one of the poorest states that is short of remdesivir and tocilizumab to treat severe COVID-19 patients. Delhi and Odisha are also courting plasma donors as India's total infections have leaped to 1.4 million with

'When we learned that a person was willing to donate, people went to his house by boat, brought him to the hospital and got the donation done.

He declined to identify the donor but said the recipient was doing well.

Plasma from a previously infected person can be used to treat up to two moderately ill patients, Sarma said. Without timely treatment, such patients' condition can potentially worsen, further straining the limited pool for medicines.

Grey market Assam, where floods have so far killed around 100 people and affected roughly 3 million, is predicting coronavirus infections will peak in mid-September. It has so far reported more than 32,000 cases with 79 deaths.

Its push for plasma comes as India, the world's biggest suppliers of generic drugs, scrambles to end a local shortage of remdesivir and tocilizumab.

Sarma said that until recently, Assam was receiving only 12-16 remdesivir vials a day compared to a demand for at least 100. But the situation eased when Assam got 400 vials from a local company some

days ago, he said. 'Still, people are not doing enough production and obviously a grey market has emerged as a result, Sarma said.





It was found that Gurpatwant Singh Pannun, chief protagonist of 'Sikhs for Justice', has uploaded a highly provocative video (duration 138 seconds) on June 18 instigating the Sikh soldiers of Indian Army to desert and join his secessionist

> A similar audio message (115 seconds) of Pannun directly instigating the Sikh soldiers, was also sent to Global System

for Mobile Communications (GSM) subscribers, in Punjab and nearby areas through the international telemarketing numbers the same day. The message was later also disseminated through social media.

Pannun, in the video, has falsely claimed that only Sikh soldiers were killed in the conflict and has accused India of using Sikhs in the Army as 'watchmen', "Pannun has also claimed that though the theatre of conflict was 'Kashmir' but the 'sacrifice' was made by Sikhs. He also stated that SFJ would pay Massachusetts, North America," salary plus ₹5,000 to the Sikh soldiers deserting Indian Army.

JeM handlers shared code: NIA

Corona patient found dead

India has secured place among countries showing the lowest fatality rates in the world, according to the Ministry of Health and Family Welfare (MoHFW). The Ministry said focused efforts of the governments on early detection and isolation through aggressive testing and efficient clinical management of hospitalised cases helped lower the case fatality rate and improve the

With effective containment strategy, aggressive testing and stan-

dardised clinical management protocols based on a holistic standard of care, the fatality rate had dipped, it added. "The case fatality rate is falling. It's 2.28 per cent at present," the Ministry data showed. Continuing the streak of over 30,000 recoveries a day for the 4th successive day, the Ministry said 31,991 patients were discharged in the last 24 hours.

It has taken the number of recoveries to 9,17,567, showing 64 per cent recovery rate. Because of low mortality and more people recovering, the recovered cases exceeded the active cases (4,85,114) by 4,32,453 on Monday. "Medical attention continues to be provided to all active cases in hospitals and home settings," it said.

During the day, India reported the highest single-day spike of 49,931 cases, taking the total to 14,35,453. With 708



Being the third-worst hit country, India is now adding 100,000 cases in less than three days. Last Monday, India had crossed the 11 lakh-mark and within seven days it added 300,000 more cases. Maharashtra remained the worst-

hit state after recording single-day spike of 9,431 cases, taking the state's tally to 3,75,799. Of this, 13,656 people have died. Maharashtra is followed by Tamil Nadu (2,13,723), Delhi (1,30,606), Karnataka (96,141) and Andhra Pradesh (96,298).

The national capital recorded a single-day spike of 1,075 cases, taking the tally beyond 1.3 lakh cases. Of this, 11,904 were active cases, 3,827 fatalities and 1,14,875 discharged. States and UTs that recorded less than 1,000 cases were the Andaman and Nicobar Islands (324), Dadra and Nagar Haveli (914), Chandigarh (887), Mizoram (361), Meghalaya (702) and Sikkim (545).

On the global front, the number of Covid-19 cases has topped 16.1 million, and deaths crossed 647,000, according to Johns Hopkins University. As of Monday, the number of cases stood at 16,199,796 and fatalities rose to 647,910, the University's Center for Systems Science and Engineering's (CSSE) latest update revealed.

New Delhi/Mumbai, July 27: The digital divide stretches long and deep across the expanse of India, further separating the haves from the have-nots and the techempowered from the tech-deprived with millions of children struggling to keep up with the challenges of online classes

The coronavirus pandemic that $% \left(1\right) =\left(1\right) \left(1\right) \left($ forced people into their homes and forced schools and colleges to move to virtual classes has edged education dreams with conditions aplenty - a computer or at least a smartphone, proper internet connectivity and uninterrupted power

The education playing field, never really level, is now potholed and bumpy as students, and their teachers, in cities, towns and villages scramble to cope with the demands

the floodplains of the Yamuna along the Delhi-Noida border, for instance, have never had it easy. They would cross the river in a boat to reach school, just minutes away from the bright lights of the national capital and its suburb. Four months ago, when India went into lockdown, their odds increased manifold.

Joshna Kumar: 12, has a phone but often no electricity so it is difficult to attend her online classes everyday. Most residents of the settlement rely on Charan Singh, a cattle rearer who visits daily, to charge their phones. And so does she.

"Every evening I give my phone for charging. He brings it charged next morning," she said, sitting on a charpoy in the backyard of her home, quickly scrolling through her Whatsapp messages to take down notes and finish her home-

work. To save battery, Joshna keeps the brightness of her phone low.

Her 10-year-old brother studying in the same school mostly stays away from class. When he does attend, Joshna has to miss school and catch up through pre-recorded videos. Their father is a daily wage worker and another phone cannot happen for them.

Her story finds echo in Faridabad,

Haryana, where Suchi Singh, a Class 8 student, said there is only smartphone between her three sib-

in attending class. That Suchi, a topper, is forced to

miss class troubles her father Rajesh Kumar, a newspaper vendor, but he said he has no option. A smartphone is a luxury when he is struggling to provide for his family. "Eclasses have made life difficult,' he said, pessimistic about what the future holds for him and his children.

Hundreds of kilometres away in Mumbai's Aarey Colony, Jyoti Randhe, a Class 10 student in a municipal school, shares a smartphone with her mother who takes it to work. Her classmate Roshni Nere has to divide her phone time with two sisters who also take eclasses. Roshni's mother said she is worried about her future and appeals to authorities to at least equip them with the required technology. Some students don't have that option either.



China seizes US consulate in Chengdu

Beijing/Chengdu, July 27: China Monday said it took control of the US consulate in Chengdu after it was formally closed as per Beijing's directive in retaliation to America's move to shut down the Chinese diplomatic mission in Houston.

'At 10am July 27, as required by the Chinese side, the US Consulate General in Chengdu was closed," the Foreign Ministry said in a press release. Chengdu is the capital of southwest China's Sichuan province.

Later in his media briefing, Foreign ministry spokesman Wang Wenbin said, "this morning, US personnel evacuated the Consulate in accordance with Chinese requirements, and the US consulate in Chengdu was closed".

He said the Chinese competent authority then entered from the main entrance and took over the premises. He defended the closure of US Consulate as a legitimate response to US ordering the closure of Chinese Consulate in Houston.

The current situation between China and the United States is something we do not want to see, and the responsibility rests solely with the US," he said, adding that China once again urge the US to immediately correct its mistakes and



create necessary conditions for the relationship between the two countries to return to the track of normal development.

Asked whether Chinese personnel entry into US Consulate in Chengdu was due to American officials entering Houston mission, Wang said the US has seriously violated international law and basic norms of international relations and initiated political provocations first. "China has the right to take coun-

termeasures reciprocally and safeguard its legitimate rights and interests." he said in a statement.

The American flag over the building was lowered at dawn, according to Chinese state-run broadcaster CCTV, and onlookers were moved back as a heavy police presence surrounded the consulate, which Beijing ordered to shut Friday in a tit-for-tat move

Last week, the US government ordered the closure of China's consulate in Houston, Texas, claiming the mission had been involved in a larger Chinese espionage effort using diplomatic facilities around the US.

The US State Department in a statement Monday expressed disappointment over the closure, saving the consulate "has stood at the centre of our relations with the people in Western China, including Tibet, for 35 years.'

Shortly before 11 am, several cars, a white ambulance, and dozens of Chinese workers were seen leaving the Chengdu Consulate as dozens of people lingered nearby the Hong Kong-based South China Morning Post reported.

Several side streets, as well as a main road leading to the consulate were blocked, with dozens of policemen guarding the intersections.

Cranes hoisted containers inside the main entrance of the US Consulate, while crowds gathered to witness the "historic" moment, taking photos and recording videos, state-run Global Times reported.

Beijing, July 27: China announced that the third flood of the year hit the vaunted Three Gorges Dam Sunday (July 26) and that it will peak Tuesday (July 28).

The country is already facing one of its worst floods since 1998 with water breaching record levels at key waterways and lakes.

Torrential rain triggered the third flood peak of the Yangtze river Sunday, putting the Three Gorges Dam under severe pressure as China grapples to mitigate the impact of the deluge that has already impacted more than 45 million people and resulted in losses worth billions of dollars.

Authorities have issued warnings of possible new flood peaks in the near future, requiring the Three Gorges Dam to reserve enough space for possible floods.

China began building the controversial Three Gorges Dam in 1994 as part of the government's heavy investment in flood control projects. It is the world's largest hydroelectricity dam spanning Asia's longest river, the Yangtze, and has an average capacity three times its counterparts built prior to 2000.

The mega-dam is capable of handling inflows of up to 83.7 million litres per second, with the most recent peak inflow reaching over 60 million litres last week.

London, July 27: A pet cat has tested positive in England for the new coronavirus that causes COVID-19, the government said on Monday in the first confirmed case of an animal being infected with the virus in Britain. The British environment min-

istry said "all available evidence" suggested the cat had contracted the coronavirus from its owners. who had both tested positive for COVID-19. Both the cat and the humans made a full recovery and there was no transmission to any other animals or people in the household, the ministry said without identifying the individuals involved. "This is the first case of a domestic cat testing positive for COVID-19 in the UK but should not be a cause for alarm," said Yvonne Doyle, medical director at Public Health England. "The investigation into this case suggests that the infection was spread from humans to animal, and not the other way round," Doyle added. The government said the infection was confirmed in lab tests Wednesday, adding there was no evidence that cats could transmit the virus to humans. The World Health Organisation (WHO) has said cats are the most susceptible animal species to the SARS-CoV-2 coronavirus and are able to transmit it to other cats. "Tests conducted by the Animal

and Plant Health Agency have confirmed that the virus responsible for COVID-19 has been detected in a pet cat in England,' Chief Veterinary Officer Christine Middlemiss said.

'This is a very rare event with infected animals detected to date only showing mild clinical signs and recovering within a few days.

The WHO has said it will investigate the possibility of cat-tohuman infection, but its chief scientist has said there is "very little risk" from domestic animals.



Salesman accused of rape in Dubai

The Dubai Court of First Instance heard Sunday that the 39-year-old Indian woman went to drop her son to the school bus pick-up point outside her building in the Naif area of Dubai in February, reports Gulf News. She returned to her apartment when the 23-year-old defendant approached her, put a knife to her throat and asked her to enter the apartment. He is also accused of filming the incident with his mobile phone. The Dubai Public Prosecution charged the defendant, who is currently in custody, with rape, robbery and illegally consuming alcohol.

Washington, July 27: The world's biggest COVID-19 vaccine study got underway Monday with the first of 30,000 planned volunteers helping to test shots created by the U.S. government -- one of several candidates in the final stretch of the global vaccine race.

There's still no guarantee that the experimental vaccine, developed by the National Institutes of Health and Moderna Inc, will really protect.

The needed proof: Volunteers won't know if they're getting the real shot or a dummy version. After two doses, scientists will closely track which group experiences more infections as they go about their daily routines, especially in



areas where the virus still is spreading unchecked.

"Unfortunately for the United States of America, we have plenty of infections right now" to get that answer, NIH's Dr Anthony Fauci recently told The Associated Press. Several other vaccines made by

China and by Britain's Oxford

University earlier this month began smaller final-stage tests in Brazil and other hard-hit countries.

But the US requires its own tests of any vaccine that might be used in the country and has set a high bar: Every month through fall, the government-funded COVID-19 Prevention Network will roll out a

new study of a leading candidate -- each one with 30,000 newly recruited volunteers.

The massive studies aren't just to test if the shots work — they're needed to check each potential vaccine's safety. And following the same study rules will let scientists eventually compare all the shots.

Next up in August, the final study of the Oxford shot begins, followed by plans to test a candidate from Johnson & Johnson in September and Novavax in October -- if all goes according to schedule. Pfizer Inc. plans its own 30,000-person study this summer.

That's a stunning number of people needed to roll up their sleeves for science. But in recent weeks, more than 150,000 Americans filled out an online registry signalling interest, said Dr. Larry Corey, a virologist with the Fred Hutchinson Cancer Research Institute in Seattle,

who helps oversee the study sites. If everything goes right with the final studies, it still will take months for the first data to trickle in from the Moderna test, followed by the Oxford one.

gross non-performing assets of all banks may jump to 12.5% by the end of this fiscal under the baseline scenario, from 8.5% in March 2020.

"If the macroeconomic environment worsens further, the ratio may escalate to 14.7% under the very severely stressed scenario." the report released last week said.

The resilience of Indian bank ing in the face of macroeconomic shocks was tested through macro stress tests which attempt to assess the impact of cumulative shocks on banks' balance sheet and generate projections of gross non-performing asset (GNPA) ratios and capital to risk-weighted assets ratio (CRARs) over a one-year horizon under a baseline and three adverse -- medium, severe and very

severe -- scenarios, the report said. Earlier this month, Das had said building buffers and raising capital will be crucial not only to ensure credit flow but also to build resilience in the financial system.

"In such a situation, it has become a lot more important that the banks have to improve their governance, sharpen their risk management skills and banks have to raise capital on an anticipatory basis instead of waiting for a situation

"Proactively, it is necessary for both public and private sector banks to build up adequate capital buffers," Das had said.

The economic impact of the pandemic -- due to lockdowns and anticipated post lockdown compression in growth -- may result in higher non-performing assets and capital erosion of banks, he

Mumbai. July 27: India Inc's borrowing from foreign market slipped over 81% to \$1.02 billion in June this year, data from Reserve Bank of India (RBI) showed Monday. The domestic companies had raised USD 5.40 billion from the overseas markets in June 2019.

Of the total fund raised by the Indian companies, USD 851.81 million was borrowed through the automatic route, while the rest of the funds came in via approval route, as per the RBI data on external commercial borrowings (ECB) for the month of June 2020. Rural Electrification Corporation Limited (REC Ltd), the government owned institution to promote rural power projects, was the only company to raise USD 170 million through the approval route of ECB for the purpose of on-

lending. Among the major borrowers who tapped the automatic route of ECB were: TVS Credit Services raising USD 100 million for onlending, and Johnson Matthey India Pvt Ltd - USD 132.10 million as working capital loan.

Ibibo Group Pvt Ltd which is into travel and tour business raised USD 99.04 million as working capital loan, while food products manufacturer Adani Wilmar raised USD 45 million for modernisation purpose, showed the RBI data.

New Delhi, July 27: The Centre has released over ₹1.65 lakh crore as GST compensation to states for 2019-20 financial year, including ₹13,806 crore for March, the Finance Ministry said Monday.

The central government has recently released GST compensation of ₹13,806 crore to states for March, 2020. Taking this amount into account, entire compensation up to 2019-20 has been released to states," the Ministry said in a statement.

The total amount of compensation released for 2019-20 is ₹1.65.302 crore whereas the amount of cess collected during the year

To release the compensation for 2019-20, the balance of cess amount collected during 2017-18 and 2018-19 was utilised. In addition, the Centre had trans-

ferred ₹33,412 crore from Consolidated Fund of India to the Compensation Fund as part of an exercise to apportion balance of Integrated GST (IGST) pertaining to 2017-18, it said.

Under the Goods and Services Tax (GST) law, states were guaranteed to be paid for any loss of revenue in the first five years of the GST implementation from July 1, 2017. The shortfall is calculated assuming a 14 per cent annual growth in GST collections by states over the base year of 2015-16.

Meanwhile, Odisha received a GST compensation of ₹5,122 crore for the Financial Year 2019-20.

According to a media report, Odisha had estimated to receive a GST compensation of ₹6,200 crore for 2020-21. The state GST is the single largest component of state's tax revenue. The report also claims that the state GST is likely to make ₹15,469 crore in FY'21.

It is estimated that Odisha may mop up ₹8,750 crore from Sales Tax and Value Added Tax (VAT) on petroleum products, indicating a hike of 9.4% over the RE (Revised Estimate) of 2019-20.

Huawei cuts India revenue target by up to 50%

Mumbai: Chinese telecom company Huawei Technologies Co has cut its India revenue target for 2020 by up to 50% and is laying off more than half of its staff in the country, as reported by a private newspaper Monday, amid calls to boycott Chinese goods. Huawei's India unit said the report suggesting layoffs of more than half of Huawei staff in the country was untrue, but did not elaborate. The newspaper said the company was targetting \$350-500 million in revenue for 2020, compared with roughly \$700-800 million it was aiming for earlier in Asia's thirdlargest economy. The newspaper said that the company was cutting 60-70% of its Indian staff, excluding those in R&D and the global service centre. Huawei's India unit said it continues "to work closely" with all customers in the country.

Rome, July 27: It's no exaggeration to say that Cristiano Ronaldo had more of an impact on Juventus' record-extending ninth straight Serie A title than anyone else.

The five-time Ballon d'Or winner matched a record by scoring in 11 straight league matches before the break for the coronavirus pandemic and quickly regained his form during the restart by reaching the 30-goal mark after only 30

games in his second season in Italy. For his 31st goal, Ronaldo scored the opener when Juventus beat Sampdoria 2-0 Sunday to seal the title with two games to spare.

Ronaldo needs only one more goal to break a tie for the Juventus single-season record for league goals set by Felice Borel in 1933-34.

Ronaldo's 10 goals after the lockdown are more than any other player has scored in Europe's top five leagues, with Manchester City's Raheem Sterling and Bayern Munich's Robert Lewandowski each scoring nine.

ECB receives Letter of Intent from BCCI

Dubai, July 27: The Emirates Cricket Board (ECB) Monday confirmed that it has received the official 'Letter of Intent' from the BCCI accepting their offer to host the 2020 IPL in the UAE.

Last week, IPL chairman Brijesh Patel had announced the dates of the tournament, September 19-November 8, and said the tournament will be held in the UAE subject to Indian's government's approval.

"We have received the (official) letter and now wait on the decision from the Indian Government which will ink the final deal," said Mubashshir Usmani, ECB secretary

general, in a statement. While the Indian government's approval is awaited, Usmani stated both Boards have 'fully mobilised and have instigated discussions with the relevant authorities, in-

cluding their respective internal

working-committees, in preparation of hosting the tournament in a safe, protected environment'

Hosting the IPL in a foreign lo-

cation amid the COVID-19 threat is going to be a major logistical challenge. However, the UAE economy is going to benefit substantially by hosting the T20 extravaganza.

"There are many factors which influence the operations and logistics of hosting what is the world's most exciting, popular and lucrative tournament," commented Usmani

"This is a massive movement of people and equipment and we now need to bring in the experts to discuss all aspects of UAE hosting the IPL. This includes the Abu Dhabi, Dubai and Sharjah Sports Councils, Abu Dhabi, Dubai and Sharjah Tourism Bodies and the respective Government entities such as the Police Forces and the UAE Ministry of Health and

Prevention," he said.
