Cabinet approves new National Education Policy (NEP), HRD Ministry to be renamed 'Education Ministry'

## WHAT IS 5+3+3+4 **DESIGN?**

NEP proposes new curricular and pedagogical structure, with 5+3+3+4 design covering children in the age group 3-18 years

## **Under this there will be**

- 5 years of the Foundational stage: 3 years of pre-primary school and Grades 1, 2;
- years of the Preparatory (or Latter Primary) stage: Grades 3, 4, 5;
- years of the Middle (or Upper Primary) stage: Grades 6, 7, 8
- years of the High (or Secondary) stage: Grades 9, 10, 11, 12

New Delhi, July 29: The Union Cabinet Wednesday approved the draft of New Education Policy (NEP 2020), and also renamed the HRD Ministry as Education Ministry. The new policy proposes new curricular and pedagogical structure, with 5+3+3+4 design covering the children in the age group 3-18 years.

Besides, a single regulator for higher education institutions, multiple entry and exit options in degree courses, discontinuation of MPhil programmes, low stakes board exams, common entrance exams for universities are among other highlights of the NEP.

The policy, which was framed in 1986 and revised in 1992, had not been revised since then.

The Cabinet also approved changing the name of the HRD Ministry to 'Education Ministry'.

"NEP 2020 aims to increase the Gross Enrolment Ratio in higher education including vocational education from 26.3 pc (2018) to 50 pc by 2035. At least 3.5 crore new seats will be added to higher education institutions," HRD Higher Education Secretary Amit Khare said at a press briefing.

"The policy envisages broad based, multi-disciplinary, holistic Under Graduate education with flexible curricula, creative combinations of subjects, integration of vocational education and multiple entry and exit points with appropriate certification. Under Graduate education can be of three or four years with multiple exit options and appropriate certification within this period," he added.

Among the key reforms in the policy are a single regulator for all higher education institutions except for legal and medical colleges, common entrance exam for admissions to universities and colleges to be conducted by the National Testing Agency (NTA) and common norms to be in place for private and public higher education institutions under the Central government's new Education Policy.

"Affiliation of colleges is to be phased out in 15 years and a stage-wise mechanism is to be established for granting graded autonomy to colleges. Over a period of time, it is envisaged that every college would develop into either an autonomous degree-granting college, or a constituent college of a university," Khare said.

Elaborating on the reforms in school education, HRD Secretary Anita Karwal said, "Board exams will be low stake. The focus will be on testing concepts and knowledge application. Home language, mother tongue or regional language to be medium of instruction up to Class V.'

She further said "school curriculum will be reduced to core concepts and there will be integration of vocational education from Class VI.'

The new education policy was part of the Bharatiya Janata Party's manifesto ahead of the 2014 general election.

In May 2016, a 'Committee for Evolution of the New Education Policy' under the chairmanship of TSR Subramanian, former cabinet secretary, submitted its report. Based on this, the Ministry prepared a document called 'Some Inputs for the Draft National Education Policy, 2016'.

New Delhi, July 29: The Ministry of Home Affairs (MHA), here Wednesday, issued guidelines for the 'Unlock 3.0', which will come into effect from August 1.

According to the guidelines, restrictions on movement of individuals during night have been scrapped, and yoga institutes and gymnasiums have been allowed to open from August 5.

International air travel has been permitted in a limited manner under the 'Vande Bharat' mission. Further opening-up will take place in a calibrated manner.

It has also has been decided that schools, colleges and coaching institutions will remain closed till August 31. Besides, cinema halls, swimming pools, entertainment parks, theatres, bars, auditoriums and Assembly halls shall remain closed.

Metros and large congregations continue to be prohibited. The

Independence Day events at national, state, district, sub-division, municipal and panchavat levels and 'at home' functions have been allowed with following social distancing norms and other health protocols.

centage of 81.98. Of the 2,47,451 boy students, 1,92,501 passed the examination with a pass percentage of 77.80 per cent, the minister said. The minister added 1,279 candidates passed the examination with A1 grade (above 90 per cent), the number was 1.180 last year.

While congratulating the successful candidates, the minister said: "Those who have failed should not consider this as their last examination. They will get enough opportunities in life to prosper."

# 71% state returnees 'won't migrate if' given regular jobs

Sambalpur, July 29: Around 71 per cent of the migrants who have returned to Odisha from across the country due to the global virus pandemic are not interested to migrate elsewhere if they find stable employment opportunities in the state, a study said.

The study, involving a telephonic survey, was conducted in four western Odisha districts of Sambalpur, Bolangir, Deogarh and Bargarh.

As many as 227 migrant returnees – 88 from Bargarh, 75 from Sambalpur, 35 from Bolangir and 29 from Deoagrh - were interviewed as part of the survey.

The study on migrant labourers. 'Perception of returnee migrants on COVID-19 and its impact on social and migratory status', was conducted by the Centre of Excellence Regional Development and Tribal Studies of Sambalpur

University. It was found that the people from the four districts of western Odisha migrate primarily for employment as they are unable to get stable jobs within the state, said Prof Arun Kumar Acharya.



# 5 of 36 Rafale jets are home

AGENCIES

New Delhi, July 29: Five of the 36 medium multi-role Rafale fighter jets built by French aircraft manufacturer Dassault landed safely at the IAF airbase in Ambala Wednesday afternoon. Significantly, the frontline IAF airbase is likely to be used in case of conflict at the northern or the western borders. Defence Minister Rainath Singh

said in a tweet, "The Birds have landed safely in Ambala. The touchdown of Rafale combat aircraft in India marks the beginning of a new era in our Military History. These multirole aircrafts will revolutionise the capabilities of the @IAF\_MCC," (sic) the min-

ister added. Interestingly, the new additions, the fighter stable of Indian Air Force, are named after current Chief of Air Staff, Air Chief

Marshal RKS Bhadauria. Of the two squadrons of the Rafale fighters, one would be based in Ambala for the western borders in Pakistan, while the second squadron would be based Hasimara in West Bengal and will be dedicated for the China border where Indian and Chinese People's Liberation Army troops are engaged in a border standoff, which left 20 Indian and unknown number of Chinese soldiers dead following a bloody

# 19-yr-old Bolangir girl helps rescue 6K trapped workers

*July 30 is 'United Nations* World Day against Trafficking in Persons', established to raise awareness of the plight of human trafficking victims, and promote and protect their rights

Bhubaneswar, July 29: She was trafficked once and till now she has rescued more than 6,000 victims of human trafficking. Meet

Manasi Bariha. This tribal girl from Bolangir has created ripples in the state for showing courage, determination and presence of mind in rescuing more than 6,000 of her co-workers and many others from nearby brick

kiln centres in Tamil Nadu. The 19-year-old Manasi Bariha along with 355 other workers from different parts of Odisha like Bolangir, Nuapada and Kalahandi among others had gone to work at a brick kiln of Pudhukuppam in Tiruvallur.

The working conditions at the brick kiln were horrible, victims said. The workers were forced to toil beyond normal working hours and paid a meagre ₹250 per week. They were kept in shanties and had to attain their brick production targets. The workers sweated it out and hoped that once they complete their targets, they could leave. But, even after completion of the work, the kiln owner did not let them go. Victims say that the owner asked his men to resort to violence to make the workers stay. Workers were dragged out of their shanties and forced to continue making bricks. She anyhow was able to sneak away and dialed up all her cell phone contacts. She shared the disturbing images at the shanties and at the kiln, seeking help.

Soon the government officials and police were alerted and help arrived. An FIR was lodged against the owner and associates: most of

the culprits were caught. The government also enquired about other brick kilns in the area and learnt about migrant workers trapped in difficult conditions. Majority of them were Odia workers. Subsequently, workers in as many



# Curtain falls on Kashinath at 108

Bhubaneswar: An era came to an end Tuesday night with the demise of Master Kashinath Sahoo, the oldest theatre personality of India. He was 108. "My father was active till the end. He skipped his breakfast Tuesday after feeling little feverish. We never imagined he would no more be with us in the evening," said a shocked Debendra Sahoo, his elder son here

Wednesday. Several members of Odisha Natva Sangh including Sept 7, 1913 - Jul 28, 2020 Prasanna Mishra, Dhira Mallick, Manoj Pattanaik, Haren Sahoo, Prakash Moharana, and Ashok Kar grieved the death.

Born to Radhamani and Bandhu Sahoo of Haripur village near Pipili, September 7, 1913, Kashinath was the youngest among eight siblings. Known for his simple lifestyle, Kashinath had a gamut of talents, all rolled into one. He was an actor, director, dance exponent, musician, organiser, educationist and a prominent social worker. Popularly known as 'Master'

Kashinath took to stage when he was five. He worked in famous troupes like Minerva Theatre

(Kolkata), Hajuri Theatre, Haribandhu Sundara's Rasa Party, Balanga's Banamali

> Theatre, Art Theatre and Annuapurna A. He acted in hundreds of historical, mythological, social and family dramas. Kashinath also di rected

many plays. However, his role as Dharama' in the play Konarka made him a



Bhubaneswar, July 29: In an attempt to ensure clean and ecofriendly travel for the passengers and fulfilling its commitment towards the 'Swachh Rail, Swachh Bharat' campaign, the East Coast Railway (ECoR) has successfully completed 100 per cent installation of bio-toilets in its trains.

These bio-toilets convert the human waste into water and biogases with the help of bacteria. This mechanism of bio-toilets is very helpful in sustainable management of solid waste.

All the 3,247 ECoR coaches are now fitted with eco-friendly biotoilets. Out of these, 2,534 are Integral Coach Factory (ICF) and 713 Linke Hoffmann Busch (LHB) coaches that have now been equipped with bio-toilets.

The installation of bio-toilets in ECoR coaches will not only help maintain cleanliness by prevent-

Bhubaneswar, July 29: State's novel coronavirus disease (COVID-19) tally crossed 29,000-mark after 1,068 more people tested positive for the disease, while the death toll rose to 159 with five more patients succumbing to the viral infection Wednesday, an official of the Health and Family Welfare (H&FW) department said.

The total number of coronavirus patients in Odisha now stands at 29.175, the official pointed out. adding that the five deaths were reported from Ganjam, Balasore, Kandhamal, Malkangiri and Puri.

Another COVID-19 patient from Bhadrak also died, but the cause of his death was attributed to 'non-COVID reasons', the official said.

Of the 1,068 fresh cases, 662 were detected from different quarantine centres while 406 were found through contact-tracing exercises. Ganjam reported the highest of 245 new cases, followed by Khurda (194), Sundargarh (112), Gajapati (88), Koraput (66) and Cuttack (61), added the official. Meanwhile, 878 persons recovered from the disease,




As per rules in the Representation of the People Act-1951, a by-election should be conducted within six months of a representative's demise.

Bishnu's son Bijava Shankar Das. chairperson of Odisha State Commission for Women Minati Behera, local parliamentarian Rajashree Mallick's husband Asutosh Mallick, ex-MP Kulamani Samal, ex-MLA Rabi Bhoi, last election's dropped out aspirant Yudhisthir Sethy, Kendrapara district's leader and ex-MLA Sipra Mallick are in the air.

Reacting to this, a close associate of Bishnu and Bisanpur sarpanch Basant Mahapatra said, "The BJD will get sympathy votes if the party fields Bijaya Shankar. However, the party workers will abide by whatever decision BJD leadership takes in this regard.'

"Whatever decision the party supremo takes will be binding on us and we will work for party candidates," Jagatsinghpur MLA Prashant Kumar Muduli said.

Coming over to the saffron camp, BJP was in second place in the last general election. "We have already accelerated our efforts in Tirtol Assembly constituency," local leader and Jagatsinghpur district BJP president Satyabrata Mohapatra said.

The BJP has been focusing on strengthening the party's organisational structure in Jagatsinghpur district. Within a few days the party will reach out to voters at panchayat levels, Mohapatra added.

# Locals decry 'no job scope' in mining firms

Keonjhar, July 29: Resentment brewed among locals in Jajanga area under Joda mining circle of Keonjhar over lack of livelihood scope in mining companies.

They alleged that lease holders of the mines have been neglecting local people in their work. Contractual agencies from other states have been roped in for mining work.

Scores of people from Kamalpur, Bandhuabeda, Jamita, Bholabeda, Jajanga, Lahuniposi, Gurutuan and Jurudi have taken up the issue with the Collector.

Besides, they have intimated their plight to Champua sub-collector, Bamebari IIC, Barbil tehsildar and the district labour officer.

Aggrieved people have long been protesting for jobs in mines, but their demand has allegedly been pushed aside by the mining firm.

"The economy of the district solely depends on the mining sector. But mining firms operating in the locality is depriving the locals of their livelihood while they have



engaged machines in their work,' they fumed.

About 80 per cent of the population in the area is living below the poverty line. Earlier, people used to depend on forests for minor forest produce, but forest cover is vanishing due to mining activities, they pointed out.

With decline of forest cover, their livelihood and wildlife are at stake. People are sitting idle in the mining rich area without getting work at hand.

"The companies have snatched out rice bowl and engaged machines in its work. We were left jobless in our land," they added.

They have formed an outfit Yuva Shakti Development with which they have been protesting for the cause of job scope for them.



# Keonjhar farmers fret over unrepaired canals



POST NEWS NETWORK

Keonjhar, July 29: Local farmers in Keonjhar face acute irrigation problems as there has been erratic rainfall in the district due to unsatisfactory monsoon. Most farmlands have become dry and paddy seedlings have died out.

"Even as the local farmers have already started farming activities, they apprehend drought-like conditions in the days ahead. Hardly there was monsoon rain over past three months," some farmers said.

Several villages of Nuagaon panchavat under Sadar block in Keonihar district have concrete irrigation canals in the region. Similarly, an irrigation canal which passes through Baradapal area bordering Kenduposi has no water at all for the purpose of irrigation.

Allegedly, the canal has not been repaired for past two years. The farmers in Keonihar district have demanded construction of a concrete canal supposedly from Baradapal area up to Narasinghpur several times, but in vain. Water of a nearby river cannot be utilised for irrigation purposes unless and until the canal is repaired. Notably, local youths of Kenduposi panchayat had earlier tried to repair the soil cast and dilapidated irrigation canal.

"Keonjhar district administration should be proactive and construct new concrete canals in order to facilitate better irrigation of farmlands," some farmers of Baradapal area said.

# Drought fears in Subarnapur

SUBARNAPUR: With the state witnessing a deficit of around 12% of rainfall, the situation is extremely severe in the coastal pockets.

The Meteorological Centre said, Sonepur district witnessed 31 per cent rainfall deficit till date which is far less than its surrounding districts in western Odisha.



by kin, over 400 recovered leprosy patients have failed to return to their homes and living a life of deprivation and obscurity in two separate settlements in this town, a report said.

This is in contrary to the tall claims of the government of a leprosy free society as the recovered patients live here with all the roads to their homes closed.

The Centre and state government are providing all assistance and help by involving social outfits to build a leprosy free society.

This has helped in reducing the number of leprosy patients in the country. However, this is off little help for these recovered patients as they are never welcomed back into their family fold due to the superstition and stigma attached to the disease. They continue to remain neglected and shunned by their own family members live a life of

deprivation and obscurity. The trial and tribulations of re-

Kushthashram in Jujumura in this district is a case in this point. Many of the patients living in this leprosy home have recovered after getting necessary care and treatment.

However, they have failed to return home as their family members are not ready to accept them back due to the superstition and stigma attached to the disease.

Unable to return home, over 400 recovered patients are now living in two leprosy colony at Nuapada and Negativepada in the town. The matter came to fore when this correspondent met some male and female patients who have recovered from the disease

A woman who has recovered from the disease said she is living here since last 12-years. Family members dropped her here after she

was afflicted with the disease. She has recovered fully since long but living here as her family members have refused to take her back home. She was living with another recovered patient but has become alone after the death of



that person. She has now become helpless and earning her living from goat rearing and the rations she receives under PDS scheme. She is pondering how to spend the rest of her life.

Another man is afraid of being ostracized by the members of his caste. He feels the hatred and quizzing eyes of his neighbours and villagers whenever he tries to visit his house comprising his two sons and a daughter. Such a situation has forced him to live here, he said

He earns his living by collecting firewood from jungle and selling them in the local market.

Another recovered man has two sons and three daughters. He said that he is fully cured now but that

has failed to free him from mental agony. He is afraid to return home. He thinks that he might well be

accepted by his family members but his neighbours will never allow him to live in peace. Moreover, his staying at his house might pose problem in the marriage of his children while his family members will be ostracized in the society.

Notably, eminent physician, Gandhian and social worker Dr Issac Santra known for his contributions for the eradication of leprosy in the country founded a leprosy home at Hatibari in 1957.

The Odisha governor is the head of the leprosy home while it is managed by Hind Kustha Nibaran Sangh. It is spread over 560 acre land having 10 ponds, fruits and flower gardens and a health centre. The inmates here get all the healthcare facilities provided by

the government. In 2005, the World Health Organisation (WHO) declared India leprosy-free and included the Hatibari Kushthshram in it. Then 456 leprosy patients were undergoing treatment at the home which has now come down to 160.

# Leather luxury

any years ago, I spoke to the Mercedes people in India and told them to stop using leather for their car seats. They didn't ban it, but they I made it optional. Now, the responsibility is on the buyers

Unfortunately, very few rich people use their money judiciously. The more they make, the more they want to show other people that they are better than them. And this 'better' involves eating strange things: cancerous livers called Pâté, pregnant fish eggs called Caviar, rare poisonous fish like Fugu.

Killing old and blind wild animals while sitting on sofas: it's called canned hunting in Africa. Wearing crocodile, snake and zebra skins. I could go on forever on how the rich spend their money to cause suffering and destroy the world.

One of the most common ways is leather seats in their cars. Some 75 per cent of luxury cars use leather seats. PETA has calculated that 1.5 million car leather interiors are produced in a year. It takes eight cow skins to make one car interior. 12 million cows are killed just for luxury cars in the US alone. Multiply that with the cars of Europe and the millionaires in India who love to show off (until they get raided).

Why do rich people aspire to dead animal skin or 'leather'? The reasons given by the manufacturers and buyers are: It gives a luscious feel and look. It is elegant. It is stain resistant and resistant to smells. It is easier to clean. All three reasons are simply not true. Luscious feels and looks are completely subjective, and nothing could be more inelegant than resting your bottom on dead animals. So we will go on to the facts: Leather costs much more – upto \$2,000 per seat. Not just the leather itself but, because it heats very fast in summer and retains cold becoming hard and cold in winter, it needs air-conditioners, heaters and seat warmers – raising the cost and increasing the unhealthiness of the car interior.

Leather has a peculiar smell. In order to turn cow and calf skin into leather, it requires several hundred chemicals, so dangerous that they kill all life in the waters in which the leather factories throw their waste. These chemicals seep out and pervade the air with their own odour. Get into a leather-using car: the smell is worse than cigarette smoke.

In fact, all leather is soaked in the beginning in perfume Tanned hides smell awful and once the perfume wears off, the seat goes back to smelling awful.

Leather is extremely high maintenance. Body oil and dirt collect on the surface of leather and act like fine sandpaper, breaking down the protective chemicals on the dead skin so that visible cracks develop on the surface. No moisture is tolerated, so if you get in when it is raining, and you are damp, you can harm the seats and cause an even more putrid smell. Sweat, alco-

Leather absorbs dirt and spills, vomit and chocolate spots, pus and nose goo, which means it can stain and become discoloured more easily. Leather is also easier to scratch, so it's not a good choice for your vehicle if you have dogs, cats or children, unless you cover the interior to protect it.

Leather needs cleaning and conditioning every two months to keep it looking good. The cleaners cost as much as the seats. Some seats have to be taken off and given to a dry cleaner. Leather ages disgracefully. Nothing looks worse than worn out leather seats. Look at old shoes. That's what the seats are going to look like in a few years, or even a few months, if you don't keep conditioning them.

During the summer the seats can get hot enough to hurt you. If you leave the windows up on a sunny day the temperature in the car can exceed 200 degrees. This is because, unlike cloth, leather absorbs heat. Leather steering wheels can get so hot that they cause burns. It is impossible to immediately hold on to them, so air-conditioners have to run for at least 10 minutes before you can get in. In summer, leather seat owners have to use towels or cloth coverings. In winter leather gets chilly and cold; so cold, that the car temperature goes down and heating has to be used - before you get in.

While the top of the line cars have heated armchairs, the less luxur models still do not include them. And that means that in winter you will have a 'frozen' armchair, and in the summer, one that will practically burn you if you dare to sit down after leaving it in the Sun.

When you first purchase the car, the new leather seats are very stiff. It takes months for the skin to become flexible and comfortable. By then it has absorbed so much oil and sweat that it needs cleaning with chemicals and then goes back to being stiff!

Most leather used for cars is not good. It has very little natural grain. The original hide of the cow was so scarred from the way it was treated that the tanner had to sand the skin down to make it even and scar free.

Look at the suffering leather causes. Cows and calves, that are earmarked for car seats in the ranches, are thrown and held while being branded on the face with burning hot branding irons. Look at the videos of PETA on YouTube on what happens in Brazilian ranches - the main suppliers of car seat leather. The video shows workers branding calves on the face, and electro-shocking and beating gentle cows and bulls. Their throats are cut while they're still conscious and able to feel pain, and their skins are pulled off. A new animal entrant for the rich is lambskin. Is this pain worth your bottom-rest in a Jaguar, Toyota, Volkswagen, and Volvo?

If animal suffering and environmental pollution is not enough for you,

look at your comfort. Do you want to own your car, or do you want it to own you? Remember that saying "God has no respect for money. Look at the peo-

# **SCHOOLING AS CASUALTY**

**EMERGENCY IS LESS VISIBLE TO** POLICYMAKERS. **BUT IT WILL LEAVE MILLIONS** OF THE WORLD'S **POOREST CHILDREN CARRYING THE SCARS OF DIMINISHED OPPORTUNITY FOR THE REST** OF THEIR LIVES

The beautiful thing about learning," the great blues guitarist BB King once wrote, "is that no one can take it away from vou." Born and raised in poverty, King understood the value of education as a force for change. If only political leaders responding to the Covid-19 pandemic had an ounce of his insight.

The pandemic is now mutating into a global education emergency. Millions of children, especially the poorest and young girls, stand to lose the learning opportunities that could transform their lives. Because education is so closely tied to future prosperity, job creation, and improved health, a setback on this scale would undermine countries' progress, reinforcing already extreme inequalities. Yet this emergency has yet to register on governments' pandemic response agenda.

Lockdowns have shut more than one billion children out of school. For an estimated 500 million, that means receiving no education at all. A Save the Children survey in India found that two-thirds of children stopped all educational activities during lockdown. The danger now is that a perfect storm of lost schooling, increased child poverty, and deep budget cuts will lead to unprecedented reversals in education. This is an emergency layered on a pre-existing crisis. Even before the pandemic, 258 million children were out of school, and progress toward universal education had stalled. Now, increased child poverty alone could result in 10 million children not returning to school. Many of these children risk being forced into child labour or early marriage (in case of adolescent girls). Meanwhile, already abysmal pre-pandemic learning levels, which left half of children in developing countries unable to read a simple sentence after primary school, are set to worsen.

Path-breaking research on the impact of the 2005 earthquake in Kashmir, Pakistan, captures the risk to learning. Schools were closed for three months. When they reopened, attendance quickly recovered. But four years later, children aged between three and 15 who lived closest to the fault line had

lost the equivalent of 1.5 years of learning. Imagining that outcome on a global scale gives a sense of what is at stake. Education empowers people, reduces poverty, improves health, and the human capital that it generates shapes the destiny of countries. Lost education will erode that capital, effectively placing the 2030 Sustainable Development Goals beyond reach.

Governments should now be investing to prevent that outcome. Unfortunately, education budgets are being hollowed out by recession and the diversion of public spending – and international aid – to healthcare and economic recovery. As a result, governments in low and middle-income countries could end up spending \$77 billion less than planned on education over the next 18 months.

So, what can be done to avert disaster? In its new global Save Our Education campaign, Save the Children has set out a three-part agenda for recovery.

The first priority is to keep learning alive during lockdowns. Governments should do all they can to reach children through radio. TV, and remote-learning initiatives. Countries such as Ethiopia, Uganda, and Burkina Faso have developed ambitious national distance-learning programmes. They and others need more donor support to implement them at scale.

Second, the pandemic creates an opportunity to address the wider learning crisis. Too many children are being taught at the wrong level, owing to schools' rigid application of poorly designed curricula. Every child returning to school should undergo a learning assessment aimed at identifying those in need of support. Remedial teaching programmes such as those pioneered by organisations like BRAC and Pratham can then prevent these children from falling further behind, thereby reducing the risk of future dropout.

Third, increased international financing is critical. Most of the world's poorest countries, especially in Africa, entered the economic downturn with limited fiscal space. That room for manoeuver is now shrinking further as recession bites and external-debt problems intensify.

Rich country governments have responded to Covid-19 by tearing up their fiscal and monetary policy rulebooks and underwriting ambitious national recovery plans. They should be equally bold in supporting education in developing countries. More effective leveraging of multilateral development bank balance sheets is an obvious starting place. The Education Commission has advocated establishing an International Finance Facility for Education to provide loan guarantees, thus enabling the World Bank and other institutions to borrow cheaply on international markets and lend the funds to developing countries Every \$1 of guarantees under this scheme could unlock \$4 of financing for education. This approach, which would include rig orous debt-sustainability evaluations of recipient countries could mobilise resources on a scale commensurate with the crisis. Aid donors and the World Bank

should support it. To its credit, the Bank is frontloading resources already allocated to the International Development Association, its concessional lending arm. But an unprecedented crisis surely demands more than that. The Bank should establish a supplementary IDA budget of at least \$35 billion and step up its support for education.

Debt relief is another potential source of financing. The G20's Debt Service Suspension Initiative for IDA members (the world's 73 poorest countries) is a small step in right direction. Unfortunately, private and Chinese creditors, which account for over half of these countries' debt-service payments (about \$25 billion this year) have shown scant interest in participating. As a result, countries like Cameroon, Ethiopia, and Ghana are currently spending two or three times more on debt service than they do on primary education.

In effect, countries are meet ing short-term debt payments by eroding long-term human capital. Allowing the claims of private creditors to rob children of their right to an education is morally indefensible and economically ruinous. That is why Save the Children has proposed a mechanism through which debt obligations can be converted into investments in children.

We can measure the health impact of Covid-19 on adults by tracking infection rates and deaths, and we can gauge its economic effects in terms of lost GDP, higher unemployment, and rising public debt. The education emergency is less visible to policymakers. But it will leave millions of the world's poorest children carrying the scars of diminished opportunity for the rest of their lives. We can - and must protect their future.

# Defections – laws, rules & confusion

ues for protests by members of the Congress party in many states on 27 July "to highlight the gravity of the issue and draw people's attention to violations of the Constitution" in Rajasthan. The question of determining defection from political parties and the various possibilities of using the law by diverse players is a complicated matter.

This case started in the High Court of Rajasthan when the former Deputy Chief Minister Sachin pilot complained against disqualification notices issued by the Speaker to 19 rebel Congress MLAs. The Speaker approached the Supreme Court with a special leave petition, saying that a court cannot bar a Speaker from acting on disqualification notice even before a decision is taken. The Speaker later withdrew his petition.

The fault of the rebel members  $\,$ that earned them the disqualification notices from the Speaker was defiance of the whip issued by the Congress and failure to attend Congress Legislative Party meetings on two days. This team of Sachin Pilot challenges the notices

aj Bhavans became the ven- and maintains that it is only seeking leadership change in the "most democratic manner.

Chief Minister Ashok Gehlot along with 100 legislators had reason to stage a dharna on the lawns of Raj Bhavan, demanding convening of the Assembly session, primarily to prove his majority. He did not succeed and ended the dharna after about five hours. A list of MLAs numbering 102 was submitted to the Governor, as his supporters.

The CM met the Governor the next day and insisted on convening the assembly session. Deciding on dates for the Assembly session, fixing the procedures, and setting the agenda are in the domain of the cabinet. The Governor initially questioned the necessity for a floor test when the government was claiming the support of a majority. The revised note of the CM to the Governor mentioned only the need for a special session to discuss the situation on Covid-19 and to introduce six bills

On 27 July, the Governor agreed to convene the assembly on the condition that 21 days' notice should be given to the members as per rules and social distancing norms must be followed. As floor test was not included in the agenda, a short notice was not enough.

The legal course, neither in the state nor at the Centre, was so far favourable to the Congress. The alternative, in keeping with the current trend in Indian party politics, is to take the fight outside the courts and on the roads.

The CM's posture was the immediate response to the Rajasthan High Court direction to the Speaker on maintaining the status quo on the disqualification notices he had issued to 18 rebel Congress MLAs and Sachin Pilot, under clause 2(1) (a) of the Constitution's Tenth Schedule. The order itself had come after the Supreme Court refused to restrain the High Court from ruling on the matter on the plea of the Speaker.

The Tenth Schedule including para 2(1)(a) on freedom of speech, vote or conscience of elected members, which was validated by the Supreme Court in 1992, mentions two grounds for disqualification of a member – one, when he voluntarily gives up membership of the party; and the other, if he votes or abstains from voting contrary to any

direction issued by his party, meaning if he violates whip. Pilot asks for deletion of this provision.

A judgement of the Supreme Court in 1994 has clarified that voluntarily giving up membership does not require a formal resignation from the party, but may be inferred from certain actions. It paved way for party action against members for having and/or expressing views different from that of the party or party leaders while remaining within the party. Party discipline overtook inner party

This judicial interpretation was followed in UP in 2003 when 13 MLAs of the BSP were disqualified for supporting the SP chief to form the government as against their leader's advice to dissolve the assembly. It was an inference by the court that the action of those MLAs was a proof that they had voluntarily given up their membership of the BSP. This provision has remained a contentious issue ever since it was written. Even courts have taken varied stand on what constitutes defection.

Srinagar, July 29: The administration of the Union Territory of Jammu and Kashmir has lifted a requirement set in place by a 1971 circular under which security forces had to obtain a special certificate in order to acquire land in the erstwhile state.

cording to the order. The move came on the heels of the UT administration agreeing to legal changes to allow construction in the region's 'strategic

areas' by the Indian armed forces. August 5 last year, the Centre revoked Article 370 and related

constitutional provisions, effectively scrapping the partial autonomy the erstwhile Jammu and Kashmir state had, splitting it into two UTs - Jammu and Kashmir, and

Guwahati, July 29: Even as three more persons died in Kokrajhar, Kamrup and Barpeta districts of Assam Wednesday raising the death toll to 107, the overall flood situation continues to improve in the state,

Respite in monsoon rains during the past one week has made the flood situation improve slightly and officials of the India Meteorological Department (IMD) hoped that in the coming days it would improve further.

Assam State Disaster Management Authority (ASDMA) officials said that, 16.55 lakh people in 1,536 villages across 21 of the state's 33 districts are still affected by floods, though the number has come down since Friday when over 28 lakh people in 2,543 villages of 26 districts were distressed.

A total of 92,900 hectares of crops are still flooded, but the area has dropped from 122,573 hectares as on July 24.

Quoting reports from the districts, the ASDMA officials said that four major rivers including the Brahmaputra, are in spate in many places in five districts, where both Brahmaputra and Jia Bharali are flowing over the danger levels. Forest officials said at least 142

wild animals have died due to the floods and 165 have been rescued, even as over 65 per cent of the 884 sq km Kaziranga National Park remains inundated.

The animals that have died in the annual monsoon flood include 15 rhinos, 104 hog deer, eleven wild boars, five wild buffaloes, three por-

# Protests against CAA resume

Guwahati, July 29: Peasant body Krishak Mukti Sangram Samiti (KMSS) Tuesday staged protests across Assam, demanding the release of its leader Akhil Gogoi as well as the repeal of the contentious Citizenship (Amendment) Act.

The members of the organisation defied prohibitory orders in Guwahati and were arrested, while at other places it formed human chains, performed songs and created artworks in support of their demand. In the state capital, the KMSS supporters defied Section 144 and formed a human chain and shouted slogans, demanding Gogoi's release and repeal of the Act.

"They did not have any permission to stage the protest. So, we arrested them for violating the prohibitory orders," a senior police official said. Gogoi is being treated at Gauhati Medical College and Hospital after testing positive for

COVID-19. He contracted the virus in Guwahati Central Jail, where he was lodged for his alleged role in violent anti-CAA protests last year.

KMSS president Raju Bora said the group has restarted the anti-CAA movement from Tuesday and it will continue till the controversial law is repealed.

"This time, the agitation will be more united and powerful. The BJP government is scared of Akhil Gogoi and that is why they have put him in jail. They want to stop the peoples' voice by imprisoning Gogoi," he added. In Jorhat city, artistes, students, educationists, advocates, journalists and common people joined the agitation and performed songs and recited poems, while painters created sketches to press for their demands.

Dergaon, Merapani, Bokakhat and many other places in Golaghat district too witnessed cultural protests. In Dibrugarh, farmers staged a unique protest by planting rice seedlings on their paddy fields. People also formed human chains at several other places in the district.

In the Chenimari area of Barpeta. which is ravaged by the devastating flood, people protested standing and forming human chains on their country-made boats.

Similar artistic and variety of protest expressions were witnessed in other districts, including Tinsukia, Sivasagar, Charaideo, Nagaon, Morigaon, Dhemaii Darrang, Kamrup, Bongaigaon Sonitpur, Goalpara, Dhubri and Baksa, The Hailakandi and Cachar districts of the Barak valley also saw some demonstrations, demanding the release of the RTI activist.

In the midst of intense anti-CAA movement. Gogoi was arrested December 12 last year from Jorhat as a "preventive measure" in view of the deteriorating law and order situation in the state and his three colleagues were taken into custody the next day.

# How exotic wildlife is smuggled into Assam

Silchar (Assam), July 29: Assam forest officials have seized some exotic wildlife species, suspected to have been smuggled from Myanmar, and arrested two men from a truck carrying the endangered animals, officials said Wednesday.

Southern Assam's Cachar Divisional Forest Officer Sunnydeo Choudhary said during a routine checkup, forest officials Tuesday midnight intercepted a truck, coming from neighbouring Mizoram, at Lailabur forest sub-beat, carrying the exotic wildlife. The rescued wildlife includes a kangaroo, six Macaw parrots, three Aldabra tortoises and two capuchin monkeys.

'The Aldabra tortoise, one of the world's largest land tortoises and capuchin monkeys are Central and South American primates found in tropical forests from Nicaragua to Paraguay and they are considered among the most intelligent of the world's monkeys," Choudhary told IANS over phone from Silchar.

He said the exotic wildlife might have been smuggled from Myanmar but the entire matter is now under investigation. During preliminary interrogation the driver of the truck Narsimha Reddy and his assistant Navnath Tukaram Daigude said the consignment was destined for Guwahati.

"The detainees said they picked

up the consignment from Mizoram for delivery in Guwahati. There are instances that exotic animals are smuggled in from Myanmar and moved to Kolkata and other major cities of the country,' Choudhary said.

The IFS officer said the veterinary doctors are looking after the health of the wildlife. "In the backdrop of COVID-19 pandemic and dismal trade and business, it's a high time to put an end to such illegal trade of exotic species of wildlife. Let these wildlife live in their natural habitat," Forest Range Officer D. Deori said adding identification of exact species of these animals is underway.

An official release of Assam Public Relations Directorate, Barak Valley Region, said that in its first global report on the illegal wildlife trade, released a week ago, the Financial Action Task Force (FATF) described wildlife trafficking as a global threat", which also has links with other organised crime such as modern slavery, drug trafficking and arms trade

The illegal trade is estimated to generate revenues of up to \$23 billion a year. Earlier, a big consignment of exotic animals, including venomous snakes and giant scorpions, was seized from a vehicle at Jorabat, about 20 km from Guwahati on the Assam-Meghalaya border. The consignment had come from Mizoram and was to be sold to a trader in Delhi

# A bridge of hope & challenges across Chenab



New Delhi, July 29: Kashmir's inaccessibility was a wake-up call for then Prime Minister Atal Bihari Vaipavee. When he returned to New Delhi after visiting Kargil in July 1999, he remarked, "We have not attacked any country in our fifty years of independence, but we have been attacked several times and lost our land. We are determined not to lose our land in the future.' Preparations for a rail link in the Valley began immediately.

In 2002, the government broke ground on the railway, which it hoped will one day connect Baramulla, Kashmir's northernmost city, to New Delhi. But despite being prioritised by Vajpayee as a "project of national importance," construction on this strategic undertaking was plagued by setbacks.

For example, in 2009, a protracted dispute over gradients broke out between two private companies which had been commissioned to work on separate sections of the line.

But the biggest delay by far has been due to the plan's most ambitious feature, the Chenab Bridge - a milelong crossing made of blast-proof steel designed to withstand both earthquakes and explosives. When completed, it will be the loftiest railway span in the world, stretching

Unsurprisingly, after becoming the head of government, PM Narendra Modi, sought reports to understand the cause of repeated delays. Following this investigation, Modi paid a one-day visit to J&K. In July 2014, while inaugurating the railway's latest link, connecting Katra to Udhampur, Modi declared: "Our aim is to win over the hearts and minds of the people of Jammu and Kashmir through development, soon Kashmir will be prosperous and peaceful. The new rail link will speed up the process of development in the state." Understanding its critical role, Modi directed officials to progress on the Chenab Bridge without any delay.

Modi added that the construction of the bridge is the most challenging task of the whole Kashmir rail link project. But at the same time, after the completion of the bridge, it will be recognised globally as an engineering marvel.

"This is the most challenging project in the 150-year-long history of the Indian Railways. The highest railway bridge in the world, that will connect Kashmir with the rest of India through the rail line will be completed by December 2021, Sanjay Gupta, Chairman of Konkan Railway said in a statement.

According to the Ministry of Railways, the deadline for the completion of the railway project has been moved ahead from June 2022 to December 2021.

Whenever the Chenab Railway Bridge is finally completed, it will be more than just another bridge but a prestigious symbol of how far India and its railway engineers have come since the country's first mile of railway track became operational more than 150 years ago.

For the people of Kashmir, the railway will provide a magnificent opportunity of integrating with the rest of India.

# Valley sees decline in stone pelting: Officials

Srinagar, July 29: Incidents of stone pelting have come down sharply in Jammu and Kashmir after abrogation of the special status of the erstwhile state, officials said Wednesday.

Comparing the figures of stone pelting incidents during the first six

months of 2020 with previous years, they said the number has fallen down considerably from 944 in 2018 to 211 so far this year.

According to officials, there has also been a reduction in injuries deaths of secu-

rity forces as well as civilians. They said a heavy deployment of security forces helped instil confidence in the public as many of the "trouble mongers" had been identified and packed to various jails ahead of or on August 5 last year when Article 370 of the Constitution

was abrogated. There was only one civilian death during stone pelting incidents this year whereas the figure for 2018 was 18 and was three for 2019 during the first six months, according to the officials.

Similarly, there were 549 cases of injuries to civilians in 2018 during the first six months followed by 335 in 2019 and only 63 this year, the officials said, adding, the number of injuries to security forces have

New Delhi, July 29: The New Education Policy (NEP), which is only the third in the country's history after 1968 and 1986, has paved way for foreign universities to set up campuses in India.

As per the policy, world's top 100 foreign universities will be 'facilitated' to operate in India through a new law. However, this reverses the BJP's earlier stand on the Foreign Educational Institutions Bill moved by the UPA-II government. One of the central reservations of BJP on the bill at that time was that they would raise the cost of education - high tuition fees, faculty poaching from public universities - rendering it out of reach for a large part of the population.

The plan to revive the UPA's plan to permit the foreign universities happened after a strategy paper was shared by the Commerce Ministry with the Ministries of External Affairs and Human

According to the ministry sources, only reputed foreign universities will be allowed to set up regulatory framework.

Several attempts had been made by previous governments to allow the opening of foreign universities' campuses in India. In 1995, a Bill to permit the entry of foreign universities was drafted but not passed. In 2005-06, another Bill drafted to this end was unable to get the cabinet's approval.

Under the UPA government, the HRD ministry under the aegis of Congress leader Kapil Sibal put forth the Foreign Educational Institutions (Regulation of Entry and Operations) Bill, 2010. However, the Bill was unable to gather the requisite support in Parliament and eventually lapsed after the UPA government finished its tenure.

Apart from opening up the Indian higher education to foreign players, the new policy marks a significant shift in the format of undergraduate education with the reintroduction of the fouryear multidisciplinary bachelor's programme with exit options.

Jaipur, July 29: The Ashok Gehlot Cabinet Wednesday cleared another proposal to the Governor for summoning the Rajasthan Assembly, saying a session should be called August 14.

Government sources argued that this meets the 21-day notice requirement on which Governor Kalraj Mishra was insisting. It was not immediately clear if this will end the impasse between the Congress government and the Governor, who has already returned proposals for calling a session three times since last week.

The Cabinet is counting the 21 days from July 23, when its first proposal was sent. But the latest proposal falls short if the notice period is counted from Wednesday. While rejecting the government proposal earlier, Mishra had said a session can be called at short notice if the agenda is to seek a vote of confidence. Otherwise, 21 days' notice is needed, he said. The state government was earlier insisting that the session should begin July 31. "Neither the Governor nor the government wants confrontation. The Cabinet has passed a revised proposal for forwarding to the Governor," Transport minister Pratap Singh Khachariyawas told reporters after the evening meeting.

We hope that the Governor will accept the recommendation this time and the deadlock will end," he said. The minister, however, did not elaborate on the contents of



the revised, fourth proposal. Earlier in the day, Mishra re-

turned the government's third proposal, saying the Cabinet had refused to state the reason why it wanted a session at short notice.

The Governor said if the government was not stating the reason for holding a short-notice session, it could call a regular session at 21 day's notice. He asked the Gehlot cabinet to resubmit its proposal, giving a 'solid reason' for calling a session at short notice. As the impasse over calling a session deepened, Chief Minister Ashok Gehlot held a 15-minute meeting with Mishra at the Raj Bhawan. Hours later, the state Cabinet met to redraft the proposal, setting the new date.

"The love letter has already come. Now, I am only going to have tea with him," Gehlot told party workers at the state Congress office before heading for the Raj Bhawan. On

sent its proposal to the Governor the third time, sticking to the July 31 date for holding a session and refusing to mention that it planned to hold a trust vote. In its reaction, the Raj Bhawan said Wednesday that the government had not given clear replies to his previous queries. It reminded that the Governor had asked the state government to redraft its proposal taking into account three points: a 21-day notice, live broadcast of the proceedings if there is a trust vote, and social distancing during the session.

In addition, he had said a shortnotice session was possible if a trust vote was on the agenda.

# Railways halts all new infra work

New Delhi, July 29: The Railways has halted all new infrastructure works sanctioned for 2020-21 after the government issued orders suspending new schemes, with costs up to Rs 500 crore, till March 2021 due to the financial crunch brought in by the coronavirus pandemic, a Railway Board order has said.

It has also directed zonal railways and its production units to

only take on new works if it was essential for the safety of running trains, that too with the approval of the finance ministry. The Railways has estimated a loss of Rs 35,000 crore to Rs 40,000 crore in the passenger segment and is 18 percent behind so far in freight loading as compared to last year due to the pandemic.

The Railway Board in an order dated July 28 has also said all other work sanctioned in previous years that have made little or no

progress should be halted as well. New works/ Umbrella works included in Pink Book 2020-21 shall be kept in abeyance.

However, those works which impact the safe running of trains and are considered essential and inescapable may be considered for sanction. Essentiality of such works will be examined by concerned Additional Member, Additional Member/Works and Additional Member/Revenue, the order said.

# Rhea moves SC for probe transfer

New Delhi, July 29: Bollywood actress Rhea Chakraborty Wednesday moved the Supreme Court seeking transfer of an FIR from Patna to Mumbai and the stay on the investigation by the Bihar police on the allegations of Sushant Singh Raiput's father that she abetted "suicide" of his actor son.

Rajput, aged 34, was found hanging from the ceiling of his apartment in suburban Bandra in Mumbai on June 14 and since then the Mumbai police has been probing the case keeping in mind various angles.

The move of Rhea to rush to the top court assumes significance in view of the fact that a four-member probe team of Bihar police is already in Mumbai and may seek to interrogate the actress as the FIR lodged at Patna by Rajput's father, K K Singh, contained allegations of severe criminal offences such as abetment of suicide and criminal breach of trust under the IPC.

Advocate Satish Maneshinde, who is representing Chakraborty, said he has filed a petition in the apex court seeking transfer of the case from Patna to Mumbai where the probe in the death case of actor

Sushant Singh Rajput is going on. The move came, four days after Rajput's father K K Singh lodged an



in Patna against Chakraborty and six others, including her family members, accusing them of abetting the actor's suicide.

The case, in which Mumbai police has been busy quizzing Bollywood's big producers and directors like Mahesh Bhatt, Sanjay Leela Bhansali, Aditya Chopra and others to know the reasons behind the untimely demise of the 34-year-old actor, suddenly took a new turn with Rajput's father lodging the FIR against his rumoured actor girlfriend Rhea and six other.

Rhea Chakraborty had also recorded her statement with the Mumbai police. Singh, July 25, lodged the FIR under various sections of IPC including 306 (abetment of suicide), 341 (punishment for wrongful restraint), 342 (punishment for wrongful confinement), 380 (theft in dwelling house), 406 (punishment for criminal breach of trust) and 420 (Cheating and dishonestly inducing delivery of

# Troop disengagement remains uphill task

India claims that Chinese People's Liberation Army troops have not moved back as per the agreed consensus arrived at during the disengagement talks between both countries. China claims that disengagement in most fric-

tion points is complete.

Chinese foreign ministry spokesperson Wang Wenbin said on Tuesday in Beijing that disengagement is complete.

Both the countries' military representatives have planned to meet and carry out talks to resolve the dispute again. India has now deployed around 35,000 more troops at the disputed places to match the Chinese deployment in the area. The Indian Army is preparing for a long haul and harsh winter in

the high-altitude region. The Indian government stated that the Chinese troops have not gone back at the friction points. Nothing much has changed on the ground at Gogra and Pangong Lake and Depsang. The Pangong Lake and Hot Springs-Gogra area that is part of Patrol Point 17A still remains



volatile. At Pangong Lake, the Chinese troops did move back from Finger 4 to Finger 5 on the bank but still remain on the mountain spurs or the ridgeline. In fact, the Chinese have only been strengthening their positions between Finger 5 and Finger 8.

The mountain spurs jutting into the lake are referred to as "fingers" in military parlance. China is not complying with the roadmap for a complete pullback drawn out during the Corps Commander-level meet on July 14. PLA troops have not moved back.

The Indian security establishment said that the Chinese retreated a bit and then returned, so there is a need for "constant verification" of the consensus achieved during the meetings between Indian and Chinese military teams. The two countries are locked in a 10-week standoff at multiple points, hitherto unprecedented, along the border.

# NGOs fear rise in human trafficking in post-lockdown period

New Delhi, July 29: About 89 per cent of NGOs surveyed for a study have said that trafficking of both adults and children for labour will be "one of the biggest threats" in the post-lockdown period as household incomes of the most vulnera-

The study conducted by the Kailash Satyarthi Children Foundation said the non-governmental organisations voiced the concern that "there is a very high likelihood" of an increase in human trafficking in the post-lockdown period for the purpose of labour.

"Seventy-six per cent of the NGOs anticipate human trafficking for the purpose of sexual abuse and child trafficking for the purpose of



sexual exploitation to see an upsurge post the lockdown," it said. The study recommended greater surveillance at village level and alertment agencies.

Titled Impact of Lockdown and Economic Disruption on Low-Income Households with Special Reference to Children, the study is based on re-

sponses of 53 NGOs (phase-1) and 245 households from the traffickingprone states (phase-2). The phase 1 was carried April 27-May 5 and the phase-2 from May 17 to 24.

The responses of NGOs were sought because of their close links



# Moderna's vaccine protects monkeys against Covid: Study

Washington, July 29: Moderna Inc Tuesday said its experimental COVID-19 vaccine induced a robust immune response and protected against infection in a study on monkeys

The candidate vaccine, mRNA-1273, was co-developed by scientists at Moderna and the National Institute of Allergy and Infectious Diseases (NIAID) in the US. The study, published in the New England Journal of Medicine, complements recently reported interim results

from an NIAID-sponsored Phase 1 clinical trial of mRNA-1273

On Monday clinics around the US began a Phase 3 trial of the vaccine candidate, with the aim of enrolling 30,000 people to test for safety and effectiveness. In the latest study, three groups of eight rhesus macagues received two injections of 10 or 100 microgrammes (µg) of mRNA-1273 or a placebo. Injections were spaced 28 days apart.

Vaccinated macaques produced high levels of neutralising antibodies directed at the surface spike protein used by SARS-CoV-2 to at-



tach to and enter cells, the researchers said. Animals receiving the 10-µg or 100-µg dose vaccine candidate produced neutralising

antibodies in the blood at levels well above those found in people who recovered from COVID-19, they said. The researchers said the ex

perimental vaccine also induced Th1 T-cell responses but not Th2 responses. Induction of Th2 responses has been associated with a phenomenon called vaccine-associated enhancement of respiratory disease (VAERD), they said. According to the researchers, vaccine-induced Th1 responses have not been associated with VAERD or other respiratory diseases. The experimental vaccine also induced T follicular helper T-cell responses that may have contributed to the robust antibody response, they said.

Four weeks after the second in-

jection, all the macaques were exposed to SARS-CoV-2 via both the nose and the lungs, according to

It found that after two days, no replicating virus was detectable in the lungs of seven out of eight of the macagues in both vaccinated groups. while all eight placebo-injected animals continued to have replicating virus in the lung.

None of the eight macaques vaccinated with 100 µg of mRNA-1273 had detectable virus in their noses two days after virus exposure, the researchers said

# **UK strikes pact for 60mn doses** of nCoV experimental vaccine

London, July 29: The UK government Wednesday announced an early access agreement with GlaxoSmithKline (GSK) and Sanofi Pasteur for an estimated 60 million doses of an experimental new vaccine being tested to combat

The agreement with Britain's GSK and France's Sanofi, which combined have among the largest vaccine manufacturing capabilities in the world, will supply the UK with 60 million doses of their vaccine based on existing DNA-based technology used to produce Sanofi's flu vaccine.

While it remains uncertain as to which, if any, of the anti-coronavirus vaccines under various stages of development around the world will ultimately work, the British government said the latest



deal helps grow the country's portfolio of vaccine candidates and adds to previous agreements.

"Our scientists and researchers are racing to find a safe and effective vaccine at a speed and scale never seen before. While this progress is truly remarkable, the fact remains that there are no guarantees," said UK Business Secretary Alok Sharma.

## China reports 101 new COVID-19 cases

Beijing: China's COVID-19 cases in a single day have crossed the 100-mark for the first time in over three months, sparking the fear of a rebound after Beijing contained it in Wuhan where the contagion first emerged in December last year. The National Health Commission on Wednesday said that 101 new confirmed coronavirus cases including 98 locally-transmitted and three imported ones were reported in the country on Tuesday. Eighty-nine of the 98 locally-transmitted cases were reported in Xinjiang Uygur Autonomous Region, eight in Liaoning province and one in Beijing Municipality, the commission said in its daily report.

## Trump defends use of HCQ

Washington: US President Donald Trump has again defended the use of hydroxychloroquine to ward off coronavirus, saying many frontline medical workers agree with him that the malaria drug works in the early stages of COVID-19 infection, despite mounting evidence that it is ineffective in treating the disease. In May, Trump disclosed that he was taking daily doses of hydroxychloroquine to ward off coronavirus after consulting the White House doctor.

# **IRAN LAUNCHES UNDERGROUND BALLISTIC MISSILES**

Tehran, July 29: Iran's paramilitary Revolutionary Guard launched underground ballistic missiles as part of an exercise involving a mock-up aircraft carrier in the Strait of Hormuz, state television reported Wednesday.

Ballistic missile fire detected from the drill resulted in American troops being put on alert at Al-Dhafra Air Base in Abu Dhabi in the United Arab Emirates and Al-Udeid Air Base, the forward headquarters of the US military's Central Command in Qatar; the military said.

Troops sought cover during that time. Al-Dhafra also is temporarily home to five Frenchbuilt Rafale fighter jets on their way to India for that country's air force. It was the latest barrage in a drill that the previous day saw two American bases temporarily go on alert over the launches.

Drone footage captured by the Guard showed two missiles blasting out from covered positions in what appeared to be a desert plateau in central Iran, with debris flying up in the air in their wake. The launches took place on Wednesday, said Gen. Amir Ali Hajizadeh, the head of the Guard's aerospace division.

# Special assistants to Pak PM resign amid criticism

Islamabad, July 29: Pakistan Prime Minister Imran Khan lost two of his key aides Wednesday when they resigned after the assets and dual nationalities of over a dozen of his special assistants were made public, prompting the Opposition to mount an attack on the government.

Shortly after Tania Aidrus, Special Assistant to Prime Minister on 'Digital Pakistan' announced her resignation, Special Assistant on Health Dr Zafar Mirza too quit the high-profile job. The resignations come amid re-

cent criticism levelled against the government after assets and nationalities of 15 special assistants to Prime Minister Khan were made public last week, revealing that seven of them were either dual nationals or held another country's permanent residency, as well as the details of their assets, the Express Tribune reported. Aidrus, a former Google executive who was appointed as the Special Assistant earlier this year and tasked to head the Digital Pakistan initiative, announced her resignation after doc uments found that she had a Canadian citizenship and was also a resident of Singapore. Aidrus announced on Twitter that she was



resigning due to the criticism against the government because of her dual-citizenship. "Criticism levied towards the state as a consequence of my citizenship status is clouding the purpose of 'Digital Pakistan'. In the greater public interest, I have submitted my resignation from the SAPM role. I will continue to serve my country and the PM's vision to my best ability," Aidrus tweeted. "I have resigned

as SAPM. I came to Pakistan on a personal invitation of @ImranKhanPTI leaving WHO. I worked hard & honestly. It was a privilege to serve Pakistan. I am satisfied that I leave at a time when COVID-19 has declined in Pakistan as a result of a grand national effort." Mirza tweeted. Prime Minister Khan's Special Assistants who have dual nationalities include, SAPM on Petroleum Nadeem Babar (US), SAPM on Overseas Pakistanis Syed Zulfigar Abbas Bukhari (UK) and SAPM on Power Division Shahzad Qasim (US).

# Very different, symbolic Hajj in Saudi amid virus

THE HAJJ IS ONE OF ISLAM'S MOST IMPORTANT AND PROFOUND REQUIREMENTS, PERFORMED ONCE IN A LIFETIME

Dubai, July 29: Pilgrims, donning face masks and moving in small groups after days in isolation, began arriving to Islam's holiest site in Mecca on Wednesday for the start of a historically unique and scaleddown hajj experience reshaped by the coronavirus pandemic.

It follows a route the Prophet Muhammad walked nearly 1,400 years ago and is believed to ultimately trace the footsteps of the prophets Ibrahim and Ismail, or Abraham and Ishmael as they are named in the Bible.

The communal feeling of more than 2.5 million people from around the world — Shiite, Sunni and other Muslim sects — praying together,


eating together and repenting together has long been part of what makes hajj both a challenging and rewarding experience like none

International media were not permitted to cover the hajj from Mecca this year. Instead, Saudi government broadcast live footage from the Grand Mosque on Wednesday showing limited numbers of pilgrims, moving several feet apart, circling the cube-shaped Kaaba in the first rituals of the hajj.

# **HK PROTEST LEADER FIRED** FROM TEACHING JOB

Hong Kong, July 29: A professor and leading figure in Hong Kong's political opposition has been fired from his university job following China's passage of a sweeping new national security law.

Hong Kong University's council voted to oust Benny Tai from his position as an associate law professor in an 18-2 vote Tuesday, local media reported. Tai has been out on bail since being sentenced to 16 months in prison in April 2019 as one of nine leaders put on trial for their part in a 2014 drive for universal suffrage known as the

Umbrella Movement. In a Facebook post Wednesday, Tai said he intended to continue writing and lecturing on legal issues and asked for public support. "If we continue in our persistence, we will definitely see the revival of the rule of law in Hong

Kong one day," Tai wrote. While the 2014 movement failed in its bid to expand democracy in the semi-autonomous Chinese city, protests returned last year following the local government's proposal of legislation that would have seen criminal suspects extradited to face trial in mainland China. Opponents called that a violation of Hong Kong's independent legal system it was guaranteed after being handed over from British to Chinese rule in 1997. Although the legislation was eventually shelved, the protesters' demands expanded to include calls for democratic changes and an investigation into alleged police abuses, growing increasingly violent over the second half of the

That prompted Beijing to pass the national security law, saying opposition made such a move impossible at the local level in Hong Kong. Critics have decried the law as part of a major crackdown on political activity, free speech and academic independence that hasprompted a prominent opposition group to disband.

India has stated that these ICT products are part of WTO's Information Technology Products (ITA-2) agreement, and New Delhi is not part of this pact. India is a part of ITA-1, signed in 1997.

According to the minutes of a meeting of the dispute settlement body held in February and March, India had stated that it was fully committed to ITA-1 and had been abiding by it over the years.

India reiterated that it had not intended to commit, and would not commit, to any obligations beyond the scope of India's ITA-1 commitment and it has maintained that the products arising out of technological progression could not be covered under ITA-1, as per the the minutes of the meeting.

A WTO member country can file a dispute if it perceives that another country's trade policies or actions are violating global trade norms and impacting their local industry.

# **IndiGo posts worst** quarterly loss in five years

Bangalore, July 29: Interglobe Aviation Ltd, which runs India's largest airline IndiGo, reported the steepest quarterly loss in at least five years on Wednesday as travel restrictions due to the COVID-19 pandemic hit its operations.

A more than two-month long lockdown that started in March to curb the spread of the pandemic forced the airline to halt its operations, adding to its woes as it was already grappling with higher maintenance costs and weak de

The airline said it expects second-quarter average seat kilometers (ASKs) to be around 40% of its ASKs for the same quarter a year earlier.

"The aviation industry is going through a crisis of survival," Chief Executive Officer Ronojoy Dutta said in a statement.

First-quarter net loss came in at Rs 28.49 billion (\$381.31 million), compared with a profit of 12 billion rupees a year earlier. Analysts had forecast a loss of Rs 22.63 billion, according to Refinitiv.

Indigo, which dominates the domestic market, said total debt as of June stood at 235.52 billion rupees, up nearly 28% from a year ear-

# China imports all-time high PVC from India

The record exports of PVC from India come at a time when the government is looking at ways to curb imports from China

New Delhi, July 29: Giving rise to an anomalous situation. China imported record high PVC from India in June at a time when the two countries are locked in a tussle at the border amid calls for reducing trade flows.

China imported a record high PVC 27,207 MT of PVC from India in June: more than five times compared to 5,174 MT recorded in May as India accelerated PVC exports during the COVID-19 lockdown, Global Rubber Markets reported.

It is a rare move as the Indian PVC market is net short by close to 2 million MT/year. During the lockdown, India's PVC demand plunged, prompting cancellation of PVC deliveries to India. Suppliers had to move their cargoes to China to clear excess supplies, it added.

Looking forward, market sources said China's PVC imports from India would likely slow as the lockdown ended early-June. For June



delivery, market participants negotiated in May.

Polyvinyl Chloride (or PVC for short) is the third most widely produced plastic in the world following polyethylene and polypropylene, and it is used in a wide variety of applications in industry, construction, agriculture, consumables, packaging, power production and public utilities. PVC is highly durable, resistant and flexible, making it useful for use in clothing, pipes, insulation and many other areas

To curb imports, Indian companies are submitting proposals to the government on ways to reduce import dependence on China.

# **BP**, Total not to bid for BPCL



New Delhi, July 29: Supermajors BP Plc and Total of France may not bid for the acquisition of Bharat Petroleum Corp Ltd (BPCL) as foreign investors weigh inflexible locations of company's oil refineries as well as tough labour laws against access to world's fastestgrowing fuel market.

Among the probables who could bid to buy government's entire 52.98% stake in India's third-biggest oil refiner and second-largest fuel retailer at the close of bidding on Friday include Russian energy giant Rosneft or its affiliates, Saudi Arabian Oil Company (Saudi Aramco) and billionaire Mukesh Ambani's oil-to-telecom conglomerate Reliance Industries Ltd (RIL), multiple sources said.

Top consideration for investors is the \$10 billion or around Rs 75,000 crore price tag at current market price, and, after including the requirement to make an open offer for additional 26% stake from shareholders post buying out of the government share, they said.

This price would give buyer ownership of BPCL's three refineries - Mumbai, Kochi in Kerala and Bina in Madhya Pradesh -16,309 petrol pumps, 6,113 LPG distributor agencies and more than a fifth of 256 aviation fuel stations in the country.

statement. The project will be executed on hybrid annuity mode (HAM). The project is a greenfield project and the concession comprises 730 days for construction and 15 years operations and maintenance rights thereafter.



# Path to recovery in doubt as murky outlook darkens: Poll

Bangalore, July 29: The outlooks for India's reeling economy has worsened again as business activity slows and COVID-19 infections soar, and will probably prompt the Reserve Bank of India (RBI) to cut interest rates again soon, a Reuters poll of economists suggests.

The latest findings echo recent criticism of New Delhi's \$266 billion economic rescue package, which does not include new spending, tax breaks or cash support, suggesting more will be needed to turn the economy around.

With India now the third-worsthit country by number of infections after the United States and Brazil, the risk of renewed lockdowns after a nationwide shutdown in March-May has risen. The Indian economy is now likely

to contract this quarter and next and in this fiscal year as a whole, according to the July 20-28 poll of nearly 60 economists. Growth had been expected for all of those periods except the second quarter in the previous poll, taken in April.

"India's failure to contain the spread of COVID-19, and the government's underwhelming support package for firms and households, means the economy will suffer its largest drop in output on record this year," said Darren Aw, Asia economist at Capital Economics in Singapore. In the quarter just gone by, the Indian economy is forecast to have shrunk


Under a worst-case scenario, the economy is forecast to have contracted 30.0% in the April-June guarter, and to shrink 10.0%, 4.0% and 9.1% in the current and next quarters and this fiscal year, re-

"The health crisis is yet to be addressed and is spreading geographically, which has led to reinitiation of lockdowns and restrictions in many parts of the country," said Prithviraj Srinivas, chief economist at Axis Capital in Mumbai. "With the health crisis yet to be contained, we cannot hope for a smooth recovery.

When asked how long would it take for India's gross domestic product to reach pre-COVID-19 levels, a slight majority of economists, 23 of 44, said within two years.

Inflation is expected to average 4.5% this fiscal year, and the RBI is forecast to cut the repo rate by another 25 basis points at its Aug. 4-6 meeting, and once more next quarter, to a record low of 3.50%.

# PAK SERIES IN BROAD'S MIND ,

Manchester, July 29: Stuart Broad said he still feels fresh and is keen to reprise his heroics against West Indies when England will return to the Test arena next week for a threematch series against Pakistan. England meet Pakistan in the first of their three-match series at Old Trafford from August 5-9.

The 34-year-old paceman became only the seventh bowler to reach the milestone of 500 Test wickets as he helped England to a resounding 269-run victory over West Indies Tuesday to win the third Test at Old Trafford and clinch the series 2-1.

He took 10 wickets in the Test for only the third time in his career and was named man of the series despite his surprise omission from the first Test in Southampton.

"I've never really set any targets and I've learned a huge amount through my career, but what is pleasing me at the moment is that I feel so fresh and excited to play the game and I've done some technical work that makes me feel in a great rhythm," he told 'Sky Sports'.

"Now I'm looking forward to a couple of days off outside the biosecure environment but also looking forward to being back and playing against Pakistan."

Broad's 500th wicket came at the start of the day when England rushed to try and dismiss the tourists because the threat of rain hung heavily overhead and there were intermittent stoppages.

He trapped Kraigg Brathwaite leg before wicket for the milestone, matching the achievement of his opening ball partner James Anderson whose



500th Test wicket came up at Lord's three years ago when he dismissed the same batsman. "What a stat that is," Broad said. "Jimmy told me in the warm-up, 'you know who it's going to be' and then told me his 500th victim was Brathwaite. The stars have to be aligned for that to happen! I think that's going to be a quiz question for many years to come.'

"When you get a milestone and put in performances, you want them to lead to wins so to get to 500 on a day that we managed to win a Test match and a series feels very great, very special," Broad added.

## YUVRAJ URGES FANS TO APPLAUD 'LEGEND' BROAD

New Delhi: India's flamboyant former all-rounder Yuvraj Singh Wednesday doffed his hat to Stuart Broad, 13 years after nearly bringing about a premature end to the England pacer's career with six sixes in an over. Broad, Tuesday, became only the seventh bowler and fourth speedster to take 500 wickets in Test cricket. Yuvraj took to Twitter to ask his fans to applaud the Englishman's hard work and achievement. "I'm sure every time I write something about @StuartBroad8, people relate to him getting hit for 6 sixes! Today I request all my fans to applaud what he has achieved! 500 Test wickets is no joke - it takes hard work, dedication & determination. Broady you're a legend! Hats off," Yuvraj tweeted. Broad was only in his second year in international cricket when Yuvraj famously took him apart in a World T20 match in Durban in September 2007. Broad was dispatched for six sixes in the 19th over of India's innings. Since that forgettable night at the Kingsmead, Broad has gone on to play 140 Tests, 121 ODIs and 56 T20Is for England, bagging 744 international wickets across formats. The two share a cordial relationship. When Yuvraj called time on his international career, Broad posted a picture of the two with the caption, 'Enjoy retirement Legend @yuvisofficial'.

# ANAND LOSES TO 1924 Games set stage for Hollywood endings WORLD NO.3 DING

Chennai, July 29: Former World Champion Viswanathan Anand crashed to his seventh defeat in the USD 150,000 Legends of Chess online tournament, going down 0.5-2.5 to World No.3 Ding Liren in the eighth round.

Going into the match against the Chinese after ending his sixmatch losing streak, Anand surrendered the first game in just 22 moves late Tuesdav.

The duo settled for a 47-move draw in the second before Liren sealed victory in the third game with black pieces in 41 moves.

Anand lies last in the table with six points with Liren and Peter Leko. The 50-year old Indian takes

on Vasyl Ivanchuk in the ninth and final round.

World No.1 Magnus Carlsen overcame the challenge of Russian Ian Nepomniachtchi after the fourgame contest ended at 2-all. The Armageddon (a tie-break) also ended in a stalemate but the Norwegian won and picked up three points because he played black.

The Norwegian player maintains his position at the top of the table with 22 points followed by Nepomniatchi (19) and Anish Giri (15). Carlsen has won all the eight matches he has played so far. Giri lost 2-3 to veteran Ivanchuk but is in line to qualify for the last four.

The tournament is part of the Magnus Carlsen Chess Tour. The winner of this event will qualify for the USD 300,000 Grand Final scheduled from August 9 to 20.

Washington, July 29: There was a soon-to-be Hollywood star in the pool, and a soon-to-be Hollywood ending on the track at the 1924 Paris Olympics.

Johnny Weissmuller, the American swimmer who went on to star as Tarzan in a dozen films, won three swimming gold medals at the Paris Games and also earned a bronze

medal in water polo. Weissmuller won the 100-meter freestyle, 400 free and 4x200 free. In the 100 free sprint Weissmuller edged American teammate Duke Kahanamoku, the two-time defending champion in the event who is also the father of modern surfing. Kahanamoku won his golds in the 100 free in 1912 and 1920. The 1916 Games were canceled because of

World War I. After winning two more gold medals in 1928. Weissmuller became a model and eventually started working as an actor. He starred as Tarzan in 12 feature films.

"I went to the back lot at MGM, they gave me a G-string and said, Can you climb a tree? Can you pick up that girl?' I could do all that, and I did all my own swinging because I had been a YMCA champion on the rings," Weissmuller was quoted as saying in his Associated Press obituarv from 1984.

The other story that made its way into movie theaters came in the form of the Academy Award-winning film 'Chariots of Fire'. The movie about two British sprinters, Harold Abrahams and Eric Liddell, centers around their gold-medal performances at the Paris Olympics.

Abrahams won the 100 meters, upsetting a group of Americans in the final, including defending champion Charley Paddock — the first

person to be known as 'the fastest man alive' after his gold-medal performance four years earlier in Antwerp. Paddock finished fifth in the 1924 final.

Liddell, who also played international rugby for Scotland, was a 100-meter runner as well. But because of his deep Christian beliefs, he dropped out of that event when he learned he would have to run in the heats. Instead, he won the gold medal in the 400 meters.

**FASTER. HIGHER. STRONGER** 



The 1924 Games, the second to be held in Paris, were the first to adopt the Olympic motto 'Citius, Altius, Fortius', or 'Faster, Higher, Stronger' It was also the first to raise three flags at the closing ceremony, one for the International Olympic Committee, one for the host country, and one for the future host country. It was also the first games to house athletes in an Olympic Village.

# **HISTORIC SWIMMER**

There was a gold medalist in the pool who made more of a name for herself in salt water two years later.



Gertrude Ederle won gold in the 4x100 freestyle as well as bronze medals in the 100 free and 400 free. But she achieved international acclaim in 1926 when she became the first woman to swim across the English Channel.

**FLYING FINNS** 



The 'Flying Finns', led by Paavo Nurmi and Ville Ritola, dominated the distance events on the track. Nurmi won the 1,500 meters and the 5,000 meters on the same day, and added another gold in cross-country. Ritola won the 10,000 meters and the steeplechase, as well as finishing second to Nurmi in the 5,000

and in the cross-country event. Nurmi and Ritola combined to help Finland win more gold in the 3,000meter and cross-country team

## **JUMPING INTO HISTORY**



DeHart Hubbard of the United States became the first black athlete to win an individual event at the Olympics, taking gold in the long jump. However, according to Olympic historian David Wallechinsky, Hubbard's feat was overshadowed by teammate Robert Legendre, who had failed to qualify in the long jump but set a world record in the event during the pentathlon a day earlier.

## **UNLIKELY GOLD**

The United States won the gold medal in rugby union, beating France in the final. It was the last time the 15-per-side sport was played at the Olympics. Rugby Sevens, however, was added to the program for the 2016 Rio de Janeiro Games.
