COVID TRAVELOGUE: FROM GUJ TO ODISHA

About 10 lakh people from various states and countries returned to the state between March and July; 4 lakh from Gujarat alone


Bhubaneswar, August 1: Gujarat—from where nearly about 4 lakh people arrived to Odisha during the lockdown period— is found to be responsible for major Covid-19 transmission in

This was revealed from a study conducted by Bhubaneswar based Regional Medical Research Centre (RMRC) and Institute of Life Sciences (ILS) after analysing 225 viral genomes of Covid positive patients who had migrated from 13 Indian states including Gujarat.

About 10 lakh people from various states and countries returned to the state in between March and July. Of them, about 4 lakh were from Gujarat alone and most of them returned to Ganjam district, which has reported highest 10,672 cases so far.

"We have analysed the samples for sequenc-



ing collected during March to July 2020. Analysis of samples showed the presence of all five reported clades (19A, 19B, 20A, 20B and 20C) of Covid-19 genome in the patients of Odisha," said RMRC director Sanghamitra Pati.

However, clade 19B was found to be much more prevalent in analysed samples as compared to other genomes reported so far from

The study showed evolution of 19A and 19B

in parallel. Majority of the 19A and 19B clades were present in cases that migrated from Gujarat state suggesting it to be one of the major initial points of disease transmission during month of March and April.

The director added phylogenetic analysis showed that clades 20A and 20B evolved quite rapidly in the Indian population and are major source of disease transmission in the country. Whereas, 20C strain is rarely detected and appeared to be less adapted or somehow contracted at early stages of infection.

The analysis also revealed higher proportion of symptomatic patients with clades 20A, 20B and 20C. The clade 20C was observed in Odisha and not present in any other isolates included in 1000 genome analysis. From these results it is obvious that Europe and Southeast Asia are two major routes of disease transmission in Odisha, she concluded.

Very heavy rain to lash Odisha from tomorrow

The state has received 17 pc deficit rainfall this monsoon

Bhubaneswar, August 1: The India Meteorological Department (IMD) Saturday said a fresh low pressure area is likely to form over north Bay of Bengal around August 4. Under its impact, very heavy rainfall will lash several parts of the state during the next four days.

The southwest monsoon has become weak in the state during past 15 days. A low pressure area is developing over north Bay of Bengal, which will bring heavy rainfall in many places across the state from tomorrow," said Bhubaneswar Met Centre director HR Biswas.

So far, the state has received 17 per cent deficit rainfall than normal rain in this monsoon season.



As many as 13 districts have recorded deficit rainfall of 20 to 59 per cent. The districts are—Puri (52 per cent deficit), Khurda (48%), Kendrapara (45%), Jajpur (45%), Cuttack (42%), Balasore (40%), Sonepur (37%), Jagatsinghpur (33%), Bhadrak (28%), Mayurbhanj (24%), Nayagarh (23%), Keonjhar (22%) and Bolangir (20%).

Out of 61 days in the past two months, there were 23 rainy days in June and 25 in July. The state witnessed 48 rainy days. Puri district saw only 35 rainy days while it was 43 in Khurda district, 41 days in Jagatsinghpur, 31 in Kendrapara, 45 in Bhadrak and 46 in Sonepur.

Some coastal districts have recorded deficit rainfall and this low pressure will bring rain in those areas, experts said, adding, the rainfall activity may also continue further. The monsoon will be there in the state till October 10

Visakhapatnam, August 1: At least 11 persons were reported killed and several others injured when a jetty crane collapsed Saturday at the Hindustan Shipyard Limited premises.

According to eyewitness accounts, the mishap occurred between 11.30 am and 12 noon when officials were testing the crane. At least 20 persons were working on the spot when the crane broke and fell on its side. crushing many workers.

Of the 11 casualties reported so far, four persons are said to be regular employees, while the remaining seven are contract staff.

District authorities rushed to the spot and took stock of the situation.

District Collector V Vinay Chand said: "The 70tonne capacity jetty crane was procured and commissioned two years ago and its full-fledged trials were initiated this morning. During the trials, officials



Immunity-boosting Vit C tabs selling like hot cakes

Despite new entrants in the market to cater to the demand, prices up by 3 times

Bhubaneswar, August 1: The outbreak of Covid-19 pandemic in the state has led to surge in demand for Vitamin C tablets owing to its immunity boosting qualities.

As the demand grows exponentially, chemist shops are running out of 'nutraceutical' and other products.

It is found that several alternatives or substitutes by some pharmaceutical companies have made inroads into the market but interestingly, they have further pushed the prices up. A few companies have rebranded their products and upped the prices by three times without even changing the combination. There are also some firms which have changed the composition to cater to the high demanding micronutrient. A close survey of some of the chemist shops in the state capital revealed that some new brands have also entered the pharma market to sell their version of the nutraceutical.

"Earlier, there was hardly anyone buying Vitamin C tablets but now due to the surge in demand because of Covid, we are seeing many customers. Several new brands offering the tablet and some with a combination of Vitamin C and Zinc have now entered the market and are making good business," said a representative from Shree Krishna



Medical Store, Satya Vihar in the city. Medically speaking, both Vitamin C and Zinc are considered as micronutrients with immunity boosting capabilities. "Both the nutrients are taken to boost immunity. They are even recommended by the ICMR for treatment of Covid patients. As they are nutraceutical, they are easily bought over the counter without any prescription," said Dr Manoj Sahu, a gastroenterologist from the city.

He also said that prolonged and excessive use of the drug should be avoided. Dr Sahu highlighted that while many countries do have norms to regulate sales of nutraceuticals, India is yet to finalise the norms. "The process had started for regulation of norms, but Covid pandemic delayed it further," he said. With lesser regulations, several pharmaceutical firms have now chipped in to get dividends from the high demanding product.

Nevertheless, doctors and pharma representatives claim that prices of life-saving and essential drugs have not been tinkered with during this hour of crisis.

"There could be some sporadic reports of black-marketing but at large we have not seen any rise in prices of drugs for most of the diseases. In fact, prices of cancer drugs have come down due to the regulation of the lifesaving drugs by the National Pharmaceuticals Pricing Authority (NPPA) in the past two years," said Ajay Goenka, Treasurer, Utkal Chemist and Druggists Association, Cuttack.

Dr Alakta Das, a gynecologist from the city also said that the prices of drugs for hypertension and diabetes and other common co-morbidities have not changed drastically. She added that surgical and medical equipment like masks, sanitisers and gloves have seen a spike in prices with the onset of Covid-19 in the state

PPE kits revive single-use 'plastic' monster

MICROBIAL FORCES TO DEFEAT HARD-FOUGHT VICTORIES THAT CURBED SINGLE-USE PLASTIC IN THE STATE

Bhubaneswar, August 1: Odisha was set to earn accolades as an ecofriendly state in the country after it had snubbed plastic. The government, in a notification September 30 last year, prohibited manufacture, sale, trade, import, storage, transportation and distribution of single-use plastics.

However, we are back to square one after the pandemic hit us. PPE kits, armour against Covid-19, have become a headache now as disposing them involves health risk apart from environmental concerns.

PPE or Personal Protective Equipment which includes goggles, face shields, masks, gloves, coveralls or gowns are made of plastic. Used largely by doctors and researchers, PPEs which are Single Use Plastic (SUP) have seen an exponential rise in demand.

Moreover, apart from the PPE kits, countless masks, gloves and other protective gears made of SUP



and discarded after use by the public are finding their way to water bodies. A study by environmentalists and conservationists presented a grave picture. The report said: If each citizen (state's) uses a singleuse face mask a day for a year, it would create an additional 32,000 tonnes of contaminated waste and 17,000 tonnes of plastic packaging.

regation from the daily waste could prove fatal! The pandemic might get over but people will continue to use protective gears. This (dumping) will be an issue when state reopens its tourism industry," said Ashok Kar, a former IFS officer.

Even though the state government has issued strict Standard Operating Procedures (SOPs) for disposing PPE kits by hospitals, the civic behaviour defeats the purpose. Panic gripped the denizens of Nabarangpur June 26 after used PPE kits were found dumped on a busy road, the report added.

Furthermore, with the state government's priorities shifting from battling plastic to battling Covid, single-use plastics have resurfaced in markets and shops. "Even though a drop in demand for plastics has been observed due to closure of restaurants, malls, poor enforcement has seen plastics and polythene re-emerge," said Shubhendu Roy, an environmentalist.

As per sources, the state had seized about 21,845 kg of plastic and collected fines of about ₹59.20 lakh from 30 districts until January.

The Bhubaneswar Municipal Corporation (BMC) too boasted seizing 5,100 kg of plastic with ₹13.26 lakh fines during the same period. However, ever since the first Covid case was detected in the city in March no such information regarding fines and raids have been presented.

"Our priority has always been conservation of our nature but

right now it has shifted to safety of our people," a senior BMC official said. "We have shifted our attention and allocated manpower to battle Covid and once this is over we will continue our fight against plastic," he added.

Odisha records 1,602 Covid cases in 24 hrs

Bhubaneswar: August 1: Odisha reported its highest single-day spike of 1,602 coronavirus cases in the last 24-hour cycle, taking the state's total to 33,479, the Health Department said Saturday.

The death toll increased to 187 after 10 more fatalities were reported from Ganjam, Khurda, Gajapati, and Sundargarh districts. Corona hotspot Ganjam district has so far recorded 99 fatalities, followed by Khurda at 25.

Of the 1,602 new cases, 993 were reported from quarantine centres and 609 are local contacts. The new cases have been detected in 29 districts. Contact-tracing and follow-up actions have been initiated, said an official. Ganjam district registered the highest 308 new cases, followed by Khurda (285), Rayagada (164) and Gajapati (108). The active cases now total 12,737, with 20,517 patients cured and discharged so far.



Paradip-Haridaspur railway line project was sanctioned in 1996 and its foundation stone was laid in 1999. However, the completion of the project was delayed by almost



Bhubaneswar, August 1: The state registered its highest single-day spike of 1,602 Covid-19 cases Saturday pushing the state's tally to 33,479 Saturday and the toll rose to 187 with 10 more deaths, a health department official said.

The 10 fresh fatalities were reported from four districts. Ganjam reported the highest five deaths, three in Khurda and one each in Gajapati and Sundergarh districts, the official said.

Ganjam district, which has emerged as Odisha's coronavirus hotspot, has so far accounted for 99 fatalities, followed by Khurda



Apart from the 10 fatalities, another 30-year-old Covid-19 positive male patient of Nayagarh district died due to acute chronic kidney disease and septic shock.

With this, the number of Covid-19 positive patients succumbing to other reasons has gone up to 38 in the state, the official said.



Elusive rain adds to pandemic woes of farmers

very year, Sanatana Bhoi, 60, a landless share cropper in Anastamala, grows paddy on one acre of land. The return, around 15 bags of paddy (his share) ensures Sanatan's family of three, rice for the year.

This year though, Santana is apprehensive of that luxury. With an erratic monsoon causing insufficient rainfall, so far, Sanatana transplanted paddy seedlings last week after watering the patch of land with the help of a kerosene run pump. He had to shell out Rs 800 for this. However, he is unsure about the harvest.

A few houses away, Harihar Das, 60, another marginal farmer, has spent Rs 4000 on water that he had saved to visit his migrant worker son. who hasn't been able to return home from Kozhikode in Kerala after Covid 19 lockdown was announced in March. Harihar, who has cultivated two acres including his own

.4 acre patch, is worried, too. "Bad monsoon has thrown an extra burden of expenses on our shoulders," Harihar says, adding, "Even, water pumps are not easily available.

nims have left the farmers, small and big, high and dry.

The entire approximately 50 families in Anastamala, a hamlet under Bagalpur village of Turintira panchayat in Khurda district's Balipatna block- a majority of them are scheduled castes- echo Harihar's sentiment. Some of them are landless, the rest own smaller patches; all fall into the category of small and marginal farmers. Primarily dependant on paddy (kharif), they grow mung (green gram) during rabi season. All of them are share croppers. A few hundred metres

away lives Manguli Bhoi (62) with his wife Kusuma in Bagalpur. Both his young sons have died in acci dents, the younger, last year. Age and ailments, don't allow the landless, Manguli or his wife to work on daily wages. The 10 bags of paddy they earn from less than an acre of land they cultivate is all that they can hope for survival.

Even, for others, who work as casual, daily wagers during off time in the vicinity. Covid 19 has curtailed such avenues. "We don't know

what to do," says Manguli. It's not difficult to visualize the sense of uncertainty writ large on his face.

Already pushed to the wall due to the Covid 19, all that the farming community hoped for was a decent monsoon. Left with no option, they blame it on their own destiny. "Perhaps it's happening because of our bad luck," thought a farmer and father of three school-going girls, Chandan Bhoi, 36 in Bagalpur.

While as many as 23 districts of Odisha have recorded a deficit rainfall ranging from 20-57 per cent in July, Khurda tops the list with a rainfall deficit of 57 per cent. The district has received only 124.9 mm of rain this year against 287.3 mm in a normal monsoon. Puri and Cuttack districts are closely behind with less rainfall of 56 and 51 per cent respectively.

According to experts, July is the most crucial month for paddy cultivation (kharif) as up-rooting and transplanting of paddy seedlings are generally carried out in this month.

"Major portion of water required for paddy cultivation is used in the land preparation for transplanting during the soil puddling phase. A minimum level of water is essential not only for the growth of the plants but also to avert excess of weeds. Under irrigated paddy cultivation, kharif crops depend on sup-

plementary irrigation. With monsoon already throwing its tantrums. delay in irrigation could well lead to crop damage. Moreover, under minor irrigation command, "scope of getting water has little possibility due to water level being at below dead storage level (DSL)", said a senior officer in the agriculture department.

"Coupled with erratic rainfall, the high temperature experienced this year could cause heat injury to paddy plants and other field crops at younger stage," the officer cautioned. According to experts, excess or deficit rainfall of 19 per cent is normal in the cropping season. Apart from coastal and central districts of Khurda, Puri, Cuttack, Nayagarh, Dhenkanal, Jajpur, Balasore, Bhadrak, those in the northern part, Keonjhar, Mayurbhanj and Sundargarh are the worst-hit with a shortfall of over 40 per cent.

Currently, the area under cultivation of paddy, pulses, oil seeds and cotton is about 45 per cent in Odisha. Both farmers and experts, say, the best period to transplant paddy seedling is between 14 and 21

days though it's safe to carry out the process when the seedlings are around 30 days-old. "The younger the seedlings are transplanted, the better the vigour of the plants and production," said an agro expert.

Some amount of standing water in the paddy field after transplanting not only helps the plant to establish itself, it also suppresses weeds' growth. This year, lack of required amount of soil moisture has put a question mark on the survivability of the seedlings.

Monsoon's whims have left the farmers, small and big, high and dry. Already, beusaning has been delayed. Though farmers at different locations have irrigated their land with pumps and carried out transplantation of seedlings, the next few weeks, experts say, are crucial and would determine the fate of

"We are sitting with fingers crossed," viewed Sukanta Pradhan, 54, a farmer in Nimapara block of Puri district. Lack of water has forced Sukanta to reduce paddy cultivation from 7 to 4 acres. "If we don't receive normal rainfall in the next two-three weeks, we wouldn't even have enough rice straw even for the cattle," he added.

DROUGHT STALKS SONEPUR, JAJPUR

Sonepur, August 1: July is over, but most parts of Sonepur district, one of the major paddy producing districts in western Odisha, has recorded steep deficit rainfall till date. Farmers started apprehending a possible spectre of a drought with the monsoon almost doing a vanishing act.

According to reports, farmlands have been left bone dry in many pockets under Sonepur, Trabha, Ullinda and Birmaharajpur blocks. In other areas, farmlands are found cracked for want of rain while paddy saplings have started drooling. Farmers are deeply worried how to face the situation when things are already in a mess owing to Covid pandemic.

"If it does not rain in a day or two, the situation will worsen towards drought. Farming activities have been completely delayed. Paddy saplings and sprouts have dried at many places," lamented some farmers of Sonepur and Biramaharajpur


The agriculture department has set a target to produce paddy in 1.235 lakh hectares in the district in this kharif season.

With the state witnessing a deficit of around 12% of rainfall, the situation is extremely severe in this

It is said Sonepur district received 31 per cent rainfall deficit till date which is far less than its neigh-

bouring districts. However, Tarabha block had received a little more rainfall than

the normal in June and July. In July, the district is supposed to receive an average of 373,82 mm rainfall, but it was 198.28 mm. The rainfall in July was most important for farming, but there was

As for the situation, district agriculture officer, Prashant Kumar Satpathy, said, "There was deficient rainfall in July. This problem has arisen in non-irrigated Sonepur and Birmaharajpur blocks.

However, water was released from Hariharajora dam to some parts of Ullunda and Birmajarajpur.

"If the district does not receive good rainfall within seven days, farmers will definitely suffer loss,

9 mega lift irrigation projects incomplete

massive crop loss with drought fear looming large in the district due to scant rainfall, a report said.

They are clueless as to how to manage livelihood in the event of na imminent crop loss. A report from the agriculture department said even as monsoon is nearing its end. the district has received only 48.75mm rainfall. Reports said the district has received only 171.09 mm rain by July end -- 51 per cent less than the rainfall required.

Kharif work here is dependent on rainfall during June, July and August. This has happened as nine under-construction mega lift irrigation projects are yet to become operational. The project works are going on for the last nine years and are vet to get completed. Reports said nine mega lift irrigation projects are being constructed in the rivers flowing through Barchana, Bari, Dharmasala, Jajpur and Rasulpur blocks to provide irrigation facilities to over 12,800 acres.

Similarly, the condition of farmers in the riparian villages of Brahmani, Kharasrota, Baitarani and Birupa rivers are no less acute due to lack of irrigation facilities. They have left everything to fate by cultivating. The farmers apprehend that they may face sprout blight if rain does not occur within next three to four days.

Industrial areas in the district have been deprived of rain during June and July. Two of the industrial areas Danagadi and Sukinda blocks

have received only 244 mm and 204.60 mm rain respectively during this period

Environmentalist Aswini Kumar Dhala and former sarpanch Pushpakanta Nayak rejected the report, stating it to be manipulated. They said the administration is allegedly manipulating the rainfall report to divert the attention of people from industrial pollution. They warned they will challenge the rainfall report.

They said the areas received rainfall between 7.6 mm and 34.4 mm for five to six days in July but no heavy rain (74.5-124.4mm) was witnessed during the period. They alleged that many of the farmers in both the areas were yet to start their cultivation due to lack of rain.

When contacted, Sarat Kumar Prusty, deputy director district agriculture department, confirmed the development. He said he has submitted a report to the state gov-



Majoritarian media

ainstream media refers to the established houses of journalism, mostly newspapers but to some extent also television. Newer sources of media such as websites or apps that do not have a physical presence in the form of a printed product are not yet thought to be mainstream media even though some of them have quite deep presence. In India, websites like The Wire and Scroll have been around for about a decade or so and have large readerships.

However, these new places do not have the size of reporting resources that mainstream media does. And at least so far they have not been able to fill the space that mainstream media is rapidly giving up.

The media space in India is funded primarily by advertising. The reader or viewer pays very little by way of subscription and our newspapers are the cheapest in the world. But the share of print in the overall advertising pie is shrinking. In 2019, for the first time digital jumped over print in India, and by a lot. Digital got 27 per cent of the advertising money spent in India while print got 22 per cent. TV remained number one at 43 per cent but both TV and print were expected to shrink further in 2020 and give up share to digital. The Covid crisis has accelerated this process.

We should understand that "digital" means essentially two companies,

Google and Facebook, which now take more advertising money in India than the Times of India or Hindustan Times or any other large Indian newspaper. This process will continue and newspapers will continue to fade away. This is one trend. It is visible and is happening before our eyes.

There is a second trend that is also visible and has also come before our eyes. It is that the media has taken a majoritarian, Hindutva edge. What is meant by Hindutva or majoritarianism? The idea that one part of society is privileged and entitled to primacy. Conversely, the others must exist on sufferance and have to be tolerated.

Of course this has happened hand in hand with a change in the political language and narrative of the state in India. During the Congress period, whether or not you agreed with the party, the fact is that the tone and tenor was inclusive. It was not trying to divide Indians on the basis of the background they were born into.

The BJP exists precisely because it was successful at mobilising on the basis of division. It has nothing else that is markedly different from any other party except the fact that it is will ing to be openly bigoted. This view is today mainstream and acceptable in the media. It is

acceptable to blame one religion for spreading a virus that has infected the world. It is fine to look away when members of another religion go ahead with their events despite the same threat of spread.

The media can look away today from the failures of the government at the actual business of governance. The enemy occupies land that 3,000 Indians died fighting to defend in 1962. But we are being regaled with shlokas about the landing of five warplanes. Are they going to be used to kick the invader out? No, the story is merely that they have arrived.

Saturday brought the news that there was 70 per cent more demand for MNREGA work in July 2020 than July 2019. More than 3 crore households had asked for it, meaning that at least 15 crore Indians were dependent on it. Another piece of news was that the government was considering extending the "moratorium" on defaulting loans. Companies have been allowed to skip the EMIs on their term loans and individuals with house and automobile loans have also been given this opportunity to not pay now and pay with more interest later. The finance minister said that it was possible that this facility would be extended because of demand from some sectors that were still, four months after the lockdown began, unable to make their regular payments. Automobile and two wheeler sales in India have been declining year-on-year for 18 of the last 19 months. Commercial vehicle sales have not grown since Modi took office in 2014, meaning that industrial growth has been hammered. But the media is focussed on the suicide of one young man. The misuse by the Prime Minister's Office of the Enforcement Directorate even in this matter is not a problem or issue of concern. The story is that one religion's people have captured the entertainment industry.

A decade ago, even though the sentiment might have been felt in large parts of the media, it was not expressed. There was a reserve and there was a culture that adhered to the principles expressed in the constitution. That we were a diverse and secular nation. That has ended now in politics and it has ended in the media.

These are well known to crews of British merchant navy ships and North Sea oil rigs. They're pastries or cakes, always baked on board, that are usually served at tea breaks, morning or afternoon. The first known user of the term in print is Malcolm Lowry. In his Under the Volcano of 1947 appears: "The tabnabs were delicate and delicious little cakes made by the second cook." It is definitely older. Its provenance is obscure. It may originally have been Royal Navy slang, but every written reference is to merchant shipping. An editor's footnote to The Collected Poetry of Malcolm Lowry (1992) says they were "small pasty delicacies, usually reserved for officers and passengers (thus, to be nabbed from the table)." The suggested origin is plausible, but unverified (and probably unverifiable). There certainly seems to have been a class-consciousness about them at one time. Wilfred Granville defined them in his Sea Slang of the Twentieth Century (1950) as a steward's term in the merchant navy for "Buns, pastry and confectionery which are reserved for the passengers in a liner and are not for the crew.' The term is certainly more democratic than that today, and perhaps always was, away from the stifling conventions of cruise ships and liners.

SOME HITS, MANY MISSES

GOVERNMENT WILL HAVE TO BE VIGILANT THAT HIGHER **EDUCATION SHOULD NOT BECOME AN INSTITUTION OF** THE RICH AND **ELITE, BY THE RICH AND ELITE** AND FOR THE **RICH AND ELITE**

he New Education Policy announced after 34 years large scale transformational reforms in education on the foundational pillars of access, equity, quality, affordability and accountability. The announcement needs to be welcomed.

The three outstanding features of the NEP are a) recognition of education for children from class 1 to 5 and preferably up to grade 8 in their home language, mother tongue and regional languages, b) recognition and introduction of vocational education from the 6th grade and c) elimination of science, commerce and arts streams in the old system of what is popularly known as the "ten plus two" system, under which the 10th and the 12th class were critical milestones. That is being replaced by a "5+3+3+4". This third aspect will ensure freedom to higher secondary students to pursue the higher education of their choice, desire and aptitude once they are out school. Students with good scores and grades may prefer to go for humanities, social and pure science instead of being pushed to professional "career promising" courses by their parents.

The National Conference on Education held in Marwari School in Wardha in 1937 under Gandhiji's leadership had strongly recommended that we have the mother tongue as the medium for learning in school and education through vocations as an integral part of learning and skill building. It was christened as Buniyadior Nai Talim. The country took 83 years to realise that children learn better in their mother tongues when young and that the development of the brain is positively associated with learning to work with hands.

Vocational education also improves the scope of self employment and employability. The pedagogy for vocational education is left to be developed by NCERT. It has the competence and understanding of Nai Talim and we should hope that Gandhiji and John Dewy's principle of learning by doing will find space in the

pedagogy of the new curricula. Here lies the promise for reaping the demographic dividend, a window of opportunity that exists for the next two decades. But it will have to be delivered. A related point is about the pedagogy for teaching about learning language and computational skills in early childhood up to the age of 10. NCERT should be open and learn from dozens of ongoing scientific and innovative experiments in the country. Let us hope that NCERT will ensure that dismal findings from the ASER [Annual Status of Education Report (Rural) 2019] studies will change. The latest 2019 ASER report notes that only 50 per cent of children in grade 5 in rural India could read a grade 2 level text, and only 28 per cent in grade 5 could solve a division problem.

The announcement and the draft policy document are silent on the structure and finance of school education in the country under the NEP. Universal primary education is no new announcement. Access to all is promised but the structures suggested are unclear. In almost all countries that have a good record in school education, the State is fully responsible to finance school education, and the structure promises school admission to any child in a State or local government-run school in the neighbourhood. The system of private fee charging schools has to be restricted severely to those who have ample resources to invest on their children's education. Any child in the country must have the right to get admitted to a school which is nearest to her place of residence. School education should thus be compulsory and free and accessible in the immediate neighbourhood. The NEP is silent about this vitally important policy issue in school education. The tacit silence may encourage commercialised, profit oriented and greedy institutions, many of which are already in the system and will move in for the kill very fast.

Ram Manohar Lohia needs to be remembered in this context. Rani ho ya mehatrani, sabke liye ek samaan shiksha (Queen or sweeper, everyone should have the same education). Unless the country follows Lohia's adage in letter and spirit, education related Sustainable Development Goals would remain a dream.

Gandhiji would have been in pain to read the provision of introducing Sanskrit only as an optional language at all levels from school to higher education under the heading of promotion of languages. Not that he would have any guarrel with Sanskrit; actually quite the contrary. In this country where an overwhelming ma jority understand and speaks Hindi-Hindustani for centuries, ignoring Urdu language is an unpardonable omission. Gujarat Vidyapith, a national university founded by Mahatma Gandhi in 1920 had in its school and higher education curricula the Urdu language. Both Sanskrit and Urdu were taught to all children in the secondary school and undergraduate college.

Unfortunately, it has discontinued in Gandhiji's Vidyapith too. Should we be reminded that Urdu is the language developed in Hindustan and not Persian or Farsi? The enlightened Muslims are strongly recommending that the madarsas should join the mainstream education system. Offering Sanskrit alone as an optional subject would have a negative impact on madarsas being persuaded to join the mainstream. Recognition and introduction of Urdu would give a nudge. Such reform is always possible.

An Indian Institute of Translation and Interpretation is a welcome idea. We have lost the opportunity till date to learn from each other in this country with diverse languages and knowledge. Free exchange was hardly possible. There have not been any formal structures to encourage and promote learning from one language and take it to another. The initiative should not be starved for funds and linguists and scholars should keep away from politicising.

Discussing higher education in the NEP would require separate space. However, a few things can be said in this limited space. There is no clarity with respect to the governance structure of higher education. Increasing the gross enrolment ratio to 50 per cent by 2035 will have meaning only if school education settles well and every school graduate has the capability and the skill set to earn a decent livelihood. Higher education should be pursued by those who have the aptitude, the desire and the competence. The government will have to be vigilant that higher education should not be come an institution of the rich and elite, by the rich and elite and for the rich and elite. Some poor and deserving may be sneaked in to showcase inclusion. The highlights in the policy announcement point towards such a pattern to emerge, but one should wait for the details to come. The jury is still out.

Nature by the numbers

INDIA AND BANGLADESH ARE FORTUNATE TO HAVE THE SUNDARBANS. BUT NO COUNTRY IN THE WORLD LACKS **NATURAL AREAS THAT ARE WORTH CONSERVING OR RESTORING**

came barreling up the Bay of Bengal this past May South Asia's first named storm of the year appeared to pose a massive threat to the people who live on the coastal floodplains and to the animals and plants - including many endangered species – that rely on these sensitive ecosystems. But nature came to the region's rescue.

The Sundarbans, the world's largest mangrove forest, offered better protection than any manmade storm wall could have done. When Amphan's 16-foot storm surge slammed into this 4.000-squaremile national park, the mangroves took the teeth out of it, just as they did with the two other supercharged cyclones. Aila and Sidr. that have

made landfall in recent times. On the other side of the world, natural storm defenses on the lower end of Manhattan have long since been paved over. Real-estate developers have even extended the island into New York Harbor with acres of landfill, neglecting to build up storm surge protections. As a result, when Hurricane Irene and Superstorm Sandy hammered the city in 2011 and 2012, respectively, lower Manhattan, including the city's financial district, was inundated.

Then Cyclone Amphan City planners have since been our looming conservation crises. Sundarbans have provided an exworking with the US government to plan for the next wave of superstorms. But the price tag of the infrastructure needed – a retractable wall across New York Harbor costing at least \$62 billion – has prevented any plans from being finalised.

As we look to rebuild the global economy following COVID-19, conserving our remaining natural assets must be top priority. If we don't act, we risk losing plants, animals, and microorganisms needed to keep our air clean, our water pure, and our food supplies plentiful – not to mention mangroves and barrier reefs that stand between us and superstorms that are becoming more frequent as a result of climate change.

The world has become less wild as we have built and expanded cities, cut down forests for crops and livestock, drained wetlands for roads, and flooded valleys for dams. The economic cost of this ecologic cal damage goes mostly uncounted. But it is prohibitively high, eroding the value of goods and services that nature produces. One million species are now at risk of extinction.

Fortunately, there is a relatively simple initiative underway to curb some of these losses and solve

Under the heading of '30x30,' it aims to protect 30 per cent of our planet's land and oceans by 2030 through effective, permanent measures. Over 20 member states in the UN Convention on Biodiversity have already committed to supporting this target. According to a new report au-

thored by over 100 scientists and economists from around the world, expanding existing protected areas to 30 per cent of the planet would add \$250 billion to annual global economic output, on average. Moreover, the study finds that protected areas and the nature-based activities they support are among the world's fastest-growing economic sectors, with 4-6 per cent projected annual revenue growth, compared to less than 1 per cent in agriculture, and negative growth in fisheries.

For countries with large areas of forest and mangroves, embracing 30x30 would prevent the loss of an average of \$350 billion (\$170-534 billion) annually in ecosystem services. These costs stem largely from flooding, soil loss, storm surges, and the release of stored carbon that occurs when natural vegetation is destroyed. By protecting India and Bangladesh over the years, the

traordinarily valuable service. Conversely, environmental de-

struction in the Brazilian portion of the Amazon has resulted in major, far-reaching losses. Even drinking water shortages that afflict São Paulo are directly connected to Amazon deforestation.

As governments contemplate how to re-open their economies after the lockdown, they must accommodate the need for greater conservation and restoration of natural resources

India and Bangladesh are fortunate to have the Sundarbans. But no country in the world lacks natural areas that are worth conserving or restoring. Not only is it critical for all countries to adopt the 30x30 target, but each should also look for ways to invest more in its natural areas. By doing so now, governments can ensure that nature-based sectors and ecosystem services will recover at the same pace as the rest of the economy. There's no better time to start than before another storm strikes.

Sisodia writes to Shah after Fresh sero survey begins in Delhi LG blocks unlock 3.0 move

New Delhi, August 1: Delhi Deputy Chief Minister Manish Sisodia Saturday wrote to Union Home Minister Amit Shah, seeking directions to LG Anil Baijal to allow hotels and weekly markets in the city.

Sisodia's letter comes a day after Baijal rejected the Arvind Kejriwal government's decision to allow hotels and weekly markets to reopen in the national capital, saying the COVID-19 situation continues to be "fragile" and the threat is still "far from over".

Baijal Friday overruled the city government's decision to open hotels and allow weekly bazaars on trial basis as a part of the third phase of easing the lockdown. This came a day after the Arvind Kejriwal government decided to reopen hotels and allow weekly bazaars to function on a trial basis for a week with social distancing and all necessary precautionary measures.

In the letter written in Hindi, the deputy chief minister said that the Delhi government will again send its proposal on reopening of hotels and weekly markets to the lieutenant governor Tuesday.

"I request you to ask LG not to stop

tect crops from animals and end man-animal conflicts permanently.

Apart from this, the state government was also working to provide land on pattas (lease) to tribals and forest dwellers under the Forest Rights Act, the minister

On the direction of Chief Minister Shivraj Singh Chouhan, virtual conferences are being held with officials to facilitate land transfers to tribals under the Act, the minister said, adding that the process is being expedited to provide the same before August 15.

Efforts were also underway to

generate employment in the tribaldominated and forested areas to

make the state self-reliant, he said. Shah further said he was overwhelmed that Madhya Pradesh had regained its tiger state status and praised forest department officials for the feat.

"We have doubled our tiger population to 526 in just eight years instead of the 10-year target that was talked about," he added.

The forest cover of Madhya Pradesh is 77,482.49 sq km, which is 25.14 per cent of the state's total geographical area, a central government report has said.

New Delhi, August 1: An ayurvedic doctor jailed for life for murdering truck drivers and feeding their remains to crocodiles has been caught after jumping parole while on release for good behaviour, police said.

Devendra Kumar Sharma, 62, was arrested by Delhi police in the capital late Tuesday. In January he failed to return from a weeks-long parole after serving 16 years behind bars.

Sharma was given a life sentence in 2004 in Rajasthan after being found guilty of several murders between 2002 and 2004, earning him the nickname "Dr Death" in the

"(He) was involved in dozens of cases of kidnapping and murder of truck and taxi drivers in Delhi, Haryana, Uttar Pradesh and Rajasthan," Delhi Police Deputy Commissioner Rakesh Paweriya said in a statement.

Police alleged that Sharma first came to the attention of authorities two decades ago over his involvement in an illegal kidney transplant racket between 1994 and 2004.

Sharma, with help from other doctors and middlemen, allegedly arranged at least 125 transplants in an organ trafficking racket.

Police also accused him of being

"They used to dump dead bodies in Hazara canal in Uttar Pradesh's Kashganj, which had crocodiles, (and) there was no chance of retrieval of any body," Paweriya said.

Rhea 'under watch', say Bihar policemen

Mumbai/New Delhi, August 1: The Bihar police Saturday said actress Rhea Chakraborty was "under watch" in the abetment to suicide case in the death of Bollywood star Sushant Singh Rajput while her plea before the Supreme Court for transfer of the FIR against her from Patna to Mumbai is listed for hearing on August 5.

A four-member Bihar police team is in Mumbai since Wednesday to probe the FIR registered in Patna against Chakraborty, 28, and six others including her family members based on the complaint filed by Rajput's father. Krishna Kumar Singh (74) had lodged the complaint for the alleged abetment to suicide of his son on Tuesday.

As the chorus for a probe by the CBI into the case grew louder, a Bihar minister said Chief Minister Nitish Kumar would definitely act if a demand for the premier investigating agency to step in comes from the family of Rajput. Bihar's Director General of Police (DGP) Gupteshwar Pandey, meanwhile, said the state police wants the forensic science laboratory reports, inquest report, post-mortem report and relevant CCTV footage in the case to facilitate its probe.

Saturday, the Bihar police team visited the Bandra police station. When asked whether Chakraborty, who was Rajput's girlfriend, would be interrogated, an official of the Bihar police said, "It is not required as of now. But she is under our watch."

Another member of the visiting team said they have sent a notice to Chakraborty under the relevant CrPC sections, asking her to cooperate with the police in the probe. He also said the Mumbai police was cooperating with them in the investigation of the case.

Rajput, 34, was found hanging in his suburban Bandra apartment in Mumbai on June 14.

A Mumbai police official said the visiting team has recorded the statements of six persons as part of the probe.

Contempt Act challenged in SC⁺

New Delhi, August 1: Senior journalist N. Ram, former Union Minister Arun Shourie and activist-lawyer Prashant Bhushan have moved the Supreme Court challenging the constitutional validity of Section 2(c)(i) of the Contempt of Courts Act and termed it as a violation of the Articles 19 and 14 of the Constitution.

The petition has been moved days before the apex court is slated to take up two contempt petitions against Bhushan for allegedly making derogatory remarks against the judiciary and bringing it under disrepute.

On July 22, the top court issued notices to Bhushan and Twitter Inc for his tweets allegedly scandalising the judiciary. Two days later, a bench headed by Justice Arun Mishra decided to begin hearing on another contempt case against Bhushan pending since 2009. The two cases will be taken up for hearing on August 4 and 5.

The petitioners argued that this sub-section is unconstitutional, as it is incompatible with preambu-



lar values and basic features of the Constitution, and violates Article 19(1)(a). They claimed the sub-section is unconstitutionally and incurably vague, and is manifestly arbitrary.

The Section 2(c)(i) of the Contempt of Courts Act, 1971, defines 'criminal contempt' as publication of anything - whether by words, spoken or written, or by signs, or by visible representation, or otherwise of any matter or the doing of any other act whatsoever - which scandalises or tends to scandalise, or lowers or tends to lower the authority of any court.

The petitioners have asked the top court to issue directions declaring Section 2(c)(i) of the Contempt of Courts Act, 1971 as being violative of Articles 19 and 14 of the Constitution. "The impugned subsection, despite setting out penal consequences, is incurably vague. It uses vague terminology whose scope and limits are impossible to demarcate. In particular, the phrase 'scandalises or tends to scandalise" invites subjective and greatly differing readings and application which is incapable of being certain and even-handed," said the plea.

The petitioners' argued that the sub-section violates the right to free speech and expression guaranteed under Article 19(1) (a) and does not amount to a reasonable restriction under Article 19(2).

"That the impugned sub-section, despite setting out penal consequences, is incurably vague. It uses vague terminology whose scope and limits are impossible to demarcate. In particular, the phrase 'scandalises or tends to scandalise' invites subjective and greatly differing readings and application which is incapable of being certain and even-handed. Thus, the offence violates the Article 14 demands of equal treatment and nonarbitrariness," said the plea.

INDIA CELEBRATES EID AL-ADHA AMID PANDEMIC

PEOPLE AVOIDED HUGGING EACH OTHER AFTER MORNING PRAYERS AT MOSQUES

New Delhi, August 1: Eid al-Adha was celebrated Saturday on a subdued note. People offered namaz at mosques as well as homes in the morning and exchanged greetings to mark the festival, following safety

guidelines amid Covid-19 pandemic. The people avoided hugging each other after morning prayers at mosques -- a tradition followed on festive occasions - to curb the spread of coronavirus that has infected 16,95,988 people across the country. On Saturday, a record 57,118 cases and 764 deaths were reported for the last 24 hours.

 $The \,people \,restricted \,themselves$ to do 'salam'. Citizens above 60 years,

persons with comorbidities or asymptomatic and children below 10 years offered namaz at home as advised. There were no prayers at Eidgahs or in open grounds. Earlier in the day, mosque care-takers disinfected the premises and surroundings before and after namaz. Most mosques saw prayers in two phases to ensure social distancing among the worshippers.

At most mosques, people who offered 'fajr' or pre-dawn prayers stayed back for Namaz-e-Eid, held 30-60 minutes after the sunrise. Eid ul-Adha or Bakrid is the second major Muslim festival celebrated to commemorate the sacrifice by Prophet Ibrahim, who offered to sacrifice his son Ismail on the Allah's

command. The almighty, however, replaced Prophet Ismail with a lamb

just as Prophet Ibrahim was about to slit his throat.

Calling upon the devout to imbibe Prophet Ibrahim's spirit of sacrifice, Imams, in their sermons on the occasion, said the Eid's message was that they should always be ready to surrender to the Allah's will. After prayers, Muslims offered sacrifice of 'halal' animals. Sacrificing is obligatory for adults who are 'saheb-e-nisab' or possess wealth equivalent to 87.48 gram gold or 612.35 gram silver. An individual can sacrifice a

sheep or goat or may join six others to sacrifice a big animal. The meat of the sacrificed animal is distributed equally in three parts. The person making the sacrifice keeps one part for his family and distributes two parts among

the relatives and the poor.

This year, the number of people offering sacrifice at homes came down due to Covid-19. To avoid the risk while buying the animal or hiring services of butchers, many either outsourced the job to traders or socio-religious organisations. Many people preferred taking a 'hissa' or share in the cattle with the individuals and groups who organised a 'ijtemai qurbani' or collective sacrifice every year.

Community leaders said many people entrusted the task of distribution of meat among the poor to the groups arranging collective sacrifice. They wanted to avoid visits to relatives, friends and others to distribute meat due to Covid-19.









Fatality rate lowest since first lockdown, says Govt

New Delhi, August 1: India continues to maintain the record of registering the lowest COVID-19 mortality rate on the global platform, the Ministry of Health and Family Welfare said Saturday.

"The Case Fatality Rate stands at 2.15% on Friday, lowest since the 1st lockdown. It has been continuously reducing from around 3.33% in mid-June" the ministry said. The case fatality rate, in epidemiology, is the proportion of people who die from a disease among all individuals diagnosed with it.

The reduction is being attributed to focused, coordinated, preemptive, graded and evolving 'Test Track Treat' strategy and the efforts of the Centre along with the state governments. The emphasis on early detection through aggressive testing and effective clinical management of the hospitalized cases has resulted in the continuously falling fatality rate, the ministry officials said, adding that it indicates that India has been able to successfully contain the fatality rate of COVID-19.

On Saturday, India reported a new record surge of 57,118 fresh infections, taking the total number of cases to 16,95,988. The country also witnessed 764 COVID-19

Meanwhile, the total number of recovered cases is nearly eleven lakh. With 36,569 patients discharged in the last 24 hours, the total recoveries have jumped to 10,94,374. The recovery rate stands at 64.53 percent amongst COVID-19 patients.

With such a consistent increase in recoveries, the gap between recovered patients and active COVID-19 cases currently stands at 5,29,271. Active cases (5,65,103) are under medical supervision. As on Saturday, there were 1488 dedicated COVID Hospitals with 2,49,358 isolation beds, 31,639 ICU beds, 1,09,119 oxygen supported beds and 16,678 ventilators. 3231 dedicated COVID Health Centres with 2,07,239 isolation beds, 18.613 ICU beds and 74,130 oxygen supported beds and 6,668 ventilators have also been operationalised.

Moreover, 10,755 COVID Care Centres with 10,02,681 beds are now available to combat COVID-19 in the country. The Centre has also provided 273.85 lakh N95 masks and 121.5 lakh Personal Protective Equipment (PPEs) and 1083.77 lakh HCQ tablets to the States and Central Institutions.

BENGAL TO GET SIX TIGERS FROM ASSAM

Kolkata, August 1: The West Bengal forest department is bringing six tigers to Buxa Tiger Reserve in Alipurduar district, as part of its effort to augment the population of big cats in the national park, an official said Saturday.

The six big cats are being brought from Kaziranga National Park in Assam, Chief Wildlife Warden Ravikant Sinha said. "Arrangements have been made to ensure safe and smooth transit of the animals," he said.

Sinha said the government wanted to increase the population of Royal Bengal tigers in BTR, the largest forest in North Bengal with an area of 745 sq-km. "Recently, two Royal Bengal tigers have been spotted in Buxa through our camera traps. These two big cats were seen from various locations of the core area of the forest. So, at least two tigers are there already and we need to raise the number," Sinha said

The six tigers are being relocated from Kaziranga to Buxa as these two reserve forests have similar habitats, the official said. The BTR, which is spread over the plains and foothills, has about 390 sq-km of core area and is home of 73 mammal species including leopard, chital deer and wild boar.

The forest department had recently launched a short film about the BTR, the official said. The film was handed over to the NTCA to create a buzz about the reserve forest nationally, he added.

Senior leaders rally behind Manmohan

Freak accident in Bangalore

social media, the video shows how a man who appeared to be an autorickshaw driver was standing beside a three-wheeler was flung a few metres by a thin wire.

With a little portion of the wire perched on the ground between his legs and a major portion also hanging before and after him, the wire was forcibly pulled by something leading to the man being right on a woman walking be-He was pulled up into the air

from between his legs and there was not escape for him. It is not clear in the video if a vehicle or anything else pulled the wire but the pull had sufficient power to fling the man of some 60 - 70 kg weight far enough. The unsuspecting woman wear-

ing a pink dress had no idea what happened but took a heavy hit from the flying man and fell flat on the tiled floor. The entire incident unfolded at a place that appeared to be the front portion of a series of shops leading to their Following the incident which oc-

curred beside a service road, a tractor and other vehicles paused to figure out what exactly happened as the video ends. "We did not receive any police complaint and I am also not sure when it actually happened," he said. The official said they will try to go to the source of the video or the owner of the cctv from where the footage emerged.



Liquor tragedy toll rises to 86

Chandigarh, August 1: The death toll in the Punjab spurious liquor tragedy rose to 86 Saturday even as Chief Minister Amarinder Singh suspended seven excise officials and six policemen, of-

ficials said. The government also announced a compensation of Rs 2 lakh for each of the families of the deceased, they said. Tarn Taran alone accounted for 63 deaths, followed by 12 in Amritsar and 11 in Gurdaspur's Batala. Till Friday night, the state had reported 39 deaths in the tragedy unfolding since Wednesday night.



According to an official statement, the CM ordered the suspension of seven excise officials, along with six policemen. Among the suspended officials are two deputy superintendents of police and four station house officers

Strict action will be taken against any public servant or others found complicit in the case, said the chief minister, describing the police and excise department failure to check the manufacturing and sale of spurious liquor as shameful. Nobody will be allowed to get away with feeding poison to our people, he added.

BJP LAUNCHES PROTESTS IN KERALA

Thiruvananthapuram, August 1: The BJP Kerala unit Saturday launched protest demonstrations across the state to demand Pinarayi Vijayan government's resignation in the wake of unearthing of the gold smuggling

BJP national Secretary Bhupender Yadav, who launched the protests online from Delhi, alleged that the CMO was "facilitating" the gold smuggling. These protests will continue till August_ 18, with all top state BJP leaders observing one-day fasts at various place during this period.

On Saturday, lone BJP legislator in Kerala Assembly, O. Rajagopal, began his day-long fast at the state party headquarters here. Yaday said Vijayan will go down in history as the "most corrupt Chief Minister" in the country.

"Vijayan, your time is now up.



You will be forced to tell the truth on how the gold smuggling is taking place, as your own office has direct control over it. Look into those who have been arrested -- they include Swapna Suresh, who despite no qualifications was given a job in the IT Department headed by Vijayan. You will have to answer," the BJP leader said in his speech.

State BJP President K. Surendran, participating in the launch of the protest from his home in Kozhikode, said the situation is grave as allegations have now surfaced that the "smuggling of gold going on with the help of Vijayan's office has terror links too".

BANGALORE POLICE WAGING WAR AGAINST DRUGS

Bangalore, August 1: The City police department is waging a war on narcotics and drug peddlers, busting multiple racketeers of late. Marijuana or ganja has emerged as the most peddled and seized drug in Bangalore in the first six months of 2020.

"We are waging a war against drugs. Trying hard to collect information and pursue further," Central Crime Branch (CCB) Deputy Commissioner of Police (DCP) Kuldeep Jain said. On Wednesday, the crime branch busted a darknet drug racket involving four educated Kerala youngsters, targeting pub hopping youth and seized drugs worth Rs 1.25 crore.

The case assumed such significance that the state Home Minister Basavaraj S. Bommai himself and Police Commissioner Bhaskar Rao attended the press conference.

Last weekend, Bangalore East DCP S. D. Sharanappa conducted a special drive against drugs, arresting 29 people including a Nigerian national, and booking 29 cases in just 48 hours. "Seized MDMA, ganja drugs. Watch also kept on hotels and lodges being misused for narcotics during Covid," said Sharanappa highlighting that the special drive was

Similarly, Bangalore South DCP Rohini Katoch Sepat had also conducted a weekend drive against drugs, registering 18 cases and ar-



resting 19 persons. Sepat appealed to the people to come forward and fight the drug menace alongside the police, asking for tip-offs on

1908 or 100 police numbers. To reinforce the police crackdown further, Joint Commissioner of Police Sandeep Patil has invited the general

public to call toll free number 1908 to report on drugs and narcotics. "1908 toll free number to report drugs and narcotics related issues. So far this year, received 18 calls but 18 is a very small number. Request more to come forward, amplify our action against drugs," said Patil. Incidentally, the 18 tip-offs lead to raids and cases while Patil promised protecting the informants' identity. Bangalore police social media handles are also reaching out to the public actively, asking for leads in busting the drug rackets.



TRUMP TO BAN TIKTOK IN US

There have been reports of tech-giant Microsoft being in talks to buy the Chinese-owned app

Washington, August 1: US President Donald Trump has said that he will act to ban TikTok as soon as on Saturday, amidst reports of American technology giant Microsoft being in advanced talks to acquire the popular Chineseowned video app.

Trump, talking to reporters travelling with him aboard Air Force 1 from Florida on Friday, said he could use the emergency economic powers or an executive order to ban TikTok in the United States.

"As far as TikTok is concerned, we're banning them from the United States," he said.

Referring to the emergency economic powers, the President said: "Well, I have that authority. I can do it with an executive order or that". Trump also made it clear that he was not in favour of a deal to let a US company buy TikTok's American operations.

Trump further told reporters that he planned to take action against the popular video-sharing app as soon as Saturday. Earlier at the White House, Trump said:



"We're looking at TikTok. We may be banning TikTok. We may be doing some other things. There are a couple of options. But a lot of things are happening, so we'll see what happens. But we are looking at a lot of alternatives with respect to TikTok"

India has banned as many as 106 Chinese apps, including TikTok, a move welcomed by both the Trump administration and the US lawmakers. The Wall Street Journal on Friday reported that Microsoft, headed by Indian-American Satya Nadella, is in advanced talks to acquire the US operations of TikTok. The deal could run into billions of dollars.

"A deal could be completed by Monday, according to people familiar with the matter; and the talks involve representatives from Microsoft, ByteDance and the White House. Talks are fluid, and a deal may not come together," the report said

Now, Mexico third in global pandemic deaths

Paris, August 1: Mexico now has the third most COVID-19 deaths in the world, behind the United States and Brazil, while former success story Vietnam is struggling to control an outbreak spreading in its most famous beach resort.

China reported a more than 50% drop in newly confirmed cases in a possible sign that its latest major outbreak in the northwestern region of Xinjiang may have run its course. However, in Hong Kong, infections continue to surge, with more than 100 new cases reported as of Saturday among the population of 7.5 million. Officials have reimposed dining restrictions and mask requirements.

South Korean prosecutors arested the elderly leader of a secretive religious sect linked to more than 5,200 of the country's 14,336 confirmed cases. He has denied charges of hiding members and underreporting gatherings to avoid broader quarantines. Mexican health officials Friday reported 688 new deaths, pushing the country's total to 46,688. That put Mexico just ahead of the United Kingdom, which has 46,119, according to the tally by Johns Hopkins University.

In Vietnam, a third person died of coronavirus complications, of-

ficials said Saturday, a day after it recorded its first-ever death as it struggles with a renewed outbreak after 99 days with no local cases. All three died in a hospital in Da

Nang, a hot spot with more than 100 cases in the past week. Thousands of visitors had been in the city for summer vacation and are now being tested in Hanoi and elsewhere. Twelve additional cases were

confirmed on Saturday, all linked to Da Nang Hospital. The city has tightened security and set up more checkpoints to prevent people from leaving or entering the city, which has been in lockdown since Tuesday.

A makeshift hospital was set up in a sports auditorium and doctors have been mobilised from other cities to help. "I want to be tested so I can stop worrying if I have the virus or not." said Pham Thuy Hoa, a banking official who returned to the capital from Da Nang.

KNOWLEDGE A 'TREASURE' FOR ITALY'S OLDEST GRADUATE

Palermo, August 1: At 96, Giuseppe Paterno has faced many tests in life - childhood poverty, war and, more recently, the coronavirus pandemic. Now he has sailed through an exam that makes him Italy's oldest university graduate.

This week, the former railway worker stepped forward to receive his diploma and the traditional laurel wreath awarded to Italian students when they graduate, applauded by his family teachers and fellow students more than 70 years his junior.

"I am a normal person, like many others," he said, when asked what it felt like to be graduating so late. "In terms of age I have surpassed all the others but I didn't do it for

Already in his 90s when he en-

rolled for a degree in History and Philosophy at the University of Palermo, Paterno grew up loving books, but he never had the chance

"I said, 'that's it, now or never,' and so in 2017, I decided to enrol,' he told Reuters in his apartment in the Sicilian city of Palermo, which he rarely leaves nowadays due to his frailty. "I understood that it was a little late to get a three-year degree but I said to myself 'let's see if I can do it'. On Wednesday, he graduated first



harbouring a desire to go further. 'Knowledge is like a suitcase that I carry with me, it is a treasure," he said. As a student, he tapped out his essays on the manual typewriter his mother gave him when he retired from the railways in 1984. He eschewed Google in favour of printed books and was not tempted by the late-night student parties of his 20year-old classmates, who applauded him warmly at the graduation ceremony

'You are an example for younger students," his Sociology professor, Francesca Rizzuto, told him after he passed his final oral examination in June. Paterno confessed to a little unease with the video calls that replaced classroom teaching during the coronavirus shutdown, but said he was not put off by the disease itself after the war and everything else he had been

"All of that strengthened us, all of my peer group, all of those who are still alive," he said. "It didn't really scare us that much." As for what he planned to do next, he said he was not about to stop now he had graduated. "My project for the future is to devote myself to writing: I want to revisit all the texts-I didn't have a chance to explore further. This is my goal."

GST COLLECTION

State logs 13% growth in July

Bhubaneswar, August 1: Despite intermittent lockdown and sub-optimal functioning of most of the sec tors in the economy due to the ongoing COVID pandemic, Odisha witnessed 13.04% growth in the State GST collection for the first time during the current financial year in the month of July, 2020.

The collection of State GST (OGST) in July 2020 increased to ₹794.02 crore as against ₹702.44 crore made during the corresponding month last year (July, 2019).

This collection came in the backdrop of poor performance during the first quarter of 2020-21 which was due to unprecedented lockdown of the state economy during the months of April and May, 2020. The growth rate of Odisha GST for April to June, 2020 was -61.15%, -25.22% & -5.83% respectively during the corresponding period last

This turnaround of positive growth rate in July is primarily due to the regular persuasion & fa-

cilitation by the field officers, continuous monitoring and hand holding supported by data analytics by the Commissionerate of CT & GST as well as better performance in the mining sector.

Meanwhile, the return filing position of the State assigned taxpayers for February to April and May 2020 reads 92.31%, 81.99%, 74.72% and 60.03% respectively in comparison to 76.24%, 79.67%, 77.66% and 79.88% during the corresponding period last year. Taxpayers have been advised to fulfill their tax compliance liabilities within the prescribed due date.

The collection from one of the non-GST items: petroleum products also showed encouraging signs during July. The collection of July against these items increased to ₹521.47 crore from ₹509.03 crore collected in July 2019 registering a growth rate of 2.5%

However, in view of setback in the economy due to COVID-19, particularly in the first quarter of 2020-21, the gross GST collection (i.e. OGST + IGST + CGST + Cess) till the end of July is ₹7,540 crore with a negative growth rate of 28% while the cumulative Odisha GST collection till July 2020 is ₹2,354 crore with a negative growth rate of 22%

The facilities have been inaugurated at Bhubaneswar and its three regional offices—South Kaliapani, Gandhamardan and

Each of the CCHs has been facilitated with 20-bed isolation facilities to accommodate COVID-19 suspect or positive cases. The CCHs will be extension of the home isolation facility exclusively for OMC employees and its workers with asymptomatic and mild symptomatic cases.

In the second phase, OMC will start the Covid Care Homes in

four other locations-Kurmitar in Koida region, Seremda in Barbil region, Bangur region and Kodingamali in Rayagada region. All these facilities will have 10-

The OMC had earlier donated ₹500 crore to the Chief Minister's Relief Fund (CMRF) in March to support the state government's efforts to control the Covid-19 situation and to help those affected by the pandemic.

The State-owned entity, during the pandemic time, also transferred ₹250 crore as the interim dividend for the financial year 2019-20. The PSU has also funded for set up of 500-bedded stand-alone Covid-19 Hospital at KIMS. Besides, the corporation also funded for establishment of 10 stand-alone Covid-19 Hospitals in eight districts across the state.



Auto fuel prices remain unchanged

New Delhi, August 1: A day after a hefty ₹8.38 per litre cut in diesel prices in the national capital due to VAT reduction, the oil marketing companies again went on a pause mode to keep auto fuel prices unchanged across the country Saturday. Accordingly, diesel continues to be priced at ₹73.56 a litre in Delhi while petrol price remains static at ₹80.43 a litre.



Across the metros, petrol and diesel prices are keeping steady for the past five days as pump prices of auto fuels have not been

On Friday, diesel prices fell by a sharp ₹8.38 a litre following Delhi government's decision to reduce VAT on the product from 30% to

The price cut has again made diesel cheaper than petrol in the city after more than a month. In fact, diesel is cheaper than petrol in Delhi by the widest margin among all metros now.

Delhi was the only major city in the country where diesel prices were higher than petrol. Diesel prices first rose above petrol's in Delhi last month, much to the discomfort of the transport sector and the fuel dealers.

The ₹1.5 a litre difference had led to substantial loss of business for pump operators in Delhi as vehicle owners preferred to buy diesel in neighbouring Haryana and Uttar Pradesh.

Apple beats Saudi Aramco as world's most valuable co.

San Francisco, August 1: Riding on strong quarter results despite the pandemic, Apple has surpassed Saudi Aramco to become the world's most valuable company with a market cap of \$1.84 trillion.

The strong earnings report nelped Apple shares closed up 10.47% Friday to become the world's most valuable publicly traded company, surpassing the largest oil producer, reports CNBC.

Saudi Aramco now trails at \$1.76 trillion. Despite the pandemic that hit its supply chain and forced the iPhone maker to close retail stores worldwide, Apple shares are up more than 44% this year.

Apple has posted \$59.7 billion in revenue for its fiscal 2020 third quarter that ended June 27, an increase of 11% from the year-ago quarter, as iPhone sales beat the Wall Street estimates.

Power consumption slump narrows

New Delhi: The slump in power consumption has narrowed to just 2.64% in July at 113.48 billion units (BU) indicating spurt in economic activity and raised hopes that it would touch normal level this month. Power consumption in July last year was at 116.48 BU, as per power ministry data. The latest data of the power ministry shows that power consumption has improved after government started giving relaxations for economic activities and onset of summer.

New Delhi: GST collections in July fell to ₹87,422 crore from ₹90,917 crore in June, according to a Finance Ministry statement. However, July collections are higher than ₹62,009 crore in May and ₹32,294 crore in April. "The gross GST revenue collected in the month of July, 2020 is ₹87,422 crore of which CGST is ₹16,147crore, SGST is ₹21,418 crore, IGST is ₹42,592 crore (including ₹20,324 crore collected on import of goods) and Cess is ₹7,265 crore," a finance ministry statement said. The revenues for the month are 86 per cent of the GST revenues in the same month last year. The ministry further said although the June collections were higher than that in July, however, it is important to note that during the previous month, a large number of taxpayers also paid taxes pertaining to February, March and April 2020 on account of the relief provided due to COVID-19.

Parisians complete domestic quadruple with Coupe de la Ligue triumph edging past Olympique Lyonnais 6-5 via penalty shootout



Paris, August 1: Paris St Germain completed their fourth domestic quadruple as they scrapped past Olympique Lyonnais 6-5 on penalties to lift the Couple de la Ligue Friday with the match ending in a goalless stalemate after regular and extra time.

Second-half substitute Pablo Sarabia scored PSG's final penalty in the shootout after goalkeeper Keylor Navas had saved Bertrand Traore's spot-kick to give the Ligue 1 champions and French Cup winners their ninth Couple de la Ligue trophy.

It was the last roar for the competition, which was founded in 1995, as the French Professional Football League (LFP) decided in September to scrap it as of next season until

The LFP had failed to secure a broadcaster

to relaunch the competition in the future.

Lyon keeper Anthony Lopes made a string of good saves in a cagey contest played in front of 5,000 fans at Stade de France, who were allowed into the stadium in line with coronavirus safety regulations.

Lopes denied Brazilian forward Neymar three times and also kept out shots by Angel Di Maria and Idrissa Gueye, while Navas kept out a Maxwel Cornet free kick at the other

Lyon defender Rafael da Silva was sent off in the last minute of extra time for a professional foul on Di Maria and Neymar blazed the free-kick over the bar.

The Brazilian held his nerve to keep PSG alive in the shootout before Navas blocked Traore's penalty and Sarabia calmly slotted his shot past Lopes to spark wild celebra-

tions among his team mates.

Cup final last Friday, will face Italian side Atalanta in the Champions league quarterfinals August 12 in Lisbon.

Their win over Lyon also means that Stade Reims, who finished sixth in the French League, have snapped up a berth in next season's Europa League qualifying.

India hockey camps to begin next week

New Delhi, August 1: The Olympics-bound Indian men's and women's hockey teams will return for their respective national camps August 4 at SAI Centre in Bangalore and head straight to a 14-day quarantine in keeping with the COVID-19 protocols.

The decision was taken by the Sports Authority of India after the nodal body received the goahead from the Karnataka government that has been battling rising COVID-19 cases in recent

"The camp will begin in keeping with all protocols and in strict adherence to the SOPs of SAI and that of the state government.

Athletes, coaches and support staff will also be tested when they arrive in Bangalore to ensure that all campers are at a reduced risk of contracting the COVID-19 virus," SAI said in a statement

The players and support staff, who will arrive from various parts of the country and abroad, will undergo a two-week quarantine inside the campus before resuming training. They will be tested on arrival and will be tested again after the quarantine period ends.

Having spent nearly four months in the camp due to the nationwide lockdown, the players headed to their home towns June 19 for a four-week break after the easing of restrictions.

Hamilton takes pole position, **Bottas second**

Silverstone, August 1: Lewis Hamilton set a new track record at the British Grand Prix and clinched a record-extending 91st

pole position Saturday. He needs five more wins to equal Michael Schumacher's Formula One (F1) record of 91 GP wins. The defending champion is also odds-on to equal the F1 great's record of seven world titles.

He clocked a time of one minute 24.303 seconds at the Silverstone circuit where he was won a record six times. He was 0.313 seconds ahead of Mercedes teammate Valtteri Bottas and about one second faster

than Red Bull's Max Verstappen. Charles Leclerc gave Ferrari a small boost with fourth ahead of Lando Norris, who could face a grid penalty after failing to slow down under a yellow flag in the second part of qualifying when Hamilton made a rare mistake. He span his car and sent gravel spraying, bringing the session to a brief halt after Bottas had set the quickest time.

Vettel, who had problems with understeering and almost went off the track toward the end of Q3, was only 10th fastest in qualifying.

Red Bull's Alexander Albon finished 12th ahead of Racing Point's last-minute replacement Nico Hulkenberg. He lost his seat in F1 this year, and is driving because Sergio Perez tested positive for the coronavirus following a trip back to his native Mexico after his mother had an accident.

Nicolas Latifi's Williams span off the track near the end of Q1, the latest incident in the Canadian driver's difficult start in F1. Kimi Raikkonen and Kevin Magnussen (were also among the five drivers eliminated from Q1.

Olympic torch relay began in 1936 at Hitler's Berlin Games

he torch relay was not always a fixture of the modern Olympics, which began in 1896. The relay tradition started at Adolph Hitler's 1936 Berlin Olympics —the Games of the XI Olympiad and was the brainchild of Carl Diem, who was the head of the organizing committee. The Tokyo Olympic relay is sched-

uled to begin its Japan leg March 26 in northeastern Fukushima prefecture. Tony Perrottet, in his 2004 book 'The Naked Olympics' - published to coincide with the 2004 Athens Olympics — captured the paradox of the Nazi regime appropriating the relay

"Ironically, considering its repellent origins, the torch race has come to symbolize international brotherhood today, and remains a centerpiece of our own pomp-filled Olympic opening ceremonies, Perrottet wrote.


He added: "The Nazis knew a good propaganda symbol when they saw one." Perrottet recounts how the Olympic flame was run from Greece to Germany over 12 days, ending with the lighting of a 'colossal brazier in the Berlin stadium before the Fuhrer's approving gaze'. Each of the torches carried the logo of German arms manufacturer Krupp, Perrottet wrote. The first person to set off July 20,

1936, was Greek athlete Konstantin Kondylis. The torch meandered through Greece, Bulgaria, Yugoslavia, Hungary, Austria, Czechoslovakia and Germany with each runner covering a kilometer or .62 miles.

Perrottet wrote that Hitler admired the images of Greek gods and goddesses and wanted the Olympics to promote his idea of the supremacy, the perfection, of the German nation. "Hitler took considerable per-

sonal interest in the ritual, and pumped funds into its promotion: The Nazi propaganda machine covered the torch relay slavishly, broadcast radio reports from every step of the route, and filled the Games with the iconography of ancient Greek athletics.


The first Olympic flame appeared at the 1928 Amsterdam Games, and then again in 1932 in Los Angeles. "Very little is known about the 1928 and 1932 flames, but they were lit on



Mallon, a former president of the International Society of Olympic Historians, said in an email to The Associated Press.

There was no relay until 1936, and it's been continuous since then. The Olympics were canceled during World War II (Tokyo was to hold the 1940 Games) and resumed in London in 1948. There have been


modifications along the way. The flame for the Summer Olympics has always been lit in



always been lit there. For the 1952 and 1960 Winter Olympics, it was lit in Morgedal, Norway. For the 1956 Winter Games, it was lit in

Rome. More recently, for the 1994 Winter Olympics in Lillehammer, Norway, the torch was lit in Greece and a second torch was lit in Norway. Having two flame origins did not please

the tradition-steeped Greeks. The relay was 'commercialized'

at the 1984 Los Angeles Olympics when relay sponsor AT&T sold 'kilometer legs' of the event to allow people to run with the torch. Coca-Cola became the sponsor in Barcelona in 1992.

"Greece was not happy with that in 1984 and threatened to not let Los Angeles light their flame in Olympia," Mallon wrote. "It was

enough of a problem that Peter Ueberroth (chairman of the organizing committee) and Juan Antonio Samaranch (IOC president) actually made contingency plans for the relay in case the Greeks held to their threat. They eventually backed off and the flame was lit in Ancient Olympia in 1984.

The 2008 Beijing Olympic torch relay ran into trouble as well. The Chinese relay, in addition to a domestic route, also circled the globe. It was targeted along the way by anti-China and pro-Tibet protests at half the stops. Taiwan also boycotted the relay when China wanted to include it on its domestic route implying Chinese sovereignty

over the self-governing island. China's authoritarian government has viewed Taiwan as a renegade province since the two separated in the 1949 civil war. Taiwan, which is also known as the Republic of China, governs itself as an independent state.

The chaos at the time led IOC President Jacques Rogge to say the Olympics and the relay were in 'crisis'. After the Beijing Olympics ended, the IOC did away with the international portion of the relay.
