Thiruvananthapuram: Heavy rain followed by a landslide at Rajamalai in Idukki district Thursday night has left at least 15 persons dead, including a child, and more than 60 others are reported missing, a police official said Friday. The latest reports indicate that there were nearly 100 people in the locality, most of whom had returned to the area following the pandemic. The landslide occurred after heavy rains over the last few days in the area mostly inhabited by tea estate workers.

## KERALA PLANE CRASH KILLS 11

New Delhi/Kozhikode, August 7: An Air India Express aircraft skidded off the runway while landing in Kozhikode and plunged into the deep valley below. At least 11 people have reportedly died in the accident, including the pilot of the flight, DV Sathe.

The incident occurred at 7.41 pm Friday when the flight from Dubai to Kozhikode skidded off the runway after landing at the 'table-top' airport.

The aircraft with 190 persons onboard, including six crew members, battled heavy rains while landing.

According to the Directorate General of Civil Aviation, Air India Express AXB1344, a B737 aircraft, with 191 people onboard, landed on Runway 10 amid visibility of 2,000 metres in heavy rain, but continued running till the end of runway, fell down in the valley and broke into two pieces.

As per the Ministry of Civil Aviation, rescue operations are going on and the injured have been moved to the hospital. After landing at runway 10, the flight continued running to end of the runway and fell down in the valley and broke into two portions, the statement said. At least 170 passengers have been rescued.

An airline spokesperson said the aircraft apparently overshot the run-

## **Record 1-day Covid** spike in India, state

New Delhi/Bhubaneswar, August 7: Registering over 60,000 cases in 24 hours for the first time, India's COVID-19 tally galloped past 20 lakh on Friday, while the number of recoveries surged to 13.78 lakh, according to Union health ministry data. The coronavirus infection tally had crossed 19 lakh just two days ago.

It took 110 days for COVID-19 cases in the country to reach one lakh and 59 days more to cross the 10-lakh mark. Thereafter it took just 21 days more to go past 20 lakh. This was the ninth day in a row that the tally increased by more than 50,000.

Odisha registered its highest single-day spike in COVID-19 cases Friday as 1,833 more people tested positive for the infection, a health official said. The state's COVID-19 death toll soared to 247 as 12 more patients succumbed to the infection, he said.

The new infections reported from 29 of 30 districts have pushed the state's coronavirus caseload to 42,550. As many as 1,118 new cases were reported from quarantine centres, while 715 people tested positive for the infection during contact tracing, he said. Khurda

The CM had recently directed the DGP to make more personnel available at police stations by way of rationalisation. The CM also approved the cre-

ation of six new police stations in various districts by bifurcating existing police stations. And the existing PSes that are to be bifurcated are Khandagiri PS, Angul town PS, Jharsuguda town PS, Bhanjanagar PS, Bhadrak (rural) PS, Bhadrak and Tihidi PSes.

The rationalisation will make a difference in strengthening 220 police stations and six outposts in 21 police districts in the state, 220 police stations across the state.

Meanwhile, Commissioner of Police Sudhanshu Sarangi, in a press briefing, expressed his gratitude to the CM for formally giving his approval for establishment of a police station at Bharatpur and increase the cops' strength at 16 police stations and one outpost in the Commissionerate Police.

The new police station at Bharatpur, carved out of Khandagiri police station, will have six sub inspectors, three assistant sub-inspectors, 21 constables along

with an inspector in-charge. Locals in Khandagiri area have been demanding upgradation of the outpost at Bharatpur into a

full-fledged police station. Similarly, the cops' strength in Balipatna PS, Chandaka, Nayapali, Chandrasekharpur, Airfield, Balianta, Mancheswar, Lingaraj, Jatni, police stations has been increased. The staff strength at Banamalipur outpost under Balipatna police station has been increased too.

The state government has given green signal for the increase of staff strength at Jagatpur, Choudwar, Chauliaganj, Badambadi, Baranga and Sadar police stations under the Cuttack UPD in Commissionerate.

Bhubaneswar, August 7: With an aim to curb fatalities on roads by creating awareness among school students, the state government has included road safety in the textbooks of students between Class-V

and Class IX. Students will learn basic road safety rules and regulations like wearing helmets, seatbelts while driving, driving on left side, among others. The government has already included road safety as a topic in the curriculum of teacher's training programmes being imparted at existing teachers' training institutes. From next academic year, the topic will come up in Class-X syllabus. The government has also decided to observe Road Safety

Day in schools once in a week. This day will feature painting, quiz and debate competitions on road safety among students.

"We have included road safety in the school curriculum. Students will learn it in schools from Class-V to Class IX. However, it may change as new education policy-2020 has come into effect. Following the National Council of Educational Research and Training (NCERT), we will revise our entire school curriculum," said director of State Council of Educational Research and Training (SCERT) Gangadhar Sahoo.

Similarly community education programmes will be conducted in roadside villages with an aim to train 3,500 participants at regular intervals. To provide critical care to accident victims, the govern-

ment also planned to set up trauma care centres (TCCs) in each of 30 districts. So far eight have been made

functional. Fatalities on roads have not stopped even during lockdowns. At least 360 people were killed only in April and May. As police personnel are busy in Covid management duty, it was decided to strengthen enforcement activities by RTO officials, sources said.

To check technical problems on roads, the transport department has conducted audit of all roads. The concerned agency has also recommended necessary measures to fix it. Out of 2,946 km length of national highways under the PWD, audit recommendations have been implemented for 475 km. Each year, 500 km road will be modified.

## Rlys to end Raj era Khalasi system; no fresh hiring

New Delhi, August 7: The Railways is set to end a colonialera practise of appointing khalasis or 'bungalow peons' who worked at the residences of senior officials, following an order from the Railway Board barring any new appointment to the post.

In an order issued August 6, the Railway Board has said the issue regarding telephone attendant-cum-dak khalasis (TADKs) is under review.

"The issue regarding the appointment of TADK is under review in Railway Board. It has, therefore, been decided that any appointment of fresh face substitutes as TADK should not either be processed or made with immediate effect. "Further, all cases approved for such appointments since 1st July 2020 may be reviewed and position advised to Board. This may be complied with strictly in all railway establishments," the order said. Upon joining railways as temporary staff, TADKs become Group D staff following a screening process after a period of around three years.

## NITI picks 6 ideas from state's aspirational dists

New Delhi, August 7: In order to promote innovative ideas in backward districts across the country, the NITI Aayog has compiled a series of best practices implemented by several aspirational districts, including six from Odisha

According to NITI Aayog, sharing of best practices and their subsequent replication by other districts form the very edifice of cooperative federalism model that aspirational district program seeks to promote. Instead of expecting every district to reinvent the wheel, dissemination of such innovative ideas allows them to learn from each other and provides a head start in finding solutions to common

The NITI Aayog has selected the practice of bike ambulance, auto ambulance and delivery van to promote institutional deliveries in Kandhamal district of Odisha. Being a tribal area, traditional healing systems are given more importance over institutional systems leading to several deaths. To bring the community on board, the district doubled its efforts for increasing the demand and supply side interventions. Five 'Bike Ambulances' and 11 'Janani Auto vehicles' were deployed in remote pockets. Seven Maternity Waiting Homes (MWHs)

were also established to facilitate institutional deliveries.

In Dhenkanal aspirational district, pregnant women were prone to skip radiology tests due to inaccessibility. To facilitate these women, the administration enabled mechanism for mandatory ultrasound sonography (USG) for all pregnant women by scheduling mass USG test dates across the sub-district hospitals under the Kalpana Programme. Bringing all pregnant women together at these hospitals resulted in discussions regarding their lifestyle, food habits and sharing of experiences

In order to reduce the infant and maternal death, 'Ama Sankalpa Rath Yatras' were organised to spread message about precautionary measures for maternal and child health in Rayagada aspiration district of Odisha.

In Koraput, the incidents of Malaria-related deaths were very high due to hilly terrain, forest cover, inadequate health facility coverage and low education levels. Bhubaneswar, August 7: With persistent rise in novel coronavirus cases, the state government Friday allowed private hospitals having 30 or more number of beds to open Covid-19 units.

In view of Covid-19 pandemic, a large number of cases of different severities from mild to very mild or moderate to severe symptomatic are being detected. At present, the patients are being treated at different healthcare facilities run by government.

However, in view of the present scenario, the state will need more number of dedicated hospitals to treat Covid patients. Therefore, the government has asked private hospitals having more than 30 beds registered under Odisha Clinical Establishment (Control & Regulation) Act, 1990 to open dedicated Covid unit.

Health and Family Welfare department has issued detailed guidelines in this regard.

The private hospitals have to ensure that infection never spreads to the other non-Covid patients. The staff managing the Covid patients will work for 14 days and then go for quarantine for another 14 days.

All the tests must be done at the approved rate notified by the government. Hospital asked to charge reasonable fees from patient and refrain from collecting exorbitant fees. Otherwise, strict action will be taken against the hospital, warned the government. The hospitals cannot detain patients or the dead body for nonpayment of fees.

The hospitals also asked to allow one willing attendant of the patient to remain in the earmarked place in the hospital premise while ensuring prevention of cross in-

Bhubaneswar, August 7: State Friday registered its highest singleday spike in novel coronavirus cases as 1,833 more people tested positive for the infection, while the death toll soared to 247 as 12 more patients succumbed to the disease. an official of Health and Family Welfare (H&FW) department said.

The new infections reported from 29 of the 30 districts have pushed the state's coronavirus caseload to 42,550, added the official.

As many as 1.118 new cases were reported from quarantine centres, while 715 people tested positive for the infection during contact tracing exercise, said the official.

Khurda district, which includes Bhubaneswar, reported 298 fresh cases- the highest so far-followed by Ganjam (279), Rayagada (152), Cuttack (124) and Sundargarh (110), the official said, adding that the remaining districts registered less than 100 fresh infections each.

Ganjam and Sundargarh districts registered three fatalities each, while Mayurbhanj, Kendrapara, Sambalpur, Bhadrak, Dhenkanal and Gajapati reported one death each. Mayurbhani and Dhenkanal registered their first COVID-19 deaths, the official

Of the 247 COVID-19 deaths reported in the state so far, Ganjam

accounted for the highest at 123, followed by Khurda (31), Sundargarh (16), Gajapati (15) and Cuttack (11), said the official, adding that 45 other COVID-19 patients have died due to other ailments.

Meanwhile, the state registered an all-time high single-day recovery of 1.810 patients, Friday,

The recoveries include 700 from Ganjam, 202 from Khurda, 147 from Cuttack, 136 from Gajapati, 116 from Dhenkanal and 106 from Sundargarh. With this, the total recovered cases of Odisha stand

The state, Thursday, tested a record number of 16,055 samples for COVID-19, taking the total number of tests conducted so far to 6,16,646, the official added.

Meanwhile, Bolangir and Nabarangpur district administrations have declared shutdowns in the districts following spike in virus cases in the last few days. While Bolangir with a report of 588 COVID positive cases declared a complete shutdown for four days, Nabarangpur district with 342 cases, declared

three-day shutdown in the district. The state government has already declared weekend shutdowns in Ganjam, Khurda, Cuttack and Gajapati districts besides the steel city of Rourkela during the August following a rise in virus cases.

The weekend shutdowns have been announced to break the chain of COVID-19 infection and intensify the contact tracing in these coronavirus hotspot districts

Bhubaneswar, August 7: The body of a 25-year-old man was left unattended at his residence at Mankaragoradi village in Konark for more than 15 hours as relatives and villagers stayed away suspecting him as COVID-19 infected, officials said Friday.

The man had died Wednesday and his family was forced to arrange PPE kits and other protective gear before the body could be taken to the cremation ground on the outskirts of the village

None was ready to carry his body on their shoulders as is the practice for fear of contracting the disease. His body was instead carried to the local cremation ground in a cycle cart the next day. The last rites were performed Thursday afternoon, the officials said.

According to sources, Vichitra Rout, a tractor driver in the area. had been suffering from high fever for the past few days and was diagnosed to be afflicted with typhoid. Rout was asked by the community health centre where he was being treated to undergo the COVID-19 test, his family members said. Rout was the sole breadwinner

headquarters hospital in Puri for

the test but when he was taken there August 4, work at its outpatient department had been suspended as some health workers there had contracted coronavirus.

Rout was therefore referred to a hospital in Bhubaneswar. However, he died Wednesday before arrangements could be made by his family for taking him to the Capital City,

By then, rumour had spread in the area that he had fallen prey to COVID-19 and the villagers shunned the family. Even the relatives showed reluctance in making arrangements for the last rites and none came

forward to help the family. Konark Notified Area Council (NAC) executive officer M Srinivas said that when he came to know about the plight of the family he sent some officials with PPE kits to the village. The NAC officials convinced the villagers to arrange for the last rites by taking the required safe-

Srinivas said the doctor who was treating the man had informed them that Rout was suffering from typhoid for a long time and had prolonged fever. However, the man died before the COVID tests could be done and it was not confirmed whether he was infected with coronavirus.

The hesitant relatives agreed to help in the cremation after they were given PPE kits. The villagers, however, kept off.

The body was wrapped in a plastic sheet and taken to the cremation ground on a cycle cart by his cautious relatives in PPEs, their faces covered with masks and gloves on their hands. Only some close relatives were present during the cremation, Srinivas said.

## Tiger repopulation project in Satkosia comes a cropper

Bantala, August 7: Satkosia sanctuary is one of 50 tiger conservation projects in the country

But, the sanctuary is allegedly losing its significance due to lack of safety and management in the tiger conservation efforts. The ambitious tiger repopulation project in the sanctuary by way of relocation has not been successful. This has posed a question mark on the future of the sanctuary

The forest department has not yet found out any plausible reason for the vanishing of tigers and failure of the repopulation effort. The tiger repopulation, which was launched in 1980, has flopped due to lack of coordination among the stakeholders from the government departments to local pop-

It was learnt that the forest and tourism departments have not really extended proper coordination in the matter of tiger conservation, hamlet relocation from inside the sanctuary and improvement in liveli-It is worthy to mention that when ti-

gress Sundari had killed a man, the de-

partment could not even arrange a vehicle and public address system to carry out awareness drive among the people.

At that time, a group, keeping in mind the elections, had reportedly opposed the tiger repopulation effort. As a result, the forest department could not take right step in

Two years ago, the state government had welcomed a tiger and a tigress - Mahavir and Sundari - under India's first interstate tiger relocation project. In the summer of 2018, the tiger Mahavir was relocated from Panna Tiger Reserve in Madhya Pradesh to the Satkosia. A few days later. tigress Sundari was also sent to Satkosia

from MP's Bandhavgarh. Mahavir died some months later. At that time, the department could not properly probe into the real cause of its death

In December last year, the National Tiger Conservation Authority had asked the Odisha government to send back Sundari from Satkosia and accused the forest and wildlife department of making a mess of the monitoring and management of the

It was said that though shifting of the tigress has been delayed due to the Covid-19 pandemic, the National Tiger Conservation Authority would begin the process in a month after assessing the situation.

Given the lush green environment and ecology of Satkosia, then Union Environment Minister Kamal Nath had proposed for tiger conservation and bios phere projects.



## Dhenkanal localities waterlogged due to poor drainage

Dhenkanal, August 7: With no stormwater drainage system in place, even light rains leave people residing in Town Planning area and left side of Karigar Sahi under Dhenkanal municipality waterlogged.

The residents alleged that their repeated pleas have fallen on deaf ears of the civic body officers. About 500 families reside in

Town Planning area and over 400 families in left side of Karigar Sahi. Both these places are devoid of drainage facility. Despite the fact that the residents of these two areas have been demanding for stormwater drainage facility in their respective areas, the municipality is yet to take any step to address the issue.

At times, people engage water pumps on their own to pump out water from their localities

The low pressure-induced rain that continued for two days --Wednesday and Thursday -- recently put the residents through a lot of difficulties. Stormwater carrying all sorts of garbage from nearby areas accumulated in those two localities.

The water even entered houses of many residents.

"We had to relocate some of our furniture and other items. At a time when coronavirus is taking its toll, such a situation makes our lives more vulnerable," alleged a senior citizen from the locality

"This place is inundated even after a little shower confining us to our houses. We have to wade through knee-deep water. We had taken up the issue with the district administration and municipality officers, but to no avail. If no immediate step is taken, we will file a PIL," said Bahadur Patsahani, a resident.

Muncicpality engineer Rashmita Mishra, said, "We have decided to increase the height of the culvert at Town Planning area.

## Elephant shelter home for Sambalpur

Sambalpur, August 7: The forest department in Sambalpur district is planning to set up a 10-acre shelter home for wild elephants at Jujumura far away from human settlement. According to forest officials, there

are many elephants in the jungle who are rejected by their herds owing to old age and many baby elephants who are suffering from various difficulties in the jungle after losing their mother elephants. To save these elephants the forest

department will open an elephant shelter home at Jujumura, said DFO Sanjit Kumar. This will be the first of its kind shelter home in western Odisha, Kumar added. Kumar said various NGOs along

with state government and central government are helping the forest department for the security of elephants. At the shelter home, a rescue centre will be made functional in a bid to provide security to old, baby and injured elephants.

PCCF. Wildlife. Bhubaneswar. Harishankar Upadhaya, had visited two places in Sambalpur in this context and selected the bare land at



Jujumara for the construction of the shelter home.

In the first phase, Rs 50 crore will be spent on construction of the shelter home.

In the shelter home, the forest department will plant various types of trees including bamboo to give the jumbos a homely atmosphere. For drinking water, the forest department will dig a big pond as well.

A small veterinary hospital will also be made functional for the treatment of sick elephants. The department has written a letter to the

state government seeking permission for employment of a veterinary doctor. The baby elephants are fully dependant on their mother's milk until they are two years old. Some trained workers will be deployed at the shelter home to ensure that baby elephants are taken care of.

The baby elephants will be released into the wild after attaining adulthood. The forest officials will take care of the safety of the elephants in the shelter home through a mobile application and tracking



## Sushant for political games

his looks like a nightmarish end to federalism as we know it. Actor Sushant Singh Rajput's tragic death has turned into a deplorable political one-upmanship. The unprecedented face-off between Bihar Police and Mumbai Police on the investigation of the suicide has far-reaching consequences. Many experts are of the view that sending a team of Bihar Police personnel to Mumbai after Rajput's father filed an FIR demanding a probe into the "crime" was out of step. In India, police is a state subject and crimes are investigated by the police depending on where they occurred. If states start to interfere and go after crimes committed against their citizens in another state, we have a recipe for disaster. With the further likely addition of the CBI into this pot, the stew has grown thicker.

Had some worthies shown some prudence, we wouldn't have had to see the DGPs of the two states slinging at each other on the TV news. TV newsrooms or Twitter are not the place to conduct a serious investigation into the death of a popular actor.

The case has grown much bigger with the respective state governments getting into the ring. Bihar CM has given his nod for a CBI probe, bowing to pressure from the actor's family, while Maharashtra CM Uddhav Thackeray is refusing to give in to the demand. Both chief ministers have decided to stand by their police chiefs. The Enforcement Directorate (ED) has also opened an investigation into alleged money laundering. It is pretty much a no-holds-barred affair now, teetering dangerously on the edge of turning into

None of this would have merited so much focus and energy were it not for the spectre of Assembly elections in Bihar, due in October. The Bihari "sentiment" seems to have taken the front stage, a thinly veiled euphemism for votes. The

politicisation of the police is one of those vexed issues that no amount of reforms has been able to deal with. But sadly, if this lack of restraint and willful flouting of procedures by the police persists, it will end badly for

#### **EXIT FROM NITI AAYOG**

The repatriation of Niti Aayog Advisor Alok Kumar to his cadre state Uttar Pradesh has set tongues wagging. Barely less than two months ago, the Appointments Committee of the Cabinet had given Kumar a one-year extension of tenure at the think tank. He was relieved July 31.

The government's U-turn has left many observers bemused. Some say that since the UP government had agreed to an extension for Kumar in May, it is unlikely that it would recall the 1993-batch IAS officer. This then implies that the Centre's U-turn may have been caused by some rift among the higher-ups in Delhi over the babu. The buzz is that there are some differences between the Niti Aayog and the Health Ministry over policy matters, and possibly Kumar was in the middle of the spat. But that may not be the only reason, certainly not enough to warrant this U-turn. After all, Kumar was reportedly handling the majority of the key assignments at the nation's premier think tank. We may never know.

However, observers believe that Kumar's unexpected exit from Niti Aayog will cast a cloud over the empanelment of 1983 batch IAS officers for additional secretary-level posts at the Centre.

his archaic British English word for riding at full gallop has strong associations with the hunting field. Those dictionaries that mention it say it imitates the sound of the hooves of galloping horses, but I can't help but feel that a better origin lies in the three notes of the huntsman's horn when rallying the riders, one that is echoed in a hunting song of 1787 by the Irish dramatist John O'Keefe: "With a hey, ho, chivy / Hark forward, hark forward, tantivy". [chivy or chevy is another old hunting cry.] A once-common figurative usage was to ride tantivy, to go at something full speed or headlong, of which a late example appears in Australia Felix by Henry Handel Richardson (1917): "He was of a nature to ride tantivy into anything that promised excitement or adventure." A century earlier, the ubiquitous Sir Walter Scott had a character say in Peveril of the Peak, published 1824: "There are those amongst us who ride tantivy to Rome, and have already made out half the journey". This used the word in another sense, of a nickname given to high churchmen and Tories in the years after the Restoration of the monarchy in 1660.

## Taphonomist

66 hange and decay in all around I see", hymned Henry Francis Lyte in ◆Abide With Me. Nobody is more conscious of that than a taphonomist. The word was found in a dystopian SF book, Zero Point by Neal Asher, in which a future dictator used computer technology to simultaneously kill off eight billion human beings and then had to work out what to do with the bodies. Asher defined the word as a specialist who studies the decomposition of dead organisms. That's pretty much correct, though there's more to it and the timescales can vary hugely. A sub-discipline, forensic taphonomy, takes a relatively short-term view, looking into ways in which human remains decay through natural processes as a way to guide police investigations - you may have heard of macabre studies in which corpses are left out in the open so their decomposition can be studied.



√he robots are no longer coming; they are here. The Covid-19 pandemic is hastening the spread of artificial intelligence (AI), but few have fully considered the short and long run consequences.


In thinking about AI, it is natural to start from the perspective of welfare economics - productivity and distribution. What are the economic effects of robots that can replicate human labour? Such concerns are not new. In the 19th Century, many feared that new mechanical and industrial innovations would 'replace' workers. The same concerns are being echoed today.

Consider a model of a national economy in which the labour performed by robots matches that performed by humans. The total volume of labour - robotic and human – will reflect the number of human workers, H, plus the number of robots, R. Here, the robots are additive - they add to the labour force rather than multiplying human productivity. To complete the model in the simplest way, suppose the economy has just one sector, and that aggregate output is produced by capital and total labour, human and robotic. This output provides for the country's consumption, with the rest going toward investment, thus increasing the capital stock.

What is the initial economic impact when these additive robots arrive? Elementary economics shows that an increase in total labour relative to initial capital a drop in the capital-labour ratio - causes wages to drop and profits to rise.

There are three points to add. First, the results would be magnified if the additive robots were created from refashioned capital goods. That would yield the same increase in total labour, with a commensurate reduction in the capital stock, but the drop in the wage rate and the increase in the rate of profit would be greater.

Second, nothing would change if we adopted the Austrian School's two-sector framework in which labour produces the capital good

and the capital good produces the consumer good. The arrival of robots still would decrease the capital-labour ratio, as it did in the onesector scenario.

Third, there is a striking parallel between the model's additive robots and newly arrived immigrants in their impact on native workers. By pushing down the capital-labour ratio, immigrants, too, initially cause wages to drop and profits to rise. But it should be noted that with the rate of profit elevated, the rate of investment will rise. Owing to the law of diminishing returns, that additional investment will drive down the profit rate until it has fallen back to normal.

At this point, the capital-labour ratio will be back to where it was before the robots arrived, and the wage rate will be pulled back up.

To be sure, the general public tends to assume that robotisation (and automation generally) leads to a permanent disappearance of jobs, and thus to the immiseration of the working class. But such fears are exaggerated. The two models described above abstract from the familiar technological progress that drives up productivity and wages, making it reasonable to anticipate that the global economy will sustain some level

of growth in labour productivity and compensation per worker. True, sustained robotisation

would leave wages on a lower path than they otherwise would have taken, which would create social and political problems. It may prove desirable, as Bill Gates once suggested, to levy taxes on income from robot labour, just as countries levy taxes on income from human labour. This idea deserves careful consideration. But fears of prolonged robotisation appear unrealistic. If robotic labour increased at a non-vanishing pace. it would run into limits of space, atmosphere, and so on.

Moreover, AI has brought not just 'additive' robots but also 'multiplicative' robots that enhance workers' productivity. Some multiplicative robots enable people to work faster or more effectively (as in AI-assisted surgery), while others help people complete tasks they otherwise could not perform.

The arrival of multiplicative robots need not lead to a lengthy recession of aggregate employment and wages. Yet, like additive robots, they have their 'downsides.' Many AI applications are not entirely safe. The obvious example is self-driving cars, which can (and have) run into pedestrians

or other cars. But, of course, so do human drivers.

A society is not wrong, in principle, to deploy robots that are prone to occasional mistakes, just as we tolerate airplane pilots who are not perfect. We must judge costs and benefits. For efficiency, people ought to have the right to sue robots' owners for damages. Inevitably, a society will feel uncomfortable with new methods

that introduce 'uncertainty.' From the perspective of ethics, the interface with AI involves 'imperfect' and 'asymmetric' information. As Wendy Hall of the University of Southampton says, amplifying Nicholas Beale, "We can't just rely on AI systems to act ethically because their objectives seem ethically neutral."

Indeed, some new devices can cause serious harm. Implantable chips for cognitive enhancement, for example, can cause irreversible tissue damage in the brain. The question, then, is whether laws and procedures can be instituted to protect people from a reasonable degree of harm. Barring that, many are calling on Silicon Valley companies to establish their own 'ethics committees.

All of this reminds me of the criticism leveled at innovations throughout the history of freemarket capitalism. One such critique, the book Gemeinschaft und Gesellschaft by sociologist Ferdinand Tönnies, ultimately be came influential in Germany in the 1920s and led to the 'corporatism' arising there and in Italy in the interwar period - thus bringing an end to the market economy in those countries.

Clearly, how we address the problems raised by AI will be highly consequential. But they are not yet present on a wide scale, and they are not the main cause of the dissatisfaction and resulting polarisation that have gripped the West.

## Who takes what from govt in healthcare

According to the National Health Accounts Estimates for India, 2018, the government spent ₹9,134 crore in 2015-16 on the 31 lakh government employees; or about ₹7,000 per person if we include their families. The expenditure on the non-government citizens was ₹38,794 crore on 131 crore persons or a meagre ₹296 per person. This includes expenditures on government-financed health insurance. The primary objective of MoHFW has, howsoever unwittingly come to serve government employees and, by default, not the public.

Secondly, in Budget for 2020-21, MoHFW, which promotes the allopathic system of medicine, has been allocated ₹63,000 crore; while the Ministry of AYUSH, which promotes alternative systems like Ayurveda and homoeopathy, has been allocated a meagre ₹2,100 crore. No doubt the allopathic system is doing a great service by brining certain cures such as placing stent in the heart. AYUSH is more oriented at providing systemic treatments. The AYUSH Ministry prevents the need for stents. Yet the government allocates more money to cure and less to prevention. The reason for this lopsided allocation appears to

Thirdly, within the MoHFW Budget, there is a lopsided allocation in favour of hi-tech treatments like stents that are called 'tertiary. and less on primary and secondary treatment. In a paper titled "Healthcare Financing Reforms in India" published in 2012, Govinda Rao of the National Institute of Finance and Public Policy has pointed out that the National Health Policy had placed a target of 10 per cent expenditures on tertiary care but the actual is 28 per cent. Once again, MNCs are the benefi ciaries. Fourthly, most of the government health expenditures are used up in paying salaries to government health workers. The share was 83 per cent in Madhya Pradesh and Odisha

One step towards the correction of these anomalies in MoHFW, as suggested by adviser to Niti Aayog Rakesh Sarwal is that the Central Government Health Service should be converted into a Universal Health Service so that the expenditure on government employees and people becomes equal. The second step is to increase the allocations of AYUSH and reduce those of tertiary treatment. The third step is to fix a maximum ratio of salaries

government expenditures and medicines that are promoted by a budget crunch, reduce the salaries these expenditures drastically and

The second area of our health system is preventive care which includes vaccinations. A problem here—in respect of Covid—is that the virus is changing rapidly. Therefore, a vaccine against Covid of yesterday may not be effective against Covid of tomorrow. The performance of our preventive health within MoHFW is unsatisfactory. Only seven per cent children do not get measles' vaccination in South America against 30 per cent in India.

The second issue in preventive care is our people need to partake of garlic, giloi, ginger and turmeric; undertake yoga and meditation; and get more exercise and sunlight. The MoHFW has successfully launched campaigns in favour of iodine-laced salt and breast-feeding of infants.

As said above, the total expenditure of the Union government on health of non-government citizens was ₹38.794 crore in 2015-16. Of this, only ₹12,000 crore was made on preventive health which included vaccination; information, education and communication; antismoking campaign; free distribution of masks; and testing for diseases like Covid, diabetes and cancer.

The third issue is to explore a different social paradigm. A paper by Vaidya Vachaspati Tripathi published on the Uttar Pradesh government website says that taking bath in the rivers during the Kumbh leads to development of immunity. Large numbers of pilgrims spread miniscule amounts of various disease-creating viruses and bacteria in the water. These enter the bodies of other pilgrims during the dip and prompt the body of the healthy pilgrim to fight viruses and bacteria and develop immunity. In his words, as told to me, one dip is sufficient for good health till the next Kumbh." This will help fight Covid-19 too.

Doctors treating Covid patients are forced to make a choice between who will live and who will die. The choice before the government is whether the few will live and many will die?

## **SSR death: Rhea appears before ED**

Mumbai, August 7: Actor Rhea Chakraborty, accused of abetting suicide of filmstar Sushant Singh Rajput, appeared before the Enforcement Directorate (ED) here Friday in connection with the money laundering case lodged by it.

The ED had summoned Rhea Chakraborty for questioning Friday (August 7), but she had requested the agency to postpone recording of her statement pending hearing of her plea filed in the Supreme Court seeking transfer of the case lodged by the Bihar police to Mumbai

However, the ED rejected her request. "In view of the fact that the ED has informed the media that the request to postpone her attendance is rejected, Rhea has appeared before the ED office," her advocate Satish Maneshinde said.

The advocate, in a statement, added that Rhea Chakraborty (28), Rajput's girlfriend, is a law-abiding citizen and would cooperate with the probe.

Rajput (34) was found hanging June 14 at his residence in subur-

## Bihar IPS officer released from 'quarantine'

The Brihanmumbai Municipal Corporation (BMC) Friday said it has allowed Bihar IPS officer Vinay Tiwari, quarantined here after arrival to oversee probe in actor Sushant Singh Raiput death case, to return to his home state. Tiwari, Superintendent of Police of Central Patna, has been exempted from quarantine protocols and allowed to return to his home state, an official said. Thursday, Bihar Police ADG wrote a letter to the Mumbai municipal commissioner, seeking the IPS officer's exemption from quarantine protocols and facilitate his return to Patna to resume his duty. Tiwari's presence is no longer required in Mumbai and his arrival period (in Patna) is within seven days, the letter said. Accordingly, the BMC informed the Bihar police that they are exempting the IPS officer from quarantine norms. The IPS officer, who was under 'home quarantine' at SRPF guest house in suburban Goregaon for two weeks, is expected to return to Bihar later in the day. Tiwari had reached Mumbai on Sunday to oversee investigation into the FIR filed against actress Rhea Chakraborty in the Sushant death case.

## Audio clip of cops' conversation out

Lucknow, August 7: Nearly a month after Kanpur's notorious gangster Vikas Dubey was put down in an encounter, an audio clip of a conversation between slain circle officer Devendra Mishra and Kanpur SP (Rural) Brijesh Srivastava has gone viral on the social media. They were part of the team that was ambushed and butchered by Dubey's men a week before his death.

The audio clip could spell trouble for the then Station Officer (SO) of Chaubeypur police station Vinay Tiwari and former Kanpur SSP Anant Deo Tiwari. Questions have been raised over the nexus between police officers and Dubey's gang ever since the July 2 massacre in

Vinay Tiwari has been arrested for his complicity with the slain gangster while Anant Deo Tiwari has been shifted to another district

after the Bikru massacre. In the phone conversation, that



apparently took place just before the police raided Dubey's premises on the night of July 2 that led to the death of eight policemen, including slain circle officer, Devendra Mishra, himself, can be heard telling Srivastava that the SO (Vinav Tiwari) is saying the raid will start only after the CO (Mishra) reaches

Mishra is also heard making allegations against "former SSP Tiwari" (in an apparent reference to Anant Deo Tiwari) - saying that he took Rs 5 lakh from the SO after a gambling racket was busted by Mishra and dropped all inquiries

At the start of the five-minute clip, the SP can be heard saying that a large deployment of police would be required in the village and Mishra says that the deployment should not be a problem.

The SO is saying that he would go for the raid only after I reach there. So, I am going," Mishra says.

SP Rural tells Mishra that "You should not worry. I will take care of these people very soon and am preparing a list of all that he is doing. The SSP might have asked him to make the arrest. Use your mind and take the force of twothree police stations as we have a great chance of catching him (Vikas Dubey).'

The circle officer who lost his life in the encounter, then says, "I will tell you about him. When he (Vinay Tiwari) touches his (Vikas Dubey) feet, what else we can expect. Once I told him that if he will keep his relations with him (Dubey) then it might lead to 2-4 murders, but he said that only a criminal can tell about other criminals.'

Marathwada, August 7: Maharashtra has recorded 1,074 farmer suicides in the six-month period between January and June this year. In other words, 6 farmers on average ended their lives every day.

The highest number of cases was in June during the lockdown when 214 cases were reported. The lockdown was particularly hard on farmers sowing perishable crops like fruits and vegetables. Initially, transport restrictions had made it difficult for farmers to take their goods to major wholesale markets, and many ended up discarding their produce.

Of 1,074 farmer suicides till June this year, most cases were in June during the lockdown. Collapse of the supply chain resulted in a price crash in wholesale markets. However, government procurement for crops like cotton was the highest in the last decade.

Despite the lockdown, the farmer figures are lower than last year when 1,336 cases were reported during the same period. In 2019, Marathwada had reported a rain deficit and then there were floods in Western Maharashtra which destroyed large tracts of crop.

"The low-profile marriage season in this pandemic year may have reduced spending pressure on farmers. In summer months, marriages are a key reason for rise in indebtedness," said Kishore Tiwari of Vidarbha Janandolan Samiti. "This year, many chose to postpone marriages or hold very small functions." However, he added that the real challenge this year will be after the kharif harvest. "Many farmers did not get crop loans and borrowed for the kharif crop. They have pinned hopes on its success," said Tiwari.

"The agrarian crisis cannot be resolved until there is control on prices of agricultural inputs and farmers get a better price for their produce. The availability of crop loans is vital." Farmer leader Vijay Jawandhia from Vidarbha feels that the fear of the pandemic kept the pressure of indebtedness at bay.

Ajit Navale from the Kisan Sabha said so far this year, farmers had been spared a major pest attack. "Also, fruit and vegetable farmers generally come from the irrigated belt. They suffered the most in the pandemic, but also tend to be better off than dry-land farmers,' said Navale.

## **SC** refuses to hear PIL for probe against **Cong over China pact**

New Delhi, August 7: The Supreme Court Friday refused to entertain a PIL seeking NIA probe into the alleged 2008 agreement between the Indian National Congress and the Communist Party of China.

A bench headed by Chief Justice SA Bobde asked senior lawyer Mahesh Jethmalani, appearing for PIL petitioners Shashank Shekhar Jha and journalist Savio Rodrigues, to withdraw the plea and approach the high court.

"Every relief which you are seeking can be granted by the high court. Secondly, high court is a proper court. Thirdly, we will have the advantage of high court order also," said the bench which also comprised Justices A S Bopanna and V Ramasubramanian.

The top court, in the hearing conducted through video conferencing, allowed the petitioners to "withdraw the petition with liberty to approach the high court.'

At the outset, Jethmalani alleged that it was an "agreement between a political party of this country with the only political party in that country (China)" and the issue pertained to national se-

"We find that there is something which appears to be, what might be called, unheard of and absurd in law. You are saying that China has entered into an agreement with a political party and not the government. How can a political party enter into an agreement with China," the bench observed.

On being stressed by the lawyer that this was the case, the bench said, "we will allow you to withdraw this and file a fresh petition. We will examine what you say in the petition and if we find any false

The officials said that past 100 days have seen the Indian Navy operating from Ladakh (with its P-8I surveillance aircraft) in the north to Mauritius, 7,000 km to the south, and from the Red Sea in the west to the Malacca Strait in the east, a distance of nearly 8,000 km.

Indian Navy deploys ships on Mission Based Deployments at key locations in the IOR so as to build a comprehensive maritime picture and respond to developing situa-

At any time, there are warships patrolling the Bay of Bengal, the Malacca Straits, the Andaman Sea, the southern and the central Indian Ocean Region, the Gulf of Aden and the Persian Gulf.

Additionally, following maritime security incidents, a combat-ready warship has also been deployed on Operation Sankalp since June 2019 for protection of Indian merchant vessels passing through the

#### **Pakistan violates** ceasefire

Srinagar: Six civilians were injured as Pakistani troops violated the ceasefire along the Line of Control (LoC) in Naugam and Tangdhar sectors of Jammu and Kashmir Friday by resorting to unprovoked firing towards Indian positions, an army official said. "Pakistan initiated an unprovoked ceasefire violation (CFV) along the LoC in Naugam and Tangdhar sectors in Kupwara (district of north Kashmir) by firing mortars and other weapons," the official said. He said six civilians were injured due to Pakistani shelling in Tangdhar sector while no casualties had been reported from Naugam sector so far.

## **Electric Vehicle Policy in Delhi**

New Delhi: Chief Minister **Arvind Kejriwal Friday** launched 'Delhi Electric Vehicle Policy' under which his government will waive registration fee and road tax, and provide incentive of up to Rs 1.5 lakh for new cars in the national capital. Addressing an online media briefing, he said the policy, which aims to boost the economy. create jobs and reduce pollution level, has been notified. The Chief Minister termed it a "progressive policy" of the country.

## Kerala bishop gets bail in rape case

Kottayam: Two days after the Supreme Court dismissed the petition filed by former Jalandhar bishop Franco Mulakkal seeking to discharge him in the Kerala nun rape case, he appeared in court here Friday and secured bail. The Kottayam Additional Sessions Court had issued a non-bailable warrant against him last month and cancelled his earlier bail in the case. after he failed to appear before the court to hear the chargesheet in the case being read out.

## 42-year-old man beaten to death

Howrah (WB): A 42-year-old man was allegedly beaten to death in West Bengal's Howrah district, police said Thursday. The incident happened late Wednesday in Bhupatipur village in the Jagatballavpur police station area, they said. Amid a brawl among family members over cutting a papaya tree, Adhir Ray was beaten on his head with a stick, police said.

## Let Italy compensate victims' kin: Top court

New Delhi, August 7: The Supreme Court Friday told the Centre to let Italy pay the victims compensation in the Italian marines case, and then it could allow the withdrawal by the prosecution. The top court insisted that it will have to hear the kin of the victims on adequacy of compensation and till then it would not close

A bench comprising Chief Justice SA Bobde, Justice AS Bopanna and Justice V Ramasubramanian told Solicitor General Tushar Mehta, representing the Centre, "bring the cheques and the kin of victims here". The bench noted that the top court cannot think of any relief for the Italian marines till their prosecution is withdrawn in the Kerala court. Mehta replied the Centre is willing to file a petition for withdrawing prosecution of the two marines. The Chief Justice replied "but the family of victims will have a problem. They will have to be heard". Mehta contended before the top court that the Centre is in favour of withdrawing the prosecution of the Italian marines in India, as Italy is ready to prosecute them. The bench noted that without hearing the kin of the deceased it cannot close the case. The top court asked Mehta to file an application seeking impleadment of the families of the victims within a week. The top court adjourned the hearing on the pend-

ing petition filed by the two Italian marines - Massimiliano Latorre and Salvatore Girone

On July 3, the Centre had informed the top court that it has accepted the international tribunal award in the killing of two fishermen by the Italian marines. The Centre asked the apex court to close the matter pending before it for eight years

The tribunal ruled for the trial of the marines in Italy. It said India is entitled to payment of compensation in connection with loss of life, physical harm, material damage to property and moral harm suffered by the captain and other crew members of the Indian fishing boat 'St Antony'.

On February 15, 2012, two Indian fishermen aboard the fishing vessel St Antony were allegedly killed by the two Italian marines aboard the Italian tanker 'Enrica Lexie' off the coast of Kerala.

## 15 dead, over 60 missing in landslide

Thiruvananthapuram, August 7: At least 15 people were killed and around 50 others feared trapped in debris after a landslide triggered by heavy rains flattened a row of dwelling units of tea estate workers at Pettimudi in Rajamala in this high-range district in Kerala early Friday, police and officials said.

Chief Minister Pinarayi Vijayan said 15 people who got trapped in the debris were rescued and a special officer has been appointed to coordinate the relief operations. The incident is said to have occurred in the wee hours when a huge mound of earth fell on the "row houses" and two children and five women were among the deceased, most of whom were plantation workers from neighbouring Tamil Nadu.

Efforts were underway amid continuing rains to locate the missing people in the first major rain-related mishap since the onset of South West monsoon last month that brought back memories of devastation caused by floods and landslides in the previous two vears in the state.

Prime Minister Narendra Modi. Kerala Governor Arif Mohammed Khan, Union Home Minister Amit Shah and Congress leader Rahul Gandhi expressed anguish at the loss of lives in the landslide. Three injured have been admitted to a private Medical College Hospital in Kolenchery in Ernakulam district and one in Tata General Hospital at Munnar. Cooking utensils buried in mud, asbestos and tin sheets strewn around were all there to be seen at the area, which was the habitation of around 80 odd work-

ers at the picturesque area near a tea plantation, about 30 kms from the tourist town of Munnar. Big boulders are also scattered around the site. Addressing a press conference in Thiruvananthapuram, the Chief Minister said 15 people died in the mishap. Teams of National Disaster Response Force personnel were on their way to Pettimudi for joining the rescue operations and the government has also sought an Indian Air Force helicopter to assist in the mission, he said.

Condoling the death of workers in the tragedy, the Chief Minister announced initial solatium of Rs 5 lakh each for the kinof the dead. Treatment expenses for the injured will be borne by the government, he said. In view of the Pettimudi incident, the district collectors have been directed to ensure safety and security of the workers staying in dwelling units in the tea estates. The Prime Minister's Office said in a tweet that an ex-gratia of Rs 2 lakh each from the Prime Minister's National Relief Fund (PMNRF) would be given to the next of kin of those killed in the landslide. Rs 50,000 each would be given to those injured. "Pained by the loss of lives due to a landslide in Rajamalai, Idukki. In this hour of grief, my thoughts are with the bereaved families," Modi tweeted. Praying for the early recovery of the injured, he said NDRF and the administration were working on the ground, providing assistance to the affected. Home Minister Shah in a tweet

said an NDRF team has reached Iddukki to assist in the rescue and relief operations. Rahul Gandhi, who represents Wayanad in Lok Sabha, in a message said "This is a terrible tragedy. I urge all our Congress party workers and leaders to lend a helping hand at this time and do whatever they can to mitigate the suffering of our brothers and sisters who are in need of help.

The death toll in rain-related incidents since June 1 this year has risen to 51. One person died in a house collapse in Palakkad on Friday, officials said.

Meanwhile, the India Meteorological Department has sounded a red alert for Idukki on Friday, indicating extremely heavy rains of over 20 cms.

## **Girl's condition** remains critical

New Delhi, August 7: The 12year-old girl, who was sexually assaulted and has suffered severe head injuries, will need another surgery and her condition continues to remain critical, sources at AIIMS, where she is undergoing treatment, said Friday. Sources said her platelet count is low and she is admitted at the neurosurgery ICU of the hospital.

The girl was sexually assaulted at her west Delhi home by 33-yearold Krishan Tuesday, who also hit her on the face and head with a sharp object.

Her rectum and intestines were injured severely by some kind of impalement for which she needed immediate intervention and that is why she was operated upon as soon as she reached the hospital, a senior doctor at the AIIMS had said Thursday. The brutality involved in the crime has led to an outrage with Delhi Chief Minister Arvind Kejriwal describing the incident as 'barbaric'. Delhi Police arrested Krishan Thursday. He told the police that he had entered the girl's house Tuesday with the intention of burgling.

However, police said they are verifying Krishan's version. A case has already been registered under section 307 (attempt to murder) and Protection of Children from Sexual Offences (POCSO) Act at Paschim Vihar West police station. Krishan was involved in a similar violent incident in the past. He had attacked a woman in 2006 in Sultanpuri while committing a burglary, in which the woman had died.

## **SC** dismisses Rehana's bail plea

New Delhi, August 7: The Supreme Court Friday junked a plea filed by Kerala activist Rehana Fathima to challenge a High Court order that rejected her petition against a case registered under the POCSO Act and IT Act over her controversial video.

A three-judge bench of the apex court comprising Justices Arun Mishra, BR Gavai and Krishna Murari observed that the video uploaded by Fathima of her semi nude body being painted on by her children was clearly obscene. Why do you do all this? You

might be an activist but why do this? What kind of nonsense is this? It is obscenity clearly which you are spreading. It will leave the society in a very bad taste. What impression will the kids get," the bench said. The petitioner, mother to a 14-year-old boy and an 8-year-old girl, had uploaded a video clip titled 'Body Art and Politics' on YouTube, showing her two children painting on her semi-naked body Rehana's counsel contended before the apex court that children seen in a video clip are 'fully clothed' and his client has been charged with child pornography and not obscenity. "Does female nudity (even when not visible) per se constitutes obscenity?" he pleaded on behalf of his client. The lawyer insisted that his client Rehana is of the opinion that the only way out of this mindset is to sensitise people. She has moved an anticipatory bail plea in a matter.

## Govts don't act till we direct them: SC

New Delhi, August 7: The Supreme Court Friday said that the governments in the country did not act till the court directed them.

'We have seen from our experience that governments do not act until we direct them," a bench comprising Chief Justice SA Bobde and Justices AS Bopanna and V Ramasubramanian said. "That is why this system is here," the court remarked. The observation came

during hearing of a plea filed by Jamiat Ulama-i-Hind that alleged "demonising of the Muslim minority" in the wake of Tablighi Jamaat congregation in Delhi in March. The Chief Justice said that the criticism is not aimed at Solicitor General Tushar Mehta.

Senior Advocate Dushvant Dave submitted before the bench regarding news reports on the Jamaat event, and insisted that only the government can take action and not the self-regulating bodies governing the media. The Ministry of Information and Broadcasting, in an affidavit filed through advocate Rajat Nair, informed the top court that it cannot gag the media from reporting on the Jamaat issue. The Centre claimed that steps have already been taken to prevent any dissemination of false and provocative information, and a blanket gag order cannot be passed against media reportage, as this could effectively harm the freedom of speech and expression and press freedom.

## Kashmir, Jammu and Ladakh could heat up by 7°C by 2100

Srinagar, August 7: Jammu. Kashmir and Ladakh may witness a temperature increase of up to 6.9 degrees Celsius by the end of the century due to climate change, according to a study which warns that the glaciers in this Himalayan region could shrink by 85 per cent if the projections come true.

The study, published in the journal Climatic Change July 29, predicted the impact of future climate change in the Jammu, Kashmir and Ladakh Himalaya, by the end of the twenty-first century using an ensemble of 11 models under three greenhouse gas emission scenarios. It also highlights the changes in the distribution of the prevalent

climate zones in the region.

"The study has been carried over the entire region of Jammu and Kashmir, including Jammu, Kashmir, Ladakh, Gilgit-Baltistan, Aksai Chin and other regions across the Line of Control (LoC)," noted Professor Shakil Ahmad Romshoo, Dean of Research at the University of Kashmir. "The average annual temperature is projected to increase by 4.5 degrees Celsius, 3.98 degrees Celsius, and 6.93 degrees Celsius by the end of the twenty first century under three different scenarios, respectively," Romshoo, lead author of the research, told PTI.

Romshoo added that if the current emission rates of greenhouse gases are sustained, the global average temperature is likely to rise by nearly 5 degrees Celsius by the end of the twenty-first century

under the worst case scenario. Similarly, the average tempera-

ture over India is projected to rise by approximately 4.4 degrees Celsius under such a scenario, he said. Romshoo noted that there will be significant impacts on almost every sec-

tor of the economy in Jammu, Kashmir and Ladakh due to this climate change driven temperature

by the end of the century if the projections come true," the professor at the Department of Earth Sciences, University of Kashmir, noted. He explained that this would lead to significant depletion of the streamflows in the Indus basin, the waters of which are shared between several countries in South Asia.

Similarly, the impacts on agriculture, horticulture and even tourism shall significantly threaten the livelihood of the dependent population in the region, the environmentalist warned. The researchers, including Jasia Bashir and Irfan Rashid from the Department of Earth Sciences, University of Kashmir, noted that the drivers of climate change are primarily the increasing emission rates of greenhouse gases in the atmosphere. Greenhouse gas emission is directly related to fossil fuel use, industrialisation, deforestation, air pollution, and other environmental unfriendly activities across the globe, they explained.

Colombo, August 7: Mahinda Rajapaksa will be sworn in as Sri Lanka's Prime Minister for the fourth time Sunday after his party registered a landslide victory in the general election, securing twothirds majority in Parliament needed to amend the Constitution to further consolidate the powerful Rajapaksa family's grip on power.

The Sri Lanka People's Party (SLPP), led by Prime Minister Mahinda Rajapaksa, won in 145 constituencies, bagging a total of 150 seats with its allies, a two-thirds maiority in the 225-member Parliament. according to the results announced by the election commission Friday.

It won all but four of the 22 electoral districts on offer, polling 6.8 million votes (59.9 per cent). The 74vear-old Prime Minister Mahinda thanked the Sri Lankan people for putting their faith in the SLPP and said that the country will not stand disappointed during its tenure.

"Heartfelt gratitude to all Sri Lankans for placing their trust in President Gotabaya Rajapaksa, myself and the Podujana Party and voting for the 'Saubhagye Dakkama' election manifesto in overwhelming numbers. We will ensure Sri Lanka will not stand disappointed during our tenure," he said.

Mahinda will be sworn in as the new Prime Minister for the fourth time Sunday at a ceremony at the historic Buddhist temple of Kelaniya, a north Colombo suburb, according to an official statement.

He created a record in polling over 500,000 individual preference votes, the highest ever recorded by a candidate in the history of elections. Prime Minister Narendra Modi was among the first world leaders to congratulate Mahinda on the outcome of the elections and said the two sides will work together to further advance all areas of bilateral cooperation and to take their special ties to ever newer heights.

In the parliamentary election, he was seeking 150 seats mandatory to execute constitutional changes, including to repeal the 19th Amendment to the Constitution which had curbed the presidential powers while strengthening the role of Parliament. Activists, already alarmed by the diminishing space for dissent and criticism in the island nation, fear such a move could lead to authoritarianism. Meanwhile, the biggest casualty from the election outcome was the United National Party (UNP) of former Prime Minister Ranil Wickremesinghe.

The UNP managed to win only one seat and that too came thanks to the cumulative votes polled nationally.

Beirut, August 7: Lebanon's president said Friday an investigation into the biggest blast in Beirut's history would examine whether "external interference" had a role, as residents tried to rebuild their shattered lives and homes after the explosion.

The search for those missing intensified, as rescuers sifted rubble in a race to find anyone still alive after Tuesday's explosion that killed 154, smashed up a swathe of the city and sent shockwaves around the region.

"The cause has not been determined yet. There is a possibility of external interference through a rocket or bomb or other act,' President Michel Aoun said in comments carried by local media and confirmed by his office.

He said it would also consider whether it was a result of negligence or an accident. He previously blamed negligence in the storage of highly explosive material for vears at the port.

The United States has previously said it has not ruled out an attack.



Israel, which has fought several wars with Lebanon, has also previously denied it had any role.

Security forces fired teargas at a furious crowd in Beirut late on Thursday, as anger boiled over at the ruling elite, who have presided over a nation that faced economic collapse even before the deadly port blast injured 5,000 people.

The small crowd, some hurling stones, marked a return to the kind of protests that had become a feature of life in Beirut, as Lebanese watched their savings evaporate and currency disintegrate, while government decision-making

There is no way we can rebuild this house. Where is the state?" Tony Abdou, an unemployed 60vear-old. His family home is in Gemmayze, a district that lies a few hundred metres from the port warehouses where 2,750 tonnes of highly explosive ammonium nitrate was stored for years, a ticking time bomb near a densely populated area

A security source and local media

previously said the fire that caused the blast was ignited by warehouse welding work. Volunteers outside swept up debris from the streets of Beirut, which still bears scars from the 1975-1990 civil war and has often witnessed big bombings and other unrest since then. "Do we actually have a government here?" said taxi driver Nassim Abiaad, 66, whose cab was crushed by falling building wreckage just as he was about to get into the vehicle. "There is no way to make money anymore," he said.

The government has promised a full investigation. A news agency said 16 people were taken into custody. But for many Lebanese, the explosion was symptomatic of the years of neglect by the authorities while state corruption thrived. Officials have said the blast, whose seismic impact was recorded hundreds of miles (kilometres) away might have caused losses amounting to \$15 billion - a bill the country cannot pay when it has already defaulted on its mountain of national debt, exceeding 150% of economic output, and talks about a lifeline from the International Monetary Fund have stalled.

## **Pak Parliament okays** FATF-related Bill

Islamabad, August 7: Amidst vociferous protests from Pakistan's religious parties, the Parliament has approved a third Bill related to the tough conditions set by the global money laundering and terrorist financing watchdog FATF.

The legislation is part of the efforts by Pakistan to move from the Paris-based Financial Action Task Force (FATF) grey list to the white list. The FATF put Pakistan on the grev list in June 2018 and asked Islamabad to implement a plan of action by the end of 2019 but the deadline was extended later due to COVID-19 pandemic.

The Mutual Legal Assistance (Criminal Matter) Bill, 2020 -which calls for exchange of information and criminals with countries -- was passed late\_ Thursday evening in a joint sitting of Parliament after a hectic twoday consultation with the two major Opposition parties --Pakistan Muslim League-Nawaz (PML-N) and Pakistan Peoples

The Bill was passed after the government agreed to include over two dozen Opposition-proposed amendments with a majority vote amidst noisy protest by the religious and nationalist parties, the Dawn News reported.

## **Fourth Canadian** gets death sentence

Beijing, August 7: China has sentenced a fourth Canadian citizen to death on drug charges in less than two years following a sharp downturn in ties over the arrest of an executive of Chinese tech giant Huawei.

Ye Jianhui was sentenced Friday by the Foshan Municipal Intermediate Court in the southern province of Guangdong.

Ye had been found guilty of manufacturing and transporting drugs, the court said in a brief statement.

Another suspect in the case was also given the death penalty and four others sentenced to between seven years and life in prison. Death sentences are automatically referred to China's highest court for review.

Ties between Canada and China have nosedived over Canada's late 2018 arrest of Meng Wanzhou, a company executive and the daughter of Huawei's founder, at Vancouver's airport in at the request of the US, which wants her extradited to face fraud charges over the company's dealings with Iran.

Her arrest enraged Beijing, which calls it a political move aimed at constraining China's rise as a global technology power.

Ye's sentencing comes a day after fellow Canadian Xu Weihong was given the death penalty by the Guangzhou Municipal-Intermediate Court, also in Guandong province.

## US lifts Covid travel advisory

Washington, August 7: The US has lifted the highest level of its global health travel advisory for Americans due to the coronavirus pandemic and restored the previous countryspecific system without changing the status of over 50 countries, including that of India and China.

The US state department issued the Level 4: Do Not Travel advisory -- the highest level of travel advisory -- on March 19, urging American citizens not to travel overseas due to the coronavirus pandemic. India remains on the Level 4 of the travel advisory along with more than 50 countries, including China. This means that the US urges its citizens not to travel to India due to the increasing coronavirus cases.

The state department, in its latest travel advisory on India issued on Thursday, said: "Do not travel to India due to COVID-19. Exercise increased caution in India due to crime and terrorism".

The Centres for Disease Control and Prevention (CDC) has issued a Level 3 (avoid non-essential travel) Travel Health Notice for India due to COVID-19, it said. Travellers to



India may experience border closures, airport closures, travel prohibitions, stay at home orders, business closures and other emergency conditions within India due to the COVID-19 pandemic, it said.

Assistant Secretary of State for Consular Affairs Carl Risch told reporters during a conference call that the State Department, in close coordination with the CDC, has lifted the Global Level 4 Health Advisory and has returned to the previous system of country-specific levels of travel advice, with levels from 1 to 4 depending on country-specific conditions.

The CDC has similarly removed its Level 3 Global COVID-19 Pandemic Notice. This important change reflects the reality that health and safety conditions are improving in some countries while potentially deteriorating in others,

By returning to the country-specific travel advisory system, the US is able to give Americans detailed and actionable information to make informed travel decisions,

"The COVID-19 pandemic poses significant risks for travellers and our destination-specific advisories take into account the latest data and public health and safety analysis on COVID-related risks," Risch said. Among other countries which have been put on the Level 4 of travel advisory include Afghanistan. Bangladesh, Bhutan, Syria, Saudi Arabia, Russia, Mexico, Egypt, and

Although the guidance from the state department has been lifted, American travellers continue to face travel restrictions in countries worldwide due to the rising cases of the deadly disease in the United States. ## No more 'mouse catching' for UK's Foreign Office cat

Lord Palmerston, famed for regular territorial tiffs with neighbouring Downing Street mouse-catcher Larry, will see out his retirement in the English countryside, where he has been spending lockdown already at the home of a member of Foreign Office staff.

Both cats have their own social media profiles and are very popular with news photographers on Downing Street duties. "In April 2016, a cat called Palmerston arrived from Battersea (dogs and cat shelter in London). I thought I was employing a mouser. What I got



was a social media phenomenon, with 105,000 Twitter followers," said Sir Simon McDonald, the Permanent Under-Secretary and Head of the Diplomatic Service at the FCO, announcing Palmerston's retirement "After four happy years,

@Diplomog (Palmerston's Twitter handle) will retire: he's enjoyed lockdown life in the countryside so much, he's accepted an invitation to stay. Everyone at the Foreign Office will miss him (our mice less so). We wish him a long & happy retirement," said McDonald in a Twitter statement.

## Trump signs executive orders banning TikTok, WeChat

Washington, August 7: President Donald Trump, citing India's recent ban on Chinese social media apps, has signed executive orders that would prevent TikTok and WeChat from operating in the US as they threatened America's national security and economy. The ban comes into effect in 45 days, Trump said in two separate executive orders signed on Thursday.

India was the first country to ban TikTok and WeChat, citing national security concerns. India has banned as many as 106 Chinese apps, a move

welcomed by both the Trump administration and US lawmakers.

'The United States must take aggressive action against the owners of TikTok to protect our national security," Trump said in his executive order. In his next executive order he said the country must take "aggressive action" against WeChat to protect America's national security. In a communique to the Congress, Trump said the spread in the United States of mobile applications developed and owned by companies in China continues to threaten the national security, foreign policy, and economy of the country. Trump noted that these risks have led other countries, including Australia and India. to begin restricting or banning the use of TikTok and WeChat. TikTok which has up to 80 million active monthly users in America - has exploded in popularity in recent years, mostly with people under 20.

TikTok, a video-sharing mobile application owned by the Chinese company ByteDance Ltd, automatically captures vast swaths of information from its users, Trump said. This data collection threatens to allow the ruling Chinese Communist Party access to



Americans' personal and proprietary information - potentially allowing China to track the locations of federal employees and contractors, build dossiers of personal information for blackmail, and conduct corporate espionage, he alleged.

TikTok also reportedly censors content that the Chinese Communist Party deems politically sensitive, such as content concerning protests in Hong Kong and China's treatment of Uyghurs and other Muslim minorities. TikTok may also be used for disinformation campaigns that benefit the Chinese Communist Party, the president said.

"To deal with this threat, the order prohibits, beginning 45 days after the date of this order, to the extent per-

mitted under applicable law, any transaction by any person, or with respect to any property, subject to the jurisdiction of the United States, with ByteDance Ltd., Beijing, China, or its subsidiaries, in which any such company has any interest, as Commerce (Secretary)," Trump said. He delegated power to the commerce secretary to take such actions, including adopting appropriate rules and regulations, and to employ all powers granted to the President by International Emergency Economic Powers Act as may be necessary to implement the order.

## **Efficient farming** must for food security: Naidu

Chennai, August 7: Vice-President M Venkaiah Naidu Friday said there is an urgent need to make agriculture more efficient and profitable to ensure food and nutrition security.

In a virtual address inaugurating a conference 'Science for Resilient Food, Nutrition and Livelihood: Contemporary Challenges' Naidu said, "If we are to ensure food and nutrition security to millions, there is an imminent need to make agriculture more efficient, resilient, profitable and productive. Pre-harvest and post-harvest losses have to be minimised.'

The conference was organised by the city-based MS Swaminathan Research Foundation (MSSRF).

According to Naidu, the market infrastructure and the national road and transportation network must be improved so that farmers are able to get their produce from the farm gates to markets at reasonable cost.

"We must step up investments in improved storage, processing and preservation to retain the nutritional value of food products, rather than investing in highly processed foods. Food, agriculture and trade policies have to be constantly reviewed and updated to suit the times," Naidu said.

Pointing out the negative health impact owing to poor diet quality, Naidu said there is need to reorient agriculture priorities towards more nutrition-sensitive food.

He said diets of poor quality are a principal contributor to the multiple burdens of malnutrition: stunting, micronutrient deficiencies, overweight and obesity.

## Global AI market to see 12.3% growth in 2020: IDC

San Francisco, August 7: Worldwide revenues for the Artificial Intelligence (AI) market, including software, hardware, and services, are expected to total \$156.5 billion in 2020, a growth of 12.3% over the previous year, according to a new forecast by International Data Corporation (IDC)

While this year's growth is somewhat slower than previous year's due to the economic impact of COVID-19, investment in AI will recover quickly, said the IDC 'Worldwide Semiannual Artificial Intelligence Tracker'.

The second largest AI category is services, which IDC forecasts will reach \$18.4 billion in 2020, an increase of 13% year over year. Within the AI services market, AI

IDC expects AI hardware (server and storage combined) revenues to reach \$13.4 billion in 2020, representing 10.3% year-over-year growth. In terms of vendor share, the top three companies in AI Server are Dell, Hewlett Packard Enterprise, and Inspur, IDC said.

In the AI Storage market, Dell Technologies, NetApp and Hewlett-Packard Enterprise hold the top three positions, it added.

Setien values Puig's passing and ball-control skills, which remind some Barcelona fans of Xavi Hernandez and Andres Iniesta, and rewarded him with a bigger role during the final stretch of the Spanish league.

Fati, 17, made a huge splash this season by becoming the youngest player to score in the Spanish league and the Champions League, among other precocious scoring milestones.

With Lionel Messi and Luis Suarez set to start in attack, Fati could get picked over fellow forward Antoine Griezmann, who was cleared to play by team doctors Friday after having recovered from a right thigh injury last

Clement Lenglet was also cleared by team doctors and will likely play with Gerard Pique in the center of the defense with Samuel Umtiti still in-

With only 13 first-team players available, Šetien has called up seven members of Barcelona's youth squad, including American Konrad de la Fuente.

"It would have been better to have all our players available, but that is not the case," Setien said. "We are going to have to rely on many players from our youth team. We have to adapt and we will do our best not to miss the players who can't be with us.



## India to host 2021 edition, Aus in 2022

New Delhi, August 7: The International Cricket Council (ICC) has decided that India will host the 2021 edition of the T20 World Cup while the postponed 2020 edition will now be played in Australia in 2022. India is also set to host the 50-over World Cup in India in 2023.

The ICC had announced July 20 the postponement of the 2020 edition World T20 due to the coronavirus pandemic, but did not mention the venue for the 2021 edition and the 2022 edition. They had only said that the 2023 50-over World Cup will be played in October-November in India.

Speaking to this agency, an ICC board member had said that the reason why the ICC release hadn't mentioned the venue of the 2021 and 2022 T20 World Cup was because a decision was yet to be taken on whether India would be requested to hand the rights of hosting the next year's showpiece event to

New Delhi, August 7: India's white-ball series against England, scheduled at home in September-October, was Friday postponed to early 2021 with both the boards citing the COVID-19 pandemic, which wrecked the international calendar and created space for the IPL during this window.

Both teams were scheduled to

play three ODIs and as many T20s and the matches could now be held after the Test series between the two in India early next year.

The series was to be a preparatory one ahead of the T20 World Cup, which was originally scheduled from October 18 to November 5 in Australia, but has now been postponed due to the pandemic.

The T20 World Cup's postponement made way for the IPL, which has been scheduled from September 19 to November 10 in the UAE.

"BCCI and ECB are in consultation with a view to confirming the 2021 schedules for an all-formats England men's tour to India to run from late January to late March and for India's Test tour to England due in the summer of 2021," the BCCI said in a statement.

BCCI secretary Jay Shah added: The BCCI and ECB are working closely to finalise the day-wise

schedule as we move towards the resumption of cricket. The India-England series is one of the most anticipated contests in world cricket. The two teams compete hard on the field and provide some riveting moments.

The five-Test series to be hosted by India could be trimmed to four to accommodate the white-ball games next year.

"International cricket between India and England is a highlight of the cricketing calendar and we look forward to working with BCCI to firm-up the schedules for these eagerly anticipated tours as soon as possible," said ECB CEO Tom Harrison.

India have not played any international cricket since March when the team engaged in a home T20 series against South Africa, which also had to be postponed midway due to the pandemic.
