Shutdown norms relaxed for I-Day

Bhubaneswar: The state government Wednesday slightly modified its earlier order on weekend shutdowns in four districts and relaxed norms to allow people to unfurl the National Flag August 15. The fresh notification said that people can unfurl the National Flag in the four districts of Ganjam, Khurda, Gajapati and Cuttack and Rourkela city till 11 am on Independence Day. Earlier, the government had imposed weekend shutdowns.

Srinagar: Top Hizbul Mujahideen (HM) commander Azad Lalhari was killed Wednesday in an encounter with the security forces in Jammu and Kashmir's Pulwama district, police said.

"In the initial firing, two soldiers were injured. One of the injured succumbed to his injuries at the Army's Base Hospital in Srinagar," police said. Lalhari was killed in the joint operation by police, Army and the CRPF in Kamrazipora.

Bhubaneswar, August 12: Headed by Chief Minister Naveen Patnaik, the state cabinet Wednesday approved 20 proposals including 25 percent reservation of urban local bodies' (ULBs) annual budget for development of slums.

Addressing a presser here, Chief Secretary Asit Tripathy said, "As 25 percent of the urban population resides in slum areas, the Cabinet has decided to reserve a fixed amount of capital expenditure to ensure basic services in the slums. Accordingly, 25 per cent of budget of a ULB will be fixed for development works in slum areas."

To implement the decision, the Cabinet has decided to amend the Odisha Municipal Act, 1950 and the Odisha Municipal Corporation Act, 2003 through Ordinance route following approval of Governor, he said.

'Moreover, under 5T initiative, the trade license of commercial establishments in urban areas will be given in online mode. Provisional trade license will be given on the same day while the original license will be given after due verifications. The trade license will be given for five years instead of one,'

The Chief Secretary said the 15,200 hectares of Bijepur Block, 6400 hectares in Sohela Block & 3840 hectares in 19 villages of Barpali Block of Bargarh district along with 5 villages in Dunguripali Block of Subarnapur district will get irrigation facility. This will also improve the economic condition of the farmers, he added.

The construction work will be done through Engineering, Procurement & Construction (EPC) mode on turnkey basis with a project completion period of 30 months. There is a provision of installation of automated micro irrigation system in 30 percent command area of the project, he said.

The government has also decided to enhance the ambit of Nirmal scheme, which was launched in the year 2018-19 to provide better ambiance to the patients and attendants in public healthcare facilities. The government has estimated to spend Rs1998 crore under the scheme in a period of five years. As many as 43 new public healthcare facilities and seven tertiary health facilities have been covered under the Nirmal scheme.

The Cabinet also approved four packages of mega drinking water projects worth ₹800.27 crore. Abour 6.07 lakh population in 911 villages under Kalimela and Malkangiri Blocks of Malkangiri district, Boipariguda block of Koraput, Saraskana and GB Nagar Blocks of Mayurbhanj, Bhograi Block of Balasore, Kasinagar & Gumma Blocks of Gajapati and Mahanga Block of Cuttack district will be benefited from the project. The Cabinet has also decided to exempt stamp duty and registration fees on the document of government land to be executed in favour of displaced families at the resettlement colony at Mangalaghat in Puri

Pass rate 70.21 pc, boys outshine girls

Bhubaneswar, August 12: Results of the Std 12 CHSE exams for the Science stream were announced Wednesday and 70.21 per cent of the total 97,373 candidates were declared successful.

Sudeep Sudarshan Rana of Jupiter Science College topped the state with 574 marks secured out of 600 (95.6 %).

The pass percentage this time was lower than last year's 72 per cent, and School and Mass Education Minister S R Dash attributed it to strict measures taken such as installing CCTV cameras in examination halls.

However, there is a rise in the number of students passing in the first and second divisions, he said.

While 25,339 students have cleared the exam in the first

division, 24,121 passed in the second division and 18,268 in the third division, the minister said. Total 137 students have

secured marks above 90 per cent in the exams conducted by the Council of Higher Secondary Education (CHSE), Odisha. The minister said, stu-

dents can check their results on orissaresults.nic.in. Total 68,374 students

cleared the examinations. Of them, 38,301 were boys and 30,073 girls, he said.

Twenty schools recorded 100 per cent success rate. There were 15 schools from which no student could pass. I have asked the department's secretary to show cause these schools, Dash said.

Pandemic at its peak in Khurda: RMRC dir

Bhubaneswar, August 12: Officials engaged in testing and management of COVID-19 in the state opined that while new cases in Ganjam seem to be stabilising, Khurda is witnessing the peak of the pandemic.

'COVID cases in Ganjam are stabilising. Now, we are getting more cases from contact tracing and less from new infections. The positivity rate of infections in the district has declined, which is a good sign," Sanghamitra Pati, Director, Regional Medical Research Centre (RMRC) said.

The director said that her institution has also submitted the sero survey report of Berhampur in Ganjam to the state government and the results are likely to be shared with the media by next Monday.

The official said that the second round of sero survey would give a clearer picture. The Phase II survey would be done in Bhubaneswar in the third week of August. The second phase, is done four weeks after the first sample collections, she added.

The RMRC director also said that the testing in the state has increased. mainly due to rise in antigen testing. She also hinted that close to one lakh testing per day could be done through all the forms of testing.

disha's COVID-19 tally Wednesday crossed the 50,000mark with the highest single-day spike of 1,876 fresh cases, while the death toll rose to 305 as nine more patients succumbed to the disease, a health department official said. The total number of coronavirus cases in the state now stands at 50,672, he said. Of the nine new fatalities, four were reported from Ganjam, two from Rayagada and one each from Angul, Balasore and Khurda districts.

"When it comes to increase testing, majority of the tests will be done through antigen mode. Only symptomatic patients who test negative in antigen tests will be sent for RT-PCR testing. This is what the ICMR norm says," she said.





Don't scribble, prescribe in caps: HC to doctors

highest regard for the professionalism of doctors for their exemplary and untiring service during Covid-19 pandemic

New Delhi, August 12: The Orissa High Court has asked the doctors to write prescriptions in capital letters and observed that illegible scrawls composed by doctors create unnecessary nuisance for the patients, pharmacists, police, prosecutors and judges who are bound to deal with such medical reports.

A bench of Justice SK Panigrahi observed that prescriptions of physi**MAJOR OBSERVATIONS**

cians, OPD slips, post-mortem reports, injury reports among others are required to be legible and fully comprehensible. The High Court also asked the state Chief Secretary to take necessary action in this regard

"This court feels, it is imperative that the entire physician community need to go an extra mile and make conscious efforts to write prescriptions in good handwriting preferably in CAPITAL LETTERS. The digital era could also throw

scriptions and the diagnosis more patient friendly," the court said.

The High Court expressed highest regard for the professionalism of doctors for their exemplary and untiring service during COVID-19 pandemic at different levels.

The bench, however, said that illegible handwriting can delay treatment and lead to unnecessary tests and inappropriate doses which in turn can, at times, result in fatal consequences. "On many occasions, the pharmacists find it difficult to decipher what is written in the prescription. Sometimes, even some physicians fail to read their own nandwriting." the court said.

Significantly, the Medical Council of India had also issued a notification in 2016 suggesting that every physician should prescribe drugs with generic names and preferably in capital letters and he/she shall

scription and use of drugs.

It is to be mentioned here that the High Court was hearing an interim bail plea by a petitioner on the ground that his wife is suffering from severe gynaecological complexities along with cardio-vascular and haematological problems and that she is living alone. The appellant submitted that his presence is necessary for attending her.

The counsel for the petitioner also submitted the medical reports for the perusal of the court.

However, while verifying the medical documents, the court observed that "prescription by the doctor is pathetically poor legibility and is far beyond the comprehension of any common man or even for this Court which is dealing with the matter.'

The High Court granted interim bail to the petitioner.

Govt tells factories to take safety measures

Bhubaneswar, August 12: The state government, Wednesday, asked all factories in the state to provide details of inflammable and explosive materials used, handled and stored in their premises in a bid to prevent any major mishap in the wake of the massive explosion that rocked Lebanese capital Beirut.

The factories were also issued instructions to take all safety measures to prevent any untoward incident and furnish a report on the preparedness on their part to deal with any such emergency, an official said


In a letter to the factories, the Directorate of Factories and Boilers asked them to provide the list and quantity of inflammable and explosive materials used, handled and stocked in their premises.

The move is aimed at preventing any major tragedy like the one in a warehouse in Beirut August 4 that claimed several lives and left a large number of people injured,

the official said. While the factories are required to furnish details of flammable and explosive materials with them and the manner in which they are stored, the field-level officials have been asked to undertake site verification to ensure that proper safety protocols are being adhered to, he said.

The state government's move comes close on the heels of the Centre's direction to the ports to verify whether any hazardous substance is lying in warehouses.

More than 2,000 tonnes of ammonium nitrate stored in a ware-

house in the port at Beirut has been stated as the possible source of the blast that devastated

While steps have been taken to conduct safety audit in different fertiliser plants in the state as they use chemical substances, a close watch is also being maintained on the ports located at Paradip, Dhamra and Gopalpur as part of the precautionary measures being undertaken, the official said.

As part of the precautionary steps, field-level officials are carrying out safety audits in the two major fertilizer units - IFFCO and Paradip Phosphates Ltd (PPL) located in Jagatsinghpur district, he said, adding that similar survey is also being conducted regularly in other major plants such as the IOCLs Paradip refinery.

Covid norm violation may attract penalty up to ₹1L

Bhubaneswar, August 12: The State Cabinet Wednesday enhanced the penalty for violation of Epidemic Diseases Act, 1897 up to ₹1 lakh.

To ensure strict observance of guidelines for containing the spread of the disease and break human-tohuman transmission, it is necessary to enhance the penalty amount as provided in the Epidemic Diseases Act, said Chief Secretary Asit

In order to regulate the non-compliance of mask use, spitting at public places, violation of social distancing norms and other rules provided in the Odisha Covid-19 Regulations 2020, the fine has been enhanced upto ₹1 lakh, he said.

Now, under Section 3 of the Epidemic Diseases Act, a violator can get imprisonment for a term which may extend up to two years or with fine which may extend upto ₹1 lakh or both.

Since the Assembly is not in session, the Cabinet decided to bring necessary amendment to the Act through Ordinance route.

Concern over vanishing giants

Bhubaneswar: Unsustainable development mechanisms and exploding human population have been creating such an aghast scenario where the wildlife, especially terrestrial giants like elephants, are brought to the brink of their survival, said experts in a webinar on the occasion of the World Elephant Day organised jointly by the Save Elephant Foundation and the Orissa Environmental Society (OES) here, Wednesday. Secretary of OES Jayakrushna Panigrahi said, "Once in lakhs, the Asian elephants have reduced to mere 40,000-50,000 presently - about 27,000 in India; and the African elephants, once in millions, have now declined to nearly 4.15 lakh. Habitat degradation as a consequence of various developmental activities such as construction of highways and railways, mining, industrialization and settlement of human habitations are carrying out degradation of the forests.

prising dos and don'ts, few basic medicines and a list of telephone numbers of doctors, counsellors/ tele-medicine professionals and government officials among all persons staying under home isolation. It was decided at the meeting to launch an appealing and convincing IEC campaigns to prevent stigmatisation of the Covid positive persons in the community.

Naveen urged the public representatives and members of Panchayati Raj Institutions (PRI) to carry the message to the people against such stigmatisation.

In a span of three weeks, the state government has been able to establish five plasma therapy units from scratch.

Several ministers have been assigned responsibilities to motivate people on plasma donation. The concept of plasma donation must be popularised at all levels, he di-

To take up the fight against COVID-19 to the next level, the government has decided to substantially enhance the testing during the coming weeks.

"We have ramped up testing. We have one of the highest recovery rates and one of the lowest fatality

rates in the country. We are one of the few states in the country which is providing universal care for Covid patients at completely free of cost," he pointed out.

The Collectors were advised to lead the programme to conduct tests at sub-divisional hospitals and community health centres. BDOs and PRIs will play an active role in motivating people to voluntarily come forward for testing and further launch a campaign at local levels to de-stigmatise the Covid-19 positive

The CM directed the officials to give more emphasis to hotspot districts-Khurda, Cuttack, Jajpur and Sundargarh.

Odisha registers highest single-day spike of cases

Bhubaneswar, August 12: State's COVID-19 tally Wednesday crossed the 50,000-mark with the highest single-day spike of 1,876 fresh cases, while the death toll rose to 305 as nine more patients succumbed to the disease, an official of Health and Family Welfare (H&FW) depart-

The total number of coronavirus cases in Odisha now stands at 50,672, said the official.

Of the nine new fatalities, four

from Ravagada and one each from Angul, Balasore and Khurda districts. The new cases were found in all 30 districts of the state. Of them 1,182 were detected from quarantine centres, while 694 people tested positive for the disease during contact-tracing exercise, the official pointed out

The highest 297 new cases were reported in Khurda, followed by Ganjam (260), Sundargarh (119) and Cuttack (109).



Puri, August 12: The Shree Jagannath Temple Administration (SJTA) has landed in a fix as palm leaf boxes containing unsold Mahaprasad were found to have been dumped near the south gate

of the Srimandir here Wednesday. Suar-Mahasuar servitors usually sell the most sought after temple delicacy at Ananda Bazar, on the premises of the 12th century shrine. However, the shrine has remained out of the bounds for devotees since March 20 owing to the coronavirusinduced lockdowns in place to break spread of the viral infection. Subsequently, owing to a sudden slump in the demand, the delicacy which was already in store got spoiled and a few of the servitors reportedly threw it in open, said a

Sources added that dogs and bovine could be seen feeding on the Mahaprasad. This has riled many who blamed the temple authorities of having no control over the servitors.

"Why the shrine had prepared a huge quantity of the delicacy at a time when the temple has been shut for devotees? It could have been distributed amongst the needy.

Disrespect to Mahaprasad is no less than disrespect to the Lord. The temple administration should investigate into the issue. Let the culprit(s) get punishment," Shree Jagannath Bhakta Parishad chairperson Suryanarayan Rath said.

MILLET MISSION STRIKING ROOTS IN MALKANGIRI

Chitrakonda, August 12: The state government's Millet Mission aims at fulfilling the nutritional needs of women, expectant mothers and kids so as to fight problems arising out of malnutrition. This mission is successfully taking roots in Swabhiman Anchal (once the cut-off area of Chitrakonda reservoir) in Malkagiri, a report said.

The mission is vigorously being pushed by the women and child welfare department, the agriculture department and Wason organization in the current kharif

Under the special programme for its promotion in tribal areas, the crops have been revived. Now it is getting the much-needed attention across the state because of its high nutritional value.

In fact, the nutrient-rich millets were fast fading away from agricultural landscape in tribal pockets, but they are now making a comeback to the scene, thanks to the Millet Mission.

The scheme's objective was to increase millet production with marketing support and promote millet-based food processing.

For the last three years, a number of steps have been taken to promote cultivation of millets such as ragi, gurji and kosla (small millet), kodo, kangu (foxtail millet) and jowars, which are known as age-old traditional food of the hill dwellers.

Under the programme, improved technologies like line sowing and transplantation are adopted with less seed and root intensification. Farmers are encouraged to cultivate these crops by adopting these methods

Agriculture Minister Arun Sahu had inaugurated a Millet Mandi at Badapada last year so that farmers can get the marketing facility of their produce. The government expects that millet cultivation will

make the farmers financially independent.

In the current kharif season, millets are being cultivated at Chitrakonda, Doraguda, Nuaguda, Gunthawada, Tunnel Camp, Badapadar, Badapada panchyats. The government has also made input incentives available for farmers.

In fiscal 2019-20, the agriculture department had provided incentive of Rs 600 to Rs 2000 to 1575 millet farmers. These farmers had adopted line sowing and Sri Methods.

Scores of farmers at Doraguda, Badapadar, Badapada and Jantapai had made profits from millet cultivation by selling off 2674 quintals. Millets were sold for Rs 31 per kg.

In 2020-21, over 2500 farmers have cultivated millets in 952 hectares and suan in 304 hectares. For varieties of millet seeds, a nursery has been set up on a hectare of land at Arnabhatta. Farmers have the ad-

Some farmers said that separating husks from suan is a difficult thing. For that reason, the farmers have to sell their produce to traders at cheap price.

"The rice of suan has a good demand in the market. There is need for a processing unit to produce rice from suan," some farmers pointed out.

Farmers are also trained on how to prepare bio-compost, organic fertilizers, vermin-compost and natural pesticides. A step was also taken to preserve some varieties of seeds in the current season.

Millet meals are also being served as 'khichhdi' and 'upma' under the ICDS and MDM programmes in anganwadi centres and schools in some areas.

Various food items like halwa vada, dosa, pakoda, biscuits and cakes made from millets are being promoted among urbanites through different events.

"Steps were taken to provide machines to grind millets, produce rice from suan, and prepare biscuits, loaves, cakes and other food stuff from millet flour. This will strengthen the economic backbone of the farmers," said Kailash Chandra Panda, the executive officer of the Women and Child Welfare Committee.

Passenger trains on ... Haridaspur-Paradip rail line in the offing

Kendrapara, August 12: Passenger train services will soon start on the much awaited Haridaspur-Paradip railway line project. A decision to this effect was taken at a meeting at the Collectorate here, Tuesday.

The district administration will take steps with immediate effect to run passenger trains as a 'rail roko' protest was held recently during an experimental trial run of a goods train on the route demanding introduction of passenger train services.

In the first phase, the railway authorities will allow goods trains and after the security check and all other necessary arrangements, the authorities will introduce passenger train services.

"People speculate there will be no passenger train services on the railway line. But we will start the passenger train service after a successful trial of goods train service," Paradip Port Trust (PPT) Chairman Rinkesh Roy said.

"There were rumours about running of passenger trains with goods trains on Haridaspur-Paradip rail line. However, all speculations about this were put to rest by the PPT Chairman Rinkesh Roy in the presence of Kendrapara MP Anubhav Mohanty, Mahakalpada MLA Atanu Sabyasachi Nayak and District Collector Samarth Verma," stated Kendrapara MLA Sashibhusan Behera. Behera stated that railways would

come up with an official announcement on the running of passenger trains after arrangements like toilets and a proper railway station are constructed.

ing the running of passenger trains on the route was cleared by the company in the meeting," said Mahakalpada MLA.

Union Minister Dharmendra Pradhan July 29 had urged Railway Minister Piyush Goyal for introduction of passenger train services on Haridaspur-Paradip rail line at the earliest.

Notably, Paradip-Haridaspur railway line project was sanctioned in 1996 and its foundation stone was laid by Union railway minister Nitish Kumar in 1999. However, the completion of the project was delayed by almost two decades.

The railway project is being executed through a special purpose vehicle in which the state government, ministry of shipping and Indian Railways have equal share. The project took an extremely long time for commissioning but with continuous monitoring, it has finally come to the final stage. The 82-km line connected Kendrapara district to the railway map of the country for the first time.

The project will cover Haridaspur to Paradip including Jajpur, Kendrapara and Jagatsinghpur districts. In November last year, the state government had directed officials concerned to complete the project within the extended deadline of March, 2020. However, train services are yet to be flagged off.

Angul heritage museum yet to see the light of day

Angul, August 12: Fifteen years ago. the state government had proposed museums in all districts. Ten years have passed since the construction work of a museum in Angul district headquarters started. But the proposed museum is yet to see the light

Angul was separated from undivided Dhenkanal district in 1993. At that time, the museum of Talcher royal palace housed a huge collection of rare articles. In the year 1995-96, the then Collector PK Nayak evinced interest to set up a museum where these rare articles treasured in the royal museum can be on display for common people.

After holding a few rounds of discussions, he on behalf of the district administration gave a proposal to the state government for setting up a museum in the district.

The state government at that point did not accept the proposal, citing the shortage of funds as a reason.

Since a museum helps students develop their knowledge base and aid researchers, the government in 2005 decided to set up a museum in all districts. The cruelty of animal hoarding

have known Merritt Clifton for many years now. He, his wife Beth, and son Wolf are completely devoted to animals, and run an e-magazine called ANIMALS 24-7 which you should all read. One of their board members, Vicky Crosetti who died recently, was a nationally recognised expert in the phenomenon of hoarding. She had written an article on how to deal with this and I will quote liberally from her experience, because we have to deal with this on a regular basis and each case breaks my heart.

People who claim to love animals often mistreat them terribly. Not just the people who keep a single pet and lock him/her up the whole day at the gate, but the people who 'rescue' animals from the street and take them back to their 'shelters'/homes.

I start getting irate messages from neighbours, of people like this, who complain about filth and noise. When I send an investigation team, we find dozens of animals crowded into a small filthy space, all tied up, some in cages, many dead, and the others close to death. This is typical of 'good intentions gone bad' and it signifies 'obsessive-compul-

people but of entire so-called 'shelters'. It breaks my heart when I see a shelter, which I have created or contributed to, whose caretakers I have believed in, show a completely different picture when I finally have it inspected. It turns out to be a crowded holding centre for hundreds of ill, diseased and wounded dogs. No medicine, no staff, no cleanliness and probably very little food. In the last 10 years, I have found at least five like this, the last one being a hellhole run by two sisters in Ghaziabad. I am not including 'gaushalas' which are more or less all terrible -- just hundreds of sick and dying cows kept for religious reasons and left to die un-

sive' behaviour. This is not just true of single

attended and unfed. Last year, the two sisters were evicted from their flat in the middle of the night. The flat was full of garbage, old newspapers, cigarette butts, used sanitary napkins, and cats on the verge of death. The stench was unbearable. I helped them by organising lawyers, but they drove them crazy. It was clear that they both needed hospitalisation. Now I have a situation in Navi Mumbai where an elderly woman runs a 'shelter' which has huge mortality, because it is literally a hellhole. Any attempt to stop her results in threats to commit suicide. slit wrists, begging on Facebook and promises to do better. But she has killed hundreds of animals. Each drama on the Net brings her in more money and public acclaim. I am the bad guy here.

Last month. I was sent a mail by someone who has a house near Kolkata. She wrote that she was an animal 'rescuer' and had run out

of money. I called immediately. She had 60 cats and 50 dogs taken from the street – one house. Not one had been sterilised and most of them were pregnant. I asked People for Animals, Kolkata to sterilise the animals immediately, and a very kind person in Kolkata offered money for the operations. One month later when I called, I learned that most of the cats had died from a feline virus because she wouldn't spend money on a vaccine. She became abusive when I told her to get the remaining vaccinated. There is no doubt that she is a typical hoarder.

We need to deal with these cases as one would deal with a normal cruelty case: have the person or perpetrator arrested for deliberate cruelty, and the animals taken away, treated and re-homed if possible. We need to make sure that this person is never going to control the fate of animals again. This is what Crosetti says: "Animal hoarding cases are cruelty cases. Whether one animal or 100 suffer, there is no valid excuse for it; original intentions are irrelevant; and legally extenuating circumstances, such as mental illness or personal crisis, are matters to address in the courtroom, often as obstacles

to effecting the best outcome for the animals. Hoarders profess to love their animals. Their love, however, tends to be

thinly veiled obsessive possessiveness. They use the word 'mine' a lot and see the animals as property, probably the only property they have. They do not want to part with their animals under any circumstance, even death.

I have seen this in three of my PFA units which, unfortunately, continue to keep the name but have nothing to do with us: one of the women managers is a widow, the other unmarried, the third is run by an unmarried, failed homoeopath. They do a dreadful job; and the shelters, which I built for them, are in shambles and the animals suffer hugely. But they will not give them up to a better team, will allow no volunteer in, are rude to everyone. cry easily, tell a lot of lies and fight like cornered rats if even one of the animals is sought to be adopted.

They will not sterilise the animals. In one of these shelters, two rescued rabbits had been put into a cage, and when I inspected it, there were over a hundred, of which many had literally been squashed to death. When I put my foot down, they took out ads accusing me of undue interference, and literally absconded with the shelters which are now simply hoarding centres for animals who are not fed or treated. I wish I could have them arrested for causing such mass misery under the guise of animal welfare. These three need to go to jail - but the police don't seem to take cruelty seriously.

In every case, I have attempted soft interventions offering money for volunteers and staff, offering to take the animals or get a doctor to treat them. No deal. "Hoarders are addicts. Like any addicts, they will do and say anything to satisfy the demands of their habit.'

'Hoarders who are reclusive eccentrics elicit sympathy. Those who manage an articulate, well-dressed facade seem to make a credible case that they are misunderstood and mistreated."

Hoarders believe that life, endured in any amount of misery, is preferable to death. But they never get rid of the dead either. In so many of these cases, I have seen long dead animals lying all over their premises.

Hoarders are also very secretive. They never make friends. Hoarding sites tend to be both unimaginably filthy and in dangerous disrepair. They slide in and out of their residences and only the smell gives them away. From experience I know what Crosetti says: "Hoarders often are almost frightening in their ability to one moment appear tearful, pleading, and pathetic, yet the next moment rage out of control, screaming obscenities. They can also become real physical threats," which is why we need a team when we

A specific protocol is needed: capture nets, drugs, safety gear, and carriers in the ambulance and a police backup. Get in touch with good shelters beforehand so that animals can immediately be put there if you have a housing problem. Videotape the operation. Each rescued animal needs a complete veterinary examination and, if necessary, have a media person present. Public outrage over animals being treated cruelly can move the police to act faster. How judges sentence offenders is often influenced by their per-

ception of public concern. Everyone should know what a good shelter is: it is a safe haven where animal are treated kindly. "Animals do not starve in a shelter, do not kill each other in fights, do not live in filth, do not suffer from untreated disease and injury, and they do not breed."

Whether the shelter is big or small, whether it is run by an organisation or one person, whether it is on institutional land or in a person's home, these

LEBANESE DESERVE BETTER

aram Lubnan, poor Lebanon. As if hosting more than a million refugees from the Syrian war next door, an economy in freefall, and Covid-19 weren't enough. now the catastrophic destruction of the port of Beirut has left more than 150 dead, over 6,000 injured, and some 300,000 – 5 per cent of the population - homeless. What can end this tale of woe for a country whose capital once saw itself as the Paris of the Middle East?

Sadly, that image is long gone, destroyed by the 1975-90 civil war, corruption, and regional turmoil. The hapless government called a state of emergency in the wake of the port blast, only to be confronted by demonstrators chanting the slogan that almost a decade ago sparked the Arab Spring: al-sha'b yurid isqat al-nizam — "The people want the overthrow of the

Although the government has now resigned, popular fury is set to grow: on August 18, the Special Tribunal for Lebanon in the Hague will issue its verdict on the 2005 assassination of Prime Minister Rafic Hariri. Four members of Hezbollah, the Shia militia and political party backed by Iran and Syria, have been tried in absentia for the bombing of Hariri's motorcade. The verdict had been set for August 7, but was postponed 'out of respect for the countless victims of the devastating explosion' in Beirut three days earlier.

Whatever the Special Tribunal's verdict, political tensions will rise. Hezbollah, classified as a terrorist organisation by the US and the European Union, enjoys widespread Shia support. Its militia is more powerful than the Lebanese army, and it has a powerful bloc in parliament. Just as the presence of Palestinian guerrillas and their 'state within a state' was a factor in the civil war, so Hezbollah's 'state above the state' will provoke still more calls - by Lebanese and outsiders alike - to end a system in which political and economic power is allocated not by merit but by religious sect

But is that what 'the people,' with their banners calling for

thawra (revolution) really want? Lebanon, carved out of the Middle East a century ago by the Sykes-Picot accord between Britain and France is a mosaic of Christians, Muslims, Druze, and others (some 18 sects are officially recognised). In 1943, when France ended its League of Nations mandate, independent Lebanon's political leaders declared an unwritten National Pact under which the president would be a Maronite Christian, the prime minister a Sunni Muslim, and the speaker of parliament a Shia Muslim.

As Riad al-Solh, the first prime minister put it, the aim was to 'Lebanonize Lebanese Muslims and to Arabize Lebanon's Christians.' The Christians were to distance themselves from the West, and the Muslims were to abandon the idea of Lebanon as part of a larger Arab nation.

The original premise was that Christians and Muslims were more or less equal in number. But the last census in Lebanon was conducted in 1932, and it is clear that Christians have become a minority in the decades since. With a lower birth rate and a higher

 $propensity \,to\,emigrate\,(thousands$ fled during the civil war), Christians now comprise just a third of Lebanon's citizens.

But why adjust the system to reflect demographic reality if the result would be another bout of sectarian warfare? The Taif agreement that led to the end of 15 years of civil war only tinkered at the edges, giving Muslims parity with Christians in parliament and enhancing the power of the prime minister

Lebanon's demonstrators have long demanded an end to confessional power-sharing and an end to meddling by a host of foreign powers, from America and Israel to Syria and Iran. Their one success was that domestic and international revulsion at the murder of Hariri forced Syria to withdraw its troops in 2005, 29 years after they began 'safeguarding' Lebanon.

The paradox is that the system the protesters decry has given them a degree of personal liberty and freedom of speech that is all too rare in the Arab world. Moreover, when jobs depend on patronage, ending the system might bring personal loss. In an experiment by a Lebanese think tank, 70 per cent of interviewees agreed to sign a petition calling for an end to the system, but the figure dropped to 50 per cent when participants were told that their names would be made public.

Lebanon has always been a fragile construction. When I lived in Beirut in the 1970s, the city was indeed the cosmopolitan 'Paris of the Middle East,' until the civil war, abetted by outside powers, fragmented it into heavily armed neighbourhoods in which the religion listed on one's ID card could mean life or death. Given the so phistication and entrepreneurial energy of the Lebanese, it is conceivable that ending the confessional system would turn fragility into strength. But I doubt it.

In other Arab countries, reli gious minorities have relied on dictators to protect them - and, as in Iraq and Syria, have suffered as soon as national unity is threatened. Would those Maronites who claim a Phoenician rather than Arab identity happily accept majority rule by Muslim Lebanese? Would the Shia accept Lebanon's Sunnis, now bolstered by Sunni refugees from Syria, as overlords?

The real challenge is to enforce accountability. It is shameful that the warlords of the 1970s and 1980s have become not statesmen but mafiosi in charge of protection rackets (power cuts, for example provide easy money for suppliers of diesel generators). It is shameful that selfish bankers and official reluctance to guarantee urgent economic and financial reform have stalled negotiations with the

International Monetary Fund. The Lebanese deserve better. In the wake of the disaster in Beirut, the open question of how they will achieve it has become more difficult than ever to answer.

sions and debates, has undergone a change in India. As is evident, there is a new trend of launching policies and programmes in a hurry without ensuring their effectiveness. The need for infrastructure development has been high. The struggle of Indian villages has fundamentally not changed. The most affected are the denselypopulated northern as well as eastern states. Backwardness is manifest in many of these districts.

For example take the Sansad Adarsh Gram Yojana (SAGY), launched six years ago aimed at developing model villages. Reports indicate the programme has been found to be ineffective in ushering in development in chosen gram panchayats with a central performance audit urging the Union Rural Development Ministry to review the scheme. The Common Review Mission (CRM) 2019 of the Ministry pointed out: "The CRM teams that visited the states neither did, nor found any significant impact of this scheme, in many of the SAGY villages.

It was found that MPs did not give any significant amount of money from the MPLADS. In isolated cases, where MPs have been proac-

over the years, via discusment has taken place. Though SAGY scheme has no budgetary allotment, each MP is expected to select a village in his constituency for development. The goal being to develop three model villages by each MP by March 2019 and five more by 2024, so far very few MPs were seen to be adopting villages under SAGY

The CRM has also expressed concern over the quality of roads constructed under schemes of state governments and maintenance of rural roads under Centre's Pradhan Mantri Gramin Sadak Yojana after the end of five-year warranty period. It is significant that the audit urged the Centre to frame a 'National Rural Roads Policy' to ensure uniform norms of construction and maintenance, irrespective of whether the road belongs to a state scheme or the PMGSY. The administrative machinery is generally indifferent.

Another example which the Central audit found even more intriguing is the work generated under MGNREGS. It remains half of the entitled 100 days per household annually despite a higher demand in states, urging the Centre to order a study in the mismatch. As per the CRM 2019, work given than the demand. In 2019, the average work per household was 48 days. It was a bit higher at 50 in 2018 but lower at 45 in 2017. Though from recent reports it is quite discernible that in the current fiscal this will not happen, there is need for giving additional resources of around 15 to 20 per cent as most migrants don't want to venture out of their states and are facing acute financial crisis.

The examples are proof enough that the government's crucial programmes aren't being properly monitored and are not reaching the intended beneficiaries. The other is the lack of direction and judicious planning. The ineffectiveness of the private sector, which plays a less pivotal role, is equally manifest.

Recently, the Adani Green Energy, the renewable energy arm of Adani Group, bagged the world's largest solar energy contract to build an 8000 MW capacity photovoltaic power plant and also set up 2000 MW capacity domestic solar panel manufacturing facility. But questions do arise as the group is reported to be facing massive debt burden.

Kashmiris who give up arms

New Delhi/ Srinagar, August 12: India is considering offering young Kashmiri militants an escape from a life of violence by temporarily resettling them in more peaceful parts of the country, according to the top military commander in the Kashmir Valley.

Lieutenant General BS Raju revealed the plan for a new scheme to offer a way out of militancy during a telephone interview from his headquarters in Srinagar.

He told Reuters recommendations had been submitted to Prime Minister Narendra Modi's government and that the plan, while not finalised, was in an advanced stage.

"These are young boys who need to be taken care of for a period of time," Raju said, adding that could involve temporarily settling them outside of the Muslim-majority Kashmir.

Past efforts to persuade militants to put down their guns have had mixed success. But Raju said the military had recommended the scheme take a longer-term approach to rehabilitating ex-militants.

"The bottom-line is that it will have a structure that will help and give confidence to the people who are opting to surrender," Raju said.

More than 50,000 people have died during more than three decades of an insurgency that New Delhi accuses neighbouring Pakistan of fuelling, by using militant groups to wage a proxy-war across the disputed border dividing the Himalayan region

India has flooded the Valley with security forces - about 200,000 military and paramilitary troops are deployed there. And Raju said militant attacks have dropped by nearly 40 per cent compared to last year.

Srinagar, August 12: It has been an unusually hot summer in Kashmir this year with temperatures crossing 35-degree Celsius on some days.

While people in Kashmir are trying to cope with the dry spell, a rainfall deficit coupled with ris-

ing temperature is Due to less rainfall, bad news for the farmers.

There seems no respite for now as the forecast shows similar weather conditions prevailing over the next few days.

"I have never seen Srinagar so hot. This has really caused a lot of discomfort to the people particularly farmers whose

paddy crops have been affected," said a resident. The MET department said that

lack of rainfall has created hot and humid conditions in Kashmir.

"There has been a major deficit in rainfall in the last two months," Sonam Lotus, Director, J&K MET department, told IANS.

"Due to less rainfall, agriculture has suffered, the water resources are not getting replenished. The temperature in Srinagar is more compared to last ten years," he added. The official said that not much rainfall is expected over the next few days in Kashmir.

According to a recent study, Jammu, Kashmir and Ladakh may witness a temperature increase of up to 6.9 degrees Celsius by the end of the century due to climate change. The study warns that the glaciers in this Himalayan region

could shrink by 85 per cent if the pro-

jections come true. The study, published in the journal Climatic Change July 29, predicted the impact of future climate change in the Jammu, Kashmir and Ladakh Himalaya, by the end of the twentyfirst century using

an ensemble of 11 models under three greenhouse gas emission sce-

It also highlights the changes in the distribution of the prevalent climate zones in the region. "The study has been carried over the entire region of Jammu and Kashmir, including Jammu, Kashmir, Ladakh, Gilgit-Baltistan, Aksai Chin and other regions across the Line of Control (LoC)," noted Professor Shakil Ahmad Romshoo, Dean of Research at the University of Kashmir.

Raj mounts campaign to stop child trafficking

Authorities are concerned about a rise in child labour as coronavirus restrictions are eased and work restarts

New Delhi, August 12: Rajasthan is mounting a major campaign to stop children being trafficked across its borders after three child victims who were rescued from factories died from malnutrition.

Extra checkpoints are being set up to stop traffickers and authorities have told police to conduct monthly drives against child labour, according to an order from the Rajasthan government.

The state is known for its handicraft industry and authorities are concerned about a rise in child labour as coronavirus re-

strictions are eased and work restarts. "We have been continuously rescuing children in the last few weeks and unfortunately three of them died because of malnourishment," said a police officer who asked not to



be named as he is not authorised to speak to the media.

"The factory owner would tell people the child workers were family, but was obviously not feeding them or treating them properly during the lockdown. Two owners have been

arrested but there are more, who just see children as cheap labour.' It is illegal to employ anyone under 15 in India, but children are permitted to support

family businesses outside of school hours. This provision is widely exploited by employers and human traffickers, child rights campaigners say, with thousands of children born into poverty being trafficked to work as slaves in factories and farms.

Police and transport officials have been told to verify the movement of every child to prevent the trafficking of child workers from poor states such as Bihar in eastern India.

The drive will last through August, said Ravi Prakash Meharda, the police officer in charge of civil rights and anti-trafficking in

The southern state of Tamil Nadu has taken similar measures after more than 100 adolescents were rescued from a spinning mill following a tip-off to staff at Childline, a tollfree helpline for children.

Child welfare committee officials said conditions at the mill "were not proper and they were not properly paid". Tamil Nadu's highest court said last week

that child labour was "rampant" in the state, calling the spinning mill case "only the tip of the iceberg". It directed police, labour and child welfare officials to be vigilant and conduct frequent raids. India has launched multiple campaigns to

check child labour in recent years, cracking down on factories where children are hired to make bangles and shoes or sew on About 175,000 children in India have been

removed or rescued from work and given support since 2016, government data shows. The campaigns have not been totally suc-

cessful and the problem continues because there is demand and there is impunity for violators," said Suresh Kumar, executive director of the Bihar-based child protection charity Centre DIRECT.

"In one of the recent Rajasthan deaths, the child's family in Bihar could not even afford to bring the body back and requested that he be cremated there only. The state didn't step up either to send the body home. It tells



Ahmedabad, August 12: The administrator of the private hospital here where eight COVID-19 patients died in a fire last week was arrested Wednesday on the charge of `causing death by negligence', a police official said.

Bharat Mahant (57), main administrator of Shrey Hospital, was arrested by officials of Navrangpura police station after he underwent medical test and tested negative for coronavirus,

Mahant, who was at the helm of affairs at the hospital since 1998, will be produced in the court on Thursday, said Assistant Commissioner of Police M A Patel A fire broke out on the fourth floor ICU ward of the hospital, which had been authorized to treat coronavirus patients, in the wee hours of August 6. Eight patients died.

On August 10, a First Information Report under IPC section 304 (A) (causing death by negligent or rash act) was registered against Mahant. The FIR said that while the cause of fire was a short circuit, the patients died due to "lack of ventilation" in the ICU as its four windows had been fixed shut with screws and did

There had been no fire safety audit of the hospital prior to the incident, nor was there any fire alarm system, it said. Though there were fire extinguishers in the ward, they were not used because the staff had not been given training in fire-fighting, the

This was followed by a landing at one of the most treacherous helipads in the region. The Light Combat Helicopters successfully

demonstrated its quick deploytions in extreme temperatures.

Light Combat Helicopters is a potent weapon platform because of its state-of-the-art systems and highly accurate weapons that are capable of hitting any type of target by day or night.

The other features of Light Combat Helicopters include its ability to operate in the complete 'Area of Responsibility' (AOR) and altitudes

Delhi cops pull the strings on Chinese manjha

New Delhi, August 12: As part of tradition, Delhi skies are studded with kites of various shapes and sizes just as Independence Day approaches

Flying kites has become a symbol of freedom, with both the young and the old taking part in kite-flying competitions either on their rooftops or empty grounds. Young kids rushing to kite shops to buy kites and charkhis is a common sight.

However it is not entirely a happy picture. Some of the strings used for these kite-flying competitions are coated with glass and metal. These are popularly known as the 'Chinese manjha' in the market. The string

can prove fatal if it strikes around the neck. In recent years many people including children have lost their lives because of its use, prompting the government to ban it in 2017 in Delhi. The National Green Tribunal ordered a total ban on maniha made of nylon or any other synthetic material in 2017 as well.

As Independence Day nears, the use of drones and paragliders has already been banned by the Delhi police. Now, the police is keeping a constant vigil on the sale of glasscoated manjha in the market.

"Using kite thread made out of plastic, nylon or similar synthetic materials popularly known as 'Chinese manjha' or any other thread coated with glass or metallic powder causes injury to hu-



mans and birds which at times proves fatal. Such deaths and incidents have been seen in the past few years," said a senior police of-

ficer. Several police stations in Delhi have been asked to escalate vigil in their areas around kite shops and see if rules are being

flouted and the banned maniha is either being secretly sold or purchased.

'Any person found selling the metallic powder or nylon or plastic manjhas would be booked under section 188 of the Indian penal code." said the officer. Surprise raids are also being conducted at various shops in different parts of the city. Most of the manjha supplies in Delhi come from Bareilly, Meerut and even Noida.

While many people including children have fallen victim to the deadly manjha, the police find to difficult to identify the accused as the kite-flyer cannot be traced through CCTV. Also tracing the string to its source is difficult considering several kites fly in the sky.

COVID FIGHT ₹6,000 crore

New Delhi, August 12: In an attempt to assist states effectively address the situation arising out of the Covid-19 pandemic, the Centre Wednesday released the fifth instalment of their share of revenue deficit grant, amounting to over Rs 6.000 crore.

The grant had been released for 14 states - Andhra Pradesh, Kerala, Himachal Pradesh, West Bengal, Uttarakhand, Tamil Nadu, Punjab, and all northeastern states

Of the 14 states, the maximum grant-in-aid in August has gone to Kerala, which has got Rs 1,277 crore followed by Himachal Pradesh with a revenue deficit grant of Rs 953 crore


excluding Arunachal Pradesh.

"The government on August 11, 2020 released Rs 6,195.08 crore to 14 states as the fifth equated monthly instalment of the Post Devolution Revenue Deficit Grant as recommended by the 15th Finance Commission. This would provide them additional resources during the Corona crisis," Finance Minister Nirmala Sitharaman's office said in a tweet.

The money has been released ahead of schedule and as a special dispensation to meet immediate funding needs of the state governments looking to restore economic activity and minimise losses to its citizens due to disruptions caused by lockdowns.



New Delhi, August 12: The Delhi High Court has allowed termination of a 22-week pregnancy of a minor rape victim following the report of a medical board, set up by Ram Manohar Lohia (RML) Hospital, that its continuation would result in psychological complications.

The high court clarified however that this will be subject to reports of further blood tests, required to assess if there is any additional risk to the girl. The pregnancy termination procedure would be carried out only if the parameters of the girl do not indicate any added risk, it said.

'This court considers it apposite to allow the present petition and direct that the petitioner (girl) be admitted to Dr Ram Manohar Lohia Hospital and the necessary procedures be carried out for termination of the pregnancy," Justice Vibhu Bakhru said. Section 3 of the Medical Termination of Pregnancy Act does not permit the procedure if the gestation period is more than 20 weeks.

The court passed the order on a plea by the 16-year-old girl, who was a victim of rape and in advanced stage of pregnancy which could not be terminated by the concerned doctors. The girl approached the high

court seeking direction to the Delhi government and a hospital here to terminate her pregnancy.

video conferencing and noted that the minor was under considerable distress and her father too was insistent that the pregnancy be terminated. The court said the risks of terminating the pregnancy have been explained to the girl and her

While hearing the matter, the court had directed the Medical Superintendent of RML Hospital to constitute a medical board to examine the girl and report whether termination of pregnancy involves risk to her and to also evaluate the risk of continuing with the foetus.

The doctors, who joined the vir tual hearing, told the court that the girl was in considerable distress and the clinical psychologist had also reported that continuation of pregnancy would result in psychological complications.

The report of the medical board indicated that the pregnancy was of 22 gestational weeks. "In view of the report and psychological assessment of the petitioner (girl), it does appear that she is at considerable risk of psychological complications if the pregnancy is continued. The concerned doctors have explained that there may be some risks in terminating the pregnancy but the same are not higher than what is acceptable and expected at this stage," the court said.

It also recorded its appreciation for the concerned doctors of RML Hospital for promptly constituting the medical board and exam-

Kolkata, August 12: A 60-yearold woman suffering from COVID-19 died in an ambulance outside a city private hospital as she was allegedly made to wait by its authorities, who reportedly demanded that Rs 3 lakh be first paid for admission, her family members said Wednesday.

The hospital authorities have refuted the charge and said that the woman's family was given an estimate for treatment but not pressurised for making payments. The woman hails from Tamluk in East Midnapore district and the alleged incident took place on Monday night after she was brought to the hospital from a nursing home in the city after she tested positive and reported severe health problems, a Kolkata Police official said.

Her son Nazeem Khan has lodged a police complaint against the hospital at Anandapur police station, the official said. The alleged incident took place a day after the West Bengal Clinical Establishment Commission allowed hospitals to charge patient parties for admission an advance of no more than Rs 50,000 or 20 per cent of the estimated treatment cost, whichever was lower but not refuse admission or treatment if the payment was not made immediately.

"The hospital authorities asked us to deposit Rs 3 lakh. We managed to pay Rs 80.000 and requested them to start my mother's treatment assuring them to get the remaining amount in the the meantime. But the hospital told us that treatment will not be started un-

less the full payment was made," Khan said.

Later, Rs 2 lakh more was transferred to a bank account of the hospital by the woman's elder son Latif Khan from Abu Dhabi, he said. "But by then my mother had passed away in the ambulance ... We repeatedly requested the hospital to send a doctor to her, but its authorities insisted that unless they see a proof that the money was transferred to them, nobody from it would attend to my mother," he

"If they (hospital authorities) had attended to my mother on time, she could have been saved," a sobbing Khan said. Refuting the charge, a senior official of the hospital said, the patient was brought in a very serious condition.

Kamala Harris may prove an elusive target for Trump


Washington, August 12: Joe Biden's selection of Senator Kamala Harris as his running mate provides a brand-new target for President Donald Trump's re-election campaign that has struggled to find an effective line of attack against his Democratic rival. But going after Harris comes with its own risks and challenges.

Within minutes of Biden's announcement Tuesday, Trump had called Harris "nasty," "horrible" and "disrespectful," while his campaign painted her as an extremist who would yank the moderate Biden to the left.

Trump again said that some men may feel "insulted" by Biden's committment to choose a woman as his vice presidential candidate. But there is little evidence at the moment that suggests that the public views Harris, a former California prosecutor and attorney general with strong ties to the Democratic establishment, as a radical.

In fact, she's more liked by Republicans than Biden, according to a Reuters/Ipsos poll conducted August 10-11, just before she was announced as Biden's pick. The poll showed 21% of registered Republican voters have a favorable impression of Harris, compared with 13% who had a similarly favorable view of Biden.

Already, leading Democratic women warned against a replay of Trump's match-up in 2016 with then Democratic presidential nominee Hillary Clinton, who was subject to gender-based critiques as

During her presidential bid, Harris was fiercely criticized by progressives who viewed her prosecutorial record as overly supportive of law enforcement. She has since become a vocal supporter of progressive criminal justice reforms.

Colombo, August 12: Twenty-six new ministers were sworn into Sri Lanka's new Cabinet Wednesday after the country recently held a Parliamentary election which saw the Sri Lanka Podujana Peramuna (SLPP) led by Prime Minister Mahinda Rajapaksa winning a landslide victory, securing a twothirds majority in Parliament.

Along with the Cabinet ministers 39 state ministers were also sworn in. President Gotabaya Rajapaksa retained the Defence Ministry. Prime Minister Mahinda Rajapaksa was appointed as the Minister of Finance, Urban Development, Housing, Buddhist Affairs, Religious and Cultural Affairs.

Dinesh Gunawardena was sworn in as Minister of Foreign Affairs. Prasanna Ranatunga was sworn in as Minister of Tourism and Keheliya Rambukwella was sworn in as Minister of Mass Media.

Some of the notable state ministers sworn in were Chamal Rajapaksa who took oaths as State Minister of Internal Security, Home Affairs and Disaster Management. and Shehan Semasinghe who was sworn in as State Minister of Samurdhi (prosperity), Micro Finance, Self-Employment and Business Development.

Sri Lanka held its Parliamentary election on August 5 under strict health guidelines amid Covid-19 pandemic which has infected over 2,800 people in the island country so far. The election was held to elect a new 225-member Parliament.

SLPP won a landslide victory by securing 145 seats, while the United People's Power, led by former presidential candidate Sajith Premadasa polled in as runnerup by securing 54 seats. Sri Lanka's new Parliament will convene on August 20.

Medics to get vaccine in two weeks: Russia

Moscow, August 12: Russia said Wednesday the first batch of its Covid-19 vaccine would be ready for some medics within two weeks and rejected as "groundless" safety concerns aired by some experts over Moscow's rapid approval of the drug.

President Vladimir Putin said Tuesday that Russia had become the first country to grant regulatory approval to a COVID-19 vaccine, after less than two months of human testing. The vaccine has not yet completed its final trials. Only about 10% of clinical trials are successful and some scientists fear Moscow may be putting national prestige before safety.

"It seems our foreign colleagues are sensing the specific competitive advantages of the Russian drug and are trying to express opinions that in our opinion are completely groundless," Health Minister Mikhail Murashko said Wednesday

He said the vaccine developed by Moscow's Gamaleya Institute would be administered to people, including doctors, on a voluntary basis, and would be ready soon.

"The first packages of the medical vaccine against the coronavirus infection will be received within the next two weeks, primarily for doctors," he said.

Alexander Gintsburg, director of the Gamaleya Institute, said clinical trials would be published once they have been assessed by Russia's own experts.

He said Russia plans to be able to produce 5 million doses a month by December-January.

Kazakhstan plans to send government officials to Moscow later this month to discuss possible deliveries of the vaccine, its presidential office said.

OUTCRY IN SOMALIA OVER 'CHILD MARRIAGE' BILL

Johannesburg, August 12: An outcry is rising in Somalia as parliament considers a bill that would allow child marriage once a girl's sexual organs mature and would allow forced marriage as long as the family gives their consent

The new Sexual Intercourse Related Crimes Bill "would represent a major setback in the fight against sexual violence in Somalia and across the globe" and should be withdrawn immediately, the United Nations special representative on sexual violence in conflict. Pramila Patten, said in a statement Tuesday. The bill also



weakens protections for victims of sexual violence, she said Already more than 45 per cent of young women in Somalia were married or "in union" before age 18, according to a United Nations analysis in 2014-15.

Somalia in 2013 agreed with the UN to improve its sexual violence laws, and after five years of

work a sexual offenses bill was approved by the Council of Ministers and sent to parliament. But last year the speaker of the House of the People sent the bill back "in a process that may have deviated from established law asking for "substantive amendments," the UN special representative said.

The new bill "risks legitimising child marriage, among other alarming practices, and must be prevented from passing into law," UN human rights chief Michelle Bachelet said this week, warning that it's passage would "send a worrying signal to other states in the region.'

That amounted to 97% compliance with the pledges, according to a Reuters calculation - lower than June's figure of well above 100%.

Tax authorities raid **Chinese entities for** money laundering



New Delhi, August 12: Indian tax authorities raided the premises of a few Chinese entities and their associates for money laundering, according to an official statement late Tuesday, adding to New Delhi's growing discomfort with Beijing

after a border clash in June. Since the clash, Prime Minister Narendra Modi's government has taken steps such as banning some Chinese mobile-phone apps, and tightening the requirements for Chinese investment and participation in government tenders.

The statement provided no details on the timing of the raids or on the kind of 'entities' mentioned.

Chinese individuals, their allies and a couple of bank employees were involved in money laundering through a series of shell companies, the statement said.

'Search action revealed that at the behest of Chinese individuals, more than 40 bank accounts were created in various dummy entities. entering into credits of more than ₹10 billion (\$134.03 million) over the period," the statement said.

During the raid, the authorities found evidence of transactions involving Hong Kong and US dollars.

UK PLUNGES INTO DEEP RECESSION

London, August 12: The UK economy plunged into a deep recession as it shrank 20.4% between April and June at the height of the coronavirus lockdown, according to new figures released Wednesday. **Thousands**


Leipzig test awaits Atletico SEVILLA, SHAKHTAR IN SEMIS

Diego Simeone's men have made a habit of upsetting the odds on the continent and, after a couple of defeats in the final over the past six years, this may just be their season.

The draw has been kind to Los Rojiblancos, putting them up against quarterfinal debutants Leipzig first and then one of Atalanta or Paris Saint-Germain in the semifinals.

Atletico will enter this onelegged tie in good shape, too, having gone 18 matches without defeat either side of the coronavirus-enforced shutdown.

Diego Simeone credited the victory over Liverpool for reigniting his side's campaign, claiming that it gave his players belief that they are good enough to beat any team.

After finishing third in La Liga

behind the big two, Atleti's full focus is now on the biggest trophy in club football, and they have a good record against German opposition. Los Rojiblancos have always pro-

gressed against Bundesliga sides in the knockout stages of the Champions League – versus Bayer Leverkusen in 2015 and Bayern Munich in 2016.

However, Leipzig will see this as a massive opportunity to create some history of their own by going all the way in the reformatted competition.

Julian Nagelsmann's charges also finished third in their domestic league, ending the season with just one defeat in their final 15 matches - that coming against

Borussia Dortmund. On the continent, Leipzig topped their group before easing to a 4-0 aggregate win over Tottenham Hotspur in the first knockout round.

Atletico confirmed Monday that attacker Angel Correa and rightback Sime Vrsaliko were the individuals being tested positive for coronavirus at the weekend. All other tests came back negative, meaning that the game has been given the all clear by UEFA to go ahead as planned.

As for Leipzig, Nagelsmann would ideally go with Yussuf Poulsen and Patrik Schick up top in the absence of star striker Timo Werner.

Blue Tigers' FIFA World Cup Qualifiers tie moved to 2021 due to pandemic

New Delhi, August 12: The Indian football team will not see any action this year with the Asian qualifying matches for the 2022 FIFA World Cup Wednesday getting postponed to 2021 owing to the COVID-19 pandemic. The Asian Football Confederation

postponed all men's qualifiers scheduled in October and November for the 2022 World Cup and the 2023 Asian Cup. India's last international match was the joint qualifying round match against Oman in Muscat in November last year, which they had lost 0-1.

Though out of contention place in the next round of World Cup qualifiers, India are still in the reckoning for a spot in the 2023 Asian Cup. They were scheduled to play Qatar at home October 8 followed by matches against Afghanistan (home) and Bangladesh (away) in November.

A third-place finish in the group will help India get a direct berth in the third round of the qualifiers for the 2023 Asian Cup.

"In light of the current COVID-19 situation in many countries, FIFA and the Asian Football Confederation have jointly decided that the upcoming qualifying matches for the FIFA World Cup Qatar 2022 and AFC Asian Cup China 2023, originally scheduled to take place during the interna-

tional match windows in October and November 2020, will be rescheduled to 2021," read a joint statement of the FIFA and the AFC.

Both FIFA and AFC stated that the decision was taken keeping in mind the safety of all participants during the COVID-19 pandemic. The games will be rescheduled in 2021.

"With the aim of protecting the health and safety of all participants, FIFA and the AFC will continue to work together to closely monitor the situation in the region and to identify new dates for the respective qualifying matches.

"Further details on the new dates for the next round of qualifying matches for the World Cup 2022 and the AFC Asian Cup 2023 will be announced in due course," the statement said.

The AFC had previously scheduled the qualifiers in October-November and considered staging them at a centralised venue for each group India are currently fourth in

Group E with three points from five games. Qatar top the table with 13 points with Oman a point behind them in second.

Eight group winners and four best runners-up will progress to the continent's 12-team final qualifying stage for the World Cup.
