### CHSE Plus II Arts results tomorrow

Bhubaneswar: The Council of **Higher Secondary Education** (CHSE) in Odisha will announce the results of Plus II arts stream for 2019-20 at 4 p.m. September 5, informed the State School and Mass **Education Minister Samir** Ranjan Dash Thursday. The results will be available online on www.chseodisha.nic.in and www.orissaresults.nic.in. A total of 2.18 lakh students had appeared the Plus II arts examination this year which was held in March. However, a few papers could not be held due to nationwide lockdown amid the Covid-19 outbreak forcing the state government to come up with a new process of evaluation.

### Another minister tests Covid +ve

Bhubaneswar: Odisha Minister of Textile and handicrafts. Padmini Dian, Thursday said she has tested positive for COVID-19, and was undergoing home isolation. Dian is the third minister in the state to have contracted the disease. Meanwhile, Basudevpur BJD MI A Bishnubrata Routray also tested Covid positive Thursday Earlier, Higher Education Minister Arun Kumar Sahoo, and Lahour Minister Susant Singh were diagnosed with the infection, "I undertook sample tests after developing mild fever and came to know that I have contracted COVID-19," she said.

### **■ Diesel price cut** by 17 paise

Bhubaneswar: In a marginal relief to the common man. diesel prices were slashed by 15-17 paise across the metros and Bhubaneswar Thursday but petrol prices remain unchanged. The price of diesel in the state capital was slashed to ₹79.92 per litre from ₹80.19 per litre, while petrol prices remained constant at ₹82.70. As per the notification from Indian Oil Corporation, in the national capital diesel price was cut to. Mumbai diesel prices were cut to ₹73.40 per litre from ₹73.56 per litre, while the petrol price remained steady at ₹88.73.

On August 6, the RBI had announced a loan restructuring scheme for all types of borrowers - corporate, MSME and personal loan segments.

For non-MSME account holders, such restructuring can be sought till December 31 this year, provided that the borrower should not be in default for more than 30 days as of March 1, 2020. The banks have to implement the resolution framework within 180 days of agreeing upon the restructuring proposal.

For MSMEs, the RBI has allowed all the three types of stressed assets to avail restructuring, provided their total exposure is not more than ₹25 crore. But for others, including MSMEs with loan of more than ₹25 crore, restructuring window will not be available if they fall under SMA-1 or SMA-2 categories.

There are three types of stress assets, technically known as Special Mention Accounts, before an account becomes an NPA: SMA-0 are those in which loan repayments have been overdue for a period of up to 30 days, SMA-1 are the ones that have been overdue for a period between 31 and 60 days, while SMA-2 accounts are those with a delay

Khurda district has surpassed Ganjam district in reporting the highest number of COVID-19 cases. While the infections are rising alarmingly in the state capital, Ganjam is currently seeing a decline in the number of cases.

Latest data released by the state Health department showed that with the addition of 722 new COVID-19 cases Thursday, Khurda is now the hotbed of the disease in the state. As of date, the district has reported 18,881 COVID-19 cases. On the other hand, Ganjam reported

18,345 cases till Thursday. However, in terms of fatalities owing to the infection, Ganjam is still at the top of the chart. A total of 197 patients died in Ganjam so far against 70 deaths in Khurda district.

As far as recoveries are concerned. Ganiam has seen 17,162 recoveries, while 12,445 patients recovered from the disease in Khurda in the last one month.

In August, there has been a paradigm shift in terms of districts reporting highest cases. Ganjam, which was the worst-hit district till re-

# China funds anti-India protests

New Delhi, Sept 3: China has paid ₹2.5 crore (in Nepali currency) to various organisations based in Nepal to carry out demonstrations against India along the Indo-Nepal border that stretches to over 1,700 km, intelligence agencies said. 'Chinese Embassy in Nepal has pro-

vided financial support to the tune of ₹2.5 crore (NPR) for organising anti-India protests/demonstrations along India-Nepal border areas highlighting the recent border disputes and interferences of India in Nepal's internal/political matters," the agencies stated. NPR stands for Nepalese Rupee.

The India-Nepal relation has been strained after China increased its influence on the Himalayan nation.

It was India's road construction to the Lipulekh at 17,000 feet that had sparked a diplomatic row between India and Nepal as Kathmandu claimed the area to be its territory. Lipulekh is a tri-junction between India, Nepal and



in Uttarakhand. The road construction was aimed at shortening travel time for pilgrims visiting the Kailash Mansarovar.

After this, Nepal brought out a new political map showing the contested area as its own. India rejected the new map saying it

was not based on historical facts or evidence. The new political map of Nepal features parts of Lipulekh, Kalapani and Limpiyadhura areas which are in Indian territory. Nepal also increased its force deployment across the Indo-Nepal border. It has also planned to increase the number of border posts (BOPs) from 120 to 500 along the 1,751-km border.

### China deploys five militia squads in Eastern Ladakh NEW DELHI: China has deployed five militia

squads for rapid response at the disputed Line of Actual Control in Eastern Ladakh. It has done so to "consolidate the border" and "stabilise Tibet region", sources said. "Militia is basically a reserve force of the Chinese's People Liberation Army. They are deployed during war time situations and help the PLA in its military operations," said a senior government officer. The officer also explained that Chinese militia conducts independent operations and provides combat support and manpower to replenish the PLA. "It is an irregular mix of mountaineers. boxers, members of local fight clubs and others. Most of the members are raised from the local population," said the officer.

India-Nepal as an opportunity, China, which is already having a border dispute with India in Eastern Ladakh, increased its troop deployment at Lipulekh," said a senior government officer.

# Ganjam sand mining under SEIAA lens

Bhubaneswar, Sept 3: The 'illegal' sand mining activities along the Ghodahad river near Maulabhania in Ganiam district have come under the lens of the State Environmental Impact Assessment Authority (SEIAA).

Villagers from the affected areas have approached the SEIAA seeking an enquiry into the alleged illegal sand mining in the area and also pass orders putting a stop to all sand mining activities in the area.

A petition filed before the authority alleged that the lease holders in the area started mining sand, thereby damaging various structures and bridges lying in close proximity without obtaining requisite approvals, including environmental clearance for the same.

It also alleged that there have been several clashes between the villagers and those operating the sand mining activities in the region. The villagers said that in the process, a former Sarpanch of the area was abducted by the

sand mining mafia. The Sarpanch was, however, rescued following police intervention. "The present Tahasildar has clamped Section 144 CrPC in the sand mining area stopping the sand mining for a while However, no damages or compensation was collected from the 'so called' lease holder," the petition before the SEIAA said.

It has been alleged that due to the 'illegal' sand mining in the area, sand was deposited in around 10 hectares of agricultural land, including vegetable fields - mak-

ing the agricultural lands unfit for cropping. Moreover, vehicles engaged in the mining are causing air and land pollution as they are not covered while transporting the mined sand.

"It is pertinent to mention that the Application for Environmental Clearance for Ghodahad sand mining, Maulabhanja, has been rejected by the State Environment Impact Assessment Authority Odisha in pursuant to the SEAC Meeting minutes dated 27/02/2017," the petition said.

### Twelve teachers caught with fake **B.Ed** certificates

Keonjhar/Joda, Sept 3: The Keonjhar district administration Wednesday issued show-cause notices to 12 teachers of various government schools of the district for allegedly submitting fake B.Ed certificates to get jobs.

The matter came to the light when the candidates, who had received appointments as junior teachers under Sarba Siksha Abhivan in 2019, submitted their fake B.Ed certificates for scrutiny

Keonjhar District Programme Coordinator Purna Chandra Sethi said, "The department has identified 12 teachers of eight blocks of Odisha who have furnished fake B.Ed certificates to get the government jobs." "For this we have issued show-cause notices and asked the concerned officials to file FIR against them within seven days," added Sethi.



### Unable to pay bills, couple 'sells' newborn to hosp Assistant Chief Medical Officer

Agra, Sept 3: In a shocking incident, a hospital in Agra has been accused of buying a newborn baby in exchange for waiving off hospital bills of a rickshaw puller's wife.

Acting swiftly on the report, the Agra administration sealed the hospital and registered a complaint against the management. The rickshaw-puller has also been reunited with his baby

According to information, Shiv Charan, who works as a rickshawpuller in the Trans Yamuna area of Agra, had taken his pregnant wife to the JP Hospital for delivery a few days back. His wife was subjected to a Covid-19 test and then the delivery was performed upon which a baby boy was born.

After the delivery of the baby, Shiv Charan's wife had to stay at the hospital for several days. On being discharged some days later, Shiv Charan was handed over a bill of ₹35,000. He had then said that he won't be able to pay the amount.

Shiv Charan alleged that the manager of the hospital took this matter to the doctor who runs the hospital. The doctor demanded that either Shiv Charan makes the entire payment, or sell the baby to him, the rickshaw puller said.

Unable to pay the bill, the couple agreed to sell the baby. The doctor bought the newborn baby for ₹1 lakh, out of which, he adjusted the ₹35,000 hospital bills and returned the remaining amount of ₹65,000 to Shiv Charan.

When the district administra-

tion came to know about this incident, a team of health department

officials raided the hospital. The team found that the hospital was running in just four rooms on the first floor of a four-story building - one room was for the man-



ager, one for the doctor, one large room was serving as the delivery room and the remaining room was the 'ward'.

According to sources, the license of this hospital has not been renewed for 5 years.




# Man sells off son; wife moves NHRC

### Online classes for spl kids since July: Govt

Bhubaneswar, Sept 3: The Social Security and Empowerment of Persons with Disabilities (SSEPD) department Thursday said that it has taken steps to ensure that children with special needs are not left behind and have access to all educational benefits.

The department said it has been reaching out to differently-abled students by providing study material through e-platforms since March 2020.

"We have produced audio and video study material which has been uploaded on the department website," said Ambika Prasad Pattnaik, deputy secretary of SSEPD department.

The video library has two units meant for hearing-impaired students and intellectual disabilitv/autism spectrum disorder/cerebral palsy students. The study materials for Class X students have been uploaded and process is on for the remaining classes. The audio library carries study material for the visually-impaired students of Classes VIII, IX and X.

The e-book library is also in the process of collecting and uploading quality books for the students with special needs.

The online classes have been initiated by the department since July 2020 for all classes of special schools. To continue the educational activities due to closure of the schools on account of Covid-19, an SOP has been issued for reference and guidance of the concerned staffers of special schools. Further, class-wise WhatsApp groups of teachers and students have been advised to collect the feedback of the students and pass the same to the department through district Collectors for quality monitoring and upgrad-

uation. Besides, online classes for teacher trainees of State Institute of Special Education and Research (SISER) including 37 visually-challenged and other disabilities are also being taken up by the experts of the state institute with the help of Google Meet app.

# Home dept's one-time relief Factories & Boilers plan for fire safety violation

POST NEWS NETWORK

Bhubaneswar, Sept 3: The state government has made a one-time relaxation scheme for issuance of fire safety certificates to buildings operating prior to the implementation of Odisha Fire Prevention and Fire Safety Rules, 2017. The Home department has re-

cently issued a notification in this regard. Deviation in height, builtup area and occupancy area will be taken into consideration under the scheme. In case of buildings having no ap-

proved plan, the owner will have to submit the building plan as per actual construction being signed by himself/herself and a registered

The fire service officials will inspect the building and if the building or occupancy fulfills the other requirements of relaxation scheme, his case will be considered for issuance of fire safety certificate.

In case of government buildings, if the plan is prepared by a technical person of any department, it will be accepted for issuance of certificate. If the adjoining road is of minimum 6-metre



width and there is accessibility to fire tenders, such buildings can also avail the benefit.

In case of high-rises, if public road of 6-metre width is available in front and 6-metre open space/public road is available at any of the adjoining sides of the building then setback norm will be relaxed.

Similarly, the low-rise buildings having public road of 6-metre width in front and 6-metre open space at any of the adjoining sides of the building then also setback is not required.

If there is no setback available on left and right side of any building, then the owners of the adjoining plots can remove the common boundary wall to provide open space and get the certificate.

# Virus test must before remand

Bhubaneswar, Sept 3: The state government has made coronavirus test mandatory for any person to be produced before a magistrate for remand as over 500 inmates and 30 officials of different Odisha jails have been tested positive for COVID-19.

In a modification of the COVID management in the state prisons, the Home department has issued an eight-point Standard Operating Procedure (SOP) to be implemented by different arresting agencies like police, excise, forest and vigilance departments.

"We have already circulated the SOP to authorities of different jails across the state," Director General (Prisons) Santosh Kumar Upadhayay said.

Since the RT-PCR test is time consuming, the Home department's SOP suggested Rapid Antigen Test (RAT) which indicates COVID status of a person within an hour, the official said.

"Any person to be produced before a magistrate for remand by the Police/Excise/Forest/Vigilance authorities shall first be screened or tested by medical officers for COVID-19 along with the mandatory medical examination in a designated hospital," it said.

The medical officer of the designated hospital will conduct thorough exanimation of those persons proposed to be remanded to jails and shall record that the person is asymptomatic or symptomatic to the novel coronavirus.

Anybody found positive in the process, should be sent to the dedicated COVID Care Centre/ dedicated Covid Health Centre/ dedicated COVID Hospital by the concerned remanding agencies, the SOP mentioned, adding that as

In case any prisoner is detected as COVID positive, the same prisoner shall be shifted to dedicated COVID Care Centre/ dedicated Covid Health Centre/ dedicated Covid Hospital forthwith for which local police shall provide po-

To avoid infection due to physical production, technology-based virtual production from jails may be considered with concerned

If a COVID positive patient is

required to be admitted in the COVID facility, one escort shall be allowed to remain in the COVID facility for safe custody of the prisoner as is done for non COVID prisoners.

"Such escort may be allowed to use PPE. After the discharge of the prisoner, the escort shall be quarantined for 14 days, either in home isolation (if a separate room with attached toilet and a caregiver is available) or may be kept in a COVID Care Centre. Covid-19 Test shall be done on the 14th day of isolation or quarantine," the SOP said.

Official sources said that the state prison authorities have so far released as many as 16,789 inmates on bail in order to decongest jails. Still, there are 16,931 inmates

# **Falling Indravati water may hit** irrigation, power production


Bhawanipatna, Sept 3: Declining water level in Indravati reservoir might seriously hit farming in Kalahandi district, a report said. The fear stems from the fact that only one-third of the reservoir's capacity is filled with water.

This has happened because the district experienced less than normal rainfall during this monsoon. Moreover, heavy siltation taking place in the reservoir has diminished its water retaining capacity. Indravati which is termed as the lifeline of Kalahandi district lacks adequate water reserve for irrigation

It is apprehended that if the district does not receive good rainfall in coming days then whatever water is left in the reservoir might not support farmers till the end of their cultivation and will also affect power production.

Reports said that water level at Indravati reservoir currently stands at 336.85 meter by Thursday while the water level in the reservoir was 640.34 meter by August 31, last year. This is 76 per cent of the highest water retaining capacity of 642 meter of the reservoir.

Reports said that floods came in various rivers due to low-pressure triggered rainfall in the state. The water level rose in those rivers and several areas and farmlands were inundated. However, the low-pressure triggered rainfall in Kalahandi district was much less in comparison to other

### Centre can't renege

he Good Services Tax (GST), introduced with much fanfare in July 2017. is unraveling itself. The new tax regime, touted to be the biggest ever tax reform in independent India, has failed to meet the purposes it had promised to serve. Both the Centre, which had appropriated to itself a lion's share of power in the GST Council, and the state governments, who had been silenced by the carrot of annual compensations of a hefty 14 per cent, have found themselves at a loss. So much so that the Union government last week threw up its hands, saying it cannot pay the compensations to states as it had promised, and state governments are free to borrow funds from the RBI. Little did the Centre say who will finally foot the bill. Many state governments like Kerala have proposed that the Centre should borrow on its own account and pass it on to states. The Centre has declined it. Exacerbated, some states like Maharashtra, Chhattisgarh and Pondicherry have threatened to go back to the pre-GST regime. The Centre has been so helpless that Union Finance Minister Nirmala Sitharaman has blamed it on God for the shortfall in revenue.

The GST system was flawed from the word go. The BJP, in its hurry to gain political advantage, pushed through the indirect tax regime and got state governments to sign onto it by offering them juicy carrots. During negotiations prior to the formal rollout of the GST, the Centre had promised to compensate states by 14 per cent. The logic was based on a calculation that the state revenue would grow at a rate of 14 per cent year-on-year. 2015-16 was taken as the base year to calculate the state's annual revenue. Any gap between the 14 per cent growth projection and actual GST revenue would be met by the compensation. This would be financed by a special compensation cess levied over and above the GST on sin goods (for example tobacco and liquor) or luxury goods (for example SUVs). This promise had obviously silenced the most recalcitrant of the states opposed to the GST like Tamil Nadu. Then Gujarat Chief Minister Narendra Modi himself had opposed the GST during the UPA regime. However, the windfall of 14 per cent compensation had silenced all the critics of the new tax regime. States had bartered away their powers of taxation for the short term promise of increased revenue. The promise of this massive windfall, in fact, had encouraged many state governments like Odisha to splurge on populist schemes and elections.

The basic fault here was that the compensation for states should have been linked to actual economic growth instead of making the provision hard-wired. Now, state governments are not willing to climb back, nor the Union can renege on its promise. This is a real Gordian knot. The Centre cannot just wash its hands of its responsibility as it did in the GST Council meeting last Thursday. It was the Centre which had cajoled and forced state governments to sign on the GST and now when the chips are down it cannot just renege on its promise. The Covid-19 pandemic has ravaged the economy of every state government. Inasmuch as health is a state subject, the spending on this head due to the pandemic has skyrocketed in states. At this difficult time for them, the Centre cannot ask state governments to fend for themselves. The Centre may try to wriggle out of this mess by taking the plea that the compensation guarantee clause cannot be legally enforceable in courts. In January 2017, Karnataka had argued that the draft GST compensation be edited to guarantee that full compensation will be paid for full five years. To this the Centre had agreed that the compensation would be paid even if the cess falls short. The council had decided that the law should be amended. But this was not eventually done. When Telengana had asked why it was not being done, former Union Finance Minister Arun Jaitley - the main driver of the Act, had assured the states that compensation was guaranteed and the central government could raise resources by other means for compensation payout to states. This being the assurance, the Centre can't leave it to state governments to meet revenue shortfall by way of loans from the RBI. The Union government, as a bigger partner of the federal system, should be forthcoming to underwrite the loans, and definitely not renege on its promise.

### ■ Through the grapevine

o hear something through the grapevine is to learn of something informally and unofficially by means of gossip and rumour. The usual implication is that the information was passed person to person by word of mouth, perhaps in a confidential manner among friends or colleagues. There are several expressions of this type, of which a well-known couple are bush telegraph and jungle telegraph. These are historically rather odd, because both were created well after the era of the telegraph. But that's because both are imitations of the first such expression, grapevine telegraph, which is where our term comes from. The phrase was invented in the USA sometime in the late 1840s or early 1850s. It provided a wry comparison between the twisted stems of the grapevine and the straight lines of the then new electric telegraph marching across America. The telegraph was the marvel of the 1840s (Samuel Morse's first line was opened between Washington and Baltimore on 24 May 1844 and rapidly expanded in the following decade), vastly improving the speed of communication between communities. In comparison, the grapevine telegraph was by individual to individual, often garbling the facts or reporting untruths (so reflecting the gnarled and contorted stems of the grapevine), but likewise capable of transmitting vital messages quickly over distances. The first recorded usage, according to Jonathan Lighter in The Random House Historical Dictionary of American Slang, was in a political dictionary of 1852, which included the sentence "By the Grape Vine Telegraph Line ... we have received the following". Various early references suggest that it was associated with clandestine communication among Southern blacks, especially slaves, For example, a writer named Samuel Bowles wrote a book in 1865 called Across the Continent in which he remarked that Colorado ladies seemed to have some secret method of learning about the latest fashions from the East: "How it is done I do not understand - there must be a subtle telegraph by crinoline wires: as the southern negroes have what they call a grape-vine telegraph". The term became widely known during the American Civil War period, so much so that the phrase permanently entered the standard language. Soldiers used it in the sense of gossip or unreliable rumour, as was made very clear in a diary note of 1862 reproduced in Major James Connolly's Three Years in the Army of the Cumberland: "We get such 'news' in the army by what we call 'grape vine,' that is, 'grape vine telegraph.' It is not at all reliable". However, it was widely acknowledged that the Blacks' communications network was extremely useful to the Union cause, as John G. Nicolay and John Hay reported in Abraham Lincoln: A History in 1888, calling it "one of the most important and reliable sources of knowledge to the Union commanders in the various fields.



By appealing to some groups more than others, parties draw lines in the sand; and by focusing on some political fault lines over others, parties assemble coalitions that could have looked quite different had the emphasis been placed on various other equally salient issues.

The point of democracy is not to forge consensus on every issue, but rather to manage conflicting interests and commitments. But democracy can break down when parties or politicians openly demonise or deny the legitimacy of other contenders for power. Such tactics have long been the specialty of right-wing populists, who wage culture wars in an effort to reduce all political conflict to questions of belonging. Hence, rather

than engage with his opponents' arguments, Trump simply smears

As the political scientists Jacob S. Hacker and Paul Pierson have shown, the GOP's propensity for culture warfare owes much to the fact that its economic-policy agenda is profoundly unpopular. Having cut taxes for the rich and failed utterly in the face of the Covid-19 pandemic, Trump and his party need to distract potential voters from material concerns.

This "plutocratic populism," Hacker and Pierson show, is the result of the GOP's complete inability to generate new policy ideas. Republicans have simply doubled down on tax cuts and mindless deregulation, while proving incapable of offering any coherent alternative to the 2010 Affordable Care ("Obamacare"), which they are always just about to replace with

"something terrific.' Just as the GOP has outsourced its identity to culture warriors on far-right television networks and websites, so has it handed off intellectual work to think tanks, most of which are more committed to their donors than to crafting broadly popular and effective policy proposals.

These are not just American problems, of course. Across the West, traditional parties have been challenged by upstarts that tend to hold no serious internal debates, let alone embrace democratic decision-making. In the Netherlands, the far-right populist Geert Wilders' party has just two official members: Wilders and a foundation of which he is the only member. Similarly, in the United Kingdom, the Brexit Party boasts more than 110,000 "paying supporters," but is in fact a limited liability company with four officers and just one registered "person with significant control": the ubiquitous Brexiteer and serial polarization entrepreneur Nigel

To be sure, political parties aren't debating societies. But they are supposed to produce new ideas and policy plans, which a one-man show or a family enterprise is unlikely to do. While parties need to represent certain principles that their members share, deciding on such principles will always be contentious, and upholding them does not happen automatically

US President Lyndon Johnson once observed that, "What the man on the street wants is not a big debate on fundamental issues; he wants a little medical care, a rug on the floor, a picture on the wall.' But as Johnson's Democratic Party learned the hard way, even "a little medical care" can become a matter of principled conflict.

Such contests are best hashed out not just with one's partisan adversaries but also in open, pluralistic internal debate. When disputes are settled in this fashion, the losers are more likely to accept defeat and remain loyal to the party. By contrast, mass acclamations of the kind the GOP staged for Trump often send some party

members heading toward the exits. The hallmark of a well-functioning party is its ability to attract people with stable partisan commitments over time. Paradoxically, the party that allows members to offer criticism without being tarred as traitors ultimately instills deeper

The point is not to idealize intraparty participatory democracy. Yet there is a reason why the constitutions of Germany, Spain, and Portugal, for instance, prescribe internal party pluralism. By habituating people to democratic debate and forcing them to consider that the other side might have a valid point, this model embodies what has been lost in an age of polarization.

Parties that are internally authoritarian are more likely to govern accordingly. A system of properly functioning political parties is not sufficient for democracy, but it is necessary. Though the state cannot require parties to hold vigorous internal debates laws can and should establish stronger guidelines for internal pluralism and accountability Limited liability companies and family enterprises have their place in society; crafting public policy

There are special provisions for SCs and STs to ensure realization of their fundamental rights through participation in governance in matters relating to their protection, participation and development. Since the days of Constitutional governance, a number of statutory bodies are being constituted to look after the protection and wellbeing of these sections. Unfortunately, it is observed that the successive governments of Odisha and other states too, have paid less attention to such aspects. The three important bodies

the state Tribal Advisory Council (TAC), the state Scheduled Castes Welfare Board (SCWB), and the state Vigilance and Monitoring Committee (SVMC)constituted under the chairmanship of the chief minister to review and monitor the protection and welfare of SCs and STs - are almost defunct. Mostly, the elected leaders and higher-level government officials are members of these bodies, which are supposed to meet regularly to review implementation of various programmes for the SCs and STs.

Article 164 of the Constitution says that in Odisha, there shall be a minister in charge of welfare of STs, SCs and BCs; and Article 244(4) speaks about TAC in states having 5th Schedule areas. Similarly, as per provision of SCs and STs underthe POA Act 1989, there shall be a state vigilance and monitoring committee under the chairmanship of the CM. There is also provision for a standing committee under the chairmanship of minister for SC-ST development under Odisha Reservation of Vacancies Act, 1975. But, it has been observed that, for the last so many years, there have been no regular meetings of these bodies. The SCs and STs constitute almost 40 per cent of the population. Even the elected members from these communities

are not much concerned about this. The government reports itself reveal that the socio-economic situations of a majority of the SCs and STs in Odisha have not changed substantially in terms of social transformation and economic development. Every day, caste-based atrocities are occurring.

The protective legislations against practices of untouchabilviewed. In 2018, the state registered 1.810 cases of atrocities against SCsand STs. The NCRB report 2018 says that 10,000 cases of atrocities have been pending for trial in different courts in the state, whereas the conviction rate was only 3 per cent. The survey revealed that hundreds of caste and ethnicity-based untouchability practices, as also social segregations, have been existing in villages.

these communities have been facing institutional discrimination. These people are not being treated with dignity in local government offices. Very often they face extortion, humiliation and negligence in dealings, while they make any claim for their rightful dues and entitlements under different government schemes, laws, and provisions.

Most SC and ST hamlets are deprived of basic amenities such as safe drinking water toilet electricity, housing and connectivity which are linked to health and hygiene during this Covid-19 pandemic situation. which said some 42 per cent of the SC and 64 per cent of the ST households are under BPL. This is extremely higher than the national average of 33 per cent (2011-12). Agriculture Census and the

SECC 2011 established the fact that a vast majority of the SC population is landless and without Record of Rights over their homestead land in possession. This, though almost 85 percent of the SC rural households depend on agriculture for livelihood as share croppers and agricultural workers.

The state has witnessed ineffective implementation of the system of reservation in education and services sectors. The jobs available in the social sector are many. but there is social exclusion for SC-STs in recruitment of rural service providers such as Aganwadi, MDM cooks and contractual appointments. Thereare 1.45 lakh cooks-cum-helpers; and 29,900 women self-help groups are engaged in MDM scheme operational in the state since 1995. There are thousands of contractual jobs being created in rural areas to facilitate effective service delivery systems, where too, the SCs and STs have insignificant presence.

Hyderabad, Sept 3: Facebook Thursday banned BJP MLA from Hyderabad, T Raja Singh, who is at the centre of a controversy that erupted after a report in 'Wall Street Journal' that Facebook's content policies favoured the BJP.

The social media giant banned the legislator from its platform and Instagram for violating its policy that prohibits content promoting violence and hate.

"We have banned Raja Singh from Facebook for violating our policy prohibiting those that promote or engage in violence and hate from having a presence on our platform, a Facebook spokesperson said.

The process for evaluating potential violators is extensive and it is what led us to Facebook's decision to remove his account, it

The action came amid mounting pressure on Facebook over its handling of hate content being circulated by members of the ruling Bharatiya Janata Party (BJP).

Facebook, which has over 300 million users in India, came under criticism after the 'Wall Street Journal', published a report last month that Facebook deliberately ignored disruptive content from members of the ruling BJP as well as right-wing voices and groups who have been 'flagged internally'.

The report quoted unnamed Facebook insiders that one of the India policy executives intervened in an internal communication to stop a permanent ban on Raja Singh after he allegedly posted communal, divisive content.

The WSJ report triggered a political controversy with the Congress and the BJP trading barbs over Facebook's alleged bias

# Covid recoveries cross 1L-mark in T'gana

Hyderabad, Sept 3: The number of people recovered from Covid-19 in Telangana crossed one lakhmark and the number of tests crossed 15 lakh Thursday even as the state reported 2,817 new positive cases and 10 deaths.

The health officials said 2,611 people recovered during the last 24 hours, taking the total number of recoveries to 1,00,013. The state's recovery rate improved further to 74.9 while the national average is 77.09 per cent.

The new cases pushed the state's tally to 1,33,406. Of them, 92,050 (69 per cent) were asymptomatic and 41,356 (31 per cent) symptomatic.

Ten more people succumbed to the virus during the last 24 hours, taking the death toll to 856.

The health officials said the case fatality rate of the state is low at 0.64 per cent against the national average of 1.75 per cent. Out of the total fatalities, 53.87 per cent had co-morbidities. The number of active cases in the state stands at 32,537 including 25,293 in home/institutional isolation.

The authorities conducted 59,71 tests during the last 24 hours but there was no information as to how

many of these were rapid antigen tests. The number of tests conducted in the state so far rose to 15.42.978. According to a media bulletin issued from the office of the director of public health and family welfare, 26,869 primary contacts and 8,359 secondary contacts were



# ITBP raises fresh unit of assault dogs

New Delhi, Sept 3: The Indo-Tibetan Border Police (ITBP) has raised a new unit of assault dogs, which have been trained to work in packs of four to pin down enemy troopers if the force's patrol teams are attacked, officials said Thursday.

The first batch of about halfa-dozen dogs completed successful training recently at an ITBP academy in Bhanu near Chandigarh, and the canines are now being sent to various "important and sensitive" bases of the paramilitary force, including those along the Line of Actual Control (LAC) with China, they said. The about 90,000-personnel strong ITBP is primarily tasked with guarding the 3,488km-long LAC and it was raised in 1962. The new team of canine soldiers includes the ferocious

Belgian Malinois and the German Shepherd breeds, and the force proposes to train a total of 30 dogs in the first go.

"These assault dogs have been trained to attack in a team of quartets, which means that four dogs will act in tandem to bring down the target be it a terrorist or any element that may harm the troops during patrolling," a senior ITBP officer said.

"This canine strategy has never been used in the world. Even the Israeli K9 (canine) Oketz have never trained dogs to attack in a quartet arrow-head

fashion," he said. The officer claimed that the mountain-warfare trained ITBP is the first force in the world to have such a canine unit.

"The dogs of this new unit are trained to seek, track, chase, pin down and hold the target, till commanded to let go," he said.

# AGE AND IMAGE: KEY FACTORS FOR MAMATA

Kolkata, Sept 3: As the Mamata Baneriee-led Trinamool Congress government in West Bengal gears up for a high-voltage Assembly polls scheduled in 2021, the party leadership is focusing on the young brigade at the grassroots primarily with a clean and clear track record in politics.

The state's incumbent formation is already plagued with corruption charges in various districts, especially after the Cyclone Amphan that ravaged a large part of south Bengal districts. Be it distribution of food grains and tarpaulin in cyclone-ravaged pockets of Sunderbans or inclusion of ghost names in the list of beneficiaries - Trinamool Congress' name cropped up almost everywhere.

Hundreds of people had staged sit-in demonstrations in districts protesting against the irregularities over distribution of Amphan relief packages. They also agitated over the irregularities of Cyclone Amphan relief funds that went to various fake accounts of local Trinamool leaders depriving those who were actually affected due to the cyclone.

According to party sources, the key responsibilities are now being given to those who are aged below 40-years and have a reasonably clean image in their respective localities. There is a clear instruction from the party's top leadership to give importance to young people in the organisation. All district committees

will have to follow the directive. The instruction was sent out from the senior state leadership



to every booth level across West Bengal that people over the age group of 40 will not be entertained in the district committees. "The size of the district committees will also likely shrink in the coming

days," said a senior Trinamool

Keeping in mind the age factor and a considerably clean image of her party workers, the Trinamool supremo has reshuffled the party's

organisational structures in July. To troubleshoot the party's image in run up to the next year's elections, Mamata Banerjee had made a number of changes in the Trinamool Congress -- from its core commit-

tee members to district presidents. Announcing a major rejig, the West Bengal CM gave more priorities to younger and new faces in the party's forefront with a relatively clean political image. She had announced a new state committee with 21 members in it and a sevenmember core panel of Trinamool Congress that included names of Abhishek Banerjee, Subhendu Adhikari, Partha Chatterjee, Subrata Bakshi, Firhad Hakim, Kalyan Banerjee and Shanta Chetri.

Besides this, the presidents of several districts, including Howrah, Coochbehar, Purulia, Nadia, Jhargram and South Dinajpur had also been removed. New and younger faces like cricketer-turnedpolitician Laxmi Ratan Shukla in Howrah, Mahua Moitra in Nadia, Dulal Murmu in Jhargram, Gurupad Tudu in Purulia and Shyamal Santra in Bankura had been given charge of the districts. Party insiders said that Team

Prashant Kishor (popularly known as Team PK within Trinamool Congress) is working closely with the party's top leadership to find many critical areas. "Various steps like preparing a unique database of localities, fights between internal factions, performance record of local leaders etc. are being taken into account to chalk out a campaign strategy ahead of the next year's poll," a Trinamool Congress insider said.

New Delhi, Sept 3: Amid a raging controversy over Facebook's alleged political bias and interference in India's democratic process, the social media giant has told the Congress that it is non-partisan, denounces hate and bigotry in all forms and strives to ensure that its platforms remain a space where people can express themselves freely.

Responding to concerns raised by the opposition Congress, Facebook's Public Policy, Trust and Safety Director Neil Potts has said that it has taken the party's allegation of bias very seriously and will ensure that it remains non-partisan and is committed to maintaining the highest levels of integrity.

The Congress accused Facebook of interfering in India's democratic process and social harmony and being soft on members of the ruling BJP while applying its hatespeech rules.

The Congress had written to Facebook CEO Mark Zuckerberg after a report by the Wall Street Journal about the conduct of

Facebook and WhatsApp India's leadership team flagged bias and proximity with the ruling BJP.

'We take seriously the concerns and recommendations you raised on behalf of the Indian National Congress... First and foremost, we want to take this opportunity to state that we are non-partisan and strive to ensure that our platforms remain a space where people can express themselves freely. We take allegations of bias seriously and want to make clear that we denounce hate and bigotry in all forms," Potts said in the letter, dated September 1.

In his letter to AICC general secretary (organisation) K C Venugopal, who had written to Zuckerberg twice, Potts said, "On

the question of hateful content by public figures, we want to assure you that our Community Standards prohibit attacks against people based on their protected characteristics, including religion, caste, ethnicity, and national origin. In line with our hate speech policy, we have removed and will continue to remove hateful content by public figures in India on our plat-

Facebook is at the centre of a raging political debate in the country with both the ruling BJP and the opposition Congress accusing it of colluding and influencing opinion. The BJP has accused the social media giant's employees of supporting people from a political predisposition that lost successive elections, and "abusing" Prime Minister and senior cabinet ministers. In a three-page letter to Zuckerberg, IT Minister Ravi Shankar Prasad flagged the social media platform's alleged "bias and inaction" by individuals in the Facebook India team on complaints by people supportive of right-of-

### Youths steal mobile, rob cab to enjoy 'parathas'

The Delhi Police has arrested the three accused and apprehended two juveniles in this connection. One of the accused is a BBA student in a Noidabased college Police station Nangloi, re-

ceived a complaint where the complainant reported that his cab was booked through Ola from Krishna Mandir, Najafgarh Road, Nangloi. When the cab reached the pick-up point, 4 to 5 boys were present there who confirmed OTP of the booking to the driver.

"After that when they reached near Rajdhani Park, all the accused riding in the car started beating the driver and over-

powered him. They robbed his two mobile phones, wallet and threw him out of the car. Accordingly a robbery case was registered at Nangloi and investigation taken up," said DCP (Outer) A. Koan.

During the course of investigation on the basis of intelligence, accused Sagar and Pankai, both residents of Nangloi were arrested. During sustained interrogation both accused confessed to the crime and disclosed the names of three of their associates. Two juveniles were apprehended and one co-accused Abhijeet, also a resident of Nangloi, was arrested as well. Abhijeet is a BBA student in a Noida-based college.

officer for Covid-19, said that the reason for the spike in deaths is that people are not coming forward for testing and they are only reporting when their condition deteriorates. "That is why we have been asking the people to opt home isolation if they don't want hospitalization, Bhaskar said. In the highest single-day rise in deaths, 106 people succumbed to the virus on Wednesday. Besides, 1,514 new cases were reported. The state toll has reached 1,618, while the number of cases climbed to 56,989.

### Border Tension Bhadauria reviews situaton

"Air Chief Marshal Bhadauria also met and interacted with air warriors serving in these units during the course of his visit. He lauded the focussed efforts by the station personnel towards maintaining proficiency in all roles envisaged and urged them to continue performing their duty with due diligence," the official said.

# Cycling gaining popularity as gyms remain off the radar

New Delhi, Sept 3: As gyms remain off the radar for most people due to safety concerns amid the Covid-19 pandemic, people are moving to free-weight and cardiovascular exercises to build endurance and stay in shape. Cycling is gaining popularity as the preferred mode of workout in these times.

Children and the youth are loving it, and now even the doctors are advocating it, especially to the

patients with lifestyle ailments. Doctors said that people having lifestyle ailments and non-communicable diseases (NCD) such as diabetes, hypertension, cardiovas-

cular diseases, and arthritis need at least 30-50 minutes of daily exercise to manage their chronic con-

Dr Maninder Shah Singh, Orthopaedic and Joint Replacement Surgeon, Indian Spinal Injuries Center, New Delhi, said that lack of adequate physical activity can worsen the disease condition of such patients and can make them vulnerable to further complications. "Cycling can prevent it in a great way," he added.

"A worrying by-product of the Covid induced social isolation regime has been a further reduction in physical activity levels of the people. Even as gyms have started



reopening, not many people are comfortable sharing space during workouts with growing disease prevalence. Yoga clubs, group exercise sessions such as pilates,

Zumba classes, etc., have also been suspended. "As doctors, we advise patients to

ensure they get at least 30 minutes of exercise through any means.

Cycling is one of the safest and the best forms of exercise during this time and is very effective for diabetes, heart disease, hypertension, etc. It can also help keep weight under check without compromising social distancing norms," Singh added.

Cycling is a non-impact cardiovascular exercise that not only imparts strength to the bone structure, but can rejuve nate the entire body, including abs, lumbar muscles, and arms. At the same time, it also helps lower blood sugar and cholesterol levels while keeping a lid on vour blood pressure.

A largely sedentary lifestyle of many urban Indians is a major health concern. The lockdown has further compounded this problem. A study published in the Lancet journal had revealed that cardiovascular diseases contributed 28.1 per cent to the total deaths in India in 2016, compared with 15.2 per cent in 1990

Dr R R Dutta (Internal Medicine), Paras Hospital, Gurugram, said that urban authorities should use people's growing liking of cycling as an opportunity. "In the current Covid era, when people are scared of going to gyms and yoga studios, and any group workouts are nearly impossible due to obvious safety issues, cycling is the best way to ahealthier body and management of chronic diseases.

Islamabad, Sept 3: A high court in Pakistan Thursday directed the federal government to give India "another opportunity" to appoint a lawyer to represent death-row prisoner Kulbhushan Jadhav as it adjourned hearing for a month.

The Islamabad High Court (IHC) took up the case of appointment of lawyer for Jadhay to hear the review of the death sentence given to him by a Pakistani military court.

Jadhav, the 50-year-old retired Indian Navy officer, was sentenced to death by a Pakistani military court on charges of "espionage and terrorism" in April 2017.

Attorney General Khalid Javed Khan told the court that to comply with the orders of the International Court of Justice (ICJ), Pakistan granted consular access to India. however, it has not replied to Pakistan's offer to appoint a lawyer for him. According to the short order issued after the hearing, Khan told the court that Jadhav was informed about the judgment of the ICJ and his rights under Article 36 of the Vienna Convention on Consular Relations as well as IHC orders on the appointment of his defence counsel. The Attorney General told the court that he was informed by the officials of the Government of Pakistan that

Ordinance of 2020.

Khan told the court that India was duly informed of the proceedings of the court held on August 3, but its response is awaited, according to the order. The court raised questions about the efficacy of the case and judgment if India or Jadhav were not ready to avail the opportunity of review. The court observed that "in order to remove any further doubt, India should be given another opportunity to appoint a lawyer". "In order to remove any doubt, and to fulfill the requirements of a fair trial, we feel that another opportunity ought to be extended to the Government of India to consider taking appropriate measures so as to ensure effective compliance with the judgment of the International Court... We, therefore, yet again restrain ourselves from proceeding in the matter in hand," according to the order.

On August 4, the IHC named three senior lawyers as amici curiae in the case of Jadhav as it had ordered the Pakistan government to give "another chance" to India to appoint a counsel for the deathrow prisoner. Amicus Curiae is a lawyer appointed by a court to assist in any matter or case.

# UK public tribunal to probe Uighur 'genocide' claims

London, Sept 3: A prominent British human rights lawyer is convening an independent tribunal in London to investigate whether the Chinese government's alleged rights abuses against Uighur Muslims in the far western Xinjiang region constitute genocide or crimes against humanity

The tribunal is expected to reveal new evidence and testimony over several days' hearings next year. While the tribunal does not have government backing, it is the latest attempt to hold China accountable for its treatment of the Uighurs and ethnic Turkic minorities, who have been subject to an unprecedented crackdown since 2017. Allegations against China about potential geno-



cide are "questions that should be asked and answered" but such claims have never been legally scrutinized in public, Nice told The Associated Press. Organisers are in the initial stages of gathering evidence, and expect to receive a substantial number of submissions from Uighurs exiled abroad over the next few months. New evidence that may emerge includes testimony from several former security guards who were involved in the Xinjiang detention camps. "At the moment, the strongest evidence would appear to be evidence of incarceration and possibly evidence of enforced sterilisation," Nice said. China has long suspected the Uighurs, who are mostly Muslim, of harbouring separatist tendencies because of their distinct culture, language and religion.

In July, the Trump administration imposed sanctions on three senior Chinese Communist Party officials for alleged human rights abuses targeting Uighurs, ethnic Kazakhs and other minorities in Xinjiang, including mass detentions and forced population control.

### FIGHT AGAINST COVID-19 Steroids cut death rates: WHO

London, Sept 3: Treating critically ill COVID-19 patients with corticosteroid drugs reduces the risk of death by 20%, an analysis of seven international trials found Wednesday, prompting the World Health Organisation to update its advice on treatment.

The analysis - which pooled data from separate trials of low dose hydrocortisone, dexamethasone and methylprednisolone -found that steroids improve survival rates of COVID-19 patients sick enough to be in intensive care in hospital. "This is equivalent to around 68% of (the sickest COVID-19) patients surviving after treatment with corticosteroids, compared to around 60% surviving in the absence of corticosteroids," the researchers said in a statement.



Major development: The US Centers for Disease Control and Prevention (CDC) has asked state public health officials to prepare to distribute a potential coronavirus vaccine to high-risk groups as soon as late October, documents published by the agency showed.

# Female poverty rate in South Asia projected to rise: UN

United Nations, Sept 3: The female poverty rate in South Asia will increase in 2021 due to the COVID-19 pandemic and more women than men in the 25-34 age group will be poorer in the next decade, according to new data released by the UN.

The UN Women and the UN Development Programme (UNDP) said that the COVID-19 pandemic will disproportionately affect women and push 47 million more women and girls into extreme poverty by 2021, reversing decades of progress to lift this demographic above the Central and Southern Asia and


"Moreover, before the pandemic, projections for the region suggested that by 2030 only 15.8 per cent of the world's poor women and girls would be living in South Asia. The


revised projections now put that figure at 18.6 per cent," the report said. The report pointed out that the resurgence of poverty due to the pandemic threatens to deepen gender poverty gaps, especially for people aged 25 to 34, which is a key productive and family formation period for both women and men. In 2021, it is expected there will be 118 women in poverty for every 100 poor men globally, and this ratio could rise to 121 poor women for every 100 poor men by 2030.

While sub-Saharan Africa and South Asia will be the most impacted, "significantly more women than men in South Asia will be affected. In the 25-34 age group, there will be 118 poor women for every 100 poor men in South Asia, and that ratio will increase to 129 women for every 100 men by 2030. The

"pandemic will push 96 million people into extreme poverty by 2021, 47 million of whom are women and girls. This will increase the total number of women and girls living in extreme poverty to 435 million, with projections showing that this number will not revert to pre-pandemic levels until 2030," the UN agencies said.

While the pandemic has posed a serious threat to the prospects of eradicating extreme poverty by the end of this decade, the reality is even grimmer as these projections of increased poverty rates for women and girls only account for the downward revision of the gross domestic product (GDP), excluding other factorssuch as women leaving the workforce due to childcare responsibilities-that may also affect the sex distribution of poverty.

New Delhi, Sept 3: Fitch Ratings Thursday said private sector banks, with stronger loss-absorption buffers, are likely to gain market share from their state-owned peers in the medium term.

Private banks' loss-absorption buffers, in particular enhanced capital bases, strengthen their ability to recognise losses up-front with less disruption in their efforts to accelerate market-share gains, Fitch said. However, it does not expect immediate gains as the sector's credit growth is likely to remain subdued, and will only resume meaningfully once a sustained recovery from the pandemic gets underway. "While state banks have announced their intentions to raise fresh equity, they have not gone further than routine board approvals nor given clear indications on the timelines, except for a few banks. "This is despite the need to expedite improvement in the state banks' capital positions, which we believe remain vulnerable to varying degrees to future stress and unexpected losses." Fitch said.



# **Services activity** shrinks for sixth month in August

According to a poll the Indian economy is likely to suffer its worst 12-month performance since 1979 for the fiscal year that ends March 2021, contracting 6%

Bangalore, Sept 3: Activity in India's crippled services industry fell for a sixth straight month in August as coronavirus restrictions continued to hurt business operations and demand, causing the longest streak of job losses on record, an industry survey showed.

Thursday's survey adds to the gloom in the service sector, an engine of economic growth and jobs, suggesting a long and painful road to recovery after the economy shrank nearly a quarter in April-

Although the Nikkei/IHS Markit Services Purchasing Managers' Index increased to 41.8 in August from July's 34.2, it remained well below the 50-mark separating growth from contraction. August was the sixth straight

month the index was sub-50, the longest such stretch since a 10month run to April 2014. "August highlights another

month of challenging operating conditions in the Indian services sector." Shreeva Patel, an economist at IHS Markit, said in a release. "Sustained periods of closure and ongoing lockdown restrictions in both domestic and foreign markets have weighed heavily on the health of the industry."

Hoping to avert more serious economic damage, the government has said it planned to reopen underground train networks and allow sports and religious events in a limited manner despite coronavirus cases growing at the fastest rate in the world's second-most populous country.

Amid the raging pandemic, even if restrictions are eased, economic activity is unlikely to quickly return to pre-COVID-19 levels as fear of getting infected will keep millions of people indoors, avoiding shopping malls, cinemas, restaurants and hotels

A Reuters poll showed the Indian economy is likely to suffer its worst 12-month performance since 1979 for the fiscal year that ends March 2021, contracting 6.0%, pushing millions more into poverty.

Although improved from July, sub-indexes tracking domestic and foreign demand remained firmly in contraction territory, leading firms to reduce their workforce for the sixth straight month, the longest streak on record.

Expectations for future business activity gave little hope for an imminent turnaround as service firms gave a neutral outlook for the next 12 months.

A composite index, which measures both services and factory activity, improved to 46.0 in August from July's 37.2, cushioned by a better manufacturing performance, but remained well below the neutral 50.0 level.

On the price front, both input costs and prices charged rose in August, suggesting Asia's thirdlargest economy could enter a period of stagflation - a phase with lofty inflation, high unemployment and stagnant demand.

Vodafone Idea's stake-sale talks had been paused pending the court ruling, but Amazon and Verizon are now set to resume them, reported the newspaper, citing two people aware of the negotiations

Amazon and Verizon did not respond to Reuters requests for comment outside regular US business

# 'US economy grows modestly amid pandemic'

Washington, Sept 3: The US economy grew modestly over the summer amid continued uncertainty about the Covid-19 pandemic and its negative effect on consumer and business activity, according to a Federal Reserve survey.

"Economic activity increased among most districts, but gains were generally modest and activity remained well below levels prior to the Covid-19 pandemic," Xinhua news agency quoted the Fed as saying in its latest survey on economic conditions, known as the Beige Book, Wednesday.

"Continued uncertainty and

market remained volatile, while

"Some districts also reported slowing job growth and increased hiring volatility, particularly in service industries, with rising in-

stances of furloughed workers being laid off permanently as demand remained soft," it said.

US private companies added fewer-than-expected 428,000 jobs in August, indicating a slow recovery in a labour market ravaged by the Covid-19 crisis, payroll data company Automatic Data Processing (ADP) reported earlier on Wednesdav.

Amid fragile economic recovery from the pandemic, Fed Chairman Jerome Powell announced last week that the central bank will seek to achieve inflation that averages 2% over time, a new policy strategy that will likely keep interest rates near zero for years.

Serb marches into US Open 3rd round as he sees off Edmund

New York, Sept 3: Novak Djokovic has earned more than USD 140 million in prize money over his accomplished career, plus plenty of other millions in endorsement deals, so there wasn't much of a question in his mind when the possibility was offered to rent a private home during the US Open.

The cost is USD 40,000. The convenience is Priceless. "As soon as there was a chance for us to choose to be in a house, we took it right away – without thinking. I'm glad we did," the topranked Djokovic said after improving to 25-0 this season and reaching the US Open's third round with a 6-7(5-7), 6-3, 6-4,62 victory over Kyle Edmund Wednesday.

"Any player had that opportunity. It's not the privilege of the top guys or girls. Anyone that wanted to spend money and stay in the house, he or she could have done that," Djokovic said. "I know there's very few players that have chosen to stay in a house, but it is a personal choice.'

Most players competing at Flushing Meadows amid the coronavirus pandemic this year opted for the official tournament hotel options. The US Tennis Association paid for one room for each player, who then would need to pony up if they wanted a second for members of their entourage.

Serena Williams and Milos Raonic were among the eight players who, like Djokovic, opted for one of the Long Island homes the USTA made available instead. Why did Diokovic go that route? "Well.

I think it's obvious. Being in a hotel, you're unable to open the window in the room. You constantly have to be with a mask indoors, outdoors, everywhere. You can't really go out, spend time in

the garden, maybe, outdoors," he said. "I saw the hotel. The hotel is not in a best position in terms of having nature around. It's very close to the highway." 6-1, 5-1 & COLLAPSE

Garcia grabbed the next two points with a service winner followed by a gutsy second-serve ace to take that game and then was superior in the tie

Although much has been expected of her, the 26-year-old Garcia only once reached a Grand Slam quarterfinal and never has been past the US Open's third round. To do so this time, she'll need to beat 28th-seeded American Jennifer Brady.

### 5-sub rule stands for new Bundesliga season

Frankfurt: The German Bundesliga will keep five substitutions for the 2020-21 season because of the coronavirus pandemic. The 36 clubs in the top two German men's football leagues voted at a German Football League meeting Thursday to continue the rule for next season. That comes after the English Premier League moved back to three substitutions after using five to finish the 2019-20 campaign during the pandemic. FIFA allowed leagues to use up to five substitutions in May as a way to reduce fatigue for players in a busy run of rescheduled games. That measure was extended in July to allow competitions to use the rule until the end of 2021. The French league has started its 2020-21 season with five substitutions.
