Cuddalore: Seven women, including the firecracker unit licensee and her kin were killed and two workers critically injured in an explosion at a fireworks factory in Kattumannarkoil here on Friday, police said. Chief Minister K Palaniswami, who expressed his condolences to the bereaved families, announced a solatium of ₹2 lakh each to them. The factory owner Gandhimathi and eight other women were allegedly involved in making country firecrackers at the unit in Kurungudi village in Kattumannarkoil when a sudden explosion ripped through the structure, killing five women, police said.

New Delhi, Sept 4: The Supreme Court Friday dismissed the pleas, including the one filed by ministers of six opposition-ruled states, seeking review of its August 17 order which paved the way for holding NEET and JEE exams physically. A bench of Justices Ashok Bhushan, B R Gavai and Krishna Murari, which considered the pleas in-chamber, also rejected the ap-

plications seeking listing of the review petition in the open court. "Applications seeking permission to file review petitions are allowed. We have carefully gone through the review petitions and the connected papers. We find no merit in the review petitions and the same are accordingly dismissed," the bench said in its order.

National Testing Agency (NTA) which conducts both the exams is holding JEE Main Exams from September 1-6, while

#### **DO NOT DEFER COMPARTMENT EXAMS: CBSE**

The CBSE Friday opposed in the Supreme Court a plea seeking postponement of compartment exams for 12th class scheduled this month, saying all "necessary" safety measures for students are being taken in view of COVID-19 pandemic. A bench comprising Justices A M Khanwilkar, Dinesh Maheshwari and Sanjiv Khanna asked the counsel for the petitioner whether postponement of the examinations will help the students. "Without examination where do you stand. Is there any other methodology contemplated by CBSE," the bench asked during the hearing conducted through video conferencing. The counsel for the Central Board of Secondary Education (CBSE) said the board has increased the number of examination centres for compartment tests from 575 to 1,278.

## Sero-survey: City in High Risk Zone

Bhubaneswar, Sept 4: With rising COVID-19 cases in the capital city, only around 5.15 percent of the residents have developed antibodies for the infection, warned Bhubaneswar Municipal Corporation (BMC) Commissioner Prem Chandra Chaudhary Friday

"So far more than 1600 samples have been collected by the BMC in the first round of the second phase of serological surveillance. But the high risk group is yet to be tested under the surveillance. The first round result of the second surveillance shows that Bhubaneswar is better placed in terms of Covid infection so far. But the low antibodies prevalent rate puts the city into high risk zone. It may lead to a further surge in the infection rate in near fu-

The first phase that concluded in July saw collection of 951 samples with 1.4% developing antibodies against the infection. "The test results indicate that it may

lead to a further surge in the infection rate in near future," Chaudhary added. The Commissioner was also of the opinion that city still remains one of the 'best protected state capital' as compared to others. As claimed by the BMC, while antibody development in sero-survey of different capital cities remained 29% on average, it remained less than 10% here.

Senior BJP leader Prithviraj Harichandan held a presser where he lambasted the government over its decision and said that the step may interfere with the autonomy and functioning of universities.

'What was the urgent need to promulgate an ordinance to do away with other legislations governing universities? There have been massive protests against the legislation. The government has planned to bring an undemocratic way of interfering with the functioning of universities," he said. He warned that the move signals the government's intention of bring-

ing the universities under their control. "The government should not try to compromise on the reputation and autonomy of the universities. It has decided to close down 596 primary schools, there is rampant vacancy of teachers in the education system and now the government plans to interfere systematically in universities." he said.

The BJD however refuted all allegations and said that the amendments were brought to boost efficacy and transparency. "University financial details were earlier placed in the State Legislative Assembly which was not accessible by all. Now the students, parents and teachers would be more aware about the University's finances," Sasmit

Patra, BJD spokesperson said. Meanwhile, Higher Education secretary Saswat Mishra asked vice-chancellors (VCs) of all staterun universities to take actions in pursuance to amendment of the Odisha Universities Act, 1989. The Odisha Universities (Amendment) Ordinance, 2020 was published in the official gazette Friday.

Mishra asked the VCs to re-constitute syndicate and academic council. "Requisition for filling up of vacant posts of teachers (in all three ranks of Asst professor, associate professor and professor) should be filed with Odisha Public Service Commission (OPSC). Ongoing selection and recruitment process should be stopped forthwith," he said in a letter to VCs.

Similarly, requirement of nonteaching posts will be done by State Selection Board (SSB) and on-going selection and recruitment process should be stopped forthwith, he said.

Last week, during a senior security Communist Party meeting on Tibet's future governance, President Xi Jinping lauded achievements and praised frontline officials but said more efforts were needed to enrich, rejuvenate and strengthen unity in the region. He said a number of major infrastructure projects and public facilities would be completed, including the Sichuan-Tibet Railway, according to remarks published by the official Xinhua news agency. The construction plans include completion of the challenging middle section of a high-elevation Sichuan-Tibet railway link, a railway line between Nepal and Tibet that has remained in the planning stages, and a newly planned dry port in the Tibet Autonomous Region, the sources said.



News of the search drew crowds of people hopeful that another life could be saved. Using their hands and shovels, they moved Friday in the "direction of the signal", trying to find a tunnel or entry point that would give them access to a "survivor or corpse", Saade said, without elaborating on how long the process could take.

Lebanon, already mired in an economic crisis before the port blast, is not equipped for disaster management. The country lacks the tools and expertise to handle advanced search and rescue operations which are now being supported by experts from Chile, France and the Unites States.

The Chileans arrived recently with a sniffer dog trained to find humans, as well as specialist sensor de-vices that can detect heart beats and breathing.








Bhubaneswar, Sept 4: In a step towards creating employment opportunities through industrialisation in pharmaceutical sector, the state government has initiated steps to set up a Bulk Drug Park at Gopalpur in Ganjam district.

Holding a high-level meeting in this regard, Chief Secretary Asit Tripathy Friday approved the proposal for setting up the park in Tata SEZ (special economic zone) at Gopalpur.

Tripathy directed the Industry department to form a State Implementing Agency (SIA) in the shape of a special purpose vehicle (SPV) and work out a detailed proposal in this regard within a fortnight.

The site is well connected with port and railways for communication. It is less than two hours reach from Biju Pattnaik International Airport here. There is also an air strip at Gopalpur which can be utilised for swift communication,


"In a state where thousands of government schools are being closed on the alibi of low-enrolment of children, schools without adequate number of teachers will deprive children of their learning," added Kashyap.

In July this year, some statelevel people's organizations undertook a survey of 2,851 school children of Class III, Class V, and Class VIII to assess the learning outcome of children in government schools in 17 districts. The survey found that out of

845 students of Class VIII, 48% were below the required standard in English. Similarly in Mathematics, it was 45% among children. The learning level of Class III and Class V students is also worrisome. Out of 1,088 students in Class V, 59% could not meet the expected level in English, 53% in Mathematics and 31% in Odia language.

One of the reasons being attributed to the low-level of learning among children was the lack of required number of teachers in schools or teacher absenteeism, said Anian Pradhan, educationist and a member of the people's organisation that carried out the survey

Meanwhile, the department is working on filling up of the trained least 21,000 teacher positions in graduate teacher (TGT) posts by appointing contractual teachers. The (DEOs) have been asked to submit the updated vacancy status of teachers in their respective districts, an official said.

Bhubaneswar, Sept 4: The state's COVID-19 tally mounted to 1,16,678 Friday with 3.267 people including a ruling BJD MLA, testing positive for the infection, an official of the health and family welfare (H&FW) department said.

Nine more fatalities pushed Odisha's coronavirus death toll to 531, said the official.

The deaths were reported from five districts Bolangir, Cuttack, Ganjam and Khurda districts registered eight fatalities, while one patient succumbed to the virus in Rayagada.

Ganjam district has so far accounted for 199 deaths, followed by Khurda (72). Of the fresh cases, 1,961 were reported from quarantine centres while 1,306 people tested positive during contact-tracing, the official said.

The state government has launched fresh contact-tracing and follow-up measures, said the official. Khurda district topped the list of new cases with 859 infections, followed by Cuttack (384), Puri (235), Rayagada (169), Bhadrak (138) Mayurbhanj (134), Sundargarh (127),

## **RETURNEES BRACE UP FOR MIGRATION**

Notwithstanding pandemic, middlemen trap them with advances in Sonepur

Sonepur, Sept 4: Nuakhai festival in western Odisha was over August 23, but the Covid situation has not improved a bit for the poor who returned home from other states.

Migrant returnees in Sonepur are bracing up to return to their workplaces in other states as they allegedly failed to avail of sufficient work to make a decent earning during lockdowns and shutdowns.

Reports said, after the coronavirus-induced lockdown was imposed across the country, the district saw a huge reverse migration of migrant workers. Considering their plight over livelihood, the government laid stress on creating job opportunities for them through MGN-REGS for their sustenance.

However, it was alleged that most of the migrant returnees had to sit idle because they failed to get adequate work to keep their pots boiling. COVID situation is yet to subside, but many migrants are preparing to go back to their workplaces in different states.

Well before Nuakhai, middlemen and contractors had visited



villages and given migrants advance money to meet their daily expenses. Those who have taken advances are preparing to go back.

Even after the festival, many labour contractors camped in villages luring poor people with advances. Want of work has provided the contractors a golden opportunity to trap the idle workforce.

Like Bolangir, thousands of people from Sonepur migrate to different parts of Andhra Pradesh, Kerala, Gujarat, Mumbai, Huderbad and Telangana. The contractors are trying to lure them to brick kilns while the local administration is reportedly worried over this prob-They are being told to work as manlem. Most of these people work in ual labourer under MGNREGS.

brick kilns of Telangana and Tamil Nadu. Besides, young people from these villages have been migrating to work in malls and hotels in Mumbai, Pune, Hyderabad and Bangalore.

Unofficially, over 15,000 migrant labourers had come back to the district during lockdowns, but only 19 had registered their return by the administration. For the last four months, most labourers had allegedly no work even as the administration tried to provide them jobs through MGNREGS. Some said they do not find work according to their skills and expertise.

Most of them are reluctant to work under MGNREGS.

In western Odisha, the migration season usually begins after Nuakhai. After the festival, labour contractors take them away for six months.

Surprisingly, this problem is noticed in Dunguripalli and Binika blocks, even though the two blocks are irrigated.

The situation of migrant returnees in non-irrigated blocks ike Tarabha, Sonepur, Birmaharajpur and Ullunda is worse

According to some migrants, they have run out of money and their life is miserable. Now they have no way but to receive advance from labour contractors to go back to their workplaces, they observed. On the other hand, preparation for migration has put a question mark on the execution of the government schemes at the grassroots level

As per guidelines, there is a provision of registration of names of labourers at panchayat offices before migrating to other states. There is no data about this with the administration.

For a long time, over 500 valuable tim-




ber like sal, dhala, mahula, kusma and jamun trees had been chopped off in the forest, but the department had no clues

Lakhanpur, Sept 4: The first unit of the Ib Thermal power station of Odisha Power Generation Corporation (OPGC) at Banharpali in Jharsuguda district was shut down over mechanical issues late Thursday night. With the shutdown. generation of 210MW of electricity has been affected.

The first unit produces 210 MW of electricity. This unit, as per the allegations of some officials and workers, has been developing technical issues on a regular basis as no proper maintenance is being carried out.

Owing to frequent shutdowns, the company is losing revenue in crores. They demanded the state government's

intervention in this regard.

When contacted, the project's information and public relation officer Himanshu Behera said the company is repairing the unit on a war footing basis. In two to three days, it will be functional again. Notably, the Thermal power station has two power generation units: 210MW each and GRIDCO purchases the entire load.

Keonjhar, Sept 4: For hand-made aluminum dishes, Atoper village in this town has earned a name for itself. People from different parts of Odisha were frequent visitors to this village on a daily basis to buy hand-made dishes.

The situation, however, has changed drastically since the advent of the COVID-19 pandemic and the lockdown it brought along with it. The hammers of the artisans have fallen silent and the deafening sound created due to the clash of metals has all but disappeared. Sales have also dropped as these days there are not many visitors to the village

Hand-made dishes are still preferred by many as they help the food retain its unique taste, said artisan Prasanna Sahu.

No doubt the job of making dishes and other kitchen utensils is tedious. The artisans have to sit for hours in front of a glowing oven hammering away on aluminium sheets to give them different shapes.

However, they opined that they do not get the real value of their work and products. They also complained that the lack of raw materials like aluminium



sheets and coal are forcing them to give up the craft they have been indulging in for generations. So many families are switching to other means of livelihood as utensil-making is no longer a profitable proposition. Only some senior artisans continue to ply in the traditional business.

"Despite the scorching heat, we continue to work in front of the oven for lengthy hours. The flames increase the heat manifold. We collect old aluminum from various places. Then we melt them in pots and make aluminum plates. These plates are then given

shape of kitchen wares by striking them with hammers." informed Prasanna. The artisan however lamented the lack of government support for their craft.

Few months back people would come to our villages to buy the dishes. Due to the COVID-19 fear that has stopped also. Now we visit weekly markets in nearby districts and states like Jharkhand to earn our livelihood. The COVID-19 situation has left us nowhere," Prasanna said. "It is high time the government takes notice of our plight and help us," he added.

The Gross Domestic Product (GDP) shrank by 23.9 per cent in the first quarter of this financial year. GDP is a measure of the total amount of production made or income earned by the country. In contrast, former professor of Jawaharlal University Arun Kumar has assessed that there was a 75 percent decline in April 2020, followed by 60 and 40 per cent decline in May and June in GDP leading to a 58 per cent decline in the quarter. I think Arun Kumar's estimates of decline are on the higher side; yet, the decline must be more than the 23.9 per cent said by the government.

The reason for this huge difference in the two estimates is that GDP is basically a guess estimate. It is virtually impossible to measure the production done by every tea shop and farmer. Therefore, statisticians make estimates based on selected data. Selection of data is at their discretion. The data for the first quarter was mostly unavailable due to the lockdown. Therefore, statisticians had to perforce rely on the data that were available. They appear to have relied on the results of corporations, GST collections, sale of fuel oil, rail travels and the like. In this quarter, only a small number of large corporations did well-private electricity distribution companies, mobile telephony, e-commerce and the like. They have announced their results. Businesses not doing well have lessened their frequently of announcing their results. Therefore, these results are unduly influenced by the select corporations. Further, the unorganised sector is entirely left out of this data. Some 95 per cent of the employment and 45 per cent of the GDP comes from this sector. This includes kirana shops, tailors, taxi operators, small schools and doctors. These businesses were worst hit by the lockdown. This hit has not been captured by the govern-

ment GDP figures. The government has estimated a 3.4 per cent growth in the agriculture. Arun Kumar says that the arrivals in the mandi were down by 50 per cent in April. I Philips India won the contract to supply five crore LED bulbs under the government's UJALA scheme. It has supplied bulbs that were 'Made in China'. Globalisation has turned on its head today. Indian businessmen are taking their money to countries like China where there is freedom to pollute the environment, where labour laws are virtually non-existent and where bureaucracy is corrupt but helpful. They, along with Multinational Corporations. are producing goods in China and importing them into India. This is beneficial for them because they can produce cheap goods and de stroy those Indian businesspersons who try to produce in India. This is also beneficial for those consumers like the government employees who have a secure income, because they get cheap goods. However, this is harmful to the domestic industries that close down due to cheap imports and workers who lose their jobs. This is also harmful for the government because it gets less of revenues because of the closing down of domestic businesses.

The solution is to increase import duties substantially. The result will be that Indian businesspersons and MNCs will not be able to import goods manufactured by them in China and sell in India.

The increase in businesses in India will lead to generation of employment, increase in demand in the market, and encourage businesses to make more investments. However, those having secured incomes like the government employees will be losers. They will have to buy more expensive Made in India bulbs. Indeed, the general public will also not get cheaper Made in China bulbs. However, their loss will be ten times compensated by the increase in incomes due to the generation of jobs.

The choice before the government is to either secure the interests of MNCs and Indian business persons manufacturing in China and government employees; or to secure GDP growth. jobs and more revenues. The government should wholly reject the advice of IMF and embrace protectionism.

#### **RETURN OF THE PRODIGAL**

He founded a political party Jammu & Kashmir People's Movement (JKPM). Now, more than a year later, he has left his own party and indicated that he would like to return to the Service.

According to sources, the government has not accepted his resignation of January 2019, pending investigation into some of his posts on social media. Apparently, before quitting politics, Faesal contacted top officials in the Home Ministry. If we believe in the rumours, he contacted even National Security Adviser Ajit Doval before announcing his decision.

Those in the know say that since the government has not accepted his resignation, the door is open for his re-entry into the IAS. However, he will have to withdraw his resignation first. The website of the Department of Personnel and Training (DoPT) still shows Faesal as a serving officer, even though he plunged into politics for a year and a half. Since his resignation has not been processed. Faesal can still withdraw it. But more likely, the final say in this matter may be a political one than an administrative decision

Vransparency or weeding out corruption is a 'theme' with the Modi sarkar, and it has been sort of pursuing this goal despite a pushback from the babus. Last year, the government endorsed lists of "dozens" of officers of the IRS and IT services accused of corruption, sexual harassment and other charges. The "campaign" continues.

Now, as part of weeding out inefficient and corrupt babus, the Modi sarkar has again reiterated that Central ministries and departments must constantly update the list of officers who have completed 30 years of service. Besides, the register of officers with 'doubtful integrity' will be regularly reviewed and updated to help identify babus who can be prematurely retired from service. Sources say that the Department of Personnel and Training (DoPT) issued a letter to this effect on August 28.

Apparently, the names of such officers will be forwarded to the respective review committees on a routine basis. Cases about the IAS, IPS, IFS and Railway cadre babus will be considered by the respective secretary of DoPT. Ministry of Home Affairs, Ministry of External Affairs and Central Railway Board respectively. Will corrupt babus get the message?

#### **EXTENSION FOR MODY**

The Chairman of Central Board of Direct Taxes (CBDT) Pramod Chandra Mody got his term extended by six months ending February 28, 2021. A retired 1982-batch Indian Revenue Service (IRS) officer, Mody was slated to retire on August 31. His predecessor Sushil Chandra (now Election Commissioner) too got an extension in May 2017, which was considered a rare exception at that time. Now, with Mody's continued tenure, it seems to have become a norm.

#### Throw in the towel

t's from boxing. Or rather, from prize-fighting, which preceded it. When a fighter in a mill (a pugilistic encounter) was doing badly and was obviously going to lose, his seconds would throw something into the ring to indicate they were conceding defeat on his behalf. At the time, the most readily available item was the sponge for wiping the blood and sweat off their man's face. So the earliest form of the expression was to throw up the sponge (occasionally to throw in the sponge), which dates from sometime before the middle of the nineteenth century. A good example is in that Australian classic Robbery Under Arms by Rolf Boldrewood, dated 1888: "But it's no use giving in, Jim. We must stand up to our fight now, or throw up the sponge". The form you give is rather more recent, dating from just after the beginning of the twentieth century. An early instance is in Jack London's story The Mexican, published in the collection called The Night-Born in 1913: "Danny, battered and heroic, still kept coming up. Kelly and others near to the ring began to cry out to the police to stop it, though Danny's corner refused to throw in the towel". People sometimes advise somebody to chuck it in or throw it in as shortened forms, as ways of advising that some activity should cease. The boxing ring is rich in such metaphors. t's a fall or new beginning. The nation is pondering over the I minus 23.9 per cent GDP crash. The figures are stark but life goes on. Does the GDP really matter? The lockdown has plunged India into a never-before crisis. The GDP slump now is likely to worsen to full-year economic contraction of 7 per cent - or simply negative seven per cent; massive for a country of 130 crores that wants to take a super leap.

This is the result of routinely jettisoning financial stability for myopic adjustments in government expenditures, says Viral V Acharya, former RBI deputy governor. Now, the growth is prescribed on government spending by the RBI. Good. Nobody has answered from where the government would bring in the precious money. The gold pawning by the Chandrashekhar government in 1990 caused a similar concern. Then the growth clocked one per cent. Again, the figures have meant not much for the nation. Post-1992 Budget, some companies did exceedingly well at the stock market. It led to exposure of the billion-dollar Harshad Mehta scam. Banks and financial institutions were denuded. The corrective steps

the banks continue to take the hit.

The RBI is eloquent. It says even in a year of crisis that began in August 2019, bank frauds jumped to 159 per cent involving ₹1.48 lakh crore for public sector banks and ₹34211 crore for private ones. During the last 30 years, the GDP swung up and down but the common man not only in India, and even in the US and Europe post-2008 sub-prime crisis, lost several billions. The insurances and mutual funds emerged as more dishonest. Nations churn out big concerns; hopes and jingoism across the world keep people busy

The US economy shrinks by -31.7 per cent, the British by -20.4 per cent and the fall guy China by -6.2 per cent. Pakistan, with scant containment, is clocking at least 1.03 per cent growth. India, many might say, is in league with the big nations. May be it is in a better position with free food grain doles being

given to 80 crore people. That is indeed a silver lining. It is also true that since these 80 crore are not part of the market as they do not generate demand. The job losses, salary cuts or its non-payment. starvation, and rising number of suicides to four a minute have led to a grim situation. But, the fall in industrial output to 38.1 per cent, services to 20.6 per cent, and manufacturing to 39.3 per cent, may not theoretically have hit them. India has notionally spent

₹150,471 crore for free rice and wheat. The overflowing stocks in FCI silos were paid long back and do not entail a financial burden. Actual hit to the exchequer as of now is ₹1,930 crore for transportation and another ₹5,000 crore for pulses. The immediate cost is ₹6,930 crore. But as the stocks are depleting, carrying out the operation beyond November or till the West Bengal polls would burden criti-

cal finances

Gross value added (GVA), which is actual production value, minus taxes, contracts by 22.8 per cent. Even the public administration, defence and other service sub-sectors record a 10.3 per cent fall in government spending. Gross fixed capital formation, in short investment, contracts 47.1 per cent. However, government consumption expenses have grown by 16 per cent, much due to inflation. Even nominal GDP has contracted by 22.6 per cent. It means the base of tax collection, as the GST controversy depicts, will shrink.

The GDP itself is not a big number but its ramifications are. It is a symptom. The disease is severe – not the Covid-19 but financial failures. As a first, the RBI has to assert itself and instead of suppressing interest rates on savings, it has to increase it to a minimum of 9 per cent for bank deposits, else the banks would collapse.

Life will go on but to become a global leader we need a minimum 8 per cent continuous growth for \$ 5 trillion economy. The central bank has to delineate the path. Disease or not, the nation has to take a vow that it would not jeopardise normal functioning ever again. INFA

## School paints village walls for outdoor classes

Since most of the families lack resources to educate their kids ligitally, we had to come up with an innovative method to keep children invested in education RAM GAIKWAD | TEACHER

Solapur, Sept 4: Out on a street in a Maharashtra village, half a dozen children gather around their teacher who points a stick at the diagrams on a wall, one of many murals in the neighbourhood being used to help poor students keep up with their education during the pandemic.

With schools shut since March in a COVID-19 lockdown, teachers in Nilamnagar became concerned that some youngsters would fall behind because their families cannot afford an Internet subscription for online classes. So they came up with a workaround

the village of more than 30,000 people,

sitting or standing as they take notes. Their teachers walk through the village each weekday morning, stopping to explain the lesson or answer any questions. The murals cover a vast range of subjects – from writing to trigonometry - in English and the local Marathi language.

On one sun-faded wall, illustrations of objects starting with the letter 'S' including a scooter, spade and swing are painted in black below the words look, listen and say.'

"When my mother sends me to buy milk, I walk through the village and look at the lessons on the walls," 13-vearold Yashwant Anjalakar told AFP.

The son of two factory workers who hopes to work for the elite Indian Administrative Service one day – said the walls are the only option for students like him who lack access to the Internet.

"I miss my school and my friends a lot. Sitting at home is boring and these walls are a great way of revising and studying ... I want to keep studying even during this pandemic.

So far, 250 walls in the village have been painted by a local artist, and the school hopes to commission another 200. Parents have chipped in to help with the project's cost, which has reached Rs 150,000 so far, said the school's principal Tasleem Pathan.

"The entire village is invested in keeping the children educated during the pandemic," Pathan told AFP.

India has the world's third highest tally of virus infections, with more than 3.7 million confirmed cases, behind the United States and Brazil.

Despite a strict lockdown, the pandemic has shown no signs of slowing down as it moves from cities into the country's rural interior.

## **Unease in Bihar's ruling alliance**

Patna, Sept 4: Former chief minister Jitan Ram Manjhi's HAM(S) Friday reignited its rivalry with the Lok Janshakti Party, warning it will field candidates against LJP if Ram Vilas Paswan's party puts up nominees to take on the JD(U)in the Bihar assembly polls, reflecting the unease in the state's ruling alliance.

The LJP, founded by Union Minister Ram Vilas Paswan, is a BJP ally but not part of the JD(U)-BJP coalition government in the state where assembly elections are due in October-November.

The party, now helmed by Paswan's MP son Chirag, has often been critical of the Nitish Kumar government over a variety of issues ranging from alleged corruption in the public distribution system, to road construction and

violation of prohibition laws. There have been media reports that the LJP was unhappy over the return of the Hindustani Awam Morcha (Secular) into the NDA fold and contemplating fielding candidates against JD (U) nominees.

Dalits, who roughly constitute around 16 per cent of the state's voters, form the bedrock of support of both the LJP and HAM(S), and some amount of jostling between the two parties for greater share in the electoral pie appeared inevitable after Manjhi's return.

"It doesn't matter who is happy or unhappy (over HAM's return). We have come here to strengthen the hands of Nitish Kumar and not for tickets to contest elections. We will

## Maha village offers window into India's surging Covid caseload

Spurt in cases in small towns and villages, where mask-wearing and social distancing have nearly vanished and community gatherings are back, explains why India's infections are now rising faster than anywhere else in the world

Rajewadi, Sept 4: The quaint, sug arcane-growing village of Rajewadi in Maharashtra did not have a single confirmed coronavirus case until mid-August. Now, one in every four people there is positive for the virus, with police blaming a local religious event for the spread.

Such spurts in cases in small towns and villages, where maskwearing and social distancing have nearly vanished and community gatherings are back, explain why India's infections are now rising faster than anywhere else in the world and why the country is soon set to top 4 million cases. Cases are accelerating in towns, villages and smaller cities while the situation has stabilised in big metropolis of New Delhi and Mumbai.

The World Health Organisation has said India's relatively low mortality rate could rise as the virus fans out to the vast countryside, where health facilities are basic at best.

In Rajewadi - a small village of around 360 - authorities launched widespread testing only after an elderly resident was found to have died of COVID-19 August 17, said Aniruddha Athalye, a senior health official in Satara district.

Since then, 91 people there have tested positive and the village has

Mumbai, Sept 4: A no holds barred verbal war erupted Friday between Maharashtra's political parties and actress Kangana Ranaut for her recent statements that are viewed as denigrating the state in general and the Mumbai Police in particular.

Top leaders from the ruling Maha Vikas Aghadi alliance of Shiv Sena, Nationalist Congress Party, Congress, and opposition Maharashtra Navnirman Sena, slammed Kangana for her remarks, while protests erupted in Mumbai and other cities against the actress.

As a huge row snowballed - in which Kangana dragged the Palghar Sadhu lynching incident, labelled Mumbai as "addicted to blood," dared the Maratha Pride of Maharashtra, alleged the existence of an "Islam-dominated" Bollywood, besides POK - an embarrassed Bharatiya Janata Party, and some of its leaders who openly supported Kangana till Thursday, abruptly dumped her like a hot potato.

Amid protests by Shiv Sena activists, burning Kangana's effigy in the city and suburbs, Thane, Palghar, Pune, Aurangabad, Nashik and other cities, strong reactions from

various quarters, the normally calm state Home Minister Anil Deshmukh (NCP) was ruffled enough to "strongly condemn" Ranaut's statements, albeit without taking her name.

"I strongly condemn allegations levelled by an actress on Maharashtra and Mumbai Police forces. Our police forces are brave and capable in executing their duties and maintaining law and order across the state. Whoever doesn't feel safe here has no right to live here," a grim Deshmukh said.

Senior minister Anil Parab termed Kangana's outbursts as "a conspiracy intended to shift Bollywood out of Mumbai" and said such attempts will not be tolerated. On the other hand, advisor to CM Kishore Tiwari has alleged that Kangana is attempting to carve a political niche in the BJP by cre-

ating herself as an alternative to the party's leaders like Smriti Irani and Hema Malini.

In a sharp critique, Congress spokesperson Sachin Sawant accused Kangana of acting as the "mouthpiece" of the BJP's IT Cell, by which they have insulted the 13 crore people of Maharashtra, the 106 martyrs who sacrificed themselves for the state and Queen of Jhansi, Rani Laxmibai.

"Devendra Fadnavis (Leader of Opposition) and MLA Ram Kadam are her mentors. If Kangana has information about drug peddlers, why doesn't she inform the central agencies? Why Sandip Singh made 53 calls to the BJP leaders must be probed," Sawant said.

Caught unaware by the storm building against the 33-year-old actress from Himachal Pradesh, the BJP suddenly backtracked and washed its hands of the Kangana controversy. "Kangana should not try to teach Mumbai, Mumbaikars and Maharashtra. Sanjay Raut should not attack us through Kangana Ranaut. The BJP has nothing to do with Kangana. Don't link us to her statements," BJP leader Ashish Shelar virtually implored. Besides political leaders such as state Congress President and Minister Balasaheb Thorat, Mumbai Congress chief Eknath Gaikwad, Sena MPs Sanjay Raut, Arvind Sawant and Priyanka Chaturvedi, several Bollywood and Marathi film personalities such as Urmila Matondkar, Riteish Deshmukh, Renuka Shahane and many others have attacked Kangana for her comments.

Lalu Prasad Yaday, who is serving a jail term, has been allegedly holding durbars at the official residence of the Director of Rajendra Institute of Medical Sciences (RIMS) in Ranchi, Jharkhand, where he has been shifted.

One can find RJD leaders roaming around the official residence of the RIMS Director everyday. They were reportedly sending their biodata to the RJD president through the security guards. The Bihar Assembly poll dates are likely to be announced in the second week of September.

The Ranchi jail administration

deployed at the RIMS Director's residence, "RJD leaders have been told not to speak to media persons. They will be denied tickets if their photos are published in the media for meeting Lalu Yadav."

New Delhi, Sept 4: India's total COVID-19 recoveries crossed the 30 lakh-mark Friday, taking the recovery rate to over 77 per cent, the Union Health Ministry said Friday, asserting that the figures show that the number of patients recovering is steadily rising.

One of the goals of the 'Test-Track-Treat' strategy of the Centre is to reduce COVID mortality and keep the case fatality rate low, the ministry said in a statement.

There has been sharp attention on sustaining high levels of recoveries and to strengthen the clinical treatment protocols to provide a uniform standardised level of medical care to save lives, it said.

"Not only is India's case fatality rate lower than the global average and progressively declining (current figure is 1.74 per cent), but a very small proportion of active cases,



amounting to less than 0.5 per cent, are on ventilator support," the ministry said.

Data also shows that two per cent cases are in ICUs and less than 3.5 per cent of the active cases occupy oxygen supported beds, it said. As a result of these measures. India's total COVID-19 recoveries crossed 30 lakh (30,37,151) on Friday. With the recovery of 66,659 patients in the last 24 hours, India

has continued its trajectory of post-

ing more than 60,000 recoveries for the eighth consecutive day, the ministry said. The recovery rate amongst COVID-19 patients is 77.15 per cent demonstrating that the number of patients recovering is steadily rising over the past several months, it said.

The higher number of recoveries has also led to a steady enhancement in the difference between the recovered and active cases, and this difference has crossed 22 lakh, as on date.

This ensured that the actual caseload of the country (8,31,124 which are under active medical care), has reduced and currently comprises only 21.11 per cent of the total positive cases

The total number of COVID-19 cases mounted to 39,36,747, while the death toll due to the disease climbed to 68,472 with 1,096 people succumbing to it in a day, the ministry's data updated at 8 am showed.



## WAR AGAINST VIRUS IGI to get India's first on-site Covid test lab

New Delhi, Sept 4: To test incoming international passengers, the country's first on-site Covid testing facility is coming up at the capital's Indira Gandhi International Airport and will provide RT-PCR test results within six hours.

The facility, to be set up by a private laboratory empanelled by the Delhi government for Covid testing. is expected to be operational by mid-September. Genestrings Diagnostic Centre, which will establish the 3,500 square metre facility at the multi-level car parking of Terminal 3. said that the results of samples collected at the facility will be declared within 4-6 hours, and

until then, the passengers will be isolated in the waiting lounge or may opt to stay in a hotel.

In case of a positive result, the passenger concerned will be processed in line with applicable Indian Council of Medical Research (ICMR) protocols by the authorities while hose testing negative can continue their onward air journey, it added.

Ministry of Health and Family Welfare guidelines mandate international passengers arriving in India and having RT-PCR negative certificate would be exempt from institutional quarantine by states and will be allowed onward air journey. The government, in an advisory issued in August, mandated that

emption from institutional quarantine, if they have a negative report from a RT-PCR test conducted within 96 hours before the journey.

Genestrings Diagnostic Centre Director, Rajat Arora, said that the facility would ensure incoming passengers from abroad who could not arrange for a report on their Covid incoming travellers may seek exstatus can get it at the first airport

upon reaching India. Besides, residents of Delhi may choose to get tested at the airport laboratory and wait for the results before entering the city, he added. 'This is the first time such an arrangement is coming up at any airport in the entire country. We will test the incoming passengers at the airport, and the reports will be ready within 4-6 hours, which will ensure that they are tested before entering the city as well as for onward journey. RT-PCR is a gold standard way of testing for Covid-19 and will be a game-changer for the safety of incoming passengers. We are very proud of this collaboration and will ensure a successful implementation," he added.

The testing facility and infrastructure at T3 has been readied by Delhi International Airport Ltd (DIAL), a joint venture of corporate firms and the Airports Authority of India handling operations, management, and development of the IGIA since 2006, with all the necessary audits and approvals from the governing bodies.

## **MPs to give Covid -ve** report for Parl session

The COVID-19 test of the MPs need to be done 72 hours before the start of the session and it can be done either in their constituencies or at the Parliament complex

New Delhi, Sept 4: Members of Parliament (MPs) will require COVID-19 negative reports of themselves, their family members and other close contacts to attend the upcoming monsoon session, beginning September 14.

According to detailed guidelines issued by the Lok Sabha and Rajya Sabha secretariats, the close contacts of MPs include personal assistant (PA), personal secretary (PS), driver and maid.

"In case a member is found to be negative, she/he can attend the session.... In case a member is found positive, she/he will have to go for institutional isolation/hospitalisation as per advice of doctor and as per patient/clinical management protocol," according to the guidelines. The guidelines further say for safety purposes, MPs' family and staff members can undergo COVID-19 test on the Parliament premises as well. If a family member of an MP or PA/PS/driver/maid is found COVID-19 positive, then the parliamentarian

Chennai, Sept 4: The Indian Coast Guard is working on a multipronged strategy to prevent an oil spill from the blazing very large crude carrier (VLCC) 'New Diamond', laden with about 300,000 tonnes of crude oil, and also for towing and anchoring the vessel, an official said Friday.


A Coast Guard official said the massive oil tanker's towing and anchoring facilities are still in a working condition. The vessel, chartered by Indian Oil Corporation (IOC), is on fire since Thursday morning, about 37 nautical miles off the Sri Lankan coast and is in its Exclusive Economic Zone. Two Coast Guard Dornier aircraft, with pollution response spray pods and oil spill dispersants, are being launched from Tuticorin to Mattalla as a preventive measure towards any oil spill contingency, the Coast Guard said. According to the Coast Guard, its ships Sarang and Sujay with Pollution Response Equipment and a Chetak helicopter have been pressed into service. Further, two Coast Guard Fast Patrol Ships Ameya and Abheek have been deployed from Karaikal and Chennai, respectively, with 1,000 litres of Oil Spill Dispersant (OSD), Dry Chemical Powder (DCP) and others to augment pollution response efforts Also, its Pollution Response Ship Samudra Pahredar is deployed specifically for any oil spill contingency.

"The General Council of the Bar Council of India has unanimously resolved to direct the Bar Council of Delhi, where Prashant Bhushan is enrolled as an Advocate, to examine the matter and proceed as per law and rules to decide the same as expeditiously as possible," the BCI said in its resolution. Bhushan on Monday was fined one rupee as punishment in the contempt case. A bench headed by Justice Aruna Mishra

Senior advocate Prashant Bhushan was held guilty of contempt by the Supreme Court and awarded ₹1 as fine on August 31

(since retired) had convicted Bhushan for his two tweets against the judiciary. As a punishment he was directed to deposit the fine with the Supreme Court registry by September 15, failing which he would have to undergo three-month jail term and debarment from law practice for three years.

The apex bar body said it deliberated upon the the apex court judgment in its general council meeting held September 3 and held that the tweets and statements made by Bhushan and the SC judgment need thorough study and examination "in the light of the statutory duties, powers and functions conferred on it under the Advocates' Act and the rules framed thereunder".

## **TOP COURT DENIES BAIL TO SAJJAN**

New Delhi, Sept 4: The Supreme Court Friday declined to grant bail to former Congress leader Sajjan Kumar in a 1984 anti-Sikh riots case

A bench comprising Chief Justice S.A. Bobde and comprising Justices A.S. Bopanna and V. Ramasubramanian said the appeal against conviction will be heard after the top court resumes physical hearing. "This isn't a small case," observed the bench, as it rejected Kumar's bail plea citing medical grounds. The top court also declined to

allow him to remain in hospital noting that his medical reports establishes he does not need hospitalisation. Senior advocate Vikas Singh, appearing for Kumar, submitted before the bench to consider the bail plea on the merits as the High Court verdict was faulty. Singh argued that witnesses' deposition was reversed in the trial court and High Court.

The bench said that bail cannot be granted, adding that neither the argument of faulty judgement of the High Court justifies it nor he needs hospitalisation. Senior advocate H.S. Phoolka, representing victims, opposed Singh's arguments stating that Kumar is getting adequate attention in connection with his health. In May, the top court had refused to grant bail to Kumar stating that his medical report from AIIMS has no ground for hospitalisation. In March, the top court had directed Kumar to appear before an AIIMS Board, which would determine whether he needed hospitalisation.

Cong attacks govt over job issues

New Delhi. Sept 4: The Congress Friday hit out at the government over the issues of unemployment and poverty and alleged that its intent behind providing jobs to youth was not sincere.

It also alleged that in spite of "collecting crores from the sale of forms for recruitment", especially in SSC and Railways, the government was yet to hold some exams and in a few cases, declare results even after months. Former Congress president Rahul Gandhi attacked the government over a media report which claimed that the unemployment rate has gone up in August

#### as rural jobs dipped.

His sister and Congress general secretary Priyanka Gandhi Vadra also slammed the government over the alleged rise in unemployment and privatisation. She raised the issue of Staff Selection Commission Combined Graduate Level Exams allegedly being in a state of limbo. "2017- No appointments till now under SSC CGL. 2018 - Even results are not out of the CGL exam. 2019 - CGL exam was not held. 2020 SSC CGL - No vacancies taken out,' Privanka said in a tweet in Hindi.

"If vacancies come out, then no exams. If exams take place, then no results. If results come out, then no recruitment." she said. "The future

of the youth is being ruined by private sector layoffs and a halt on government recruitment, but the government is serving lies in advertisements and speeches to hide the truth," Priyanka tweeted with the hashtag 'stop privatization'.

In a tweet in Hindi, Rahul appealed to the Narendra Modi government for "employment, reinstatement, results of exams". "Provide solutions to the problems being faced by the youth of the country," he wrote. Congress spokesperson Gaurav Vallabh at a virtual press conference alleged that the government's intent towards the youth was not sincere and was doubtful.

New Delhi, Sept 4: With the number of Covid cases rising in the country, patients from the outskirts were coming to Delhi for treatment to avail of better facilities, claimed Delhi government sources.

As per the sources, the Delhi government has 14,000 beds. nearly 4,500 were occupied of which 1,500 (nearly 33 per cent) were occupied by those who were not Delhi residents.

Delhi government sources said that close to 70 per cent beds were still vacant. Only three of the 131 Covid hospitals (private and government) were full. There's no shortage of beds right now. But the increasing number of patients from outside Delhi was a cause of major concern.

private hospitals were all occupied -- Max Saket, Max Patparganj, Indraprastha Apollo and Fortis Vasant Kunj -- over 70 per cent of these patients were from outside Delhi, gov ernment sources added. With 83,341 fresh coronavirus infections in the last 24 hours, India's tally mounted to 39,36,747 Friday while the toll climbed to 68,472 with 1,096 more fatalities, said the Health Ministry.

Of the confirmed cases, 8,31,124 were active cases, while 30,37,151 have recovered from the virus till now. With 66.659 recoveries in a day, the recovery rate has increased to 77.15 per cent. The number of patients recovering was on a steady rise over the past several months. As the daily recoveries increase, India has registered more than 60,000 recoveries each day, eighth day in a row.

## Parole, furlough not absolute right: MHA to states

New Delhi, Sept 4: The Ministry of Home Affairs (MHA) said Friday the release of prisoners on parole and furlough is not an absolute right and should be on the basis of well-defined norms of eligibility. and directed states that those involved in terrorism and other heinous crimes should not be allowed to go out of jails.

In a communication to all States

and Union Territories, the home

ministry also said that parole and

furlough may not be granted as a

matter of routine and may be de-

cided by a committee of officers

and behavioural experts keeping

in view all relevant factors, especially

for inmates sentenced for sexual

offences, serious crimes such as murder, child abduction and violence.

The communication came following reports from different parts of the country that many of those released from jails due to the coronavirus pandemic were indulging in crimes.

The video of a recent incident in Punjab where a girl bravely fought against two armed snatchers, who were also released from a prison recently, was widely circulated on the social media. Referring to the Model Prison Manual, 2016, the home ministry said prisoners whose immediate presence in the society may be considered dangerous or otherwise prejudicial to public peace and order by the District



Magistrate and the Superintendent of Police should not be considered for release

Prisoners who are considered dangerous or have been involved in serious prison violence like assault, outbreak of riot, mutiny or escape, or who have been found to be instigating serious violation of prison

discipline as per his or her annual good conduct report should not be eligible for release. Prisoners convicted for heinous offences such as dacoity, terrorist crimes, kidnapping for ransom, smuggling of commercial quantity of narcotic and psychotropic substances and such prisoners who in the opinion of the District Magistrate and the District Superintendent of Police may not report back to the prison after completion of the furlough period and should not be released.

It is, therefore, important for state authorities to review their guidelines to ensure that the facility and concession given to inmates, by way of parole, furlough and premature release, etc., with the intention of providing them relief

and rehabilitation, is not abused and misused by them and their advantage does not turn into disadvantage and nuisance for the society at large. The home ministry suggested that following provisions may be included in the guidelines: i) Grant of parole and furlough

to those offenders, whose release may have adverse impact on the security of the State or safety of individuals, may be strictly restricted.

ii) Parole rules of States, including the criteria, duration and frequency may be reviewed after making an assessment based on their experience about the benefits and detriments of such parole.

iii) Parole and furlough may not be granted as a matter of routine and may be decided by a committee of officers and behavioural experts who may meet as per requirement, keeping in view all relevant factors, especially for inmates sentenced for sexual offences, serious crimes such as murder, child abduction and violence.

iv) It may be useful to invariably include an expert psychologist criminologist, correctional administration expert as a member of the Sentence Review Board and in the committee which decides grant of parole and furlough to inmates and obtain their opinion before such temporary release. The home ministry also drew the attention of the States and UTs to some extracts of the United Nations Standard Minimum-Rules for the Treatment of Prisoners. known as "The Nelson Mandela Rules".







"We are really not expecting to

see widespread vaccination until the middle of next year," Harris told a UN briefing in Geneva.

Islamabad, Sept 4: Pakistan's attempt to get two Indian nationals on the UN Security Council's (UNSC) terrorist list through a proposal was blocked by top member countries including the US. France. the UK, Germany and Belgium, leaving Islamabad's efforts hollow.

Pakistan's Foreign Ofice expressed its regret over the decision of the UNSC, insisting the need to de-politiciaation of the UN sanction regime.

"Pakistan has always stressed the need for de-politicization of the transparency in the UN sanctions regime for its effectiveness and credibility," said Foreign Office spokesperson Zahid Hafeez Chaudhri.

"These Indian nationals are wanted criminals in Pakistan for their involvement in many high-profile terrorist attacks and are currently residing in India under state protection," he added.

Pakistan had proposed designation of two Indian nationals Gobinda Patnaik and Angara Appaji, be designated under the UNSC's Islamic State of Iraq and Levant and Al Qaeda Sanctions List in 2019.

Pakistan's attempt to get rorist entities such as Tehreek-e-Taliban Pakistan, Jamat-ul-Ahrar two Indian nationals on and others. the UN Security Council's Pakistan also took the opportu-

nity to remind the UN of what it claimed as clear violations of the world body's Basic Principles on the Use of Force and Firearms by Law Enforcement Officials and the UN Code of Conduct of Law Enforcement Officials, by the government of India in relation to the ongoing tense situation in Jammu and Kashmir.

"No illegal Acts, such as the Armed Forces Special Powers Act (AFSPA) and Public Safety Act (PSA), can provide a legal cover to a crime recognized as such by international law," said Foreign Office spokesman.

'Pakistan and the people of Kashmir reject Indian attempts to impose illegal and unilateral decisions in Illegal Indian Occupation in Jammu and Kashmir against the wishes of the majority.

"The international community must take cognizance of the series of illegal Indian decisions and actions taken since August 5, 2019 and act in support of the human rights of the Kashmiri people," he added

The officer's name wasn't immediately released.

#### 5.0-magnitude quake hits Japan

According to the Japan Meteorological Agency (JMA), the temblor occurred at 9.10 a.m., with its epicentre at latitude of 36.1 degrees north and a longitude of 136.2 degrees east, and at a depth of 10 km, reports Xinhua news agency. There were no immediate reports of injuries or damages.

## **Portland suspect** shot dead by cops during arrest

Portland, Sept 4: Police have shot dead a man suspected of fatally shooting a right-wing activist during protests in the US city of Portland in Oregon state, officials have said.

The victim, Michael Reinoehl, 48, was being investigated for the killing of Aaron Danielson, a supporter of President Donald Trump during last weekend's tension in the city the BBC reported.

A warrant for Reinoehl's arrest was issued and he was located by agents Thursday in Lacey, Washington about 193 km north of Portland. Thurston County Sheriff's Lieutenant Ray Brady said it was not clear why the suspect was in Lacey and he did not believe Reinoehl lived at the address.

Lieutenant Brady said the police were conducting surveillance when the suspect left the apartment and got into a vehicle in the road.

'There was a confrontation between the officers that were on scene and the subject. The information we have at this time is that the subject was armed. There were shots that were fired into the vehicle and the subject fled from the vehicle, at which time there was additional shots that were fired.' the BBC quoted Lieutenant Brady as saying.

According to the BBC report, Reinoehl was a regular participant in Portland's anti-racism demonstrations and was part of the protesters' security team that aimed to protect demonstrators from potential agitators.

Several hundred protesters gathered in Portland following the shooting on Thursday and one sign in the street outside a police station.

## *'FLYING' ELECTRIC SPEEDBOAT* **DEBUTS ON SWISS LAKES**

Lucerne (Switzerland), Sept 4: The world's first electric-powered hydrofoil speedboat, which reduces energy consumption and noise - as well as sea sickness - by "flying" above the waves, has made its debut on Switzerland's lakes. The Candela Seven can hit

speeds of 55 km per hour when its foils lift it out of the water. Its manufacturers sav it travels further and smoother than other electric boats.

The foils reduce water friction and the effect of waves slamming into the boat - cutting energy



consumption by 80% compared to normal diesel-powered boats and extending the craft's range to 90 km (56 miles).

The carbon fiber boat also carries an on-board computer which automatically adjusts the foil positions 100 times per second to

reduce rolling and sea-sickness.

"Because we don't have any waves hitting, we don't have any slamming or bumping around and you really have a quiet a smooth ride," Swiss importer Christian Vogel told Reuters.

Until now, electric boats have tended to sacrifice either speed or range because of the capacity limits of their batteries.

The Candela Seven made its Swiss debut on Lake Lucerne this week, with Candela Speed Boat hoping to drum up new business with a European tour. The Stockholm-based company has delivered 16 boats since last year.



An international daily reported that the company is looking to sell about 10% of Reliance Retail. "Silver Lake is in talks to invest about \$1 billion in Mukesh Ambani's Reliance Retail," it said, citing sources.

Reliance and Silver Lake did not immediately respond to emails sent for comments.

After monetising Jio Platforms which houses the firm's telecom arm and digital ventures, richest Indian Mukesh Ambani is looking to rope in investors in the retail business. Last week. Reliance acquired the retail and logistics businesses of Future Group for ₹24.713 crore to boost its retail vertical. Silver Lake was the first US private equity firm to invest in Jio after tech giant Facebook took a 9.99 per cent stake in the company for ₹43,573.62 crore. Silver Lake bought 2.08 per cent in Jio in two tranches for a total of ₹10,202.55 crore. Rival private equity groups KKR, Vista and General Atlantic followed Silver Lake to take stakes in Jio. Other notable investors included Google and Abu Dhabi's sovereign wealth fund Mubadala. Commenting on the report,

CLSA said the \$57 billion valuation for Reliance Retail is 15% lower than the value it had assigned for the company.

## Moody's downgrades deposit ratings of 4 PSBs

Mumbai, Sept 4: Moody's Investors Service Friday downgraded the long-term local and foreign currency deposit ratings of Bank of Baroda, Bank of India, Canara Bank and Union Bank of India to Ba1 from Baa3.

The ratings agency also downgraded Baseline Credit Assessments (BCAs) of all the four lenders to B1 from Ba3

The outlook on the ratings of the four banks is negative.

It affirmed Punjab National Bank's (PNB) long-term local and foreign currency deposit ratings at Ba1 and its BCA at B1 but changed its ratings outlook to negative from stable

Deepening economic slowdown exacerbated by the coronavirus outbreak will strain the standalone credit strength of the banks, the agency said in a release.

Prolonged financial stress among households, weak job creation and a credit crunch among non-bank financial companies will lead to a rise in non-performing loans, delaying the ongoing clean-up of banks' balance sheets, it said.

On Bank of Baroda (BoB), Bank of India (BoI), Canara Bank and Union Bank, it said, "The BCA downgrades take into consideration rising risks to the banks' asset quality as a result of the severe economic contraction, which will result in an increase in credit costs."

This increase in credit costs will hurt profitability and also strain the banks' modest capitalisation, reversing recent improvements, it said.

The agency, however, said funding and liquidity continue to be key credit strengths given their status as public sector banks, which

However, PNB's financial metrics had been improving prior to the economic slowdown, which combined with its good funding and liquidity mitigates the negative impact on its credit profile of deteriorating asset quality and profitability, it added.

Moody's said the negative outlook factors in further downside risks to the banks' financial profiles because of the country's uncertain operating environment.

Mumbai, Sept 4: The Reserve Bank of India (RBI) Friday released its revised priority sector lending guidelines wherein the credit limits have been raised for farmer producer organisations, renewable energy and for health infrastructure.

As announced by the RBI Governor, startups have been brought under the ambit of priority sector lending. Bank finance of up to ₹50 crore has been included as a fresh category under priority sector, an RBI statement said.

The RBI statement said that a higher credit limit has been specified for Farmers Producers Organisations (FPOs) or Farmers Producers Companies (FPCs) undertaking farming with assured marketing of their produce at a pre-determined price. Further, "loan limits for renewable energy have been increased (doubled)" and "credit limit for health infrastructure (including those under 'Ayushman Bharat') has been doubled".

The filing further mentioned, "issuance of unsecured and / or secured, non-convertible debentures up to an aggregate amount of ₹15,000 crore, by way of public offering or private placement basis or otherwise, in one or more tranches".

The proposals will be taken up at the company's annual general meeting scheduled September 30, 2020.

It may be recalled that recent reports had suggested that Verizon and Amazon may invest over \$4 billion into the company, but Vodafone

Idea had on Thursday clarified that while it constantly evaluates various opportunities as part of corporate strategy, there is no such proposal currently before the Board at yet

Fund infusion is critical for VIL, the third largest operator in the fiercely-competitive Indian telecom market, where Jio's entry in 2016 with free calls and cheap data pushed some rivals to exit, acquire, or merge to stay afloat.

Jio Platforms -- the unit that houses India's youngest but largest telecom firm Jio and apps -- recently raised ₹1,52,056 crore from thirteen investors, including Facebook, Google, General Atlantic, Intel Capital and Qualcomm Ventures.

The monthly report, however, noted that the world after Covid-19 will be different with structural changes in production, consumption and work patterns.

"As India emerges from this crisis, it will be critical to re-orient the country's policy matrix towards a calibrated reconstruction of the economy and building resilience for an uncertain future," it said.

As per the report, some areas that may require specific attention include agrarian supply chains, factor markets, infrastructure, ICT, start-ups, financial inclusion, skilling and health care. Progress in these areas will sustainably boost economic growth in years to come, it

added.

Serena Williams sets up US Open face-off against Sloane Stephens as the 23-time Grand Slam winner sees off Gasparyan in the second round

New York, Sept 4: Serena Williams won in straight sets again. She moved into an all-American showdown at the US Open against Sloane Stephens. Still, this victory did not quite go according to plan.

Her serve only so-so at times, her footwork a bit off, Williams got by and got through Thursday night against an opponent ranked just 117th, beating Margarita Gasparyan 6-2, 6-4 and letting out a cry of 'Yes!' at the end that reverberated in a nearly empty Arthur Ashe Stadium. It sounded more like relief than excitement.

The only thing holding me back is that I get frustrated," said Williams, who has won six of her 23 Grand Slam singles titles at Flushing Meadows and was the runner-up the past two years.

"But I'm out here, I'm fighting. It was just a minor setback. If anything, it could help me know what not to do next time." That'll be Saturday against Stephens, the 2017 US Open champion.

It is their seventh match-up; Williams leads 5-1, including victories in the past four meetings in a row, but they last played at the 2015 French Open. Stephens' lone head-to-head victory came all the way back at the 2013 Australian Open.

This calibre of contest certainly doesn't feel as if it belongs in merely the third round at a Slam, but that's the luck of the draw this time. What will also be odd: the quiet.

All spectators were banned from Flushing Meadows this year because of the coronavirus pandemic. "I know if there were fans it would be so lit, and I'm kind of sad that we're not playing in front of fans, because it would be so fun,' said the 26th-seeded Stephens, who advanced Thursday by defeating Olga Govortsova 6-2, 6-2.

"The atmosphere won't be as big, but obviously a big opportunity to play against the greatest player in the world. So, yeah, unfortunate but still fortunate.'

Both have compared the setting to their days as juniors, playing at age 10 or 12. Williams turns 39 this month and expended a lot of energy lately. Things weren't as easy as they might have been against Gasparyan, who hits flat with a one-handed backhand and whose only trip to the fourth

round at a major ended with a loss to Williams at the 2016 Australian Open. Williams served for the first set at 5-1 and got broken.

She went up 4-2 in the second set and got broken, dropped 8 of 10 points in one stretch and found herself at 4-all. In all, she put only 58 per cent of her first serves in and was broken three times

Light rain began falling during the warm-up period, so Williams and Gasparyan sat on the sideline, each draping a towel over their shoulders, until Ashe could be turned into an indoor facility. The roof remained closed for the match that followed: Andy Murray against Felix Auger-Aliassime.

New Delhi, Sept 4: Senior offspinner Harbhajan Singh Friday became the second high-profile name to pull out of this year's IPL owing to 'personal reasons', saying he has informed the Chennai Super Kings (CSK) team management about his decision.

The 40-year-old, who has been a part of CSK during the past two seasons is currently in Jalandhar, Punjab with his family and requested privacy. The IPL starts September 19 in the UAE after being moved out of India due to the COVID-19 pandemic

"I have informed the CSK management about my decision to pull out of this year's IPL. I have decided to take a break due to personal reasons in these difficult times. I expect that everyone would respect my need for privacy," Harbhajan, who was bought by the franchise for Rs 2 crore this season, told this agency Friday.

Earlier, all-rounder Suresh Raina, who too turned up for CSK, had opted out also citing personal reasons. Harbhajan said that he was indebted to the CSK management for understanding his priorities.

"When I told the CSK management about my decision, they were very supportive and I can't thank them enough for that," Harbhajan said. Once Harbhajan officially announced his pullout. CSK issued a statement, backing the player

"Harbhajan Singh informed us he won't be available due to personal reasons. Team CSK is supportive of his decision and stands by him and his family during these testing times," CSK tweeted CEO KS Viswanathan's statement.

It's not clear if CSK will opt for a finger spinner as replacement or would seek a batsman as they have depth and quality in bowling.

#### **PSG's COVID +ve tally rises to six**

Paris: Three more Paris Saint-Germain (PSG) players tested positive for the coronavirus, taking the number so far to six and throwing the club's start to the new season into chaos. PSG announced the positive tests late Thursday, without giving the names of the players and only saying that they are 'subject to the appropriate health protocol'. But sports daily 'L'Equipe' named them as defender Marquinhos, goalkeeper Keylor Navas and striker Mauro Icardi. The other three cases, confirmed by the club Wednesday, reportedly are forward Neymar, winger Angel Di Maria and midfielder Leandro Paredes. All six were part of a recent holiday trip to Ibiza in Spain, which was authorized, following the club's defeat to Bayern Munich in the Champions League final August 23.

#### Atletico stars test positive

Madrid: Atletico Madrid striker Diego Costa and defender Santiago Arias have tested positive for the coronavirus, the Spanish club said. The players are in quarantine and will not report for the team's first day of training Friday. Most of the squad underwent their tests on Thursday, but Costa and Arias had tested positive while on vacation, the club said. They were not showing symptoms of COVID-19. Atletico Madrid will begin their season at the end of the month against Granada in the Spanish league. Their first two league matches were postponed because their season ended later as they participated in the Champions League quarterfinals.

#### Messi's father slams La Liga over the player's release clause dispute

Barcelona: The saga surrounding Lionel Messi and Barcelona has taken a new twist in the shape of Jorge Messi issuing a statement addressed to La Liga president Javier Tebas. The statement reiterates his camp's belief that Messi's 700 million euro buyout clause is no longer valid if the player decided to leave after the 2019-20 season. Jorge's statement appears to quote directly from his contract, stating: "The release clause will not apply when the unilateral resolution of the contract comes into effect after the end of the 2019-20 season." He says La Liga made a 'clear error' and adds that he's not exactly sure what contract they were looking at previously. La Liga had announced five days ago that they believe Messi is still under contract and the clause is still valid.

## Vaccine not a requirement: Muto

Tokyo, Sept 4: A vaccine is not a requirement for holding next year's postponed Olympics and Paralympics, the CEO of the Tokyo Games Toshiro Muto said Friday. Muto was speaking after a task

"It's not a prerequisite," Muto said of the vaccine. "The International Olympic Committee and the WHO already discussed this matter. It's not a condition for the delivery of the Tokyo 2020 Games.

"A vaccine is not a requirement. Of course, if vaccines are developed we'll really appreciate it. And for Tokyo 2020 this will be great. But



if you ask me if that's a condition — it's not a condition.' The task force meetings over the

lenge, with the public skeptical the Olympics can take place — or should take place. Japan has already invested billions, and the delay is likely to cost billions more.

A poll last month of almost 13.000 Japanese companies showed 53.6% want the games canceled or postponed again. The IOC has said if the Olympics can't happen in 2021, they will be canceled. A poll in July found that two-thirds of the public also favors another postponement or cancellation.

## Gaya saves Spain the blushes

Stuttgart, Sept 4: Spain defender Jose Gaya scored deep into stoppage time to salvage a 1-1 draw against Germany as the UEFA Nations League started without fans ending a 10-month international break.

The Valencia defender scored in the sixth minute of injury to time to cancel out Timo Werner's opening goal on his return to his hometown Stuttgart.

With international football returning for the first time since the outbreak of the coronavirus pandemic, all 54 games that are scheduled to take place across the continent over six days are taking place with strict hygiene measures, including the exclusion of fans. Players had to pass mandatory pregame tests for COVID-19.

Werner, who was born here and went on to become the club's youngest scorer, gave Germany the lead in the 51st minute.

He finished off a move started by a cross-field ball from Ilkay Gundogan, with debutant Robin Gosens providing the cross.

Barcelona winger Ansu Fati came on for the second half to become Spain's youngest debutant since Angel Zubieta in 1936. The 17year-old had an injury-time equaliser ruled out for a foul by Sergio Ramos in the build-up.

But there was still time for Rodrigo Moreno to set up Gaya for the equaliser, with the defender converting from close range.

It was Spain's first game with coach Luis Enrique back in charge following the death of his nineyear-old daughter Xana due to a type of bone cancer in August 2019. Enrique had stepped down for five months before returning in November, when he couldn't
