#### Two poachers killed while making bombs

# **'Lack of congruence' in business reform rankings**

New Delhi, Sept 6: The Industrial Promotion and Investment Corporation of Odisha (IPICOL), a state government agency, has said that there seem to be a "lack of congruence" in the results, as the state recorded a dismal performance in the Centre's Business Reform Action Plan (BRAP) rankings with its performance worsening as per the data. In a statement, IPICOL has said that it will seek further details and clarification on the evaluation methodology from the Department for Promotion of Industry and Internal Trade (DPIIT).

"There seems to be incongruity in the results as states/UTs which have implemented much lower number of reforms have been ranked higher than states which have implemented significant reforms. Further details and clarifications on the evaluation methodology will be sought from DPIIT, Government of India, on the results announced," it said.

As per the Business Reform Action Plan (BRAP) rankings for 2019 released

Bangalore, Sept 6: In what may be described as a scarring development, Fortis Hospital here has reported that a 27-year-old woman from the city tested positive again nearly a month after she was treated and discharged from the hospital.

SCW seeks ATR, to move for DGP's intervention

Bhubaneswar, Sept 6: The State Commission for Women (SCW) has asked the Commissionerate Police to submit the Action Taken Report (ATR) in the minor gang rape incident involving cops and media personnel. SCW chairperson, Minati Behera sought details of progress made in the probe into the matter.

The SCW has also announced it will seek the DGP's intervention in case if it finds the investigations into the case are unsatisfactory.

Notably, a 13-year-old was repeatedly raped at her residence here by her mother's colleagues and a policeman among others during the March-April lockdown and the po-



lice have launched a manhunt to trace the accused. The victim's mother, who is an employee of a private TV channel here, filed the complaint on the sordid incident with Mahila police station August 30.

At least seven persons were involved in this heinous act and the mother's colleagues are absconding, Bhubaneswar Deputy Commissioner of police US Dash

said Sunday. In her complaint, the woman alleged that two of her colleagues, two private security personnel, a policeman and his two associates raped her daughter in her rented accommodation when she was in office

While the girl stays with her mother in a rented house at the Info-city, her father and other members of the family stay at their native place at Kendrapara, over 85 km from here, it said.

However, the case was later handed over to Investigating Integrative Units for Crime Against Women (IUCAW). Earlier, the DCP had said Saturday through a video message that a special team has been constituted to identify the accused.

### **RAINS IN SOME PARTS OF STATE LIKELY TODAY**

Bhubaneswar, Sept 6: The Meteorological department here has predicted rainfall in different parts of the state Monday.

The latest forecast by the department says thunderstorms and lightning are expected at several places. It has issued a yellow warning has been released accordingly for the same asking the authorities to be updated on the developments.

"Thunderstorm with lightning is very likely to occur at one or two places over Malkangiri, Koraput, Ganjam, Gajapati, Rayagada, Mayurbhanj, Keonjhar, Kandhamal, Kalahandi, Sundargarh, Deogarh, Angul, Dhenkanal and Balasore districts," the department's evening bulletin read.

The forecast further said, "Light to moderate rain or thundershower very likely to occur at a few places over the districts of North Interior Odisha, Kandhamal, Rayagada, Gajapati, Nabarangpur and at one or two places over rest the districts of Odisha,

The department, however, did not issue any warning for the next two days, but has forecasted rains in different parts of the state Tuesday and Wednesday too.

The department said that light to moderate rain may occur Tuesday at few places over coastal Odisha, Keonjhar, Mayurbhanj, Kandhamal and others. It could be accompanied by thunderstorms too.

Similarly Wednesday the department has forecasted light to moderate rains at northern interior parts of Odisha at one or -( two places and other districts from the state.

# Seer who inspired 'basic structure' doctrine no more

Kesavananda Bharati, the sole petitioner in the historic Fundamental Rights case that prevented the India from slipping into a totalitarian regime, dies

Kasaragod, Sept 6: Kesavananda Bharati, on whose petition the Supreme Court delivered the landmark judgement on the celebrated doctrine of basic structure of the Constitution, died here Sunday.

Vice-President Venkaiah Naidu and Prime Minister Narendra Modi were among a host of leaders who condoled the demise of the 79-year old Kerala-based seer, saying he will be remembered for his service to the people.

Police said Kesavananda Bharati Sripadagalvaru died at the Edaneer Mutt here due to age related ailments.

"As per the information with us, he passed away at around 3.30

AM Sunday," police told PTI. People from all walks of life paid homage to the departed seer at the Edneer Mutt of which he became

the head over five decades ago. The case in which Bharati had challenged Kerala Land Reform laws nearly four decades ago set the principle that the Supreme Court is the guardian of the basic structure of the Constitution and the verdict involved 13 judges, the largest bench ever to sit in the

apex court. While the seer did not get the relief he wanted, the case became significant for its landmark judgment which clipped the widest power of Parliament to amend the Constitution and simultaneously gave judiciary the authority to review any amendment.

Former Judge of Madras High Court Justice K Chandru told PTI: 'The Kesavananda Bharati case is significant for its ruling that the Constitution can be amended but not the basic structure."

Senior Advocate Arvind P Datar said when some parcels of land of the Edaneer Mutt were acquired under the land reform laws of Kerala, Bharati moved the Kerala High Court against it and partially succeeded.

However, when the 29th


Constitutional Amendment was adopted by Parliament giving protection to Kerala laws, the seer moved the Supreme Court challenging it.

The apex court ruled that the 29th Amendment is valid and held that the two Kerala land Acts that were included in the Ninth Schedule are entitled to the protection of Article 31B of the (validation of certain acts and regulations) Constitution

The verdict had held that though Parliament has power to amend under Article 368 of the Constitution, it did not have the power to emasculate its basic features.

Besides Naidu and Modi, Union Minister V Muraleedharan, Madhya Pradesh Chief Minister Shivraj Singh Chouhan, Congress leader Abhishek Manu Singhvi, BJP Kerala unit president K Surendran were among those who paid rich tributes to the seer.

"Kesavananda Bharati Swamiji, the seer of Edneer Mutt was a rare blend of philosopher, classical singer and a cultural icon. His patronage of Yakshagana was crucial in reviving this traditional theatre form in Karnataka. #KesavanandaBharati," Naidu tweeted.





# **TRANSGENDERS STILL DEPRIVED**

The SSEPD dept is yet to update their online system to add transgenders as one of the beneficiaries of MBPY

Bhubaneswar, Sept 6: Notwithstanding 52 days since the state government allowed transgenders to be eligible for Madhu Babu Pension Yojana (MBPY), it has not yet enabled the system for accepting online applications from the community.

The State Social Security and Empowerment of Persons with Disabilities (SSEPD) department is the nodal agency for social sector pensions. This department July 16 notified that the transgenders from economically weaker backgrounds would be allowed to apply for the MBPY. The department also amended its rules for their inclusion to the list of eligible beneficiaries for MBPY.

However, close to two months after the announcement, the SSEPD department website has no options for the transgenders to apply for the pension benefits. The department is yet to update their online system to add transgenders as one of the beneficiaries of MBPY where the community members can click and apply. A scrutiny by this cor-

members are finding it very tough to apply for the pension despite the government notifying it two months back Many of us have visited the Puri District Social Security Officer (DSSO) for applying but neither online nor offline applications are entertained by the department," said Piyanshi Das, President of Puri District Transgender Association. Many DSSOs are reported to be telling the applicants that they have not received any notice from the department for getting them registered for the pension. Several other eligible members

from the community from other districts also narrated the same ordeal. The department in their notification dated July 16,2020 said that those from the community earning less than Rs 40,000 per annum and not having any family member with government job or taxpayers would be eligible for the

pensions. The department, however, said that it would be available shortly, 'We have recently announced the pensions for eligible members from the community. We are working on updating the website for online applications. The option for application for transgender pensions will be made available very shortly," Bhaskar Sarma, SSEPD department secretary told Orissa POST.

Booking for these trains will start from September 10. The special trains notified Sunday are Bhubaneswar-Durg-Bhubaneswar daily special, Visakhapatnam-Korba-Visakhapatnam via Rayagada daily special, Bhubaneswar-Ahmedabad-Bhubaneswar weekly special, Tiruchchirapalli-Howrah-

Tiruchchirapalli bi-weekly special and Guwahati-Bangalore Cantt triweekly special.

The tickets will be available on Reservation Counters and also IRCTC website. Other special trains running from New Delhi to Bhubaneswar, Bhubaneswar to Mumbai, Bhubaneswar to Howrah/Sealdah, among others will continue to run as notified earlier, said ECoR official.

# Now, Mahaprasad only for Puri residents

The Suar-Mahasuar Niyog Sunday took a decision to restrict the sale of Mahaprasad after receiving a suggestion in this regard from the district administration, sources said.

It is learnt that the Shree Jagannath

Temple Administration (SJTA) had decided to stop cooking of Mahaprasad for sale purpose due to the rise in the number of Covid-19 positive cases in Puri. Puri Collector Balwant Singh held discussions with the Suar-Mahasuar Niyog and sought their cooperation on the issue. "We have decided to cook less amount of Mahaprasad for sale purpose as per the direction of the SJTA. The temple delicacies would be sold to the residents of Puri city and the servitors' families only. We will not sell Mahaprasad to people outside the Holy City." said Suar-Mahasuar Niyog secretary Krushna Chandra Pratihari.

Pratihari further revealed that they would cook Mahaprasad for only 1,000-1,500 people. "Now, we require less number of workers to help us in the cooking of the temple delicacies. We have decided to restrict the sale of Mahaprasad to check the spread of novel coronavirus," Pratihari added.

It is worth mentioning here that Srimandir has been shut for devotees since March 20 this year. However, servitors have been performing the temple rituals amid the shutdown.

Even though the 12th century shrine has been closed for people since March, the Suar and Mahasuar servitors were selling Mahaprasad to the devotees. Many people used to congregate at the various gates of Srimandir to buy the temple delicacies. There were reports that the people did not maintain social distancing while buying Mahaprasad.

# **COVID-19 IS WORSENING IN STATE**

WITH 3,810 FRESH INFECTIONS ODISHA LOGS ITS HIGHEST SINGLE-DAY SPIKE IN COVID CASES SUNDAY

Bhubaneswar, Sept 6: The state registered its highest single-day spike in COVID-19 cases Sunday as 3,810 more people tested positive for the infection, while eight fresh fatalities pushed Odisha's coronavirus death toll to 546, an official of Health and Family Welfare (H&FW) department said.

The fresh infections have taken the state's caseload to 1,24,031, said the official.

As many as 2,286 new cases were detected in quarantine centres, while 1,524 people tested positive for the infection during contact tracing, added the official.

Odisha had reported its previous highest single-day spike of 3,682 COVID-19 cases August 27.

Khurda district, under which Bhubaneswar falls, registered the highest number of fresh infections at 797, followed by Bargarh (396), Cuttack (322), Jajpur (252), Jharsuguda (192) and Mayurbhanj (142), said the official.

Ganjam district reported the highest number of fresh fatalities at four, while Khurda, Koraput, Rayagada and Sundargarh districts registered one death each, the official pointed out. Ganjam has till date reg-

# blocks, virgin forests: Experts

Bhubaneswar, Sept 6: With the advancement in science and technology, economic and social development processes have been intertwined with the extraction of geological resources from beneath the earth crust. Unfortunately, mining of ores and minerals have been associated with the destruction of above-ground biological resources, viz. forests, biodiversity and their habitats. Mining operations and industrial processing lead to extensive pollution of air, water and soil, thereby deteriorating the environmental quality. It has been realised that exploitation of resources and their unrestrained utilisation should not be at the cost of the ecology and the focus needs to be on a rational mechanism, as has been envisioned in the Sustainable Development Goals of the UN.

Though Odisha has been blessed with diverse mineral reserves and presently the state has been aggressively pushing mining and industrial projects for economic benefit, it is happening at the cost of environmental degradation and loss of ecosystem sustainability. In such a scenario, the present decision of the state to undertake mining operations in virgin forests and put nine green-field mineral blocks of Sundargarh and Keonjhar districts with iron and manganese



reserves under auction would certainly not be the best option considering the long-term environmental and ecological sustainability. Environment experts opined this while participating in a webinar on 'Mining, Development and Ecology' organised by the Orissa Environmental Society (OES) Sunday.

In the webinar, Virendra Pratap Upadhyaya, former Advisor of MoEFCC stressed that the existing mine leases of Odisha have the potential to meet the targeted demand and instead of leasing out virgin mineral blocks in green-fields, mineral production can be enhanced by revamping these mines with the aid of advanced technology. This will maximise extraction and help in beneficiation of sub-

grade minerals that create huge waste-dump leading to loss of minerals and pollution. Emphasis needs to be laid on eco-restoration measures, and social security and economic upliftment of the local populace.

President of OES, Sundar Narayan Patro, urged the authorities not to act in haste unless cost benefit analysis is done in terms of ecosystem sustainability. It was resolved to communicate the recommendations of the webinar to the government for corrective action.



# BSF saves ailing woman's life in Maoist belt


### Siblings electrocuted in trap laid for boars

# Make cooling less polluting

he ironies of climate change are often cruel. In our warming world, for example, the demand for air conditioning (AC) and refrigeration is exploding, especially in developing countries. But more AC units lead to more warming, both from the refrigerant chemicals they contain and the electricity they use. Globally, cooling can account for up to half of peak electricity demand during the hot season, which is getting longer and longer.

A new report by the International Energy Agency (IEA) and the United Nations Environment Program (UNEP), based on data gathered by a team we co-chaired, shows that the transition to energy-efficient, climate-friendly cooling - using refrigerants that pose a lower global-warming threat - is technically and economically feasible. Adopting the best currently available technologies for both refrigerants and energy efficiency could eliminate the equivalent of up to 460 billion tonnes of carbon dioxide emissions by 2060, an amount equal to eight years of global greenhouse-gas emissions. By 2030, emissions equal to those of nearly 1,600 medium-size peak power plants would be avoided.

Eliminating the 'super pollutant' refrigerants known as hydrofluorocarbons (HFCs) is critical, as is increasing the energy efficiency of cooling equipment. Otherwise, emissions from this sector alone could use up the remaining 'carbon budget' for capping global warming at the 'safe' threshold of 1.5°C relative to pre-industrial times.

Here, the world's most successful environmental treaty, the Montreal Protocol, is a source of inspiration. The protocol, which was concluded in 1987 and entered into force in 1989, successfully addressed the first great threat to the global atmosphere: that chlorofluoro-Durwood Zaelke &

carbon refrigerants and related gases were destroying Earth's protective ozone layer. At the same time, the Montreal Protocol has

done more to reduce the climate threat than any other agreement - avoiding warming by an amount equivalent to that caused by all the carbon dioxide emitted in the twentieth century, which is more than half of all warming. These fluorinated gases are also powerful greenhouse gases - or climate super pollutants - with thousands of times more warming power per molecule than CO2. By eliminating

them, the Montreal Protocol not only put the ozone layer on the path to recovery, but also significantly slowed the development of the climate crisis. The Montreal Protocol's most recent mandatory measure is the 2016 Kigali Amendment, which aims to phase out HFCs, used primarily as refrigerants, and avoid up to 0.5°C of warming by 2100. The amendment's initial schedule ensures that about 90 per cent of this target will be reached. With the Kigali Amendment, the nearly 200 parties to the Montreal Protocol (including every UN member) also recognised the importance of improving the energy efficiency of AC units and other cooling equipment during the switch from HFCs to more climate-friendly refrigerants. Efficiency gains can more than double the Kigali Amendment's climate benefits by midcentury, while reducing energy generation and transmission costs by nearly \$3 trillion. They will also reduce consumers' monthly electricity bills, create jobs for installation and maintenance staff, and, by reducing air pollution, protect public health and agricultural productivity

The UNEP-IEA report highlights 10 policies that would help to realise these benefits. They include universal ratification of the Kigali Amendment (the milestone of 100 countries was reached in July), national cooling action plans, proven measures like minimum energy-performance standards and building codes, and aggregating demand for sustainable cooling through buyers' clubs and bulk procurement. This would help develop sustainable cold chains to reduce food loss and ensure effective vaccine dissemination. Improving service and maintenance is also essential, as is preventing inefficient AC units from being dumped in developing countries.

The enormous growth in cooling demand means we must act quickly. Today, an estimated 3.6 billion air conditioners, refrigerators, and related appliances are used worldwide; to meet the world's cooling needs, that number will more than triple, to 14 billion cooling units, by 2050.

Access to cooling is already becoming a leading climate and social justice issue around the world - especially in the many Asian, African, and South American countries that are subject to increasingly unlivable temperatures and already suffer from poverty, water shortages, and other related problems. For example, only about 7-9 per cent of Indian households have access to AC today, compared to 60 per cent in China and 90 per cent in the United States. In India alone, demand for AC will grow by more than a billion units over the coming decades. During this time, making cooling less polluting will be critical. Decreasing the cost, as India has done through its innovative bulk procurement program, will also be beneficial. We should all take courage from the Montreal Protocol's success in repairing the ozone layer and mitigating more warming from greenhouse gases than any other measure. All countries must now adopt common-sense initiatives to make cooling more efficient, less emissions-intensive, and more affordable for consumers. Most urgently, we must heed the latest understanding of the planet's sensitivity to continuing emissions and recognise that without rapid action, runaway climate change will be far harder to prevent. # **UNITY ACROSS FAITHS**

priceless gift from a friend in Kerala, a Namboodri to boot, is a film to augment my collection which has sustained my personal film festival to beat the unintelligible lockdown. The film, Agraharathil Kazhuthai, or Donkey in a Brahmin Village, was a pleasant shock; not because of the title, but its authorship. A baby donkey, whose mother has been beaten to death for reasons unknown, strays onto the doorsteps of a tall, lanky professor of Philosophy in a local college. Saeed Nagvi The donkey in the bachelor professor's house leads to amusement, gossip, graffiti until the principal, a stern looking pastor, informs the professor that his hos-**IT MAY NOT BE** 

pitality towards the donkey was affecting the college's reputation. The professor carts the donkey by bus and bullock cart to the Agraharam or the Brahmin village where his parents live. A deaf and mute maidservant looks after the

donkey. The maid has an affair with the village washerman, delivers a stillborn male child which is left outside the temple. The chief priest declares it the most dreadful omen, unanimously attributed by the elders to the donkey's presence in the village. The animal is beaten to death, followed by a series of unfortunate events which the Agraharam, on second thoughts. blames on the fact that the donkey was killed in haste. A monument to the beast is planned. A wild fire dance burns much of the village leaving the professor and the maid contemplating the scene for its deeper significance.

The reason for my focus on the film is not "cinema," but the fact that someone with a name like John Abraham could satirise the Agraharam with such outrageous audacity. In my limited experience-a day's visit-the Agraharam was quite stately in its austerity. I saw no car in the street nor, in the middle of the day, was there any

movement outside, dogs, cats, cattle, nothing. There is a lovely view of river Kalpathy below, like the Agraharam's private pond for a holy dip. Away from the road, on the stone seat were occasional bare bodied men, sporting the fattest 'janeyus' I have seen. The visitor's room has a mural size painting of Palghat Mani Iyer, the great mridangam player and a local icon. The centre of the main hall is dominated by a swing; every square inch of the wall space is covered with Gods and Goddesses.

At the end of the passage is a 'tulsi' plant in a decorated pot on a pedestal. The master of the house, a man of wit and music, had worn a shirt to appear hospitable. With amusement in his eyes, he showed us where he slept: on a narrow bed in the passage. And his wife? "On the floor right below me." He puts his head back and guffaws. But it is not quite so unequal. "She qualifies for the bed when she is unwell.<sup>2</sup>

I found it quaint, as an uncritical bird of passage would. But the Agraharam, like Peyton Place, would expose its darker side to a son of the soil, a few mohallas removed, like Abraham

It is all so refreshing this informality across faiths, this ability to tolerate irreverence without ill will. The most popular political prisoner in Adoor Gopalakrishnan's The Wall is Basheer, pining for Narayani on the other side of the wall and whom he has not seen. Adoor is quite unselfconscious about the fact that the protagonists belong to different faiths. My romance with "God's Own Country" goes back to the 70s when I was editor of The Indian Express in the south. But a change has come upon me: earlier I admired Kerala, indeed much of the South; now I have begun to envy it.

India was always one country, but the basic affiliation was with Awadh of which Lucknow was the markaz or centre. Mir Taqi Mir talked of Delhi's destruction: "Dill jo ek shaher tha alam mein intekhab

rehte thay muntakhib hi jahan rozgar ke

Usko falak ne loot ke barbaad kar diya Hum rehne waley haen usi ujre

dayar ke. (Delhi which was once the world's pride, where only those

with good manners lived, Fortune turned upon the city, destroyed and looted it. In that desolate city did I once live)

Delhi with Replace Awadh/Lucknow and you are somewhere near the root of those ogres in the mind.

Lucknow, indeed Awadh, was generosity personified. Ram Advani from Sindh was embraced as Lucknow's very own. His book shop was an incomparable cultural landmark. Among the Lucknavi's several quaint beliefs: to be a lawyer or a doctor, you had to be a Bengali first. For obvious reasons, western enlightenment had come to Bengal first. Riding this belief, Bengali lawyers and doctors had easy passage in Lucknow. The intellectual life of Lucknow University was dominated for long stretches by Radha Kumud and Radha Kamal Mukherjee. Little wonder, when Satyajit Ray, soaked in Bengaliness, ventured out of Bengal, it was towards Lucknow he deviated with his superb Shatranj Ke Khiladi.

The ogres of the mind have been gestating for at least 30 years when the BJP and the Congress began to compete for the Hindu vote. Congress chose to play both sides of the street. Once, VP Singh tossed the Mandal Commission into the simmering cauldron, the Hindutva brigade ran away with the platform of brazen anti-Muslim Hindu consolidation, leaving the Congress sleeping by the lamp post with its soft saffron.

There is a certain demoralisation in the anti-Hindutva ranks at the presumed invincibility of Narendra Modi, despite the country crashing on every count. This may well be a function of shrewd tactics: keep the media focus away from regions where the country still breathes easy. It may not be such a good thing, though, for national cohesion if different parts of the country

All these measures helped to minimise the human death toll from cyclones, such as Fani and Amphan. However, Odisha's recent flood impact shows that these measures are not adequate. A 2020 article published in the Environment. Development and Sustainability empirically shows that the contemporary level of economic development in districts is not adequate to mitigate flood fatalities in Odisha. The government would do well to devise a long-term flood management policy along with building flood-resilient infrastructure such as construction and monitoring of river embankments, construction of canals, and improving river connectivity. Other measures include installing a flood warning system in coastal districts, providing pucca houses to beneficiary households, and creating a massive community awareness campaign. More than any other word, tiffin, meaning lunch or any light meal, evokes British India. It entered the language at the very beginning of the nineteenth century, perhaps because the English fashion for eating dinner mid-afternoon was giving way under the influence of the Indian climate to a main meal taken later in the day, requiring a lighter midday meal and a name for it. Why the much older luncheon wasn't used isn't clear. Instead, the English in India borrowed tiffing, an old English dialect or slang word for taking a little drink or sip. (I forbear from suggesting that the habit among some sahibs of drinking their lunch had something to do with the popularity of the term.) The word is still widely used in India for any hot light meal or snack taken at any time during the day. In Mumbai (formerly Bombay), the term tiffinwallah is sometimes heard, though the more common term is dabbawallah. Lunches are cooked at home by workers' wives and then transported, often by train, perhaps 20 or 30 miles to their husbands' workplaces, each three-tiered tiffin-carrier or dabba probably passing through several hands in a sophisticated and efficient cooperative process. Those who deliver the meals by bicycle on the final stage of their journeys are the tiffin-wallahs or dabbawallahs.

According to a report from the Ministry of Home Affairs (MHA), 34 persons have been killed due to floods, 4.3 million people have been affected, and 0.12 million have been evacuated in or from 7,528 villages across 27 districts from June 1 to September 2. Moreover, 12,447 houses were damaged as also around 0.38 million hectares of crop area. This was one of the devastating floods that Odisha experienced after the 1999 Super Cyclone. The heavy rainfall in the Mahanadi river's upper catchment areas and the breaching of river embankments at various locations led to flooding in different coastal districts.

Odisha is highly vulnerable to various natural disasters due to its unique geo-climatic conditions. A high degree of socioeconomic vulnerability, inadequate mitigation measures, low levels of economic development, higher poverty, and high dependency on the agricultural sector have further accentuated the damage caused due to natural disasters.



Kolkata, Sept 6: A professor of Jadavpur University has been subjected to casteist attacks on social media for a post about conducting final semester exams during the COVID-19 pandemic.

Jadayour University Teachers Association (JUTA) and All Bengal University Teachers Association (ABUTA) Sunday condemned the "vicious casteist trolling" of Maroona Murmu, an associate professor of history of JU for an innocuous post on Facebook.

September 2, Murmu was subjected to a volley of casteist abuse on social media when she wrote in a Facebook post about the need to postpone the final semester exams as "one year cannot be more precious than someone's entire life.'

This triggered a comment by a



third year student of Bethune College on her wall that "such thinking stems from quota-centric state of mind" implying that Murmu had academically benefitted being a tribal. A hurt Murmu, who did her undergraduate studies at Presidency College before doing research at

JNU, expressed anguish in her reply how her opinion as an individual was ignored by a female student and wondered if someone can be called incompetent and undeserving if he/she carries a tribal surname.

This invited more trolling as

many others supported the young third year student of Bethune College while support also poured in for the professor.

The Bethune College Students' Committee posted a statement on social media saying, "it is extremely disheartening and condemnable that a student of our college is still unaware of the caste dynamics in India and the need of reservations for the underprivileged. The incident in question is extremely shameful and has brought the institution into disrepute.

'Therefore on behalf of the students of Bethune College, the students committee unequivocally condemns, the comment by the third year student of the institution and resolves to stand by Dr Murmu and the struggle of all Dalits in our campus, state and country," the statement said.




A view of the West Bengal Legislative Assembly in Kolkata, Sunday. A two-day session of the state assembly will commence from September 9 with certain restrictions

public salon, where men from all communities can get their hair cut

Idukki, Sept 6: Raman (name changed) has a postgraduate degree and a job at a reputed private company to boot. But that's not enough for him to get his hair cut at any of the barber shops in his village. Reason: The salons are frequented by upper caste people and Raman belongs to the Chakkliya community.

In Vattavada, a village located in the rainshadow area of the Western Ghats in Idukki, higher caste people have announced a blanket ban on Dalits accessing services at salons visited by them.

"Barbers in the village have been pressured by the upper caste," sources said. This practice has been common in Vattavada, an area dominated by Tamil settlers. The ancient customs practised in neighboring Tamil Nadu are followed more here. Even the Dalits hardly

raise any voice against it. It was only recently that some Dalit youths from the village decided to complain to the panchayat authorities about such discrimination. But the barbers continued to refuse and said they preferred shutting their shops to cutting the hair of Dalits. Eventually, two barber shops in Vattavada were closed by the panchayat authorities five months ago. Dalit men from the village continue to get their hair cut at salons in Munnar or Ellappetty, both nearby towns

Earlier, bizarre practices like serving food in coconut shells or keeping separate tumblers for dalits in tea shops existed in Vattavada. Thanks to the joint efforts of local politicians and social workers, those



practices were put to an end by 1990. Vattavada has a population of 270 families from the Chakkliya community and the rest belong to the Mannadiyar, Maravar, Thevar and Chettivar communities. Vattavada panchayat president

Ramaraj said, "The practice of lower

caste men cutting hair in separate salons has been there in Vattavada for nearly a century now. However as per the request of some Dalit youngsters, we convened a meeting with the community representatives recently to take a decision on the issue. But the barbers were

adamant that they would not cut the hair of people from the Chakkliya community. The shops were closed following this," he said.

To curb the discrimination, Ramaraj said the panchayat would soon open a public salon near the bus stand at Koviloor, where men from all communities can get their hair cut. Although the issue of higher-caste men staying away from public salons still remains a question, Ramaraj said people belonging to upper castes, including him, will get their hair cut at the salon so that it will become a model for others to emulate.

Moreover, the panchayat has also decided to appoint a barber with progressive thinking from the barber community in Vattavada at the salon so that it will help others of his community change their mindset.

"The agency (NIA) has summoned me as a witness in the case, under section 160 CrPC. Therefore, there are no charges against me. I have no connection with this case as I have never been to Bhima Koregaon. I wasn't even aware of the incident till I read about it in the newspapers," he told PTL

The National Investigation Agency (NIA) has issued a notice to Ray, who is also the convenor of Persecuted Prisoners Solidarity Committee (PPSC) West Bengal unit, asking him to appear for questioning in its Mumbai office on September 10 in connection with the Bhima Koregaon violence. The case pertains to an incident

of caste violence that took place near the Bhima Koregaon war memorial on January 1, 2018.

Several vehicles were torched and one person killed in the incident, triggering large scale dalit agitation in Maharashtra.

"This is nothing but a tactic to harass and intimidate me, as is being done with academics and intellectuals all over India. I am a biomedical scientist who has been involved in the battle against COVID-19," he said.

# **Rhea grilled for six hours by NCB**

Mumbai, Sept 6: Bollywood actor Rhea Chakraborty, who was steeling herself for possible arrest by the NCB Sunday, was allowed to leave the anti-narcotics agency's office here after a gruelling six-hour-long session of questioning.

She is likely to be summoned again Monday as the National Control Bureau (NCB), which has arrested her brother Showik Friday, continues its investigations in the drugs angle emerging in the Sushant Singh Rajput case.

As per preliminary information, Rhea was mostly questioned by the NCB sleuths on the narcotics angle now shrouding Sushant's death. Rhea, who did not appear to be flustered as she stepped out, underwent interrogation by several teams of NCB sleuths at the agency's Zonal Office on the third floor of the Exchange Building in Ballard Estate, before they finally permitted her to go home after 6 p.m. in her own vehicle.

Earlier on Sunday, a NCB team including Sameer Wankhede, who is heading the investigation, and a woman official had gone to pick up Rhea at her home in PrimRose Apartments in Santacruz but she opted to go in her own car along with a Mumbai Police escort, amid speculation that she would be arrested.

PTI PHOTO The 28-year old actress, who has already been questioned by the Central Bureau of Investigation and Enforcement Directorate, reached the NCB office for questioning, a day after her brother was sent to NCB custody till September 9.

Besides Showik, Sushant's house manager Samuel Miranda, domestic help Dipesh Sawant, and drug peddlers Abdel Basit Parihar and Zaid Vilatra are also in NCB custody. In a statement, released through her lawyer Satish Maneshinde, Rhea said she was "innocent" and would fully cooperate with the investigations.

"Rhea Chakraborty is ready for arrest as this is a witch-hunt and if loving someone is a crime, she will face the consequences of her love," Maneshinde said. He added that being innocent, she has not approached any court seeking anticipatory bail in all the cases foisted by Bihar Police, now with the CBI, the ED and the NCB.

In a statement late Saturday, Rhea and Showik's father, Lt Col Indrajit Chakraborty (retd) condemned his son's arrest by the NCB

"Congratulations India, you have arrested my son, I'm sure next on the line is my daughter (Rhea) and I don't know who is next thereafter," he said.

The leaders have urged the Congress high command to open channels of communication with senior leaders. They have warned that if it continues to turn a blind eye to the prevailing state of affairs, the Congress would hit rock bottom in UP which was once the party's stronghold. The letter comes at a time when the party is already facing its worst factional divide in Uttar Pradesh. While the senior leaders have withdrawn from party activities, the younger leaders have accused the UPCC leadership of promoting caste interests.

In order to maintain social distancing, the NTA has increased the number of centres from 2,546 to 3,843 for the National Eligibility cum Entrance Test (NEET) while the number of candidates per room has been reduced from earlier 24 to 12.

'For ensuring social distancing outside the examination hall, the entry and exit of candidates has been staggered. Adequate arrangements have also been made out-



side the examination centres to enable candidates stand with adequate social distancing while waiting," a senior NTA official said. "Candidates have also been is-

sued an advisory guiding them about the 'dos and don'ts' for proper social distancing. We have also written to states governments to extend support in local movement of the candidates so that they are able to reach their examination centres on time," the official added. Making hand sanitisers avail-

able at the entrance of the examination centre and inside the exam hall at all times, replacing the process of checking the admit cards of candidates with barcode

readers, increasing the number of examination centres, alternate seating plans, fewer candidates per room and staggered entry and exit are among the steps the NTA has taken

"While all the candidates will be asked to go to the exam centres with masks and sanitisers, once they enter the centre, they will have to use the masks provided by the examination authority. "Each candidate will be offered a threeply mask at the time of entry and are expected to wear the same during the examination in order to avoid any form of unfair means at the time of examination," the official added.

Jabalpur (MP), Sept 6: The Netaji Subhash Chandra Bose Medical College and Hospital (NSCBMCH) in Jabalpur in Madhya Pradesh has established live interaction with families to curb depression and suicidal tendencies among COVID-19 patients.

The experiment began after two coronavirus positive patients tried to kill themselves at the state-run facility. "Since September 1, we are allowing the patients to meet their family members to do away or minimize depression which they undergo during treatment," NSCBMCH Dean Dr PK Kasar said Sunday.

"A glass partition with a hole that separates patients from kin is in place for the interaction. Already, more than ten patients have talked to their families. We are studying patient behaviour and pros and cons of the interaction," the dean added.

September 4, a 65-year-old patient had committed suicide,

The experiment began after two coronavirus positive patients tried to kill themselves at the state-run facility

though he had met with his family before he took the extreme step, said Kasar. "Our staffers have also averted two suicide bids in August. This made us sit up and give serious thought to this issue. We roped in psychiatrists to talk and comfort these patients. We then started arranging such interactions following all protocols in place to stem the outbreak," he

Currently, 260 people are undergoing treatment for the infection at NSCBMCH, Kasar informed. As on Saturday, the district has 1,139 active cases, while 96 people have died of the infection.

Ahmedabad, Sept 6: A 6-yearold boy suffocated to death after accidentally getting trapped inside a car parked by the roadside for a few hours in Ahmedabad Sunday, police said.

The boy's mother, a domestic helper, was taking him along to her place of work around 10 am, when he entered the car parked on Airport Road without her knowledge, police said.

The minor, identified as Ajay Saraniya, entered the vehicle out of fun, but accidentally got himself locked inside, an official of the Airport police station said. "His body was found inside the car around 1 pm. Prima facie, he appeared to have died of suffocation as he remained locked inside the car for a few hours," police inspector R R Desai said. "After the boy got into the car, the boy's mother went ahead thinking that he was following her. But after she failed to spot him behind after going some distance, she started looking for him all the way back to her home, but failed to trace him." he added.

#### Man ends life

Kota (Raj): A 40-year-old man allegedly hanged himself from a tree after a fight with his wife in Rajasthan's Baran district, police said Sunday. The incident took place in Goverdhanpura village Saturday night, they said. The body of Gyanchand Sahariya, a resident of Ranibarode village, was found hanging from a tree at an agricultural field near his in-laws' house, police said. Sahariya was living with another woman. He, however, had been staying with his wife for the last one month at his in-laws' house, said Station House Officer (SHO), Bhanwargarh, Vijendra Singh.

#### Centre may buy 200 mn doses of vaccine

The world is after the Covid vaccine and spending billions of dollars in research and creating facilities for the killer virus. But the Indian government is still in the process of making up its mind. But one thing is clear that India will buy 200-300 million doses of Covid vaccine being developed world-over. The figure emerged during a close-door

meeting that the Indian Vaccine Association members had with the top government officials. Four vaccines are in the trial-3 stage and will go into mass production and mass consumption will be permitted only after it is cleared by various regulatory authorities world-over. The PM's Task Force on vaccine had given clear indications that India may need anywhere between 200-300 million doses. India has not made any advance purchase commitments while the US, UK, European Union, Switzerland and Japan have paid and committed \$5 billion to global drug companies.

#### Govt clueless

With the rise in the number of Covid-19 cases in India, experts are keeping their fingers crossed as to when India will touch its peak. All government estimates including that of the one by Dr V K Paul,

head of PM's Task Force on Covid, has gone for a toss. As the festive season is fast approaching, the government is fumbling over giving any future prediction. Privately, officials admit tally could cross one lakh cases a day. In fact, Massachusetts Institute of Technology had said in its June, 2020 study that India could see up to 2.87 lakh cases a day by 2021 on the basis of mathematical models, if a cure or vaccine was not found. But the Union Health ministry debunked it saying, "mathematical models do not take into account the efforts and interventions taken by governments.

# **TWO YEARS AFTER SECTION 377 VERDICT**

# **IMUNITY STILL BATTLING PREJUDICE**

THE JUDGEMENT WAS WIDELY WELCOMED BY MOST SECTIONS OF SOCIETY, ESPECIALLY THE YOUTH WHO CALLED IT A VICTORY OF LOVE

New Delhi, Sept 6: The Supreme Court, in a landmark judgement September 6, 2018, unanimously struck down part of the Section 377 of the Indian Penal Code (IPC) which criminalised gay sex, saying that it violated the constitutional right to equality and dignity.

Section 377 declared "carnal intercourse against the order of nature" punishable by imprisonment for life. The judgement was widely welcomed by most sections of society, especially the youth who called it a victory of love.

Shubhankar Chakravorty, a Bengaluru-based writer, says the next move should be to extend the same civil rights to the LGBT population that the straight popula-

tion enjoys. "LGBT people are too taxpaying, law-abiding citizens, they have every right to the same

Things have surely changed. LGBT people are now more confident to express themselves, grow personally, and own their relationships without the fear of discrimination and harassment. However, this change has primarily been for the urban, privileged few. Also, the lives of transgender people have not reallv improved much," Chakravorty said. Bittu Kondaiah, a trans-man, agrees with Chakravorty that the SC verdict did not do much for the

Anjali Gopalan, a member of Naz Foundation, an NGO that has been at the forefront of the battle against Section 377, said the community



transgender community.



has become a lot stronger since the verdict but there are more rights that it needs to be given.

"The LGBT community does not have any rights per say which society takes for granted like the

right to marriage, inheritance so these are rights that should be there for everyone in society. Unfortunately, the LGBT community has been left out of it and that is something that needs to happen," she said.

Tripti Tandon, lawyer and deputy director of Lawyers Collective, said it has been seen that the judgement gave many from the LGBT community the confidence to live their lives on their own terms.

Divya Dureja, a counselling psychologist and LGBTQIA+ wellness advocate, said there are still inadequacies in the "free and fair rights" of the LGBTQ community members.

"When will the state begin to recognise non-hetrosexual unions? How do we address the homelessness. bullying, violence, workplace discrimination still being faced by the members of the LGBTQ community and how can you give support to queer population drowning in mental health conditions," she asked. She said even though the gay community has found some respite from being targeted now that Section 377 has been struck down, crimes and harassment against trans folks and lesbians still continue under the present laws.

Akhila Sivadas, the managing trustee and executive director of the Centre for Advocacy and Research (CFAR), a non-profit organisation said while the significance of this ruling to decriminalise homosexuality cannot be reduced, the process of social inclusion and acceptance now assumes even greater importance.

Lawyers for Assange and the US Government are scheduled to face

off in London Monday at an extradition hearing that was delayed by the coronavirus pandemic.

American prosecutors have indicted the 49-year-old Australian on 18 espionage and computer misuse charges adding up to a maximum sentence of 175 years. His lawyers say the prosecution is a politically motivated abuse of power that will stifle press freedom and put journalists at risk.

Assange attorney Jennifer Robinson said the case "is fundamentally about basic human rights and freedom of speech.'

"Journalists and whistle-blowers who reveal illegal activity by companies or governments and war crimes - such as the publications Julian has been charged for - should be protected from prosecution,' she said. American prosecutors say Assange is a criminal, not a free-speech hero.

They allege that Assange conspired with US Army intelligence analyst Chelsea Manning to hack into a Pentagon computer and release thousands of secret military files.

Anti-government protests have been held in Hong Kong almost every weekend since June 2019.

Mumbai, Sept 6: The much-awaited festive season is unlikely to bring any cheers to the travel industry, including the airline sector, as less than 20% of people polled plan to travel during October-November amid the pandemic, a survey said.

The festive season in India falls between October and November every year during which festivals such as Dussehra, Durga Puja and Diwali are celebrated. Moreover, the majority of those having travel plans said that they do not want to make their booking till they get closer to their travel date, according to the survey conducted by online platform LocalCircles.

Television replays suggested the goal should have stood with Kane in an onside position but there was no VAR technology in use to check the decision.

Ferrari's abysmal weekend continued as Sebastian Vettel had a brake failure on lap seven and he limped into the pits with his rightrear brake disc in flames. It was the four-time champion's first did not finish (DNF) at Monza in his 14th start.
