Serum Institute pauses Covid vax trials in India

New Delhi, Sept 10: The Serum Institute of India, which is manufacturing the coronavirus vaccine Covishield being developed by the Oxford University along with pharma major AstraZeneca, said Thursday it will stop Phase 3 trials that were to begin in India next week. AstraZeneca stopped vaccine trials across four nations as a precautionary measure after a volunteer in the UK showed some potentially adverse symptoms.

The Serum Institute, headed by Adar Poonawalla, was issued a showcause notice by the country's drug controller DCGI Wednesday, which questioned why it was continuing the trials in India though it has been stopped elsewhere. The DCGI also questioned why it has not received a report detailing the symptoms of the patient in the UK.

"We are reviewing the situation and pausing India trials till AstraZeneca restarts the trials," read a statement from the Serum Institute, which was still doing the groundwork for the trial including listing volunteers. The trials were to be held on 1,600 volunteers across 17 sites in India and were expected to begin next week. "We are following DCGI's instructions and will not be able to comment further on trials. You can connect with DCGI for more updates on this front," added the statement.

After the DCGI notice, the Serum Institute had said Wednesday evening,

"We are going by DCGI's direction and so far were not told to pause the trials. If DCGI has any safety concerns, we will follow their instructions and abide by the standard protocols."

1,350 kg cannabis from state seized in Karnataka PRESS TRUST OF INDIA

Bangalore, Sept 10: Even as the Central Bureau of Narcotics has been in the news for probing drug use by celebrities, a large haul of cannabis, reportedly having its origin in Odisha, was seized in Karnataka recently.

In the ongoing drive against drugs, 1,350 kg of cannabis was seized from a farmhouse in Kalaburagi, over 600 km from here, police said Thursday.

Four people have been arrested in this connection, the police said. On August 30, 37-year-old autodriver Jnana Shekhar allegedly selling cannabis here, was caught, they said. During interrogation, the auto-driver revealed that he got the consignment from a 22-year-old farmer Siddhunath Lavte of Sindagi Taluk in Vijayapura and the latter was also arrested.

Based on the inputs provided by him, police seized 150 kg of cannabis in Kamalapura in Kalaburagi. While investigating the case, police found that the kingpins of the racket Chandrakanth and Naganath reside in Kalaburagi, who were arrested September 8.

Interrogation revealed that Chandrakanth had stored 1,350 kg of cannabis in his farmhouse in Kalagi Taluk of Kalaburagi district. Chandrakanth told police that he used to bring cannabis in packets from Telangana under the pretext of transporting vegetables. Police said there is huge supply of cannabis in Telangana from Odisha. **MORE P7**



Cats 'catching' nCoV at far higher rates than thought

NONE OF THE CATS TESTED POSITIVE FOR COVID-19 OR DISPLAYED SYMPTOMS AND NONE OF THESE FELINES HAVE DIED

Beijing, Sept 10: Chinese researchers have found that cats may be catching the novel coronavirus at far higher rates than thought before, which could mean they have unique ways of fighting off the virus.

Researchers from Huazhong Agricultural University, in the Chinese city, took blood samples from 102 cats. Nasal and anal swabs were also collected.

The study, published in the journal Emerging Microbes & Infections, shows Covid-19 antibodies present in 15 of the blood samples taken from the cats. Of these, 11 cats had -neutralizing antibodies - proteins that bind so successfully to a virus they block the infection. None of the cats actually tested positive for Covid-19 or displayed obvious symptoms and, according to the results of return visits, none of these felines have died, the study said. The sample of cats looked at included 46 abandoned from three animal shelters, 41 from five pet

cluded 46 abandoned from three animal shelters, 41 from five pet hospitals, and 15 cats were from Covid-19 patient families.

The three cats with the highest levels of antibodies were all owned by patients who had been diagnosed with Covid-19, whilst there were also signs of cats being infected with the virus by other cats from those that were abandoned or based in the pet hospitals.

The research team stated that whilst there is currently no evidence for cat-to-human transmission,



precautions should be considered. "Although the infection in stray cats could not be fully understood, it is reasonable to speculate that

these infections are probably due to the contact with SARS-CoV-2 polluted environment, or Covid-19 patients who fed the cats," said study lead author Meilin Jin.

The team assessed the type of antibody reactions in thorough detail and was able to describe the dynamic characteristics of the antibodies found.

Amongst many discoveries within the antibodies, they saw that the type of reaction produced by the cats resembles those observed in seasonal coronavirus infections, implying that the cats that have had SARS-CoV-2 infection "remain at risk of re-infection". The authors stated that this is a similar transient antibody response to also be observed in humans and that their study should be used going forwards as a "reference for the clinical treatment and prevention of Covid-19". pandals/mandaps

Bhubaneswar, Sept 10: Following a directive of the Orissa High Court, the state government has allowed observance of Durga Puja, Laxmi Puja, Kali Puja and other pujas during September to November, but with certain riders.

Though all religious places are closed for the public till September 30, the government has allowed observance of pujas during next three months in compliance with the high court's directive.

"Having regard to the order dated 31.8.2020 passed by the High Court in WP(C) PIL No 21016/2020, the state government hereby directs that the guidelines shall be followed for observance of Durga Puja, Laxmi Puja, Kali Puja and other similar Puja during September, October and November of 2020," Chief Secretary Asit Tripathy said an order issued Thursday.

For conducting pujas in puja pandals/mandaps, the organisers will have to apply and obtain necessary permissions from the district Collector or other officers authorised by him/her. For Cuttack and Bhubaneswar, the Police Commissioner or any other officer authorised by him will grant the ter and spirit. This year, the government has also banned immersion procession and musical or any other entertainment programme for the pujas. The idols will be immersed in artificial pond created by the local administration for the purpose. District collectors, municipal commissioners and Police Commissioner have been instructed to ensure strict enforce the guidelines. Any person violating these measures will be liable to be proceeded against in accordance with the provisions laid down under Disaster Management Act, 2005,

New Delhi/ Bhubaneswar, Sept 10: Union Petroleum Minister Dharmendra Pradhan Thursday dedicated 56 compressed natural gas (CNG) stations to the nation through videoconferencing.

The newly-commissioned CNG stations will strengthen the efforts to have a clean and green future for the country, Pradhan added.

The Petroleum Minister claimed that Prime Minister Narendra Modi is committed to provide affordable and clean fuel to all. "Today, many CNG stations have been ded icated to the nation. Efforts are on to make India a gas-based economy. A target has been set to provide natural gas to 5 crore houses in the country through pipelines,' Pradhan said

The Union Minister further revealed that a plan has been chalked out to set up 100 LNG stations along the Golden Quadrilateral. This apart, the Government of India is progressing towards establishment of 5,000 compressed bio-gas plants across the country, he added.





Coming soon: Certificates to be stored in DigiLocker

Bhubaneswar, Sept 10: As part of 5T model of governance, the state government has planned to issue higher education certificates and mark-sheets online from next financial year.

Higher Education secretary Saswat Mishra Thursday asked the vice chancellors of all state-run universities and principals of all government and non-government autonomous colleges to mandatorily use National Academic Depository (NAD) for online issuance of academic certificates and mark-sheets.

Under the Odisha Right to Public Services Act-2012 (ORTPSA), academic certificates and mark-sheets are mandated to be issued to students within stipulated time.

"Under the 5T initiative, the state government has decided to convert more and more physical service delivery systems to online service delivery systems. Therefore, universities and colleges need to switch over to online service delivery system at the

Universities, autonomous colleges have been asked to use the **National Academic Depository system** before March 2021

earliest," Mishra wrote to the VCs. All universities and colleges were instructed to use NAD instead of each institution individually developing its own online service delivery module.

NAD is an initiative of Ministry of Education (erstwhile Ministry of Human Resources Development) to facilitate digital issuance, storage, access and verification of academic certificates issued by academic institutions. NAD intends to do away with difficulties/inefficiencies of collecting, maintaining and presenting physical certificates. UGC is the authorised body for implementation of NAD

Nitish rings Naveen to back RS dy chief pick

Bhubaneswar, Sept 10: With only four days remaining for the election to the Rajya Sabha Deputy Chairman post, Bihar Chief Minister Nitish Kumar Thursday dialled his Odisha counterpart Naveen Patnaik seeking his support for NDA nominee Harivansh Narayan Singh for the post.

Harivansh, a Janata Dal (United) MP, filed the nomination for the post Wednesday.

JD(U) chief Nitish Kumar requested Patnaik to extend the BJD's support to Harivansh Narayan Singh for the post, a source at the Chief Minister's residence, 'Naveen Niwas', said. Patnaik's BJD had supported Harivansh in the last election as well, he said.

Further word from the BJD president has not been received so far, the source said. The monsoon session of the Parliament is scheduled from September 14 to October The election for the Deputy Chairman's post is likely to be held on the first day of the session. The nomination filing process began on September 7 and will conclude September 11. The election for the

post was necessitated as the incumbent Harivansh completed his term as a member of the Rajya Sabha earlier this year. He was sent to the Upper House of Parliament again from BIhar.

In 2018, he had defeated Congress's BK Hariprasad and was elected the deputy chairman. Harivansh is likely to be re-elected to the post as BJP floor managers are confident of securing the support of about 140 MPs, including the fence-sitters YSR Congress, TRS and BJD. The strength of the BJP-led NDA has also gradually increased to more than 114 in the house with an effective strength of 244 members as there is one vacancy.

Floor managers of NDA are trying to build a consensus among all parties so that Harivansh could be elected unanimously.

The Congress has decided that the opposition will put up a joint candidate for the post and it will reach out to various parties in this regard.

BJD has nine members in Rajya Sabha of the 10 seats from Odisha, while the other one is held by the BJP. BJP's Ashiwini Baishnab was elected to Rajva Sabha with the support of BJD in June last year.

As per the agreement, BMC shall pay Rs 5,750 per vehicle to Jagruti for collection of bio-medical waste in the city in a month.

"Though the government has scaled up MGNREGS by issuing job cards to migrant labourers and providing jobs through convergence with different departments and specially run schemes, it is still insufficient to cater to the growing demand and respond to the requirements of skilled and semi-skilled workforce," said Focus Odisha Foundation, Director Sudarshan

keynote address.

Flood havoc in Jajpur: RD pegs losses at ₹21.29-cr

₹12.39-CR SOUGHT FOR REPAIR AND RESTORATION OF BREACHES ON VARIOUS EMBANKMENTS

Jajpur, Sept 10: The rural development department in Jajpur has suffered massive losses due to recent floods from the Brahmani, Baitarani rivers and their distributaries.

An assessment report prepared by the rural development division-II (Jaraka) said, the loss of the rural development was estimated at ₹21.75 crore. 141 projects including roads, bridges, embankments, buildings were damaged by floodwaters.

The report also put forth some post-flood repair measurers and restoration of these infrastructures.

There are 154 projects of the rural development department. Roads/embankments with 174.890 km are included in these projects. The floodwaters have created 25 major breaches in roads between August 26 and August 29, for which the department has sought ₹12.39 crore for repairs and restoration.

The report submitted to the engineer-in-chief said that ₹19.81 crore

Differently-abled elderly woman, son charred to death

Keonjhar, Sept 10: A differentlyabled elderly woman and her son were charred to death in a fire that broke out in their house at Kalinga village under Hatadihi block in Keonjhar district late Wednesday night.

The police recovered the bodies Thursday morning. The deceased have been identified as Janjali Jena (70) and Banamali Jena (45). They were living in an abandoned Anganwadi centre.

While local people were clueless as to who killed the motherson duo, police's preliminary investigation suggests that they were set afire by some miscreants



According to the police's preiminary investigation. like anv other day, they went to sleep after having their dinner Wednesday night. They woke up to some unusual sound in the dead of night. At that time, miscreants had broken into a nearby shop. It was when they realized that the woman and her son had seen them enter the shop: they feared that the duo might inform the police. They then locked the centre and set it on fire, resulting in the mother-son duo being charred to death Some local people could smell something burning inside the house and informed Nandipada police. The police recovered the bodies and seized them for post mortem The incident irked the local people who staged a road blockade on Salania- Orali road, demanding immediate arrest of the miscreants. Further investigation is underway.

Similarly, the RD has also sought ₹36.50 lakh for repair of 13 buildings belonging to the rural development department, the revenue department and the education department.

The RWSS has suffered the worst due to floods. There are 17,261 tube wells in 10 blocks of the district out of which 6461 were affected by the floods. Of the 237 drinking water projects, 120 were damaged. Meanwhile, 30 of the drinking water projects have been repaired.

Bamboo shoots to tickle your taste buds Device to measure 'pulse of plants' invented in Sambalpur POST NEWS NETWORK

Sambalpur, Sept 10: Three scholars from Sambalpur district have invented an instrument which can measure the exact pulse rate of plants. The device will help calculate exactly the amount of pesticide needed to keep a plant healthy. In the process unnecessary expenditures will be reduced.

The device is called 'Rhythm Metre for Plant'. It has been developed by Akshav Kumar Mishra. Lecturer of Mahamaya Degree College, Pradosh Acharya, Professor of Gangadhar Meher University and Aishwarya Khamari a research scholar of Sambalpur University.

"The device is otherwise known as 'Organic Watch'. This project has made it to the top four cate-



gories at the 'Rural Experience Programme' in '3M-CII Young Innovators Challenge Award'. The instrument can also provide data about plants' biological clocks and rhythm and nutrient intake", team leader and scientist Akshay said.

"Through the device, the nutritional value of pond water can also be measured, which will extensively help fish farmers in Odisha. It was developed by Akshay Mishra, Lecturer of Mahamaya College, Pradosh Acharya, Prof of GM varsity and Aishwarya Khamari a

Chronic problem

atural disasters such as floods and cyclones are routine in Odisha. There has been hardly a year when we have not seen a natural calamity, big or small. The frequency of such disasters has gone up with time due to fast-paced climatic changes. Since the Super Cyclone in 1999, Odisha has seen half a dozen major cyclones and the government has given a good account of itself with regard to its handling of pre- and post-cyclone situations. The state government has gathered enough expertise in handling the situations. Over the years, it has evolved a tested template to minimize the loss of lives and properties due to cyclones. However, the same is not the case with regard to floods. The government's record with regard to flood management has left much to be desired. Floods are regular phenomena here. Breaches on the river embankments are regular. The administration has not been able to identify the vulnerable areas even though breaches take place year after year. Even after they are identified, repairs do not happen. Worse, after repairs are carried out they are not failsafe against floods

Odisha is an agrarian economy. Over 75 per cent if its people depend on farming for their living and livelihood. This number is likely to go up as lakhs of unemployed youths, who had gone outside the state for livelihood, have returned home. Jobless for most part of the year and a majority of them not willing to go back to their workplaces, they have very little option but to turn to farming. A bulk of the farmland across the state is rain-fed. Except for western Odisha, most of the farm land in the state are non-irrigated and hence depend on monsoon. Inasmuch as paddy is the main crop here, monsoon and the consequent floods make and break the fortune of farmers here every year. The state is blessed with a network of large rivers. However, an absence of proper infrastructure on rivers to tame floods and similar calamities has rendered them unruly. Floods in September and October damage grownup crops. Lakhs of hectares of farmland get inundated with floods. Roads, bridges and communication lines are destroyed. Villages in hundreds get marooned. People in rural areas are more prone to such disasters.

The government's response system to the recurring floods has marked by adhocism. Instead of developing permanent anti-flood infrastructure, it gives away dollops of relief, both in kind and cash, to affected people. The Mahanadi river system, currently in the middle of a discord between Odisha and Chhattisgarh, accounts for a lion's share of the state's problems arising from floods. The Hirakud Dam, built across the Mahanadi in Sambalpur district, is one of the longest in the world. Although it is one of independent India's early multipurpose projects, its primary mandate is to prevent low-lying areas in the river's downstream from being inundated. However, the authorities have failed to carry out this basic mandate here. There seems to be poor coordination between the local authorities with their Chhattisgarh counterpart and the Indian Meteorological Department (IMD) to put in place a foolproof mechanism to minimize the monsoon ravages The dam authorities should keep releasing water at regular intervals from the dam in sync with the changing climatic conditions and rain forecasts instead of waiting for reservoir to brim over. There has been a change in the rainfall pattern due to climatic changes and other factors. To this extent, the rule book devised in 1988 that governs the release of water from the dam may have become obsolete. The government may revisit this and put in place a sound scientific mechanism. Floods are a chronic problem here. They may not be prevented but their adverse impact can be.

Tinhorn

A greenhorn was originally a young ox with newly grown horns: later on it Acame to mean anyone young or inexperienced. The usual sense of tinhorn, on the other hand, is of someone contemptible, especially a person who is pretending to have money, influence, or ability. Tinhorn has a much more interesting history than greenhorn. To find the origin of tinhorn we must delve into the murky world of gambling with dice. There was a game in the 19th century called grand hazard (nothing to do, however, with the old French and British dice game from which our noun hazard derives and which was the origin of the game of craps). A cruder version of grand hazard was usually given the name chuck-a-luck in North America. Both games were played with three dice, a chute containing a set of inclined planes that tumbled the dice as they fell, and a flat area on which the dice fell and whose layout determined whether the player had won or not. The difference between grand hazard and chuck-a-luck was that the former's layout was much more complicated, with possibilities for betting on odds or evens or other combinations (rather like roulette); the chuck-a-luck layout consisted only of six areas numbered from one to six. Chuck-a-luck was unsophisticated and easy to set up, so it was the province of small-time gamblers on river boats, on street corners, or in low gaming establishments. Though the proper chute was made of leather, those with limited resources used a cruder one made of tin. The term tinhorn referred to this cheap chute. It's actually an abbreviation of the fuller phrase tinhorn gambler. This was a term of contempt for these small-time operators of games of chuck-a-luck, whose patrons (tinhorn sports) played for small stakes.

participation for perhaps two reasons. One, keep the Chinese engaged in a dialogue until normalcy is restored on the LAC; and secondly, to have the Russians on our side, even notionally. At any rate, the bulk of our defence arsenals still come from Russia. India's participation in SCO, however, gives mixed signals about our foreign policy. On the one hand, it is in keeping with realpolitik as India is still not ready for a successful military operation to push Chinese back from our side of the LAC. On the other: New Delhi seems to be mixing up dialogue diplomacy with both deterrence and use of force, the language the Chinese understand.

Comparing our China approach with our dealings with Pakistan, we have ruled out any dialogue as long as Pakistan abates crossborder terrorism. The same logic and principle should apply to China which occupies our territory We go hammer and tongs on Pakistan as we have a decisive military edge. With China, the reverse is the case. Our military and political leaderships have been obsessed with Pakistan and have failed to keep track of the upward trajectory of PLA's military capabilities. Such oversight and deficit could be rectified with renewed and fresh diplomacy.

Alas, on China, we have not only fallen short in diplomacy, but it is also that the present Ladakh crisis has exposed the vacuity of India's policy-making, whereas, driven by its economic and military power, China's diplomacy rests on a show of strength and it has no time for talks or tantrums. India seems to have no

matching answer to this approach. Coming back to the SCO meetings, in Russia, the current meeting is called Exercise Kavkaz-20, where 13000 troops from around 20 countries including eight members of the SCO will participate in a joint military exercise from 15-20 September. It is a saving grace that India decided against sending the troops to this activity where Chinese and Pakistani troops are there.

How ironical is it that members of a security alliance like SCO largely headed by China are under threat by the same country! SCO meeting is taking place when China and India are in an active military conflict. Again, to draw a parallel, India boycotted and scuttled the 19th SAARC summit in the wake of the Uri terrorist attack in 2016. India accused Pakistan of its involvement in the Uri attack. Yet, India went ahead to SCO in our national interest.

Let us look at the defence minister's participation and its outcome so far. Rajnath Singh met Wei Fenghe, Chinese defence minister and the state counsellor. What is not in public domain is the likely

Russian hand in brokering such meetings on the sidelines of the SCO. But what is the outcome? While both sides profess to maintain the lines of communication, both at military and diplomatic levels, the statements before and following the meeting reek of belligerence and obduracy. After the meeting, China said, "India is entirely responsible for the border stand-off in Ladakh and China will not lose an inch of its territory". It called on India to earnestly implement important consensus reached by President Xi and Prime Minister Modi. They insist on resolving the issues through dia-

logue and consultation. The Indian side came out with an equally terse statement, the action of the Chinese troops, amassing of troops, aggressive behaviour. attempts to unilaterally alter the status quo wherein violation of the bilateral agreements. It added, There should be no doubt about our determination to protect India's sovereignty and territorial integrity" Foreign Minister S Jaishankar has been consistently pleading that the two countries

should resolve their issues diplo

matically. A bloody conflict is not good for either of the parties. But do we really comprehend Chinese diplomacy?

Before we touch on the art of Chinese diplomacy what is the issue that challenges our strategic ingenuity at present? Talks between our forces have reached the fifth round. From the military sources, de-escalation or pulling back will only happen once the Indian army reconciles to the PLA's new position on the ground. New Delhi finds it hard. In the past four months, starting from May, China has moved LAC in to Indian territory, some 4.5 km deep, in places

On Chinese diplomacy, they follow the legendary strategists Sun Tzu, the author of the Art of War. He has given a lot of clues to tackle the enemy. One that China seems to follows vis-à-vis India is, "the whole secret lies in confusing the enemy so that he cannot fathom our real intent". We have Chanakya. Understanding Sun Tzu, will certainly stand in good stead for Indian diplomacy. So far, we have adhered to Indian ethos and principles, but not responded effectively to the Chinese strategy. Are we short of China hands in South Block?

To sum up, Indian diplomacy must engage beyond bilateralism with China. Even in military option, Indian should not be one-to-one with China. New Delhi must draw the attention of the world and join others in calling China a threat to world security. It should, along with other countries play the Tibet, Taiwan, Hong Kong card, even talk about other territories like Yunnan and East Mongolia occupied by China. 

Bangalore, Sept 10: Dr Ravindranath MH, a veteran Karnataka Health and Family Welfare Department doctor, has got his first posting in two years following wide-scale media coverage of him being forced to drive an auto-rickshaw to earn a living. Photos and videos of him riding an auto with-Harassed by IAS Officers' Misrule-painted in the front and back had gone viral. The widescale media coverage had led to the Health Minister taking notice of Dr Ravindranath's plight with the former saying that he will look into the issue.

The posting was given to Dr Ravindranath after Health Minister B Sriramulu intervened.

An elated Dr Ravindranath said he will join as the new District Family Welfare Officer in Koppal.

"I am happy with the posting. I am currently on my way to Koppal and will report to duty in the evening," he said.

It was Sunday that the issue of alleged harassment by IAS officers leading to Dr Ravindranath being left without a posting for two years came to light during this pandemic.

Dr Ravindranth who had joined government service more than 20 years ago, was posted in Ballari district. His last posting was the district Reproductive and Child Health Officer.

But left without a posting and his salary withheld for more than a

Once upon a time this was a hub of Punjabi literature

Amritsar, Sept 10: With 25 publishers abounding the Bazaar Mai Sewan, it was considered once the world's largest setting of Punjabi (Gurmukhi) books. But as of now, all glory has been lost in the mists of time.

The original area starting from Darshni Deorhi to Chowk Ghanta Ghar, which was more than 200 sqft, has been reduced. Several historic buildings, including Udasi Akhara, Sangal Wala Akhara, Gianian Wala Bunga and Hathi Khanna dotting the bazaar are all gone.

Meanwhile, a big chunk of the history was demolished by the government for the construction of Galiara around the Golden Temple in 1988. Most of the book sellers and publishers were moved to other markers, while many left the business. Today, you could say the market is totally no-nostalgia-evoking, unrecognisable remnant of its past grandeur. Only shops of drafting materials, hotels and religious symbols can be seen. A scanty of booksellers

is the only reminder. During the much-condemned attack of the Indian Army on Akal Takht in 1984, a number of shops were reduced to ashes. Come 1988, the government's decision of Galiara at the expense of market left many sellers in turmoil. Many were displaced.

With the emergence of Gurumukhi printing press, a large number of these were established in Lahore and Amritsar. The first Punjabi printing press (using Gurmukhi font) was established through a Christian mission in



Ludhiana in 1835. Eminent Punjabi writer Bhai Vir Singh established Wazir Hind Press in the city in 1899. During the 1980s, Lahore became a hub of Gurmukhi printing presses publishing religious text and Qissas.

Meanwhile, Amritsar emerged as the main market of religious and Gurmukhi literature. During the early 20th Century, a large number of publishers settled in the Bazaar Mai Sewan and established their machines. Famous Qissakar (story writer) Kishan Singh Arif (1836-1904), whose father Narain Singh was a publisher and bookseller in the same bazaar, published Qissa Shirin Farhad, Puran Bhagat, Raja Bharthari, Raja Rasaloo, Dulla Bhatti and Kalianwali Heer.

A number of publishers, including Mehar Singh and Sons, Buta Singh-Partap Singh, Chattar Singh-Jewan Singh, Singh Brothers, Khalsa Brothers, Jawahar Singh-Kirpal Singh, Uttam Singh-Gurmukh Singh, Ameer Bhandar, Kastoori Lal and Sons, Munshi Chirag Deen, Bhai Fakeer Singh and sons and Ladha Singh-Kartar Singh among others had established their presses later on and published religious literature.

The Bazaar Mai Sewan started early in the Ranjit Singh era (1780-1839). It was Maharaja Ranjit Singh, who dedicated this bazaar to a lady named Mai Sewan. She was the wife of a military commander Fateh Singh Kaaliawaala. Mai Sewan was known for her dedicated services at the Durbar Sahib and was one of the most respected figures among the locals. Interestingly, a myth also runs parallel to the belief. It is said that it belongs to Mai Sewan, a devotee of the third Sikh Guru — Amardas ji. Once, she expressed her desire of wanting her name to live forever to the master. The Guru is said to have complied with the demand. When fifth Guru Arjan Dev developed the city and allotted land to the settlers, a bazaar leading to Guru Ke Mehal (residence of Guru) was dedicated to Mai Sewan.

Police smell Odisha link in ₹4cr worth B'lore ganja seizure

Bangalore, Sept 10: The Bangalore City police busted an inter-state ganja sale network and seized a whopping 1,350 kg of the drug worth nearly ₹4 crore Thursday. The police have arrested four persons in this connection.

Preliminary investigations revealed that the ganja sale network was spread over Odisha, Telangana and Karnataka. The alleged drug smugglers had dug a huge pit (like a silo) in a sheep-rearing farm situated at Kamalapur Taluk in Kalaburagi district which was located nearly 750 km from Bangalore in the upper-most northern part of Karnataka.

"These accused had stored as many as 600 packets totalling 1,350 kg of ganja in this pit," the police said. The pit was filled with the ganja

packets and covered with a wooden plank which was then covered with a thick layer of mud. Speaking to

reporters, Bangalore City Police Commissioner Kamal Pant said this was the biggest such seizure in the history of Bangalore Police.

"A day-to-day investigation led to a small clue of an accused selling ganja within Seshadripuram Police station limit, where the police had seized two kg of ganja from the accused. But detailed investigations threw light on how the ganja trade was flourishing as far as Odisha to Bangalore," the Police Commissioner explained.

According to him, the ganja was allegedly grown in the interior forests of Odisha and transported through Telangana in trucks or vehicles carrying vegetables.

"These accused used to store it in a pit in a sheep-rearing farm, as nobody could suspect that any such activity was happening in such a remote area. The packets were systematically packed and stacked in this pit," he added.

New Delhi, Sept 10: After years of negotiations, India and Japan have inked a landmark agreement that will allow their militaries to access each other's bases for logistics support, a key development that comes in the backdrop of growing concerns over China's military muscle flexing in the region. The acquisition and cross-servicing pact was signed by Defence Secretary Ajay Kumar and Japanese Ambassador Suzuki Satoshi, a de-

fence ministry spokesperson said Thursday. The agreement provides for creation of an enabling framework for closer cooperation and interoperability, besides allowing militaries of the two countries to use each other's bases and facilities for repair and replenishment of

supplies, the official said. Prime Minister Narendra Modi and his Japanese counterpart Shinzo Abe, who held a telephonic conversation earlier in the day, welcomed the signing of the "Agreement on Reciprocal Provision of Supplies and Services" between the Indian Armed Forces and the Self-Defense Forces of Japan.

The two leaders concurred that the pact will further enhance the depth of defence cooperation between the two countries and contribute to peace and security in the Indo-Pacific region, according to a release from the external affairs ministry here.

A statement by Japanese foreign ministry said the agreement will promote closer cooperation between the militaries of the two

countries, and enable them to actively contribute to international

peace and security. The defence ministry said the pact will enhance the interoperability between the armed forces, resulting in further expansion of bilateral defence engagement under the Indo-Japan special strategic and global partnership

"The agreement establishes the enabling framework for closer cooperation between the armed forces of India and Japan in reciprocal provision of supplies and services," it said. In June, India and Australia sealed a similar Mutual Logistics Support Agreement (MLSA) while resolving to scale up their overall defence cooperation. India has already signed similar agreements

with the US, France and Singapore. India has been signing MLSAs with countries primarily eyeing deeper maritime cooperation which is important considering China's rapid military expansionism in the Indo-Pacific, Indian Ocean and South China Sea

The pacts signed with the US and France provide for accessing various crucial bases by Indian military in Djibouti, Guam and the Reunion Islands among others. India is also expanding overall strategic cooperation with Japan in the Indo-Pacific region under the framework of four nation coalition 'Quad'.

In November 2017, India, the US Australia and Japan gave shape to the long-pending "Quad" to develop a new strategy to keep the critical sea routes in the Indo-Pacific free of any influence.

The US has been pushing for a greater role for India in the Indo-Pacific which is seen by many countries as an effort to contain China's growing clout in the region. In June, the Indian Navy carried out a maritime exercise with the Japanese navy as part of efforts to bolster military cooperation.



A strict watch is also being maintained for movement of civilians along the Line of Control as terrorists may disguise themselves as nomads or shepherds to pick up an arms consignment.

'We have discovered some dumps of arms and ammunition in recent

past along the LoC. This is a clear indication that people across the border are making shallow infiltration, dumping the weapons and returning to their launch pads across the border. This may be because of robust anti-infiltration grid being in place.'

On whether Pakistan is gathering its troops along the LoC in the view of increased tension in Ladakh sector between India and China, Gen Raju said, "We have not noticed any such attempts so far but let me assure that we are preparedfor any eventuality and ready to give a befitting reply".

Implementation of the Act for admissions in educational institutions and appointments to public posts during the pendency of these appeals will cause irreparable loss to the candidates belonging to the open category," said the bench. Staying the Maratha reservation in jobs and education, the bench observed that it will be difficult to cancel the admissions made in the educational institutions and appointments made to the public posts by implementing the reservations as per the Act. However, the top court said the admissions made to postgraduate medical courses shall not be altered.

The top court observed it was categorically held that reservations contemplated in Clause (4) of Article 16 should not exceed 50 per cent. The relaxation of the strict rule of 50 per cent can be made in certain extraordinary situations

The Declaration calls for efforts to ensure countries sustain essential health services and public health programmes during public health other related workers.

Addressing the Health Ministers of the 11 member States, Dr Khetrapal Singh said: "Continued efforts should be made to keep health workers safe from infection and violence and to provide mental health and psychosocial support.'

The Declaration also calls for strengthening safety of patients and the people through adequate public health and social measures and access to quality personal protective devices, and strengthening occupational and environmental safety through medical waste management systems andmaking biomedical and systems research stronger.

German chemical weapons experts have determined that the 44year-old was poisoned with a Sovietera nerve agent, prompting Berlin to demand that Russia investigate the case.

The German hospital treating him said Monday that Navalny's condition has improved, allowing doctors to take him out of an induced coma.

Russian authorities have prodded Germany to share the evidence

that led them to conclude "without doubt" that Navalny was poisoned with a military nerve agent from the Novichok group, the same class of Soviet-era agent that British authorities said was used on former Russian spy Sergei Skripal and his daughter in England in 2018. Russian doctors said they had found no trace of poison in Navalny's system.

Speaking at a news conference Thursday, Foreign Minister Sergey Lavrov charged that Germany, the United States and other Western allies who urge Russia to conduct a probe into Navalny's poisoning squarely expect Russia to accept blame for something it hasn't done.

In New York, the double beams of light that evoke the fallen twin towers were nearly cancelled in the name of virus safety, until an uproar sparked a change of heart.

The Fire Department has cited the virus in urging members to stay away from any observances of the 2001 attacks that killed nearly the 3,000 people, among them almost 350 firefighters.

Some victims" relatives say they understand the ground zero observance had to change in a year when so much else has. Washington, Sept 10: The IMF Thursday said that there is a need for another stimulus, especially expenditures on health, food and income support for vulnerable households, and support for businesses in view of the COVID-19 pandemic. Gerry Rice, Director of

Communications Department at the International Monetary Fund (IMF), told reporters at a virtual news conference here that the Washington-based global financial institution supports the Indian government's responses to the pandemic including fiscal stimulus with a focus on low income workers and households.

'We support the monetary easing and liquidity and regulatory measures for the financial sector and borrowers that have taken place. 'We believe further fiscal stim-



ulus is warranted, especially expenditures on health, food and income support for vulnerable households, and support for businesses," Rice said, responding to questions on the massive contraction that the Indian economy has experienced in the latest quarter due to the coronavirus pandemic. In the short term, a detailed well

communicated and credible medium-term fiscal consolidation plan is also important, alongside an increase in fiscal transparency, the IMF spokesperson said.

'Investments by PE. VC funds more than halve to \$1.9 bn in Aug'

Mumbai, Sept 10: Investments by venture capital (VC) and private equity (PE) funds more than halved to \$1.9 billion (about ₹13,950 crore) in August as there were no large deals, consultancy firm EY said Thursday.

Investments stood at \$4.3 billion in August last year and \$4.1 billion in July this year on the back of deals struck by the Mukesh Ambani-led Jio Platforms, data collated by EY said.

"Although PE/VC investments of \$1.9 billion in August 2020 are over 50% lower than that in August 2019 as well as July 2020, it has been better than the sub-\$1 billion monthly run rate seen in the initial months of the pandemic," EY Partner Vivek Soni said.

He said there is a "perceptible improvement" in investor confidence as the Indian as well as global markets begin to open up. The USD 1.9 billion was invested across 75 deals.

The financial services sector reclaimed its top position for PE/VC investments after a gap of three months, with investments worth USD 1.1 billion in August, while the education space is also receiving considerable attention with USD 1.1 billion invested this year, he said.

Exit activity continued to be subdued with only USD 67 million worth of transactions, primarily coming from open market activity, EY said, adding that buoyant equity markets with many PE-backed IPOs lined up for listing may reverse the trend.

Pandemic hits auto industry, retail sales tumble 29%

Bhubaneswar, Sept 10: In the wake of ongoing COVID-19 pandemic, the retail automobile sales in Odisha continued to remain down by 29% in August on Y-o-Y basis but showed some improvement due to the ongoing festivities when compared to M-o-M, as per the data showed by Federation of Automobile Dealers Associations of India (FADA). In July, the retails sales declined by 40.6% in the state.

According to FADA's report, automobile retails sales saw only 39,353 units in all categories in Odisha for the month of August, 2020. Tractor segment was the only category that showed a positive re-



tail sales trend with a growth of 40.65% to 1,730 units compared to the same month of 2019. The passenger vehicles sale in August was declined by 2.08% and around 3,757 units were sold in same month.

While the two-wheeler sales were downed nearly by 29.39% to about 32,165 units in the state. Also, the commercial vehicles retail sales

down by 62.08% and the threewheeler category registered negative growth of 69.01%. In August, commercial vehicles sales were 1,116 units and three-wheeler sales were 585 units.

The automobile sales across India, in overall, dipped 26.81% in August. FADA says that entry level pas-

New York, Sept 10: Not only had 2019 runner-up Daniil Medvedev not dropped a set in this US Open entering his all-Russian quarterfinal against long-time pal Andrey Rublev, but Medvedev hadn't allowed

more than four games in any set.

So when Rublev grabbed a sizable lead in the opening-set tie-breaker Wednesday and three times was a single point from closing it, the moment felt momentous.

Turned out it was. The No.3-seeded Medvedev fought off that trio of chances for No.10 Rublev in the tie-breaker by reeling off five points in a row, and was on his way to a 7-6(8-6), 6-3, 7-6(7-5) victory to return to the semifinals at Flushing Meadows.

The only concern for Medvedev in the latter stages was whether his body would hold up – he was dealing with cramps and needed his right shoulder massaged by a trainer in the third set – but he did, indeed, hold on. "It was tough at the end," Medvedev said. "I felt like I could get in trou-

ble. He took 51 of 57 points when his first serve went in, never faced a break point and wound up with a 51-23 edge in total winners. In all, through five matches, Medvedev has won 65 of his 68 service games, saving 6 of nine break points.

It's been 60 years since a man won this Grand Slam tour-nament without ceding a set; Neale Fraser did so in 1960 at the event – then known as the

US Championships. A year after losing to Rafa Nadal in a five-set US Open final that lasted nearly five hours, Medvedev heads to his second career major semifinal. He will face No.2 seed Dominic

Thiem, who crushed No.21 Alex de Minaur 6-1, 6-2, 6-4. The other semifinal Friday will be between No.5 Alexander Zverev and No.20 Pablo Carreno Busta. None of the remaining men has won a Grand Slam title.

Medvedev versus Rublev pivoted in that first-set tie-breaker, which Rublev led 5-1, then 6-3. But Rublev started losing points and then his cool, slamming his racket down during the change of ends at 6-all. Medvedev's five-point, set-clinching run culminated with

a 128 mph ace. In the second set, Rublev leaned over and screamed and was given a warning for an audible obscenity, although he told chair umpire James Keothavong that he didn't curse. At the changeover, Rublev told Keothavong, "You under-

Williams' latest threeset comeback at the US Open, yet they were pivotal and consisted of the sorts of lengthy exchanges filled with athleticism and brilliance that in any other, non-pandemic year would be marked by thousands of folks rising to their feet for delirious roars and raucous applause.

She needed both of these points, one of which included a shot she hit left-handed, to reverse a deficit that reached the scale of a set and a break after 45 minutes of her quarterfinal against Tsvetana Pironkova on a cloudy Wednesday in empty Arthur Ashe Stadium. Williams needed both of these

points during a five-game, matchaltering run — along with 20 aces, her most in a match in eight years - to end up on the right side of a 4-6, 6-3, 6-2 score after more than two hours to get to the semifinals Flushing Meadows for at an 11th consecutive appearance.

"It's not how you start, it's how you finish, right?" Williams said. Two more victories would allow her to claim a record-tying 24th Grand Slam singles title.

"In the beginning, I was a little fatigued, for whatever reason," Williams said. "Obviously, I can't do that if I want to keep winning, so I need to figure that out.

How big an upset would this have been if Pironkova had held on? Not only is she not seeded at Flushing Meadows, she doesn't

even appear in the WTA rankings at all — this was her first tournament of any sort in more than three years, because she left the tour to become a mother.

"It's unbelievable," Williams said about Pironkova's impressive return to competition. "Wow. I couldn't even do that.'

When the players stepped out onto the court, the stadium announcer - announcing for whom, exactly, was something of a mystery — referred to Pironkova, a 32-year-old from Bulgaria, as "Alexander's mom" and then to Williams as "Olympia's mom" during the pre-match introductions.

But he never had a car really capable of challenging Mercedes during his stint with the Scuderia, where he lost his No.1 status as teammate Charles Leclerc came to prominence.

"It's a new adventure for me with a truly legendary car company," Vettel said. "I have been impressed with the results the team has achieved this year and I believe the future looks even brighter. I still have so much love for Formula 1 and my only motivation is to race at the front of the grid.

Currently fourth in the constructors' standings, Racing Point was handed a 400,000 euro fine and docked 15 points last month for copying a Mercedes design for its brake ducts. The team, however, was allowed to continue to use the offending components this season.

Oz need to find a permanent No.3 in ODIs: Ponting

Melbourne, Sept 10: Former Australia captain Ricky Ponting feels that the national team management needs to find an ideal 'No.3' in ODIs, someone who will own that slot in vears to come.

The next ODI World Cup is scheduled to be played in India in 2023 and Ponting believes Australia have 'work to do' on their one-day cricket ahead of the quadrennial event.

'They need to find someone that's going to bat at No.3 for them for a long time. It's such a pivotal role, they need to find someone who's going to be a long-term player there," Ponting said while talking to 'cricket.com.au'.

It could either be Marnus Labuschagne or Steve Smith, according to the two-time World Cup

winning skipper. "Whether that's Marnus (Labuschagne) there (at No.3) and Smith at four, or whether it's the other way round, who knows what it's going to be."

We'll see how the Aussie boys go, but they've still got some work to do on their one-day cricket, I think," Ponting said.

While Australia lost 1-2 to England in the T20 series, Ponting isn't worried about the shortest and the longest (Tests) formats.

"We know their T20 cricket of late has been good and we know their Test cricket has been outstanding, but there's still a few little holes in their one-day game and hopefully they can patch them up over the next week or so.

Australia will head into the threematch ODI series that begins in Manchester Friday. "There's not too many holes, but I think they just have to work out what their brand of oneday cricket is going to be and how they're going to go about it because there's no doubt the talent's all there," he said. "You look at that squad right now and that group of players you've got over there, it's a very good squad."

Talking about England's World Cup winning skipper Eoin Morgan, Ponting said: "I think back three or four years ago and I thought Morgan was gone. I thought he was done as an international player.

"He was in the IPL, on the bench for Sunrisers (Hyderabad) and couldn't get a game, moving around different franchises as a spare overseas player. But now he just seems like he's found another gear and he's probably playing better than he's played in his life."
