In eastern Ladakh region, India and China Five 'missing' Arunachal troops are in an eyeball-to-eyeball situation



New Delhi, Sept 12: China has mobilised thousands of soldiers, tanks and howitzers within rifle range of Indian Army deployment at Spanggur Gap in the southern part of Pangong Tso in eastern Ladakh, sources said, even as Indian troops are on high alert.

The Chinese People's Liberation Army made provocative military deployments at Spanggur Gap, which is between Gurung Hill and Magar Hill, from August 30 after Indian soldiers seized tactical heights on the ridge line on the southern bank of Pangong Tso near Chushul

Talks after talks but nothing conclusive

NEW DELHI: To prevent the situation at the Line of Actual Control (LAC) in eastern Ladakh from further escalating, the armies of India and China held an interaction Saturday where they discussed withdrawing forces from the points where there are in eyeball-to-eyeball situations. Brigade commanders of both sides met at Chushul and held an interaction from 11 am to 3 pm but the talks remained "inconclusive." Both the countries' military delegates are continuously in talks since September 7, the day Chinese People's Liberation Army made a provocative move to occupy Indian territory at the LAC that was thwarted by the Indian Army. Both countries have now decided to hold their sixth round of toplevel military talks within the next few days. The corps commanders - 14 Corps commander Lt-General Harinder Singh and South Xinjiang Military District chief Major General Liu Lin have not met since August 2.

Bhubaneswar, Sept 12: Amid rising number of nCoV cases, the state government has allowed sale of Favipiravir tablet and Remdesivir injectable formulation in medicine stores for the treatment of Covid-19 infected persons. The Directorate of

Drugs Control of Odisha Saturday issued an order in this regard following necessary permission from the Drugs Controller General of India (DCGI).

As per conditions set by the DCGI, the tablet and injection will be available for patients or patients' representatives producing prescription by medical specialists and residence proof.

Consent of the patient or his/her representative in the prescribed form is mandatory before initiating the treatment, the order said.

The drug will be made available to the patient/ his representative only through in-house retail chemists attached to hospitals/nursing homes having valid drug licences. Where there is no in-house retail chemist shop in the hospital/ nursing home, the local Drugs Inspector will identify one or more retail chemist shop through whom the drugs will be made available," it said. The official is to ensure the stockist and retail chemist having valid drug licences must have a

good track record under the provision of the Drugs and Cosmetics Act and Rules there under. As per the norms, the retail chemist shop will mandatorily have to retain a photocopy of the prescription, written consent

Odisha logs 3,777 fresh Covid cases

BHUBANESWAR: State's Covid-19 tally mounted to 1,46,894 Saturday with 3.777 more people testing positive for the disease. Moreover, 11 fresh fatalities pushed Odisha's death toll to 616, an official of Health and Family Welfare (H&FW) department said. Three deaths were reported in Cuttack, two in Khurda, and one each in Bolangir, Jajpur, Kandhamal, Keonjhar, Nayagarh and Rayagada, said the official. Of the 3,777 fresh cases, 2,191 were recorded in various guarantine centres and 1.586 were detected during contact tracing.

Bhubaneswar, Sept 12: A lady police officer lost around Rs1 lakh to cyber fraudsters after ordering food through a popular online food ordering and delivery platform, few days back. The victim identified as Binodini Nayak has been staying at Jayadev Vihar area under Nayapalli police limits here.

Nayak is currently working as an Inspector of Police at the Biju Patnaik State Police Academy. As per her complaint, she ordered some food items from a local restaurant through the food delivery app. She also made advance payment of ₹386 from her bank account through PhonePe, a digital payment app.

However, the online food delivery platform failed to deliver the order and sent a cancellation message on her email address

Subsequently, Nayak called the 'officials' of the food aggregator who transferred her complaint to another person with mobile number— 9064131625. The accused person on the other side sent a code to the victim lady inspector's mobile number.

Suddenly, she received two messages in quick successions informing about the withdrawal of amounts worth Rs24,905 twice from her account. Later, she tried to contact her bank SBI and PhonePe authorities to block her account, but to no avail.

Meanwhile, the cyber fraudsters withdrew another Rs49.905 from her account as well. Police have started investigations into the matter after registering a case in this regard based on the complaint of the lady cop.

THE WWF REPORT PAINTS A GRIM PICTURE AMID THE COVID PANDEMIC

degradation, leading to the emergence of zoonotic diseases such as Covid-19, according to WWF's Living

Planet Report, 2020. The

Living Planet Index (LPI) shows that factors believed to increase the planet's vulnerability to pandemics - including landuse change and the use and trade of wildlife - were also some of the drivers behind the 68 per cent average decline in global vertebrate species population beween 1970 and 2016.

"The Living Planet Report, 2020 underlines how humanity's increasing destruction of nature is having catastrophic impact not only on wildlife populations but also on human health and all aspects of our lives," said Marco Lambertini, Director General, WWF International.

"We can't ignore the evidence – the serious decline in wildlife species populations are an indicator that nature is unraveling and that our planet is flashing red-warning signs of system failure. From the fish in our oceans and rivers to bees which play a crucial role in our agricultural production, the decline of wildlife affects nutrition, food security and livelihoods of billions of

people," he added. In the midst of a global pandemic, it is now more important than ever to take unprecedented and coordinated global action to halt and start to reverse the loss of biodiversity and wildlife populations across the globe by the end of the decade and protect our future health and livelihoods.

The LPI, which tracked almost 21,000 populations of

more than 4,000 vertebrate species between 1970 and 2016, also shows that wildlife populations found in freshwater habitats have suffered a decline of 84 per cent - the starkest average population decline in any biome equivalent to four per cent per year since 1970.

One example is the spawning population of the Chinese sturgeon in China's Yangtze river which declined by 97 per cent between 1982 and 2015 due to the damming of the waterway.

The modelling makes clear that stabilising and reversing the loss of nature caused by humans' destruction of natural habitats will only be possible if bolder, more ambitious conservation efforts are embraced and transformational changes made to the way we produce and consume food

Bhubaneswar, Sept 12: Keeping in view the rising cases of COVID in the city, the Bhubaneswar Municipal Corporation (BMC) has requested all COVID Care Centres and hospitals to ensure timely attendance of its doctors and establish a mechanism to monitor the same.

In a letter to all Covid Care Centres (CCC) and Dedicated Covid Hospitals (DCH), the civic authority urged that a mechanism be setup to ensure timely presence of doctors and paramedics for effective treatment of patients.

The BMC also said that such planning will help in timely shifting of patients more often in a day.

"The mere presence of a doctor near the patient has great psychological advantage and, hence, it is essential that doctors should visit patients more often daily to ascertain the health condition of a patient. This will also help in shifting patients from general to ICU wards and decrease the mor-

tality rate," the letter said. 'It, therefore, needs strict monitoring of the attendance of the doctors and paramedics. This will enable the BMC to obtain dailv/weeklv advanced dutv schedule for cross-checking. It is further suggested that surprise checks be conducted at least twice a week half-an-hour before and after shift change," the letter added. Stating that there are limitations of Assistant Medical Officers (AMOs) visiting the COVID wards. the civic authority has asked the CCCs and DCHs to install CCTVs in hospital buildings, wards and corridors to ascertain the movement of doctors in the wards.

SIDDHAMAHAVEER LEVEL CROSSING Delay in ROB project irks Puri residents

Puri, Sept 12: The National Highway Authority of India (NHAI) is yet to begin construction work for a railway overbridge (ROB) at Siddhamahaveer level crossing on Puri-Konark National Highway here even though the Centre has approved the project around 10 months ago.

The NHAI and the district administration had initiated the process for acquisition of land for the ROB project in January this year. However, the authorities concerned are yet to begin work for the same.

Members of Jana Jagaran Manch, a Puri-based voluntary outfit, Saturday submitted a memorandum to the NHAI and the district administration seeking early execution of the ROB project.

It is worth mentioning here that the residents of the Pilgrim city

Bolangir; Sept 12: Here is some good news for farmers in Bolangir! Hopes of resuming the work of the ambitious Lower Suktel Irrigation project has been rekindled again. Its construction work, which remained stalled for over two years now is going to start soon.

According to a report, a high level technical team recently visited the project site and signaled restart of work on the project from Friday.

The state government had sent this four-member high-powered committee to the area a couple of days ago

The team comprising chief engineer of the Water Resources department Jyotiraj Rath, additional secretary of department Rajendra Pattnaik, OCC's managing director Asim Kumar Mohaptra and chief engineer of the Subarnarekha Irrigation Project Prabhat Ranjan Rout held talks with the local MLA Narasingh Mishra and members of the different Action Committees.

The Chief Engineer hinted that construction work of the dam will start from Friday.

He also said that the state government has appointed a special officer to deal with problems of the displaced people.

Locals, the MLA and members of Balangir Action Committee (BAC) demanded that with the start of the dam work, problems of the displaced people should be redressed on priority basis.

They stressed on the need of this irrigation project for a droughtprone district like Bolangir.

Some weeks ago, locals united under Bolangir Action Committee (BAC) had warned of agitation over the stalemate if the work on the project was not started within a month. A six-member delegation led by MLA Narasigh Mishra had submitted a memorandum to the Chief Minister through Collector Arindam Dakua

MLA Narasingh Mishra, president of the BAC Gopalji Mishra, president of the Nagarika Committee Bikramananda Bohidar, president of the district Bar Association Pramod Kumar Tripathy, lawyer Bhawani Shankar Satpathy and Ratan Kumar Moharana held discussions with the Collector over the status of the project and the bottlenecks that are hampering the work of the irriga-

and others affected by the project. "For a long time, RPDAC did not hold any meeting. As a result, the problems of the displaced villagers were not taken up for discussion. The displaced people should get what they deserve and the RPDAC meeting should be called immediately?

Balangir district and 2,684 hectares in Sonepur, covering 189 villages

said Mishra. Mishra also said that he would hold talks with the Speaker; the minister of the Water Resources department and the department secretary during his stay in Bhubaneswar so as to ensure resumption of work within a month.

The BAC is spearheading a movement in support of the dam project. Members of the BAC had visited Paradhiapali and conducted a meeting with the villagers who were up in arms against the project.

The construction work of the project was stopped due to stiff opposition from villagers around seven months back.

Paradhiapali village is the epi centre of the agitation against the project. Its residents are seeking one-time compensation as per Land Acquisition and Rehabilitation Act, 2013. They also demand that their family members, who are 18 years of age, be included for compensation.

Worried over stoppage of project work, the BAC had earlier urged the district administration to end the impasse with the agitating villagers.

BAC leader Gopalji Panigrahi urged the villagers of Paradhiapali to cooperate with the administration in carrying out the project work. It may be noted here that the state government has already spent over Rs1,000 crore for the project. At the meeting, the villagers raised their concerns over the proposed dam and pressed their old demands.

Once commissioned, the project will irrigate 29,146 hectares in Balangir district and 2,684 hectares in Sonepur, covering 189 villages.

Due to frequent conflicts between pro and anti-dam activists, the work on the project has been disrupted several times in the last 12 years.



Sullying past for follies of present

ndia's Foreign Minister comes from a family of scholars. His father, K Subrahmanyam was the founder of the famous think tank IDSA in Delhi and advised Indira Gandhi. On the weaponising of India's nuclear programme and on military intervention in Bangladesh, Subrahmanyam had a hand

Subrahmanyam's son Sanjay, Jaishankar's brother, is one of the world's most famous scholars of medieval India. He has written books on commerce in Surat (my home town) and South India as well as on Vasco Da Gama.

My point is that Dr (he is a PhD himself) S Jaishankar has a background which is not the same as our other ministers. Jaishankar has recent a book released a few days ago that said three things had negatively affected India's foreign policy. The first was the partition, which reduced the size of India and gave China even more importance than it was. The second was the delay in the economic reforms of 1991, which had they come earlier would have made India a wealthier nation earlier than it will become. And third the delay in choosing to make atomic weapons. He called them the three burdens What should we make of what he is saying? We need to examine two separate things, first to see to what extent what he says is true

India's partition did reduce the size of the country and if India had not been partitioned, the undivided nation would be larger geographically, stretching from Burma to Iran and with a population of 1.7 billion people. It would not be particularly different in terms of its economy, per capita income, productivity or any other way. South Asia has developed together, none of the three countries which were part of British India have either be

come a developed country. A visit to Pakistan and Bangladesh reveals them to be no different than most parts of India. The second issue is the delay in economic reforms. This is not Jaishankar's subject because he is not an economist. So we must be cautious when we accept what he is saying as true. The Indian economy of Nehru's time had little capacity. State capital was needed as an element, especially in heavy industry. And without the state, the institutions we take for granted, for example in higher education, would not have come at all. Whatever bhajans we may sing to privatisation there is no private equivalent of the IITs or the IIMs even today in the country. This is not to say that the license raj of Indira was a good thing. It was not. The best we can offer Jaishankar's statement on the delay in reforms is a qualified yes, not a full endorsement.

The third is the exercise of the nuclear option, which happened in May, 1974. India makes a big deal of having an atom bomb. It is not such a big deal. Many nations in South America, Europe, Asia and Africa had the capacity to make one but choose not to. The other thing is that India violated its foreign commitments to make the bomb. The reactors producing the material used in our bombs came from Canada whom we had promised that we would only use nuclear technology for peaceful purposes (this is why Indira Gandhi made the claim that the 1974 was a "peaceful explosion"). We have

held these weapons for 45 years now. How have they helped us? We cannot use them against Pakistan which for 30 years we have accused of terrorism We cannot use them against China which is today inside our borders. It is debatable that the early weaponising of our programme could have helped us in any way

Jaishankar calls these three things 'burdens' and he lays them at the Congress' door. Let us see what his party has done and is doing. India may have been partitioned but its Pakistan and Bangladesh are still next to us They have not been relocated to Africa. What stops India from unifying the subcontinent through trade or travel? It is our nationalism. We have free movement (without visas) with Nepal but not with Bangladesh. Why? We could unify South Asia with visa free travel and trade if we chose to. The BJP does not want it. The assumption Jaishankar makes about liberalisation automatically producing economic growth is false. Under the BJP, India's economic growth has been declining since January 2018 according to its own figures. That is two and a half straight years of decline in six years of government. This did not happen during socialism or license raj. This year we will see a contraction of the economy. Mere liberalisation does not mean economic growth What Jaishankar says in his three points is reductive and simplistic. The past does not matter that much. If we think that it does it is because we are not good enough at running the nation competently today and are searching for excuses. If Jaishankar's diagnosis is correct, what stops him from correcting it today? His book does not say that. Perhaps that will come in a future book.

he World Bank's Doing Business index has been both conceptually and operationally suspect since its inception in 2003, but mainstream economists have only recently started to criticise it. Although the Bank's own recent acknowledgement of some of the problems is welcome, the index has already caused huge damage to developing countries, and it should be scrapped.

The Bank has already been forced to suspend publication of the index, owing to 'irregularities' in its data. The latest brouhaha concerns straightforward number fudging. Apparently, data from four countries - Azerbaijan, China, Saudi Arabia, and the United Arab Emirates – were inappropriately altered, at least for 2017 and 2019 (thus affecting the 2018 and 2020 Doing Business reports). Other irregularities may have occurred, too. The Bank has begun a 'systematic review' of the last five vears of data. launched an independent audit of the process, and pledged to correct the most-affected countries' data.

But this is a minor issue compared to all the other concerns with the index. Paul Romer, then the Bank's chief economist, highlighted some of these in a stinging 2018 criticism of the tool. According to Romer, most of the changes in country rankings over the previous four years had resulted from repeated methodological changes that gave more weight to national governments' political orientation. Specifically, Romer said that data for Chile appeared to have been manipulated to show that the country's business environment had deteriorated under a

left-wing government. Chile's overall ranking fluctuated between 25th and 57th between 2006 and 2017, when the country's presidency alternated between the socialist Michelle Bachelet and the conservative Sebastián Piñera. Under Bachelet, Chile's rank-

ing consistently worsened, while it consistently climbed under Piñera. Romer even offered "a per-

Moreover, the index focuses entirely on the 'ease' of doing business and the costs of regulation for companies. It gives no consideration to the benefits of these regulations and whether they create a better overall business environment. Likewise, Doing Business regards taxes only as a cost, and not as a source of revenue that can be used to deliver important economic benefits such as modern infrastructure and an educated workforce.

The overall thrust of Doing Business is thus anti-regulatory: the fewer regulations a country has the better it performs on the index. The inclusion of the tax rate in the underlying indicators is so egregious that two independent evaluations commissioned by the World

Bank suggested leaving it out. As Isabel Ortiz and Leo Baunach have noted, the index effectively "undermines social progress and promotes inequality." That is because it "has encouraged countries to take part in the 'deregulation experience' including reductions in employment protection, lower social security contributions (denominated as 'labour tax'), and

lesser corporate taxation. Ortiz and Baunach are correct to argue that it is time to stop publishing Doing Business. And the World Bank owes the developing world a debt of contrition for all the harm this misleading and problematic tool has already caused.

ment is in a state of utter shock, disbelief, fear and consequent panic! This is where the adverse sideeffects of Covid-19 reveal themselves, whereby what is not and

should not be normal is accepted to be so by a fearful mankind. The most insidious of these sideeffects, perhaps even more of concern to mankind than the economic downturn, is the enormous power suddenly vested upon the State by the affliction, whereby the needs of the "individual," including her or his liberty, have been subsumed by the needs of "society," its safety and wellbeing. Such subsuming, of course, is considered to be "normal" in an authoritarian regime like China. If China could attempt to contain the epidemic within Wuhan. from which the virus is thought to have originated, placing its 11 million citizens in quarantine, and also imposing lockdown in cities in the Hubei Province, thereby cutting more than 50 million of its people off from the rest of the world, it had been because the Chinese people have long been conditioned to accept the unquestionable power of the State and unhesitatingly obey

whatever directive it imposed. Not surprisingly, in the absence

up the Chinese model of containment, and impose lockdowns upon their citizens. In order to do so. most of them have had to decree stringent directives which violate the basic rights of citizens. People's movements restricted, professional activities stopped and sources of livelihood taken away by the State.

The irony is that such violation of civil liberties is actually of exigent requirement at this moment if mankind is to get the better of this deadly virus and save lives. Equally ironic is the fact that the course adopted by the State in most democracies has the sanction of scientists and the medical fraternity.

Obviously, directives for people to stav at home will not directly prevent deaths: what these are designed to do is to slow the rate of infection, thereby ensuring that health-systems are not overwhelmed by sheer number of cases and authorities can keep a grip on the therapeutic handling of the pandemic. In ensuring that people are kept at homes, the governments of democracies have adopted the same autocratic methodology that China had, thereby removing the broad line which divides the two. Yet it would be a foolhardy civil

would any rational individual question the right of global leadership to assume the "Big Brother" mantle or attempt to create an Orwellian. dystopian world

Little wonder that, in the context of the pandemic, the steps a country like South Korea had taken. are not only being lauded, but also being presented as an ideal modus operandi. The moment the danger of a pandemic had loomed on the horizon, that nation had put into place a strict identification, monitoring and tracing mechanism whereby the movements of each of its citizens could be tracked, something akin to what China had done. In other words, the argument for surveillance and monitoring of individuals in society, thereby break ing the canons of right to privacy, has been legitimatised. Yet, given that South Korea has not only succeeded to a great extent in controlling the pandemic, but also kept its fatalities comparatively low, the necessity of such measures have been underlined! A similar psychology is behind the reality that all of a sudden in a nation like India highhanded behaviour by the police has won a nod of approval from a panic-stricken midand also later the initiation of relaxation measures, the electronic media in the country has been filled with visuals of the police taking the law into their own hands, beating lockdown "violators" or making them perform sit ups with their hands clutching their ears. No matter that such actions do not follow the due process of law and erase the distinction between a democracy and a dictatorship, the shrill exclamations of approval from television anchors perhaps reflect the approval society has greeted them with!

Yes, these are abnormal times which require abnormal measures. Unfortunately, as Bill Gates has reminded us, the current pandemic is an "era defining event" whose effect would last for years to come. Thus the danger is very real that the insidious empowerment of the State because of Covid-19 would remain operative for a long time. and one can only hope and pray that "the new normal" does not convert into "the forever normal!"

Madurai, Sept 12: A 19-year-old medical aspirant died of alleged suicide here Saturday, apparently 'apprehensive' over the National Entrance cum Eligibility Test (NEET), police said.

The victim, Jothisri Durga, daughter of a police Sub-Inspector, was found hanging at her residence and a purported suicide note left behind by her said she was 'apprehensive' about NEET though others had high 'hopes'

on her, they said. The death, which comes days after an other medical aspirant in Ariyalur in the state also allegedly committed suicide, drew

sharp responses from Tamil Nadu political parties opposed to NEET, even as Chief Minister K Palaniswami and his deputy O Panneerselvam of the ruling AIADMK expressed shock over the incident.

DMK President MK Stalin said NEET "is not an exam at all."

Taking to Twitter, Palaniswami expressed grief over the 'sad' incident and said students have many avenues to taste success and resorting to such extreme steps was distressing

"It is distressing to see students, the hope for the future, taking such steps," he said. Condoling the girl's death, he expressed his sympathies with the family.



Chennai, Sept 12: The lockdown forced people to largely remain within the confines of their homes, but it was life as usual for birds and a good number of them were sighted by bird watchers here and in other parts of Tamil Nadu.

At least 80 bird species in June and about 83 in July were spotted in the Pallikaranai Marsh, the last remaining wetland in the city, which also attracts migratory birds, according to the Tamil Nadu Forest department

"The Greater Flamingo was the seasonal migratory bird here. The marshland is the home for about 8,300 birds," a senior official told PTI. Apart from breeding residents, the biodiversity rich area attracts a good number of winter visitors. The migratory bird season at

With a steep decline in noise pollution and industrial and other human activities coming to a halt, the call or song of birds fill our ears, said wildlife activist K Mohan Rai

"But the sky, the air, the birds are always there. We are experiencing them anew as we are staying at home. It is not that the birds have suddenly surfaced because of the lockdown," he said.

"Had we kept our eyes and ears alert, we would have spotted the resident birds on normal days,' says N Subramaniam, an avid bird watcher.

"All the birds that have been spotted in towns and villages were always there, but we failed to see

them due to our fast-paced life," Raj said.

S Venkatesh, a naturalist and member of the SOF, said the foundation managed to keep its members engaged during the lockdown by requesting them to sight the birds even from their backyards and record them.

'With the lockdown imposing numerous restrictions we could not venture out. So, we were asked to spot the birds from our windows, gardens and villages. Since our members were spread across the rural areas of Salem district we were able to notice and record 81 endemic species on World Endemic Day(in May)," he said.

The foundation had even introduced Lockdown Nature Writing Challenges to encourage the habit of nature writing and also to keep boredom and stress at bay.

Over 1 lakh cancer patients treated since March in TN

Chennai, Sept 12: The Tamil Nadu government has helped provide cancer-related medical treatment to over 1.30 lakh people in government hospitals and government medical college hospitals across the state since March, Health Minister Dr C Vijaya Baskar said Saturday.

Also, about 250 cancer patients, who had tested positive for COVID-19, were treated, he said.

Of the total 1,31,352 cancer patients who were provided treatment till date, 48,647 were admitted to hospitals.

In a press release here, the Minister said efforts were being taken to provide uninterrupted medical care to cancer patients during the COVID-19 pandemic.

As many as 2,191 patients underwent surgery, including for breast cancer.



While 27,721 people underwent chemotherapy, 11,678 took radiation therapy, and 6,664 received treatment through pain and palliative care units.

The state government's 102 ve hicle service was utilised to shift patients from their homes to the hospitals and back after treatment during the COVID-19 lockdown.

"This has facilitated uninterrupted treatment for the patients during the lockdown period. About 1.396 patients benefited through the vehicle service from March till date," the Minister said.

Seven get life term

Chandigarh: In an honour killing of a bride by her family in 2014, a sessions court in Haryana has sentenced seven people to life imprisonment. The convicts were relatives of Amandeep Kaur of Dharbi village in Sirsa district, who was married to her neighbour Manmeet Singh in August 2014 against the family wishes. Fearing threat to their lives, the couple had also sought the Punjab and Haryana High Court protection. After staying in a shelter home initially, the couple moved to Manmeet's house. There will be 'flood' of pending cases: CJI

New Delhi, Sept 12: Chief Justice of India S A Bobde Saturday said that the COVID-19 pandemic would present a "huge pendency of cases" in courts and a lot of emphasis has to be placed on utilising mediation for resolving many of these matters. The CJI also stressed on the need to focus on mental health and referred to the "uncomfortable prediction" that there might be a suicide pandemic following the COVID crisis.

"This COVID pandemic is going to present us with huge pendency of cases. I do not see any way out of it. We have to decide cases," the CJI said during a virtual event where he launched the book -'Judiciary, Judges and the Administration of Justice' - authored by former top court judge Justice R Banumathi.

The CJI said he believes that this is the time when a lot of emphasis has to be placed on utilising mediation, pre-litigation and postlitigation mediation to resolve many matters.

"I am not suggesting every matter can be, but when the pandemic goes away and the lockdowns are all lifted, we are going to face a flood of cases which I do not know how we are going to decide if we go in the usual way of following the detailed procedure and this is something which we all have to put in our minds together to deal with,³ he said.

Addressing the gathering, Justice N V Ramana said judges are now being construed as soft targets for criticism and are becoming "victims of juicy gossip and slanderous social media posting"

Justice Ramana, the senior-most

judge of the apex court after the CJI, said that judges have to balance their social life in order to be independent."It is completely upon the judge to maintain a distance. Judges themselves restrain from speaking in their own defence and they are now being construed as soft targets for criticism. This issue is further complicated by the proliferation of social media and technology. Judges are becoming victims of juicy gossip and slanderous social media posting," he said.

Raising the issue of mental health, the CJI said it requires serious attention as there is a very "uncomfortable prediction" about a suicide pandemic."I don't believe and sincerely hope that it does not happen," he said, adding that pandemic has brought two things amongst people which is very troublesome -- depressive tendency and unnecessary aggression.

"It is high time that we devote energy to mental health," he said, adding that the Supreme Court has taken an initiative to deal with the mental health issue and provide professional mental health advice, which the secretary general of the top court would soon announce.

Bhushan seeks right to appeal PRESS TRUST OF INDIA

New Delhi, Sept 12: Activistlawyer Prashant Bhushan, convicted and awarded one rupee fine for his contemptuous tweets against the judiciary on Saturday moved the Supreme Court seeking the right of appeal against convictions in original criminal contempt cases to be heard by a larger and a different bench. Bhushan on August 31 was directed to deposit the fine with the Supreme Court registry by September 15 and failure to comply would entail a three-month jail term and debarment from law practice for three years. In a fresh plea filed through lawyer Kamini Jaiswal, he has sought a declaration that a "person convicted for criminal contempt by this court, including the petitioner herein, would have a right to an intra-court appeal to be heard by a larger and different bench". Bhushan, in the plea, suggested procedural changes to reduce the chances of "arbitrary, vengeful and high-handed decisions" in criminal contempt cases saying that in such cases the top court is the aggrieved party, the "prosecutor, the witness and the judge" and hence

'That the existing Act and Rules, do not bar or prohibit the prayers as sought by the Petitioner. In fact, it is in the spirit of the Contempt of Courts Act. 1971 to lav down such a procedure. This Hon'ble Court has in the past framed special rules to deal with cases concerning death penalty and has also devised special remedy in the nature of 'curative petition' against a final judgment of the Supreme Court on certain limited grounds," it said.

The plea said it has been filed in order to bring important procedural safeguards when the top court considers cases of criminal contempt in original proceedings that is those proceedings where it does not act as an appellate court.

"The Memon family has been given total seven 'otthas' (graves) at the cemetery. The complaint said that besides Yakub's, three more graves given to the family were sold at Rs 5 lakh collectively," he said.

Digvijaya, Khurshid, Anwar -- the comeback men in Cong rejig

New Delhi, Sept 12: With the Congress effecting a major rejig ahead of internal polls for a new chief, political pundits feel the entire exercise is as much about stamping Rahul Gandhi's authority as it is about a careful balancing act done through the return of stalwarts like Digvijaya Singh, Salman Khurshid and Tariq Anwar along with cutting down to the size of several dissenting voices

Political observers also feel these organisational changes may not quell the simmering dissent completely and it remains to be seen whether the country's grand-old party eventually heads for a split, as those having sought large-scale reforms have been craftily divided

-- a few have been co-opted, some have been given time to make up their minds and the rest have been left out in the cold

Several leaders and observers are of the opinion that some oldtimers might have been brought back in the organisational fold to counter the 'Group of 23', who had written to interim president Sonia Gandhi seeking urgent organisational overhaul, including an active and full-time leadership. But, not many of them were not willing to be quoted for their views, citing the 'sensitivity' involved in talking about 'the family' matters.

The massive organisational shakeup is also being seen as having a dominant Rahul Gandhi imprint with Randeep Singh Surjewala and Jitendra Singh, both considered to



be close to the former party chief, becoming new general secretaries along with the veteran Anwar.

Even the reconstituted 'Central Election Authority' has a Rahul Gandhi stamp on it with his loyal-

ist Madhusudan Mistry heading it and Krishna Byre Gowda and S Jothimani becoming its members.

Though several leaders such as Pawan Kumar Bansal and Rajeev Shukla, who are former Union ministers but did not have any significant assignments in the party till recently, have also made a comeback of sorts as AICC in-charges, the party watchers feel the big comeback has been of Singh, Anwar and Khurshid.

Singh, once considered a close confidante of Rahul Gandhi, was dropped by him from the Congress Working Committee (CWC), the party's highest decision-making body, in 2018 ahead of the Lok Sabha polls. Singh, who has been brought back into the CWC as a permanent invitee, seems to have won back the confidence of Gandhis in the af-

termath of Jyotiraditya Scindia's exit from the party. He had also openly backed Priyanka Gandhi Vadra and Rahul Gandhi amid rumblings over the leadership issue.

Another interesting inclusion is that of Khurshid as a permanent invitee in the CWC along with that of Jairam Ramesh, who was recently appointed convenor of a five-member committee formed to discuss and formulate the party's stand on key ordinances promulgated by the government. Khurshid, known to be among leaders considered close to the Gandhi family, did not have any significant party assignment after his Lok Sabha poll defeat from Farrukhabad. However, his steadfast support for the Gandhi fam-ily's leadership seems to have worked in his favour.

A SIGNIFICANT NUMBER OF PEOPLE ATE LESS NUTRITIOUS FOOD, BINGED ON JUNK DURING THE LOCKDOWN AND PUT ON WEIGHT

New Delhi, Sept 12: The impact of Covid-19 has been far-reaching, and in ways, no one could have imagined. It impacted the health directly and in corresponding manners. One such impact it had was on the food and nutrition.

Coronavirus-led lockdown widened the health and financial inequalities and worsened food poverty among marginalized sections. However, most of the privileged population used this period for feasting and indulging in unhealthy eating habits leading to a low intake of nutrition and weight

gain A significant number of people ate less nutritious food, binged on

junk during the lockdown, and put on weight. The nutrition experts said that they have started receiving complaints from people developing lifestyle diseases. The most common and alarming among these was weight gain. "The sudden restrictions on physical activity, lack of exercise, increased intake of calorie-dense food, and sweets have pushed many people under the looming threat of obesity and related comorbidities

"The majority of our patients are from the newly adopted 'Work from Home' culture," said Ushakiran Sisodia, Head of Dietary Department and Clinical Nutritionist, Nanavati Super Speciality Hospital, Mumbai. Majority indulged into unhealthy



eating practices, said Sandhya Pandey, Chief Clinical Nutritionist, Fortis Memorial Research Institute in Gurgaon, and estimated that around 60 per cent of the people would have gained weight due to and sugar content, highly processed and prepackaged products, have been the highest during this pandemic

"A majority had a lot of homecooked unhealthy stuff right from ready-to-eat pasta or noodles to baking cakes and making sweet dishes such as jalebis, gulab jamuns, and Mughlai delicacies,' she said. Rohatgi added that the immediate impact was weight, higher oxidation in the body. "However, we are yet to see their long term repercussions," she said. Doctors observed that over-eat-

ing was the primary factor behind weight gain among people during the lockdown. However, it was triggered by multiple factors like social media challenges and stress.

"While the fast-food eateries were closed during the lockdown, people turned into master chefs and cooked all the high-colorific foods, beverages, and junk ranging from Dalgona coffee to Pani Puri at home. They were either influenced by social media challenges or indulged into emotional eating due to stress," she said.

Sisodia also said an abundance of instructive cooking videos on social media and the luxury of time had motivated those addicted to junk foods to cook oily, high-calorie food items at home. "Besides, the lack of physical activities as people were forced to stay at home during the lockdown period addedto the weight-gain problem," Sisodia added.

China imposes fresh curbs on US diplomats' activities

Beijing, Sept 12: China has announced new restrictions on the activities of US diplomats working in mainland China and Hong Kong, in what it called a justified response to similar measures imposed on Chinese diplomats in the US last year.

In a statement posted online late Friday, a foreign ministry spokesperson said the rules would apply to senior diplomats and all other personnel at the American Embassy in Beijing and consulates throughout China.

However, the spokesperson said China supported "normal exchanges and cooperation between all sectors of the two countries" and said the restrictions could be lifted if the US were to revoke the measures it imposed last October.

"Once again we urge the US side to immediately correct its mistakes



and lift the unreasonable restrictions imposed on the Chinese Embassy and consulates and their staff. China will make reciprocal responses to US actions," the spokesperson, who wasn't identified, said.

No details were given about the new restrictions. US diplomats already face limits on what parts of the country they can visit and even access to college campuses. The US rules require Chinese diplomats to report travel and meetings in what was seen as an attempt to prevent interference within the overseas Chinese community and foreign students.

Washington has also complained about a lack of reciprocity in access to media, saying Chinese diplomats are able to put their views across US outlets while America's representatives are shunned by Chinese state media.

Most recently, the State Department protested over the refusal by the Communist Party's flagship newspaper People's Daily to publish an op-ed by Ambassador Terry Branstad. The paper responded that the piece did not meet its editorial standards.

China-US tensions over trade, technology and a multitude of other issues have increasingly spilled over into the areas of diplomacy and media, with the US ordering the closure of the Chinese Consulate in Houston in July.

US budget deficit hits record \$3tn

Washington, Sept 12: The US budget deficit hit an all-time high of \$3 trillion for the first 11 months of this budget year, the Treasury Department said Friday.

The ocean of red ink is a product of the government's massive spending to try to cushion the impact of a coronavirus-fuelled recession that has cost millions of jobs.

The deficit from October through August is more than double the previous 11-month record of \$1.37 billion set in 2009. At that time the government was spending large sums to get out of the Great Recession triggered by the 2008 financial crisis.

With one month to go in the 2020 budget year, which ends September 30, the deficit could go even higher. The Congressional Budget Office is forecasting the deficit this year will hit a record \$3.3 trillion.

Nancy Vanden Houten, an economist at Oxford Economist, predicted the September deficit would hit \$200 billion, giving the country a deficit for this budget year.

Warring Afghan groups meet in search of peace

Dubai, Sept 12: Afghanistan's warring sides started negotiations Saturday for the first time aimed at ending decades of war. bringing together delegates appointed by the Afghan government and the Taliban.

It's the latest in a flurry of diplomatic activity by the Trump administration ahead of the US presidential election in November. The discussions are important in the search for lasting peace that will also provide an exit for US and NATO troops

after nearly 19 years. The sides will try to tackle tough issues. This includes the terms of a permanent cease-fire, the rights of women and minorities and the disarming of tens of thousands of Taliban fighters and militias loyal to warlords, some of them aligned with the government.

The talks in Doha follow the USbrokered recognition of Israel by two Gulf nations - Bahrain Friday and the United Arab Emirates earlier this month. The Afghan sides are also expected to discuss constitutional changes, and power sharing.

Friday's development makes Bahrain the fourth Arab nation after Egypt, Jordan and the UAE to establish diplomatic ties with Israel, Xinhua news agency reported. Bahrain King Hamad bin Isa Al Khalifa, Israeli Prime Minister Benjamin Netanyahu and US President Donald Trump agreed to the establishment of full diplomatic relations between the two countries in a joint statement.

Pak scribe held for defaming Army

Karachi: A senior Pakistani journalist working with a leading English daily was arrested on Friday for allegedly defaming the country's Army and fanning sectarian hate. Bilal Faroogi, who works with The Express Tribune, was taken into custody from his home in **Defence Housing Authority** by a police team accompanied by two men in plain clothes. Additional Inspector General Ghulam Nabi Memon told the media that Bilal has been arrested after FIRs were registered.

Rape of woman in front of her kids sparks uproar in Pakistan

Lahore, Sept 12: Brutal gang rape of a woman in front of her two minor children in Pakistan's Punjab province has caused widespread uproar, condemnation and protest. Women in the country have demanded more measures for their safety and security as the country bays for public hanging of the culprits.

The incident was reported from Gujjarpura area in Punjab province Wednesday, when two men robbed and raped the woman at gunpoint while she was waiting for help on the motorway after her car broke down.

The woman had crossed the toll plaza on the Lahore-Sialkot motorway, her car stalled due to shortage of fuel. As per police report, she called her relative in Gujranwala, who asked her to call the police Punjab police.

Dozens missing in 2 large Oregon fires

HUNDREDS OF FIREFIGHTERS BATTLED TWO LARGE WILDFIRES FRIDAY THAT THREATENED TO MERGE NEAR THE MOST POPULATED PART OF OREGON. INCLUDING THE SUBURBS OF PORTLAND

Salem (US), Sept 12: Hundreds of firefighters battled two large wildfires Friday that threatened to merge near the most populated part of Oregon, including the suburbs of Portland, and the governor said dozens of people are missing in other parts of the state.

The state's emergency management director, Andrew Phelps, said officials are "preparing for a mass fatality event" and that thousands of structures have been destroyed.

Gov Kate Brown said more than 40,000 Oregonians have been evacuated and about 500,000 are in different levels of evacuation zones, either having been told to leave or to prepare to do so. She was dialling back on a statement late Thursday



issued by the state Office of Emergency Management that said a half-million people had been ordered to evacuate statewide.

Dozens of people are missing in Jackson County in the south and Marion County, where a fire continues to burn east of Salem, Brown

told a news conference Friday. Also Friday, authorities an-

nounced that a man had been arrested on two counts of arson for allegedly starting a fire in southern Oregon Tuesday.

The Oregon Convention Center in Portland was among the buildings

being transformed into shelters for evacuees. Portland, shrouded in smoke from the fires, on Friday had the worst air quality of the world's major cities, according to IQAir.

National Guard troops and corrections officers transferred about 1,300 inmates from a women's prison in a southern suburb of Portland "out of an abundance of caution," the Oregon Department of Corrections said. Spokeswoman Vanessa Vanderzee said it took 20 hours to transfer the inmates Thursday to another prison in a safe zone.

A change in the weather, with winds dropping and shifting direction and humidity rising, greatly helped firefighters struggling to prevent the two fires from advancing farther west into more-populated areas.

Charlie Hebdo threatened for republishing Prophet's cartoons

Paris, Sept 12: Al-Qaeda has threatened French satirical weekly Charlie Hebdo with a repeat of a 2015 massacre of its staff, after it republished controversial cartoons of the Prophet Mohammed, the SITE observatory said Friday.

Al-Qaeda in its publication One Ummah had warned that Charlie Hebdo would be mistaken if it believed the 2015 attack was a "one off", after the magazine printed the "contemptible caricatures" in a defiant issue that marked the start of the trial in Paris of suspected accom-



plices in the attack. The comments came in an English edition of the Al-Qaeda publication that purported to mark the anniversary of the

France the for of PresidenEmmanuel Macron as it did for his predecessor Francois Hollande who was president at the time of the 2015 attacks.

It said France under Macron "gave a green light" to the republication of the cartoons.

Twelve people, including some of France's most celebrated cartoonists, were killed January 7, 2015, when brothers Said and Cherif Kouachi went on a gun rampage at the offices of Charlie Hebdo, whose no-taboo style, including publishing cartoons of the prophet, had divided the country.

The trial, which began September 2 and is expected to continue until November, sees 14 suspected accomplices face justice even though all the perpetrators were killed in the wake of the attacks.

It had reopened one of the post painful chapters in France's modern history which heralded a spate of jihadist attacks on its territory that have claimed more than 250 lives

Charlie Hebdo's director Laurent Sourisseau, known as "Riss" and who himself was badly wounded in the shoulder in the attack, told the court this week that there was noth-

ing to regret in publishing the cartoons. "What I regret is to see how little people fight to defend freedom. If we don't fight for our freedom, we live like a slave and we promote a deadly ideology," he said.

Charlie Hebdo's republication of the cartoons drew new condemnation from states including Iran, ২ Pakistan and Turkey.

But Sourisseau, who now lives under round the clock protection, said it had to republish them.

"If we had given up the right to publish these cartoons, that would -(mean that we were wrong to do so" in the first place, he said.

LIC expands market share as pvt insurers lose ground

New Delhi, Sept 12: Helped by single-premium plans and continued consumer preference for endowment and money-back policies, the country's largest insurer LIC has come back in a big way and captured 46.8% share in India's insurance market in terms of annualised premium equivalent (APE) in August.

APE is the sum of annualised first-year premiums on regular premium policies and 10% of single premiums on the new business written during any period.

According to a sector report from Emkay Global Financial Services, the share of private players on the APE basis weakened the sequential improvement, with the LIC bouncing back big time with 46.8 per cent share (49.2% in July) against the peak of 60.2% in February.

Mumbai, Sept 12: As COVID-19 is likely to pose financial risks for microfinance institutions (MFIs), there is a need to build capital buffers and manage cash positions for micro lenders to protect their balance sheets from any disruptions, according to an article published in RBI's monthly bulletin.

The article, prepared by Snimardeep Singh of Department of Supervision, Reserve Bank of India (RBI), said though COVID-19 presents new challenges and significant financial risks for the microfinance sector, it also presents an opportunity to build long-term resilience.

"Going forward, building capital buffers and managing liquidity would be crucial for MFIs in fortifying their balance sheets against COVID-19 led disruptions," it said. The article termed COVID-19 as the biggest tail risk event in a long

time Owing to the disruptions in supply chain and business operations, the likelihood of loss of livelihoods and consequent drop in household incomes is high, it stated.

"Non-banking financial company microfinance institutions (NBFC-MFIs), being specialised institutions extending collateral free loans to low-income groups, are particularly exposed to credit risks in this scenario." it said.

The article said the repayment rates have dropped significantly, posing liquidity risks to MFIs.



Though COVID-19

presents new challenges and significant financial risks for the microfinance sector, it also presents an opportunity to build long-term resilience,

says the article downgrades, which may hamper their ability to raise fresh capital

and access liquidity, it said adding they "need to diversify their sources of funds for sustaining healthy portfolio growth".

COVID-19 is expected to afflict the microfinance sector with financial risks in the near term. However, it may also incentivise digitisation, it added. Efforts to migrate loan collections to digital platforms may greatly improve operational effitions, it said. The article said data analytics

may be leveraged for predicting portfolio behaviour, building risk models and designing customer centric products.

At this juncture, when the risk of spread of misinformation is high, it is important that credit discipline be maintained, it added. Increasing engagement with borrowers through virtual/telephonic

means and sensitising staff on fair practices code would go a long way in restoring confidence in borrowers and rebooting the credit cycle, as per the article.



S'pore Convention comes into force

New Delhi: The Singapore Convention on Mediation came into force Saturday and will provide a more effective way for enforcing mediated settlements of corporate disputes involving businesses in India and other countries that are signatories to the Convention. Also known as the United Nations Convention on International Settlement Agreements Resulting from Mediation, this is also the first UN treaty to be named after Singapore.

he sale of used cars is growing at a faster pace than the sale of new cars, with more persons preferring the personal vehicles over shared mobility due to the unfortunate ongoing pandemic. We also live in a country wherehaving a third party motor insurance is mandated by law. If you could not catch the correlation, and are planning to buy a second hand car or wish to sell your previous car, this article is a must read for you!

Whenever a new car is bought, its price includes of the on-road price including the road tax and the insurance cost which is added to the ex-showroom price of the vehicle. This is not the case with the pur-

chase of second hand cars. Both the parties involved in a second hand sale, agree upon a value and the contract of sale is then made. Subsequently, RC copy is transferred, and vehicle ownership is shifted to the buyer.

After purchasing a used car, Section 157 of the MV Act casts a duty on he new vehicle owner to get the insurance policy transferred in his name by applying to the insurance company within 14 days. For these 14 days, while the "Third Party" part of the insurance policy gets automatically transferred, the "Own Damage" part will be transferred only after the policy gets registered under the new owner's name. Post this period of 14 days the insurance company is not liable to bear any losses incurredby new vehicle owner in either of the Third Party / Own Damage sections, as the contract of insurance hasn't been transferred to his/her name. Let's con-

sider two situa tions, to understand these points better: Situation

1-You have sold your first car to an acquain-

tance. The RC is transferred, but the insurance is not. Months later, you receive a court notice, stating that your car has hit a pedestrian causing him severe bodily injury, and as the insurance is still in your name, you shall be liable for compensating the in-

iured Situation 2 – You have bought a second hand car from an acquaintance. You

aware of transferring insurance to your name. During a road trip, your car got severely damaged in an accident. You approach the insurance company, with whom the car was previously insured. They do not honour the claim.

Both these situations are not uncommon in the Indian scenario. Owing to low financial awareness, we often find ourselves in circumstances, which could have been easily avoided through some prudence. In Situation 1, as the insurance is not transferred and the policystill bears your name as the car owner, the court sends you a Notice to compensate the loss caused to third party. The were un-

whole process of establishing the proofs of sale, the transfer of vehicle RC etc. can be a gruelling exercise.

While so much thought is put into the purchase of a second hand car, most are oblivious when it comes to transferring the Motor Insurance policy to their name. This can have huge financial impacts, in case of any damage to thevehicle, or damages to a third party in the event of an accident. Being vigilant about getting the policy transferred is definitely the smarter choice, always!

Zvonareva, a Russian who turned 36 this week, added this title to the 2006 US Open trophy she won with Nathalie Dechy. She also was the runner-up in singles at Flushing Meadows in 2010, falling to Kim Clijsters, and rose to a career-high singles ranking of No.2 the following month.

She also won the 2012 Australian Open doubles title but later battled injuries and began playing less, especially after giving birth to daughter Evelina in 2016. Zvonareva and Siegemund, who have each won the US Open mixed doubles title, raced to a 5-1 lead in the first set and a 3-1 start in the second.

Siegemund, who was sharp early, paid tribute to an aunt who died of cancer while she was in New York. Her parents were late arriving to the match after returning from the funeral. Xu and Melichar finished second for the second straight tournament in New York. They were runners-up at the Western & Southern Open that's usually played in Ohio.


