



Yoshihide Suga named Japan's **Prime Minister**

Tokyo, Sept 16: Yoshihide Suga was formally elected Wednesday as Japan's new prime minister in a parliamentary vote.

Suga is replacing Shinzo Abe, who resigned earlier in the day because of ill health. Suga had been chosen as leader of the ruling party on Monday, virtually assuring his succession.

Suga, who was chief Cabinet secretary and long seen as Abe's right-hand man, is to launch his own Cabinet later Wednesday.

Suga has stressed his background as a farmer's son and a self-made politician in promising to serve the interests of ordinary people and rural communities.


He has said he will pursue Abe's unfinished policies, and that his top priorities will be fighting the coronavirus and turning around an economy battered by the pandemic. Abe, Japan's longest-serving prime minister, announced last month that he was stepping down because of health problems.

"I devoted my soul for the economic recovery and diplomacy to protect Japan's national interest every single day since we returned to power," Abe said.

Most Indian Americans back Biden but Trump gains ground

Washington, Sept 16: US President Donald Trump has made inroads into the Indian-American vote bank, the biggest ever by a Republican president, according to a survey which has sent worrying signals to the Democrats that the support of this influential ethnic community can no longer be taken for granted. The survey by Indiaspora and Asian Americans & Pacific Islanders (AAPI) Data showed that a majority of Indian-Americans still favour former vice president Biden, the Democratic Party's nominee in the November 3 US presidential election. It found that 74-year-old Trump, seeking re-election, is making a big

According to the survey, 66 per cent Indian-Americans currently favour Biden and 28 per cent favour Trump while six per cent were undecided Notably in the 2016 presidential election, 77 per cent voted for

former US secretary Hillary Clinton, and 16 per cent for Trump. In 2012, as many as 84 per cent Indian-Americans voted for Barack Obama

Dr Karthick Ramakrishnan, pro fessor of public policy and political science at University of California, Riverside and founder of AAPI Data who is author of the survey, said that the Indian-Americans' support to Trump, in case of a swing of the undecided Indian-Americans, would probably reach the 30 per cent mark.

'Democrats absolutely should be concerned about making sure that they conduct sufficient outreach to the Indian-Americans, Indian-American Congressman Raja Krishnamoorthi said.

The Democrats should conduct sufficient outreach to the different groups that comprise Indian-Americans, because every vote is going to count, especially in those battleground states as the survey result indicated," he said.

There are a lot of Indian-Americans, for instance in key battleground states like Pennsylvania, Michigan, Florida and North

Carolina, among others and they in conjunction with other Asian-Americans could certainly be a part of the tipping factor, he said, asserting that the Indian-Americans would finally come home to the Democratic Party

Seema Nanda, visiting fellow, Harvard Law School Labour and Worklife Programme and former CEO, Democratic National Committee, said "It is a vote (of Indian-Americans) that this research shows, absolutely, cannot be taken for granted'

While the support for Biden has dropped as compared to Clinton in 2016, the support for the Republican Party has dropped from 19 per cent to 16 per cent in these four years.

Mumbai: Actress Sonakshi Sinha says she is not fretting about getting back to work, or how the industry will change in the Covid era.


The actress shared that she loves the lockdown life for now.



ects sanctioned under Odisha Mineral Bearing Areas Development Corporation (OMBADC) have been fast-tracked and showed an impressive 95 per cent completion under Phase-I, thanks to continuous efforts made by Chief Secretary Asit Tripathy.

The OMBADC is sanctioning critical infrastructure projects under Phase-I (Ad hoc CAMPA) and Phase-II (compensation money) for development of mineral-bearing districts. Tripathy, Wednesday, once again reviewed the progress made in utilisation of OMBADC fund.

Chief Executive Officer (CEO) of the corporation, Uma Nanduri, said projects worth ₹1,080.92 crore in priority sectors like housing. drinking water, skill development and forestry have been sanctioned under Phase-I.

Major projects include construction of 29,829 housing units, 215 small pipe water supply projects and three mega pipe water supply projects, bulk plantation on 882 hectares, avenue plantation along 842 km and distribution of 9,80,000 seedlings for urban plantation, she said.

Over 28,500 (95 per cent) dwelling units, 199 (93 per cent) drinking water projects and over 95 per cent of the activities under farm/social forestry have been completed by end of August in this financial year.



Similarly, projects worth ₹12,118 crore were sanctioned under Phase-II (compensation money). These projects ranged over the sectors like drinking water supply, quality improvement in education, skill development, up-gradation of infrastructure in healthcare institutions, livelihood promotion, creation of water bodies, etc. These projects are being implemented through 12 departments.

Nanduri said, "So far, ₹2,085 crore has been released against Phase-II projects. The balance amount will be released as and when the implementing department will place the demand.'

Chief Secretary Tripathy directed the implementing depart-

ments to complete the projects within scheduled time without fail. He laid emphasis on expeditious implementation of livelihood, drinking water and health sector projects. The corporation was asked to strengthen the district-level OM-BADC cells and make them more vibrant.

Bhubaneswar, Sept 16: Odisha registered its highest single-day spike in COVID-19 cases Wednesday as 4,270 more tested positive for the infection, a health official said.

The new cases pushed the state's coronavirus tally to 1, 62, 920, he said. Eleven more patients succumbed to the infection during the last 24 hours, taking Odisha's COVID-19 death toll to 656, the official said.

The state had reported its previous highest single-day spike of 4,198 coronavirus cases September 14, he said.

As many as 2,478 new cases were detected in guarantine centres, while 1,792 people tested positive for the infection during contact tracing, the official said.

Khurda district registered the highest number of new cases at 876, followed by Cuttack (374) and Puri (287), he said.

Three fresh fatalities each were reported from Puri and Sambalpur districts, two in Khurda and one each in Kalahandi, Mayurbhanj and Sundergarh districts, the official said, Fifty-three COVID-19 patients have died in the state due to other ailments so far. he said.

The rehabilitation centre is likely to help in reducing man-elephant conflict in the state, said Chief Wildlife Warden HS Upadhyaya. He said around 70 jumbos die due to different reasons in the state every year while nearly 100 people lost their lives in jumbo attack.

HC orders Baripada Urban Cooperative Bank management to disburse money within 8 weeks

Baripada, Sept 16: Over 72,000 depositors of Baripada Urban Cooperative Bank (BUCB) have long been waiting to get back their money,

They throng the BUCB every day ever since the High Court issued an interim court order directing the management to disburse the money of the depositors within eight weeks

It may be noted here that RBI had cancelled the cooperative bank's license as its financial condition was not sound in October 2014. Since then thousands of depositors were in trouble as their money got stuck in the bank.

Stakeholders of Baripada Urban Cooperative Bank (BUCB) have long been demanding their deposited money back, but their efforts have proved futile.

The recent HC order has rekindled hopes for return of their longstuck deposits

According to some depositors, they had appealed to the RBI April 24, 2018, to allow the bank to return their money, but their appeal was rejected.

Under pressure, the bank management had moved the High Court against the RBI directive for closure of operations. In its interim order,

the HC had directed return of money to depositors June 25, 2020.

Then, the RBI filed a writ petition at the HC against its order. However, the HC ordered return

of deposits. Meanwhile, a liquidator has been appointed for the bank management. But a case has been filed at the court over appointment of a liquidator

Manoj Sendha, a cloth store owner of Baripada town, said, "The amount of profits I was making from this business was deposited in the bank. But all the deposits are stuck in the bank at this time of crisis.

Explaining her miseries, Swagatika Nayak, a service holder of Baripada, said," I have a fixed deposit with monthly savings. The money has got stuck over years. I am tired of running from pillar to post. Following the HC order, I have submitted all necessary documents.

The depositors alleged that though RBI fixed guidelines for refund of depositors' money, no steps have been taken by the bank in the interest of the beneficiaries.

Many depositors frustrated with the apathetic attitude of the bank authorities had drawn the attention of the cooperation minister and Chief Minister to their plight earlier.

Hopes brighten for NABARD LAUNCHES 'WADI' IN MAOIST HEARTLAND

Malkangiri, Sept 16: In a bid to provide sustainable income to members of tribal communities and curb their migration to neighbouring states, the National Bank for Agriculture and Rural Development (NABARD) launched 'Wadi' programme. Tuesday.

'Wadi' means a small orchard of one or two-acre having multiple crops. The programme has been launched in Manyamkunda panchayat under Kalimela block in Malkangiri district – which was once a Maoist heartland.

Under this programme, nearly 500 tribal families of Kusumput, Potteru, Dokunda, Rajgiri and Manyamkunda villages under Manyamkunda panchayat have planted mango and cashew saplings on high land belonging to them. 'Following demand from several

quarters, NABARD started Wadi programme in Manyamkunda panchayat from this year," said

When eating is an act of cruelty

cannot make up my mind: is the meat eater; who eats dead animals killed in slaughterhouses, worse than the meat eater who kills the animal himself while eating it?

There is a certain type of person who goes to a restaurant, chooses a live fish, octopus shrimp or snake in a transparent aquarium tank, has it taken out of the glass and killed and cooked in front of him. His only reason for this to himself is that the meat should be 'fresh'. In fact some people truly enjoy suffering. That, for them, is as important as the taste.

What can I say about people who enjoy eating such food? The Chinese Ying Yang fish is fried but kept alive. You can see videos of diners prodding at the face and eyes with their chopsticks while the fish struggles to breathe with its mouth and gills. It is prepared extremely quickly, with care not to damage the internal organs, so that the fish can remain alive for thirty minutes. Fish are the most sensitive of all to pain. Imagine yourself being fried and then eaten bit by bit

In Japan, Sashimi, which means pierced body, is a common dish consisting of fresh raw fish or meat sliced into thin pieces and eaten with soy sauce. One kind of Sashimi is Ikizukuri (prepared alive) made with live sea beings. Fish and octopus are common ingredients that move on the plate as vou eat them. Sashimi could also include live frogs. The frog is stripped of its skin while alive and stabbed delicately with a fork and eaten. One restaurant in Shinjuku serves the frog's fresh, still beating heart, as starters. Lobsters are not always boiled alive and dead by the time they reach your plate. Restaurants in New York serve lobsters while they're still alive. They are upturned and diners pick out 'belly sashimi' from the lobster which flails in pain for all the time you take to slash and take out his stomach meat.

In South Korea, Sannakji is a dish that involves hacking the tentacles off a baby octopus and serving them still wriggling. Sannakji connoisseurs enjoy the sensation of the still-active suction cups on the octopus' arms as they stick to the mouth.

The Chinese cannot be bested for their addiction to cruelty. Live shrimp are put into a liquor called Baijiu and diners bite their heads off while drinking it. This can give you lung fluke disease, but what is more important than proving your manhood by killing a shrimp. In China there is a dish called 'three squeaks' in which live baby mice are dunked in sauce and eaten alive. The reason why it is called 'three squeaks' is due to the sounds the mice make when grabbed with chopsticks, dunked in the sauce and bitten through. Raw live baby monkey brain is an expensive dish eaten by rich people in China and Hong Kong. The chef puts a live monkey beneath a table with its head poking up through a hole. The chef slices the top of the head off and the customers eat its brains while it screams. The animal has its legs tied and its body held down, while the chef cuts its body and serves the meat immediately to customers

Live baby duck embryos, just a day from being

hatched, are a famous Chinese specialty which is now common in the Philippines as well. In the latter country it is called Balut. The Filipinos eat the egg boiled. The Chinese eat it raw to get the full taste of the egg white, the little yolk left, and the live squirming chick. No wonder the Chinese make such dangerous enemies. They love violence and gore.

Consuming the beating heart and blood of live snakes is common in Vietnam. In China people eat live baby snakes.

Sea urchins are the porcupines of the sea; globular animals with long spines to defend themselves. They live on the seabed. But their spines cannot protect them from human greed. They are caught and served live. Their testicles are a delicacy across the world, especially Europe. The live animal is cut on the plate with scissors and its salty gonads are taken out and eaten raw. The most common animal to be eaten alive is the oyster which is served alive. Its spine is broken, and its insides are slurped up raw. This was originally a French dish but is now eaten all over.

Once he has appointed his cabinet, the LDP's internal rivalries and fissures will likely re-emerge.

Suga's best strategy might well be to go to the voters soon. Winning a general election, rather than just an internal party contest, would give him the popular mandate he needs to chart a bolder economic-policy course.

One of the latest additions to most common journalist language is "Trial by Media". It is generally used as a derogatory term by sections of the society affected by concerned reports, while the neutral public is game with it. Authors, reporters, and performers do not call their product as media trial. Trial by Media is indeed a misnomer for findings of investigative journalism that has grown as a special branch of journalism practised by bold journalists who research on real-life stories. Their task requires absolute commitment to truth and unbiased coverage. The more complicated the crime, the greater is the scope for investigation.

As the general public is curious to follow criminal cases handled by the public and private entities, media picks up such incidents to satisfy their audience. Many of the high-level crimes reflect political

Investigative journalism is allowed in India. Readers and viewers are by and large thrilled with real life crime stories. The investigator, the facilitator, the publisher, and the sponsor are duty-bound to search and find out the truth. They are accountable for errors, biased reporting, partial coverage, and distorted disclosure. The task calls for a high level of moral responsibility and professional integrity.

Journals and television channels are no longer passive recipients and communicators of incoming newsroom reports. They are not post offices. Today, they are active explorers of truth hidden beneath the visible surface. In this transformation, journalists have become 'creators' of news revealing the inside of events and incidents and do not remain mere reporters of what is visible to the naked eye.

Washington-based International Consortium of Investigative Journalists (ICIJ) launched in 1997 is a global network of reporters and organisations of about 267 investigative journalists probing se-

vestigative journalism so far is the Watergate revelations by Woodward and Bernstein (1974) that led to the resignation of the American President, Richard Nixon.

Popular kings in olden days adopted the practice of sending trusted secret agents to mix with people and ascertain what their subjects think and do. Some rulers used to go round their kingdom incognito. In modern free democracies, media's professed role is to act as people's agents and take upon the onerous job of unraveling the truth behind complicated crimes

UN's basic principles on the Independence of the Judiciary states in Article 6 that the judiciary is required "to ensure that judicial proceedings are conducted fairly and that the right of the parties is respected." This principle is also in the International Covenant on Civil and Political Rights (ICCPR) which provides that "everyone shall be entitled to fair and public hearing by a competent, independent, and impartial tribunal in the determination of any criminal charge or a suit at law." ICCPR acknowledges that right to public trial is not absolute and that certain

of expression as a fundamental feature of democratic society and includes under it freedom of press. European Convention on Human Rights also admits freedom of press as paramount. However, freedomloving USA's Supreme Court has confirmed the potential danger the impact of media could have on trials. This must be due to the continuance of jury system. The increasing tendency to use media when a matter is sub-judice is a subject of discussion among lawyers and laymen in India. In England. the court held that it is important to understand that any other authority cannot usurp the function of the court in a civilized society.

On the other hand, it is a debatable point whether media exposure before court trial can prejudice a case. Courts and judges go by written documents and evidence and, if so, cannot be influenced by media or public reaction. If media investigations expose evidence relevant for a case, it has to be welcomed. Therefore, adherence to truth must be the foundation of media investigation.

Tirupati temple awash with ₹50 cr demonetised cash offerings

Tirupati, Sept 16: The world famous Tirupati temple in Andhra Pradesh is awash with ₹50 crore demonetised cash offerings, which it continued to receive from the devotees, but could not utilise.

'Though the Central government had demonetised ₹1.000 and ₹500 notes November 8, 2016, devotees continued to offer demonetised notes, said a TTD official. As a result, the temple in the

southern state received 1.8 lakh notes of ₹1,000, amounting to ₹18 crore, and 6.34 lakh notes of ₹500. amounting to ₹31.7 crore. All the offered demonetised notes amounted to a total of around ₹50 crore.

Unable to monetise the huge amount of delegitimised cash, Tirumala Tirupati Devasthanams (TTD) Chairman, YV Subba Reddy, has requested Union Finance Minister Nirmala Sitharaman to enable the temple to deposit the old money with the Reserve Bank

of India (RBI) or any other commercial one to monetise that amount. "Once monetised, TTD will use it to fund several spiritual and wel

fare activities," the official said. Regarding the old notes, TTD had already written to the Union Finance Ministry and the RBI in 2017 but did not receive a favourable response. "As this issue is linked to the faith and sentiments of the devotees, Reddy requested Sitharaman for a favourable outcome, enabling the temple to deposit the money with the RBI or any other bank," the official said

Reddy has asked the Finance Minister for favourable instructions in this direction.

The TTD chairman said that the temple could not stop the devotees from offering old notes as it is linked with their faith and religious sentiments.

TTD is a conglomeration of 12 temples and their sub-shrines. It employs 14,000 people. Spread over 16.2 acres, the main Tirumala temple is dedicated to Lord Sri Venkateswara, also known as Srinivasa, Balaji and Venkatachalapati.

'Bleeding Heart' was to replace Hurriyat in Valley

Srinagar, Sept 16: After tightening of terror funds by the National Investigation Agency (NIA), Pakistan had approved a proposal by Irfan Shafi Mir, who was arrested along with Deputy SP Davender Singh, to set up a new outfit called 'Bleeding Heart' as it had realised in 2018 that Hurrivat Conference, the separatist conglomerate created by ISI, won't be able to deliver any more

During a visit to Pakistan in 2018, Mir held an extensive discussion with ISI officials as well as terrorist top brass to set up an NGO by the name 'Bleeding Heart' which would replace the role of Hurriyat Conference, says the NIA chargesheet filed in a designated court of Jammu.

Mir was arrested along with Jammu and Kashmir Deputy Superintendent of Police Devender Singh and Hizbul Mujahideen terrorist Syed Naveed Mushtaq alias Naveed Babu and accomplice Rafi Ahmad Rather

The details of the 3,064-page chargesheet, accessed by PTI, show that Mir alias 'Advocate' made this proposal of the NGO and had started working for it after receiving a go ahead from his mentors across the border.

The NIA filed the chargesheet under the Unlawful Activities



ISI and terror groups were rattled by the case of May 2017 registered by the NIA against members of Jamaat-ud-Dawa, Dukhtaran-e-Millat, Lashkar-e-Taiba, Hizbul Mujahideen and other separatist groups and leaders in the state for allegedly raising, receiving and collecting funds to fuel separatist and terrorist activities, conspiracy to cause disruption in the Valley, and waging war against India

(Prevention) Act and various sections of the Indian Penal Code against Mir. Singh. Naveed. his brother Syed Irfan Ahmad, Rather and businessman Tanveer Ahmad Wani, former president of the Line of Control Traders Association.

According to the NIA, the accused were part of a deep-rooted conspiracy hatched by Pakistan-based terrorist organisation Hizbul Mujahideen and Pakistani State agencies "to commit violent acts and to wage war against the Union of India.

During his extensive questioning, the NIA said Mir had met banned

terror group Hizbul Mujahideen chief Syed Salauddin, his deputy Amir Khan, the so-called operational chief Khursheed Alam and the terror group's financial head Nazar Mehmood where the broad

concept of 'Bleeding Heart' was discussed. Later during his stay in Pakistan. Mir had a meeting with ISI officers like Umar Cheema, Ahshan Chaudhary and Sohail Abbas who also tasked him to work on a new 'Hawala (non-banking) channel' for transfer of money for sustaining terrorist activities in the Kashmir val-

ley. The investigation into the case

led by Inspector General Anil Shukla and his team has listed 3,017 oral and documentary evidences along with the chargesheet.

The chargesheet also gives instances of his connection with officials of Pakistan High Commission in India with whom he was in constant touch and also received mon etary assistance.

Visa applications from Kashmir recommended by Mir were also given top most priority at the Pakistan High Commission, the chargesheet said.

Mir was sitting in the car driven by Singh January 11 this year along

with Naveed and Rather when their car was intercepted by Jammu and Kashmir police near Qazigund on the national highway connecting the Valley with the rest of the country

A search of the vehicle led to the recovery of an AK-47 rifle, three pistols and a cache of ammunition and explosives. The NIA took over the case January 17 this year.

After thorough investigation into the case, the NIA arrested many people including influential businessman Zahoor Ahemd Watali and prominent politician Sheikh Abdul Rashid alias 'Rashid Engineer'.

"Prima facie, there are grounds to reexamine the report. I would like to get into the sample methodology and questionnaire to understand the report better," Chinaveerabhadrudu told IANS while pointing out that it was important to understand how the NSO had carried out the survey.

For 2017-18, the NSO rated the southern state lower than Bihar. Rajasthan, Jharkhand, Odisha, Chhattisgarh. and Madhva Pradesh in literacy rate for individuals above seven years of age.

"Since we are almost 10 years from the last Census, in any way, the literacy rate should only be increasing and not decreasing," the source pointed out.

"This is only a sample study -- its main objective is not to find out the literacy rate, but about the consumption patterns. So, the data or observations of the NSO study about literacy are tangential or a byproduct of the research. The main objective is not to study literacy. So you need not give it more importance than what is required,' the source added. Irrespective of the NSO adjudicating Andhra Pradesh as the lowest literate state, several towns and a few cities in the state are major educational hubs, drawing thousands of students for studies. Vijayawada, Guntur, Nellore, Bhimavaram, Kakinada, Vishakapatnam, Rajamundry, Kurnool and others are known for famous schools, intermediate junior colleges and several engineering colleges.

Amaravati, Sept 16: Andhra Pradesh's ruling party YSRCP has urged the Centre to order a CBI investigation into the alleged land scam in the Amaravati capital region and irregularities in the Andhra Pradesh State FiberNet Limited (APSFL) during the previous TDP regime.

The YSRCP, which had already made a request in this regard a couple of months ago, decided to once again raise the issue during the ongoing Parliament session. The YSRCP alleged that the then TDP government resorted to insider trading, benefiting Chandrababu Naidu, his family members and those close to them.

The party reiterated that the information about choosing Amaravati as the location for building the new state capital was leaked by those in power and they through their aides purchased land in and around Amaravati at throwaway prices.

The investigations conducted so far including by the Cabinet Sub-Committee revealed that before the announcement of Amaravati as the state capital, 4,069.94 acres of land was purchased in Krishna and Guntur districts by those involved in insider trading.

The YSRCP Parliamentary Party has decided to highlight the 'nepotism, manipulation, corruption and breaking the oath of secrecy by the people in high office who were privy to information leaking it to their close circles and the insider trading aris-

ing out of such malpractice.' People in the know of cabinet decisions including cabinet ministers, legislators, party associates, and their benamis reaped undue benefits by buying land ahead of the actual announcement, it said


According to YSRCP leaders, the beneficiaries included Chandrababu Naidu, his son and then cabinet minister Nara Lokesh. his close associate and NRI, Vemuri Ravi Kumar Prasad, then minister Paritala Sunita, Public Accounts Committee chairman and MLA Pavvavula Keshav, former MLAs G V S Anjaneyulu and Dhulipalla Narendra, Kambampati Rammohan Rao and several other TDP leaders.

The benami transactions that took place in the land deals allegedly involved Ministers and TDP leaders. The boundaries of the capital area were redrawn to suit their favoured few to keep their landholding at an advantageous place. The YSRCP also alleged that assigned and government land was grabbed and surrendered for land pooling to get the benefits announced by the government. Unwilling farmers were intimidated to acquire their land. The land pooling scheme rules also do not comply with the Land Acquisition Act. The YSRCP also decided to highlight the irregularities in APSFL involving then chief minister Chandababu Naidu, his son Nara Lokesh and then technical advisor to the government, Vemuri Hari Krishna Prasad.

Saifuddin Soz has said the issuance of a large number of domicile certificates in J&K has led to apprehensions of demographic changes among Kashmiris.

There are 18.678 active cases in the UT as of now, while 37,062 patients have recovered, according to the officials.

Meanwhile, two cab drivers have been arrested from Tourist Reception Center in Srinagar for allegedly providing fake COVID-19 negative reports to people wanting to travel outside the Kashmir valley amid the pandemic, police said Wednesday. The matter was reported to police by a man who had approached the TRC for a trip outside the valley with his family. The man asked the drivers about the travel norms and told them that he had not undergone a COVID-19 test. New Delhi, Sept 16: In what could lead to a major crack in the National Democratic Alliance (NDA) in Bihar ahead of the crucial state Assembly polls scheduled later this year, Lok Janshakti Party (LJP) leaders have demanded to field candidates on the seats contested by the ruling Janata Dal-United (JD-U).

The LJP also asked the BJP to contest on more seats than the ruling JD-U in the state. According to a highly-placed LJP source, the demands were raised during the meeting of all the MPs and former MPs of the party at the residence of LJP supremo Chirag Paswan here.

A party source present in the meeting said that all the MPs and former MPs of the LJP demanded that the BJP should contest more seats than the JD-U in Bihar. "Former MP Kali Pandey demanded that the LJP should announce candidates on seats which are being contested by the JD-U in the upcoming Bihar Assembly elections," the source said.



Kota (Raj), Sept 16: At least 11 people, including women and children, were killed after a boat carrying over 30 devotees to a temple in Rajasthan's Bundi district capsized in the Chambal river here Wednesday morning, officials said.

Three people are still missing while 20 devotees were rescued, they added. Belonging to the Khatoli-Itawa area of Kota, they were going to the Kamleshwar temple in Indergarh of Bundi to offer prayers.

The accident took place around 8.45 am near Gotra village under the Khatoli police station, about 110 kilometres from Kota district headquarters.

The depth of the river where the boat overturned is around 40-45 feet, an official said, adding a rescue operation was launched by the SDRF and the NDRF. "At least 11 people have been killed in the mishap in Khatoli while the search for three others is under way." District Collector Ujjaval Rathore said, adding that 20 people were rescued. According to local residents, 35-50 people were on board with 14 to 15 motorbikes when the accident took place, he added. The district collector said prima facie, a weak structure of the boat caused the mishap. Area DSP Shubhkaran said the bodies were handed over to families after autopsy and they have lodged a case against the boat's Sailor and owner. Describing the incident as "sorrowful and un-fortunate", Rajasthan Chief Minister Ashok Gehlot on his Twitter handle expressed condolences to the aggrieved families. The Chief Minister announced a compensation of Rs 1 lakh to the kin of each deceased. Lok Sabha Speaker Om Birla, who is an MP from the Kota-Bundi constituency of Rajasthan, too expressed grief over the incident. Local Congress MLA Ramnarayan Meena expressed sorrow over the tragedy and demanded that the relief amount be increased.



Vulture-toxic drug still being sold in India: Researchers

New Delhi, Sept 16: More than a decade after being banned, a vulturetoxic drug is still being prescribed in pharmacies across India, according to an undercover investigation led by a group of environmental organisations and universities.

In 2003, the widespread veterinary use of a non-steroidal antiinflammatory drug diclofenac in cattle was discovered to be decimating the most iconic birds in South Asia -- Asian vultures -- after entering the vultures' food chain. This environmental disaster

caused 99.9 per cent of white-rumped vultures and 97 per cent of long and slender-billed vultures to be wiped out -- a staggering 40 million birds -- pushing these birds to the brink of extinction.

Governments were quick to react, with India, Pakistan, Nepal and Bangladesh banning the drug from veterinary practice. Yet cattle carcasses in India continue to be found containing potentially lethal concentrations of diclofenac along with contaminated, dead vultures.

Worryingly, populations of these critically endangered birds were not showing significant signs of recovery. The new study, published recently in the journal Bird Conservation International, set out to identify what non-steroidal antiinflammatory drugs were being offered for sale for veterinary use.

From 2012 to 2017, members of the research team visited pharmacies and asked for drugs to treat



their injured cow, buying the first drug that was offered. This research was undertaken by the Royal Society for the Protection of Birds

"We had to pretend to be livestock owners so we could get an unbiased picture of its availability." In India, trends in sales of different non-steroidal anti-inflammatory drugs varied between the different regions surveyed.

In the first year, diclofenac was still the most commonly offered non-steroidal anti-inflammatory drug. Whilst sales of diclofenac declined in some states, elsewhere there were actually increases. In the five Indian states surveyed in the

final year, 2017, diclofenac was still being offered by 10 to 46 per cent of pharmacists.

Chris Bowden, Programme Manager of Saving Asia's Vultures from Extinction (SAVE), said: "The importance of these results is emphasised by the most recent published nationwide population surveys of vultures in India and Nepal." "In Nepal, there is evidence that vulture populations have begun to recover, but in India they either continue to decline or, at best, are stable but at low levels and not yet showing signs of a recovery." However, the study had some positive findings. Sales of diclofenac declined in all three countries over the course of the survey, al-though there was variation depending on the region.









Hospitals scramble for oxygen as Covid cases top five million

Mumbai, Sept 16: India's coronavirus infections surged past 5 million Wednesday, piling pressure on hospitals grappling with unreliable supplies of oxygen that they need to treat tens of thousands of critical patients.

In the big states of Maharashtra, Gujarat and Uttar Pradesh, that are also some of the worst-affected by the virus, demand for oxygen has more than tripled, doctors and government officials said, prompting urgent calls for help.

"Desperate patients have been calling me through the night but I don't know when I will get stock,' Rishikhesh Patil, an oxygen supplier in the western city of Nashik, said. The health ministry reported 90.123 new infections Wednesday, taking the total caseload to 5.02 million.

The death toll from COVID-19 is now at 82,066, the ministry said, with 1,290 fatalities recorded in the previous 24 hours. India has the world's fastest growing novel coronavirus epidemic and added its last



million infections in just 12 days. It is only the second country in the world to have more than 5 million cases, after the United States. "At least 6% of India's nearly 1

million active cases need oxygen support," health ministry official Rajesh Bhushan said. "Supplies were adequate but state governments should monitor usage and flag shortages," he said

"The problem happens when at a facility level, if there is no inventory management. Every state should ensure this," Bhushan said In the capital of India's most populous state of Uttar Pradesh, the total requirement of oxygen cylinders stood at 5,000 cylinders compared with 1,000 cylinders in normal times, a government official said. The worst-affected state of

Maharashtra has decided to reduce supply to neighbouring states to meet its growing demand, a state government official said. Vehicles carrying oxygen will get right of way and can use sirens to ensure they reach hospitals faster.

Ravindra Khade Patil, a doctor who manages two private hospitals on the outskirts of Mumbai. spoke of the stress he faces trying to ensure he can supply his patients with oxygen. Two days ago, the supplier of oxygen to his hospitals did not turn up at his usual time.

Patil made frantic calls to the supplier and then to nearby hospitals and lawmakers, knowing that if the oxygen didn't arrive on time, it would be too late for some of his most critical patients. Finally, past midnight, thanks to pressure from a government official, the oxygen tanks arrived. "If they had arrived even a couple of hours late, we could have lost five or six patients. Every day, we are worried if we will be able to meet our requirements, if the oxygen will arrive or not," Patil said.

Centre to SC: Will welcome speedy trial

New Delhi, Sept 16: The Centre Wednesday told the Supreme Court that it would welcome any order for the speedy trial of sitting and former MPs/MLAs facing criminal and corruption charges.

Solicitor General, representing the Centre, submitted before a bench headed by Justice N. V. Ramana that the apex court can fix time frame for the completion of trials in pending cases against Legislators, sitting and former.

Senior advocate Vijay Hansaria, who is a court appointed amicus curiae, has suggested that trials in these matters should be completed within one year. The apex court will pass an order on the report

submitted by the amicus suggesting expeditious disposal of criminal trials pending against legislators across the country.

After revealing that 4,442 cases are pending against sitting and former MPs and MLAs in different courts, amicus curiae have informed the Supreme Court that there is no uniformity in setting up of Special Courts for MPs/MLAs across the country

The High Courts may be directed to prepare a blueprint for expeditious disposal of the cases not later than one year for conclusion of trial, suggested the amicus. In the supplementary submission. Hansaria had said the analysis of the pending cases show that there is no uniformity

as to the setting up of Special Courts for MPs/MLAs.

The report said: "In the states of Andhra Pradesh, Karnataka, Madhya Pradesh, Telangana and West Bengal, there is one Special Court for all cases against MPs/MLAs. In the State of Telangana apart from the Special Court for MPs/MLAs cases are also pending before the Special Court, CBI. In all other states, these cases are pending in respective jurisdictional courts".

The report was filed on an order passed by the top court on a PIL by BJP leader and advocate Ashwini Upadhyay, who urged the court to give directions for speedy trial of criminal cases against sitting and former lawmakers

New Delhi, Sept 16: With Islamic State and its various manifestations spreading base in 12 Indian states in recent years, the Sunni jihadists' group is now "most active" in these states across the country.

Apart from southern states like Telangana, Kerala, Andhra Pradesh, Karnataka and Tamil Nadu - where the Iran and Syria-based terrorist outfit penetrated years ago -- investigating agencies have found their links in states like Maharashtra, West Bengal, Rajasthan, Bihar, Uttar Pradesh, Madhya Pradesh, and Jammu and



Kashmir as well. The Islamic State or ISIS, which has taken control over much of Syria and Iraq since 2014 and has branches in countries like Bangladesh, Mali, Somalia,

and Egypt and links with other terror outfits like Lashkar-e-Taiba and Al-Qaeda, is using various social media platforms to propagate its ideology in India.

Many instances of individuals from different states joining the group have come to the notice of the central and state security agencies. The information on IS was provided by Minister of State of Home G Kishan Reddy in the Rajya Sabha in a written reply to Bharatiya Janata Party MP Vinay P Sahasrabuddhe's Unstarred Question. The Minister said: "The cyberspace is being closely watched by Indian agencies and action taken as per the law."

Reddy said that probes by the National Investigation Agency (NIA) have revealed that the IS is most active in Kerala, Karnataka, Andhra Pradesh, Telangana, Maharashtra, Tamil Nadu, West Bengal, Rajasthan, Bihar, Uttar Pradesh, Madhya Pradesh, and Jammu and Kashmir.

The NIA -- India's anti-terror agency -- has registered 17 cases related to the presence of IS in Telangana, Kerala, Andhra Pradesh, Karnataka and Tamil Nadu. It has arrested 122 accused. Reddy replied. "Islamic State, or Islamic State

of Iraq and Levant (ISIL), or Islamic State of Iraq and Syria (ISIS), or Daesh, or Islamic State in Khorasan Province (ISKP), ISIS Wilayat Khorasan, or Islamic State of Iraq and the Sham-Khorasan (ISIS-K) and its manifestations have been notified as terrorist organisations and included in the First Schedule to the Unlawful Activities (Prevention) Act, 1967 by the central government," the minister said. Asked whether the government has any information on how these group members are funded and whether they are getting any foreign funding for terror activities, the minister replied in the positive.

However, Reddy did not explain what information the Ministry of Home Affairs -- which is responsible for internal security and law and order in the country -- has onthe IS and which foreign country is funding for their terror activities.

Sally's northern eyewall had raked the Gulf Coast with hurricaneforce winds and rain from Pensacola Beach, Florida, westward to Dauphin Island, Alabama, for hours before its center finally People play in a flooded parking lot

"I have at his demand sent a request for parole,' Breivik's lawyer, Oeystein Storrvik, told VG. "This is a right that all prisoners (who can be detained indefinitely) have and that he wants to use," he said. Storrvik was not immediately available for comment. Reactions to the news were immediate and negative.

United Nations, Sept 16: Social distancing at the global level will not help as no country could combat COVID-19 alone, President of the UN General Assembly's 75th session Volkan Bozkir has said, asserting that multilateralism is the "panacea" to all the problems in the world.

Bozkir, addressing the UN ambassadors and delegates, said that since the beginning of the crisis earlier this year, critics of multilateralism have become more vocal and the pandemic has been used to justify unilateral steps and weaken the rules-based international system.

"In the past six months, our plans for the 75th year of the United Nations have changed. Today, we have other urgent priorities. Our masks remind us of the very serious threat we face. They remind us we are in this together," Bozkir said as the 75th session of the General Assembly commenced on

Tuesday. Wearing masks, UN diplomats and envoys sat socially distanced in the iconic General Assembly Hall as the high-level annual session begins in a largely virtual format this year due to the COVID-19 pandemic.

"International organisations have been reproached and the need for international cooperation has

been questioned. These criticisms are not baseless but their conclusions are misguided," the veteran Turkish diplomat told the 193-member General Assembly.

Giving a clarion call for strengthening multilateralism to combat the pandemic, Bozkir said, "Make no mistake: No state can combat this pandemic alone. Social dis-

tancing will not help at the international level. Unilateralism will only strengthen the pandemic. "It will move us further away from our shared goal. At this time of crisis, it is our responsibility to strengthen people's faith in multilateral cooperation and international institutions, with the UN at their center." Later, addressing the UN correspondents at a press briefing, Bozkir said that multilateralism is the "panacea" to all the problems of the world.

Responding to a question on whether he thinks the UN can survive a second term of US President Donald Trump, who has been very critical of its agencies and withdrawn from the UN entities and agreements like the World Health Organization and the Paris climate accord, he said if the UN shows to the world that it is doing its job in a strong manner and "the wind is blowing from all the world behind to the UN, then I don't think any country or any person can think of abolishing this institution or lessening its strength."

UN Secretary-General Antonio Guterres, addressing the opening of the 75th session of the General Assembly, said in the landmark year of the world organisation, "it is clear that the world has high expectations of us, as the main platform for multilateralism and cooperation on a rules-based international system.

For the first time in the 75-year history of the United Nations, state heads and government, ministers and diplomats from 193-UN member states will not be gathering in New York for the highlevel UNGA week due to the coronavirus pandemic.

World leaders will send prerecorded video statements in advance to the UN for the largely virtual General Debate as well as other virtual summits planned during the session, including the highlevel meetings to commemorate the 75th anniversary of the UN.

Smoke from US fires reaches Europe

Berlin: Satellite images show that smoke from wildfires in the western United States has reached as far as Europe, scientists said Wednesday. Data collected by the European Union's **Copernicus Atmosphere** Monitoring Service found smoke from the fires had traveled 8,000 kilometers (almost 5,000 miles) through the atmosphere to Britain and other parts of northern Europe. The European Centre for Medium-Range Weather Forecasts, which operates some of the Copernicus satellite monitoring systems, said the fires in California, Oregon and Washington state have emitted an estimated 30.3 million metric tonnes (33.4 million tons) of carbon.

New Delhi, Sept 16: The government has brought amendments to the Banking Regulation Act, 1949 in order to protect the interests of the depositors, Union Finance Minister Nirmala Sitharaman said in Parliament Wednesday.

The Finance Minister said the government is trying to bring amendments in order to protect the interest of depositors who in the last two years have been put to hardships.

The depositors in some unfortunate situations in the banks or cooperative societies, which are also operating as banks, are put to hardship, the Minister said while moving the Banking Regulation (Amendment) Bill, 2020 to amend the Banking Regulation Act, 1949 in the Lok Sabha.

She said the government had introduced the Bill so that the depositors' interests will be taken care of. But, the Minister said, unfortunately, during the Budget session the government could not have this Bill passed and had to bring in an ordinance. Sitharaman said the ordinance was brought in only because the financial health of many of these cooperatives, which were also performing as banks, was becoming very bad.

She informed the Lower House that the financial condition of 277 urban cooperative banks was very delicate and they were reporting losses, while 105 such banks were unable to fulfil their minimum reg

She said her Ministry has brought in amendments in Section 3, Section 45 and Section 56. By amending Section 3 and 56, the government is making provisions applicable to banking companies applicable to cooperative banks also so that cooperative banks are equally subject to better governance and sound bank ing regulations through the Reserve Bank of India (RBI). Section 45 is being amended because it will enable the RBI to make a theme of

reconstruction and amalgamation, she said.

Giving the example of the recent Yes Bank reconstitution scheme, she said it is to protect the interest of the public depositors without making the bank undergo a moratorium period. She also gave an example of BMC bank in which the depositors could not get a resolution till now.

The minister clarified that the Bill will not be applicable to the Primary Agricultural Credit Society and will also not be applicable to the cooperative society whose primary business is providing long term finance for agricultural development. "This will be applicable only on those who bank, banker and banking business in cooperative society."

Mentioning that her government is not doing anything new, the Minister said Section 3 and 56 have also been amended earlier in 1965, 1984, 1987, 1989 and 2012.

On the first day of the session, Sitharaman had withdrawn the Bill saying "it is being withdrawn to add a few new things giving the Reserve Bank of India a chance to be able to restructure distressed cooperative banks, which are in serious need". The Bill was not passed by Parliament during the Budget Session and subsequently an ordinance was issued.

"Government has consistently taken steps to balance our trade with China by increasing our exports to China and reducing our dependence on imports from China," he said.

In a separate reply, the minister said at present, about 550 tariff lines (or products) are under the restricted/prohibited category for imports under the Foreign Trade Policy. Imports of these products are restricted from all countries, including China.

Replying to a separate question, he said merchandise exports from special economic zones (SEZs) dipped to ₹81,481 crore during April-August, 2020 as against ₹1,30,129 crore in the same period of 2019-20. "However, services exports have shown a growth of 9 per cent during April to August 2020in comparison to corresponding period of previous year," he added.

"No matter how far I go from the game, no matter how long I stay out, when I come back, it has to be worth it. I have prepared very well and I think, great things are coming ahead," the 26-yearold flamboyant all-rounder added.

Rome: Novak Djokovic behaved better Wednesday in his first match since being defaulted from the US Open. The top-ranked Serb was mostly courteous with the chair umpire during a 6-3, 6-2 win over local wild-card entry Salvatore Caruso in his opening match at the Italian Open. When the umpire came down to inspect a ball mark on the red clay early in the first set and made an overrule in Caruso's favor, Djokovic just replied, 'Yup', and rubbed out the mark with his red sneaker. When Caruso impressed him — the Italian hit 13 winners to Djokovic's 12 - Diokovic said, 'Bravo'. Djokovic's only testy moment came during the third game of the second set, which went to deuce seven times before Djokovic finally broke Caruso's serve. As the game wore on, Djokovic appeared bothered by crowd noise. even though the Campo Centrale is empty of fans this year because of the pandemic.

Italian teenager Musetti stuns Wawrinka in Rome

Rome: Local teenager Lorenzo Musetti stunned Stan Wawrinka 6-0. 7-6(7-2) in the first round of the Italian Open for a memorable first win on tour. Out-hitting Wawrinka's famed backhand with a one-handed version of his own, the 18-year-old qualifier moved the three-time Grand Slam champion from corner to corner and displayed an all-court game that belied his years. Musetti became the first player born in 2002 to win on the ATP tour - after fellow Italian Jannik Sinner achieved the feat last year for players born in 2001. Wawrinka, who chose not to travel to the US Open, appeared rusty and committed a series of errors early on. Musetti, who came through gualifying, was the runner-up in the 2018 US Open junior final then won the Australian Open junior title in 2019.

Germany to take on Belgium on FIH Pro League's return

Lausanne: Following a long COVID-19 hiatus, the second season of the FIH Hockey Pro League will return next week in Dusseldorf where Germany will entertain the national women's and men's teams of Belgium September 22 and 23. The fixtures – which take place at Dusseldorfer Hockey Club 1905, located less than 90 kilometres from the Belgian border - will see the teams face each other twice over the two days. The International Hockey Federation had in April extended the second season of the Pro League through to June 2021 because of the global health crisis. Season 2 of the league was initially set to run from January to June 2020. Around one third of the planned matches were completed between January and early March, before the crisis brought the competition to a standstill.

East Bengal place bid to participate in ISL 2020-21

New Delhi: Kolkata football giant East Bengal have submitted the Invitation to Bid (ITD) documents to Football Sports Development Limited (FSDL) to participate in the upcoming edition of the Indian Super League (ISL). East Bengal had recently announced that they had sold a majority stake to city-based Shree Cement Ltd and would appeal to the ISL organisers in a bid to make a dramatic late entry into the country's top-tier club competition. "We are extremely happy to announce that the consortium of Shree Cement Ltd and East Bengal club have placed the bid to participate in this year's ISL," the club announced on Twitter late Tuesday. The red-and-gold brigade's new investors were slated to pick up the bid proposal for a spot in the ISL in the name of 'Shree Cement Foundation', a new company it has registered with the Ministry of Corporate Affairs.



Grenoble (France), Sept 16: Defending Tour de France champion Egan Bernal has pulled out of the race ahead of a mammoth stage in the Alps, his Ineos Grenadiers team said Wednesday.

Bernal had been struggling since last weekend's stage in the Jura mountains, where he dropped more than seven minutes on the main contenders and slipped out of contention. Hampered by back pain, the 23-year-old rider lost more time during Tuesday's first Alpine stage.

Bernal was in 16th place overall, 19 minutes and four seconds behind race leader Primoz Roglic. "This is obviously not how I wanted my Tour de France to end, but I agree that it is the right decision for me in the circumstances," Bernal said. "I have the greatest respect for this race and I'm already looking forward to coming back in the years ahead."

Last year, Bernal became the first Colombian to win the Tour, and the youngest



champion of the post-World War II era. His team said Bernal will try to recover as quickly as possible and redefine his goals for the rest of the season.

"We have taken this decision with Egan's

best interests at heart," Ineos manager Dave Brailsford said. "Egan is a true champion who loves to race, but he is also a young rider, with many Tours ahead of him.

Bernal's withdrawal marked the end of Ineos' dominance at cycling's biggest event. The successful period started in 2012 with Bradley Wiggins' victory, when the team was called Team Sky.

The squad won seven of the last eight editions with four different riders, but its bestplaced rider this year is Richard Carapaz, who stood 14th ahead of Wednesday's Stage 17.

Arguably the toughest, the trek features the Col de La Madeleine and the Col de La Loze, the Tour's highest point this year at 2,304 meters. The traffic-free pass between the ski resorts of Meribel and Courchevel was opened to cyclists this year after a forest track was paved by local authorities. The last six kilometers of the climb are particularly difficult, with very steep sections and sharp turns.

Chennai, Sept 16: Indian Grandmaster P Harikrishna claimed a share of the top position with Armenian GM Levon Aronian after posting two wins and a draw in three rounds of rapid competition in the St Louis Rapid and Blitz online chess tournament.

The India No.2 started with a win over US Grandmaster Leinier Dominiguez, before settling for a draw with Iranian prodigy Alireza Firouzja in games played late Tuesday. In the third round, Harikrishna pulled off a victory over experienced Russian Alexander Grischuk in 41 moves.

World champion Magnus Carlsen, the favourite to win the title, was fifth with three points. After a win over Hikaru Nakamura in his opener, the Norwegian went down to Russia's Ian Nepomniachtchi in the second round. A draw with Wesley So in the third left the World No.1 in fifth spot.


Harikrishna, coming from a good showing in FIDE Online Olympiad, outwitted the American in 51 moves with black pieces, to begin his campaign in the elite 10-player event. The Indian ace will face Nepomniachtchi in the fourth round, followed by games against Aronian and Carlsen late Wednesday

Manchester, Sept 16: Jonny Bairstow's (112, 126b, 12x4, 2x6) wonderful century and a late flourish from Chris Woakes (53 n o, 39b, 6x4) helped England post 302/7 in their 50 overs in the third and final ODI against Australia here, Wednesday. The series is locked at 1-1.

Bairstow played a superb innings on a track where most of the English batsmen struggled to get going. Bairstow was ably supported by Sam Billings (57, 58b, 4x4, 2x6), who had scored his maiden ODI century in the first ODI.

Earlier, England won the toss and opted to bat first, which was backfired in a most unexpected way. Mitchell Starc (3/74) struck twice in the first two balls of the innings pegging back Jason Roy and Joe Root.

However, England skipper Eoin Morgan (23) and Bairstow made amends adding 67 runs for the third



(3/51) struck twice. He first broke the dangerous-looking stand removing Morgan, before getting rid of Jos Buttler to reduce the hosts to 96/4.

It proved to be the Aussies' last laugh in the innings as Bairstow and Billings joined hands to add 114 runs for the fifth wicket. It was Zampa, yet again, who broke the stand dismissing Billings. Pat Cummins (1/53) then came to attack and he accounted for the dismissal of Bairstow

With the scoreboard reading 220/6, Woakes had the opportunity to take England to a competitive total. He was ably supported by Tom Curran (19) as the duo put together 46 runs. Then, Woakes changed gears to find some quick runs as he and Adil Rashid (11 n o) guided the hosts past 300.
