Blast exposes safety loopholes

Bhubaneswar, Oct 10: The recent filling station explosion at the heart of the capital city has exposed several loopholes in the legal framework monitoring the safety standards of petrol pumps

The incident has also raised concerns regarding the safety of people living in close vicinity of such hazardous outlets.

Experts from various legal institutions claim that there is a desperate need to frame fresh rules for setting up petrol pumps in residential areas.

"We have a dearth of legal framework to restrict petrol pumps in residential and populated areas of cities. The latest we have is a norm by the Central Pollution Control Board (CPCB) which restricts setting up of new petrol pumps within 50 metres of schools, hospitals and residential areas," Sankar Prasad Pani, lawyer at the National Green Tribunal (NGT), told Orissa POST.

He added, "The recent case showed that petrol pump explosions can impact an area of 200 metres. We need to look into restricting such stations in residential areas and revisit the law after taking into consideration

have the jurisdiction to approve the borrowing plan of states and it has to be decided only between the states and the expenditure department.

The constitutional provisions with regard to borrowings to be undertaken by states is clear. If some states want a vote on the issue at GST Council meeting they seem to be mistaken about the mandate of the Council. Even if voting is done there, it would be meaningless." said the source.

With the Covid-19 pandemic sharply reducing the revenue realisation of both the Centre and the states, the GST compensation needs of states have enlarged substantially beyond what is expected to be collected through compensation cess. This gap, however, needs to be filled and in this regard the Centre offered the states two borrowing options to meet the shortfall in compensation cess collection

this year. The GST Council is yet to receive the unanimous support of the states for this proposal with about 10 opposition ruled states

and union territories wanting the options to be dropped and the Centre undertaking all borrowings to pay for the GST compensation shortfall to states.

"Majority support of 21 states is for the first option suggested by the Centre. So, even in voting, this option will win. But without the Council's mandate, voting will not take place," said the source quoted earlier.

The expenditure department in the finance ministry is already working and discussing with the states individually to get the borrowing programme going so that the compensation issue is settled.

'60K PLA troops on India's border'

Washington, Oct 10: China has amassed 60,000 troops on India's northern border, US Secretary of State Mike Pompeo has said as he hit out at Beijing for its bad behaviour and the threats it poses to the Quad countries.

The foreign ministers from the Indo-Pacific nations known as the Quad group - the US, Japan, India and Australia - met in Tokyo Tuesday in what was their first inperson talks since the coronavirus pandemic began. The meeting took place in the backdrop of China's aggressive military behaviour in the Indo-Pacific, South China Sea and along the Line of Actual Control (LAC) in eastern Ladakh.

When doubts were cast on the purported study, the CMO deleted the tweet in English. Almost all vernacular dailies carried the reported Oxford University study prominently Friday.

Set aside order on NPA classification freeze: RBI to SC

New Delhi, Oct 10: The Reserve Bank of India has urged the Supreme Court to lift the across-theboard stay on classification of nonperforming asset (NPA) till further orders as it has huge implications for the banking system

In a fresh affidavit filed in the apex court, the RBI said, "It is humbly submitted that this court had given an across-the-board stay on classification of any account as NPA till further orders. If the stay is not lifted immediately, it shall have huge implications for the banking system, apart from undermining the regulatory mandate of the Reserve Bank of India.'

September 3, in a respite to

stressed borrowers, the Supreme Court had directed that accounts not declared NPAs as of August 31 should not be classified as such until further orders.

October 3, in an affidavit, the Centre had informed the court that any account becoming non-performing even due to the bank's or any other delay need not suffer from being labelled as NPA.

The classification of a loan account as NPA, based on the record of recovery, actually enables the lenders to follow the regulatory guidelines with regard to income recognition and provisioning. Every regulatory forbearance has its tradeoffs in terms of adverse incentives and unintended consequences". said the RBI in the affidavit

it is not possible to revise its decision to waive interest-on-interest for loans up to ₹2 crore, wherein the government would bear the cost for MSME loans and personal loans. On the aspect of sector-specific relief instead of a monolithic resolution framework sought by real estate and power sectors, the RBI said such prayers deliberately obfuscate the fact that resolution framework gives complete discretion to the lending institutions and borrowers to arrive at resolution plans tailored to the specific requirements of sector subject. The RBI said that sectors such as

power and real estate were already stressed even before the coronavirus pandemic on account of various factors pertaining to sector-specific problems. "Nonetheless, it is submitted that the travails of the realty sector cannot be solved through banking regulations. The banking regulations of the RBI cannot substitute the redressal of structural problems of the real estate sector," the affidavit read.

Road opens for hassle-free access to SCB

Bhubaneswar, Oct 10: As part of a plan to transform the SCB Medical College and Hospital (SCBMCH) in Cuttack into a world-class healthcare institution. Chief Minister Naveen Patnaik Saturday inaugurated the renovated Taladanda canal road in the Millennium city through videoconferencing.

The embankment roads on both sides of Taladanda canal have been made three-lane connecting the SCB Medical College and Hospital from the Ring Road near Jobra barrage to ensure free passage for the outside patients.

The new road, constructed at a cost of ₹14 crore within a record time of six months, will allow patients from outside Cuttack to reach the hospital without any traffic congestion and get immediate medical attention.

Inaugurating the project, Naveen said that the main problem of this Millennium city of Cuttack is the congested narrow roads, which are causing traffic

Conman dupes doctor of ₹40L

Bhubaneswar, Oct 10: A fraudster has duped an elderly doctor here of ₹40 lakh on the pretext of investing the amount in share market which would him yield high returns.

The victim, Birendra Kumar Das, 78, a native of Banki, has been staying at Damana under Chandrasekharpur police limits here. Das has lodged a complaint with the police in this regard October 7.

Das who owns a hospital at Niladri Vihar area alleged in his complaint that the accused, Prakash Kumar Mantri, of Banki met him at his office a few months ago. Mantri introduced himself as a share broker and requested Das to invest some amount in the share market promising high returns. He also assured Das and his wife that they would get 20 per cent interest on the amount invested in the share market.

Das refused to invest in the share market as he lacked adequate knowledge about investing in stock market. However, the accused persuaded Das and his wife to make them fall in the trap by making frequent visits to their office and residence. Das reportedly gave Mantri ₹40 lakh in 23 installments to invest in share market.

However, Mantri started avoiding the elderly couple after the receiving the money. Meanwhile, Das failed to trace the accused when he visited his residence in the city and at his village.

KANDHAMAL RIOTS SC to hear plea for SIT probe Tuesday

New Delhi, Oct 10: The Supreme Court (SC) will Tuesday hear a petition filed by Archbishop John Baruwa seeking a probe by a special investigation team (SIT) into several cases registered in the aftermath of Kandhamal riots.

A three-judge bench of the apex court comprising Justices UU Lalit. S Ravindra Bhat and Hrishikesh Roy will hear the petition.

Significantly, Petitioner Archbishop John Baruwa urged the apex court to direct the state government to form an SIT headed by a senior police officer with the exclusive mandate of comprehensively looking into 315 cases in which no offence was found to be made out. He pleaded for the direction to the state government to carry out further in-

vestigation in these cases He also prayed the court to direct Odisha government to file revision petitions in 266 acquittal cases till May 2020. The petitioner also sought early disposal of cases pending for over 10 years now. The petitioner submitted that contrary to the SC's directions, the state did not look into these 315 cases and also did not take up the 266 cases of acquittal disobeying the August 2016 judgement of the Supreme Court.

He further submitted to the court that out of 284 acquittal cases, the state has filed only 18 revision petitions. According to police, Haluri Pahadsingh and Sanatan Pahadsingh, two Dalit persons of Sarua, had lodged a complaint against OTV MD, her father and brother.

As per the complaint, the duo has agricultural lands under Sarua revenue village. A few vears ago. OTV authorities had tried to lure the duo to sell their lands to the media house. However, Haluri and Sanatan refused to part their lands.

Subsequently, OTV authorities purchased anded properties close to the victim duo's agricultural lands and constructed buildings and boundary walls, said the complainants. As a result. Haluri and Sanatan lost access to their farmlands. Khurda Sadar SDPO had recorded the victim duo's statements and served a notice on OTV in connection with the land grab case. Woman dies after 10-day wait for ICU bed

Cuttack, Oct 10: A woman, who was rendered critical by consuming pesticide, died Saturday at SCB Medical College and Hospital here after waiting for a bed in the intensive care unit (ICU) despite advice by doctors, a report said.

The deceased identified as Swetapadma Nayak of Rajnagar area in Kendrapara district battled with life for 10 days and finally succumbed Saturday afternoon. Doctors, while admitting her for treatment, had advised to shift her to an ICU due to her critical health condition. However, authorities failed to shift her to an ICU due to alleged negligence in conducting an RTPCR test on her, the report said.

Reports said the woman consumed pesticide October 1 and was rushed to SCB Medical College and Hospital the same day by family members as her health condition deteriorated. She was administered treatment after she underwent a rapid antigen test which came out negative.

Later, she was shifted to the trauma ward under the medicine



department and administered treatment. There the doctors on checking her critical health condition advised to shift her to intensive care unit (ICU).

Since that day she was kept in the trauma ward and was never shifted to ICU as the hospital staff kept on dillydallying in collecting her swab for an RTPCR test as per rules. Sources said the authorities have made it mandatory for every patient to undergo an RTPCR test before availing any kind of treatment.

As a result, the woman was kept

BMC cuts de-sludging rate to improve SBS rankings

Bhubaneswar, Oct 10: In a bid to provide affordable de-sludging to the urban poor in the capital city, the Bhubaneswar Municipal Corporation (BMC) declared that it would be providing cesspool vehicles owned by the civic authorities at subsidized rates.

In notification issued by the BMC, the civic body said it will now be providing the services at Rs290 only. As per sources, while the BMC charges Rs 900 from people for de-sludging, the urban poor living in slums will be charged Rs 492 and taxes and the combined expenses will be around Rs 580.

"However, if two households are to be covered by cesspool vehicle in one trip, the price to be paid by a slum dweller to access the service will be further reduced to Rs 280. The subsidy, however, will not be applicable if one books a private cesspool vehicle," said BMC Deputy Commissioner, Sanitation, Suvendu Sahu.

Puri. Oct 10: A case was filed against Satyabadi BJD MLA Umakanta Samantray after he attended the funeral of party leader Pradeep Maharathy despite testing positive for COVID-19, police said Saturday.

The case was registered at the Sea Beach Police Station in Puri Friday night under IPC sections 269 (negligent act likely to spread infection of disease dangerous to life). 270 (malignant act likely to spread infection of disease dangerous to life) and section 3 of the Epidemic Diseases Act.

However, no case was registered against the party's Nimapara MLA and School and Mass Education Minister Samir Ranjan Dash who was also accused of attending Maharathy's funeral October 4, violating the COVID-19 guidelines.

Jagannath Sena, a local outfit, had lodged a complaint against Dash and Samantray, alleging that they attended the funeral despite testing COVID-positive. The two ruling party leaders were also accused of violating guarantine protocols.

However, Puri's Superintendent of Police Akhileswar Singh said that the minister had attended the funeral after remaining in quran-



tine for 17 days. Therefore, no case has been registered against him, Singh said. Jagannath Sena claimed that both Dash and Samantray were found to be COVID-positive at the camp held for mandatory testing at the assembly premises on September 27 ahead of the Monsoon session.

As they were diagnosed with COVID-19, the two leaders were not allowed to attend the Monsoon session, which was held from September 29 to October 6, it claimed. Samantray, the MLA from Satyabadi, apologised for the violation. In a video message, he said he committed a mistake by attending Maharathy's funeral

He said he had rushed to the funeral out of emotion because of his relation with Maharathy. Samntray had tweeted September

28, informing about his coronavirus infection. Dash, however, said that he had tested positive September 12 and completed a 17-day quarantine before attending the funeral.

He claimed that he did not attend the Monsoon session as "mild infection" was detected in the test conducted at the assembly.

Maharathy, 65, died at a private hospital in Bhubaneswar in the early hours of October 4. The seventime MLA from Pipili in Puri district had tested positive for COVID-19 September 14.

He was discharged from the hospital following recovery but was admitted again as his condition de-

teriorated, breathing his last after remaining on ventilator support. On Friday Odisha's Minister of State for Home DS Mishra wrote to Union Minister of State for Home Affairs Nityananda Rai, drawing his attention to the alleged violation of COVID-19 guidelines by Bhubaneswar MP and BJP national spokesperson Aparajita Sarangi.

Sarangi was accused of violating the guideline while celebrating her birthday Thursday. She, however, rejected the allegation and raised questions as to why Mishra was silent on the issue pertaining to the alleged violation by Samantray and Dash.

Fluoride content in groundwater takes a toll on Boudh villages

Harbhanga, Oct 10: Although high fluoride content in water was earlier confined to Nuapada district, this problem has been reported from various parts of Harbhnaga block in Boudh district. High fluoride content in ground-

water is taking its toll on the health of inhabitants. Many people in the block were affected by kidney disease and teeth ailments while the administration was accused of doing little in this regard

The number of kidney ailments is reportedly increasing in seven panchayats under this block. In the absence of preventive measures, the disease is allegedly acquiring crisis proportions in 24 villages.

Locals were upset over the rise in kidney diseases. In the last four vears, over 200 people allegedly died of kidney disease.

Locals united under Bikash Garjan Sena, a local outfit working for the cause of development, took up the issue with the administration Friday. A delegation submitted a memorandum to the Collector in this regard.

Their major demand is a mega drinking water in the block and arrangement of a special ward for kidney patients at the Purunakatak community health centre. They also demanded that given the increasing cases of kidney ailments due to consumption of fluoride content water, the government should appoint a specialist doctor to deal with such cases.

They also demanded financial assistance to the families who have lost their kin to kidney-related ail ments.

"Fluoride content in ground water continues to kill people and it will acquire the shape of an epidemic if the administration doesn't intervene in the matter, lamented Bikash Mahakud, the secretary of the outfit.

The kidney disease is spreading in 24 villages under seven panchayats. In four years, 205 people have died while 252 people are affected with kidney disease, the outfit said. Many complain of backbone problem while others have skeletal fluorosis, it was alleged.

It was leant that a team of experts had earlier visited various villages and collected samples of the groundwater to ascertain the cause of the kidney disease that is spreading in the areas

"But thereafter, no step has been taken to prevent the disease. Public discontent is brewing against the apathy of the administration," the outfit added.

It also warned that agitation will be staged against the administration if immediate step is not taken in this direction.

Youth held for slitting father's throat in Ganjam

Berhampur, Oct 10: Police Saturday arrested a youth for slitting his father's throat after the latter denied him money.

The incident took place at Byaghradevi Sahi under Buguda police limits in Ganjam district.

The accused has been identified as Dhoba Pradhan and the critically injured father as Surendra Pradhan.

According to a source, Surendra worked as a daily labourer in Andhra Pradesh. The Covid-19 induced lockdown had rendered him jobless and forced him to return to his village.

On being informed, police reached the village and arrested-Dhoba. A detail investigation is underway.

Mushrooming prawn gheries breed crime in Kendrapara

Kendrapara, Oct 10: Mushrooming of illegal prawn gheries has threatened the law and order situation and encroachment of government land and water bodies in seaside Mahakalapara and Rajkanika blocks in this district

So much so that this has led a to a rise in crime graph in the areas with various criminal outfits trying to call the shots for the lure of easy money. Establishment of illegal prawn gheries is not limited to these two blocks. The matter came to the fore at a press conference at Rajkanika block October 6. Pratima Rout of Koilipur village under the block alleged that her husband Pitambar Rout was kidnapped by the henchmen of some prawn traders September 30. She lodged a com-

plaint in Rajkanika police station.

Pitambar is not the lone person to be kidnapped by prawn traders but there are several others who have been kidnapped or killed in the recent past. Mushrooming of illegal prawn gheries has turned the district into breeding ground of criminals. In the recent past, mem-

bers of the Sapo gang kidnapped a youth of Kurunti village under Rajnagar block and tortured him to death. Use of firearms to settle scores has become common in the district.

Moreover, miscreants are not hesitating to encroach on water bodies like nullahs and creeks and forest lands. The district administration has received several complaints in the past but is yet to take serious action on them.

4 years, zero growth

f I do not acknowledge that I have a problem I cannot solve it. If the problem is minor this is less consequential and does not affect me beyond a point. It is only an irritant that I can continue to ignore.

If the problem is major, if the problem affects not just me but people around me, then ignoring it must have a sound reason. Ignoring it must in some way be more important than addressing it.

The sale of cars in India has not grown for the last five years. The number of cars bought by Indians in 2015-16 was 27 lakh units. The number of cars bought in 2019-20 was 27 lakh units. India's middle class is either not growing or not spending.

The government says stagnating car sales is not a problem because the young prefer to use Uber and Ola. The United States sold 2 crore cars last year. Uber and Ola do not seem to affect any other nation.

The sale of two wheelers in India has not grown for the last four years. 1.7 crore units were sold in 2016-17 and 1.7 crore units were sold in 2019-20.

This is the vehicle of the lower middle class, the size and consumption of which has not grown for four years. What theory the government has for this we do not know because it has not been acknowledged that there is no growth.

Commercial vehicles have not shown any growth for the last four years. Sales were 7 lakh units in 2016-17 and 7 lakh units in 2019-20. These are the vehicles like trucks that carry products either to manufacturers or to the market. The real meaning of four years of zero growth in this market can be imagined.

Real estate has shown no growth over the last four years. Indians bought ₹2 lakh crore worth of real estate in 2016. They bought ₹2 lakh crore worth of real estate in 2019. India's exports have not grown for six years. The country exports the same quantity that it did when Manmohan Singh was Prime Minister. India was exporting about \$300 billion a year when the UPA left It exported about \$300 billion in 2019-20. Why is this the case? We do not know because the government does not speak about it. When imports into India fell more than exports out of India, the government celebrated the moment as an achievement.

Employment has not only not grown in the last six years, it has actually gone down. A report produced by the government showed it to be at over 6 per cent in 2018, more than at any other time in history. Why are Indians losing employment? We do not know. The government has dismissed the issue and said

that pakora sellers and Uber drivers were replacing traditional employees. It is true that Covid has affected India's economy deeply and will continue to do so. We are unlikely to get back to the GDP figure we achieved in January this year for another three years. Meaning that by the time Modi's second term ends, we will still only be economically where we were in January this year. The problem is that where we were in January this year was not a good space. All the numbers that have been referred to above are before Covid.

The stagnation in our economy has happened before the lockdown and has nothing to do with our current crisis. If and when we are able to overcome the Covid related problem with our economy we will go back only to the earlier problem.

India's GDP growth declined every quarter for 10 quarters before Covid. Why? We do not know. It could be one reason, it could be many reasons. But if we do not acknowledge the issue we will never solve it. You can only think about, discuss and then implement corrective measures if you acknowledge that corrective measures are needed. If you carry on like nothing happened, then deep problems do not fix themselves and do not go away. US is already alarming, it is worth considering just how bad things could become. There is ample reason to worry that an election-related conflict could devolve into atrocity crimes against black and brown civilians on US soil. As someone who has spent his career studying genocide and mass violence, I fear that the chances of such violence are higher than most people think.

There are six reasons why Americans should prepare for the worst. First, the political, social, and economic situation in the US is deeply unstable. Such instability is a leading factor in all the robust models that researchers have developed over the past few decades to assess the risk of atrocities (including crimes against humanity, war crimes, ethnic cleansing, and genocide).

In the atrocity-risk model used by the United Nations, the US checks several boxes: in addition to a runaway pandemic, it is experiencing economic distress, high unemployment, mass protests, natural disasters, and ever-deepening political polarisation. The presence of just one or two of these factors would be alarming enough; the US features more than a half-dozen.

A second risk factor is the country's history of mass violence and human-rights abuses. Beyond the obvious examples of genocide committed against Native Americans and the enslavement of black peo-

ple, the US interned Japanese-Americans during World War II and, more recently, engaged in torture as part of its War on Terror. Some argue that the Trump administration's treatment of undocumented immigrants - including the separation of families - at the southern border constitutes crimes against humanity. and liken US immigrant detention centres to concentration camps.

A third risk factor is the political demonisation that has taken root, particularly on the right, with Trump relentlessly vilifying people of colour. He has referred to Mexicans as 'rapists,' Muslims as terrorists, and Latinos as criminal 'animals.' He smeared Haiti and all of Africa as 'shithole countries.' During the 2018 midterm election, Trump tried to mobilise his base by warning of an immigrant 'infestation.' Now, he regularly inveighs against black and brown 'rioters' and 'left-wing radicals' who are supposedly burning down cities and threatening to invade white suburbs and destroy the American 'way of life.'

In this context, it certainly is no coincidence that hate crimes have risen dramatically during Trump's presidency, including instances of violent anti-Semitism. When Trump labelled COVID-19 'the China virus' and 'kung flu,' reports of anti-Asian animus surged. Fourth, by undermining

America's constitutional system of checks and balances, Trump's presidency has eroded many of the buffers for preventing unrest. Trump openly flaunts the rules, including those meant to curb corruption, and has succeeded in politicising independent agencies from the US Department of Justice to the Centres for Disease Control and Prevention. Trump's attorney general, William Barr, routinely intervenes on Trump and his cronies' behalf, and supported the administration's efforts to deploy federal troops against US citizens. Meanwhile, Trump has pardoned or granted clemency to criminal allies and alleged war criminals.

Such impunity further heightens the risk of violence, by signalling to Trump's heavily armed followers that anything goes. Indeed, Trump has even voiced support for a 17-year-old gunman charged with murdering two protesters in Kenosha, Wisconsin.

A fifth category of risk comprises catalysts that can make a bad situation worse, including contested elections, marches by armed groups, and other mass protests. Trump has already repeatedly questioned the integrity of the election, suggested that he won't leave office, and proved eager to use force on civilians. Facing massive, largely peaceful protests, his first instinct was to invoke the Insurrection Act

and activate the military

This summer in Washington, DC, where federal law enforcement has jurisdiction, troops were issued bayonets and deployed to expel peaceful demonstrators from Lafayette Square. In response to nationwide Black Lives Matter marches, Trump's supporters have taken to warning of sedition, insurrection, martial law, and coup attempts, and armed extremists like the Boogaloo and the Proud Boys have taken to the streets. At the first presidential debate, Trump, prompted to repudiate such groups, instead instructed them to 'stand back and stand by."

The sixth factor includes anything that could trigger atrocity crimes in today's tinderbox political climate. There are many plausible scenarios. For example, Trump's refusal to accept electoral defeat could spark mass protests (and probably some rioting), creating an ostensible pretext for him to invoke the Insurrection Act and deploy troops against US civilians.

Unrest would undoubtedly spread. Some protesters would respond with violence, prompting US soldiers and federal troops to use even more force. Images of people of colour firing guns would dominate Fox News and Facebook, a leading online disseminator of far-right propaganda that has already been implicated in genocide elsewhere. That would be the trigger: Trump would call for those 'standing by' to rise up and crush the black and brown 'criminals' and 'radicals' he has been demonising. The race war that the mass murderer Charles Manson tried to instigate 51 years ago – he called it 'Helter Skelter' - will have been launched by America's president.

This is just one potential massatrocity scenario, but it is not hard to conjure others. Now more than ever, such risk assessments are necessary. By forcing us to consider the worst, they give us time to act. Genocide and mass atrocities have happened all too often, including in America. The question is not whether it could happen here, but whether it can be prevented.

Turgescent

On 1 July 2003, the Observer reported various comments that had been made by visitors to its website: "Meanwhile 'stochata' suspects that George Orwell is 'the reason we have the word "turgescent" in the English language.' No-one at the Observer was aware that we did have the word 'turgescent' in the English language, so we're grateful for that, at least." You may share the Observer's misapprehension, though you can be excused, as turgescent rarely appears except in technical specialities such as anatomy or botany, in the sense of becoming or seeming swollen or distended. In these fields you may find usages such as "the mucosal lining of the nasal septum is less turgescent than that of the nasal conchae" or "the stigma often remains turgescent and fresh for a period of 6 to 7 days." You may also occasionally encounter it in the turgid prose of some fantasy writers. "To one who dared peer within," wrote Clark Ashton Smith in his short story Demon of the Flower, published in 1933, "the cup was lined with sepulchral violet, blackening toward the bottom, pitted with myriad pores, and streaked with turgescent veins of sulphurous green." Turgescent is from Latin turgescere, beginning to swell, from turgere, to swell. This last word is also the origin of turgid, swollen or distended, and of turgor, the normal swollen condition of cells or tissues. Another Latin verb meaning to swell, tumere, has bequeathed us tumescent , with a similar meaning, though one that often appears in sexual contexts.

rwell's '1984' published in 1949 is a novel about dystopian times, his vision of a frightening future where humans are no longer human, being above or below the pale of humanity and defying what constitutes as 'humanity'

A book that has graced several high school syllabi, imperfectly understood by young readers, today has become a symbol of the times we are passing through. The propaganda, the internal surveillance. the authoritarian politics, the doublespeak, that seemed to pervade the fictional state of Oceania, seems to be in order today in totalitarian hierarchies masquerading as democracies. Democracies that stifle dissenting notes and obliterate individuality reduce their citizens to assenting robots to the powers that be.

Winston Smith, the doomed protagonist, a 39-year-old living in a miserable apartment building that smells of 'boiled cabbage', works in the Ministry of Truth that propagates falsehoods, where history is daily rewritten, records destroyed and reality fabricated according to the will of the State. Overseeing him is the image of the Big Brother from billboards, hoardings, banners, posters, wrappings, 'every commanding corner' and even private tele screens. There are no pri vate moments, every detail of one's life is under the scalpel. In despair, Winston tries to maintain a diary of his innermost thoughts all the time fearing the consequences and attempts to find out what life was like before Big Brother but no one seems to remember.

'1984' - A novel for our times

The State is in a constant state of warfare with neighbouring nations and the contradictions in the pithy slogans mouthed by the citizens -- "War is Peace, Ignorance is Strength, Freedom is Slavery," are the result of doublethink which is the power of holding contrary beliefs in one's mind simultaneously and accepting both. The lingua franca of the State is Newspeak, no longer the Oldspeak, the language spoken hitherto, where archaic use of language and form is dispensed with, new words are created with more precision, old meanings violated and new vocabularies built as sole means of communication in speech and writing. The literature of the past would be destroyed and Chaucer, Shakespeare, Milton will only exist in Newspeak but

differently. At the heart of the novel is a love story, a romance that dares to flower even in such dire conditions between Winston and Julia and they experience that purity of emotion in sylvan surroundings amidst the music of birdsongs in the woods. The idyll ended when the lovers were discovered by the Thought Police and bundled off for interrogation and inquisition. After tortuous encounters with his inquisitors Winston still holds on to his freedom for dissent and individuality and his enduring belief that it is impossible to found a civilisation on fear and hatred and cruelty. However after endless mental and physical torture he gives in. even betraying his lover Julia, as writhing on the floor, he feels "in the face of pain there are no heroes, no heroes." He confesses to everything he has done or not done and "He became a mouth that uttered. a hand that signed whatever was demanded of him.

He is told categorically "There will be no loyalty except loyalty towards the Party. There will be no love except the love of Big Brother. There will be no laughter except the laugh of triumph over a defeated enemy. There will be no art, no literature, no science." After the painful process of indoctrination is over Winston emerges reincarnated admitting to himself that he has indeed strayed, the struggle was over and he loves Big Brother.

Yet in the midst of despair and hopelessness the glimmer of humanity in Winston shines through his love for Julia, whom though he betrays he does not stop loving which in itself he feels is not an act of betraval. His fond memories of his mother and his efforts to recall happier times are evidence of this. There was a time "What mattered were individual relationships, and a completely helpless gesture, an embrace, a tear, a word spoken to a dying man could have value in itself." These feelings in Winston and his resistance to all that is evil in spite of the fact he succumbs to it is what still holds hope for the future of humanity.

Winston's world is not too far from our own world today where we are fighting our own demons of racism, casteism and violence, discrimination, corruption and lawlessness, conflict of ideologies and majoritarianism without conscience.

Shortened cooling off period for bureaucrats Sir, Generally, a waiting period or resting period of a couple of years is advocated for top civil ser-

vants and judges before they take up a new post if any after retiring from service. The subject 'conflict of interest' is raked up to corner them. Jurists favoured a five-year cooling off period for judges. But that's in a way too long; considering the enactments of Parliament from time to time providing for appointment of sitting or retired judges to various commissions and authorities, the Centre may not be able to find a suitable judge for these positions. So, at least a cooling off period of a couple of years was mooted by some stakeholders. When a top bureaucrat, who was part of key governmental decisions, joins a private sector company after superannuation eyebrows are raised. If that happens quickly after retirement, that too in a company that stands to benefit from his/her expertise in a related department of the government, suspicious glances are invariably exchanged. Only an outstanding officer, with an impeccable track record, may escape being a target of doubters. Not that an officer would mind much; he/she would continue in the post-retirement assignment ignoring all hushed tones. One quality the long bureaucratic service would have taught the officer was to go about a work with a nonchalant look. However, probity in public life is not an issue that can be discarded without much ado. It is pertinent to note that the present government reduced the cooling off period, from two years to one year, in 2015. Having said that, exceptions are made in individual cases, and many high profile retired bureaucrats have taken advantage of the government's affinity towards 'special cases'. Some officers, who have benefited from the rule of exception, may have richly deserved the concession in rule. But what about the others? Ganapathi Bhat, AKOLA



Amid surging virus cases, Kerala sees a silver lining

Thiruvananthapuram, Oct 10: Though Kerala is witnessing a spike in COVID-19 cases of late, there is a silver lining as the mortality rate was only 0.36 per cent, Health Minister KK Shailaja said as she praised the tireless efforts of Health workers and urged people not to overwhelm the healthcare system by their negligence.

Lauding the services of the health workers, Shailaja said it was due to their tireless service, the state could keep the state's death rate at 0.36 per cent despite a high number of cases. "In the end all that matters is

how we reduce the mortality rate. How many lives we could save That's our aim. Our mortality rate is still below 0.4 per cent. The mortality rate of 0.36 is the best among the world," Shailaja noted.

The southern state had reported the country's first coronavirus case January 30, a woman medical student who returned from Wuhan. the epicentre of deadly virus in China. The second and third cases were also Wuhan returnees from the state and all the three had been successfully treated.

May 8, after reporting a solitary case and with just 16 people under treatment, Kerala had announced that it had flattened the COVID-19 curve.

But as lockdown restrictions were lifted and people from abroad and other states started returning, positive cases started shooting up. Five months later October 7,



Kerala's fresh infections crossed the grim mark of 10,000, taking the total infection count to over 2.5 lakh. On Friday, 9250 cases were reported as the infection tally crossed 2.66 lakh.

Experts had predicted that Kerala was likely to witness a sharp increase in COVID-19 cases in August and September with daily infections expected to touch between 10.000 to 20,000. Asked about the spike in cases, Shailaja told PTI that many people had failed to heed to the health directions issued during the Onam festivities, resulting

Guwahati. Oct 10: The Gauhati High Court has asked the Assam government to set up six detention centres outside the jails for housing "declared foreigners", an official said Saturday.

The Assam government had set up six detention centres within the existing jail premises in Goalpara, Kokrajhar, Jorhat, Silchar, Dibrugarh and Tezpur and lodged the "declared foreign nationals' pending their deportation or repatriation and whose movements are required to be restricted.

An official of the Border Wing unit of the Assam Police said Saturday that Gauhati High Court judge Justice Achintya Malla Bujor Barua, after hearing multiple petitions, asked the state government earlier this week to set up the six detention centres outside the existing jails.

The court ordered the government to submit an action taken report October 16 regarding suitable

Justice Barua in his 11-page order said that it is discernible that more than 10 years have gone by since a part of the jail premises in Goalpara, Kokrajhar and Silchar had been declared to be detention centres.

"Certainly, a period of more than 10 years cannot be understood to be a temporary arrangement. Even in respect of Jorhat, Dibrugarh and Tezpur, a period of five years is almost over which again cannot be strictly said to be a temporary arrangement." the order said.

The high court order said that the Supreme Court had clearly provided that the detainees be kept at an appropriate place with restricted movement pending their deportation and repatriation and the places where they are to be kept may be detention centres or by whatever name such places are called, but they must have the basic facilities of electricity, water and hygiene besides appropriate security.

China's BRI promised prosperity, gave debt trap

SEVEN YEARS DOWN THE LINE, THE BRI, TOUCHING 70-ODD COUNTRIES, HAS ALSO HAD LIMITED IMPACT ON EMPLOYMENT GENERATION

New Delhi, Oct 10: Several countries like Sri Lanka, Zambia, Djibouti, Laos, Maldives, Republic of Congo, Tonga, Pakistan and Kyrgyzstan, among others, where China has invested through its much-hyped Belt and Road Initiative (BRI) have run into serious financial threat and debt trap, contrary to the expectation that the infrastructure exercise would help in their economic growth.

The BRI project, involving the development of infrastructure for ports, roads, railways, airports and power plants which has run into hundreds of billions of dollars, was kicked off in 2013 just after Chinese President Xi Jinping took control.



Seven years down the line, the mega infrastructure project, touching 70-odd countries, has also had limited impact on employment generation.

After Sri Lanka leased its prestigious Hambantota Port Holdings Co to China for 99 years, concerns over an imminent debt trap have emerged among many countries.

The list is long. Maldives owes about \$1.4 billion to China. It is a huge sum for a country which has a GDP of \$5.7 billion. The China Several countries where China has invested through its much-hyped BRI have run into serious financial threat and debt trap

Africa Research Initiative at the Johns Hopkins University in a study said that Zambia's total loans from China amounted to almost \$6.4 billion at end-2017.

"If this figure is correct, Zambia may have a total debt of \$14.7 billion (including state guaranteed loans). of which Chinese loans account for some 44 per cent," the CHR Michelsen

Institute said in a report. Pakistan's growth in 2018 was about 5.83 per cent. It was down to less than 1 per cent in 2019 - a decline of over 4.8 per cent from 2018. 

New Delhi, Oct 10: Amid reports of Television Rating Points (TRP) manipulations by some channels, the Parliamentary Standing Committee on Information Technology has decided to take up the matters of media ethics, news coverage and the TRP scam issue for discussion next week.

This comes after Congress MP and member of the panel Karti Chidambaram requested Shashi Tharoor to take up the issue and call the officials of the Information and Broadcasting Ministry before the committee to seek clarification and remedial measures. Karti Chidambaram had said, "The government's advertising expenditure depends on the TRP system, and public spending should not be based on flawed data."

The Parliamentary committee on IT has asked Broadcasters Association, Press Council of India and Prasar Bharati to depose on 'Ethical Standards in Media Coverage'

"Flawed or manipulated TRP cannot be the basis of ad spends. TV companies also base their valuations on TRP. Those valuations are questionable now," Karti further said.

It has been notified that the next two sittings of the Committee will be held October 15 and 16. On Thursday, the Parliamentary panel will be taking up the topic of "ethical standards in media coverage".

In an interview to PTI, Abdullah, the chairman of the powerful High Council for National Reconciliation, also dispelled National India's apprehensions that a prominent role for the Taliban as part of a possible outcome to the ongoing intra-Afghan peace talks could be detrimental to its strategic interests.

"It is not in our interests if any terrorist group has any foothold in Afghanistan. The agreement should be one which is acceptable to people of Afghanistan. It should be dignified, sustainable and durable," Abdullah said.

The influential Afghan leader also said if a peace deal is struck with Taliban, then all other terror groups "freelancing in mountains and deserts of Afghanistan and launching attacks on us or any other nation" will have to cease their activities.

"Peaceful settlement will not be and should not be detrimental to any country's national security including India. India is a country which has helped Afghanistan, contributed to Afghanistan. It is a friend of Afghanistan," he said.



Health experts signal rise in mental problems amid Covid-19

New Delhi, Oct 10: Public health experts have flagged a manifold increase in mental health cases amid the coronavirus pandemic, with many attributing the rising stress and anxiety levels to isolation, loss of loved ones, economic uncertainty and the fear of contracting the disease

According to a survey by the World Health Organisation (WHO), the pandemic disrupted critical mental health services in 93 per cent of the countries worldwide. World Mental Health Day is observed October 10 every year with the objective of raising awareness about mental health, global mental health education, awareness and advocacy against social stigma.

During the pandemic people have been experiencing anxiety, fear, frustration, sadness and loneliness to the point that these feelings have become constant and overwhelming or promoting the urge to attempt suicide. Existing mental health conditions, including severe anxiety and major depression, have also worsened.

Dr Jyoti Kapoor, Senior Psychiatrist at Gurugram's Paras hospital, said, "In the last three months, the cases of mental health illness have increased nearly twofold, with 25 per cent new cases of obsession and 50 per cent more cases of anxiety in the psychiatry OPD. Psychosomatic manifestations are also on the rise.

"The prolonged self-isolation and social-distancing measures have



caused deterioration in the condition of old or pre-existing patients. Even depressive symptoms have recurred in patients who were otherwise stable," Kapoor added.

People are now taking the help of experts to tackle the situation as awareness about mental health has increased due to celebrities' endorsement of mental health concerns coupled with unfortunate events such as the death of Hindi film actor Sushant Singh Rajput.

"There is an increase of 80 per cent in patients. Most of the patients are between 19 and 40 years,

and the predominant concerns they have include job loss, anxiety due to Covid-19 cases nearby, separation from near and dear ones and the inability to meet them or friends due to lockdown," said Dr Shweta Sharma, consultant clinical psychologist, Columbia Asia hospital. Nearly half of these patients do

not have any history of mental illness. Despite the lifting of lockdowns, the number of cases has remained largely the same, Sharma added

Dr Manu Tiwari, consultant psychiatrist at Noida's Fortis hospital, said, "With anxiety and insomnia in the beginning, now we are also seeing mood disturbances. The cases of substance abuse withdrawal and domestic violence have

also increased substantially. One

can identify and manage the triggers better as well as develop emotionalcoping mechanisms.

A Delhi-based doctor said selfharm is one of the extreme manifestations of mental illness and emphasised the need to destigmatise mental health issues. "Right now approaching a mental health doctor or consultant is considered to be a major stigma.

According to a report by WHO it is estimated that nearly 36 per cent of Indians are depressed or suffering from some kind of mental disorder, said Kartik Naidu, Transpersonal Therapist and Trainer at Green Aura Holistic.

"The problem with our society is that there is a stigma attachedto mental health problems,' Naidu added

Moscow, Oct 10: With Russia's mediation, Armenia and Azerbaijan agreed to a ceasefire in Nagorno-Karabakh starting Saturday following two weeks of heavy fighting that marked the worst outbreak of hostilities in the separatist region in more than a quarter-century.

The countries' foreign ministers said in a statement that the truce is intended to exchange prisoners and recover the dead, adding that specific details will be agreed on later. Minutes after it entered force at noon (0800 GMT), Armenia and Azerbaijan accused each other of breaching the ceasefire with new attacks. The claims couldn't be independently verified. The announcement of the truce followed 10 hours of talks in Moscow sponsored by Russian Foreign Minister Sergey Lavrov, who read the statement. It stipulated that the ceasefire should pave the way for talks on settling the conflict.

If the truce holds, it would mark a major diplomatic coup for Russia, which has a security pact with Armenia but also cultivated warm ties with Azerbaijan. The latest outburst of fighting between haven't produced any deal, leaving Azerbaijani and Armenian forces Azerbaijan increasingly exasper-

Islamabad, Oct 10: A Pakistani court through newspaper advertisements has asked Nawaz Sharif to appear before it by November 24 to avoid being declared a "proclaimed offender" after the former three-time Prime Minister reportedly refused to receive nonbailable arrest warrants at his residence in London.

The Islamabad High Court (IHC) Friday noted that it was left with no option but to order issuance of proclamation for intimating 70-year-old Sharif, who has been living in London since November last year, to appear before it on November 24.

A two-member bench comprising Justice Mohsin Akhtar Kayani and Justice Aamer Farooq observed that the examination of statements of witnesses as well as the documents showed that all out efforts were made for serving the non-bailable warrants of arrest on Sharif to ensure his attendance before the court in the Al-Azizia and Avenfield graft cases.

October 7, the court recorded the statements of Dildar Ali Abro, the first secretary (consular affairs), and Rao Abdul Hannan, consular attache. Pakistan High Commission, London, as well as Mohammad Mubashir Khan, director for Europe-I, at the Foreign Ministry. They told the court that efforts were made in compliance with the court orders to serve the non-bailable warrants of arrest on Sharif to ensure his attendance in the court. Despite efforts, that service of warrant, issued by the Islamabad High Court September 15, could not be served.

Irked by the attitude of Sharif's representatives at his residence in London, the high court October 7 had ordered that advertisements be issued in newspapers to summon him.

The court directed the federal government to bear the cost of the advertisements in the Dawn and Jang newspapers.

The government later told the court that Rs 60,000 were paid for advertisement in the nominated papers. The court has asked Sharif

Sharif has been living in London since November last year after he was allowed by the courts and the government to go there for a period of eight weeks for medical treatment

to appear before it by November 24 otherwise he would be designated as a "proclaimed offender". The proclamation may result in the confiscation of his properties as well as passport.

The PML-N supremo was declared a proclaimed offender earlier in September and had refused multiple times to receive the arrest warrant issued in his name. Sharif has been living in London since November last year after he was allowed by the courts and the government to go there for a period of eight weeks for medical treat ment. But he did not come back, while his lawyers told the court that he was still recovering. However, he made a scathing speech on September 20, blaming the Pakistan Army for its interference in politics. After the speech, pressure is mounting on Sharif to return to Pakistan to face corruption cases against him.

The court last month issued arrest warrants for Sharif, previously sentenced to seven years in prison on corruption and money laundering charges stemming from disclosures in the Panama Papers. Sharif was bailed out in both cases and also allowed to go to London for medical treatment in November last year

Grace Forrest, co-founder of the Walk Free anti-slavery organisation, said Friday that means one in every 130 women and girls is living in modern slavery today, more than the population of Australia.

"The reality is that there are more people living in slavery today than any other time in human his tory," she told a UN news conference.

Walk Free defines modern slavery "as the systematic removal of a person's freedom, where one person is exploited by another for personal

or financial gain," she said. Forrest said the global estimate of one in 130 women and girls living in modern slavery was made based on work by Walk Free, the

International Labour Organisation and the International Organisation for Migration, both UN agencies. "What this report has shown is that gender stacks the odds against girls from conception throughout their lives," she said. According to

the report, titled "Stacked Odds. women account for 99 per cent of all victims of forced sexual exploitation,

84 per cent of all victims of forced marriage, and 58 per cent of all vic-

tims of forced labour. Forrest said the face of modern

slavery "has radically changed." "We're seeing normalised exploitation in our economy in transnational supply chains and also in migration pathways," she said. 'The world's most vulnerable people have been pushed even further into this practice of modern slavery because of COVID-19."

She said the estimate of women and girls in modern slavery is conservative because it doesn't account for what's happened during the pandemic, which has seen "sharp increases of forced and child marriage and exploited work conditions around the world." Forrest said Walk Free and the UN's Every Woman Every Child program are launching a global campaign to demand action to eliminate modern slavery. The campaign urges an end to child and forced marriage, which 136 countries have vet to criminalise. It urges the elimination of legalised systems of exploitation such as kefala, which legally binds a migrant worker's immigration status to an employer or sponsor for their contract period.

The campaign also urges transparency and accountability for multinationals. "We know that women and girls are experiencing unprecedented levels of exploitation and forced labour in supply chains of the goodswe buy and use every day — clothing, coffee, technology," Forrest said.

London, Oct 10: Being a man, having a lower income, a lower level of education, not being married, and being born in lowor middle-income countries -these are factors that relate to an elevated risk of dving from Covid-19, warn researchers.

"We can show that there are independent effects of various separate risk factors that have been brought up in debates and news about Covid-19." said study author Sven Drefahl from Stockholm University in Sweden.

"All of these factors are accordingly individually associated with a strongly elevated risk of dying from Covid-19," Drefahl added. The study is based on data from the Swedish National Board of Health and Welfare on all registered deaths from Covid-19 in Sweden for adults aged 20 and older In a study, published in the

iournal Nature Communications, Drefahl explained that those born abroad generally have lower mortality than people born in Sweden This also applies when the research took income and level of education into account.

The elevated risk of dying from Covid-19 for this group remains after the researchers controlled for circumstances, such as income and level of education. The study shows that being a man, having a lower income and lower level of education also result in a strongly elevated risk of dying from Covid-19. As to these aspects, this also agrees with the patterns for mortality from other diseases.

New Delhi, Oct 10: The government Saturday said it will initiate steps to facilitate renewal of International Driving Permit (IDP) for citizens whose IDP has expired while they are abroad. A draft notification has been issued by the Ministry of Road Transport and Highways (MoRTH) in this regard.

"The Ministry of Road Transport and Highways has issued a draft notification...seeking comments and suggestions for amendment to Central Motor Vehicles Rules, 1989 for facilitating the issuance of International Driving Permit (IDP) for citizens whose IDP has expired while they are abroad," MoRTH said in a statement.

It said that it has come to its notice that in certain cases for the citizens who are travelling abroad and in a foreign country, the IDP gets expired and there is no mechanism for its renewal while abroad.

"The proposal is to amend the CMVR 1989 to facilitate such citizens. The citizens can apply through the Indian Embassy / Mission Abroad portals and the applications would then move to the VAHAN for being considered by the respective RTOs (regional transport offices)," the statement said.

Fuel demand up 7% in Sept; first monthly gain since June

New Delhi, Oct 10: India's fuel demand in September rose for the first time since June as easing coronavirus restrictions supported economic activity and travel, but consumption remained weaker than a year earlier, government data showed Friday. Consumption of refined fuels, a proxy for oil demand. rose 7.2% in September from the prior month to 15.47 million tonnes, the first monthly increase since June when demand rose to 16.09 million tonnes.

However, demand fell 4.4% from the same period a year earlier, posting its seventh consecutive yearon-year slide, data from the Petroleum Planning and Analysis Cell (PPAC) of the Ministry of Petroleum & Natural Gas showed.

The country's daily number of coronavirus infections has slowed since hitting a single-day high of 97,894 new cases September 17, a sign that infections were peaking for now. The country's factory activity also expanded at its fastest pace in more than eight years in September, even as layoffs

2.38 million tonnes in August. Cooking gas or liquefied petroleum gas (LPG) sales increased by 4.8% to 2.27 million tonnes from a vear earlier, while naphtha sales rose 2.9 per cent to 1.14 million tonnes and by 5.7% from August. Sales of bitumen, used for mak-

ing roads, rose 38.3% from last year, and fuel oil decreased by 7.4% and by about 4.1% month-on-month.

Credit offtake from banks remained poor in H1: RBI

Mumbai, Oct 10: Although the banks remain flush with liquidity and interest rates lowered significantly, credit offtake from banks was very low and "anaemic" during the first half of the current financial year (2020-21). The low credit offtake can be attributed to the weak demand and persistent uncertainty amid the pandemic.

"During H1 2020-21, bank credit offtake was anaemic, reflecting weak demand and uncertainty in the wake of the pandemic," showed the Monetary Policy Report for the October 2020 released by the Reserve Bank of India (RBI).

It showed that non-food credit growth (y-o-y) was 5.1% as of September 25, 2020, lower than 8.6% a year ago, driven by weak momentum and base effects. It noted that the slowdown in credit growth was spread across all bank groups, especially foreign banks.

Credit growth of the public sector banks remained modest, although with some uptick since March 2020.



"Of the incremental credit extended by the scheduled commercial banks (SCBs) on a y-o-y basis (September 27, 2019 to September 25, 2020), 62.3% was provided by the public sector banks and 41.2% by the private sector banks, while the share of the foreign banks

turned negative," said the report. The deceleration in non-food credit growth was broad-based. with credit offtake slowing down in all the major sectors.

Though personal loans and credit to agriculture registered some improvement in July 2020, the momentum could not be sustained in August. Credit growth to services and industrial sectors has also tapered off after showing some promise in the Q1 of FY21.





Sao Paulo, Oct 10: Brazil and Colombia had no trouble beating two of the weakest South American teams to score their first wins in the opening round of World Cup qualifiers.

Brazil easily beat Bolivia 5-0 in a rainy day here while Colombia scored all of their goals in a 3-0 victory in the first half in Barranquilla.

After the first round, Brazil, Colombia, Uruguay and Argentina lead with three points. Peru and Paraguay have one. Ecuador, Chile, Venezuela and Bolivia have none.

All five matches in the second round will be played Tuesday: Peru vs Brazil, Bolivia vs Argentina, Chile vs Colombia, Ecuador vs Uruguay and Venezuela vs Paraguay.

In the 16th minute, Duvan Zapata calmly scored from close range after a low cross by Juan Cuadrado. Ten minutes later Johan Mojica bulldozed through the Venezuelan defense from the left and assisted Luis Muriel to add a second.

Muriel scored the third in the first-half stoppage time. He dribbled past Jhon Chancellor and beat goalkeeper Wuilker Farinez with a hard left-foot shot.
