Rain havoc in southern districts

Berhampur/Patrapur/Sheragad, Oct 13: Several villages in Ganjam and Gajapati districts were marooned Tuesday following heavy rain induced by a deep depression over Bay of Bengal since Monday.

Normal life was disrupted forcing residents to remain confined indoors. A landslide from the hill between Tadkasahi and Riabada under Patrapur block cut off communication. Similarly, a landslide occurred in Tamoisingh village under Gumma block of Gajapati. Gajapati Collector had people in affected areas evacuated. Over 500 people from Kashinagar, Raigad, R Udayagiri and Gumma were shifted



to safer places starting from Monday night till Tuesday. The evacuees have been provided with cooked food. Reports of house collapse have also been reported. In Ganjam, 1,385 mm rain was recorded over last 24 hours. Khallikote registered maximum 128 mm rain. Rushikulya, Baghua, Nandini and Ghodahada rivers were swollen. Hilltop villages like Ankuli, Buratal in Patrapur

block witnessed heavy rainfall.

Villages like Elagal, Baniabasa, Beheraputu, Maduagumma, Uparburatal, Badua. Kurgarh. Dhobalingi and Andaanda under Patrapur block have been marooned. A diversion over Jarau river on

A diversion over Jarau river on Badagada-Gangapur road was washed away due to a sudden rise in the water level following incessant rain.

Similarly, residents of more than 50 villages in Sheragada area were affected as two diversions on Sheragada-Badagada road were washed away. Vehicular movement on the route was completely disrupted.

A flood like situation emerged in Digapahandi block. Baghalati reservoir discharged rainwater through two gates to Bahuda river. Digapahandi tehsildar Adwait Kumar Swain and Chikiti tehsildar Haraprasad Bhoi are keeping a close watch on the situation.

All communications between Aska and Berhampur were disrupted after above 2-ft water overflowed on NH-59 at Ramachandrapur-Pital road. A bridge on Jarau river connecting Gokulpur village has collapsed near Sorada-Badagad road. All communications between Shergad and Badgad were disrupted after an approach road near Manikpur was washed away. The Mahendratanaya and Vamshadhara rivers in Gajapati district and several others smaller rivers were in spate. Naveen opens 'Sujal' tap for town dwellers

Bhubaneswar, Oct 13: Chief Minister Naveen Patnaik Tuesday virtually launched the 'Sujal- Drink from Tap Mission' here, making Odisha "the first state in the country to provide quality drinking water, fit for direct consumption, in urban

areas," a minister said. The initiative aims to benefit more than 15 lakh people in the cities, Housing and Urban Development Minister Pratap Jena said. The project, in its first phase, will supply drinking water to Bhubaneswar and Puri.

"Odisha is the first state in India, where people in urban areas will be able to drink water directly from taps, under the government's new initiative," Jena stated.

Her pickle jar grew from ₹100 to ₹40L

Jeypore, Oct 13: She started a small startup of pickles with all of ₹100, about 20 years ago. However, after years of struggle and competition, Manjula Patra has established herself as a woman entrepreneur in Koraput,. At present, her annual turnover is in excess of ₹40 lakh.

Patra, a resident of Kumbhasahi in Jeypore town, is no less than a business icon in the area. She is an epitome of women empowerment and self-reliance. Her small enterprise Manjula Achar Company is striking roots deeper every year with its volume of business growing. After overcoming many hurdles,

she now owns a successful enterprise. Her company is preparing 42 varieties of pickles from mangoes, lemons, jackfruit, chili, cauliflowers, and tomatoes. Demand for her pickles is growing in various parts of the district and even outside the district. Through her company, she is providing livelihood support to members of 12 families.

Walking down the memory lane, Manjula says, "I was going through a very difficult time when I hit upon the idea of making pickles. I started it with ₹100 some 20 years ago."

"I maintain high quality as they are prepared from fresh vegetables and fruits. They are tasty too while prices are affordable for consumers. That's why demand for my pickles is on the rise," She added. She purchases fresh raw materials from local markets to ensure quality. Customers reach out to her and take their choicest products, he added.

As business is growing, some members of her family have lent their hands in the business. "If government help comes, job scope for more families can be created," said K Tirupati, the husband of Manjula.



Cuttack, Oct 13: A 15-year-old girl was abducted and 'sexually abused' by two youths at a poultry farm here for around 22 days, a senior official of Chauliaganj police said Tuesday.

According to police, the minor, a resident of Rankei under Tirtol police limits in Jagatsinghpur, had come to her sister's place at Professorpada here around a month ago following a dispute with her parents.


"Her sister, however, asked her to return home following a marital discord. The girl was waiting for a bus near OMP Square when Santosh Kumar Behera met her. Behera lured her into coming with him on the pretext of helping her reach home. However, Behera took her to his friend's poultry farm at Gatiroutpatna where the duo sexually abused her for nearly 22 days," said the official.

would further intensify action against drug trafficking and accelerate drive against brown sugar and ganja based on satellite mapping data shared by the Indian Space **Research** Organisation (ISRO). Director General of Police

(DGP) Abhay said this while addressing a press conference on the seizure of huge amount of contraband.

"The state police have seized a total of 1,054 quintal ganja between January and September this year,' the DGP said.

This is the highest seizure by the police in any year, Abhay said, adding that the maximum quantity of the contraband item weighing up to 413.14 quintal has been seized from Koraput district followed by Malkangiri (240.66 quintal) and Gajapati district (126.58 quintal). While the average seizure

quintal of ganja has been seized in the last five years, he said.

This apart, the DGP said, "Odisha Police has intensified financial investigation against organised gangs behind such trafficking."

The DGP said that action of the last 10 years is 312 against drug trafficking re-

Almost all the servitors had opposed the idea of reopening the temple for devotees before the completion of Hindu month of Kartik. They had argued that Covid-19 infections will rise. if the shrine is reopened for devotees in recent future.

"The SJTA chief administrator has collected the views of many Srimandir niyogs on the temple reopening in last couple of days. He will continue to consult some other servitors' groups for three more days," said a source in the temple administration.

Bhubaneswar: Oct 13: The National Green Tribunal (NGT) has now asked the Joint Committee, constituted after its earlier order, to re-examine the violations of environment laws and prepare a comprehensive report.

The order of the tribunal came into limelight after a petition was filed seeking intervention of the tribunal against lakhs of trees felled in Angul district for industrialization and expansion of National Highways

The petitioner in the case had alleged that some industrial plants have not built a green belt of 500 metres around their industries and went against the established rules and norms of the state government. It also alleged that the highway expansion works undertaken by the National Highway Authority of India (NHAI) also failed to plant trees.

The petitioner cited government records and claimed that for the establishment of some public sector and private sector companies and expansion of NH, more than 3.6 lakh trees were felled in Angul district and the compensatory afforestration against the damage



was not done as per rules

The NGT earlier had formed a Joint Committee comprising several key officials from different sectors to examine the region. After going through their report, the NGT claimed that the panel confined their scrutiny to only one government plant and failed to look into the wider picture.

It has now asked the panel to reexamine the issue. The written order of the NGT said that on perusal of the report, it found that the Committee appeared to have confined its report only in respect of one government plant situated in Angul District.

"The report, therefore, is incomplete and, therefore, we direct the Committee to submit a com-

prehensive report covering the en tire district of Angul. Let the committee file its report within two months from hence. While doing so, the committee shall look into the application filed by the applicant which sets out the width of the inspection to be carried out by the committee," the order of the tribunal said.

The petition had claimed that the industries and NHAI flouted the Green Highways (Plantation and Maintenance) Policy 2015 and Guidelines on Landscaping and Tree Plantations-2009 in the district during their course of work. It has now been demanded that as per the norms, more than 36 lakh trees should be planted in the district.

4 years later, how far have we progressed in potato mission?

POST NEWS NETWORK

Jajpur, Oct 13: Even as the state government launched a potato mission in 2015 with an aim to increase tuber production in the state and make good of tuber shortage but lack of effective implementation has derailed the efforts, a report said.

The reason is attributed to deficit production and lack of adequate cold storages in the state to store the surplus cultivation for use and sale next year.

A survey by the National Sample Survey Organisation (NSSO) claims that there is a requirement of 10.21 lakh metric ton of potatoes per annum in the state while only 20 per cent of the actual requirement is produced here every year. Farmers here produce around 2.5 lakh mt of potatoes on 15,000 hectares of land.

Around 22.76 mt of potatoes in the country and 16.48 mt in the state are produced annually if we take a look at the production per hectare of land. This is the reason for which Odisha has to depend on other states to meet 80 per cent of its potato requirement.

As a result people now have to spend more from their pockets to buy a kilogram of potato at ₹35 which was earlier selling at ₹15 per kg. The pace at which potato mission is being implemented to make the state self-reliant in tuber production and construction of cold storages is quite disappointing. Reports claimed that only 22 out of the proposed 112 cold storages have been built in last five years. The payment of subsidy money to the owners is also disappointing, the report added.

The mission also proposed to construct 112 cold storages of 5, 60,000 mt capacities between 2015 and 2020 and made a plan outlay of ₹133.15 crore. However, only ₹59.35 crore fund were allocated for the purpose.

The shortage in tuber production in the state could be gauged from the fact that 72,040 mt of potatoes were supplied from other states, 16,260 mt of potatoes were produced locally; 13,750 mt of fruits and other vegetables of 10,9830 mt have been stored in the cold storages in 2018-19 which is just 47 per cent of the capacity of the cold storages.

However, ironically only 22 cold storages of 1,00,600 mt capacity have been built. Among them four cold storages are in Sambalpur, three in Khurda, three in Sundargarh, two in Balasore and one each in Jajpur, Jharsuguda, Angul, Bhadrak, Ganjam, Puri, Bolangir, Koraput, Cuttack and Nabarangpur

districts.

The state government has sanctioned Rs2,668.80 lakh and Rs1,413.60 lakh as subsidv to the owner of the cold storages in two installments during the last five years. The delay in construction is attributed to excessive maintenance cost, spending more during the initial phase of construction, non-coopera-

tion by banks and fall in production of vegetables which can be stored over a longer period, the report added

Reports said that a cold storage has been constructed while another is under construction at Panikoili in Jajpur district. The district produces vegetables on 18,000 hectares of land while plans have been made to produce 150 quintal of tubers this year.

ord is out that a certified Covid vaccine could be expected for distribution in three months' time. Hints are also that the pandemic situation could overall be brought under control by the middle of 2021. This optimism is despite some set-backs in efforts at evolution of a vaccine by principal pharma firms and scientists working at labs across the world Union Health Minister Harsh Vardhan has stated that a vaccine could be reaching the people by early next year, and his ministry has begun working out the distribution plans. World Health Organisation chief scientist Soumya Swaminathan too has stated as much; that registration process for a new vaccine could be expected by end of this year. By mid-2021, expectations are that one-fifth of the Indian population could have access to a vaccine. This should take care of the vulnerable segments. The infection figures are steadily going up and this is only to be expected in view of the relaxations effected on public activities. The three generations of the Kim family's rule have left North Korea a dark spot on Earth if only for the denial of basic freedom to the people, lack of economic progress, and forced labour. What happens within the country is normally kept a secret. Kim succeeded his father in 2011, meaning he's at the head of the nation for a full decade. The national economy is in shambles, requests to UN for free food shipment a periodic obsession, and the iron curtain refuses to be drawn up or removed. If tears can be a compensation for all these, and keeping the people shut from the outside world for generations a credit, this will still be a small comfort. A problem however is, a weak heart is not the right endowment for a dictator. Those around could be smarter and turn the 'leader' around, now that he is demonstrating his

weak spot in full public view. Dictators must be made of sterner stuff. The history of the world has always shown that those who are dictato rial and cruel towards people eventually fall and are forgotten. It is a mat-

In the decades after WWII, the world made unprecedented strides toward eradicating poverty, reducing childhood mortality, increasing life expectancy, and expanding literacy. Today, international cooperation and trade, which drove the post-war improvement in these and many other measures of human progress must be maintained and defended against renewed skepticism of their merits

At the same time, the world also must remain focused on the defining issue of the pre-pandemic era: the 'Fourth Industrial Revolution' and the digitisation of countless economic activities. Recent technological advances have given us the tools that we need to confront the current crisis – including through the rapid development of vaccines, new treatments, and personal protective equipment. We will need to continue to invest in research and development, education, and innovation, while at the same time building protections against those who would misuse technology.

But other shibboleths of our global economic system will need to be re-evaluated with an open mind. Chief among these is the neoliberal ideology. Free-market fundamentalism has eroded worker rights and economic security, triggered a deregulatory race to the bottom and ruinous tax competition. and enabled the emergence of



The reset that we need is not a revolution or a shift to some new ideology. Rather, it should be seen as a pragmatic step toward a more resilient, cohesive, and sustainable world. Some of the pillars of global system will need to be replaced, and others repaired or strengthened. To achieve shared progress, prosperity, and health requires nothing more - or less

massive new global monopolies. Trade, taxation, and competition rules that reflect decades of neoliberal influence will now have to be revised. Otherwise, the ideological pendulum - already in motion - could swing back toward full-scale protectionism and other lose-lose economic strategies.

Specifically, we will need to reconsider our collective commitment to 'capitalism' as we have known it. Obviously, we should not do away with the basic engines of growth. We owe most of the social progress of the past to entrepreneurship and to the capacity to create wealth by taking risks and pursuing innovative new business models. We need markets to allocate resources and the production of goods and services efficiently, particularly when it comes to confronting problems like climate change.

But we must rethink what we mean by 'capital' in its many iterations, whether financial, en-

vironmental, social, or human. Today's consumers do not want more and better goods and services for a reasonable price. Rather, they increasingly expect companies to contribute to social welfare and the common good. There is both a fundamental need and an increasingly widespread demand for a new kind of 'capitalism.

To reconsider capitalism, we must reconsider the role of corporations. An early exponent of neoliberalism, the Nobel laureate economist Milton Friedman believed (quoting former US President Calvin Coolidge) that "the business of business is business." But when Friedman pioneered the doctrine of shareholder primacy, he did not consider that a publicly traded company might be not just a commercial entity but also a social organism.

waddle, meaning trivial or foolish speech or writing, has been in the language since the latter part of the 18th Century. It is found first of all in the correspondence of Mrs Mary Delany, a famous letter writer, better known for her flower compositions under the title of Hortus Siccus. In 1782, she wrote about an author of the period: "Fanny Burney has taken possession of the ear of those who found their amusement in reading her twaddle (that piece of old fashioned slang I should not have dared to write or utter, within hearing of my dear mother)." Aha. But it turns out that Mrs Delany just meant that the word was impolite, not obscene. It's a variant of an older word twattle, which has mainly been dialectal and hasn't been recorded much in print. That meant to talk foolishly or idly or to chatter inanely. A twattlebasket was a chatterbox. It seems to have been itself a variation on tattle, as in tittle-tattle, another of those many reduplicated terms that English is so fond of, which has also been written as twittle-twattle. The Oxford English Dictionary notes that these, and other forms, are probably echoic in origin and are primarily colloquial, not often having been written down.

wee means excessively or affectedly quaint, sentimental or mawkish, sometimes coupled with words like nauseatingly. It's a strongly negative word, and a very useful one, that is in common British use. It appeared at the beginning of the twentieth century to mean something dainty or sweet, a girly and gushing word. It appears to have developed from tweet, not the noise a bird makes, but a childish attempt at saying sweet. It might have been helped along by a feeling that it could be a blend of tiny and wee (Scots for small), though it isn't.

The Delhi Police, which comes under the BJP-led central government, is completely silent when this murder took place, Bhardwaj said.

"Now under the pressure from the BJP, the Delhi police is harassing the eyewitnesses of this case. The BJP and the Delhi Police are standing with criminals and supporting them," he said.

Panaji, Oct 13: Under pressure to deal with crimes related to tourists, floating migrant population, as well as dealing with the infrastructure stress caused by constant VVIP arrivals to Goa, the Goa government has split the two existing police districts in the state to four, carving out two new police districts for administrative convenience and maintaining law and order more efficiently

"The government of Goa has decided to create two new police districts namely Mapusa and Ponda. Hence, there will now be a total of four police districts with four district Superintendents. This decision will enable better and effective control over law and order, and prevention of crime," Chief Minister Pramod Sawant said.

"The large number of tourist arrivals has resulted in tourist-related crimes and other issues. With Goa hosting many international events and the participants and the visitors coming from the higher echelons of the society, it has put a tremendous strain on the police



machinery. Likewise, frequent visits of VVIPs require elaborate police arrangements involving large scale police deployments during their visits," a statement issued by the Chief Minister's Office said.

"Therefore, in order to handle these situations and keep crime and law and order under control, it is necessary to increase the number of police districts in Goa, so that there is effective control over

the crime and security situation and better supervision over the police force during exigencies," the statement also said. At present Goa has two police

districts: North Goa and South Goa. The two additional police districts which have been carved out by the state government are Mapusa, in North Goa and Ponda in South Goa. "The overall security scenario and the upward crime graph needs

increase in Police Districts in the state of Goa. Over the years, the role and tasks of Goa Police have expanded and its functioning has become highly complex calling for a higher degree of professional skills and expertise. Moreover, the work opportunities to the people have led to migration which has resulted in the influx of migrant population," the CMO statement further said.

New Delhi, Oct 13: The Delhi government has urged the Central Board of Secondary Education (CBSE) to not conduct the board exams next year before May and further reduce syllabus as schools still continue to remain closed due to the pandemic.

In a letter to the CBSE, the Directorate of Education (DoE) said due to the COVID-19 pandemic a major chunk of time of 2020-21 academic session (approximately seven months) could not be utilised for classroom teaching learning process as schools in Delhi are closed till October 31. "Though online, semi-online teaching learning activities are being conducted through live classes as well as worksheets or activity sheets it cannot replace the physical classroom teaching learning process," the DoE said in the letter.

"In order to provide students with a reasonable time to study in person in schools, it is requested that the ongoing academic session be extended beyond March and CBSE board exams be conducted not be-

fore May 2021. Consequently, the next paper design and made available for academic session may commence from July, 2021," it added. The department has requested to further reduce the syllabus for the current session, keeping the COVID-19 pandemic condition and the leftover

the students at the earliest," the DoE said. Universities and schools across the country were ordered shut March 16 to contain the spread of novel coronavirus. March 25, the Centre announced a nationwide lockdown. While several restrictions have been eased gradually in different phases of the 'unlock' since June 8, educational institutions continue to remain closed.

However, according to the latest 'Unlock 5' guidelines, schools, colleges and other educational institutions outside COVID-19 containment zones can reopen after October 15.



New Delhi, Oct 13: In view of the winter season and festivities around the corner, the NITI Aayog has warned that the second peak of Covid-19 is impending over the country. Dr VK Paul, member (health) and head of the national Covid-19 task force, cautioned on Tuesday during a press briefing that India will see another storm of Covid-19 cases.

However, the mortality will be much lower as our healthcare system is now prepared for the fight, he added.

"Observing the nature of the respiratory virus and the significant rise in cases in Europe and the United States of America (USA), we can assume a rise in the cases of the Covid-19," Dr Paul said.

The tendency of respiratory virus is that it thrives during winters. Since SARS-Cov-2 is a respiratory virus, we assume that its infectiousness will increase during winters. The study of pandemics of the Influenza virus reveals that the cases were increased during winter phases, more than the earlier



phases," he explained. Dr Paul also stressed the need to take more precautions during the winters and cautioned people not

PARL PANEL TO VISIT LEH

New Delhi, Oct 13: Amid the border stand-off with China at the Line of Actual Control (LAC), a parliamentary panel will be visiting Leh in Ladakh later this month.

During the two-day visit from October 28, the parliamentary panel will meet soldiers deployed at forward posts for a first-hand assessment of their working conditions, sources in the government said Tuesday. Sources told India Today that the committee will hold informal discussions with Defence Ministry officials and the Northern Command of Army during its Leh visit. The panel will also discuss procurement and issue of high altitude clothing, equipment, ration and housing.

CBI team records statement of victim's kin, recreates scene

New Delhi/Hathras, Oct 13: A CBI team Tuesday quizzed the family members of the 19-year-old Dalit victim in the gangrape and murder case in Hathras district of Uttar Pradesh and examined the crime scene, officials said.

The team, which reached the crime scene in Bulgarhi village Tuesday morning after registering the FIR two days back, took the brother of the victim to record his statement, they said.

The victim had died a fortnight after an alleged brutal assault, including gangrape, by four men of the village September 14.

When the brother was being taken away by the team, speculation about his arrest started doing the rounds, but CBI Spokesperson RK Gaur said that "no arrest has been



made". The CBI investigators spoke to the family members at their residence in detail about the sequence of events on the day of the crime, they said. The officials directed the local police to cordon off the crime scene, which was virtually a thoroughfare for nearly 29 days since the incident.

Meanwhile, the CBI has augmented its Hathras team by assigning four more officers under Superintendent of Police Raghuram Rajan who is heading the Anti-Corruption Bureau. Ghaziabad

Mehbooba released after **13 months**

New Delhi, Oct 13: Former Jammu and Kashmir Chief Minister Mehbooba Mufti was released late Tuesday night after being detained by the government for over 13 months - since it scrapped Article 370 in August - and since being charged under the Public Safety Act (PSA) - a stringent law that allows detention and multiple extensions without trial for up to three months - in February.

"Ms Mehbooba Mufti being released," Rohit Kansal, J&K Principal Secretary, tweeted at 9.17 pm.

The release comes just as a deadline set by the Supreme Court, which had been approached by her daughter Iltija Mufti with a habeas corpus petition challenging her 'illegal' detention, was set to expire.

The court September 29 had questioned the central and J&K governments, asking: "How long can Mehbooba Mufti be kept in custody?" The J&K administration was given two weeks - till October 14 - to explain how long they intended to do so.

Ms Mufti's PSA detention, which was announced on the last day of her six-month detention without charges, had been extended by another three months in July.

Minutes after her release her daughter, Iltija Mufti, who took over her mother's Twitter account after she was detained, tweeted: "As Ms Mufti's illegal detention finally comes to an end, I'd like to thank everybody who supported me in these tough times. I owe a debt of gratitude to you all. This is Iltija signing off. May Allah protect you". Hundreds of politicians, in-

former chief ministers Faroog Abdullah and his son Omar-were detained or ar rested as part

clampdown by the centre to quell backlash over its Article 370 decision.

The mystery of India's low coronavirus death rate

New Delhi, Oct 13: India passed the threshold of recording seven million coronavirus cases Sunday. But given the huge number of confirmed infections, second only to the US, experts are baffled as to why the country's mortality rate is comparatively so low.

The world's second-most populous country, with 1.3 billion people, it has the lowest number of deaths per 100 confirmed cases out of the 20 most-affected countries in the world. India has recorded more than 7.05 million Covid-19 cases and 108,334 deaths from the disease since the first recorded death in mid-March. In terms of deaths per 100

cases, this stands at 1.5%, according to Johns Hopkins University data. The United States, which has the most cases in the world with more

than 7.7 million, has an apparent lethality ratio of 2.8%, with 214,778 deaths. In terms of mortality in relation to the population, the number of coronavirus deaths in India per 100,000 people is 7.73 compared to 64.74 in the United States.

WHAT ACCOUNTS FOR THIS? India has a young population,

with a median age of 28.4, according to the UN World Population Report.

By comparison, the median age in France is 42.3 and this country has reported nearly 700,000 cases and over 32,000 deaths with an apparent lethality ratio of 4.7%

Experts believe that older people, who are more likely to have comorbidities such as diabetes or hypertension, are more likely to die from infectious disease TIME TO PREPARE

According to the Indian govern-



ment, the first case was detected in the country January 30 and the number of cases passed the 100 mark in mid-March. At the same time, the pandemic was already spreading throughout Europe, with more than 24,000 cases and some 2,000 deaths in Italy and around 5,500 cases and 150 deaths in France.

Prime Minister Narendra Modi enforced a national containment from 25 March that severely restricted travel. According to experts, this gave India time to prepare for the arrival of the pandemic and gave doctors time to learn from the experiences of other countries.

'Many of the care protocols were much more stabilised (at that time) whether it was oxygen use or intensive care," Anand Krishnan, professor at the All India Institute of Medical Sciences (AIIMS) in Delhi, said.

Some experts also think it is possible that antibody protection was already present in some of the population of India before the outbreak of the nCoV, due to earlier disease outbreaks such as dengue fever.

STATISTICS NOT CORRESPONDING

Another explanation is the lack of official records of death in much of the country. Around 70% of people live in rural areas, where deaths and causes of deaths are often not recorded.

The pandemic has seen this phenomenon in action, with some areas

showing the information provided by cities and cemeteries and crematoriums not corresponding.

"Our inadequate death surveillance system...is already forgetting many deaths in the first place. Only one in five deaths is registered with a definite cause," Hemant Shewade, a public health expert in Bangalore, said.

He believes it is likely that many deaths related to Covid-19 have not been registered. Government studies using serological tests show that the number of infected people is ten times higher than the official figures, which means that deaths from the disease may have been underreported, he adds.

More accurate assessments are possible by increasing testing, better recording of deaths and autop-sies of presumed victims, according to experts.

Nagorno-Karabakh conflict deepens

Saturday's Russian-brokered ceasefire was aimed at allowing ethnic Armenian forces and Azerbaijan to swap prisoners and bodies of those killed in the deadliest fighting over Nagorno-Karabakh in more than 25 years.. On Tuesday, the truce appeared

to buckle further as Azerbaijan's defence ministry said Armenian forces were shelling the Azeri territories of Goranboy, Terter and Aghdam, "grossly violating the humanitar-



'ABOUT 600 KILLED IN CLASHES'

B'DESH APPROVES DEATH PENALTY FOR RAPE CASES

Dhaka, Oct 13: Bangladesh President Md Abdul Hamid Tuesday signed an ordinance elevating the maximum punish-ment in rape cases to death from life imprisonment.

The development came after the amendment to the Women and Children Repression Prevention Act, was approved by the Prime Minister Sheikh Hasina-led cabinet led Monday, reports bdnews24.

The maximum punishment under the previous law in rape cases was life imprisonment. In recent days, protests have been staged by different organisations at Dhaka's Shahbagh square and other parts of the country against sexual assaults on a woman in Noakhali and the rape of another woman in Sylhet's MC College.

As many as 4,541 rape cases have been reported Bangladesh in the past 16 years and the accused were punished in only 60 of these incidents, according to data from the tribunals. At least 889 women have been raped in Bangladesh between January and August 2020, rights group Ain O Salish Kendra said.

Dubai. Oct 13: A total of 49 Indians. who were stranded for several months in the UAE after being abandoned by their employers, have been repatriated after the Indian mission here helped them secure their passports and security deposits from two companies, a media report saidTuesday.

Left to fend for themselves, the expats reached out to the Indian Consulate in Dubai in July and sought help to return home. "The workers had been in dire straits after the companies were shut and the Indian employer went unreachable. They had not been paid for about six months and they reached out to the consulate for



help to return home." Neera Agrawal, Consul for Press. Information and Culture, was quoted as saying in the report.

He said the mission has provided food supplies to the workers since July. "However, the workers' passports were still under the custody of the companies. Though the owner was not reachable, the consulate somehow contacted the PROs of the firms and the workers' passports and security deposits [3,000 dirhams each] were taken with the support of Dubai Police and Al Adheed Centre of Dubai Courts which provides services related to labour disputes," he said. "CGI provided them with rations for more than 3 months & helped to retrieve their passports from their employer," the mission said in a tweet. The workers, majority of whom are from Uttar Pradesh, flew home in three batches.

During the Supreme Court confirmation hearing of Judge Barrett on Monday, Harris condemned the idea of holding the process amid the COVID-19 pandemic and an outbreak among members of the committee. Two Republican members of the Judiciary Committee --Senator Mike Lee (Utah) and Senator Thom Tillis (North Carolina) -- have tested positive for

Appearing remotely from her office before the Senate Judiciary Committee, of which she is an important Democratic member, Harris taking time off from the campaign said more than nine million Americans have already voted and millions more will vote while "this illegitimate committee process is underway"

Harris alleged that Senate Republicans have made it crystal clear that rushing a Supreme Court nomination is more important than helping and supporting the American people who are suffering from a deadly pandemic and a devastating economic crisis.

"Their priorities are not the American people's priorities. But for the moment. Senate Republicans hold a majority in the Senate and determine the schedule, so here we are," she said asserting that she does believe this hearing is a clear attempt to jam through a Supreme Court nominee who will take healthcare away from millions of people during a deadly pandemic that has already killed more than 214,000 Americans. Monday's hearing was devoted to opening statements among all of the senators on the committee. Meanwhile, in her opening remarks, Judge Barrett said, if confirmed, it would be the honour of a lifetime to serve alongside the chief justice and seven associate justices.

Climate change means more weather disasters every year'

Geneva, Oct 13: In the wake of heat waves, global warming, forest fires, storms, droughts and a rising number of hurricanes, the UN weather agency is warning that the number of people who need international humanitarian help could rise 50 per cent by 2030 compared to the 108 million who needed it worldwide in 2018.

In a new report released with partners Tuesday, the World Meteorological Agency says more disasters attributed to weather are taking place each year. It said over 11,000 disasters have been attributed to weather, climate and phenomena like tsunamis that are related to water over the last 50 years — causing 2 million deaths and racking up \$3.6 trillion



worth of economic costs.

In one hopeful development over that period, the average number of deaths from each separate weather disaster per year has dropped by one-third, even as the number of such events and the economic costs from them have both surged. The 2020 State of Climate Services report, compiled by 16 international agencies and financing institutions, calls on governments to

put more money into early-warning systems that can improve countries' ability to prepare for, respond to and mitigate the impact of such natural disasters.

'While COVID-19 generated a large international health and economic crisis from which it will take years to recover, it is crucial to remember that climate change will continue to pose an on-going and increasing threat to human lives, ecosystems, economies and societies for centuries to come," said WMO Secretary-General Petteri Taalas. "Recovery from the COVID-19 pandemic is an opportunity to move forward along a more sustainable path towards resilience and adaptation in the light of anthropogenic climate change," he said.



While more research is needed, the scientists said the possibility of reinfections could have significant implications for understanding

COVID-19 immunity, especially in the absence of an effective vaccine. 'It also strongly suggests that individuals who have tested positive for SARS-CoV-2 should continue to take serious precautions when it comes to the virus, including social distancing, wearing face masks, and handwashing," Pandori explained. According to the scientists, at least four other reinfection cases have been confirmed globally in Belgium, the Netherlands, Hong Kong, and Ecuador with the latter being the only other instance in which the second infection displayed worse disease outcomes than the first.

According to the researchers, the patient may also have come in contact with a more virulent variant of the virus.

Demand stimulus not enough

New Delhi, Oct 13: As the Finance Minister Nirmala Sitharaman has announced a couple of demand boosting measures along with loans to states for increasing capital expenditure after a lot of anticipation, concerns have again been raised over the adequacy and effectiveness of the measures.

As per stock brokerages, the latest demand-moving measures are insufficient and the results are only going to be "modest".

Sitharaman Monday announced an 'LTC Cash Voucher Scheme' which will be launched with applicability till March 31, 2021. Under the LTC scheme, central government employees get LTC in a block of four years -- one travel to anywhere in India and one to hometown or two for hometown visits. Air or rail fare, as per pay scale or entitlement. is reimbursed and in addition leave encashment of 10 days (pay and dearness allowance) is paid.

In this case, the government will make full cash payment on leave en-



cashment and payment of fare in three flat-rate slabs depending on class of entitlement, including making the fare payment tax free. An employee opting for this

scheme, would be required to buy goods or services worth 3 times the fare and one time the leave encashment before March 31, 2021. The money must be spent on goods attracting GST on 12 per cent or

Further, with the recent job losses of 1.9 crore people in salaried class, revival in that demand would require more aggressive steps by the government, it said.

The impact of the ₹73.000 crore package would be marginal it said, adding that generally capital spending has much higher multiplier impact on growth and is likely to last longer.

Loan interest waiver to cost ₹6,500 crore



We expect an all-round improvement in margins in 2QFY21 driven by rising utilisation levels (production is now running at 65-

90 per cent of capacity)," said Aditva Makharia, Institutional Research Analyst (auto), in the report.

"Correspondingly, valuation multiples for auto companies continue to re-rate and are now trading at levels between mean 'P/E and +1std deviation'," Makharia added.

As per the report, Nifty Auto index is up a further 20 per cent over the quarter versus 9 per cent for the broader Nifty. "We believe that stock price returns will be driven by retail trends in the festive season as well as expectations of supportive government policy (GST reduction, scrappage scheme).

"We have a BUY on Maruti. Hero and Endurance in the autos segment and prefer Gateway Distriparks in the logistics segment," Makharia said.

J&J pauses vaccine trials due to unexplained illness

THE MOVE COMES AROUND A MONTH AFTER ASTRAZENECA ALSO SUSPENDED TRIALS OF ITS EXPERIMENTAL CORONAVIRUS VACCINE

New Delhi, Oct 13: Johnson & Johnson has paused clinical trials of its coronavirus vaccine candidate due to an unexplained illness in a study participant, delaying one of the highest profile efforts to contain the global pandemic.

The move comes around a month after AstraZeneca also suspended trials of its experimental coronavirus vaccine - which uses a similar technology - due to a participant falling ill. J&J said Monday the illness was being reviewed by an independent data and safety monitoring board as well as the U.S. group's clinical and safety physicians.

The company, which reports quarterly financial results Tuesday morning, said such pauses are normal in big trials, which can include tens of thousands of people. It added the voluntary "study pause" in giving doses of the vaccine candidate was different from a "regulatory hold" imposed by health authorities.

AstraZeneca last month paused late-stage trials of its experimental coronavirus vaccine developed with the University of Oxford due to an unexplained illness in a British study participant. While AstraZeneca's trials in Britain, Brazil, South Africa and India have since resumed, its U.S. trial is still

on hold, pending a regulatory review. The J&J and AstraZeneca vac-



cines are both based on a so-called adenovirus, a harmless modified virus that instructs human cells to produce vaccine proteins. They are both also part of the U.S. govconcerns," said Bryan Garnier analyst Olga Smolentseva. AstraZeneca and medical experts say trial suspensions to look into the cause of a participant's illness are not uncommon. Underwriters of clinical trial insurance have said premiums for coronavirus vaccines studies are only marginally higher than for pre-pandemic vaccines.

J&J Sept. 22 became the fourth Warp-Speed participant to enter the final stage of testing on humans, with the aim of enrolling 60,000 volunteers in the United States and abroad." Everybody is on the alert because of what happened with AstraZeneca," Dr. William Schaffner, a professor of infectious diseases at the Vanderbilt University School of Medicine, said by email, adding it could take a week to gather information.

"This is likely to be a neurological event," he said. Last month, J&J said its vaccine candidate produced a strong immune response in an early-to-mid stage clinical trial. This prompted the company to start the large scale trial, with results expected by the end of this year or early 2021. J&J declined to elaborate on the illness due to privacy concerns.

It did say some participants in studies get placebos, and it was not always clear whether a person suffering a serious adverse eventin a trial received a placebo or the treatment.
