Washington, Oct 15: The world is experiencing one of the deepest recessions since the Great Depression in the 1930s owing to the novel coronavirus, World Bank President David Malpass has said, terming the COVID-19 pandemic a "catastrophic event" for many developing and the poorest countries.

He told reporters that given the extent of the economic contraction, there was a rising risk of disruptive debt crises in countries.

So that has got a lot of focus here at the meetings, Malpass told the media Wednesday at the start of the annual meetings of the International Monetary Fund and the World Bank.

"The recession has been deep, one of the deepest since the Great Depression. And for many developing countries, and for the people in the poorest countries, it is truly a depression, a catastrophic event. It is continuing to add to the ranks of those in extreme poverty," he said. That is the focus of this meeting and the focus of their actions,



he said, adding that the World Bank was building as big a growth programme for countries as they can in this fiscal year.

A day earlier, the Board approved the extension of the health emergency programmes to up to \$12 billion for vaccines and therapeutics and distribution of those in countries that do not otherwise have access.

Responding to a question, Malpass said that the world was currently experiencing a K-shaped recovery. That means that the advanced economies have been able to provide support, especially for

their financial markets and for people that have jobs that can be done by working from home. But people that are in the informal economy have lost their jobs, and are depending on social protection programmes, he said.

For the developing countries, and especially the poorest developing countries, that downward leg in the K is an increasingly desperate recession or depression that is facing people in the poorest countries because of the loss of jobs, the loss of income, and also the loss of remittances coming from workers, working outside the country, Malpass said.

"What we're trying to do at the World Bank is recognise that problem and provide extra support for social protection for the poorest in countries, also recognising the agricultural challenges," he said.

The president welcomes countries that are keeping open their export markets, and also countries that are able to change their subsidy systems in order to allow more food availability within their economies during this very challenging time.

US appoints spl officer for Tibet

New Delhi/Washington, Oct 15: A day after President Xi Jinping called on Chinese troops to prepare for war, the United States appointed a senior official as its special coordinator for Tibetan issues.

Tibet, which has been under Chinese occupation since 1950, remains a sensitive issue for Beijing diplomatically. The Chinese Communist Party regime has persistently refused to engage with the US coordinator on the Tibet issue.

The Tibetan government in exile, established in India, is headed by the Dalai Lama.

Since the beginning of President Donald Trump's term in 2017, the position for the US special coordinator for Tibetan issues was vacant.

On Wednesday, US Secretary of State Mike Pompeo announced that Robert Destro, assistant secretary of state for democracy, human rights and labour, would assume the additional charge.

"Destro will lead US efforts to promote dialogue between the People's Republic of China and the Dalai Lama or his representatives; protect the unique religious, cultural, and linguistic identity of Tibetans; and press for their human rights to be respected," Pompeo said in a statement.

He added that the US remains concerned with the PRC's "repression of the Tibetan community."

The Trump administration in the past has threatened to restrict visas for the Chinese officials responsible for human rights abuses in Tibet and blocking diplomatic access to the region.

Another low pressure likely to form October 19

Bhubaneswar, Oct 15: A fresh low pressure area is likely to be formed over central Bay of Bengal around October 19 which will trigger heavy rainfall several parts of the state, Bhubaneswar Meteorological Centre director HR Biswas said.

The low pressure likely to bring heavy rain in some places of south and coastal Odisha districts between October 19 and 20, he said, adding, "We are now monitoring the system. The exact impact of the low pressure in the state will be known once it will take shape."

As per preliminary prediction, Koraput, Rayagada, Gajapati, Ganjam, Puri and Khurda would experience heavy downpour, October 19.

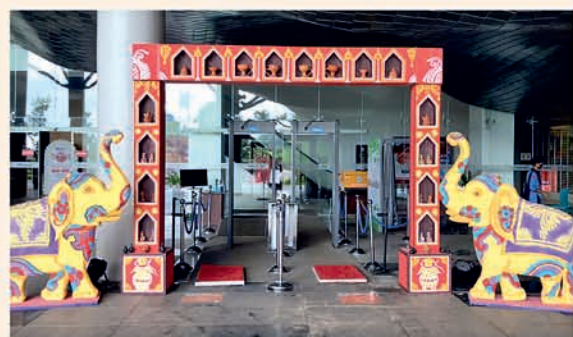
The Met centre said thund

derstorm with lightning very likely to occur at one or two places over the districts of Puri, Khurda, Nayagarh, Ganjam, Gajapati, Malkangiri, Koraput, Rayagada and Kandhamal during the next 24 hours.

Southwest monsoon is active over Odisha. Light to moderate rain or thundershower is very likely to occur at most places over the districts of south coastal Odisha and at many places over the rest districts of Odisha in the next 24 hours. Heavy rainfall in past three days has created havoc in south Odisha.

Between 8.30 am and 5.30 pm Thursday, highest rainfall was recorded at Boudh (43 mm), followed by Angul (19 mm), Chandbali (15), Nayagarh (14), Talcher (10), Puri (9), Paradip (8) and Cuttack (7).

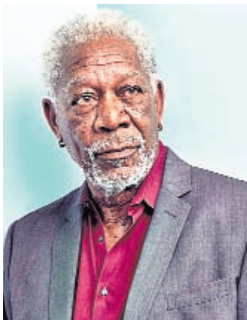

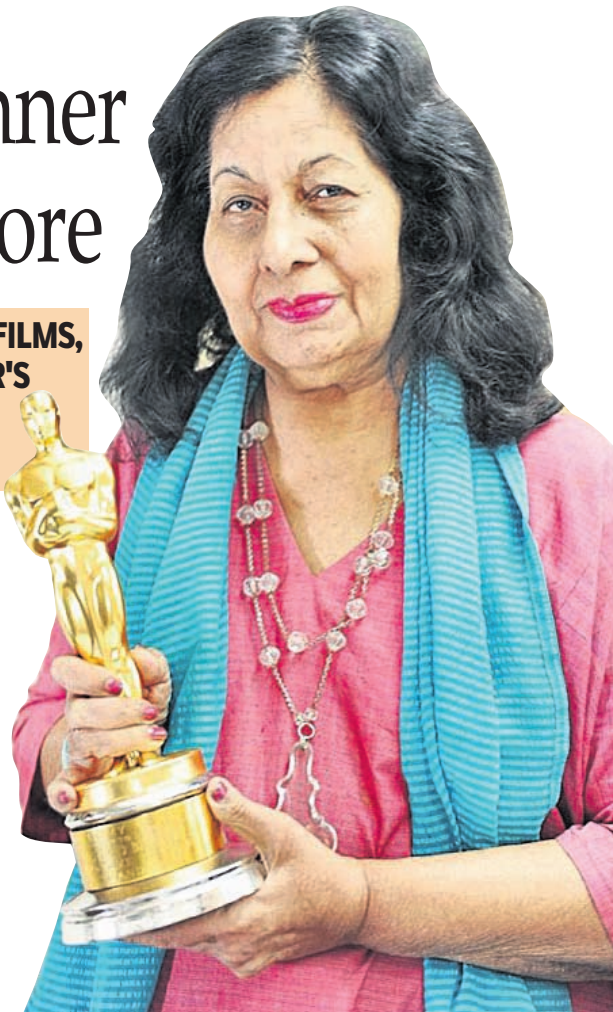


India's first Oscar winner Bhanu Athaiya no more

IN A CAREER SPANNING FIVE DECADES AND OVER 100 FILMS, ATHAIYA WON TWO NATIONAL AWARDS -- FOR GULZAR'S MYSTERY DRAMA *LEKIN* (1990) AND THE PERIOD FILM *LAGAAN* DIRECTED BY ASHUTOSH GOWARIKER

Mumbai: Costume designer Bhanu Athaiya, India's first Oscar winner, died at her home Thursday after prolonged illness, her daughter said. She was 91. Athaiya, who won an Oscar for her work in the 1983 film *Gandhi*, passed away peacefully in her sleep, her daughter Radhika Gupta said. The last rites took place at the Chandanwadi crematorium in South Mumbai. "She passed away early this morning. Eight years ago, she was diagnosed with a tumour in her brain. For the last three years, she was bedridden because one side (of her body) was paralysed," her daughter said.

Athaiya, who was born in Kolhapur, began her career as a costume designer in Hindi cinema with Guru Dutt's 1956 superhit *C.I.D.* She won the Academy Award for Best Costume Design in Richard Attenborough's *Gandhi* along with John Mollo. In 2012, Athaiya returned her Oscar to the Academy of Motion Picture Arts and Sciences for safe-keeping. In a career spanning five decades and over 100 films, she won two National Awards - for Gulzar's mystery drama *Lekin* (1990) and the period film *Lagaan* directed by Ashutosh Gowariker.

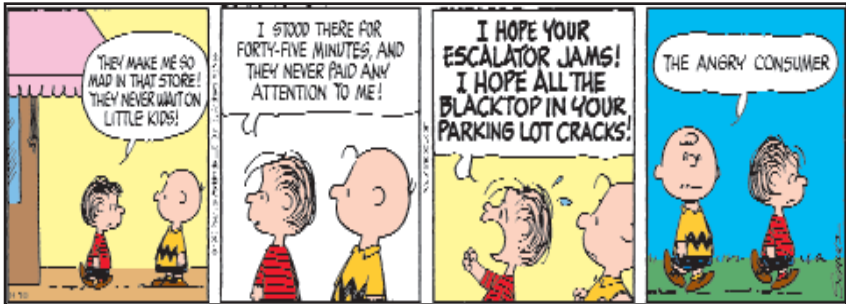


Sanjay says he will beat cancer soon

State’s virus caseload at 2,62,011

WITH 17 MORE FATALITIES, ODISHA’S CORONAVIRUS DEATH TOLL STANDS AT 1,089

Bhubaneswar, Oct 15: State’s novel coronavirus disease (Covid-19) tally rose to 2,62,011 Thursday as 2,470 more people tested positive for the infection, while 17 fresh fatalities pushed Odisha’s coronavirus death toll to 1,089, an official of the Health and Family Welfare (H&FW) department said.

As many as 1,462 new cases were reported in quarantine centres, while 1,008 people tested positive for the infection during contact tracing, said the official.

Khurda district, under which Bhubaneswar falls, registered the highest number of fresh cases at 368, followed by Cuttack (186) and Angul (170), the official pointed out.

Four fresh fatalities were reported in Khurda, three each in Cuttack and Sundargarh, two in Ganjam, and one each in Balasore, Boudh, Jajpur, Kalahandi and Nayagarh, said the H&FW department official.

Ganjam has so far reported the highest number of coronavirus fatalities at 225, followed by Khurda (189) and Cuttack (94).

As many as 53 coronavirus pa-



tients have succumbed to other ailments so far, the official said. The state has so far tested over 39.21 lakh samples for Covid-19, including 42,148 Wednesday

Capital city registers 253 new cases

Meanwhile, the state capital also reported 299 Covid-19 recoveries in the past 24 hours.

Silver City sees 112 fresh infections

Cuttack: Of the 186 new Covid-19 cases reported Thursday in Cuttack district, 112 belong to Cuttack Municipal Corporation (CMC) area, the civic body said. The latest surge has taken the virus tally in the Silver City to 13,863.

3rd round of sero-survey from today

In a bid to identify prevalence of novel COVID-19 in the state capital, the BMC Thursday, said that it will begin the third round of sero-surveillance from 16th to 18th Oct. Briefing the media, BMC Commissioner Prem Chandra Chaudhary said that the BMC along with technical support from RMRC will be conducting the survey in different parts of the city for three days. “Five teams will be carrying out sample and data collection from 1500 people of Bhubaneswar city selected randomly from 25 wards across the city. We urge the general public to support the endeavour and participate in good numbers,” the Commissioner said.

Special care taken for kids, says govt

Bhubaneswar, Oct 15: The State Health and Family Welfare Thursday said that it took special care and initiatives to ensure Early Childhood Development of children from the state during the COVID 19 outbreak.

Bijay Panigrahy, Director of State Family Welfare said that the state roped in the frontline workers during the period to ensure the important phase of the children is not compromised during the pandemic.

“We took several steps to ensure that the Early Childhood Development (ECD) of kids is taken care of. We took the help of anganwadi workers, ASHA workers and others for the same. An Odia booklet especially crafted for them was also distributed,” he said.

The statement from the state health department came into lime-light in a discussion on the issue organized by the All India Institute of Medical Sciences (AIIMS), Bhubaneswar and UNCIEF-Odisha.

Dr Mridula Phadke, Advisor to the National Health Mission (NHM) said that nutrition plays a key role in the early stages of development



of a kid. “Adequate nutrition is of paramount importance during the ECD days which consists of the conception period (270 days) and the first 2 years of life (730 days). COVID is also having an effect in the overall development process.”

Dr Bhagirathi Dwivedi, pediatrician from AIIMS Bhubaneswar said that the ECD encompasses physical, socio, emotional, cognitive development between zero – six-year age and development starts in the womb itself and thus it needed special care from the people involved in upbringing of children.

Monika Nielsen, Chief of Field Staff, UNICEF Odisha talked about the capacity building of frontline workers, increasing awareness among care givers, promoting policies and other areas which can act as strong base for the early development of children in Odisha.

Revenue from MVs shoots up

Bhubaneswar, Oct 15: The State Transport Authority (STA) Thursday said that it has seen an improvement in the revenue collection from motor vehicles in the month of September this year.

The department said that it reported a total collection of ₹89.5 crore in the month of August. However, the total collections in September this year touched 117 crore, showing a 31 percent increase.

However, compared to September 2019, the collections for September this year were a bit lower. While the government saw collection of ₹126 crore in September last year, the amount was ₹117 crore for the month this year.

The department claims that it has seen rise of revenue collections every month from motor vehicles since June 2020

The department in a statement said, “The collection has picked up due to growing sale of new motor vehicles and collection of taxes due to increased economic activity particularly in the mining sector.”

HC seeks response on Bagala land sale

Cuttack, Oct 15: The Orissa High Court (HC) Thursday sought the state government’s response in connection with the alleged sale of Bagala Dharmashala land in Puri.

A division bench comprising Chief Justice Mohammad Rafiq and Justice Bidyut Ranjan Sarangi served a notice on the state government seeking its response on the alleged sale of land belonging to the Dharmashala while hearing a plea filed by Bharatiya Janata Party (BJP) national spokesperson Sambit Patra.

A similar petition was also filed by Jagannath Bastia, who later filed a misc case with the state’s apex court on the issue. The HC decided to hear the cases simultaneously and posted the hearing to November 2.

Patra had filed a petition in the HC demanding the Dharmashala land to be brought back to Lord Jagannath’s ownership.

Police stops BJP delegation

BHUBANESWAR: Odisha Police Thursday stopped the padyatra march of the Bhartiya Janata Party (BJP) delegation at the outskirts of the state capital before they entered the city.

A number of BJP leaders began their padyatra from Puri and were expected to march towards Bhubaneswar towards Naveen Nivas to meet the Chief Minister. The delegation was miffed with the decision of the government to allegedly sell the age-old property of Bagala Dharmasala to private players.

The cops intercepted them at Uttara Square in the city outskirts and barred their movement ahead, making their plan to meet the CM futile. The delegation wanted to meet the CM and express their opposition to government plans on the matter.

Cyber crooks create fake id of official

Bhubaneswar, Oct 15: Cyber crooks continue to target top bureaucrats of the state by hacking their social media and email accounts.

In the latest development, one senior IAS officer has fallen prey to the cyber criminals after senior IPS officers, Commissioner of Police, Sudhanshu Sarangi and DIG (Intelligence) Anup Sahoo.

As per the sources, cyber fraudsters have created a fake email id, managingdirector@mail@gmail.co, in the name of R Vineel Krishna, top IAS officer and the OMC MD.

The fraudsters also sent email messages to various top officials of OMC seeking favour.

Subsequently, the officers enquired with the OMC MD who denied writing the email. The OMC officials have lodged a complaint at the Capital police station seeking stringent action in this regard.

Academicians favour reopening of Srimandir

Puri, Oct 15: Most of the academicians, NGOs and senior citizens Thursday expressed their views in favour of reopening Srimandir for devotees.

During a virtual conference with Shree Jagannath Temple Administration (SJTA) chief administrator Krishan Kumar

Thursday, they said that the temple had remained closed for more than seven months and it should be reopened for devotees under the Covid-19 guidelines.

Kumar had interacted with office bearers of Daitapati, Chunara, Paniapat, Akhand Mekap, Sudhasuar and Muduli the eight Niyogs of the temple Wednesday. He too sought opinions of the Muktimandap.

He is likely to seek opinion of Gajapati Maharaj and Sankaracharya Friday before placing his report in the temple managing body and Chhatisha Niyog.

The temple body would deliberate over the matter and send the outcome of meeting to the state government for its final approval.

Bhubaneswar, Oct 15: The state government’s project of constructing 4-lane roads in different stretches of the state have now hit bottlenecks at various regions due to delay in land acquisition in the affected areas.

A recent meeting of the State Works Department during their review of the Biju Expressways found that several areas had been facing land acquisition issues leading to delay in the project. The local

Executive Engineers of the areas have now been asked to expedite the process.

It is reported that 82.7 km of the Sohela-Mondosil, a 4-lane road under the Bargarh Division is complete and a 18.4 km-stretch is still 2-lane. It is said that there was no land acquisition on 38 spots on the stretch.

In the Nuapada Division, 11.56 kms of road in the Ghatipada Chhak to Kalahandi border out of the 104.9kms are said to be facing land acquisition issues. Few households

are said to be residing on government lands.

On similar lines, works in 4 kms of the Kalahandi border to Amapani in Bhawanipatana division is halted due to land acquisition issues. Moreover, out of the total 70.9 km road, 60.37 kms are only two-lane. The delay in works is also cited to constriction of three major bridges enroute.

“It was pointed out that the land acquisition is being taken up for 4-lane. Therefore, it was decided that necessary steps must be taken for

construction of 4-lane road for entire stretch. Chief Engineer (Roads) was requested to take necessary action for preparation of Detailed Project Report (DPR) for these stretches. The DPR should include construction of major bridges and any other left out work,” the minutes of the meeting said.

It also added, “It was further discussed that Biju Expressway should be developed as a model road for the state. All other ancillary and roadside infrastructure also needs to be provided.”

Robotic intervention to control dust in mines

The villagers of Sarua had earlier alleged that the boundary wall was blocking them to access a public pond and their agricultural lands. Accepting the villagers’ complaint, the administration had launched a probe into the incident.

According to sources, OTV authorities had set up a building at Sarua in the name of Sarua Mahila

Bikash Samiti, a women society. The media house authorities had then claimed that they would promote women empowerment and self-employment through the society.

Subsequently, the media house authorities erected a boundary wall around the building. However, the building has been lying idle since its inauguration.

Locals had alleged that the boundary wall constructed by the media group was preventing them from accessing a public pond and their agricultural lands at Sarua. As a result, the villagers were facing problems to carry out agricultural work, said the complaint.

“We have started demolishing the boundary wall to allow free access to the village pond and facilitate the drainage of rainwater,” said the Sub-Collector. Begunia Tehsildar Prithwiraj Mandal said they will take every possible step to allow villagers free access to the pond and their farm lands.

Rly dvn, route plans in cold store

Berhampur, Oct 15: The proposed establishment of a separate railway division in Silk City is lying in cold storage due to alleged apathy by the Centre and the state government, a report said.

Also, the construction of a rail route to Sambalpur from the city is also hanging fire for the above reason. As a result, the dream of residents in having a separate railway division in Berhampur and a rail route to Sambalpur lies unfulfilled.

Reports said both the Centre and the state government are implementing various plans for the benefit of people. However, many of the plans are never implemented or abandoned in the middle due to lack of willpower on part of both the governments.

Similar is the case of Berhampur where establishment of a railway division and a rail route to Sambalpur is hanging fire for long despite the city fulfilling necessary criteria for the projects. The government is showing no willpower for establishment of a railway division in the city and is backtracking on the issue, various outfits have alleged.

Sources said Berhampur is the second largest town in the state but has remained neglected on various fronts due to government apathy. The railway station in the city witnesses heavy traffic as people

from Ganjam, Gajapati, Kandhamal as well as from neighbouring Andhra Pradesh depend on the station to travel to their destinations.

The revenue collection from Berhampur railway station is highest in comparison to all other railway stations under the jurisdiction of east coast railway zone.

However, the dilly-dallying attitude of the government in establishment of the railway division and rail route has raised questions among people.

The state government has forwarded a proposal to the Union Railway Ministry for establishment of two railway divisions at

Rayagada and Jajpur. However, Berhampur is better suited for a railway division in comparison to Rayagada, Abani Kumar Gaya, convener of Manav Adhikar Surakshya Manch (MASM), a human rights outfit, said.

He said Berhampur is better placed socially, geographically, financially, transport and healthcare facilities as well as in trade and commerce for establishment of railway division.

He said the step-motherly attitude of both the Centre and the state government is responsible for the delay. He alleged that parties ruling at both the Centre and state

have betrayed the trust of the residents by not implementing these projects. He said, a case has been filed in the high court and if the projects are not implemented soon then a joint agitation and railroko will be launched.

He said the plan for construction of Berhampur-Sambalpur rail route is also lying in cold storage despite sanction of funds. The Centre approved the project having a plan outlay of Rs 2957 crore and conducted a survey in 2004. However, since then the project has failed to move ahead and is stuck in red-tapism.

Recently, the Centre has given

its approval to Berhampur-Talcher rail route project. The route to be constructed under a public-private partnership mode will pass through five tunnels, 40 long bridge, 154 small bridges and 20 stations like Jagannathpur, Kukudakhundi, Hinjilicut, Aska, Khandrabali, Basudevpur, Bhanjanagar, Mujagad, Phulbani, Lakrapaju, Sunamundi, Mundapada, Boudh, Kadaligarh, Redhakhole and finally Talcher.

He said travelling of the residents between Ganjam, Gajapati and Kandhamal districts would be easier and reduce time if these rail routes are constructed.

Three minor siblings die of 'food poisoning'

Malkangiri, Oct 15: Three minor siblings of a family died due to alleged food poisoning at Kacheli village under Sadar block in Malkangiri district Thursday. Their younger sister and mother were also in critical condition and admitted to the district headquarters hospital for treatment.

The deceased have been identified as Sukanti Madi, 12, Sitaram Madi, 7, and Anjali Madi, 5, daughters and son of Bhime and Pandu Madi in the village. The incident has spread shockwaves in the area as a pall of gloom descended on the village after the tragic incident. Sources said the four children and their mother complained of uneasiness, vomiting and loose motion after having dinner in their home in the village Wednesday night. The ailing family members had reportedly consumed food preparations made

from wild roots and greens last night. They consulted a quack before medical treatment, locals said.

When their health condition started deteriorating, they consulted the ANM of the village. A team of doctors reached the village for the treatment of the family members following a phone call from the ANM. Seeing the condition of the family members, they immediately shifted the affected family members to the district headquarters hospital where Sukanti, Sitaram and Anjali succumbed to their illness while undergoing treatment.

Pandu's wife Bhime and youngest daughter Malati, 3, were administered treatment while the former was discharged after she showed signs of improvement. Malati is still undergoing treatment. A team of police officials led by IIC Ram Prasad Nag of Malkangiri Model police station sent the bodies for post-mortem.

Tito aide nabbed in Bhadrak; gun seized

Woman farmer bears lockdown brunt, seeks aid

Bantala, Oct 15: A woman farmer of Poktung village under Bantala police limits in Angul district had high hopes of making a handsome profit from her banana plantation. However, the COVID-19 pandemic has shattered her hopes.

Ashalata Pradhan, a widow, is hoping for some assistance from the government. She said if she doesn't get any financial assistance it will be impossible for her to continue farming.

Ashalata lost her husband, Amar, two-and-a-half years ago. She had

grown banana and other vegetables on five acres. Just at the time of harvest, COVID-19-induced restrictions were imposed, spelling doom for her. More than one thousand banana bunches perished and she suffered losses of more than Rs 1,00,000.

According to Ashalata, her husband used to grow banana and sell it in the market to run the family. After his demise, the responsibility of running the family fell on her shoulders. She could not think out a way as to how she could educate her three children – one son and two daughters.



Eventually, Ashalata decided to take up banana cultivation like her husband. She started growing crops on five acres at Jammutaila near Bada School. Two acres belonged to the family and she hired three acres from a neighbour. She had grown

banana on three acres and vegetables like egg plants, pointed gourds on the rest two acres. Last year, from the banana plantations she had earned a profit of Rs 70,000.

Eyeing better profits this year, she invested Rs2,00,000 in her farmland. She also engaged eight to 10 labourers on a daily wage basis to grow bananas. She had expected to sell over 1,000 banana bunches with the price of each varying between Rs 250 and Rs 300.

Due to the lockdown restrictions, traders could not visit her plantation and the fruits were left to rot on trees, she lamented.

Crorepati Hindi teacher arrested by Vig

Displaced people fume over unkept promises

DEMAND MORE COMPENSATION, AGRICULTURE LAND AS PER NEW R&R NORMS

Paralakhemudi, Oct 15: The families displaced by Harbhanga irrigation project under Mohana block in Gajapati district have decried their yet-to-be-unresolved problems and promises. They said they have allegedly been suffering for over 23 years after being displaced by the project.

The affected family members under the aegis of Harabhanga Bisthapita Mahasanga protested the government apathy toward their plight and submitted a memorandum to the district administration at Paralakhemundi Wednesday.

They pointed out that they have lost everything after being displaced by the project 23 years ago, but the promises they were given by the administration have remained unfulfilled till date.

They alleged that some people in the area had made a bid to grab their land they are cultivating for 23 years.



False cases have been filed against them as part of a conspiracy to grab the land. As a result, they are unable to harvest maize from the land, they lamented. They also said that they were exhausted from frequenting to the tehsil office to sort out the case, but the tehsildar instead of resolving the issues is making them run. "Though we had sought details about the land status through RTI queries from the tehsildar, no information is being provided to them," they said. Besides, the irrigation project is not

beneficial to the Gajapati district, but more beneficial for the neighbouring district, they rued.

Notably, Harbhanga irrigation project was started in 1980 and was completed in 1998.

The government had promised a job to a member of each displaced family, 10 acres of land to each family, compensation for the trees, cattle, wells and financial assistance for five years. Housing units were promised to them, but it is yet to be fulfilled. "Due to a dishonest officer

of the irrigation department, financial assistance was thrown to the winds," they said. As per the resettlement and rehabilitation policy, youths over 18 years of age should be considered oustees and they should be paid compensation accordingly. 44 displaced people have not got compensation till date. Over 56 displaced families in six villages have not been provided any assistance. Many of them have died after years of suffering, the association said.

"The government has forgotten promises such as jobs for one member of the displaced families, free vocational training provision for the unemployed youth, special schools for the displaced people, provision of safe drinking water," they added.

They demanded revised compensation as per the new R&R policy, jobs for the families, providing 10 acres of agriculture land, permission for harvest and sale of maize on their land. "The government should keep their promises," they added.

Dud policy

The role of real estate sector in turning around the ongoing economic slump cannot be overestimated. Besides, the sector is a dynamo of employment. Because of its inter-linkages with other sectors and industries, a revival of the real estate sector in the country will open opportunities for other sectors leading to their revival. The Covid-19 induced lockdown in the country put paid to housing sector; throwing millions of people jobless. A major portion of the migrants, who headed back home post Covid-19 induced lockdown, had been employed in real estate businesses in metros and tier-II cities. These people constituted a major portion of the migrants who were mobilized between April and July this year. In light of this, the Reserve Bank of India has done well by rationalising the risk weights and loan-to-value (LTV) ratios of new housing loans to be sanctioned till March 31, 2022. This will free up more capital in banks which could be passed on to customers. This measure will address the urgency of funds required to boost the real estate sector in the country. Home loans will become accessible and cheaper for customers. Earlier, lenders looked at multiple factors before fixing the loan size to be disbursed to a customer. They included his credit profile. Lenders were also hamstrung by various regulatory caps. For example, if a bank underwrites a loan of ₹75 lakhs, the customer is asked to arrange ₹15 lakhs after which the lender chips in with ₹60 lakhs. The LTV would be ₹60 lakhs (value of the loan) divided by ₹75 lakhs (cost of the home purchased). The LTV will be 0.8 per cent. If the LTV increases the banks' risk weights for advances will also go up. Therefore, the risk size is linked to size of the loan as well as the loan to value (LTV) ratio. The rise in the LTC therefore will decrease the risk weight of a loan making it easy for banks to extend loans to prospective borrowers.

Having said this, it will be too simplistic to assume that banks will loosen their purse strings for home buyers. Policies are at one level but when it comes to practice, banks are free to decide. Earlier, the central bank had increased the loan to value (LTV) ratio for gold loans to 90 per cent from the earlier 75 per cent. This had been done to redress the economic sufferings of people in the wake of the pandemic. However, few banks followed the order. Ergo, the latest directive by the RBI with regard to home loans may face the same fate. Keeping the existing borrowers out of the new scheme is also not comprehensible. Existing borrowers may want more money against their punned properties which are in any case undervalued because of the lower LTV. The lenders should include the existing borrowers and pass on the benefits of the bigger LTV to them. Keeping such a large chunk of borrowers out of the benefits of the bigger LTV will not serve the full purpose of the measure. Raising the LTV of home loans will of course lower the risk weight of loans freeing banks of the obligations of larger provisioning, but it all depends on the risk appetite of banks. They are free to decide what they want to do with the idle capital. To assume that banks will lower the interest rates to encourage prospective home buyers to take loans as they will be left with more idle money will be too simplistic. Chances are that a rise in home LTV will face the similar fate of the rise in gold LTV. Policies can only make a difference for the beneficiaries if they are executed in letter and spirit. In case of banks, both PSBs and private ones, there is a huge wall between policies and practices.

Twitterpated

This lovely term appeared, slightly differently, in the article Sex in Space in Wired magazine on 18 May 2007: “How do you handle love, sex, romance, heart-break, jealousy, hurt, unrequited longing, crushes, loneliness and twitterpation when you're 18 months away from Earth and perhaps unsure whether you'll make it back?” It refers to the feelings of besottedness you get when you think about your current object of desire. A contributor to the Urban Dictionary defined it as “An enjoyable disorder characterized by feelings of excitement, anticipation, high hopes, and recent memories of interludes, giddiness, and physical overstimulation which occur simultaneously when experiencing a new love.” One stimulus for its current popularity is that it appears in the film Bambi II, following on its invention in the original Bambi of 1942, in which Friend Owl says, “Nearly everybody gets twitterpated in the springtime.” When the film first came out, the Oakland Tribune remarked that “‘Twitterpated’ is perhaps the best adjective coined by Hollywood since the pixilated sisters were invented for ‘Mr. Deeds Goes to Town.’” It also shows signs of becoming accepted, at least in the short term, as a mildly derogatory term for those obsessive communicators who use the online medium Twitter to tell their friends every small thing they're doing with their day.

Twixter

The cover story in Time Magazine of 24 January 2005 argued that a shift has taken place in the culture of young people between the ages of about 20 and 28, usually college graduates who are often unmarried and living at home, often with no settled employment. The article wasn't kind to them, calling them “permanent adolescents” and “twenty-something Peter Pans”, stuck between childhood and the adult world; it also coined twixters for them because they were “betwixt and between”, perhaps modelled on the established terms tweens and tweemies for those a little younger than teenagers. As the article implied, there's nothing particularly new in identifying this age group as one with special problems: psychologists have in the past coined terms such as kidult, youthhood, adulescent, emerging adulthood, and boomerang kid when writing about it, none of which have been especially successful in linguistic terms. The piece got a lot of attention, including criticism from members of the group, who argued that it was economics, not arrested development, which has led to their situation. It's too early to say whether twixter stands any greater chance of catching the public imagination than previous creations.

Two hoots

A hoot in this slangy sense is the tiniest little bit of something, a whit or jot. To care not even that much shows just how little you really do care about some matter. The original form — which started to appear in the 1870s — had just the one hoot, but it got doubled up later for dramatic effect, around the time that it started to be elaborated into phrases like I don't care a hoot in hell! It might refer specifically to the hoot of an owl but some examples suggest it's more general than that, most likely harking back to two senses known in the seventeenth century: either a loud cry or a shout of disapproval (as in hoots of derision). The owl hoot was taken from the human cry and doesn't appear until near the end of the eighteenth century; the slang sense of an amusing situation or person (“your mother's a real hoot!”) is of the early 1920s.

FOCUS HISTORY

MARATHAS IN ODISHA



It is well-documented as to how the Marathas led by the Bhonsle chief of Nagpur plundered and despoiled this landmass during their half-a-century rule here – from 1751 to 1803 AD – turning the life of the inhabitants upside down through a mix of strong-arm tactics and plunder

direct Mughal rule, was divided into 150 Paraganas or a group of villages or a subdivision of a district, which were left under the management of 32 Amils or local Diwans. Each Paragana was subdivided into two, three, four, or more Mahalas or allotments. The Amil or Revenue Commissioner was responsible for the assessment of revenue and entrusting charges to different officers for the revenue collection.

During the Maratha rule, the normal practice was to grant various allowances by way of money or land to the revenue officer together with other expenses for these collections and also authorise deductions in the expenses. Records show there was a surplus of about ₹4 lakh to be annually dispatched to the court of Nagpur.

In those times, people were paying rent based on the amount of land under cultivation. The Maratha government imposed heavy customs duties and discouraged cotton cultivation in Odisha. Its aim was to procure more rice from here to be sent to Nagpur. Paddy was cultivated in huge quantities here and was a main item of export to Bengal. The export of commodities from Odisha like sugar, textiles, muslin,

earthen pots and other handicrafts was a net addition to the economy of this province.

Under the Marathas, Odisha was producing salt in plenty due to the existence of a large saliferous tract along the coastal belt. A flourishing salt trade brought huge income to the Maratha government by way of annual revenue. This exceeded the amount of land revenue derived by them from this province. Towards the close of the 18th Century, an economic dispute unfolded on the issue of salt trade between the Maratha government in Odisha and the East India Company in Bengal. Irritated over this, the British decided to conquer Odisha.

During the Maratha rule, Odisha was well-connected by roads with Bengal, Madras, and Nagpur. Roads were made not for the benefit of the people but with the motive of controlling the administration in Odisha and Bengal from Nagpur. Roads were a source of income to the state. Taxes were collected at toll gates on the way from people coming from outside to Odisha. A Customs duty was also collected. For instance, a bullock load of silk was taxed at six rupees.

Notably, the Marathas were not pro-people but pro-Brahmin. They were often portrayed as agents of

Hindu nationalism. They gave priority to aspects like maintenance of the Lord Jagannath Temple in Puri, maybe to woo majoritarian Hindus and camouflage their repressive, nefarious and exploiting nature. Puri used to receive pilgrims from all over India. A pilgrim tax was imposed on them by the Marathas. Some ₹9 lakh – a huge amount in those times – came in as pilgrim tax from those visiting the Jagannath temple.

The Marathas were tyrannical. The one and single aim of the Bhonsle of Nagpur was to treat this land as a milching cow and extort maximum as rent from the local inhabitants. This infuriated the masses. The frequent change of governors made the administration of this land wobbly, shaky, and risky.

Allowing frequent march of the British troops through Odisha sparked a sense of trepidation and consternation in the local inhabitants' minds. Lawlessness prevailed and that was perhaps one reason why there began a mass upsurge against the Marathas. This helped the British to conquer Odisha in 1803.

The United States is nudging India into a closer bilateral security alliance as the latter continues to stand-off against China at the border. Also, the US faces Presidential election November 4. Obviously supporting India, the statements emanating from US officials disapprove of India's cautious approach to China.

The US National Security Adviser Robert O'Brien said, “Dialogues and negotiations will not work with China which amassed 60,000 troops on the Northern border”. The deputy secretary of state Stephen Beigun visiting India from 12-14 prior to the 2+2 meeting on 26-27 this month said, “As we build the strategic partnership between US and India, there is an elephant in the room, China”. Whereas the US seeks to confront China in alliance with India, is New Delhi ready for it?

The US Secretary of State Mike Pompeo said in a radio interview that tensions have spiked between China and India after the hand-to-hand combat where 20 Indian troops died and China suffered casualties so far not disclosed. Pompeo asserted: “They (India) absolutely need the US to be their ally and partner in this fight”. The world has awakened

and the tide has begun to turn. President Trump has built up a coalition that will counter the threat from China, maintain the rule of law and the basic civic decency that come from democracies running the world, not authoritarian regimes. Characterising the growing India-US partnership, Beigun said, in his speech to a think tank in Delhi, “US” benefits from forging close links with countries like India that seeks to provide for their own defence. US own interests intersect with those of India. We have seen the conditions emerged for an organic and deeper partnership, fundamental alignment along shared security, shared interests, shared values and geo-political goals”. He elaborated on the partnership and said that post-World War II alliance format requiring in-country US troops' presence may be no longer necessary.

This is a hint at accommodating India's foreign policy tradition of strategic autonomy, or giving India leeway to maintain its neutral posture. Beigun added, “The US benefits from an India that is strong and prosperous”. He promised that the US was prepared to do more to strengthen India's ability to defend

itself by promoting inter-operability among the militaries of both countries through regular exercises and exchange, common defence platform and co-development. Cooperation can be achieved in multiple ways in view of advance technology shifts in global economic scenario and changing geo-politics. The US strategy vis-à-vis China, is two-fold. One, to improve the resilience of US institutions, of alliances and partners to counter the challenges China presents. Second, it seeks to impose tangible costs in order to compel Beijing to stop actions harmful to America's national interests and those of its allies and partner-nations. In this context, one important partnership which will be one of the most key partnerships for the US in the 21st century is that with India.

It is time New Delhi looks at pooling of sovereignty for a common cause like it is in the European Union. A good many scholars and observers have suggested countries accepting limitations on their autonomy in a mutually beneficial alliance system for a greater goal. New Delhi can no longer be a lone ranger in international politics. In the Cold War time in 1970s

and 80s, New Delhi could play the role of mediator on many occasions. New Delhi should focus on building its economy up to the size of China before beginning to confront it by herself.

The US is talking of deepening and expanding the quadrilateral security dialogue called Quad, an informal group of India, Australia, Japan and US. The perspective on Quad articulated by Beigun suggests that any country wanting a free and open Indo-Pacific and is willing to contribute to it, is welcome to join the Quad.

New Delhi is maintaining friendly relations with all the other three Quad participants. But it is fighting shy of developing Quad into a security framework. New Delhi is bugged by this continuing dilemma of choosing between autonomy and alliance. It is somewhat treating ‘autonomy’ as a Hobson's choice. This is causing continued vulnerability and heavy costs on our security. The hang-over of non-alignment affects the foreign policy establishment of our country.

Sir, India's coronavirus active cases have decreased by 20 per cent since the peak of September 17. This is a matter of great relief. However, while cases in worst-hit Maharashtra decreased by 90,000; it is offset by Kerala's increase of 60,000 cases. Active cases now are in the range of 8.27 lakhs. Southern states are having 29 per cent of India's population but they account for 64 per cent of the active cases. Morbidity is also high in these states; some 64 per cent of India's Covid-linked deaths. MANY COLONIES IN THE RAIN BATTERED CITY REMAIN UNDERWATER

The D-gang ‘connection’ in Kerala gold smuggling

Hyderabad, Oct 15: Many colonies in Hyderabad and suburbs remained under water Thursday while Army and the National Disaster Response Force (NDRF) personnel continued rescue and relief work in the flood-hit areas.

Clear skies provided respite to the city battered by heavy rains in the intervening night of October 13-14 but the areas abutting overflowing lakes and nullas remained inundated while traffic on damaged highways was to be restored.

Personnel of Army, NDRF and Disaster Response Force (DRF) of Greater Hyderabad Municipal Corporation continued rescue and

relief works in the worst-affected areas. People trapped in marooned houses were being shifted to safe places through boats.

One of the worst floods in the city's history has so far claimed 19 lives while five others are missing. Colonies in Chandrayangutta in the old city of Hyderabad, Chaderghat and Moosarambagh on the banks of Musi river, Uppal and Vanasthalipuram on the city outskirts were still under the flood waters. Following release of surplus water from Himayat Sagar upstream, Musi river was flowing dangerously at Moosarambagh, flooding adjacent areas.

Officials were working to save Palke Cheru lake from breach at



Mailardevpally. Sand bags were arranged to strengthen the embankment. Ranga Reddy district collector Amoy Kumar and Cyberabad Police Commissioner VC Sajjanar were supervising the efforts.

People living in areas surrounding the lake were alerted to move to safe places. A part of the bund had breached following heavy rains Tuesday night, inundating Ali Nagar area.

Eight members of a family were washed away while trying to wade through flood water in Ali Nagar Wednesday. Bodies of three people were found while the search was on for others.

Some colonies in Manikonda area were also inundated due to an overflowing Firangi nala. With cellars of the buildings completely submerged, residents of the apartments were waiting for help.

Several colonies in Uppal, Boduppall, Ramanthapur, Peerzadiguda and Ghatkesar also

remained inundated.

Road connectivity to many areas in the city remained disrupted due to inundation. Traffic is also yet to be restored on the highways. Authorities were trying to repair Hyderabad-Bangalore highway which was badly damaged at Gaganpahad.

The state government has already declared two-day holiday Wednesday and Thursday to all private institutions, offices, non essential services within Outer Ring Road (ORR) with work from home advisory. Chief Minister K Chandrasekhar Rao will review the flood situation in Hyderabad and other parts of the state at a high-level meeting to be held later in the day.

The Chief Minister asked all the officials concerned to come prepared for the meeting, as the state government has to submit a report to the Centre on the loss caused due to heavy rains and flash floods in the state.

Kochi, Oct 15: In a major development in the Kerala gold smuggling case, the NIA has found links between one of the accused and India's most wanted underworld don Dawood Ibrahim Kaskar and his gang, a report said.

The National Investigation Agency probe has revealed that as one of the accused visited Tanzania, where the 1993 Mumbai accused has vast networks, to launch his diamond business and to smuggle firearms.

The submissions were made by the anti-terror probe agency in a Special NIA court here Wednesday.

"KT Ramees and M Sharafuddin visited Tanzania on several occasions and met one of Dawood's close aide Feroze 'Oasis' and discussed ways to smuggle firearms into India," an NIA official related to the probe told IANS.

The official said that Ramees visited Tanzania first in 2016 to start a diamond business there. He then also smuggled one kilo gold from Tanzania to the UAE in 2017.

Ramees was caught with 13 smuggled revolvers at the Kozhikode airport in November 2019 while returning from Dubai, he added.

Ramees had brought the guns for the Palakkad rifle club, it was alleged, however, the charge was denied by the rifle club.

Another NIA official said that they are checking all the details of Ramees, as he has been linked to

gold smuggling as well as firearms smuggling. The gold smuggling case first surfaced when PS Sarith, a former employee of the UAE Consulate here, was arrested by the Customs Department July 5 when he was allegedly facilitating the smuggling of 30 kg gold in a diplomatic baggage from Dubai to Thiruvananthapuram.

The case became murkier when Swapna Suresh, a former employee of the UAE Consulate and later employed with the Kerala IT Department, came to light. Her links stretched to the Chief Minister as she had links to M Sivasankar, Kerala's senior IAS official and secretary to Pinarayi Vijayan. She

later revealed that Sivasankar was her mentor.

After his links with Swapna surfaced, Vijayan first removed Sivasankar from the post of his secretary and also the State IT secretary and later suspended him from service.

While Suresh and her accomplice Sandip Nair, were arrested from their hideout in Bangalore five days later. A multi-agency team started probing the case and 30 people have been arrested so far. Besides the NIA, ED, DRI, Customs and Income Tax are also part of the investigation. The ED has questioned Kerala Higher Education Minister KT Jaleel in connection with this.

Hyderabad, Oct 15: Telangana has slashed the number of daily Covid-19 tests in the last few days which have resulted in fewer cases being reported, a report said.

During the last 24 hours ending 8 pm Wednesday the authorities conducted 38,895 tests against daily average of 55,000 to 60,000 samples tested over the last couple of months. There was no official word for conducting fewer tests.

As a result of the drop in the number of tests, the state is consistently reporting a daily count of less than 2,000 cases. Thursday, the state reported 1,432 positive cases.

The previous day, 40,056 tests were conducted. Only 30,000 tests were conducted Saturday-Sunday.

The latest infections rose the cumulative tally to 2,17,670. Of this 23,203 are active including 19,084 who are in home isolation.

The state continues to see more recoveries from Covid-19 than the new infections.

As many as 1,949 people recovered from the virus during the last 24 hours, taking the total number of recoveries to 1,93,218.

The state's recovery rate climbed further to 88.76 per cent against the national average of 87.3 per cent.

Eight more people succumbed to the virus during the period, pushing the death toll to 1,249.

The fatality rate remains at 0.57 per cent against the national average of 1.5 per cent.

Officials said the percentage of deaths due to Covid-19 was 44.96 while the remaining 55.04 had comorbidities.

Of 38,895 samples tested, 17,113 were primary and 4,667 secondary. According to a media bulletin from

the office of the director of public health and family welfare, 36,362 tests were conducted in government-run laboratories and 2,533 in private.

Seventeen government-run laboratories, 44 private laboratories and 1,076 Rapid Antigen test centres are conducting the tests.

Samples tested per million population ratio rose further to 99,490. The daily testing target for the state is 5,600 per day as per the World Health Organisation (WHO) benchmark of 140 per million per day.

Out of 2,17,670 total positive cases so far, 70 per cent (1,52,369) were asymptomatic while the remaining 30 per cent (65,301) were symptomatic. Of the new cases registered during the last 24 hours, Greater Hyderabad accounted for 244 cases. Medchal Malkajigiri district recorded second highest number of cases at 115 followed by Bhadradi Kothagudem (99), Khammam (91), Rangareddy (88), Karimnagar (74), Nalgonda (74), Khammam (52) and Suryapet (53).

The data shows that 63.9 per cent of those tested positive so far are in the age group of 21-50 years while 22.91 are above 51 years of age. Those below 20 years are 13.18 per cent.

Officials said 64.64 per cent of those tested positive were male while the remaining 38.37 per cent were female.

The data also shows most of the beds in government and private hospitals treating Covid patients are vacant.

Out of total 8,792 beds in 62 government-run Covid hospitals, 7,095 are vacant.

A total 228 private hospitals treating Covid patients have 9,037 beds, of which 6,615 are vacant.

Munderi School built at a cost of Rs1.20 crore, scheduled for 10.15 am by Gandhi did not happen as the district administration did not give it clearance.

"70 per cent of the funds for this new school building came under the Central alloca-

tion and the rest came from the state government. The local body at the location is ruled by the Left and its chairperson wrote to Gandhi and asked for his time. Gandhi said he will be able to do it October 15 and it was fixed," said Balakrishnan.

"But the district administration called him up and said that since protocols have to be followed and the State Education Minister and others have to be informed, it has to be cancelled. We had no other option but to call off all the arrangements made by the school Parents Teachers Association," added Balakrishnan, who is also a Congress legislator from the district. The local Congress party expressed their ire after the earlier planned inauguration was called off.

3 weeks after receiving Jnanpith, Mahakavi Akkitham passes away

Akkitham's literary works began to gain wide attention in the early 1950s

Thrissur, Oct 15: Renowned Malayalam poet and Jnanpith award winner Akkitham Achuthan Namboothiri, who is said to have heralded modernism in Malayalam poetry, died at a private hospital here Thursday.

He was 94.

A widower, the Mahakavi (great poet), as he was known, leaves two sons and four daughters.

Hospital sources said he was admitted for age-related ailments a couple of days ago and the end came at 8.10 am.

Popularly known as Akkitham, his 'Irupatham Noottandinte Ithihasam' (Epic of the 20th Century) is considered as one of the first truly modernist poems in Malayalam literature.

A popular verse—"Velicham dukhamanunni, thamasallo sukhapradam," which is roughly translated as "light brings sorrow, my child, darkness is bliss" is like a proverb for Keralites. It is also interpreted as "worldly knowledge is pain my child, ignorance is bliss."

He penned around 45 books, comprising poetry anthologies, plays and short stories including 'Balidarsanam' (The Vision of Bali), 'Arangettam', 'Nimisha Kshetram', 'Idinju Polinja Lokam', 'Amrita Ghatika', and 'Kalikkottilil' and many more.

Akkitham had bagged the Jnanpith award, the highest literary award, in 2019 and is the sixth



writer to bring the honour for Malayalam literature.

Due to the Covid-19 pandemic, the award was presented to him last month at a function at his home in Kumaranalloor in Palakkad district. Among the numerous awards which came his way are Padma Shri, Ezhuthachan Award, Kendra Sahitya Akademi Award, Kerala Sahitya Akademi Award for Poetry, Odakkuzhal Award, Vallathol Award and Vayalar Award.

Born March 18, 1926 in a traditional Namboothiri family, Akkitham, was a true Gandhian, social reformer and journalist, and had worked as an editor in various magazines before joining the All India Radio (AIR) in 1956 at Kozhikode.

Akkitham's wife, Sreedevi Antharjanam, had passed away last year, aged 85.

Kerala Governor Arif Mohammed Khan and Chief Minister Pinarayi Vijayan ex-

pressed grief over the death.

Condoling the death, Khan said the poet's demise was a loss for India literature and Malayalam poetry.

"...With roots firm on Indian thought, he played a role in bringing modern sensibility to Malayalam poetry...He represented the loftiest ideals of poetic tradition, with utmost respect for Indian values & tradition deeply reflecting in his poems (sic)," Khan tweeted.

Vijayan said Akkitham was a great poet who stood for sublime human love.

"He was a poet who wished for unconditional love to be the foundation for the universe and translated that wish into his poetry."

Considered synonymous with an era in Malayalam literary history, Akkitham ushered in modernity into Malayalam poetry through his works, 'Irupatham Noottandinte Ithihasam' and 'Idinju Polinja Lokam,'" Vijayan said in his condolence message.

Heavy rains cause collapse of T'gana's historic Shahpur fort

Hyderabad, Oct 15: A large portion of the historic Shahpur fort in Telangana's Jangaon district collapsed Thursday.

Three houses were damaged under the debris of the fort. However, no one was injured as the residents had vacated the house after cracks in the fort widened following heavy rains during the last few days.

A video of the fort's collapse went viral on social media. Locals can be heard screaming as the dilapidated structure caved in.

Popular as Qila Shahpur, the

hill fort was located in Raghunathapalli mandal of Jangaon district.

It was built in 1690s by Sardar Sarvai Papanna Goud, who along with nearly 4,000 men had attacked Warangal in 1708 after the death of Mughal emperor Aurangzeb.

It is said that the fort was blown up by the forces led by Dil Khan, then deputy governor Hyderabad. Papanna Goud later rebuilt the fort.

According to historians, Papanna Goud and his men were besieged four times while occupying the fort. He was captured and executed in 1710.

CM asks Keralites to make the state carbon-neutral by setting up greenhouses

Thiruvananthapuram, Oct 15: Kerala Chief Minister Pinarayi Vijayan said the state should transform itself into a carbon-neutral region by setting up greenhouses.

Inaugurating through video conference the 1,261st greenhouse set up here by the Haritha Kerala Mission, he said though the target was to construct 1,000 greenhouses, it was an achievement that 1,261 had been set up in an area of over 454 acres.

"Greenhouses are our great contribution to future generations. Every year, more greenhouses should be set up in this manner and it will be possible with the co-operation of local bodies and the people," he said.

Thousand more greenhouses are to be established. If there is no public space, interested persons should be encouraged to put up greenhouses in their place, added Vijayan. Each greenhouse was set

up by selecting plants suitable for each area.

The first greenhouse containing rare herbaceous plants was established at Vengode, Pothencode, in Thiruvananthapuram with the help of the botanical garden at Palode.

In some places, there were only bamboo shoots and in the backwaters and beaches, mangroves and allied trees were planted in the greenhouses.

The stalks have expanded and green stems have come creating a visible change in the habitat in the last one year.

The greenhouses of the mangroves in Kumarakom have made a positive difference to the fishing ecosystem there.

The plants are maintained for three years as part of the project, he said. CPI leader and MLA C Divakaran planted a tree-sapling at the 1,261st greenhouse at Nedumangad block in Thiruvananthapuram district.

China has no locus standi to comment on Ladakh, J&K: MEA

New Delhi, Oct 15: India Thursday asserted that the union territories of Jammu and Kashmir and Ladakh "have been, are, and would" remain an integral part of the country, insisting that China has no locus standi to comment on its internal matters.

The comments by External Affairs Ministry Spokesperson Anurag Srivastava came in response to China's contention that it does not recognise the union territory of Ladakh as well as the state of Arunachal Pradesh. "Our position on this has always been clear and consistent."

"The union territories of Jammu and Kashmir and Ladakh have been, are, and would remain an integral part of India. China has no locus standi to comment on India's internal matters," Srivastava said at a media briefing. "We hope that countries will not comment on India's internal matters, as much as they expect the same of others," he added. Srivastava also said that Arunachal Pradesh is an "integral and inalienable" part of India. "Our position on Arunachal Pradesh has also been made clear several



times. Arunachal Pradesh is an integral and inalienable part of India. This fact has also been clearly conveyed to the Chinese side on several occasions, including at the highest level," he added. After Defence Minister Rajnath Singh inaugurated a number of new bridges in certain border areas Monday, a Chinese foreign ministry spokesperson said China does not recognise the Ladakh union territory 'illegally set up' by India as well as Arunachal Pradesh.

The Chinese spokesperson had also claimed that development of border infrastructure by India was the 'root cause' of tensions between the two countries. On the border standoff in eastern Ladakh and the outcome of the bilateral military talks, Srivastava referred to a

joint press statement issued by the two armies after their dialogue October 12, calling the meeting "positive and constructive". "Disengagement is a complex process that requires redeployment of troops by each side towards their regular posts on their respective sides of the LAC," Srivastava said. "To achieve this, the two sides will maintain the current momentum of communications based on the guidance of our leadership to not to turn differences into disputes and work towards a mutually acceptable solution for complete disengagement in all the friction areas along the Line of Actual Control(LAC) and restoration of peace and tranquility in the India-China border areas," he added.

Fresh SOPs for cultural events

New Delhi, Oct 15: The Culture Ministry released a new set of SOPs Thursday for organising cultural programmes with adequate safety measures, making it mandatory for artistes and crew to furnish a valid Covid-negative test certificate, barring entry of visitors and patrons without masks and allowing seating on only 50 per cent seats for the audience.

The Standard Operating Procedures are to be followed by the management of theatres and host institutions as well as the entertainment or creative agencies, artistes, crew or any other person who hire an auditorium or any other open/closed space for cultural events, the ministry said. It said digital no-contact transactions should be preferred to issue, verify, or pay for tickets, and contact details of all customers should be taken at the time of booking of tickets to facilitate contact-tracing. For viewers, the guidelines said, wearing masks is mandatory and physical distancing of at least 6 feet is to be followed at all times. For the organisers, the SOP included sanitisation of venue before and after the event, availability of hand sanitisers, preferably in the touch-free mode, at entry and exit points as well as common areas within the premises.

IAF team in France to review Rafale project

New Delhi, Oct 15: As it prepares to induct a second batch of Rafale jets, the Indian Air Force has sent a team of officials to France to oversee the logistical issues and review the training of a hand-picked group of pilots at the Saint-Dizier air base there, officials said Thursday.

The second batch of four Rafale jets is expected to arrive in India in the next four weeks. The first batch of five Rafale jets arrived in India July 29, nearly four years after India signed an inter-governmental agreement with France to procure 36 of these aircraft at a cost of Rs 59,000 crore.

Several teams from the IAF have visited France since January to oversee the progress of the Rafale project including integration of India-specific enhancements and weapons systems, the officials said. The IAF's Rafale project management team has an office in Paris headed by a Group Captain-rank officer. The team is tasked with overseeing the production timelines as well as coordinating training of the crew.

A team of experts headed by assistant chief of air staff (projects) reached France earlier this week to coordinate logistical issues as well



as training of pilots and technicians, said the officials. The first batch of Rafale jets was finally inducted into the IAF September 10. Chief of Air Staff Air Chief Marshal RKS Bhadauria on October 5 said the induction of all 36 Rafale jets will be completed by 2023.

Ten Rafale jets have been delivered to India so far and five of them stayed back in France for imparting training to IAF pilots. Known for their air-superiority and precision strikes, the Rafale jets are India's first major acquisition of fighter planes in 23 year after the Sukhoi jets were imported from Russia.

The newly inducted fleet has been carrying out sorties in eastern Ladakh where Indian and Chinese troops are engaged in a bitter border row for over five months. A group of IAF pilots is currently undergoing training on Rafale jets at the Saint-Dizier air-base in eastern France.

Lokpal has no power to review its order

New Delhi, Oct 15: Anti-corruption ombudsman Lokpal has held that review petitions regarding an order passed by its bench cannot be entertained due to the absence of related provisions in the law governing it, according to an official order.

The move comes after the Lokpal witnessed an increasing number of complainants desirous of a "reconsideration" or "review" of the orders passed by it. A committee comprising three Lokpal members -- Justices Abhilasha Kumari, D K Jain and I P Gautam -- was constituted to look into the aspect of recommending a policy regarding requests for a review of an order passed by the bench.

The committee, which was formed by Lokpal chairperson Pinaki Chandra Ghose, submitted its reports October 6, 2020. "The committee has opined that in the absence of any express and substantive power of review in the Lokpal and Lokayuktas Act, 2013, a request for review of an order passed by a bench of the Lokpal of India cannot be entertained," said the order issued Monday.

Hence, it is notified that review petitions regarding an order passed by the bench of Lokpal of India will not be entertained,

it said. The committee, in its report, said that the central government may be requested to consider the inclusion of power of review in the Lokpal and Lokayuktas Act. In view of the fact that a large number of complainants are filing applications for review of an order, the lack of an express power of review in the Act may act as a deterrent to the dispensation of justice, it said. "Therefore, in order to ensure that no injustice has occurred to the complainant and in the interest of justice, it may be in the fitness of things to request the government of India, at an appropriate stage, to consider the inclusion of the power of review on appropriate grounds, in the Lokpal and Lokayuktas Act 2013," the report said.

The institution of Lokpal and Lokayuktas has been established under the Lokpal and Lokayuktas Act, 2013 to enquire into allegations of corruption against certain public functionaries. The jurisdiction of review can only be derived from the statute and thus, if any order of review is passed, in the absence of any statutory provision empowering the same, it would be a nullity, being without jurisdiction, said the panel, which had held its meeting September 29, citing a Supreme Court order.

CBI refutes closure of SSR case

New Delhi, Oct 15: Amid some media reports that the Central Bureau of Investigation (CBI) is likely to file a closure report in Bollywood actor Sushant Singh Rajput's death case, the federal agency Thursday refuted the claims and said that such reports are "erroneous" and the investigation is still continuing.

CBI spokesperson RK Gaur said in a statement. "CBI continues to investigate the death of Sushant. There are certain speculative reports in the media that the CBI has reached a conclusion. It may be reiterated that these reports are speculative and erroneous." The remarks came amid media speculation that the agency will be filing a closure report soon.

Earlier, the forensic team of the All India Institute of Medical



Sciences (AIIMS) led by Sudhir Gupta had ruled out the murder angle in the actor's death case. The CBI had registered a case on August 6 after a notification from the Centre on the request of the Bihar government based on a complaint filed by Sushant's father KK Singh in Patna.

The CBI sleuths, alongn with the AIIMS forensic team, visited

Mumbai August 20, a day after the Supreme Court gave its nod for a federal agency probe. The CBI team recorded the statements of Sushant's girlfriend Rhea Chakraborty, her brother Showik, the late actor's house manager Samuel Miranda, flatmate Siddharth Pithani, personal staff Neeraj Singh, Keshav Bachane and Dipesh Sawant, Sushant's former manager Shruti Modi, talent manager Jaya Saha and several others. Sushant was found dead in his Bandra's apartment June 14. Besides the CBI, the Enforcement Directorate and the Narcotics Control Bureau are also probing the money laundering and drugs angle in connection with the actor's death, respectively. Rhea was arrested by the NCB in a drugs related case. She was granted bail after spending 28 days in Byculla jail, while her brother Showik is still lodged in the jail.

it comes to keeping ourselves healthy and safe. Handwashing is also one of the key cornerstones of Covid-19 prevention," said Dr Poonam Khetrapal Singh, Regional Director, WHO South-East Asia Region. 'nCoV doubling time improves'

The doubling time of the coronavirus infection has sharply improved from 25.5 days in mid-August to nearly 73 days now, the Health ministry said on Thursday. Doubling time for COVID-19 is the number of days it takes for the count of cases to double. In a statement, the Health ministry said 81,514 new recoveries were added in the last 24 hour. With this, the total number of recoveries are nearly 64 Lakh (63,83,441). "India has come a long way from registering a doubling rate of 25.5 days in mid August to now registering a doubling rate of nearly 73 days (72.8 days)," it said.

Flood situation grim in K'taka

Bangalore, Oct 15: The flood situation in Karnataka worsened further Thursday with several areas in the northern parts of the state inundated due to torrential rains and release of water from major dams.

According to the Karnataka State Natural Disaster Management Centre, the floodgates of all the major dams have been opened resulting in water gushing into villages and formation of islands at different places. Dams which were filled to the brim were Linganamakki, Supa, Varahi, Harangi, Hemavathi, Krishna Raja Sagar, Kabini, Bhadra, Tungabhadra, Ghataprabha, Malaprabha, Almatti and Narayanapura.

An overflowing river Bhima has wreaked havoc in Kalaburagi and Yadgir districts whereas water level in Krishna river at Devasagur in Raichur district is rising at an alarming level. The Central Water

Commission too warned that River Bhima at Deongaon Bridge in Afzalpur Taluk of Kalaburagi was rising and "is expected to cross danger level by this evening".

The river in Yadgir district was expected to go very near high flood level by Thursday afternoon. The Commission has also stated that though the water level of River Kagna at Malkhed in Kalaburagi District was receding, it continued to flow at an alarming level.

According to sources in the Karnataka Disaster Management Authority, as many as 515 animals lost their lives while 4,782 people have been shifted to 36 relief camps opened by the district administration.

The NDRF team rescued people stranded at Haragadde, Karakalagadde in Raichur in the temporary island due to the sudden release of water from the dam across Krishna river due to the rising level.

DELHI-NCR SHROUDED BY HAZE

New Delhi, Oct 15: The national capital's air quality hit an eight-month low on Thursday with stubble burning accounting for only six per cent of the city's PM2.5 concentration, according to government agencies. NASA's satellite imagery showed a large cluster

of farm fires near Amritsar, Patiala, Tarn Taran, and Firozpur in Punjab, and Ambala and Rajpura in Haryana. Union Environment Minister Prakash Javadekar has urged the Punjab government to curb stubble burning.

The Ministry of Earth Sciences' air quality monitor, SAFAR, said the wind direction was partly

favourable for the transport of smoke from farm fires and "hence, an increase in contribution in Delhi's PM 2.5 (concentration) is expected". Delhi recorded a 24-hour average air quality index (AQI) of 312. The last time the air quality hit such a poor level was in February with an AQI 320. The 24-hour average AQI was 276 on Wednesday, which falls in the 'poor' category. It was 300 Tuesday, 261 on Monday, 216 Sunday and 221 on Saturday. Javadekar flagged off 50 inspection teams of the Central Pollution Control Board (CPCB) for field visits in Delhi-NCR to keep a watch on pollution hot spots during the winter season even as a layer of smoky haze lingered over the region with the air quality hitting 'very poor' levels Thursday.

Theatres open after seven months in nCoV shadow

New Delhi, Oct 15: Cinemas in several parts of the country opened after almost seven months on Thursday, ushering in a new era of 'contactless' movie watching in the shadow of a pandemic with alternate seating, 50 per cent capacity and packaged snacks.

While theatres and multiplexes will remain closed in states like Maharashtra, Tamil Nadu, Kerala and Chhattisgarh, they will open in several places, including Delhi and parts of Madhya Pradesh and Gujarat, with stringent dos and don'ts in keeping with the new COVID-19 normal.

While PVR will resume commercial screenings on Friday, Cinepolis and INOX started showing films from Thursday with an emphasis on safety measures, including stringent sanitising and social distancing. "Yes, you heard that right! We are open now! See you at the big screen! Cinemas will not



be functional in a few states until further notice," Cinepolis India said in a tweet.

"Sanitisation and deep cleaning with WHO recommended chemicals is done at regular intervals to keep your surroundings safe," the tweet further read. PVR Cinemas, India's largest film exhibitor with 845 screens in 176 properties across 71 cities, on Wednesday said 10 states and four union territories have given their go-ahead for the re-opening of cinemas.

Accordingly, PVR started operations in 487 screens. The hope is that other states will soon give their green signal too. The Ministry of Home Affairs allowed theatres to reopen from Thursday with up to 50 per cent of their seating capacity. They have to strictly follow the central government's Standard operating procedures (SOPs).

The SOPs mandated by the Union government include one seat distance in halls, 50 per cent capacity, masks at all time, proper ventilation

and air conditioner temperature settings at above 23 degrees Celsius. 5,600 Afghan families displaced

Lashkar Gah: Renewed fighting in southern Afghanistan's Helmand province between Taliban insurgents and government forces has forced more than 5,600 families to flee their homes, local officials said Thursday. Thailand declares emergency in Bangkok amid protests

Bangkok, Oct 15: Thai authorities declared a strict new state of emergency for the capital Thursday, a day after a student-led protest against the country's traditional establishment saw an extraordinary moment in which demonstrators heckled a royal motorcade.

After the pre-dawn declaration, riot police moved in to clear out demonstrators who after a day of rallies and confrontation had gathered outside Prime Minister Prayuth Chan-ocha's office to push their demands, which include the former general's stepping down, constitutional changes and reform of the monarchy.

Several top leaders of the protest movement were taken into custody,

with one later declaring on his Facebook page that he had been denied access to a lawyer and was being forced onto a helicopter and taken to a city in the country's north.

Police said they had made 22 arrests. The text of the emergency declaration said it was needed because "certain groups of perpetrators intended to instigate an untoward incident and movement in the Bangkok area by way of various methods and via different channels, including causing obstruction to the royal motorcade."

The protest Wednesday in Bangkok's historic district, not far from glittering temples and royal palaces, was the third major gathering by student-led activists who have been pushing the boundaries

of what is considered acceptable — and legal — language by publicly questioning the role of Thailand's monarchy in the nation's power structure.

Thailand's royal family has long been considered sacrosanct and a pillar of Thai identity. King Maha Vajiralongkorn and other key member of the royal family are protected by a lese majeste law that has regularly been used to silence critics who risk up to 15 years in prison if deemed to have insulted the institution.

The protest — held on the anniversary of a 1973 student-led uprising against a military dictatorship — was complicated by the presence of royalist counter protesters who had gathered both to show support for the government and to greet the royal family as they travelled to and from a religious ceremony in the area.

That led to a moment captured in photos and video that circulated widely on social media in which what appeared to be protesters gestured and shouted just meters (feet) from the royal motorcade. Such actions are unprecedented in Thailand, where those waiting for a royal motorcade regularly sit on the ground or prostrate themselves.

Some experts say a line may have been crossed.

Kyrgyz Prez steps down after unrest

Bishkek, Oct 15: Following weeks of unrest that resulted from a disputed election, Kyrgyz President Sooronbai Jeenbekov Thursday resigned, saying that he made the decision in order to restore stability in the country. In a statement, the Jeenbekov said: "I do not want to go down in Kyrgyzstan's history as a President who shed blood and shot at his own citizens."

"The military and security forces will be obliged to use their weapons to protect the state residence. 'Blood will be inevitably shed. I urge both sides not to fall for provocations.'"

The President also called on newly-appointed Prime Minister Sadyr Japarov and other opposition politicians to "take their supporters away" from the capital Bishkek

in order to restore peace in the city, the BBC reported.

Jeenbekov is the fifth President of the Central Asian country, which gained independence from the Soviet Union in 1991. He came to power November 24, 2017.

Kyrgyzstan has been gripped by unrest sparked by allegations of vote buying and impropriety in the October 4 parliamentary elections, in which 16 political parties participated, Xinhua news agency.

Preliminary results showed that four parties crossed the 7% threshold to enter Parliament.

Some parties which failed to meet the threshold organized nationwide protests the next day, demanding the annulment of the elections and claiming gross violations. The protests led to clashes between the police and protesters.

London goes into stricter lockdown

London, Oct 15: London, the world's international financial capital, will enter a tighter COVID-19 lockdown from midnight Friday as Prime Minister Boris Johnson seeks to tackle a swiftly accelerating second coronavirus wave.

The respiratory pandemic, which emerged in China last year and has killed over a million people worldwide, is spreading in most parts of Britain, whose official death toll of 43,155 is the highest in Europe.

Anger, though, is rising over the economic, social and health costs of the biggest curtailment of freedoms since wartime. One former government adviser warned some people would have trouble clothing their children soon.

Health Secretary Matt Hancock said London, which has a population of 9 million, as well as the adjacent, heavily populated county of Essex, would be put on "high" alert level, up from "medium", at

one minute past midnight (23:01 GMT Friday).

The main impact of the move to "high" is that people cannot meet other households socially indoors in any setting, for example at home or in a restaurant. Travel should be reduced where possible, Hancock said.

"Things will get worse before they get better," Hancock said. "But I know that there are brighter skies and calmer seas ahead - that the ingenuity of science will find a way through and until then we must come together."

Britain's move to halt socialising in its capital means that London and Paris - Europe's two richest cities - are shortly to be living under the shadow of state-imposed restrictions as the second wave of the outbreak spreads through Europe.

President Emmanuel Macron announced night curfews for four weeks from Saturday in Paris and other major cities.

California heat wave prompts power shutdowns

San Francisco, Oct 15: More than 50,000 California utility customers were without power and others around the state were urged to conserve electricity Thursday amid a fall heat wave that brought another round of extreme wildfire danger.

The National Weather Service issued heat advisories through Friday for temperatures in the 90s and even triple digits in many parts of the state.



Red-flag warnings for extreme fire danger were in place for much of the San Francisco Bay Area where winds bringing hot, dry gusts of up to 55 mph (88.5 kph) were expected to pose a threat of sparking new blazes in a region that already has seen some of the worst wildfires in state history.

A brush fire erupted early Thursday near the inland Southern California city of Redlands, triggering a small evacuation as it grew to about 100 acres (40 hectares), but was about 30% contained before dawn. The Pacific Gas & Electric utility began shutting off power Wednesday evening to customers in portions of 24 counties, mainly in the Sierra Nevada and the San Francisco Bay Area.

France declares health emergency

Paris, Oct 15: The French government Wednesday declared a public health state of emergency, giving officials greater powers to impose new measures to contain the spread of COVID-19. "The COVID-19 epidemic constitutes a public health disaster which, by its character and its severity, puts at risk the health of the population," the government said in a statement announcing the state of emergency.

"It justifies the declaration of a state of emergency so that measures can be adopted ... which are strictly proportionate to the public health risks." The statement did not say what action the government would take, but the adoption of a state of emergency gives the authorities statutory powers to impose tough measures.

President Emmanuel Macron is expected to detail the measures being planned when he gives an



interview on national television at around 8 pm (1800 GMT) Wednesday.

French media reported that a night curfew between 9 pm and 6 am was one of the measures Macron would unveil. The French government previously declared a public health state of emergency in March this year, when hospitalisations caused by the epidemic were near their peak. At the time, the authorities used their extra powers to order people to stay at home except for essential work, buying food or taking one hour of daily exercise.

CURFEW IMPOSED

France will deploy 12,000 police officers to enforce a curfew that starts Friday night and plans to spend another 1 billion euros helping businesses hit by the new restrictions. French PM Jean Castex and other government ministers laid out new rules Thursday aimed at what he called a "sudden acceleration" of infections.

Interior Minister Gerald Darmanin says 12,000 police officers would be deployed between 9 pm and 6 am to enforce the new curfew, imposed in Paris and eight other cities.

'DUELING ELECTORS' POSE RISK OF US VOTE DEADLOCK

If early returns show a Trump lead, experts say he could press Republican-controlled legislatures to appoint electors favorable to him, claiming the initial vote count reflects the true outcome

Washington D.C.: The 2020 US presidential election could be the most closely contested in recent memory due to a deeply divided electorate and the possibility that President Donald Trump will challenge widely used mail-in ballots, claiming without evidence they are fraudulent.

Some election law experts are concerned the combination of factors could lead to a crisis in which both political parties claim to have won the same state, a phenomenon known as "dueling electors."

Below are details of how that might play out.

What are electors?

The US president is selected by 538 electors, known as the Electoral College, rather than the popular vote. Electors are apportioned among the states based on population and the popular vote in each state typically determines which candidate receives that state's electors.

The Constitution and the 1887 Electoral Count Act govern the counting of electoral votes and any related disputes. The electors will meet on Dec. 14 to cast their votes which are then counted by Congress on Jan. 6 in a process overseen by Vice President Mike Pence in his role as president of the Senate. **What are dueling electors?**



States with close contests between Republican Trump and his Democratic rival Joe Biden could produce competing slates of electors, one certified by the governors and the other by the legislature.

The risk of this happening is heightened in the battleground states of Michigan, North Carolina, Pennsylvania and Wisconsin, which have Democratic governors and Republican-controlled legislatures.

Some election law experts are concerned that an unprecedented volume of mailed-in votes and legal challenges will delay the outcome of the election for weeks, creating an extended period of uncertainty.

Trump has repeatedly said the election is rigged and made unfounded attacks on mail-in voting, which tends to favor Democrats.

If early returns show a Trump lead, experts say the president could press Republican-controlled legis-

latures to appoint electors favorable to him, claiming the initial vote count reflects the true outcome.

Governors in those same states could end up backing a separate slate of electors pledged to Biden if the final count showed the Democratic candidate had won.

Both sets of electors would meet and vote on Dec. 14 and the competing results would be sent to Congress.

Set of electors who would prevail

Both chambers could agree to accept one slate of electors, which would almost certainly put the matter to rest.

The chambers could also split, which is more likely if the Republicans retain control of the Senate and Democrats hold onto their House majority.

If lawmakers cannot agree on a set of electors, the country will find itself in uncharted territory.

The Electoral Count Act, often described by academics as "unintelligible," seems to favor the slate of electors certified by the state's governor, according to Ned Foley, a professor at Ohio State University Moritz College of Law.

But Foley notes that some scholars and an analysis by the Congressional Research Service have rejected that conclusion.

Import of ACs banned

New Delhi: The government Thursday banned imports of air conditioners with refrigerants with a view to promote domestic manufacturing and cut imports of non-essential items. "Import policy of air conditioners with refrigerants ...is amended from free to prohibited," directorate general of foreign trade said in a notification. The government is taking steps to promote domestic manufacturing and reduce import bill of non-essential goods.

Lendingkart's income doubles

New Delhi: Fintech company Lendingkart Thursday said it has disbursed funds worth over ₹2,500 crore to micro and small enterprises, and its gross income increased by 113 per cent to ₹465 crore in FY20 over the previous fiscal. Lendingkart Finance Ltd (Lendingkart group's NBFC arm) disbursed about 53,000 loans in FY20, about 85 per cent increase over the last year, it said.

Multiplexes roll out offers

New Delhi: Multiplexes and their partners are rolling out a number of offers to woo film goers and rev up their business that fell silent for seven months on coronavirus pandemic woes. Movie halls have reopened or are reopening in several places, including the national capital and parts of Madhya Pradesh, this week, with stringent dos and don'ts in keeping with COVID-19-triggered new normal ways.

Toyota rolls out special offers

New Delhi: Toyota Kirloskar Motor (TKM) Thursday said it has launched special offers for salaried people from both government and private organisations, ahead of festive season. As part of the initiative, the company is providing flexible finance options, including a three-month EMI (equated monthly instalment) holiday, to prospective customers. "At Toyota, we always look for ways to enable that big purchase decision with attractive offers for different segments of buyers," TKM Senior Vice-President (Sales and Service) Naveen Soni said in a statement.

GST SHORTFALL

New Delhi, Oct 15: The Central government will borrow up to ₹1.1 lakh crore on behalf of the states to bridge the shortfall in GST collections, the Finance Ministry said Thursday. A slowdown in the economy since last fiscal has resulted in a drop in the Goods and Services Tax (GST) collections, upsetting the budgets of states which had given up their right to levy local taxes such as sales tax or VAT when GST was introduced in July 2017.

To make up for the shortfall, borrowing from the market was proposed.

In a statement, the Union Finance Ministry said states were offered a special window to borrow ₹1.1 lakh crore over and above their existing limits, to bridge the shortfall. "Under the Special Window, the estimated shortfall of ₹1.1 lakh crore (assuming all States join) will be borrowed by Government of India in appropriate tranches," the statement said. "The amount so borrowed will be passed on to the States as a back-to-back loan in lieu of GST Compensation Cess releases."

Jio, BSNL add new users in July: TRAI

Bhubaneswar, Oct 15: The telecom service providers Reliance Jio and state-owned BSNL are only operators who added new subscribers during the month of July in Odisha.

As per latest mobile subscriber data released by Telecom Regulatory Authority of India (TRAI), Jio added over 2.15 lakh new subscribers in July while BSNL added 41,005 new subscribers in same month in the state.

On the other hand, Vodafone Idea lost over 90,000 subscribers in the state followed by Bharti Airtel which lost over 41,000 subscribers during the same period. TRAI's report said.

With continual addition, Reliance Jio further consolidated its top position as the most preferred digital service provider in Odisha. Also, Jio now holds nearly 40% customer market share in Odisha and is the market leader with highest customer and revenue market share in the state.

Nationally, Jio continued adding millions of new subscribers and became the first digital service provider in the country to surpass 40 crores, as per the data released by TRAI for July 2020.

Also, as per the latest 4G speed chart published by TRAI on its MySpeed portal, Jio has again topped in 4G download speed chart with 19.3 Mbps download speed in September, which is more than 2.5 times than Bharti Airtel which has 7.5 Mbps download speed in September.

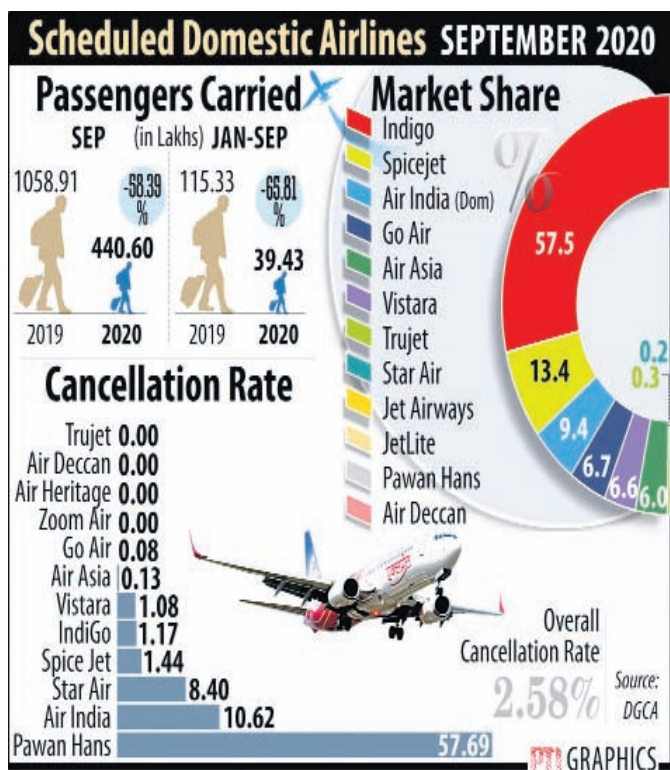
Exports turn positive in Sept, up 6% at \$27.58 bn

New Delhi, Oct 15: After contracting for six straight months, India's exports rose 5.99% to \$27.58 billion in September on account of growth in shipments of drugs and pharmaceuticals and readymade garments, as per the government data released Thursday. Exports stood at \$26.02 billion in September 2019.

The country's imports contracted 19.6% to \$30.31 billion in September. It was \$37.69 billion in the same month last year. The trade deficit narrowed to \$2.72 billion, compared to a shortfall of \$11.67 billion in the year ago-month.

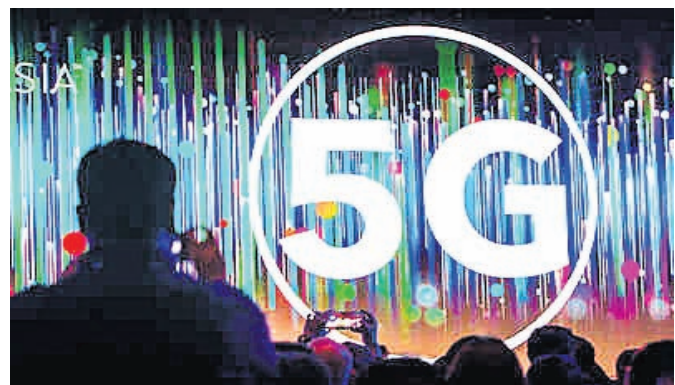

DoT urges space department, defence to vacate spectrum

New Delhi, Oct 15: The Department of Telecom (DoT) has urged the space department and defence ministry to vacate airwaves in the medium and high range spectrum bands for rolling out 5G services, according to sources. The issue was discussed in a meeting of a committee formed under the chairmanship of Cabinet Secretary Rajiv Gauba to resolve spectrum related issues, they added.

Differences among the DoT, Department of Space (DoS) and the defence ministry have led to delay in rollout of 5G services in the country.

The government had set a target to launch 5G services by 2020 but sources said the auction of spectrum can be held only in early 2021 if the issues are resolved in time.

The DoT has requested the defence ministry to vacate 100 megahertz (MHz) of spectrum in the frequency band of 3300-3400 Mhz and use frequencies in the 3000-3100 Mhz band.

It has urged the DoS to vacate spectrum in the frequency band of 3600-3700 Mhz, the sources said.

"The DoT is now looking for 400 Mhz of contiguous spectrum in the medium band which can be efficiently utilised by telecom operators to meet standard broadband speed for 5G services," a government source told PTI.

E-mailed queries sent to the DoT, DoS and the defence ministry in this regard did not elicit an immediate response.

The Telecom Regulatory Authority of India (Trai) has given price recommendation only on spectrum in the 3300-3600 Mhz band for the next round of auction based on reference sought by the DoT.

Trai has recommended a price of ₹492 crore per megahertz for spectrum in the 3300-3600 Mhz band.

Telecom operators interested in buying radiowaves for 5G services will have to shell out a minimum of ₹9,840 crore on pan-India basis to buy spectrum in the 3,300-3,600 Mhz band as Trai has suggested that it "should be put to auction in the block size of 20 MHz".

According to technical experts, a telecom operator will need at least 80-100 Mhz of spectrum in the 3300-3600 Mhz band to achieve 5G standard.

Bharti Airtel has said it will not bid for this spectrum at the Trai-recommended price as companies will need to shell out about ₹50,000 crore to acquire decent quantity of frequencies in this band.

"The scope of the committee under the cabinet secretary has now been expanded to discuss all spectrum bands including V-band that can be used for mobile services and their prices," another source said.

STATE GOVT TO ESTABLISH TECHNOLOGY CENTRE AT RSP

Bhubaneswar, Oct 15: Principal Secretary of State MSME department Satyabrata Sahu Thursday stated that the Government of Odisha has approved for the establishment of a technology centre at Rourkela Steel Plant (RSP).

and RCC also attended the meeting. Among others they put forth their grievances under that GCM procurement done by RSP concession to be given to the local MSMEs as per their requirement, purchases items from local MSMEs, and entry pass into RSP.

RSP authorities assured their cooperation on the grievances of MSMEs. Principal Secretary requested RSP to facilitate the local MSMEs so that their economic conditions may improve amid the pandemic.

Director of industry department was requested to list out the grievances of the MSMEs and circulates it to RSP to sort out within a time frame and review the same after three months in mid January, 2021.

World facing new Bretton Woods moment: IMF MD

Washington, Oct 15: Facing the twin task of fighting the coronavirus pandemic today and building a better tomorrow, the world is experiencing a new Bretton Woods moment, IMF Managing Director Kristalina Georgieva said Thursday. Addressing the annual meeting of the International Monetary Fund's Board of Governors, she said that what was true at Bretton Woods, when allies at the end of World War II gathered for a conference to create the institutions that would use economic cooperation to prevent future conflicts, remains true today.

"Today we face a new Bretton Woods moment. A pandemic that has already cost more than a million lives. An economic calamity that will make the world economy 4.4%

smaller this year and strip an estimated \$11 trillion of output by next year. And untold human desperation in the face of huge disruption and rising poverty for the first time in decades," she said.

"Once again, we face two massive tasks: to fight the crisis today and build a better tomorrow," she said.

Prudent macroeconomic policies and strong institutions are critical for growth, jobs and improved living standards, she said.

Strong medium-term frameworks for monetary, fiscal and financial policies, as well as reforms to boost trade, competitiveness and productivity can help create confidence for policy action now while building much-needed resilience for the future, she added.

"We know what action must be taken right now. A durable eco-

conomic recovery is only possible if we beat the pandemic.

Health measures must remain a priority. I urge you to support production and distribution of effective therapies and vaccines to ensure that all countries have access,"

Georgieva said.

She urged countries to continue support for workers and businesses until a durable exit from the health crisis.

"We have seen global fiscal actions of \$12 trillion. Major central banks have expanded balance sheets by \$7.5 trillion. These synchronised measures have prevented the destructive macro financial feedback we saw in previous crises," she said.

"But almost all countries are still hurting, especially emerging market and developing economies. And while the global banking system entered the crisis with high capital and liquidity buffers, there is a weak tail of banks in many in emerging markets. We must take measures to prevent the build-up of financial risks over the medium term," she said.

The IMF expects 2021 debt lev-

els to go up significantly – to around 125% of GDP in advanced economies, 65% of GDP in emerging markets; and 50% of GDP in low-income countries, Georgieva further said.

The fund is providing debt relief to its poorest members and, with the World Bank, they support extension by the G20 of the Debt Service Suspension Initiative.

"Beyond this, where debt is unsustainable, it should be restructured without delay. We should move towards greater debt transparency and enhanced creditor coordination. I am encouraged by G-20 discussions on a Common framework for Sovereign Debt Resolution as well as on our call for improving the architecture for sovereign debt resolution, including private sector participation," she said.

KXIP WIN LAST-BALL THRILLER

Sharjah, Oct 15: The 'Universe Boss' Chris Gayle (53, 45b, 1x4, 5x6) sent warning to the opposition teams with his trademark innings as Kings XI Punjab (KXIP) secured an eight wicket victory over Royal Challengers Bangalore (RCB) in their IPL encounter here, Thursday.

KXIP almost made a mess of what could have been an easy task. In spite of having nine wickets in hand and needing only two off the final over, bowled by Yuzvendra Chahal (1/35), it all came down to one off the final ball after Gayle was un out off the penultimate delivery while searching for a quick single. However, Nicolas Pooran completed the task with a six, which just cleared the long-on boundary.

Chasing 172, KXIP stated with a bang as skipper KL Rahul (61 n o, 49b, 1x4, 5x6) and Mayank Agarwal (45, 25b, 4x4, 3x6) added 78 runs inside 7.5 overs before the latter's departure in the final ball of the eighth over: Chahal broke the stand casting Mayank.

Then it was all Gayle and Rahul. Gayle started his innings cautiously before unleashing his power, what the KXIP fans were waiting for: Both Rahul and Gayle were at their best playing shots all around the ground. The duo added 93 runs for the second wicket.

Earlier, KXIP put up a disciplined effort with the bowl to restrict RCB to 171/6 in their must-win IPL match. Skipper Virat Kohli top-scored with 48 off 39 balls in his 200th game for RCB but it was Chris

Morris' 25 off 8 balls in the death overs that took the team to a competitive score.

The final over bowled by Mohammad Shami (2/45) went for 24 runs. Notwithstanding Shami's wayward 20th over, it was a much-improved bowling effort from a team who have been leaking runs in the death overs game after game. KXIP conceded only 25 runs from over 16-19 before Morris and Isuru Udana hammered Shami for three sixes.

After Kohli chose to bat, KXIP experimented by opening the bowling with Glenn Maxwell (0/28). Both the openers - Devdutt Padikkal (18) and Aaron Finch (20) - could not build on their starts.

Padikkal was foxed by a slower one from left-arm pacer Arshdeep Singh, while Finch missed a fast leg-break

from Murugan Ashwin (2/23), leaving RCB at 62/2 in the seventh over.

With Kohli looking good at the other end, AB de Villiers was expected to come in at his usual number four spot but with two leg-spinners in operation, left-handed batsman Washington Sundar and Shivam Dube were sent ahead of the South African.

Following Dube's dismissal in the 15th over, De Villiers finally joined Kohli for the late assault, which was eventually provided by Morris.

MI favourites against KKR

Abu Dhabi, Oct 15: An explosive batting line-up and a lethal-at-death bowling attack will give defending champions Mumbai Indians (MI) a definitive edge over Kolkata Knight Riders (KKR) when the two teams clash in an IPL game here Friday.

The defending champions are on a roll having won their last four games, while there are problems aplenty for KKR, who were decimated by the Royal Challengers Bangalore by 82 runs in their last game.

Mumbai Indians are thus unlikely to tinker with their playing XI. For KKR, questions remain as to whether their key spinner Sunil Narine, who has been once reported for suspect bowling action, will play or not. He had missed the game against RCB even as KKR hoped for an 'early resolution' to the issues surrounding his controversial action.

In the event of Narine missing out again, Mumbai will fancy their chances even more at the Sheikh Zayed stadium, where skipper Rohit Sharma has scored both his half-centuries this season.

Sharma (216 runs), on his day, can pummel any attack to submission and particularly enjoys playing against Kolkata. When the two teams met last, Mumbai rode on his belligerent 80 to register a 49-run win.

Apart from Sharma, the Mumbai top and middle-order is in good form - be it Quinton De Kock (191 runs) or Suryakumar Yadav (233 runs), who would like to continue in the same vein.

Ishan Kishan (186 runs) underlined his potential with a blistering 99 against RCB, but the Jharkhand player needs to convert his starts into big scores



to make his presence felt.

Mumbai Indians coach Mahela Jayawardene would be pleased with the likes of Hardik Pandya and swashbuckling Kieron Pollard, who have been launching into the opposition attack with their big-hitting prowess along with Krunal Pandya. Given the trio's abilities, they can rip apart the KKR attack, especially one sans Narine.

On the bowling front too, Mumbai looks a settled unit with Trent Boult and Jasprit Bumrah providing early breakthroughs. They are complemented by Australian James Pattinson and the trio has accounted for 31 wickets. Spinners Rahul Chahar and Krunal will be again looking to contain the KKR batters.

Meanwhile, the biggest drawback for KKR is the inconsistent performance of their batsmen, particularly Andre Russell, who has just managed a meagre 71 runs from

seven games.

There was talk of Russell being promoted up the order, but he continues to bat down and hasn't done justice to his abilities.

Kolkata also possess a number of batsmen who can take any attack to cleaners. It comprises the young and elegant Shubman Gill, England's World Cup-winning captain Eoin Morgan, Nitish Rana and skipper Dinesh Karthik, but they have not got going barring the odd game.

The management would be hoping that come Friday, they fire in unison to reduce pressure on young guns Rahul Tripathi and Tom Banton.

KKR bowlers did well to fashion narrow victories against Kings XI Punjab and Chennai Super Kings, but were profligate against RCB when Pat Cummins and Prasidh Krishnan leaked 38 and 42 runs respectively.

They would want to forget the hammering and regain form. KKR may also look to play Kuldeep Yadav, who was dropped after playing just three games, in place of a third pacer. He can come in handy along with mystery spinner Varun Chakravarthy, who was economical in the game against RCB.

Coutinho makes good on 2nd chance with Barca

Barcelona, Oct 15: Two months after helping Bayern Munich hand Barcelona their most humbling loss in decades, Philippe Coutinho is helping the Spanish club rebuild.

Coutinho has been through plenty

since joining Barcelona from Liverpool in January 2018, burdened by the responsibility that went with his club-record club transfer. Besides his price tag of 160 million euros, he had also been tasked to replace the irreplaceable Andres Iniesta.

After a season-and-a-half of failing to meet the huge expectations placed upon him, his relationship with Barcelona hit a low point when he seemed to taunt the team's fans by plugging his fingers in his ears after scoring his finest goal with the team in a 3-0 win over Manchester United. Many were offended by his gesture, which they took to mean he was fed up with criticism.

Hoping that a temporary move would be good for the player, and possibly the club's chances to eventually sell him, Barcelona loaned Coutinho to Bayern in 2019.

At that point, it would have been difficult to imagine that in the last game of Barcelona's season it would be Coutinho who scored two goals against the club that owned his rights.

Those goals capped Bayern's eight-goal rout of Barcelona in the Champions League quarterfinals, assuring the club finished the season without a title for the first time in 12 seasons. While Barcelona went home broken, Bayern went on to win

the European Cup.

His goals for Bayern, ironically, may have helped him regain his post in Barcelona. Incoming coach Ronald Koeman wanted Coutinho to come back and play, unlike a long list of players that the club sold or practically gave away to make way for new faces and reduce a heavy salary burden.

"Like any player, he needs the support and confidence of his coach, but this all starts with the player. He has demonstrated that he is a great player, and I am happy to have him with us," Koeman said about

Coutinho after he scored in a 1-1 draw with Sevilla two weeks ago.

Coutinho has proven to be a key piece in Koeman's new-look Barcelona. The Dutch coach has moved on from the classic 4-3-3 of Barcelona and shifted to a 4-2-3-1 with Coutinho acting as the central playmaker behind Lionel Messi as striker.

With Ansu Fati on his left, Antoine Griezmann on his right, and Frenkie de Jong and Sergio Busquets defending his back, Coutinho has a full range of passing options and orders to go forward.

Perhaps, too, it helped that with the COVID-19 crisis there are no fans in the stadiums to judge his every pass and dribble.

Gone was the player who looked uncertain and appeared to shrink from the action during long stretches of his first stint with Barcelona. Coutinho now seems to be in his ideal position, as the assists and goals have shown so far. He set up Fati to score two goals in a 4-0 win over Villarreal to open the season and in a 3-0 win at Celta Vigo.

Coutinho then scored his first goal since returning to the team against Sevilla before a break for international matches, where he played well for Brazil in two World Cup qualifying wins.

Back from the national team, Coutinho will again likely be back in the heart of Barcelona's attack when they visit Getafe Saturday. Known for their physical defending, Getafe are undefeated in two home games and has kept clean sheets in three of the four games they have played.

When asked about his transformation, Coutinho focused on what he considered the basics. "I am motivated to work hard and do things well, to achieve important things for this club," Coutinho said after his goal against Sevilla. "That is what counts."

Zagreb, Oct 15: Star striker Kylian Mbappe scored late as France frustrated Croatia again, winning a closely-contested UEFA Nations League match 2-1 to stay level on points with group leader Portugal.

Croatia have never beaten France, losing the last Nations League encounter and the 2018 World Cup final by the same score of 2-4. They were also beaten 1-2 in the 1998 World Cup semifinals.

After forward Antoine Griezmann put France ahead early, midfielder Nikola Vlasic equalised midway through the second half.

Croatia were starting to get on top when France substitute Paul Pogba floated over a superb pass from the halfway line to Lucas

Digne sprinting down the left. The Everton left-back's volleyed pass fell to Mbappe, who met the ball on the bounce from close range for his 16th international goal.

Griezmann netted in the eight minute after Croatia's defense failed to properly clear Ferland Mendy's cross from the right. Lurking to the right of the penalty spot, Griezmann smacked a quick shot which hit the underside of the crossbar for his 33rd international goal.

Croatia improved after the break but did not threaten until Vlasic's excellent finish from the edge of the penalty area in the 64th. He controlled Josip Brekalo's pass with his left foot and stabbed the ball past Lloris and into the bottom corner with the outside of his right.

Netherlands hold Italy in a thriller

Bergamo: Italy were held to a 1-1 draw by the Netherlands in a game that paid tribute to Bergamo's many victims of the coronavirus pandemic. Dutch midfielder Donny van de Beek cancelled out Lorenzo Pellegrini's opener in the first half Wednesday. It was the first time in 14 years that Italy played a match here. Italy took the lead in the 16th minute. Nicol Barella played a perfect through ball for Pellegrini to run onto and drill past Dutch goalie Jasper Cillessen. The Dutch levelled nine minutes later as Van De Beek fired into the roof of the net from close range.

Jota shines

Lisbon: Diogo Jota scored two goals and set up another as Portugal defeated Sweden 3-0 in the Nations League in their first game since Cristiano Ronaldo had to be dropped from the squad after testing positive for the coronavirus. Jota set up Bernardo Silva's opening goal in the 21st minute and scored himself in the 44th. The Liverpool forward finished off the scoring in the 72nd.

Denmark stun England

London: Christian Eriksen marked his 100th Denmark appearance by scoring the penalty that clinched a 1-0 victory over England in the UEFA Nations League. England had already been reduced to 10 men Wednesday after Harry Maguire was sent off by the time a disputed penalty was awarded for Kyle Walker's challenge on Thomas Delaney. Eriksen converted the penalty for his 34th international goal in the 35th minute at Wembley. Reece James' first England start ended with him being sent off after the final whistle.

Lukaku scores twice in Belgium's victory

Reykjavik (Iceland): Striker Romelu Lukaku scored both goals to give Belgium a 2-1 win at Iceland, taking his international tally to 55 goals and moving his team back atop their Nations League group. Iceland scored in between Lukaku's goals as midfielder Runar Mar Sigurjonsson's astute pass sent veteran right-back Birker Saevarsson through and he beat goalie Simon Mignolet with a low shot.
