Ardern's mammoth win in NZ elections

Wellington: Prime Minister Jacinda Ardern's centre-left Labour Party won a landslide victory in New Zealand's general election Saturday as voters rewarded her for a decisive response to Covid-19. The mandate means Ardern, 40, could form the first single-party government in decades, and faces the challenge of delivering on the progressive transformation she promised but

failed to deliver in her first term, where Labour shared power with a nationalist party. "This is a historic shift," said political commentator Bryce Edwards of Victoria University, describing the vote as one of the biggest swings in New Zealand's history

Credit still a worry for 'self-reliant' India

The Khadi and Village Industries Commission, implementing agency for the 'Aatmanirbhar Bharat' programme, receives a flurry of complaints from prospective entrepreneurs alleging non-cooperation from banks on their loan applications

New Delhi, Oct 17: The Modi government's ambitious 'Aatmanirbhar Bharat' programme faces a major hurdle in the form of non-cooperation from banks in granting loans for small manufacturing units under the flagship scheme Prime Minister Employment Generation Program (PMEGP).

The Khadi and Village Industries Commission, the implementing agency, has received a flurry of such complaints from prospective entrepreneurs alleging inaction or non-cooperation from banks on their loan applications. Following the complaints, KVIC Chairman Vinai Saxena has written to Finance Minister Nirmala Sitharaman saying "such apathy by the banks could derail Centre's efforts to create sustainable employment in the country." Saxena's comments came after

Sunaina Mathur, proprietor of Shiva Udyog in Jaipur, Rajasthan, wrote to him October 7 highlighting the apathy of bank officials in providing short term working capital loan of ₹50 lakh to her unit despite of a confirmed order from the government with a guarantee of time-bound payment.

"As this was a government-to-government order, there was pressure of getting blacklisted if the order was not met on time. So, I had to arrange money from friends and relatives to purchase the raw materials for the order." the Shiva Udyog proprietor said.

IANS tried to contact Mangal, who asked us to get in touch with Deshraj Meena, the General Manager of the PNB in Jaipur.

When asked about the loan request from Shiva Udyog, Meena told IANS, "I will check the details of the said loan request."

Commenting on the complaint of Jaipur-based mustard oil manufacturing unit, KVIC Chairman Vinai Saxena said, "The first-ever supply of mustard oil to ITBP by KVIC was a prestigious order and timely supply of high-quality oil to the jawans was the key concern of KVIC."

New Delhi, Oct 17: The Drug Controller General of India (DCGI) has granted approval to Dr Reddy's, a global pharmaceutical company headquartered in India, to conduct phase 2 and 3 clinical human trials of the Sputnik V, a Covid-19 vaccine made by Russia.

September 16, the Russian Direct Investment Fund (RDIF) and Dr Reddy's Laboratories Limited agreed to cooperate on clinical trials and distribution of Sputnik V Covid-19 vaccine in India.

Sputnik V. an adenovirus vector-based vaccine, was developed by the Gamaleya Scientific Research Institute of Epidemiology and Microbiology, along with the Russian Direct Investment Fund and registered August 11.

Co-chairman and managing director of Dr Reddy's Laboratories GV Prasad in a statement said, This is a significant development that allows us to commence the clinical trials in India and we are committed to bringing in a safe and efficacious vaccine to combat the pandemic.'

"On regulatory approval in India, RDIF shall supply to Dr Reddy's 100 million doses of the vaccine. The Sputnik V vaccine, which is based on well-studied human adenoviral vector platform with proven safety, is undergoing clinical trials for the coronavirus pandemic," a statement from the Russian fund had earlier stated.

The Russian Direct Investment Fund had also said that the deliveries could potentially begin in late 2020 subject to completion of successful trials and registration of the vaccine by regulatory authorities in India.

"The agreement between RDIF and Dr Reddy's reflects the growing awareness of countries and organisations to have a diversifiedanti-Covid vaccine portfolio to protect their populations," RDIF added.

India fares poorer than neighbours in Hunger Index LAST YEAR, OUT OF 117 COUNTRIES INDIA HAD RANKED 102 AND THIS YEAR, OUT OF 107 NATIONS WE ARE PLACED AT 94

New Delhi, Oct 17: India ranked 94 among 107 nations in the Global Hunger Index 2020 and was in the 'serious' hunger category. Experts have blamed poor implementation processes, lack of effective monitoring, siloed approach in tackling malnutrition and poor performance by large states behind the low ranking.

Last year, India's rank was 102 out of 117 countries. Neighbouring Bangladesh, Myanmar and Pakistan too were in the 'serious' category but ranked higher than India in this year's Hunger Index. While Bangladesh ranked 75, Myanmar and Pakistan were in the 78th and 88th position respectively.

Nepal in 73rd and Sri Lanka in 64th position were in 'moderate' hunger category, the report showed.

Seventeen nations, including China, Belarus, Ukraine, Turkey, Cuba and Kuwait, shared the top rank with GHI scores of less than five, the website of the Global Hunger Index, that tracks hunger and malnutrition, said Friday.

According to the report released Friday, 14 per cent of India's population was undernourished.

It also showed the country recorded a 37.4 per cent stunting rate among children under five and a wasting rate of 17.3 per cent. The under-five mortality rate stood at 3.7 per cent. Wasting is children who have low weight for their height, reflecting acute under-nutrition. Stunting is children under the age of five who have low height for their age, re-

flecting chronic under-nutrition. Data from 1991 through 2014 for Bangladesh, India, Nepal, and Pakistan showed that stunting was



concentrated among children from households facing multiple forms of deprivation, including poor dietary diversity, low levels of maternal education, and household poverty

During this period, India experienced a decline in under-five mortality, driven largely by a decrease in deaths from birth asphyxia or trauma, neonatal infections, pneumonia, and diarrhoea, the report stated.

"However, child mortality, caused by prematurity and low birth weight, increased particularly in poorer states and rural areas. Prevention of prematurity and low birth-weight is identified as a key factor with the potential to reduce under-five India is categorised in the 'serious' hunger category

Experts think that poor implementation processes, lack of effective monitoring and siloed approaches to tackling malnutrition often result in poor nutrition indices.

Purnima Menon, a senior research fellow at the International

Food Policy Research Institute, New Delhi, said the performance of large states like Uttar Pradesh, Bihar and Madhya Pradesh need to be improved to see an overall change of India's ranking.

'The national average is affected a lot by the states like UP and Bihar... the states which actually have a combination of high levels of malnutrition and they contribute a lot to the population of the country."

"Every fifth child born in India is in Uttar Pradesh. So, if you have a high level of malnutrition in a state that has a high population, it contributes a lot to India's average. Obviously, then, India's average will be slow to move," she told PTL "So, if we want a change in

India then we would also need a change in Uttar Pradesh, Jharkhand, Madhya Pradesh and Bihar," she said





The inordinate delay in the establishment of the Odia University has invited criticism from social activists as well as intellectuals.

The heritage cabinet of the state government, formed to propagate and preserve the heritage and culture of Odisha and enrich Odia language in 2017, had decided to set up the university at Satyabadi where Satyabadi Vana Vidyalaya had been established by the famous Panchasakha - Pandit Gopabandhu Das, Acharya Harihar Das, Pandit Nilakantha Das, Krupasindhu Mishra and Godavarish Mishra. The proposed university would

offer postgraduate courses in Odia language and promote research. Chief Minister Naveen Patnaik

had laid the foundation stone for the proposed university at Satyabadi 'Bakulabana' on the occasion of Utkalamani Gopabandhu Das's 141st birth anniversary October 9, 2018

It was then decided that the university would be set up on the land of Satvabadi Gopinath Deb for which 28.74 acre land at Phula Alasha mouza was earmarked.

Since the owner of the land is Satyabadi Gopinath Deb, the state government had applied before the Endowment Commission to buy the land. The application was made in accordance with Section-19 of Odisha Hindu Endowments Act. But the residents of Satyabadi opposed the move as Bakulabana has been deeply associated with rituals of Sakhi Gopal temple and Srimandir in Puri. They had re-

quested the Puri Collector to save Bakuklabana. Subsequently, a meeting was convened and it was decided that Bakulabana would be excluded from the original layout and the university would be set up on the

special duty (OSD) for the proposed university. However, the construction work for the project is yet to be started by the state government. It is learnt that Higher Education department Commissioner-cum-Secretary Saswat Mishra has re-

cently written to his Works department counterpart seeking the latter's intervention in providing an architectural plan for the proposed Odia University.

In his letter to the Works department Commissioner-cum-Secretary, Mishra pointed out that the Higher Education department had urged the Chief Engineer (buildings) October 14 last year to provide an architectural plan and design for the university. However, the Higher Education department is yet to receive the architectural plan, said the letter.

"We had thought that the Odia University at Satyabadi would work to promote our language and culture. Now, we are very much skeptical about the proposed university. We are unable to understand the reason behind delay in the construction of the institute. The state government should look into the issue and take immediate step to begin work for the proposed Odia University," said retired teacher and former student of Satyabadi Vana Vidyalaya Banamali Behera.

Puri Collector Balwant Singh said the required land for the proposed university has been acquired after settlement of all issues in this regard. "Nothing related to the construction work for the Odia University is pending with us," he clarified.

Probe plaint against Kangana: Bandra court

The order by Bandra 12th Court Magistrate Jaidev Ghule came in a plea by Munawwarali alias Sahil A Sayyed, a casting director, said his lawyer Ravish F Zamindar. 'The court directed the Bandra

police to probe the matter under Section 156 (3) of the CrPC and take necessary action," advocate Zamindar told this news agency. Among other things, Sayyed ac-

cused Kangana and Rangoli of defaming Hindi film industry, portraying people working in it in a bad light with claims of nepotism, drug addiction, communal bias, attempting to create a rift between artistes of different communities, insulting religions, calling them murderers etc on social media and through public statements.

Sayyed also accused them of creating a Hindu-Muslim divide through objectionable comments, citing Rangoli's "make the mullas and secular media stand in line and shoot them down; the history



may call us Nazis, who cares remarks.

When he tried to complain to the Bandra police September 16, Sayyed claimed, police refused to entertain his complaint after which he sent another one to Deputy Commissioner of Police (Zone XI) a fortnight later, pointing out alleged lapses of the Bandra police.

Moving the Bandra court Thursday, Sayyed prayed for appropriate directions under Section 156 (3) of the CrPC to the Bandra police to register a first information report against the two sisters under the IPC.

Bhubaneswar, Oct 17: Public health and community medicine experts from All India

Institute of Medical Sciences (AIIMS) Bhubaneswar and other premier institutions, Saturday, said that several frontline workers in Odisha are anaemic and need attention.

This was revealed by Dr Vikas Bhatia, former head of AIIMS, Bhubaneswar Community Medicine department in a brainstorming session. He said that in one of the surveys conducted by AIIMS, Bhubaneswar, several categories of frontline workers were found to be anemic after their examination of Hemoglobin (Hb) levels.

"Anaemia is not only prevalent

among common people; it is there among frontline health workers. Among the frontline workers, anaemia is most common among ASHA workers Anaemia (69 per cent), followed is most common by Anganwadi among ASHA workers workers (62%) (69%), followed by

> He also said that the occurrence of severe anaemia is low (at 1-3 per cent), but the prevalence of moderate anaemia (at 7-20 per cent) and of mild anaemia (39-58 per cent) is very high in the state

The disease is mostly found in lactating mothers (77 per cent), followed by women of reproductive age (71 per cent), pregnant women (69 per cent) and adolescent girls (68 per cent), the central government



institution said.

Other experts said that several lactating women are also found to be anaemic and batted for better screening and timely medical intervention for the same.

"We need to think of better and effective therapeutic options such as intravenous Ferric Carboxy Maltose (FCM) for improving hemoglobin level among postpartum women with moderate to severe anaemia. Multi pronged approach must be adopted to deal with the condition," said Shashi Kant, Senior Professor & Head, Centre for Community Medicine. New Delhi.

Debasish Hota, head of Pharmacology department at Bhubaneswar AIIMS, said that over 50 per cent population in Odisha is anaemic and women and children are the worst sufferers.

"If a child is anaemic, there will be problem in its growth and development, whereas in adult, we find depression and reduction of life span, if the adult is anaemic. We as medical personnel need to deal with anaemia with a holistic approach.'

The session was organized by the **Resource Center for Advancement** of Public Health Nutrition, AIIMS Bhubaneswar in collaborations with Unicef. Odisha.

BMC shuts down 2 Covid care centres as cases drop

Bhubaneswar, Oct 17: Observing the drop in COVID cases in the state capital, the Bhubaneswar Municipal Corporation (BMC) here said it has decided to shut down two Covid Care Centres (CCCs) at Jamujhari and Jatani.

Briefing media, Friday, the BMC Commissioner, Prem Chandra Chadhary said they have decided to close down two CCCs having a combined capacity of 750 beds. The commissioner added that bed load in Bhubaneswar has also reduced substantially and almost 100 ICU beds are lying vacant in government facilities

"We are at declining phase as about 250 to 300 new cases are being detected per day in the capital city over last four-five days. As opposed to about 300-400 cases a few weeks ago the cases have reduced substantially. As projected and confirmed by the RMRC (Regional Medical Research Council) in its report, the city is experiencing a decline after the peak,' Chaudharv said.

Stating that with a capacity of 400 to 500 ICU beds available in government facilities, he said only 305



have been occupied until now. With most of the cases in home quarantine, the distribution of Favipiravir tablets to mild symptomatic patients is also going on. "So far we have distributed the drug to 712 patients.'

Meanwhile, experts have pointed that the civic authority is claiming the decline on back of reduced testing. As per sources, the BMC over past 10 days had conducted about 3 lakh tests. While 4059 tests were conducted October 2, it dropped to only 2574 October 11.

However, denying any intended drop in tests, the BMC commissioner said that citizens cannot af-

ford to drop their vigil against the infection. Citing examples of other states that had recorded a surge after festive seasons, he said people need to be extra-vigilant ahead of Durga Puja and should not leave any room for complacency. 'The upcoming Durga Puja is

the next challenge for us. Evidence from other cities in India and cases in certain foreign countries show that cases have surged after festivities or other celebrations. We have planned to raise awareness in coordination with the commissionerate police and will ensure strict enforcement of COVID norms." he added.

Patients, kin allege non-receipt of quality food in SCB isolation ward

Supply agency has reduced the drinking water quota for patients

Cuttack, Oct 17: Covid suspect patients admitted to the isolation ward of SCB Medical College and Hospital here are allegedly not getting nutritious and good quality food over last couple of days, a report said.

Patients and their kin have alleged that the agency supplying food to them has also reduced the quota of drinking water from three litre per patient to two. This has sparked resentment among patients and their kin. Observers alleged that this might hit the treatment of patients in the isolation ward and delay their recovery.

Sources said the isolation ward was opened in March for treatment of Covid suspects visiting the hospital. The number of patients in the ward was less in the first two months. However, later the number reached around 300 to 400 daily.

Reports said the hospital has sanctioned Rs 240 for each patient on food and drinking water. The hospital has signed an agreement with city-based supply agency, Ujwal Suppliers, to provide food and drinking water to the patients.

As per rules, the agency has to supply food for breakfast, lunch, evening snacks like biscuits and tea and dinner along with drinking water bottles of three litre to each patient. The agency after opening of the ward went on supplying food





SPCB orders closure of non-compliant plant

Bhubaneswar, Oct 17: The Odisha State Pollution Control Board (SPCB) has ordered closure of a non-compliant stone quarry plant in Dhenkanal district

This comes after a complaint against the erring unit was filed before the SPCB. The board after its own inspection found non-compliance of environmental laws and after issuing a show cause notice, ordered closure of the plant situated at Jhilli in Kankadahad teshil of the district

The SPCB claimed that the plant

in question failed to satisfy the board about their compliance with the established laws in the matter. The board found activities of the plant in gross violation of the consent order and Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981.

"Now therefore by the virtue of the power conferred under Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981 and rules framed under consent to operate in favour of your stone quarry is hereby re-



voked and you are directed to close down operation of the stone quarry forthwith," the board said.

The SPCB had earlier said that the firm was allowed for production of 6500 m3 but as per government documents the production was found to be 92,930 m3. It had claimed that the overproduction without approval was in violation of Section 25/26 of Water (Prevention and Control of Pollution) Act 1974 and Section 21 of Air (Prevention and Control of Pollution) Act 1981.

The board claimed that there were air pollution measures that were needed to prevent fugitive dust emission during the loading and unloading process

The board also said that dust suppression mechanism was not chipped in for the plant to provide relief from dust emanating out of the process

posed a ban on animal sacrifice in Manikeshwari temple and its vicinity during annual Chhatar Yatra.

On the other hand, in view of the fast rise of covid case, the Kalahandi district administration has imposed on certain restrictions



on Chhatar Jatra so as to prevent congregation and spread of the infections.

As per the recent decision, no devotees will be allowed to enter into the temple nor to take part in rituals during the event. Angul, Oct 17: The number of COVID-19 positive cases is rapidly increasing in Angul district, more so in September and October. The rapid response team (RRT) has been blamed for not discharging its duties perfectly a source said.

There are 27 RRTs functioning in eight blocks, two municipalities and one notified area council (NAC) of the district. Each team comprises two doctors and four nurses. The responsibilities for these teams start when COVID-19 patients are detected. The teams are supposed to collect the lists of patients from the concerned municipalities or block offices. Then they will visit the patients, test their health conditions and decide whether they will go to COVID-19 hospitals or in home isolation.

But it has frequently been alleged that members of these teams are not even visiting patients, let alone enquiring about their health conditions.



In most cases, they are learnt to have left the home isolation kits meant for the patients on the road instead of delivering them to patients. So, the brochures are often found not filled up completely. Due to such an attitude of the teams, they often get off on the wrong foot with the patients and their relatives.

Most importantly, these teams are not visiting the home isolation patients as a result of which patients and their relatives are not able to know what precautions the patients and their relatives should take so that the

family members cannot contract the virus. As a result, the complaints of family members contracting the virus from the patients are pouring in from across the district.

If this is the situation in the district headquarters, the situation in remote areas can well be imagined, rued town resident Himanshu Samal, adding, "The team members are doing so because no stringent action has been taken against them."

In this regard, executive officer. Angul Municipality, Binod Chandra Panda termed the way the teams are

handling the situation as unfortunate. The number of patients will decrease only when these teams' performance go up to the mark. It will also help boost patients' will power.

When contacted, chief district medical officer (CDMO) Dr Abhay Kumar Dash said, "The team members have been asked to be careful about their duties or else they will face music.³

Angul District Collector, Siddharth Shankar Swain, when asked, said he is aware of the fact that the rapid response teams are not discharging their duties as they should. "The CDMO has been asked to look into the allegations. The doctors and the nurses in the RRTs have been appointed only for COVID-19. So, any negligence would not be tolerated anymore," he added.

Notably, Angul district Saturday reported 107 fresh Covid-19 cases. With this fresh addition, the district's tally has gone up to 6,658. Of them, 5,217 patients have already recovered. 1,432 patients are under treatment.

omplex problems require many minds. Leadership is important but mostly in terms of directionality. The solutions need to be produced by those implementing, not the person directing. If this is reversed, progress will not be made and generally what results is retardation.

For solutions to be produced below the level of leadership, it is necessary that there be some devolution of authority and power. Such is not the case in India of our times. The leadership of this large and complex nation is centralised in a way that it has never been in our history. There are some parallels with Indira Gandhi but the 1970s was another world.

Some of the most important positions in the Cabinet are filled by those who have never won an election. The finance minister, foreign minister, railways and commerce and industry minister are none of them elected. The previous finance minister was also unelected. They owe their position not to personal political popularity but to the patronage of Modi. They cannot defy him and they will do what he says. That is why they have in fact been chosen and placed there. The moment they defy or question, they will be replaced by someone who will keep their mouth shut but keep their job. There is no devolution of authority and none of accountability.

When things begin to go wrong in such a place, the leader cannot be blamed or even named. It will be assumed that he is right and the solution lies not in correcting his behaviour but in something else

A few weeks ago there was this headline in the online publication The Print: "Modi govt plans media blitz for 'image correction' to boost India rank on global lists." It reported that the government was trying to improve India's

ranking on some 30 global indices by "building a massive publicity campaign" which was a "planned perception-overhaul exercise.

These indices are those which monitor religious, economic, political, media freedoms, the rule of law, innovation, terrorism and other things. Either data is compiled or global experts are asked for their perceptions and then countries given a score or rating

Many of these are compiled by bodies that are multilateral, such as the World Bank or the United Nations. It is not clear how India will get its poor ratings improved through a media campaign when it comes to such bodies or when it comes to hard data.

For instance India is ranked 142 on the World Press Freedom Index, falling from 140 in 2019 and 138 in 2018. The main reason for its falling is the violence against journalists and the number of internet shutdowns in Kashmir. These are objective things that are measurable. They cannot be corrected by publicity campaigns. This year India has introduced a new media policy in Kashmir that has more or less throttled all freedom of media in that state.

The government's response in the instance of the media index was to set up its own 'Index Monitoring Cell' which would have journalists Rajat Sharma (of Aap ki Adalat fame) and P Sainath. Not much has been heard from this cell since and it will not affect the global rating. India's ranking in press freedom is not going

to improve globally next year either and spending money on marketing an image that is removed from reality is neither wise nor will it be effective.

India's numbers on Covid are self-declared. These are government numbers. They can and they will be compared to how India is doing versus the rest of the world and particularly the rest of South Asia with which an honest comparison can be made. On infections and fatalities, our performance is below the rest. A media blitz will not correct the perception that India has been the least competent at addressing the issue because the perception is based on reality.

This week news has come that in the current financial year, Bangladesh will overtake India in terms of per capita income. Meaning the average Bangladeshi's income will be more than the average Indian's. Even to those who are referred to as Modi haters, this was shocking. It was not expected because India was far ahead of Bangladesh in terms of per capita income in 2014. One reason for their overtaking us is that that the Bangladeshi leadership handled the Covid hit to their economy better. The other reason is that in the last six years, Bangladesh has been growing much faster than India. It would have overtaken us anyway in time. The Covid just made it sooner. It has been a long slide that has not been in the public realm because the leader does not acknowledge it and the minions cannot speak. It seems like we were talking about competing with China and the US only a few years ago. Now we must first compete with Bangladesh. This is not what we had been promised. How will this be corrected by a media blitz? It will not. But it is what the great man has ordered so it will be done. The slide will continue, the noise about achche din will also continue.

QUAD SHARPENS ITS EDGES

he Quad, a loose strategic coalition of the Indo-Pacific region's four leading democracies, is rapidly solidifying this year in response to China's aggressive foreign policy. Following a recent meeting of their top foreign-policy officials in Tokyo, Australia, India, Japan, and the United States are now actively working toward establishing a new multilateral security structure for the region. The idea is not to create an Asian version of NATO, but rather to develop a close security partnership founded on shared values and interests, including the rule of law, freedom of navigation, respect for territorial integrity and sovereignty, peaceful dispute resolution, free markets, and free trade.

China represents a growing challenge to all these principles. At a time when the world is struggling with a pandemic that originated in China, that country's expansionism and rogue behaviour have lent new momentum to the Quad's evolution toward a concrete formal security arrangement. Of course, the Quad's focus also extends beyond China, with the goal being to ensure a stable balance of power within a "free and open Indo-Pacific." That concept was first articulated in 2016 by then-Japanese Prime Minister Shinzo Abe, and has quickly become the linchpin of America's regional strategy.

While all of the Quad partners agree in principle on the need for a free and open Indo-Pacific, it is Chinese expansionism that has catalysed their recent actions. China is forcing even distant powers like the United Kingdom, France, and Germany to view a rules-based Indo-Pacific as central to international peace and security.

France, for example, has just appointed an ambassador for the Indo-Pacific, after unveiling a new strategy affirming the region's importance in any stable, lawbased, multi-polar global order. And Germany, which currently holds the European Council presidency, has sought to develop an Indo-Pacific strategy for the European Union. In its own recently released policy guidelines, it calls for measures to ensure that

rules prevail over a 'might-makesright' approach in the Indo-Pacific. These developments suggest that in the coming years, Quad members will increasingly work with European partners to establish a strategic constellation of democracies capable of providing stability and an equilibrium of power in the Indo-Pacific.

After lying dormant for nine years, the Quad was resurrected in late 2017, but really only gained momentum over the last year, when its consultations were elevated to the foreign-minister level. US Secretary of State Mike Pompeo said this month that, "once we've institutionalised what we're doing. the four of us together, we can begin to build out a true security framework, a fabric that can counter the challenge that the Chinese Communist Party presents to all of us." The Quad's future, however, hinges on India, because the other three powers in the group are already tied by bilateral and trilateral security alliances among themselves. Australia and Japan are both under the US security (and nuclear) umbrella, whereas India not only shares a large land border with China. but also must confront Chinese territorial aggression on its own, as it is currently doing. China's stealth land grabs in the northernmost Indian borderlands of Ladakh earlier this year have led to a major military standoff, raising the risks of further localised battles or another 1962-style frontier war.

It is precisely this aggression that has changed the strategic equation. Chinese President Xi Jinping's authorisation of the People's Liberation Army incursions into the Himalavas has forced India itself to take a more confrontational position. It is now more likely than ever that the Quad will shift gears from consultation and coordination to become a de facto strategic alliance that plays a central role in a new multilateral security arrangement for the region.

This new architecture will bear little resemblance to America's Cold War-era system, which rested on a patron-client framework, with the US as the 'hub' and its allies as the 'spokes.' No such arrangement would work nowadays, for the simple reason that a country as large as India cannot become just another Japan to the US. That is why the US is working to coax India into a 'soft alliance' devoid of any treaty obligations. This effort will be on full display on October 26-27, when Pompeo and US Secretary of Defense Mark Esper visit New Delhi for joint consultations with their Indian counterparts. Most likely, this meeting will conclude with India signing on to the last of the four foundational agreements

that the US maintains with its other close defense partners. Under these accords, both countries will be committed to providing reciprocal access to each other's military facilities, securing military communications, and sharing geospatial data from airborne and satellite sensors.

Moreover, having held multiple bilateral and trilateral military exercises with its Quad part ners, India is likely to invite Australia to this year's 'Malabar' naval war games with the US and Japan. This would mark the firstever Quad military exercise; or, as the Chinese communist mouthpiece Global Times, put it, "it would signal that the Quad military alliance is officially formed.'

US foreign policy has always been most effective when it leverages cooperation with other countries to advance shared strategic objectives. Despite President Trump's undermining of US alliances, his administration has built the Quad into a promising coalition, and has upgraded security ties with key Indo-Pacific partners, including Taiwan, Japan, South Korea, Australia, Thailand, and India.

More fundamentally, the Quad's consolidation is further evidence that the Xi regime's aggressive policies are starting to backfire. International views of China have reached new lows this year. Yet the Chinese foreign ministry doubling down on its 'wolf warrior diplomacy - recently dismissed as 'nonsense' Pompeo's plan to forge an international coalition against China. "He won't see that day," the ministry declared. "And his successors won't see that day either, because that day will never, ever come." But that day is coming. 
Uqsome

f this reminds you of the inarticulate cry of disgust that most often appears as ugh! then you're on the mark. The conventional spelling of ugh! was probably influenced by that of ugsome, something loathsome or horrible. In a case of linguistic turn-and-turn-about, ugsome derives from the ancient and long defunct word ug, which about a millennium ago came into English from the Old Norse ugga, to dread. That Old Norse word is also the source of ugly (which meant frightful or horrible before it weakened to refer to something merely unpleasing in appearance). You could argue that ugsome is the opposite of handsome. In the centuries before Shakespeare, ugsome was common enough, mostly in Scotland and northern England, but then almost completely died out except in dialect. It was resurrected in the eighteenth century by writers seeking an archaic word to help set a historical scene. The following century, popular authors such as Sir Walter Scott ("Like an auld dog that trails its useless ugsome carcass into some bush or bracken"), Sir Edward Bulwer-Lytton (""Tis an ugsome bit of road!" said the Corporal, looking round him") and Charles Dickens ("One very ugsome devil with goggling eyes, seems to hold up frightful claws, to bar the traveller's way") regained it some small exposure, though it was never very popular. Today, ugsome is unknown to most English-speaking people.

Hyd pays price for destroying flood control system

Hyderabad, Oct 17: The devastation caused by torrential rains and flash floods in and around Hyderabad this week is another grim reminder of the havoc played with the chain of lakes and storm water drains that were working as a natural flood control system.

This is not the first time the city has witnessed flooding but every time in the recent period, it faced nature's fury, it failed to learn a les-

Flooding of roads and inundation of low-lying areas are a common sight in the city whenever it rains heavily. Every time it is brushed aside either as a natural occurrence or inevitable consequence of the rapid development the tech hub is witnessing.

Whenever the city faced flash floods, those in power form committees comprising officials and experts to suggest measures to prevent recurrence. However, reports of these panels, containing almost similar suggestions, are gathering dust.

The extremely heavy rainfall of October 13 triggered a deluge in not just the outskirts but also in the heart of the city. More than 30 people lost their lives and about 2,000 colonies were inundated.

The last time the city had witnessed such massive floods was some 20 years ago. Rainfall of 24.5 cm August 24, 2000 had caused the deluge.

As the city has expanded by leaps and bounds to become Greater Hyderabad, the rainfall at some Automatic Weather Stations (AWS) installed by the Telangana State Development Planning Society was much higher than 24.5 cm. The AWS at Havathnagar. for instance.

Over the years, however, most of these water bodies have disappeared. According to the Forum, studies have suggested that since the 1990s, Hyderabad has lost over 3,000 lakes.

"Even till 1970, we had the balance. Post 1970, there was a frightening imbalance in the planning as people from all over the state started coming to the city. People started moving into the city knowingly or unknowingly and converted water bodies into buildings," says heritage activist P. Anuradha Reddy, who earlier headed Society for Preservation of Environment and Quality of Life (SPEQL).

After the floods of 2000, the then government had constituted a committee to suggest measures to improve nalas. The committee, in its report, identified 28,000 encroachments and estimated that removing them and improving the nala system required Rs 10,000 crore. The report was kept aside as its implementation was perceived impossible.

Another committee for expansion and modernization of nalas was formed in 2007. It gave a report which was similar to the previous panel and met the same fate.

Subsequently, another panel of experts suggested various measures to improve nala and restoration of lakes but its report too is gathering dust.

AIMPLB to build consensus against uniform civil code

The AIMPLB member also said the board will challenge the special CBI court judgement in the Babri mosque demolition. "Representatives of the board will appeal against the judgement in the high court," he said. The special court acquitted all 32 accused including BJP veterans LK Advani, MM Joshi and Uma Bharti of involvement in the destruction of Babri Masjid 28 years ago.

In a 2,300-page judgment, the CBI court said there was no conclusive evidence against the accused of being part of any conspiracy to bring down the disputed structure in Ayodhya.

Hyd metro runs special train to ferry pregnant woman

Hyderabad, Oct 17: In a rare gesture, the Hyderabad Metro Rail arranged a special train service to ferry a pregnant woman to her destination during the recent downpour, which pounded the city and left several areas inundated.

According to a top Metrol Rail official, the lady reached the Victoria Memorial station October 14 night and told the metro rail personnel that she had to get to Miyapur and that there was no other transport available.

Moved by the plight of the

woman, the officials decided to operate an exclusive service.

We were shutting down services by 9 PM as per rules...the woman entered the station at around 10 PM and requested us to take her to Miyapur as she had no other option...so our people arranged a special train and transported her safely to her destination," NVS Reddy, Managing Director of HMRL told PTI.

Torrential rains battered the city and neighbouring parts October 13 and 14 disrupting normal life including public transportation.

The official noted that the train has the capacity to ferry 1,000 people. However, due to COVID-19 protocols, the coaches were running with only 60 per cent capacity.

Reddy said as of now the total network of metro rail, which resumed operations September 7 after remaining suspended for over four months as part of nationwide lockdown, is presently carrying one lakh passengers per day in the city.

Covid-19: Telangana sees more recoveries than fresh infections


Hyderabad, Oct 17: Telangana registered 1,451 new coronavirus cases, taking the state's tally to 2.2 lakh, even as 1,983 more patients recovered from the infection, officials said Saturday.

Greater Hyderabad Municipal Corporation (GHMC) area accounted for the highest 235 new cases in the past 24 hours, followed by Rangareddy district at 104, Medchal Malkajgiri at 101, Bhadradri Kothagudem at 92, Nalgonda at 84 and Khammam at 71.

Other districts where new cases were reported include Karimnagar (65), Siddipet (64), Warangal Urban (55), Suryapet (37), Nizamabad (32), Rajanna Sircilla (30), Jagityal (29), Peddapalli (28), Medak (25), Nirmal and Wanaparty (24 each), Vikarabad and Nagarkurnool (22 each).

However, nine more patients died, raising the statewide COVID death toll to 1.265.

In all, 55 per cent patients died



cent due to Covid alone.

The southern state tested 42,497 samples in the past 24 hours, increasing the number of Covid-19 tests to 37.8 lakh.

The total recoveries in Telangana are 1.9 lakh. Of the 2.2 lakh cases in Telangana, 22,774 are active. Nearly 70 per cent of the casesare asymptomatic and 30 per cent symptomatic.

New Delhi, Oct 17: The All India Bar Association (AIBA) Saturday urged the Chief Justice of India to initiate contempt of court proceedings against Andhra Pradesh Chief Minister Jagan Mohan Reddy for making scandalous allegations against Justice NV Ramana, senior most judge of the Supreme Court and the judges of the Andhra Pradesh High Court.

This came after Jagan, in a letter to Chief Justice of India SA Bobde October 6, alleged that Justice Ramana has been influencing the sittings of the High Court, including the roster of a few judges.

The Chairman of AIBA Adish C Aggarwala, while condemning the Chief Minister for his October 6 letter to the Chief Justice of India, said the scurrilous and scandalous remarks against Justice Ramana, the next in line to become the Chief Justice of India and the judges of the Andhra Pradesh High Court, has shaken the independence of the judiciary. Expressing serious concern over the issue, Aggarwala said the letter from a Chief Minister facing various corruption and money laun-

dering charges in the courts, is un-

warranted and clearly an attempt to obstruct the courts by vilifying judges and intimidating them for obtaining favourable orders.

"It is completely an abuse of the process of rule of law that the Chief Minister instead of resorting to appeals and other mechanisms provided under the Constitution, has resorted to level serious allegations against judges, who have dealt with certain cases," the All India Bar Association added. It is a dangerous and callous act

undertaken by the Chief Minister, which may have consequences for democracy in the state and may lead to serious consequences, it said, adding that the letter is rife with mala fides as the same appears to have been intended to bench hunt for securing favourable orders.

"The tone, tenor and timing clearly establish the vested interests and hidden agenda of the Chief Minister. In this context, it would be important to note that Justice NV Ramana is dealing with a public interest litigation for decriminalizing politics and fast tracking pending criminal cases against corrupt politicians. There is no gain saying

BJP, AAP in war of words over Delhi pollution

New Delhi, Oct 17: The politics over stubble burning and subsequent air pollution in Delhi has heated up with the BJP hitting back at the Aam Aadmi party on Saturday, a day after the AAP blamed the Centre for it. The BJP claimed that it has been 'proven' that there is more pollution due to local factors inside Delhi.

"Day before yesterday, Union Minister Prakash Javadekar told you that the daily data of stubble burning changes. He told you an overall average of 4%. In response to that, the Delhi government gave a figure of 1st November, 2019," said BJP spokesperson Nupur Sharma at a press conference. Sharma quoted a newspaper re-

port to bolster her point of variation of such data on a daily basis. Sharma claimed that the share of pollution caused by stubble burning in Delhi-NCR's air pollution PM 2.5, on Wednesday was 1%. The same was 6 per cent Thursday and 18 per cent Friday. The BJP's counter charge comes

New Delhi, Oct 17: The Enforcement Directorate (ED) Saturday filed a charge sheet in a Delhi court against former AAP councillor Tahir Hussain in a money laundering case related to the communal violence in northeast Delhi in February.

The ED was probing the allegation that Hussain and his linked persons laundered about ₹1.10 crore by using purported shell or dummy companies to fuel protests against the Citizenship Amendment Act (CAA) and the riots.

Additional Sessions Judge Amitabh Rawat took cognisance of the offences under section 3 (money laundering) read with section 70 (offences by companies) punishable under Section 4 of the Prevention of Money Laundering Act (PMLA), 2002 against Hussain and co-accused Amit Gupta.

The judge directed that Hussain and Gupta be produced in court October 19.

This money, which was allegedly proceeds of crime, was used for committing various other scheduled offences, the agency had claimed.

While the top leaders will raise Rahul Gandhi's apparent comparison between Pakistan and India and P Chidambaram's call to reinstate Article 370, state BJP leaders will drum up the issue of Congress fielding controversial former Aligarh Muslim University (AMU) student leader Maskoor Usmani

Sources say, if the response is good, it will be the party's campaign strategy in the other two phases as well. However, one source added that its star campaigners like Prime Minister Narendra Modi, party chief JP Nadda, and Rajnath Singh will also raise issues like BJP's free ration scheme for 80 crore families. the National Education Policy and India's 'successful handling' of the

Covid pandemic. A Delhi-based senior BJP functionary said, "Rahul Gandhi taking Pakistan's side has become a regular thing. It no longer surprises us. But a former Finance Minister promising to reinstate Article 370 is shocking. People of Bihar need to know their stand on Kashmir." It became clearer when

Minister Prakash Javadekar said, "They (Congress) are saying that the decision to abrogate Article 370 was wrong and the Congress will bring it back. Nadda showed the way by hitting back hard against the Congress immediately on Twitter. calling it Congress' "dirty tricks"

allegedly aimed at "breaking India". Nadda also commented on Congress "praising Pakistan" which was a reference to a sarcastic tweet by Congress leader Rahul Gandhi where he posted a GDP growth chart that said: "Another solid achievement by the BJP government. Even Pakistan and Afghanistan handled Covid better than India.'

Javadekar also said, "Rahul Gandhi is praising Pakistan. Be it any issue, he likes to praise Pakistan and China. This is the face of Congress." Javadekar also highlighted how abrogation of Article 370 helped bring social justice for the Dalits in the two Union territories of Jammu & Kashmir and Ladakh. Incidentally, scheduled castes constitute 15 per cent of

Bihar's population, according to the 2011 Census.

The third issue that will be strongly raised in the next few weeks by the BJP is Congress fielding former Aligarh Muslim University (AMU) student leader Maskoor Usmani as a candidate. Already, Union minister from Bihar Giriraj Singh has raised it and BJP sources indicate, state leaders, particularly those campaigning in Darbhanga district, where Usmani is fighting from Jale constituency, will follow suit.

Giriraj Singh said Friday, Congress and the Mahagathbandhan leaders have to answer the nation that if the Jale candidate supports Jinnah. Congressand Mahagathabndhan have to say if they also support Jinnah?"

Man ends life after losing job

Aligarh (UP): A 22-year-old man allegedly committed suicide by consuming poison in Aligarh district in Uttar Pradesh after he lost his job in a private firm amid the coronavirus pandemic, police said Saturday. "It is the handiwork of the Khalistani terrorists as my family did not have any personal enmity with anyone," Sandhu's wife Jagdish Kaur told the media.

'His killing is the first step of the onset of 'Referendum 2020' in Puniah," she added.

'Referendum 2020', propagated globally by the banned Sikhs For Justice (SFJ), is a pro-Khalistan movement to 'liberate' Punjab as a 'nation' state.

Sandhu was shot dead by two unidentified gunmen almost a year after the government withdrew his security cover. He was cremated at his native place.

'We have lost a family member but that doesn't mean that we are afraid of militants. We are still strong enough to fight with them,' Jagdish Kaur said.

Centre mulls surrender policy for J&K youth taking up guns

Srinagar, Oct 17: India is coming up with a surrender and rehabilitation policy for the youth who want to give up militancy in Jammu and Kashmir. The Union Defence Ministry is deliberating over the issue with the Home Ministry in New Delhi.

The Indian Army is pushing the youth who have taken to arms to surrender so that they can be rehabilitated properly in the society, said 15 Corps GOC Lieutenant General BS Raju during an interaction at the Chinar Corps headquarters here. He said: "We will be doing more

work to ensure that more surrenders

take place.' The officer pointed out that it gives no pleasure to the forces to kill young boys who have picked up arms. The men on the ground during counter-terror operations risk their lives to convince these youth to shun their guns and surrender. He also said that the government

is working on a surrender and rehabilitation policy. The matter is currently deliberated between the Defence Ministry and the Home Ministry. There are a lot of issues in-

volved," said Lieutenant General Raju, adding that he has directed



those engaged in counter terror operations to ensure that no out-of-proportion force is used

"Whenever a local terrorist is involved, we offer him to surrender



NAGORNO-KARABAKH CONFLICT Armenian missile kills 13

Baku (Azerbaijan), Oct 17: Azerbaijan Saturday accused Armenia of striking its secondlargest city with a ballistic missile that killed at least 13 civilians and wounded 50 others in a new escalation of their conflict over

Nagorno-Karabakh. The Armenian Defence Ministry denied launching the strike, but the separatist authorities in Nagorno-Karabakh put out a statement listing alleged "legitimate" military facilities in the city of Ganja, although they stopped short of claiming responsibility for the attack.

Azerbaijani officials said the Soviet-made Scud missile destroyed or damaged about 20 residential buildings in Ganja overnight, and emergency workers spent hours searching in the rubble for victims and survivors. Scud missiles date back to the 1960s and carry a big load of explosives but are known for their lack of precision. In a televised address to the na-

tion, Azerbaijan's president, Ilham Aliyev, denounced the missile strike as a war crime and warned the leadership of Armenia that it would face responsibility for that. "Azerbaijan will give its response

and it will do so exclusively on the battlefield," Aliyev said. While authorities in both Azerbaijan and Armenia have denied targeting civilians, residential areas have increasingly come under shelling amid the hostilities that have raged for three weeks despite Russia's attempt to broker a cease-fire.

Divided world is

failing COVID-19

REUTERS Lisbon, Oct 17: A divided world has failed to rise to the challenge of fighting the COVID-19 pan-

demic, UN Secretary-General Antonio Guterres said Saturday and warned concerted action was needed to prevent millions of people being pushed into poverty and hunger.

The former Portuguese prime minister said far more could have been done if countries had worked together to combat the disease, which has killed more than one million people.

'The COVID-19 pandemic is a major global challenge for the entire international community, for multilateralism and for me, as secretary-general of the United Nations," Guterres told Portuguese news agency Lusa.

"Unfortunately it is a test that, so far, the international community is failing.'

He said that if coordinated measures were not taken, "a microscopic virus could push millions of people into poverty and hunger, with devastating economic effects in the years to come".

Guterres also criticised countries for a lack of unity in trying to solve other global challenges including the conflicts in Afghanistan, Yemen and Syria. "It is a source of enormous frus-

tration," he said. More than 39 million people

have been infected by COVID-19, according to a Reuters tally based on official disclosures.

Infections have been reported in more than 210 countries and territories since the first cases_ were identified in China in December 2019.

Shutdowns fail to deter protests

Bangkok: Pro-democracy activists in Thailand staged a fourth straight day of highprofile protests in the capital on Saturday, thwarting efforts by the authorities to stop them, including a shutdown of the city's mass transit systems. Unlike protests a day earlier, which saw police using water cannons to keep the protesters at bay, Saturday's demonstrations were peaceful, with no reports of any clashes by the time participants started heading home in the evening.

Iran's virus death toll passes 30,000

Tehran: Iran announced Saturday that its death toll from the coronavirus has passed the milestone of 30.000 killed. The announcement by Health Ministry spokeswoman Sima Sadat Lari saw Iran put its total death toll from the outbreak at 30,123 killed, with 253 new deaths being added to the official count. Iran has been struggling with the coronavirus since announcing its first cases in February. Iran has seen the worst outbreak in the Middle East, with more than 526.000 confirmed cases.

TEACHER BEHEADING China on friendship drive after US flexes muscles

New Delhi, Oct 17: Rattled by the strengthened US naval presence in the region, China has gone in for a fresh round of gunboat diplomacy with the Association of South East Asian Nations (ASEAN) countries as it sees these nations looking at Washington for support to keep the dragon at bay

The recent meeting in Tokyo of foreign ministers of the Indo-Pacific quad countries comprising the US, India, Japan and Australia also seems to have been factored into China's stepped up diplomatic drive with Foreign Minister Wang Yi undertaking a whirlwind tour to the ASEAN neighbours.

The ASEAN grouping includes countries such as Indonesia, Malaysia, the Philippines, Singapore,

and Thailand while some partner countries like Vietnam also have close ties with the group.

China has been continuously bullying these countries by staking ownership claims over their outlying islands and sending warships into their Exclusive Economic Zones (EEZ) to intimidate them.

However, in the context of the changed geopolitical situation, Wang went on a hectic "goodwill visit" to the ASEAN region this week. While assuring them of support for a vaccine to fight the deadly Covid-19 outbreak and closer economic co-operation, China's gunboat diplomacy also makes it clear that these countries must keep clear of the US.

Beijing and members of ASEAN should work together to remove

"external disruption" in the South China Sea, Wang said during a joint news conference with Malaysia's FM in Kuala Lumpur.

Wang claimed America's Indo-Pacific strategy was a "security risk" for East Asia, saying: "I believe all parties see this clearly and will stay vigilant against it. The South China Sea should not be a ground for major power wrestling teeming with warships.'

"China and ASEAN have full capacity and wisdom, as well as responsibility, to maintain peace and tranquility in the South China Sea. Wang added. As an economic sop to Malaysia, China committed to purchase 1.7 MT of palm oil until 2023 and agreed to encourage increased shipments of the product which is crucial for the development of the ASEAN member's economy.

Conflans-Sainte-Honorine, Oct 17: French police have arrested nine people over the beheading of a teacher near his school in a Paris suburb, a judicial source said Saturday, in what President Emmanuel Macron labelled an Islamist terror attack

The source said the killing was carried out by an 18-year-old Chechen, who was then shot and killed by police near the scene in Conflans-Sainte-Honorine, northwest of Paris. Police said the victim was 47-vear-old history teacher Samuel Paty, who had shown his pupils some cartoons of the Prophet Mohammed as part of a class discussion on freedom of expression -- a lesson that had prompted complaints from parents.

Two of the suspect's brothers

and his grandparents were initially detained by police for questioning. The judicial source told AFP Saturday that five more people had been detained, including the parents of a child at the school and friends of the suspect.

According to the source, the parents had signalled their disagreement with the teacher's decision to show the cartoons.

The attack came as a trial is in progress over the January 2015 massacre at the offices of the Charlie Hebdo satirical magazine, which had published caricatures of the prophet Mohammed that unleashed a wave of anger across the Islamic world.

New York, Oct 17: It is often advised not to sit for prolonged hours, but a new study has challenged the 'couch potato' belief, saying when it comes to the brain and cognition abilities, some sedentariness are not all that bad so long as basic physical activity benchmarks are met.

The study could be a bit of good news for a population that spend a significant amount of time sitting for work and for leisure, streaming their favourite movies and TV shows in these times of social distancing.

The research from assistant professor Aga Burzynska in the Colorado State University examined the association between sensor-measured physical activity and cognitive performance in a sample

of 228 healthy older adults, aged 60 to 80

Published in the journal 'Psychology and Aging', the results showed that as expected, adults who engaged in more moderate-tovigorous activity had better speed, memory and reasoning abilities. However, the data also revealed that adults who spent more time sedentary performed better on vocabulary and reasoning tasks.

The association between increased physical activity and improved cardiovascular and metabolic health is one that's well documented, according to

Burzynska But the link between different intensities of daily physical activity and cognitive health is less understood, especially in older adults. 'We know that as we grow older,



even if we do not have any cognitive impairments, people aged 60 and up already show some decreases in speed, executive functioning, and memory.

"Those decreases are totally within a normal range, but this study was looking to understand how our behaviors and habits may correlate with cognitive outcomes in older age." said Burzvnska.

What differentiates this study

from others is the way the researchers measured daily physical activity, using scientifically validated sensors that are more accurate than the average, consumerbased activity tracker.

"If you ask, 'How long did you sit today?' people will perhaps say 2 to 3 hours when the reality is more like 6 to 8 hours," Burzynska said. The study employed a broad as-

sessment that tested 16 cognitive

He said all the focus has been on comparisons based on GDP measured at current, market exchange rates and this yields "conclusion" of Bangladesh eclipsing India. But market exchange rates are not appropriate for welfare comparisons across time and countries. Subramanian said, adding that GDP

per capita is an estimate for one indicator of the average standard of living/welfare in a country.

The former CEA said there is need to measure real GDP in local currency after taking out effects of inflation and then, convert all local currency estimates of real GDP into comparable dollars.

He noted that more appropriate basis is GDP at constant, purchasing power parity (PPP) exchange rates. Noting that India has no room for complacency. Subramanian said. "India will return to pre-COVID *LEVEL* of real per capita GDP only in 2022, 3 lost years.

According to the IMF, India is set to drop below Bangladesh in terms of per capita Gross Domestic Product (GDP) as the economy is projected

to contract by a massive 10.3 per cent this year. IMF's forecast for India -- a huge

downward revision from its previous prediction in June -- is also the biggest contraction projected among major emerging markets amid the COVID-19 pandemic.

However: India is likely to bounce back with an impressive 8.8 per cent growth rate in 2021, thus regaining the position of the fastest growing emerging economy, surpassing China's projected growth rate of 8.2 per cent, the IMF said in its latest World Economic Outlook' report.

Released ahead of the annual meetings of IMF and the World Bank, the report said global growth would contract by 4.4 per cent this vear and bounce back to 5.2 per cent in 2021.

in equal proportion. The loans would be sanctioned in two equal tranches.


REC also said it has sanctioned ₹2,790 crore to Jammu Kashmir Power Corporation Ltd (JKPCL) under the scheme.

Sharjah, Oct 17: Shikhar Dhawan (101 n o, 58b, 14x4, 1x6) made the most of his drop-chances and scored his maiden IPL century guiding Delhi Capitals (DC) to a splendid fivewicket victory over Chennai Super Kings (CSK) here, Saturday.

Chasing 180, DC were needed 17 runs off the final over. In spite of having an option in experienced Dwayne Bravo, MS Dhoni went with Ravindra Jadeja for the crucial over and it cost dearly. Axar Patel, who scored 5-ball 21, struck three sixes in four balls to complete the chase with a ball to spare.

He got another lifeline in the 10th over, dropped by Dhoni, a tough chance though. He was on 50. Ravudu was the next culprit who dropped a sitter of the left-hander. Dhawan, then, was on 79.

In spite of missing out on partners at the other hand, he made the most of his opportunity to guide his side home comfortably.

Premier League leaders Everton twice came from behind to level in an absorbing contest at Goodison Park. Michael Keane cancelled out Sadio Mane's third-minute opener and Dominic Calvert-Lewin did the same after Mohamed Salah scored his 100th goal for Liverpool.

Richarlison was sent off for a rash challenge on Thiago Alcantara and that indiscretion looked to have been doubly punished in injury time by Henderson, only for VAR to intervene and keep Everton three points ahead of Liverpool at the top of the table.

Liverpool needed only two minutes and 15 seconds to break the deadlock as a well-worked move saw the ball shifted out to Andy Robertson, whose low left-wing cross was side-footed into the roof of the net by Mane.
