Custodial deaths rock Puri, Biramitrapur

Bhubaneswar, Nov 19: Tension prevailed in Puri and Biramitrapur in Sundergarh district as news of two alleged custodial deaths spread Thursday.

While the state police sent the two bodies for post-mortems under the NHRC guidelines, the twin incidents sparked tension in both the localities as a large number of people protested both in Puri and Biramitrapur. In both the cases, the victims were picked up by the police and they died Thursday morning.

“Post-mortems are being carried out in both the places by teams of doctors as per the guidelines of the National Human Rights Commission (NHRC). The entire inquest is being videographed. The fact behind the incidents will come to the fore only after investigation,” DGP Abhay told reporters here.

In regard to the Puri incident, Superintendent of Police, Akhileshwar Singh said that a 32 year old man identified as K Ramesh died at the hospital early Thursday morning following a scuffle with police.

“A scuffle ensued when police attempted to catch Ramesh who was roaming along with a sharp weapon. Some police personnel have also sustained minor injuries during the scuffle,” Singh said, adding that the victim was a known criminal with a number of cases lodged against him in different police stations. The SP said that Ramesh was released from jail in

Angul district recently and was nabbed by police when he was going to commit a crime in Puri town.

The local people alleged that he was picked up by the police Wednesday night and hacked to death at Baselisahi Police Station. There were injury marks on Ramesh's body, they claimed.

Though the SP admitted that there was a scuffle between police and Ramesh, he rejected allegations of po-

lice personnel hacking him to death.

“A DSP rank officer of Human Rights Protection Cell of Odisha Police is probing into the incident and a team of doctors performed an autopsy of the body. Puri ASP has been monitoring the case,” Singh said.

Meanwhile, tension mounted in Puri town as a large number of people collected near the District Headquarters Hospital where post-

mortem of Ramesh was being carried out. Angry people attempted to barge into the hospital which was prevented by the police. A youth identified as Tarique Salim died at the Ispat General Hospital in Rourkela. He was arrested by the personnel of Biramitrapur police station Wednesday.

Sundergarh SP Sagarika Nath, however, denied the charges of custodial death. “The accused was unwell and was first admitted to the Kumarmunda hospital and then shifted to IGH as his condition deteriorated,” Nath said.

Following the death of the arrested person, some local people gathered in front of the police station and tried to barge into it.

In both the places, the local people demanded stringent action against the erring police personnel involved in the alleged custodial deaths. They demanded arrest of police personnel as Ramesh and Salim died in police custody.

This is not the first time that custodial deaths have rocked the state. According to National Crime Records Bureau, two accused died under mysterious circumstances in police custody in 2017. In 2018, two more accused who were brought on remand by police were later found dead in the custody. In 2019, four people died either in police custody or lockup.

In the last five years, none of the accused police officers have been convicted in these cases. [MORE P3](#)

₹1.5L compensation to fake encounter victim's family

BHUBANESWAR: The Odisha Human Rights Commission (OHRC) has directed the state government to pay Rs 1.50 lakh as compensation to the relatives of one Manda Kadraka, who was killed by security forces in a fake encounter near Dangamatia village under Kalyansinghpur Police station limits of Rayagada district February 27, 2016. The OHRC delivered the order after hearing two petitions filed by human rights activists Biswapriya Kanungo and Prabir Kumar Das seeking compensation for the deceased's next of the kin. The Commission perused the enquiry report submitted by Revenue Divisional Commissioner and DIG, South Western Range, Koraput before issuing the order. The Commission received the enquiry report from RDC and DIG, South Western Range June 20 and November 3 in 2016. The OHRC bench also rejected the authorities' claim that the deceased was a Maoist cadre as they failed to present any evidence to corroborate their claims. Both, the DGP and Principal Secretary of the state Home department have been directed to pay the compensation within two months from the receipt of the order. According to sources, Manda, a tribal youth was killed during a joint anti-Maoist operation by the teams of Border Security Force (BSF) and District Voluntary Forces (DVF) in a forest area near Dangamatia village in 2016.



Mystery shrouds OSWC staff's death

Bhubaneswar, Nov 19: An employee of the Odisha State Warehousing Corporation (OSWC) died here Thursday under mysterious circumstances. The deceased, Prasant Kumar Rath, was a resident of Berhampur. Rath, a driver of the Managing Director of the corporation, was staying at E7/1 at Unit VIII area under Nayapalli police limits here, police said.

Sources claimed there is a conspiracy behind Rath's murder as the scared family has been trying to conceal his death. When asked by this reporter, his wife claimed Rath has gone to Berhampur on official work.

According to sources, three bike-borne miscreants arrived at his residence when Rath was starting his vehicle to take his son to tuition early Tuesday morning. The miscreants suddenly started beating him black and blue without speaking anything to Rath. They also assaulted and stabbed his back with a sharp-edged weapon.

However, the miscreants fled from the spot when some neighbours rushed to his help after hearing Rath's loud screams.

Rath later went to a nearby hospital for treatment and attended office as usual. He also lodged a complaint at the Nayapalli police station alleging murderous attack on him by unknown people.

However, he was rushed to Capital Hospital after he complained of unease

Wednesday evening. He succumbed to his injuries at the hospital at around 6am Thursday. His body was handed over to the family after post-mortem. A case (450/20) was registered by Nayapalli police under Section 307 (at-

tempt to murder) of IPC which has since been transformed into Section 302 (murder) of the IPC. Sources in the police said this seems to have been a planned murder as there is no loot angle in it. The miscreants did not take away his mobile phone, vehicle or demand money from him, police said, adding that investigations are on.

Miscreants loot ₹10cr in Cuttack

CUTTACK: Some unidentified armed miscreants allegedly looted cash worth ₹10 crore at gun point from a finance company in Nayasarak here Thursday. Sources said the miscreants armed with weapons barged into the bank and held the security personnel and other employees at the bank hostage at gunpoint. They then took away the cash amounting to ₹10 crore and ornaments before fleeing from the bank premises. Cuttack DCP Prateek Singh after being informed has reached the spot. Disparate readings of economy baffle many

Bhubaneswar, Nov 19: Moody's, Barclays and Oxford Economic have put out their latest readings of the India economy. However their prognosis appears so dichotomous that they make for a hilarious reading. While Barclays and Moody's have seen signs of green shoots following a few recent policy initiatives by the government, Oxford Economic has painted a much gloomier picture. It said the country's output will be 12 per cent below the pre-pandemic levels through the middle of this decade and things are going to worsen only.

Moody's Investors Service Thursday upped India's growth forecast to (-) 10.6 per cent for the current fiscal, from its earlier estimate of (-) 11.5 per cent, saying the latest stimulus prioritises manufacturing and job creation, and shifts focus to longer-term growth.

Moody's said the latest measures aim to increase the competitiveness of India's manufacturing sector and create jobs, while supporting infrastructure investment and is "credit positive" as it presents potential upside to growth forecasts. "We have revised our real, inflation-adjusted GDP forecast for fiscal 2020 (April 2020-March 2021) to a 10.6 per cent con-

traction, from 11.5 per cent drop previously," Moody's said.

On the other hand, British multinational investment bank and financial services company **Barclays** Thursday revised India's GDP forecast for FY22 to 8.5 per cent from 7 per cent earlier as the economy is seeing faster return to normalcy with recovery in both consumption and investment following government's fiscal and monetary stimulus measures.

Barclays said that flattening of Covid-19 curve in the country and the prospect of an effective vaccine early next year alongside high seroprevalence of antibodies across the population support the case for a more durable economic recovery.

Differing from these two projections, **Oxford Economics** says India will be among the worst-hit major economies of the world even after the Covid-19 pandemic disappears. According to the study, the country's output will be 12 per cent below the pre-pandemic levels through the middle of this decade.

The balance sheet stress that had been building before the coronavirus outbreak will probably worsen, Priyanka Kishore, head of economics for South Asia and South-East Asia, wrote in the report. She projects potential growth for India at 4.5% over the next five years, lower than 6.5% before the virus.

Bihar edu minister resigns

Patna, Nov 19: Bihar Chief Minister Nitish Kumar's fourth term started with the resignation of a minister three days after he and his 14-member Cabinet took oath. Education minister Mewalal Choudhary had to step down after the Opposition Rashtriya Janata Dal flagged a three-year-old corruption case against him and questioned why he was inducted in the government.

A criminal case was filed against the JD(U) MLA from Tarapur back in 2017

after allegations that he was involved in irregularities in the appointments to posts of assistant professor and junior scientists as the vice-chancellor of Bhagalpur agriculture university.

He was suspended from the party for a while after jibes from the BJP, which was in the Opposition at the time.

Chaudhary had been named an accused in a five-year-old case relating to alleged irregularities in appointment of teachers and technicians at Bihar Agricultural University, Bhagalpur, where he was the Vice Chancellor.

Assembly Winter Session starts today

GOVERNMENT EYES TO PASS 10 BILLS INCLUDING THE CONTROVERSIAL AGRI MARKET BILL

Bhubaneswar, Nov 19: The 40-day Winter Session of state Assembly is all set to begin Friday with strict adherence of Covid-19 norms. Like the Monsoon Session, this session of the Assembly will be conducted following Covid norms including wearing mask, face shield and maintaining social distance. The seating arrangements for the members have been made accordingly.

The session will continue till December 31 and the House proceedings will be for four-and-a-half hours each day. On the first day, Finance Minister Niranjana Pujari will present the Supplementary



Budget worth ₹12,700 crore for the 2020-21 fiscal.

Of the total 40 working days, 31 days have been earmarked for official business, while the House will discuss the demand for grants November 26, 27 and 28. The Appropriation Bill on the first supplementary statement of expenditure will be tabled November 29, said Parliamentary Affairs Minister

Bikram Keshari Arukha.

The Private Members' Business (Bills and Resolutions) will be tabled on five days – November 25, December 4, 9, 11 and 18. As in the last Monsoon Session, the Assembly will be held even on Sundays, he said.

The session likely to be stormy as the state government plans to pass 10 Bills, including the controversial Odisha Agriculture Produce & Livestock Marketing (Promotion & Facilitation) Bill for which an Ordinance has been already promulgated. Even though the BJD has opposed the farm Bills brought by Centre in both Houses of Parliament, it will bring one such Bill in the Assembly

The Factories (Odisha Amendment) Bill, the Contract Labour Regulation and Abolition (Odisha Amendment) Bill, the Odisha Maritime Board Bill and the Odisha Industrial Infrastructure Development Corporation Amendment Bill are likely to be passed during the session.

Similarly, the government will also table the Odisha Local Fund Audit Amendment Bill, the Odisha Lokayukta Amendment Bill, the Odisha Essential Services Maintenance Amendment Bill, the Societies Registration (Odisha Amendment) Bill and the Odisha Public Libraries Amendment Bill on the floor of Assembly.

BBC to probe explosive 1995 Princess Diana interview

THE PRINCESS' BROTHER CHARLES SPENCER HAS ALLEGED THAT THE FLAGSHIP "PANORAMA" PROGRAMME REPORTER MARTIN BASHIR, WHO CONDUCTED THE INTERVIEW, SHOWED HIM FAKED DOCUMENTS TO PERSUADE HIS SISTER TO TAKE PART

London, Nov 19: The BBC announced Wednesday the immediate start of an investigation into how it obtained an explosive 1995 interview with Princess Diana that lifted the lid on her troubled marriage to Prince Charles.

The corporation said it had approved the appointment of former Supreme Court judge John Dyson to lead the probe, which comes after calls from the late princess' brother, Charles Spencer.

Spencer has alleged that the flagship "Panorama" programme reporter

who conducted the interview, Martin Bashir, showed him faked documents to persuade his sister to take part.

In the November 1995 interview, which was watched by a record 22.8 million people, Diana detailed her collapsing marriage to the heir to the throne.

She famously said "there were three people" in her marriage – herself, Charles and his long-time lover Camilla Parker-Bowles – and also revealed she had been unfaithful.

Diana and Charles formally divorced in 1996. She died in a Paris car crash the following year.

New reports have surfaced alleging that Bashir used underhand methods to persuade Diana to talk, including by claim-

ing her own staff members were being paid to spy on her.

"This is an important investigation which I will start straight away," Dyson said in a statement. "I will ensure it is both thorough and fair."

The BBC set out the terms of reference for the probe, focusing principally on the role of Bashir, who was little-known at the time but went on to have a global career.

It will consider "the mocked-up bank statements purporting to show payments to a former employee of Earl Spencer... (and) the purported payments to members of the Royal Household".

It will also look at revelations made by Spencer this month about Bashir to the

Daily Mail, which said the reporter made "lurid claims" about Queen Elizabeth II, Charles and other royals.

Bashir has not responded to the latest claims. The BBC has said he was seriously unwell after contracting the coronavirus.

The BBC has been accused of a cover-up in a previous inquiry when rumours about Bashir's alleged methods first surfaced.

The publicly funded broadcaster said its latest investigation will be published once completed.

"The BBC is determined to get to the truth about these events and that is why we have commissioned an independent investigation," director-general Tim Davie said.

Akshay Kumar files ₹500 crore defamation suit against YouTuber

Mumbai: Khiladi actor Akshay Kumar has filed a defamation suit of crores against a YouTuber who brought up his name while spreading fake news.

Akshay has served a Rs 500-crore defamation suit against Rashid Siddiqui, a civil engineer from Bihar, who brought up his name in the Sushant Singh Rajput case.

He named Akshay on several occasions in his videos and levelled various allegations. In one instance,

Siddiqui claimed that Akshay was unhappy with Sushant getting big films like *MS Dhoni: The Untold Story*, and alleged that the actor had 'secret meetings' with Aditya Thackeray and the Mumbai Police.

Siddiqui had also linked Akshay with late actor Sushant's girlfriend, actress Rhea Chakraborty, claiming that the actor helped Rhea to escape to Canada. It is believed that Siddiqui earned around Rs 15 lakh in a span of four

months and his subscribers also grew from 2 lakh to over 3 lakh. Siddiqui was earlier arrested for spreading fake news and dragging the name of Maharashtra Chief Minister Uddhav Thackeray and his son, minister Aditya Thackeray, in the case. IAN S

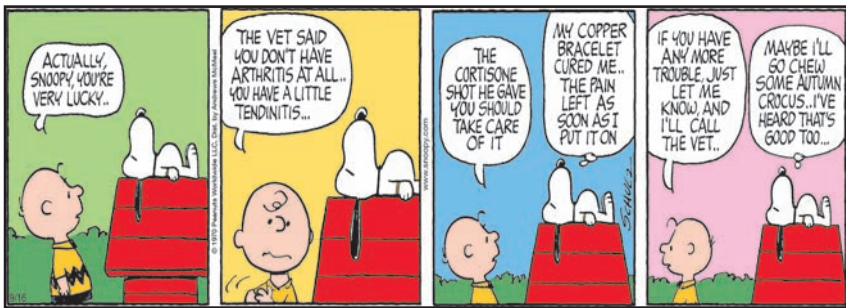

tions, good and bad. It causes material losses in order to force a more spiritual outlook in a person.

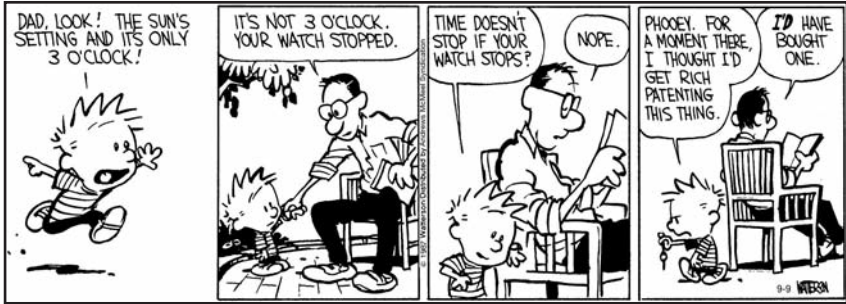

The film is shot and edited in isolation by Amartya at Bhubaneswar.

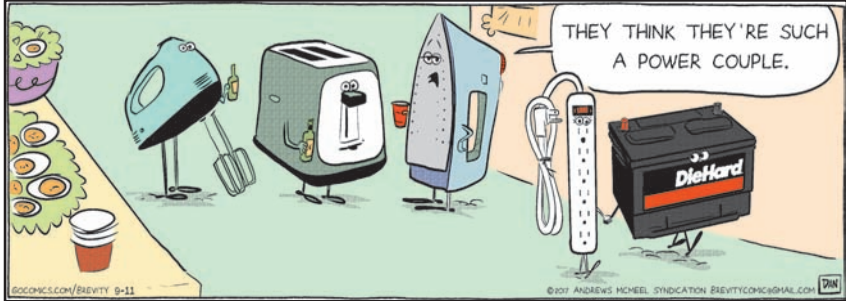

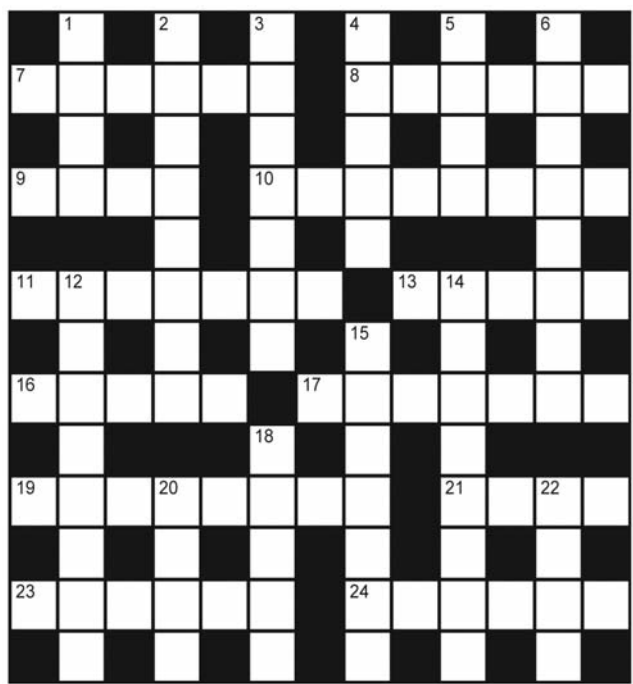

Deaths in custody trigger stir

Puri/Kuanrmanda, Nov 19: Tension prevailed in Puri and Sundargarh, Thursday, over the alleged death of two persons in police custody with the BJP demanding ₹1-crore compensation to the family of the deceased.

Relatives of deceased K Ramesh in Puri alleged that the 32-year-old died due to torture in police custody. However, Puri Superintendent of Police (SP) Akhileshvar Singh rejected the allegation and claimed that Ramesh died Wednesday following a scuffle with police.

Singh claimed that Ramesh had earlier been booked in four cases at different police stations in Puri. "Ramesh had snatched away ₹5 lakh from a person under Puri Sadar police limits after resorting to firing. He was booked by Sea Beach police for extortion and by Kumbharpada police for some other crimes. He had been released from Angul jail recently," Singh said.

The SP said the case would be thoroughly probed as per the guidelines laid by the National Human Rights Commission (NHRC) to deal with custodial death allegation.

"A case has been registered with Baselisahi police under Sections 341, 323 and 307 of IPC. The Human Rights Protection Cell (HRPC) DSP will probe the incident while the Additional SP will supervise the investigation," said the SP.

Relatives of Ramesh, however, said, "Ramesh died due to torture in police custody. Police have also detained his parents. Police did not hand over the body to us after postmortem. They hurriedly cremated the body at Swargadwar without informing anything to

us," they alleged. The incident triggered protests from various quarters. Activists of Congress and BJP along with the locals held a sit-in in front of the DHH. They also scuffled with the police when the latter did not allow the victim's body to his relatives. The activists later held a demonstration in front of the SP office.

"There is no truth in the version given by the SP. If somebody has committed a crime then there is the judiciary to punish him. Who has given police the power to torture an accused? Police officials must change their attitude towards people," said Congress leader Binayak Dasmahapatra.

On the other hand, a BJP delegation led by Leader of Opposition in Odisha Assembly Pradipta Naik, met the relatives of the deceased and sought an investigation by a sitting judge. The BJP delegation also sought ₹1-crore compensation for victim's family and stripping the SP of his duties.

BJP likens Odisha to Pakistan

Bhubaneswar: The state unit of BJP Thursday launched a scathing attack on the ruling BJD for the two custodial deaths by likening the law and order situation in the state to that of Pakistan. BJP MLA Jaya Narayan Mishra said, "The police officials who are involved in this should be booked under Section 302 (murder). There are daylight cases of loot in Bhubaneswar. Those going against the government are facing the wrath of the ruling dispensation. There is no difference between Pakistan and Odisha. In Pakistan, army is everything and in Odisha, bureaucrats hold the supreme power. There is no major difference between the two." Leader of Opposition in the Assembly, Pradipta Naik, demanded stringent action against the policemen involved in the custodial deaths. He said, "Today is a black day for Odisha as two people have been killed in police custody in Puri and Sundargarh districts. I condemn the incidents. The bodies should have been given to the family members of the deceased after the postmortem which was not done. Signatures were taken from their family members through forged papers."

Govt to suspend DLs of helmetless bikers

Bhubaneswar, Nov 19: The state government has asked police and other Motor Vehicle (MV) law enforcement authorities to suspend driving licences (DLs) of people, who are caught riding motorcycles without helmets.

Following the instruction of Supreme Court Committee on Road Safety, Commerce and Transport secretary Madhusudan Padhi has instructed the Director General of Police and Transport Commissioner to impose ₹1,000 fine and suspend DL for three months for violation of helmet law.

"You are requested to take steps for suspension of DL of the offender in case of detection of violation of helmet law and also closely monitor its implementation," Padhi said in his letter.

The DGP and Transport Commissioner were asked to submit a district-wise report on suspension of DL for violation of helmet law during 2019 and during January to October 2020 for appraisal of the Supreme Court Committee.

During 2019, two-wheelers were involved in 4,688 road accidents out of total 11,064 road accidents. As many as 2,398 riders or pillion riders died against the total deaths of 5,333. Out of the 2,398 people died, 2,156 were not wearing helmets at the time of accident. Besides, about 8.5 lakh persons have been detected by police and Odisha Motor Vehicles Department (OMVD) officers violating the helmet law during last year.

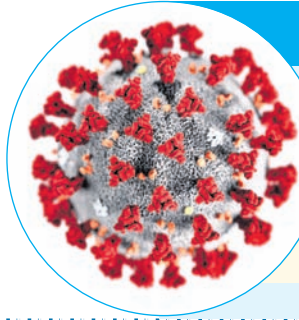

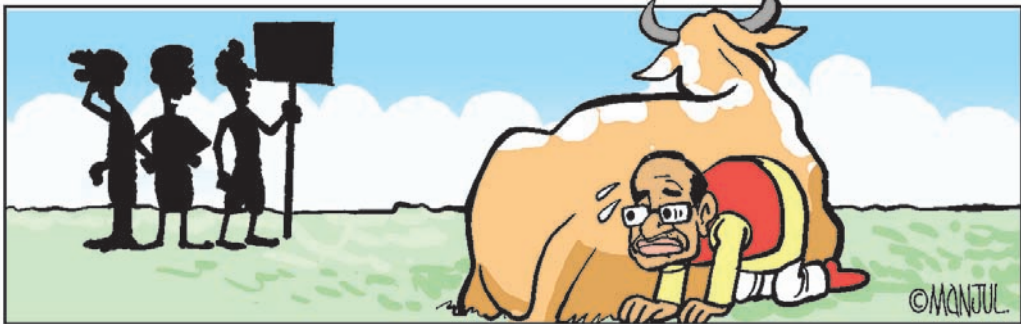

Finance co robbed of over ₹10cr

Cuttack, Nov 19: Four armed robbers decamped with gold and cash worth around ₹10 crore from the office of a finance company in Cuttack Thursday, police said.

The robbers held the staff of the India Infoline Finance Limited (IIFL) in a room at gunpoint and decamped with the booty, breaking open the cash and gold lockers, they said. The incident happened in the Lalbagh police station area.

"Four men with their faces covered with masks, entered the office when the shutter was opened for the day's work. Soon, they pulled out guns from their bags and asked the staff to get inside a room as they downed the shutters from inside. Forcibly snatching the locker keys, they decamped with cash bundles and gold bags," said IIFL branch manager Satyabrata Pradhan. The company deals in loans against gold, and the exact value of cash and gold robbed will be ascertained after checking the accounts, he said.

As per initial estimates, gold and

cash worth over ₹10 crore have been robbed, he said. The robbers had come in two motorcycles and they were speaking in Hindi and Odia, he added. Following the daylight heist, the police conducted several raids after sealing both entry and exit points of the city, Cuttack's Deputy

Commissioner of Police Prateek Singh said. Several teams have been formed for conducting raids and search operations, he said.

Forensic teams have also been requisitioned to assist the investigation and a breakthrough is expected soon, the officer said.

3 NEW MEDICAL COLLEGES BY NEXT YEAR

Thermal Power Corporation (NTPC) is extending support to the medical college at Sundargarh. The institutions would run through a trust on 'no profit no loss basis'.

Tripathy directed the concerned officials to complete furnishing of the building for Sundargarh medical college by December 2020 and move Medical Council of India (MCI) for necessary permission to commence admission from next academic session.

Puri, Nov 19: Vigilance sleuths of Bhubaneswar division arrested Nimapara assistant horticulture officer (AHO) Ramakanta Parida on charges of demanding and accepting a bribe of Rs 10,000 Wednesday evening.

Acting on a complaint lodged by Samantray in this regard, the anti-corruption agency laid a trap. The officer was caught red-handed by the Vigilance team while accepting a bribe at his office room.

Notably, a residential house of Parida at Mukundaprasad area in Khurda district was searched by the officials. A case in this connection under Section 7 PC (Amendment) Act, 2018 was registered and a detailed probe is underway, an official of the team said.

Choudwar, Nov 19: Police Thursday recovered the decomposed body of a man, aged about 50, wrapped in a polythene sheet.

As the packet was unwrapped, the police found a decomposed body with hands and legs tied inside it. The police's preliminary investigation suggested that after murdering him somewhere else, the miscreants had dumped the fully wrapped up body by the roadside.

State's Covid-19 toll nears 1,600

Odisha registers 868 fresh coronavirus cases, 17 fatalities in 24 hours

Bhubaneswar, Nov 19: State's Covid-19 tally rose to 3,11,788 as 868 more people tested positive for the infection, while 17 more patients succumbed to the infection in the last 24 hours, pushing Odisha's coronavirus death toll to 1,592, an official of Health and Family Welfare (H&FW) department said Thursday.

As many as 499 new cases were reported in quarantine centres, while 369 infections were detected during contact tracing exercise, the official said.

Khurda district, under which Bhubaneswar falls, reported the highest number of fresh cases at 126, followed by Sundargarh at 87 and Cuttack at 64, said the official.

Four fresh fatalities were reported in Sundargarh, three in Sambalpur, two in Khurda and one each in Bhadrak, Cuttack, Gajapati, Ganjam, Kendrapara, Nayagarh, Rayagada and Subarnapur districts, the official pointed out.

Khurda has so far reported the highest number of Covid-19 fatalities at 272, followed by Ganjam (234), Cuttack (126) and Sundargarh (110), said the H&FW department official.

SC seeks NHRC report
on Kandhamal riots

New Delhi, Nov 19: The Supreme Court Thursday granted liberty to the state of Odisha to file a report of the National Human Rights Commission (NHRC) in connection with Kandhamal riots case.

A three-judge bench of the apex court comprising Justices UU Lalit, S Ravindra Bhat and Vineet Saran observed that the petition filed by Archbishop John Barua needs to be heard in length and posted the matter to January 13 next year.

During the hearing, advocate Shibashish Misra, appearing for the state government, referred to the NHRC report on the Kandhamal riots and submitted that the apex court's 2016 order for additional compensation was confined to 2008 riots victims only.

Significantly, a contempt petition was filed by Barua in SC saying that compensation has not been paid by the state government to victims of 2007 riots. The petitioner contended that the apex court's directions in 2016 were to give additional compensation to all victims of Kandhamal riots. He submitted that the state government has given additional compensation to 2008 riots victims but they have been completely neglecting victims of 2007 violence.

Notably, at least three persons were killed and over 100 churches and church institutions, including convents and hostels, about 700 houses and other structures were burnt in the riots which devas-

Raisuan airstrip renovation grounded

Raisuan, Nov 19: Mineral rich Keonjhar district generates hundreds of crores of rupees as revenue from its mining sector, but renovation of its only airstrip at Raisuan has been left halfway when work on the airports at Rourkela, Jeyapore and Kalahandi is heading towards completion, reports said.

Various quarters in Keonjhar have decried the step-motherly neglect of the Centre to the airstrip as the project holds much importance to mineral-rich Keonjhar in terms of air connectivity necessary for quick travel of mineral traders, bosses and miners.

The Centre has been developing small aerodromes and airports across the country under Ude Desh ka Aam Naagrik (UDAN) scheme.

It may be mentioned here that Raisuan airstrip is said to be one of the oldest in the country. Alleged neglect to it has wounded sentiments of the people. Reports said Jharsuguda airport has been operational while development of other airports at Rourkela, Jeyapore and Kalahandi is in progress; their work is expected to be completed within the deadline. Raisuan airstrip is only 7 km from Keonjhar town. The district is rich in terms of mineral reserves and

industries. According to mining and industrial experts, both the state and central governments have been earning thousands of crores of rupees from mining and industrial sectors, but they have forgotten to pay due attention to the development of the airstrip, which can boost communication to economic pockets, they lamented.

In view of the need for air connectivity for the mineral rich district, the state government had sent a proposal to the Centre to develop the airstrip January 21, 2016.

The public works department

had conducted a survey and proposed to the state government for acquisition of 22 acres. A plan was drawn up to develop it into a low cost airport. Then a high level delegation of the Airport Authority of India (AAI) had visited the project area. In 2011-12, ₹1 crore was spent for raising a boundary wall. Besides, a runway with 920ft long and 30 metre wide was blacktopped. Thereafter, there has been no progress on its renovation, locals alleged.

It may recalled that prominent leaders like Indira Gandhi, Rajiv

Gandhi, Biju Patnaik and mining barons have landed and taken off from the airstrip.

Although the airstrip has seen many take-offs and landings, there have been no records for it.

From May 2010 till date, the airstrip has seen landing of over 400 planes, it was learnt.

People from various quarters have demanded quick steps by the state and central governments to make the airstrip full-fledged and operational in the larger interest of the mining and the industrial sector in the district.

Kuchinda Union Bank loot: 9 held, ₹10L recovered

Sambalpur, Nov 19: In a major crackdown Thursday, police arrested nine persons including a minor in connection with the loot of over ₹35 lakh from the staff of the Union Bank at Kuchinda in Sambalpur district November 9.

This information was given by SP Kanwar Vishal Singh here. Kuchinda police have recovered over ₹10 lakh from those arrested. Eleven persons were involved in the heist and two are still absconding, Singh added.

Those arrested were identified as Gobinda Kisan (24), Dillip Bag (22), Biswanath Kisan (35), Amaresh Kisan (25), Sumanta Lakra (26), Chitrasen Lakra (22), Rohita Naik (34), Umesh Sahu (32). Police however, did not disclose the name of the juvenile.

Some staff of Laimura branch were on their way back from the main branch of Union Bank in this city carrying ₹35,41,000 in a private vehicle when they were was looted. Further investigation into the incident is on.

Hatadihi, Nov 19: The riverbed of Baitarani under Hatadihi block in Keonjhar has been a hunting ground of sand mafia. Even as the mafia keeps on transporting truck-loads of sand, the government loses revenues worth crores of rupees, a report said.

The report said, the lease term of Dimiria and Habaleswar sand ghats has expired earlier this year.

However, the mafia has been carrying out extraction of sand at non-lease ghats of the river. They have created a road on which scores of heavy vehicles carry sand, locals alleged.

JCB machines have been engaged to dig out sand. Locals feared that the way sand was being excavated at the place will lead to erosion of river banks. The river may change its course, posing danger to over 30 riverside villages, local

residents said, accusing the revenue department of adopting an ostrich like attitude.

There are nine flood-prone panchayats under this tehsil. Rampant sand mining may worsen their condition in future.

Additional tehsildar Rashmيرانjan Das said he was not aware of the places where illegal sand mining and transportation are taking place. "If information is given, raids will be conducted," he added.

Two killed in jumbo attacks in Sundargarh

Rourkela, Nov 19: In two separate incidents that occurred in the wee hours of Thursday, two persons were killed after they were attacked by elephants at two places under Lathikata block in Sundargarh district. Ganduru was working in a garden near his house when a tusker came out of nowhere and trampled him to death. The victim did not have a chance even to react and run away. Arrival of migratory birds to Chilika lake delayed

Krushnaprasad, Nov 19: Even as it is a fortnight since winter has set in here, few birds have arrived in Chilika and its adjoining areas in Puri district, a report said.

The Chilika lake is the largest brackish water lake in Asia which comes alive in winter with a cacophony of the migratory birds. The whole area of the lake and its adjoining areas of Krushnaprasad turn into a paradise as the migratory birds arrive in large numbers.

The arrival of the birds draws tourists to the place. However, this year the number has dropped due to a change in climatic condi-

tions. Observers claimed that the low-pressure triggered heavy rainfall in the month of October is the reason behind the delay in arrival of birds.

While fewer birds are seen hovering over the lake, very few were seen in Parikuda, Gurubai, Nuapada, Sipia, Anlakuda, Tichhini, Panchakudi, Banamal, Chateikona, Solakudi, Panda, Chikhili, Chitrakota, Khataikudi, the areas near the coast of Chilika lake.

Moreover, areas under this block are experiencing a near drought condition due to germination blight affecting the paddy crops further delaying the arrival of birds, the observers claimed. This has also hit

the business in the area as the number of tourists is expected to come down.

The birds visiting the lake come from as far as Mongolia, Siberia, Kazakhstan, Himalaya, Caspian Sea and Australia. They travel thousands of miles to reach the lake.

Birds usually start arriving at Chilika in November as it is comparatively more hospitable habitat compared to the extreme freezing conditions in Siberia, China, Japan and other countries in the northern hemisphere.

The birds often frequent open wetlands like Chilika lake due to easy availability of fish, prawns, frogs, snakes and mollusks and paddy grown on farmlands.

The Nalabana island or Nalabana bird sanctuary in Chilika is the most favoured destination of the birds as winter sets in the state from November.

The forest department has initiated several measures to ensure the safety of birds and is conducting awareness camps to prevent poaching of birds, Balugaon and Nuapada range officer Pramod Kumar Panda said.

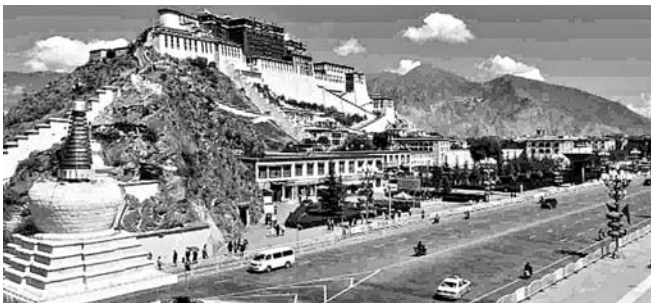
Ease procurement

Paddy procurement is arguably the most important agri-business activity in the state that runs for five months in two phases with a nearly two months' gap. It constitutes a key part in the state's overall economy. This year, the state government has maintained more or less the same procurement target. It will procure 71 lakh MT of paddy – a rise of just 50,000 MT from last year. Ever since Odisha was declared a decentralised procurement (DCP) state in 2004, the volume of procurement has been gradually going up with every passing year. The Odisha State Civil Supply Corporation (OSCSC) is the nodal agency for procurement here. From mere 5-6 lakh metric tonnes in 2004-05, the size has gone up to over 70 lakh (MT), which works out to approximately 45 lakh MT of rice per year. The uptick in the volume indicates a rise in production and a corresponding rise in consumable surplus. What does this rise in target indicate? In the absence of minimum support price (MSP) for other crops, farmers have no option but to cultivate paddy on maximum land that they own. However, the flawed system deprives many farmers of availing the benefits of MSP. First, the government is not very keen to augment the size of paddy procurement. It spends over Rs 12,500 crore every year on buying paddy from farmers at MSP. Add to that other incidental expenses like money spent on gunny bags and administrative expenses. While the Centre is supposed to bear the entire financial burden of MSP, the OSCSC borrows the funds upfront from banks to buy paddy. In recent years, the Centre has delayed releasing the funds to OSCSC and this has resulted in ballooning the loan and the consequent interest. This is the prime reason why the corporation is not showing much interest to increase the volume of procurement. While farming is the main calling of over three quarters of people in Odisha, an overwhelming majority of them cultivate paddy as the crop is supported by MSP. Yet, there has not been a single year when the MSP delivery has been hassle-free. Like in the past, this year also farmers in western Odisha are up in arms against the token system. The system mandates that farmers wishing to avail MSP must secure tokens 15 days prior to sale. The date of sale and the quantity of paddy to be sold are mentioned in the token that is sent to the farmer through his/her mobile number. Beneficiaries regardless of where they live have to register themselves with the centralized system that is operated from Bhubaneswar. The system has proved counter-productive. Farmers are forced to store their produce waiting for tokens and the prolonged wait dries up the crop resulting in loss of weight. Farmers have no idea when they will get the elusive tokens. The system more often than not malfunctions. Farmers who have not even harvested their paddy are given tokens while those post harvest keep waiting for tokens. The government must review the token system. There have been protests by farmers in Bargarh and Kalahandi where procurement began last week. Protests may intensify as the system is delaying procurement. Adding to the mess are incidents of middlemen getting tokens by enlisting the names of fake farmers. In Jeypore, bogus farmers have been registered by middlemen to avail the benefits of MSP.

The token system must be reviewed forthwith as it is inherently faulty. It is difficult for people sitting in Bhubaneswar to know when the farmer in a village in Bargarh will harvest his paddy and sale it. Further, the size and yield of harvest is different in different parts of the state. Therefore the policy of one size fits all may not be ideal. The urgency of sale and the logistics involved in the exercise can be better handled if the decision-making power is vested with local level authorities. The centralized system has made the process rather sluggish. Farmers are made to watch their stocks at market yards during day and night in winter as they wait for their tokens. Lured by higher MSP (Rs 2500/quintal) in Chhattisgarh, traders are seen falling head over heels to buy paddy from western Odisha. Higher MSP in the neighbouring state has always attracted traders/middlemen to buy paddy from Odisha at lower rates and sell it in Chhattisgarh at a premium. The token system is pushing farmers to traders leading to distress sale. This is time the government reviewed the system.

Zhao Lijian, spokesperson for the CCP Foreign Ministry was quoted stating that the global community is falsely accusing CCP of manipulating the Mekong river. However, there is presently a drought-like situation along the Mekong river, while Chinese reservoirs across Tibet are overflowing and causing wide-scale flooding in West and Central China. While there is still hope for a late flood season in the Mekong this year, reservoir levels so far are similar to those in 2019, when the entire region was hit by a severe drought. The economies of Myanmar, Thailand, Laos, Cambodia and Vietnam could be significantly affected by such diversion of the waters of the Mekong.

Similarly, regular discolouration in the waters of the Brahmaputra has led to concern in India about undiscovered up-river construction, which could hurt both India and Bangladesh. Pertinently, the CCP continues to avoid any water sharing agreements in the region. With a looming 'food crisis' in China, Xi Jinping

and his CCP are likely to accelerate their efforts to capture Tibet's fresh water reserves for their use. Urgent, coordinated and persistent international effort will be required to defeat this strategy of the CCP.

Further, ongoing socio-political efforts of the CCP in Tibet also need to be addressed. Ever since the CCP Army's illegal annexation of Tibet in 1950, the Tibetan people have been forced to change their way of life. They have been forced to abandon their villages, traditional livelihoods and freedom to practice their faith, to survive under the CCP regime. Large-scale relocation of CCP functionaries to Tibet has caused a change in the region's demography. In recent years, there has also been rapid militarisation of the entire Tibetan region, which has strengthened the CCP's political hold and increased the vulnerability of the indigenous peoples. This is a travesty given that Tibet is the abode of Buddhism, one of the most peaceful religions in existence.

With His Holiness, the 14th Dalai Lama Tenzin Gyatso already in his 85th year and the current Panchen Lama Gedhun Choekyi Nyima captured by CCP since 1995, the Tibetan Buddhist community may indeed face a leadership void in the times to come. The CCP 'approved' Panchen Lama has been visible in China, but re-

ceives limited support from the Tibetan Buddhist community. This problem is exacerbated by CCP's insistence that the next Dalai Lama must be 'approved' by the party. Simply put, Xi Jinping will decide who will be the 'living god' for Tibetan Buddhists!

Moreover, the recent call to reinforce 'Socialism and Chinese considerations' in Tibet implies that the re-education camps of Xinjiang, where millions of Uighurs have been 'indoctrinated' are likely to be replicated in Tibet. This would have drastic implications for the entire Tibetan Buddhist Community, who are already facing an uncertain and vulnerable future.

It is therefore imperative that the global community recognises the threat being posed by the CCP's nefarious designs in Tibet. A unified global call to counter CCP is vital for the survival of the Tibetan Buddhist Community as well as the continued growth and security of developing economies across Asia. The global response would require three actions by the CCP as a demonstration of good faith and intentions – meaningful demilitarisation of Tibet to safeguard the local community, comprehensive water-sharing and management arrangements with all lower riparian nations and independent international oversight of infrastructure building activity in Tibet to prevent environmental and economic disasters in Asia.

Xi Jinping and the CCP leadership are at crossroads, where the false narrative of 'peaceful rise of China' narrative has finally been discarded. With growing global discontent against CCP, a coordinated global response to save Tibet would demonstrate that the comity of nations can indeed enforce a 'rules-based global order'. In the long run, such action would also ensure that 'Asia's Century' delivers on its immense potential, bringing further prosperity across the globe.

Global South's path to self-reliance

Covid-19 continues to have a devastating impact on public health and to rattle the global economy with structural shocks. The pandemic has now killed more than one million people, while the International Monetary Fund estimates that global GDP will shrink by 4.4% in 2020. But, strange as it may seem, the current crisis could offer developing countries a path toward greater economic self-reliance.

This is partly because developed countries have in general borne the brunt of the pandemic's health effects so far. Many advanced Western economies have experienced more Covid-19 cases and deaths relative to their populations than have developing countries of the Global South, despite their superior healthcare systems and stronger social safety nets. For example, India's health system ranks 112th globally, while that of the United States ranks 37th. But whereas India has so far reported about 6,400 Covid-19 cases per million population, America's tally is more than four times higher.

Some developing countries like Vietnam combated the coronavirus effectively by introducing strict testing, tracing, and quarantine measures at a very early stage – something most developed countries failed to do. Even after allowing for possible underreporting

and data inaccuracies in poorer countries, the relative performance of developed economies remains a paradox.

Moreover, development financing has already started to plummet as richer countries focus on engineering domestic post-pandemic recoveries. The OECD estimates that external private finance in flows to developing economies could decrease by \$700 billion year on year in 2020, exceeding the impact of the 2008 global financial crisis by 60%. Non-resident portfolio outflows from emerging markets totaled \$83.3 billion in March 2020 alone, according to the Institute of International Finance. And the OECD thinks global foreign direct investment (FDI) will drop by at least 30% this year, with flows to developing economies likely to fall even more. Such trends imply a grim outlook for Global South countries that historically have largely relied on development aid from the Global North.

But studies have shown that development aid and humanitarian assistance do not necessarily foster economic empowerment. A recent OECD survey found that between 48% and 94% of respondents in developing countries do not believe that humanitarian assistance helps them to become economically self-reliant. People want financial autonomy, not prolonged assistance.

Even before Covid-19 struck, many developing economies had been looking for ways to make a sustainable shift from aid dependency to self-reliance. In 2018, Rwanda banned second-hand clothes imports with the aim of encouraging its domestic textile industry to produce higher value-added garments; the US responded by ending the country's duty-free export privileges. And last year, the United Kingdom's government allocated part of its £14 billion (\$18.5 billion) aid budget to capacity-building projects intended to help developing countries increase their international trade and attract FDI.

Today, developing countries have more opportunities to become self-reliant. For starters, trade in developing East Asia has declined less sharply than in the West during the pandemic, according to the World Trade Organization. A key reason for this is that industries producing high value-added goods usually suffer more during downturns. Developing countries' greater resilience, stemming from their reliance on low value-added manufacturing, is evident in Vietnam's textile and garments sector, which has remained operational throughout the pandemic and is expected to have a swifter recovery in 2021 compared to their regional competitors.

Second, digitization will play a crucial role in the post-pandemic

recovery by significantly boosting e-commerce, which implies a fairer competitive playing field for producers around the world. Bangladesh's e-commerce sector grew by 26% year on year by August, and other South Asian countries show a similar trend.

Third, the health-care and pharmaceutical sectors are expected to thrive in the post-pandemic economy as people become more aware of the importance of health and fitness. Least developed countries can take advantage of World Trade Organization provisions by producing more generic drugs, which face no patent-related obstacles.

Finally, governments in the Global South can mobilise domestic resources to offset the decline in external development finance – in particular by transforming their tax policies to generate revenue from fast-growing digital economic activities. Currently, developing countries' low levels of tax revenue as a share of GDP – typically between 10-20%, compared to 40% in high-income countries – hinder development by constraining governments' ability to invest in public goods like health, infrastructure, and education.

Between versus among

William Safire commented in the New York Times in 1999 that three style guides – those of his own newspaper, the Associated Press and The Wall Street Journal – all “stand foursquare for the between/among rule” that you cite. He commented that the AP guide included the maxim that “between introduces two items and among more than two”, arguing that as a result it was correct to write “between you and me” but “among the three of us”. This is still a matter that's capable of arousing controversy in the US. John McIntyre, an editor with the Baltimore Sun, was criticised for saying in a radio broadcast on National Grammar Day in March 2008 that between could be used for more than two. He wrote in the paper later that month that he had come across a passage in Robert Dallek's Nixon and Kissinger that made his point: “Between February 25 and March 4, Kissinger resumed his shuttle diplomacy, traveling between Damascus, Tel Aviv, Cairo, Amman, Riyadh, and Bonn, before his return to the United States.” Mr McIntyre comments, “He did not travel among those six cities; he traveled between one and another serially.” Most US style guides agree with Mr McIntyre that between can be used for more than two. British guides say the same, following the statement by James Murray in the Oxford English Dictionary more than a century ago: “Between has been, from its earliest appearance, extended to more than two”, with his earliest example being from the year 971. Noah Webster made the same point in his dictionary in 1828; Sir Ernest Gowers called the rule a superstition in the Second Edition of Fowler in 1965. It seems to have grown out of a view by grammarians of the eighteenth century that was falsely based on etymology, since the second part of between is from a Germanic source that's related to twain and two. This led Dr Johnson to assert the rule as you have given it in his own dictionary in 1755, although he added, “but perhaps this accuracy is not always observed”.

NIA cracks the whip in Bangalore

THE AGENCY CONDUCTED 43 RAIDS ‘IN CONNECTION TO THE RIOTS’ THAT SHOOK BANGALORE AUGUST 11

Bangalore, Nov 19: The National Investigation Agency (NIA) conducted search operations in over 43 locations Wednesday including four offices of the Social Democratic Party of India (SDPI), the political wing of the Popular Front of India, for their alleged involvement in Bangalore riots.

The NIA officials said seized incriminating material relating to the SDPI and PFI besides weapons like swords, knife and iron rods during the raids.

According to a statement issued by the NIA, the raids were conducted on a total of 43 locations in Bangalore in relation to the riots that had shaken Bangalore August 11. It said that 293 persons have been arrested in connections with the riots so far.

In this, 124 arrests were made in relation to the riots in DJ Halli Police Station case and the remaining 169 arrests were in relation to the riots in KG Halli Police Station case

The NIA, in its statement, said that the riot led to fear and panic in the nearby areas and the cases pertain to large scale rioting armed with lethal weapons causing injuries to police personnel, destruction of public and private property including DJ Halli and KG Halli police sta-



tions buildings besides public and private vehicles.

The NIA is probing two cases related to Bangalore riots, including on SDPI's involvement.

August 11, an insidious Facebook post by Naveen Kumar, nephew of Congress MLA R. Akhanda Srinivasa Murthy led to violent protests by an enraged mob.

The riots unleashed by a violent mob left four people killed in a po-

lice firing and as many as 60 police personnel were injured. Two police stations and the house of Congress MLA were torched.

After taking over the investigation of the riots, the NIA had named SDPI leader Muzamil Pasha for "instigating the mob" to unleash violence on the streets.

Former Mayor's custody extended

The local court extended former Bangalore mayor and Congress

leader, R. Sampath Raj's custody by one day, Thursday.

Raj, a Congress dalit leader, was arrested in connection with his alleged role in instigating the mob that, August 11, went on rampage and torched the house of Congress Dalit MLA, representing Pulikeshinagar, R. Akhanda Srinivasa Murthy. The CCB had sought 10-days custody of Raj, but the court extended it only by a day.

2L pvt school students in AP shift to govt schools

Amaravati, Nov 19: More than 2 lakh students have left private schools in Andhra Pradesh to join government schools in 2020, propelled by the myriad schemes introduced to encourage public education.

"A total of 42.46 lakh students have enrolled themselves in government and government aided schools this year, which is 2.68 lakh more than the enrolment figure from 2019, which stood at 39.78 lakh," said an official statement. Out the increased admissions, 2,01,833 students choose to leave private schools for studies in public schools.

"Government's success in reversing the trend can be attributed to a plethora of student - parent oriented schemes implemented since 2019. Jagannanna Ammavodi, Nadu-Nedu and Jagannanna Vidya Kanuka form the base of the government's drive to place government schools at par with their corporate counterparts," said an official.

As part of these schemes, the state government is revamping infrastructure at government schools, distributing free school kits and others.

Under Jagannanna Ammavodi scheme,

eligible mothers of students from classes 1 - 12 will receive Rs 15,000 incentive so as to not discontinue their children's education to employ them for extra money. As part of Nadu-Nedu, the state government is renovating over 45,000 schools in an effort to provide better facilities to government schools students.

"Apart from major infrastructural renovations, each of the schools will also be equipped with a dedicated English lab in order to facilitate modern learning. 15,715 schools were taken up in the first phase of the project and are expected to be finished by January, 2021," said the official.

Jagananna Vidya Kanuka offers basic necessities to students for free, such as schools bags, uniforms, books, socks, belt and others.

"This not only reduces the financial turmoil that poor families are put through at the start of each academic year but also helps the government control dropout rates," said the official.

Chief Minister Y. S. Jagan Mohan Reddy has already stated that children are the future of the state and he would invest in their education.

"Investing in education is investing on my kids, the next generation of my state," said Reddy.

All branches of education, from kindergarten to college and university in the southern state have a strong presence of profiteering corporate players, who minted money over the decades, taking gullible students and parents for a ride with their make believe promises.

Priyanshu Singh, a postgraduate student, was found hanging from an iron pipe on the roof of her house in Gorkha locality under Kotra Road police station limits on Wednesday morning, said Chaman Sinha, station house officer (SHO) of Kotra Road police station. Singh was allegedly upset about the death of her four-year-old dog, who succumbed to an illness on Tuesday night, the official said.

■ Three Naxals held

Bijapur: Three Naxals, including a woman ultra with a reward of Rs 2 lakh on her head, were arrested in Chhattisgarh's Bijapur district, police said Thursday. The cadres were apprehended near Peddagelur village under Basaguda police station limits, where a joint team of security forces was out on a counter-insurgency operation on Wednesday, an official said.

■ Techie ends life

Hyderabad: A 21-year-old techie jumped to death from a multi-storey building of a leading information technology company in Hyderabad Thursday. According to the police, the techie jumped from the sixth floor of Tech Mahindra building in Secunderabad. She had joined the company on October 30. According to her family, she underwent training for two weeks and began work as associate (customer support) on November 13. Jammu/Srinagar, Nov 19: Four suspected Jaish-e-Mohammad terrorists were killed and two policemen were injured in a gunbattle on the Jammu-Srinagar national highway after a truck carrying a group of freshly infiltrated militants was intercepted by security forces on the outskirts of Jammu city on Thursday, top police officials said.

The terrorists had come to execute a "big plan" which has now been foiled, Inspector General of Police (IGP), Jammu, Mukesh Singh, said. In Srinagar, IGP, Kashmir, Vijay Kumar said the four terrorists were on their way to the Kashmir valley to disturb the District Development Council (DDC) polls scheduled later this month, as Pakistan has been trying to cause trouble in the political process.

Giving details of the encounter, IGP Singh told a press conference in Jammu that during checking a truck was stopped at Ban toll plaza in Nagrota area at 5 am but the driver fled leaving behind the vehicle. CRPF and police personnel moved to search the vehicle and came under fire of the terrorists hiding in the truck. They retaliated re-

sulting in an encounter. Other forces also joined resulting in a fierce gunbattle in which terrorists fired grenades and arms, he said.

In the three-hour-long gunbattle, four terrorists were killed and two policemen were injured, he said, adding the policemen were out of danger. A huge cache of arms, ammunition and explosive material was recovered including 11 AK rifles, 3 pistols, 29 grenades and 6 UBGL grenades, he said.

As per weapon recovery and past instances, it appears that they belong to JeM, he added. Speaking on

the sidelines of a function in Srinagar, IGP Kumar said, "For the last few days, Pakistan has increased attempts to infiltrate militants into this side and to disturb the elections for which the process is on. In this context, Jammu Police and security forces have done a good job by neutralising four Pakistanis (militants). Their (militants') aim was to come to Kashmir to disturb the election process".

He said there were apprehensions about militants targeting the elections, but the security forces were fully prepared to deal with

the situation. "Whether there is an election or August 15 or January 26 or even a VIP visit, apprehensions are always there, but we are fully prepared... We are providing security to the candidates and they have started going to the field for campaigning from yesterday and there is nothing to fear," he said.

Kumar, however, said providing security to each candidate contesting the polls, which begin on November 28, was difficult. "Providing security to each candidate is difficult. We are providing them collective security and they are being put up in secure areas. Whenever any candidate goes out for campaigning, we provide a double escort with him and secure the area for him to campaign," he said when pointed out that the candidates were alleging that they had not been provided security. DDC polls will be held from November 28 to December 22. Results will be declared December 22.

These polls will be the first major political activity in Jammu and Kashmir since August 5 last year, when the Centre revoked the special status of the erstwhile state under Article 370 of the Constitution and split it into two Union territories - Jammu and Kashmir, and Ladakh.

Punjab CM's son records statement

Chandigarh, Nov 19: After failing to appear twice, Punjab Chief Minister Amarinder Singh's son Raninder Singh on Thursday appeared before the Enforcement Directorate (ED) in Jalandhar city to record his statement under the Foreign Exchange Management Act (FEMA), an agency official said. "His statements were recorded," said the official said. Raninder Singh had earlier denied any wrongdoing. The probe is linked to the Income-Tax Department's findings that certain assets acquired abroad were not disclosed in 2005-07. On November 6, Raninder Singh for the second time in less than a fortnight did not appear before the ED at its zonal office in Jalandhar. He had sought an adjournment in the matter, citing health reasons.

Earlier this month, the Chief Minister questioned the timing of the various notices issued by the ED and the Income Tax Department to him and his family members ever since the state passed its amendment Bills to negate the impact of the central Farm Laws.

Drugs worth ₹2,320 cr seized

Imphal, Nov 19: The Manipur Police and Assam Rifles troops have seized 582 kg brown sugar smuggled in from Myanmar valued at Rs 2,320 crore in three different actions since October 28, officials said Thursday.

The Manipur government has announced a cash reward of Rs 30 lakh for 94 police personnel of Thoubal and Bishunpur districts, including district Superintendents of Police Sarangthem Ibomcha Singh and L. Priyadarshini, respectively, for seizing the huge quantity of drugs in the two districts of central Manipur.

The police and intelligence officials have confirmed that the drugs were smuggled in from neighbouring Myanmar. According to an official statement of Manipur Home Department, the police in Thoubal district seized 435.945 kg brown sugar and 438 litres of morphinated liquid from the residence of one Kayamuddin Alias Amuthi on October 29 at the Moijing Awang locality. The police had also busted a drug processing laboratory. In another action, the police seized 74 kg brown sugar from a Chevrolet car in Khordak Ichin locality in Bishunpur district on October 28. In the third incident, the Assam Rifles troops and Manipur Police personnel recovered 72 kg brown sugar from a hideout in Kamu village in Thoubal district on November 11.

Sena worker's weird order

Mumbai, Nov 19: In a huge embarrassment for the ruling Maha Vikas Aghadi, an activist of the Shiv Sena Thursday ordered the owner of the reputed Karachi Sweets in Bandra to change its name to something more Indian or Marathi.

However, hours later the Shiv Sena washed its hands off the incident by making it clear that it was not the "official stand" of the party. The Sena activist - Nitin Nandgaonkar, barged into the shop and confronted the owner with his demand, contending that the word 'Karachi' causes anguish to him as the Pakistani city is associated with terror.

"We are not bothered if you are a Hindu or Muslim. The name Karachi is a problem, and you cannot use it

here. It is a place of terrorism and there should be no business in the name of Karachi," Nandgaonkar sternly told the owners-managers.

Even as the shop owners said that they had migrated to India after Partition, the Sena activist was in no mood to listen and said he would return "after 15 days to check out the name change." Nandgaonkar even offered to help the shop with the registered name-change formalities with the BrihanMumbai Municipal Corporation (BMC) and other departments if required, but said he would not tolerate the word 'Karachi'.

Incidentally there are other shops and establishments bearing names like 'Karachi' and 'Lahore' in Mumbai, Pune and some other cities of Maharashtra, mainly as a reminder of the ancestors of the present-day owners.

Reacting to the development, Shiv Sena MP and Chief Spokesperson Sanjay Raut said: "Karachi Sweets and Karachi Bakery have been in Mumbai since 60 years. They have nothing to do with Pakistan. It makes no sense to ask for changing their names now...It's not the Shiv Sena's official stance."

A former activist of Maharashtra Navnirman Sena (MNS), Nandgaonkar also posted a video and a warning on social media that "henceforth, 'Karachi' would not be allowed in Mumbai or Maharashtra" as it is the den of terrorists.

"Karachi Bakery, Karachi Sweets, Karachi School, etc. will not be tolerated. In 15 days, change the name," he said in his ultimatum, but after the party dissociated itself from his solo campaign, he suddenly went incommunicado.

Ram temple: Raj set to allow legal mining of unique sandstone

Jaipur/Ayodhya, Nov 19: The district administration in Rajasthan's Bharatpur is seeking the denotification of part of a wildlife sanctuary to allow the mining of a special sandstone, much sought after by builders including those constructing the Ram temple in Ayodhya.

Thousands of tonnes of the pink sandstone mined in Bharatpur's Banshi Paharpur have been sourced for the temple over the years, but much more is needed. There were concerns in Ayodhya that supplies of this stone with a unique pink hue would dry up.

Since blocks of this sandstone had already been carved - ready to



be put in place as the temple comes up - switching over to a lesser grade of stone would have caused problems. The Dholpur variant is said to be no match to the Banshi Paharpur stone.

Authorities in Congress-run Rajasthan denied that the move to denotify Banshi Paharpur block in

Bharatpur's Band Baretha wildlife sanctuary has anything specific to do with the Ram temple. But a Vishwa Hindu Parishad leader approved of reports that this "technical problem" is now being sorted out.

"The Rajasthan government never created hurdles in the supply of the stone. However, there was some

Kharge hits out at party colleagues

Bangalore, Nov 19: Lashing out at colleagues who are targeting the Congress leadership following defeat in elections, senior leader Mallikarjun Kharge Thursday accused them of "weakening the party from within."

Stressing the need to support the party high command, he said, "... We have to fight unitedly. It has pained me that some senior leaders have spoken against the party and its leadership." Speaking at an event to mark the birth anniversary of former Prime Minister Indira Gandhi, Kharge said on the one hand we have BJP and RSS on our back and on the other these people are drilling from within.

"If we weaken the party and our leaders in such a way, definitely the party cannot go forward and ultimately if our ideology is weakened we will be destroyed. You will have to keep this in mind," he added.

Kharge's comments came in the back drop of questions raised by a section of Congress leaders against the leadership after dismal performance in Bihar polls.

Congress leader Kapil Sibal had recently criticised the leadership for the party's abysmal performance in the Bihar elections, where it bagged only 19 of the 70 seats it contested.

He was part of a group of 23 senior Congress leaders who had written to party chief Sonia Gandhi in August, giving suggestions on ways to revive the grand old party.

Citing an old adage that the true nature of our friends and those with us can be measured during a defeat and that of a family during illness, Kharge said now that we

have seen a defeat, your true nature can be seen, how strongly you are backing us and are giving strength to our principles.

"When the party is in a good position everyone will praise... When weak or lost they blame (leadership) for not paying heed to them. So you workers don't do what others are doing," he said.

Noting that there are some leaders who blame Rahul Gandhi and Sonia Gandhi for the defeat, without naming any one, Kharge, a Rajya Sabha member said every state has leaders, they demand tickets for themselves or loyalists while finalizing candidates. Ninety per cent of the tickets are given based on their (state leaders) advice, despite that after loss they complain that nobody listens to them, lack of unity, he noted.

Pointing out that it was decided in the Congress Working Committee that Sonia Gandhi should continue as interim president until elections are held, Kharge said polls are yet to be held and Covid-19 hasn't still gone, we can't have 100 people together in one place, and yet, people are talking. Congress legislature party leader Siddaramaiah said, Kharge has spoken pained by the developments within the party.

UP lawyer sues Obama

Pratapgarh (Uttar Pradesh), Nov 19: A lawyer in Pratapgarh district has filed a civil suit against former US President Barack Obama's latest book 'The Promised Land' in which he has mentioned Congress leaders Rahul Gandhi and Manmohan Singh, a former prime minister.

The lawyer has demanded an FIR be lodged as the book that "insults" the leaders and hurts the sentiments of their followers. Gyan Prakash Shukla, national president of All India Rural Bar Association, has filed the civil suit in the Lalganj Civil Court.

The case has been scheduled for hearing on December 1. The lawyer has alleged in his petition that what Obama has said about Manmohan Singh and Rahul Gandhi is humili-

The lawyer said that if an FIR is not lodged, he will go on a fast outside the US embassy.

Anubhai Sompura, an architect associated with the temple project, said one lakh cubic feet of the stone has already been stockpiled, adding that two lakh cubic feet is still needed.

According to Bharatpur district collector Nathmal Didel, initial steps have now been taken for the denoti-

fication of Banshi Paharpur block - a move which will remove its status as forestland and allow legal mining. A preliminary survey is being done by a team of revenue, forest and mining department officials, he said.

"After the initial survey, a report will be sent to the chief wildlife warden of the forest department," he said, adding that the recommendations will go to the Centre for approval. He said the stone is in high demand across the country and the process has not begun because it is required for the Ram Temple.

The collector said there is rampant illegal mining in the area. There is no forest left there, and if it is delinked from the sanctuary the state government will get the revenue from any mining there.

HC raps Delhi govt over COVID spike

New Delhi, Nov 19: The Delhi High Court Thursday asked the AAP government if it could explain to those who had lost their near and dear ones to COVID-19 in the last 18 days why the administration did not take steps when cases were spiralling in the national capital.

The high court, which also asked the government to look at the situation with a "magnifying glass",

observed that it was "disheartening" to see that the number of daily deaths due to the virus has increased to 131 and rising COVID cases have risen to 7,486.

Pulling up the Delhi government, a bench of Justices Hima Kohli and Subramonium Prasad asked why it waited till the court intervened to take steps such as reducing the number of people attending weddings to 50 to prevent the spread of COVID-19. "You (Delhi govern-

ment) saw from November 1 which way the wind was blowing. But you turn turtle now because we asked you some questions. The bell should have rung loud and clear when the numbers were spiralling. Why did you not wake up when you saw the situation was deteriorating?" Why did we have to shake you out of your slumber on November 11? What did you do from November 1 till November 11? Why did you wait 18 days (till November 18)

₹2,000 fine for not wearing mask

NEW DELHI:The Delhi government Thursday decided to impose ₹2,000 fine for not wearing masks in public areas, a four-fold increase from the earlier fine. Earlier, violators were fined ₹500 for not wearing masks in public places. Delhi Chief Minister Arvind Kejriwal made the announcement on Thursday during a press conference held after an all-party meet at Delhi secretariat over issue to control the pandemic. Kejriwal said Lieutenant Governor Anil Bajjal also gave his nod for imposing a stiff ₹2,000 fine against those moving without masks publicly.

FARMERS VOW TO PROTEST IN DELHI

New Delhi, Nov 19: Up in arms against the three agriculture-related Acts enacted by the Centre in September, representatives of farmers across the country Thursday unanimously decided here to rally in Delhi on November 26 to lodge their protests.

Representatives of all-India farmer unions decided on this issue after their parleys with Union Ministers remained inconclusive. The farmer leaders warned the respective state governments that if they were stopped from proceeding towards Delhi, they would stage indefinite protests en route. They also demanded permission to rally at Ramliia Maidan, failing which they threatened to block entry points to Delhi from Haryana and Uttar Pradesh.

The meeting of representatives of All India Kisan Mahasangh, All India Kisan Sangharsh Coordination Committee, and a farmer forum led by BS Rajewal and Gurnam Singh Chanduni was called to chalk out the 'Delhi Chalo' programme. The farmer organisations said that more than 450 farmers' organisations from across the country had come together for the protests that will continue indefinitely.

Swaraj India national President Yogendra Yadav told the media that the Centre should first end the 'economic blockade' in Punjab by allowing the goods trains to ply. He said this it was for the first time in the history of independent India that farmer organisations from all over India, cutting across party lines and ideology, were coming together on a platform to save their livelihood and those of farm labourers and commission agents.

"The farm laws are an assault on



Indian farmers. They are aimed at corporatisation of agriculture and makes farmers more vulnerable," Yadav, who attended the meeting as the national working group member of the All India Kisan Sangharsh Coordination Committee, said. Rashtriya Kisan Mazdoor Mahasangh President Shiv Kumar Sharma said the laws were akin to 'death warrants' for farmers as they would benefit a handful of corporates.

"These laws should have a provision that if any trader purchases agricultural produce below the MSP (minimum support price) then the difference between the MSP and the actual rate should be paid by that trader as a fine," Sharma, a farmer leader from Madhya Pradesh, said. He said that Punjab took the lead in the agitation against the central government and "now it is spreading across the country".

Bhartiya Kisan Union's President Balbir Singh Rajewal said they should be allowed to stage a protest at Ramliia Maidan in Delhi. "If farmers are stopped from going to Delhi, they will block all entry points to Delhi from Haryana and Uttar Pradesh," he warned.

House panel grills Twitter over Kunal Kamra's tweets

Kamra has refused to retract his controversial tweets against the Supreme Court or apologise for them, saying he believes they "speak for themselves"

New Delhi, Nov 19: A parliamentary committee questioned representatives of social media giant Twitter on stand-up comedian Kunal Kamra's recent "obscene" tweets targeting the Supreme Court and the chief justice of India and sought a reply within seven days, the panel's chairperson Meenakshi Lekhi said Thursday.

This came close on the heels of Twitter apologising in writing to the same parliamentary panel for wrongly showing Ladakh in China and promising to correct the error by the month-end. Twitter India representatives deposed before the Joint Committee of Parliament on Data Protection Bill on Thursday.



"It is shameful that Twitter is allowing its platform for obscene remarks like the one by stand-up comedian Kunal Kamra against the Supreme Court and the CJI," Lekhi told reporters here.

"Twitter is allowing its platform to be misused for abusing top constitutional authorities, such as Supreme Court and CJI." She said

India talking to vaccine companies: Vardhan

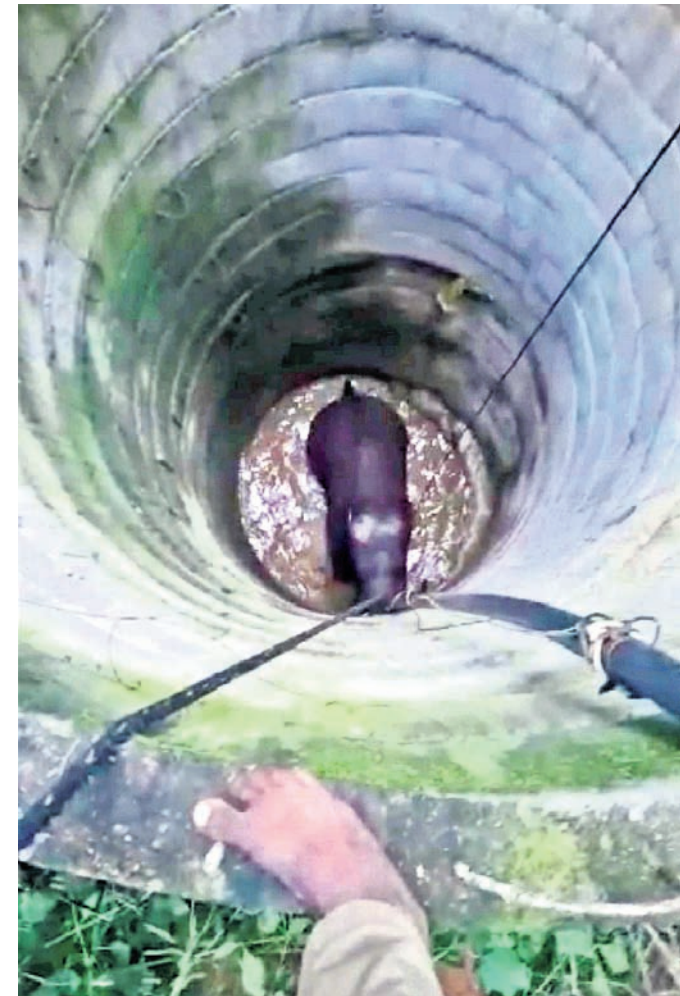
New Delhi, Nov 19: Union Health Minister Harsh Vardhan said Thursday that India is in talks with the vaccine companies for the procurement of 400 to 500 million doses till July next year.

Speaking at an event on 'Shifting Healthcare Paradigm During and Post-Covid', the Health Minister stressed the importance of following safety protocols, and said that vaccine distribution will be rolled out with a scientific and systematic approach.

Harsh Vardhan said, "Priority

will be given on medical grounds. We are a country of 135 crore people, and it's not possible to procure vaccines for such a large population at one go. By July-August 2021, we will have 400-500 million dosages available."

The Health Minister also shared his vision on introducing universal healthcare in India, the government's success in coming closer to bridging the rural-urban gap in healthcare infrastructure and services, as well as on the programmes in place to eradicate tuberculosis and measles.

Five killed, five injured in blast

Malda (WB), Nov 19: Five persons were killed and five others critically injured in a blast in a plastic factory in West Bengal's Malda district Thursday, police said.

The incident took place in Sujapur area around 11.30 am, a senior police officer said. "Four factory workers were killed on the spot and one was brought dead to the hospital. Five others have been critically injured in the explosion that ripped the establishment apart," he said.

Preliminary investigation has found that a technical fault in a heavy machine inside the factory caused the high-intensity blast, Superintendent of Police Alok Rajoria said. "The explosion happened during plastic manufacturing. We are probing all the angles and a forensic team will visit the spot," he said. A huge police contingent has been deployed at the spot to keep the situation under control, the officer said. The state government announced an ex-gratia of ₹2 lakh each for the kin of the deceased and ₹50,000 each for the injured persons.

Senior TMC leader and state minister Firhad Hakim has been sent to the spot to take stock of the situation. Governor Jagdeep Thakur expressed anguish over the incident and asked Chief Minister Mamata Banerjee to "contain illegal bomb-making" and ensure "professional non-partisan investigation". "Anguished at deaths in reported blast that ripped establishment apart at Sujapur area of Malda district. According to SP five killed & five injured. Time @MamataOfficial to proactively contain illegal bomb making and ensure professional non partisan investigations @WBPolice," he tweeted. Thakur also asked the administration to ensure medical assistance to the injured.

Cap on wedding guests leaves many families worried

New Delhi, Nov 19: With hardly a week remaining for his wedding, 30-year-old Krishna Kumar and his family are now a worried lot after the Delhi government announced it would restrict the guests' list in marriage ceremonies from 200 to only 50 amid a sudden spike in COVID-19 cases in the national capital.

Kumar, whose wedding is scheduled for November 27, said invitations have been already sent to nearly 250 people. "Even though, 200 guests were earlier allowed, we had sent out invitations to around 250 people both verbally or through WhatsApp. The government should have taken this decision earlier as the marriage season has already

started," he said.

Kumar's family is extremely worried since it has already invested around ₹15 lakh for the special occasion. He said all payments have been made already - from venue to catering. "What can we do now, we won't even get refund. We had booked a lavish farmhouse in Palla for the wedding since we were expecting around 200 people but now that only 50 are allowed, we would not need such a huge space for the wedding. But we have already paid them. I'm not sure if we would get any refund or can change the venue," he said.

The only relief for most of the families is that amid COVID-19, they planned to organise rest of the wedding ceremonies from sangeet to mehendi at their homes



with close family members and friends.

After the Delhi government's announcement, Sneha Samaddar, whose wedding is scheduled for December 7, was flooded with messages from friends and family members. Fortunately, she and her family had already decided to limit their guest list to 70 people.

"We have only invited very close relatives and family friends for the wedding. Not more than 70. But now that it is decided that only 50 members will be allowed at wedding ceremonies, we will only be prune the guest list further. All arrangements have been made already. But now it will be our families and few extremely close friends," she said.

Since COVID-19 cases were on a

surge here, her family had decided to organise wedding function in the same hotel where rooms were booked for the groom and his family since they would be coming from Maharashtra.

A marketing executive, who did not wish to identify herself, said that her wedding is slated for December 10 and since there are a number of elderly people in the family, the guest list was already kept below 100.

And now after the Delhi government's decision, there will be further cut in the guest list. Her sister Reva Sarna, who is personally monitoring all the wedding arrangements, said it would be awkward to request those who have been already invited to not attend the wedding now.

Ethiopia accuses WHO over unrest

Nairobi: Ethiopia's government is accusing the head of the World Health Organization, a fellow Ethiopian, of lobbying neighboring countries to come to the aid of the country's rebellious Tigray regional government with arms and other support. Ethiopia's army chief, Gen Birhanu Jula, asserted to reporters Wednesday that Tedros Adhanom Ghebreyesus had urged unnamed neighbors to "oppose the war and for (the Tigray People's Liberation Front) to get arms." The army chief did not provide any evidence.

Africa on alert for 2nd Covid-19 wave

Addis Ababa: African countries are on high alert for a second wave of the Covid-19 pandemic as the number of confirmed cases on the continent hit 2 million Thursday. Africa reported its first 1 million confirmed cases August 7 after it registered the first infection February 14 in Egypt, reports Xinhua news agency. As of Thursday, the continent's overall caseload and death toll stood 2,013,388 and 48,408, respectively, according to the Africa Centers for Disease Control and Prevention (Africa CDC).

Iota impacts over 3,57,339 people

Teguchigalpa: At least 357,339 people were impacted by hurricane Iota as it passed through Honduras, according to authorities. In a preliminary report of the damage caused by Iota, which reached El Salvador Wednesday as a tropical depression, the Permanent Contingency Commission (COPECO) said 61,228 Hondurans had been forced to evacuate to 750 shelters, reports Xinhua news agency. Heavy rains caused 42 rivers and streams to overflow, damaged two bridges and cut off two towns.

No LTTE-related events: SL courts

Colombo: Two Sri Lankan courts have banned events commemorating LTTE cadres, who died during a 30-year armed campaign for a separate Tamil homeland in the north and east provinces. "The magistrate's courts of Vavuniya and Mannar have issued restraining orders on anyone trying to commemorate the LTTE," police spokesman said Thursday. "Anyone trying to commemorate a terrorist group will be charged under the civil procedure code," he said.

Hongkongers' 'doubtful' letters from Chinese prison

Hong Kong, Nov 19: Family members of some of the 12 Hong Kong people arrested by China at sea in August said Thursday they have received their first letters from them, but they were suspicious of the praise for how well they have been treated in prison.

The 12 were arrested as they tried to flee by boat to Taiwan, with most of them suspected of crimes related to last year's often-violent pro-democracy protests, and have since been detained in the neighbouring Chinese mainland city of Shenzhen.

In a joint statement, families of seven of the detainees said their lawyers, chosen from a list provided by Chinese authorities, passed

and urging their families and neighbours back home not to worry.

Dragon shifts focus to domestic consumption

China expects that hostility with the US would continue under Joe Biden tenure as well though Chinese experts believe some buffering period

Beijing, Nov 19: Chinese President Xi Jinping said Thursday that China is set to change its development model from next year. The country will rely more on domestic consumption than export-reliant growth which propelled it to become the world's second largest economy next only to the United States.

"From next year on, China will embark on a new journey towards fully building a modern socialist country," 67-year-old Xi said while addressing the Asia-Pacific Economic Cooperation (APEC) CEO Dialogues via video link.

"We will foster a new development paradigm with domestic circulation as the mainstay and domestic and international circulations reinforcing each other," he said.

"The new development paradigm is a strategic decision we have made based on the current stage and conditions of development in China and with full consideration given to economic globalisation and

changes in the external environment," he said.

Last month, a key conclave of the ruling Communist Party of China (CPC) headed by Xi adopted his proposals for the formulation of the 14th Five-Year Plan (2021-

2025) for National Economic and Social Development and the Long-Range Objectives Through the Year 2035.

While the 14th Five-Year plan envisages a massive overhaul of the country's domestic market to boost consumption in order to reduce China's reliance on shrinking exports markets, the Vision 2035 visualises a long-term plan, reflecting the development vision of Xi.

China's status as a world's factory has been affected by declining global markets and US President Donald Trump's trade war as well his move

to ban Chinese tech firms like Huawei, TikTok.

The US also recently clamped restrictions on exports to Semiconductor chips to China, deepening the technology conflict between world's top two economies.

China expects that hostility with the US would continue under President-elect Joe Biden tenure as well though Chinese experts believe some buffering period.

Explaining the reasons for the paradigm shift in China's development model, Xi in his address said the model of reliance on foreign markets and resources has gone through some gradual changes.

"The ratio of foreign trade to GDP dropped from 67 per cent in 2006 to less than 32 per cent in 2019, while the ratio of current account surplus to GDP has come down from 9.9 per cent in 2007 to less than one per cent today," he said. "In seven years since the 2008 global financial crisis, the contribution of China's domestic demand to GDP exceeded 100 per cent, making domestic consumption the main driver of its growth," he said.

China's per capita GDP has topped USD 10,000 and its middle-income population has exceeded 400 million. It is projected by many international institutions that China's retail market will reach USD six trillion in size this year, he said.

Xi said the new development paradigm will enable China to fully unlock its market potential and create greater demand for other countries.

"As China's economy grows, our people naturally want to lead an even better life. This will create more demand for a greater variety of quality products, technologies and services from across the world," he said.

Pak court awards 10-yr jail to Hafiz Saeed

THE ANTI-TERRORISM COURT HAD EARLIER AWARDED IMPRISONMENT SENTENCES TO OTHER JUD LEADERS IN AT LEAST SIX CASES

Lahore, Nov 19: An anti-terrorism court in Punjab province has awarded 10-year imprisonment to Jamat-ud-Dawa (JuD) chief Hafiz Saeed and other top leaders of the organisation in at least two cases related to terror-financing.

As per the court order, the authorities have been directed to confiscate the properties of Hafiz Saeed along with the imposition of Rs 10,000 fine. Abdul Rehman Makki, brother-in-law of Saeed and second in command in JuD, has also been sentenced to six months' imprisonment for being an accomplice to the terror-funding cases.

Other than the above mentioned leaders of JuD, Zafar Iqbal and Yahya Mujahid have also been sentenced to 10.5 years' imprisonment each by the anti-terrorism court.

The case, filed by the Punjab Counter Terrorism Department (CTD), was heard by Judge Arshad Hussain Bhutta of the Lahore Anti-Terrorism Court No.1.



The verdict was announced after cross-examination of witnesses' statements, which later brought the court to the conclusion that the accused were proven guilty.

The latest verdict is part of at least 23 cases registered against Saeed and the members of his organisation in 2019 by the CTD with charges of terror-financing, terror-facilitation and terror-funding through various umbrella outfits working under the supervision of JuD.

Sharif's health worsening fast

ISLAMABAD: Former Pakistan Prime Minister Nawaz Sharif, who is currently in London, made several unscheduled visits to the hospital this week after he developed acute pain in his kidney, a media report said Thursday citing family sources.

Sharif visited consultants Tuesday and Wednesday and is scheduled for more scans on Thursday, the sources told Dawn news.

"He is very unwell and has serious pain in his kidney owing to

deteriorating kidney function. Doctors are conducting tests and scans to determine a course of action," Adnan Khan, Sharif's personal physician, said, adding that the former premier had developed kidney stones.

Tuesday, Sharif's daughter Maryam Nawaz said in a tweet that the PML-N supremo was unable to participate in a meeting of the opposition alliance Pakistan Democratic Movement because of "severe kidney pain", adding she would attend in his place.

Canadian-founded tech firm at centre of US polls controversy

New York, Nov 19: A Canadian-founded voting systems company is at the centre of a poll irregularities controversy in the 2020 US Presidential election with allegations against it from President Donald Trump's camp.

But it appears that the company, Dominion Voting Systems, does not have the connections to Democrat Joe Biden, the projected winner of the November 3 election.

Trump's lawyers, Rudy Giuliani and Sidney Powell, have in TV interviews claimed that Dominion is linked to another company, Smartmatic Corp., one of whose directors, Peter Neffenger, is on the Biden transition's review panel for the Department of Homeland Security.

However, it has been established



that Smartmatic does not own Dominion and both companies are rivals in the election technology field.

In a tweet Trump said that "vote tabulated by a Radical Left privately owned company, Dominion, with a bad reputation & bum equipment that couldn't even qualify for Texas (which I won by a lot)." And in another tweet he said: "Dominion is running our Election. Rigged!"

Pfizer vax delivery 'before Christmas'

New York, Nov 19: Pfizer Inc and BioNTech could secure emergency US and European authorisation for their Covid-19 vaccine next month after final trial results showed it had a 95% success rate and no serious side effects, the drugmakers said Wednesday.

The vaccine's efficacy was found to be consistent across different ages and ethnicities - a promising sign given the disease has disproportionately hurt the elderly and certain groups including Black people.

The US Food and Drug Administration could grant emergency-use by the middle of December, BioNTech Chief Executive Ugur Sahin told Reuters TV. Conditional approval in the European Union could be secured in the second half of December, he added.

"If all goes well I could imagine that we gain approval in the second half of December and start deliveries before Christmas, but really only if all goes positively," he said.

The success rate of the vaccine developed by the US drugmaker and German partner BioNTech was far higher than what regulators had said would have been acceptable. Experts said it was a significant achievement in the race to end the pandemic.

Of the 170 volunteers who contracted Covid-19 in Pfizer's trial involving over 43,000 people, 162 had received a placebo and not the vaccine, meaning the vaccine was 95% effective. Of the 10 people who had severe Covid-19, one had received the vaccine.

"A first in the history of mankind: less than a year from the sequence of the virus to the large-scale clinical trial of a vaccine, moreover based on a whole new technique," said Enrico Bucci, a biologist at Temple University in Philadelphia.

Biggest spending boost for UK military in 30 yrs

London, Nov 19: UK Prime Minister Boris Johnson has announced that the country will increase its defense budget by 16.5 billion pounds (\$21.8 billion) in the next four years, the biggest military investment in 30 years and since the Cold War.

Addressing the media Wednesday evening, Johnson said that he was making the announcement "in the teeth" of the coronavirus pandemic because "the defence of the realm must come first," the BBC reported.

"The international situation is more perilous and more intensely competitive than at any time since the Cold War," he added.

The Prime Minister said that in order for the country to "be true to our history and stand alongside our allies" it must make improvements "across the board."

"This is our chance to end the era of retreat, transform our armed forces, bolster our global influence, unite and level up our country, pioneer new technology and defend



our people and way of life," he said. The Ministry of Defence's (MoD) annual budget is around 40 billion. The 16.5 billion pounds increase over four years is about a 10 per cent hike.

The extra spending is on top of the Conservatives' 2019 manifesto commitment. Based on forecasts of inflation, the government said it expects the MoD to get an overall increase of about 24.1 billion pounds over four years, compared with last year's budget.

The Prime Minister will set out further details in a virtual speech to the House of Commons Thursday, reports the BBC.

RRVL completes ₹47K cr fundraise

New Delhi: Billionaire Mukesh Ambani's Reliance Industries Thursday said it has completed the sale of about 10% stake in its retail unit to a clutch of foreign investors for ₹47,265 crore. Since September 25, the company has sold 10.09% stake in Reliance Retail Ventures Ltd (RRVL) to private equity firms Silver Lake Partners, KKR, GIC, TPG and General Atlantic, as well as sovereign wealth funds Mubadala, ADIA and PIF.

Gold slips ₹248, silver declines ₹853

New Delhi: Gold prices on Thursday dropped ₹248 to ₹49,714 per 10 grams in the national capital, as investors and traders switched to riskier assets on new vaccine development, according to HDFC Securities. The precious metal had closed at ₹49,962 per 10 grams in the previous trade. Silver also declined by ₹853 to ₹61,184 per kg, compared to the previous close of ₹62,037 per kg.

Thyssenkrupp to cut 5,000 jobs

Frankfurt/Duesseldorf: German conglomerate Thyssenkrupp plans to cut another 5,000 jobs to stem losses across its sprawling empire after posting a 1.6 billion euro (\$1.9 billion) operating loss in its latest financial year, it said Thursday. Despite closing the sale of its elevators business in July for more than 17 billion Euros to help fund restructuring and cut debt, the group remains in crisis and CEO Martina Merz said more painful restructuring might be needed to stop burning cash.

NDB, Centre sign \$500mn loan pact

New Delhi: A loan agreement for \$500 million (about ₹3,700 crore) was signed Thursday between the government and the New Development Bank (NDB) for funding the Delhi-Ghaziabad-Meerut RRTS Corridor. The proceeds will be utilised to finance rolling stock, signalling system, operational structures, residences for operational staff, train control and telecommunication system and other miscellaneous works of the corridor, NCRTC said in a statement.

New Delhi, Nov 19: The Centre Thursday told the Supreme Court that issue pertaining to loan moratorium in view of the COVID-19 pandemic is a fiscal policy matter and the government has taken various proactive steps keeping in mind different sectors.

While apprising the apex court about the steps and measures taken so far by the Union Finance Ministry and the Reserve Bank of India (RBI), the Centre told a bench headed by Justice Ashok Bhushan that it is not a case of "no action" and no further indulgence may be given even if the petitioners say that there could

be better option on this issue.

The bench, also comprising Justices ₹Reddy and MR Shah, was told by Solicitor General Tushar Mehta that to ask for sector specific reliefs from the top court now is perhaps not a remedy available under Article 32 of the Constitution.

The apex court was hearing a batch of petitions relating to charging of interest on interest by banks on EMIs, which were not paid by the borrowers who availed of the loan moratorium scheme in view of the pandemic.

The RBI had March 27 issued the circular which allowed lending institutions to grant a moratorium on payment of installments of



term loans falling due between March 1, 2020, and May 31, 2020, due to the pandemic. Later, the moratorium was extended till August 31 this year.

The RBI and the Finance Ministry have already filed separate additional affidavits in the top court saying that the banks, financial

and non-banking financial institutions will credit into the accounts of eligible borrowers by November 5 the difference between compound and simple interest collected on loans of up to ₹2 crore during the moratorium scheme period.

During the hearing conducted through video-conferencing Thursday, Mehta told the bench that it is the responsibility of banks to credit the difference between compound and simple interest collected on loans of up to ₹two crores during this period.

He said the disaster management authority has taken all the steps which were required to be taken by it and the NDMA has already done

what it could have under the law.

"Centre has proactively taken steps through the Finance Ministry and the RBI," Mehta said, adding, "These are all fiscal policy matters."

He said if the court is satisfied that the government is examining these issues, taking adequate steps and grievance redressal mechanism lies within the system itself then further indulgence was not required.

"It is not a case of no action," the solicitor general said, adding, "The government is on top of it". He said that several relief measures were announced and decisions were taken by the concerned authorities keeping in mind every sector.

GOVT OVERHAULS FDI APPROVAL PROCEDURES

New Delhi, Nov 19: The government made major changes in Foreign Direct Investment (FDI) regime with the focus on simplification of procedures and administration rather than a tweak in the investment caps.

Accordingly, the Department for Promotion of Industry and Internal Trade (DPIIT) has come out with fresh set of standard operating procedures (SOPs) for processing FDI proposals that makes online furnishing of investment proposals and clearance by the respective authorities mandatory and within a specified period of time.

In line with changes brought about in the functioning by the outbreak of the pandemic, digitally signed applications and documents by an applicant will be accepted without any human interface. In case this is not available, additional seven days time would be given to the applicant to furnish physical copies of the document for further processing of the FDI proposal.

Under the new FDI approval plan, timelines for each stage of clearance has been defined with final clearance of FDI proposals being given in 10 weeks from the day



Under the new FDI approval plan, timelines for each stage of clearance has been defined with final clearance of FDI proposals being given in 10 weeks from the day it is received by DPIIT

it is received by DPIIT in cases where no security clearance is required. FDI proposals needing security clearance will have to be cleared by taking additional two weeks time in 12 weeks from the application date.

Government has also decided to assign FDI proposals coming in the domain of respective ministries to them for clearance. Such ministries, which will be called competent authority, will have a free hand to examine the proposals and

clear them in a time-bound manner.

To smoothen the process, commerce and industry ministry has advised administrative ministries not to set up inter-ministerial groups to clear FDI proposals but rather assign it to an identified group of people for clearance within the ministry. This has been done to save time with the focus remaining with a specific group within the ministry.

DPIIT and each of the Competent Authorities shall maintain a database on the proposals received along with details such as date of receipt, investor and investee company details, volume of foreign investment involved, and date of grant of approval/rejection letter.

Additional time of two weeks will be given to DPIIT for consideration of those proposals which are proposed for rejection or where additional conditions which are not provided in the FDI Policy are proposed to be imposed by the Competent Authority.

Besides, to prevent pendency of FDI proposals, it has now been decided that competent authorities will hold a regular monthly review on pending proposals and take a call on its disposal in a time bound manner.

India to see ₹10,000cr investment in LNG stations

New Delhi, Nov 19: Indian companies will spend ₹100 billion (\$1.35 billion) over three years on 1,000 liquefied natural gas (LNG) stations along main roads and industrial corridors and in mining areas, the oil minister said Thursday, to cut diesel consumption.

Diesel, which accounts for about two-fifth of India's refined fuels consumption, is widely used by buses, truck and in the mining sector.

"Even if the LNG vehicle segment achieves 10% market share in a fleet of 10 million trucks, it will have a positive impact on reducing emissions and substituting crude," Dharmendra Pradhan said at a foundation-laying ceremony for 50 LNG stations.

Use of LNG in heavy vehicles will cut fuel costs by 40% compared with diesel and help contain inflation, he said, and urged automobile makers to look at producing LNG-compatible vehicles.

LNG is suitable for long-haul trucks and buses as its higher en-

ergy density can help vehicles travel 700-900 km with one fill compared with about 300 km for a diesel vehicle, said VK Mishra, head of finance of Petronet LNG.

Companies will set up LNG fuelling stations along a 6,000-km network of highways linking the four main metropolitan areas, he said, adding transport sector can utilise up to 25 million cubic meters a day equivalent LNG in the initial phase.

Indian companies are spending billions of dollars to build gas infrastructure including pipelines and import terminals to raise share of gas in energy mix to 15% by 2030 from the current 6.2%.

Use of LNG will also help India in meeting its commitment made under the Paris accord to cut greenhouse gas emission intensity of its GDP by 33% to 35%, he said.

'77% INDIANS OPTIMISTIC ABOUT ECONOMIC RECOVERY'

Mumbai, Nov 19: About 77% Indians are optimistic of an economic recovery and business revival, and 27% believe the turnaround could happen in the next three months, said a new survey Thursday.

While 22% of those surveyed said they expect a revival in the next three to six months, 28% felt it could take anywhere between six months to a year, said the survey by digital lending platform IndiaLends.

"The economy is slowly but steadily recovering from the coronavirus pandemic and is getting back on the growth trajectory. There are clear signs of a business revival and consumer confidence,"

70% of the respondents said they were now spending more on electronic gadgets for their children

IndiaLends Founder and CEO Gaurav Chopra said in a statement.

The nationwide survey of nearly 1,700 respondents comprising both salaried and self-employed, conducted in November; also said that 71% of the respondents said they planned to take a personal loan in the next three to six months.

They cited two and four-wheelers,



business startups, household durables, electronic gadgets and

home renovation as the main reasons for personal loans.

At least 7% of the respondents said they would opt for a loan to pay for up-skilling courses, which points to the impact of Covid-19 on jobs and the need to utilise free time to acquire new skills, while 31% of those surveyed said they would use the loan to start their own business.

Among other findings, nearly 46% of the respondents said they expected an increase in household expenses towards consumer

durables such as washing machines and dishwashers, and 11% said they would opt for a personal loan to buy these appliances.

With people spending more time at home, almost 38% of the respondents said they would consider getting their home renovated in the coming months, and 15% said they would take a loan for the same.

About 70% of the respondents said they were now spending more on electronic gadgets for their children, namely smartphones, tablets and laptops.

World No.4 Russian outplays top-ranked Djokovic to enter ATP Finals last four

London, Nov 19: Daniil Medvedev is enjoying the ATP Finals a lot better in his second appearance. Medvedev secured a spot in the semifinals of the season-ending tournament by dominating five-time champion Novak Djokovic 6-3, 6-3 Wednesday for his second straight win of the group stage. Medvedev, who lost all three of his group matches last year on his tournament debut, has now beaten Djokovic in three of their last four meetings. The top-ranked Serb

can still advance if he beats 2018 champion Alexander Zverev in a winner-takes-all match Friday. Zverev kept his tournament hopes alive with a 6-3, 4-6, 6-3 victory over Diego Schwartzman earlier Wednesday. Medvedev broke Djokovic three straight times to go from 3-3 in the first set to a 3-0 lead in the second. The first break came after a marathon game when the Russian finally converted his third break point when Djokovic missed a forehand after a long rally. Djokovic then double-faulted on

set point and never looked likely to stage a comeback in the second. Medvedev saved the only break point he faced at 20 and then secured the victory with a forehand winner on his first match point. “He was just better, no question about it,” Djokovic said. “Just not a great match from my side. I thought I could have and should have done better, but credit to him for playing on a high level.” Medvedev is looking a lot more comfortable at the O2 Arena than last year, when his three losses included a collapse against Rafa Nadal

in a match where he led 5-1 in the third set. “You always have doubts in your head, like maybe next year is going to be (like) last year in London, I’m going to go out there and be tight, again, I’m not going to show anything in the Masters finals,” Medvedev said. “Well, not the case. Finished as No.1 in the group already, which is great.” Zverev, coming off what he had described as one of his worst matches of the season in his opening loss to Medvedev Monday, led 3-1 in the second set before his Argentine opponent battled back with two breaks. A visibly frustrated Zverev fired



a ball into the empty stands after losing the second set. The 23-year-old German recovered and broke Schwartzman twice in the third set. Schwartzman, who struggled with unforced errors, sent a forehand into the net to end the match. The decisive Zverev-Djokovic match Friday will be a rematch of the final from two years ago when the German won in straight sets. “I’m happy to give myself a chance to go to the semifinals,” Zverev said. “I need to win every match, otherwise I’m out, so I’ve got to go in with that mindset. I went to that mindset today, and I did my job.” Schwartzman broke early in the first set, but like in Monday’s loss to Djokovic he immediately gave it back. Zverev broke again for a 4-2 lead thanks to Schwartzman’s unforced errors. Nadal will play Stefanos Tsitsipas with a semifinal place at stake. Nadal has lost to Tsitsipas just once in six meetings — at the 2019 Madrid Open. He beat Tsitsipas here last year in the round robin before the 22-year-old Greek went on to win the title. Nadal has never won the ATP Finals. Dominic Thiem, who has already qualified for the semifinals, faces Andrey Rublev. The Russian is 0-2 and can’t advance.



Prajnesh in Orlando Challenger last eight

AITA postpones nat’l camp for elite players

New Delhi, Nov 19: The All India Tennis Association (AITA) has postponed the national camp it had planned for the country’s elite players from November 30 due to a recent surge in COVID-19 cases in the national capital. Delhi’s tally crossed the five-lakh mark Wednesday with thousands of fresh cases being added in the last few days. The national capital also reported a record 134 deaths Wednesday. The AITA had laid out a plan for the top 20 elite men’s and women’s players for the camp, which was to culminate with a national cham-

pionship in the singles format among the assembled players in a bio-secure environment. The planned 21-day camp was scheduled to begin for the men’s players from November 30 and was to be followed by a women’s camp from January 4. AITA secretary general Anil Dhupar, DLTA President Rohit Rajpal and former AITA president Anil Khanna had a meeting to take stock of the situation and decided to postpone the camp. India’s Davis Cup coach Zeeshan Ali even spent five days at DLTA to set up the camp, overseeing the required arrangements, but flew back to Bangalore after cases start



to rise in Delhi. “The staff at both DLTA and AITA is shaken up. Life is important, so we have decided to postpone the camp. We were ready for it, a system with proper infrastructure was created but unfortunately we

are postponing the camp,” Dhupar told this agency. “We will wait normally to return. Whenever players are comfortable to travel, we will re-schedule. We will see if we can follow the same order (men’s, women’s boys, girls) or change the sequence,” added Dhupar. The AITA official also said that all those players who are not travelling had agreed to join the camp. India’s top men’s players, Prajnesh Gunneswaran and Ramkumar Ramanathan, are already competing on the ATP Challenger Tour while Sumit Nagal has been in Germany for training for a long time.

Italy, Belgium advance into stellar Nations League finals

London, Nov 19: Italy earned the right to host a star-filled Nations League finals that will feature the current No.1-ranked team and three of the past four World Cup champions. Italy’s 2-0 win at Bosnia-Herzegovina Wednesday sealed top spot in Group 1 above the Netherlands, who beat Poland 2-1. That group winner had been pre-selected to host the Final Four next October. Top-ranked Belgium also booked their place in that knockout bracket, lifted by Romelu Lukaku’s 56th and 57th international goals in a 4-2 win over Denmark. Belgium and Italy join Spain and France, who topped groups that finished Tuesday. That means the tournament will feature the winners of the World Cup in 2006, 2010 and 2018. A total of 18 Nations League games were played Wednesday to complete a difficult 2020 program for Europe’s 55 national teams amid a spike in the coronavirus pandemic. **LEAGUE A** Andrea Belotti and Domenico Berardi scored for Italy midway through each half in a win that relegated last-place Bosnia from

the top tier. Had Italy slipped up, the Netherlands or Poland could have taken top spot with a win. The Dutch sealed a 2-1 win with late goals from Memphis Depay and Georginio Wijnaldum. Belgium could have lost top spot in Group 2 to Denmark but eased into a 3-1 second-half lead when Lukaku struck with trademark powerful finishes. Belgium gave up a freakish own goal when Thibault Courtois let a pass slide under his foot, but Kevin de Bruyne immediately restored the two-goal margin. England’s 4-0 win over Iceland made it 10 straight losses for the visitors across two editions of the Nations League and relegation to the second tier. **TOP-TIER PROMOTION** Hungary, Wales and the Czech Republic earned promotion to the top tier by finishing top of their League B groups. Russia’s 0-5 loss at Serbia opened the door for Hungary to rise in the Group 3 standings with a 2-0 home win over Turkey. A 2-0 win over neighboring Slovakia lifted the Czechs above Scotland, which lost 1-0 at Israel. It

was Scotland’s second 1-0 defeat on the road since qualifying for the European Championship last week. Wales protected its lead in Group 4 by beating second-place Finland 3-1. Ireland drew 0-0 with Bulgaria, which joined Turkey and Slovakia in being relegated to the third tier. The group winners also earned a little insurance in the World Cup qualification program which starts next year. Two places in a 12-nation qualifying playoff will go to winners of Nations League groups. **NORWAY FORFEIT** The first Nations League game canceled because of COVID-19 cases was forfeited as a 0-3 loss for Norway in a UEFA ruling Wednesday. UEFA’s appeals committee decided the Norwegian soccer federation was to blame for not sending a team to Romania for a game scheduled Sunday. Norwegian public health officials ordered the players to quarantine and not fly to Bucharest after one player tested positive. Norway gave up an equalizer deep into stoppage time in a 1-1 draw that gave Austria first place in Group 1. The UEFA ruling relegated Northern Ireland before it drew 1-1 with Romania.
