
Rhuhaneswar: Petrol and diesel

prices rose sharply by 43 paise per litre and 44 paise per litre respectively after a two-day pause Wednesday. After the surge, petrol prices stood at ₹83.12 per litre while diesel prices reached ₹79.14 per litre. Oil companies began increasing pump prices of the two petroleum products from last Friday after a nearly two-month-long hiatus in the fuel price revision. In five days, petrol price had gone up by 53 paise and diesel rate had risen by 95 paise per litre.

'No control' over pvt schools

In an affidavit to the Orissa HC on a fee waiver case, the state government makes it clear that it has no control over the fee structure of private schools

Cuttack, Dec 2: The state government Wednesday submitted an affidavit to Orissa High Court on a case seeking waiver of fees by private schools in the wake of Covid-19 pandemic.

In the affidavit, the state government made it clear that it has no control over private schools. But, the MoU between the stakeholders has a provision for reduction of fees within the range of 5 to 30 per cent, said the affi-

The affidavit stated that there are many government schools in the state, but parents are still enrolling their children in private schools.

While hearing the case, a division bench of Chief Justice Mohammad Rafiq and Justice Bishwanath Rath sought to know whether the state has any Act on private schools. În his reply, Advocate General Ashok

Kumar Parija told the HC that the state does not have a private school Act. The bench posted the next hearing

on the case to December 7. Earlier, the HC had November 23 directed the state government to submit an affidavit mentioning its decision on the amount of waiver in private school fees

November 10, the state government had requested the High Court to take a call on the waiver of private school fees. Notably, the Odisha Abhibhabaka Mahasangha, an outfit of parents, and others had moved the HC seeking exemption of fees by private schools in view of the Covid-19 pandemic. The Confederation of Odisha Public Schools had also moved an intervention application in the Orissa High Court in connection with a PIL seeking ex-

emption of tuition fees by private

schools during the lockdown, reports said. September 1, the HC had issued an order for mediation of the dispute and directed representatives from Confederation of Odisha Public Schools, representatives of the three PIL petitioners — Odisha Abhibhabak Mahasangha, Mohamed Mustaq and Prahallad Rout — and representatives of Odisha Private Schools Teachers Association to participate in the process to be convened by the secretary of the school and mass education depart-

In his report, department principal secretary Satyabrata Sahu said near unanimity could be achieved except for the representative of one of the three PIL petitioners. He said all 14 members had signed an MoU agreeing for waiver of fees in a 'flat rate'.

The HC had asked Sahu to examine whether any unreasonable and excessive fees are being demanded by private educational institutions.

"This could not be verified by inspecting various schools with varied fee structure, in view of the restrictions on movement of officials into the school campuses." Sahu said.

Patnaik visited the Ekamra Khestra and reviewed development works carried out in the area.

"I express my sincere gratitude towards the people who have donated land for the development of Lingaraj temple area. I am delighted to see the progress of development works. Soon, there will be a special legislation for Lingaraj temple like we have for the Srimandir. It will boost the beauty and tourism of the area," he

With the act, temple affairs will

be streamlined just like it was in case of Srimandir which is run according to the Shri Jagannath Act of 1955. The Act clearly talks about the formation of a temple committee and assigning of roles of the members of the panel. When enquired about any deadline

for the legislation, Patnaik declined to comment and proceeded with his officials works. Asked whether the state government has any plan for development of other heritage sites, he said, "There will be more, but we will discuss the matter."

Four Deputy Superintendents of Police, 151 Sub-Inspectors, 203 Assistant Sub-Inspectors and 740 Constables will be engaged to provide the '112' emergency service.

The officials of the board also said that if students were not able to sit for practicals in classes before


the exams, alternatives would be ex-

UK gives Pfizer a shot, rollout in days

London, Dec 2: The UK Wednesday became the first country to approve the PfizerBioNTech vaccine against COVID-19, paving the way for mass vaccinations against the deadly novel coronavirus from as early as

next week. The British regulator, the Medicines and Healthcare products Regulatory Agency (MHRA), says the jab, which claims to offer up to 95 per cent protection against COVID-19 illness, is safe for roll out.

The UK government said the approval follows a rigorous analysis of the data, conducted at a faster pace but without any compromise on standards.

'The vaccine will be made available across the UK from next week. The NHS (National Health Service) has decades of experience in delivering large scale vaccination programmes and will begin putting their extensive preparations into action to provide care and support to all those eligible for vaccination, said a spokesperson for the Department of Health and Social Care (DHSC).

The UK's Joint Committee on Vaccinations and Immunisations (JCVI) will now publish its final advice for the priority groups to receive the vaccine.

Around 50 hospitals are on standby and vaccination centres in venues such as conference centres are being set up now, with military personnel being deployed to assist with the logistics.

The joint vaccine, produced by American pharmaceutical giant Pfizer and German biotech firm BioNTech, had recently claimed trials suggested it works well in people of all ages, races and eth-



Bhubaneswar, Dec 2: The Special Vigilance Court here Wednesday allowed the police to take suspended IFS officer Abhay Kant Pathak and his son Akash, who have been ar rested on charges of amassing assets disproportionate to their known sources of income, on a three-day remand for further investigations into the case, sources said.

Meanwhile, suspecting tax evasion in view of a staggering ₹9.48 crore cash deposits and deposits by transfers to the tune of ₹5.29 crore - totalling upto ₹14.77 crore - in three bank accounts belonging to the Pathak senior without any income tax returns, the state Vigilance has referred the matter to the Income Tax (I-T) department for investigation.

"The Income Tax department has been urged to investigate the matter in accordance with the Income Tax Act, 1961 and Benami Transactions (Prohibition) Act, 1988," read a statement issued by the state Vigilance.

Choudhurv also said that the agency had booked rooms in five-star hotels in this city, Mumbai and Delhi for Akash. "Whenever we approached them to clear the dues, they threatened us with dire consequences,'

AYUSH doctors seek reinstatement

Bhubaneswar, Dec 2: More than 267 AYUSH doctors Wednesday wrote to Chief Minister Naveen Patnaik demanding their reinstatement in services as part of pandemic management.

In the letter, they said, "We 267 AYUSH doctors (130 in Ayurveda and 137 in Homoeopathy) beg to state that we were posted under Covid-19 in Odisha, from May 12, 2020 to July 31, 2020 on contract daily remuneration basis



we are now disengaged."

Stating that they had rendered their duty sincerely and dedicatedly at Covid care centres, OPD and Covid hospitals, the doctors said that not a single death occurred in Covid care centres during their entire duty period. "Many of us also had been affected seriously by Covid-19 during the duty but we did our duty without hesitation," they added.

Since the WHO and health experts have predicted a second wave of Covid-19 due to the onset of winter, the public health system needs to be strengthened, they said in the letter. "Based on these aspects, we make an earnest request before you for our kind consideration to engage us in activities like treating Covid patients, sensitising people, guiding ASHA, ANMs for identification of patients with symptoms among others," they said.

Bhubaneswar, Dec 2: Another cyclonic storm Burevi which has formed over southwest and adjoining southeast Bay of Bengal will have no impact on Odisha, said the regional centre of the India Meteorological Department (IMD) here, Wednesday.

The IMD confirmed that the impact of the cyclonic storm will only be felt in Tamil Nadu December 4. Bhubaneswar Met Centre Director HR Biswas said, "There will be no impact of the system on Odisha and there is no such warning. Weather will remain dry for next five days and there will be no major changes in minimum temperature during the period.'

However, there is a possibility of shallow to moderate fog in some parts of the state including Kalahandi, Kandhamal, Sundargarh, Keonjhar, Mayurbhanj and Subarnapur December 4 and 5," added Biswas.

The IMD in its latest bulletin said that the deep depression over southwest and adjoining southeast Bay of Bengal has intensified into a cyclonic storm-Burevi and moved west-northwestwards with a speed of 12 kmph during past six hours and lay centered over southwest Bay of Bengal about 300 km east-southeast of Trincomalee (Sri Lanka), 530 km east-southeast of Pamban (India) and 700 km nearly east

Kanniyakumari (India). "It is very likely to intensify further during the next six hours. It is very likely to move westnorthwestwards and cross Sri Lanka coast between latitude 7.50N and 9.00N, close to Trincomalee evening/night of December 2 as a Cyclonic Storm with a wind speed of 75-85 kmph gusting to 95 kmph. It is very likely to move nearly westwards thereafter, emerge into Gulf of Mannar and adjoining Comorin area on December 3 morning,' said the IMD.

The department also predicted that it would then move nearly west-southwestwards and cross south Tamil Nadu coast between Kanniyakumari and Pamban around early morning of December 4.

BJP seeks CBI probe into Pari 'murder' case The party said Pari's

Bhubaneswar, Dec 2: Apprehending involvement of an organ trade racket in the alleged abduction and murder of 'Pari', a minor girl of Nayagarh district, the Bharatiya Janata Party (BJP) Wednesday demanded a CBI probe into the incident. BJP's state unit president Samir

Mohanty Wednesday told the media that the parents of the deceased have levelled serious allegations. "They suspected stealing of eyes and kidneys of Pari. The government has claimed that there was no trace of any attempt to outrage her modesty," Mohanty said.

He also added, "The National Crime Records Bureau (NCRB) data claims that several children are missing from the state. The report said that the cases



of human trafficking have increased in Odisha and the state has seen nonperformance of the police. Organ smuggling racket is flourishing in Nayagarh district. There should be a CBI enquiry into the matter.'

The leader also said that the parents of the deceased as well as the villagers are now being pressured by the ruling

dispensation to suppress the issue. "The parents have often raised the names of some BJD leaders and hinted at their involvement. The police have been putting pressure on the families of the deceased and on the villagers. The parents have raised their allegations before the media against the police. The local sarpanch has been put under pressure not to protest against the incident and stay silent," he said. He also said that there is need to in-

The %age of DMF Funds spent in the directly mining affected areas i.e, within 10kms radius of the mine, was misrepresented in the above-mentioned news item as Rupees in crores utilized out of DMF Funds in various Districts. For example, 63.80% has been spent in directly affected areas in Keonihar district and not Rs 63.80 crore as per the newspaper report.

It is therefore, requested to kindly publish the factual position as stated in the reply to the Unstarred Assembly Question No-654 in Odisha Legislative Assembly by the Hon'ble Minister, Planning and Convergence on 26th November, 2020, through a suitable correction or clarification in your esteemed Daily, which may help in removing wrong impression created by the published news item in the minds of the stakeholders of DMF not only within Odisha, but at the National Level, lest they may take it as a point of reference in future.

VOLUNTEERS LEARN WASTE 2 MORE HELD IN **SEGREGATION SKILLS**

Bhubaneswar, Dec 2: The Bhubaneswar Municipal Corporation (BMC), Wednesday, began training and education for various associations and volunteers on effective garbage segregation in order to ensure smooth functioning of micro composting centres (MCCs) in the city.

The training which began in all the three zones saw programmes and sensitisation of about 150 organisations from three zones. With about 50 members from each zone, the volunteers and NGOs were trained about segregation of wet and dry wastes which will help in smooth functioning of the MCCs.

"The programme is being carried out under decentralization of waste initiative. Since MCCs are being set up in the city for decomposing organic wastes, it's imperative to segregate waste at source and not mix them up which will defeat the purpose. Thus sensitisation is important part which will help the MCCs in the long run," a BMC official said.

Notably, the BMC has planned to complete construction of as many as 32 MCCs out of the proposed 43 by end of December this year. As of now, four MCCs - one each at Nicco Park for Ward No $-55, Laxmi\,$ Sagar for Ward No – 32 and 33, Unit – VIII for Ward No -51 and another at the Temporary Transit Centre (TTS) near Sainik School for Ward No – 12 and 17 – are operational. While MCCs at TTS, Nicco Park, Laxmi Sagar can process wastes up to 5 tonne per day, the capacity of Unit – VIII is 3 tonne per day.

The department is optimistic about generation of a trade surplus of ₹100 crore from the kendu leaf operations in the current fiscal. Chief Secretary Asit Tripathy directed the officials to ensure more bush cutting in convergence with the Mahatma Gandhi National Rural Employment Generation Scheme (MGNREGS).

He said that the bush cutting works can pave way for better production and production of the processed leaves for which the state is known in the country. Meanwhile, the Development Commissioner

Basant Nayak, programme manager. Centre for Youth and Social Development, Bhubaneswar underlined that behind any intervention, budgeting is the most essential component and when we talk about budgeting for disabled, data segregation is the most essential element. The government must enumerate persons with disabilities to know the actual size of the population and allocate the resources accordingly.

Water, sanitation and hygiene are essential for prevention of COVID-19 and more importantly for persons with visual impairment, limited mobility and those who are mentally challenged stated Dr. Bhushan Punani, executive secretary, Blind People's Association.

Sambalpur, Dec 2: Massive irregularities in advance distribution of free rice to PDS beneficiaries during the Covid-19 restrictions have been alleged in the district, a report said.

The state government and the Centre issued directions for advance distribution of free rice to the beneficiaries so that they will not face hardship in arranging their food during the Covid induced lockdowns and shutdowns

The rice was to be distributed in advance for a period of five months under the Pradhan Mantri Garib Kalyan Yojana. However, the welfare measure did not have a smooth sailing as allegations of irregularities in rice distribution rocked the district administration.

It was alleged that a major racket was involved in the irregularities as many of the beneficiaries failed to get free rice during this period. This happened as the civil supplies officials failed to make timely verification of rice supply, its stock and distribution. Moreover, it was also alleged that the irregularity is

not limited to the Sambalpur Municipal Corporation area alone but is spread to Redhakhole and

Kuchinda sub-divisions. The matter came to the fore after vernacular daily 'Dharitri' published a report in this regard in its November 22 edition.

The report rocked the district administration as the district civil supplies officer, Subodh Mallick, sought a probe.

The five-year-old girl was found dead at Jadupur village under Sadar police limits of Nayagarh district under mysterious circumstances June 14. Her body was recovered from a spot 50 metres from the place where she went missing a day earlier.

In the past, lakhs of rupees have been spent for renovation, desiltation, canal repair and construction of guard walls, but all the works have been botched up by contractors, it was alleged. Under various schemes, Rs 1.33 crore has been spent for the project renovation in different times in the past since 2006-7.

Rs 2.10 lakh has been used for renovation of the project between 2007



and 2009. In 2009-10, the department had spent Rs 9, 98, 445 for its multiple repairs under MGNREGS

Under the MR grant, Rs 22 lakh was spent for the project in 2010-11 while another Rs 22 lakh was under RRAR scheme. Rs 3 lakh was used for building shutters while Rs 9 lakh was spent for canal lining work under the **MGNREGS**

Under the Biju KBK Yojana, Rs 7.45 lakh was used for a part of left canal in 2012-13. In 2019-20, Rs 20 lakh more was used for upgradation of the project.

It was alleged that due to technical defects and botched work, the canals have collapsed. As canals remained unused for a long time, iron gates of the canal had been stolen in 2013. In 2016, canals also suffered complete damage due to floods.

Farmers in the area said the proj ect has been mired in irregularities and there is a need for a vigilance investigation into it.

Though they had drawn the attention of the officials of the department and the administration toward the sorry state of the project, no step is being taken to make the project workable for farmers.

Sameness of all beings

t is only Western philosophy that draws a dividing line between human and animal ('man and beast'). The religions - that emerged from the earth organically - have never done so. Hindu dharma holds that all creation is interconnected—vasudhaiva kutambakam - and has always acknowledged animals as sentient beings. Finally science is catching up with what our belief systems have always known.

Over the last 50 years, with increasing frequency and accuracy, countless studies are proving the 'sameness' of all living beings. Human beings have a left and right side of the brain which both do different things. Till now this was assumed to be specific to the human brain. But chickens have the same brain as humans. The chicken's brain subdivides its cognitive processing so that the right hemisphere (left eye) is specialised to detect unexpected stimuli and the left hemisphere (right eye) to categorise stimuli based on past experience. The right hemisphere has broad spatial attention, while the left hemisphere has focussed attention. Chicks can attend to at least two visual tasks simultaneously. The tasks used in tests, done by University of New England, were a) searching for foodgrains scattered on a background of small pebbles, and b) detecting a predator moving overhead. The left hemisphere is specialised to carry out the former task and the right hemisphere to

Have you ever found yourself humming a song that's stuck in your head? That's just like dolphins. At an aquatic park, Planete Sauvage in France, a group of five captive dolphins has been recorded making whale-like noises late at night — despite the fact that they have only heard whale sounds as recordings during their daytime shows. Ethologist Martine Hausberger, of the University of Rennes, and her colleagues had hung microphones in the tank to hear what dolphins sound like at night. One night, they heard 25 new sounds that the dolphins had never made before. Because dolphins are known for mimicry, the researchers examined their daytime environment for clues. They found that the park was playing music, sea gulls' calls, the dolphins' own whistles, and humpback whale calls. The dolphins, all of whom were born in captivity, had never had the opportunity to hear a whale sing, except on the soundtrack, yet they were singing whale songs

Do you remember your mother yelling after you that you had forgotten your lunchbox? According to goat specialist Dr Daniel Waldron (cited in Wickman, 2013) goats are great yellers too. Both sheep and goats have larynxes and vocal

tracts similar to humans and they use them to great effect. When a mother goat is separated from her kid, she will yell; when it's time for them to be fed, the herd will yell to remind you. And the similarity doesn't end there. Like humans, goats too develop different accents depending on the company they keep. According to recent research by Briefer and McElligott (2012), the calls of goats within the same social group became more similar over time. Comparing the calls of goats at oneweek-old and five-weeks-old, they found that the calls of kids raised in the same social groups were more similar than those from different groups. The same is true of cows. After English dairy farmers noticed their cows had slightly different moos, depending on which herd they came from, a study revealed that cows have regional accents like humans. So, clearly animals can modify their vocalisations according to their social environments, which means they can learn lan-

While on the subject of communication, remember the Mahabharata story of how the unborn child, Abhimanyu, heard the secret of the maze when it was told to his pregnant mother, Subhadra? It is now widely accepted that babies in the womb respond positively to external stimuli like music and conversation. Expectant

mothers can often be seen crooning and whispering to their unborn child. It is the same with animals. A mother hen talks to her chicks before they are born. She will cluck and purr softly while sitting on the eggs or moving them around under her. This early messaging imprints on them their mother's voice and enables newborns to distinguish their mother's call from rest of the flock. Towards the final hours of the hatch, you can hear them responding to Mama as she encourages them to break out of the shell, reassuring them that they are safe. It has also been proven that mother hens can modify their teaching of their chicks based on their understanding and aptitude. If the chick is a slow learner, Mama will slow down the pace of the lesson. And just like our mothers push our veggies at us and our colas away, so too do mother hens encourage their children to eat healthy. In a recent study, mother hens were conditioned to identify one colour of food as preferable and another colour of food as unsuitable. From a separate room they were given to watch as their chicks chose to eat the colour of feed they (the hens) deemed less preferable. Perceiving the chicks making an error, the mother hens responded by pecking and scratching the ground more frequently in an attempt to attract their chicks away from the bad food and toward the better food. Mums will be Mums.

Now that even science can no longer deny that animals think, speak and behave just like us, how can we deny them even the basic consideration that we, as humans, take for granted? If we claim freedom as our birthright, how do we justify imprisoning billions of our fellow beings in zoos, factory farms, research laboratories, animal pounds, slaughterhouses, and inflicting on them the worst kinds of torture?

It would be so much happier to embrace their sameness and celebrate their differences. I know that before I die I would like to hear the lovesong of the Ecuadorian Hillstar Hummingbird. The male inflates his throat, causing his throat feather to glisten an iridescent purple, and then launches into an opera that only birds of his kind can hear. That's because the mating call is at 13.4 kilohertz. And birds can't hear above nine or 10 kilohertz. Then why so high-pitched? So that the sound of love can transcend the sound of mountain winds, streams, and the songs of other birds. Simply amazing!

Chaucer's use is easily its most famous appearance in literature, because vinolent has never been common and indeed has almost completely vanished from the English language (though a web search did turn up a firm apparently willing to print the word on a T-shirt for you; if you wore one it might provoke spectators to ask whether you were boasting or complaining).

LANGUAGE & LOCKDOWNS

ur recent experience with COVID-19 and the word 'lockdown' once power of language to influence our lives and wellbeing. The infinite variety of reality, and the finite number of words and phrases we have to describe it, creates an inescapable philosophical challenge to articulating policy. Adding to the challenge is our tendency to regard a person's usage of certain words as a signal of their political ideology. In managing the pandemic,

much of the policy discussion has coalesced around lockdowns. But reducing the issue to a binary question (Should we lock down or not?), or even a linear one (How much should we lock down?), oversimplifies a complicated problem.

The binary tendency has been prominent in US President Donald Trump's recent statements. At an Iowa campaign rally shortly before the presidential election, Trump claimed that, "The Biden plan will turn America into a prison state, locking you down." He also tweeted that, "Biden wants to LOCKDOWN our Country, maybe for years. Crazy! There will be NO LOCK-DOWNS." Trump's brazen politicisation of the COVID-19 policy debate put left-wing groups on the defensive, because, unlike the president, they accepted the science and usually favoured certain aspects of lockdowns.

To see why linearising the lockdown debate is equally problematic, consider a restaurant where the menu asks how salty, on a scale of 0-10, you want your food to be. Chaos will ensue, with some customers who ordered a seven complaining that they received a salty dessert, and others who asked for a zero (because they wanted a pudding) grumbling about their bland pizza.

Tragically, this situation has parallels in the real world of pandemic management, where there are a thousand dimensions to policy. For example, governments can lock down bars while keeping schools open, or ask people who do not wear face masks to remain at home while allowing those who do to go outside. They can also in-

sist on social distancing for vulnerable populations while imposing fewer restrictions on those with immunity to COVID-19. To ignore these choices when designing so-called non-pharmaceutical interventions is to court disaster.

Having said that, one big pattern that has not received enough attention is the geography of COVID-19. The difference between the Americas and Europe, on one hand, and Africa, Asia, and Oceania, on the other, in terms of cases and deaths is too great to be attributed to policy alone.

For example, it would be utterly disingenuous for Philippine President Rodrigo Duterte to proclaim the success of his pandemic policies by comparing his country's crude mortality rate (CMR) the number of COVID-19 deaths per million people – of 76 with Spain's CMR of 964. In fairness, it would be equally fallacious to say that US policy has failed because America's CMR is 827 while that of Vietnam, a much poorer country, is only 0.4.

The geographic pattern is so marked that there has to be an explanation in terms of past illnesses and immunities, viral strains, ecology, or some other factor that we are yet to identify. To see the effect of policy, we need to make within-region comparisons (as I recently argued in a co-authored paper for the Brookings Institution).

The experience of India also demonstrates the risks of lockdown semantics. On March 24 the Indian government announced a 'lockdown' that supposedly was even more severe than those in Europe, often described as the strictest possible. The problem with this policy became evident after a week or two. The authorities had made no provision for the country's poor migrant workers who, stranded in urban centres without work or pay, had no choice but to walk hundreds of miles back to their homes, mostly in the countryside. So, although India's cities, towns, and economy were locked down, the opposite was true of 23-40 million migrant workers. For them, this could be described as the 'Great Unlocking.'

This misstep is now showing up in the statistics. India's number of daily COVID-19 cases rose without

interruption for six months, a trend seen in very few places. India's CMR of 99 is now the highest among South and East Asian countries (and higher than in most of Africa), largely because the 'lockdown' actually unlocked the coronavirus and scattered it nationwide.

But instead of lamenting the past, we need to move on. At least until a safe, effective COVID-19 vaccine becomes available, all countries need different forms of tailored, limited lockdowns and rules of behaviour. And as far as possible, this should be implemented through persuasion and leadership rather than by police

Here is one suggestion. We have to begin to rely on people who have already had COVID-19 and are now immune. Instead of resorting to compulsion, we should offer people with certified immunity attractive pay to take jobs that involve physical human interaction and contact. This will help to keep supply chains open and the over-

all economy running. Once governments take the lead, market forces will kick in and do the job. As we discuss in the Brookings paper, this option is not risk-free. But it has huge potential, and economies that develop a functioning 'immune labour

market' can reap big benefits. Now that the US election is over, there seems to be more flexibility in the lockdown debate Encouragingly, many on the left support tailored lockdowns and rules of behaviour that can enable the bulk of the economy and society to remain open. Assuming that Trump, who has adamantly opposed any lockdown, does not lock himself down in the White House beyond January 20, 2021, the US response to COVID-19 is likely to be overhauled accordingly.

abled persons with bowl in pass their day around the religious and tourist spots or in row at a corner in market with soliciting eyes. These hapless, helpless persons also witnessed loitering at road crossings or on footpath, are often derided at, reprimanded and scorned. A section of them is those of cursed children who were cruelly crippled, and dragged into begging by the mafias.

No one is perfect. As a thumb rule, when we focus on someone's flaws, we are often disabled to appreciate their talent, abilities and skills. Robert Hensel of Guinness World Record fame, himself having inborn disability said, "There is no greater disability in society than the inability to see a person as more." What matters in the context of disability is our perception and not the lacuna in someone. "The only disability in life is a bad

attitude," said Scott Hamilton. In India, prevalence of disability is higher in rural than in urban areas, gender-wise it is more among males than females. Overriding the 1995 Act, the amended Right of Persons with Disabilities Act 2016 defines debility as "a person with

lectual or sensory impairments which, in interaction with barriers, hinders his full and effective participation in society equally with others." With very large populations having deficit of some kind, one with 40 per cent or above disability of a specified type came to be accepted as disabled. In the amended Act, the categories of disabilities have been increased from 7 to 21. A major issue that hampers mainstreaming of the disabled is tardy execution of programmes. For example, concerned that over 74.05 per cent schools don't have ramps for the disabled, just a month ago Madras High Court summoned the chief secretary, Tamil Nadu school education department to explain the steps taken to provide disabled-friendly toilets and other facilities.

Globally, over a billion people (15 per cent of world population) are living with disability, according to WHO World Report on Disability. Unfortunately, two-thirds of these do not seek medical help due to ignorance or stigma or because they have no access to requisite help. In line with the universal buzzword, 'Leave No One Behind (LNOB)', the UN document 'Agenda evolve appropriate mechanisms and strategies so that the interests of the disabled are not compromised. The UN-promoted International Day of People with Disability (IDPwD), an annual observance on 3 December, aims to promote an understanding of people with disability and encourage support for their dignity, rights and wellbeing. Noting that 'Not all Disabilities are Visible' this year's focus of IDPwD is on spreading awareness and understanding of disabilities that are not immediately apparent, such as mental illness, fatigue, chronic pain or sight, diabetes, brain injuries, neurological disorders, learning differences as well. The isolation, disconnectedness, disrupted routine and diminished therapeutic services due to ongoing Covid-19 pandemic have added to the woes of the disabled across the world.

In the inclusiveness model that an egalitarian growth-oriented society seeks to follow, the disabled lot cannot be sidelined. They need to be assisted with proper rehabilitation, offered equal opportunities, and encouraged to act proactively to serve their role. It is possible only after empowerment that the

bers of society.

Quite many labelled as 'disabled' have outperformed the able-bodied in several arenas attesting the belief that they are generally imbued with special guts or that Nature more than makes up for their deficiency in one organ with enhanced capability of other senses, one reason they are renamed, Divyang jan by the current governance. We have luminaries like Stephen Hawking who set benchmarks what disability means. In our own country we did it despite formidable odds: classical dancer Sudha Chandran; Dr Satendra Singh who helped develop disable-friendly machines; sightless film musician Ravindra Jain. badminton player Girish Sharma; journalistic doyen Ramakrishnan, cancer expert Dr

Suresh Adwani, and so on. It is said, difficult roads often lead to beautiful destinations. Let it not be overlooked, what Nido Qubein said, "Your present circumstances don't determine where you can go; they merely determine where you start.'

Compensate acid attack victims

Sir, The neglect on the part of the states to provide compensation to acid attack victims is glaring. Reports say that till October 2018, nearly 60 per cent of acid attack survivors had not received compensation that was rightfully due to them under Section 357 B of IPC. The systematic time frame fixed by the provisions of the criminal law amendment, for payment of compensation, has had no takers in the governments. Reimbursement of medical expenses is vital for the victims to withstand the trauma, and undergo quick surgeries that most of them require. Not all hospitals possess facilities and faculties to manage acid attack survivors. All hospitals should be directed to admit acid burn patients and provide priority treatment before shifting them to specialty hospitals. On an average, 300 to 500 cases of acid attacks on women are reported in a year in India. The actual number is much more. There is also a large gap between acid attack incidents and police chargesheets. Section 326(A) of IPC provides for a punishment of not less than 10 years that may extend to imprisonment for life with or without fine. Many women who have survived acid attacks have lived with grit, courage, dignity and determination sending a firm message that their willpower cannot be destroyed by meek sadists hoping to scar their bodies. Unfortunately, the efforts of governments have not matched with that of survivors. In 2013, the Supreme Court mandated videography of acid buyers, by sellers, for easy identification; but the rule has been, more often than not, flouted. States were directed to allow only select stores to sell acid, and ensure there was no over the counter business of acid. One cannot say states have not taken stock of the situation. But it is also true that the SC order has not been implemented with seriousness.

UP may scrap 44-yr-old incentive scheme for interfaith marriages

Lucknow, Dec 2: After bringing in the anti-conversion law to check forced religious conversions, the Yogi Adityanath government is now planning to withdraw a scheme that has encouraged interfaith marriages for almost 44 years.

The Inter-caste and Interfaith Marriage Incentive Scheme has been in place since 1976 and was initiated by the national integration department in Uttar Pradesh.

Under the scheme, an interfaith couple can apply to the district magistrate within two years of marriage. After verification, the district magistrate forwards the application to the Uttar Pradesh national integration department.

"In U.P, 11 interfaith couples were beneficiaries of the scheme last year and got Rs 50,000 each," said a government spokesman.

This year, no amount has been released. The four applications that were filed remain pending.

'The scheme will be reconsidered after the Uttar Pradesh Prohibition of Unlawful Conversion of Religion ordinance. In any case both work at cross purposes," the spokesman

The ordinance, signed by Governor Anandiben Patel Saturday, makes way for punishment for the "forced" conversions, including those by marriage.

In 2017, the state government had added a caveat to the scheme - the interfaith couple could not convert after they got married, or they would lose the incentive.

Roshni scam illuminated **Gupkar bungalows: Singh**

Jammu, Dec 2: Firing a fresh salvo at rival parties in Jammu and Kashmir, BJP leader and Union Minister Jitendra Singh Wednesday said that the Roshni scam had illuminated the "Gupkar bungalows" but extinguished hope for the poor.

He said the Roshni scheme was launched in 2001 by the then government with an envisaged obiective of raising an amount of Rs 25,000 crore for setting up power projects which were to provide electricity to every household, including those of economically weaker sections of society.

"However, in the final bargain, what was witnessed was that all the loot out of the scam went into the construction of lavish bungalows at Gupkar Road and other VIP locations, whereas the poor neither got the electricity nor the house," said Singh, the Minister of State for Personnel.

"Roshni scam had illuminated the Gupkar bungalows, but extinguished hope for the poor," he told PTL

The BJP has been targeting leaders of the Congress, PDP and

NC including former Jammu and Kashmir chief minister Farooq Abdullah, who lives in a bungalow on Gupkar Road in Srinagar, over alleged encroachment of government and forest land.

The NC leader has, however, denied the charge.

November 1, the Union Territory administration cancelled all land transfers that took place under the JK State Land (Vesting of Ownership to the Occupants) Act, 2001 - also known as the Roshni Act - under which 2.5 lakh acres of land was to be transferred to the existing occu-

The Jammu and Kashmir High Court had declared the Roshni Act as "illegal, unconstitutional and unsustainable" and ordered a CBI probe into the allotment of the land under this law.

Singh said over the last decade, the BJP had been consistently demanding a thorough and impartial probe into the "embezzlement" that had taken place in

the name of the Roshni scheme. But, he alleged, successive governments run by the National Conference, Congress and the PDP did not agree to the probe and instead sought to "cover-up" the scam because the ministers and the chief ministers of the then governments were themselves beneficiaries.

It is only now under the Modi government, said Singh, when the investigative agencies were given a free hand to carry on their task that the entire scam has got unearthed and the skeletons are tumbling out.

While the "Gupkar governments robbed the land" that should have legitimately gone to the poor, he said, it is under Prime Minister Modi that targets have been set to construct a house for each family under Pradhan Mantri Awas Yojana (PMAY).

BJP-backed councillor becomes Srinagar mayor

Election of a BJP-backed councillor as mayor in the UT's most important ULB-the stronghold of the NC and the PDP-is seen as a setback for the PAGD as well as the Congress

New Delhi, Dec 2: BJP-supported independent councillor Junaid Azim Mattu has become the first mayor in the Srinagar Municipal Corporation (SMC) after Jammu and Kashmir was created as a Union Territory in August 2019.

After his education in Michigan, Mattu had a brief tryst with the secessionist ecosystem. His exit had come amid sharp protests from his friends about a decade back. Omar Abdullah picked him as the NC's spokesperson.

Mattu dissented NC's decision to boycott the Urban Local Body (ULB) elections after the downfall of Mehbooba Mufti's PDP-BJP gov-

ernment in 2018. He joined Sajad Lone's unrecognised Peoples Conference (PC) and was returned as that party's nominee from two wards in the summer capital traditionally monopolised by the NC and the PDP. With the support of the BJP and the PC, as also a number of independent councillors controlled by the two parties, Mattu was elected as mayor in the 74-ward SMC on November 6, 2018, when J&K existed as a State with special status.

The NC and the PDP had boycotted the much-delayed elections in the Panchayati Raj Institutions (PRIs) and the ULBs in 2018 in protest of the Centre's perceived plan to withdraw J&K's Statehood and the special status which was ul-

timately executed in August 2019. Leaders of several political parties, including the NC, the PDP and

the PC-as also the former Ministers and legislators who subsequently joined Altaf Bukhari's Apni Partywere arrested in apprehension of a political turmoil and detained for six to fourteen months. Leaders of the BJP and the Congress, however, were not detained in this crackdown.

Mattu continued as the PC's spokesperson but he was not arrested. June 16, 2020, he was removed through a no-confidence motion which was supported not only by the BJP but also its rivals, the NC and the Congress. Affiliated to the NC, an independent councillor Parvaiz Qadri was elected as deputy mayor.

Weeks after the political detainees were released, Mattu regained proximity to the BJP. In September, 2020, he announced his resignation from the PC as Sajad Lone's party had become a key constituent of the pro-370 Peoples Alliance for Gupkar

Declaration (PAGD). After deferring elections several times for one or the other reason and affecting changes to the law and its pertinent rules, the Department of Housing and Urban Development on November 19 notified the polling to fill up the post of the mayor in SMC. Three candidates filed the nomination papers. The Congress nominee, Aijaz Rasool, withdrew at the eleventh hour as the party issued a whip, binding its members to vote for Imran in his direct contest with

the BJP-backed Mattu.

Cong attacks BJP for dubbing Oppn leaders as 'anti-national'

Jammu, Dec 2: The Jammu and Kashmir Congress Wednesday hit back at BJP leaders for calling the Opposition "anti-national", alleging the saffron party was using every tool and instrument to "target political rivals" at the time of elections.

While campaigning for the District Development Council polls, J&K BJP president Rayinder Raina has been describing the opposition parties, including Congress, as "anti-national". He was recently joined by party general secretary Tarun Chugh who alleged that Peoples Alliance for Gupkar Declaration (PAGD) was indulging in anti-social and antinational rhetoric.

'The ruling party (at the centre) is vitiating the political atmosphere and even harming the broader national interest by dubbing the political rivals including Congress,

as anti-nationals for petty political gains, which is cheapest political tactics," J&K Pradesh Congress Committee (JKPCC) chief spokesperson Ravinder Sharma said in a statement.

Reacting to statements of senior BJP leaders who are camping in Jammu and Kashmir for campaigning for the District Development Council polls, he said they are using "highly loaded language" against political rivals and even terming them anti-nationals.

CCTVs must in CBI, ED and NIA offices: Top court

New Delhi, Dec 2: The Supreme Court directed the Centre Wednesday to install CCTV cameras and recording equipment at the offices of investigating agencies, including the CBI, the ED and National Investigation Agency (NIA), which conduct interrogations and have the power of arrest.

by Justice R F Nariman said that states and Union Territories (UTs) should ensure that CCTV cameras are installed at each and every police station,

making them imperative at all entry and exit points, main gate, all lock-ups, all corridors, lobby and reception area as also areas outside the lock-up room. The apex court, which had ear-

lier ordered installation of CCTV cameras in police stations to check human rights abuses, said that as most of the probe agencies including Narcotics Control Bureau, Department of Revenue Intelligence and Serious Fraud Investigation Office carry out interrogation in their offices, CCTVs be "compulsorily installed" in all offices where such questioning takes place and accused are kept.

It said the CCTV systems must be equipped with night vision and have audio as well as video footage and it shall be mandatory for the Centre, states and UTs to purchase such system which allows storage of data for maximum period possible, and in any case not below one year. "In addition, the Union of India is also directed to install CCTV cameras and recording equipment in the offices of: Central Bureau of Investigation, National Investigation Agency Enforcement Directorate, Narcotics Control Bureau, Department of Revenue Intelligence, Serious Fraud Investigation Office (SFIO), any other agency which carries out in-

terrogations and has the power of arrest," said the bench, also comprising Justices K M Joseph and Aniruddha Bose.

"As most of these agencies carry out interro-

gation in their office(s), CCTVs shall be compulsorily installed in all offices where such interrogation and holding of accused takes place in the same manner as it would in a police station," the bench said in its order. The top court said that in

September this year, it had impleaded all the states and UTs in the matter to find out the exact position of CCTV cameras in each police station as well as constitution of Oversight Committees in accordance with the April 3, 2018

The apex court, while dealing with a matter related to custodial torture, had in July this year taken note of a 2017 case in which it had ordered installation of CCTV cameras in all the police stations to check human rights abuses, videography of crime scene and setting up of a Central Oversight Committee and such a panel in every states and Union Territory.

NGT imposes total ban on crackers in NCR

New Delhi, Dec 2: In a fresh directive, the National Green Tribunal has directed that there would be a total ban on the sale and use of all kinds of firecrackers during COVID-19 pandemic in the NCR and all cities/towns in the country where the ambient air quality falls under the 'poor' and above category.

The green panel, however, said during Christmas, and new year, green crackers can be used from 11:55 pm to 12:30 am only at places where air quality is 'moderate' or

A bench headed by NGT Chairperson Justice Adarsh Kumar Goel said its direction to restrict the use of firecrackers in cities/towns where air quality is 'moderate' or below to green crackers and for the duration of not more than two hours will continue.

Other than specified festivals,



prior permission of the District Magistrate of the area will be required for use of crackers for limited period which will be given having regard to air quality, the tribunal said.

cities/towns in the country where the ambient air quality falls under the 'poor' and above category," the bench said.

"Since pandemic is still continuing and aggravated by the addition of pollution by fire crackers, having potential of damage to public health, invoking precautionary principle under section 15 and 20 of

the NGT Act, 2010, we are satisfied that there is need to continue directions for prohibition and regulation of use of fire crackers," the bench said.

It directed all District Magistrates to ensure that banned firecrackers are not sold and asked them to recover compensation

from violators. Any victim of pollution, apart from other remedies, can approach District Magistrate for compensation, it added.

"Any victims of pollution ,apart from other remedies can approach the District Magistrate for compensation, by showing evidence of individual damage and the person responsible for the damage. Such claim may be dealt with by a reasoned order," it said.

The NGT also directed that at least one air quality monitoring station must be set up at every district headquarter at the earliest.

59% Indians sceptical about vaccine

New Delhi. Dec 2: With chances of affordable Covid-19 vaccine likely to be available by February 2021, 59 per cent Indians divulged that they will not rush to take it, a survey revealed Wednesday.

The last few weeks have given hope to the world with three vaccine makers -- Pfizer, Moderna and Oxford-AstraZeneca releasing their efficacy data. Oxford-AstraZeneca has a partnership with Serum Institute of India for production and reports suggest that the vaccine could be available as early as February at Rs 500-600

With the possibility of an affordable vaccine by February 2021, a survey was conducted by 'LocalCircles' to understand the hesitancy levels. The survey received more than 25,000 responses from citizens across 262 districts of India.

The first question in the survey asked. "The Covid-19 vaccine is likely to be available from February 2021 via private and Government channels. If that happens, what will be your ap-



proach to taking this vaccine?". Responses from 8,936 citizens were received. Of which, 8 per cent said. "I am a health or frontline worker and will get it on priority through the government", 13 per cent said "will get it as quickly as it becomes available via any healthcare channel", 11 per cent said "will get it as quickly as it becomes available via private healthcare channel"

Another 59 per cent of re-

spondents said that they will not rush to take the vaccine even if The perception of the majority of citizens sceptical on taking vaccine has not changed much as compared to the result of the survey conducted in mid-October by LocalCircles.

Sixty-one per cent of 8,312 voters at the time had said they are sceptical about COVID-19 vaccine and will not rush to take it in 2021 even if it is available.

Closer home in India, where Serum Institute of India is conducting trials for the vaccine under name Covishield, a participant who undertook the trial has alleged the vaccine of causing him serious sideeffects, both neurological and psychological filing for dam-

ages against Serum Serum has dismissed the claims as "oblique pecuniary motive" maintaining that the participant's suffering was independent of the vaccine trial he underwent and has sought damages for malicious allegations in excess of Rs 100 crores.

'2nd wave of nCoV in K'taka likely in Jan-Feb'

Bangalore, Dec 2: The Technical Advisory Committee (TAC) for COVID-19 in Karnataka has said the second wave of the pandemic is expected in early 2021 and has made a slew of recommendations including banning public celebrations ahead of the new year in a bid to avert a crisis.

It has also recommended clamping night curfew during that period, but the government said it was yet to take a call on the matter.

The TAC has said the second wave of the pandemic was expected in January-

February next year. It has asked to keep ready by first week of January, clinical facilities at October level (when daily cases were about 10,000 per day) in terms of beds, ICUs, ventilators, and so on, both in government and private hospitals or this could be ramped up at a short notice of 2-3

days maximum. It has also recommended a ban on new year public celebrations from December 26 to January 1 and impose night curfew (8 pm to 5 am) during this period. The TAC, based on the deliberations at its 53rd meeting held November 24, has given advisory on recognition and containment measures for the second wave of

COVID-19 in Karnataka. According to

TAC, early recognition of the second wave of COVID-19 in the state can be done by closely monitoring the 7-day average growth rate and repro-

duction number (R0) at district

and state levels. It said an epidemic intelligence team shall be supporting the state war room for early recognition of the second wave and alert the Additional Chief Secretary and Commissioner of the Health and Family Welfare department.

'Make community service must for mask rule violation

Ahmedabad, Dec 2: The Gujarat High Court Wednesday ordered the state government to come up with a notification, making it mandatory for those violating the face mask rule to do community service at COVID-19 centres as a punishment in addition to the fine

imposed on them. A division bench of Chief Justice Vikram Nath and Justice J B Pardiwala said the community service at COVID-19 centres shall be non-medical in nature and shall be for four-six hours for a period of 5 to 15 days, as authorities deem it fit and necessary. The HC also asked the government to widely publicise this in the media so it could have a "desirable deterrent effect", noting that a person not wearing a mask is not only putting himself at risk, but

putting the community at risk. "Hence, the said violator must extend services to the community which is put at risk," the court said.

India's readiness prompts China to scramble for high-altitude gear

New Delhi, Dec 2: China is making last minute efforts to make emergency procurements of highaltitude gear and clothing for its troops as they were caught unaware with India's readiness for the harsh winter atop the Eastern Ladkah heights -- that has been the bone of contention between the two Asian majors.

India has occupied critical mountain heights on the southern bank of the Pangong Lake including Rechin La, Rezang La, Mukpari that were unmanned till now.

This along with some other peaks allows India to dominate Spangur Gap under Chinese control and also the Moldo garrison on the

Chinese side. This has irked the PLA which has made multiple attempts to dislodge Indian troops leading to instances of warning gunshots being fired.

Sasikala applies for remission

Bangalore, Dec 2: Late Tamil Nadu Chief Minister J Jayalalithaa's close aide V K Sasikala, serving a four-year jail term on graft charges, has sought remission and early release from prison, official sources said Wednesday.

Sasikala, lodged at the Parappana Agrahara prison here, is expected to come out on January 27, 2021 after she deposited ₹10 crore fine at a special court.

The prison authorities have forwarded her application to higher officials. "She has applied for remission of her jail term and it has been forwarded to the head of the department for their consideration," a source said. Authorities are yet to take a call on it. After the Supreme Court restored the trial court judgment in toto against Sasikala and two of her close relatives in the disproportionate assets case, she surrendered before the court in Karnataka on February 15, 2017 and has been lodged in Parappana Agrahara Central Jail

Her two relatives are also undergoing four years simple imprisonment and all three of them were slapped with a fine of ₹10 crore each. With the death of Jayalalithaa in 2016, who was the first accused in the case, the appeal by Karnataka against her stood abated. As per the norms, three days of remission for good conduct is available for every month in jail and so far, she has completed 43 months, making her eligible for a reduction of 135 days in prison.

CHINA TURNS TO INDIA FOR RICE

Mumbai, Dec 2: China has begun importing Indian rice for the first time in at least three decades due to tightening supplies from Thailand, Myanmar and Vietnam and an offer of sharply discounted prices, Indian industry officials said.

India is the world's biggest rice exporter and China the biggest importer. Beijing buys in around 4 million tonnes a year but has avoided purchases from India, cit-

ing quality issues. India has tightened rules for investments from China and banned dozens of Chinese mobile apps, including from tech giants Tencent, Alibaba and ByteDance.

Although the public mood in India has been anti-China, the country has remained engaged with Indian

"For the first time China has made rice purchases. They may increase buying next year after seeing the quality of Indian crop," B.V. Krishna Rao, president of the Rice Exporters Association, said Wednesday.

Indian traders have contracted to export 100,000 tonnes of broken rice for Dec-February shipments at around \$300 per tonne on a free-on-board (FOB) basis, industry officials said. China's traditional suppliers, such as Thailand, Vietnam, Myanmar and Pakistan, have limited surplus supplies. Thailand, the world's second-largest rice exporter and key supplier to China, suffered a drought this year that has affected the rice crop. Its shipments in 2020 could fall to 6.5 million tonnes, the lowest in 20 years. "Thailand Myanmar and Vietnam are struggling due to limited supplies. China eventually was left with no option but to buy from India," said Himanshu Agarwal, executive director at Satyam Balajee, India's biggest rice exporter

'China buying rice from India, or US or any country, is just adding some flavor to the domestic market,"said Yin Xiuying, analyst website trade www.ChinaGrain.CN, based in Harbin, capital of China's northeastern province of Heilongjiang.

India records largest reductions in malaria cases: Govt

New Delhi, Dec 2: The WHO's World Malaria Report (WMR) 2020, which provides estimated cases for malaria across the world based on mathematical projections, indicates that India has made considerable progress in reducing its malaria burden, the Union health ministry

said Wednesday. India is the only high endemic country which has reported a decline of 17.6 per cent in 2019 as compared to 2018 as far as malaria cases are concerned, it said.

The Annual Parasitic Incidence (API) reduced by 27.6 per cent in 2018 as compared to 2017, and by 18.4 per cent in 2019 as compared to 2018. India has sustained API less



than one since year 2012," the ministry said. India has also contributed to the largest drop in such cases region-wide, from approximately 20 million to about 6 million.

The percentage drop in the malaria cases was 71.8 per cent and deaths was 73.9 per cent between 2000 to 2019, the ministry said.

India achieved a reduction of 83.34 per cent in malaria morbidity and 92 per cent in malaria mortality between the year 2000 (20,31,790 cases, 932 deaths) and 2019 (3,38,494 cases, 77 deaths), thereby achieving Goal 6 of the Millennium Development Goals (50-75 per cent decrease in case incidence between 2000 and 2019).

"Decrease in incidence of malaria cases is also exhibited in the year-

on-year tally. The cases and fatalities have declined significantly by 21.27 per cent and 20 per cent, respectively in the year 2019 (3,38,494 cases, 77 deaths) as compared to 2018 (4,29,928 cases, 96 deaths).

"The total number of malaria cases reported in 2020 till October(1,57,284) has further decreased by 45.02 per cent as compared to the corresponding period of 2019 (2,86,091)," the ministry said.

Malaria elimination efforts were initiated in the country in 2015 and intensified after the launch of the National Framework for Malaria Elimination (NFME) in 2016 by the Ministry of Health and Family Welfare.

The National Strategic Plan for Malaria Elimination (2017-22) was

launched by the health ministry in July, 2017 which laid down strategies for the next five years.

The first two years saw a 27.7 per cent decline in cases and 49.5 per cent reduction in fatalities; 11,69,261 cases and 385 deaths in 2015, and 8,44,558 cases and 194 deaths in 2017.

The states of Odisha, Chhattisgarh, Jharkhand, Meghalaya and Madhya Pradesh disproportionately accounted for nearly 45.47 per cent (1,53,909 cases out of India's 3,38,494 cases) of malaria cases and 70.54 per cent (1,10,708 cases out of India's 1,56,940 cases) of falciparum malaria cases in 2019. The health ministry said 63.64 per cent (49 out of 77) of malaria deaths was also reported from these states

The consortium of lenders consists of China Development Bank, China Construction Bank. Industrial and Commercial Bank of China and Bank of China, the paper said. The implementation agreement and water use charges agreement for construction of the project were signed by PoK Electricity Secretary Zafar Mahmood Khan and Azad Pattan Power Private Limited CEO Li Xiaota on Tuesday, the paper said.

The CPEC, which connects Gwadar Port in Balochistan with flagship project of Chinese President Xi Jinping's ambitious Belt and Road Initiative (BRI) Originally valued at USD 46 billion, the CPEC projects were worth USD 62 billion as of 2017.

India has protested to China over the CPEC as it is being laid through PoK. The Ministry of External Affairs early this year said that Pakistan was told that the entire Jammu and Kashmir and Ladakh, including areas of Gilgit and Baltistan, are an integral part of India and that Islamabad should immediately vacate the areas under its illegal occupation.

China's Chang'e-5 probe collects moon samples

of Bengal coast in Colombo, Sri Lanka, Wednesday

Beijing, Dec 2: On the most China's Chang'e-5 probe drilled the lunar surface, collected samples Wednesday in the first such effort in over 40 years and began preparations to bring the precious soil to earth, the country's space authority said.

The Chang'e-5 probe has collected moon samples after landing on Tuesday, the China National Space Administration (CNSA) announced on Wednesday. The unmanned probe landed in the area called Oceanus Procellarum, also known as the Ocean of Storms, on the near side of the moon and started rolling out its solar panel wings and unlocking some of the payloads on-board to prepare

for sample collection. The lander first drilled a 2meter-deep hole, digging out soil, and sealed it up at 4:53 a.m. on Wednesday. Next, it will use its robotic arms to scoop up more samples from the lunar surface for backup, state-run media reported. About two kgs of samples are expected to be collected and sealed in a container, CNSA officials said.

State-run media has shown photos of the lander on the lunar surface after it landed successfully. "We designed two methods for the spacecraft to collect samples. One is to sample the lunar surface, and the other is to drill underground. The two methods could increase the chance of getting more diverse samples." Peng Jing, deputy chief designer of the Chang'e-5 probe said.

It is China's maiden attempt to retrieve materials from an extra-terrestrial body. The United States sent astronauts to the moon to collect samples. In the Soviet Union's unmanned lunar sampling missions, the spacecraft took off from the moon and returned to Earth directly.

China planned Galwan Valley incident: US report

Washington, Dec 2: The Chinese government had planned the Galwan Valley incident in June, potentially including the possibility for fatalities, a US Congressional Commission has said, asserting that Beijing "provoked" the first deadly clash on the Sino-India border in nearly half a century.

The ruling Chinese Communist Party employs its armed forces as a coercive tool during peacetime, carrving out large-scale intimidation exercises around Taiwan and in the South China Sea, the US-China Economic and Security Review Commission said in its latest annual report to Congress. "This year, it provoked the first deadly clash on the China-India border in nearly half a century. China's rising aggression has not gone unnoticed," the report said. In June, China's People's Liberation Army (PLA) and Indian troops engaged in a massive physical brawl in the Galwan Valley, located in the far-western Ladakh region along the Line of Actual Control (LAC) separating the two countries, said the report dated December 1.

The clash, which followed a se-



ries of standoffs beginning in early May along multiple sectors of the LAC, led to at least 20 Indian deaths and an unconfirmed number of Chinese casualties, the first time since 1975 that lives were lost in fighting between the two sides.

'Some evidence suggested the Chinese government had planned the incident, potentially including the possibility for fatalities," the report said. For instance, several weeks prior to the clash Chinese Defence Minister Gen. Wei Fenghe made a statement encouraging Beijing to "use fighting to promote stability."

Just over two weeks before the incident, in another potential indication of Chinese leaders signalling their intent to escalate tensions, an editorial in China's state-owned tabloid Global Times warned that India would suffer a "devastating blow" to its trade and economic ties with China if it got "involved in the US-China rivalry.

Further satellite images depicted a large Chinese buildup in the Galwan Valley, including potentially 1,000 PLA soldiers, the week before the deadly skirmish, said the Congressional Commission created in 2000 for monitoring and investigating national security and trade issues between the US and China.

China and India have engaged in multiple physical clashes along their border for decades, but since General Secretary Xi Jinping assumed power in 2012 the two countries have seen five major altercations along their border. The exact motivations behind the Chinese government's provocative behaviour on the LAC this year remain unclear, it noted

More midwives could save millions of lives per year by 2035: Study

London, Dec 2: Increasing the number of midwives and their level of care could save up to 4.3 million lives per year over the next 15 years, particularly in low and middle income countries, according to a study published in The Lancet Global Health journal.

This modelling study estimates that scaling up the provision of midwife-led care across the world could potentially reduce maternal deaths by 67 per cent, newborn deaths by 64 per cent and stillbirths by 65 per cent if midwives were enabled to provide a range of interventions from family planning to post-natal care. This could equate to saving 4.3 million lives per year by 2035, the researchers noted.

"Supported by appropriate professional education, regulation and improved working environments. it is possible to achieve a substantial increase in the level of provision of essential interventions delivered by midwives. This could save millions of lives," said study lead author Andrea Nove from Novametrics

"However, there are numerous barriers to fulfilling this level of scale-up, particularly in low to middle income countries," Nove said. These limitations, he explained, include inequitable dis-

tribution of qualified midwives, poor transport links, lack of supplies and equipment and, in some countries, a lack of trust from the public, adding there is need for greater recognition of the importance of supporting and enabling this service to reach its potential.

The new study follows a past report on midwifery in The Lancet iournal and uses the Lives Saved Tool (LiST) which models the deaths that could be avoided, assuming a specific uptake, effectiveness and impact of a range of interventions.

Using an updated version of LiST, the current study aimed to provide a more accurate estimate of the impact of increasing the provision of



midwife healthcare around the world. The study used the LiST to model effects on mortality at a country level of about 30 essential interventions which can be delivered in their entirety by competent and enabled

midwives, the researchers said. These were treatments, responses

and procedures that can be provided before conception, in antenatal care, during labour and birth and after birth, such as family planning, hypertension screening, induction of labour and the use of antibiotics for newborn sepsis, they said. The study modelled the effect of changes in the level of provision of healthcare interventions delivered by midwives for 88 countries and amalgamated the results.

This was also done for three groups of countries that were categorised according to their level of development. If current mortality rates persist, in these 88 countries there will be over three million stillbirths per year by 2035, three mil-

lion newborn deaths per year by 2035 and over 400,000 maternal deaths per year by 2035, according to the researchers.

They estimated that relative to the current provision of healthcare by midwives, a 25 per cent increase every five years in the 88 countries would result in 41 per cent fewer deaths of mothers, 26 per cent fewer stillbirths and 39 per cent fewer ঽ deaths of newborn babies.

The researchers noted that this would mean averting 170,000 maternal deaths, 852,000 stillbirths and 1.2 million newborn deaths per year by 2035, adding the reductionin deaths was estimated to be greater in the least developed countries.

SC stays **NCLAT** order for **CCI probe against Flipkart**

New Delhi, Dec 2: The Supreme Court Wednesday stayed the March 4 order of National Company Law Appellate Tribunal (NCLAT) asking fair trade regulator CCI to again initiate the probe against e-commerce major Flipkart for an alleged use of its dominant position.

A bench of Chief Justice SA Bobde and Justices AS Bopanna and V Ramasubramanian, which initially was of the view to send back the matter to NCLAT after setting aside March 4 order and decision on all aspects including the issue of dominant position being enjoyed by Flipkart, later stayed appellate tribunal's decision.

The top court issued notice to All India Online Vendors Association (sellers association) and Competition Commission of India (CCI).

Senior advocate Harish Salve, appearing for Flipkart, said that CCI doesn't look at the findings of the Government and relied on the tax department findings and misread the findings of the tax tribunal. He said that the other e-commerce major Amazon is against his client company and if he is not a dominant player then the allegations of predatory pricing does not apply on Flipkart.



Salve submitted that the predatory pricing is an issue to be considered against the dominant player as a case of abuse of power but his client has not been held as a dominant player.

The bench said that the CCI has rendered a categorical finding that Flipkart does not have the dominant position and the NCLAT has not reversed the findings on the dominant position.

It told the counsel for vendors association that if they are agreed that the NCLAT should have considered the issues of dominant position then it can remand back the matter. To which counsel appearing for All India Online Vendors Association (sellers association)

said that they would like to argue

The bench then issued notice and stayed the March 4 order of NCLAT and listed the matter for further hearing. On March 4, the NCLAT has set aside the earlier order passed by the CCI absolving Flipkart of unfair practices using its dominant position and directed it to ask its probe arm Director General (DG) to investigate into the allegations. The NCLAT said that the All India Online Vendors Association (AIOVA) had success

fully made its case here. In November 2018, the AIOVA had approached the CCI alleging abuse of market dominance by e-

Exporters seek extension of tax benefits for SEZs

New Delhi, Dec 2: Exporters Wednesday suggested to the government a series of steps, including extension of fiscal benefits to SEZ units, presumptive tax for crossborder e-commerce and free trade pacts with countries like the US and UK, to boost domestic manufacturing and outbound shipments.

These recommendations were made by the Federation of Indian Export Organisations (FIEO) at a meeting of the Board of Trade (BOT) which was chaired by Commerce and Industry Minister Piyush Goyal. Other suggestions included permitting duty free import of equipment required for R&D and product development; setting up of a Niryat Vishwavidyalay; extension of interest subsidy scheme in the new foreign trade policy; and immediate release of GST and drawback funds.

Further, the federation recommended refund of GST to foreign tourists, RoDTEP (Remission of **Duties or Taxes on Export Products)** scheme covering all products; and amnesty scheme for schemes prescribing export obligation.

FIEO Director General Ajay Sahai said that these measures would help in significantly promoting manufacturing and boosting the country's exports.

He further said the minister asked the officials present in the meeting to examine these suggestions. Apparel Export Promotion Council (AEPC) Chairman A Sakthivel sought resolution of operational issues for ease of doing business and redressal of the issue of duty disadvantage in

overseas markets by entering into early negotiations for free trade agreements (FTAs). He also asked for changes in the Export Promotion Capital Goods (EPCG) scheme to take care of the growing need of capital investment in the sector. He added that the entire process

of flagging an exporter as a 'risky exporter' to removal of the tag and resumption of refunds should be completed within 30 days, and a protocol must be developed for transparent flow of information. Engineering exporters too sug-

gested for easing of GST refund rules and extending affordable credit to the sector.

Measures to boost exports, manufacturing and the new foreign trade policy figured in the meeting.

The board, which includes members from both public and private sector, advises the commerce and industry ministry on policy measures related to foreign trade policy (FTP). Secretaries of different departments, heads of various government bodies, representatives of apex industry associations and export promotion councils are members of the BOT.



The cushion provided by his 'senior' helped Natarajan to start bowling his yorkers under pressure and Thakur also chipped in with necessarv wickets.

The inconsequential match became something of consequence for Virat Kohli and his men as they

Canberra: India captain Virat Kohli Wednesday became the fastest cricketer to score 12,000 ODI runs, breaking a record held by legendary compatriot Sachin Tendulkar. Kohli reached the milestone during the third and final match against Australia here. Kohli, who needed 23 runs for the landmark coming into the match, touched the figure in his 242nd innings when he took a single off Sean Abbott in the 13th over of India's essay. In comparison, it took Tendulkar 300 innings to get there. The 32-year-old Indian captain was playing in his 251st ODI and averages close to 60 in the format with 43 hundreds and 59 half centuries. He made his debut in 2008. Tendulkar scored 18,426 runs from 463 ODIs between 1989 and 2012 at an average of 44.83 with the help of 49 hundreds and 96 half centuries.



Oz move to top of ICC Super League table, India sixth

Dubai: Australia Wednesday jumped to the top of the ICC World Cup Super ODI League points table following their 2-1 series victory over India, who are placed sixth. With the series win, Australia moved to 40 points, overtaking second-placed England (30 points). On the other hand, India are sixth with nine points. Australia had defeated England 2-1 in their previous series of the 13-team championship, which was introduced this year to bring context to ODI cricket and also to decide the seven direct qualifiers for the ICC World Cup 2023. India, though assured of a berth as hosts, were to use the opportunity for long-term preparation.

STARC JOINS WARNER IN AUSTRALIA'S INJURY LIST

Canberra: Australia pacer Mitchell Starc is nursing a back and rib niggle, captain Aaron Finch revealed Wednesday after the pacer was not named in the playing XI for the third and final ODI against India here. Starc, who struggled in the first two matches of the ongoing ODI series, joined David Warner in the injury room. "Starcy has got a little bit of a back and a rib niggle. The medical staff thinks he will benefit from a few days off," Finch said at the toss. In the first two ODIs in Sydney, Starc took just one wicket for 147 runs. He conceded a whopping 20 runs, bowling four wides and a no ball, in the opening over in the first match. Australia won the ODI series 2-1, Wednesday.

Paris, Dec 2: While former champions Liverpool and Porto eased to the knockout stage of the Champions League, record 13-time champion Real Madrid faces an embarrassing group-stage exit after losing 0-2 at Shakhtar Donetsk.

Zinedine Zidane's side would have advanced with a win Tuesday, but they have defended poorly all season and it was undone by counterattack goals in the second half. Instead of progressing, Madrid dropped to third place in Group B behind the Ukrainian side and Borussia Monchengladbach.

Six-time champion Liverpool overcame injury problems to beat four-time winner Ajax 1-0 at Anfield, thanks to a second-half goal from midfielder Curtis Jones.

Two-time winner Porto held already-qualified Manchester City to a 0-0 draw at home, although City ensured the top spot. No drama in those two groups, but plenty in Madrid's as Gladbach missed the chance to advance after losing 2-3 at home to three-time champion Inter Milan, who had to win.

Atletico Madrid did not do enough, drawing 1-1 at home to Bayern Munich even though the defending champion fielded a weak ened side having already qualified.

Madrid has advanced to the knockout stage in all 24 of its previous group-stage campaigns but things are looking tense. Madrid have conceded nine goals in five games for their worst-ever defensive record at this stage, losing twice to a Shakhtar side who leaked 10 goals in two defeats to Gladbach.

Brazilian forward Dentinho profited from a mix-up between Ferland Mendy and Raphael Varane to net in the 57th minute following a counterattack. Zidane's players failed to take heed and the second stemmed from another counter as substitute Manor Solomon finished confidently.

was in no way in an offside position. The Men of Steel finally restored parity in the game in the 85th minute thanks to a thunderous strike from Eze. Valskis initiated the move with a cross which Adil Khan cleared but the ball fail to Monroy who set up for Eze to shoot and the Nigerian found the back of the net.

Malan, Buttler help Eng conquer SA T20Is

Cape Town, Dec 2: England swept the T20I series against South Africa 3-0 with a blistering 99 not out (47b, 11x4, 5x6) from Dawid Malan seeing the tourists romp to a ninewicket win in the final game here.

Malan knock made a difficult run chase look like a breeze as England overhauled South Africa's 191/3 with more than two overs to spare. England finished on 192/1 in 17.4 overs, with Malan and Jos Buttler (67 n o, 46b, 3x4, 5x6) sharing an unbroken partnership of 167 for the second wicket to take England charging home at Newlands. It was England's highest partnership in T20s and the eighth-highest

of all time. The only disappointment was Malan missing out on a second T20I century, which he could have got if he'd hit what turned out to be the last ball of the game for a boundary. Instead, with him on 98 and England needing one to win, he took a single out on the off side and then appeared to re-



alize his error.

South Africa appeared in good position to take something from the series when Faf du Plessis (52 no, 37b, 5x4, 3x6) and Rassie van der Dussen (74 n o, 32b, 5x4, 5x6) put on 127 for the fourth wicket. Their stand resurrected South Africa
