ONCE-IN-A-CENTURY CRISIS

ECONOMIC CONTRACTION PROJECTED AT 7.7 PC IN FY21, STATES ECONOMIC SURVEY

New Delhi, Jan 29: India's Gross Domestic Product (GDP) is projected to contract by a record 7.7 per cent in the current fiscal ending March 31, 2021, the Pre-Budget

Economic Survey said Friday. The economy is likely to rebound with an 11 per cent growth in the next financial year as it makes a 'V-shaped' recovery after witnessing a pandemic-led carnage.

India witnessed its last annual contraction of 5.2 per cent in fiscal year 1979-80. The Economic Survey 202021 said the agriculture sector is the only silver lining while services, manufacturing and construction were most hit by the lockdown that was imposed to curb the outbreak of the COVID-19 pandemic.

After an estimated 7.7 per cent pandemic-driven contraction in 2020-21, India's real GDP is projected to record a growth of 11.0 per cent in 2021-22 and nominal GDP by 15.4 per cent.

These conservative estimates reflect upside potential that can manifest due to the continued normalisation in economic activities as the

Singhu border witnesses violence

New Delhi, Jan 29: Violence broke out at the Singhu border protest site after large groups of people claiming to be locals reached there to vacate the area, leading to a clash between them and agitating farmers and prompting police to resort to baton charge and use tear gas

Delhi Police SHO (Alipur) Pradeep Paliwal was injured in the violence after a man attacked him with a sword, an official said, adding that some people were also wounded.

The official said that police detained the man who attacked the station house officer. The locals demanded that the farmers vacate the Singhu border protest site as they had "insulted" the national

OLLYWOOD ICON CICELY TYSON NO MORE



Los Angeles: Emmy award- winning actress Cicely Tyson, known for her portrayal of strong Black women on screen, is no more. She was 96. Tyson, who was nominated at the

Oscars for her role in Sounder, passed

away Thursday. The news of her demise was announced by her family through her manager Larry Thompson, reports variety.com.

"I have managed Miss Tyson's career for over 40 years, and each year was a privilege and blessing," said Thompson, adding: "Cicely thought of her new memoir as a Christmas tree decorated with all the ornaments of her personal and professional life. Today she placed the last ornament, a Star, on top of the tree."

Tyson's memoir 'Just As I Am' was published Tuesday.

The actress had her Hollywood break in the 1959 Harry Belafonte film *Odds* Against Tomorrow, and followed it with films like *The Comedians*, *The Last Angry* Man, A Man Called Adam and The Heart Is a Lonely Hunter.

Tyson received an Oscar nomination in 1973 for Martin Ritt's drama Sounder and an Honorary Oscar in 2018.

She is also known for featuring in Miss Jane Pittman, Roots, The Wilma Rudolph Story, King: The Martin Luther King Story, When No One Would Listen, A Woman Called Moses. The Marva Collins Story, The Women Of Brewster Place, The Oldest Living Confederate Widow Tells All and the TV adaptation of Trip To Bountiful.

Throughout her career. Tyson refused to play drug addicts, prostitutes or maids as she thought it demeaned and stereotyped Black women. The actress was one of 25 Black women honoured for their contribution to art, entertainment and civil rights as part of Oprah Winfrey's 2005 Legends Ball.

Several Hollywood stars mourned her

Actress Viola Davis, who co-starred with Tyson in How To Get Away With Murder, shared a long note: "I'm devastated. My heart is just broken. I loved vou so much!! You were everything to me! You made me feel loved and seen and valued in a world where there is still a cloak of invisibility for us dark chocolate girls. You gave me permission to dream.

"Because it was only in my dreams that I could see the possibilities in myself. I'm not ready for you to be my angel yet.


But...I also understand that it's only when the last person who has a memory of you dies, that you'll truly be dead. In that case, you will be immortal. Thank you for shifting my life. Thank you for the long talks. Thank you for loving me. Rest well,"Davis added.

Oprah Winfrey posted: "Of all the times and experiences we shared together, this was one of my favorites .. What a joy to honor her and feel her receive it! I loved her hat so much, she sent it to me afterwards. Cicely decided early on that her work as an actor would be more than a job. She used her career to illuminate the humanity of Black people. The roles she played reflected her values; she never compromised. Her life so fully lived is a testimony to Greatness.





State to revamp Single Window Clearance Authority

Bhubaneswar, Jan 29: In a bid to attract more investments, the state government has decided to transform its Single Window Clearance Authority (SWCA) system to the next level.

This was revealed at a high-level meeting held under the chairmanship of Chief Secretary Suresh Chandra Mahapatra, Friday.

Mahapatra asked the Industries department to make the new version more comprehensive and gratifying for the investors with end-to-end system from receipt of application to delivery of all services.

He made it clear that the investors should not be asked to run to any office physically for getting any clearance. He also directed all the departments concerned to designate a nodal officer for coordinating with Industrial Promotion & Investment Corporation of Odisha (IPICOL) in development of the new online version.

Further, Mahapatra directed to revamp the district-level single window authorities with more professionalism and accountability. He advised to put in place a district-level industry facilitation authority with **WOOING INVESTORS**

SC seeks report on pending penalty with mining firm

New Delhi, Jan 29: The Supreme Court, Friday, asked the Odisha government to file an additional affidavit regarding the pending penalty on Narayani Sons Ltd, a mining company, for violation of environment norms and mining without consent to operate.

A three-judge bench of the apex court headed by Chief Justice SA Bobde and comprising justices AS Bopanna and V Ramasubramanian asked Odisha to file an affidavit in three weeks.

During the hearing, the counsel appearing for the lessee, NS Nandkarni, submitted to the court that he had paid all the dues along with interest to the state government for alleged environmental clearance violations and urged the court to grant him permission to lift and sell the extracted ore.

However, the counsel for Odisha, Kirti Mishra, submitted that the lessee hasn't paid all the dues. Mishra sought time from the court to file an affidavit giving details of the dues pending on the lessee.




Meanwhile, advocate Prashant Bhushan opposed the prayer of the lessee to lift extracted ore citing that its lease licence had expired in 2010.

However, the lessee's counsel referred to an affidavit filed by the state government in the apex court and said that the lease of Narayani Sons Ltd was extended till March 2020.

It is pertinent to mention here that the Supreme Court had imposed huge penalty on the mining firm for carrying out mining operations in Odisha without obtaining environmental clearance.


State ready for greener fuel

Bhubaneswar, Jan 29: Odisha police secured the third place in terms of policing in the recently released India Justice Report for 2020. The report has been prepared jointly by various leading legal and human rights think tanks of India.

Odisha had held the seventh spot in policing in the India Justice Report for 2019. Now, it jumped to 3rd spot in the current report which was released Thursday. The report revealed that the state police

force showed significant development in filing up vacancies in lower ranks, increased the number of women in force.

'Odisha's four-spot jump to third place in police ranking is the result of the state's efforts to improve deficits in the policing capacity since 2017. It has made efforts to im-

prove not only the caste diversity amongst officers but has also increased the presence of women personnel (9 per cent to 10 per cent) and the share of women officers (8 per cent to 11 per cent)," reports the IJR

eport also stated that the state police have showed a decrease in constable vacancies over a five-year period (2015–2019). However, the report indicated an 'increase in vacancies at the officer level'.

The state police force also managed to 'utilize only 10 per cent of its Modernisation Fund, over 40 percentage points less than

Of the nine officials, seven have been terminated on cor-

ruption charges while two others have been removed for their inefficiency in delivering services. With this, a total of 113 government servants have so far been given compulsory retirement in the state.

Sources said two mines department officials, one forest ofOrganisation (PHEO) were asked to retire Friday. Five officials were given compulsory retirement a few days ago, official sources said.

Srijagannath Sebayat Sammilani, an outfit of Srimandir servitors, Friday alleged that the SJTA did not take prompt action to resolve the dispute between Singhari Puspalak and Bhandar Mekap servitors. There was a dispute between Singhari Puspalak and Bhandar Mekap servitors during the Nagarjuna Besha (warrior attire) ritual of Lord Jagannath in November last year. "The reason of the dispute was the presence of excess number of Singhari servitors on the Ratnabedi (bejeweled throne). The SJTA was quite aware

of the dispute but it did not take any

step to solve the issue. The two groups of servitors were in a tussle over the same issue again Thursday," said the outfit.

Senior Daitapati servitor Binayak Das Mahapatra too blamed the SJTA for the Suna Besha ritual delay. "The dispute between Singhari and Bhandar Mekap servitors is nothing new. The dispute was reported during Nagarjuna Besha. But, the SJTA did not take any step to resolve it," Das Mahapatra said.

The senior Daitapati servitor

also claimed that many devotees could not witness Suna Besha (golden attire) due to the delay. Besides, Mahaprasad, the Srimandir delicacy, could not be made available for the devotees on time due to the inordinate delay. "The Suar-Mahasuar servitors incurred huge losses as large amount of Mahaprasad remained unsold,"

Notably, The Suna Besha ritual of Lord Jagannath and his siblings was reportedly delayed for around five hours Thursday.

"The Sakala Dhoopa ritual of the presiding deities was completed by 9.40am Thursday. It was expected that the Suna Besha ritual would be performed by 11:30am. However, the ritual was performed at 5pm due to some dispute between two groups of servitors,' said a source in temple administration.

SJTA chief administrator Krishan Kumar had said that the temple authorities would seek reports from the two groups of servitors on the ritual delay and take necessary steps to solve the issue

NGT seeks report on sand mining in Subarnarekha

Bhubaneswar, Jan 29: The National Green Tribunal (NGT) has asked the state government to examine the allegations of illegal sand mining in Jaleswar area of Balasore district and submit a report within two months.

The development follows a petition filed in the tribunal seeking its intervention in the alleged illegal sand mining activities along Subarnarekha river under Jaleswar tehsil in Balasore.

The NGT has asked the state government to form a special panel and examine the issue before filing a report within two months. The tribunal in its written order has also made CPCB, SEIAA and SPCB as parties to the panel.

"Let a joint Committee of four members, comprising Central Pollution Control Board (CPCB), State Pollution Control Board (SPCB), State Level Environment Impact Assessment Authority (SEIAA), Odisha and District Magistrate, Balasore, look into the grievance in the application and furnish a report to this Tribunal within two months," the

order said

It also added, "SEIAA, Odisha will be the nodal agency for coordination and compliance. Based on the observations of the Committee, the concerned statutory authorities may take appropriate action in accordance with law, following due process.

The original petition had claimed that sand mining along Subarnarekha river was in violation of the Environment Protection Act, 1986. Several norms of sand mining were also found to be flouted in the case. The petitioner had demanded early hearing of the case and intervention of NGT. The case was heard by a three-judge bench headed by Justice Adarsh Goel while Justice Sheo Kumar Singh joined the bench as the judicial bench while Dr Nagin Nanda was in the bench as expert member.



The then Dharmasala tehsildar issued a demand notice of ₹58,62,79,633 to the miners asking them to deposit the money in government exchequer towards mineral loot. Directed by the District Collector, the tehsildar in a letter (1878, dated- May 28, 2016) asked leaseholder Sribatsha Jena to deposit

Then Collector Satva Kumar Mallick in a letter (5547, dated-December 3, 2015) also directed the deputy director, mines, Jajpur Road to form a special team comprising revenue and mines officials and make an assessment of the actual revenue loss and other losses to the government.

The team visited the hill site in the second week of January, 2016. The mines department submitted its report to the Collector.

The report said around 73,38,022.50 cubic meter of area on the hill has been excavated for quarrying of black stones. Reports said Jena had from the period starting from November 2002 till 2015. During this period, Jena had deposited only ₹6, 64,89, 908 cr as revenue towards extraction of black stones to the tune of 14,15,996 cubic meter on

He had evaded depositing revenue on the rest of 59,22,0165 cubic meter of area on the hill from which he had extracted black stones. The mines department had estimated that Jena had defrauded the state exchequer of ₹58,62,79,633 cr if ₹99 is the revenue per cubic meter.

The matter is sub-judice. Since then, 17 tehsildars have been appointed in the Dharmasala tehsil but none has cared to recover the revenue from Jena.

Later, then Jajpur Collector and principal secretary, revenue and disaster management department published a notification under Section-15 of the Orissa Civil Services Act directing a probe against 10 revenue inspectors and 10 tehsildars for conniving with the leaseholders in the loot. However, that also failed to make progress.


Covid aid of ₹56L returns to govt

Khandapada, Jan 29: The famous Nilamadhav temple, a very old and famous Vishnu temple situated atop twin hills on the banks of the Mahanadi at Kantilo in Nayagarh district is visited by hundreds of devotees every day. The deity is revered by devotees

who throng it round the year to witness the permanent flow of holy water from the feet of Lord Nilamadhava. Lord Siddheswar present in the shrine is another highlight of the place. The deity occupies a central po-

Modi reshuffles babus

n a major reshuffle, the Centre has transferred and posted 18 secretaries to different ministries and departments while several have been pro-I moted. As is often the case, there is a story behind many of the babus in-

The Department of Personnel & Training (DoPT) has finally got a new secretary in Deepak Khandekar, who was laterally shifted to North Block from Shastri Bhavan where he was Tribal Affairs Secretary. The post had been vacant for four months. Curiously, the government may soon have to find a replacement for Khandekar as well, since he is due to retire in seven months. There is also much whispering about who will replace ABP Pandey, who retires as Finance Secretary in 45 days.

Of the 18 IAS officers involved in the reshuffle, sources say that 13 were appointed as secretaries while five were upgraded to the Special Secretary in the rank of secretary. They include Praveen Garg, SS Sandhu, Anjali Bhawara, JN Swain and Anil Kumar Jha.

A lot of the buzz has centred around two officers who have been given plum assignments despite rumours that they had been sidelined. The first is 1988

batch IAS officer Alok Kumar of the Uttar Pradesh cadre who has been shifted from his cadre state and appointed Union Power Secretary. The other is also a UP cadre officer Alok Tandon who has been named Secretary, Ministry of Mines.



Arvind Kumar Sharma, who recently took VRS to plunge into the UP legislature, has been replaced in the Ministry of Micro, Small and Medium Enterprises by another Gujarat cadre officer BB Swain.

CUTTING IT FINE

The delay in inviting applications for the post of Managing Director of Delhi Metro has led to speculation that incumbent Mangu Singh may get yet another extension on March 31, when his second extension ends.

Sources say that since Delhi Metro Rail Corporation (DMRC) is a joint venture between the Centre and the Delhi government, the delay in starting the procedure could be because the two governments are unable to decide how to proceed in the matter. Normally, the process is initiated and completed by the state government with the concurrence of the Centre. That the two governments rarely see eye-to-eye on various issues, this could another of

Meanwhile, Mangu Singh has enjoyed a rather long inning heading the Delhi Metro. He took over from "Metro Man" E Sreedharan in January 2012. He was given an extension in December 2016 and another extension in December last year until March 31, 2021, to give the government sufficient time to find a suitable successor.

But that clearly isn't happening, say observers. The delay has set off speculation about the government's plans since a clause in the Delhi Metro rules states unequivocally that a suitable person for senior posts must be named before the posts fall vacant. Though there is still some time, by dragging on the process the government is cutting it fine, to say the least.

BABU WHO HAS COME IN FROM THE COLD

Tukaram Mundhe, one 2004-batch IAS officer known for his frequent transfers and who was kept waiting on posting since August last year, has seemingly come in from the cold, for now. He has been appointed as Secretary of the Maharashtra Human Rights Commission.

According to sources, this is the Maharashtra cadre officer's 17th post-

ing in 15 years of his civil service career! Known for his rule-based work ethic, it is not surprising that he came up against vested interests. Apparently, he has faced threats and had no-confidence motions passed against him in several municipalities where he served. In his last posting at Nagpur Municipal Corporation, he was appointed Member Secretary in the Maharashtra Jeevan Pradhikaran in September last year, but the appointment was inexplicably cancelled within days and he was kept waiting for posting. It can be hoped now he will have a more stable stint at his new workplace, but don't count on it!


Zorbing

magine yourself suspended inside a ten-foot clear plastic sphere by nylon ropes, then rolled to the top of a slope and pushed off. No brakes, no steering, just you and gravity. By all accounts, it's like being a strav sock in a spin dryer, and it's obligatory to scream a lot. There are reports that some find hillsides too tame, and have tried rolling off cliffs and waterfalls. The balls bounce OK; so usually do those inside. Some have tried walking on water by taking the spheres on to lakes. This adventure activity was invented by Dwayne van der Sluis and Andrew Akers in New Zealand in 1995 as something exciting for tourists to do once they became jaded with bungee jumping. They created the term Zorb for the ball, presumably a variation on orb, which they trademarked and which they used for the name of their company. Confirming my suspicion that there is no activity so crazy that it will not be taken up by somebody somewhere, Zorbing has large numbers of enthusiastic participants, not only in New Zealand but also in the US. Europe and elsewhere. The term. and zorbing for the activity, began to appear in print in 1996. Since Zorb is a proprietary name in New Zealand and the US, the term sphereing has been used as an alternative, though zorbing is showing some signs of becoming generic. Variations are becoming known, such as hydrozorbing, in which you are drenched in soapy water on the way down (the nearest thing in existence to a human washing machine), and harness zorbing, in which two people are strapped together. On flat land, a number of participants can play bumper-zorbs. A participant is often called a Zorbonaut.

TIME TO AUGMENT RESOURCES

ODISHA AMONG OTHER STATES HAS SEEN A MAJOR REDUCTION IN DEVOLVED **TAX REVENUE** IN THE CURRENT **FISCAL**

disha Finance Minister Niranjan Pujari will likely present his third budget in February at a time when the economy is ravaged by the pandemic-induced recession. Indeed, it is a herculean task to present a please-all budget especially when the share of states from the divisible pool is going to be reduced in the current financial vear and the next financial year for which budget will be presented.

Generating resources for budgetary outlay is a gigantic task especially when rich people are evading taxes. Scarcity of resources always stands as a great impediment to higher allocation for various schemes. Though the Centre had promised cooperative federalism, actually states are experiencing hostile federalism. Normally, the Centre has a lion's share in the use of public funds. But heavy welfare obligations and higher expenditures lie with state governments. The implementation of GST has squeezed the scope for generating resources by state gov-

ernments. A state government generates resources by own taxes, non-taxes, disinvestment, borrowings, recovery of loans, etc. It gets funds from the Centre in the form of the state's share from Central taxes. grants-in-aid through transfers to local bodies, from National Disaster Response Fund, Central sector schemes, and Centrally-sponsored schemes (CSSs). The share of net proceeds from Central taxes recommended to be devolved to states has increased from 29.5 per cent in the 11th finance commission (FC) to 30.5 per cent in 12th FC. It has further increased to 32 per cent in 13th FC and to 42 per cent in 14th FC. The 15th FC has kept devolution to states unchanged in its interim report for 2020-21 even as their cumulative share contracted marginally to 41 per cent after the number of states was reduced to 28 because of the reorganisation of Jammu & Kashmir into two Union Territories. But actually, states are getting much less with each passing year as the Centre's revenue collection from cesses

and surcharges though increasing by leaps and bounds does not constitute a part of the divisible pool. As a result, instead of 42 per cent, states are getting much less. In 2015-16, states were getting 35 per cent from the divisible pool instead of 42 per cent as decided by 14th FC. This further dropped to 32.4 per cent in 2019-20.

Total cesses and surcharges as a percentage of total revenue collected by the Centre have increased from 9.4 per cent in 2013-14 to 15.3 per cent in 2019-20. The Centre has estimated to collect Rs 3,69,111 crore through cesses and surcharges this financial year and it may increase in 2021-22 as new cesses may be imposed to mitigate the coronavirus crisis. So, all states including Odisha are severely affected and this the finance minister must raise in an appropriate platform. What is reprehensible is that between 2014-15 and 2019-20, the Modi government failed to utilise cess amount of Rs 3.59.000 crore.

A disconcerting news is that the percentage share of Odisha from net proceeds of the Central taxes and duties has declined from 5.16 per cent (12th FC) to 4.77 per cent (13th FC) and further to 4.64 per cent in the 14th FC. It is further likely to decline to 4.63 per cent in the 15th FC. The Centre's gross tax revenue

may fall short of nearly Rs 5 lakh crore in the current fiscal affecting the its transfer of funds. Some of the Central schemes already cover the sectors chosen for performance-based grants. The state is expected to lose around Rs 8,000 crore this fiscal. Tax devolution and grant for Odisha till October 2020 is 21 per cent and 15.5 per cent less as compared to the corresponding period in 2019. Odisha, Uttar Pradesh, Maharashtra, Karnataka, Telangana, Kerala, Andhra Pradesh, Rajasthan, Madhya Pradesh, and Bihar have seen a major reduction in devolved tax revenue in the current fiscal. Odisha has received Rs 13,456 crore from the divisible pool between April and October against Rs 17,030 crore during the same period last year.

Similarly, the share of CSSs during the seven months was Rs 14,007 crore as compared to Rs 16,594 crore received during the period in the previous year. After the 14th FC's recommendations, the Centre reduced the number of schemes from 67 to 29 and substantially increased the 'matching contribution' by states to 40 per cent from 25 per cent earlier. The proposal to reduce Central share further will subvert the financial health of states. The

states should demand a higher percentage of contribution from the Centre in CSSs.

However, the Odisha government is doing well in comparison to other states in the pandemic times. As of August, the own tax revenues of state governments were 3 to 38 per cent lower than last year. In Odisha it is 14.8 per cent lower. Only Tripura, Meghalaya, Sikkim, Chhattisgarh are better placed compared to Odisha. In case of own non-tax revenues of state governments, all states have negative growth ranging from - 8 to - 82 per cent. But only two states have positive growth -- Tripura 11 per cent and Odisha 36 per cent.

The state's own tax as per the percentage of GSDP was estimated to be 6.43 per cent in 2020 21. Though this is better compared to many states, it is still behind the target of 6.75 per cent as envisaged by the 13th FC. Similarly, non tax revenue as a percentage of GSDP was estimated at 3 per cent in 2020 21. Hence, the state's own revenue (both tax & non-tax) as a percentage of GSDP was estimated at 9.4 per cent in 2020-21, but it is below the record high of 9.51 per cent achieved in 2015-16. However, it is better than the national average of 8 per cent.

It is high time the Odisha gov ernment explores various avenues to enhance its own revenues, otherwise resources crunch will hamper progress and the state may be dragged into a quagmire of debt trap. A committee should be constituted to explore the possibility of raising resources. The government should collect taxes that are pending and curb tax evasion. The state government may impose some new taxes like pollution tax, may enhance entertainment tax too. It can raise resources by imposing rent by leasing unused land, quarters of closed industries, barren land, and a higher tax rate for those having more than one house or plot in an urban area, or using more than one car/luxury car.

The Arctic on the frontlines

RISING ARCTIC TEMPERATURES THREATEN TO TRIGGER A **DEVASTATING DOMINO EFFECT THAT ENDS** IN GLOBAL **CATASTROPHE**

where else on the planet. But even those of us who follow the Arctic closely were shocked by the changes that occurred in 2020, a year of broken records, retreating glaciers, and shattering ice sheets. The alarm bells are ringing louder than ever: we must urgently and drastically reduce our greenhouse-gas emissions. Last year, temperatures in the

Arctic Circle reached their highestever recorded levels. A heatwave in Arctic Siberia brought temperatures of 38°C (100°F) – 18°C higher than the average maximum daily temperature in past years. Meanwhile, fierce Arctic wildfires released a record-breaking level of carbon dioxide and set a new pollution record for the region.

With the heat turned up, the Arctic landscape has been changing fast. For the first time since records began, sea ice in the Arctic's Eurasian sector had not yet begun freezing in October. The previous month, an ice sheet the size of Paris broke off from Greenland's largest glacier shelf, and in July, Canada's intact ice shelf – 4,000 years old - fragmented. As Arctic ice melts, sea levels rise, threatening countries worldwide.

Over the last year, scientists have

limate scientists have known also spotted worrying signs of futo grow taller, permafrost is thawing faster – a process that releases enormous amounts of carbon dioxide and methane, accelerating the temperature rise. Last year, a 164foot-deep crater or "funnel," one of many reported in recent years, was found in northern Siberia after an underground pocket of methane, formed by melting permafrost, burst through the tundra. The consequences of climate

collapse in the Arctic are wideranging. A fuel tank cracked open in the Russian Arctic after settling into softened permafrost, releasing about 150,000 barrels of diesel into a river. A Human Rights Watch report found that climate-related changes in animal migration patterns are making it harder for indigenous communities in Canada to find food or traverse previously frozen bodies of water. And coastal villages can be devastated when fish species migrate to escape warming waters.

If the events of 2020 have shown us anything, it is that what happens in the Arctic does not stay there. On the contrary, rising Arctic temperatures threaten to trigger a devastating domino effect that ends in global catastrophe.

Scientists believe this change in the jet stream is behind a number of deadly weather events, including wildfires in California and Siberia, extreme winter storms in Eastern United States, and record-high temperatures in Mojave Desert.

The second way Arctic warming affects the rest of the world is by disrupting the polar vortex, a lowpressure weather system that sits above each pole and keeps cold air there. As the Arctic warms, the cold air contained in the polar vortex is thought to be displaced and moved to the south, leading to extreme and unusual cold weather in faraway places. This winter, Italy, Japan, and Spain experienced extreme snowfall.

During the pandemic, "build back better" has become something of a mantra. Measures to preserve the Arctic must be at the centre of this effort. To aid in this process, Arctic Basecamp, which I founded, will be developing an by changes in the Arctic ecosys-

Fortunately, a growing number of decision-makers seem to recognise the Arctic's critical importance. The World Economic Forum's recently released "Global Risks Report 2021" ranked extreme weather, weak climate action, and human-induced environmental damage among the most likely-and highest-impact-risks we face over the next decade. During the WEF's Davos Agenda week, I led a highlevel panel aimed at accelerating progress toward protecting this critical region.

It is comforting to imagine the Arctic as a snowy faraway place. populated by reindeer and polar bears. In fact, it is a cornerstone of the climate system that keeps our weather stable, our communities habitable, and our economies prosperous. And it is under immense pressure. Relieving that pressure - especially by ending all mining for oil and gas - is a prerequisite for a more sustainable and equitable world.

Now, Tejashwi questions Nitish's political ideology

Patna, Jan 29: Rashtriya Janata Dal leader Tejashwi Yadav Friday targeted CM Nitish Kumar saying he doubts whether Kumar is actually a socialist leader.

"Keeping in view the present situation, farmers, teachers and students are angry with the central and state government. Crime against women is on the rise...Instead of addressing their issues, CM Nitish Kumar is putting all effort behind saving his chair. He does not have any political ideology," Tejashwi said in Patna.

The RJD leader chaired a party meeting at the residence of former CM Rabri Devi Friday to discuss the progress of the human chain programme scheduled for January 30 to support the farmers agitation across Bihar.

"We firmly believe that farmers of Bihar have the same ideology as the farmers of Punjab, Haryana and Western Uttar Pradesh. They will also come out in their support," Tejashwi said.

"In absence of Bazaar Samiti and Mandi, the farmers of Bihar are forced to sell their agriculture prod-

Support Price (MSP). They are selling paddy at not more than Rs 700 to 800 per 100 KG while the MSP is Rs 1868. The state government should establish Bazaar Samiti and Mandi in Bihar so that farmers can sell their agriculture products,

Meanwhile, Rajesh Ranjan alias Pappu Yadav, president of the Jan Adhikar Party (JAP) launched an indefinite hunger strike at Gandhi Maidan on Friday morning in solidarity with the farmers.

He said that the Modi government must roll back the three farm laws. "The Centre should stop torturing farmers of our country. Our elders fought with the British and eventually forced them to retreat. The current government at the Centre is more ruthless than the British," alleged Yadav.

"In the agitation, 133 farmers have lost their lives in the last two months. This government had conspired against tractor rallies in a well-planned manner to defame farmers. How did more than 10,000 farmers come to ITO? The Delhi Police fired tear gas shells on farmers. The entire incident should be investigated thoroughly under monitoring by a court," Yadav said.

Bihar to guide 4 states on holding polls amid pandemic

Officials from West Bengal, Tamil Nadu, Kerala, Assam and Puducherry, where elections are lined up this year, are dialling the Bihar Health Department for tips to accomplish the gigantic task without causing a surge in coronavirus cases

Patna, Jan 29: The Bihar government will guide four poll-bound states and a Union territory on conducting elections amid the COVID-19 pandemic, officials said. The state's Health Department had won accolades for conducting the elections to the 243-member assembly amid the coronavirus surge last

Officials from West Bengal, Tamil Nadu, Kerala, Assam and Puducherry, where elections are lined up this year, are dialling the Bihar Health Department for tips to accomplish the gigantic task without causing a surge in coronavirus cases, they said. Accepting the Assam government's request, a Bihar Health Department team will visit the northeastern state soon to give a detailed presentation on how the assembly elections were conducted with adherence to the COVID-19 guidelines, Principal Secretary, Health, Pratyaya Amrit

"Bihar has received similar requests from West Bengal and other states and we will share our experiences with them," the official, credited with leading his team to successfully conduct the Bihar elections in October-November last



year, said. On conducting the polls amid the coronavirus surge, he said, "It was a big challenge before us. We could accomplish the task due to the hard work of all the staffers and support from the Election Commission of India and the state government.'

The Bihar administration had made arrangements for the 7.3 crore voters to exercise their franchise at over 1.06 lakh polling stations. Chief Election Commissioner Sunil Arora had lauded the manner in which the elections were conducted. Around 57.34 per cent (over four crore) of the

chise, which was higher than the previous assembly election's voting percentage of 56.8 per cent. The ECI had procured 18 lakh face shields, 70 lakh masks, 5.4 lakh single-use rubber gloves for polling and security personnel and 7.21 crore one hand single-use polythene gloves for voters to press the EVM button and sign the register at the polling stations. Keeping paucity of time in mind, the orders were placed by the Bihar Medical Services and Infrastructure Corporation Ltd through the

Government e-Marketplace portal. Teams were then sent to the production and supply centres at Agra Aimer, Dehradun and New Delhi to ensure timely delivery of items Over 10 lakh ASHA workers and Jeevika didis (members of SHGs) were mobilised at three nodal centres Patna, Muzaffarpur and Purnia for packaging the procured items into kits, Health Department sources

Buses were arranged for the women to and from the centres, which were sanitised thrice a day they said. The kits were then packed and handed over to district magis trates and superintendents of police for booth-wise distribution. ANMs, paramedics and ASHA workers were trained for thermal scanning at polling stations. Lists of COVID-19 positive electors were provided beforehand to polling officials and special training was imparted to handle them.

The supply of such a large quantity of safety kits also necessitated effective bio-medical waste management. Every polling station had yellow bags and bins for the collection of waste. Trucks were arranged for collecting the waste twice on the day of polling. The waste items were deposited at the nearest assigned healthcare facility and later disposed of as per

Jaipur, Jan 29: Aiming to bring in big investors in the petroleum and value-added petrochemicals space, the Rajasthan government rolled out the red carpet for the global oil and petrochemical majors to set up operations in the upcoming Petroleum, Chemicals and Petrochemicals Investment Region (PCPIR) at

A global virtual meeting was held Wednesday between potential investors from across the world and state government officials to promote investment in the region. The meet was jointly organised by the Rajasthan State Industrial Development and Investment Corporation Limited (RIICO) and the Confederation of Indian Industries (CII).

Delegates from the embassies of the UAE and Brazil along with representatives of nearly 100 companies from India, Saudi Arabia, UAE, Oman, Germany, UK, USA, Switzerland, the Netherlands, France, Japan, Singapore, Taiwan, Brazil, Bahrain, Jordan, South Korea and other countries participated in the global meet.

Representatives of important stakeholder associations like CHEMEXCIL and IFIBCA also participated. According to officials, the first phase of development of the project would see around Rs 15,000 crore from top global players and will generate around 1.5 lakh job opportunities. They confirmed that the Raiasthan government and RIICO will provide industrial land to the global investors at the PCPIR by

Representing the state government, senior ministers and officials assured investors of support and opportunities in the sector. "It is the first global dialogue for investment, however, we wish to hold it as a continuous process for facilitating investments in the region," said Industries Minister Parsadi Lal Meena.

The PCPIR is being developed by RIICO in Barmer district of Rajasthan. 

RAJ ANNOUNCES 2 PC CUT IN VAT ON PETROL, DIESEL

Jaipur, Jan 29: The Rajasthan government has reduced valueadded tax (VAT) rate by two per cent on petrol and diesel, giving people the much needed respite from rising fuel prices.

The state finance department late Thursday issued orders, which came into effect from Thursday midnight.

Chief Minister Ashok Gehlot said that despite the price of crude oil being at the lowest level for a long time at the international market, inflation is rising as prices of petrol and diesel are hovering at all-time high levels and the common man is facing economic difficulties.

The price of branded or premium petrol price had crossed Rs 100-mark in Sriganganagar town of Rajasthan January 27.

Retail fuel prices vary from state to state depending on local sales tax or VAT.

The Chief Minister said in a statement that the government of India is currently charging an ex-

cise duty of Rs 32.98 per litre on petrol and Rs 31.83 per litre on diesel, which is excessive.

Gehlot said that the basic excise duty paid by the government of India is part of the divisible pool paid to the states, which has been reduced continuously from Rs 9.48 to Rs 2.98 on petrol and Rs 11.33 to Rs 4.83 on diesel due to which all the states, including Rajasthan are losing huge revenue.

He said that the Centre has been continuously increasing the additional excise duty from Rs 8 to Rs 18 per litre on petrol and diesel and special excise duty has been increased from Rs 7 to Rs 12 on petrol and from zero to Rs 9 per litre on diesel. Due to this policy of the Centre, the states are not getting their benefits. At the same time, people have to bear the brunt of ex-

pensive petrol and diesel. He said that following the initiative taken by the state government, the central government should also give relief to common man by reducing central taxes on petrol and diesel.

Bihar Grand Alliance to organise human chain against farm laws

Patna, Jan 29: The opposition Grand Alliance in Bihar Friday declared it will organise a human chain across the state Saturday to express solidarity with the farmers agitating against the farm laws.

Flaying the NDA government in Bihar for having scrapped APMCs over a decade ago, former deputy CM Tejashwi Yadav alleged "this had reduced farmers to labourers. The central laws will convert them, like cultivators elsewhere, into beggars". Kumar's government had abolished Agriculture Produce Marketing Committee (APMC) Act in 2006 and also ended the mandi (wholesale markets for agricultural produce) system.

He claimed that while his RJD was in power and the state was ruled, first by his father Lalu Prasad and subsequently mother Rabri

Devi, farmers were better off as they often sold their produce at prices higher than the MSP. Decrying the use of force on many occasions to quell the stir in and around Delhi. the RJD leader said "it is for the first time in the country that the chants of 'Jai Jawan Jai Kisan' have been jettisoned and jawans are being pitted against kisan (farmers).

Yadav, whose promise of "10 lakh government jobs" is widely believed to have boosted prospect of the RJD as well as the five-party opposition coalition in assembly polls, also slammed the state government for setting up committees to assess performance of 50 years plus employees with the supposed aim to retrench those who were not found up to the mark. Representatives from other grand alliance constituents Congress, CPI, CPI(M) and CPI(ML) also spoke on the occasion.





Jawan shoots dead colleague

Raipur: A CRPF jawan was killed and another one got injured after one of their colleagues opened fire at them at a camp of the paramilitary force in Chhattisgarh's Bastar district Friday, police said. The offender, who was undergoing treatment for some mental health issue, later allegedly tried to shoot himself in a bid to commit suicide, they said. "The incident occurred at 8 am in the camp of CRPF's 241st 'Bastariya' battalion in Sedwa village under Kesloor police station area," Inspector General of Police (Bastar range) Sundarraj P said.

Teen raped, poisoned to death

Medininagar (Jharkhand): A para-teacher has been arrested for allegedly raping and poisoning a 13-year-old girl to death in Jharkhand's Palamu district, police said Friday. The girl, with whose accused had a land dispute, was raped inside an empty classroom in a school in Panki police station area Wednesday and was then poisoned, Lesliganj Subdivisional Police Officer Anup Kumar Baraik said. She died while undergoing treatment at a hospital on Thursday, the officer said, adding that the accused has been arrested.

Another TMC MLA quits party

Kolkata: Days after quitting the Mamata Banerjee cabinet, TMC leader Rajib Banerjee Friday resigned as the MLA of the West Bengal Assembly, as speculation that he might join the saffron camp ahead of the state elections picked up steam. The former Forest minister. who represented the Domjur Assembly seat, visited the state assembly in the morning and submitted his resignation to Speaker Biman Banerjee. "I have resigned as MLA of the state Assembly. I have submitted my resignation letter to the speaker," he said.

Migrant labourers found dead

Dhanbad: Two migrant workers from West Bengal working in a brick kiln were found dead in a makeshift hut at a village in Jharkhand's Dhanbad district Friday morning, a police officer said All three were residents of Purulia district in West Bengal and had been working in a brick kiln at Ranglitand village under Tetulmari police station limits. The bodies were spotted by the brick kiln owner when he came to the hut after finding them absent

Single man can't rape a minor without scuffle: Bombay HC

It seems highly impossible for a single man to gag a survivor's mouth, remove her and his clothes, and perform the forcible sexual act without any scuffle: HC

Nagpur, Jan 29: The Nagpur bench of the Bombay high court January 17 acquitted a man of raping a 15-yearold girl, ruling that "it seems highly impossible for a single man to gag a survivor's mouth, remove her and his clothes, and perform the forcible sexual act without any scuffle"

"Had it been a case of forcible intercourse, there would have been a scuffle. Medical evidence also doesn't support the survivor's case as no injuries from a scuffle could be seen," Justice Pushpa Ganediwala

On March 14, 2019, petitioner Suraj Kasarkar (26) was sentenced to 10 years of rigorous imprisonment by a Sessions court after being convicted for rape of the minor. He was also convicted for criminal trespass. He was charged under Sections 376(1) and 451 of the IPC along with Section 4 of the POCSO Act. The complaint against him was lodged by the survivor July 26 2013. Kasarkar challenged the trial court's verdict, contending it wasn't rape but a consensual act and the survivor lodged the complaint after her mother found him fleeing her

He also said the girl was "habit-



public prosecutor MJ Khan argued that the survivor couldn't have given a false deposition. Justice Ganediwala observed that the testimonies of the girl and her mother could not prove that she was below 18 years when the offence was committed. Moreover, in her cross-ex-

amination, she admitted that she declared her age as 15 years in the FIR on her mother's insistence. Even the birth certificate submitted in court isn't in the specified format and couldn't prove the sur-

'The defence of consensual phys-

ical relations does appear probable. The accused could bring on record the probable doubt with regard to consensual relation. The girl admitted that she wouldn't have lodged a complaint if her mother hadn't arrived," the judge said.

Quoting settled law in such cases. Justice Ganediwala added that stricter the sentence, stronger should be the proof. "The sole testimony of the prosecutrix in rape cases is sufficient to fix criminal liability against the accused. However, considering the substandard quality of the girl's testimony, it would be grave injustice to send the petitioner behind bars for 10 years. The prosecution miserably failed to fix criminal liability of rape against him by criminal trespassing in the survivor's house," she said, while quashing the Sessions court order convicting the accused.

Resign or prove majority, AIADMK tells Pondy CM

Puducherry, Jan 29: The Opposition AIADMK here Friday asked Congress senior leader and Chief Minister V Narayanasamy to prove his government's majority on the floor of the Territorial Assembly or quit the post of the Chief Minister.

The AIADMK made this demand as the resignation of the ruling Congress members had weakened the strength of the party in the House. The leader of the legislature wing of the AIADMK A Anbalagan said in a press release that A Namassivayam, who was number-two in the Narayanasamyheaded government, had resigned from the post of the PWD Minister and also the MLA post.

Another Congress legislator E Theeppainthan too quit the MLA post, reducing the strength of the Congress to a minority

Therefore, Anbalagan said, the Chief Minister should come forward and prove his government's majority. He said the Lieutenant Governor Kiran Bedi should direct convening of a special session of the House to ascertain the majority of the government. Anbalagan said the AIADMK

and its alliance partners would submit a memorandum soon to the Lieutenant Governor seeking a directive for the session. The current political developments have weakened the government. Routine administration has also come to a standstill and the Chief Minister has failed to implement the promises made in the Congress election manifesto, Anbalagan said.

Govt 'vigilant', addl forces deployed at LAC, says President

New Delhi, Jan 29: Against the backdrop of the Chinese aggression in eastern Ladakh, President Ram Nath Kovind Friday said the government is "vigilant" and that additional forces have also been deployed at the Line of Actual Control (LAC) to protect the sovereignty of the country.

In an address to a joint sitting of Parliament on the opening day of the Budget session. Kovind, who is also the Supreme Commander of the Armed Forces, said when India was grappling with the COVID-19 crisis attempts were made to challenge its capability at the border.

'Efforts were made to disrupt the peace at LAC in utter disregard of bilateral relations and agreements. However, our security forces not only responded to these machinations with promptitude, force and courage, but also foiled all attempts to change the status quo at the border," he said.

'TANDAV' CONTROVERSY

'Alarming to hold actors accountable for fictional roles'

THE SC'S REFUSAL TO GRANT INTERIM PROTECTION TO TEAM "TANDAV" AND ITS OBSERVATION THAT ACTORS CANNOT PLAY ROLES HURTING THE "RELIGIOUS SENTIMENTS OF OTHERS" HAS LED TO CONSTERNATION IN THE INDUSTRY

Mumbai, Jan 29: The Supreme Court's refusal to grant interim protection to Team "Tandav" and its observation that actors cannot play roles hurting the "religious sentiments of others" has led to consternation in the industry with many insiders worried about the road ahead for India's "soft power".

A day after the apex court ruling on the starry political saga from Amazon Prime Video from which several scenes have already been cut. most Bollywood biggies were silent.

However, there were others, including Hansal Mehta, Pritish Nandy, Konkona Sen Sharma and Gulshan Devajah who spoke of the line between art and the artiste being blurred and the implications

of it. Some asked how actors could be held accountable for who they played on screen. On Wednesday, the Supreme

Court declined to grant interim protection from any coercive action to "Tandav" director Ali Abbas Zafar, actor Mohd Zeeshan Ayyub and others facing multiple FIRs for allegedly hurting religious sentiments. Ayyub's lawyer defended the alleged objectionable part of the Web series, saying that as an actor he has no artistic control over dialogues spoken by him. "You cannot take up role without reading script. You cannot play role hurting religious sentiments of others, the bench remarked.

Viewing the observations with alarm, several said it exposes actors, whose very job is to play varied



Notwithstanding the Ghaziabad administration's ultimatum to the protestors to vacate the UP Gate protest site, more farmers from western Uttar Pradesh districts such as Meerut, Baghpat, Bijnor, Muzaffarnagar, Moradabad and Bulandshahr reached the UP Gate early morning to join the stir following an emotional appeal by BKU leader Rakesh Tikait.

The crowd of protesters that had reduced to 500 Thursday night has now again increased with over 1000 farmers joining the stir.

Flanked by supporters, Tikait remained at the centrestage of the protest site on the Delhi-Meerut Expressway, which has been barricaded from both sides, prohibiting regular traffic movement.

Backing the protesting farmers, Rashtriya Lok Dal (RLD) chief Ajit

Singh announced support to the BKU. The former Union minister spoken to BKU president Naresh Tikait and spokesperson Rakesh Tikait, RLD vice president and his son Jayant Chaudhary said.

"It is a matter of life and death for farmers, but do not worry. All have to stay together, united in this - this is Chaudhary sahab's (Ajit Singh's) message," the RLD vicepresident said in a tweet in Hindi.

The Kejriwal government also extended its support to the farmers with Deputy Chief Minister Manish Sisodia visiting the Ghazipur border protest site to check the arrangements made for them by the city government.

The Ghaziabad administration late Thursday night gave an ultimatum to agitating farmers to vacate the UP Gate protest site but Tikait remained adamant, saving he would commit suicide but won't end the stir.

Customs officials to question Kerala **Assembly Speaker**

Thiruvananthapuram, Jan 29: Customs officials are preparing to question Kerala Assembly Speaker P Sreeramakrishnan by next week in the dollar smuggling case, according to informed sources.

The sources revealed that the Speaker will be questioned unofficially without serving a notice and the Customs Department has received a legal opinion in this regard.

During their appearance before the the Department, the two accused in the gold and dollar smuggling case. Swapna Prabha Suresh and PS Sarith, said that Sreeramakrishnan is also involved.

They have also given written statements before the Department that the smuggled dollars were used to buy stakes in an educational institution in Oman. The Customs officials have also interrogated Naz Abdulla, a close associate of the Speaker based on the information shared by Swapna and Sarith that Sreeramakrishnan was using a SIM card taken in Abdulla's name. Abdulla is also the director the educational institution in Oman where the Speaker has allegedly invested. The informed sources further revealed that the SIM card ceased to function after the smuggling case came to light.

If evidences are found against the peaker after the unofficial ques tioning, the Customs Department will move ahead with further actions, the sources added.

After being served a notice by the Customs Department, K Ayyappan, Assistant Private Secretary of the Speaker, failed to appear before the officers for three times in a row citing various reasons. In response, the Opposition has levelled allegations that the Speaker was protecting Ayyappan to cover up things.

Indian Union Muslim League legislator M Ummer had submitted a notrust motion against the Speaker and there were heated discussions in Assembly on how Sreeramakrishnan had sacrificed the sanctity of the position by indulging in such matters. Chandigarh, Jan 29: Actor-turnedactivist Deep Sidhu, who has been booked in connection with the religious flag incident at Red Fort, has said he needs some time to bring out the truth and will then join the investigation.

The 36-year-old Sidhu is in the eye of a storm for being among the protesters who put up a religious flag atop the Red Fort on Republic Day.

"Arrest warrant has been issued against me and also a look out notice has been issued against me. First I want to give this message that I will join the investigation," Sidhu said in a video uploaded on Facebook.

He said he needed some time to bring out the truth.

'Because whatever has been spread, it is false information and it is misleading the public at large. Therefore, I need a couple of days to bring out the truth and then I will join the investigation," said Sidhu.

"I am requesting the investigation agencies...I have not done anything wrong then why should I run away and why should I be scared. I am not scared. I have done nothing wrong and that will come out,' he said. He told the investigation agencies and the police department

that he will come to them in two days. 'The kind of rumours being spread is not based on facts. I need two days to bring out the truth based on the facts and I will collect all the evidence and proof," he

The Delhi Police had named Sidhu in an FIR lodged in connection with the Red Fort incident. Sidhu was present at the Red Fort when a religious flag and a farmer flag were put at the flagpole at the historic monument, triggering massive outrage. Sidhu had been accused by farm bodies of trying to de-

Washington, Jan 29: Voicing outrage over the acquittal of those involved in the brutal murder of Daniel Pearl in 2002, the White House has asked Pakistan to expeditiously review its legal options, including allowing the US to prosecute al-Qaeda terrorist Ahmed Omar Saeed Sheikh and other suspects to secure justice for the American journalist's family.

Pearl, the 38-year-old South Asia bureau chief for The Wall Street Journal, was visiting Pakistan to report on Islamist militant networks in the country and on the links between the country's powerful spy agency ISI and al-Qaeda following the September 11, 2001 terror strikes. He was kidnapped in Karachi, the capital of Sindh, and beheaded days later.

Pakistan's Supreme Court Thursday dismissed appeals against the acquittal of British-born al-Qaeda terrorist Sheikh in the kidnapping and murder case of Pearl and ordered his release, a judgement denounced by the American journalist's family as "a complete travesty of justice.'

The apex court cleared Sheikh and his three Pakistani accomplices in the case of all the charges, ordering that Sheikh and others be immediately freed from jail.

Hours after the ruling, White House press secretary Jen Psaki underlined the new Biden administration's commitment to secure justice for Pearl's family. Psaki, during her daily news

conference on Thursday, said: "The United States is outraged by the Pakistani Supreme Court's decision to affirm the acquittals of those responsible for Wall Street Journal reporter Daniel Pearl's kidnapping and brutal murder which shocked the world's conscience in 2002".

"This decision to exonerate and release Sheikh and the other suspects is an affront to terrorism victims everywhere, including in

Novavax found effective against UK nCoV variant



London, Jan 29: Novavax, a vaccine undergoing trials for effectiveness against the novel coronavirus, has become the first immune dose to definitively confirm protection against the new variant of the deadly virus which was detected in the UK late last year.

A late-stage clinical trial involving over 15,000 people in the UK found that the vaccine produced by American firm Novavax is 89.3 per cent effective in preventing coronavirus and offered 85.6 per cent protection against the new British strain of COVID-19, which is up to 70 per cent more transmissible. A smaller, separate trial also

showed that it was about 60 per cent effective against the South African variant, despite concerns that this strain may not respond to vaccines.

rational end to this war, and that it's got to be done through a negotiated settlement that includes the Afghan government," he added.

The US and Taliban signed the historic agreement on February 29, 2020, which called for a full withdrawal of the American military forces from the war-torn country by May 2021 if the militant group meets the conditions of the deal. including severing ties with

Last week, US National Security Advisor Jake Sullivan spoke with his Afghan counterpart Hamdullah Mohib during which he made clear Washington's intention to review the agreement, including to assess whether the Taliban was living up to its commitments to cut ties with terrorist groups, to reduce violence in Afghanistan, and to engage in meaningful negotiations with the Kabul government and other stakeholders.

MYANMAR FACES THREAT OF MILITARY

Naypyitaw, Jan 29: Just two months after Aung San Suu Kyis National League for Democracy (NLD) swept the general elections in Myanmar, the largest country in mainland Southeast Asia is facing the threat of a military coup.

The military-backed opposition Union Solidarity and Development Party (USDP) in Myanmar has disputed the results of the general elections held on November 8 last year, in which the NLD secured way above the 322 seats required to form the government. It was the second general polls since 2011, when the military rule ended in the country.

Earlier this week, the army had warned that it will take action if the complaints about "election fraud" were not addressed. It also hinted at the possibility of a coup.

Sources on Friday told IANS that a military coup appeared to be a likely outcome given China's grip over the internal situation in the country.

Myanmar's military junta, which ruled the country through the 90s and 2000s, has had the backing of the Chinese Communist Party (CCP). After a long struggle against the military regime for nearly two decades, Suu Kyi led Myanmar's transition to a partial democracy in the last five years.

Suu Kyi, a former Nobel laureate, however, faced widespread criticism from the West when her government expelled around 700,000 Rohingya Muslims accused of perpetrating Islamist terrorism and propagating separatism.



In a case filed by a group of Islamic countries at the International Court of Justice in The Hague, she has been accused of genocide of Rohingyas. However, her government, whose survival depends on the military, not only stood by the army, but also began engaging

Beijing to secure investments. For China, Myanmar is of strategic importance due to its access to the Indian Ocean, the main route for China's oil imports from the Middle East. Beijing is keen on the development of overland routes for oil and gas pipelines via the

Kyaukphyu special economic zone (SEZ) and deep-sea port, which will allow it to bypass the South China Sea where the US and Japan are challenging its sovereignty.

While New Delhi has been interested in Myanmar's entry into Association of Southeast Asian Nations (ASEAN) grouping against Beijing, China seems to have extended its backing to the military in Myanmar, amid the rapidly evolving situation in the region.

India and China remain locked in a stand-off along the Line of Actual Control (LAC) in Eastern Ladakh since last year, while Washington-Beijing relations also deteriorated over their bilateral trade and later over the coronavirus pandemic, which originated in Wuhan city of Hubei province in China. On Friday,

Australia, the sharpest critic of the Chinese government, along with other democracies including the UK and the US, warned Myanmar's military against staging a coup. A joint statement from the diplomatic missions in Myanmar, said, "We urge the military, and all other parties in the country, to adhere to democratic norms and we oppose any attempt to alter the outcome of the elections or impede Myanmar's democratic transition." United Nations Secretary-General Antonio Guterres has also issued a statement, calling on "all actors to desist from any form of incitement or provocation, demonstrate leadership, and to adhere to democratic norms and respecting the outcome of the November 8 general election.


New Delhi, Jan 29: India requires an active fiscal policy which will ensure accrual of overall benefits from Centre's seminal economic reforms, said Economic Survey 2020-21 Friday. The survey document which was tabled by Finance Minister Nirmala Sitharaman in the Parliament cited fiscal multipliers are disproportionately higher during periods of economic crises than booms.

LIVERPOOL DOWN SPURS 3-1

London, Jan 29: Roberto Firmino ended Liverpool's 483-minute goal drought in the Premier League to set the champions on their way to a 3-1 win over Tottenham and revive their faltering title defense.

Trent Alexander-Arnold and Sadio Mane also netted as Liverpool ended a five-game winless run in a league it dominated so resoundingly last season.

"We were really up for the game, everyone was at it," Alexander-Arnold said. "No one put too much of a foot wrong and it was an unbelievable performance from the lads."

The victory, which lifts Liverpool into fourth place, started with VAR ruling out an opener for Tottenham when Son Heung-min was adjudged to be offside.

Pierre-Emile Hojbjerg reduced the deficit to 1-2 with a powerful strike shortly after Alexander-Arnold scored at the start of the second half, but the Liverpool right back set up Mane for the third that sealed the win.

While Liverpool moved within four points of leader Manchester City, Jose Mourinho's Tottenham are eight points adrift in sixth after their first defeat in 2021, albeit with a game in hand.

And Mourinho faces an anxious wait to discover the extent of Harry Kane's injury after the striker twice went down in the first half clutching his left ankle before being replaced at the interval.

"He is injured in both ankles," Mourinho said. "He said to compete with one pain he probably could, but both—it was very painful and very sore and he couldn't. He just couldn't. He is a guy with a good sacrifice spirit, he can fight against pain, but it was difficult for him."

There are problems at the back too for the north London club, which is in danger of failing to qualify for the Champions League for a second consecutive season after reaching the final in 2019 — losing to Liverpool.

Liverpool was forced to play mid-

fielder Jordan Henderson at center back due to injuries and also lost Joel Matip at halftime with ankle ligament damage. But it was Tottenham's back

three looking more fragile, "We were punished by our individual mistakes," Mourinho said. "It's nothing new for us."

How different, though, this game might have gone had Son not been

marginally offside when he was released by Kane before scoring.

Liverpool was more threatening going forward after that, with Mane testing Hugo Lloris with tame shots before setting up the opener in the fourth minute of stoppage time at the end of the first half.

Firmino tapped in after Mane passed across the face of goal, scoring Liverpool's first league goal since December 27. It was clear from Mourinho's post-match comments that it was a tense atmosphere in the dressing room at halftime.

"It is the mood of a team that is difficult to accept that you are losing," Mourinho said. "It's a mood where people are not happy. But then we have to move on." But Liverpool doubled their lead two minutes into the second half when Lloris spilled Mane's shot into the path of Alexander-Arnold.

Tottenham threatened an immediate comeback when Hojbjerg powered in a shot from outside the area. There was another break for Tottenham when Mohamed Salah's goal was ruled out because Firmino was adjudged to have handled in the buildup despite Eric Dier grappling the Brazilian.

But Liverpool restored their twogoal cushion in the 65th when Alexander-Arnold's long cross came off Joe Rodon and fell for Mane to strike into the roof of the net.

Bowl 'best ball' to Kohli & co as often as possible: Thorpe

Chennai, Jan 29: Such is the quality of the Indian batting line up that England bowlers will need to bowl their best balls repeatedly if they want to put the hosts, led by their peerless skipper Virat Kohli, under any kind of pressure during the upcoming Test series, reckons batting coach Graham Thorpe.

Since his horrendous show in an away series in England in 2014, Kohli has demolished England attack both at home (2016) and away (2018) although the team had contrasting results in both series.

Asked if the bowling unit led by James Anderson has any specific plans for the Indian captain, the former England left-hander said, "We know that he is a fantastic player and he has shown that for many years now. Virat is in one of that batting order which understands home conditions very well."

"The key for our bowling attack will be to bowl our 'best ball' as often as we can. I don't think we can ask for anything more from our spinners and seamers. We need to have runs on the board and then having the Indian batting order under pressure will really be the key for us. To take the game deep will be an important aspect for England," Thorpe said.

The Indian bowling is no longer about spinners weaving magic on rank turners and Thorpe said that they are well aware about how rounded this current home team attack is

"The one thing about the Indian bowling attack is, it's not just about spin. I suppose their seam attack is also strong and so from that point of view it's not to just get side-tracked completely in into the spin side of things as well."

The challenge posed by both Jasprit Bumrah and Ravichandran Ashwin can be a tough one but the batting coach understands that a balance needs to be created.

"Indian bowling has developed into a very good attack and we are very aware of that. When you come to the sub-continent you will have to deal with spin. More so with Indian attack, we are aware. The training time (three days) will be used to strike a fine balance practising both."

Sindhu opened up a 9-5 lead early on before entering the interval with a two-point advantage. Chochuwong managed to turn the tables at 15-14 but a determined Sindhu ensured there was no hiccups as she claimed the opening game.

In the second, Sindhu dished out a dominating game as she



jumped to a 6-0 lead and then kept moving ahead, keeping her rival at bay to seal the contest without much ado.

uch ado. "For any athlete, losing two games is going to be hard to come back stronger to, but I think it's very important from these wins to come back stronger and believe in yourself. I just played my game after yesterday's upset," she said.
"Today is a new day and a fresh

The 34-year-old from Raebareli in Uttar Pradesh joined an elite list of track-and-field Padma winners comprising the likes of Milkha Singh, Anju Bobby George and PT Usha among others. She was nominated for this year's award by the Uttar Pradesh government.

"I was a bit surprised when I got the news that I have been awarded Padma Shri. I deserved to win it but you never know you will get it or not. I am grateful to the UP chief minister for nominating me," Sudha

told this agency in an interview.

"I have won a lot of laurels at the international level since a bronze in 2005. I feel the award is recognition of my hard work and dedication in the last 15 years. Surely, win-

ning the award is one of the biggest moments in my life," she said from Bangalore's Sports Authority of India (SAI) Centre, where she is currently training.

"When I started my athletics career, I never thought I would win Padma Shri one day. It has been an amazing journey."

Sudha has taken part in two Olympics, three Asian Games, two World Championships and four Asian Championships, mostly in 3000m steeplechase, an event she held the national record before it was broken by Lalita Babar.

Her best achievement to date is the gold she won in the 2010 Asian Games. She won a silver in the same event in the 2018 edition of the Games. She also won a gold in the 2017 Asian Championships besides three silver medals (2009, 2011 and 2013).

"After the (team) bronze in Asian
Cross Country Championships in
2005, I got a job in Western Railways
but after some time I got indica-



tions that I will have to keep winning medals if I have to continue the job.

gold in National Games in 2007 and

2008, 2009) before claiming a silver in 2009 Asian Championships. After that there was no fear of losing my job," she said.

Almost all her international achievements have come in 3000m steeplechase but Sudha is aiming

for her third Olympics in marathon, an event in which she has represented the country in the 2015 World Championships.

"I want to qualify for the Tokyo Olympics in marathon, 3000m steeplechase is not my priority now as far as Olympics qualification is concerned. I am going to run in the New Delhi Marathon in March and there I am targeting Olympics qualification.

"Talso want to break the national record, let's see," said Sudha who is going to give Mumbai Marathon February 28 a miss. "I want to start my season a bit late and moreover, it will be warmer in Mumbai by that time as compared to Delhi."

She has a marathon personal best of 2:34.56 sec which she had clocked while finishing 10th in the 2019 Mumbai Marathon. The Tokyo Olympics qualification time is 2:29.30 while the national record stands

at 2:34:43 in the name of OP Jaisha. Shudha has been running—(marathons since 2015.
