### 5 cops killed as Naxals blow up bus in Chh'garh

Raipur, March 23: Five police personnel were killed and 13 others injured as Naxals blew up the bus in which they were traveling in Chhattisgarh's Narayanpur district Tuesday, senior police officials said.

The landmine explosion took place between Kanhargaon and Kadenar villages under Dhaudai police station limits. Personnel of the police's District Reserve Guard (DRG) were returning in the bus to Naryanpur town, 300 km away from capital Raipur, after a counterinsurgency operation, said Inspector General of Police (Bastar



# Vax for all above 45 from April 1

New Delhi, March 23: The government Tuesday announced that from April 1, all people above 45 years of age will be eligible to get COVID-19 vaccines and requested them to get registered for the inoculation.

Union Minster Prakash Javadekar said now even people without comorbidities who are more than 45 years of age can get vaccinated. He requested people entitled to get themselves registered to take the jabs. He said the second dose of the vaccine can be taken between four and eight weeks, on the advice of doctors. It was allowed to be taken between four to six weeks earlier. but scientists have now said that taking the second dose between four and eight weeks gives improved results.

The Union Cabinet discussed about the vaccination drive which has already achieved speedy and good progress, Javadekar said. "Today after discussion and on the advice of the task

"We request that all eligible people should immediately register from April 1 and get vaccinated, as it is the shield against the disease," Javadekar told reporters. He said till this day, 4.85 crore vaccines have been administered for COVID-19 and more than 32 lakh people administered the vaccine in last 24 hours

Another decision taken, on the advice given by scientists and world scientist bodies, was that the second dose of vaccine can be administered between fourth and eighth week, particularly for Covishield, he said. "Our appeal is that all above 45 years should take vaccine as early as possible, that will provide them the shield against coronavirus and they should register for getting vaccinated," the minister said.

Vaccines are available in enough number and there is no scarcity and the supply chains and supply line is intact, he said, adding that "I am sure everyone will welcome this decision and come forward to get vaccinated." The minister said he was confident that vaccination will increase at a fast pace.

#### **CENTRE ISSUES COVID GUIDELINES FOR APRIL**

**NEW DELHI:** Amid a spike in COVID-19 cases in some parts of the country, the Centre Tuesday asked all states and union territories to enhance proportion of RT-PCR tests, strictly enforce testtrack-treat protocol and speed up the pace of vaccination to cover all priority groups. Issuing fresh guidelines for April the Ministry of Home Affairs (MHA) said keeping in view the fresh surge in COVID 19 cases, the new positive cases, detected as a result of intensive testing, need to be isolated or quarantined at the earliest and provided timely treatment. The state governments and UT administrations should strictly enforce the testtrack-treat protocol in all parts of the country, ensure observance of COVID-19-appropriate behaviour by everyone and, scale up the vaccination drive to cover all the target groups, the guidelines said. All contacts have to be traced at the earliest, and similarly isolated and quarantined. The home ministry said based on the positive cases and tracking of their contacts, containment zones shall be carefully demarcated by the district authorities at the micro level taking into consideration the guidelines prescribed by the Union Health Ministry. The states and UTs where the proportion of RT-PCR tests is less should rapidly increase it to reach the prescribed level of 70 per cent or more of total tests. The authorities may impose local restrictions



## 15% quota in state-run

medical, engg colleges

Bhubaneswar, March 23: The State Assembly Tuesday unanimously passed a resolution setting aside 15 per cent of seats in engineering and medical colleges of the state for state-run high school students. Chief Minister Naveen Patnaik moved the resolution that was passed unopposed in the house.

The move was in keeping with the recommendation of a high-powered committee constituted under the chairmanship of retired High Court judge AK Misra. After introduction of the common entrance examinations like NEET and JEE. the number of students from government schools and colleges of Odisha in professional courses is getting considerably reduced, Naveen said, adding, this is not due to lack of merit. Rather the students are un-

able to fare better in these tests due to lack of proper coaching facilities.

The students studying in government schools and colleges lack both physical and economic access to coaching centres which has resulted in inequitable conditions for a majority of students of Odisha, he said. In this backdrop, the Cabinet in December last had resolved to reserve adequate number of seats for the students

The high-powered panel said, about 86 per cent of the students in Odisha are in government schools and they get 23 per cent of seats in state medical colleges and 21 per cent seats in state engineering colleges. However, 12 per cent of the students studying in private schools get almost 60 per cent of seats in both medical and engineering colleges.

## ₹356cr for stadiums

at district or sub-district and city level.

Bhubaneswar, March 23: The State Cabinet Tuesday approved the State Level Sports Infrastructure Development Project worth ₹356.38 crore. The government said investments for the project will be primarily used in two componentsexpansion of Kalinga Stadium Sports Complex and construction of a new international hockey stadium in Rourkela which will be the host venue for the Men's Hockey World Cup-2023.

It has been decided that out of ₹356.38 crore, ₹90 crore will be allocated from the state government's budget from three financial years starting from 2020-21. The remaining funds will be used from Corporate Social Responsibility (CSR), District Mineral Foundation (DMF) from Sundargarh and Odisha Sports Development Funds (OSDF). The government has fixed a 16-month deadline to complete the project.

The cabinet also approved sev-

eral other decisions. In another development, the cabinet allowed settlement of urban slum dwellers living in 30 sq feet or lesser areas in land adjacent to them. For this the government has planned to amend the Odisha Land Rights to Slum Dwellers Act.

The government has also planned to amend the Orissa Minerals (prevention of theft, smuggling & illegal mining and regulation of possession, storage, trading and transportation) Rules, 2007 to enable inclusion of IT-based technologies to monitor illegal mining.

The cabinet also decided to waive interest payments from allotees against delayed payment of premium who received houses constructed by the Odisha State Housing Board and Bhubaneswar Development Authority (BDA) from the land given by the general administration department. The move may help 2803 allotees. Out of these, 1925 were allotees from OSHB and 878 from the BDA in 17 projects.

### 283 companies went bankrupt amid pandemic

New Delhi. March 23: The National Company Law Tribunals (NCLT) across the country admitted a total of 283 companies into insolvency amid the pandemic after the announcement of the nationwide lockdown last year.

The Minister of State for Corporate Affairs, Anurag Thakur, also said that during the period of April 1, 2020 and December 31, 2020, a total of 76 corporate insolvency resolution processes ended in resolution, 128 CIRPs were closed due to withdrawal or appeal or settlement and 189 companies went into liquidation.

Further, the government temporarily suspended the initiation of CIRP under Sections 7,9 and 10 of the code for six months or such further period not exceeding one year from March 25, 2020.

The benefit of the suspension is applicable to all those defaults of the corporate debtor that occur from March 25, 2020 and till the end of period of suspension.

The 283 bankruptcies declared the pandemic pertain to defaults made before March 25, 2020. Thakur told the house that 30 corporate persons were dissolved or sold as a going concern or undergone compromise or arrangement under section 230 of Companies Act, 2013 under liquidation process.

Further, 59 corporate persons were dissolved under voluntary liquidation process. Retailers, airlines, restaurants, oil producers, mall landlords and gyms these are some of the more than 340 companies that declared bankruptcy in the US in 2020 and blamed Covid-19 in part for their demise.

Many were in deep financial trouble even before governors ordered non-essential businesses shut to help contain the spread of the virus. Some, like opioidmaker Mallinckrodt and a number of Catholic dioceses, filed primarily to get relief from huge lawsuit liabilities but also saidthe pandemic contributed to their financial woes.

# Now, Bengal polls in Odisha villages

New Delhi, March 23: In a relief to borrowers, the Supreme Court Tuesday directed that no compound or penal interest be charged during the six-month loan moratorium period announced last year amid the COVID-19 pandemic and the amount already charged shall be refunded, credited or adjusted.

The apex court refused to interfere with the Centre's and the Reserve Bank of India (RBI's) decision to not extend the loan moratorium beyond August 31 last year, saying it is a policy decision. A bench headed by Justice Ashok

Bhushan said the SC cannot do judicial review of the Centre's financial policy decision unless it is malafide and arbitrary. The apex court said it cannot interfere with the government's decision to fix priorities for relief during the pandemic which has hit all across the country and the government has been under severe financial constraints.

The bench said this in its verdict on a batch of pleas filed by various trade associations, including from real estate and power sectors, seeking extension of loan moratorium and other reliefs in view of the pandemic. The RBI had March 27 last year issued the circular which allowed lending institutions to grant a moratorium on payment of instalments of term loans falling due between March 1, 2020 and May 31, 2020, due to the pandemic. Later, the moratorium was extended till August 31 last year.

In its verdict, the top court said that from various steps taken by the government, it cannot be said that the Centre and the RBI have not considered the relief for the borrowers. The bench said it cannot strike down a policy decision merely at the behest of petitioners on grounds that the other view is possible and the other decision could be more beneficial.







Bhubaneswar, March 23: The Assembly Tuesday unanimously passed a resolution to include the word 'Ahimsa' (non-violence) in the Preamble of the Constitution of India.

The resolution was moved by Culture Minister Jyoti Prakash Panigrahi and was unanimously passed in the Assembly commemorating the 100th anniversary of Mahatma Gandhi's first visit to Odisha, March 23, 1921. Mahatma had visited Odisha eight times. The House, from 10:30am to 1pm, discussed various aspects of Gandhiji's visit to Odisha.

Participating in the discussion, Chief Minister Naveen Patnaik said Odisha had a special place in the heart of Mahatma Gandhi, the father of the nation.

"During his visits to Odisha, Gandhi had extensively travelled in different parts of the state and interacted with cross sections of the people. He took many Padayatras through which he became very close to the hearts of people of Odisha. His visits created greater awareness about various social issues apart from energizing the Freedom Movement," Patnaik said.

"Of all the things that this country has given to the world, Gandhi's philosophy and his message stand out as one of its greatest contribu-

He said Gandhi's emphasis on the shunning of individual greed and his exhortation to think of the community is the reminder that the world needs.

The resolution was unanimously passed in the Assembly commemorating the 100th anniversary of Mahatma Gandhi's first visit to Odisha

"There is also an increasing polarisation and divisiveness globally. Gandhi's commitment to pluralism and his message of tolerance and harmony is as relevant now as it was then. Mahatma's non-violent resistance is a spark that ignited peaceful movement around the world," he added.

Quoting Martin Luther King JR, the Chief Minister said, "If Humanity is to progress, Gandhi is inescapable. We may ignore at our own risk". Patnaik said this statement was relevant for today's world

When Mahatma came to Odisha for the first time in 1921, it was not a separate Province. This aspiration of millions of Odia speaking peo-

Narasingha Mishra said that people, who are inspired by the ideology of Gandhi's assassin, are ruling the country. They are also building temple of Gandhi's murderer and shooting at a picture of Gandhiji. "Though Prime Minister had condemned the incident, the person concerned was not removed from party," the Congress leader said. BJP members opposed such statement of Mishra. Stating that people have started forgetting Mahatma Gandhi, he said life and his teachings should be taught in schools

Congress lawmaker Taraprasad Bahinipati demanded total prohibition and ban on illegal trafficking of cattle. Speaker SN Patro, government chief whip Pramila Mallick and many members irrespective of party spoke about Gandhi's ideology and visit to Odisha.

## State has 13,620 child labourers in 16 dists

Bhubaneswar, March 23: As many as 13,620 child labourers have been identified in 16 districts during a survey conducted by National Child Labour Project (NCLP) in 2016, 2017 and 2018, Labour Minister Susanta Singh told the Assembly Tuesday.

In a reply to a query by BJP MLA Nauri Nayak, the minister said that out of the 24 NCLP districts, survey was completed in 16 districts till 2018. The survey report shows that 13,620 child labourers - 7,235 boys and 6,385 girls - are there in 16 districts, he said.

The highest 2,536 child labourers were found in Kalahandi while only 184 such children are there in Bolangir. As many as 1,875 child labourers were identified in Deogarh district, followed by Sundargarh (1,351), Gajapati (999), Cuttack (890), Keonihar (865), Angul (849), Jajpur (816), Ganjam (693), Khurda (671), Dhenkanal (657), Nuapada (379), Sambalpur (351), Nayagarh (268) and Jharsuguda (236).

Singh said 1,365 prosecutions have been pending till February 2021 under the Child and Adolescent Labour (Prohibition and Regulation) Act, 1986. Of them, convictions have been made in 75 cases.

For elimination child labour, the government in coordination with nine other departments has been implementing a State Action Plan since 2015. As per Sustainable Development Goal (SDG), the state government aims to eliminate child labour by 2025, the minister added.

### 1.12 lakh forest fires in 10 years

Bhubaneswar, March 23: Forest and Environment Minister Bikram Keshari Arukha said in a written reply in the Assembly Tuesday that the last decade experienced a total of 1,12,406 incidents of forest fires from across Odisha.

The department gave a detailed account of forest fires in the last 10 years, between 2010 and 2020.

A total of 33,185 incidents were reported from February 1 to March 15, 2021. Out of these, verified fire incidents stood at 23,258.

The total area affected by the incidents stood at 15,992.731 hectares.

The Assembly also approved demand for grants of Rs 1891.60 crore for the department. Out of the total grant, Rs 1389.90 crore is earmarked for programme expenditure while Rs 501.70 crore given for administrative expenditure.

However, the TTPS authorities have claimed that the units were shutdown as the workers did not turn up for their duty. A delegation of plant authorities held discussions with the workers and assured them to run the plant if they joined their

The shutdown of the plant has sparked anger and resentment among various labour outfits and trade unions. A trade union outfit, Shramik Ekta Manch, has rejected the charges. Surprisingly, the administration was found to be in dark about the development.

The manch member alleged that the plant authorities had shut down the plant a week before as there was fear of the plant getting closed after March 31 due to non-compliance of an order of the Central Pollution Control Board (CPCB)

They claimed that the state will face power loss to the tune of 460 megawatt daily if the plant is not made operational soon. Apprehending a law and order sit-

The plant, however, remained operational as the state Pollution Control Board reportedly permitted it to run it till March 31, 2021.

Speculations are rife that the plant will soon be closed down from

The plant authorities had shut down all the units in phases from Monday ahead of the scheduled date of closure. Out of the total six units, the sixth unit of the plant had been shut down earlier.

The first unit was shut at 1.13pm, second unit at 12.39am, third unit at 12.14am, fourth unit at 12.30am and finally the fifth unit was shut at 5.05 am, Tuesday. As a result, no power was generated by the plant

The workers alleged that no coal was transported to the plant by the railways since March 1 as the authorities had planned to shut down the plant from March 31. The plant had even emptied its coal stock in the conveyor belt. The authorities had shut down the plant after fulfilling the power production target for this month.

The trade unions questioned that how the plant could be shut down when there wasn't any problem on coal supply.

When contacted, group general manager DN Tiwari said that the units have been shut down as the workers did not turn up for their duty. As a result, the bunkers remained empty and the units could not be fed with coal, he added.

Talcher sub-collector Rajanikant Swain, however, denied of having any information regarding closure of the plant from the TTPS au-

### TIMES WASTED

ll of us would remember this day one year ago. The nation was pushed into a so called 'Janata Curfew' and Prime Minister Narendra Modi lack asked citizens to bang gongs and ring bells, we were told, to scare away the coronavirus by creating a vibration in the atmosphere. A movie star of great repute told the nation, through a video message, that the timing was appropriate keeping in mind the conjunction of planets and the results would be miraculous. Unfortunately, that very aged actor along with his son and other family members later fell prey to Covid-19 and needed hospitalization. Two days later after the Janata Curfew and ringing of bells, at 8 pm on 24 March 2020, the Prime Minister of India announced a complete lockdown that paralysed normal life across the length and breadth of the country. Come midnight of 24 March 2020, all air and rail services came to a halt. From 25 March last year, even private cars and motorbike riders were stopped by police and the drivers heavily penalized. This kicked off the long march of migrant labourers from one end of the country to another. Children, women and men started out on foot from their places of employment and headed back home. The factories or fields they were working at were suddenly and forcibly shut. Owners refused to take care of their labour force which resulted in one of the greatest humanitarian crisis of modern times. International media termed Modi's lockdown as one of the most inhumane and stringent compared to actions of other governments which too were facing the same predicament.

While all this was being done, a very crucial action was consciously ignored. International flights were not stopped which resulted in infected people from other countries pouring into India. In the usual political style of current times, efforts were made to blame the Tablighi Jamaat, a congregation of international Moslem preachers, for spread of the virus in India. No one bothered to question how the Indian embassies in highly infected countries of that time, such as Malaysia and Indonesia, sanctioned visas to the preachers who sought to visit New Delhi. The idea that coronavirus is a rich man's disease seems applicable to India. Instead of dramatizing and creating a farce, the Central government could have easily cancelled the US President's Namaste Trump trip and stopped Indians stuck abroad from returning back home. Interestingly, Prime Minister Modi not only offered doctors and medical assistance in the early days in late 2019 but also sent Air India aircrafts to Wuhan and brought back Indians living in that city. This morbid joke continued with the Vande Bharat inward flights which ferried stranded Indians

from highly infected countries like Italy, Spain and England. Such poor judgement pushed the country into a stage where everything seemed to collapse inwards. The past saga should have taught us Indians a great

Times gradually changed. The rate of infection seemed to dissipate. Indians took pride in the new knowledge that their country was one of the largest vaccine manufacturers of the world. Companies like



Serum Institute of India suddenly became household names and the Central government did not hesitate to politically cash in on the situation. First, it used the vaccine manufacturing infrastructure to gain international acceptance by sending huge batches of vaccines overseas. That, supposedly, gained credibility for Prime Minister Narendra Modi. On the other hand, domestic vaccination drive has not, even till date, been properly organized and it has resulted in barely 3 per cent of the population getting the jab till now. According to reliable estimates, a complete vaccination of all Indians would take slightly over a decade. Nobody seems to notice this grand failure. On the other hand, extremely valuable time has been wasted by the government by inciting people with crazy new farm laws being enacted and wild efforts of curbing social media by issuing new regulations. These were times which should have been used positively to build awareness and create an atmosphere of cooperation and understanding. Resultantly, the Indian society has not learnt much from the sufferings of 2020. Now we are faced with a second wave leering at our faces. We have people like the Chief Minister of Uttarakhand who claimed that India was enslaved by America for 200 years and while America has failed to control the spread of Covid-19, India has done remarkably well in that field because of Modi's leadership. Unfortunately, the CM himself has been infected by the coronavirus pretty much soon after his utterances. The government of India claims that more than 280 companies went bankrupt in the past year. Reality, however, may be very different. It is not only the sky rocketing fuel prices that have hit the citizens of India but more the overall mismanagement of the entire economy, the results of which will be even more cruel in the months to come.

Today, all of us Indians need to take a step back and re-assess what we learnt from the last year and prepare for a long drawn struggle ahead.

#### Minigarch

minigarch is like an oligarch, only less well-endowed in the back-pocket Adepartment. It's a weird formation, not least because oligarch means a member of a small group that holds power in a state (from Greek oligoi, few, plus arkhein, to rule), and strictly has nothing to do with money. But the term has long been tainted with the implication that oligarchs use their great power to gather riches; in particular it has been used for members of the nomenklatura, former Communist Party appointees, who were most directly involved in gaining wealth in post-communist Russia. The Financial Times wrote in January 2001, "The oligarchs divided up among themselves the most valuable state companies, which Yeltsin privatized under fire-sale conditions." Minigarch appeared in British newspapers in 2006, an early instance in the Independent on 26 May: "Vladimir Gusinsky, 53, used to be one of Russia's most powerful media magnates, but he lost almost everything and is now more minigarch than oligarch." It has never been common, though it turned up several times in 2007, but the global financial turmoil of 2008 hit the Russian super-rich especially hard and the word has had a resurgence. Moscow's exclusive watering holes, such as this expensive fusion restaurant near the Kremlin, are still hosting so-called minigarchs and the merely wealthy further down the scale (NPR Morning Edition, 15 Oct. 2008), A lower oil price may affect the geopolitical ambitions of Russia and its allies. Some oligarchs may become minigarchs. But Russia will not need to beg for cash from the outside world (The Economist, 23 Oct. 2008).

# SACRED COW, POLITICAL COW

THE THEORY OF **CULTURAL ECOLOGY IN ANTHROPOLOGY BRINGS THE RELATIONSHIP BETWEEN POLITICAL CONFLICTS AND RELIGIOUS PRACTICES** 

The recent initiatives of the Rashtriya Kamdhenu of India to disseminate information on economic, scientific. environmental. health, agriculture and spiritual relevance of indigenous cows has brought to the fore three major discourses associated with the 'sacred cow' going on between 'right wing extremism' versus 'liberal' social thinkers. Firstly, should the spiritual transformation of the Indian cow be understood through modern scientific terms? Secondly, should cow worship be a political debate? The theory of cultural ecology in anthropology brings the relationship between political conflicts and religious practices. Finally, should the prohibition of beef consumption be understood as a form of disaster insurance in the Indian society?

The cultural ecology of 'India's sacred cow' needs a restudy - why the Hindus in India would rather starve to death than eat the cow or even deprive it of food. Or for that matter, not eating beef can, in the right context, result in having more food. Firstly, history says that cow worship is a relatively recent development in India: it evolved as the Hindu religion developed and evolved. The earliest Vedas, the Hindu sacred texts from the second millennium BC, do not prohibit cow slaughter. Instead, they ordain its slaughter as a part of sacrificial rites and its consumption at ceremonial feasts presided over by Brahman priests. AN Bose, in Social and Rural Economy of Northern India, 600 BC-200 AD, writes that many of the sacred-cow passages were incorporated into the texts by priests of a later period. By 200 AD, the status of the Indian cattle had undergone a spiritual transformation and by 1000 AD all Hindus were forbidden to eat beef.

Three major justifications can be cited for the sacredness of cow and restrictions for beef eating spiritual, religious and economic. Ahimsa, the Hindu belief in the unity of all life forbids it. Another important event that helped to shape the modern complex was the Islamic invasion. Hindus may have found it politically expedient to set themselves off from the

invaders, who were beef-eaters. Thirdly, Indian peasants who decided to save the cow for procreation to produce oxen were the ones who survived natural disasters. Those who ate beef lost the tools with which to farm. Over a period of centuries, more and more farmers probably avoided beef until an unwritten taboo came into existence. Later on, to remove temptation, the practice was codified by the priesthood, flesh of cattle became taboo and the cow became sacred.

Secondly, cow worship even carries over into politics, keeping aside the significance of its cultural ecology. The issue of cow protection was not a debate during the earlier governments. For instance, once the Ministry of Information maintained that "the large animal population is more a liability than an asset in view of our land resources". Contrary to it, India's neighbouring country Nepal equates cow slaughter as murder. Once, a car driven by an official of a United States agency struck and killed a cow. In order to avoid a situation that would have arisen if the official was arrested for murder, the Nepalese magistrate concluded that the cow had committed suicide. In India, the rise of cow protection committees is a recent development.

In modern India, cow is a symbol of health and abundance. It provides milk, which could be the substitute to mother's breastfeeding. The cow is the factory that produces ox, the mainstay of the Indian agricultural system and also treated as the peasant's tractor. Unlike western countries, the food for cattle costs the human population virtually nothing in India. Indian cattle eat only the inedible remains of subsistence crops - rice straw, rice hulls, the tops of sugarcane, and mustard-oil cake. As American agronomist Odend'hal says, "Basically, the cattle convert items of little direct human value into products of

immediate utility." More than 800 million tonnes of dung is used as cooking fuel and fertilizer. Dried dung burns slowly cleanly, and with low heat - characteristics that satisfy the household needs of Indian women. It is estimated that the dung used for cooking fuel provides the energy equivalent to 43 million tonnes of coal. It would cost India more than two billion dollars extra in foreign exchange to replace the dung with coal. And if the 350 million tonnes of manure that are being used as fertilizer were replaced with commercial fertilizers, the expense would be even greater. Roger Revelle of the University of California has calculated that 89 per cent of the energy used in Indian agriculture (the equivalent of about 140 million tonnes of coal) is provided by local sources.

Thirdly, specialists in food habits argue that India, one of the world's great civilizations, is being stran-

gled by its love for cow. Hinduism is an irrational ideology that compels people to overlook abundant, nutritious food for scarcer, less healthful foods. MN Srinivas, an Indian anthropologist, states: "orthodox Hindu opinion regards killing of cattle with abhorrence, even though the refusal to kill the vast number of useless cattle is detrimental to the nation". The statutes prohibiting cattle slaugh ter are less important than the religious laws. Legally, the ban on cow slaughter is State, not Union law and not all States restrict it. But religious laws see it as consumption of flesh of cows, bulls and oxen. The cow is the most sacred because it can produce the other two. The peasant whose cow dies is not only crying over a spiritual loss but also over the loss of his farm as well. Thus, prohibiting beef consumption is a form of disaster insurance for Indian society. Indian agriculture is full of natural disasters like failure of monsoon and drought. Indian farmers and the cat tle are accustomed to these natu ral disasters. Keeping alive the cows, that can later produce oxen, assures the recovery of the agricultural system from these greatest challenges, which has happened several times in the history of the Ganges valley.

The sacredness of the cow is not just an ignorant belief that stands in the way of progress. Like all concepts of sacred and profane, this one affects the physical world; it defines the relationships that are important for the maintenance of society. The practice arose to prevent the population from consuming the animal on which Indian agriculture depends Practices and beliefs can be rational or irrational, but a society that fails to adapt to its environment is doomed to extinction. Only those societies that draw the necessities of life from their surroundings without destroying those surroundings, inherit the earth. They are not understandable in modern scientific terms.

## Ripped jeans: A battle I've already lost

7irath Singh Rawat, the Chief Minister of Uttarakhand, has drawn a lot of criticism on social media for his recent comments on ripped jeans. While taking a flight, he apparently met a woman traveling with two children and did not appreciate her attire, which included boots, several bracelets, and jeans that were not fully intact.

'You run an NGO, wear jeans ripped at the knees, move about in society, children are with you, what values you will teach?" Rawat said, speaking at a workshop organised by the State Commission

for Protection of Child Rights. An avalanche of criticism followed, seemingly from every Indian woman who has a Twitter account. Just because you wear ripped jeans does not give anyone the right to rip your character, does it? Of course not. And wearing perfect jeans jeans with no holes or blemishes does not mean that your character is perfect, does it? Nope, not at all.

Rawat later apologised for his comment, saying that people are free to wear whatever they want, but continuing to insist that wearing ripped jeans "is not right."



I understand his discomfort. I fought that battle several years ago and I lost. My teenage daughter Divya got her way and wears torn jeans whenever she wants, but thankfully not every day.

Ripped jeans have been around since the 1980s and steadily growing in popularity. They can be quite expensive, which is why Divya did not buy her first pair of torn jeans from a store—she made them. She used a pair of scissors, but it didn't quite look authentic.

To make an authentic pair of ripped jeans yourself, you have to wear the jeans on a motorcycle and get thrown off at high speed. Just try not to get any blood stains on them. That would ruin the look. And another thing: please wear a helmet. There is no point in wearing a pair of stylish jeans while you're lying in the morgue.

I've never bought ripped jeans myself, but I've certainly worn them. Almost every pair of jeans I buy will eventually get torn at the knees. A scrape here and a scrape there, and before you know it, I'm making a fashion statement.

This sums up my relationship with fashion: If I am ever found to be stylish, it is always by accident.

Divya, on the other hand, is quite deliberate in her clothing choices. She won't buy just any pair of ripped jeans she finds in a store. She has to examine the pair carefully, make sure the rips are just right. Quantity matters, but so does quality.

All the rips must be in the front and preferably spaced apart, so they do not join together and cause your jeans to suddenly become shorts. That might cause some discomfort to you, as well as a certain chief minister.

It's also important that the rips do not all look the same. One or two of them can be holes, giving people a view of your legs through your jeans. These holes should not be large enough that you can accidentally put a leg through them, nor should they give easy passage to any rodent looking for temporary shelter.

One or two of the rips can also be shreds—spots where the material has been torn, but where threads remain, permitting no view of the skin. Other blemishes can be scrapes, mere abrasions on the fabric that do not permit any ventilation.

Train judges

Sir, Some high court judges are in the news for their preconceived notions on crimes against women. Indian courts, and their presiding officers, are expected to strike a balance when they conduct trials. Deeply disturbing is the fact that judges, even of higher courts, are displaying an insensitive approach towards women in sexual harassment cases. A judge of the Nagpur bench of the Bombay High Court made headlines a couple of months ago for her unusual, and uncalled for, interpretations on molestation, in two cases, while acquitting the accused. Strange and despicable reasoning by high courts make for a sorry reading. They reflect a chronic lack of application of mind with regard to cases that require high levels of understanding and empathy. Fortunately, the Supreme Court has stepped in to take stock of the situation. While setting aside the Madhya Pradesh High Court order on bail to an accused of sexual misconduct, the top court has rightly rued the acute paucity of gender sensitisation training in judges. How a woman looked and how she behaved are immaterial for a judge to come to a conclusion on a case at hand. Over the years, reports have it that the some men accused of rape had proposed to marry their victims. It would be a travesty of justice if such 'proposals' become a rule and the courts entertain them. The criminal justice system would be reduced to a laughing stock in such a scenario. Therefore, courts and the judges being their torchbearers are expected to adopt an empathetic attitude toward women. Marriage or mediation, as the SC has said, are beyond the courts' jurisdiction. Each case needs an unbiased adjudication without preconceived notions, and strictly on merit



## Alarm in Punjab: 81 per cent of Covid samples have UK variant

Chandigarh, March 23: Eighty one per cent of the 401 samples sent by the government for genome sequencing have tested positive for the UK variant of COVID-19, Punjab Chief Minister Amarinder Singh said Tuesday, asking the Centre to widen the vaccination net to cover those younger than 60.

Expressing concern over the COVID-19 situation, the chief minister also appealed to people to get themselves vaccinated and stressed the need for the Union government to urgently open up vaccination for a larger section of the population.

He urged Prime Minister Narendra Modi to widen the vaccination ambit to cover those younger than 60 as the mutant has been found to be infecting young people more, an official statement quot-

ing him said. "The process needs to be expe dited," he said, pointing to the fact that experts had found the Covishield vaccine to be equally effective against the UK variant--

It is essential to vaccinate more and more people to break the chain of transmission, he said.

Surprisingly, superstar Mithun Chakraborty, who recently joined the saffron camp, did not feature in the list of new candidates, eventually ending all speculation of Bengal's beloved 'Dada' contesting the high-voltage electoral bat-

Chakraborty had joined the BJP's grand rally at Kolkata's Brigade Parade Ground March 7, when he shared the podium with Prime Minister Narendra Modi along with many other senior BJP leaders.



## Money no constraint for Bengal's 'zero asset' candidates

Kolkata, March 23: Meet Manas Sardar, Bahujan Samaj Party (BSP) candidate for Purulia Assembly constituency, who has borrowed Rs 30,000 from his friends to contest the election as he believes his constituency has been neglected for too long and needs an MLA who can deliver.

Sardar's assets according to the affidavit submitted to the Election Commission shows the 30-year-old has an unbelievable 'zero' value in moveable and immovable assets. "I have nothing. I am a devoted party activist and a social worker. My sole aim is to develop our area. I am fighting the election for the first time and for this I have borrowed Rs 30,000 from my friends. I will return the money in instalments," Sardar told PTI when contacted.

Stating that he had to convince seniors in the party to give him a ticket to fight the election in Purulia constituency, Sardar said he was confident of winning despite "feeling the pinch in pocket.

"Purulia has been neglected by all political parties and there has been no development. Drinking water, proper sanitation have long been a problem here. I will work for overall development ... I am getting a good response from the people," he said.

His party colleague Anadi Tudu, who also has reported "zero assets", is contesting the election from Balarampur also in



Purulia district. Talking to PTI from her constituency, the 52-year-old Tudu said "Money cannot stop you from achieving dreams to do good for the people."

"I want to work for my people in

Balarampur. Nobody has done anything for us. I will work with the people to develop the area," she said.

SUCI(C) candidates Dipak Kumar and Bhagirathi Mahato - contesting in Balarampur and Joypur assembly constituencies -- also declared zero assets in their affidavit. Kumar, who fought the 2016 assembly elections but lost, said that the strength of his party has "increased massively" and people are eager to vote the two to power.

"There is no employment. The ruling Trinamool Congress is only talking big. People have understood what they need. There is good response from them." Kumar said. Among candidates with assets worth just Rs 500 are Rajib Mudi and Swapan Kumar Murmu from SUCI(C). They will be fighting for Binpur(ST) in Jhargram district and Manzbazar(ST) assembly seat in Purulia respectively. Another candidate with low asset base is CPI's Saikat Giri. He has declared assets of just Rs 2000 and is contesting the election from Purba Mednipur's Patashpur assembly constituency.

"I can feel the difference because I hardly have money. Both BJP and the TMC are spending huge amounts in this election compared to which we are spending almost nothing. But we have deep rooted connections with common people. They know what is our motto. People in Patashpur are tired of corruption." Giri said.

"I always wanted to do something big in life, but had never dreamt of being a part of such a huge rally which is to be addressed by world's most popular leader Narendra Modi. I wished to work for the poorer sections of our society, and that wish will now be ful filled," he had said at the rally.

Amid huge cheers from supporters, Chakraborty, borrowing a dialogue from one of his films, said, "Ami joldhorao noi, bele borao noi... ami ekta cobra, ek chobol-ei chobi (Don't mistake me for a harmless snake, I am a cobra, can kill people in one bite)," he

had said. Days after joining the BJP, the actor recently enrolled himself as a voter from Kolkata's Kashipur-Belgachia constituency with an address of his cousin's place. Earlier, Chakraborty was a registered

voter in Mumbai. The BJP has pitted retired Lieutenant General Subrata Saha from Kolkata's Rashbihari constituency, while former Chief Economic Advisor Ashok Lahiri has been fielded from South Dinajpur's Balurghat. Earlier, Lahiri was fielded from Alipurduar in North Bengal, but was replaced following agitation by a section of party workers.

Chakraborty, who earlier maintained close ties with TMC supremo and Chief Minister Mamata Banerjee, was nominated to the Rajya Sabha by the TMC

He, however, quit the Upper House seat in 2016 citing health reasons, after his name surfaced in the Saradha ponzi scam.

Elections to the 294 assembly seats will be held in eight phases from March 27 to April 29. Votes will be counted on May 2.

# 14 yrs on, justice eludes Nandigram rape survivors

Residents of the discrete village, where at least 30 women had to endure sexual abuse during the unrest, are sceptical that this could just be another election

Nandigram, March 23: Rukmini Mondal and Sikha (names of both changed), neighbours at a tiny hamlet here, have stopped seeing eye to eye ever since they joined rival political parties.

What had bound the two all these years was the grief that befell on them following the sexual abuse they faced during the anti-land acquisition movement in Nandigram, and the never-ending wait for justice thereafter.

Political colours have changed in this part of Bengal in the past 14 years, but justice continues to elude the women, who are at the crossroads this time, having reposed faith on two opposing camps, with a hope that

their demands would be met. This obscure Nandigram village that had shaken the base of the mighty Left regime and propelled the TMC to power now stands divided between its 'Didi and Dada',



as Chief Minister Mamata Banerjee has locked horns with her protégé-turned-adversary and the face of farmers' protest, Suvendu Adhikari, in the constituency - set

to go to polls April 1. More than 42 people were killed, including 14 who died in the police firing March 14, 2007, and over 40 women raped during the ten-month-long bloody battle

in then-little-known agrarian town. With battle lines having been redrawn in Nandigram, which stands polarised along political and communal lines, the survivors, despite all differences, are keenly waiting for justice to be served.

"Didi has given us everything -- compensation, jobs and other benefits. But we have one regret that we didn't get justice. We want to see perpetrators languishing behind bars," Sikha told PTI.

Standing in front of a large cut-out of Banerjee, 42-year-old Sikha, during a streetcorner meeting in Sonachura market, asked people to vote for the TMC and defeat the BJP and 'Mir Jafar' (traitor) Adhikari.

"Suvendu has not just betrayed the TMC but also the people of Nandigram. Some of the perpetrators of violence, who were then with the CPI(M), have now joined the BJP. But Suvendu has turned a blind eye to this, just for political reasons," she said.

Echoing her demand for justice, Mondal, however. wondered why the TMC, despite being in power for 10 years, could not do anything to ensure that the culprits get punished. "Can jobs, money or doles compensate me for the honour I have lost? I want justice. I want to see them (perpetrators) in iail. I am hoping that if the BJP is voted to

power, there will be fair play," she said. Showering praise on Adhikari, she said that it was the 50-year-old leader who stood by her, and many more like her through thick and thin. The residents of the discrete village, where at least 30 women had to endure sexual abuse during the unrest, are, nonetheless, sceptical that this could just be another election, before which the parties make tall promises only to end up delivering nothing. With the TMC supremo and her former

lieutenant at each other's throats, Nandigram, often referred to as the cradle of change in Bengal, is once again on the edge. Many rape survivors, disenchanted with the TMC, are yearning for yet another change. "People of Nandigram are not very happy with the TMC. They also have grievances against Mamata, as she hardly visited the constituency, which once catapulted her to power. But there is also a section, which has a soft corner for Didi." another survivor Rama Das (name changed) said.





## Vaze 'prime accused' in Hiran case: ATS

Mumbai, March 23: Maharashtra Anti-Terrorism Squad (ATS) on Tuesday said suspended police officer Sachin Vaze was a "prime accused" in the Mansukh Hiran murder case and it will approach the special NIA court here to get his

More arrests were likely in the case, said ATS chief Jaijeet Singh. Vaze, arrested in connection with the recovery of explosives-laden SUV near industrialist Mukesh Ambani's residence in south Mumbai, is currently in the custody of the National Investigation Agency (NIA). The NIA custody will expire March 25.

The ATS had last week arrested suspended policeman Vinayak Shinde and cricket bookie Naresh Gaur in the Hiran murder case. "After the arrest of both these men. ATS found Vaze is a prime accused in the case and played a vital role,' the ATS chief told reporters.

'We need his custody and will approach the court March 25," Singh added. Vaze's statement was recorded in the Hiran case on March 8 when he flatly denied any role in the crime, but probe revealed that he was lying, the ATS chief said. It was Vaze who had contacted Shinde when the latter walked out of jail on parole and took his help, he said.

Gaur procured 14 SIM cards and some of them were activated and used in the crime, the ATS chief said. According to ATS, Shinde contacted Hiran, posing as 'Tawde

saab from Mumbai crime branch on the evening of March 4, the day before Hiran's body was found in a Thane creek.

"Preliminary investigation suggests that Shinde along with others was involved. A Volvo car seized from Daman is suspected to have been used in the crime," the ATS chief said. Forensic Science Laboratory at Kalina in Mumbai examined the car Tuesday, he added.

The ATS has also obtained CCTV footage from various spots even though the accused destroyed some CCTV footage in a bid to destroy evidence of their movement, officials

Shinde, convicted in the Lakhan Bhaiyya fake encounter case, was released on parole last May and since then he was in touch with Vaze and helped him in his "illegal activities", the ATS had said earlier.

"Many more people were involved in the crime," said the ATS chief. On Monday, the ATS seized a Volvo car with Maharashtra registration from the Union Territory of Daman in connection with the case.

The probe agency had also claimed to have detained a person from Ahmedabad who had allegedly provided SIM cards to the accused. The SUV with explosives found near industrialist Mukesh Ambani's house February 25 had been allegedly stolen from Hiran's possession. On March 5, Hiran, who ran auto spare parts business in Thane, was found dead in a creek. Hiran's wife had alleged that Vaze had played a role in his death.

## Turmoil inside Bihar Assembly

Patna, March 23: Virulent opposition to a bill introduced in the Bihar assembly by the Nitish Kumar government, with a view to giving more teeth to the police force, Tuesday led to unprecedented turmoil in the House where police was called in to physically evict legislators who had laid siege to the Speakers chamber.

Members of the opposition Grand Alliance, comprising RJD, Congress and the Left, were agitated over the Bihar Special Armed Police Bill, 2021, and the ruckus created by them caused proceedings of the assembly to be adjourned as many as five times during the day. Leader of the opposition Tejashwi Yadav, who courted arrest while participating in a procession taken out against the "black law", in addition to other issues, gave an inkling of what was in store at an early morning press conference.

After being let off by the police, which had taken Yadav and other RJD leaders to the Kotwali police station for taking out the unauthorised procession and indulging in stone-pelting which led to use of force and water cannons, Yadav was back in the assembly when it reassembled at 3 pm, after having

been adjourned thrice since morning. No sooner than minister Bijendra Yadav presented the bill for debate, opposition members trooped into the well where marshals rushed to prevent the agitated legislators from getting physical with those in the treasury benches. Speaker Vijay Kumar Sinha ad-

iourned the House till 1630 hours but ended up being held hostage inside his chamber as Grand Alliance members surrounded it from all sides and squatted shouting slogans.

Chandrashekhar Singh and Upendra Sharma, District Magistrate and Senior Superintendent of Police respectively, rushed to the Vidhan Sabha premises upon learning that the situation had become too problematic for the marshals to handle. A heavy contingent of police personnel wearing riot gear also reached the premises and they got down to work, physically evicting many an MLA stubbornly refusing to let the Speaker come out. In the meantime, proceedings resumed with senior BJP MLA Prem Kumar in the Chair but the agitation seemed to have rubbed on all members of the legislature.

## Fake Covid certificates starting from ₹1,800

Fake negative Covid-19 test results are on sale from various sellers from just \$25, according to Check Point Research

New Delhi, March 23: Cyber security researchers on Tuesday revealed that forged Covid-19 test results and fake vaccine certificates are being offered on the Dark Web and various hacking forums from as low as \$25 (Rs 1,800) to \$250 (about Rs 18,000), for people seeking to board flights, cross borders, attend events or start new jobs. To access fake 'vaccine passport'

certificates, those interested just need to send their details and the money, and the seller on Dark Web will email back the fake documents for \$250

The researchers found that the dark net advertisements for Covid-19 vaccines have increased by over 300 per cent in the past



three months.

"Multiple vaccine variants are also available for sale: AstraZeneca, Sputnik, SINOPHARM and Johnson & Johnson, with prices ranging between \$500 and \$1000 per dose," the report noted. The Covid vaccine

sellers are majorly based in the US and European countries including Spain, Germany, France and Russia.

The vaccines advertised include Oxford-AstraZeneca (at \$500), Johnson & Johnson (\$600), the Russian Sputnik vaccine (\$600) and the Chinese SINOPHARM vaccine," the researchers informed. Only around 1 per cent of the world's population has received full course of iabs while billions are still waiting for their first dose.

As a mean to prepare society for restarting tourism, flights routine and border crossing, the European Commission has proposed a vaccination certificate to be used as the ultimate 'door opener' across countries and societies.

## 'Constitutional': Centre backs Maratha reservation in SC

New Delhi, March 23: The Centre Tuesday told the Supreme Court that it is of the view that the Maharashtra government can grant reservation to Maratha community in public education and employment.

Solicitor General Tushar Mehta. representing the Centre, told a five-judge Constitution bench headed by Justice Ashok Bhushan that the Maharashtra government's decision is constitutional as the 102nd Amendment of the Constitution does not deprive a state of the power to declare its list of Socially and Educationally Backward Classes (SEBC).

Emphasising that Maharashtra government's granting reservation to Maratha community is constitutional, he said the Centre adopts the submissions of Attorney General KK Venugopal and it should be taken as Centre's view.

Last week, the AG had submitted before the apex court that 102nd Amendment does not take away the power of the state legislatures



to ratify a law to determine the SEBC and then confer benefits on

As the top court asked Mehta why the Centre did not issue any notification of SEBCs under Article 342A so far, he said that the existing SEBC list continues.

At this, the bench queried as to what will be the correct interpretation of Article 342A, and what will be the effect of not having a list? Mehta said that there are petitions challenging the validity of 102nd Constitution Amendment, and once they come up for hearing, then this

query would be probably answered. Senior advocate Manish Singhyi. representing the Rajasthan government, said the determination of SEBC in each state is the sole prerogative of the government concerned and insisted that 1992 Indra Sawhney verdict capping reservation at 50 per cent requires to be examined by a larger bench.

Advocate Manish Singh, representing the Bihar government, cited two separate SEBC lists: for central service, one is prepared by the Centre and the other by state for state services. These lists have been existing since 1993. Singh added that Indra Sawhney judgment needs to be examined by a larger bench against the backdrop of changed social dynamics of the society.

The arguments on the petitions challenging Maratha reservation will continue on Wednesday.

## Karaikal fishermen to boycott Pondicherry polls

## Doc tests covid+ve after completing vax course

Lucknow, March 23: A Lucknow-based doctor has become the first person in Uttar Pradesh to test positive for Covid even after completing the twodose course of the vaccine.

Nitin Mishra, emergency medical officer at the Civil hospital, had been vaccinated with Covaxin February 15 and then March 16. However, he developed a severe cough along with mild fever March 18 and got himself tested March 20.

The report Sunday revealed he was Covid19 positive and has isolated himself at home because he has only mild symptoms and regularly monitors his blood pressure and blood oxygen levels.

Subhash Chandra Sundariyal, director, Civil hospital, said that, We are also in touch with him and in case, symptoms aggravate, he will be hospitalised. The entire hospital has been sanitized and services are continuing as usual.'

Meanwhile, director general

of medical health, D.S. Negi confirmed that Nitin Mishra's case is the first recorded instance where a person has been found to have contracted Covid-19 and turned symptomatic after completion of the two-dose course of Covaxin

Covaxin has been indigenously developed in India by Hyderabadbased Bharat Biotech in collaboration with the Indian Council of Medical Research (ICMR).

Negi said "Data shows that the efficacy of Covaxin is about 80-90 per cent. The vaccine does not act as a shield against infection, but protects a person from falling critically ill, hence people should go for the vaccine, if they are medically eligible, without any hesitation."

Prof Amita Jain, head of the microbiology department in King George's Medical University, said "It takes a few weeks, even after completion of the vaccination course, to build full immunity against the disease. During this period, a person may get infected and develop

The national transporter has instructed zonal railways to initiate intensive awareness drive of seven days to educate all the stakeholders, including railway users and employees, about precautions to be taken against fire incidents.

Carrying inflammable objects in trains is a punishable offence under Section 164 of the Railways Act and the offender may get an imprisonment of up to three years or a fine of ₹1,000 or both, and a fine of ₹500 is applicable under Section 165. In a directive, the Railway Board said these include enforcing the 'no-smoking' rule, preventing carriage of inflammable material through rail, creating awareness through distribution of leaflets, pamphlets, pasting of stickers; conducting street plays, announcement through public address system at stations, and advertisement in print, electronic and social media.

#### Time to frame CAA rules extended by Parl **SOMNATH BHARTI**

New Delhi, March 23: The government has been granted time till April 9 by Lok Sabha and July 9 by Rajya Sabha to frame rules under the citizenship law.

Union Minister of State for Home Nitvanand Rai said in Lok Sabha that the Citizenship (Amendment) Act, 2019 (CAA) was notified December 12, 2019 and came into force from January 10, 2020. The Committees on Subordinate Legislation, Lok Sabha and Rajya Sabha have granted time up to April 9 and July 9 respectively to frame these rules, he said in a written reply.

Rai said the foreigners covered under this CAA may submit applications for grant of Indian citizenship after appropriate rules are notified by the central government.



Rules are mandatory for the implementation of any new or amended law and normally framed within six months of its enactment.

The objective of the CAA is to grant Indian citizenship to persecuted minorities -- Hindu, Sikh, Jain, Buddhist, Parsi and Christian

-- from Pakistan, Bangladesh and Afghanistan. Those from these communities who had come to India till December 31, 2014, facing religious persecution in their respective countries, will not be treated as illegal immigrants but given Indian

#### **CAA** will be implemented 'in time', says Nadda

GUWAHATI: BJP President J P Nadda oTuesday asserted that the Citizenship Amendment Act (CAA) has been passed by the Parliament and will be implemented "in time". Nadda after releasing the party's manifesto for the Assam elections said that the law, (which does not find a mention in the manifesto), is a central legislation and the Congress claim that they will not allow its implemenation in the state, if voted to power, may be either "due to their ignorance or they are trying to fool the people of the state". "I do not want to comment on the Congress thinking but their approach is not only problematic but also dangerous for the state", he said.

## **JAILED FOR 2 YEARS**

New Delhi: A Delhi Court Tuesday upheld the conviction of Aam Aadmi Party (AP) MLA Somnath Bharti relating to the assault of All India Institute of Medical Sciences (AIIMS) security staff in 2016. On January 23, Additional Chief Metropolitan Magistrate Ravindra Kumar Pandey had sentenced Bharti to two years of imprisonment and imposed a fine of ₹1 lakh in the case. Five days later, on the appeal filed by Bharti, Special Judge Vikas Dhull had staved the magistrate court's order. In an order Tuesday, the court upheld the order dated January 23 and sent him to jail for offences such as rioting, unlawful assembly under the Indian Penal Code (IPC) along with mischief causing damage to public property under Prevention of Damage to Public Property (PDPP) Act.

## Fake romance, influencer scams thriving on Instagram

New Delhi, March 23: Facebookowned Instagram has seen a surge in frauds on its platform that were up by 50 per cent since the pandemic began, and scams related to romance, phishing and influencer sponsors top the chart, a new report said Tuesday.

According to Sophos Naked Security, part of the cybersecurity firm Sophos, the scamming on Instagram has worsened over the past year.

"Phishers try to get access to your Instagram account by sending you a suspicious link, either as an Instagram direct message or via email, where you are then tricked into putting in your username and password on a fake login page," the researchers said in a statement.



Once the crooks have your login details, they can access your personal information and even change your password to lock you out of your own account. Scammers are also tak-

ing advantage of the rise in influencers on social media to exploit the influencers themselves

"These scammers pretend to be an established brand and offer influencers an advertising deal. If the influencer is unlucky enough to believe that the deal they are receiving is legitimate, they may hand over their personal banking details

in order to be 'paid' by the brand," the report noted.

Since its launch in 2010, Instagram has seen more than 1 billion accounts opened, and users on the service share close to 100 million pho-

tos every day.

Romance scams are also wit-

nessing a surge on the platform. Here, fraudsters enter into a fake online relationship, often speaking with their targets for weeks, months or even years to earn and then to

abuse their trust. Once the target is ensnared, the scammer starts asking for money for visas, flights, travel expenses and more. But there's always an excuse why the scammer wasn't able

to get the visa, or board the flight, or do whatever they said they would. "Sudden travel restrictions due to Covid-19 regulations have apparently become a popular excuse during the coronavirus pandemic. The scammer will continue asking for money for as long as the person at the other end continues to send it," the researchers noted.

Don't use the same password as vou do on any other sites, they urged. "If you think you may have given away your password on a fake site, change it as soon as you can before the crooks do. Consider using a password manager if you don't have one already," the researchers advised.

"As much as it seems to be common to share a lot of your life on Instagram nowadays, you don't have to give away everything about yourself. Also think about who or what is in the background of your photos before you upload them," they



#### 3 military pilots killed

Moscow: Three members of a Russian warplane crew died Tuesday when their ejection seats accidentally activated during preflight checks, the military said. The Russian Defense Ministry said that the incident happened Tuesday at a military airbase in the Kaluga region, about 145 kilometers southwest of Moscow. It said the crew of a Tu-22M3 long-range bomber was preparing for a training mission when its ejection system malfunctioned and accidentally bailed the crew out.

#### **Road mishap** claims 14

Tehran: A road accident in southeastern Iran Tuesday killed at least 14 people, including eight children, an Iranian semi-official news agency reported. Under the Bangladesh law, the death sentences would require to be endorsed by the High Court following an automatic death reference hearing. The convicts are allowed to file an appeal as well.

For the five convicts who are at large, the judge ordered the verdict to be executed after their arrest or surrender. All the convicts are operatives of

Bangladesh (HuJI-B).

HuJI-B's chief Mufti Abdul Hannan, who was found to be the mastermind of the plot, too was indicted in the case but his name was dropped from the trial as he was executed 2017 in another case involving attempted assassination of the then Bangladeshi-origin British High Commissioner.

The convicts had hatched the plot to kill Hasina by planting a high-powered 76 kilogram bomb near a ground in her constituency in Kotalipara area in southwestern Gopalganj district where she was supposed to address an election rally July 2000.

## Reputation of Astra marred by missteps

London, March 23: AstraZeneca's release Monday of encouraging data about its coronavirus vaccine from its US trial raised hopes that the drug company could bury doubts about the shot and put a troubled rollout behind it.

But hours later, US officials issued an unusual statement expressing concerns the company had included "outdated information" from its study and that it may have provided "an incomplete view of the efficacy data."

A company spokesman said Tuesday it was "looking into it." Even before this latest stumble, AstraZeneca had made missteps



in reporting data and faced a blood clot scare. Health officials worried that those past issues could cause lasting harm to the shot that is key to global efforts to stop the pandemic and undermine vaccine confidence more broadly.

"The way they handled their data early on, AstraZeneca basically shot themselves in the foot,' Julian Tang, a virologist at the University of Leicester, said even before the latest issue arose.

"Even though the new study confirms what we previously thought about the vaccine's efficacy, people may have lingering doubts," he said. "Unfortunately, that might mean more people will die of COVID." Britain was the first to authorize the vaccine in December, based on partial results from the UK, Brazil and South Africa.



Separate official data based on tax records showed an increase of 68,000 in the number of employees on business payrolls in February from January, though the total is 693,000 lower than a year earlier before the start of the pandemic.

## RBI sets up panel for issuing new bank licences

Although the guidelines for on-tap licensing were announced in 2016, the central bank had said that the applications would need to be scrutinised by a standing committee



Mumbai, March 23: The Reserve Bank of India (RBI) has set up a standing external advisory committee (SEAC) headed by former deputy governor Shyamala Gopinath to evaluate on-tap applications for universal and small finance banks.

Although the guidelines for ontap licensing were announced in 2016, the central bank had said that the applications would need to be scrutinised by a standing committee, which has been appointed only now. Changes to the 2016 guidelines were proposed by an internal group that had said that non-banking finance companies (NBFCs) floated by corporates could be given licences. With the SEAC in place, the RBI appears to be sending out a message that it is finally ready to look at new applications.

Besides the chairperson, the other four members are RBI central board director Revathy Iyer, NPCI chairman B Mahapatra, Canara Bank's former chairman TN Manoharan, and SBI's former MD & PFRDA's former chairman Hemant Contractor. While announcing the guide-

lines for 'on-tap licensing of uni-

versal banks' in 2016, the RBI had indicated that applications will be initially screened by the central bank to ensure 'prima facie eligibility of the applicants'. It was also stated that an SEAC will evaluate the applications thereafter and that the constitution of this committee will be announced by the RBI

The constitution of an SEAC was also mentioned in the RBI guidelines for 'on-tap licensing of small finance banks'. There has been fresh debate over the issue of new licences after the RBI's internal work ing group reviewing the corporate structure of private banks said that NBFCs owned by corporates should be allowed to set up banks.

However, former central bankers pointed out that there has been a harmonisation of guidelines for banks and large NBFCs. This meant that large NBFCs are going to be more intensely regulated. Since the on-tap guidelines were announced, only one entity – UAE Exchange - had shown interest in applying for a bank licence.

Since then the group promoted by UAE entrepreneur BR Shetty has fallen in troubled times. Around a decade ago, when the RBI invited applications for bank licences, there were 24 applicants.

New Delhi, March 23: After power, the country's oil sector PSUs would now float an infrastructure investment trust (InvIT) as part of the asset monetisation exercise announced by the government and mobilise resources for fresh capital investment.

As part of the exercise, gas transportation utility Gail India is expected to set up the gust InvIT in the oil sector in the next financial year. The proposed InvIT will house some of the gas pipeline infrastructure created by the company.

Oil ministry officials said that this will help Gail to mobilise over ₹20,000 crore through this route

## CEOs don't expect to see a return to 'normal' until 2022

KPMG CEO Outlook Pulse Survey has brought out key insights into how global CEOs are thinking during the continued run of the pandemic

New Delhi, March 23: The CEOs of the world's most influential companies are planning what the 'new reality' will look like post-pandemic. The 2021 KPMG CEO Outlook Pulse Survey finds that almost half (45 per cent) of global executives do not expect to see a return to a 'normal' course of business until sometime in 2022, as opposed to nearly onethird (31 per cent) who anticipate this will happen later this year.

As the changes prompted by the pandemic have resulted in onequarter (24 per cent) of CEOs saying that their business model has been changed forever by the global pandemic.

The study conducted by KPMG

in February and March of this year asked 500 global CEOs about their response to the pandemic and the outlook over a 3-year horizon. A majority (55 per cent) of CEOs are concerned about employees' access to a COVID-19 vaccine, which is influencing their outlook of when employees will return to the workplace. A significant majority (90 per cent) of CEOs are considering asking employees to report when they have been vaccinated, which may help organisations consider measures to protect their workforce. However, one-third (34 per cent) of global executives are worried about misinformation on COVID-19 vaccine safety and the potential this may have on employees choosing not to have it



administered

Bill Thomas, Global Chairman & CEO, KPMG, said: "Before any major decisions are made, CEOs want to be confident that their workforce is protected against this virus. The COVID-19 vaccine rollout is providing leaders with a dose of optimism as they prepare for a new

reality. CEOs are scenario planning for difference across certain key markets that could impact their operations, supply chains and people, leading to uneven economic recovery. "Our research shows that some executives have taken strong measures during the crisis to transform their operating model and

ways of working, accelerating the rollout of key transformational projects, some by choice, while some out of necessity. The pandemic has also been a catalyst for CEOs to evaluate the role their companies play in society. Many have given voice to issues they may not have previously commented on publicly -from tackling climate change to supporting the diverse communities they operate in - and we need to keep hearing those voices. There is much more to be done.

The survey has brought out key insights into how global CEOs are thinking during the continued run of the pandemic. Nine out of 10 leaders globally (90 per cent) intend to ask their employees to report when they have been vaccinated in order to protect the wider workforce. In India, 94 per cent CEOs intend to do so.

Similarly, majority of CEOs globally will wait for more than 50 per cent of population to be vaccinated before returning to the office. In India, this number stood at 76 per cent. Also, 66 per cent CEOs in India as opposed to 74 per cent CEOs globally felt the pandemic has accelerated the digitisation of operations and creation of next-generation

About three-quarters (76 per cent) of CEOs globally see government encouragement for businesses to return to 'normal' as the prompt for businesses to ask staff to return to the workplace. In India, this number stands at 86 per cent.









# DEBUTANTS' DAY OUT

Krunal, Krishna shine on their debut as India take lead in 3-match ODI series against England winning the first game by 66 runs

Pune, March 23: Krunal Pandya (58 n o, 31b, 7x4, 2x6; 1/59) and Prasidh Krishna (4/54) pulled off sensational performances on their debut which helped India win the first ODI by 66 runs against England here, Tuesday. With this, the hosts are now one-up in the three-match series.

Krunal smashed the fastest fifty by an ODI debutant and broke down remembering his father who died in January this year after suffering a heart attack. The 30-year-old Krunal was handed the India cap by his younger brother and star all-rounder Hardik.

He reached the half century mark in just 26 balls, overtaking John Morris (35 balls) of New Zealand. Krunal broke down while being interviewed by the host broadcaster.

"This one is for my father," was all that Krunal could tell commentator Murali Kartik when asked



about his unbeaten knock before being overwhelmed by emotions. He was enveloped by Hardik in a tight hug soon after.

Krishna, despite being too expensive in his first three overs, came back strongly and finished with 4/54 in a spell where he bagged the crucial scalps of Jason Roy (46, 35b, 7x4, 1x6), Ben Stokes (1), Sam Billings (18) and the final English wicket of Tom Curran (11) to wrap up the match for India.

Chasing a competitive 318, openers Roy and Jonny Bairstow (94, 66b, 6x4, 7x6) gave England a flying start as they added 135 runs before Krishna broke the stand dismissing Roy in the 15th over. In his next over, Krishna got rid of Stokes.

England were reduced to 176/5 in the 25th over after Shardul Thakur (3/37) struck thrice in two overs. The visitors then kept on losing wickets at regular intervals and they were eventually bowled out for 251



in 42.1 overs. Bhuvneshwar Kumar (2/30) was as usual impressive with his economical nine-over spell.

Earlier, Shikhar Dhawan delivered under pressure with a solid 98 (106b, 11x4, 2x6) before half centuries by skipper Virat Kohli (56, 60b, 6x4), KL Rahul (62 n o, 43b, 4x4, 4x6) and Krunal fired India to 317/5.

Dhawan and Kohli shared 105 runs for the second wicket, but it was the 57-ball 112-run unbeaten stand between Rahul and Krunal that

sent England on a leather hunt.
Put into bat here, Rohit Sharma
(28) and Dhawan shared 64 runs
for the opening wicket. India were
placed at 64/0 after 15 overs. However,
Rohit soon perished, after getting

Jos Buttler off Stokes (3/34).
India lost their way in the middle overs before Krunal and Rahul went on the offensive. It was after Dhawan pulled one straight to Eoin Morgan at mid-wicket to miss out on a hundred.

## Ganemat-Angad pair bags gold

New Delhi, March 23: The gold rush continued for Indian shooters at the ISSF World Cup here as Ganemat Sekhon and Angad Vir Singh Bajwa claimed the skeet mixed team top honours on the fifth competition day here, Tuesday.

The 20-year-old Ganemat and 25-year-old Angad, who had topped the qualification with a score of 141, produced another good show to beat the Kazakh pair of Olga Panarina and Alexandr Yechshenko 33-29 in the gold medal showdown. It was the only final lined up for the day.

With this, table-topper India's gold haul at the ongoing event went up to seven. The hosts have also won four silvers and as many bronze medals for a total of 15 medals so far in the tournament.

Another Indian pair of Parinaaz Dhaliwal and Mairaj Ahmad Khan, however, missed the bronze medal by a whisker at the Dr Karni Singh Shooting Range Tuesday. Qatar's Reem A Sharshani and Rashid Hamad claimed the bronze medal with a score of 32 against the Indian team's 31.

The duo had produced a perfect score in the final four shots even as 19-year-old Dhaliwal crumbled under pressure and missed a shot to miss out on a third place finish. In the gold medal match, the 25year-old Angad, World No.62, looked in fine form as he produced a nearperfect show, missing just one out of his 20 shots even as Ganemat ter as th missing It was in the o

It was a nail-biting showdown as India and Kazakhstan were level at 16-16 after the first set of 20 targets. Ganemat got her act together in the second half, producing perfect next four shots and even though Angad missed one, Olga and Alexander both missed two each to give India a 23-20 lead.

In the final four shots, Angad once again produced a confident performance and even though Ganemat missed her last shot, it didn't mat-

ter as the Kazakhs were guilty of missing three.

It was the Ganemat's third medal in the ongoing tournament, having claimed a silver along with Parinaaz Dhaliwal, Karttiki Singh Shaktawat in the women's skeet final on Monday.

The 20-year-old had won the country's first-ever ISSF World Cup medal in the women's skeet event when she bagged a bronze on the third competition day.

For Angad, it was his second gold after having claimed the yellow metal along with Gurjoat Khangura and Mairaj Ahmad Khan in the men's skeet final Monday.

### Para shooter Narwal shatters world record

Al Ain (UAE), March 23: Promising Manish Narwal shattered the world record en route clinching the gold in the P4 mixed 50m pistol SH1 event on the penultimate day of the 2021 Para Shooting World Cup here, Tuesday.

This was India's second gold medal in the event after Singhraj claimed the yellow metal in P1 men's 10m air pistol SH1 event.

Narwal, the 2019 World Championship bronze medallist, overcame a strong field that had Paralympic and world champions, including Iranian Sareh Javanmardi and Ukraine's Oleksii Denusiuk, to finish with 229.1 points, enough to



break the previous world record of Serbia's Rastko Jokic (228.6).

The 19-year-old Narwal shot 5.7 points better than Javanmardi who ended on 223.4 points. The other Indian in the fray, Singhraj, also a Worlds medallist, claimed the bronze with 201.7 points.

In SH1 events, athletes are able

to support their firearm without assistance. "The way Manish performed today was expected from him. I was in fact expecting a better score from him. Today's result will surely boost the entire team's confidence and preparation for the Tokyo Paralympic Games," national chief coach JP Nautival said.

After six days of competition, Ukraine continued to lead the medals tally with four gold, four silver and one bronze, followed by the hosts United Arab Emirates with three gold and a silver and India with two gold, one silver and a bronze medal.

A total of 120 athletes from 24 nations are competing in the event.
