### Petrol, diesel prices cross ₹100/ltr mark

New Delhi, June 12: Sri Ganganagar, a small city in northernmost part of Rajasthan near the India-Pakistan border has become the first city in the country where retail prices of both auto fuels - petrol and diesel - have crossed the century mark.

The city already had the distinction of having the highest pump price of petrol across the country at ₹107.23 a litre. With diesel prices now increasing there by another 25 paisa per litre Saturday it reached ₹100.06 a litre.

However, the record may not be held for long as elsewhere in Rajasthan



# No GST on black fungus drug

### Taxes slashed on several Covid items, no change in GST on vaccine

New Delhi, June 12: The Goods and Services Tax (GST) Council, at its "single-agenda" meeting, Saturday decided to retain the GST on Covid-19 vaccines at 5 per cent. However, it temporarily slashed the tax rates on most supplies and also exempted drugs for treating the black fungus. The Council decisions are in line

with the recommendations made by a Group of Ministers (GoM), which was mandated to examine tax exemption and concessions on various Covid items including vaccines, drugs, and equipment. The GoM which submitted its report early this week recommended keeping rates on Covid vaccines unchanged, owing to the issue of multiple rate structures for procurement.

"When Centre is purchasing and paying GST too on Covid vaccines and they are being given free of cost to the public, the GST rate will make no difference or impact on the people," said Finance Minister Nirmala

Sitharaman after the meeting. She further added: "It was felt that

the GoM's recommendations have brought substantial change. Tax rates on many Covid items have been reduced from 18 per cent to 5 per cent, from 12 per cent to 5 per cent. The GST council largely agreed to go with the recommendations, except for some slight tweaking," she added.

On sharing vaccine revenues with states, the Union minister said that the Centre will buy the 75 per cent vaccine as announced and will pay its GST too. But 70 per cent of income from GST will be shared with states. "Some of the states pitched for

zero tax on Covid relief items which were not taken for consideration,' said Chhattisgarh Finance Minister TS Dec. Some states also raised issues with respect to the compensation period, but Council decided to have a separate meeting on it, Deo added. Sources said that some states pushed to raise states' borrowing ceiling to 5 per cent for the current financial year.

Covid essentials for which tax rates have been reduced include medicines, oxygen, concentrators, related medical devices, testing kits, related machines and other relief items. GoM had suggested temporarily reducing the rate to nil and 5 per cent on a majority of items including imports and domestic supplies of Covid-19 medicines and materials, including medical oxygen, oxygen concentrators, ventilators, pulse oximeters and testing kits and extend the same till August. But the Council decided to extend the move till September 30.

While GST on Tocilizumab and Amphotericin B (a medicine to treat black fungus) were slashed to nil from 5 per cent, the rate on Remdesivir and anticoagulants like Heparin is lowered from 12 per cent to 5 per cent. The Council stated that tax cuts are valid till September 30, and can be extended further upon nearing the deadline. Based on advice and states inputs, whether to extend further will be further considered by the GST Implementation Committee.

### Daily wager beaten to death in City

Bhubaneswar, June 12: In another horrific incident, a daily wager was beaten to death after a heated argument turned violent at Bapuji Nagar under Capital police station here Saturday evening. The accused was identified as Narayan Sahu, a resident of Laxmipur in Koraput.

Sahu has been detained by the  $\ensuremath{\mathsf{cops}}$ at Capital police station for interrogation. The deceased, Trinath, and Sahu worked as labourers and they engaged in an argument over a petty issue related to their work, Saturday evening. During the argument, Trinath allegedly pushed Sahu and he fell on the ground. An enraged Sahu reacted by hitting Trinath on his head with a boulder injuring him severely.

On being informed, police reached the spot and arrested the accused. At the same time, Trinath was rushed to the Capital Hospital where the doctors declared him 'brought dead'. Three gruesome murders in the last ten days in the city have exposed the tall claims by the Commissionerate Police regarding the law order situation here. Miscreants have been active despite heavy deployment of police personnel across the city to enforce the Covid-induced lockdown.

Another daily wager was beaten to death by his friend over past enmity near Master Canteen area under Kharavela Nagar police station here June 5. Two days later a youth was brutally assaulted by miscreants and he succumbed to his injuries at the SCB Medical College.

# SERO SURVEY **PLANNED IN 3** ODISHA DISTS

*This is the first time that children above six* years old would be included in the survey

Bhubaneswar, June 12: The Indian Council of Medical Research (ICMR) will conduct a national serological in 70 districts in the country, including three from Odisha, to ascertain the levels of penetration of

Covid-19 in these areas. The Regional Medical Research Centre (RMRC) in Bhubaneswar will jointly work on the project with the state Health department and the local administrations of the selected districts - Ganjam, Raygada and Koraput.

According to RMRC, preparations for the same have already started in the state. The sero survey is done at intervals to ascertain the levels of coronavirus infections in the community, especially the health workers, frontline workers, common people and others.

"We have already started the preparations and are coordinating with the state government to undertake the sero survey. This is the fourth national sero survey

wherein samples from 10 clusters would be collected from each district,' Sanghamitra Pati, Director, RMRC, told Orissa POST. She further said that dur-

ing the survey the levels of exposure to the virus are tested among high risk communities, local communities and different sets of people. The survey also studies the presence of antibodies to find the exposure levels of people who might have been exposed to the virus in the period between the past two weeks and a month.

In the upcoming serological survey, the ICMR has planned to study the samples from children who are above the age of six years. "This year a peculiar element has been added where we will also be studying children above six years of age in the three districts of Odisha," she said.

During the serological survey the teams collect blood samples of the selected members of different communities randomly to study the presence of antibodies in the subjects.



### Dists with low TPR to unlock soon

Bhubaneswar, June 12: Districts reporting very low test positivity rates (TPR) are likely to go for unlock soon. This was indicated by the Director of Health Services, Bijay Mohapatra here Saturday.

Speaking to the media here, Mohapatra said that all districts in the state have been divided into three zones on the basis of their TPR - red, yellow and green. The lockdown restricts likely to be relaxed in the districts in green zone (TPR below 5 per cent), while the restrictions would continue in districts having 10 per cent or more TPR, the director

said. However, the final decision will be taken by the government, he said. Asked about the increasing num-

ber of Covid fatalities in the state, he said that the number is going up as critically ill elderly patients are still under treatment in various hospitals.

62 per cent ICU and ventilator beds in the state are still occupied by them. Their health status would decide the future fatality graph, he said.

Public health experts suggested that government relax the curbs in a phased manner: "Shopping malls, cinema halls, parks, gyms, religious places, educational institutions etc should remain closed for some more

days. These places can be reopened gradually assessing the Covid-19 situation," said former AIIMS director, Ashok Mohapatra.

Senior doctor Niroj Mishra said the restrictions like weekend shutdowns and night curfew should be continued for some more weeks. Besides, the government should issue SOPs for opening of shops and commercial establishments, he opinioned.

As per data shared by the Ministry of Health and Family Welfare, nine districts - Ganjam, Sonepur, Kandhamal, Deogarh, Bargarh, Gajapati, Sambalpur and Balangir, reported TPR of less than five per cent during

past one week (June 5 to June 11).

# Indian-origin journalist wins Pulitzer Prize

### **MEGHA RAJAGOPALAN'S XINJIANG SERIES ON DETENTION CAMPS FOR MUSLIMS IN CHINA WON HER THE PRIZE**

New York, June 12: Megha Rajagopalan, an Indian-origin journalist, along with two contributors has won the Pulitzer Prize for innovative investigative reports that exposed a vast infrastructure of prisons and mass internment camps secretly built by China for detaining hundreds of thousands of Muslims in its restive Xinjiang region.

Rajagopalan from BuzzFeed News is among two Indian-origin journalists who won the US' top journalism award Friday.

Tampa Bay Times' Neil Bedi won for local reporting. Neil Bedi along with Kathleen McGrory has been awarded the



Office initiative that used computer modelling to identify people believed to be future crime suspects. About 1,000

people were monitored under the programme, including children.

What Kathleen and Neil unearthed in Pasco County has had a profound impact on the community," said Mark Katches, Times executive editor: "This is what the best investigative journalism can do and why it is so essential." Rajagopalan's Xinjiang series won the Pulitzer Prize in the International Reporting category.

In 2017, not long after China began to detain thousands of Muslims in Xinjiang, Rajagopalan was the first to visit an internment camp - at a time when China denied that such places existed, BuzzFeed News said.

"In response, the government tried to silence her, revoking her visa and

ejecting her from the country," BuzzFeed News wrote in its entry for the prize."It would go on to cut off access to the entire region for most Westerners and stymie journalists. The release of basic facts about detainees slowed to a trickle.

Working from London, and refusing to be silenced, Rajagopalan partnered with two contributors, Alison Killing, a licensed architect who specialises in forensic analysis of architecture and satellite images of buildings, and Christo Buschek, a programmer who builds tools tailored for data journalists.

The three of them set out to analyse thousands of satellite images of the Xinjiang region to bring out the series.



### 4 yrs on, Smart Janpath still a pipe dream In a first, Odisha Police opens door to 3rd gender Bhubaneswar, June 12: The pro-

posed Smart Janpath project in the Capital city has missed several deadlines since its inception in 2017, causing much inconvenience to the denizens

Initiated as one of the projects under Bhubaneswar Smart City Limited (BSCL), the idea was to give a grandiose makeover to the 5.8-km stretch between Sishu Bhawan Square and Raj Mahal Square- also known as Janpath here.

The ambitious project envisages construction of public plazas (hangout zones), an 11-km long footpath and cycle track, smart vending zones, sensor-based onstreet parking facility, underground cabling and active surveillance

However, four years down the lane the project has been hanging fire even though construction activities continue every day. Moreover, the delay has caused cost overrun. Sources said that the BSCL has already spent ₹80.67 crore, which is more than the es-

timated cost of ₹79.56 crore. 'This is the consequence of poor planning and coordination among the departments. While the plan was initiated with much zest much thought hasn't gone into manage ment of traffic, congestions and other issues. Also, official rigmarole and slow inter-department communication has delayed the implementation of the project," said Saroi Chandra Panigrahi, a city-based urban planner.

Speaking to **Orissa POST**, contractors and agencies involved in the construction activities blamed unexpected events for the delays. "We have to suspend work many times either due to cyclones, rains or official events. Most of the raw

bling and sometimes some other work. How long are we supposed to bear the losses? While lockdowns have already impacted our businesses and livelihood, customers are now turning away from our shops when they fail to find a parking

lot nearby owing to the construc-

tion activities," rued Sarbajit

Chaddha, a store owner at Janpath. As per a survey conducted by German Corporation for International Cooperation (GIZ), Rajmahal and Master Canteen on Janpath are the two busiest stretches of the Capital city next

to Kalpana Square. About 5,970 vehicles cross Master Canteen Square and 10,525 vehicles cross Rajmahal Square every hour during peak hours. Besides, vehicular movement on this stretch is estimated to grow at an annual rate of 5 to 7 per cent.

Reacting to the issue, BSCL general manager (Engineering), Saroj

Ranjan Dash, said, "Much of the delay had been due to Covid-19, Cyclone Fani and Hockey World Cup in 2018. However, we are very much into the completion of the project and the project will be completed very soon.

Notably, the original deadline for the project was by end of 2019. However, as the Capital city hosted Hockey World Cup in 2018 and was hit by Cyclone Fani in 2019, the deadline was extended.

In its 14th annual meeting of the Board of Directors of the BSCL in November 2019 it was decided that the project will be completed within a year.

The works were again halted due to lockdowns and shutdowns. The then CEO of BSCL, Prem Chandra Chaudhary, had said, "The deadline has been extended to six more months. We are looking to finish the project between

Bhubaneswar, June 12: In a landmark decision, the Odisha Police Saturday opened its door to people from the transgender community, seeking their applications for the posts of constables and sub-

The Odisha Police Recruitment Board sought online applications from men, women and transgender people for the appointment of 477 sub-inspectors and 244 constables (communication). The application portal will remain open from June 22 to July 15.

"I invite qualified women and men to join the Odisha Police as constables (communication) and SIs to serve the people of the state. Also, for the first time, people belonging to the transgender category can apply for both the posts, Director General of Police (DGP)

Abhay told reporters in Cuttack. However, differently-abled people will not be eligible to apply Transgender candidates are eligible to apply, PWDs (Persons with Disabilities) are not eligible to apply," the notification seeking the applications stated.

# **Most Covid patients in Cuttack youngsters: CMC**



# Heavy rain to continue for another two days

### Man dies shortly after taking first dose of Covid vaccine

Chhendipada, June 12: A man from Khamar village under Chhendipada police limits in Angul district Friday died shortly after taking his first Covid vaccine shot, his family alleged.

According to the family members of the deceased, Sarat Chandra Senapati (58) and his wife received their first vaccine doses at Barasahi panchayat at 10:00 am Friday. After spending 30 minutes under observation at the vaccination centre, Sarat returned home on his bicycle.

About 15 minutes later, he complained of uneasiness and his body started to tremble. Subsequently, he succumbed. The family members immediately informed Dr Rajalaxmi Sahu and ANM Geli Pradhan of Bagadia Primary Health Centre (PHC) about the incident. A team from Bagadia PHC immediately reached the spot and

declared Sarat dead Chhendipada CHC's medical officer Dr Ashis Pani, block project manager Sanjay Behera, magistrate Prakash Chandra Nayak and Chhendipada IIC Sushant Singh

reached the spot. Later the body was shifted to the CHC for postmortem.

"Though initially the body was sent to the CHC for postmortem, it was later taken to SCB Medical College and Hospital (SCBMCH) for the same due to the complexities involved," Bagadia police outpost officer Ashis Dash informed.

CHC medical officer Pani said the deceased's family alleged that he died after receiving a vaccine dose. As per the government rule, in such a case the postmortem must be performed at a nearby medical college. So the body has been sent to SCBMCH. The report will reveal the cause of death.

### **Civil Society Action**

e have entered the third year of this government and in the months to come the discussion will turn to the election of 2024. Some of the recent political activity around Uttar Pradesh is being seen in this light. In India what the government does is left generally to the political parties, especially by the middle class which, once it has voted, does not engage with the state. But there is a part of our country which does engage and does not remain aloof.

The term civil society refers, according to the World Health Organisation, to a wide array of organisations: community groups, non-governmental organisations (NGOs), labour unions, indigenous groups, charitable organisations, faith-based organisations, professional associations, and foundations.'

In India we usually use the term civil society almost exclusively for NGOs and activists, because professional associations are quite afraid of confronting the government. There are exceptions but these are few. It is the NGOs, activists and indigenous groups who represent the people and their interests outside the framework of politics. In India

when we say indigenous groups we mean Adivasis. The model of development India has adopted is to extract from Adivasi lands the resources that are used for the rest of the country. You and I do not get displaced by the government from our homes. It is the Adivasi who must leave her place her ancestors have lived on for thousands of years because we need to build a dam or because we have found coal un-

Adivasis have protested against India's government for over a century. The rebellion of Birsa Munda, the man whose statue Amit Shah once wanted to garland (but he wrongly garlanded someone else's) forced the British to introduce the Chotanagpur Tenancy Act, which banned the transfer of Adivasi land to non-Adivasis. The BJP wanted to garland Munda but it also passed a law to undo the Chotanagpur Tenancy Act in 2016. This produced such a backlash from the Adivasis that the BJP retreated from the law and was defeated in the next state election. This is why Shah was garlanding what he thought was Munda's statue in 2020.

Adivasi resistance to the Indian state is not understood and it is not widely covered in the

media. This month has seen at least two places where Adivasis have been on protest. In Gujarat 11 Adivasis were arrested for protesting against a proposed parking lot near the Statue of Unity. They said the land acquired by the Sardar Sarovar Narmada Nigam for the development project belonged to them and had been taken illegally. The strength of the emotion can be understood by knowing that the women among them removed their clothes in public. An FIR was filed against 20 of them under sections including 143 (unlawful assembly) and 294 (singing obscene song, ballad or words near a public place). In Chhattisgarh, which has a Congress government, thousands of Adivasis have been on protest against a Central Reserve Police Force camp erected on their lands without their permission. The government opened fire on them, killing three, but the Adiyasis are still there in the open in Bastar. demanding their rights and insisting that the camp be removed.

On the outskirts of Delhi, tens of thousands of farmers remain on protest, having gathered in November and spent the entire winter and now the summer in the open along the highway. The laws that they are protesting against were passed without a division vote in the Rajya Sabha. The laws have been suspended indefinitely by the Supreme Court and the Modi government itself has offered to suspend them for 18 months. There is extreme disaffection against the laws including by groups supporting the BJP in Uttar Pradesh and it is unlikely that the laws will ever be implemented. The Modi government itself has lost interest in them and does not speak about their implementation. But it has allowed the protests to continue because it does not want to be seen as retreating, though it appears to have already retreated. Similarly, though the CAA law was passed by the Parliament more than a year and a half ago, it has not been implemented. One reason is the protests against it in India, the other is the widespread condemnation against it globally including in the European Parliament.

Civil society action in Gujarat has resulted in the setting up of fast track courts to hear atrocities against Dalits and Adivasis. This came after the protest against the assault on Dalits in Una over a cow's carcass. The civil society action was led by a former journalist, Jignesh Mewani, who was then elected into the Gujarat Assembly.

A lot of action has taken place in civil society since 2014. A weakening of the government, meaning a Centre with no party in a single majority, or a change in government will give civil society additional leverage. Laws that are unacceptable to civil society groups will not be easy to pass and implement. And laws that are in outright violation of international human rights standards will come under pressure to be repealed. It is a most interesting time leading up to 2024.


### ■ Nincompoop

t's a silly-sounding word for a foolish or stupid person. Many writers have tried hard to find an origin for it, though most dictionaries play safe and list it as "origin unknown". The good Dr Johnson, in his famous Dictionary of 1755, said it was from Latin non compos, as in the medical and legal phrase non compos mentis, not mentally competent. But as the Oxford English Dictionary commented 150 years later, this supposed origin doesn't explain versions of the word that were around in the seventeenth and early eighteenth centuries, such as nicompoop and nickumpoop. The first edition of the OED concluded that the word was simply a fanciful formation. The late John Ciardi, in A Browser's Dictionary, dismissively calls the OED's idea "a clerk's guess" and asserts that it comes instead from the Dutch phrase nicht om poep, meaning "the female relative of a fool". He added, "And if that does not work out ... I will be a monkey's uncle". Such a stretched derivation from a foreign language is typical of a type of folk etymology that turns up a lot. Though there was once an English verb poop, to fool or cheat, and it did come from Dutch poep, the original Dutch word meant a shit or a fart — the English slang poop for faeces comes from this. The association with a fool came through a slang use of the word by the Dutch in the seventeenth century for a migrant worker from northern Germany. Modern Dutch speakers use nicht specifically for a niece, not just any female relative, but it is also slang for an effeminate homosexual. So nicht om poep might be construed with quite a different meaning. A more intriguing idea, one with a fair level of acceptance that is given with some caution in the current revision of the OED, links it with the given name Nicodemus, especially the Pharisee of that name who questioned Christ so naively in the

Gospel of St John. This word still exists in French as nicodème, a simpleton.

ments is a dramatic improvement in its citizens' average standard of living. According to the most recent data from the International Monetary Fund, Bangladesh's per capita GDP (measured in purchasing-power-parity terms) was about half of Pakistan's in 1987 and two-thirds of India's as recently as 2007. But in 2020, Bangladesh has surpassed the former and is catching up with the latter, owing partly to its success in becoming a leading textiles and clothing exporter, trailing just behind China and Vietnam.

Even more noteworthy are the improvements in social indicators such as life expectancy, infant and maternal mortality, fertility, and female labour-force participation. And, equally important, Bangladesh has managed to sustain a modicum of democratic stability - keeping the army in the barracks.

But beyond such metrics, Bangladesh's experience is distinctive in two ways that have yet to be fully appreciated from a broader development perspective. The first relates to state formation and capacity. The defining characteristic of the modern state is that it holds a monopoly on legitimate violence, legitimate extortion (namely, taxation), and the provision of essential services. The second monopoly serves the objective of the third, and even when the state does not provide services directly, it dictates

state has voluntarily ceded the service-provision monopoly to the nongovernmental sector. BRAC and a number of other now-famous NGOs have played a major role in providing health care, schools, and financial services, and in leading public-health campaigns to deliver oral rehydration therapy and immunisation. Despite the NGO sector's outsize presence, Bangladeshi leaders have not perceived its activities as a usurpation of the state's authority.

As such, Bangladesh offers a fascinating study in political economy. Normally, democratic states aim to ensure popular support by providing the services that citizens need. Most are loath to cede that function lest they lose power and legitimacy (not to mention opportunities for rentseeking and corruption). The more effective that non-state actors become in delivering services, the more threatened most states feel. But Bangladesh has escaped this dynamic.

A partial explanation is that Bangladesh was so poor and lacking in state capacity in its early years that public service delivery suffered, creating a vacuum for other actors to fill. Those who seized the opportunity then enjoyed access to vast inflows of foreign aid, which averaged (in net terms) 5 per cent of GDP for 25 years until the turn of the century.

But deeper factors could also be at play. Given that Bangladesh has a relatively low tax-to-GDP ratio of less than 10 per cent, one can infer that the state implicitly chose to cede its monopoly on service provision to avoid exercising the politically costlier monopoly of taxation. So, while Pakistan is seen as a failing state, and India as a "flailing state,' Bangladesh is a fledgling state, though more effective than its South Asian neighbours.

The other distinctive feature in Bangladesh's development is its export performance. The fact that its success in manufacturing contributed in turn to greater education and agency for Bangladeshi women has been well documented by the economists Rachel Heath and A. Mushfiq Mobarak. Less appreciated is the paradox that lies at the heart of this export

As my research with Raghuram G. Rajan of the University of Chicago has shown, export sectors historically have fared relatively poorly in developing countries that received a lot of aid, suggesting the work of an 'aid curse' - a variant of the natural-resource curse. Foreign aid, no less

than an abundance of oil and gas, tends to make the real exchange rate too strong, rendering export sectors uncompetitive. But Bangladesh has bucked the trend again.

Beyond luck and chance, additional factors that may have contributed to Bangladesh's export success include plentiful labour, which kept dollar wages low enough to offset an exchange rate kept too strong by foreign aid and remittances; and preferential trade access to foreign markets, first under the Multi-Fiber Agreement (until it was abolished), and then under programmes established by the United States and the European Union.

Looking ahead, low-lying Bangladesh, of course, faces a serious climate change challenge. but its ability to sustain its economic transformation will depend on how these two distinctive features evolve. If non-state actors enter politics, they could upset the current equilibrium, prompting the state to reappropriate its monopoly on service provision. Were that to happen, the state would almost certainly have to increase taxes to show that it can be as effective as the NGOs

Similarly, Bangladesh's export competitiveness could be undermined by rising wages, the enforcement of cost-increasing labour standards and regulations, and the loss of preferential export ac cess in rich markets.

Bangladesh was carved out of India in 1947 on religious grounds and then broke away from Pakistan in 1971 on linguistic and cultural grounds. For decades, it was an object of condescension for India and Pakistan alike. Not anymore. Now a shining model of development, this twice-dismembered country offers lessons for the struggling countries from which it was born.

# What is the point of the Olympics?

aori Yamaguchi, an Olympic are for Japanese politicians who medalist in judo and an exmade an astonishing statement – astonishing, that is, for an Olympic official. She said that Japan had been 'cornered' into holding this year's Games during a pandemic: "What will these Olympics be for, and for whom? The Games have already lost meaning and are being held just for the sake of them. I believe we have already missed the opportunity to cancel. She is not alone. A top Japanese

medical expert warned that the Games could trigger fresh COVID-19 outbreaks, and that going ahead under present conditions would 'not be normal.' Over 80 per cent of the Japanese population wants the Games to be either postponed or cancelled. The Asahi Shimbun newspaper, an official sponsor of the Games, has urged the government to abandon the enterprise. If the Games do go ahead, which seems most likely, the events will take place in mostly empty stadiums built at huge expense.

Yamaguchi's question is a valid one. For whom are the Olympics? The athletes already have ample opportunity to compete in all kinds of international championships. And the Japanese should not pay the price for entertaining television viewers. Perhaps the Games

hoped the spectacle would burnish Lecutive member of the their prestige, or for the fat cats of Japanese Olympic Committee, the International Olympic Committee (IOC), those blazered worthies who believe their juggernaut's interests should trump those of everyone else?

> The question of what the Olympics are really for has haunted the Games ever since Baron Pierre de Coubertin 'revived' them in Athens in 1896. The Baron, like other French conservatives at the time, was worried about national virility, especially after losing the war against Prussia in 1871. He thought competitive sports would he the answer to the shortcomings of French manhood.

Apart from restoring French masculinity, Coubertin also hoped that an international sporting event would promote peace by bringing the world's peoples together. Like World Fairs and Boy Scout Jamborees, the Games would encourage international friendship as well as patriotism. After clean and fair competition, the healthiest specimens from many nations would march together to a better future.

Charles Maurras, the far-right ideologue who joined the ultra-nationalist Action française, ridiculed Coubertin's idealism at first. He despised the idea of international friendship. But then he changed his mind. Competing on track and field would make people from different nations hate one another even more. And that, in his view, would be a very good thing.

In the end, neither Coubertin idealism nor Maurras' cynicism prevailed. World peace did not come about, but wars were hardly the result of national partisanship in sports stadiums.

One cannot deny that the Games have had some positive purposes since the end of World War II. The Tokyo Olympics in 1964 were immensely important to the Japanese, symbolising not only economic revival but also political respectability.

Something similar might be claimed for the 1988 Seoul Olympics. After decades of harsh imperial Japanese rule, the devastating Korean war, and more decades of military dictatorship, South Korea had emerged as a relatively open society with competitive elections, a rambunctiously free press, and a young population brimming with pride and optimism. The Koreans richly deserved the international limelight.

Apart from these rare occasions, however, the Olympics are hard to justify. The marching, flag-waving, uniformed jamborees are a nineteenth-century anachronism, still cherished in countries whose people have no right to elect their leaders but only the obligation to praise them. North Korea is the past-mas-

ter at this kind of thing, but Vladimir Putin's Winter Olympics in 2014, held in a subtropical resort filled with artificial snow, was clearly meant as an homage to his authoritarian rule. And the brand of Chinese nationalism on display at the Beijing Games in 2008 would have been closer to Maurras' heart than to Coubertin's.

Tokyo in 2021 surely doesn't need the Olympics. And yet the Olympic army marches on, making enormous amounts of money even as some countries are almost bankrupted. The IOC made a tidy 985 million from the Athens Olympics. I remember watching the Olympic officials strutting around in Seoul. The poorer the country they represented, the bigger their platinum watches seemed to be.

The Games are a gigantic business for the IOC, for sponsors, for property developers, and sometimes for corrupt politicians. That is what they are for. Thousands of Olympic officials will be crowding the lobbies of expensive hotels in Tokyo this year. And after they leave for the next place, the big stadiums built for nothing will remain as largely abandoned sites of an event that should never have taken place.

### Covid TPR falls, but deaths remain high

 ${f F}$  or the first time in the last few weeks, the Covid test positivity rate (TPR) in Kerala fell to 12.72 per cent, but the death tally continues to be high, said Chief Minister Pinarayi Vijayan in a statement Saturday. Vijayan's statement said that 13,832 people turned Covid positive after 1.08,734 samples was tested in the past 24 hours, while there were 1,29,488 active cases across the state. The TPR last month rose as high as 30 per cent following which Vijayan announced a statewide lockdown, which will be in force till Wednesday. Saturday also saw 18,172 people turn negative taking the total recoveries to 25,75,769. Among the 14 districts, Thiruvananthapuram Saturday recorded the highest tally of 2,234 cases. The day saw 171 Covid deaths taking the total death tally to 10,975. Across the state there were 5,45,000 people under observation at various places which includes 31,103 at hospitals. There were 880 hot spots in the state. Saturday and Sunday are being observed as a triple lockdown with the police increasing their checking and those who are out without a valid reason are being fined and vehicles confiscated.

### Mother of jailed IS supporter awaits her return from Kabul

Thiruvananthapuram, June 12: A housewife Bindhu, Saturday reposed faith in her country and hoped that India will do the needful to bring back her daughter Nimisha, presently in jail in Kabul for allegedly being an Islamic State

Bindhu who lives in the state capital was reacting to a news report in a leading national English daily Saturday that the Indian government is unlikely to make efforts to bring back four women including Nimisha.

"How can my country say like that? They can bring the women and let them conduct the trial as per the law of our country. I am hopeful and I have trust in my country. All the four women are widows and they have children. What wrong have the kids done I want my granddaughter who is four years now," said Bindhu. The four women presently lodged in a jail in Kabul include Soniya, Merin, Nimisha and Raheela, all Keralites.

The news of Keralites joining the IS surfaced after the Kerala government contacted various central agencies - IB, NIA, RAW in 2016 about the veracity of reports about 19 missing people from the state. According to some of the relatives they are believed to have joined the IS.

These 19 included 10 men, six women and three children and of these, most of them hail from Kasargode and a few from Palakkad districts and include Christian and Hindu converts.

In the past three years, a few of those who had joined the IS were reportedly killed, according to their it. The husbands of these Kerala women were among those who have been killed.

It was in 2016 that Bindhu, who is settled near Manacadu in the state capital, approached Chief Minister Pinarayi Vijayan seeking his help to locate her daughter who had gone missing.

### **Unseasonal hailstorms leave** Jammu farmers distraught

Udhampur (J&K), June 12: Every time we go out for hoeing the maize saplings, the rain and hailstorms start. Till now, our net sown area of around 5 kanals of land has been devastated by unseasonal hailstorms four times, said an anxious-looking Guddo Devi.

The 26-year-old was preparing the firewood to make dinner for her three children while speaking about the calamity. She lives in the remote Pounsa hamlet in the Chenani tehsil of Jammu's Udhampur district and like her, many farmers in the surrounding areas of Udhampur have lost their crops to hailstorms.

In these winter zones, farmers often cultivate only one crop a year in the autumn and this loss has left them anxious about surviving

Usually, it does not hail in Jammu in June, but this year unseasonal rainfall and hailstorms have wreaked havoc by damaging standing crops in over hundreds of kanals (1 kanal is equal to 0.125 acres) in the winter areas of Udhampur district.

According to Sonam Lotus, director. Meteorological Department, Jammu and Kashmir, the hailstorms in Jammu and Kashmir are not unseasonal. Rather their frequency has increased due to more local developments this year, he told 101Reporters. Explaining the local developments, he said, "The months of April and May have been categorised as 'hot weather months' by the Indian Meteorological Department (IMD). In this period, India's northern region, including



hailstorms accompanied by gusty winds due to western disturbances and local developments, particularly convection

This year, the frequency of these western disturbances and local\_ convection was very high, resulting in more hailstorms and hence more damage to the crops in the higher reaches of Jammu, explained the weather scientist. When asked if the frequency of windstorms and hailstorms will increase with the advent of monsoon in July in Jammu and Kashmir, he said, "This phenomenon cannot be predicted.

Yash Pal, the sarpanch (village head) of Satyalta Panchayat, which has a population of around 3,000, said that the panchayat has 17,000 kanals of total agricultural land. Of this, he said that maize, rajma, amaranthus, pumpkin, beans and other hilly crops are grown on about 10,000 kanals of land.

Around 90 per cent of these 10.000 kanals of agricultural land has suffered damages due to the hailstorms and incessant rainfall this year.

While the farmers wait for compensation, many believe it may not be able to make up for their losses

### Lashkar behind attack on security forces: DGP

Even as they mounted retaliation, four police personnel and three civilians were injured, the DGP

Constables Waseem and Showkat succumbed to injuries later, while Sub-Inspector Mukesh Kumar and SPO Danish are undergoing treatment, and their condition is stated

to be stable, he said

Two of the three civilians injured in the attack died too, the police chief said.

He said initial indicators have led to the identification of the outfit, and a follow-up on that is on.

"The forces have launched an operation in the area, and we are hopeful that we will soon bring to justice the perpetrators of the crime... As per our information, LeT is involved in it, and we have almost identified the militants in the attack, but we will not share their details yet, the DGP said.

He said police and other security force personnel work in dangerous circumstances and sometimes such attacks take place.

Unfortunately, our responsibilities are such that we have to work in danger and sometimes, such incidents take place. But, our endeavour is to bring to justice all those involved in such attacks, the police chief said.

Bhadarwah (J&K), June 12: Despite Covid-19 induced lockdown, around 1,000 families associated with exotic lavender farming here have not only made themselves self-reliant but also emerged as job provider during the pandemic time.

Lavender farmers have also become a source of inspiration for those still practising traditional farming, according to a grower.

The families from different villages of Jammu and Kashmir's additional district Bhaderwah under Union Government's Aroma Mission switched from maize cultivation to growing of aromatic plants and they are happy over their decision in the backdrop of ever increasing demand of lavender oil in the international market,

which earned them good fortunes. At the time of the pandemic and prolonged lockdowns, the farmers

were providing jobs to hundreds of labourers, thus becoming a true symbol of 'Atmanirbhar Bharat'. officials said.

"I worked with a multinational company in Delhi for four years before losing my job due to the pandemic last year...I packed my bags and returned to my native village dejected after finding it difficult to get another job," 28-year-old Anish, a resident of Tipri village, told PTI. However, he said his decision to return and join his family in growing Lavender revolutionised his life as he became a job provider from a job seeker a year ago.

"I am more confident today than ever before as not only my savings have increased but it gave me immense satisfaction that I am giving jobs to others," he said, thanking the scientists of IIIM Jammu for mobilising farmers of this far flung area. Farmers from Tipri, Lehrote, Khellani, Manwa, Chinta, Trabbi, Koundla, Sharora, Chattra,



Dandi, Bhalla and some parts of Athkhar, who have started harvesting their produce of lavender flowers, are expecting a bumper crop this year and opined that switching to lavender farming has come as a major relief for them during these testing times of corona pandemic. When we switched from growing traditional maize crops to aromatic lavender farming 10 years ago, we were discouraged even by our relatives and friends but today all of them look at us as

an inspiration. During current crisis of pandemic when everybody is worried about losing jobs and businesses, lavender farmers are not only making good fortunes for themselves but also providing jobs to at least 3,000 others during these testing times, Toufeeq Bagban, a young

entrepreneur, said. Growing of lavender not only helped us survive during the hard

times of pandemic but it's strong aroma also kept Corona at a bay and it's proof is that not a single positive case was reported from any of the villages where there are lavender fields, Sarpanch, Neota-Karyan, Om Rai, believes.

The progressive farmers of Tipri village, where all the residents have switched to lavender farming and have become the leading producer of lavender flowers, demand road connectivity to transport their produce to the

distillation units. No doubt lavender farming has changed our fortunes but we have to carry our produce on our back to the distillation centre at Dradhu which is 7 km away from the village for extraction of oil, Anjali Devi,

a local resident, said.

She said it is not only very cumbersome to transport the produce on backs in sweltering heat, but the nonavailability of a motorable road is a major disadvantage for the residents.

# **"No exemption to mainstream"** media from new IT Rules'

The ministry dismissed the concerns that the oversight mechanism stipulated under the digital media rules would lead to excessive government control over the functioning of the digital news publishers and the OTT platforms

New Delhi, June 12: All mainstream media, including print and electronic, will have to comply the provisions of IT Rules, 2021 with immediate effect without exemption as the government has refused to exempt them from the ambit of the new digital media rules.

Ministry of Information and Broadcasting (I&B) has said that the rationale for bringing the websites of the organisations under the ambit of the law is "well-reasoned".

"Making any exception of the nature proposed will be discriminatory to the digital news publishers who do not have a traditional TV/print platform," the ministry said in a clarification to digital news publishers, publishers of online curated content or OTT platforms and associations of digital media publishers.

The government's clarification came as the National Broadcasters Association (NBA) had recently written to the I&B ministry urging it to "exempt and exclude" the traditional television news media and its extended presence on digital news platforms from the ambit of the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021, saying they are already "sufficiently regulated" by various

and regulations. Accordingly, it said, the request for exempting the digital news content of such organisations from the ambit of digital media rules 2021 cannot be acceded to.

statutes, laws, guidelines, codes

"It does recognise that entities having traditional TV and print media are already registered with the government either under the Press and Registration Books Act or the Uplinking and Downlinking Guidelines of 2011.

The digital version/digital publication of the organisations having traditional news platforms (TV and print) may be following internal guidelines of the self-regulatory bodies. Accordingly, if the organisations so desire, they can request the same self-regulatory bodies to serve as the Level II of the self-regulatory mechanism, after ensuring consistency with the Digital Media Rules, 2021," said the Ministry. The Ministry also clarified that when any news and current affairs content of a digital news publisher is transmitted on an OTT platform, such content would be outside the regulatory responsibility of that platform.

"Further, Level III is visualised as a residual level, in so far as the grievances which do not get addressed at the first and second levels would go to the IDC. Accordingly, the apprehension of excessive government control through these mechanisms is misplaced," said

In the overall context, the Digital Media Rules, 2021 may be complied with by the digital news publishers and the OTT platforms without any misapprehensions, it added.

The Ministry further said that the publishers may furnish the requisite information in the prescribed format immediately, take urgent steps for appointing a grievance officer, if not done, and place all relevant details in the public domain, constitute self-regulatory bodies through mutual consultation so that the grievances are addressed at the level of publishers or the self-regulating bodies themselves.

It further added that over 500 publishers have already submitted their details in the requisite

### **Twitter sends notices** to cartoonist Manjul, other prominent users

New Delhi, June 12: Unnamed law enforcement agencies have asked Twitter to take down certain tweets of popular cartoonist News co-founder Mohammed Zubair and others, over alleged violation of law. Manjul, Zubair and retired IAS officer Surya Pratap Singh have shared screenshots of the notice sent by the microblogging platform on their Twitter handles

over the last few days. Sources said the Ministry of Electronics and IT was not involved in sending these legal requests to Twitter: It wasn't clear which agencies have flagged these tweets by these users and for what violations.

Meanwhile, the screenshot shared by Manjul showed Twitter as saying "In the interest of transparency, we are writing to inform you that Twitter has received a request from Indian law enforcement regarding your Twitter account @MANJULtoons that claims the ... Content violates the law(s) of India". It further stated that Twitter has "not taken any action on the reported content at this time as a result of this request"

Twitter, in its notice, said it is the company's policy to notify users if it receives a legal request from an authorised entity (such as law enforcement or a government agency) to remove content from their account.

# Govt approves policy on archiving, declassification of war histories

The History Division will be responsible for coordination with various departments while compiling, seeking approval and publishing of war and operations histories

New Delhi, June 12: India has for the first time formed a policy to compile, archive, declassify, and publish military operations and

war histories. Earlier there was no such provision. Indian Defence Minister Rajnath Singh Saturday approved the policy on archiving, declassification and compilation, publication of war, operations histories by the Ministry of Defence.

"The policy envisages that each organisation under the Ministry

Integrated Defence Staff, Assam Rifles and Indian Coast Guard, will transfer the records, including war diaries, letters of proceedings and operational record books, etc., to the History Division of Ministry of Defence (MoD) for proper upkeep, archival and writing the histories," the Ministry of Defence stated.

The responsibility for declassification of records rests with the respective organisations as specified in the Public Record Act 1993 and Public Record Rules 1997, as



should ordinarily be declassified in 25 years. "Records older than 25 years should be appraised by archival experts and transferred

once the war/operations histories have been compiled," said the ministry

Secretary, MoD and comprising of representatives of the Services, Ministry of External Affairs, Ministry of Home Affairs and other organisations and prominent military historians, if required, for compilation of war and operations histories.

The policy also set clear timelines with regard to compilation and publication of war, operations histories. "The Committee should be formed within two years of completion of war/operations," the ministry said.

Chandigarh, June 12: The Shiromani Akali Dal and the Bahujan Samaj Party formed an alliance Saturday for the 2022 Punjab Assembly elections, coming together after a gap of 25 years.

Under the tie-up, the BSP will fight 20 of the 117 Assembly seats while the rest will be contested by the SAD, said Akali Dal chief Sukhbir Singh Badal while announcing the alliance here.

The SAD-BSP alliance had contested the 1996 Lok Sabha polls together and won 11 out of 13 seats in Punjab. While three seats were won by the BSP and the rest were won by the SAD.

BSP chief Mayawati dubbed the alliance between the SAD and her party as a "new political and social initiative" which will usher in progress and prosperity in Punjab.

SAD stalwart and former CM Parkash Singh Badal described the formation of the SAD-BSP alliance as "the beginning of a secular, federal democratic revolution in the state and the country for a total socio-economic and political revamp of polity".

Punjab has 31.94 per cent Dalit population, mainly concentration in Jalandhar, Hoshiarpur, Nawanshahr and Kapurthala districts.

About the new alliance, Mishra said, "Today is a historic day. The BSP, which is a national party, has entered into an alliance with Punjab's strongest party SAD. This alliance will continue forever now."

This tie-up has been revived after two parties were together 25 years ago, said Badal and Mishra.

"Each BSP worker supports and welcomes this alliance. The SAD and the BSP are pro-farmer parties, who have worked for uplift of the Dalits, labourers and weaker sections," Mishra said, Sukhbir Badal said he wants to thank Mayawati for playing "an instrumental role in stitching this alliance".

# 'No going back on 2015 Framework Agreement'

Kolkata, June 12: The National Socialist Council of Nagaland (NSCN) has reminded the Central government that it "cannot and should not" go back on the 2015 Framework Agreement in its quest for a final solution of the Naga problem.

"The Framework Agreement is not something that was signed in a hurry. It was the result of the well thought out proposal from the government of India when the Indo-Naga political talk faced deadlock-like situation," the NSCN said in a statement.

NSCN said the agreement was arrived to resolve the deadlock by touching on "the core issue of solution within Indian Constitution (Centre's stand) and outside the Indian Constitution (Naga stand)".

"It was the result after a long series of talks, when the government of India finally proposed the Framework Agreement as a formula of win-win solution. Significantly, the talks had revolved around the Framework Agreement with both the parties cautiously taking care not to allow either side to take strategic advantage or deviation from the agreement," the statement added.

Rajib Banerjee had recently skipped a meeting of the Bengal BJP and warned members of the saffron party over a social media post that "people will not take kindly to threats of Presidents rule against a government elected with a huge mandate"

After quitting the TMC in January, Banerjee had claimed that he was forced to do so as a section of party leaders "humiliated him for airing his grievances over their style of functioning".

New Delhi, June 12: India has approached the Dominica High Court seeking to be impleaded as a party in the case filed by lawyers of absconding businessman Mehul Choksi whose bail was rejected by the High Court after a five hour long hearing, sources said here.

The central agency is likely to focus on establishing criminal culpability of Choksi, his fugitive status, pending warrants against him, Red Notice and charge sheets while the External Affairs Ministry will argue that Choksi continues to be an Indian citizen, they said

The affidavits, if admitted by the

High Court, will pave way for noted lawyer Harish Salve to plead India's case in Dominica, they said.

The CBI and External Affairs Ministry have sought to implead in the Habeas Corpus matter, which seeks return of Choksi to Antigua and Barbuda, by filing two affidavits in **Dominica High Court** 

to Choksi calling him a flight risk after a five-hour-long court proceeding through video conferencing.

Justice Wynante Adrien-Roberts ruled that "the court cannot impose any condition that will assure Choksi will not abscond," Dominica News online reported from the island country.

Choksi's lawyers vehemently sought bail arguing that allega-tions of "illegal entry" should be discarded because as "a Caribbean Community (CARICOM) citizen, he is entitled to such benefits since his allege offense is not of a serious nature", the report said.

The team was ready for stringent bail conditions to be imposed by the High Court besides offering "any amount" for bail set by the

Court, it said. The counsels also cited poor health condition to argue that he was not a flight risk

# Indian SIM cards used in China for frauds under lens

The move comes after the agencies learnt that 1,300 SIM cards were used to hack accounts and to commit other financial frauds. The revelation comes after Han Junwe, a Chinese intruder arrested Thursday, told the agencies about it during his interrogation

New Delhi, June 12: Indian agencies are engaged in getting details of 1.300 SIM cards as they were being used by a gang of Chinese to hack accounts and commit financial frauds, a suspected activity of a Chinese intelligence agency.

All the telecom operators are learnt to have been directed to report to the agencies concerned soon after they find any suspicious link related to any SIM cards being operated from outside India, said

As per the information, the agencies have sought from these telecom



operators to make a list of all Indian SIM cards being operated from China since 2010. Revealing the shocking fact, Han, a 36-year-old Chinese national who has been a wanted criminal in India, informed the agencies that he has so far taken around 1,300 Indian SIM cards to China using fake documents from India since 2010.

Han, through his associates, used to hide the SIM cards in undergarments and send these to China. "These SIM cards were used to hack accounts and to do other financial frauds," said the Border Security Force (BSF) who arrested the suspected Chinese

spy who allegedly sneaked into Indian territory crossing India-Bangladesh border in West Bengal's Malda district.

'The purpose was to cheat people using SIM cards to get their money out of money transaction machines," said the BSF, which is responsible to guard 4,096 km India-Bangladesh border. The agencies have also raided the hotel of the Chinese national which he has been running from Gurugram named 'Star Spring" where some of his col-

leagues from China were working. Han, who is now under West Bengal Police custody for further legal proceedings along with seized items, was held under Border Outpost Malik Sultanpur when he was trying to illegally cross India-Bangladesh International Boundary (IB).

A resident of Chinese city of Hubei, Han entered Bangladesh June 2. From interrogation and his recovered passport, it was learnt that Han reached Dhaka June 2 on a business visa and stayed there with a Chinese friend.

June 8, he came to Sona Masjid in Chapainawabganj district (Bangladesh) and stayed in a hotel there, the statement said, adding he was trying to enter Indian territory today (Thursday) when he was caught by the BSF troopers.

### Afghanistan: Twin blasts kill seven

Kabul: Separate bombs hit two minivans in a mostly Shiite neighbourhood in the Afghan capital Saturday, killing at least seven people and wounding six others, the Interior Ministry said. The attacks targeted minivans on the same road about 2 kilometres apart in a neighborhood in western Kabul, Interior Ministry deputy spokesman Ahmad Zia Zia, said. It wasn't immediately clear what type of bombs were used and no one immediately claimed responsibility for the attacks.

### **Covid cases spike** 47% in a week

Moscow: Russia's national coronavirus taskforce Saturday reported that the country's tally of daily new infections has risen by nearly 50% over the past week and more than doubled in Moscow. It said there were 13,510 infections recorded in the previous day, sharply higher than the 9,163 reported June 6. Nearly half the new cases were in Moscow — 6,701 compared with 2,936 a week ago.

### Algeria votes for new Parl

Algiers: Algerians vote Saturday for a new parliament in an election with a majority of novice independent candidates running under new rules meant to satisfy demands of pro-democracy protesters and open the way to a "new Algeria". Tension surrounded the voting in the gas-rich North African nation. with activists and opposition parties boycotting. Authorities have tightened the screws on the Hirak protest movement in recent weeks, with police stopping weekly marches and arresting dozens.

### UK to set up new vax centre

London: Britain will set up a new animal vaccine development centre that will aim to stop viruses jumping into the human population as part of a landmark global health declaration to be agreed by G7 world leaders at Carbis Bay in Cornwall Saturday. The so-called "Carbis Bay Declaration" will see the world's leading democracies commit to a series of measures that are designed to quash future pandemics within the crucial period of the first 100 days.

Moscow, June 12: Just days ahead of the much-awaited summit with his American counterpart Joe Biden, Russian President Vladimir Putin said that Russia-US relations were at their lowest point in years. "We have a bilateral relationship that has deteriorated to its lowest point in recent years," Putin told NBC News in an interview on Friday which will be aired June 14.

But he said that Biden is a career politician and there is hope that there will not be any impulse-based movements, TASS News Agency reported.

He "is radically different from (former US President Donald) Trump because President Biden is a career man. He has spent virtually his entire adulthood in politics" 'That's a different kind of per-

son, and it is my great hope that ves.

there are some advantages, some disadvantages, but there will not be any impulse-based movements, on behalf of the sitting US president," Putin said.

Meanwhile, he also denied a Washington Post story saying that Russia is preparing to supply Iran with an advanced satellite that would enable Tehran to track military targets in the region, Xinhua news agency reported citing the NBC News interview. "It's just fake news," Putin told NBC News.

"At the very least, I don't know anything about this kind of thing. Those who are speaking about it probably know more about it. It's just nonsense, garbage.

Biden, who is on the first foreign trip of his presidency to Europe, will meet Putin June 16 in Geneva, Switzerland Relations between Washington

## SL seeks \$40mn from cargo ship's operator

Colombo, June 12: Sri Lanka on Saturday made an interim damage claim of USD 40 million from the owners of the Singapore-flagged cargo ship that caught fire near the outer area Colombo port May 20 and caused the country's worstever marine ecological disaster.

Sri Lanka has lodged the claim of \$40 million through the Attorney General following a directive by PM Mahinda Rajapaksa.

'We are still assessing the scale of damage, environmental and economic and decided to make this interim claim of," Rohitha Abeygunawardena, the minister of ports, said.

The cargo vessel - MV 'X-PRESS PEARL'- was carrying a consignment of chemicals and raw materials for cosmetics from Hazira in Guiarat to Colombo Port when it caught fire some 9.5 nautical miles away from the port of Colombo.

All 25 crew members of the ship



-- of Indian, Chinese, Filipino and Russian nationality -- were rescued May 21.

The recovered Voyage Data Recorder, which is an instrument installed on a ship to continuously record vital information related to the operation of a vessel, has now been handed over to the local law enforcement agencies to assist ongoing investigations.

Though the fire on the ship was doused by a joint effort of the Sri Lanka Navy and the Indian Coast Guard, the efforts to drag the ship away from the port's outer harbour area into deep seas has failed as the rear end of  $\bar{t}$ he ship came to be stuck after being submerged.

### Haj to be limited to 60,000: Saudi

The haj, a must for able-bodied Muslims at least once in their lifetime -- typically packs millions of pilgrims into congested religious sites and could be a major source of contagion.

Only up to 10,000 Muslims took part in last year, a far cry from the 2.5 million who participated in the five-day annual pilgrimage in 2019.

In a relaxation of coronavirus curbs last October, Saudi Arabia

opened the Grand Mosque for prayers for the first time in seven months and partially resumed the all-year-round umrah pilgrimage.

### **UK mulls delaying** lockdown by another month: Sources

London, June 12: The UK government is considering delaying the lifting of the remaining restrictions in England by another month amid concerns over the spike in new Covid cases and the further transmission of the Delta variant, informed sources said Saturday.

The development comes as government is facing increasing pressure to delay the final step of unlocking restrictions in England on June 21 due to concerns over the spread of the Delta variant, which has become the "dominant" strain in the UK.

As of now, the government's roadmap is expected to see all legal limits on social contact to be removed June 21.

The Downing Street sources told the BBC that a final decision on the lockdown is yet to be taken by the government.

According to one of the source, data was still being examined ahead of a final announcement scheduled for June 14 and the government was "considering 'options - plural' for step four of England's roadmap".

"Pushing the date back would allow the vaccination programme to take greater effect, as the rollout moves through to younger age groups," the source told the BBC.

As part of the roadmap, pubs, bars and restaurants in England were permitted to open indoors, while indoor entertainment resumed, including cinemas, museums and children's play areas, from May 17 onwards.

People were also allowed to travel abroad to a number of "green-list" countries without having to quarantine upon return as the ban on foreign travel has also been lifted.



# Continued war, poverty force Afghan kids to work on streets

Kabul, June 12: The continued brutal war, insurgency and extreme poverty in Afghanistan have forced countless number of children to resort to child labour and work on streets to earn livelihood for their families, instead of going to school.

A UN Assistance Mission in Afghanistan (UNAMA) report released in April documented 1,783 civilian casualties (573 killed and 1,210 injured) in the first quarter of 2021 which indicates a 29 per cent increase against the same period of last year, reports Xinhua news agency.

women casualties while a 23 percent spike in child casualties com-

### Govt asks ministries to target 20% reduction in controllable expenditure

New Delhi, June 12: The government has asked all ministries and government departments to target 20% reduction in expenditures like domestic and foreign travel, overtime allowance, rent and office expenses, in the current fiscal year as it tightens its purse strings amid the second wave of the

The Department of Expenditure under the Finance Ministry issued an office memorandum in this regard June 10.

"All the ministries/ departments are requested to take steps to curtail all avoidable non-scheme expenditure and aim for 20% reduccontrollable in expenditure....Expenditure in 2019-20 may be taken as the baseline for this purpose," the memorandum said. However, expenditure related to containment of the pandemic is excluded from the scope of this order. The memorandum said, ministries should aim to control expenditures like overtime allowance, rewards, domestic and foreign travel, office expenses, rents, rates and taxes, royalty.

Besides, expenditures related to publications, other administrative expenses, supplies and materials, cost of ration, clothing and tentage, advertising and publicity, minor works and maintenance, service or commitment charges, grants-



in-aid general, contribution and other charges, should also be cut.

The savings that would accrue to the government due to this move cannot be exactly ascertained. This is the second year in a row that the government has come out with measures to rationalise expenditure.

Last year, the expenditure department had asked all ministries /departments to review appointments of consultants, curtail functions and ban use of imported paper for printing as part of measures to rationalise non-priority expenditure

As per estimates, the government is staring at an additional expenditure of up to ₹1.45 lakh crore to provide free vaccines and foodgrains to people devastated by the deadly second wave of covid in-

# 'Higher subsidy under FAME II to be game changer in adoption of EVs'

New Delhi, June 12: Electric twowheeler makers Saturday termed as "a phenomenal move" by the government to increase subsidy for such vehicles by 50 per cent under the FAME II scheme saying it would be a game changer in the adoption of eco-friendly vehicles.

The government Friday made a partial modification of the scheme for Faster Adoption and Manufacturing of Electric Vehicles in India Phase II (FAME India Phase II), including increasing the demand incentive for electric twowheelers to ₹15,000 per KWh from the earlier uniform subsidy of ₹10,000 per KWh for all EVs, including plug in hybrids and strong hybrids except buses.

In the latest modification, the department of heavy industries also capped incentives for electric twowheelers at 40 per cent of the cost of vehicles, up from 20 per cent earlier. "The revision in the FAME (II) policy, increasing the subsidy by 50 per cent per KWh is a phenomenal move. Sales of electric two-wheelers have grown despite the pandemic and with this additional subsidy, we expect electric two wheeler sales to disrupt the market, and clock 6 million-plus units by 2025," Ather Energy CEO and Co-founder Tarun Mehta said in a statement.

The government's continued support to drive adoption of EVs,



with a keen focus on locally built electric two-wheelers will make India the manufacturing hub of EVs, he added.

Welcoming the "government's continued support to EVs", TVS Motor Company Joint Managing Director Sudarshan Venu said "Sustainable mobility solutions are very important for the future and TVS is investing significantly behind this. The improved incentives for electric two wheelers will increase penetration.

He further said, "Such policy direction should lead to indigenous development of future technology." 

# Biden sells G7 on global tax, but US Cong is a hurdle

Washington, June 12: President Joe Biden might have persuaded some of the world's largest economies to hike taxes on corporations, but the US Congress could be a far tougher sell. White House press secretary Jen Psaki said Friday that leaders of the Group of Seven, which also includes the United Kingdom, France, Canada, Germany, Italy and Japan, agreed with Biden on placing a global minimum tax of at least 15% on large companies.

The G7 leaders, participating in a three-day summit in England, affirmed their finance ministers who earlier this month endorsed the global tax minimum.

make big multinational corporations pay their fair share so we can invest in our middle class at home," Jake Sullivan, the president's national security adviser, said Friday on Twitter.

A minimum tax is supposed to halt an international race to the bottom for corporate taxation that has led multinational businesses to book their profits in countries with low tax rates.

This enables them to avoid taxes and encourages countries to slash rates. The minimum rate would make it tougher for companies to avoid taxes, and could possibly supplant a digital services tax that many European nations are imposing on US Tech firms that pay at low rates.

Copenhagen, June 12: Denmark midfielder Christian Eriksen was taken to a hospital Saturday after collapsing on the field during their match against Finland in the Euro 2020.

The UEFA said Eriksen has been stabilised and the Danish football federation said he was awake. "Christian Eriksen is awake and is undergoing further examinations at Rigshospitalet," the Danish federation wrote on Twitter.

The match was suspended after Eriksen was given urgent medical attention on the field near the end of the first half. Later UEFA announced the restart of the match on Twitter.

"Following the request made by players of both teams, UEFA has agreed to restart the match between Denmark and Finland tonight at 20:30 CET (12:00 am IST). The last four minutes of the first half will be played, there will then be a 5minute half-time break followed by the second half," the tweet reads.

Eriksen was treated for about 10 minutes after collapsing. He was then carried off on a stretcher. UEFA then announced the game had been suspended 'due to a medical emergency'.

Eriksen had just played a short pass when he fell face-forward onto the ground. His teammates immediately gestured for help and medics rushed onto the field. Eriksen was given chest compressions as his Denmark teammates stood around him in a shielding wall for privacy.

Finland players huddled by their bench and eventually walked off the field while Eriksen was still getting treatment. Eriksen was eventually carried off to a loud ovation, with his teammates walking next to the stretcher.

winning streak. She is the sixth consecutive firsttime Grand Slam champion to collect the trophy at Roland Garros, where the red clay can diminish the effectiveness of speedy serves and the sometimes odd bounces produced by, and particular footwork required on, the surface can frus-



### Mirabai Chanu's **Tokyo Olympics** berth confirmed

New Delhi, June 12: The International Weightlifting Federation (IWF) Saturday conformed that star Indian lifter Mirabai Chanu has qualified for the upcoming Tokyo Olympics in the women's 49kg category.

Chanu, the 2017 World Champion in weightlifting, had secured her place in Tokyo by winning a bronze medal in the Asian Championship in Tashkent in April with a world record in clean and jerk.

The 26-year-old from Manipur has qualified on the basis of her standings on IWF's Absolute Ranking list. The Indian lifter is ranked second in the 49kg category with 4133, 6172

points in her kitty. Chanu was earlier ranked fourth but North Korea's withdrawal from the Olympics lifted the Indian to the

second place. This will be Chanu's second appearance in the Olympics, five years after a disappointing outing in Rio, where she failed to lift any of the weights in clean and jerk to bow out of the showpiece.

In the men's 67 kg category, India's Jeremy Lalrinnunga is ranked 12th and lost the continental quota to Korea's Hak Myeongmok, but the 18-year-old still has a chance to qualify. The final list will be released June 25
