India's research

Thiruvananthapuram, June 13: Despite making 'solid progress' in achieving Sustainable Development Goal (SDG) targets relating to industry, infrastructure and innovation, the India's investment in research remains unsatisfactory, the UNESCO Science Report has observed.

According to the report, the gross domestic expenditure on research (GERD) has been dormant at 0.7% of the GDP for years, though in absolute terms, research expenditure has increased, the chapter on India authored by Sunil Mani, director; Centre for Development Studies (CDS), Thiruvananthapuram, noted. India has one of the lowest GERD/GDP ratios among the BRICS nations, the report, which is published every five years, noted.

"India's research intensity has been declining since 2014. The Science and Technology Policy of 2003 fixed the threshold of devoting 2% of GDP to research and development (R&D) by 2007. This target date was set back to 2018 in the new Science, Technology and Innovation Policy (2013) then again to 2022 by the Economic Advisory Council of the Prime Minister. In 2020, the task force drafting the country's new Science and Technology Policy recommended pushing back the target date to a more realistic 2030," it observed.

Bhubaneswar, June 13: The state School and Mass Education Minister Samir Ranjan Dash Sunday said that the results of the annual matriculation examinations will be announced by the last week of June.

According to the minister, the process of evaluation is already underway. "We are hopeful of publishing the results within the stipulated time frame that was announced earlier."

It may be mentioned here that the Matric examinations were to be held from May 3, 2021. But, in view of the alarming spike in Covid-19 cases, the examinations were postponed. This triggered students' resentment as their fate hanged in a balance over the government's inability to take a decision regarding holding the matriculation examination.

Later, the Board of Secondary Education (BSE) Odisha announced an alternative method of as-

sessment to award marks to Class X students. According to the announcement, the evaluation of marks will be done based on the performance of the students in their Class IX and Class X examinations.

It was decided that the assessment of marks will be done after considering the marks secured by a student in the half-yearly and annual examinations in Class IX and the 2nd, 3rd, 4th practice tests in Class X. The Board would then take into consideration the two highest marks in each subject from the three practice tests conducted in Class X. In addition, 40% weightage will be given to highest marks secured in Class IX.

Two highest marks in all the subjects in the three practice tests conducted in Class X will be given weightage of 30% each. In case any candidate has appeared only in one practice test, then 70% weightage will be given in the marks secured in Class IX half yearly and annual examinations

Govt is saving money for welfare schemes: Pradhan

New Delhi, June 13: With prices of petrol and diesel climbing steeply, Union Minister for Petroleum and Natural Gas, Dharmendra Pradhan, Sunday agreed that the rates were a problem, but said that since government expenses are up due to Covid-19 relief measures, "the Centre is saving money to spend on welfare schemes"

"I accept that fuel prices are pinching consumers, there's no doubt about this. But over ₹35,000 crore has been spent on Covid vaccines in a year. ₹1 lakh crore has been spent on Pradhan Mantri Garib Kalyan Yojana in order to provide eight months' ration to the poor. A few thousand crores of rupees have also been transferred to farmers' bank accounts under PM Kisan...In such dire times, we're saving money to spend on welfare schemes," Pradhan said, speaking to the media.

With the Centre facing constant flak from the Opposition over fuel prices, Pradhan asked Congress governments in Rajasthan and Maharashtra to cut sales tax if the party was "that concerned about the burden on the common man". Asked about Congress leader

Rahul Gandhi's repeated attacks on the Modi government, Pradhan said, "Rahul Gandhi must answer why fuel prices are high in Congress-ruled states like Punjab, Rajasthan and Maharashtra. If he is so concerned about the poor, he should instruct the Maharashtra Chief Minister to reduce taxes, as fuel prices are very high in Mumbai.'

Pradhan, however, refrained from commenting on whether BJP-ruled states, like Madhya Pradesh and

Fuel prices differ from state to state depending on local taxes such as VAT and the freight charges levied on them. Due to this, petrol at present costs more than ₹100 per litre in seven states and Union Territories, which include Rajasthan, Madhya Pradesh, Maharashtra Andhra Pradesh Telangana, Karnataka and Ladakh. Of these states, Congress is in power in Rajasthan and is a coalition partner with Shiv Sena and NCP in Maharashtra. Madhya Pradesh and Karnataka are ruled by the BJP Ladakh too is under Central rule. Andhra Pradesh has YSR Congress in power

while TRS rules in Telangana. While international oil prices have crossed \$72 per barrel in anticipation of demand recovery following the rollout of vaccination programme by various countries. Last year when rates collapsed to two-decade low, the union government instead of passing on the benefit to consumers raised excise duty to record high. The excise tax on petrol was ₹9.48 per litre when the Modi government took office in 2014, and that on diesel was ₹3.56 a litre.

Man, son beaten to death for practicing sorcery

R Udaygiri, June 13: In a shocking incident, some villagers allegedly ganged up against a man and his son and beat them to death at Muthaguda village under Adaba police limits in Gajapati district late Saturday night. The villagers suspected that the duo was practicing black magic. The deceased have been identified as Luka Dalabehera and Anak Dalabehera of the same village.

Family members of the victims alleged that the locals were suspecting the involvement of Luka and Anak in the death of a minor boy in the village. They said that the boy had died due to 'black magic' performed on him by the father-son duo. They attacked and killed the two Saturday night.

Sources said that the villagers had a meeting and then took Luka and Anak to a nearby forest, where the two were mercilessly beaten up. Luka died on the spot, while Anak managed to flee the spot and return home. However, a few minutes later he also breathed his last.

The local sarpanch reported the incident at the Adaba police station. R Udaygiri sub-divisional police officer (SDPO) Dillip Kumar Nayak and other officers reached the spot and sent the bodies for post-mortem. The SDPO said that a detailed probe into the matter is underway. The police are trying to identify the villagers involved in the assault on the deceased duo.

Heavy rains likely across state today

Bhubaneswar, June 13: The regional office of the India Meteorological Department (IMD) Sunday said that the southwest monsoon has covered the entire state.

At the same time, the MeT has forecast heavy rainfall in different parts of the state in the next two days, while moderate to light rains are expected in other parts of the state for next few days.

Issuing a 'Yellow Warning' (be updated) for the next two days, the IMD said, "Heavy to very heavy rainfall is very likely to occur at one or two places over the districts of Sundargarh, Jharsuguda, Bargarh, Sambalpur, Deogarh, Angul, Keonjhar, Mayurbhanj Monday."

It added that heavy rains may also occur in the other parts of the state Monday. According to the evening bulletin of the IMD, heavy rainfall is very likely to occur at one or two places over the districts of Malkangiri, Koraput, Nabarangpur, Kalahandi, Dhenkanal, Jajpur, Cuttack, Bhadrak, Balasore, Kendrapara, Jagatsinghpur, Puri and Khurda Monday.'

At the same time, light

to moderate rains are likely in most of the districts in North and South Odisha. Thunderstorms may also occur, the department said.

The IMD said that Sundargarh, Jharsuguda, Keonjhar, Sambalpur and Deogarh districts may witness heavy to very heavy rainfall Tuesday, while districts like Kalahandi, Kandhamal, Boudh, Angul, Dhenkanal, Cuttack, Bargarh and Jajpur may see heavy rainfall. Light to moderate rains are likely to continue in many other places of Odisha Tuesday.

The department, however. has not issued any warning regarding heavy rains for Wednesday and Thursday. The IMD also said that as far as the state capital is concerned, there may be few spells of rains and thunderstorms Monday. The maximum temperature could go up to 33°C. It has also issued an advisory for the fishermen not to venture into deep sea till June 15.

The bulletin said that the highest rainfall in the last 24 hours was reported in Angul district, which saw 98mm percipitation. It was followed by Kenonjharwhich saw 81.2 mm rainfall during the period.

'Small' groups don't rule the world

The re-emergence of China as a leading global power is among the most significant geopolitical events of recent times

London, June 13: China Sunday pointedly cautioned Group of Seven leaders that the days when "small" groups of countries decided the fate of the world was long gone, hitting back at the richest democracies as they sought to act in concert to counter Beijing's might.

The re-emergence of China as a leading global power is considered to be one of the most significant geopolitical events of recent times, alongside the 1991 fall of the Soviet Union that ended the Cold War. But the return of China as a global power has unnerved the United States: President Joe Biden casts China as the main strategic competitor and has vowed to confront China's "economic abuses" and push back against human rights violations.

"The days when global decisions were dictated by a small group of countries are long gone," a spokesman for the Chinese embassy in London said.

"We always believe that countries, big or small, strong or weak, poor or rich, are equals, and that world affairs should be handled through consultation by all countries.'

The Chinese spokesman said the only valid global system was the international order based on the principles of the United Nations and "not the so-called rules formulated by a small number of countries.

The G7, whose leaders are meeting in southwestern England, has been searching for a coherent response to the growing assertiveness of President Xi Jinping



after China's spectacular economic and military rise over the past 40 years.

Leaders of the group, which comprises the United States, Canada, Britain, Germany, Italy, France and Japan, want to use their gathering in the English seaside resort of Carbis Bay to show the world that the richest democracies can offer an alternative to China's growing clout.

Canadian Prime Minister Justin Trudeau led a G7 discussion of China Saturday and called on leaders to come up with a unified approach to the challenges posed by the People's Republic, a source said. The G7 is planning to offer developing nations an infrastructure scheme that could rival Xi's multi-trillion-dollar Belt and Road initiative.

Beijing has repeatedly hit back against what it perceives as attempts by Western powers to contain China, and says many major powers are still gripped by an outdated imperial mindset after years of humiliating China.





Govt warns of strict action in spurious drug cases

Bhubaneswar, June 13: Health Minister Naba Kishore Das Sunday warned medicine dealers of strict actions if they are found indulged in malpractices such as the sale and distribution of spurious drugs in the state.

The Health minister said that raids had been undertaken after receiving information on such malpractices. "After the investigations are done and reports of involvement of persons in such cases are received from the authorities concerned, the state government will take strict action against the persons involved,' he said.

"We will not tolerate such things in the state. After receiving vital information, the drug controller's office swung into action and raided a drug trader in Cuttack. We saw 170 boxes of spu-

rious Favipiravir medicines and each box had around 100 tablets. Other drugs relating to cold and other ailments were also seized on suspicion," he said.

According to the minister, the

samples have been sent to labs in Kolkata and Bhubaneswar. He said that the health department and the police department have also been asked to act in such cases and trace the malpractices.


This comes after the office of the state drug controller raided several medicine stores, wholesalers dealing with the procurement, distribution and sales of medicines in the state.

The department in the last few raids in Cuttack, Rourkela and other cities has found spurious Favipiravir and nine other drugs used in the treatment of different diseases including Covid-19. Many of the of drug traders

under lens have been booked under the Drugs and Cosmetics Act which has provisions of jail as well as fine for the crimes which could directly harm people's health.

The raids were triggered by interstate intelligence reports from the offices of drug controllers of Himachal Pradesh, Maharashtra and other states which led to more revelations post seizure and raids on selected traders and dealers of drugs in the state.

100 foreign-bound students shortlisted for vaccination

Bhubaneswar, June 13: Taking an initiative to vaccinate those seeking to fly abroad for higher studies the Bhubaneswar Municipal Corporation (BMC) has prepared a list of about 100 students who will be administered the Covishield vaccine in the state capital.

As per sources, while only Covaxin doses are available in the capital city, special arrangements have been made to make available the Covishield vaccines for those planning to go abroad. The reason behind this special arrangement is that Covaxin is yet to be recognised as a vaccine by the foreign na-

While 83 students are enlisted after verification of the necessary documents, 19 have already been administered with the doses.

"Two vaccination centres at PN College, Khurda and CMC Kalyan Mandap, Gopalpur, Cuttack have been made available for providing vaccination to students leaving for overseas. Moreover, a special desk has been set up for the document verification and listing of the students at operation centres here," a BMC official said.

The foreign-bound students for higher studies in the age group of 18-44 can register their requests through 1929 call centre. While no pre-booking of slots is necessary, students will need to keep ready documents like confirmation letter of admission from the respective foreign universities and their valid ID proof for the vaccination process.

"I came home during Covid after completing my second year. I was in great stress to take the vaccine before joining the class. Now I am happy that I can go and join my class with the two doses of vaccines," said Urmila Pradhan, a third-year student of Vinnitsa National Medical University in Ukraine.

Bhubaneswar, June 13: A firm based in New Delhi allegedly duped a non-profit organisation here of around Rs 7 lakh on the pretext of providing various financial consultancy and community-based project related services. The NGO Kalinga Kusum Foundation located at Infocity road at Patia has lodged a complaint with the police in this regard.

According to the complaint, the NGO and the accused firm Innovative Financial Advisors Private Limited signed several agreements between January and March 2019. The NGO had reportedly paid a total Rs 17, 46,400 to the Delhi-based project consultancy firm. The NGO alleged that the firm failed to provide any service for which it had received huge amount of money from the NGO. Subsequently, the consultancy company was asked by the organization to return the money. However, the company allegedly returned only Rs 7 lakhs while a cheque of Rs 5.60 lakhs was bounced due to insufficient amount in the bank account of the foundation, said the city-based organization. A separate case has also been filed against the firm under the Negotiable Instruments Act.

Cuttack, June 13: Contrary to the smooth vaccination claims by the civic authorities, many locals in the Silver City here have alleged several loopholes in the inoculation drive against novel coronavirus.

ments to vaccinate foreign-bound students. Around 30 students have been vaccinated in these facilities since June 9." said a source in the CMC. However, the locals claimed that

special measure to vaccinate the eld-

Many in the city have blamed the online registration and slot booking system as a stumbling block in the vaccination of poor people and slum dwellers. "The city has around 50,000 slum dwellers. Till date, only around a thousand people from the slums have been vaccinated against the deadly virus," said Brundaban Das Azad, president of Akhila Odisha Jhopadipati Mahasanga that champions the cause of slum dwellers.

There are also allegations that the CMC is yet to create awareness on the vaccination drive among the poor and people from the lower

"Only a few educated people from our community have been vaccinated against the Covid-19. More than 80 per cent people have been deprived of the vaccine due to their ignorance about the inoculation drive," said Qadam-E-Rasool Development Committee president Sheikh Muntakim Bux.

Covid, lockdowns hit blood donation drives


Bhubaneswar, June 13: The outbreak of Covid-19 pandemic and subsequent lockdowns as well as shutdowns seem to have taken a toll on the blood donation drives

Several blood banks in the state saw a sharp decline in blood collection during the pandemic, making the health system vulnerable. Owing to the restrictions, the blood donation drives and overall functioning of the centres suffered a jolt.

Officials from the Central Red Cross Blood Bank, Cuttack, one of the largest blood banks of Odisha that used to collect upto 150 units of blood per day during the pre-Covid days is now struggling to get even 50 units of blood per day. However through special camps, the centre has been trying to ensure timely collections.

"Although the collections are down due to Covid, we have been roping in special blood collection drives to regularly collect blood for our blood bank," Dr Chandrika Das, Director, Central Red Cross Blood Bank, Cuttack said.

The blood bank at Capital Hospital, which caters to the areas upto 100 kms away from the city, also suffered a setback due to the pandemic. The centre also caters to the needs of other districts far away from the state capital in case



of rare blood groups like AB group. Dr Debasish Mishra, in-charge of Capital Hospital blood bank attributed lesser collections to the closure of educational institutions. "Like several other sectors, blood donations also got affected due to Covid-19. Educational institutions had been our prime source of blood donations but as they remained closed we focused on local clubs and other voluntary donors to keep the drive going," he said.

Dr Mishra meanwhile urged the people to come in good numbers to donate blood which he claimed can save upto three lives. "A single unit of blood can save lives of three patients. The donated blood is used in treatment of patients of cancer, burn, thalessemia and others. Blood is the only live thing from a human body that can be donated while the

The blood banks in the state

meanwhile claim that they screen the donated blood against diseases like HIV, Hepatitis B and Hepatitis C before administering it to other patients through techniques like NAT-PCR and other robust means.

However, till now the NAT-PCR technique is available only in Capital Hospital, MKCG Medical College (Berhampur), VIMSAR (Burla) and SCB Medical College

Meanwhile there are many patients who regularly need blood transfusions for their survival or better quality of lives like patients of Thalessemia. Experts claim that centres where mandatory NAT-PCR is done for the blood samples are safer than others.

"There are several sets of people like Thalessemia patients who require regular blood transfusions. For them and for others also the receipt of safe blood from centres undertaking mandatory NAT-PCR tests give an added advantage as it can detect fatal infections like HIV in initial stages of infection," said Dr CR Prasad, head of department of transfusion medicine, VIMSAR, Burla.

However owing to the high cost of the machine, several blood banks are still deprived of this or dependent on the NAT-PCR machines setup in different medical colleges.

Woman killed in Odisha sends 29,313 MT crocodile attack O2 to 17 states in 52 days

Kendrapara, June 13: A 55-yearold fisherwoman has died following an attack by a crocodile in close vicinity of Bhitarkanika National Park in Odisha's Kendrapara district.

An estuarine crocodile pounced on the woman while she was fishing in a creek at Vekta village under the jurisdiction of Rajnagar police station Saturday.

The half-eaten body of the woman was retrieved from Patasala river Sunday, officials said.

The incident occurred outside the limits of the national park.

The deceased woman's family will be given Rs 4 lakh ex-gratia under the compensation payment scheme, the Divisional Forest Officer, Rajnagar Mangrove (wildlife) Forest Division, Bikash Chandra Dash said.

According to this year's reptile census, the Bhitarkanika National Park and adjoining Mahanadi deltaic region are home to 1,768 saltwater crocodiles.

Lethal attacks by the reptiles



and consequent retaliatory attacks by people have become a regular feature in this part of the state, forest officials said.

The conflict and consequent loss of human lives are most frequently recorded during the monsoon and winter months, the nesting season of the estuarine crocodiles.

Often, the mishaps occur when the victims intrude into animal habitat, for illegal fishing, poaching, wood collection and honey collection, they said.

The animals, in the wake of depleted food reserves in the river system, stray into nearby rivulets

Cuttack, June 13: In the last 52 days, Odisha has sent 1,577 containers carrying 29,313.583 metric tonne (MT) of medical oxygen to 17 states facing shortage of the lifesaving gas in treating Covid-19 patients, an official said Sunday.

According to ADGP (Law and Order) YK Jethwa, who is also the nodal officer overseeing the logistics for the transportation of oxygen, Odisha Police is leaving no stone unturned to ensure that there is no delay in loading and transportation of oxygen.

As many as 125 containers were dispatched from Angul with 2036.562 MT of medical oxygen and 339 tankers were sent from Dhenkanal with 5647.33MT of the lifesaving gas. While 312 containers carried 6358.494 MT of the gas from Jajpur, 801 tankers have so far left Rourkela with 15271.197 MT of medical grade oxygen.

While Andhra Pradesh has so far received 465 tankers containing 9111.371 MT oxygen, Telangana got 387 tankers with 6894.439 MT



of liquid oxygen. Tamil Nadu, on the other hand, received 239 tankers filled with 4416.418 MT of medical oxygen.

Haryana has received 182 containers filled with 3331.793 MT of oxygen. 41 tankers with 660.051 MT of oxygen have so far been sent to Maharashtra, while 836.711 MT of the lifesaving gas filled in 50 tankers have been dispatched to Chhattisgarh.

As many as 68 tankers have carried 1319.962 MT of oxygen to Uttar Pradesh, while 67 containers with 1182.6 MT of the gas have been sent to Madhya Pradesh. Around 22 tankers with 410.24 MT of oxygen have been sent to Delhi, while four tankers with 107.89 MT of medical grade oxygen have been

sent to Punjab. While Karnataka received 21 tankers with 424.99 MT of oxygen, 3 tankers with 66.14 MT of the lifesaving gas have so far been sent to Bihar: Two tankers carried 25.29 MT of oxygen to Chandigarh, while 21 tankers with 405.068 MT of the gas have been sent to Kerala. West Bengal, on the other hand, received 29.1 MT oxygen filled in a tanker.

Jharkhand and Rajasthan have so far received 52.1 MT and 39.42 MT of oxygen respectively filled in two



"Like many, I also thought that this might be happening due to excessive sweating. So I completely dried up my body and tried the same experiment again but in vain," he added.

The first such case of the body turning magnetic was reported by a senior citizen Arvind Sonar from Shivaji Chowk in Maharashtra's



Nashik district. He said that his body turned magnetic after taking the second dose and made a video of how coins and spoons stuck to his body. A team of doctors from Nashik Municipal Corporation met Sonar and tried to find out the reason.

On being contacted, Bhadrak Works Department executive engineer Manoj Kumar Singh said, "The old bridge was demolished to facilitate construction of a new as well as wider bridge in its place."

Big Calls Small

The plan of the G-7 countries, currently holding a summit in the UK, to donate one billion COVID-19 vaccine doses to poorer countries has been rightly mocked at by former British Prime Minister Gordon Brown as 'passing around the begging bowl.' Various human welfare groups and agencies have likewise dismissed it as too little too late as the world is confronted with a once in a century crisis. Queen Elizabeth II seems to have correctly seized the gravity and magnitude of the crisis, when she reportedly didn't conceal her angst and asked, tongue in cheek, the beaming G-7 leaders posing for group photographs if they were "supposed to be looking as if you're enjoying yourselves." The British Prime Minister Boris Johnson's reply to the Queen in the affirmative may sound confounding, but in a way it sums up the irony of the fight against the pandemic. For, the G-7 heads of states posing for the photographs were without masks and only maintained the stipulated social distance since they had all got their jabs against COVID-19. They had, indeed, reasons to be without fear and hence cheerful, armed as they are with vaccines, while the world would need a stupendous 11 billion doses to end the pandemic!

Vaccination efforts so far are heavily linked with wealth. Rich countries such as the United States, European countries, Israel and Bahrain are far ahead of other countries in this regard. A total of 2.2 billion people against a world population of over 8 billion have been vaccinated worldwide, according to data collected by Johns Hopkins University. As most people need two vaccine doses and possibly booster shots to tackle emerging variants, charity organisation Oxfam called on G-7 leaders to support a waiver on the intellectual property rights behind the vaccines. Of the 2 billion doses under the G-7 plan, 5 million will be given out by the end of September, 25 million by the year-end and the remaining during 2022. So, the supply is not going to be fast enough.

COVID-19 has ripped through the global economy, with more than 17.5 crore infections reported in more than 210 countries and territories since the first cases were identified in China in late 2019. The World Health Organisation (WHO) estimates 11 billion doses will be needed to vaccinate the whole world to a level of 70 per cent, the point at which transmission of the virus could be significantly checked.

The head of the United Nations. Antonio Guterres, has welcomed the G-7 move, but made it clear much more is needed, warning that if people in developing countries are not inoculated quickly, the coronavirus could mutate further and become resistant to the new vaccines. "We need a global vaccination plan. We need to act with logic, with a sense of urgency and with the priorities of a war economy. We are still far from getting that," Guterres warned in a no-nonsense manner.

US President Joe Biden and British Prime Minister Boris Johnson have announced they would donate 500 million and 100 million vaccines, respectively, for the world's poorest nations, while Canada is expected to commit to sharing up to 100 million doses.

While all the G-7 drama along with the Queen's caustic remark are happening in the UK, the rest of the world is simultaneously watching the Chinese theatre. China has said that 'the days when global decisions were dictated by a small group of countries are long gone'. This statement clearly puts China on a path of virtual confrontation with the world's biggest democracies. This is not an unexpected development. China has been at its game of attaining global hegemony for the last few decades. Coronavirus pandemic has forced a new order upon the earth. The virus that originated in a lab in Wuhan, China, has not only wreaked havoc on global health and economy but has also offered China a much higher level of power. The biggest example of Chinese hard power is the inability of all these democracies to respond to the Hong Kong situation. There may have been worldwide demonstrations in support of the second anniversary of the Hong Kong uprising on 12 June 2021 but the G-7 could only voice impotent 'concern' about Hong Kong, Xinjiang, South China Sea and Tibet. That is probably why China could tell the world that these G-7 countries are 'small' and cannot dictate global decisions any longer. Chinese economy and the dictatorial government look like it will not tolerate any interference from democracies of the world. When seen through this prism, the G-7 utterances and offerings to the world may have very serious fallouts on the free world in the days to come.

■ Nine days' wonder

t's odd that the number nine should be so often associated with extremes — we have dressed to the nines, cloud nine and the whole nine vards. The same number turns up in lots of places: the nine Muses. the nine orders of angels, the Nine Worthies, the nine lives of a cat (and a cat o'nine tails), the nine tailors of bell-ringing fame, and so on. There are also the proverbs: "possession is nine points of the law", "a stitch in time saves nine" and the old gardening saw that "parsley seed goes nine times to the devil" before it germinates. The most common suggestion is that the expression derives from the Roman Catholic novena, a form of worship that consists of special prayers or services on nine successive days. But there are so many other expressions that include the same number that the source of the phrase may lie elsewhere. Whatever the thought behind it, as far back as the early fourteenth century scoffers were saying that nine days, or nine nights, was the period of time that some novelty was likely to attract attention before our minds turned to something else. It later developed into our modern idiomatic form and had certainly become fixed like that by the time it was used in a play by Philip Massinger, A New Way to Pay Old Debts, of 1633. There is an earlier example. For a bet, William Kemp (or Kempe), a famous clown of the Elizabethan stage, Morris-danced 130 miles (200 km) from London to Norwich over nine days during February and March 1600. He published his account of it later that year under the title Kemp's Nine Daies Wonder. His play on words suggests that the idiom was already known in that form. There has been nothing shortlived about nine days' wonder.

But remaining in power was paramount for Netanyahu, so he tended to focus more on appeasing his base than serving the national interest. That often - and increasingly-meant pitting groups against one another by appealing to people's tribal instincts. He ruled by incitement, implementing policies that matched his ultranationalistic, anti-Arab rhetoric.

For example, Netanyahu backed the 2018 nation-state law, which effectively establishes Israeli Arabs as second-class citizens. And he embraced the goal of annexation of Palestinian lands - an issue over which Israeli right-wing coalitions have historically wavered effectively taking extreme religious Zionism mainstream.

Netanyahu's successive governments have worked tirelessly to create the conditions for annexation of the occupied West Bank. At times, he seemed to prioritise the fantasy of Judea and Samaria shared by much of his base above Israel itself, pouring billions of dollars into realising it.

And yet, there were times when Netanyahu was not quite the energetic builder of Jewish settlements in the West Bank that his constituency wanted him to be. In 2009, he declared a ten-month freeze on new settlements that then-Secretary of State Hillary Clinton called "unprecedented" (though no restrictions were placed on the thousands of buildings already under construction to expand existing settlements).

In 2014. Netanyahu negotiated a peace framework with Palestinian President Mahmoud Abbas, in which he adopted some unexpectedly reasonable positions. That said, to keep his right-wing base

happy, he refused to restrain construction by Jewish settlers in the West Bank and East Jerusalem. even during the negotiations.

A similar logic lay behind Netanyahu's exorbitant concessions to Israel's Orthodox community, reversing his own previous efforts made as finance minister in the early 2000s to cut their parasitic dependence on state allowances. By contrast, he invested far less in improving the conditions in Israel's poorer periphery; he trusted that his unrelenting attacks on the old liberal "elites" would be enough to maintain the support of voters there.

Netanyahu's history of coalition-building reflects a similar focus on self-preservation. In the past, he has formed governing coalitions with left-leaning and centrist parties. After the last four legislative elections, however, he did not hesitate to govern with Jewish-supremacist factions.

This is not some reflection of a genuine ideological shift. If it was, Netanyahu would not have been willing to strike a coalition deal with Ra'am, an Islamist Partv linked to the Muslim Brotherhood this past March. This is, after all, the same man who warned in 2015 that Israeli Arabs were heading to the polling stations in droves, in order to give his party a boost in a tight race.

Netanyahu will go down in Israeli history as the politician who legitimised the participation of Arab parties in government. Anything to stay in power. This particular thing, however, may well have been Netanyahu's undoing: the coalition that his political opponents have formed would not have been large enough to unseat him without Ra'am.

That is not the only reason the new coalition could not exist without Netanyahu. Its eight ideologically diverse parties - including leftists, centrists, right-wing nationalists, and Arab Islamists are united by one thing: the desire to unseat him. Many are former Netanyahu allies, who were increasingly alienated by his narcissistic, overbearing, and often shameful behaviour. For them. his indictment on three charges of corruption and breach of trust was the last straw.

Netanyahu's penchant for bridge-burning can also be seen in Israel's deteriorating image in the United States, especially among moderates and liberals, including most US Jews. By aligning himself closely with the Republican Party and former President Donald Trump, he turned support for Israel into a hyper-partisan affair.

The recent escalation of violence with the Palestinians seems to have further estranged many Americans. More fundamentally, it was a wake-up call for Netanyahu, who believed he had all but defeated the cause of Palestinian nationalism. This belief was fortified by the recent signing of the Abraham Accords, establishing diplomatic relations

between Israel and four Arab states Netanyahu knew how to leverage regional changes to Israel's benefit. He saw that the Middle East's incumbent Sunni regimes feared popular uprisings akin to the 2011 Arab Spring, as well as the rise of a nuclear (Shia) Iran. This, together with the recognition that the US is losing interest in the region, created a golden opportunity for Israel to normalise relations with them - ostensibly weakening the Palestinians' diplomatic support significantly.

And yet, as the recent violence shows, Israel's Palestinian problem is as acute as ever, and Jerusalem remains a flashpoint that could well trigger a religious war in the Middle East. Netanyahu's counterproductive fight against the 2015 Iran nuclear deal and his consequent failure to stem Iran's nuclear ambitions and regional designs only exacerbate the risk of a regional flare-up.

Beyond the Abraham Accords, Netanyahu oversaw two other major strategic developments. First, building on Israel's new status as a gas-producing power in the Eastern Mediterranean, he established a tripartite strategic alliance with Greece and Cyprus, as a counterweight to Turkey's destabilising aspirations. Second, he expanded Israel's economic links with China, Japan, and India.

Yet Netanyahu's economic legacy also leaves much to be desired. Under his strict neoliberal policies, the welfare system was hit hard, and Israel consolidated its position as one of the OECD's most unequal countries, with 21 per cent of the population living below the poverty line.

Ultimately, Netanyahu's legacy is one of tension, loathing, and chaos. Israel is now more divided than it has ever been, and Israelis have largely lost hope that their country can be both Jewish and democratic. Can a government united only by its aversion to Netanyahu push back against this

n a WhatsApp message, a wife tells her half-asleep husband, "Wake up, there is news, lockdown has been lifted from today. Get ready for the job." The drowsy husband slowly leaves the bed, and picks up the broom to clean the house. "Appears, you didn't hear me correctly. I repeat, lockdown is over. Get dressed for your office." Full-blown factional war raging in Rajasthan's two main parties

As the raging factional feuds hit both the Congress and the BJP, questions are being asked if the state can see any kingmaker in the coming polls, bringing in new political equations

Jaipur, June 13: There is a full blown factional war raging in the Rajasthan Congress and the BJP these days with the veterans in both parties showing reluctance in handing over power and positions to their juniors.

While Congress Chief Minister Ashok Gehlot has been delaying since months the much-awaited political appointments and cabinet expansion to accommodate young leaders like former deputy Chief Minister Sachin Pilot, former Chief Minister Vasundhara Raje is also refusing to give in to the BJP's new state leadership. She is running her parallel programmes to keep her hold intact on the state, which she has ruled twice.

Looking at the full blown confrontation between the old guard and the younger lot, there are fair chances of a third party emerging which might dent the two-party system which the state has seen since decades

It has just been the Congress and the BJP ruling the state where $\,$ power keeps shifting from one to the other every five years

However, these days, looking at Raje launching her own campaigns such as the 'Vasundhara Jan Rasoi' and the Office of Raje Twitter handle, there are open discussions if she will contest individually in the coming elections. Recently, her posters have been removed from the state party headquarters.

Sources said that her teams are active on social media under the banner Team Vasundhara 2023 in

Pilot has openly accused the AICC team of ignoring the promises made to him and his team after a patch up with the party and returning to its fold, post rebellion last year.

Pilot's strength is his stronghold on the eastern belt of the state where the BJP lags behind due to the absence of any strong leader from the region. Hence, his dominance in this region makes him pivotal and he can be a kingmaker if he decides to go for a divorce with the ruling party.

However, he has already denied plans of joining the BJP. Friday, when senior BJP party worker Rita Bahuguna said that she has extended an open invitation to Pilot, the latter said that she might have spoken to Sachin Tendulkar and not to him, quashing the speculation about his joining the saffron party.

Meanwhile, BJP leaders said that what is going on is just eyewash and more things shall unfold in coming days.

Next in the fray is another Jat leader Hanuman Beniwal, convenor of RLD and Nagaur MP, who has broken his ties with alliance partner NDA over the farm laws issue and fielded three candidates in the recent by-polls for the Rajsamand, Sahada and Sujangarh seats, thereby hurting the prospects of both BJP and Congress.

If he decides to field his own candidates in the next Assembly polls he might win over the Jat voters, hurting both the Congress and the BJP in the state.

UP BJP works to strengthen its social arithmetic

Saffron party joining hands with smaller parties with a political base in different castes

New Delhi, June 13: Joining hands with smaller parties with a political base in different castes was a part of the BJP strategy as it won big in Uttar Pradesh in the 2017 Assembly polls and 2019 Lok Sabha polls. The saffron party is again working to stitch up a strong social alliance as it prepares for the state elections slated for early next vear.

With senior party leader and Union minister Amit Shah reaching out to the leaders of Apna Dal (S) and Nishad Party, both BJP allies but disaffected over the issue of their representation in the government, and Congress leader Jitin Prasada joining the saffron party, the ruling party seems to be taking measures to get its arithmetic right

Prasada hails from a noted Brahmin family of the state that had remained in the Congress for three generations, and the BJP believes that the young leader's defection to its ranks will help it contain any dissatisfaction a section of the politically influential community might have with Chief Minister Yogi Adityanath-led government.

While Anupriya Patel of Apna Dal has not spoken on her meeting with Shah, Sanjay Nishad of Nishad Party made it clear that his party wants representation in the state government to "fulfil" the aspira-

tions of the marginalised communities it draws its support from.

"Political power is stronger than God's power," he told PTI to emphasise its importance to address myriad issues facing different deprived communities.

He also reiterated his demand for giving the community of boatmen. who come under various castes and subcastes, benefits under the scheduled castes and not under the category of Other Backward Communities as being given currently in UP.

In a message to the BJP, he said the community has in the past supported parties like the BSP, SP and the Congress but stopped voting for them after they did not address their concerns

"We understand the Modi government has been busy with important national issues," he said, referring to Article 370 revocation. 'Now we believe our concerns will be addressed." he said.

His son Praveen Kumar Nishad's victory as Samajwadi Party candidate from Adityanath's pocket borough of Gorakhpur had shocked the BJP, which then worked to woo him over to its camp during the 2019 Lok Sabha polls.

Patel was a minister in the first Modi government but her party's reported talks with the Congress during the 2019 Lok Sabha elections even as it finally fought as a

leader being kept out of its sec-

ond innings. There have been reports that the BJP may also bring its former ally Suheldev Bhartiya Samaj Party to its fold again but its leader Om Prakash Rajbhar has ruled out

such a possibility.

BJP sources said their party has always worked to give due representation to various communities and noted that it has never been averse to tying up with smaller parties.

'We have done it in various states, be it Bihar, Assam or Uttar Pradesh," a leader said.

Samajwadi Party leader Akhilesh Yadav has also been working to broaden his party's social appeal by bringing leaders from outside its core constituency.

With the Yogi government's handling of the recent COVID-19 crisis drawing questions from even state BJP leaders, with several of them writing letters to highlight

leadership has been taking measures to address organisational and governance challenges.

There has been strong speculation that Adityanath may go for an expansion of his Cabinet, and Shah's meetings with allies are being seen as part of the exercise.

The BJP has a lot at stake in the next round of assembly elections in five states early next year as it is in power in four of them, including Uttarakhand, Goa and Manipur besides the all-important Uttar Pradesh.

The party's performance in the latest round of five assembly polls was seen by many as below-par despite its victory in Assam and has emboldened the opposition after the Trinamool Congress handed it a heavy defeat in West Bengal while its seat tally in Kerala fell to zero. Its top brass is likely to pull out all the stops to score a win in the next phase of elections, espe-

Phone tapping issue resurfaces

Jaipur, June 13: Phone tapping charges have come back to haunt the Chief Minister Ashok Gehlot led government in Rajasthan, with Congress MLA Ved Prakash Solanki alleging that some legislators have talked about their phones being

Without naming any MLA who levelled the phone tapping charge, Solanki. a staunch supporter of Congress leader Sachin Pilot, said the legislators also fear of being trapped by various agencies.

"I do not know if my phone is being tapped or not. Some legislators have told me that their phones are being tapped. I am also not aware if the state government is involved in phone tapping. Many officials told them (legislators) that it seems that there are efforts underway to trap them," Solanki, a legislator from Chaksu assembly constituency, told reporters Saturday.

"Some of these MLAs have also informed the chief minister of the matter," he said.

Solanki said he does not know whether the MLAs have technical knowledge or there is some App through which they come to know that their phones are being tapped.

Radhe Shyam, the temple priest, said, "We have earlier heard the name of 'Chechak Mata' (smallpox mother) who cured the disease. Similarly, we had set up 'Corona Mata' mandir with the belief that Mata would solve all the difficulties. We collected funds from the villagers.

He said, however, this was not the first time such a temple has come up in the country. "When plague and other deadly diseases like smallpox spread across villages and towns and killed many people years back, people also worshipped in a similar manner.'

Villagers claimed that devotees were not allowed to touch the idol and offered only yellow flowers to the goddess.

Ram temple trust accused of land scam

Lucknow/Ayodhya, June 13: Shriram Janmabhoomi Teerth Kshetra Trust general secretary Champat Rai was Sunday accused by two Opposition leaders of buying a piece of land worth ₹2 crore at an inflated price of ₹18.5 crore for the Ram temple premises with help from Trust's member Anil Mishra.

The allegation, strongly refuted by Rai, was made by AAP's Rajya Sabha member Sanjay Singh and a former minister in the Samajwadi government, Pawan Pandey.

Terming it a case of money laundering, Singh and Pandey both sought a probe by the Central Bureau of Investigation and the Enforcement Directorate into the land purchase for the temple

Both the leaders alleged that Rai purchased the land, measuring 1.208 hectares and located in Bag Bjaisi village under Sadar tehsil of Avodhva district for a price of ₹18.50 crore from the first purchaser, who had bought it minutes earlier on March 18 this year from its original owners for a sum of ₹2 crores

"Champat Rai, the general secretary of Shriram Janmabhoomi Teerth Kshetra Trust with the help of Trust's member Anil Mishra bought the land worth ₹2 crore at ₹18.5 crore. This is a case of money laundering and the government should get it probed by the ED and



CBI," Singh told reporters

in Lucknow SP's former Ayodhya MLA Pandey reiterated the same allegation in the temple town.

Quoting entries of the registered sale deed of the land. Singh explained that the land was first purchased by Sultan Ansari March 18 this year from its original owner Kusum Pathak, wife of Harish Kumar Pathak alias Baba Hardas for a sum of ₹2 crore.

Minutes later, the same land was purchased by Trust's general secretary Rai for a sum of ₹18.50 crore from Ansari, Singh said, again quoting entries of the second sale deed showing the transaction between Ansari and Rai

Trust member Anil Mishra and Ayodhya mayor Hrishikesh Upadhyay testified the land sale deed as witnesses and were witnesses to the purchase of the land by Rai as the Trust's general secretary, Singh alleged.

"Prime Minister Narendra Modi and his government must initiate a thorough probe by the CBI and ED, and the corrupt persons should be sent to jail, as it is the question of faith of crore devotees of Lord Ram, who have given their hardearned money for the construction of the Ram temple, Singh said.





Congress: Kapil Sibal

New Delhi, June 13: The Congress must bring widespread reforms across all levels of the organisation to show it is no longer in a state of inertia and to present itself as a viable political alternative to the BJP, party veteran Kapil Sibal said Sunday.

"India needs a resurgent Congress. But for that, the party needs to show that it is active, present, aware and is in the mood to engage meaningfully," the former union minister said in an exclusive interview to PTI. "For this to happen, we will need to have widespread reforms at the organisational hierarchy both at the central and state levels to show that the party is still a force to reckon with and is no longer in a state of inertia." he said. New Delhi, June 13: Delhi and Tamil Nadu permitted more activities from Monday as the easing of restrictions by states gained momentum following a continuous decline in active Covid-19 cases in the country where most parts were under a lockdown or similar curbs for over a month.

Karnataka will also begin the unlock process, barring in 11 districts, from Monday, with the opening of parks and industrial units with riders, besides other re-

laxations. Restaurants with 50 percent capacity, weekly markets and religious places will reopen in the national capital from June 14, Delhi Chief Minister Arvind Kejriwal announced Sunday, saying the COVID-19 situation has significantly come under control in the city.

Salons, beauty parlours and barbershops closed since the imposition of lockdown on April 19, will reopen. Markets and malls, which were earlier allowed to reopen on an odd-even basis, will now open on all days, from 10 AM to 8 PM.

Only one weekly market per municipal zone per day will be allowed, he said. Schools, colleges, educational and coaching insti-

tutes, cinema halls, multiplexes, theatres, gyms, spas, yoga institutes, swimming pools, auditoriums, banquet halls, amusement and water parks, and public parks and gardens, will continue to be closed till 5 AM on June 21, according to the Delhi Disaster Management Authority (DDMA) order issued on Sunday.

Guj: Over 24K abortion kits seized

Ahmedabad, June 13: The Food and Drugs Control Administration (FDCA) in Gujarat has seized 24,363 pregnancy termination kits worth over Rs 1.5 crore along with narcotic and psychotropic drugs that were being sold illegally, and eight persons have been arrested in this

connection, officials said Sunday. The accused were apprehended by the FDCA from multiple locations in the state, including Ahmedabad and Surat, as part of an operation carried out Friday and Saturday, they said.

While seven accused have been charged under the Drugs and Cosmetics Act, another one has been arrested by the Gujarat police

under the Narcotic Drugs and Psychotropic Substances (NDPS) Act after drugs, including three lakh vials of oxytocin, were found in his possession, FDCA Commissioner Hemant Koshia

He said that such abortion kits could be sold only on the prescription of gynaecologists as per the provisions of the Medical Termination of Pregnancy Act. Ahmedabad-based Pintu Shah, one of the accused, was procuring pregnancy termination kits illegally from accused Vinod Maheshwari and Lokesh Maheshwari, owners of a distributing unit in Banaskantha's Deesa, and selling them online without prescription. Shah had

sold around 800 such kits through an online platform in the last oneand-half years, the FDCA said in

release. Deesa-based Maheshwaris had got the kits on the basis of forged medical prescriptions from Javeri Sangala of Surat, who had procured them from accused Rajesh Yadav, a Gujarat region sales manager of a Mumbai-based marketing company. Among the other accused are Nilay Vora, a marketing representative of Mumbai-based firm. Vipul Patel and Monish Panchal, with whom 700 kits were found, the

release said. One of the accused, Tushar Thakkar, was found with narcotic and psychotropic drugs and has been handed over to the police.

Mumbai, June 13: A video of a car disappearing into a pool of water in a Mumbai housing complex after the spot where it was parked caved in went viral on social media Responding to the viral video, the BrihanMumbai Municipal Corporation (BMC) said the spot where the car sank used to be a well but was partially covered with cement concrete by the housing so-

ciety. The incident took place at the Ram Nivas society located at Kama lane in Ghatkopar West area on Sunday morning, police said, adding no one was injured. "The housing society had covered a well with reinforced concrete cement and residents were using the area to park their cars. A police team reached the spot and brought the car out of the water body. The spot has been cordoned for the safety of residents," an official said. Some years ago, the housing society had closed half the portion of the well by carrying out RCC work and used the spot to park the vehicles. However, due to rains, the portion caved in, and the vehicle drowned, he said. The BMC refused to take responsibility for the incident which followed a spell of heavy rains in the city. In a statement, the Shiv Sena-controlled municipal corporation stated it has nothing to do with the incident. The municipal corporation said, "There is a well in the premises of this society. It was covered by RCC on half the portion.

The residents of the society used to park their cars in that area. Preliminary information shows that a car parked on the spot was submerged." The society has been asked to take necessary safety measures immediately, the



India begins 'Extension of Hosps'

New Delhi, June 13: To plug a major health infrastructure gap in India's fight against Covid-19, especially in rural areas and smaller towns, India has started project 'Extension of Hospitals' in vari-

Modular hospitals are an extension of hospital infrastructure and can be built adjacent to an existing hospital building.

As Covid-19 cases surged in different parts of the country, infrastructure in hospitals was under immense pressure. Keeping in view of the need, innovative modular hospitals came as a huge relief amidst the crisis. Project 'Extension Hospitals' is one such initiative for which Office of the Principal Scientific Adviser (PSA) invited private sector companies, donor organizations, and individuals to support the initiative along with various other projects of national importance. The PSA office identified requirements of close to 50 hospitals in states where the high-



est number of Covid-19 cases were reported. Modulus Housing, a startup incubated at Indian Institute of Technology, Madras (IIT-M) developed the MediCAB hospitals. This enables building a 100-bedded extension facility in 3-weeks' time. MediCAB hospitals are designed with a dedicated zone of Intensive Care Units (ICUs) that can accommodate various life-support equipment and medical devices. These negative pressure

portable hospitals have durability of around 25 years, and they can also be shifted in the future for any disaster response in less than a week. These rapidly deployable hospitals will plug a major health infrastructure gap in India's fight against Covid-19, especially in rural areas and smaller towns. The office of PSA has been actively working towards securing Corporate Social Responsibility (CSR) support to implement these projects in different areas across the nation.

Modulus Housing has started deploying MediCAB extension hospitals with the help of the American Indian Foundation (AIF). Mastercard, Texas Instruments, Zscaler, PNB Housing, Goldman Sachs, Lenovo, and NASSCOM Foundation have also extended CSR support. The first batch of 100 bedded hospitals is being commissioned at Bilaspur (Chhattisgarh); Amravati, Pune, and Jalna (Maharastra); Mohali (Punjab), and a 20-bed hospital at Raipur (Chhattisgarh). Bengaluru (Karnataka) will have one each of 20, 50, and 100-beds in the first phase. The Office of PSA has also collaborated with Tata Projects Ltd to deploy modular hospitals at multiple sites in Punjab and Chhattisgarh. They have initiated work on 48 bedded modular hospitals in Gurdaspur and Faridkot (Punjab). Expansion of ICU at multiple hospitals in Chhattisgarh including Raipur, Jashpur, Bemetara, Kanker, and Gaurella is also underway.

The active cases further declined to 10,26,159 comprising 3.49 per cent of the total infections, while the national Covid-19 recovery rate has improved to 95.26 per cent. A net decline of 54,531 cases has been recorded in the Covid-19 caseload in a span of 24 hours. Also 19,20,477 tests were conducted Saturday taking the total cumulative tests conducted in the country to 37,62,32,162.

Leopard triggers panic in Srinagar

Srinagar, June 13: Panic gripped the densely populated Natipora area in Srinagar Sunday after a leopard was sighted.

Two weeks ago, a minor girl was mauled by a leopard in the Humhama area after which the animal was declared as a man-eater and professional hunters were employed to eliminate it. A team of the wildlife department was deputed to Natipora area earlier in the day to locate the animal and catch it before it caused any casualty.

'The animal was spotted around 10 p.m. yesterday and we informed the local police station immediately," a resident of the area said.

People have been advised not to move out unnecessarily till the animal is caught and restored to its natural habitat. Locals are making announcements about the presence of the leopard through mosque loudspeakers.

Kashmir wildlife warden, Rashid Nagash said: "Our teams are on the ground in the area. We are trying to establish the presence of the animal in the area through direct or indirect evidence." "So far, we have not been able to establish the presence of the animal in the area.'

India handed over 577 intruders to B'desh since 2018

The locals made video clips of the incident, which occurred in Kahalgaon block under Bhagalpur. Mithilesh Kumar died due to snake bite in his native village Nawada Bazar in Banka district. His family members took his body to the Barari Ghat in Bhagalpur but the Dom Raja of the Ghat demanded Rs 1 lakh to allow them to dump it in the Ganga.

In Bihar, there is a tradition that the last rites of someone who died of snake bite are doing by putting the body into the Ganga, along with a banana tree trunk.

The family members negotiated with Dom Raja and the latter agreed to Rs 11,000 but as they did not even have that money, they took the dead body to Kahalgaon, some 50 km away from Bhagalpur city. They negotiated with the Dom Raja of Kahalgaon Ghat for Rs 1,500, and also contacted a boat owner, and set a deal for Rs 2.500. Then they took the dead body to the middle of Ganga, tied it to a banana tree trunk and dumped it in the river.

Local residents claimed that the District Magistrate had deployed a judicial magistrate at every cremation ground when the corona infection was at peak but these were withdrawn from June 1. Contacted for comments, R.P. Sharma, a duty officer of Kahalgaon police station, said: "We have received a complaint pertaining to this case and we are trying to contact the deceased's family.'

During the severe second wave of corona, people in several districts such as Buxar, Bhojpur, Patna, and Bhagalpur dumped a large number of dead bodies into the Ganga.

Japanese airline starts crew vaccination drive

Tokyo, June 13: Japanese airline All Nippon Airways has begun vaccinating its pilots and cabin attendants on international flights. That makes it one of the first companies to launch workplace vaccinations in Japan, one of the world's least-vaccinated nations.

Japan is desperately pushing to accelerate the pace of inoculations before the Tokyo Olympics start in about 40 days.

Following criticism over the slow pace of the vaccine rollout, the government recently unveiled workplace inoculation programs by major companies to supplement efforts led by municipalities around the country.

On Sunday, 50 ANA pilots and flight attendants dressed in their uniforms got their first shot of the Moderna vaccine at a company inoculation site at Tokyo's Haneda airport.



Israel to swear in new

But he has defended the possible move as a way to bring Catalans and Spaniards closer together after the divisive convictions that put most of the Catalan leaders behind bars.

The prime minister is also facing criticism in his own Socialist camp, where the move is seen as a risky political gamble.

While more than 60% of Spaniards oppose the pardons and only 29.5% back them, according to a recent poll.

Swiss narrowly reject tax hike to fight climate change

Geneva, June 13: Exit polls Sunday indicated that Swiss voters appear to have narrowly rejected a proposed "carbon dioxide law" that would have hiked fees and taxes on fuels that produce greenhouse gases

The Alpine country has been experiencing an outsized impact from climate change. Switzerland has faced a rise in temperatures that is twice as fast as the global average, the government says.

Greenhouse gases — notably carbon dioxide — are seen as the primary culprit.

The proposal would have revised and strengthened an existing law that was aimed at reducing CO2 emissions by 2030

It would have enacted new taxes on CO2-generating fuel and natural gas, as well as on airline tickets. The proposal was rejected by 51 per cent of the vote, Swiss public broadcaster SRF reported.

Mumbai: The country's total merchandise exports are projected to grow 70.1% to \$87.2 billion in the first quarter of fiscal 2021-22 from \$51.3 billion in the year, Export-Import Bank of India (India Exim Bank) said. The non-oil exports may jump 68.5% to \$78.26 billion in the April-June period as compared with \$46.4 billion in the corresponding period of fiscal 2020-21, it said.

The FPO is being launched to meet the SEBI norm of minimum public shareholding of 25 per cent in a listed entity. Ruchi Sova filed the draft red herring prospectus (DRHP) with market regulator SEBI on Saturday, sources said, adding that the company plans to raise up to Rs 4.300 crore through the share sale.

Exchanges to suspend trading

New Delhi: Leading exchanges BSE and NSE will suspend trading in the shares of Dewan Housing Finance Corporation Ltd (DHFL) with effect from Monday. The move, aimed at avoiding "market complications", comes against the backdrop of the National Company Law Tribunal (NCLT) approving Piramal Group's resolution plan for the bankrupt-DHFL. The resolution plan under the Insolvency and Bankruptcy Code (IBC) was approved by the tribunal June 7.

Amway plans to invest ₹170Cr

New Delhi: Direct selling FMCG firm Amway India plans to invest Rs 170 crore in the next 2-3 years in the country to boost research and development (R&D), manufacturing automation and innovation. The company also plans to strengthen its nutrition portfolio, which accounts for over 60 per cent of its revenue, by exploring adjacent and expanded spaces around the nutrition segment. "Amway has earmarked an investment of Rs 170 crore for the next 2-3 years in India," Amway India CEO Anshu Budhraja said.

'Int'l prices to help steelmakers tide over 2nd wave'

New Delhi, June 13: Supportive international prices are expected to help domestic steelmakers tide over the second Covid wave, ratings agency ICRA said.

Besides, ICRA expects domestic demand to recover in the coming months with the gradual lifting of lockdowns and mobility restrictions in India during June 2021 and improving vaccination coverage. This trend in turn will result in a pick-up in capacity utilisation levels, the agency said.

"Domestic steel prices are currently trading at a significant discount to the landed cost of export



"The prices of food articles have risen by nearly 5 per cent in April. Primary commodities saw a rise of 10.16% and manufactured products have risen by 9.01 per cent. By the time these commodities reach the retail markets, the consumers are charged much more.

"This is happening while the economy is witnessing a deep re-

cession. galloping unemployment collapsing purchasing power and rising levels of hunger. Clearly, unscrupulous black-marketing and hoarding is taking place under state patronage. The Modi government must strictly crackdown on such black-marketing especially of essential drugs, vital for people's survival," the statement said.

Income inequalities telling story of 'uneven' eco recovery

New Delhi, June 13: Former RBI Governor D Subbarao has expressed concerns over "extreme unevenness" in economic recovery and "sharpening inequalities" between upper income segments and lower income households in the country, cautioning that the trend will hit growth prospects going forward.

Terming the uneven recovery "morally wrong and politically corrosive", he said liquidity in the domestic market and foreign fund inflows are leading to soaring of prices of stocks and other assets despite disruptions due to Covid

The ex-central bank governor further said that earlier expectations of a sharp economic recovery this year have been dashed by the new pandemic wave.

Copenhagen, June 13: Christian Eriksen remained in stable condition in a hospital here Sunday. He also 'sent his greetings to his teammates' as he recovers from his collapse during a European Championship game, the Danish football federation said.

The rest of the Danish team were given crisis management assistance as they process the incident that happened during Saturday's game against Finland here. Eriksen fell face-forward to the ground late in the first half and needed CPR from medical staff before regaining consciousness.

'This (Sunday) morning we have spoken to Christian Eriksen, who has sent his greetings to his teammates," the Danish federation wrote on Twitter: "His condition is stable, and he continues to be hospitalised for further examination. The team and staff of the national team have received crisis assistance and will continue to be there for each other after yesterday's (Saturday) incident," it added.

For the record, Finland won the $\,$ game 1-0. Joel Pohjanpalo scored the winning goal and Lukas Hradecky saved a penalty to give Finland a memorable win.

Eriksen was playing in his 66th competitive game in exactly one year since soccer restarted after a shutdown caused by the coronavirus pandemic.

His collapse came hours after the soccer players' union, FIFPRO repeated long-standing fears about pressure on its members in a congested season.

St Petersburg (Russia), June 13: Belgium striker Romelu Lukaku sent a message of support Saturday to his stricken Inter Milan teammate Christian Eriksen after scoring twice to help the Red Devils open their Euro 2020 campaign with a 3-0 win over Russia here. Lukaku gave Belgium an early lead, then shouted "Chris, Chris, stay strong – I love you" into a pitchside camera during the celebration for his opening goal.

"I am really happy with the win, but it was hard for me to play because my thoughts were with Christian Erkisen," said Lukaku, who revealed he cried tears of concern before kick-off for his Inter teammate.

Belgium coach Roberto Martinez also admitted other members of his squad were also affected after seeing Eriksen suddenly slump to the turf during the Denmark-Finland game.

"We were watching the game live and five minutes after Christian collapsed, we went into a team meeting. As you can imagine, the last thing we wanted to do was talk about football," said Martinez. "There were a lot of tears from players who have shared dressing rooms and big moments with

Christian," he added. Substitute Thomas Meunier doubled Belgium's lead on 34 minutes before Lukaku put the result beyond doubt with a late second goal.

Belgium, the world's top-ranked team, are under pressure to deliver at the European Championship as some pundits claim this is Martinez's last chance to win a title with an ageing squad.



Paris, June 13: Grand Slam No 19 was not easy to say the least. But then for 'super human' Novak Diokovic as many commentators described him, climbing new peaks is just another natural event. In an epic French Open men's final played Sunday, Djokovic after being two sets to love down, came back to win a thriller in a match that lasted fours and 12 minutes. Djokovic in the end prevailed 6-7 (6-8), 2-6, 6-3, 6-2, 6-4 over Greek Stefanos Tsitsipas.

It was a match that none deserved to lose, but in the end there had to be one winner. The 34-year-old Djokovic eliminated 13-time French Open champion Nadal in a semifinal that lasted more than four hours Friday night. That might be why the 22year-old Tsitsipas had the upper hand early, and Djokovic looked drained for two sets.

Eventually, he started making fewer mistakes, got his best-in-thegame returning on track, served almost flawlessly down the stretch and was able to complete his sixth career comeback from two sets down and second of the past week.

and Stan McCabe (Australia). Considered one of India's greatest-ever all-rounders, Mankad played 44 Tests, scored 2,109 runs at 31.47, took 162 wickets at 32.32. He was an opening batsman and slow left-arm orthodox bowler.
