Sunak, Javid resign

LONDON: UK finance minister Rishi Sunak and health secretary Sajid Javid submitted their resignations Tuesday, as dissent continues to mount against Prime Minister Boris Johnson. "I recognise this may be my last ministerial job, but I believe these standards are worth fighting for and that is why I am resigning," Sunak said. Javid, while sharing his resignation letter on Twitter, said he 'can no longer continue in good conscience'. The resignations were announced amid Johnson being forced into a humiliating apology over his handling of the Chris Pincher row, as it emerged that he had forgotten about being told of the past allegations of 'inappropriate' conduct.

### Rupee plunges to all-time low

MUMBAI: The rupee fell by 41 paise to close at a fresh lifetime low of 79.36 (provisional) against the US dollar Tuesday amid a strong greenback overseas and unrelenting foreign fund outflows. At the interbank forex market, the local unit opened at 79.04 against the greenback and witnessed an intraday high of 79.02 and a low of 79.38. It finally settled at 79.36 (provisional), down 41 paise over its previous close. "Rupee is expected to trade on a negative note on a firm tone in the US dollar and elevated oil prices, said financial analyst Anuj Choudhary. MORE P11

When her family failed to contact her over the phone Monday evening and night, they got in touch with the landlord Tuesday. He went and knocked on Senapati's room a number of times, but did not get Contd...P4 any response.

The girl's father has lodged a complaint at the Capital police station in this regard. In it he has blamed the superintendent of the hostel where Subhasini was staying.

## 784 jumbo deaths in 10 yrs

Keeping in mind the high number of elephant deaths in the last decade, the government is taking proactive measures to ensure the safety of the animals

Bhubaneswar, July 5: A total of 784 elephants have died in the state during the last 10 years, Forest, Environment and Climate Change Minister Pradip Kumar Amat informed Tuesday the Assembly.

Replying to a question of Congress MLA Tara Prasad Bahinipati, Amat said 36 jumbos died in accidents while 34 were killed by poachers and others from 2012-13 to 2021-22. Out of 36 accidental deaths, 30 died in train accidents, six in road mishaps, Amat said.

Out of the total elephant deaths in the last decade, at least 245 jumbos died from 2019-20 to 2021-22, as per another written reply submitted by the Minister in the House.

While 82 elephants died in the year 2019-20, the toll decreased to 77 (2020-21). Then in 2021-22, a total of 86 pachyderms died. The highest among these jumbo deaths were reported in the Dhenkanal forest division (35), followed by Keonjhar di-

vision with 21 and Angul (12). In the last three years, Deogarh and Athamallik forest divisions have reported 11 elephant deaths each whereas 10 each have been



reported from Balasore wildlife, Kalahandi (south) and Khurda divisions.

However, in the reply, Amat also said that despite the high number of deaths, the elephant population has increased to 1,976 in 2017 from 1,827 detected during the census conducted in 1999.

The minister also talked about various steps taken by the state government for the conservation and protection of wild elephants. He said the government has formed three elephant conservation projects at Mayurbhanj, Sambalpur and Mahanadi to check the deaths

### BJD MLA slams minister

Bhubaneswar, July 5: In what can be termed as an unexpected development, BJD MLA from Anandpur, Bhagirathi Sethi criticised Odisha Health Minister Naba Kishore Das over the impoverished condition of health affairs in Keonjhar district. Sethi lamented that despite pointing this out to the health minister on a number of occasions, the situation has not improved.

Sethi informed that the Keonjhar district headquarters hospital lacks staff in many departments. He informed that health centres in Keonjhar do not have doctors and even pharmacists. The situation has reached such a state that now peons are administering health checkup to patients, the MLA informed.

He also rued the fact that Anandpur

does not have a hospital of good quality. Hence people in need of basic health problems are compelled to travel more than 100 kilometres to Cuttack. "MLA Badri Patra and I have

often attracted Naba Das's attention regarding the non-development of health infra. Despite repeated appeals to the health minister, the situation has not improved. I feel talking to Das is similar to slapping yourself," Sethi stated. He also demanded that a super-specialty hospital be set up at Keonjhar as it is the need of the hour.

BJD MLA Raj Kishore Das tried to downplay the allegations and said concerns raised by Sethi will be looked into properly. "There indeed is a shortage of doctors in Odisha. The government is taking all necessary steps to resolve the situation," Raj Kishore said.






Radhika calls out actors for their double standards





## Job racket: Lookout circular against two


Bhubaneswar, July 5: The Bureau of Immigration has issued a lookout circular against two persons accused of running a fake job racket and are suspected to have fled to Malaysia after non-bailable warrants were issued in their names, an official said Tuesday.

The lookout circular was issued in the names of Bhiku Bisoi and Manikandan, who are directors of Kinney Infotech Private Limited, for duping jobseekers of more than Rs 1 crore, an official said.

The circular was issued after requests by the Economic Offences Wing (EOW) of Odisha Police. The EOW has already registered a case against the company and its directors April 27, 2022 under Sections of the IPC and IT Act, 2000.

Lookout circular is generally issued to alert immigration check posts at airports and seaports to alert law enforcement agency if a wanted person tries to leave the country or arrive in the country from abroad.

The case was registered by taking over the investigation by Bhanjanagar police in Ganjam district into allegations of collecting huge amounts of money from a large number of job seekers allegedly by Kinney Infotech Pvt Ltd through its office bearers for providing them jobs, the EOW said

## Explained: How soil pollution raises heart disease risk


esticides and heavy metals in soil may have detrimental effects on the cardiovascular system, according to a study. Pollution of air, water and soil is responsible for at least nine million deaths each year. More than 60 per cent of pollution-related disease and death is due to cardiovascular disease such as chronic ischaemic heart disease, heart attack, stroke and heart rhythm disorders (arrhythmias).

"Soil contamination is a less visible danger to human health than dirty air," said author Professor Thomas Munzel of the University Medical Center Mainz (Germany).

"But evidence is mounting that pollutants in soil may damage cardiovascular health through a number of mechanisms including inflammation and disrupting the body's natural clock."

In the paper, published in Cardiovascular Research, the team states that contaminated soil may lead to cardiovascular disease by increasing oxidative stress in the blood vessels (with more 'bad' free radicals and fewer 'good' antioxidants), by causing inflammation, and by disturbing the body clock (circadian rhythm).

Dirty soil may enter the body by inhaling desert dust, fertiliser crystals, or plastic particles. Heavy



metals such as cadmium and lead, plastics, and organic toxicants (for example in pesticides) can also be consumed orally. Soil pollutants wash into rivers and create dirty water which may be consumed.

Pesticides have been linked with an elevated risk of cardiovascular disease. While employees in the agricultural and chemical industries face the greatest exposure, the general public may in-

gest pesticides from contaminated food, soil and water. Cadmium is a heavy metal that

occurs naturally in small amounts in air, water, soil and food, and also comes from industrial and agricultural sources. Food is the main source of cadmium in non-smokers.

Lead is a naturally occurring toxic metal with environmental contamination through mining, smelting, manufacturing and recycling. Exposure to arsenic, a naturally occurring metalloid, is linked to higher risk of death from cardiovascular disease. Levels of arsenic can increase due to industrial processes and using contaminated water to ir-

rigate crops. The potential hazards of con-

taminated airborne dust are also noted in the study. Desert dust can travel long distances, and research has shown that particles from soil in China and Mongolia were related to an increased odds of heart attacks in Japan.

While there are no population studies on the cardiovascular health effects of nano- and microplastics in humans, research has shown that these particles can reach the bloodstream, making it plausible that they could travel to the organs and cause systemic inflammation and cardiometabolic disease, the team said.

The toll remained unchanged at 9,126 as there were no fresh fatalities in the last 24 hours. Fiftythree other Covid patients have died in state due to comorbidities so far, it added.

In a business-as-usual scenario, coastal and marine tourism is expected to represent the largest ocean economy sector by 2030 (measured by GDP) and employ approximately 8.5 million people, second only to small-scale fisheries in terms of employment.

"(However), the health and beauty of these ecosystems, the very thing that draws people to coastal and marine destinations, continue to be threatened by tourism itself," pointed out the re-



port titled 'Opportunities for transforming coastal and marine tourism: Towards sustainability,

regeneration and resilience'. Coastal and marine tourism is highly dependent on the quality of coastal and marine ecosystems to attract visitors, but the continued depletion and degradation of these natural assets is putting the sustainability and viability of the industry, along with the local communities that rely on it, at risk, said the report released coinciding with the UN Ocean Conference with more than 150 countries collectively agreeing to scale up science-based and innovative actions to address the ocean emergency.

Pointing out that the current model of coastal and marine tourism is inherently unsustainable, characterised by high levels of economic leakage, seasonality and vulnerability to natural and economic shocks, the authors of the report said, "Mass tourism in and around coastal cities leads to higher costs of living and relatively lower purchasing power for many locals.

"This situation is exacerbated by the seasonal nature of coastal and marine tourism, in particular in islands, contributing to job insecurity, low wages and high workload, affecting the wellbeing of locals and their access to resources."

The report also warned that systemic change will not occur without significant long term policies and regulatory commitments from governments to attract and support investments targeting sustainable and regenerative forms of tourism and provide the stability required by the private sector to confidently pursue new business models.

Drawing on 32 case studies and examples from 23 countries to iden-

tify a set of priorities designed to help catalyse systemic change in destination-wide management through strategic investment and intervention by governments to support sustainable recovery from the Covid pandemic, the report provides a holistic assessment of the current state of coastal and

marine tourism. Most importantly, it proposes a framework that encourages action simultaneously across three pillars: Reducing the negative impacts of tourism on the local environment, economy and community; regenerating ecosystems, local markets and communities, and building resilience to threats and future shocks and crises.

The lead author of the report is Eliza Northop, who led a team of 23 experts from across the globe. It had two Indian experts, Joyashree Roy and Shreya Some, one a professor and another a researcher at the Jadavpur University in Kolkata. Both are currently working with the Asian Institute of Technology, Thailand.

Similarly, iron content remains high in the groundwater of Kamarda mining area in Jajpur; Angul Nalco Township and Kulad; Nuapada government hospital area and Court Chhak in Kendrapara.

## Villagers risk life wading through Nagavali

POST NEWS NETWORK

Rayagada, July 5: The residents in the tribal-dominated Khilmisguda village under Sadar block of this district have to risk their lives while crossing the Nagavali river to avail healthcare and education services at Jemadeipentha, as there is no bridge across the river, a report said.

In fact, they remain disconnected from the outer world for days together during the monsoon in the absence of a bridge across the river. In case of emergency, they do not mind risking their lives to cross the river and avail the services which are essential for their daily survival.

Reports said the state government has been taking a host of measures for the development of the tribal-dominated regions of the state. However, these developmental initiatives are still a far cry in many remote pockets, locals rued. The plight of Khilmisguda village under Kereda panchayat of Sadar block is a case in point.

The state government had given its approval for construction of a

While students are finding it difficult to attend their schools, people are seen carrying patients and pregnant women on slings and wade through the river to reach the hospitals on the other side of the river. "The situation is frightful as well as painful when someone falls sick or if a pregnant woman experiences labour pain at night," said villagers Kamala Chandra and Manoj Kumar Tadingi.

They alleged that there is no one to listen to their plights when the state government is insisting on completion of every developmental project within the deadline under 5T initiative.

When contacted, chief executive officer, rural works division, Pradipta Kumar Mohanty said the contractor is delaying the work for which a proposal has been given to the state government to assign the work to some other agency by floating a fresh tender.

It is alleged that the villagers are paying a heavy price as the project work has been affected by apathy of the rural works division and the contractor's whimsical way of working.

In this situation, nobody here knows when the fresh tender will be floated and the bridge completed, the report added.

ccording to a Pew Research Center survey in March of this year, 61% of Americans believe that abortion should be legal in most cases. Even so, the US Supreme Court overturned the constitutional right to abortion established in its 1973 Roe v. Wade decision.

No wonder the reaction has been fierce. One Democratic congresswoman, Alexandria Ocasio-Cortez, called for two Supreme Court justices to be impeached for lying under oath during their Senate confirmation hearings. Panicked commentators warn of the end of democracy in the United States. Others blame misogyny and "theatrical masculinity."

Less attention is paid to one important element in America's abortion debate: the steady ascendancy in American public life of a deeply reactionary strain of Catholicism. Of course, Catholics are no less divided than anyone else on many issues, including the right to abortion. Liberal Catholics, such as President Joe Biden and Speaker of the House Nancy Pelosi, as well as many of the roughly 50% of Catholics who voted for Democrats, support a constitutional right to abortion. The same is true of Justice Sonia Sotomayor, one of the three liberals on the Supreme Court. But five of the nine Supreme Court justices adhere to an ultra-conservative brand of Catholicism which holds that even an embryo has a soul and thus is sacrosanct.

Samuel Alito, who wrote the majority opinion overturning Roe, cited the seventeenthcentury English jurist, Matthew Hale, who considered abortion to be murder (he also believed in witches). Such views are far from the mainstream of contemporary American life. But radical Catholics - for that is what they are have been a driving force behind the anti-abortion cause for nearly a half-century.

Even conservative Protestants supported the Roe outcome at the time. The Southern Baptist Convention stated in 1973 that "religious liberty. human equality, and justice are advanced by the Supreme Court abortion decision." And yet, a decade later, evangelical conservatives, fearful that a wave of progressive secularism would threaten such cherished institutions as racially segregated Christian colleges, began to make common cause with radical Catholics. Roe became their rallying point. Their common goal was to break down the wall separating church and state, so carefully erected by the Constitution's framers.

Some radicals now even claim that the separation of church and state was never actually intended. In the words of Far-right Republican congresswoman Lauren Boebert: "I'm tired of this separation of church and state junk that's not in the Constitution."

But things are moving fast. Just days after overturning Roe, the Supreme Court decided

that a football coach in Washington state should have the right to conduct post-game prayer meetings at his public high school. This, too, is a break with precedent barring religious expression, as a private matter, from public institutions like schools.

The radicals appeal to "religious freedom." If a football coach wants to pray at football games, surrounded by players who might not wish to invite his disapproval, he is only exercising his right to free speech and religious belief. But the separation between church and state, at least in mostly Protestant

democracies, such as the US, was meant precisely to defend religious freedom. Whereas the French notion of laicité was intended to keep the Catholic clergy from interfering in public affairs, the US Constitution was devised to protect religious authority from state intervention, as well as vice versa.

One reason why the Protestant elites in the US were suspicious of Catholics until not so long ago, apart from snobbish anti-Irish or anti-Italian sentiment, was the fear that Catholics would be more loyal to their faith, and thus to the authority of the Vatican, than to the US Constitution. That is why in 1960, as he campaigned for president, John F. Kennedy had to stress his belief "in an America where the separation of church and state is absolute, where no Catholic prelate would tell the president (should he be Catholic) how to act ... "

What those Protestant elites feared is now a real threat. Catholic radicals and Protestant zealots are actively trying to impose their religious beliefs onto the public realm. Alito, as well as other Catholics, such as former Attorney General William Barr, see secularism as a threat (in Barr's words) to "the traditional moral order." That is to say, a strict interpretation of the Christian moral order. Marriage, according to Alito, is a "sacred institution between one man and one woman." One day – and possibly soon – he may decide to overturn the Court's seven-year-old decision recognising a federal right to same-sex marriage.

The danger of injecting a religious agenda into politics or law goes further than eroding the autonomy of secular institutions. It makes reasoned political debate impossible. Politics is not value-free, of course. There is nothing wrong with a politician, or indeed a jurist, who believes that religious values matter. But there is a serious problem when religious orthodoxy trumps all other considerations.

The Israeli philosopher Avishai Margalit described this succinctly in his book On Compromise and Rotten Compromises. In "politics as economics," material interests are "subject to bargaining, everything is negotiable, whereas in the religious picture, centered on the idea of the holy, the holy is non-negotiable."

This, then, is why politics in the US is now in such a perilous state. More and more, the secular Left and the religious Right are engaged in a culture war, revolving around sexuality, gender, and race, where politics is no longer negotiable. When that happens, institutions start breaking down, and the stage is set for charismatic demagogues and the politics of violence.





## CRIPPLING RESOURCE CRUNCH

THE STATE HAS **ADHERED TO FISCAL DISCIPLINE AS ALL FISCAL PARAMETERS ARE WITHIN THE PRESCRIBED** LIMITS

n July 2, 2022, Odisha Finance Minister Niranjan Pujari, presented the full state budget for fiscal 2022-23 with a total outlay of ₹2 lakh crore. On March 30, he had presented an interim budget for ₹2 lakh crore having a provision of a maximum of ₹1.06 lakh crore for the first four months of the current fiscal. Like previous years, this year also the budget was presented in two parts - 'agriculture budget' and 'general budget' along with statements on gender budget, SDG budget,

nutrition budget. Further fiscal risk statements, fiscal strategy reports, and status papers on public debt have been presented. A "Budget Stabilization Fund" worth ₹10,000 crore has been created - for the first time in India - to mitigate any revenue shock in future. According to Pujari, the budget is in line with the government's transformational agenda under "5T" and "Mo Sarkar" and will meet the aspirations of the people of the state. The budget has evoked mixed reactions. Chief Minister Naveen Patnaik described it as progressive and pro-people, while the

Opposition dubbed it as disap-

pointing, outmoded and lacklustre.

Normally, the budgetary outlay is decided in tandem with an expected rise in nominal GDP growth. The interim budget assumed a nominal GSDP growth of 12.7 per cent and a real GSDP of 9-9.5 per cent for the current fiscal. Thus, for working out all fiscal indicators, the nominal GSDP is estimated to be ₹7.19 lakh crore for 2022-23. However, in the present budget, probably, in view of inflation and recessionary tendencies, the finance minister has trimmed down the real GSDP forecast to 8 to 8.5 per cent for the current fiscal.

Budget outlay for 2021-22 which was estimated to be ₹1.70 lakh crore has shrunk to ₹1.65 lakh crore in a revised estimate. It may be noted that in addition to ₹1.70 lakh crore, Pujari had presented a supplementary budget of ₹19,380 crore December 1, 2021, which proved redundant and a routine affair. Since the budgetary outlay is about 17.6 per cent more than the previous annual budget, the present budget seems to be expansionary.

The finance minister says that in the last 22 years, the size of the

budget has increased by 17 per cent. Actually, in the nominal value, everything - GDP, debt, taxes, and expenditure - usually increases. However, in 1999-2000 as a percentage of nominal GSDP, the budget size was 16 per cent. It had increased to 19.92 per cent in 2012-13, and further to 25.8 per cent in 2021-22 and is estimated to be 27.8 per cent in 2022-23. This is a welcome feature.

Total Programme Expenditure outlay for the financial year 2022-23 has increased to ₹1,00,000 crore, from ₹75,000 crore in the previous fiscal. This constitutes 50 per cent of the budget size. The administrative expenditure has increased marginally to ₹89,500 crore from ₹85,000 crore in the previous fiscal. Administrative expenditure comprises salary, pension, interest payments. It means the government is not going to create more employment which will dampen the spirit of youths.

In line with the Centre, capital expenditure has increased by 56 per cent to be estimated at ₹38,732 crore equivalent to 5.4 per cent of GDP. This is welcome, but due to the incompletion of various projects in due time, cost-overrun is increasing.

The finance minister said that the allocation in the first agriculture budget presented in 2013-14 was ₹7166 crore. In the current fiscal, it is estimated to be ₹21,166 crore which is 21 per cent more than the previous fiscal. This increase is welcome, though in nominal terms. However, never a discussion has been held on the extra benefit of presenting a special agricultural budget. Still, there is no substantial increase in irrigated land. Many cold storages are out of order. Further, we are still depending on other states for potatoes, onions, fish.

The state's revenue receipts comprise its own tax revenue, nontax revenue, the state's share in the central tax, and the grant-in-aid from the Centre. According to the Fifteenth Finance Commission. states bear more than 62 per cent of expenditure responsibilities but are given only 37 per cent of revenue-raising power, while the Union government owns 63 per cent of revenue-raising power to spend on 38 per cent of its expenditure responsibilities.

The states should, therefore, get more from the Central fund, but the disconcerting news is that the state's share of the Central tax is declining. Over the years, the Union government has made use of cesses and surcharges an additional revenue mobilisation measures in which states have no share. The levy on account of cesses and surcharges is very high at ₹3,72,971 crore during 2020-21 and is increasing every year. The state's dependence on Central transfers has reduced with the state's own revenue contributing about 57.45 per cent to the total revenue pool.

In its total revenue receipts, Odisha's share from Central tax was 38.12 per cent in 2017-18, but it has declined to 23.83 per cent in 2021-22. In 2022-23, it is estimated to decline further to 22.55 per cent. Similarly, in its total revenue receipts, Odisha's share from the Centre's grant-in-aid was 20.73 per cent in 2016-17. But gradually it has declined to 15.31 per cent in 2021-

22, though estimated to be 20 per cent in the current fiscal.

The state's own tax/GSDP ratio is estimated at 6.40 per cent in 2021-22 and has increased by 6.50 per cent in the revised estimate. However, it is estimated to be 6.40 per cent in 2022-23. It should touch 6.75 per cent as per the Thirteenth Finance Commission. Many states have a lower tax-GSDP ratio than Odisha. But Odisha is witnessing a massive increase in non-tax revenue due to a rise in mining royalties. But this is not sustainable as mineral resources are not unlimited. The state government should explore other avenues to raise resources.

The state has adhered to fiscal discipline as all fiscal parameters are within the prescribed limits. The revenue receipt for 2022-23 is estimated at ₹1,63,966.52 crore and the revenue expenditure is at ₹1,45,727.29 crore. The revenue surplus is of the order of ₹18,239 crore, which would be 2.5 per cent of GSDP. The estimated fiscal deficit of ₹21,588 crore amounts to 3 per cent of the GSDP. The total debt is estimated to be ₹1.12.400 crore by the end of the current fiscal which is equivalent to 15.6 per cent of GSDP.

There was tremendous pressure from the Centre on state governments to stop welfare schemes as the Centre wants to squeeze the power of states. However, the finance minister has not succumbed to such pressure. According to budget, the social sector accounts for 34 per cent of the total outlay. The finance minister has tried to present a pro-people budget with limited resources, but could not address the sufferings of the pandemic victims, especially families that have lost earning members. No attempt was made to revive sick industries.

The major problems of today are unemployment, inflation, and costlier health and education. Hence a huge revenue surplus is unwarranted when the economy is plagued by stagflation. Money should have been spent more on creating jobs and providing financial assistance to those who have lost jobs and livelihoods during the pandemic. The impediment may be a resource crunch. The Finance minister should make a special effort to raise resources.

#### **KAALI POSTER ROW UP, Delhi Police** file case against Leena Manimekalai

New Delhi/Lucknow, July 5: The Delhi Police and the Uttar Pradesh police have filed separate FIRs against filmmaker Leena Manimekalai over a controversial poster of her documentary 'Kaali' even as the Indian government urged Canadian authorities to take down all the "provocative material" in the film.

A massive row has erupted after the Madurai-born filmmaker based in Toronto in Canada shared a poster of 'Kaali' on Twitter Saturday allegedly depicting the goddess in a disrespectful manner. The poster showed the goddess smoking and holding an LGBTQ flag.

A senior Delhi police officer said Tuesday that from the contents of a complaint and the social media post, prima facie an offence under sections 153A and 295A of the IPC was made out and a registered against Manimekalai at the Intelligence Fusion and Strategic Operation (IFSO) unit of the Special Cell.

While Section 153A deals with the offence of promoting enmity between different groups on ground of religion, race etc. And doing acts prejudicial to maintenance of harmony, Section 295A relates to deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs.

The Indian High Commission in Ottawa urged the Canadian authorities to take down all "provocative material" related to the film after it received complaints from leaders of the Hindu community in Canada about the "disrespectful depiction" of Hindu Gods. The film was showcased as part of the Under the Tent' project at the Aga Khan Museum in Toronto.

In Lucknow, the FIR was registered at the Hazratganj police station against Manimekalai, producer of 'Kaali' Asha Associates and editor Shravan Onachan on Monday night, police said.

Ghaziabad/Raipur, July 5: A police team from Chhattisgarh reached Uttar Pradesh's Ghaziabad town Tuesday to arrest a TV news anchor from his home for playing a doctored clip of Congress leader Rahul Gandhi but he was taken into custody by the Noida police instead, officials said.

While police from Congressruled Chhattisgarh landed at Zee News anchor Rohit Ranjan's home in Ghaziabad's Indirapuram near the national capital early morning, the team from Noida in BJPgoverned Uttar Pradesh reached a couple of hours later.

The Chhattisgarh police landed around 5.30 am, while the local Ghaziabad police RAHUL reached an hour later and the GANDHI Noida police got there after 8 am, officials said.

In Raipur, Senior Superintendent of Police Prashant Agrawal told PTI that a case was registered against Ranjan and others at Zee News Sunday for allegedly promoting enmity between different groups and outraging religious feelings of people based on a complaint by Congress MLA Devendra Yadav.

In his complaint, Yadav said a video, in which Rahul Gandhi described those attacking his Wayanad office as children and said he had no ill-will against them, was "mischievously" used by the TV channel July 1 to suggest he was forgiving the killers of Udaipur tailor Kanhaiya Lal.

As the drama unfolded outside Ranjan's home with the police teams from two states ready to arrest the anchor, a senior Ghaziabad police officer told PTI that the local city police were not involved in



the case. Chhattisgarh police was not able

to arrest him and a member of the team led by a DSP-rank officer later alleged obstruction by the local police.

He claimed that the Ghaziabad police had intervened in the legal procedure by taking Ranjan away with them from his home and then saving that he had been detained by the Noida police.

"We have registered a criminal case against Rohit Ranjan at Civil Lines police station in Raipur. We had

the arrest warrant and the court order. We came here regarding that in the morning but even after 12 hours the police here (Ghaziabad and Noida) are not informing us about Rohit Ranjan's whereabouts," the official told PTI.

The FIR in Raipur was lodged under IPC sections including 153A (promoting enmity between different groups), 295A (deliberate and malicious acts, intended to outrage religious feelings of any class), 467 (forgery), 469 (forgery to harm reputation), 504 (intentional insult).

Officials said these are more serious charges than the case lodged by the Noida police. On July 2, a day after the video was aired, Ranjan had apologised for "mistakenly" playing Gandhi's statement out of context by linking it with the Udaipur murder case.

## Do farmers go for crop diversification or not?

New Delhi, July 5: A conference of state food ministers on 'Food and Nutrition Security in India' Tuesday may have sent contrasting signals to the states when it comes to crop diversification.

It was addressed by Union Minister for Consumer Affairs. Food and Public Distribution (CA, F&PD), Piyush Goyal and Minister of State (CA, F&PD) Sadhvi Niranjan Jyoti, Food Secretary Sudhanshu Pandey and food ministers and food secretaries from multiple states.

Incidentally, the year 2023 has been declared as the Year of Millets by the UN.

Since morning, many speakers, including Sadhvi Niranjan Jyoti, had highlighted the importance of coarse grain, millets etc. In fact, Karnataka which had distributed laddus and



biscuits made of ragi at the venue - was lauded for encouraging millets. And then, while taking feedback from the states about the time consuming audit processes and their submission to the Centre etc. Goval suddenly donned his avatar as the Union Minister for Commerce and

Industry. "This time the paddy sowing is 16 per cent less than previous year. I request all of you to have a word with your Agriculture Ministers,

the sowing of rice more than last year. We have sufficient stocks (for ourselves), there is no problem with stocks," Goyal said. "But there is a lot of demand in-

ternationally. So, the more our farmers produce, they will get more price in the international market. I am also the Commerce Minister. so I have also to keep increasing the exports," the Minister said, adding, "We will increase our exports, if required, we will increase our procurement also."

He also exhorted states to increase wheat sowing in October. "The other day, Madhya Pradesh chief minister was telling me, Uttar Pradesh was also telling me. Punjab should also consider. You should increase the sowing of all the crops and look at higher productivity too."

When one of the states immediately pointed out that it is policy recommendation of the Government of India to reduce area under paddy, Goyal said, "That is applicable only if you are converting any of these to pulses, oil seeds and millets a that is welcome But otherwise, make sure the production and productivity is high."

Shubha Thakur, joint secretary

in the Department of Agriculture and Farmers Welfare, made a presentation about crop diversification. Starting from how the green

revolution necessitated increased rice and wheat production for ensuring food security, she elaborated on the changed conditions, including the increasing instance of climate change and asserted how important it is to diversify into crops other than rice and wheat. Thakur also gave examples of

states that have successfully started or already diversified into a variety of millets and cereals. Those states included Haryana, Telangana, Madhya Pradesh, Odisha and Chhattisgarh. She had quoted the 2018 NITI Aayog report about aggregate demand and supply estimates for various crops. That report had stated that in 2032-33, India's production of coarse cereals, pulses, oil seeds and fruits is going to witness a shortfall against rice, wheat, cereals, food grains, milk and milk products that all are going to be surplus then.

## Society should be sensitive about different sexual orientations: HC

Kolkata, July 5: A division bench of the Calcutta High Court without making a direct reference has observed that the society at large should be sensitive about people with different sexual orientation.

"Certain things might appear different in the current social structure and if that difference is evident in any individual the society should be sensitive and get adapted to those changes," Calcutta High Court's division bench Justice Tapabrata Chakraborty and Justice Raja Basu Chowdhury observed in a 'habeas corpus' case relating to a woman with different sexual

orientation and her parents.

The woman concerned, a college student having inclination to same-sex relationship, became a medium of ridicule for her relatives, following which her parents faced questions from different sections of the society, including neighbours and blood relations. Unable to bear these questions and apparent social stigma, the parents arranged for her marriage.

With a feeling that the marriage would be another disaster for her as well as her would-be spouse, the woman left home and started residing at an NGO-run home in South Kolkata.

The parents reached that home

with the police. However, the woman refused to go with her parents. Instead, she gave a written declaration to the police that she, being an adult, voluntarily decided to stay at the NGO-run home and no one had put pressure on her to do so. She also mentioned in the written declaration that she voluntarily decided to stay away from her ancestral residence, unable to bear the pressure of ridicules from neighbours and blood-relations. The parents approached the di-

vision bench of the Calcutta High Court. In the court also the woman clearly said that she did not want to stay with her parents. After examining all related documents as well as the police report, the division bench dismissed the habeas corpus case filed in this connection by the parents.

At the same time, the division bench observed that the society should be sensitive about the feelings of the person concerned in such cases. The division bench also observed it is unjust for anyone to totally get isolated from the parents who had faced immense hardship in his or her upbringing and that behaviour too goes against the social values.

Speaking to IANS, the counsel for the petitioner and senior counsel of the Calcutta High Court, Kaushik Gupta said that he is extremely happy that the division bench has upheld individual rights as regards to gender identity or sexual pref-

## Indian Oil delivers LPG via boats in flood-hit Assam

Guwahati, July 5: In flood-hit Assam, LPG delivery vans of PSU major Indian Oil Corporation (IOC) have been replaced by boats for the seamless supply of the fuel to keep the burner flames on, a senior official said Tuesday.

At least 180 people have died and more than 89.13 lakh people suffered cumulatively across 34 districts since April 6 in one of the worst floods Assam witnessed in recent times.

The challenge increased manifold with severe landslides in several neighbouring states such as Meghalaya, Arunachal Pradesh and Manipur, Indian Oil Corp Executive Director (IndianOil-AOD) G Ramesh told PTI here.

"Indian Oil rose magnificently to the occasion and ensured an uninterrupted supply of LPG as well as petrol and diesel to affected areas. Our dealers and distributor network rolled up their sleeves and also made food and water available to stranded people," he added.

The IOC official particularly praised the Liquefied Petroleum Gas (LPG) cylinder delivery channels, which never stopped working despite immense difficulties in reaching households that were completely submerged by floodwaters.



Saturday, more than 1,400 fresh cases and three deaths were reported. The positivity rate is around 14 per cent. The state government has appealed to people to take all precautions and wear masks," a doctor associated with the state Health department said.

Commuters spend a lot of time in an air-conditioned environment while travelling by Metro. In such confined spaces, even one affected person -- even if he is asymptomatic -- can spread the infection to several others. People with co-morbidities are at greater risk and many of them have had to be admitted to hospitals with severe complications.

Another doctor from the RN Tagore hospital said how several patients with Covid-19 are now getting admitted to the special ward. Some of them are youngsters without known co-morbidities. The

severity of the virus may have reduced but Covid-19 still remains, he reminded.

"A few days ago, I returned from Mumbai. They were strict about masks at the airport and on-board the flight, even threatening to offload passengers who do not comply. Several establishments in Kolkata, including shopping malls, have now reimposed the mask rule. This is necessary. Metro authorities should take note. After all, it's not only passengers but their own staff who are at risk," the doctor

A Metro Railway official admitted that there has been a bit of laxity in recent times. The problem is the absence of any circular or notice from the Railway Board. Without such a notice, enforcing a rule becomes difficult, as the state ( government has not yet made masks mandatory in public places.

New Delhi, July 5: A Q400 plane of SpiceJet Tuesday conducted a priority landing at the Mumbai airport after its windshield cracked at 23,000 feet altitude, according to officials of aviation regulator DGCA.

This is at least the seventh incident of technical malfunction happening on SpiceJet aircraft in the last 17 days. Earlier in the day, SpiceJet's Delhi-Dubai flight was diverted to Karachi as the fuel indicator started malfunctioning.

The Directorate General of Civil Aviation (DGCA) is investigating the two incidents which took place Tuesday, along with the previous five incidents, the officials noted. Officials said the Kandla-Mumbai flight of SpiceJet was at 23,000 feet altitude when the windshield's outer pane cracked. The pilots then conducted priority landing at the Mumbai airport, they said.

Reacting on the latest incident, SpiceJet said, "On 5th July, 2022, SpiceJet Q400 aircraft was operating SG 3324 (Kandla - Mumbai). During cruise at FL230, P2 side windshield outer pane cracked. Pressurization was observed to be normal. The aircraft landed safely in Mumbai."

The weather office Tuesday said central India and the west coast would experience active monsoon conditions for the next five days while the north-western parts of the country are expected to receive seasonal showers from Wednesday.

### Dairy farmers to stage protest

New Delhi, July 5: The Dairy Farmers' Federation of India (DFFI) Tuesday called upon the dairy farmers across the country to protest imposition of GST on dairy products, machineries and milking machines July 27.

The organising committee of the DFFI appealed to all the farmers' organisations and the joint platforms including Samyukt Kisan Morcha (SKM) to join the protest demonstrations and ensure the Union Government repeals "this anti-farmer decision through protracted struggles if required."

The GST Council at its 47th meet-

ing held on June 28 and 29 had recommended imposition of 5 per cent GST on dairy items such as "pre-packed, pre-labeled curd, lassi and butter milk" as well as to increase GST on dairy machinery and milking machines from 12 per cent to 18 per cent.

India is the world's largest milk producer, and the sector is characterised by the concentration of petty producers with 75 per cent of the rural households owning 2-4 cows. Women and peasants from the lowest social strata are highly dependent on the dairy sector.

The DFFI, affiliated with All India Kisan Sabha, said, the price of milk in the open market will skyrocket and millions of consumers would be forced to pay higher price for milk and other dairy products.

The recommendation to increase GST on the dairy machinery and milking machines will have consequences on the cooperatives and small dairy entrepreneurs operating in production and value addition.

Chennai, July 5: A software developer from Coimbatore, who was in Chennai for weekend holiday along with his family, was beaten to death by an Ola cab driver following a dispute over delay in entering the one-time password (OTP) on the Old Mahabalipuram Road here Sunday.



Greater Chennai Police Commissioner, Shankar Jiwal, told IANS that the police have now directed all the cab operators to monitor the antecedents of the drivers they employ for ferrying passengers.

Jiwal also called upon the cab operators to submit Aadhaar and other identification records of the drivers with the local police stations for background check.

On Sunday, H. Umendar (34), a software developer, visited a mall to watch a movie along with his wife Bhavya, their two children, Bhavya's sister Divyapriya and her two children. Bhavya booked an Ola cab at around 3.30 pm and on seeing the registration number of the vehicle, all seven hopped into it.

The driver of the vehicle, Ravi (41) from Salem, was furious that the customers entered the vehicle without verifying the OTP and asked them to get out of the car.

This led to an altercation between Ravi and Umendar and in a fit of rage, Ravi showered blows on the software developer. The driver also smashed his mobile phone on the forehead of Umendar, besides hitting him on the nose repeatedly.

Umendar was rushed to the hospital, where he was declared brought dead. Ravi tried to flee from the scene but was apprehended by the local people and handed over to the police.

#### Mathematician Maryna awarded

Berlin: Ukrainian mathematician Maryna Viazovska was named Tuesday as one of four recipients of the prestigious Fields Medal, which is often described as the Nobel Prize in mathematics. The International Mathematical Union said Viazovska, who holds the chair in number theory at the Swiss Federal Institute of Technology Lausanne, was being honored for her work on the densest packing of identical spheres in eight dimensions. Viazovska said Russia's attack on Ukraine in February had profoundly changed her life and those of all Ukrainians.

#### France brings 51 citizens home

Paris: French authorities Tuesday repatriated 51 women and children from the former Islamic State group-controlled areas in Syria, according to a statement from the national counterterrorism prosecutor's office. It's the single largest return of women and children to France from camps in northeastern Syria since the territorial defeat of IS in March 2019. France saw more of its citizens leave to join the group than any other country in Europe. Tuesday's group was made up of 16 women, ages 22 to 39, and 35 minors, seven of whom are coming to France unaccompanied by adults.

#### 13 killed in Nepal road accident

Kathmandu: At least 13 people were killed and 24 others injured Tuesday in a bus accident in eastern Nepal's Ramechhap district, police said. The passenger bus was on its way to Kathmandu from Sunapati when the accident occurred at around 10 am, they said. As many as 24 people sustained injuries in the accident, according to the police. Those injured are undergoing treatment at Dhulikhel Hospital.

#### China opens up to air travel

Beijing: China has started permitting international flights after a two-year ban due to the COVID-19 pandemic, but there is no word yet on the resumption of air services to India even after Beijing lifted a visa ban for Indian professionals and their families last month. China is further streamlining procedures for those arriving into the country after reducing the quarantine time to 7 days in designated hotels followed by 3-day isolation at home from the previous 2-day isolation for inbound travellers, official media here reported Tuesday.

## Finland, Sweden sign protocol to join NATO

Brussels, July 5: The 30 NATO allies signed off on the accession protocols for Sweden and Finland Tuesday, sending the membership bids of the two nations to the alliance capitals for legislative approvals — and possible political trouble in Turkey.

The move further increases Russia's strategic isolation in the wake of its invasion of neighbouring Ukraine in February and military struggles there since. "This is truly a historic moment for Finland, for Sweden and for NATO." the head of the alliance, Secretary-General Jens Stoltenberg, said.

The 30 ambassadors and permanent representatives formally approved decisions made at a NATO summit in Madrid last week, when the leaders of member nations invited Russia's neighbour Finland and Scandinavian partner Sweden to join the military club.

Securing parliamentary approval for the new members in Turkey, however, could still pose a problem even though Sweden, Finland and Turkey reached a memorandum of understanding at the Madrid summit.

Turkish President Recep Tayyip Erdogan warned that Ankara could block the process if the two countries failed to grant Turkey's demands for the extradition of people it views as terror suspects.

The people wanted in Turkey have links to outlawed Kurdish groups or the network of an exiled cleric accused of a failed 2016 coup

At a news conference, the foreign ministers of Sweden and Finland were asked whether the memorandum specified people who would have to be extradited to Turkey. Both ministers said no such list was part of the agreement.

"We will honor the memorandum fully. There is, of course, no lists or anything like that in the memorandum, but what we will do is to have better cooperation when it comes to terrorists," Swedish Foreign Minister Ann Linde said. Finnish Foreign

#### Russia shells Donetsk

Kviv: Russian forces struck targets across Ukraine's eastern Donetsk region on Tuesday to prepare the path for an expected armoured thrust to try to take more territory as the five-monthold war entered a new phase. The strikes, reported by the region's local governor and the Russian military, followed Moscow's capture of the Ukrainian city of Lysychansk on Sunday, a move that handed it total control of the Luhansk region, one of its main war aims. Taking full control of Donetsk, the other region in Donbas, the industrialised eastern part of Ukraine that has become the stage of the biggest battle in Europe in generations, is another goal of what Moscow calls its "special military operation."

Minister Pekka Haavisto was equally adamant.

"Everything that was agreed in Madrid is stated in the document. There are no hidden documents behind that or any agreements behind that," Haavisto said.

Every alliance nation has different legislative challenges and procedures to deal with, and it could take several more months for the two Nordic nations to take their place as official NATO members.

Germany's parliament is set to ratify the membership bids Friday, according to the Free Democrats, a partner party in the country's coalition government.

## Hackers claim theft of police info

Hong Kong, July 5: Hackers claim to have obtained a trove of data on 1 billion Chinese from a Shanghai police database in a leak that, if confirmed, could be one of the largest data breaches in history.

In a post on the online hacking forum Breach Forums last week, someone using the handle "ChinaDan" offered to sell nearly 24 terabytes (24 TB) of data including what they claimed was information on 1 billion people and "several billion case records" for 10 Bitcoin, worth about USD 200,000.

The data purportedly includes information from the Shanghai National Police database including names, addresses, national identification numbers and mobile phone numbers as well as case details.

One person said they were skeptical until they managed to verify some of the personal data leaked online by attempting to search for people on Alipay using their personal information. "Everyone, please be careful

in case there are more phone scams in the future!" they said in a Weibo post.

### Australia floods worsen

Sydney, July 5: Torrential rains kept battering Australia's east coast Tuesday, intensifying the flood crisis in Sydney as thousands more residents were ordered to leave their homes after rivers swiftly rose past danger levels.

About 50,000 residents in New South Wales, most in Sydney's western suburbs, have been told to either evacuate or warned they might receive evacuation orders, up from Monday's 30,000, authorities said.

"This event is far from over." New South Wales Premier Dominic Perrottet told reporters. "Wherever you are, please be careful when you're driving on our roads. There are still substantial risks for flash flooding."

Prime Minister Anthony Albanese, who returned to Australia Tuesday after a week-long trip to Europe, said he would tour the affected regions on Wednesday along with Perrottet. 

### Gunman fired over 70 rounds

Highland Park (US), July 5: The gunman who attacked an Independence Day parade in suburban Chicago fired more than 70 rounds with an AR-15-style gun that killed at least six people, then evaded initial capture by dressing as a woman and blending into the fleeing crowd, police said Tuesday.

Lake County Major Crime Task Force spokesman Christopher Covelli told a news conference that the suspected shooter, who was arrested late Monday, used a high-



powered rifle "similar to an AR-15" to spray bullets from atop a commercial building into a crowd that had gathered for a parade in Highland Park, a close-knit community on the shores of Lake Michigan that has long drawn the rich and sometimes famous. More

than 30 people were also wounded. Investigators who have interrogated the suspect and reviewed his social media posts have not determined a motive for the attack, Covelli said. They have also not found any indication that the shooter targeted anyone by race, religion or other protected status. Authorities have not filed criminal charges.

Earlier in the day, FBI agents peeked into trash cans and under picnic blankets as they searched for more evidence at the site where the assailant opened fire.

#### Stay away from politics: ISI chief

Islamabad, July 5: The chief of Pakistan's spy agency ISI has issued strict orders to all commanders to stay away from politics following directives from Army chief Gen Qamar Javed Bajwa to offset a smear campaign against the military by ousted Prime Minister Imran Khan's party, according to

a media report Tuesday. Lieutenant General Nadeem Anjum, Director General of Pakistan's ISI, personally issued the instructions to his subordinates, The Express Tribune newspaper reported. "They have been told in the strictest terms to stay away from politics and avoid any such activity," the report quoted a source as saying.

The spymaster further said that there would be zero-tolerance for violations and any intelligence official found violating the directives would have no place in the premier agency. The development came a day after Army chief Bajwa directed his top commanders and key officers - including those from the Inter-Services Intelligence - to stay away from politics after leaders of ousted prime minister Khan-led party alleged that some officials of the country's intelligence agency were trying to "manipulate" the by-elections in Punjab. Pakistan Army, which has ruled the country for more than half of its 73-plus years of existence, has hitherto wielded ( considerable power in the matters of security and foreign policy.



#### Corporate defaults may rise again

Mumbai: Rating agency Crisil Tuesday warned of more companies defaulting on their debt obligations as it expects the withdrawal of pandemicinduced relief measures coupled with volatile input prices creating cost pressures for entities, especially those rated in the sub-investmentgrade category. The annual default rate has nearly halved to 2.2 per cent in FY22, marginally higher than 2 per cent in FY21, for the straight two fiscal years on the back of a K-shaped recovery evident in the default rates, Crisil said in a report. The annual default rate stood at averaged at 4.1 percent in the past decade. The report, however, warned that the default rate may increase going forward as the pandemic-induced relief measures are withdrawn and volatile input prices create cost pressure for the industry in general, and for entities rated in the sub-investmentgrade category, in particular, dominated by MSMEs.

Data late Monday showed India's June trade deficit widened to a record high of \$25.63 billion, following a rise in crude oil and coal imports, from \$9.61 billion a year earlier.

Analysts and economists are expecting the country's current account deficit to widen to around 3.2% of the GDP in fiscal year 2023 compared with 1.2% in 2022

The partially convertible rupee closed trading at 79.37/38 per dollar, after hitting a life low of 79.3750. It had touched the previous record low of 79.12 last week and had closed trading at 78.95 Monday.

"We expect India's widening current account deficit to remain an ongoing drag for INR, with limited offsets from India's FDI and overseas investment inflows, ex-



acerbated by ongoing FPI outflows," Sonal Varma, economist at Nomura, said. "Therefore, we expect USD/INR to reach 82 by Q3 2022 and 81 by Q4 2022. One risk to our view is the RBI's USD selling intervention, which could slow the pace of INR depreciation.'

The domestic share market turned negative towards the end of trade to close down 0.2%, adding to the pressure on the rupee.

Foreign portfolio outflows from equities in the month of June stood at \$6.6 billion, the highest since March 2020, taking the total outflows

so far in 2022 to over \$30 billion. Traders said the central bank sold dollars sporadically and helped stem a steeper fall in the local unit, but expectations of aggressive rate hikes by the US Federal Reserve and

#### FICCI seeks zero-rating GST on healthcare

New Delhi, July 5: Industry body FICCI has sought zero-rating GST on healthcare services to enable the service providers to claim input tax credit.

In a letter to the Finance Minister Nirmala Sitharaman, the chamber's President Sanjiv Mehta said "enabling this would not only ensure that the input tax credit chain is intact but will also make compliances easier and ensure that the input taxes are not loaded into the cost of healthcare services".

"Hence, it is our sincere request that the exemption of healthcare services from GST may kindly be discontinued, and the healthcare providers be allowed to avail the input tax credit," he added.

Sharing its views on the recommendations made in the recent GST Council meeting, the chamber said the incorporation of 5 per cent GST on room rent (exceeding ₹5,000 per day) will go on to increase the cost of healthcare service to the patients.

"Further, the room rent is usually a part of the package rate for a treatment, and taxing only one component of the package will create confusion and will lead to deconstructing of the packages, which is against the current practice being encouraged by the government," FICCI President said.

### SENSEX REVERSES INTRA-DAY GAINS

Mumbai, July 5: Benchmark BSE Sensex Tuesday reversed its intraday gains to close down by 100 points due to fag-end selling in FMCG, banking and IT stocks amid a weak opening in European stock markets.

The 30-share BSE index declined by 100.42 points or 0.19 per cent to settle at 53,134.35 points. The index opened higher and later jumped 631.16 points or 1.18 per cent to touch the day's high of 53,865.93 after buying in banking, metals, energy and pharma shares boosted by gains in most Asian markets.

However, the barometer lost steam in the pre-close session due to selling in IT. FMCG and select banking counters as European stock markets opened with losses on recession fears.

The broader NSE Nifty also erased its intra-day gains and dipped 24.50 points or 0.15 per cent to close at 15,810.85.

Among Sensex stocks, ITC fell the most by 1.73 per cent. Wipro dropped by 1.58 per cent, M&M by 1.2 per cent, L&T by 1.12 per cent, Maruti by 1.1 per cent and IndusInd Bank by 0.98 per cent.

Infosys fell 0.77 per cent and TCS by 0.57 per cent while Axis Bank, Asian Paints and HDFC twins also declined.

Gains in Reliance Industries (0.8 per cent) and HUL (0.92 per cent) restricted losses in Sensex. Power Grid, Bajaj Finserv, Sun Pharma, and Tata Steel were among the major gainers.

Meanwhile, international oil benchmark Brent crude declined 0.88 per cent to USD 112.5 per barrel. Foreign institutional investors (FIIs) remained net sellers in the capital market, as they sold shares worth ₹2,149.56 crore Monday, as per exchange data.

### Unemployment rate rises to 7.80 pc in June: CMIE

Mumbai, July 5: The country's unemployment rate has shot up at 7.80 per cent in June with the loss of 13 million jobs, mainly in the agriculture sector, according to the data released by economic thinktank Centre for Monitoring Indian Economy (CMIE). The massive fall in number of

jobs last month was triggered by higher unemployment rate in rural areas, which went up to 8.03 per cent from 6.62 per cent in May. In urban areas, it was slightly better at 7.30 per cent compared to 7.12 per cent recorded in May, according to the CMIE data. "This is the biggest fall in employment during a nonlockdown month. This is basically a rural phenomenon and seasonal. However, this is a seasonal phase when there is a lull in agricultural activities in rural areas and it is most likely to be reversed in July when the sowing begins," CMIE managing director Mahesh Vyas told PTI

over a telephonic conversation. He said, while 13 million lost

jobs during the reporting month, the count of the unemployed increased by only 3 million.

The rest exited the labour markets as the labour force shrunk by 10 million, he added.

Vyas further said the fall was located mainly in the informal markets and it is possible that this is largely a labour migration issue and not an economic malaise. "It is worrisome that such large swathes of labour are so vulnerable to the vagaries of the monsoon," he stated.

He said, the other worrisome data point is that June 2022 saw a fall of 2.5 million jobs among salaried employees.

"June also exposed the growing vulnerability of salaried jobs. The government shrunk the demand for armed personnel and opportunities in private equity-funded new-world jobs also started to shrink. The rain god cannot save these jobs. The economy needs to grow at a faster pace than it may in the near future to save and generate such iobs," he added.

New Delhi, July 5: India's services sector activities touched the highest mark since April 2011 amid ongoing improvements in demand conditions, even as cost pressures in the service economy remained stubbornly high, a monthly survey said Tuesday.

The seasonally adjusted S&P Global India Services PMI Business Activity Index rose from 58.9 in May to 59.2 in June - its highest mark since April 2011. For the eleventh straight month,

the services sector witnessed an expansion in output. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes contraction. "Demand for services improved to the greatest extent since February 2011, supporting a robust economic expansion for the sector over the first quarter of the fiscal year 2022/23 and setting the scene for another substantial upturn in output next month," said Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence.

According to panellists, the up-

provements in demand following the retreat of pandemic restrictions, capacity expansion and a favourable economic environment.

Firms were able to secure new orders despite charging more for their services. June data showed the fastest rise in selling prices since July 2017, as several companies sought to transfer part of their additional cost burdens to clients. "Cost pressures in the service economy remained stubbornly high in June, despite easing to a three-month low. With companies retaining significant pricing power, owing to robust demand

tion climbed to a near five-year peak," Lima said. According to the survey, unre-

lenting inflation continued to concern businesses, who were cautiously optimistic about the vear-ahead outlook for business activity. The overall level of sentiment was well below its long-run average as only 9 per cent of companies forecast output growth.

"Unrelenting inflation somewhat concerned service providers, who were cautious in their forecasts. On average, business activity is expected to increase over the course of the coming 12 months, but the

overall level of sentiment remained historically low," Lima said. On the job front, some companies

responded to capacity pressures by hiring additional staff in June, but the vast majority (94 per cent) left payroll numbers unchanged. Overall, services employment rose marginally, following a decline in Meanwhile, the S&P Global India

Composite PMI Output Index -which measures combined services and manufacturing output was at 58.2 in June, little changed from 58.3 in May.

"Growth of Indian private sector output steadied in June, as a faster increase in services activity offset a slower rise in factory pro-

duction," the survey said. Thursday, the Reserve Bank of India (RBI) said the Indian economy is well on the path to recovery even though inflationary pressures and

geopolitical risks warrant careful handling and close monitoring of the situation.

The RBI's 25th Financial Stability Report (FSR) also said banks, as well as non-banking financial institutions, have sufficient capital buffers to withstand shocks.

## \$12bn windfall for govt from windfall tax on oil firms

New Delhi, July 5: The windfall taxes on domestic crude oil production and fuel exports will generate close to USD 12 billion (Rs 94,800 crore) for the government in the remainder of the current fiscal while trimming profits of firms such as Reliance Industries Ltd and ONGC, Moody's Investors Service said Tuesday.

July 1, the government imposed windfall gain taxes on the export of petrol, diesel and aviation turbine fuel (ATF), and on the domestic production of crude oil. It has also mandated exporters to meet the requirements of the domestic market first.

"The tax increase will reduce the profits of Indian crude producers and oil exporters like Reliance Industries Limited (RIL) and Oil and Natural Gas Corporation Ltd

(ONGC)," Moody's said in its comments on the new taxes. Following the government's announcement, Indian oil companies will have to pay ₹6 per litre (around USD 12.2 per barrel) on exports of petrol and ATF, and ₹13 per litre (around USD 26.3 per barrel) on exports of diesel. At the same time, upstream producers will have to pay taxes of ₹23,250 per tonne (around USD 38.2 per barrel) of crude oil produced in India. "Based on the production of

crude oil and export of petroleum products in India in the fiscal year ended on March 31, 2022 (fiscal 2021), we estimate that the government will generate close to USD 12 billion of additional revenue for the remainder of fiscal 2022," the rating agency said. The additional revenue will help

to offset the negative impact of a

reduction in excise duties for petrol

and diesel announced in late May to tame soaring inflation.

In May 2022, the government announced a cut in the excise duty of ₹8 per litre on petrol and ₹6 a litre on diesel, which is estimated to have reduced its revenues by ₹1 lakh crore.

"Significant additional tax rev-

enue will offset fiscal pressure on the sovereign," it said. "We expect this government

measure to be temporary and that taxes will be eventually adjusted according to market conditions, including considerations related to inflation, external balances and currency depreciation."

Moody's said higher revenue also supports its view that the gradual fiscal consolidation trend will continue, notwithstanding associated risks posed by the current inflationary environment, such as higher subsidy spending.

"India's higher export duties for fuel products will curtail export receipts, but the concurrent announcement of higher customs duties on gold imports will serve to limit a further widening of the current account deficit. The country's large foreign exchange reserves remain sufficient to preempt any issues concerning the repayment of external debt despite the weak-

ening of the rupee," it said. The rating agency said the rise in tax payments is not expected to materially weaken the RIL or ONGC's credit quality because their margins will continue to be healthy.

#### RACIAL ABUSE CHARGE TO BE INVESTIGATED

Birmingham, July 5: An investigation has been launched into allegations of racist abuse aimed at Indian fans during the fourth day of the fifth Test between India and England at Edgbaston, the ECB and Warwickshire County Cricket Club said.

Several Indian fans took to Twitter to report the racist behaviour they endured during the fourth day's play Monday night. They claimed that some British fans hurled racial taunts at them.

The official Edgbaston Twitter account responded to Rafig's tweet saying: "We're incredible sorry to read this and do not condone this behaviour in anyway. We'll be investigating this ASAP."

Warwickshire later released a statement, stating they are investigating the incident. "I'm gutted by these reports as we're working hard to make Edgbaston a safe, welcoming environment for all," Stuart Cain, Chief Executive at Edgbaston said.

"Having seen the initial tweets, I've spoken personally to the gentleman who raised them and we're now speaking to the stewards in this area to establish what happened. Nobody should be subject to any form of abuse at Edgbaston. So, once we've got all the facts, we will make sure this issue is addressed swiftly," the statement added.

One spectator, who was in the Hollies Stand, alleged that the stewards refused to take any action despite several complaints. "Racist behaviour at @Edgbaston towards Indian fans in block 22 Eric Hollies. People calling us Curry C\*\*\*\* and paki b\*\*\*\*\*\*. We reported it to the stewards and showed them the culprits at least 10 times but no response and all we were told is to sit in our seats. @ECB\_cricket."

"We were also fearful of our safety for women and children but no assistance when we left. This is unacceptable in today's society @BCCI #ENGvIND," a spectator said in a series of tweets.

Birmingham, July 5: Jonny Bairstow (114 n o, 145b, 15x4, 1x6) and Joe Root (142 no, 173b, 19x4, 1x6), who have made chasing tricky targets in Test matches fashionable, put famed Indian pace attack to sword with imposing hundreds as England recorded their highest ever chase of 378 runs with minimum fuss to level the five-match series 2-2.

It is fourth straight successful chase for England, having accomplished tricky fourth innings targets of 278, 299 and 296 against New Zealand in the previous series.

For India, the ignominy was of not being able to defend their highest fourth innings target. When England were rattled on the fourth afternoon by stand-in skipper Jasprit Bumrah (2/74), the two star batters didn't waver from their game plan. The entire Indian attack, except Bumrah, looked pedestrian. All England needed was just under 20 overs to knock off the remaining 119 runs on fifth morning.

What was more embarrassing was England knocking off the runs in 76.4 overs, which isn't even a full day's play and at a run-rate of nearly five runs per over (4.93).

Root, who has been in even more sublime form since relinquishing captaincy, scored his 28th century and was involved in an unbroken 269-run stand with Bairstow, whose ton count reached a dozen after

the completion of this game.

Bairstow, who is in the form of his life, topped up his first innings of 106 with an even more graceful century as Brendon McCullum's philosophy of deflating teams on flat decks is currently working wonders.

A cursory look at a statistical nugget reveals the impact Bairstow and Root have made in England's last four victories. Both have played significant role in three chases in the last four games.

This is India's third straight Test match defeat in a 'SENA' country (SA, England, NZ, Australia) after back-to-back defeats against South Africa but this will hurt more as they had a sizeable first innings lead of 132 runs.

The defeat would also significantly dent India's chances of finishing in top-two in the World Test Championship (WTC) table.

Bumrah in his first tryst as captain was very impressive despite the disappointing outcome but what would hurt India badly is the tactics employed by the team that had so many senior players.

A team that has set a target of 378 couldn't have possibly started with a spread out field, logic of which would need some explaining from head coach Rahul Dravid. Since he has taken over, India have lost three out of four overseas Tests and for a man, who relies heavily on method and process, that's not a great piece of stat. The gaping holes in the field were a testimony of a hollow strategy.

Ravindra Jadeja (18.4-3-62-0), a classical left-arm spinner, bowled over the wicket throughout, negating any chance of trapping the batters in front of the wicket. Not for once did he come round the wicket to pin the batters.

And to make matters worse, India's third and fourth pacers -Mohammed Siraj (15-0-98-0) and Shardul Thakur (11-0-65-0) - hardly made in impact.

Virat Kohli's presence in the field is imposing but perhaps time has come to ask if his aggressive on-field demeanour and rubbing the opposition in wrong way is proving to be counter-productive as it happened in this Test match.

He hurled harsh words at Bairstow without any provocation and the result was there for everyone to see. Ian Bishop termed it akin to poking a bear while Virender Sehwag in his inimitable style tweeted that before Kohli's sledges, Bairstow was "batting like Pujara" and post his unsavoury engagement, the Englishman turned into "Pant".

The 'Fab Four' (Joe Root, Kane Williamson, Steve Smith and Kohli) is in danger of losing one member as Kohli's diminishing returns with the bat for the last three years continues to be a huge of cause of concern.

Root hitting the winning run with an audacious reverse sweep was symbolic than ever, rubbing it on Kohli's wounds.

#### **PAY PARITY IN KIWI CRICKET**

Christchurch, July 5: In a first in world cricket. New Zealand men and women will receive the same match fees across formats and competitions, according to a ground-breaking five-year deal between the sports' governing body in the country and the players' association.

"I want to thank and congratulate the players and the Major Associations for their part in reaching such a significant agreement," NZC chief executive David White said in a statement. "This is the most important agreement in our sport, as it binds NZC, the Major Associations, and our players at the hip, and sets the foundation to fund, grow and develop cricket."

According to the landmark agreement struck between NZC, the six major associations, and the New Zealand Cricket Players Association, White Ferns and domestic women's players will receive the same match fees as the men across the formats.

"Translated, this means the highest-ranked WHITE FERN would be able to receive a maximum of NZD 163,246 a year (up from NZD 83,432), the ninth-ranked, NZD 148,946 (NZD 66,266), and the 17thranked NZD 142,346 (NZD 62,833)," the statement said.

The top-ranked women's domestic players in each Major Association would be able to receive a maximum of NZD 19,146 (up from NZD 3,423), the sixth-ranked NZD 18,646 (NZD 3,423), and the 12th-ranked NZD 18,146 (NZD 3,423)."
