Jumbo with 5 bullet injuries succumbs

Narsinghpur. July 29: An elephant that was suffering from grievous bullet injuries, succumbed Friday in Narasinghpur West Range under Athgarh Forest Division.

A team of veterinarians and wildlife experts had camped in the forest since Wednesday and managed to tranquilise the elephant for treatment.

The elephant had sustained at least five bullet injuries which led to infections.

A couple of days ago, locals had spotted the elephant moving in the Bhrahmani beat area and informed the forest officials about the ailing elephant.

The animal was aged around 20-25 years.

Wildlife experts and veterinarians carried out a medical checkup and detected five gunshot wounds near the left ear, leg, trunk and on two different parts of the elephant's body.

Without giving details, 17 tweets from verified journalists and news outlets globally were withheld during the second half of 2021 as compared to 11 tweets withheld during January-June.

Twitter said it received a legal demand from the National Commission for Protection of Child Rights in India to remove content relating to privacy issues involving a minor.

While Twitter did not name anyone, the reference was to Congress leader Rahul Gandhi's tweet of August last year when he shared a picture of the parents of a minor Dalit girl who was allegedly raped. 'The reported tweet published by

8-year jail term sought for Shakira

Madrid: A Spanish prosecutor is seeking a prison term of eight years for Colombian superstar Shakira over a 14.5 million-euro tax fraud case, his office document showed on Friday.

The Columbian singer, who has sold more than 80 million records worldwide with hits such as Hips Don't Lie, rejected a settlement offer from the prosecutor's office to close the case. She is accused of failing to pay taxes between 2012 and 2014, a period in which Shakira confirms of not staying in Spain.

The prosecutor's statement asserts that Shakira was ordinarily a resident in Spain between 2012 -14 and in May 2012 bought a house in Barcelona which became a shelter for her family.

However, Shakira's representatives have showed confidence on her innocence and have said that she considers the case "a total viola-tion of her rights". The 45-year-old singer said she initially paid the 17.2 million euros that the Spanish tax office said she owed and claims she has no outstanding debt with the tax authorities. No date for a trial has been set yet.





Bhubaneswar, July 29: Opposition BJP and Congress Friday asked the state government to open Srimandir Ratna Bhandar and prepare a detailed list of the valuables available at the temple treasury. Raising the issue during Zero Hour in the Assembly, Congress

MLA Santosh Singh Saluja said the devotees of Lord Jagannath are eager to know whether the jewellery and other valuables of the temple are in safe custody or not. He urged the Speaker to ask the state government to open the temple treasury and renovate the struc-

ture. The Congress legislator also asked the state government to go for an inventory of valuables at Ratna Bhandar and make it public. Moreover, Saluja requested Speaker BK Arukha to direct the



state government to table the report of Justice Raghubir Dash Commission, which was constituted to probe issues relating to the missing keys of Ratna Bhandar.

"The BJD government has set up 24 commissions of inquiry on various issues at the cost of crores of rupees during last 21 years of its rule. However, it is a matter of regret that eight commissions have not submitted their reports yet.

The government, on the other hands, has been extending their tenures," Saluja said.

Speaking to media persons outside the Assembly, Saluja claimed that Puri king Dibyasingha Deb has also expressed concern over the structural status of Ratna Bhandar. The king has also supported the demand for opening of the temple treasury and an audit of the ornaments stored in it, he added.

BJP chief whip Mohan Majhi asked the government to open Ratna Bhandar and prepare a list of the ornaments and valuables stored in it.

"Questions are being raised regarding the state government's reluctance to open Ratna Bhandar and audit its valuables. We all have the right to know about the precious items stored inside the temple treasury," Majhi said.





People with Covid are over 2.5 times more likely to have an unfavourable outcome and face a difficult recovery post-stroke.

Researchers from Thomas Jefferson University in the US found that the patients with Covid, who were younger and had less risk factors, were less likely to achieve successful revascularisation -- a procedure aimed to restore blood flow into blocked arteries or veins.

Moreover, thrombectomy -- a

minimally invasive procedure that uses a catheter to reopen blocked arteries in the brain -was prolonged in the Covid group, as was the length of hospital stay.

Most alarming, mortality rates were higher by more than twofold in the Covid group compared to the control.

Overall, Covid was a predictor of poorer outcomes, even though many of the patients were younger, healthier and even had mild symptoms of the virus before the onset of stroke, the researchers said.

'There is still so much we need to learn about Covid, especially its impact on younger patients," said lead author Pascal Jabbour, Professor of neurological surgery



at the university.

"Stroke's impact on individuals with Covid-19 is alarming and one we must continue to research and remedy," Jabbour added.

The findings were presented Society the of NeuroInterventional Surgery's (SNIS) 19th annual meeting held in Canada.

The team compared which patients had successful revascularisations and left the hospital with little to no disabilities

Of the individuals with Covid, the severity of the virus on stroke onset was moderate in 75.5 per cent of the cases, severe in 15.8 and critical in 8.7 per cent.

The mean duration between symptoms and stroke onset was about nine days, and 34 per cent of the Covid group had stroke as their first symptom of the disease. IANS

RPDACs run out of steam across state

Jajpur, July 29: Rehabilitation and Peripheral Development Advisory Committee (RPDAC), which assumes significance in dealing with issues of the displaced and land losers, and in suggesting developmental projects, has apparently been pushed to the doldrums over the years as the meetings are not being held regularly as per norms

The RPDAC in the state was formed July 6, 2006 to tackle R&R and other issues with effective solution, particularly in mineralbearing areas and industrial areas of the state. As per guidelines, Revenue and Disaster Management department has been mandated to hold RPDAC meetings at district levels four times a year -once in every three months

Hence, RPDAC meetings in Jajpur district should have been held 64 times during the last 16 years. But ironically, RPDAC meetings have been held only 11 times in some mining hit and industrially rich districts in the state. This was revealed by Revenue and Disaster Management minister while replying to queries in this regard in the Assembly recently.

Revenue Divisional Commissioners (RDCs) are chair-

persons of RPDACs while Collectors are the conveners. It is alleged that indifference of the top officials has left the RPDACs in doldrums. RPDAC's role assumes signifi-

cance as the state government lays stress on industrialisation to foster economic growth and alleviate unemployment. Issues of rehabilitation and displacement crop up and persist in areas where industries are being set up. This is when RPDAC comes to play its role with its mediatory and advisory roles in resolving these issues on

a priority basis. As per guidelines, decisions taken by RPDACs are executed in the troubled areas. But in reality, RPDAC's roles are allegedly being given a short shrift the reasons of which are unknown. Reports said in Angul, RPDAC meetings relating to Mahanadi Coalfields, Talcher,

have been held only six times between 2012 and 2021 In Bolangir, RPDAC meetings about Lower Suktel project were held three times between 2007 and 2018 while it was held twice about the issues of Arti Steels Limited; thrice for Tata Powers and twice for KVK Nilachal Powers in Cuttack.

It was found that there has been no RPDAC meeting for some projects from 2016 till date. When asked, Kalinganagar ADM Santosh Kumar Mishra said that the administration has been successfully handling issues of the displaced with focus on employment.

A decision on the RPDAC meeting will be taken in time, he added.

Retd techie's pomegranate farm the envy of many

FORMER ENGINEER DIBAKAR BEHERA NOW EARNS ₹6-7 LAKH PER ANNUM FROM THE FRUIT FARMING

Umerkote, July 29: Dibakar Behera of Umerkote town in Nabarangpur district, though an engineer by profession, used to keep his childhood passion for horticulture and orchard farming burning.

After retirement, he found enough time and used it on pomegranate farming that brought him resounding success. He is now earning ₹6-7 lakh per annum from this fruit farming. Moreover, he has also created scope of earning for seven families.

His success story has given a ray of hope for other farmers in the area who have been struggling to make both ends meet from traditional paddy farming.

His lush green pomegranate farm spread over three acres at Badabasini village is said to be an object of envy for many. But for this passionate farmer, the well

yield has good demand in the market too

grown farm is the outcome of his steely will and indefatigable efforts which he has been investing in his farmland every day.

After retirement as an assistant engineer. Behera was browsing social media for information about



commercially viable farming that can fetch him a good income. During Covid times, he joined 'Bharatiya Chasi Sangh' and later came in contact with a Guiarat-based professor BT Gore, who provided him training and guidance online about pomegranate cultivation. Significantly, the advantage of pomegranate farming is that these plants are droughtproof and can survive even with little water.

"I procured pomegranate saplings from Surat and planted

them on three acres of farmland. There are 1,050 plants in the farm. After a year of nursing and proper care, these plants started bearing fruits." he added.

A plant bears 25 to 30 pomegranates and produces fruits twice/thrice a year.

"In the first phase, the farm yielded 15 quintal pomegranates. One can earn ₹ 6 to 7 lakh per annum from a 3-acre farm. The fruits are grown organically and no fertilizer is used. The yield has good demand in the market too," he said.

He sells his produce to some dealers in parts of Nabarangpur and neighbouing Chhattisgarh.

Besides, he is engaging five to seven local labourers per day in the farm activities.

He said that if anyone is keen to learn about the pomegranate farming, he would provide technical knowhow to them.


President Droupadi Murmu has inherited four senior officers of the Rashtrapati Bhavan from the Ram Nath Kovind presidency, including the President's Secretary Kapil Dev Tripathi, Joint Secretary Ajay Bhadoo, Officer on Special Duty Jaganath Srinivasan and Press Secretary Ajay Kumar Singh. Though these officers had been working on a co-terminus basis with the term of Kovind, the Appointments Committee of the Cabinet has approved the extension of their tenure for a period of two months beyond July 25 or until further orders.

We wonder if an able and proven competency in governance and government won't make the new President assemble her own team? Even if, traditionally, there is a sign-off, by the System (read Cabinet Secretary) it's usually a minor presidential privilege some choose to exercise more than others. Most likely, Murmu will eventually assemble her own team of trusted aides, and these officers will be at hand to ensure a seamless transition as the President settles into her role.

Tripura gets a new DGP

When senior IPS officer Tapan Deka was appointed as the new Director of the Intelligence Bureau (IB), he superseded four IB colleagues, who quickly decided to move out and seek what is called a "respectful rehabilitation" in babu parlance. Deka checks many boxes, to occupy this especially sensitive post. His skills weren't in question and seniority issues were mainly the ones in play. However, sensing some unhappiness over Deka's appointment, the government has moved quickly to acquiesce to their request.

Special Director of Intelligence Bureau, Amitabh Ranjan, who was among the four IPS officers superseded by Deka, has been ap pointed as the new Director General of Police of Tripura. Sources have informed DKB that Ranjan had a



major backer in Tripura chief minister Biplab Kumar Deb, who called Union Home Minister Amit Shah to clear all the formalities for the 1988-batch IPS officer's appointment. The state is headed for assembly elections early next year

DKB has learnt, that three other superseded officers have been moved out of IB. Special Director Manoj Kumar Lal, has returned to his parent UT cadre, while Manoj Yadava has been sent to the National Human Rights Commission as Director General (Investigations). Only Anish Dayal Singh, Deka's junior, continues to work in IB as Special Director.

Calm has been restored by placing these IPS officers in other rank-appropriate positions. It needs to be noted that Deka's is not the first instance of a junior officer being promoted to the top position in a hierarchy-driven organization. The new IB chief is junior to Manoj Yadava, Manoj Kumar Lal and Amitabh Ranjan. And even though seniority is not the sole criterion for appointment to a prestigious post like this, the episode does point to perhaps taking a fresh look at the promotion policy and managing succession among the senior police officials.

Vacancies at Centre hit new low


Even as the Centre continues to grapple with a shortage of civil service officers, the Ministry of Personnel has revealed that the number of vacancies advertised by the UPSC has fallen by more than 50 per cent since 2014!

The Minister of State for Personnel Jitendra Singh reportedly informed Parliament that UPSC recommended 4,119 candidates for Central government jobs in 2021-22, which is the lowest number of job positions at the Centre in the past 10 years. As the Modi sarkar sets its sights on the 2024 general elections, it is clear that governance will be a big factor in its claims to retain power. As of now, the panel's report should set off alarm bells within the ruling dispensation. Shortage of IAS officers is compelling many states to take recourse to appointing non-cadre officers in cadre officer posts, and also continuing them in such posts beyond permissible limits. Also, we have noted several IAS officers holding multiple assignments due to the dearth of eligible officers

Certainly, the shortage of IAS officers is nothing new. Apparently, even back way in 1951, the number of appointed officers compared to the required was low. There were 336 fewer officers than the required strength of 1232 officers. But over the decades instead of bridging the gap, it has steadily widened But the bigger question is why have successive governments not managed to solve the issue, despite diligent annual cadre reviews and recommendations of numerous panels? Hopefully, the urgency recommended by the Modi panel will stir the Centre into moving determinedly in this direction.



In 2017, a team of researchers Abhijit Banerjee, Michael Fave, Alan Krueger, Paul Niehaus, and one of us (Suri) – in collaboration with Innovations for Poverty Action and Give Directly, began a randomized evaluation in Kenya to test the effect of a digitally transferred UBL The team focused on two low-income counties, Siaya and Bomet, and evaluated three distinct UBI designs: a large lump sum, equivalent to approximately \$500 (the "lump-sum arm"); a payment of \$0.75 per day for two years, equivalent to about \$500 (the "shortterm arm"); and a payment of \$0.75 per day for 12 years (the "longterm arm"). Payments were made to each adult over the age of 18 in the assigned villages


The researchers also saw how more income can lead people to take greater risks. Before the pandemic, new businesses established by some UBI recipients posted large increases in profits. But such risk-taking does not always pay off. Although these enterprises largely remained open during the COVID-19 crisis, earnings declined to levels similar to those in the comparison group.

This decrease in income for UBI beneficiaries during the pandemic was not a failure of UBI. The grant is designed to maintain a minimum standard of living and, by providing a form of insurance, may encourage recipients to take more risks. But in a crisis of the magnitude of the pandemic, policymakers should also consider protecting incomes (as some high-income countries did).

The onset of the pandemic in Kenya coincided with the agricultural off (or lean) season, when hunger and illness typically increase, and income declines. Although the study could not iso late the pandemic's effects from these seasonal trends, the evidence highlights the importance of access to cash transfers and other income supplements during crises, particularly to reduce hunger and illness. Policymakers and businesses in poorer countries should therefore consider building cash-transfer systems that can be activated at short notice to deliver additional funds to a large number of people, if not everyone, in response to unanticipated shocks.

Alamagoozlum

t's a wonderful word, one of the best of the exotics that came out of North America in the nineteenth century. It's still to be found, though you're likely to encounter it in the company of the Corpse Reviver, the Fogcutter, the Monkey Gland and the Widow's Kiss. The original alamagoozlum was maple syrup. The name may have been a blend of French-Canadian and American terms, since it's conjectured it was created from à la (as in à la mode) and goozlum, with a ma thrown in to make it bounce better in the mouth. The goozlum or goozle was the throat, windpipe or Adam's apple, possibly a variant form of guzzle. The word was rarely recorded in the old days. The Bradford Era of Pennsylvania in 1888 did its best to confuse unwary etymologists by composing a ditty that included the lines, "From Alamagoozlum / To Kalamazoo, / We can bamboozle 'em!" Today, alamagoozlum is almost entirely the province of those well-informed mixologists who know their old-style cocktails. Charles H Baker recorded it in 1939 in The Gentleman's Companion or Around the World with Jigger, Beaker and Flask. It's not a drink for the faint-hearted, either to create or consume, since it includes Chartreuse, gin, Jamaican rum, orange curaçao, egg whites, Angostura bitters, and a big dollop of syrup. Curiously, none of the recipes that I've seen even mention maple syrup, the classic ingredient being gomme syrup (perhaps from French gomme or an old form of English gum), which is a mixture of a simple sugar syrup with gum arabic. A reader, Mary Louise Lyman, recalled that her father referred to a stew or casserole of leftovers as a magoozlum. It isn't common in print, but it is in The Long Goodbye by Raymond Chandler: "I've written twelve best-sellers, and if I ever finish that stack of magoozlum on the desk there I may possibly have written thirteen." It has been defined as hooey, nonsense, tosh, tripe, twaddle or tommy-rot. Etymologists have suggested it may derive from the cartoon character Mr Magoo or from magoo, Hollywood slang for the gooey insides of custard pies (the throwing sort), but it seems at least as likely that it's a shortening of alamagoozlum.

Similarly, another study by SBI showed farmer income doubled in fiscal 2021-22 compared to FY 18 for certain crops in some states. In all other cases, it rose in the range of 1.3-1.7 times. The study found that the increase in farm ers' incomes, engaged in cash crops, has been more prominent compared to those growing non-cash crops. Allied and non-farm income showed a significant increase of 1.4-1.8 times in most states in tandem with farm income during the period.

These developments augur well for the sector, though questions remain. The first and foremost is the condition of small and marginal farmers who have not witnessed any increase in their income while most have shown a decline. Take seeds, in the last five years, there have been cases of foreign seeds like Bt being expensive but hurting a section of farmers. The claim that such seeds have high yields and no pests has properly no base. In fact, small and marginal farmers have become indebted.

The National Sample Survey data showed that around 80 percent of farmers in Andhra Pradesh are in debt, while in Punjab and Maharashtra, the figure averages 65 per cent. These states have the highest number of farmer suicides. The country can fill the stomachs of the subsistence farmers if the farmers get the right price for their produce, proper storage, marketing facilities, reduction of cost of agricultural produce, ban on entry of

capitalists in this business.

This being the present situation in the agricultural sector, there is a need to take adequate measures to boost agricultural growth. Obviously, productivity has to increase in the states that are below the national average. Added to this, one cash crop would have to be grown to increase farmers' income. For this, technological support is very much needed and research institutes such as the ICAR have to come forward in locating at least 200 to 250 districts where cash crop production has to be encouraged in a big way.

International scientists have been of the opinion that responsibility does not lie solely with the state, but with civil society too. There is a need for allocation of more resources from the Centre, promoting good nutrition through education, promoting better local farming methods, increasing local food processing and, of course, better technological inputs which India's scientific institutions can provide. Only then can India emerge as a major food hub in the world by increasing agricultural production and productivity.

Chinese casualties can't be disclosed: CIC

New Delhi, July 29: Information regarding casualties suffered by Chinese soldiers in the Galwan valley clash with Indian forces in Ladakh two years ago cannot be disclosed, the Central Information Commission has held.

In a recent order, the CIC, the highest appellate body under the Right to Information Act (RTI), refused to allow a plea seeking "the casualties to the Chinese forces, if any, by brave soldiers of the country" during the clashes in the night of June 15 and 16, 2020.

RTI applicant Akhand had also sought information about casualties suffered by Indian forces at Galwan River Valley, Ladakh near the Line of Actual Control during the clash and rehabilitation and ex-gratia paid to the families. In addition, the RTI applicant had sought to know from the army if Indian soldiers are missing in the Galwan river valley after the clash and its plans to rescue them. The army refused to disclose the information saying it was third party information which cannot be shared under Section 8(1)(j) of the Act, which exempts from disclosure the information which is personal in nature. To deny the information, the army also cited Section 8(1)(a) of the Act which exempts from disclosure the information which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence. The representative of Akhand argued before the CIC that the matter involves larger public interest and the information should be provided to him.



Number of tigers up, but rise in poaching cause of concern: Experts

New Delhi, July 29: Though India's tiger conservation efforts have vielded favourable results, the rise in poaching and man-animal conflict due to shrinking prey base is a cause for concern, experts said Friday.

According to the 2018 tiger census, India has a tiger population of 2,967. There were 1,411 tigers in 2006. The National Tiger Conservation Authority (NTCA) says India has lost 1,059 tigers since 2012 with Madhya Pradesh, which is known as the "tiger state" of the country, recording the highest number of deaths of the striped felines.

NTCA data showed 75 tigers have died this year so far,

Tito Joseph, programme manager, Wildlife Protection Society of India, said though the mortality rate is not a matter of concern, authorities should be worried about the deaths due to poaching and human-tiger conflict.

"The government is putting in a lot of effort in tiger conversation and the number of tiger reserves has increased to 52 (from nine in 1973). But, states should focus more on areas where poaching is high and involve local people," he said.

A visibly devastated Arpita Mukherjee did not utter a single word to the waiting mediapersons

Soon after she was taken inside the building, another vehicle of ED carrying Partha Chatterjee reached the hospital premises. But unlike Mukherjee, he did not resort to any emotional scene and while going into the hospital building on a wheelchair pushed by the ED



staff, he just gave a one-liner to the media - "I am a victim of conspiracy".

However, that one-liner was enough to provoke sharp reactions from the political circles.

Ridiculing Chatterjee's one-liner, state Trinamool Congress general secretary and party spokesman, Kunal Ghosh said that in such cases the natural reaction would have been - "I am innocent".

"However, if Partha Chatterjee really thinks that he is a victim of conspiracy, he should prove that in the court," Ghosh said. BJP's national vice president and the party MP, Dilip Ghosh said that it was strange that one of the key accused in the entire WBSSC conspiracy was crying and claiming that he was a victim of con-

Kolkata: The Enforce Directorate raided the third apartment linked to Arpita Mukherjee, the close associate of arrested West Bengal minister Partha Chatterjee, in the city's Chinar Park area after recovering around Rs 28 crore cash from another flat belonging to her. The raid by the ED, which is probing the money trail of the school jobs scam, was conducted late Thursday evening, an official of the agency said. As the door of the flat was locked and the keys could not be traced, the ED sleuths broke open its entrance door in the presence of central force officers.



sect bite. "With increasing awareness through the internet, people are coming to us with queries about monkeypox if they have rashes or simple insect bite. There is no need to panic. The number of cases is relatively low. But if you have a doubt, it is better to consult the doctor," he said.

Dr Pooja Chopra, senior dermatologist, Aakash Healthcare Super Specialty Hospital, Dwarka, said her colleagues in other parts of the country have seen cases of patients with atypical rashes accompanied by fever and joint pains.

Stressing that being vigilant and alert is the key, she concurred with her counterparts that patients are confusing skin allergy with monkeypox.

"Look out for symptoms like atypical rashes, fever, joint pain, generalised weakness, in case yoususpect you have the infection," she added.

Bangalore/Mangaluru, Julv 29: Karnataka Chief Minister Basavaraj Bommai Friday said the probe into the murder of a BJP youth wing leader will be handed over to the National Investigation Agency (NIA), noting it was an "organised crime" with inter-state links.

As the move came in the backdrop of a backlash from section of the BJP cadres against its state top brass after the brutal killing of Praveen Nettar and demand for a NIA probe, a Karnataka minister Dr C N Ashwath Narayan said time has come to carry out "encounters" against perpetrators of such incidents and that the state government is ready for it.

Narayan's comments came a day after Bommai said, if the situation demands, the "Yogi model" government in Uttar Pradesh will be adopted in Karnataka too to deal with anti-national and communal elements trying to create unrest.

One more person was arrested on Friday in the killing of Nettar, a leader of Bharativa Janata Yuva Morcha (BJYM), on Tuesday night in front of his broiler shop in Dakshina Kannada district, taking to three the total number

of arrests The communally sensitive Dakshina Kannada district has been rocked by back-to-back murders of two people belonging to different communities in the last three days. Mohammad Fazil, a native of Surathkal, was murdered by four unknown assailants outside a shop on Thursday night, police said.

Bommai said that upon getting complete details of the Nettar murder case, the state government will write to the Union Home Ministry requesting for a probe by the NIA. "We have decided to hand over the case to the NIA since it is an inter-state issue (Karnataka-Kerala).

Surendranagar (Gujarat): An Indian Army team rescued a 12-year-old girl from a borewell in the Gajanvav village of Guiarat's Surendranagar district. The girl was later sent to the government medical hospital for treatment. Dhrangadhra Deputy Collector M.P. Patel said, "12-year-old Manisha, while playing in the field where her parents were working, fell in a 600 to 700 feet deep borewell. The village sarpanch informed the local authorities, and fire and medical teams were rushed."

Chennai, July 29: A physical education teacher in a government school near Tamil Nadu's Coimbatore city was arrested after several girl students complained of his sexual harassment, police said on Friday.

Prabhakaran, 55, from Valparai was recently transferred to the government school in Coimbatore and ever since, girl students have been complaining about him. Parents of the girl students alleged that even after the students had lodged formal complaints with the headmistress, no action was taken against him.

Friday morning, parents and students gathered at the school and demanded Prabhakaran be arrested. The students said that ever since he joined the school, he had been touching them with bad intentions and that even after complaining several times to the headmistress, he was not punished. hence they had to resort to a mass

Court Friday observed that the approach of a judge, who sentenced a convict to capital punishment within four working days and decided a POCSO case and awarded life term to the convict within a working day, cannot be termed commendable.

However, the top court sought response from the Registrar General of the Patna High Court on the plea by the judge, Shashi Kant Rai, challenging his suspension.

Senior advocate Vikas Singh along with advocate Nitin Saluja, represented the judge, before a bench headed by Justice U.U. Lalit. Singh submitted that his client, who sought seniority on the basis of a new evaluation system, received a call from the high court and he was subsequently suspended without any reason.

The bench said: "Merely because something is done in four days it does not mean that judgment has to be set aside.'

"But we cannot say such an ap-



proach is commendable." it added.

The bench told petitioner's coun sel: "You have heard and sentenced the accused to life imprisonment in a single day. It does not happen like this," and clarified that pendency is one issue and approach to a matter is a different issue.

Citing top court's judgments, the bench pointed out that there are many judgments which say sentencing issues should not be done on the same day. However, counsel argued that a judge cannot be proceeded against for an erroneous

judgement.

The bench recalled that a person was given death sentence in a span of nine days and the top court set aside that order and sent the matter back to the sessions court for fresh trial.

It said it will be a travesty of justice if adequate notice is not given, and also adequate opportunity not given to the person who is finally going to get the death sentence.

After hearing arguments in the matter, the top court issued notice

to the Registrar General and the state government on the claim by Rai that his suspension order and the pending disciplinary proceedings against him recorded no reasons. Rai, an Additional District and Sessions Judge in Araria, sought quashing of the non-speaking suspension order dated February 8, 2022 issued by the Patna High Court and the purported disciplinary proceedings as mentioned therein, being malicious, illegal and arbitrary

New Delhi, July 29: The Indian Air Force (IAF) is set to retire a squadron of MiG-21 Bison aircraft by September 30. Thereafter, only three squadrons of the aircraft will remain in service, which would be phased out by 2025. 'The 51 Squadron based out of

Srinagar airport is being number plated on September 30 ... Thereafter, every year one squadron will be fitted with a number plate," sources said.

The 51 Squadron is famous for thwarting Pakistan's air strike on India on February 27, 2019 and shooting down an F-16 by an aircraft flown by Wing Commander (now Group Captain) Abhinandan Varthaman. Sources said this is the only instance when a MiG-21 aircraft shot down an F-16 in an air-toair combat. IAF is replacing MiG-21 fighter jets with more capable aircraft like Su-30 and indigenous Light Combat Aircraft (LCA).

In the last 20 months, 6 MiG-21 aircraft have crashed in accidents in which five pilots have lost their lives. On Thursday evening, a MiG-21 Type 69 Trainer aircraft crashed in Barmer, Rajasthan killing both the pilots. The MiG-21 was supposed to be discontinued long back, but the delay in induction of the LCA Tejas aircraft has forced the

IAF to continue flying these aircraft. As per officials, the IAF conducts extensive checks of these aircraft before flight and all safety aspects are taken care of before the pilot takes off. Officials said that the number plated squadron would be reactivated soon with more capable aircraft



7,700 medicine samples declared poor quality

New Delhi, July 29: A total of 7.700 samples of medicines were declared not of standard quality and 670 declared spurious or adulterated out of a total 84,874 samples picked for testing during the last three vears

The government data disclosed that a total of 2,652 samples of medicines were declared not of standard quality and 263 were declared spurious or adulterated out of a total 84.874 samples picked for testing during the year 2020-21.

The enforcement actions were carried out in terms of samples tested, number of drug samples declared sub-standard and spurious/ adulterated during the last three years. While 164 persons were arrested as the concerned authority



initiated prosecutions in the year 2020-21, over 500 such arrests were made in the last three years. In a reply in the Lok Sabha on

Friday, the ministry of Health and Family Welfare said that the manufacture, sale and distribution of drugs in the country are regulated under the provisions of Drugs & Cosmetics Act, 1940 and Rules, 1945. The regulatory control over the manufacture, sale and distribution of drugs in the country is exercised through a system of licensing and inspection by the State Licensing Authorities (SLAs) appointed by respective State Governments. The SLAs are legally empowered to take action in case of violation of the condition of Licence.

The government has taken measures, including strengthening of legal provisions, workshops and training programmes for manufacturers and regulatory officials and measures such as risk based inspection.

In cases of fake and spurious drugs, various enforcement actions like drug seizure, arrests of accused persons / registration of FIR, etc., have been carried out by the states/UTs Drugs Controllers. The Central Drugs Standard Control Organisation (CDSCO) and the Union Ministry of Health and Family Welfare have taken various regulatory measures to ensure the quality of medicines distributed in the country The Drugs and Cosmetics Act,

1940 was amended under the Drugs & Cosmetics (Amendment) Act 2008 to provide stringent penalties for manufacture of spurious and adulterated drugs. Certain offences have also been made cognizable and non-bailable. Besides, the states / union territories were requested to set up special courts for trial of offences under the Drugs and Cosmetics Act for speedy disposal. So far, 33 states have already set up designated special courts.

Tokyo, July 29: Long-time allies the United States and Japan launched a new high-level economic dialogue on Friday aimed at pushing back against China and countering the disruption caused by Russia's invasion of Ukraine.

Japanese media said the so-called economic "two-plus-two" ministerial meeting in Washington was expected to agree on joint research for next-generation semiconductors to establish a secure source of the vital components.

The meeting was headed by US Secretary of State Antony Blinken and Commerce Secretary Gina Raimondo and Japan's Foreign Minister Yoshimasa Hayashi and Trade Minister Koichi Hagiuda.

"As the world's first- and thirdlargest economies, it is critical that we work together to defend the rules-based economic order, one in which all countries can participate, compete and prosper," Blinken told the opening session.

Blinken said recent world events, including Covid-19 and the war in Ukraine, had shown the vulnerability of critical supply chains, while a growing number of countries were struggling with debt burdens due to unsustainable and non-transparent lending practices.

SEMI-CONDUCTORS Japan's Hayashi called Russia's

invasion of Ukraine a serious challenge to the international order and - in an apparent reference to

China, though he did not name it directly - referred to attempts "to use economic influence unfairly and opaquely to realize... strategic interests and to modify the existing international order"

"In order to effectively deal with this, it is essential to discuss foreign policy and economic policy as a unit rather than discussing foreign policy and economic policy individually," said Hayashi.

Japan's Nikkei Shimbun newspaper said the semi-conductor development center would be set up in Japan by the end of this year to research 2-nanometer semiconductor chips. It will include a prototype production line and should begin producing semiconductors by 2025, it said, adding that the agreement to set up the center would be included in a statement to be issued after the meeting.

Taiwan now makes a vast majority of semiconductors under 10-nanometers, used in products such as smart phones, and there is concern about stability of supply should trouble arise involving Taiwan and China, which views the island as a renegade province.

Friday's meeting comes at a time of heightened tensions over Taiwan. On Thursday, Chinese leader Xi Jinping warned in a call with US President Joe Biden against playing with fire over Taiwan, highlighting Beijing's concerns about a possible visit to the Chinese-claimed island by US____ House Speaker Nancy Pelosi.

5G SPECTRUM AUCTION Bids worth ₹1,49,855 crore received; 71% of block sold

New Delhi, July 29: India's 5G spectrum auction received bids worth about Rs 1,49,855 crore as of Friday, the fourth day of sale, as continued interest for radiowaves stretched the bidding process to Saturday. About 71 per cent of the total

spectrum put on the block has been provisionally sold, Telecom Minister Ashwini Vaishnaw said. "This is a very good response," Vaishnaw said. Seven rounds of bidding took

place and incrementally Rs 231.6 crore came in Friday. In all, 23 rounds of bidding have been con-

ducted so far.

Billionaire Mukesh Ambani's Reliance Jio, Sunil Mittal-led Bharti Airtel, Vodafone Idea and a unit of billionaire Gautam Adani's flagship Adani Enterprises are in the race to bid for 5G spectrum, that offers speeds about 10 times faster than 4G, lag-free connectivity, and can enable billions of connected devices to share data in real-time.

After a flying start Tuesday, that saw players pouring in Rs 1.45 lakh crore on Day 1. A total of 72 GHz (gigahertz) of radiowayes worth at least Rs 4.3 lakh crore were put on the block.
