The aid for the various districts devastated by floods will be in a phased manner with some getting relief for 15 days while others for a week

Bhubaneswar, August 18: Chief Minister Naveen Patnaik carried out an aerial survey Thursday of some of the flood-hit areas of several districts and announced relief for 15 days for the affected people. Patnaik made an aerial survey of the Mahanadi delta area falling between Luna, Chitratola and Paika rivers in Kendrapara district, Kujang and Naugaon in Jagatsinghpur district, Gop. Nimapara, Astarang. Delang, Pipili and Kanas localities of Puri district. Secretary to CM (5T) VK Pandian accompanied Patnaik during the survey which lasted for more than an hour. Patnaik expressed concern over the large areas inundated by the floods and damage of crops and houses. He directed concerned officials to expedite the distribution of relief and cooked food to the affected people. He also asked officials to ensure proper healthcare services and drinking water supply in the flood-hit areas. He also asked officials to provide food and veterinary treatment to the affected cattle/livestock. After making the aerial survey, Patnaik announced relief measures for the affected people. 

Serial woman burglar 'Babli' nabbed, 'Bunty' still elusive

Ghaziabad, August 18: Police have finally managed to arrest a modern day 'Babli', a suspected serial burglar who worked as a domestic help and allegedly stole from around 100 houses, officials said here Thursday. However, his associate 'Bunty' has managed to remain elusive, though police is confident of

nabbing him soon. The woman (identified as Poonam Shah alias Kajal), has 26 cases registered against her in the National Capital Region NCR) alone. She would travel by air to various cities she worked in, a police officer said. Poonam can easily be termed a 'Babli' referring to the hit film Bunty Aur Babli (2005). In the film 'Bunty' (Abhishek Bachchan) and 'Babli'

Poonam mainly stole gold ornaments from her employers, and built a house for herself in Delhi allegedly with the proceeds of the crime, a police official said Thursday. She hails from Bhagalpur district of Bihar and targeted people in various cities including Delhi, Jodhpur, Kolkata, and Ghaziabad.

The case which led to her arrest is related to the theft of gold ornaments worth ₹10 lakh from Poonam's employer Vipul Goel's house in Ghaziabad. The police officer said Poonam, who is in her late 30s, was arrested from the Amrapali Village Society on the basis of CCTV footage with stolen gold ornaments worth ₹3 lakh in her possession.

Police official Sandeep Mishra said that during interrogation Poonam said she had planned the theft with the help of her accomplice 'Bunty'.



According to their plan, Poonam engaged Goel's wife in an animated conversation, and 'Bunty' stole the ornaments from an almirah. They both decamped from the complex in an auto-rickshaw and divided the stolen gold ornaments. Before she got the job as a house help here, Poonam was living in Delhi's Uttam Nagar.

According to the police, Poonam confessed she purchased a plot in Uttam Nagar and constructed a house on that using the stolen gold ornaments. She also said she had committed burglary at least in 100 houses and was booked in 26 cases across NCR districts, officials added.

Police said they will seize Poonam's ill-gotten property and book her under the stringent Gangsters Act. Mishra informed that 'Bunty' and the jeweller who purchased the stolen ornaments are at large and will be nabbed soon.

PRESS TRUST OF INDIA

Jamshedpur, August 18: Fifteen people were sentenced to death by a court in Jharkhand's East Singhbhum district Thursday for killing an inmate of the Ghaghidih Central Jail here during a clash between two groups June 25, 2019.

The court of Additional District Judge-4, Rajendra Kumar Sinha sentenced the 15 to death by hanging after convicting them under IPC sections 302 (murder) and 120B (criminal conspiracy), additional public prosecutor Rajeev Kumar said. The court also sentenced seven others to 10 years in prison after convicting them under IPC section 307 (attempt to murder). Kumar added. Two of those sentenced to death are at large, police said.

Two groups of inmates clashed in the jail leading to inmate Manoj Kumar Singh, suffering grievous injuries. On the way tohospital, Manoj succumbed to his injuries.

Bhubaneswar, August 18: A fresh spell of torrential rain over the next two days, owing to the formation of a new low pressure area (Lopar) Thursday, may exacerbate the flood situation in the state.

The weather system, third in two weeks, took shape over the northeast Bay of Bengal Thursday morning and is set to concentrate into a well-marked low pressure, the Bhubaneswar Meteorological Centre said.

It is expected to intensify into a depression over the northern Bay Friday morning and move northwestwards across the Gangetic West Bengal, north Odisha and Chhattisgarh, and Jharkhand, according to a bulletin.

The Met office asked fisherfolk, who are in deep sea, to return to the coast by Thursday. They have been advised not to venture off the coasts of Odisha and West Bengal for the next two days as the sea can be very rough. Squally weather with wind speed of 45-65 kmph is expected over the northern Bay.

12 Hirakud gates closed

With the rains letting up in the upstream of Mahanadi river in Chhattisgarh 12 of the 40 gates of Hirakud dam were closed, special relief commissioner PK Jena said. The reservoir level will be brought to 622 ft by 9am Friday, he added. Water Resources department chief engineer BK Mishra said there are seven breaches on the embankments of the Mahanadi river and its tributaries, and workers have been deployed to repair them. With the flood inundating over 1.757 villages and 10 urban areas, the state government has strengthened rescue teams of the NDRF, ODRAF and Fire Services, officials said.

The department predicted pouring rain in eight districts and heavy showers in seven Saturday.

Around five lakh people in 12 districts have already been affected by the flood in the Mahanadi river system due to incessant rain since last week due to low pressure and depression.





Bhubaneswar, August 18: The state government is taking steps to withdraw the power bestowed upon the rural police to impose penalty on traffic rule violators as per Motor Vehicles (MV) Act.

This was discussed at a highlevel meeting held recently under the chairmanship of Chief Secretary Suresh Chandra Mahapatra.

The state government has noticed that the police are harassing the staff of buses on the road throughout the state by issuing challans in fabricated manner.

It was decided that the notification issued by the Transport department in September 2019 for this purpose will be modified and the power will be delegated only on selected accident-prone stretches of national and state highways as notified in 2022 and in urban local bodies (ULBs), official sources said here Thursday.

The Transport department has sought views of the Director General of Police (DGP) and transport commissioner on the above issue for issuing government orders in the matter.

Balasore, August 18: In a tragic incident, a five-year-old boy drowned after falling into a 10-ft deep water tank filled with rainwater at Begunia village under Nilagiri block of Balasore district, Thursday.

The deceased was identified as Kiran Singh, 5, son of Gobinda Singh of the village. The incident occurred when the minor was playing near the water tank while his family members were busy working inside the house.

Family members searched for him frantically after they failed to find him. Later, they found the child floating in the tank and rushed him to the nearby hospital where the doctors pronounced him dead. The tank had been dug up by a consultancy agency engaged in construction of a mega drinking water project. It was filled with rainwater and the kid fell into it Thursday morning.

The incident sparked tension in the area as villagers and kin alleged that the kid died due to the negligence of the contractor and demanded compensation for the bereaved family members. On being informed, Nilagiri police reached the spot and placated the irate residents and sent the body for post-mortem.

Puri, August 18: Sitting in her house in the nondescript Gundalba village in Puri district, Charulata Biswal, 55, speaks with poetic creativity. A noted environmental crusader, she has received numerous accolades, but the awards and recognitions have not made her shun the simplicity. Her testimonials reflect the culture and aesthetics of her work, more than scientific references

"The cool breeze under the shade of the tree on a hot summer afternoon, the soft ruffling of leaves as wind brushes past, the melodious chirping of the birds nested in the tree... These are the little joys in life that only a tree can provide," she articulates her emotions in Odia, in a near melodic cadence. For over two decades now.

Charulata and a group of 75 women from adjacent villages have been guarding a casuarina forest in Gundalba from timber mafia. Additionally, they protect the mangroves around the coastal belt that lies in close proximity to the village. which comes under Astaranga block.

The Super Cyclone and its aftermath The devastating Super Cyclone of October 1999, which swept away several villages along Odisha's coast, was their wake-up call. Though inundated, Gundalba, which lies half a km from Astaranga beach, was not cut off. "The mangroves saved us. They

reduced the pace of the waves entering our village. If not for these trees, our village could have been washed away," says Charulata. Two years later, under the aegis

of Pir Jahania Van Surakhya Samiti - it was named after the spiritual shrine situated near the village women from each household of Gundalba joined the green drive. Their counterparts from other villages joined in gradually. The areas of conservation were demarcated for the convenience of the partic-

ipant villages. The thengapali method

Women in Gundalba use thengapali method to protect the casuarina forest. In local parlance, thenga means a stick and pali means turn. So, armed with sticks a group of 10 to 12 women stay on guard throughout the day. Each week, a group takes up the task of patrolling the woods. They watch out for anyone trying to cut a tree. They work in two shifts: from 8am to noon and post-lunch to sunset. "Sometimes, we also venture

out in the dark, if we get information about anyone sneaking into the forest. Those in our village follow the rules, but outsiders cause trouble at times." says a woman associated with the group.

Since the women also have households to look after, their duty hours have to be managed efficiently.

"In a household where only one member is female, she completes all daily chores before venturing into the forest. If the family has more women, we place them in different groups so that at least one of them is present in the house to manage chores," says Mehjabeen Nisa, a member of the group.

If any intruder is caught, he is usually let off with a warning. But if the situation gets out of hand, the local administration is informed. Nisa recollects one such incident, which took place over two years ago. "A large group of people had come to the forest once to cut the trees down. When we tried to stop them, they behaved violently. We immediately informed the Forest department about the matter," she recalls.

stick and pali means turn

Local residents are dependent on the forest for firewood, but they mostly rely on agriculture to make ends meet. The women on forest duty always allow people to collect broken twigs and dry leaves, but ensure that no trees are touched. A safe spot for Olive Ridleys

Women led by Charulata also offer their services to protect the nesting places of Olive Ridley turtles along Astaranga beach. "We all belong to the same village and help each other. The women who protect the forest also clean the beach area regularly. This is an important aspect in the Olive Ridley conservation," says Bichitrananda Biswal, an Olive Ridley conservationist. Inside the forest, the women keep an eye on water bodies frequented by animals. If the ponds run dry, they alert the local administration.

Globally, there are numerous studies that highlight the successful implementation of communityled efforts to conserve local biodiversity. While it is difficult to ascertain accurate statistical data on what impact they make - since most such endeavours are voluntary in nature - studies and surveys by local NGOs report improvement in the overall health of the forests after such initiatives.

"Women and forests are dependent on each other. When there is a dip in forest cover, women are the first to know as they rely on forest resources a lot," says Sanjukta Basa, a subject expert from Odisha who has followed thengapali closely. A report suggests that the forest cover in Astaranga region is up by 63 per cent - from 2.58 sq km in 1985 to 4.21 sq km in 2004. The women themselves have realised this positive change. "We now spot deer in the forests. Sometimes, they enter agricultural lands and damage crops, but we are still happy to provide them a habitat by protecting the forest," says Charulata.

A helping hand

The concept of Joint Forest Management is gaining ground, but there are challenges on the way, primarily due to the lack of coordination between different stakeholders and the conflicts in management. Being voluntary in nature. most community conservation efforts are driven by motivation, often due to cultural resemblances. The villagers of Gundalba also started off voluntarily, but were backed by the forest department since 2009. "We do not get any monetary support, but the forest department supports us in case of a rift with intruders. We are in a way recognised by them for the work we do," says Nisa.

"Our work is to protect the forest and that is all what we know. Today, a lot of people are recognising our efforts. We might not understand the technicalities, but we understand the forest and will workto conserve them till our last breath," Charulata concludes.







Govt relief for flood-hit districts

After his return from the aerial survey Patnaik tweeted in Odia that the flood has caused extensive damage to agriculture, roads. houses and other infrastructure.

Around five lakh people in 12 districts are reeling under the floods caused by the Mahanadi river after incessant rains lashed the state last week in the wake of a low pressure and a subsequent depression. There were reports of two minors missing in Cuttack and Balasore districts. The floodhit districts are Angul, Bargarh, Boudh, Cuttack, Jagatsinghpur, Jaipur, Kendrapara, Khurda. Nayagarh, Puri, Sambalpur and Subarnapur.

The country saw a single day rise of 12,608 new coronavirus infections taking the total tally of Covid-19 cases to 4,42,98,864, while the active cases declined to 1,01,343, according to the Union Health Ministry data updated Thursday. The national death toll climbed

to 5,27,206 with 72 fatalities, including 29 fatalities by Kerala, the data updated at 8 am stated. The active cases comprised 0.23

per cent of the total infections, as the national Covid-19 recovery rate was recorded at 98.58 per cent, the health ministry said.

A decline of 3.715 cases was recorded in the active Covid-19 caseload in a span of 24 hours. The daily positivity rate was recorded at 3.48 per cent, and weekly at 4.20 per cent, according to the

'Child labour, caste discrimination, poverty closely linked in India'

hild labour, caste-based discrimination and poverty are closely inter-linked in India, according to a UN report which highlighted contemporary forms of slavery, including severe discrimination against Dalit women in South Asia due to which they are systematically denied choices and

freedoms in all spheres of life. Human Rights Council Special Rapporteur Tomoya Obokata in his report on contemporary forms of slavery, including its causes and consequences, said that deep-rooted intersecting forms of discrimination, in combination with multiple other factors, are the main causes

of contemporary forms of slavery affecting minorities. They are often the result of historical legacies, such as slavery and colonisation, systems of inherited status, and formalised and State-sponsored discrimination, he said. Obokata said in the report to the UN General Assembly Wednesday that child labour (among children 5 to 17 years of age), including its worst forms, exists in all regions of the world.

In Asia and the Pacific, the Middle East, the Americas and Europe, between 4 and 6 per cent of children are said to be in child labour, and the percentage is much higher in Africa (21.6 per cent), with the highest rate in sub-Saharan Africa (23.9 per cent).

"In India, child labour. castebased discrimination and poverty are closely interlinked. Child labour among minority and migrant children have also been reported in Angola, Costa Rica, Honduras and Kazakhstan, in various sectors," the report said.

The report also notes that systematic discrimination has profound implications for the ability of affected individuals and communities to live a life of dignity and enjoy human rights on equal footing with others. Marginaliaed communities often remain overlooked in public policies and national budgetary allocations, and their access to justice and remedies in cases of human rights violations, including contemporary forms of slavery, is generally limited.

It said that the stigmatisation



of some communities is perpetuated by negative stereotypes in the media, textbooks, or on the Internet, which contributes to their disempowerment. People discriminated against

on the basis of work and descent represent one example. They are bound by their inherited status and subjected to dehumanizing discourses that refer to "pollution" or "untouchability", with no re-

spect for human dignity and equality. "Consequently, such people have limited freedom to renounce inherited occupations or degrading or hazardous work and are often subjected to debt bondage without sufficient access to justice," the report said.

"Additional intersectional factors, such as class, gender and religion are also affected by caste realities. Dalit women in South Asia

The report further notes that bonded labour continues to be prevalent among people discriminated against on the basis of work and descent, such as Dalits in South Asia.

Dalits in Bangladesh are forced to undertake certain types of labour as a consequence of their assigned caste status and are almost exclusively working in "unclean" jobs in urban areas, like street sweeping and burying the dead.

"Manual scavenging, predominantly carried out by Dalit women, is widely regarded as forced labour and a contemporary form of slavery, entailing harsh working conditions that have a negative impact on mental and physical health."

Obokata said in the report rates of child marriage spike among marginalized communities in particular, such as Roma girls in South-Eastern Europe.

Official data collected by the Forced Marriage Unit of the United Kingdom and Northern Ireland suggests that a large majority of forced-marriage cases relate to Pakistan and, to a lower extent, to Afghanistan, Bangladesh, India and Somalia.

Forced marriage of women and girls is a concern in Asia, including Cambodia, India, Kazakhstan, Sri Lanka, and Vietnam.

Man duped of ₹99k on pretext of . outstanding power dues in Ganjam

Berhampur, August 18: Cyber criminals have again defrauded a person of Rs 99,000 from his bank account on the pretext of collecting outstanding energy bills in Silk city, police said Thursday.

The duped man was identified as TK Prasad, a resident of a private apartment near Budhi Thakurani temple under Bada Bazaar police limits in the city. The matter came to the fore after Prasad lodged a written complaint at the Cyber Police Station. The fraudsters first took Rs 10 from his account and later withdrew Rs 99,600 from his bank account. Police have registered a case and started an investigation. Reports said, Prasad received a

message on WhatsApp where an un-



known person had asked him to contact on a number, August 8. Prasad called the number and talked to

the person who identified himself as a staff of the power distribution company

He asked him to deposit his outstanding energy bill by 9pm the same night failing which his power supply will be disconnected. The caller also asked him to deposit the money online and sent him a link for the purpose.

Later, he clicked on the link and sent Rs 10 as initial amount to the number via digital payment app GooglePay. Soon after, messages flashed on his mobile phone and he found that a total of Rs 99, 600 had been withdrawn from his account in four phases. He realised that he had been defrauded and informed the bank authorities and later lodged a complaint in the Cyber Police Station.

Dhenkanal, August 18: Over three years have passed since the announcement but the National Waterways project in Odisha's two major rivers Mahanadi and Brahmani have remained a non-starter.

Union Minister Nitin Gadkari had announced this while laying the foundation stone for expansion of National Highway-53 at Sarangdhar Stadium in Kamakhyanagar of Dhenkanal district, February 6, 2019. Gadkari had said that the establishment of an inland waterway project is essential for the development of the state.

The Centre will spend over Rs 5,000 crore for this mega project which will open a new chapter in the field of import and export, he had declared, spreading cheers among the residents.

The aim behind including these two rivers in this Centre-sponsored project was to facilitate plying of cargo ships. The cargo ships would ferry manufactured goods and heavy equipment from the industrially rich Dhenkanal, Angul and Jajpur districts. The implementation of the National Waterway



nouncement, a roadmap was prepared by the state Works department to construct new bridges on the rivers and upgrade the existing bridges to greater heights to facilitate plying of cargo ships. However, the project is yet to take off with Centre remaining silent on the project. Accordingly, construction of

new bridges has been started in Dhenkanal district. However, the project has remained a non-starter with no instruction yet available on upgradation of two old bridges. The project is mired in haze as no clear picture is yet available whether the heights of these old bridges will be increased as per guidelines or they will be dismantled to con-

struct new bridges. As per guidelines, if these old bridges will be dismantled then what will be the deadline for construction of new bridges and what will be the alternative to cross the river during the period of conits stand and issue any guideline. struction, locals expressed concern. Meanwhile, three years have passed since Gadkari made this announcement and no report is available as to when and how it will be implemented. The state government has written letters to the Centre asking it to clear the doubts surrounding the project but the latter is yet to reply. Residents have termed it as sheer eyewash with no response plement the project. However, not much coming from the Centre. headway has been made in this front.

Notably, the National Waterways Act received the approval of the Centre in 2016. This project has been named as the Talcher-Dhamara Jalmarg-5. Accordingly, a new bridge at an expense of Rs 205 crore is being constructed on the Brahmani river from Kaluria in Gondia block to Dighi in Bhuban block of Dhenkanal district. The

Tryst with tussar lets tribals earn with dignity

Keonjhar, August 18: Tussar farming has turned out to be a boon and changed the lives of scores of landless tribals including women in Keonjhar district. It has enabled them to earn their livelihood with dignity

Tussar farming involves growing cocoons from which the silk yarn is extracted to make silk. The fabric is in great demand both in and outside India.

Mamata Naik, 36, a poor landless woman of Dhaladihi village under Phulajhar panchayat of Bansapal block in the district is a case in this point. She was earning her livelihood by working as a casual labourer with her job being collection of tussar from nearby jungles.

Little did she know that the tussar she was collecting will one day change her life! The district administration officials one day contacted her and asked her to take up tussar farming. She was provided with 2.5 acre of land to start cultivation.

She planted 'Arjun' and 'Asana'



trees on the land with the financial assistance she received from the district mineral foundation (DMF) and Mahatma Gandhi National **Employment Guarantee Scheme** (MGNREGS). Her tryst with tussar helped her increase her income substantially

Soon the efforts of the district administration paid off as many tribal and landless farmers got attracted to tussar farming and took up its cultivation to earn their livelihood. With funds available from the DMF. tussar plantation has now come up on vast tracts of land. A nursery has also been set up and a cocoon-preserving unit has also been built.

The cloth prepared from tussar is in great demand among fashion connoisseurs. Sensing the enthusiasm among local people, the district administration is also planning to establish two mega nurseries at Bansapal and Harichandanpur in the district.

The administration is also trying to spread tussar cultivation to other areas for which it has plans to establish a tussar seed production centre and a disease prevention centre. It is also planning to establish a

'Tussar Development Committee' and TRCS to attract more and more people towards tussar farming.

Over, 6,600 people are presently employed in tussar cultivation and its manufacturing in this district. 'Arjun' and 'Asana' trees have been planted in over 600 hectares of land for production of cocoons.

Experts are of the opinion that tussar cultivation can be a great life changing activity in areas that suffer due to mining activities. The cultivation will help reduce poverty, increase green cover on unused land and help in protecting environment.

Push for fruit farming under **MGNREGS** in Mayurbhanj

Baripada, August 18: The horticulture department has planned to promote fruit farming in a big way through Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in tribal-dominated Mayurbhanj district in order to create scope of earning for local populace and farmers.

It will be executed under the rural job scheme, a good scope of work for scores of job card holders and local labourers will be created thereby, a report said. 

GETTING PRODUCTIVISM RIGHT

wrote recently about the possible emergence, from both the Left and Right of the political spectrum, of a new economicpolicy paradigm that could supersede neoliberalism. The new framework gives governments and community organisations greater responsibility to shape investment and production – in support of good jobs, the climate transition, and more secure, resilient societies-and is much more suspicious of markets and large corporations than the outgoing paradigm is. I called it "productivism," though others can no doubt think of sex-

Throughout history, the pendulum of economic ideology has swung from deification of markets to reliance on the state and then back again. Superficially, we appear to be in the midst of another periodic realignment. It was perhaps inevitable that neoliberalism's excesses - increased inequality, concentration of corporate power, and neglect of threats to the physical and social environment would trigger a backlash.

But establishing new paradigms requires developing novel approaches, not just emulating the old. When the New Deal and the welfare state replaced the freewheeling capitalism that preceded them, policymakers did not simply revert to former mercantilist practices. They established new regulatory regimes and social-insurance institutions, and embraced explicit macroeconomic management in the form of Keynesianism.

Similarly, if productivism is to be successful, it will have to move bevond conventional social protection, industrial policies, and macroeconomic management. It will need to internalise lessons learned from past failures and adapt to fundamentally new challenges.

State interventions aimed at reshaping an economy's structure so-called industrial policies - have traditionally been faulted for being ineffective and vulnerable to capture by special interests. "Governments cannot pick winners," as the old adage goes. But much of this criticism is overdone. While there have been notable failures, recent systematic studies find

Public-sector initiatives have been behind some of the most impressive high-tech successes of our time, including the internet and GPS. For every Solyndra, the US solar cell manufacturer that failed spectacularly after obtaining \$500 million in federal government loan guarantees, there is often a Tesla, the phenomenally successful electric battery and vehicle manufacturer that also received government support at a critical phase of its development.

Nevertheless, there is much room for improvement. The most effective industrial policies entail close, collaborative interaction between government agencies and private firms, whereby companies receive critical public inputs -financial support, skilled workers, or technological assistance in exchange for meeting soft and evolving targets on investment and employment. This kind of industrial policy is likely to work much better - whether in promoting local economic development or directing major national technological efforts - than openended subsidies or tax incentives.

As the name suggests, productivism focuses on enhancing the productive capabilities of all re-

facturing, including the bill recently passed by Congress that

A similar point can be made about the subsidies for green technologies that are a core component of the Inflation Reduction Act. which President Joe Biden is likely to sign soon. The green transition is without question an urgent priority that the new paradigm needs to tackle. But here, too, governments cannot kill two birds with one stone. Policies that target climate change are not a substitute for good-job policies, and vice versa.

Shoring up the middle class and disseminating the benefits of technology broadly through society requires an explicit good-jobs strategy. It is too soon to tell whether a new productivism paradigm will jell, let alone prove adequate to the tasks at hand. Inflation worries may yet come to dominate policymaking and subordinate structural transformation. Price sta bility is a sine qua non for the pursuit of productivist economic policies. But a return to orthodox macroeconomic approaches focused on monetary tightening and deficit reduction will leave little fertile ground for policy innovation and experimentation.

Ultimately, what economies need is sound ideas, not necessarily a new paradigm. By the time any set of ideas becomes conventional wisdom, it is riddled with onesize-fits-all generalisations and truisms that are bound to be unhelpful and misleading. If the new thinking on productivism is successful, it will eventually be described as a "paradigm," whether we call it that or not.

the country. According to a recent Pentagon reidentification zone port, the US has no plans to retrieve or destroy the equipment, despite recognising that the Taliban has already "repaired some damaged Afghan Air Force aircraft and made

incremental gains in its capability to employ these aircraft in operations." In short, Biden's decision to overrule his generals and withdraw from Afghanistan – a month before his own target date of September 11 – has created a security and humanitarian nightmare. And Biden is nowhere near finished making foreign-policy blunders in Afghanistan.

After Kabul's fall, US Secretary of State Antony Blinken declared that the US would judge its future engagement with the Taliban-led government based on "one simple proposition": whether it helps the US advance its interests, including "seeing that women's rights are upheld," delivering humanitarian assistance, and pursuing counterterrorism. But even though the Taliban has failed on all three counts, the Biden administration is gradually easing sanctions on the regime.

At the UN, the US spearheaded a resolution providing for a humanitarian exemption to the sanctions imposed on Afghanistan. The US Treasury Department's General Licenses, aimed at facilitating the provision of humanitarian relief, now allow financial transactions involving the Taliban and the Haqqani network. And the US is currently negotiating with the Taliban

over the release of \$3.5 billion of Afghan central-bank reserves.

Meanwhile, the US refuses to target Haqqani or other leading terrorists in Kabul. Yes, al-Zawahiri was assassinated, but, contrary to the Biden administration's narrative, he was not all that influential. He was largely retired, living with members of his extended family in a Kabul house under Haqqani's protection.

What's next? Will the US now reward Pakistan - one of America's 18 "major non-NATO allies" – for opening its airspace to the drone that killed al-Zawahiri? True, Pakistan reared the Taliban and engineered the US defeat in Afghanistan, but now it wants an early International Monetary Fund loan dispersal to help it avert a debt default.

Likewise, will the US now continue to pursue the release of Afghanistan's central-bank reserves to the Taliban, despite its indisputable harboring of terrorists and establishment of an oppressive and violent Islamic state? The Biden administration defends its engagement with the Taliban by speciously contending that the top terrorist threat in Afghanistan is the Islamic State-Khorasan. But ISIS-K has relatively few members, no state sponsor or Afghan allies, and controls no territory.

The Biden administration seems committed to striking a kind of Faustian bargain with the Taliban. But to what end? The Taliban's political power and Islamist ideology make it a critical link in the international jihadist movement. And its rule is threatening to turn Afghanistan into a breeding ground for international terrorism, narcotics trafficking, and mass migration. There is no justification for engaging with it.

Through its precipitous and bungling withdrawal from Afghanistan, the Biden administration handed Islamists worldwide their greatest victory. But the war in Afghanistan is hardly over. As the Taliban's self-styled emir, Mullah Haibatullah Akhundzada, recently declared, "This war never ends, and it will continue till judgment day."



🝸 ndia is celebrating 75 years of "anti-national" have been included made the BJP - a party which it is mated under the BJP juggernaut. its Independence. An apt time to reconcile the republic's gains and losses and also access where the critics of the current government have gone wrong. India and Indians have travelled a long way on the road to democracy during the last 75 vears. We have every reason to be proud of our country and its achievements.

However, the critics of the current government say that the Indian democracy is under siege. They point out further that Indian democracv is in serious decline according to major international democracy rankings, or that India may no longer be a democracy at all. They claim that the deterioration in the quality of democracy has only accelerated since the 2019 re-election of the BJP led by Prime Minister Narendra Modi. Critics also allege that due to the social engineering initiated by the BJP, historically oppressed Bahujan (backward) are sought to be marginalised as do the religious minorities who find themselves identified as internal enemies. Bemoaning further they allege that liberals and leftists, activists who have raised issues of the environment and human rights, and anyone else perceived to be to the list of internal enemies.

Whither Opposition parties

They turn hoarse saying dissent is muzzled, increasingly through official edicts. Old controversies like in Mathura and Varanasi over temples and mosques are reignited, and claims that mosques were built upon the demolition of temples have resurfaced. They allege the social fabric knitted together by diverse communities is being torn and new religious flashpoints have been created.

It would be pertinent to note that India shares its democratic degradation with many other countries across the world. This process has been variously described as authoritarian, populist, ethnocratic, exclusionary and fascist. But to be sure, the dominant groups in ethnocracies value democracy - at least for themselves - and often take pride in their democratic institutions. But a polity based on the structural exclusion of a section of its population cannot reasonably be said to qualify as a democracy.

However, all these shrill noises of criticism and dissent beg a question. If all these accusations are true, then what has prevented other political parties to prevent this bulldozing by the BJP and adopt the practices and systems which have

today? There is a good reason why the BJP is in power in 18 states out of 28, and has more than 400 members in Parliament, and 1,300 legislators in state assemblies. Driving the party is its 'here and now' approach. There is no room for political complacency - with an energetic PM who communicates with the people directly; there is simply no other option for karyakartas (workers). Contrast this with other political parties. BJP's careful planning, managing its cadres and execution resulted in these victories. whereas the Congress had lost the plot much before the 2014 elections.

Before that the Communists, too had lost the plot completely. Their rout was more or less linked to the booming of the Indian economy after India opened up its economy and the market reforms rolled in. The middle class which now had access to more consumer goods and could aspire to a more lavish lifestyle, had no place for the politics of demonstrations and agitations.

Other smaller parties like the Samajwadi Party or the RJD or the NC, except the south Indian parties, were interested in furthering their own petty selfish goals and they were nearly deci-

As far as the minorities of India are concerned and particularly the largest minority -- the Muslims, they themselves are to be blamed for their woes. After independence the community as a whole seems to have withdrawn into a shell. It was not seen as part of the mainstream, their self-promoting leaders kowtowed to their political masters by assuring them of Muslims' votes for their own personal benefit. These leaders failed to drive their community to a path of greater learning and become an essential part in the country's growth, as the others like Sikhs and Parsis did.

Right now it is a Right-wing push that is dictating the frenetic pace of statecraft now, but there is nothing wrong in this, as the Right wing has come to power using the democratic tools available to every party. This makes us ponder what has stopped the other political parties from adopting the same strategy and planning? If they are not up to it then they themselves are to be blamed. No one else! Stop bemoaning! Get your act together!



Judicial remand of Partha, Arpita extended by 14 days

Kolkata, August 18: A special court of Enforcement Directorate (ED) Thursday extended the judicial custody of Partha Chatterjee and Arpita Mukherjee, both tainted in the multi-crore West Bengal School Service Commission (WBSSC) scam, by another 14 days.



Surprisingly, although Partha Chatterjee's counsel moved a bail plea on behalf of his client, a similar approach was not evident of Arpita Mukherjee's counsel.

Chatterjee's counsel moved the bail plea on his client's health grounds. However, ED's counsel objected to the plea claiming that despite having some chronic illness, Partha Chatterjee's condition is not that critical that he will have to be granted bail. Finally, after hearing all parties, the court rejected the bail plea and ordered the extension of judicial custody for both by another 14 days.

The court also approved the ED counsel's plea that the central agency officials be allowed to interrogate Partha Chatterjee and

Arpita Mukherjee in the prisons. The ED counsel furnished fresh documents relating to the financial involvement between Partha Chatterjee and Arpita Mukherjee. They even furnished a document that showed that the premium for a life insurance policy held by Mukherjee with Chatterjee as a nominee, was paid from a bank

account held by Chatterjee. On Thursday afternoon while Chatteriee was brought to the court, Partha Chatterjee told media persons that everything will come clear some day or the other. "None____ will be spared," he added.

Govt blocks 8 YouTube channels for fake news AGENCIES

New Delhi, August 18: The Union Ministry of Information and Broadcasting has blocked eight YouTube channels, seven Indian and one Pakistan based, for spreading disinformation related to the country's national security, foreign relations and public order.

The Ministry, utilizing the emergency powers under the IT Rules, 2021, had issued orders for blocking the eight YouTube news channels. one Facebook account, and two Facebook posts.

The blocked *YouTube* channels had a cumulative viewership of over 114 crore, and were subscribed by over 85 lakh users. Analysis of content revealed that the purpose of the content published by some of these YouTube channels was to spread hatred among religious communities in India.

False claims were made in various videos of the blocked channels and content was found to have the potential to create communal disharmony and disturb public order in the country.

The channels were also used to post fake news on various subjects such as the Indian Armed Forces, Jammu and Kashmir, etc. The content was observed to be completely false and sensitive from the perspective of national security and India's friendly relations with foreign States. Globally, internet restriction cases decreased by 14 per cent in the first half - from 84 in the second half of 2021 to 72 this year. 'We see a positive trend of in-

ternet restriction cases going down this half of the year. Nevertheless. the number of countries that use internet disruptions as a weapon to silence citizens' unrest remains

worryingly high," said Agneska Sablovskaja, lead researcher at Surfshark.

Most cases are of national or local magnitude where the internet is slowed or completely shut down, leaving its people without most of their means of communication, Sablovskaja said in a statement.

In the first half of 2022, Surfshark registered 66 internet blackouts in six countries and territories

Burkina Faso, India (Jammu & Kashmir), Kazakhstan, Pakistan and Sudan.

Internet was shut down locally in Jammu & Kashmir and Pakistan.

In comparison, three countries (Burkina Faso, Kazakhstan, and Sudan) chose to cut down internet connections nationwide, even though it cripples the economy the most.

The slight decrease in observed nation-scale internet shutdowns in early 2022 follows a period of unprecedented reliance on the internet during the pandemic, said Alp Toker, CEO of NetBlocks, the global Internet watchdog organisation.

Research shows that social media censorship cases this year spread through all continents.

According to the report, 5.7 billion people in 76 countries have been deprived of Internet access since 2015.

Jammu, August 18: Amid controversy over inclusion of outside voters in Jammu and Kashmir electoral rolls, government officials Thursday cited rules to assert that any citizen of India who has attained the qualifying age and ordinarily residing at a place is eligible to get registered as a voter. Upping its ante, National

Conference (NC) president Farooq Abdullah has convened an allparty meeting here August 22 to formulate a common position on the issue of inclusion of outside voters in Jammu and Kashmir electoral rolls.

The meeting will discuss the future course of action on this new development.

With the abrogation of Article 370 and applicability of Representation of the People Act 1950 and 1951, any citizen of India who has attained the qualifying age and 'ordinarily residing' at a place is eligible to get registered in the electoral roll of that place, if not disqualified otherwise, a senior government official said.

The official said prior to the abrogation of Article 370, the assembly electoral rolls in Jammu and Kashmir were made under the ambit of Jammu and Kashmir Representation of People Act 1957, wherein only permanent residents were eligible to get registered in the assembly rolls and possessed consequential voting rights in assembly elections.

It is provided he gets his name deleted from electoral roll of his native constituency, as registration at two places is not permitted under law, the official said.

At a press conference Wednesday, Jammu and Kashmir's Chief Electoral Officer Hirdesh Kumar said the Union territory is likely to get around 25 lakh additional voters, including outsiders, after the special summary revision of electoral rolls being held for the first time after the abrogation of Article 370.

Prior to the abrogation of Article 370, these people were eligible to get registered in the electoral rolls, if they were ordinarily residing in any of assembly segments of Jammu and Kashmir, but had the right to vote only in parliamentary elections and were categorised as Non Permanent Resident (NPR) voters, officials said, adding during the last parliamentary elections, there were approximately 32.000 such NPR voters.

Raigad (Maha), August 18: A crew-less Australian-couple owned speed-boat with some sophisticated weapons -- adrift in the Arabian Sea for 52 days -- washed ashore at Harihareshwar Beach in Raigad coastal district, sounding alarm bells Thursday, a day ahead of the crowded 'dahi-handi' celebrations.

The incident suddenly revived the chilling memories of the 1993 Mumbai serial terror strikes when huge quantities of arms, ammunitions and explosives had been surreptitiously offloaded at certain small ports or beaches on the Raigad coast.

Mumbai, August 18: The breeze on the face of passengers on the upper deck of Mumbai's famed double-decker buses will be a thing of the past as the electric ones set to be introduced by the Brihanmumbai Electric Supply and Transport Undertaking are air-conditioned with a giant windscreen playing spoilsport.

However, transport enthusiasts who have been using the conventional double-decker for years now, agreed that the breeze apart, views will be better with bigger windows. These 65-seater buses will re-

place the existing double-decker fleet of the civic-run undertaking

Existing double decker buses have a single wide door, while some conventional buses with double doors had seen one of them being sealed by BEST authorities.

The interior of the new doubledecker buses set to be introduced are white with green hued seats with belts, and passenger amenities include laptop and mobile phone charging points and a passenger address (PA) system.

However, head space for those on the window seats may be on the lower side due to the AC duct, which may cause some problem for tall passengers on the stairway behind the driver as well.

MAN DIES HOURS AFTER COLLAPSING **DURING RUNNING TEST FOR AGNIPATH**

Marathwada University campus since the last couple of days, the official said.

Pawar, who was running as part of one of the fitness tests for the recruitment process, collapsed on the ground around 1 am Thursday. He was taken to the Government Medical College and Hospital for treatment, but

died in the morning during treatment, he said.

After the post-mortem, his body was handed over to his family members this evening, a senior official of Begumpura police station said, adding that a probe will be conducted into the death.

The scheme seeks to recruit youngsters in the age bracket of 17-and-a-half to 21 years for a four-year period, with a provision to retain 25 per cent of them for 15 more years. For 2022, the upper-age limit has been extended to 23 years.

Several parts of the country had witnessed violent protests against the scheme that largely provides for a four-year tenure on a contractual basis and does notoffer pensions and other benefits that regular soldiers are given.













Chennai, August 18: AIADMK leader O Panneerselvam Thursday extended an olive branch to his rival, "dear brother" Edappadi K Palaniswami (EPS) to run the party jointly and said "let bygones be bygones" but the latter ruled out any association with OPS and even blamed him for the party's defeat in the 2021 Assembly polls which the DMK-led bloc swept.

Incidentally, Pannerselvam's call for unity also pertained to deposed AIADMK leader VK Sasikala and her nephew TTV Dhinakaran. Palaniswami also moved the

Madras High Court against a single judge order on Wednesday which declared as not valid the AIADMK General Council resolutions of July 11, which among others, 'expelled' Panneerselvam and picked EPS as the party's interim general secretary.

A day after securing the High Court order in his favour, OPS informed there had never been an issue with the earlier dual leadership but said the arrangement of "joint leadership" was brought in to steer the party in the absence of late Chief Minister J Jayalalithaa.

"After Amma's death (in December 2016), dear brother Palaniswami became CM and we travelled along extending good cooperation. Many democratic duties were discharged



by us," he said.

'After Amma's death. Dharmayudham was undertaken (by him against deposed leader VK Sasikala and her family) and as per the wishes of party workers and leaders, it was decided as a policy that AIADMK will function under joint leadership," he told reporters here. As a result, the Coordinator (OPS) and the joint coordinator (EPS) posts were created. Panneerselvam added.

There was no shortcoming in this aspect from either leaders as they diligently performed the roles in the interest of the party and within the ambit of its laws, the former CM said.

AIADMK workers had set their political path as "brothers" of the party founder, the late CM MG

Ramachandran and "sons" of Amma (Javalalithaa). but due to some "difference of opinion" there was an "abnormal situation," OPS said, in an apparent reference to the differences with Palaniswami.

"Let bygones be bygones...Would never sav it affected us...1.5 crore party workers and the people who desire the good rule of MGR and Amma want this movement to remain united. Without holding any grudges of the past bitterness, we should throw them away (as) the party's unity should be the sole idea," he said.

Such an association was the desire of the party's 1.5 crore workers, Panneerselvam said. Asked if his invitation extended to Sasikala and Dhinakaran also, the senior leader said it applied to all those

"who strived for the party during" the period of MGR and Jayalalithaa and responded in the affirmative when prodded further. Sasikala was a confidante of Jayalalithaa and was 'expelled' from the AIADMK in 2017, months after she was jailed in a disproportionate assets case. Hitting out at Panneerselvam. Palaniswami said his rival often gave such invitations. "Against whom did he undertake Dharmayudham. He is now inviting them all. He wants posts, can't live without it. He does not struggle for them, but wants post for himself and his family," the for-

mer CM told reporters. He slammed Panneerselvam's son and Lok Sabha MP P Ravindranath for "praising" the MK Stalin-led DMK government, after meeting the CM recently and claimed that this had "demoralised" the party's rank and file. The AIADMK was founded by the late MGR against the DMK, he pointed out.

"How can we join. Should he (OPS) not have come to the General Council. He went to the party of fice with rowdies and attacked it. broke open the doors, damaged comps and stole key documents. How can we work with such a person who employs rowdies and goondas, despite being in the leadership role. Party workers were attacked. How can I work with him?' Palaniswami asked.

CBI conducts searches

in missing coins case

New Delhi, August 18: The CBI Thursday conducted searches at 25 locations in connection with a case of coins worth Rs 11 crore going missing from the vaults of an SBI branch in Karauli in Rajasthan, officials said Friday.

The searches were spread across Delhi, Jaipur, Dausa, Karauli, Sawai Madhopur, Alwar, Udaipur and Bhilwara at the premises of around 15 former bank officials and others, they said.

The matter came to light after the State Bank of India (SBI) branch decided to carry out counting of money after a preliminary enquiry indicated discrepancy in its cash reserve at Mehandipur branch in Karauli district in August 2021. Alarmed bank officials had roped in a Jaipur-based private vendor to do counting of coins supposed to be Rs 13 crore according to account books

To their shock, the vendor found only 3,000 bags carrying coins worth about Rs 2 crore coins while over coins of Rs 11 crore were missing from the branch. It is also alleged that the em-

ployees of the private vendor who were doing the counting were threatened in the night on August 10, 2021 at the guesthouse where they were staying and were asked to refrain from the counting, the FIR has alleged

SBI had approached the Rajasthan High Court seeking a CBI probe into the matter as the missing amount was higher than Rs 3 crore, the threshold for seeking a probe by the agency.

On the high court's directions. the CBI has taken over the FIR earlier registered by the Rajasthan Police.

A HUGE ROW HAS ERUPTED IN RAJASTHAN **OVER THE KILLING OF A 9-YEAR-OLD STUDENT FOR DRINKING WATER FROM** THE POT KEPT FOR HIS TEACHER. A SO-CALLED 'UPPER CASTE'

Jaipur, August 18: The death of Class 3 Dalit student in Jalore district of Rajasthan after being bashed up by his school teacher is opening up new revelations each day, nullifying the claims being made earlier.

The initial fact being circulated around that the school teacher bashed the student for touching his water pot has fallen flat as villagers and school students unitedly had claimed that there was no water pot in school. Students, since years, have been using one water tank installed in school premises, without any bias, said a local villager talking to IANS.

In fact, police officials and the education department team also maintained silence and have not confirmed anything about the water pot. In fact, they are yet to receive a single clue in that direction.

Superintendent of Police (SP) Jalore, Harsh Vardhan said, "The theory of water pot is yet to be ver-

ified. Our investigation is on." Similarly Rekha Shankar Garg, chief block education officer Sayla, said, "We went to school Sunday and could not find out water pot for teachers or any caste based discrimination in school. There is a water tank and everybody drinks water from it, we have learnt so far." Another student of the school



Rajesh Tailor said, "The deceased had a fight with him over a textbook after which school teacher Chhail Singh slapped two of them. After that, the child did not come."

In fact, the audio going viral on social media highlighting conversation between father of the deceased and school teacher Chhail Singh, also proves that the child was beaten due to indiscipline and the school teacher had offered financial help for treatment of the student.

One Ajmal from Surana village in Jalore said, "The child had an ear infection and he was undergoing treatment for the last two years. He was coming to school with cotton in his ear for the last few months.'

In fact, there is another myth busted in the matter. The school where the incident was reported was Saraswati Bal Vidhya Mandir and many considered it to be the RSS-run school as Saraswatinamed schools are generally RSSrun schools in Madhya Pradseh and Uttar Pradesh.

Congress leader Udit Raj also mentioned the school to be run by RSS and tweeted, "A 9-year-old Dalit student was beaten to death by a caste teacher because he drank water from teachers's pot at the Saraswati Vidya Mandir by RSS in Jalore, Rajasthan. Discrimination is taught in their schools and the government should take over all the schools." he said and share a media report.

Later, when he realised that the school is run by a private body, he apologised and said, "Usually Shishu Mandir and Saraswati Vidva Mandir are run by the Sangh. The name of the school where the incident happened with

the Dalit student in Jalore is also Saraswati Vidya Mandir. Later I came to know that this school does not belong to the union, so I apologize for this mistake," he said.

Meanwhile, a private school association of Block Sayla has given memorandum to tehsildar Kaushalya Jangid in the name of Chief Minister Ashok Gehlot claiming that there is no caste discrimination in any school in the district.

However, there is another angle to the story. A source confirmed to IANS that a professor associated with Delhi-based JNU aggravated the issue. He hails from Jalore and has worked with Jodhpur University too.

Meanwhile, the villagers are quite disheartened with the overall episode. "What happened with our son is sad, but the worst part is that it has been given a casteist touch which has brought ill fame to our village. This should bestopped," said residents of village Surana.



21 killed in Kabul mosque bombing

Kabul, August 18: A bombing at a mosque in the Afghan capital of Kabul during evening prayers killed at least 21 people, including a prominent cleric, and wounded at least 33, eyewitnesses and police said Thursday.

There was no immediate claim of responsibility for the attack Wednesday night, the latest to strike the country in the year since the Taliban seized power. Several children were reported to be among the wounded.

The Islamic State group's local affiliate has stepped up attacks targeting the Taliban and civilians since the former insurgents' takeover last August as US and NATO troops were in the final stages of their withdrawal from the country. Last week, the IS claimed responsibility for killing a prominent Taliban cleric at his religious center in Kabul.

Khalid Zadran, the spokesman for Kabul's police chief, gave the figures to The Associated Press for the bombing at the Sunni mosque. According to the evewitness, a resident of the city's Kher Khanna neighborhood where the Siddiquiya Mosque was targeted, the explosion was carried out by a suicide bomber. Gaza, August 18: When Israeli missiles started landing in Gaza in early August, shattering glass and collapsing buildings, Jouman Abdu put on headphones, covered her eyes with a blindfold and stretched on the couch.

The 8-year-old Palestinian girl said she came up with this ritual to escape the bang of the blasts, the second round of steady violence she had experienced in 15 months. "I didn't want to hear the sounds of ex-

plosions," she told Reuters as she sat with her mother. "I was afraid they would bomb our house.

The latest outbreak of hostilities lasted only a weekend but buttressed the trauma faced by

Palestinian children growing up in the densely populated strip in the years since 2007 when Israel and Egypt imposed a blockade, cutting it off from outside, four people, including parents and experts, said.

"If you are a child in or around Gaza and you are 15 years old, in your life you have already gone through five different conflicts," said Lucia Elmi, special representative of UNICEF, the United Nations Children's Fund, in Palestine

Islamic Jihad, a militant group committed to Israel's destruction and the creation of an Islamic Palestinian state, fired more than 1.000 rockets towards Israel and held Israel responsible for the es calation, saying it had informed Egyptian mediators it was about to call off a state of high alert among its fighters when the Israeli strikes began. Israeli studies over the years have established that children under continuous exposure to bombardment experience high levels of stress, with particularly high levels of anxiety in areas near Gaza. "There is endless research and work regarding the long-term effects of exposure to traumatic situations," said psychologist Ilana-Elyassi, speaking in her office in Gevim, in southern Israel.

Rate hikes needed to tame inflation

Mumbai: Inflation is persistently at elevated levels that warrants appropriate policy responses to anchor expectations going forward, said an RBI article published Thursday, Retail inflation based on the consumer price index (CPI) softened to 6.71 per cent in July, mainly on account of moderation in food prices. The Reserve Bank has increased the benchmark lending rate (repo) in three quick successions by 140 basis points to tame inflation, which remains above its tolerance level for the seventh month in a row. "Perhaps the most heartening development in recent times has been the easing of inflation in July 2022 by 30 basis points from June 2022 and an appreciable 60 basis points from the average of 7.3 per cent for Q1:2022-23. This has validated our hypothesis that inflation peaked in April 2022," said the article on the 'state of the economy'.

New Delhi, August 18: The government Thursday hiked the windfall profit tax on the export of diesel to ₹7 per litre and brought back a tax on jet fuel exports, but slashed the levy on domestically produced crude oil in line with softening rates.

At the third fortnightly review, the government raised the windfall profit tax on the export of diesel to ₹7 per litre from ₹5 a litre and brought a ₹2 a litre tax on ATF exports, a finance ministry notification showed.

Earlier this month, the government had scrapped the windfall profit tax on ATF (Aviation Turbine Fuel) exports.

Alongside, the tax on domestically produced crude oil has been cut to ₹13,000 per tonne from ₹17.750.

The tax on exports has been raised as cracks or margins rose but the same on domestically produced oil was reduced as international oil prices slid to a sixmonth low.

On July 1, export duties of ₹6 per litre (\$12 per barrel) were levied on petrol and ATF and a ₹13 a litre tax on the export of diesel (\$26 a barrel). A ₹23.250 per tonne windfall profit tax on domestic crude production (\$40 per barrel) was also levied

Thereafter, in the first fortnightly review July 20, the ₹6 a litre export duty on petrol was scrapped, and the tax on the export of diesel and iet fuel (ATF) was cut by ₹2 per litre each to ₹11 and ₹4, respectively. The tax on domestically produced crude was also cut to ₹17,000

per tonne. Thereafter, August 2, the export tax on diesel was cut to ₹5 a litre and that on ATF scrapped, following a drop in refinery cracks or margins. But the levy on domestically produced crude oil was raised to ₹17,750 per tonne in line with a marginal increase in international crude prices.

At the third fortnightly review, the taxes on fuel exports has been raised but that on domestically produced crude oil has been cut.



The reduction in taxes earlier this month came as India's trade gap swelled to a record high in July as elevated commodity prices and a weak rupee inflated the country's import bill.

The gap between exports and imports widened to \$31.02 billion in July from \$26.18 billion in June. This, as a result of exports falling and elevated commodity prices together with a weak rupee, are inflating the import bill. Imports jumped 43.59 per cent in July from the year-ago month, while exports

dropped 0.76 per cent. International oil prices have since then slid to below \$95 per barrel but cracks on diesel and ATF rose.

New Delhi, August 18: In an interim relief, the Supreme Court Thursday ordered the status quo and said the Delhi High Court-appointed three-member Committee of Administrators (CoA) will not take over the affairs of the Indian Olympic Association (IOA).

A bench comprising Chief Justice NV Ramana and CT Ravikumar took note of the submissions of Solicitor General Tushar Mehta, appearing for the Centre and the IOA, that the world sports body does not recognise any un-elected bodies like the CoA and consequently, India may be barred from taking part in international sports events.

"The Indian Olympic Association is a unit of the International Olympic Association and they have their own rules and according to them, if any national-level body like petitioner IOA here is represented by a non-elected body then it is treated as a third party interference," the law officer said.

Every country is bound by the rules of the international body, Mehta said, adding that the high court's intervention may or may not be for valid reasons which can be gone into by the bench at a later stage

"But the moment they (CoA) takes over, India stands almost 99 per cent chance of being suspended from participating in any Olympic and international event," the solicitor general said.

The CJI said that Justice Hima Kohli, the third judge of the bench, did not want to hear this case which originally arose from the Delhi High Court's order. The law officer said that the interim relief can be awarded by the two judges on the bench.

'The counsel for the petitioner (IOA) and as well as the solicitor general submitted that by virtue of the present order (of the high court), there is a possibility of India losing the chance of participation in the Olympic and all international events ... "We direct the parties to maintain the status quo. It is made clear that the charge is



not handed over to the CoA. We direct the matter to be listed before an appropriate bench on Monday (August 22)," the bench said in its order.

Consequently, the Delhi High Court-appointed CoA, comprising former Supreme Court judge Justice Anil R Dave, former Chief Election Commissioner SY Quraishi, and former Secretary of Ministry of External Affairs Vikas Swarup, will not be able to take IOA over.

Earlier in the day, the solicitor general sought an urgent hearing and said the appointment of the CoA may lead to the Association's suspension by the International Olympic Committee as happened in the case of the All India Football Federation (AIFF) recently.

The IOA "welcomed" the interim relief granted to it by the Supreme Court, saying it will continue to challenge the "contentious" clauses of the National Sports Code, primarily related to "tenure guidelines for officials and voting rights" of state bodies. "It is a welcome order by the Hon'ble Supreme Court. The IOA and the government jointly approached SC. We had the full support of the government. We are happy that the Court took into consideration our submission," IOA secretary general Rajeev Mehta told PTI.



member CoA to manage the affairs of the IOA. The high court had said the "persistent recalcitrance" of the IOA to comply with the Sports Code made it imperative that its affairs be put in the hands of the CoA.

The high court had directed the executive committee of IOA to forthwith hand over the charge to the newly appointed committee and said that the members of the CoA will be assisted by three eminent sportspersons, namely, Shooter Olympian Abhinav Bindra, Long Jump Olympian Anju Bobby George, and Archer Olympian Bombayla Devi Laishram.

The IOA is recognised by the International Olympic Committee as the National Olympic Committee for India.

The high court, which considered in detail the issues concerning the tenure of office bearers and voting rights, struck down the post of "Life President" and any such permanent post for an individual in the IOA for being illegal and said that the maximum term for the President and likewise to all Office Bearers and members of the EC has to be limited to 3 tenures as per the law.

The honorarium payable to the CoA members and facilities to be extended to them will be akin to what may be fixed by the Supreme Court in the case related to the All India Football Federation and for the moment, as interim honorarium, a deposit of Rs 3 lakh per month shall be made with each CoA member and Rs 1.5 lakh each with the consultant sportsperson, the high court had said.

CORIC SPOILS NADAL'S RETURN Praggnanandhaa beats Nieman in third round

Miami, August 18: Young Indian ter R Praggnanandhaa beat Hans Nieman 2.5-1.5 in the third round to notch up a third straight win in the FTX Crypto Cup, the American finale of Champions Chess Tour, here Thursday. The 17-year-old Indian is on top of the standings with nine match points along with World No.1 Magnus Carlsen, a 2.5-1.5 winner over Levon Aronian. Praggnanandhaa bounced back brilliantly after losing the first game to secure victories in game two and four after a drawn second game to pick up three points. Having started his campaign with victory over World No.4 and the top ranked junior Alireza Firouzja, the Indian prodigy beat Anish Giri in the second round. In other matches of the third round, Firouzja edged out Giri 4-3 in a tie-break in a thrilling match and Quang Liem Le of China defeated Poland's Jan-Krzysztof Duda 2.5-1.5. Aronian and Firouzja trail Carlsen and Praggnanandhaa with five points while Duda has four. The eight-player all-play-all tournament is the American finale of Champions Chess Tour. There is USD 7.500 at stake for each match win at the event. Each match will be played over four rapid games, with blitz tiebreaks in case of a 2-2 draw.

Madrid, August 18: The expectations were high for Barcelona coming into the new season. The club's financial maneuvers allowed for some high-profile signings that significantly boosted the squad after a trophyless campaign without Lionel Messi.

The new players performed well in the preseason and Barcelona president Joan Laporta said the club would meet the Spanish league's strict financial fair play regulations. Barcelona were back in their

place, seen as a reference in world football again, Laporta boasted a few days before the league opener.

But it didn't take long for the hype to turn into more disappointment, and the Catalan club enters the second week of the season reeling and looking for ways to rebound. Another setback in a tough visit to Real Sociedad Sunday could leave the club in a deep hole early on.

Laporta was not able to register all the new signings as he had expected ahead of the opener, and on the field the team struggled yet again, beginning its league campaign with a 0-0 home draw against Rayo Vallecano at the newly renamed Spotify Camp Nou.

To make it worse, Barcelona's closest rivals all won their openers, with defending champion Real Madrid defeating promoted Almeria and Atletico Madrid routing Getafe, both in away matches.

It won't help that Barcelona will have to face Sociedad without veteran midfielder Sergio Busquets, who was sent off in stoppage time against Rayo. It was also unclear if newly signed defender Jules Kounde would be allowed to be

registered in time. Of the team's top signings, only Robert Lewandowski and Raphinha were added to the squad ahead of the opener.

Madrid opened by coming from behind to win at Almeria. The defending champions will stay on the road Saturday to visit a Celta Vigo team.
