Police book rapper for anti-govt song; 2nd case this week

Mumbai, April 9: Mumbai Police have registered a case against rapper Umesh Khade for his song allegedly against government and the administrative system, an official said Sunday.

With this, the Maharashtra Police have registered cases against two different rappers in a week for allegedly targeting the government. In the latest case, a complaint was filed by an official of the Mumbai

Police's Crime Intelligence Unit. Based on the complaint, an FIR was registered Friday against rapper Umesh Khade, who stays in Wadala area of Mumbai, for his song 'Bhongli keli janata' (referring to sufferings faced by people), the official said.

Khade had uploaded the song on a social media platform having the account name Shambho, and the song went viral, he said.

The case was registered against Khade under Sections 504 (intentional insult to provoke breach of peace), 505(2) (statements creating or promoting enmity, hatred or ill will between classes) of the Indian Penal Code, and Section 67 (publishing or transmitting obscene material in electronic form) of the Information Technology Act, 2000, he said. He was called for questioning by the police Thursday and later allowed to go, the official said.

After registration of the FIR Friday, a notice was served to Khade asking him to appear before the investigating officer whenever required, he said, adding the rapper was not arrested. Earlier, the Ambernath police Wednesday registered a case against rapper Raj Mungse for his song which allegedly targeted the Shiv Sena-BJP government in Maharashtra using derogatory language.

India's tiger count up at 3,167 in 2022 To mark 50 years of

'Project Tiger', Prime Minister Modi unveils the 'International Big Cat Alliance' (IBCA)

Mysuru (K'taka), April 9: India's tiger population rose by 200 in the past four years to reach 3,167 in 2022, the latest tiger census data released by Prime Minister Narendra Modi here Sunday revealed.

According to the data, the tiger population was 1,411 in 2006, 1,706 in 2010, 2,226 in 2014, 2,967 in 2018 and 3.167 in 2022.

At the inaugural session of the commemoration of 50 years of 'Project Tiger', the Prime Minister also launched the 'International Big Cat Alliance' (IBCA) and released a booklet 'Amrit Kaal Ka Tiger Vision', presenting the vision for tiger conservation in the next 25 years.

The Prime Minister said that protection of wildlife was a universal issue, adding that IBCA was India's endeavour for the protection and conservation of big cats.

"Cheetahs had become extinct in India decades ago. We brought this magnificent big cat to India from Namibia and South Africa. This is



thrive, it is important for ecosystems to thrive. Modi said adding that this has been happening in India. "India is a country where protecting nature is part of culture...

We do not believe in conflict between ecology and economy, but give importance to coexistence between the two," he noted.

In July 2019, the Prime Minister had called for an 'Alliance of Global Leaders' to obliterate demand and firmly curb poaching and illegal wildlife trade in Asia. India launched the IBCA to bring focus to protection and conservation of seven major big cats of the world - Tiger, Lion, Leopard, Snow Leopard, Puma, Jaguar and Cheetah -- with membership of the range countries harbouring these species.

India launched 'Project Tiger' April 1, 1973 to promote tiger conservation. Initially, it covered nine tiger reserves spread over 18,278 sq km. At present, there are 53 tiger reserves spanning more than 75,000 sq km (approximately 2.4 per cent of the country's geographical area).

HC: Executive magistrate cannot record confession

■ The court sets aside the conviction and sentence imposed on the accused, saying that the statement of the accused to the executive magistrate can, at best, be treated as an extra-judicial confession

Cuttack, April 9: The Orissa High Court has held that an executive magistrate is not empowered to record confession for offences under Essential Commodities Act (ECA), 1955, and that in absence of any specific procedure governing recording of confession as well as trial under the ECA, the Criminal Procedure Code (CrPC) shall apply.

While hearing a case of 1984, a single-judge bench of Justice Sashikanta Mishra observed that investigations conducted in connection with offences under 'Special Acts' like the Essential Commodities Act, 1955 shall be governed by the provisions under Section 164 of CrPC unless a specific procedure is laid down in such Act(s).

According to the case details,

authorities had carried out inspection at M/s. Minati Stores March 24, 1984 and claimed to have found the unit in illegal possession of a huge quantity of groundnuts.

The firm had sold and purchased groundnuts beyond the permissible limit. Besides, no stock and price declaration board was exhibited by the unit. It amounts to contravention of Clause-3 of Orissa Declaration of Stocks and Prices of Essential Commodities Order, 1973. Subsequently, the executive magistrate recorded the statement of an accused and held the accused

guilty for violating the ECA. The Additional Sessions Judgecum-Special Judge of Jajpur December 23, 1994, convicted the accused for offence under Section 7 of the ECA and sentenced them to undergo three months of rigorous imprisonment besides slapping a penalty of ₹100 on them. The accused then moved the HC challenging the conviction.

The petitioner challenged the conviction on two grounds - the trial court could not have relied upon the confessional statement of the accused as it is not admissible in the eve of law and the evidence on record does not at all link the accused with the occurrence.

The HC observed that there is no particular procedure to be followed for trial of offences under the ECA. Hence, the procedure provided under the CrPC will govern the investigation for ECA, "Under Section 164(1) of CrPC only a Judicial Magistrate or a Metropolitan Magistrate is empowered to record confession. Thus, an Executive Magistrate has not been conferred any authority under the Code to record confession," the HC observed. The court set aside the conviction and sentence imposed on the accused, saying that the statement made by the accused to the executive magistrate can, at best, be treated as an extra-judicial confession.

BJP demands white paper on migration

Bhubaneswar, April 9: The BJD got richer while ruling Odisha, but the common people became poorer because of which they have to go outside the state to work as labourers. the BJP alleged Sunday, demanding a white paper on migration.

Citing an ADR report which showed that the BJD recorded the second-highest income among regional parties at ₹307 crore, BJP general secretary Lekhashree Samantasinghar said the ruling party of the state has become richer, but made the people of the state poorer during its 23 years' rule.

Odisha is a rich state as it has huge mineral deposits and natural resources, but the local people were not engaged to unlock the potential of these resources, she said.

Noting that the people of Odisha are forced to migrate to different states in search of work, Samantasinghar claimed that at

least 10 migrant labourers have died under unusual circumstances in the last three months

"The ruling party and the state government are insensitive towards the plight of migrant labourers," she alleged.

She alleged that the state government was deliberately not keeping a record of migrant workers.

BJD also reported the highest increase in its income at ₹233.941 crore, according to the report released Saturday. BJD vice-president Debi Mishra said it was a sign of transparency.

Money plays a big role in electioneering at present, and it is often alleged that political parties are spending money in the wrong ways but the BJD is transparent in that manner, he told PTI. 10 regional parties, including the DMK, BJD, YSR Congress, JDU and the AAP, have declared receiving ₹852.88 crore donations through electoral bonds Decreasing levels of immunity in population may trigger new Covid waves and to tackle this, India needs a strong disease surveillance along with high vaccine

coverage, WHO Regional Director, South-East Asia,

Dr Poonam Khetrapal Singh has stressed. India is currently seeing a surge in Covid cases, to levels last seen during the Omicron wave in early 2022. India Saturday recorded 6,155 fresh Covid-19 infections, according to the Health Ministry data. Speaking to IANS, Singh stressed the need for people to take booster vaccine doses and

follow Covid-appropriate behaviour to tackle the surge in infections. Excerpts from the interview:

■ Are we going to see a new Covid wave, even as India is currently seeing the highest surge in infections?

■Over the past six months, we have been seeing surges in infection in some countries that have not been associated with a rapid increase in the need for hospitalisation, intensive care, or an increase in fatalities. As the virus continues to circulate and evolve, we will continue to see waves of infections. While these waves are not likely to be as large as before as we have population-level immunity that has increased around the world from vaccination and prior infection, we should, by no means, downplay the threat from Covid-19 and become complacent. We must reduce risk to ourselves and to others from Covid-19. We can also expect new waves of infection as our immunity wanes. We can contain the impact of this with strong disease surveillance, high vaccine coverage, and making our health

systems more resilient. We also need to strengthen our capacity to track the virus and urgently address any gaps in the health systems. As we continue to do all this, we need to transition to long-term control of Covid-19 and other respiratory diseases.

■ Adoption of the second and third doses of Covid vaccines in India has been very less, compared to the first dose. What is your take?

■ Vaccination is an important tool in our fight against Covid to prevent severe disease and death. Even in communities that have experienced high Covid-19 infection rates, vaccination and boosters provide an additional layer of protection against the future trajectory of the disease. India has already administered more than 2.2 billion doses to date, an impressive feat given the size of the country. While the vaccine rollout started at a slow pace. it picked up speed with the country

crossing a billion doses in October 2021 and crossing the two billion mark in a record 18 months in July 2022. In April 2022, India also rolled out booster doses in a phased manner for those who had completed their primary series, with a focus on the elderly, those with underlying medical conditions, and frontline workers which was gradually expanded. While vaccine coverage and prior infections has provided population level immunity globally, the effectiveness of vaccines wanes over time and it is important that the primary series should be followed by additional booster doses, especially to those at the highest risk from severe disease and death.

■ How can we tackle the rising infections?

■ We should isolate if we have a fever or symptoms and follow medical advice. Even individuals without infection must continue to follow protective measures to reduce transmission which include maintaining safe distance, practising good hand and respiratory hygiene, wearing well-fitting masks, and avoiding crowded and poorly ventilated places, where possible. Booster doses provide additional protection against infection and severe disease beyond the primary series. Persons at high risk of developing severe Covid-19 disease should continue to be prioritised

■ Should children under 11 years of age be vaccinated?

Children and adolescents are generally at low risk of infection and in case they do get infected; it is likely to be a mild disease in most instances. However, children and adolescents with co-morbidities or obesity are at a higher risk and must be vaccinated and should receive primary series vaccination and one booster dose. Vaccination of healthy children and adolescents could be considered by individual countries based on disease burden, and other health or programmatic priorities and opportunity costs. Achieving high vaccination coverage with primaryseries and boosters in the at-risk population groups remains a priority.

CP nabs fleeing convict from Sundargarh

Bhubaneswar, April 9: The Commissionerate Police Sunday arrested a convict who had escaped from the Biju Patnaik Open Air Ashram at Jamujhari a few months ago. The convict, identified as Nabin Patra alias Bhuri, 32, is a resident of Bangurkola village under Hemgiri police limits of Sundargarh district.

The convict, along with other inmates, December 23, 2022, had gone outside the Ashram for morning walk While other inmates returned to the Ashram after the walk, two prisoners including Patra sneaked away taking advantage of the situation. On the basis of a complaint

lodged by the Ashram Superintendent Saroj Kumar Biswal the Chandaka police registered a case (313/22) and launched manhunt to arrest the two convicts.

The police received a vital input from reliable sources regarding the whereabouts of Patra April 7, 2023. Following the intelligence, a team of Chandaka police, with the help of Sundargarh police, arrested him from his hideout in Lephripara

Patra was produced before a local court here Sunday that later sent him to judicial custody.

Notably, the convict was awarded life imprisonment in connection with a murder case several years ago. While serving his term in a jail in Sundargarh, his good behaviour caught the attention of the iail authorities who later shifted him to the Open Air Ashram in 2021.

Do awards really help solve climate change problems?

very year, tens of billions of dollars are spent by universities, research institutes and private companies to develop solutions for climate change.

Yet when a government decides to fund research for a piece of technology or branch of science, it rarely makes news

In recent years, high-profile climate solutions prizes have started to buck that trend. These prizes are often awarded to innovators or researchers who are proposing solutions to the many problems facing the planet.

Compared to traditional funding pathways, the amounts are relatively small – in the thousands or sometimes millions of dollars

and they are often backed by bil-

lionaires and celebrities. In an episode of The Conversation Weekly podcast, the host spoke with three researchers who study how climate research is funded to find out whether the pomp and circumstance of these prizes outweighs the actual research they fund, or whether they actually play an important role in the larger effort to find climate solutions.

Climate innovation prizes often work like a competition or a bounty. Someone, usually a rich benefactor, will offer a sum of money to the first person who can accomplish a particular goal or solve a certain problem, and people will compete for the pot of money.



The first innovation prize was announced almost 300 years ago, explains David Reiner, a professor of technology policy at the University of Cambridge in the UK.

In the 1700s, sailors were easily able to measure their latitude using stars, but tracking one's position east to west required accurate time-

'So a prize was launched by

British Parliament offering 20,000 pounds," says Reiner. "They were trying to find a clock that would be viable on a ship."

This prize, roughly equivalent to a million and a half British pounds today, triggered a number of inventions that eventually led to the invention of the marine chronometer. The accurate timekeeping device revolutionized navigation at sea.

The nature of research funding has changed dramatically since the 1700s, as Abbas Abdul, a research fellow who studies science policy at the University of Sussex in the UK, explains.

He says the kind of work that gets funded today is "interdisciplinary, multidisciplinary and cross-disciplinary research" and often done at large, Western universities.

Climate prizes can "fill in the gaps of this research." in particular with regard to climate adaptation. says Abdul. One of the reasons they are good at that is that climate prizes are often awarded to researchers or inventors in the global south who are outside of traditional funding systems.

Climate innovation prizes are not without their controversy, though. They are often bankrolled by the extremely wealthy and are announced at extravagant awards ceremonies hosted by celebrities who fly in for the occasion.

These are far from carbon neutral events. But according to Mark Maslin, a professor of earth systems science at University College London in the UK, the entertainment is part of the value.

Maslin was hired by the BBC to fact-check their broadcast of the Earthshot Prize awards ceremony

According Maslin, that's a good thing. "It is little bit of razzmatazz, and it basically says 'Guess what? Solving climate change is cool.' And this is something that hasn't actually happened until very recently."

Maslin believes that getting hopeful messages about climate solutions into popular media can help inspire people to action and that climate prizes are an excellent way to

Balasore, April 9: Senior BJP leader and Union Minister Bishweswar Tudu has courted controversy by claiming that many of the officers appointed through Union Public Service Commission (UPSC) are dacoits.

A chicken thief can be punished but the mineral mafia cannot as the system protects them, the Union minister of state for tribal affairs and Jal Shakti alleged while addressing as the chief guest in the golden jubilee function of a government school at Baliapal in Balasore district Saturday.

He was heard making that controversial statement in a video which was shared on social networking sites. The authenticity of the video was not checked by PTI.

"I had an idea that those who are appointed through UPSC are the most knowledgeable persons and are always in high positions. But now I feel that most of those who have qualified from there perhaps are dacoits. I do not say 100 per cent, but many of them are dacoits," Tudu said.

The UPSC is the country's premier central recruitment agency that appoints top government

The minister, who is an MP of Odisha, said that the UPSC office is just behind his residence in Delhi and initially he had high regard for it but that has changed now.

During his speech, Tudu also asked: "Why our society is engulfed in corruption and injustice if such educated people are there?".

Giving the reply to his own question, Tudu said, "It is because of lack of morality in our education system. Lack of spiritual education and thoughts among us.'

The minister had in 2021 accused state government officials of misbehaving with him in his constituency in Mayurbhanj.

Joda, April 9: Blessed with abundant natural resources, Keonjhar district could have been boasting of robust economic growth along with better social indicators However, the stark reality is that the children under Joda block here are malnourished as they feed on boiled mohua and tamarind seeds

According to sources, more than 30 children of Sargitalia area under this block in mineral rich Keonjhar district are in the grip of malnutrition as the benefits of the Union and state government schemes have failed to reach the locals.

The matter came to the fore after a medical team conducted a check up of the afflicted children and admitted two of them to the nutritional rehabilitation centre (NRC) in Barbil.

A team member, Ramani Ranjan Patra, rejected the death of two children which occurred last Wednesday and Friday due to malnutrition. He said that the two children perished due to pneumonia

and tuberculosis.

Sources said the residents of Sargitalia area under ward no-13 of Joda Municipality in Keonihar district are all poor due to lack of livelihood opportunities. They are living a helpless life and are unable to arrange two square meals a day. They have to consume boiled mohua, tamarind seeds and forest produce due to lack of nutritious food. As a result, over 30 children have reportedly been afflicted with

malnutrition. Sargitalia area is surrounded by various mines and geographically it is the largest ward under Joda Municipality. The Surisahi. Latarsahi and Chitansahi localities in Sargitalia are some of the places where basic facilities still

They get rice under the government scheme but that falls short to feed their entire family. Left with no option, they consume boiled mohua, tamarind seeds, wild tubers, sal seeds and a kind of wild ants as food. locals Sonu Munda, Tamba Munda and Guru Charan Munda alleged.

Their children also eat the same food for which they are down with

leged that his three-year-old daughter Shalini Munda fell sick and became anaemic as he could not provide her with nutritious food. Initially, he admitted Shalini to Tata Hospital in Joda and later shifted her to Keonjhar district headquarters hospital before shifting her to Sishu Bhawan in Cuttack. She, however, failed to recover and

succumbed to her illness. He said that he did not received any financial assistance from the state government during treatment in Cuttack and only received Rs 200 from the district mineral foundation which he was spending to meet his daily expenses.

Sudura Munda, an elderly tribal, said that the responsibility of his three grandchildren befell on him after the death of his son. The children eat only once in a day and remain starved at night as the rice supplied to him falls short for the whole family.

Tribals Julu Munda, Sudan Munda and Sonu Munda alleged that over 30 children have become feeble and sick due to lack of adequate food to eat and medical care.

They alleged that there is an Anganwadi centre at Khuntapani, about 3 km from Sargitalia. However, it is of no use as the children do not get healthcare and study facilities at the centre. Consequently, the children do odd jobs to earn a living.

They also alleged that Baitarani river flows near Sargitalia but they do not get safe drinking water, while a tube well in the area has become defunct. Moreover, the area witnesses regular power outage due to elephant protection plan.

A social activist Churchil Mahakur is spending from his own pocket to renovate a defunct well and supply water to the residents. Tata Steel has installed a motor pump in the area for supply of drinking water to the residents. However, frequent power cuts have

made it redundant. In a bid to make the people selfreliant, Joda Municipality authorities are constructing a park near Baitarani river bank, However, construction of the park is only halfway through due to lack of coordination between the Forest department and the civic body authorities.

Joda Municipality chairman Jagdish Prasad Patra said that steps will be taken to complete the park soon.

Jajpur/Korei, April 9: Rice mills in Jajpur district have turned out to be the bane of the local environment as they are discharging toxic water into open spaces, a report said. The discharge of toxic effluents

is assuming alarming proportions by the day as the rice mills have not installed effluent treatment plants on their premises. The toxic water discharged overflows on the ground and pollutes the groundwater, atmosphere and soil in their respective areas.

The matter came to the fore after residents of Mulari mouza under Patharpada panchayat of Korei block lodged a complaint against Ashirbad Rice Mill in their area with the regional officer of State Pollution Control Board (SPCB) at Kalinganagar.

They alleged that the rice mill is discharging toxic water after 10pm on a regular basis. The toxic water flows down into nearby ponds and water bodies through a nullah. The pollution of the water bodies has affected the livestock and farmers in the area.

that he had dug up a fishery pond on his farmland after taking loan from a bank. However, the whole lot of fish died after the toxic water discharged from the rice mill entered the pond.

This has pushed him to the brink as he ponders over repayment of the loan after suffering loss. This waste water destroys the fertility of the soil when it overflows on land and also contributes to air and water pollution. People are being afflicted by various aliments after coming in contact with the water. The livestock are also affected.

Aware of its ill effects, the SPCB has issued guidelines for proper management of the toxic water. However, the rice mills are blatantly violating these norms and

discharging toxic water outside. When contacted, SPCB's Kalinganagar regional officer said that action will be taken against erring rice mills after conducting a probe into the charges. Ashirbad Rice Mill manager Babula Das rejected the charges and termed the allegations as false.

Fake currency racket busted in Baripada

Baripada, April 9: Baripada police busted an Indian fake currency note racket during the investigation into an FIR lodged over a missing person related to this incident, a source said Sunday.

According to the source, police arrested seven persons in connection with the fake note racket and booked three in connection with the kidnapping case.

A senior police official said that a man and his wife were the main suspect in the fake note racket. They allegedly lured people into a return of Rs 10 lakh - which were fake currency notes -- against a deposit of Rs 3 lakh.

According to police, the couple was operating the racket with some other agents. They were circulating fake notes in Mayurbhanj, West Bengal and Jharkhand.

However, one of their agents named Gajendra Behera was detained by some locals after they discovered the fake notes. Later, Gajendra's father lodged an FIR on allegations of kidnapping, said the source. During the probe, police discovered the fake currency note racket and detained seven persons in this connection, the police source said.

Tiger kills woman, 19 livestock in a month

Nuapada, April 9: With the death of another cow reported Saturday from Chulabhat village under Nuapada Sadar forest range, the tiger on the prowl reportedly has claimed the life of an elderly woman and as many as 19 cattle within a span of one month.

A fearful atmosphere has gripped the area, with the local residents fearing to venture out of homes after sunset.

The latest victim of tiger attack was Gobardhan Majhi's cow, which had gone to the forest for grazing and did not return in the evening. Later: the family members searched for the cow nearby and failed to find it. Some Mahua flower collectors spotted its carcass near a stream in the same village. On being informed, Nuapada forest range officials later arrived at the spot and buried the dead cow after conducting a post-mortem.

Reports said, forest officials do not enter into Sunabeda wildlife sanctuary which spreads across Komana, Boden and Nuapada blocks as Maoists are mostly active



in the region throughout the year. On the other hand, rampant deforestation by timber mafia is forcing tigers and leopards to enter human settlements triggering mananimal conflicts.

The tiger has been on the prowl in the area for the past few weeks. It is attacking cattle and occasionally venturing into human settlements. Despite the Forest department's efforts to capture it, the big cat has managed to evade all attempts so far.

The incident has once again brought to the forefront the issue of human-wildlife conflict and the need for effective measures to mitigate such incidents.

As the search for the tiger continues, the villagers in the affected areas remain in fear and uncertainty, hoping for a swift resolution to the crisis.

MAN HELD FOR **RAPING MINOR**

Post-Human Desert

The Future of Life Institute's open letter demanding a six-month precautionary pause on artificial-intelligence development has already been signed by thousands of high-profile figures, including Elon Musk. The signatories worry that AI labs are "locked in an out-of-control race" to develop and deploy increasingly powerful systems that no one - including their creators - can understand, predict, or control.

What explains this outburst of panic among a certain cohort of elites? Control and regulation are obviously at the center of the story, but whose? During the proposed half-year pause when humanity can take stock of the risks, who will stand for humanity? Since AI labs in China and Russia will continue their work (perhaps in secret), a global public debate on the issue is inconceivable.

Still, we should consider what is at stake, here. In his 2015 book, Homo Deus, the historian Yuval Harari predicted that the most likely outcome of AI would be a radical division – much stronger than the class divide – within human society. Soon enough, biotechnology and computer algorithms will join their powers in producing "bodies, brains, and minds," resulting in a widening gap "between those who know how to engineer bodies and brains and those who do not." In such a world, "those who ride the train of progress will acquire divine abili-

ties of creation and destruction, while those left behind will face extinction. The panic reflected in the AI letter stems

from the fear that even those who are on the "train of progress" will be unable to steer it. Our current digital feudal masters are scared. What they want, however, is not public debate, but rather an agreement among governments and tech corporations to keep power where it

A massive expansion of AI capabilities is a serious threat to those in power – including those who develop, own, and control AI. It points to nothing less than the end of capitalism as we know it, manifest in the prospect of a self-reproducing AI system that will need less and less input from human agents (algorithmic market trading is merely the first step in this direction). The choice left to us will be between a new form of communism and uncontrollable chaos.

The new chatbots will offer many lonely (or not so lonely) people endless evenings of friendly dialogue about movies, books, cooking, or politics. To reuse an old metaphor of mine, what people will get is the AI version of decaffeinated coffee or sugar-free soda: a friendly neighbour with no skeletons in its closet, an Other that will simply accommodate itself to your own needs. There is a structure of fetishist disavowal here: "I know very well

that I am not talking to a real person, but it feels as though I am – and without any of the accompanying risks!

In any case, a close examination of the AI letter shows it to be yet another attempt at prohibiting the impossible. This is an old paradox: it is impossible for us, as humans, to participate in a post-human future, so we must prohibit its development. To orient ourselves around these technologies, we should ask Lenin's old question: Freedom for whom to do what? In what sense were we free before? Were we not already controlled much more than we realised? Instead of complaining about the threat to our freedom and dignity in the future, perhaps we should first consider what freedom means now. Until we do this, we will act like hysterics who, according to the French psychoanalyst Jacques Lacan, are desperate for a master, but only one that

The futurist Ray Kurzweil predicts that, owing to the exponential nature of technological progress, we will soon be dealing with "spiritual" machines that will not only display all the signs of self-awareness but also far surpass human intelligence. But one should not confuse this "post-human' stance for the paradigmatically modern preoccupation with achieving total technological domination over nature. What we are witnessing, instead, is a dialectical reversal of this process

Today's "post-human" sciences are no longer about domination. Their credo is surprise: what kind of contingent, unplanned emergent properties might "black-box" AI models acquire for themselves? No one knows, and therein lies the thrill – or, indeed, the banality – of the entire enterprise.

Hence, earlier this century, the French philosopher-engineer Jean-Pierre Dupuy discerned in the new robotics, genetics, nanotechnology, artificial life, and AI a strange inversion of the traditional anthropocentric arrogance that technology enables:

"How are we to explain that science became such a 'risky' activity that, according to some top scientists, it poses today the principal threat to the survival of humanity? Some philosophers reply to this question by saying that Descartes' dream - 'to become master and possessor of nature' - has turned wrong, and that we should urgently return to the 'mastery of mastery.' They have understood nothing. They don't see that the technology profiling itself at our horizon through 'convergence' of all disciplines aims precisely at nonmastery. The engineer of tomorrow will not be a sorcerer's apprentice because of his negligence or ignorance, but by choice."

Humanity is creating its own god or devil. While the outcome cannot be predicted, one thing is certain. If something resembling "post-humanity" emerges as a collective fact, our worldview will lose all three of its defining, overlapping subjects: humanity, nature, and divinity.


Our identity as humans can exist only against the background of impenetrable nature, but if life becomes something that can be fully manipulated by technology, it will lose its "natural" character. A fully controlled existence is one bereft of meaning, not to mention serendipity and wonder.

The same, of course, holds for any sense of the divine. The human experience of "god" has meaning only from the standpoint of human finitude and mortality. Once we become homo deus and create properties that seem "supernatural" from our old human standpoint, "gods" as we knew them will disappear. The question is what, if anything, will be left. Will we worship the AIs that we created?


There is every reason to worry that tech-gnostic visions of a post-human world are ideological fantasies obfuscating the abyss that awaits us. Needless to say, it would take more than a six-month pause to ensure that humans do not become irrelevant, and their lives meaningless, in the not-too-distant

A TIMELY PAUSE

FISCAL POLICY AND MONETARY POLICY ARE LIKE TWO WHEELS OF A COUNTRY'S **ECONOMIC CHARIOT**

fter seven successive increases in reporates since May 2022 with a 250 bps hike, the MPC has finally pushed the pause button and retained the repo rate at 6.5%. The increases in the past were basically to tame inflation which has been exceeding the 6% tolerance limit, which was agreed to by the MoF and RBI while amending the RBI Act 1934 in 2016. The primary objective of amending the Act was to maintain price stability (inflation in the range of 4-6%) while keeping in mind the objective of growth. The RBI Governor Shaktikanta Das reiterated this policy leitmotif by observing: "We must remain unwavering in our commitment to bring down inflation towards a target of 5.4% over the medium-term while being mindful of growth." India has been following the US Fed in this regard which has increased the benchmark rate to 3.25% as the USA has been witnessing doubledigit inflation due to the cash stimulus infused by the government to revive the slump in demand dur-

ing the pandemic. While the MPC meeting on 6 April has been unanimous, in its previous meeting in February when four members voted for a hike of 25 bps, two outside members strongly dissented. Prof Ashima Goyal noted that excessive front loading of rate hikes carries the risk of overshooting. More so, when there are no signs of demand-pull inflation and core inflation moderating. Prof Jayanth Varma was far more critical when he noted: "In the second half of 2021-22 monetary policy was complacent about inflation, and we are paying the price for that in terms of unacceptably high inflation in 2022-23. In the second half of 2022-23, monetary policy has become complacent about growth and we may pay the price for this in terms of low growth in 2023-24.

The trade-off between growth and inflation is indeed problematic. It was Jan Tinbergen, the Nobel laureate, who had famously said that ideally there should be one policy tool for each policy target; like the reporate to combat inflation. It may recall that when Paul Volcker, the US Fed Governor applied this rule to increase the Fed rates to around 20% in the 70s to bring down inflation which was in two digits, inflation indeed came down drastically. But it also ushered in an economic recession in

George Santayana, the philosopher, famously observed: "Those who forget history are condemned to repeat it." The MPC must be complimented for not increasing the reporates in view of the fact the GDP growth rate during 2023-24 is now being scaled down to around 6.3%-6.4% by IMF & RFI from their 7% earlier projected as the manufacturing sector is likely to grow by only 1.6% during 2022-23 as against a growth of 9.9% during 2021-22, as per the latest NSSO data. The unemployment rate has risen to 7.8% in March as per the

CMIE report. This does not include the vast pool of disguisedly employed in the agricultural sector and informal sector. In such a situation where capacity utilisation is quite low in most industries, adding to their cost by way of a high repo rate is inadvisable and the RBI seems to have gone wrong in going for successive rate hikes, after it set a reasonable repo rate of 4% in October 2020 to ease the cost pressure of MSMEs during the pandemic.

The RBI must be complimented for the way it acted in unison with the MoF to combat the unprecedented economic recession in 2020-21. When the FM announced a slew of fiscal stimulus in 2020 to revive various sectors of the economy including MSMEs by providing a 3 lakh cr window and collateral-free loans, the RBI promptly followed it up, bringing massive relief to MSMEs. The reporate was also scaled down to 4%. It is often said that monetary policy has efficient brakes but weak accelerators. This is where appropriate fiscal policy comes as a more potent weapon. It was John Maynard

Keynes who had flagged the importance of creating more employment through public investment, which through the multiplier effect will take the economy out of the quagmire of economic depression. He was proved prescient when FDR through his New Deal Programs not only bailed the US economy out of depression but made the USA a fully employed global hegemon by 1944. The fiscal policy of India by bolstering in infrastructural spending to around 10 lakh crores in our budget of 2023-24 has a Keynesian and timely touch to it.

Fiscal policy and monetary policy are like two wheels of a country's economic chariot. The RBI must come out of its ostrich-like approach of slaying inflation alone and be a complement to the progressive fiscal policy of India to boost growth, and employment and break the vicious cycle of likely recession. The pause button must now move into an accommodative stand which rules out repo rate hikes in the future. Prof Varma has also underscored the need to have an accommodative stand by the RBI. Prof Goyal & Prof Varma must be complimented for bringing to public discourse the need not to trade off growth at the altar of inflation control. It was Robert Taylor, who in 1992 formulated the famous Taylor rule as per which the apex banking institution should look at three parameters viz potential GDP vs actual GDP, desirable inflation vs actual, and an optimal reporate to determine the repo rate. Alan Greenspan, the longest serving US Fed Governor, adopted this rule with considerable success marrying growth, inflation, and interest rate adroitly. It's time the RBI Governor and other MPC members took a hard look at the Taylor rule.

Case for nature-based carbon markets

THE ATMOSPHERE **DOES NOT CARE ABOUT OUR** MOTIVATIONS, COUNTERFACTUALS, **OR MORAL HAZARDS. ALL IT SEES IS CARBON FLOWING IN AND OUT**

oluntary markets for carbon offsets have recently come under fire, with critics questioning the efficacy of contracts that aim to reduce atmospheric carbon dioxide relative to what would have happened in the contract's absence. The biggest concerns are about "nature-based" projects involving various landuse changes – such as protecting forests, planting new ones (afforestation), and so forth.

But these instruments' imperfections are no secret. For well over two decades, ecologists and foresters have been working to develop more sophisticated methods to satisfy economists' faith in market instruments, and they have made good progress. Though offset schemes are still riddled with complexity, there is no question that they pay for something that

Imagine seeing what the atmosphere sees. Intergovernmental Panel on Climate Change's Sixth Assessment Report provides an outline of the planet's carbon cycle, which makes evident the fundamental role of plants' conversion of CO2 into cellulose and back on a massive scale. Terrestrial photosynthesis alone draws down 113 billion tonnes of carbon every year. By comparison, humanity added about 11 billion tonnes of carbon to the atmosphere last year.

The problem, of course, is that humans' cumulative contributions go in only one direction,

whereas the carbon captured by vegetation is normally balanced by an equal, opposite flow from plant respiration and degradation. By interfering with the climate system, we have thrown this balance off. adding a net flow of about 5.9 billion tonnes to the landscape and the ocean every year. In other words, the planet is drawing down only half of what we inject into the atmosphere.

Even a relatively small perturbation in this vast natural cycle can reach an enormous scale. That is why nature is such an attractive climate-mitigation option. Suppose we succeed in eliminating fossilfuel combustion. Keeping global average temperatures within 1.5° or 2° Celsius of pre-industrial levels will still require substantial carbon removal. Estimates vary, but they are on the order of 200-300 billion tonnes removed by plants be-

Nor will the story end there. The atmosphere contains about 870 billion tonnes of carbon in the form of CO₂, and the carbon cycle connects that atmospheric stock to vast reservoirs. The largest is the ocean, which holds 900 billion tonnes at the surface and another 37 trillion tonnes deeper below. Terrestrial vegetation and soils also hold about 2.15 trillion tonnes, and permafrost contains another 1.2 trillion. As far as the atmosphere is concerned, losses from any of these reservoirs could easily exceed the carbon we burn.

Far from being a secondary con-

cern, managing the stocks and flows of carbon through the planet's ecosystems is essential to keeping the entire Earth system in balance. But to carry out that task, we will need to think differently about the landscape. Landscapes and seascapes are not just the backdrop to our life. They are public infrastructure, and like all infrastructure, they must be paid for and maintained.

Since the nineteenth century, however, we have known that paying for infrastructure by rewarding its marginal benefit almost never covers the total cost. Because public-utility infrastructure like a highway or an airport tends not to command a high enough marginal value, taxation must cover the rest. Whom to tax then becomes the most important question.

To illustrate the point, consider Brazil, whose ecosystems contain some 60 billion tonnes of carbon in above-ground biomass. One way to estimate how much this stock is worth is to assume that we value carbon at a given price, say, \$50 per tonne. In this scenario, Brazil is home to ecosystems worth \$10 trillion, which is over six times the country's GDP and far greater than the value of its 13 billion barrels of oil reserves

Now, how much should the world pay Brazil to keep that forest in trust for everyone? Assuming a 2% fee on the value of the assets. the country ought to receive \$200 billion per year. On those terms, Brazil would almost certainly put a stop to deforestation in the

But here we run into a sad truth. There is simply no evidence that the international community has any appetite to pay such sums. In 2022, total overseas direct assistance amounted to just \$186 billion. For years, rich countries have failed to honor a 2009 pledge of mobilising \$100 billion per year to help developing countries adapt

to climate change. By thinking of natural assets not as infrastructure but as service producers, we end up relying on the voluntary payments companies make at the margin in exchange for "offsetting" some other reduction that they cannot or will not carry out. But, for all this mechanism's shortcomings, at least it directs some money - albeit a drop in the ocean - toward carbon-landscape management.

The atmosphere does not care about our motivations, counterfactuals, or moral hazards. All it sees is carbon flowing in and out. Ecosystems store carbon and draw it from the atmosphere at scales that matter. All of us - taxpayers, consumers, and companies - must pay for this critical public good.

Challenges galore, says Status Tiger-2022 report

Bangalore, April 9: Though the tiger population has increased to more than double from 1,411 in 2006 to 3,167 in 2022, there are still several challenges that need to be addressed despite efforts to conserve tigers, the Status Tiger-2022 report has pointed out.

The latest tiger census data released by Prime Minister Narendra Modi to mark 50 years of 'Project Tiger' here on Sunday showed that the tiger population was 1,411 in 2006, 1,706 in 2010, 2,226 in 2014, 2,967 in 2018 and 3,167 in 2022.

"One of the major challenges is aligning the aspirations of largescale economic development while safeguarding forests and their wildlife and mitigating humantiger conflict," the report said. It added that climate change-related impacts on habitats and the loss of the quality of forests over time were other mounting threats.

Out of the approximately four lakh square kilometres of forests in states that have tiger habitats, only one-third are in relatively healthy condition, the report said. It also underlined that illegal wildlife trade posed a major threat to wildlife in general and tigers in particular.

joined the BJP as he kept up his offensive against the government over the Adani issue.

"They hide the truth, that's why they mislead everyday! The question remains the same - whose Rs 20,000 crore benami money is in Adani's companies?" Rahul Gandhi asked in a tweet in Hindi, sharing an image with 'Adani' written as an acronym of sorts with letters of the names of the leaders.

He cited the names of Ghulam Nabi Azad, Jyotiraditya Scindia, Himanta Biswa Sarma, Kiran Kumar Reddy and Anil K Antony in his tweet. After quitting the Congress, Azad formed his own party, while the rest joined the BJP. Scindia is now a Union Minister and Sarma the Chief Minister of Assam.

The official said as the intruders started to run away, they were fired upon. One of them was shot dead while the other two managed to escape into a jungle taking advantage of the thick foliage, darkness and rocky outcrop, he added.

"The area was immediately cordoned off to prevent their escape across the LoC and a search operation was launched at first light wherein the body of the slain intruder was recovered at the encounter site," Lt Col Anand said.

Mowgli Schools: Oasis of learning for children in Bahraich's forest

THE SCHOOLS -- ONE LOCATED IN MOTIPUR AND **ANOTHER IN BARDA AREAS OF THE FOREST RESERVE -- IMPART EDUCATION TOGETHER TO AROUND 350 CHILDREN, MOST OF THEM AGED BETWEEN 7 AND 10 YEARS**

Bahraich (UP), April 9: 'Mowgli Schools', set up deep in the Dudhwa-Katarniya forest area here, have become an oasis of learning for children of forest dwellers.

The schools -- one located in Motipur and another in Barda areas of the forest reserve - impart education together to around 350 children, most of them aged between seven and 10 years. These children used to wander in the forest area to collect firewood which made them susceptible prey for the wild animals, before the schools were set up by the forest department officials.

Named after the main character 'Mowgli" of Rudyard Kipling's 'The Jungle Book', the schools operate in the evening from forest department buildings. "The children are provided with colourful books, comics, sports items, and are also shown cartoons. The schools



are run more like tuition centres where children from nearby areas come in the evening and study," said Akashdeep Badhawan,

Divisional Forest Officer. Forest department officials said most of the children are from marginalised families. They help their parents in farms during the day and in the evening come to school, the officials said. Earlier, these children use to venture inside the forest in the evening to collect firewood or simply play that made them susceptible prey for wild animals especially big cats like leopards.

Located along the Indo-Nepal border, the Dudhwa-Katarniya forest area is a hotspot of man-animal conflict and many cases have even been reported where leopards killed locals, the officials said.

The idea of 'Mowgli Schools' took birth five years ago. "The idea is to prevent the children from venturing into the forest by providing them a safe place to play and learn. The number of students in schools has increased over the years. We want the children of the area to become an important part

nel and other government officials also volunteer and take classes. "The parents and other villagers after seeing the educational development of the children are supporting the initiative," the DFO said. The forest department gets support from the World Wildlife Fund (WFF)

and other social organisations to run the schools. These organisations donate teaching equipment, projectors, books and sports items to the schools on regular basis, he said.

As the search progressed into the jungle, he said, the other two intruders were apprehended.

In Bihar, Chirag Paswan is considered as the strongest leader of all smaller parties. His popularity was seen several times during bypolls in Mokama, Gopalganj, Kurhani and other places.

For BJP, making alliance with smaller parties is its political compulsion. At the same time, if Chirag would opt for the strategy of 2020 Assembly election, his political existence could be over in Bihar. During the 2020 election, Chirag had given the tickets to candidates

Mukesh Sahani is another leader in Bihar who claimed himself as son of mallah (fisherman community). The Modi government had given Y plus category security to him. The idea could be to make an alliance

with his party VIP in the 2024 Lok Sabha election.

Sahani is considered as an influential leader in the fisherman community and he had proved it in the 2020 Assembly election when VIP won four seats. Mukesh Sahani however lost his own seat at that time. Later, three of his MLAs joined the BJP and another MLA died in 2021. Sahani has not opened his cards about which way he will go. Since, Mahagathbandhan has seven parties, the chances of negotiation for the alliance are thin. So, he may side with BJP.

Upendra Kushwaha is another prominent face of Kushwaha community in Bihar. Like Chirag Paswan Unendra Kushwaha is another leader who has openly sup ported BJP in Bihar.

However, BJP has given a clear message to Upendra Kushwaha that the former is not dependent only on him for the Kushwaha vote bank. BJP recently appointed Samrat Chaudhary as state president of the party. He also comes from Kushwaha community.

For the BJP, the vote of the Kushwaha community is important. It is a core vote bank of Nitish Kumar's Lav-Kush equation. BJP wants to intrude into Nitish Kumar's vote-bank and separation of Upendra Kushwaha followed by appointment of Samrat Chaudhary could be a plan of its

The Lok Sabha election 2024 is crucial for BJP in Bihar. The state has 40 seats which will decide the fate of Narendra Modi. Sikkimese are feeling betrayed: Chamling

Gangtok, April 9: SDF supremo Pawan Kumar Chamling claimed that the Sikkimese people feel be trayed as Article 371F, which guarantees special provisions for Sikkim, was 'violated'. ment jobs. They were also exempted from paying income tax.

"But now, the Financial Bill. 2023 redefines Sikkimese as any Indian itizen domiciled in Sikkim, extending to them the same benefits as that of the original inhabitants whose forefathers' names were in the 1961 register," Chamling said.

"This violates Article 371F, which was the basis for the merger of Sikkim with India in 1975. People of Sikkim feel betraved as the special provisions extended to them have been taken away," he said.

Analysts feel the main concern of Sikkim's politicians is that land rights which are now enjoyed by only those Sikkimese whose parents were subjects of the earlier princely kingdom will be extended to any Indian domiciled in the state.

Asked whether this will be a major poll issue, he said, "People are very angry over the issue. We have a very small population of only 6-7 lakh and we fear we will be swamped by settlers within 2-3 years."

27K cases withdrawn in Assam to lower burden on judiciary: Sarma

Guwahati, April 9: Assam Chief Minister Himanta Biswa Sarma has said that the state government has withdrawn at least 27,000 cases related to minor crimes with an aim to reduce the burden on the judi-

Attending the platinum jubilee celebrations of Gauhati High Court, Sarma said, "For facilitating ease of justice, the Assam government took a decision of withdrawing petty offence cases to bring down the pendency of cases.

"Cases punishable for up to three years with or without fine were taken into consideration for withdrawal, barring the cases of heinous nature," Sarma said, adding that till February this year, around 27,000 such cases have been withdrawn and it is estimated that through this action around one lakh criminal cases will be dis-

Sarma also asserted that this will reduce the load on lower courts.

The Chief Minister hailed the role played by the Gauhati High Court as the true guardian of human rights, protector of the Constitution and promoter of the age-old democratic ethos.

He mentioned that the Gauhati

"Currently, the Bihar government and NRCL (Muzaffarpur) are taking joint initiatives to improve litchi production, its quality and

Talking to PTI, Bikash Das, Director, (Muzaffarpur), said, "The contribution of Muzaffarpur district in litchi production is impressive. but there is a need to increase the productivity of litchi. The ICAR-NRCL has the mandate to address the productivity gap through basic and strategic research in areas of crop improvement and genetic enhancement, development of sustainable production technologies, integrated pest management systems, and post-harvest management and value addition.

Since litchi is a non-climacteric fruit that possesses poor shelf life, the post-harvest losses have been assessed to the tune of 18-23 per cent, the official said.

We did not have any place for rehearsal. We used to practice in the houses of our members. After coming to know about our problems,

Samiran Roy, the editor of a local newspaper, gave us a room in his office for the purpose. That helped us a lot," she said.

The band then had only a guitar and a harmonium. While performing at a programme organised by ONGC, the oil company donated a set of drums.

By 2023, the band has become well-known across the tiny northeastern state and performed in many shows, especially in college programmes and during Durga Puja organised by local clubs.

The band, which has now grown to 10 members between the age group of 16-32 years, has also performed in Santiniketan in West Bengal.

"Renowned Rabindra Sangeet artiste Mohan Singh Khandora, who was present there, appreciated us," lyricist Ankita Roy said.

Some of the band members are students while Roy has a government job and Saha gives guitar tuitions.

"We now have a dream of establishing a music institution where elderly people, besides youngsters, get to learn music at a minimal expense. We have come across many elderly people who could not chase their dreams due to monetary constraints or other barriers," she

Survey (2022-23), the production of litchi in the state was 308.1 tonnes in 2021-22, whereas it was 308 tonnes in 2020-21.

Shahi Litchi got the GI tag, thereby becoming an "exclusive brand" in national and international markets, in 2018.

Muzaffarpur, Vaishali, Samastipur, Champaran, Begusarai districts, and adjoining areas of Bihar have a favourable climate for this variety.

The Department of Posts recently issued a postage stamp on Shahi Litchi of Muzaffarpur.

Man kills son

Chandrapur: An inebriated man in Chandrapur in Maharashtra allegedly killed his three-and-half-year-old son and then attempted suicide Sunday, a police official said. The incident took place in Rajoli village in Mul tehsil, some 45 kilometres away from the district headquarters, he said. "The 33-year-old man strangled his son after he had a fight with his wife over a petty issue. His wife had left home and was at a kin's place when the murder took place. The man then tried to end his life by stabbing himself in the neck," the official said.

Tourists rescued

Khandwa: At least 15 tourists were rescued from a rock they were on after water was released from a dam on Narmada river in Madhya Pradesh's Khandwa district n Sunday, an official said. The incident occurred at Nagar Ghat of Omkareshwar when water was released from the dam, sub-divisional magistrate (SDM) Chandar Singh Solanki said. Water is routinely released from the dam by the Narmada Hydroelectric Development Corporation Limited during power generation. The water was released after sounding the siren, as usual but some people did not come out of the water and got trapped on rocks, he said.

Body found

Lucknow: A partially charred body of a man has been found near a garbage dump at Hanumant Dham, a temple, under Hazratganj police circle in Lucknow. This is the second incident of a charred body being recovered in the state capital. Additional Deputy Commissioner of Police (ADCP), (Central), Manisha Singh said that the primary investigation has revealed that the deceased was mentally disturbed and lived near Hanumant Dham for past five years.

Man dies

Ujjain: A 42-year-old man whose name had cropped up in connection with a bribery incident was found ablaze under mysterious circumstances on a road in Ujjain city of Madhya Pradesh and later died during treatment, police said Sunday. Police are investigating the incident from various angles, an officer said. The incident occurred Saturday night when a burning man came out rushing from a public toilet under the Kotwali police station area.

New Delhi, April 9: The Central Bureau of Investigation (CBI), India's premier anti-corruption agency, is facing criticism for its inability to bring cases related to high-profile scams to their logical end because of delayed investigations

Take for instance the two cases that the CBI has filed against former Delhi Deputy Chief Minister Manish Sisodia in the Delhi excise policy scam and snooping case. The agency has made Sisodia the accused number one in both the cases, but it is yet to file a chargesheet in either.

The ICICI-Chanda Kochhar matter has also raised eyebrows, as the CBI filed the FIR in January



2019, two years after the preliminary inquiry into the case was initiated. The CBI arrested former ICICI bank CEO Chanda Kochhar, her husband Deepak Kochhar, and Videocon group MD V N Dhoot in December 2022, five years after lodging the case. The delay in action has raised questions about the agency's effectiveness. Recently

the CBI has filed a chargesheet in connection with the ICICI-Videocon loan case

The CBI has failed to complete its investigation into the death of actor Sushant Singh Rajput, who passed away in June 2020 under mysterious circumstances. His body was found hanging from the ceiling fan of his rented accommodation in Mumbai. The CBI had recreated the crime scene but the investigation is still pending.

Arushi Talwar and domestic help Hemraj Banjade were murdered during the intervening night of May 15 and 16 in 2008. The case was handed over to the CBI in 2009. The Allahabad High Court acquitted the accused saying the evidence was not beyond reasonable doubt.

The CBI had failed to prove its case in the alleged 2G spectrum scam that cost the exchequer Rs 176,000 crore. Special Judge O.P. Saini, who oversaw the trial of all 2G spectrum cases since early 2011, had said in 2017 that his sevenyear anticipation for evidence ended "all in vain" because the case was mainly based on "rumour, gossip and speculation".

CBI under fire for delayed investigations Congress fires fresh salvo at govt

New Delhi, April 9: Firing a fresh salvo at the government, the Congress Sunday pointed to Adani Group's alleged China links and asked why the conglomerate is still being permitted to operate ports in India.

Attacking the Centre, Congress general secretary Jairam Ramesh cited a media report which claimed that the government denied security clearance in 2022 to a consortium of APM Terminals Management and Taiwan's Wan Hai Lines after agencies discovered a connection between a Wan Hai director and a Chinese firm.

This blocked the consortium's bid to operate a container handling terminal at the Jawaharlal Nehru Port Authority, Ramesh said in a statement, pointing out that it is a government policy to prevent Chinese firms and entities with Chinese connections from operating ports and terminals in India.

'This raises fresh questions about the Adani Group's China links. As we have repeatedly pointed out in our Hum Adani ke Hain Kaun (HAHK) series of questions to PM Narendra Modi, Chinese citizen Chang Chung-Ling is closely associated with the Adani Group," Ramesh alleged.



The Opposition led by the Congress has been seeking a Joint Parliamentary Committee probe in the Adani issue

The Gautam Adani-led group has dismissed the charges as lies, and said they comply with all laws and disclosure requirements

"His son owns PMC Projects, a firm that has constructed ports, terminals, rail lines, power lines and other infrastructure assets for the Adani Group. The Adani Group and PMC were alleged to be involved in a Rs 5,500 crore power equipment over-invoicing scam by the Directorate of Revenue Intelligence," he claimed.

Ramesh also said the Adani Group has been known to have operated at least two Shanghaibased shipping companies, one of which was involved in the "illegal sale of petroleum products to the close China ally North Korea". Given these close China links, why is the Adani Group being permitted to operate ports in India, Ramesh asked.

Pilot revives war with Gehlot

Jaipur, April 9: Congress leader Sachin Pilot Sunday alleged that the Ashok Gehlot-led government failed to investigate cases of alleged corruption during the BJP rule in Rajasthan and announced a daylong fast to press for action, in a sign of escalating tussle in the party's state unit ahead of assembly polls.

Without referring to Pilot's demand, the Congress issued a statement in Delhi that its government with Ashok Gehlot as chief minister has implemented schemes that have benefited people and the party will seek a renewed mandate later this year "on the strength of these landmark achievements and the collective efforts of our organisation".

The move by former Deputy Chief Minister Pilot to open the new front against Gehlot amid the factional fighting is seen as an attempt to pressure the high command to resolve the leadership issue ahead of the year-end polls.

'No action was taken (by the Gehlot government) on the corruption by the previous Vasundhara Raje government. While in the Opposition, we promised an inquiry into the mines scam of Rs 45,000 crore," Pilot said at a press conference at his residence here, announcing a hunger strike on Tuesday.

He said he wrote to Gehlot last year on March 28 and November 2 on the issue but did not get any answer to his letters."With six seven months left for the elections, the opponents can spread an illusion that there is some collusion. Therefore, action will have to be taken soon so that the Congress workers feel that there is no difference between our words and actions," he said.

He also showed videos of statements of Gehlot in the Assembly and outside in which he had levelled corruption allegations against the previous BJP government. He said he will observe a day-long fast at Shaheed Smarak on April 11, the birth anniversary of Mahatma Jyotiba Phule who was from the Saini community to which Gehlot belongs.

Gehlot and Pilot have been at

loggerheads over the post of the chief minister ever since the Congress formed the government in Rajasthan in December 2018. The opposition BJP said that Pilot should also demand an investigation into the alleged corruption during the Congress government's

Leader of Opposition Rajendra Rathore said in a statement that the infighting between the chief minister and his former deputy has increased to such an extent that now Pilot will sit on hunger strike against his own government.

While a section of Congress leaders supported Pilot's demand, others claimed it would inflict great harm to the party in the upcoming election, particularly when it is working on a strategy to repeat its government in the state.

In a statement, Congress general secretary Jairam Ramesh said the Congress government in Raiasthan with Ashok Gehlot as CM has implemented a large number of schemes and taken many new initiatives that have impacted the people profoundly.

"This has given the state a leadership position in governance in our country. The Bharat Jodo Yatra in Rajasthan was an outstanding success made possible by the dedication and determination of the party organisation in the state," he said

Man, sister tied to tree; thrashed

A video surfaced on social media in which the married woman and her cousin brother were seen tied to a tree with a rope. The man had come to meet his sister in the village and both were sitting on a cot and talking outside her home, Chouhan said.

Since the woman's husband was not at home, some villagers raised suspicion over their relation and surrounded them, he said. Even after the woman's husband confirmed over phone that the man was_ his wife's cousin, some villagers beat them up.

Three prominent leaders of the G-23 grouping; Manish Tewari, Prithviraj Chavan and Anand Sharma, were part of Kharge's team of three dozen leaders to address a series of 'save democracy' campaigns. It transpires that Kharge had consulted the Gandhis before evolving this strategy. For Kharge,

he wants to send a message to Karnataka voters that he has brought unity within the party.

BJP's secret plan

Even as the Opposition parties are struggling to evolve a common strategy to take on the mighty BJP under the leadership of Prime Minister Narendra Modi in the 2024 Lok Sabha polls, the ruling party's strategy is already in the works to ensure the defeat of prominent Opposition leaders. It has been decided to give charge of around 20 Lok Sabha constituencies to select Union Ministers to defeat prominent Opposition leaders. The BJP had identified 165-odd Lok Sabha seats

which it had lost in 2019 Lok Sabha polls. But special attention is being paid to wrest these 20 Lok Sabha seats to defeat prominent leaders who are considered invincible.

BJP caught in its web

he BJP has run a highly successful campaign against the Congress on the issue of dynastic politics but tends to ignore the political heirs being groomed by its own leaders. Union Minister Jyotiraditya Scindia's son Mahanaryaman Scindia is the latest political scion to join this tribe going by his increasing public exposure. B S Yeddiyurappa,

Karnataka's former Chief Minister, is batting for his son's ticket in the Assembly. BJP's many top leaders have the privilege of having their sons as MP in the Lok Sabha. Jyotiraditya Scindia has been taking his son to all major public events in the family strongholds of Guna and Gwalior while several fan clubs have sprung up in the Scindia bastions. These clubs have been organising cricket matches and other sporting events where Mahanaryaman is invited either as chief guest or special guest. With Madhya Pradesh headed for Assembly polls this year-end, all this activity indicates Scindia is preparing for his son's electoral debut who is now 27 years old and eligible to contest an election.

Ferencz no more

Washington: Benjamin Ferencz, the last surviving prosecutor from the Nuremberg trials in Germany that brought Nazi war criminals to justice after World War Two and a longtime apostle of international criminal law, died Friday at age 103. Ferencz, a Harvardeducated lawyer, secured convictions of numerous German officers who led roving death squads during the war. Circumstances of his death were not immediately disclosed. The New York Times reported that Ferencz died at an assisted living facility in Boynton Beach, Florida. He was just 27 years old when he served as a prosecutor in 1947 at Nuremberg, where Nazi defendants including Hermann Göring faced a series of trials for crimes against humanity including the genocide known as the Holocaust in which six million Jewish people and millions of others were systematically killed.

Sunak to meet Biden

London: British Prime Minister Rishi Sunak will welcome US President Joe Biden to Belfast in Northern Ireland next week as the UK commemorates the 25th anniversary of the Belfast (Good Friday) Agreement, the peace treaty struck for the region in April 1998, Downing Street said Sunday. Biden will arrive in the UK Tuesday evening, when Sunak will meet him off Air Force One and the US President will then undertake a programme of engagements including a bilateral with Sunak. It comes as Monday marks a quarter of a century since the Good Friday Agreement was signed, transforming the political and economic landscape of the devolved region of Northern Ireland. "The Belfast (Good Friday) Agreement was an incredible moment in our nation's history. It was a powerfully rare example of people doing the previously unthinkable to create a better future for Northern Ireland," said Sunak.

UKRAINE BRINGS BACK 31 ABDUCTED CHILDREN FROM RUSSIA AMID WAR

Kyiv, April 9: The head of a Ukrainian rescue organization said Saturday that the organization has brought back 31 children from Russia, where they had been taken during the war.

Mothers hugged sons and daughters as they crossed the border from Belarus into Ukraine after a complex rescue mission involving travel across four countries.

'We were treated like animals. We were closed in a separate building," said Vitaly, a child from Kherson region whose age was not clear. He added that they were told their parents no longer wanted

Mykola Kuleba said at a news

conference in Kyiv that the children were expected to arrive in the capital later in the day. Kuleba is the executive director of the Save Ukraine organization and is the presidential commissioner for children's rights. Deportations of Ukrainian chil-

dren have been a concern since Russia's February 24, 2022, invasion of Ukraine. The International Criminal Court increased pressure on Russia when it issued arrest warrants March 17 for President Vladimir Putin and Russian children's rights commissioner Maria Lvova-Belova, accusing them of abducting children from Ukraine.

The International Committee of the Red Cross said this week it

Belova, the first confirmation of high-level international intervention to reunite families with children who were forcibly deported.

ICRC spokesman Jason Straziuso said the organization was in contact with Lyova-Belova "in line with its mandate to restore contact between separated families and facilitate re-

unification where feasible."

An Associated Press investigation revealed Lvova-Belova's involvement in the abductions and found an open effort to put Ukrainian children up for adoption in

Russia. Lvova-Belova

told an informal UN Security Council meeting Wednesday that the children were taken for their safety, not abducted - a claim widely rejected by the international community.

The exact number of Ukrainian children taken to Russia has been

difficult to determine, and numbers from the warring countries differ vastly.

Kyiv estimates nearly 19,500 children have been taken to Russia or Russian-occupied Crimea since Moscow invaded in February last vear, in what it condemns as illegal deportations

Moscow, which control chunks of Ukraine's east and south, denies abducting children and says they have been transported away for their own safety. It has not concealed a programme under which it has taken thousands of Ukrainian children from occupied areas, but presents this it as a humanitarian campaign to protect orphans and children abandoned in the

Taipei, April 9: China's military simulated precision strikes against Taiwan in a second day of drills around the island Sunday, with the island's defence ministry reporting multiple air force sorties and that it was monitoring China's missile forces.

China, which claims democratically governed Taiwan as its own territory, began three days of military drills around the island Saturday, the day after Taiwan President Tsai Ing-wen returned from a visit to the United States. Chinese state television reported

that the combat readiness patrols and drills around Taiwan were continuing. "Under the unified command of the theatre joint operations command centre, multiple types of units carried out simulated joint precision strikes on key targets on Taiwan island and the surrounding sea areas, and continue to maintain an offensive posture around the island," it said.

The ministry said they were paying particular attention to the People's Liberation Army's Rocket Force which is in charge of China's land-based missile system.

"Regarding the movements of the Chinese communists' Rocket Force, the nation's military also has a close grasp through the joint intelligence, surveillance and reconnaissance system, and air defence forces remain on high alert," the ministry said.

It reiterated that Taiwan's forces will "not escalate conflicts nor cause disputes" and would respond

"appropriately" to China's drills. This is a serious warning to the Taiwan independence separatist forces and external forces' collusion and provocation, and it is a necessary action to defend national sovereignty and territorial integrity," the Chinese army's Eastern Theatre Command said.

The security source said about 20 military ships, half from Taiwan

and half from China, were engaged in a stand-off near the Taiwan Strait's median line, which has for years served as an unofficial barrier between the two sides, but did not behave provocatively.

China's aircraft carrier Shandong, which Taiwan has been monitoring since last week, is now more than 400 nautical miles off Taiwan's southeast coast and is carrying out drills, the source said.

'COMFORTABLE, CONFIDENT' US

The de facto US embassy in Taiwan said Sunday the United States was monitoring China's drills around Taiwan closely and is "comfortable and confident" it has sufficient resources and capabilities regionally to ensure peace and stability.

US channels of communication with China remain open and the United States had consistently urged restraint and no change to the status quo, said a spokesperson for the American Institute in Taiwan. which serves as an embassy in the absence of formal diplomatic ties.

Washington severed diplomatic relations with Taipei in favour of Beijing in 1979 but is bound by law to provide the island with the means to defend itself. Beijing considers Tsai a separatist and has rebuffed her repeated calls for talks. Tsai says only Taiwan's people can de-

cide their future. China has over the past three years or so stepped up its military pressure against Taiwan, flying regular missions around Taiwan, though not in its territorial air space or over the island itself. Chinese state media said the aircraft were armed with live weapons. Taiwanese air force jets also typically carry live weapons when they scramble to see off incursions.

Jerusalem, April 9: Israeli jets hit Syrian military targets Sunday in response to rockets launched towards Israeli controlled terri tory overnight. Israel's military said, as violence flared again following cross-border exchanges of fire during the week.

State media in Syria reported explosions in the vicinity of the capital Damascus as Israel said its forces continued to hit Syrian territory after six rockets were fired overnight towards the Golan Heights.

Israel said artillery and drone strikes hit the rocket launchers and were followed by airstrikes against a Syrian army compound,

military radar systems and artillery posts.

The Israeli military "sees the State of Syria responsible for all activities occurring within its territory and will not allow any attempts to violate Israeli sovereignty," the Israeli Defense Forces said.

The Syrian defence ministry said its air defences had responded to the Israeli attacks and intercepted some Israeli missiles. It said no casualties had been reported with only material damage caused by the strikes.

Sirens had sounded earlier near towns in the Golan Heights as rockets were launched from Syrian territory, but no damage or casualties were reported. Israel seized the Golan Heights in the 1967 Middle East war and annexed the 1,200square-km territory in 1981, a move not recognised by most of the international community.

Lebanon-Based Al Mayadeen TV said the rocket salvoes were claimed by Al-Quds Brigades, the armed wing of the Iranian-backed Palestinian Islamic Jihad movement.



Russian oil imports now double of Iraq

Refiners continue to snap up plentiful Russian cargo available at a discount to other grades

New Delhi. April 9: India's imports of crude oil from Russia touched a new high of 1.64 million barrels per day in March and are now double of the purchases from Iraq - the nation's traditional top oil supplier. But the purchases appear to have plateaued as growth has slowed.

Russia continued to be the single largest supplier of crude oil, which is converted into petrol and diesel at refineries, for a sixth straight month by supplying more than one-third of all oil India imported, according to energy cargo tracker Vortexa.

From a market share of less than 1 per cent in India's import basket before the start of the Russia-Ukraine conflict in February 2022, Russia's share of India's imports rose to 1.64 million barrels per day in March, taking a 34 per cent share.

The purchases from Russia in March were double of 0.82 million barrels per day (bpd) of oil bought from Iraq, which has been India's top oil supplier since 2017-18.

India, the world's third-largest crude importer after China and the United States, has been snapping Russian oil that was available at a discount after some in the West shunned it as a means of punishing Moscow for its invasion of Ukraine.

Month-on-month, purchases from Russia rose marginally from 1.62 million bpd of oil imported from the country in February.

According to Vortexa, Saudi Arabia was India's second largest

"While India continues to increase its imports of Russian crude month-on-month in March, the growth has slowed," said Vortexa's head of Asia-Pacific analysis, Serena Huang. "Refiners' purchases of medium-sour Russian Urals have remained steady in March, and the increase in imports are attributed to higher purchases of sweeter grades like Novy Port Light."

In December, the EU banned Russian seaborne oil and imposed a \$60-per-barrel price cap, which prevents other countries from using EU shipping and insurance services, unless oil is sold below the cap.

Industry officials said Indian refiners are using UAE's dirham to pay for oil that is imported at a price lower than \$60. "Almost a quarter of the Russian imports are now paid in dirham," an official said.

Gold imports dip 30% in April-Feb

New Delhi, April 9: India's gold imports, which have a bearing on the current account deficit, fell about 30 per cent to \$31.8 billion during April-February 2023 due to high customs duty and global economic uncertainties, according to data from the commerce ministry. Imports of the yellow metal

stood at \$45.2 billion in the corresponding period of 2021-22. Silver imports, however, rose by 66 per cent to \$5.3 billion during April-February 2023

The imports are in the negative zone since August 2022. The significant fall in gold imports though has not helped in narrowing the country's trade deficit -- the difference between imports and exports. The merchandise trade deficit for April-February 2022-23 was estimated at \$247.52 billion against \$172.53 Billion in the year ago period.

According to industry experts, high import duty on gold and global economic uncertainties are the reason for the dip in the imports

Before these outflows, FPIs invested a record Rs 2.7 lakh crore in equities in 2020-21 and Rs 6,152 crore in 2019-20

The import of coking coal rose 7.69 per cent to 50.50 MT during April-February FY23 compared to 46.89 MT a year ago, mjunction said in its latest report.

Coking coal imports were 4.40 MT against 4.03 MT imported in February 2022.

For coking coal - a key raw material used in steel making - the country remains heavily dependent on imports.

Mjunction MD Vinaya Varma said, "The softening of seaborne prices coupled with high domestic demand resulted in continued buying interest among Indian traders and consumers".

However, the increased domestic supply and the healthy stock position may restrict the volumes in the coming month, he added.

Unseasonal rains, high-interest rates fret automakers

New Delhi, April 9: Unseasonal rains impacting rural demand, high-interest rates on auto loans and increased costs due to new regulatory norms are making the automotive industry cautious about the growth prospects in the current fiscal.

The industry --- which witnessed the first full year without any impact of Covid-19 in FY23 after a gap of two years with double-digit growth of 21 per cent in overall retail sales -- is now set to clock tapered growth in the low singledigit due to a high base, according to the Federation of Automobile Dealers Associations (FADA).

Maruti Suzuki India Senior

Executive Officer, Marketing and Sales, Shashank Srivastava said the unseasonal rains in March and early April could have a dampening effect on the sentiment in the rural areas. "Because this is the harvest time and these rains are not so good (for the rural sales)," he told PTI.

Similarly, FADA said, "The untimely rains and hailstorms in north and central India have destroyed key rabi crops and delayed harvesting, (and) will have a negative impact on rural sales".

Another concern for automakers is the high-interest rates on automobile loans.

"The interest rates continue to be high," Srivastava said, adding since the rate tightening cycle started by the RBI in May 2022, the



repo rate has gone up from 4 per

cent to 6.5 per cent. He further said, "And what we have found is that the transmission of the reporates into the auto loan rates has been almost complete. There are different banks which have increased between 180 basis

points to 250 basis points" With auto loans constituting 80


