### PROTESTING SCHOOL MERGER, GIRLS FAINT DURING SIT-IN

Mumbai: Benchmark Sensex and Nifty rallied for a third day in a row to close at fresh lifetime high levels Monday following buying in banking and oil stocks and FII inflows. Analysts said the first guarter results by Indian companies have been mostly in line with expectations, triggering a rally in local equities despite mixed global cues. The 30-share BSE Sensex jumped 529.03 points or 0.80 per cent to settle at its new alltime closing high of 66,589.93. The NSE Nifty also soared by 146.95 points or 0.75 per cent to close at a new record high of 19,711.45. P11

#### Fire in battery box of Vande Bharat

Bhopal: A fire broke out in the battery box of a coach of the Vande Bharat train heading from Madhya Pradesh capital Bhopal to New Delhi Monday morning, a senior railway official said. This was the first instance of a fire breaking out in a Vande Bharat Express train. There were 37 passengers in the affected coach and they were shifted to other coaches immediately. No injury was reported to anyone in the incident, the official said. The fire was later doused and repairs were conducted. The train resumed its onward journey after remaining halted for more than three hours, the official said.

Bhubaneswar, July 17: Girl students of a school here and their parents staged a sit-in opposing the state government's decision to merge their institution with a boys' school, police said.

At least five students of Unit-9 Government Girls' High School fainted during the agitation. They were rushed to the Capital Hospital and their condition was stable, the police said.

The state government has decided to merge the Unit-9 Girls' High School with the Unit-9 Boys' High School to accommodate and relocate Rama Devi Women's Junior College.

The Director of Higher Secondary Education, Odisha, has already written a letter to the School & Mass Education Special Secretary on the separation of the infrastructure of RD Women's Higher Secondary School from Rama Devi Women's University.

As per the decision, the Arts and Commerce streams can be shifted to Unit-9 Government Girls' High School in the first phase. However, the classes for science students will be held at Rama Devi Women's University as there is no laboratory facility at the school for science education.

'Former Chief Minister Dr Harekrushna Mahatab had set up the girls' high school at Unit-9 for encouraging girls to continue study. The government cannot merge this school,' Congress leader and Jatni MLA Suresh Routray who joined the girls' agitation said.

Bhubaneswar Block Education Officer, Pragyan Paramita Jena, who visited the agitation site, tried to convince the students and their parents to pave the way for the merger. However, her appeal was rejected by the agitators. "I will inform the government about the opinion of the girls," she said before leaving the place.

#### AGENCIES

Bangalore, Jul 17: Several new BJP allies, including Lok Janshakti Party (Ram Vilas), OP Rajbhar-led SBSP and the Hindustani Awam Morcha (Secular), will join a key meeting of the National Democratic Alliance (NDA) here Tuesday as the ruling party eyes a grand show of strength amid a get-together of 26 opposition parties in Bangalore ahead of the Lok Sabha elections in 2024.

At least 38 parties are expected to attend the NDA meeting. The Lok Janshakti Party (Ram Vilas) became the latest entrant to the NDA with its leader Chirag Paswan meeting BJP president JP Nadda and Home Minister Amit Shah Monday.

The Shiv Sena led by Maharashtra Chief Minister Eknath Shinde, NCP led by

Maharashtra Deputy CM Ajit Pawar, Rashtriya Lok Janata Dal (RLJD) led by Upendra Kushwaha and the Jana Sena led by Pawan Kalyan will be among the new entrants that will be attending the NDA meeting. Some of these parties had partnered with the BJP earlier as well.

Meanwhile, with a call for unity, top leaders of 26 opposition parties began crucial deliberations Monday to chalk out their joint programme aimed at defeating the BJP in the 2024 Lok Sabha elections.

Congress leader Sonia Gandhi and Trinamool Congress (TMC) chief Mamata Banerjee, who were seated next to each other, Congress president Mallikarjun

Kharge, Rahul Gandhi, chief ministers MK Stalin, Nitish Kumar, Arvind Kejriwal, Hemant Soren and RJD chief Lalu Prasad were among those who attended the dinner meeting where discussions were held to finalise the agenda for the formal talks starting Tuesday morning.

Sources said NCP chief Sharad Pawar was the only leader among the invitees not present at the meeting at Taj West End Hotel and he would arrive Tuesday along with his daughter Supriya Sule.

The leaders sat in front of a huge banner with "United We Stand" slogan, which was also put on posters that dotted the streets of Bangalore with pictures of opposition leaders.

Corporation Ltd (IRCTC) has now changed the scheme to allow the option to opt out.

Curiously, the premium charged for ₹10 lakh personal accident insurance cover is a paltry Re 0.35 paise. The policy covers death, disabilities and/or medical expenses due to a train accident during the travel.

The insurance cover is provided by two non-life insurers -SBI General Insurance Company Ltd and Liberty General Insurance Company Ltd.

Odisha last month killing 288 passengers and injuring over 1,000. The Insurance Regulatory and Development Authority of India (IRDAI) had told IANS that a total of 624 passengers were having insurance cover under the IRCTC travel accident insurance scheme. A total of 22 claims totalling ₹60.52 lakh were reported to the two insurers for disability and hospitalisation due to the Odisha train accident and no death claim has been lodged.

Even though they would like to have insurance cover, not many passengers while booking a Tatkal train ticket on the IRCTC portal will be inclined to click on the insurance cover box as their main goal to reserve a ticket in hurry, the insurance official said

Berhampur, July 17: Digapahandi police Monday arrested a man in Dengausta of Ganjam district for impersonating as an allopathic doctor without any proper medical qualification or registration.

The accused identified as Subhrajit Panda, 29, is a native of Hindol Road under Parjang police limits in Dhenkanal and resides at Nua Bazar in Cuttack city. He was running clinics named as Best Poly Clinic at Dengausta of Ganjam and Ranihat area of Cuttack for the last one year.

As per reports, he was visiting the Dengausta-based clinic in Digapahandi and another in Aska twice a month to see patients. He used to take the medicine representative's help to prescribe medicines and treat the patients. A case was registered in this connection and the accused was produced in the court, the police said.

Notably, a woman suffered kidney ailments and had to undergo dialysis in Bhubaneswar after consuming the medicines prescribed by the fake doctor. Following this incident, the family members of the patient lodged a complaint before the police.

When the police conducted a sting operation in Panda's clinic at Dengausta, it was found that all his medical certificates and other documents were fake.

"We found that his MBBS certificate, specialisation from Germany, orthopaedic certificate and some fellowship documents are fake. We caught him red handed in his clinic," said Berhampur SP Saravana Vivek M.

He was earlier arrested in ২ 2020 by Telangana Police in Hyderabad for impersonating as a doctor. He was in jail for 15 days and is out on bail now. The trial of the case is still going on, he said. The SP ap-pealed to people to inform the police whenever they come across any such fake doctor.

Moscow halts grain deal after bridge to Crimea struck

Moscow, July 17: Russia halted participation Monday in the vear-old UN-brokered deal which lets Ukraine export grain through the Black Sea, just hours after a blast knocked out Russia's bridge to Crimea in what Moscow called a strike by Ukrainian sea drones.

Russia said two civilians were killed and their daughter wounded in what Moscow cast as a terrorist attack on the road bridge, a major artery for Russian troops fighting in Ukraine.

The Kremlin said there was no link between the attack and its decision to suspend the grain deal, which it says must also ease restrictions on Russian food and fertilizer exports.

"In fact, the Black Sea agree-

ments ceased to be valid today," Kremlin spokesman Dmitry Peskov told reporters on a conference call. Unfortunately, the part of these Black Sea agreements concerning Russia has not been implemented so far, so its effect is terminated.

Images showed a section of the road bridge had come down and traffic was halted in both directions, although a parallel railway bridge was still operational. Blasts were reported before dawn on the 19-km bridge, which Russian President Vladimir Putin ordered built after seizing and annexing the peninsula from Ukraine in 2014.

Kyiv gave no official account of the blasts. It typically does not comment on reports of attacks in Crimea or in Russia,



but has long maintained that the bridge was built illegally, and its use by Russia for military supplies makes it a legitimate target. Russia reopened the bridge after it was last hit by a massive explosion and fire in October.

Russia's suspension of the Black Sea grain deal could drive up food prices across the globe, especially in the poorest countries. Ukraine and Russia are both among the world's biggest exporters of grain and

The grain deal was hailed as preventing a global food emergency when it was brokered by the United Nations and Turkey last year, halting a de facto blockade of Ukrainian ports by Russia, which agreed to let ships pass after inspections in Turkey.

Turkish President Tayyip Erdogan, the deal's powerful sponsor, said he still believed

Putin wanted it to continue. The Russian and Turkish foreign

ministers would talk later Monday, he told reporters. Global commodity food prices

rose Monday, though the increase was limited, suggesting traders did not yet anticipate a severe supply crisis

Putin had threatened last week to suspend participation in the grain deal, while also saying Russia could return to it if its demands were met for easier rules for its own agriculture and fertilizer exports.

Alongside the Black Sea grain deal, a three-year deal was struck last year under which UN officials agreed to help Russia get its food and fertiliser to foreign markets. Moscow says those terms have not been fully implemented.







#### 62.6L IN ODISHA PULLED OUT OF POVERTY IN 5

New Delhi, July 17: At least 62,62,852 people in Odisha were pulled out of multidimensional poverty in five years, according to NITI Aayog's 'National Multidimensional Poverty Index: A Progress Review 2023'

According to the report released by NITI Aayog vice-chairman Suman Berry Monday, at least 13.5 crore people across the country exited the multidimensional poverty between 2015-16 and 2019-21.

Odisha has registered a significant decline of 13.65 percentage points in number of multidimensionality poor in five years- from 29.43 per cent in 2015-16 to 15.68 per cent in 2019-21, it said. While rural Odisha registered the fastest decline in poverty - from 32.64 per cent to 17.72 per cent, urban areas saw


marginal decline – from 12.32

per cent to 5.42 per cent. Malkangiri topped the chart in the state with 45.01 per cent multidimensional poor population, while Puri has 3.29 per cent multidimensional poor people. The National MPI measures simultaneous deprivations across the

three equally weighted dimensions of health, education, and standard of living that are represented by 12 SDG-aligned indicators. India saw a significant decline of 9.89 percentage points in number of multidimensionally poor-from 24.85 per cent in 2015-16 to 14.96 per cent in 2019-2021.



The rights body asked the Chief Secretary to show reasons within six weeks as to why Rs5lakh compensation should not be given to the next of the kin of Uma Charan Bisoyi of Boutajholi village under Berhampur Sadar police limits of Ganjam.

The commission's move fol lows a plea filed by human rights activist Rabindra Mishra who informed the commission that Bisoyi and his female friend had gone to spend some quality time at the cashew forest near Baiganbadi in the district when the tragedy struck around 11pm December 13, 2022 "While parking his motorcycle at the forest, Bisoyi came in contact with a live wire laid for poaching wild boar and died instantaneously. After learning about the mishap from Bisoyi's female friend, his brother

Bhuabneswar, July 17:The Econmic Offences Wing (EOW) of state police Monday issued an advisory cautioning people about online cyber fraud. The EOW has also urged the victims who have already fallen in the trap of cyber crooks to contact police without getting panciked. "All are advised to remain

alert and not to fall in the traps of these cyber thugs. And, in case, they fall in the trap, they should immediately inform police/112/1930 (Cybercrime helpline). They should never panic because these cyber thugs can't do anything if you remain strong and don't surrender to their illegal demands," the EOW advises.

The cops have also drawn the attention of the people towards various modus operandi of cyber fraudsters. According to EOW, the criminals create websites/apps to run their schemes and also promote those on social media. The fraudsters ususally communicate with their associates and victims through WhatsApp and Telegram channels to avoid getting tracked by law enforcement agencies. "They use fake SIMs and mule bank accounts wherever required to ensure anonymity. They control and do business through numerous mule bank accounts (traded on dark market in some Whatsapp groups and Telegram channels)", revealed EOW.

Sources said that hope of em-

ployment among the locals is slowly dying while people are becoming increasingly disillusioned over industrial development.

'Nuvoco' bought the cement plant at Dasmania under Mantira mouza of Danagadi tehsil in Jajpur district at an investment of ₹401 crore and started production in 2021. Officials had said that approximately 500 people will be employed for the running of the plant and 58 of them will be permanent. It had also promised one job each for the 50 displaced families. But till date, jobs haven't been provided and locals alleged that the management of the firm, because of its close affinity to some influential political leaders is running the show with impunity.

### Man awarded 10-yr **RI** for raping minor

Baripada, July 17: A court in Mayurbhanj district Saturday sentenced a 31-year-old man to 10 years of rigorous imprisonment for raping a girl eight years ago

District Special POCSO Court Judge Sumita Jena also imposed a fine of `7,000 on the convict, **Special Public Prosecutor** Abhinna Kumar Pattnaik said.

The court also directed Mayurbhanj District Legal Services Authority to pay ₹2 lakh to the survivor as compensation.

According to the prosecution, the girl, who was 15 years old then, was kidnapped by the convict from Sunagaria Sahi in



Baripada town police station area March 5, 2015 and raped multiple times.

The survivor's mother lodged an FIR with the police. A case under POCSO Act was registered, the accused was arrested and the girl underwent a medical examination.



### **Bothersome Backyard**

The deafening silence of Prime Minister Narendra Modi and the half-hearted, partisan approach of his government towards the ethnic violence in Manipur, over the past two months, are responsible for the apparently uncalled for resolution of the European Union Parliament urging the Centre to "take all necessary measures to promptly halt the ongoing ethnic and religious violence." It did not even stop at that and sent out a strong message to the Indian government to protect all religious minorities, such as Christians in Manipur. This is no mere expression of concern, but a warning that if the humanitarian crisis is not stopped immediately, it would impact the economic ties between India and EU. It is also true that the EU Parliament does not have any teeth and cannot do much beyond economic strangulation. The European lawmakers asserted that human rights should be an important part of ongoing negotiations between India and the EU on the free trade agreement.

Meanwhile, the reaction of Ministry for External Affairs (MEA) to the EU resolution, terming it as unnecessary interference in India's internal affairs and a reflection of "colonial mindset", smacks of arrogance and foolhardiness. When the BJP-led government has been making tall claims for digitising India, it should have realized that in today's social media world it takes only a few minutes for the whole world to know the exact extent of ethnic violence in Manipur and the seemingly deliberate inaction of the double engine BJP government - since it is ruling both in that state and the Centre

No wonder the resolution described with hard statistics the situation in Manipur where the ethnic violence has left over 120 dead, 50,000 people displaced and 1,700 houses and over 250 churches and several temples destroyed. The statistics are no figment of imagination, but facts that cannot be hidden by the government or denied with the brazenness that characterises the current dispensation.

The MEA may dismiss with utter contempt the EU advice to Indian political leaders to refrain from making inflammatory statements and try to re-establish trust. But, the diagnosis of the EU Parliament that the violence had been instigated by "politically motivated, divisive policies promoting Hindu majoritarianism" and increased activity by militant groups is on target.

The BJP's brand of pseudo-nationalism and communal polarisation has been mainly restricted to Moslem-bashing since that community is the largest among the minority groups in the country. The lack of mutual trust and even hatred born out of the partition have helped the BJP sway the minds of majority Hindoo community, mostly in the Hindi speaking belt, for successfully re-capturing power.

But, the situation in Manipur is different and the communal polarisation there is between majority Hindoos, the Meiteis, comprising 53 per cent of the state's population and predominantly Christian Kukis, accounting for about 30 per cent of the state's 28.5 lakh population. The Chief Minister of the BJP government in Manipur, N Biren Singh, belongs to the Meitei community and he has been accused of partisan handling of the conflict. The root cause of the ethnic strife is the demand by the majority community for a tribal status that would enable it to get a greater share of the state's land in the hills given to the Kukis through constitutional arrangement. The BJP-led government at the Centre is supporting the Meiteis' demand, seemingly for vote-bank politics.

This is the reason why the EU Parliament resolution has observed that partisan involvement by security forces in the killings have increased distrust towards the authorities.

In a way, the intervention of the European lawmakers is not wholly welcome but because the ruling group seems not to care two hoots about criticism of its polarisation politics by political opponents and civil society groups, it may seem acceptable. It is not a question of interference from outside, since human rights issues transcend geographical boundaries. The government would do well to listen to voices of criticism, both internal and external, and stop playing with fire and pitting one community against another for capturing power. Right-wing forces across the globe have been raising their ugly heads to trample down minorities and immigrants. Post-independent India had a favourable tradition of managing unity in diversity. This should not be allowed to be destroyed as the world today, since our Prime Minister would understand it best, has truly shrunk and looking into each other's backvard is no more considered 'interfer-

Has this ground reality changed in recent times? It would appear so, in the light of a set of news reports in the last few weeks that tell us that the NPAs in the Indian banking sector have fallen dramatically, down to a 10-year low, quoting the RBI's Financial Stability Report that was released June 28, 2023. The report says gross NPAs were 3.9% in FY23, down from a high of 11.5% in 2018. The period also saw gross advances grow, from Rs 83.6 lakh crore in 2018 to Rs135 lakh crore in 2023, so that falling percentages of gross NPAs on an increased base of advances may not tell the full story. Yet, the drop in the gross NPA percentage is a turnaround of sorts. A different picture might emerge if the issue is studied from the numbers of new NPAs that are even now being created in the system. If the old NPA number fell because of huge haircuts and write-offs, and new NPAs continue to be added in the system, then that poses a different set of questions on the what, how and why of the management of NPAs and the protection of what essentially are public funds. Strict follow-ups and penal or criminal action where warranted would signal a resolve to come to grips with the problem of rising NPAs. which can of course be genuine business failures but are often tangled with loose governance and the unique Indian idea of "wilful defaulters" – those who can pay back but refuse to do so and continue to roam free.

Consider that gross NPAs were 5.8% in 2021-22, which translated to a total NPA figure of Rs 7.44 lakh crore. This number was down from Rs 8.35 lakh crore at the beginning of the year. The single largest contributor to the lowering of the number was write-offs, which were reported at Rs 1.79 lakh crores. More significantly, Rs 2.83 lakh crore new NPAs were added in 2021-22, the latest for which data is available.

Improving the lives of these children is not a question of food supply. Current cereal grain production, about 2.8 billion tonne, provides enough calories to feed 11-14 billion people - more than meeting humanity's current needs. But less than half of the world's grain is eaten by humans, with the remainder fed to animals or burned as fuel. Almost every gallon of gasoline in the US, for example, contains 10% corn ethanol. Too poor to affect grain prices in global markets, the chronically hungry are economically invisible. To avert the devastating and long-lasting effects of poor nutrition and health, we propose an innovative financing mechanism that will attract impact investors and ensure adequate food for these malnourished children. In 2019, two World Bank economists, Emanuela Galasso and the late Adam Wagstaff, found that childhood stunting reduces

#### Magnetar

This word, not often seen outside the specialist field of cosmology till the late 1990s, has since then become a hot topic. Reports have appeared of a colossal burst of gamma rays which hit the Earth's upper atmosphere on 27 August 1998. The pulse lasted about five minutes, ionised the atmosphere on the night side to levels normally seen in daytime, disrupted some radio traffic, sent detectors on several spacecraft off scale and caused one to shut down completely. What is astonishing about this phenomenon is that it was traced to a star some 20,000 light years away, of a strange and rare kind known as a magnetar. Astronomers think they are young neutron stars, formed in supernova explosions, which are rotating at speeds that approach a thousand times a second. This rotation generates immense magnetic fields. The heat generated by the movement of the field through the iron crust of the neutron star quickly becomes so great that it cracks apart in what has been dubbed a starquake, the stellar equivalent of an earthquake. This causes the release of vast amounts of gamma rays. Though our atmosphere protects us from the radiation, such huge bursts can, as we've seen, knock out satellites. The name is a blend of magnetic and star; it was coined by Robert Duncan and Christopher Thompson in a paper in the Astrophysical Journal in 1992; these exotic stars are also called soft gamma repeaters, a name which was given to them after a huge radiation burst was observed in 1979 and long before their true nature was realised. Here are two examples of the word's use in publications in the late 1990s. "In ordinary neutron stars the crust is stable, but in magnetars, the crust is stressed by unbearable forces as the colossal magnetic field drifts through it," said Duncan (published in Space Science News, May 1998). A young magnetar would be very hot, because of frictional heat generated by mobile material, redistributed by the powerful magnetic field (published in New Scientist, August 1998).

Galasso and Wagstaff also conducted a cost-benefit analysis of applying ten tested nutrition interventions over ten years in 34 countries that together account for 90% of the world's stunted children. According to their estimates, the benefits would outweigh the costs by a ratio of at least five to one, and the annual rate of return would be 12%

Such high payoffs could induce investors to buy development impact bonds focused on ending childhood stunting in low-income countries. The idea behind this type of financial instrument, in which investors provide financing for development programmes and receive returns only if agreed-upon outcomes are achieved, is "to generate a positive, measurable social and environmental impact alongside a financial return.

Returns on investments in nutrition-intervention bonds would be tied to programmes' projected economic benefits. After all, effective nutrition interventions should boost productivity and

The simplest model would offer fixed principal and interest payments, backed by fixed contractual payments. But investors with a greater appetite for risk may prefer governments to reward better-than-expected improvements in child nutrition and related tax revenues with larger contractual payments, triggering larger payments to the bondholders. Of course, poorer-than-expected improvements would result in smaller payments.

Nutrition-intervention bonds are an innovative financing vehicle that promises to put food on the table, prevent childhood stunting, and yield high returns for investors. If well-structured, they can be powerful catalysts for economic growth and improving the welfare of the world's most vulnerable people.




A senior police officer confirmed to PTI that Seema, Sachin and Netrapal Singh were being interrogated by the ATS on Monday and that the local police were not involved in it.

### Dumping debris in mountains multiplies mudslides: Experts

#### HAPHAZARD MUCK AND DEBRIS DUMPING ALONG STREAMS AND RIVERS OFTEN MULTIPLIES HAZARDOUS LANDSLIDE CHAIN REACTIONS DOWNSTREAM

#### INDO-ASIAN NEWS SERVICE

Shimla, July 17: The roaring rapids of rivers relating to climate related risks in Himachal Pradesh have been evidently triggered by extremely wet southwest monsoon rainfall this season. Even the cold desert Lahaul-Spiti, the rain-shadow zone, had to face a deluge, say meteorologists and climate scientists.

They say in recent years flash floods have intensified as the mountains are getting older and they contribute to more silt and sand. The haphazard muck and debris dumping along streams and rivers that disturbs the natural course of rivers and streams often multiplies hazardous landslide chain reactions downstream. Also debris from blasting and construction of hydropower projects and national highway projects is dumped on slopes, damaging the vegetation too.

They say incessant downpours in the mountainous states are now a reality due to global warming and the local communities may now have to unlearn their former ways of living and the authorities must stop unwanted construction. This time frightening visuals of bridges, residential and commercial buildings, vehicles and highways collapsing like a pack of cards and being swept

#### **DEADLY DELUGE**

In less than a month since the onset of monsoon June 24, 53 landslides and 33 flash floods have occurred in Himachal that claimed 108 lives with 12 people missing

This time the deluge reminded the locals of the 1995 floods in Kullu-Manali that wreaked havoc on an unprecedented scale

away in mudslides indicate how bad is the debris management. Floodwaters are receding, but they are leaving a coating of mud with boulders that has to be cleaned up from fields, villages

and towns. Blaming global warming for the increasing intensity of the flash floods and the unusually high soil erosion in the hill states, disaster risk reduction and management expert Rajnish Ranjan told IANS that during the summer the higher terrains witness contractions and extractions, while the mountains observe freeze-and-

thaw action during winter. Freeze-thaw weathering is a process of erosion that happens in cold areas where ice forms.



However, due to increased global warming, the process of weathering and exfoliation has increased manifold.

"Thus, whenever there are intermittent torrential rains in mountain regions nowadays, we see more sand and silt. Secondly, mountains are also getting older and that also contributes to more silt and sand," Ranjan explained.

Global science related to climate change says the scale of the rise in extreme weather events in India has been charting new highs with every passing year. 2023 began on a hotter note, with temperatures in February breaking the 123-year-old record. The humid heatwaves in April and June over East and Central India

were made 30 times more likely due to climate change. Then the formation of cyclone Biparjoy lasted for 13 days in the Arabian Sea and became the longest-duration cyclone since 1977. With extremely heavy rainfall wreaking havoc across northwest India, science blames the increasing levels of global warming.

Anjal Prakash, lead author of two UN Intergovernmental Panel on Climate Change (IPCC) reports released between 2019 and 2022, told IANS that the relentless downpour has transformed picturesque landscapes into a battleground of resilience, as Himachal Pradesh, Puniab. Delhi-NCR and parts of Uttarakhand currently bear witness to the havoc. "As the rain clouds persist, it is a stark reminder of the urgency to address climate change and its far-reaching consequences.

According to Prakash, communities, especially people on the margins of society, are impacted by these severe precipitation events, which cause disastrous floods, landslides, and extensive devastation as the globe sees. "It serves as a sharp reminder that immediate action is required to curb climate change's causes, lower greenhouse gas emissions, and prepare for the new normal of increasingly frequent and extreme downpour events."

New Delhi, July 17: The Supreme Court Monday asked the Lieutenant Governor and Delhi Chief Minister to "sit together" and "rise above political bickering" to mutually decide on the name of the Chairman of Delhi Electricity Regulatory Commission (DERC).

'Why don't two constitutional functionaries (Delhi L-G and CM) sit down and make it work? They have to rise above political bickering. "We will approach the Delhi L-G tomorrow," said senior advocate Abhishek Manu Singhvi, who represented the Delhi government, in response to the suggestion put forth by the court. "It will only be miraculous that both of them (Delhi L-G and CM) agree on a name," he added further. The reservations expressed by Dr Singhvi were opposed heavily by senior advocate Harish Salve, appearing for Delhi L-G. "It is unfortunate that the Delhi government lawyer (Dr. Singhvi) starts by saying that he has no hope. The first reaction should be yes,

The appointment of Justice Umesh Kumar as the DERC chairperson has become yet another flashpoint in the turf war between the city's AAP government and the Centre

The court has posted the matter for further hearing July 20. Earlier July 4, the Supreme Court had asked the Delhi Lieutenant Governor to not administer oath of office to the newly appointed DERC Chairman Justice (retired) Umesh Kumar. It had directed that the administering of oath to the former judge of Allahabad High Court will stand deferred till July 11. Chennai, July 17: The Enforcement Directorate Monday conducted searches at the premises of DMK leader and Tamil Nadu Higher Education Minister K Ponmudy and his MP son Gautham Sigamani in a money laundering case linked to alleged illegal sand mining, official sources said.

The 72-year-old minister was late night taken by the Enforcement Directorate (ED) to its office at Haddows Road for a detailed session of questioning.

The agency, according to the sources, has seized fixed deposit receipts of Rs 41.9 crore, around Rs 70 lakh cash and some foreign currency, including pounds (worth about Rs 8-10 lakh), from the linked premises of the minister.

Ponmudy is the second minister in the cabinet of Chief\_ Minister M K Stalin to come under the scanner of the federal probe agency after Senthil Balaji. Balaji, who was the Tamil Nadu electricity and prohibition minister, was raided and arrested by the ED in June as part of an alleged cash-for-jobs linked money laundering case investigation pertaining to his earlier stint as the state's transport minister. The raids were undertaken at the premises of the fatherson duo in state capital Chennai and in Ponmudy's stronghold of Villupuram, the sources said.

While the price continues to rise over the Rs 200 mark, as if competing with the flood waters of the Indo-Gangetic plain after twice- over jump past those of petrol, a national daily devoted its Sunday magazine main page to 'Tomato travels' with the additional offer of scanning the code for a 'cooking without it' recipe video. 'Seasonal cycle, will cool down soon",

Contradictions abound. While the ruling BJP, both in the country and the north-eastern state remains tightlipped on the fratricidal warring, it is shouting itself hoarse on the local self-government body elections in Trinamool Congress (TMC) ruled West Bengal. Again, no less than the Prime Minister Narendra Modi guarantees action against NCP leaders in Maharashtra involved in a Rs 70,000 crore scam. Within days the NCP leaders led by Aiit Pawar, under the glare of corruption charges, breakaway to join the Shinde-Fadnavis government with the blessings of the BJP national leadership. There is not a word from the fount on the mount.

The CBI's stance was that the offence committed was "heinous, grave and serious" and hence they cannot be released prematurely and no leniency may be given" to them. Mexico, adding to a growing list of reporters who have lost their lives amid an intensifying drug war in the country, authorities and a press freedom organisation said. Nelson Matus was shot to death on the fringes of Acapulco in southwestern Mexico Saturday, officials and Article 19 confirmed. Matus' death comes just a week after the grisly killing of another journalist in western Mexico, something the Committee to Protect Journalists said "underscores the crisis of deadly violence and impunity that continues to plague the Mexican press." In the past five years alone, CPJ documented the killings of at least 52 journalists in Mexico. Last year, Mexico was one of the deadliest places in the world for journalists, second only to Ukraine.

# HEATWAVE HORROR World reels under fires

Scientists have long warned that climate change, caused by CO<sub>2</sub> emissions from burning fossil fuels, will make heatwaves more frequent, severe and deadly

Madrid, July 17: Global temperatures headed towards alarming highs and extreme weather proliferated as the world's two biggest polluters, the China and the United States, sought on Monday to reignite climate talks.

With scientists saying the target of keeping global warming within 1.5 degrees Celsius of pre-industrial levels is moving bevond reach. evidence of the crisis was everywhere.

A remote town in China's arid northwest, Sanbao, registered a national record of 52.2 Celsius (126 Fahrenheit).

Wildfires in Europe raged ahead of a second heat wave in two weeks that was set to send temperatures as high as 48C.

In the United States, a quarter of the population fell under extreme heat advisories, partly due to a heat dome that has settled over western states.

In a resumption of diplomacy on global warming between the two superpowers, U.S. climate envoy John Kerry met Chinese counterpart Xie Zhenhua in Beijing, urging joint action to cut methane emissions and coal-

fired power. "In the next three days we hope we can begin taking some big steps that will send a signal to the world about the serious purpose of China and the United States to address a common risk, threat, challenge to all of humanity created by humans themselves," Kerry said, noting the proliferation of storms and fires.

"It is toxic for both Chinese and for Americans and for people in every country on the

planet." Prolonged high temperatures in China are threatening power grids and crops and raising concerns about a repeat of last year's drought,

the most severe in 60 years. Typhoon Talim was gaining strength and due to make land at night along China's southern coast, forcing the cancellation of flights and trains in the regions of Guangdong and Hainan.

In South Korea, torrential rains left 40 people dead as river levees collapsed causing flash floods. They followed the heaviest recorded rain in the capital Seoul last year.

An anticyclone nicknamed Charon - who in Greek mythology was the ferryman of the dead - could cause Europe to break its highest recorded temperature of 48.8C, possibly on the Italian island of Sardinia.

Greek authorities issued evacuation orders for at least six seaside communities Monday as wildfires threatened vacation homes near Athens, with gusts of wind up to 70 kph (45 mph) pushing flames through hillside scrub and pine forests parched by extreme heat.

Water-dropping planes and helicopters tackled the flames near Lagonisi, some 40 kilometres (25 miles) southeast of the capital, in an area with thousands of seaside vacation homes. Tourists in the Italian capital cooled themselves under giant fans set up outside the Colosseum and took turns to drink from a fountain near the Spanish Steps.

In Spain, temperatures could rise to as high as 44C in some regions. However, a forest fire on the island of La Palma in the Canaries that forced the evacuation of 4,000 people was being brought under control as temperatures fell, local official Sergio Rodriguez said in an interview on TVE.

The European Union's Copernicus Climate Change Service says 2022 and 2021 were the continent's hottest summers on record. As many as 61,000 people may have died in Europe during heatwaves last summer, with a repetition feared this season.

The heat dome across the west ern United States also helped to generate heavy rains in the northeast, claiming at least five lives. The heat warnings spread as far as Florida.

The UN said it has recorded instances in which the Taliban have enforced previously announced limitations on women's freedom of movement and employment

Islamabad, July 17: Taliban authorities have further increased restrictions on women and girls in Afghanistan in recent months, including in education and employment, the UN said in a report on the human rights

situation issued Monday. Taliban's Ministry of Public Health has announced that only males will be allowed to take exams to pursue specialised medical studies, the UN mission in Afghanistan said in the report, which covers developments in May and June.

That follows a ban on female medical students taking graduation exams announced in February and a prohibition on women attending universities issued last December, the report said.

In early May, two Afghan fe-

male staff of an international non-governmental organisation were arrested by Taliban forces at an airport because they were travelling without a male companion, or mahram, the report said.

In June, a midwife was detained and interrogated for five hours by the Taliban's intelligence service, which threatened her with death if she continued her work with an NGO. She resigned two days later as a result, the report said.

There have also been reports of physical violence against women, including an incident in which members of the Taliban's vice and virtue department beat a woman with a stick and forced her to leave a public park, it said.

#### FALSE PROMISES

Despite initial promises of a more moderate rule than during their previous period in power in the 1990s, the Taliban have imposed harsh measures since seizing Afghanistan in August 2021 as US and NATO forces were pulling out.

They have barred women from most areas of public life and work and cracked down on media freedoms.

### Cats test positive for bird flu in Poland: WHO

Geneva, July 17: Poland is the first country to report "high numbers" of cats infected with bird flu across a large area, the WHO said Monday, adding that the risk of human infection remained low

World Health The Organization said that since Polish health authorities informed it last month of unusual cat deaths across the country, 29 cats had tested positive for H5N1 bird flu.

They were among 46 cats and one captive caracal tested for the virus, it said, adding that 14 of the infected animals were reported to have been euthanised, while another 11 had died. The last death was reported June 30. "The source of the exposure of cats to the virus is currently

unknown and epizootic investi-

gations are ongoing," WHO said

in a statement. Since late 2021, Europe has had its worst-ever outbreak of bird flu, while North and South America have also experienced severe outbreaks.

This has led to the culling of tens of millions of poultry worldwide, many with the H5N1 strain

of the virus, which first emerged in 1996. There has recently been a worrying spike in infections in mammals

The UN health agency pointed out that sporadic infection of cats with H5N1 had previously been reported.

Bird flu infections in humans are rare, but when they occur can cause severe disease with a high mortality rate.

Human H5N1 cases are usually the result of direct or indirect exposure to infected live or dead poultry or contaminated environments.

Since 2020, the WHO said it had received 12 reports of human H5N1 cases worldwide. Four of them were severe cases, while eight were mild or asymptomatic.



The database is hosted on the DGFT website (https://dgft.Gov.In) and allows users to search using export or import item descriptions, technical characteristics, or Indian tariff classification codes

### G20 FMs deliberate on risks to global economy

FOREIGN MINISTERS FLAGGED THAT ECONOMIC FRAGMENTATION WILL BOTH UNDERMINE GROWTH AND MAKE IT HARDER TO TACKLE PRESSING GLOBAL CHALLENGES, FROM RISING SOVEREIGN DEBT CRISES TO THE EXISTENTIAL THREAT OF CLIMATE CHANGE

Gandhinagar, July 17: Finance ministers of G20 nations Monday deliberated on global economy and risks, as well as policy measures for promoting green and low carbon technologies on the opening day of the ministerial conference.

The meeting of the G20 finance ministers and central bank governors in the first session deliberated on issues pertaining to global economic outlook, economic risks, and key policy responses to support recovery, the Finance Ministry

said in a tweet. International Monetary Fund (IMF) Managing Director Kristalina Georgieva last week



in a blog said that the IMF forecast for global growth over the medium term is around 3 per cent -- well below the historical average of 3.8 per cent during 2000-19.

#### DEADLOCK OVER DEBT RESTRUCTURING

he failure of the G20 to achieve a breakthrough on debt restructuring for vulnerable countries is a "grave concern", the head of a United Nations agency said Monday as the body seeks pauses in debt repayment for poor nations amid rising poverty. The debt restructuring talks made little progress during the third finance meeting of the G20 countries in India, reports said Monday, as the bloc was unable to overcome key differences and low attendance due to domestic issues adding to the roadblocks, "I think the G20, so far, the finance ministers (and) central bank governors' negotiations have not really been able to advance a breakthrough on this question of debt and debt restructuring," Achim Steiner, administrator of the UN Development Programme, said.



Wimbledon, July 17: Regrets? Novak Djokovic has two. There was that tie-breaker pretty early in the Wimbledon final Sunday, when the 36-year-old Serb was one point from taking a two-setsto-none lead over his 20-year-old opponent, Carlos Alcaraz.

And then there was that missed volley on break point early in the fifth set with all the momentum at that stage going the seven-time Wimbledon champion's way.

"Some regrets," Djokovic said after losing 1-6, 7-6(8-6), 6-1, 3-6, 6-4 in a high-energy and highly entertaining championship match on Centre Court.

"I had my chances. I think I could have closed out that secondset tie-breaker better. But credit to him for fighting and showing

some incredible defensive skills, passing shots that got him the break in the fifth. He was a deserved winner today, no doubt."

Djokovic has been a deserved winner on so many occasions in the past. Seven times right here at the All England Club, where he was one victory from matching Roger Federer with a men's record eight titles at the grass-court Grand Slam. And 23 times overall at major championships, tied with Serena Williams for the most in the Open era, which began in 1968.

Back in 2019, for instance, Federer was going for his ninth Wimbledon title while Diokovic was the defending champion. Federer had two match points in the fifth set, but Djokovic saved them both, forced a tie-breaker at 12-12 and then ran away to claim his fifth championship.

"I've won some epic finals that I was very close to losing," said Djokovic, who had earlier mentioned those match points in his on-court interview during the trophy ceremony. "Maybe this is kind of a fair-and-square deal, I guess, to lose a match like this for me here.

After breezing through the first set on a windy day, the pair traded breaks of serve early in the second ahead of the eventual tie-breaker.

With a set point and Alcaraz serving at 6-5, Djokovic put a backhand into the net. And then another: "The backhands kind of let me down, to be honest,' Djokovic said. "Set point, I missed the backhand. He did play a backhand that was quite long in the court, had a little bit of a bad bounce. But I should not have missed that shot.

"Then on 6-all, again, another backhand from middle of the court in the net. Just two very poor backhands. That's it. The match shifted to his side. It turned around."

Djokovic hasn't missed too many of those shots over the years. In fact, his last loss at Wimbledon was way back in 2017 when he retired in the second set from his quarterfinal match with an injury. His last loss on Centre Court was in the 2013 final against Andy Murray.

That other point Djokovic mentioned? The other regret? That miss was even more surprising — especially coming from a guy who has made a career of making shot after shot and waiting for his opponents to mess up.

Alcaraz was serving in the second game of the final set and

Diokovic had what looked to be an easy volley to break for a 2-0 lead — the kind of lead he doesn't often relinquish. But his forehand went into the top of the net instead of over it, allowing Alcaraz to recover.

"I managed to regroup and regain the momentum midway in the fourth (set)," Djokovic said. "I felt that the momentum shifted to my side. That was my chance. That was my opportunity. That break point, I think I played a really good point, kind of set up that drive volley.

'It was very, very windy today. The wind kind of, yeah, took it to an awkward place where I couldn't hit the smash, I had to hit the drive volley kind of falling back. I saw him perfectly running to the opposite corner. I kind of wanted to wrong-foot him with that drive volley, and I missed.

Wimbledon, July 17: Carlos Alcaraz held onto No.1 in the ATP rankings Monday by virtue of his victory over No.2 Novak Djokovic in the Wimbledon final, and Marketa Vondrousova's first Grand Slam title pushed her all the way up to a career-high No.10 on the WTA list.

Vondrousova jumped 32 places from No.42 thanks to her 6-4, 6-4 win against Ons Jabeur in Saturday's final at the All England Člub. Vondrousova, a 24year-old from the Czech Republic, was the lowest-ranked and first unseeded women's champion at the grass-court major.

Alcaraz's victory over Djokovic Sunday marked the third time in the past four major tournaments that the men's title match determined who would be at No.1.

At last September's US Open, Alcaraz became the first teenager to lead the ATP by beating Casper Ruud in the final. At January's Australian Open, it was Djokovic – who has spent more weeks atop the rankings than anyone in tennis history — who assured himself of being at No.1 by defeating Stefanos Tsitsipas.

Alcaraz, a Spaniard who turned 20 in May, and Djokovic, a 36-year-old from Serbia, have been trading the highest spot this season. Alcaraz now enters his 29th week there.

The club previously announced that Messi's deal will be for  $2 \frac{1}{2}$  seasons and will pay him between USD 50 million and USD 60 million annually - putting the total contract value between USD 125 million and USD 150 million in cash alone. The 35-year-old, in 2008, made the leap to the professional ranks, signing for Waitakere United in New Zealand before a careerdefining move to Auckland City FC in 2013, guiding them to multiple titles. His true impact, however, was felt when he joined the ISL in 2017, representing ATK (now Mohun Bagan Super Giants). The Fijian played a pivotal role in ATK's title-winning campaign in the 2019-20 season. Last season, Krishna joined Bengaluru FC. A crowning achievement came when he lifted the prestigious Durand Cup with the Blues. With him leading the line alongside Mauricio, OFC's attack becomes significantly more potent.

New Delhi, July 17: The quarterfinal loss at the US Open has "left a significant emotional impact" on PV Sindhu but the premier Indian shuttler has vowed to finish the season on a high.

Sindhu has looked off colour this season after returning from a five-month long injury layoff following a stress fracture on her ankle. With more than half the year gone, the former World Champion and two-time Olympic medallist is still searching for her first title this season.

The World No.12 made a quarterfinal exit after going down in straight games to China's Gao Fang Jie. "This loss has left a significant emotional impact on me, especially considering the challenging and demanding year I've had," Sindhu wrote on her Twitter

"It's disheartening to experience a disappointing defeat after each successful tournament. However, I am determined to channel my emotions into redoubling my efforts and making the remainder of the year truly remarkable," she added.

Sindhu was part of India's bronze medal win at the Badminton Asia Mixed Team Championships at Doha in February but has missed a few World Tour events this year. Her best result this year has been a sliver at the Madrid Masters Super 300 event in April

Sindhu reached the Canada Open semifinals earlier this month and looked in good nick but lost to World No.1 Akane Yamauchi before the last eight loss to Jie at the US Open

'My US Open journey came to an end in the quarterfinals, where I faced the talented Gao Fang Jie. Despite having previously defeated her in Canada, she outplayed me in straight sets this time, making effective use of my weaknesses

"I must commend her for being fully prepared and delivering an impressive performance. Next time I face you Gao, should be a battle," Sindhu wrote.

The 27-year-old also lavished praise on compatriot Lakshya Sen, who struggled this season due to the effects of a nose surgery be-

fore winning the Canada Open. "I want to express my genuine happiness for Lakshya, who has been performing exceptionally well despite the difficulties he has faced. Witnessing his strong performances has

been truly inspiring. Sindhu will next compete at the Korea Open Super 500 in Yeosu this week. "As I look ahead, I am eagerly anticipating the upcoming competitions in Korea and Japan. I will continue to push forward, driven by the unwavering support and encouragement of Indian fans everywhere I go. Your support means the world to me, and I am deeply

### Men to compete in artistic swimming at Paris 2024

Fukuoka, July 17: Snicker if vou wish. Guffaw for good measure. Bill May and other male synchronized swimmers - now called artistic swimmers - have heard the putdowns before. But they're getting the last laugh.

Men have competed in synchro at the lower levels for decades. Now they're being included in the Olympics, meaning next year's Summer Games in Paris.

"I think it's a huge opportunity for the sport to grow and attract more men," May told the Associated Press at the World Aquatics Championships. "By keeping men out you're limiting the sport. By including men you're going to see an upshift in the popularity and the numbers.'

May looks like a lean bodybuilder. He was among the first men to compete when synchro was included in the worlds for the first time in 2015. And he worked



for 17 years at Cirque du Soleil doing water-themed shows. He has come out of competitive retirement for a chance to compete at the Olympics.

"There has always been that misconception that it's a femaleonly sport, or that it's for wimps, or that it's not a difficult sport,' the 44-year-old May said. "Anyone that has anything negative to say about the sport — boy, female, anyone. Just try it and you'll know it's the most difficult sport in the world.

This is not the synchronized swimming that your parents or grandparents watched — the water ballet that made few waves below the flowery rubber caps and permanent smiles, It's estranged from the sport introduced at the 1984 Los Angeles Olympics.

The acrobatic team event, in

particular, features lifts, throws and flips, and diving routines launched off the shoulders of teammates treading water below. It's gymnastics on water and concussions are a risk. Interested men often confront the stereotypes.

Beginning in elementary school, 18-year-old American Kenny Gaudet dreamed of being a synchronized swimmer. He made it, but it wasn't easy.

"It makes me emotional just to think about the problems we all went through and the struggles we all had just to get a chance to swim and do what we love," said Gaudet who competed at this year's worlds.

"So much bullying. So much slander. So much hate," he added. "Just because of my gender, just because I'm a male in artistic swimming. When I first started I wanted to quit so many times. Growing up my peers would ask why I'm doing a female sport, why am I being like a girl and degrade

me for doing what I love to do.'

A few countries at the World Championships have male swimmers including the US, Japan, Germany and China. Spain and Italy also have top competitors.

Another fear, apparently unfounded, is that women might resent the men competing in the sport. Men will compete in only team events at the Olympics. Teams have a maximum of eight members — with a limit of two men — which means men might crowd out some women. There is no requirement for men to be included.

Asked about any acrimony, two-time American Olympian Anita Alvarez replied: "No, not at all." Men can add some physicality to routines, and their presence could lead to a wider audience. Alvarez also credits May with choreography skills that he picked up with Cirque du Soleil. And we're about to see more men trying it.
