# Jolt to Haryana govt

Less than two months after the Nayab Singh Saini-led BJP government won the trust vote by voice vote in the 90-member Haryana Assembly, it plunged into a massive crisis Tuesday following the withdrawal of support by three Independent MLAs. The levelopment is likely to have its effects felt in the Lok Sabha elections in the state scheduled May 25, even as Leader of Opposition and former CM Bhupinder Singh Hooda demanded immediate resignation of the government and declaration of fresh elections as BJP's strength in the House has reduced to 40, two short of a simple majority

Chandigarh, May 7: Three Independent MLAs Tuesday withdrew support to the BJP government in Haryana and announced they would back the Congress, reducing the Navab Singh Saini government to a minority in the state Assembly.

The government which has the support of two other Independents is now two short of the majority mark in the 90member House which has a current strength of 88.

In recent days, some Jannayak Janata Party (JJP) MLAs have indicated support to the BJP though the JJP pulled out of the coalition government in March.

Speaking at the presser, Udai Bhan said, "The three Independent MLAs have extended their support to the Congress... The BJP government earlier had support of 10 JJP MLAs and Independents, but the JJP also withdrew support and now Independents are also leaving.

The Assembly elections in Harvana are due in October. The BJP has 40 MLAs, the while elections for the 10 Lok Congress 30 and the JJP 10 in the Sabha seats will be held May 25 Hooda expressed his grati-Independent MLAs Sombir

tude to the three MLAs for their support and said they have taken this decision keeping in mind the public sentiments.

At the presser, Gollen said, "We had given our support to the BJP government with honesty. But today unemployment is at its peak, and inflation and farmer issues are there. Every section of society is fed up. People are facing lot of issues with Parivar Pehchan Patra (family ID card)

and property ID system." When asked why they did not speak up on these issues earlier. Gollen said even during farmers agitation, they had raised their voice. The Saini-led BJP government in Harvana had March 13 won the trust vote by voice vote in the House after he took oath as the new CM replacing

Manohar Lal Khattar. Khattar, who is contesting Lok Sabha polls from Karnal, had resigned as MLA from Karnal.

New Delhi, May 7: Over 63 per cent voter turnout was recorded Tuesday in the third phase of Lok Sabha elections in 93 constituencies spread over 11 states and Union Territories (UTs) with stray incidents of violence in West Bengal

Assam recorded the highest turnout at 77.06 per cent, followed by Goa at 75.13 per cent and West Bengal at 73.96 per cent, while Uttar Pradesh witnessed the lowest at 57.34 per cent, with Bihar at 58.16 per cent, Gujarat at 57.62 per cent and Maharashtra at 61.44 per cent doing slightly better, according to the figures from the Election Commission at

The overall voting percentage was 63.53 per cent. According to the EC, the figures are an 'approximate trend' and are likely to rise as data is being collected.

While the official time for the voting to conclude is 6pm, it can go beyond to enable voters who have come in the queue before the end of fixed polling hours to exercise their franchise.

Among other states and UTs, Chhattisgarh recorded 70.05 per cent polling, Dadra and Nagar Haveli and Daman and Diu 68.89 per cent, Karnataka 69.65 per

cent, and Madhya Pradesh 66.05 per cent, according to the EC.

As many as 17.24 crore people. including 8.39 crore females, were eligible to vote in the third phase and 1.85 lakh polling stations manned by 18.5 lakh officials had been set up.

With this, voting has been completed in 20 states/UTs and 282 Lok Sabha seats out of 543. The overall voting percent-

age in the first and second phases was 66.14 per cent and 66.71 per cent, respectively

Sporadic incidents of violence marred the polling in the four constituencies in West Bengal as TMC, BJP and Congress-CPI(M) workers clashed with each other in various parts of Murshidabad and Jangipur seats.

"Across all the states and UTs, voters from all walks of life have placed their faith in the NDA and our development agenda, INDI Alliance is losing even more steam, thanks to their regressive economics and outdated votebank politics," PM Narendra Modi said on X.

The Congress claimed that the BJP has been wiped out in the south and reduced to half of its strength after the three phases

"It's very clear that for the BJP, it is South mein Saaf, North mein Half," Congress general secretary Jairam Ramesh said on X.

#### No CM duty for Kejri if out on bail: SC

New Delhi, May 7: The Supreme Court said Tuesday it doesn't want Delhi Chief Minister\_ Arvind Kejriwal to discharge his official duties if he is released on interim bail in the money laundering case linked to the alleged excise policy scam as it would lead to a conflict of in-

Keiriwal failed to get any relief from the top court, with a two-judge bench rising without pronouncing an order granting him interim bail to enable him to campaign in the Lok Sabha elections.

The Aam Aadmi Party (AAP) leader was arrested March 21 and is currently lodged in Tihar Jail under judicial custody.

A bench of Justices Sanjiv Khanna and Dipankar Datta, which reserved its verdict on the question of interim bail, said allowing Kejriwal to attend his office may have a "cascading effect".

"Suppose we grant you interim bail on account of elections. Then if you say you will attend office, it may have a cascading effect. If we give you interim bail, we don't want you to perform official duties as somewhere it will lead to conflict of interest. We don't want your interference at all in the working of the government," the bench told senior advocate Abhishek Singhvi, appearing for Kejriwal.

New Delhi, May 7: The Delhi High Court has imposed costs of ₹1 lakh on a man who made Lord Hanuman his co-litigant in a plea concerning the possession of a private land having a temple of the deity.

The plea, which was an appeal against a lower court order rejecting their 'objection petition' in relation to the transfer of the land to another party, claimed that since there was a public temple on the property, the plot belonged to Lord Hanuman and the appellant man was before the court as his next friend and a worshipper.

Calling it a case of "rank collusion with an intent to grab" the property, Justice C Hari Shankar dismissed the appeal and ruled that appellant man acted in "contumacious collusion" with the current possessors of the land so as to stop another party from regaining possession following a lawsuit between them and a settlement.

"The defendants (current possessors) grabbed the plaintiff's (the other party) land. The plaintiff sued to recover possession. The defendants pleaded adverse possession. Ultimately, the defendants asked the plaintiff to pay ₹11 lakh to vacate. The suit was



'Thereafter, the plaintiff actually paid the amount of ₹6 lakh but the defendants still did not vacate.

"The plaintiff filed for execution. In the execution, the present appellant, who is a third party, filed an objection saying there is a public temple on the property dedicated to Lord Hanuman and that, therefore, the land belongs to Lord Hanuman and that he was entitled to protect Lord Hanuman's interest as his next friend, as a deity is a minor in law," the court, in an order passed May 6, stated.

"I never thought that God would, one day, be a litigant before me. This appears, however, thankfully, to be a case of divinity by proxy," the court ob-

The court said there was no

concept of the right to worship at a private temple vesting in the public unless the owner of the temple makes such a right available or with the passage of time the private temple metamorphoses into a public temple.

In the present case, the court stated, there was nothing to indicate, even prima facie, that the temple was a public temple and therefore the appellant man's claim that he was entitled to defend Lord Hanuman as his next friend does not survive for consideration.

Dismissing the appeal, the court directed the appellant man to pay costs of ₹1 lakh to the other party.



The film is reportedly set in the Mughal era.





The PGIMER and Capital Hospital here had started in 1954 with only 60 beds on 20 acre of land.

## WB man relieved of 7kg scalp tumour at AIIMS

Bhubaneswar, May 7: The All India Institute of Medical Sciences (AIIMS) here has successfully removed a seven kilogram tumour from the scalp of a 51-year-old West Bengal man in a rare procedure that lasted for around seven hours, marking a significant milestone in medical innovation and collaborative healthcare efforts.

AIIMS sources said it was an exceptionally rare tumour, synovial sarcoma, especially in the scalp, with only scant documented cases in the medical literature.

AIIMS-Bhubaneswar

Executive Director Ashutosh Biswas said the surgery, the second of its kind in the country, was a collaborative endeavour led by a dedicated team of medical professionals, giving a new lease of life to Rabindra Bishui.

Bishui had sought treatment from many healthcare institutions but was denied before ultimately reaching the Department of Plastic Surgery AIIMS. at Bhubaneswar, Biswas said.

A multidisciplinary team of AIIMS-Bhubaneswar comprising experts in interventional radiology, surgical oncology, neurosurgery, plastic surgery, anaesthesiology and pathology, meticulously crafted a treatment strategy under the guidance of Burns and Plastic Surgery head Sanjay Kumar Giri, the AIIMS-Bhubaneswar executive director said.

Bishui underwent the complex procedure last week to address a longstanding scalp swelling that had plagued him for over two decades, he pointed out.

"The growth — a 7 kg synovial sarcoma tumour - posed a formidable challenge to conventional treatment methods. The intricate procedure involved precise embolization of blood vessels, targeting the bilateral superficial temporal arteries and the left occipital artery, by Manoj Kumar Nayak from the Radio Diagnosis Department, followed by surgical excision by other doctors of the institute," Biswas said.

The procedure was intricate, necessitating the ligation of the left external carotid artery and posterolateral neck dissection, culminating in the successful removal of the tumour.

Despite challenges posed by the surgery, including significant intraoperative blood loss requiring approximately six units of blood and other blood products, the dedicated anaesthesia team, led by Aparajita Panda, along with the vigilant nursing team, ensured the patient's safety and well-being throughout the procedure, which lasted about

Following the successful surgery, the patient received intensive care for around 24 hours before being transitioned to the ward for further observation and recovery. The patient was discharged from the hospital Tuesday, AIIMS sources said.

AIIMS sources said Dr Pritinanda Mishra's timely pathological evaluation of the specimen played a crucial role in the treatment process.

The collaborative efforts of the surgical teams involved not only ensured the successful treatment of a rare scalp tumour but also underscored the importance of interdisciplinary cooperation in addressing complex medical cases

Biswas congratulated the team of doctors for performing such a rare operation and reiterated the commitment of the national institute to provide modern and quality healthcare services to the people of Odisha as well as neighbouring states.

## BJP lines up Union ministers, CMs for poll campaign in state

Modi recently held rallies in Berhampur and Nabarangpur Lok Sabha seats and is scheduled for more campaigning before the first phase of polls in the state May 13.

According to BJP candidate Aparajita Sarangi, Modi is set to hold a roadshow in Bhubaneswar May 10 and possibly address an election rally in Bolangir May 11.

'The PM's programme for May 11 is yet to be confirmed. He is likely to address an election rally in Bolangir," a BJP spokesperson said.

Addressing a press conference here, state BJP vice president Golak Mohapatra informed that Chhattisgarh Chief Minister Vishnu Deo Sai will arrive in the state May 8 on a two-day visit and address public meetings in Nabarangpur and Koraput.

Assam CM Himanta Biswa Sarma is also slated to address public meetings in different parts

Defence Minister Rajnath Singh and Union Minister Nitin Gadkari are also scheduled to address public meetings, highlighting issues such as highway projects and the need for a 'double-engine' government in Odisha.

"He is likely to speak about how BJD government's non-cooperation has affected highway projects in the state, and thus, justify the need for a double-engine government here. Mohapatra said. Furthermore, the BJP has enlisted actressturned-politician Hema Malini as one of its star campaigners, expected to join the campaign trail in Berhampur.

Meanwhile, Congress leader Rahul Gandhi has campaigned for his party candidates in Cuttack district

While the BJP rallies its national leaders and ministers for campaigning in Odisha, the duo of Patnaik and Pandian from the BJD has been actively touring the state for the upcoming Lok Sabha and Assembly elections, set to be held in four rounds between May 13 and June 1, starting with the first round in Berhampur, Nabarangpur, Kalahandi, and Koraput May 13.

New Delhi, May 7: Country's small malls are increasingly turning into ghost malls as consumers move towards online purchases and bigger shopping centres for a better experience, a consultancy report said,

Mall properties with a vacancy rate of more than 40 per cent have been termed ghost

While there was a 238 per cent year-on-year increase in the Gross Leasable Area (GLA) of all shopping centres in prime Indian markets in 2023, the number of ghost malls rose to 64 from 57 in 2022, said real estate

consultancy Knight Frank India. Industry analysts said this reflected weak consumer demand and could lead to job losses and economic dislocation, particularly for small retailers and service providers

Private consumption, accounting for 60 per cent of country's gross domestic product (GDP), has remained weak, rising 3.5 per cent year-on-year in the last quarter of 2023 while the economy grew 8.4 per cent.

"Many of the small shopping malls are on the verge of closure," said Gulam Zia, director of Knight Frank after the release of the 'Think India Think Retail 2024' report based on a survey of 29 top cities.



There has been a sharp rise in low-performing retail assets with 13.3 million square feet of shopping space remaining vacant, resulting in the loss of 67 billion rupees (\$802.5 million) of revenue for developers in 2023,

the report said.

Unable to match the convenience and diversity of large shopping centres, many small mall owners are caught in a downward spiral of declining revenue, Zia said.

Among small shopping centres, with an average leasing area of 100,000 square feet, 132 are on the verge of turning into ghost malls - with the vacancy rate rising to 36.2 per cent in 2023 from 33.5 per cent in the

previous year, the report said. However, among bigger shopping malls, with an average leasing area of 500,000 square feet, the vacancy rate remained at 5 per cent, and at 15.5 per cent among middle-level shopping

malls, it said. In the top eight cities, including Delhi, Mumbai and Bangalore, the total number of shopping malls declined to 263 in 2023, with eight new retail centres added but 16 shut down.

# No innocent should figure in history sheet, says SC

*The top court says police* authorities in states and UTs should ensure that no mechanical entries in a history sheet are made of innocent individuals belonging to socially, economically and educationally disadvantaged backgrounds along with backward communities, SCs/STs

New Delhi, May 7: The Supreme Court Tuesday asked the police in states and Union Territories (UTs) to ensure that innocents and individuals from backward communities are not named in a history sheet.

Initiating suo motu action, a bench of Justices Surya Kant and KV Viswanathan said there are some studies available in the public domain that reveal a pattern of 'unfair, prejudicial and atrocious' mindset

Police authorities in states and UTs should ensure that no mechanical entries in a history sheet are made of innocent individuals belonging to socially, economically and educationally disadvantaged backgrounds along with backward communities, scheduled castes (SCs) or scheduled tribes (STs), the apex court said.

The top court said a history sheet is an internal public doc-



cessible report. Extra care and precaution should be observed by police officers while ensuring that the identity of a minor is not disclosed as provided by law in a history sheet, it said.

"It is alleged that police diaries are maintained selectively of individuals belonging to Vimukta Jatis, based solely on caste bias, a somewhat similar manner as happened in colonial times," the court observed.

"All the state governments are therefore expected to take necessary preventive measures to safeguard such communities from being subjected to inexcusable targeting or prejudicial treatment. We must bear in mind that these pre-conceived notions often render them 'invisible victims' due to prevailing stereotypes associated with their communities, which may often impede their right to live a life with self-respect," the bench said.

The top court said a periodical audit mechanism will serve as a critical tool to review and scrutinise entries made in a history sheet.

"Through the effective implementation of audits, we can secure the elimination of such deprecated practices and kindle the legitimate hope that the right to live with human dignity, as guaranteed under Article 21, is well protected,'

"We are conscious of the fact that states or UTs, other than the NCT of Delhi, are not before us. They have not been heard. No positive mandamus can thus be issued to them. Further, we are not aware of the existing rules/policies or standing orders in vogue in different states/UTs," the bench said.

"We, therefore, deem it appropriate, at this stage, to direct all the states/UTs to revisit their policy regime and consider whether suitable amendments on the pattern of the 'Delhi Model' are required to be made so that our observations made in paragraphs 14 to 16 of this order can be given effect in true letter and spirit," it said.

The apex court directed its registry to forward a copy of this judgement to the chief secretary and director general of police of all states and Union Territories to enable them to consider and comply with what has been held above, as early as possible but

Besides creating awareness among girls on how to protect themselves and understand the difference between 'good touch' and 'bad touch', the department has also launched 'Mo Parikalpana' initiative, under which parents are informed what they should do to safeguard their daughters when they are alone at home, and also their issues are heard, the department's secretary

Roopa Roshan Sahoo said. Another official said that 'Mo

Parikalpana' is like a listening window to capture the voices from the ground so that the observations could lead to policy action. The department has also asked

the sexual harassment committees in the hostels to remain alert regarding such complaints and cross-verify those, the official said.

## **Poverty haunts Nagada villages**

Even minors are migrating to other places in Odisha and outside the state to eke out a living

**Jajpur, May 7:** Nagada villages in forested areas under Chingudipal panchayat in this district shot into limelight in 2016 after 19 children died due to malnutrition. Since then approximately eight years have elapsed, but the woes continue for the inhabitants of these villages including children. Sources said that due to scarcity of food many kids from these villages migrate to other cities to earn a living. The residents of Nagada villages are mostly tribals from the primitive Juang community.

The Odisha government had launched several schemes for development of infrastructure, poverty alleviation and healthcare facilities for the villages after the tragedy. It had sanctioned ₹23 crore for construction of roads, setting up of drinking water facilities and power supply to the villages. However, poverty still continues to haunt the villagers.

Sources said that this year, 28 tribals, mostly minor boys and girls left for Balasore and Bhubaneswar to work as daily

wagers. They took the help of middlemen to get jobs. Bata Padhan, the father of one of the kids, confirmed the development. He said that the minor girls and boys migrated to other places after they were promised salaries of ₹7,000 per month. However, now they are being paid less than the amount agreed upon and are being forced to work for 12-14 hours a day.

A minor boy who managed to come back to his village narrated his ordeal. "We were forced to work for more than 12 hours a day without a break and at times sans food. When we asked for our wages, we were only paid ₹3,000 for two months. I had a chance to run away and came back to my village," he stated.

Despite Sukinda valley being rich in minerals, majority of the people living in the locality

lead a life of poverty. This is because the companies extracting minerals rarely employ locals and tribals. They deprive the natives of the area by bringing in people from outside, locals alleged. Hence the residents of Nagada villages languish in poverty, sources pointed out. "Every five years we vote for our representative to the state government, but nothing really changes for us," said a villager on condition of anonymity. District officials said that the

state government has spent close to ₹100 crore for various development works in the area. In reality however, no transformation has come in the life of the Juang community. To compound their troubles, they have lost their traditional occupation of collecting minor forest produce for a living as trees have been felled indiscriminately Even though they get their monthly quota of free rice from the state government, it is of not much use to them.

### Miscreants assault independent nominee

Bhawanipatna, May 7: Miscreants allegedly attacked independent nominee for the Kalahandi Lok Sabha constituency, Naresh Nihal while he was on his way to take part in a meeting here. Sources said that miscreants waylaid Nihal's car near Karlapada and the moment he got down from the vehicle, they severely assaulted him with sticks. Locals rescued the injured Nihal and rushed him to a hospital here. Even though he has suffered serious injuries, doctors said Nihal is stable.

Though the reason behind the assault on Nihal is yet to be ascertained, it is suspected that political rivalry led to the attack. A complaint in this regard was lodged at the Karlapada police outpost under Bhawanipatna Sadar police station limits. Even though officials have initiated an investigation into the inci-

dent, they are yet to identify the culprits. "I was attacked by hooligans when I was on my way to Bhawanipatna to attend a meeting. I don't know why I was attacked and I did not recognise any of the attackers. I trust police and I hope they will nab the miscreants soon and find out the reason behind the attack," Nihal said.

## Muzzling Media

The Israeli government under Prime Minister Benjamin Netanyahu and his Far-right allies has been growing authoritarian by the day, throwing to the winds that country's democratic credentials. But, two days after World Press Freedom Day on 3 May, it has shown its intolerance of free speech and expression by unanimously banning the Qatari news channel Al Jazeera. This is a major onslaught on one of the pillars of democracy that has been exposing the brutality being perpetrated by Israel government on thousands of Palestinians hounded out of their homes in the Gaza Strip since the attack on Israel by Hamas 7 October, 2023. The media outlet has been prevented from covering the horrors in the name of national security. The world is getting information on the massacres in Gaza thanks, among a few others, to the journalists of Al Jazeera stationed there as all other international media has been denied access to the scene of depredation. The unacceptable measure comes at a time when reports suggest Israel is planning strikes on Palestinians in Rafah. This only gives rise to suspicion and fear about the deadly attacks to come that Netanyahu's government does not want the world to see through Al Jazeera's coverage. It is in this manner that dissemination of information on government functioning and wrongdoing - a key element of democracy -

While saying this, we must also accept that a country at war, any country for that matter, has to have stringent control over all media. It does not matter if the media is domestic or international. In Israel's case, it is even more so since that nation has enemies or the ocean surrounding it. The Israel Defence Forces (IDF) has a tough job cut out for it. The pressure on them to get all the hostages back alive may have subsided somewhat but then the future of that nation is at stake in a manner it never was before. Netanyahu has everything at stake now. Not just his own political survival but also that of the government he heads currently.

This may be the reason for Netanyahu's description of the media outlet as "terrorist," and the closure of its offices on Israeli territory. Its equipment was also confiscated. Such practices may brand a government authoritarian as it does not tolerate any voice that is not pro Israel. Such acts may now get Israel included in the list of countries where cases of attacks on freedom of information pile up. In the past, the Israeli authorities made no secret of their mistrust of Al Jazeera's openly pro-Palestinian editorial line, but they stopped short of shutting it out.

Releasing its World Press Freedom Index on 3 May, Reporters Without Borders noted that "more than half of the world's citizens live in extremely dangerous places for press freedom, places where working as a journalist means risking your life or your liberty." Five of the world's 10 most populous countries are subject to this situation, particularly during election periods.

Among such victims the most notable is the Wall Street Journal reporter Evan Gershkovich held in Russia for over a year, awaiting trial on obviously trumped up charges of espionage. In Hong Kong, now under Chinese rule, Jimmy Lai, boss of former Opposition press group Next Media, is facing life imprisonment after a farcical judicial process. On 1 May, free speech advocacy organisation PEN America noted that the number of writers imprisoned in China exceeded 100 for the first time in 2023. This is only expected of an authoritarian system.

On 3 May, Subhash Chandra, the owner of Zee Television and the man who brought the first Indian satellite television channel to homes in this country, surprised many by releasing a video statement mentioning the dangers that lay for freedom of the press. What was surprising was that Chandra was known to be close to the powers that be and his channels always sang paeans to the current brand of politics in India. Yet the very mention of that issue by him seemed to have a deep meaning. Such events never go unnoticed, demonstrating that India too is going through a period where media is being gagged.

Blocking the flow of information on what is happening around the globe is a challenge to defenders of democracy and a danger to the survival of any open and modern society.

#### THIS DAY **IN HISTORY**

- 1886: Coca-Cola is invented. According to legend, Dr. John Styth Pemberton, an Atlanta pharmacist, produced the syrup in a brass pot in his backyard. It was first intended as a patent medicine. Today, Coca-Cola is one of the world's most popular soft drinks and one of the most recognized trademarks.

## **APATHY OF YOUNG VOTERS**

**IT IS IMPERATIVE FOR POLITICAL PARTIES TO PONDER WHY** THE COUNTRY'S **YOUTH ARE SHUNNING THEIR RIGHT TO VOTE** 

ndia's foreign minister recently wrote in a national daily that "this is the first general election of the Amrit Kaal, (an empowered and inclusive economy) and our youth must recognise its significance." What this means may be clear to the present government but for youth it would remain a grey area as its impact is not sufficiently felt by either the educated or uneducated sections. The government nurturing human resources, enhancing ease of living and fostering entrepreneurship, are words unmatched by action for this generation.

Opinion amongst social analysts and youth leaders boils down to a concern that the government is unfortunately not aware of the dimension of the problem, even though the youth represent the most dynamic and vibrant segment of the population. It is distressing that the youth by and large are not much interested in the electoral process and do not see it as a tool to have their voice heard. Whatever may be projected by justifying high rates of GDP growth, the rural youth are increasingly finding agriculture unremunerative while small jobs are not quite available in rural areas. There is growing sense of frustration and disillusionment amongst GenNext, and though the ongoing election may be a talking point it doesn't inspire hope of a new government addressing their issues.

This is borne out by a recent report of International Labour Organisation on unemployment in India. It found that of the total unemployed, 83% are youth. The share of educated youth among the total unemployed population is 66%. In fact, India has one of the highest unemployment rates in the world. The headline rate of 23% puts the country in the company of Yemen, Iran, Lebanon, Syria and other such nations which don't boast of being the fastest growing economy or fifth largest economy. For our small neigh-

bour, Bangladesh, the figure is just 12% - half of that of India's. Even scarier is that unemployment rate is 44% among those in age group of 20-24 years.

It is thus not astonishing that those who have the highest stake in the future have shown the least inclination in voting. Around 38% of youth have registered to vote in the 2024 elections with some states such as Bihar, Delhi and Uttar Pradesh seeing less than a quarter enrolling. Anil Verma of Association for Democratic Reforms explains that there's cynicism amongst the youth about the electoral process. The apathy emanates from a feeling that major political parties which don't have enough youth leaders are not genuinely involved about the GenNext and its problems.

Moreover, political leadership is not showing concern about emerging social and economic problems. About Bihar's low young voter numbers, Rajiv Kumar of Action for Accountable Governance explains that though political awareness was there, a sense of hopelessness and frustration persists among the youth about commitment of political lead-

Therefore, the guarantees or promises of political parties are not quite appealing to the young generation as they are not based on genuine intentions. Prime Minister Modi has been accused by Opposition of being silent on creation of job opportunities for youth. There is no word on adequate financial allocation to states to ensure employment is guaranteed for 100 days in a year, as per MN-REGA. Besides, there's a demand for such a programme in urban areas to provide jobs the youth.

Moreover, many of the guarantees given by various political parties over the years have remained elusive, leading to disillusionment in elections. The future torchbearers of the country are also in a situation where there is intense competition and pressure, right from say Class X or XI, to rank and achieve high standards, which has resulted in increasing suicides, even among students who have entered IITs. According to a recent Lancet article, 75% of those who die by suicide are men, many economically precarious youths. The suicide rate in India increased from 6.3 per lakh in 1978 to a whopping 12.4 with 44% urban growth as recorded by the last Census, whereas suicides in remote areas largely go unrecorded.

Recently, the Prime Minister claimed that in past decade over ₹30 lakh crore was spent on various development policies with beneficiaries receiving money directly into their accounts. This, he recalled as being different to the Congress, which once had claimed, "if one rupee

was sent from Delhi, only 15 paise would reach its destination..." adding "imagine the consequences if they had control over ₹30 lakh crore. However, rural youth would be cynical about it as they see little difference in welfare projects meant for them or their families, whether by Centre or states. Corruption at grassroots remains unchanged, if not increased over the years.

Congress on other hand has been alleging a pro-rich nexus of the ruling party and has promised to conduct a financial and institutional survey to ascertain who's in possession of country's wealth and would then undertake to redistribute the same. Whether it would bring cheer to the young is uncertain as corporates are moving towards automation which would further cut down job opportunities.

It is imperative for political parties to ponder why the country's youth are shunning their right to vote. The only answer is a strategy or plan of action to influence and motivate them, as gainful engagement of GenNext is the key to harmonious socio-economic development. The government must ensure that apart from filling up vacancies in its sector, private sector too must recruit enough personnel, to be determined by a professional body, and not over-work their labour force, as is the case

There is also a need to start an unemployment allowance as suggested by some economists. When massive projects. whose beneficiaries are the rich, are being undertaken, starting such an allowance for the poor and EWS should not pose a problem. If necessary, a cess of say 1% for those who are super rich could be imposed to start such an allowance.

In our march towards a developed nation, the interests of the youth can't be ignored as it's this generation which can shape the future of the country and contribute productively to nation-building.

# Districts asked to be vigilant

Thiruvananthapuram, May 7: The Kerala government Tuesday said that West Nile fever cases have been reported from Thrissur, Malappuram and Kozhikode districts of the state.

State Health Minister Veena George, in a statement, confirmed that cases of the viral infection have been reported in the state and that all the districts have been asked to be vigilant.

As part of the vigil against the viral fever, spread by the Culex species of mosquitoes, the minister has ordered that steps be taken for controlling mosquito by destroying their breeding grounds, the statement

The minister also informed that there was no need to be concerned, but requested anyone showing signs of fever or other symptoms of the West Nile infection to seek treatment immediately. "The main symptoms of West Nile infection are headache, fever, muscle aches, dizziness and loss of memory, but most patients do not experience these," she said.

"Some people experience symptoms like fever, headache, vomiting and itching and in one per cent of the cases, it can lead to brain damage resulting in unconsciousness and sometimes death. But the death rate is relatively low compared to Japanese encephalitis which shows similar symptoms and is more dangerous," the minister's statement said.

It said that instructions to begin pre-monsoon cleaning activities were already given in a high-level meeting held last

tensify the same. As there is no medicine or vaccine available against West Nile virus, symptomatic treatment and prevention is the key,

home and surroundings clean. Earlier in the day, Kozhikode district health officials confirmed reports of five cases of West Nile fever. The infected persons are all fine now and back at their homes with no new cases reported from the areas they live in, an official of the Kozhikode

The bench said a prisoner can-not be left in the lurch when suffering from a serious ailment only on the grounds of a strict provision of the Prevention of Money Laundering Act (PMLA), under which Goyal has been booked.

"A prisoner has the right to have treatment to preserve his health. It is the obligation of the State to provide requisite treatment to a prisoner to preserve and protect his health. A prisoner is entitled to the dignity he deserves," the bench observed.

There is a qualitative difference between the treatment a person gets as an undertrial prisoner and as a citizen under no restraint, it added.

The bench refused to accept the Enforcement Directorate's argument that Goyal was getting treatment in a private hospital of his own choice and was hence, not entitled to be released on bail.

"Such a broad submission loses sight of the precious value of personal liberty. To accept such a broad proposition that once a person gets the requisite treatment, he does not deserve bail, however critical his health condition may be, would defeat the legislative intent of enacting the proviso and render the proviso otiose," the court said.

The bench added that Goyal has roots in society. Hence, the possibility of fleeing from justice and tampering with evidence seems remote.

The bench directed Goyal to pay a surety of ₹1 lakh and not to leave Mumbai without prior permission from the trial court. The ED arrested Goyal in

September 2023 on allegations that he had laundered money and siphoned off loans to the tune of ₹538.62 crore given to Jet Airways by Canara Bank.

His wife, Anita Goyal, was arrested in November 2023 when the probe agency submitted its chargesheet in the case. She was granted bail by the special court on the same day, considering her age and medical condition

Mumbai, May 7: The Mumbai police have arrested a 70-year-old man, who had been absconding in a kidnapping and rape case for the last 40 years, from Agra in Uttar Pradesh, an official said Tuesday.

dors, fishermen, migrant workers and so on are forced to work under the scorching sun to make ends meet, he pointed

The LoP wanted the state government to reschedule the working hours in such a way that their livelihood is not af-

Farmers in the state are in dire straits as their crops have been destroyed and production has drastically come down, he

Especially mentioning the plight in the plantation sector, he said the production there has decreased by 25 to 50 per cent.

"A special package should be announced for farmers to come out of this crisis," Satheesan said, adding that the drinking water shortage in the state is also acute.

The Congress party's demand came amidst heatwave conditions that continue to play havoc in several places in the state.

Authorities urged people not to venture out of the scorching heat and advised them to drink more water to keep hydrated.

### BMC releases list of 188 dangerous, shabby buildings in Mumbai

Mumbai, May 7: In view of the upcoming monsoon season, the Brihanmumbai Municipal Corporation (BMC) Tuesday released a list of 188 residential buildings that are in a 'very dangerous' and 'dilapidated' state.

The civic body has appealed to people living in such structures to move to safer places as a precautionary measure.

Of the 188 buildings on the list, the highest 114 structures are in the western suburbs, followed by the eastern suburbs with 47 and 27 in the island city, the release said.

The buildings have been declared 'very dangerous and dilapidated' under section 354 of the Brihanmumbai Municipal Corporation Act (BMCA), 1888, it said.

While appealing to people to vacate these dilapidated buildings, the civic body has also asked concerned authorities who own these buildings to take necessary steps before monsoon.

As per section 353B of the BMCA, 1888. the owner and occupier of every private building, existing and in use for more than 30 years should carry out a structural audit of their buildings and submit structural stability certificate to the civic body within 30 days, the release said.

The civic body has also warned of action if owners, occupiers and cooperative societies ignore its directives.

Palanpur (Gujarat), May 7: The Banaskantha district collector Tuesday ordered an inquiry after Congress Lok Sabha candidate Geniben Thakor alleged electors were threatened and asked to vote for the BJP by some youngsters posing as Central Reserve Police Force (CRPF) personnel at a polling station.

Guwahati, May 7: A total of 965 Electronic Voting Machine (EVM) components – control units, VVPATs and ballot units - were replaced due to malfunctioning in the third and last phase of polling across the four Lok Sabha seats in Assam Tuesday, officials said.

In several cases, the components were replaced as the complete EVM set, while it was

changed in parts in most of the cases after snags were detected, a senior official of the **Election Department** told PTI on condition of anonymity.

Several of these

glitches were noticed during the mock polling, which started 90 minutes before the

commencement of the actual voting, and those machines were replaced accordingly, he added.

An EVM has three components -- Control Unit (CU), Voter

Verifiable Paper Audit Trail (VVPAT) and Ballot Unit (BU). "In the four constituencies, 259 CUs, 447 VVPATs and 259

BUs were replaced in total from different machines," the official

Out of these, 147 CUs, 210 VVPATs and 147 BUs were replaced during the mock poll after they malfunctioned, the official said.

"During the actual poll, 112 CUs, 237 VVPATs and 112 BUs

were changed. After replacing the machines, the polling continued smoothly," he added.

As per the data compiled from all the constituencies, the highest 280 units of the three components combined together were replaced in Dhubri, followed by 265 units in Barpeta, 226 units in Guwahati and 194 units in Kokrajhar.

There are a total of 9,516 polling stations, including 300 critical ones, in the third phase.



Out of the total booths, 326 are managed by women and 14 by persons with disabilities (PwD). here are also 84 model polling stations.

A total of 81,49,091 electors, including 41,00,544 men, 40,48,436 women and 111 third gender are eligible to vote in the third phase of polling in Assam.

There are 1,529 centenarians, 40,705 voters above 85 years and 2,10,177 people are first time vot-

A total of 47 candidates, including six women, are in the fray in the four constituencies --Guwahati, Barpeta, Dhubri and Kokrajhar (ST).

## JMM-Cong votes hold the key in Biramitrapur

Rourkela, May 7: With the cancellation of the candidature of INDIA bloc candidate Nihar Surin, the Biramitrapur Assembly segment will see a straight fight between BJD's Rohit Joseph Tirkey and BJP's Shankar Oram. It is now clear that Jharkhand Mukti Morcha (JMM)-Congress votes will play a decisive role in the upcoming polls.

During scrutiny May 6, it was found that Surin's nomination papers lacked the required number of proposers for him following which his candidature was disqualified. Surin's presence had made the fight more exciting while he had asserted, just before filing his papers, that he would win the polls even though there would be a triangular fight.

His optimism was based on the fact Surin had won the election defeating George Tirkey in 2004 when JMM and Congress

fought the polls together. Earlier, he had said, "The political equation now is the same as that of 2004 as Congress is backing us." In 2009, they parted ways and George Tirkey won seat as an independent candidate. George had resigned from



BJD in protest against the infamous Kalinga Nagar incident. Incidentally, George had won twice on JMM ticket - in 1995

This time, George's son Rohit Joseph, who had lost the election here in 2019 on a Congress ticket, is up against BJP's Oram, the sitting MLA. Oram had then polled 60,397 votes, which is 34.66 per cent of the total votes - a whopping 13.61 per cent increase in the vote share for the saffron party as compared to the previous

Maklu Ekka of BJD came second with 44,586 votes which is



25.36 per cent of the total votes polled. There was a 9.86 per cent increase in BJD's vote share in

Rohit came as a close third by securing 44,212 votes, which is 25.15 per cent of the total votes. The increase in the vote share for INC was 9.96 per cent.

Likewise, JMM's Sebeyan Aind got 14,374 votes while the tribal outfit's vote share fell by 8.98

It is significant to note that BJP's vote share is increasing with each passing election while that of the Congress' is decreasing, barring that of 2019,

Now, BJD will try to wrest the seat this time, which it has never achieved. The only time Janata Dal won the seat was way back in 1990. Otherwise, it has been shared between Congress I, Congress, Janata Dal, JMM and Now the question is who stands

the present order shall undertake to refund the entire amount of the salary which may be paid from the date of this order and the final judgement of this court," the bench said in its order.

It said the issue which would merit closer analysis is whether the appointment which suffers from tainted can be segregated (with the genuine ones).

If such is possible then it would be wrong to set aside the entirety of the process, the bench said

The court should also be mindful that a large number of teachers for class 9-10th would be effected. New Delhi, May 7: It is imperative for celebrities and public figures to act responsibly while endorsing a consumer product as advertisers and endorsers are equally responsible for issuing misleading advertisements, the Supreme Court said Tuesday.

Clamping down on misleading advertisements, the apex court directed that before an advertisement is permitted to be issued, a self-declaration be obtained from the advertisers on the line of the Cable Television Networks Rules, 1994.

Rule 7 of the 1994 rules deals with advertisement code and stipulates that advertisements carried in the cable service shall be designed to be in conformity with the laws and should not offend morality, decency and religious susceptibilities of the subscribers. The top court said the min-

istries concerned need to set up a specific procedure which will encourage consumers to lodge complaints regarding misleading advertisements and the complaints be taken to their logical conclusion. It said self-declarations by ad-

vertisers shall be uploaded on the 'Broadcast Seva' portal which runs under the aegis of the Ministry of Information and



Broadcasting.

Regarding advertisements in the print media, the bench said the ministry shall create a portal within four weeks and advertisers shall file self-declaration before issuing any advertisements.

The bench said the proof of filing self-declaration has to be made available by the advertiser to the broadcaster or publisher.

It also asked the health ministry to file an affidavit regarding complaints received from 2018 onwards by the Food Safety and Standards Authority of India on misleading advertisements concerning food products and also details of action taken or proposed to be taken on them.

The bench referred to the Central Consumer Protection Authority guidelines including those related to children-targeted advertisements and duties of the manufacturer. service provider, advertiser and advertising agency.

It also perused the affidavits filed by the ministries of Ayush, consumer affairs and information and broadcasting.

#### Mayawati drops nephew as 'successor'

Lucknow: Bahujan Samaj Party chief Mayawati Tuesday night said she is divesting her nephew Akash Anand of his responsibilities as the party's national co-ordinator and her "successor", barely five months after she had anointed him. Announcing it on X, the former Uttar Pradesh Chief Minister said she has taken the decision in the interest of the party and the movement and till the time Anand gains "full maturity". She said her brother and Akash's father Anand Kumar will continue to fulfil his responsibilities as before. The surprise decision came on the day voting was held for the third phase of the Lok Sabha polls in the country.

#### Kejriwal, Sisodia, Kavitha to stay in jail

New Delhi: A Delhi court Tuesday extended the judicial custody of Chief Minister Arvind Kejriwal, his party colleague Manish Sisodia and BRS leader K Kavitha in cases related to the alleged excise scam. Special judge for CBI and ED matters Kaveri Baweja extended Kejriwal's custody till May 20 in the money laundering case linked to the alleged scam being probed by the ED, after he was produced before the court through a videoconference on the expiry of his remand granted earlier. The judge also extended the judicial custody of Sisodia till May 15 in a related corruption case being probed by the CBI.

Srinagar: Two terrorists, including a top "commander" of Lashkar-e-Taiba offshoot TRF who was involved in several cases of killing of policemen and civilians, were eliminated by security forces in an encounter in Jammu and Kashmir's Kulgam district Tuesday, officials said. One of the slain terrorists has been identified as Basit Dar, an "A" category terrorist who belonged to The Resistance Front (TRF), according to Inspector General of Police (IGP), Kashmir, V K Birdhi. He said security forces got inputs about the movement of terrorists in Redwani village following which a cordon and search operation was launched there Monday night. "There was firing from the other side," he told reporters in Kulgam. Birdhi said the terrorists were given an opportunity to surrender, but they continued their firing on the security personnel.

## India slams Canada on violent imagery

New Delhi, May 7: India Tuesday accused the Canadian government of allowing "celebration and glorification" of violence and called on Ottawa to stop providing criminal and secessionist elements a safe haven in Canada after a parade in Ontario's Malton displayed pro-Khalistan sentiments.

External Affairs Ministry spokesperson Randhir Jaiswal said India continued to remain concerned about the security of its diplomatic representatives in Canada and expect Ottawa to ensure that they are able to carry out their responsibilities without fear. The controversial parade was organised Sunday.

"As you are aware, we have repeatedly raised our strong concerns regarding the violent imagery being used by extremist elements in Canada against our political leadership,' he said. "Last year, a float depicting the assassination of our former prime minister was used in a procession, he said. Jaiswal said posters of Indian diplomats have also been put out across Canada threatening violence against them.

"Celebration and glorification of violence should not be a part of any civilised society. Democratic countries which respect the rule of law should not allow intimidation by radical elements in the name of freedom of expression," he said.

### EC asks X to take down BJP's video targeting Muslims

New Delhi, May 7: Election Commission Tuesday directed social media platform 'X' to "immediately" take down an animated video shared by the Karnataka unit of the BJP related to the row over reservation for the Muslim community.

In a letter to the nodal officer of 'X', the EC took exception to the non-compliance of the directive of the Karnataka Chief Electoral Officer to the social

media platform for taking down the video. The panel said the animated video shared by the Karnataka unit of the BJP on its social media handle was violative of the extant legal framework. The EC said the Chief Electoral Officer of Karnataka registered an FIR in this connection and wrote to 'X' May 5 to take down the objectionable post as per the provisions of the Information Technology Act and the IT (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021.

"However, the post has not been taken down yet. Therefore, 'X' is directed to take down the post immediately," the EC said. The fresh directive to 'X' came on the day votes were being cast in the remaining 14 Lok Sabha seats in Karnataka. Polling in the other 14 parliamentary constituencies of Karnataka was held April 26. The Karnataka Congress had filed a complaint with the Chief Electoral Officer of the state, accusing the BJP of\_ promoting enmity and hatred between the Muslim and the SC/ST communities.

#### 2 killed, 21 hurt in knife attack at hosp

Beijing/Kunming: At least two people were killed and 21 others injured in a knife attack at a hospital Tuesday in China's Yunnan Province, local authorities said, in the latest incident of mass stabbing in the country. The attack took place at around 11:30 am when a man assaulted people with a knife at a local hospital in Zhenxiong County, the county's public security bureau said. The injured are being treated in the hospital, and the case is under investigation, the state-run Xinhua news agency reported. The suspect, identified as a male local villager, was captured in the afternoon, Xinhua reported. No motive has been given for the attack.

#### **Five killed in SA** building collapse

Cape Town: Rescue teams worked through the night searching for dozens of construction workers buried for more than 12 hours under a multi-story apartment complex that was being built collapsed in a coastal city in South Africa. Authorities said early Tuesday that the death toll had risen to five, while 49 workers remained unaccounted-for in the mangled wreckage of the building, which collapsed on Monday afternoon. Authorities said a further 21 workers had been rescued from the rubble and taken to various hospitals with at least 11 of them suffering severe injuries.

#### **Russia detains** 2 US nationals

Moscow: Russian authorities said Tuesday they had detained two US nationals, including a serving US soldier, in separate criminal cases. The soldier. detained Monday on charges of criminal misconduct, was arrested on theft charges by a court in Vladivostok in Russia's Far East, the regional office of the Interior Ministry said in a statement Tuesday. The Russian Foreign Ministry said the case had no political element and there were no allegations of espionage.

#### TikTok sues US

New York: TikTok and its Chinese parent company ByteDance are suing the US federal government to challenge a law that would force the sale of ByteDance's stake or face a ban, saying that the law is unconstitutional. TikTok alleged the law, which President Joe Biden signed as part of a larger \$95 billion foreign aid package, is so "obviously unconstitutional" that the sponsors of The Protecting Americans From Foreign **Adversary Controlled Applications** Act are trying to portray the law not as a ban, but as a regulation of TikTok's ownership.

# **Israel seizes Rafah crossing**

The UN warned of a potential collapse of the flow of aid to Palestinians from the closure of Rafah and the other main crossing into Gaza, Kerem Shalom, at a time when officials say the northern part of the enclave is already experiencing 'full-blown famine'

Cairo, May 7: Israeli tanks seized control of Gaza's vital Rafah border crossing Tuesday as Israel brushed off urgent warnings from close allies and moved into the southern city even as cease-fire negotiations with Hamas remained on a knife's edge.

The Israeli foray overnight came after hours of whiplash in the Israel-Hamas war, with the militant group Monday saying it accepted an Egyptian-Qatari mediated cease-fire proposal. Israel, however, insisted the deal did not meet its core demands.

The high-stakes diplomatic moves and military brinkmanship left a glimmer of hope alive - if only barely — for a deal to bring at least a pause in the war, which as it marked its 7-month point Tuesday, has killed more than 34,700 Palestinians, according to local health officials, and has devastated the Gaza Strip.

Footage released by the military showed Israeli flags flying from tanks that seized the area It also said that ground troops and airstrikes targeted suspected Hamas positions in Rafah. The military claimed it had intelligence the crossing was "being used for terrorist purposes," though it did not

immediately provide evidence. It said Hamas fighters near the crossing launched a mortar attack that killed four Israeli troops near Kerem Shalom Sunday and that more mortars and rockets were fired from the area Tuesday.

The Rafah crossing with Egypt and the Kerem Shalom crossing with Israel are critical points of entry for food, medicine and other supplies keeping Gaza's population of 2.3 million alive.

They have been closed for at least the past two days, though the smaller Erez crossing between Israel and northern Gaza continues to operate. Israeli authorities denied the UN humanitarian affairs office access to Rafah crossing Tuesday, its spokesman Jens Laerke said, warning that the disruption could break the fragile aid operation.

All fuel for aid trucks and generators comes through Rafah, and Laerke said they have a 'very, very short buffer of about one day of fuel.'

Israeli strikes and bombardment across Rafah overnight killed at least 23 Palestinians, including at least six women and five children, according to hospital records.

Egypt has previously warned that any seizure of Rafah which is supposed to be part of a demilitarised border zone - or an attack that forces Palestinians to flee over the border into Egypt would threaten the 1979 peace treaty with Israel that's been a linchpin for regional security.

Netanyahu has said an offensive to take Rafah — which Israel says is Hamas' last major stronghold in Gaza — is crucial to the goal of destroying Hamas after its October 7 attack on southern Israel that triggered the war.



Putin begins his

5th term as Prez

Moscow, May 7: President Vladimir Putin began his fifth term at a glittering Kremlin Tuesday, inauguration embarking on another six years as leader of Russia after destroying his political opponents, launching a devastating war in Ukraine and concentrating all power in his hands.

At the ceremony in the gilded Grand Kremlin Palace, Putin placed his hand on the Russian Constitution and vowed to defend it as a crowd of handpicked dignitaries looked on.

"We are a united and great people and together we will overcome all obstacles, realise all our plans, together we will win," Putin said after being sworn in.

Since succeeding President Boris Yeltsin in the waning hours of 1999, Putin has transformed Russia from a country emerging from economic collapse to a pariah state that threatens global security. Following the 2022 invasion of Ukraine that has become Europe's biggest conflict since World War II, Russia has been heavily sanctioned by the West and is turning to other regimes like China, Iran and North Korea for support.

Already in office for nearly a quarter-century and the longest-serving Kremlin leader since Josef Stalin, Putin's new term doesn't expire until 2030, when he will be constitutionally eligible to run again.

In a heavily choreographed performance, Putin was pictured in his office looking at his papers before walking along the Kremlin's long corridors, pausing at one point to look at a painting, on the way to his inauguration.

His guard of honour waited in the sleet and rain for hours, in temperatures hovering just above freezing, while Putin made the brief journey to the Grand Kremlin Palace in his Auras

Putin used the the first moments of his fifth term to thank the "heroes" of his war in Ukraine and to rail against the West. Russia "does not refuse dialogue with Western states,' he said. Rather, he said, "the choice is theirs; do they intend to continue trying to contain Russia, continue the policy of aggression, continuous pressure on our country for years, or look for a path to cooperation and peace.

He was greeted with applause when he entered the hall with more than 2,500 invited guests. They included senior members of the Russian government as well as celebrities including American actor Steven Seagal.

Neither the US, UK nor German ambassadors attended. The US Embassy said Ambassador Lynne Tracy was out of the country on "prescheduled, personal travel".

A handful of European Union envoys attended even though top EU diplomat Josep Borrell said he told them "the right thing to do is not to attend this inauguration," because Putin is the subject of an arrest warrant by the International Criminal Court for war crimes, accusing him of personal responsibility for the abductions of children from Ukraine.

"This case involves, by any footing, a very substantial fraud allegation... not one where bail can be granted and the application is refused," he said.

#### Suicide bombing that killed 5 Chinese planned in Afghan: Pakistan

Islamabad: Pakistan's military said Tuesday that a suicide bomb attack that killed five Chinese engineers was planned in neighbouring Afghanistan, and that the bomber was also an Afghan national. The suicide bomber rammed a vehicle into a convoy of Chinese engineers working on a dam project in northwest Pakistan in March, killing six people. "The entire attack was planned in Afghanistan, the car used in it was also prepared in Afghanistan, and the suicide bomber was also an Afghan national," Pakistan military spokesman Major-General Ahmed Sharif told a news conference in Islamahad, Afghanistan's Talihan-run administration did not immediately respond to a request for comment. Kabul has previously said rising violence in Pakistan is a domestic issue for Islamabad and denied allowing the use of its territory by militants.

#### **UK blames unnamed 'malign actor' for defence ministry payroll hack**

London: British Defence Secretary Grant Shapps Tuesday said that a "malign actor" was behind a massive data breach involving the Ministry of Defence, targeting service personnel from the Royal Navy, Army and Royal Air Force, as he underlined that "state involvement" in the large-scale cyber attack cannot be ruled out. Earlier, the BBC had reported that the government suspects China was behind the hack of the armed forces payroll system that is run by an external contractor and includes data of both current and some past armed forces members. Shapps told Parliament that the government cannot rule out "state involvement" in the cyber attack but stopped short of naming any particular country. "This was the suspected work of a malign actor and we cannot rule out state involvement." Shapps told the House of Commons.

### UKRAINE WAR: FEARS OF MOSCOW-PYONGYANG AXIS

Kyiv, May 7: Ukrainian state prosecutors say they have examined debris from 21 of around 50 North Korean ballistic missiles launched by Russia between late December and late February, as they seek to assess the threat from Moscow's cooperation with Pyongyang.

In previously unreported details of an investigation under way into the missiles, the office of Ukraine's top prosecutor, Andriy Kostin, also told Reuters that the failure rate of the North Korean weaponry appeared to be high.

"About half of the North Korean missiles lost their programmed trajectories and exploded in the air: in such cases the debris was not recovered,' Kostin's office said in written answers to Reuters' questions.

North Korean missiles account for a tiny portion of Russia's strikes during its war on Ukraine, but their alleged use has caused alarm from Seoul

to Washington because it may herald the end of nearly twodecade consensus among permanent members of the United Nations Security Council on preventing Pyongyang expanding its nuclear and ballistic missile programmes.

In addition to providing North Korea with an opportunity to test missiles. Russia has taken steps that will make it harder for the United Nations to monitor sanctions imposed on Pyongyang in 2006. Last month, Moscow vetoed

the annual renewal of the UN sanctions monitors - known as a panel of experts - that has for 15 years monitored enforcement of the UN sanctions on the Democratic People's Republic of Korea (DPRK), North Korea's official name.

China, one of the five permanent members on the Security Council with Russia, the United States, Britain and France, abstained from the vote.

## Household savings dip Significant divide in consumption

Mumbai, May 7: A Swiss brokerage Tuesday said there is a 'significant divide' in India's consumption story and that the K-shaped trend is likely to continue in the near-future.

"India's consumption story reflects a significant divide, driven by a resilient economy but characterised by a stark contrast in spending patterns," UBS India economist Tanvee Gupta Jain said in a note.

"...the divergence between affluent and broad-based household demand persists, accentuated by factors such as income inequality, increased consumer credit access, and declining household savings," she added.

The brokerage anticipates



household consumption growth in FY25 to "remain subdued" at 4-5 per cent, which is below the

trend observed in previous years. It can be noted that after the pandemic, concerns have been raised about a K-shaped growth representative of deepening inequalities in the country. Some economists have gone public with their disapproval and called the pandemic as a 'leveller' for reducing inequalities as well.

The UBS report said India's household consumption nearly doubled in the past decade to USD 2.1 trillion in 2023, with an annual compound growth rate of

However, household consumption growth remained muted in the last two years, it said, adding that it is the affluent segment that witnessed a significant increase in demand.

The brokerage said the consumption growth recovery is 'uneven', and pointed out that there has been faster growth in premium car sales, residential units of over ₹1 crore, smartphones costing over USD 300, or ₹25,000, while entry-level and mass market goods have seen muted growth post-pandemic.

It attributed the divide in con-

sumption to factors such as in come continuity being enjoyed by those in the top of the pyramid versus the bottom, limited fiscal support for vulnerable sections and lower household savings due to weaker incomes.

The 'K-shaped' consumption pattern continues post pandemic as well, it said, adding that the urban economy continues to outperform relative to the rural economy recovery post-pan-

## Sebi rejects NSE's proposal to extend trading hours

New Delhi, May 7: Capital markets regulator Sebi has rejected a proposal by the National Stock Exchange (NSE) to extend the trading hours in the equity derivatives segment citing a lack of feedback from the stock brokers community

"Currently, there is no plan to extend the timings as Sebi has returned our application as the stock brokers have not given the feedback that Sebi wanted. So, as of now, the extended time frame (plan) is shelved," NSE MD and CEO Ashishkumar Chauhan said in a post-earnings analysts call.

This came after the NSE had urged Sebi to extend trading hours in the equity derivatives segment in a phased manner. This was aimed at potentially curtailing the overnight risk arising from global information

Sriram Krishnan, Chief Business Development Officer of NSE, had told PTI in September that the bourse was planning a session from 6 pm to 9 pm after a break from the closure of the regular session from 9.15 am to 3.30 pm. Based on the response, a gradual extension of the market timing till 11.55 pm was proposed on the lines of commodity derivatives.

To begin with, only index derivatives in phase 1 were proposed to be available followed by single stock options and oth-

In 2018, the Securities and Exchange Board of India (Sebi) allowed stock exchanges to set their trading hours in the equity derivatives segment between 9 am and 11.50 pm. This was similar to the trading hours for the commodity derivatives segment, which are currently fixed between 10 am and 11.55 pm.

The move was part of Sebi's efforts to enable the integration of stocks and commodities trading on a single exchange.

With regard to NSE's IPO, Chauhan said that "situations remain as in". Last month, he said that NSE is awaiting approval from Sebi to kickstart the initial public offering process. The NSE's listing plans have been on the backburner amid a Sebi probe against the exchange and some of its top officials.

During the fourth quarter ended March 2024, NSE reported a 20 per cent year-on-year increase in consolidated net profit at ₹2.488 crore. Further, the consolidated operating revenues stood at ₹4,625 crore for the January-March quarter of the financial year 2023-24, marking a surge of 34 per cent year-on-

Apart from trading, the total revenue was also supported by other revenue lines, including listing, index services, data services and co-location facility.



Bangalore, May 7: Indian fast-moving consumer goods' sales rose in January-March, with rural growth outpacing that in urban areas for the first time in five quarters, market researcher NielsenIQ said

Consumer goods-makers in the world's fifth-largest economy have been struggling with sluggish demand, especially in the hinterlands, as higher prices of essentials including milk and tomatoes have forced people to cut back spending on non-essentials.

Sales volumes for fast-moving consumer goods rose 6.5% in the March quarter from a year earlier, NielsenIQ said, quickening from a 6% growth in the previous quarter.

Sales rose 7.6% in rural India, boosted by the personal and home care categories, against a 5.8% growth in the previous quarter.

Meanwhile, urban sales growth slowed to 5.7% from 6.9% in the previous quarter, as consumer goods makers struggled with rising competition.

Sales in the non-food segment rose at double the pace com-



pared with the food segment, NielsenIQ said.

Consumer goods majors including Nestle India and Dabur have posted strong results for the March quarter as demand for products such as biscuits buoved their bottom-lines.

## From Marseille to Mont-Blanc: The journey of Olympic torch to Paris

Paris, May 7: The Olympic torch will finally enter France when it reaches the southern seaport of Marseille Wednesday. And it's already been quite a journey.

After being lit by the sun's rays April 16 in Ancient Olympia, the torch was carried around Greece before leaving Athens aboard a three-mast ship named Belem, headed for Marseille.

The Belem was first used in 1896, the same year the modern Olympics came back. It will be accompanied by more than 1,000 boats as it parades around the Bay of Marseille, before arriving at the Vieux-Port, or Old Port, and docking on a pontoon resem-

bling an athletics tracks. Torch bearers will carry the flame across Marseille the next day, the last stretch running on the roof of the famed Stade Velodrome, home to Marseille's passionate football fans. After leaving Marseille, a vast relay route will be undertaken before the torch odyssey ends July 27 in Paris.

MONT-SAINT-MICHEL The torch is due to reach the famed and visually stunning site of Mont Saint-Michel in Normandy May 31. Located in an area of raised land surrounded by water, the island fortress looks like it was created for a Game of Thrones film set. But it's real, and very old. So old that it already existed during the Hundred Years' War be-

tween England and France, from

1337 to 1453. Later it became a



The torches have a lower environmental impact than those used at previous Games as they burn biogas instead of propane and are recharged when fuel runs out. Around 2,000 torches will be used compared to more than 10,000 before

prison, and in 1979 it was named a UNESCO World Heritage Site.

#### **ACROSS THE OCEANS**

This route is even more unique considering it takes a detour through France's overseas territories called the Relais des Oceans, or Ocean Relay. Riding the waves of the Atlantic, Pacific and Indian Ocean, it will be in French Guiana June 9 before hitting New Caledonia June 11. Next is the island of Reunion at Saint-Denis — coincidentally the same name as the Paris suburb with the Olympic villagebefore reaching Papeete in the surfing realm of Tahiti, then Baie-Mahault in Gaudeloupe

and finally Fort-de-France in

Martinique. The torch comes

back to France June 18 in the southern city of Nice.

#### FROM SEA BREEZE TO HEAVY

Just five days after landing on French shores, the torch heads up the Alpine mountain pass of Chamonix-Mont-Blanc for Olympic Day June 23. The Haute-Savoie region is known for its outstanding Chamonix ski resort, which hosts World Cup races, for sweeping views across glacier fields to nearby Italy, and some would say more importantly as a producer of fine cheese.

#### **HEADING FOR PARIS**

After leaving fromage-friendly Savoie, torch bearers will digest in the Doubs region of eastern France, and then visit the Alsace city of Strasbourg in the northeast. Three days later the torch will reach Verdun, the site of one of the most horrific battles of World War I. In 1916, more than 700,000 French and German soldiers were killed or wounded at the Battle of Verdun.

#### **BASTILLE DAY ARRIVAL**

The torch is to arrive on the streets of Paris July 14—hardly surprising, considering it's Bastille Day, France's national day. The torch will stay the following day in Paris, then exit again before snaking back to the French capital via Versailles — home to the resplendent Royal Palace — and the suburbs of Nanterre July 24 and Seine Saint-Denis July 25. From there, it's to travel a very short distance back to Paris July 26, the eve of the grandiose opening ceremony where athletes will parade on more than 80 boats at sunset on the Seine River.

#### **FINAL DESTINATION**

After the nearly four-hour ceremony ends shortly after 11 pm, the cauldron will be lit at a location that is being kept top-secret until the day itself. Among reported options are such iconic spots as the Eiffel Tower and the Tuileries Gardens outside the Louvre Museum.
