

Turbulence in AI Exp; 100 flights cancelled

New Delhi / Kochi, May 8: Air India Express has cancelled more than 100 flights since Tuesday night as a section of cabin crew reported sick to protest against the alleged mismanagement at the Tata Groupowned airline, impacting around 15,000 passengers.

Faced with cabin crew shortage, the airline, which operates a significant number of flights to the Gulf, has decided to curtail flights till May 13. Air India Express is to operate around 360 flights daily to domestic and international destinations, sources said Wednesday.

The Civil Aviation ministry Wednesday sought a report from Air India Express on the flight cancellations and also asked the airline to resolve the issues promptly. Apart from cancella-

tions, scores of flights were delayed and the airline's passengers, mostly scheduled to travel to the Gulf nations, protested at airports in Kerala against flight cancellations as many of them were informed only after the security checks.

at various airports, including Kochi, Calicut, Delhi and Bangalore. Domestic as well as international services, including to various Gulf countries, have also been hit. At Delhi airport alone, 14 flights of the carrier were cancelled from 4am to 4pm

Last month, the Air India Express Employees Union (AIXEU), which claims to represent around 300 cabin crew members, mostly seniors, had also alleged that mismanagement of the affairs has affected the morale of the employees.

Pitroda lands Cong in new mess, quits post

New Delhi, May 8: Congress leader Sam Pitroda Wednesday resigned as the chairman of the Indian Overseas Congress after his controversial remarks spurred the BJP to label the party "racist".

Congress general secretary Jairam Ramesh said on X that party chief Mallikarjun Kharge has accepted Pitroda's decision.

"Mr Sam Pitroda has decided to step down as Chairman of the Indian Overseas Congress of his own accord. The Congress President has accepted his decision," Ramesh said in his post.

The development came after Pitroda's choice of ethnic and racial identities like Chinese. Arabs, Whites and Africans at a podcast to describe how Indians from different parts of the country look triggered a political firestorm. The Congress swiftly distanced itself from his words. calling the remarks "most unfortunate and unacceptable".

ASTRAZENECA STARTS WITHDRAWAL OF VAX

London/New Delhi, May 8: UK-based pharmaceutical major AstraZeneca has started global withdrawal of its Covid-19 vac-

cine, which was provided in India as 'Covishield' in partnership with Serum Institute of India, days after it admitted to rare side effects of blood clotting and low platelet counts. The withdrawal has been initiated due to a surplus of available

updated vaccines since the pandemic, the company said. AstraZeneca had partnered with Oxford University to develop the vaccine, which was sold in India as Covishield and Vaxzevria in Europe.

He also asked Modi if he was "scared". "Modiji, are you a little scared? Normally you talk about Adani and Ambani behind closed doors. but for the first time you have talked about Adani and Ambani in public," Rahul said in the video message.

dren in Nabarangpur district have been found to be infected with Rubella virus, a Health department official said, Wednesday.

The cases have been detected at Panaspadarguda village under Padalguda panchayat of Nandahandi block of this tribaldominated district, said Malaya Kumar Tripathy, chief district medical officer (CDMO) in-charge of Nabarangpur.

The affected children have been identified as seven-yearold Kapilas Majhi and 22-monthold baby boy Tripati Majhi, the CDMO said. The patients have been kept under isolation and are being given antibiotics and vitamins for recovery. A medical team will keep them under observation for 21 days.

Three others who were having similar symptoms are also being given medicines. Later, senior manager of WHO O Mausam Mona, CDMO Tripathy, microbiologist Raj Dutta, epidemiologist Irshad Ahmed Khan, medical officer of Nandahandi CHC Sibananda Bishoi, and a medsons displayed signs of Rubella virus. On being apprised, ANM Gunjan Pattnaik rushed to the village April 26 and interacted with the villagers. She informed, the medical officer of Nandahandi CHC after she found fever and measles type symptoms among the affected villagers. Five samples were collected and sent for tests to the (RMRC) ICMR laboratory in Bhubaneswar, of which two were found to be Rubella positive while another of measles April 29, he said.

Health Services Director Bijay Mohapatra said Nandahandi block of Nabarangpur district have been affected by Rubella.

'So far, 18 persons have been found with fever and rashes in the body, a symptom of Rubella virus. We've conducted tests for Scrub typhus, leptospirosis, but the results are negative. Now, we have sent the samples to ICMR for Rubella tests," the director said. However, there is no need to panic as the situation is under control, added the Health Services director.



New Delhi, May 8: A total of 695 candidates are in the fray across 49 constituencies spread over eight states and Union Territories (UTs) in the upcoming fifth phase of the Lok Sabha polls May 20, the Election Commission (EC) said Wednesday.

The figure emerged after the scrutiny of 1,586 nomination forms filed for the fifth phase of the ongoing polls. Of the nominations, 749 were found to be valid after the deadline for filing papers closed May 3, according to a statement issued by the EC.

Each constituency is expected to witness an average of 14 contesting candidates, reflecting a diverse range of political options for the voters

The statement said 695 candidates will contest the polls from eight states and UTs in the fifth phase May 20. Maharashtra topped the list with 512 nominations, resulting in 301 valid candidates contesting across 13 constituencies, while Uttar Pradesh followed closely with 466 nominations, leading to 147 valid candidates across 14 constituencies

The highest number of nominations in a single constituency was seen in Maharashtra's Chatra, which received 69 candidatures, followed by Lucknow in Uttar Pradesh with 67 nominations

Each constituency in the fifth phase is expected to witness an average of 14 contesting candidates, reflecting a diverse range of political options for the voters

The state-wise breakdown of the nominations and valid candidates after the scrutiny showcases the dynamic electoral landscape across the country. Bihar, Jammu and Kashmir Jharkhand, Ladakh Maharashtra, Odisha, Uttar Pradesh and West Bengal together form the crux of the fifth phase, encompassing a significant portion of the country's electorate, the statement said.

DO NOT USE COERCION FOR GST RECOVERY: SC

New Delhi, May 8: The Supreme Court Wednesday directed the Centre to not use 'threat and coercion' during search and seizure operations against traders for recovery of Goods and Services Tax (GST) and instead persuade them to clear the dues voluntarily

A bench of Justices Sanjiv Khanna, MM Sundresh and Bela M Trivedi, which is examining various provisions of the GST Act. said there is no provision under the law which empowers the authorities to

exert force for payment of outstanding dues

"There is no power under the Act to compel any person to pay the tax liability during the search and seizures. Ask your de-

partment that the payment should be voluntarily and there should not be use of any force. You have to give threefour days' time to the alleged offender to consult, think and clear the liability. It should be voluntary and there should not be use of any threat or coercion," the bench told Additional Solicitor General SV Raju, appearing for the Centre.

Raju did not discount the possibility of use of force in the past but said mostly the payment during search and seizure is voluntary

"Yes, there is possibility of both ways but mostly the payment is done voluntarily or after a few days as the alleged offender wanted to consult his advocate for payment of liability. Yes, there may have been some instances in the past but that is not the norm," he said during the day-long hearing

The bench said several petitioners have alleged that the authorities exercised threat and coercion during search and

seizure operations. It said, "We know what is on paper and what happens in reality when a person is subjected to search and seizure. If there is denial of payment, you can provisionally attach the properties but you have to give some time to consult, think and clear the liability. You can't put him under threat and coercion of arrest."

When Raju said many a time the alleged offenders adopt various methods to evade taxes, the bench told him, "Arrest him but it should be strictly under the procedure laid down

under law." It said unlike the Income Tax Act, there is a provision for arrest under section 69 of the GST Act

Senior advocate Sujit Ghosh, appearing for one of the petitioners. said safeguards provided under the law are not implemented and in-

stead people are subjected to threat of arrest to pay up. During the hearing on a batch of 281 petitions which have challenged various provisions of the GST Act, Customs Act and the

Prevention of Money Laundering Act, the bench told Raju that the GST law provides for checks and balances. "We agree there cannot be a



April 2024 warmest ever, says C3S as temp records topple

New Delhi, May 8: The world experienced the warmest April ever, with record heat, rain, and flooding crippling normal life in many countries, according to new data released Wednesday

It was also the 11th consecutive month of record-high temperatures, a result of the combined effect of now weakening El Nino and human-caused climate change, the European Union's climate agency Copernicus Climate Change Service (C3S) said.

The average temperature of 15.03 degrees Celsius in April was 1.58 degrees Celsius higher than the month's average for 1850-1900, the designated preindustrial reference period.

It was 0.67 degrees Celsius above the 1991-2020 average for April and 0.14 degrees Celsius above the previous high set in April 2016.

"El Nino peaked at the beginning of the year, and the sea surface temperatures in the eastern tropical Pacific are now going back towards neutral conditions. However, while temperature variations associated with natural cycles like El Nino come and go, the extra energy trapped in the ocean and the atmosphere by increasing concentrations of greenhouse gases will keep pushing the global temperature towards new records," Carlo Buontempo, Director of C3S, said.

The global average temperature for the past 12 months (May 2023-April 2024) is the highest recorded, at 0.73 degrees Celsius above the 1991-2020 average and 1.61 degrees Celsius above the 1850-1900 pre-industrial average, the climate agency said. According to C3S, the global



average temperature breached the 1.5 degrees Celsius threshold for an entire year for the first time in January.



WORLD THALASSEMIA DAY WHY IS INDIA THE THALASSEMIA CAPITAL OF THE WORLD?

ack of widespread awareness, genetic counselling and traditional belief systems are some of the major reasons why India has the highest number of thalassemia major patients in the world, said experts on the occasion of World Thalassemia Day (WTD) Wednesday.

WTD is observed every year May 8 to raise awareness about the disease. The theme this year is 'Empowering Lives, Embracing Progress: Equitable and Accessible Thalassaemia Treatment for All'.

Every eighth thalassemia patient in the world lives in India. And yearly about 10,000-20,000 new thalassemia majors are born.

"India has the largest number of children with thalassemia major in the world, with around 1-1.5 lakhs of children affected. India's status as the thalassemia capital stems from a complex

interplay of factors. Genetic predisposition, consanguineous marriages, and lack of awareness contribute to its prevalence. The rise in India can be attributed to population growth, limited access to screening, and lack of awareness," Sunil Bhat, director and clinical lead - Pediatric Hematology, Oncology and BMT, Narayana Health Network Hospitals, told IANS.

Thalassemia major is a severe inherited blood disorder, passed from parents to children. The disorder occurs when the body doesn't make enough of a protein called haemoglobin - an important part of red blood cells - forcing the need for blood transfusions every fortnight. It is particularly prevalent in

populations with a high incidence of cousin marriages and within certain ethnic and geographical groups.

"In India, certain communities such as Sindhis, Punjabis,



Bhanushali, Kutchi, Marwari, Maratha, Muslim and Bengalis have a higher prevalence of the gene, which increases the incidence of thalassemia. The incidence of thalassemia minor in this community varies from 8-14 per cent," Vijay Ramanan, senior consultant Clinical Haematologist, Bone Marrow and Stem Cell Transplant, Ruby

Hall Clinic, Pune, told IANS.

The large population and high birth rate in India also contribute to a greater number of individuals being affected by genetic disorders.

"Lack of widespread awareness and education about thalassemia and genetic counselling among the general public leads to insufficient preventive measures. Prenatal and pre-marital screening for thalassemia is not uniformly practised across the country," Vijay said.

"Ignorance and desire to believe that astrology is more important than science has contributed to an increase in number of cases where thalassemia minors marrying another thalassemia minor. Such marriages have a 25 per cent chance of getting a thalassemia major child," he added.

The doctor lamented that while prenatal diagnosis exists in the country to prevent the birth of such children, "it is not availed by such couples due to religious beliefs or ignorance.

Moreover, the availability and accessibility of medical services, including blood transfusions and chelation therapy, can be uneven across urban and rural regions in the country.

Importantly, the doctor also pointed out a lack of data.

"The rough estimate is that about 4 lakh to 6 lakh children with thalassemia major exist in India. However, the diseases needing transfusions are not usually collected in the data. Distribution of thalassemia major patients across states has not been done due to lack of registry," Vijay said.

Comprehensive education on genetic risks, premarital counselling and widespread screening is essential to address the burden of thalassemia in India, noted the experts.

"In addition, promoting voluntary genetic testing national policy from the government and fostering partnerships between doctors and communities can enhance prevention efforts. Ultimately, proactive measures, such as early diagnosis and timely management, hold the key to alleviating the impact of thalassemia in India," Sunil said.

Privileged Protesters

t is easy to ridicule the college protesters in the United States calling for a free Palestine "from the river to the sea." Students at some L of the country's most expensive and prestigious universities don Palestinian keffiyehs, "liberate" campus buildings, as though they were freedom fighters, and, in the case of at least one young protester, demand food and water from the college authorities as "basic humanitarian aid.³

To be sure, all political demonstrations are a kind of theatre. Certainly not everyone protesting against the killing of large numbers of innocent civilians in Gaza is worthy of derision. Using violence against them, whether by the police, or, as happened at UCLA, by mobs, is unconscionable.

The problem is that the "anti-Zionist" cause gaining ground on college campuses is often incoherent. Its ideological underpinnings tend to see everything as interconnected: police brutality against African-Americans, global warming, US imperialism, white supremacy, the history of American slavery, European colonialism, trans- and homophobia ("Queers for Palestine"), and now the Israel-Hamas war. In the words of a Cornell University student, interviewed by the New York Times, "climate justice" is "rooted in the same struggles of imperial-

ism, capitalism – things like that. I think that's very true of this conflict, of the genocide in Palestine.³

Zionism, a disparate nineteenth-century Jewish nationalist movement that contained religious, secular, left-wing, and right-wing elements, has now become syn onymous with colonialism, imperialism, and racism. To be a good, humane, and moral person, the thinking goes, one must be an "anti-Zionist."

Whether this is also anti-Semitic, as some people claim, is not always clear. Opposition to Zionism, or criticism of Israeli policies, is not necessarily anti-Semitic. Denying the right of Israel to exist is certainly hostile, as is the assumption that all Jews are Zionists.

Connecting all forms of oppression has its own academic jargon: "intersectionality." Many students currently demonstrating for Palestine have adopted this line of thinking because they have been taught to do so, mostly by professors at the same institutions against which the protesters are now revolting.

In a sea of competing identity politics there is one marker on which all well-educated members of the liberal left, especially in the US, agree: to be a right-thinking cit izen of the post-slavery, post-colonial West, one must be actively anti-racist, anti-imperialist, and anti-colonialist. That means applying such a lens to all global events, past

and present, including complex conflicts from the US to the Middle East. This worldview might explain why the pro-Palestine protests started at some of the most exclusive American universities: Columbia, Harvard, Yale, Stanford. Intersectionality is not the main preoccupation of working-class people, but instead a mark of the educated elite, whose members are used to thinking of themselves as the collective moral conscience of the Western world.

A certain degree of class guilt about attending the most expensive universities could be contributing to the swell of campus activism, especially in a society where the gap between rich and poor is growing. It is easier to live with privilege when class struggle is replaced by protests against colonialism and racism.

Class does, however, play its part. Rebellions often stem from a fear of privileges slipping. Former US President Donald Trump's demagoguery appeals to relatively uneducated white people who resent that immigrants might be doing better than they are. Something similar is occurring in elite American institutions and other parts of the Western world. Until recently, being a white man from a well-educated family was usually a ticket into the upper echelons of society. But now there is more competition from highly educated non-whites and women for the most sought-after jobs in academia, publishing, museums, journalism, and other fields that require a higher education. This is an entirely positive development. Anyone who believes in inclusivity, diversity, not to mention intersectionality, should applaud it. But the liberal-left ideology that insists on active "decolonization" and ritual confessions of racial privilege can lead to defensive reactions. An increasing number of young white men in Europe and the US are drawn to far-right political parties and slick guru-like figures who promise to teach them how to reassert their masculinity and put women back in their place. That this can also play on prejudices against people of color is obvious. The elite's anxiety about maintaining its privilege can also go the other way, however. Students at the most expensive private universities may see it as being in their interest to demonstrate their intersectional bona fides as anti-racists, anti-imperialists, and anti-colonialists by outdoing minorities in their zeal. It is one way of clinging to leading positions in the intellectual and cultural spheres Perhaps that is why students and faculty at Columbia University showed the way in protesting Israel's war in Gaza, and were swiftly followed by activists at other Ivy League schools. Whether this will really help Palestinians gain their own state, where they can lead better and more dignified lives under a freely chosen government, is unclear. But that may never have been the main point. As is often the case with protest movements in America, this one is really all about the US

LAND AS PRIVATE PROPERTY

n the early seventh century in rural England, the process of territorialisation has played a major role in the transformation of land into private property in its institutionalised form. This transformation was facilitated through implementation of various practices such as surveying, husbandry, and legal frameworks. Rise of territorialisation marked a profound shift in the relationship between communities and the land they inhabited. The transition from communal ownership, often associated with divine commons, to private property rights reshaped

the dynamics of land usage and stewardship. Previously, land had been held collectively, with communities sharing rights and responsibilities for its collective usage and communitarian management. However, as territorialisation

advanced, individual ownership emerged as the predominant form of land tenure. Surveying techniques allowed for the precise delineation of property boundaries, facilitating the demarcation of individual land parcels. Concurrently, advancements in agricultural husbandry practices improved land productivity, incentivising individuals to assert control over specific tracts of land for personal gain. Moreover, legal systems began to recognise and enforce individual property rights, granting landowners exclusive authority over their holdings. This legal framework provided the foundation for the establishment of private property norms, further solidifying the concept of individual land ownership. As a result, the once-shared relationship between communities and the land gradually shifted towards one characterised by private individual rights. This transformation not only altered the economic landscape but also had

profound social and cultural implications, fundamentally reshaping the way people interacted with and perceived their environment.

The process of land privatisation in England did not begin solely in the early seventh century but rather unfolded over several centuries, with significant milestones marking its progression. While territorialisation laid the groundwork for the emergence of private property, it was the Norman Conquest of 1066 that initiated a more pronounced shift towards private ownership of land. The Norman Conquest brought about a restructuring of land ownership, as William the Conqueror redistributed vast tracts of land among his supporters, consolidating power and establishing a feudal system. This redistribution fundamentally altered the landscape of land tenure, with large estates granted to Norman nobles in exchange for military service, effectively privatising formerly communal land.

However, it was not until the pe riod of the enclosures during the 16th century that land privatisation reached its zenith. Enclosure Acts were passed by the English Parliament, allowing landowners to convert common lands into private property by enclosing them with fences or hedges. This

barked on vast imperial projects aimed at expanding their territorial control and extracting re sources from colonised lands. This process involved the imposition of Western legal and administrative frameworks on indigenous societies, often resulting in the dispossession of traditional landowners and the establishment of colonial land tenure systems. 








X users get police notice for posting meme on Mamata

Kolkata, May 8: The Kolkata Police warned of legal action against two users of micro-blogging site X for allegedly posting an "offensive, hateful and inflammatory meme" of West Bengal Chief Minister Mamata Banerjee, a senior officer said.

Two X handles @SoldierSaffron7 and @Shalendervoice - allegedly shared the 'offensive' meme of Mamata Baneriee, he said. The Kolkata Police wrote in the 'reply' box of the posts, "You are directed to disclose your full identity including name and address immediately".

The police have warned that legal action will be taken against them

"It has been observed that you are using social media for posting offensive, malicious and inciting post. Cyber Police Station Kolkata hereby issues notice against you under section 149 of the CrPC" for under posting such a message which can affect the law and order situation, the police said in a notice to the X handlers.

"You are hereby directed to delete the above-mentioned post and also refrain from such acts failing which you will be liable for strict penal action under the relevant provision of law," it added.

Though the post has been removed by @Shalendervoice, @SoldierSaffron7 retained the meme - a video of Banerjee made using artificial intelligence technology.

Condemning the police move, SoldierSaffron7 said in another post. "Those who say there is no democracy under BJP government in India should sometimes visit West Bengal. So much Freedom of Speech in Bengal!"

Kolkata, May 8: Boys outshone girls in this year's Higher Secondary Examination in West Bengal, the results of which were declared Wednesday.

That, despite the number of female examinees far outweighing the number of their male counterparts, which is a commendable feat in itself, at the state's school leaving exams which began February 16 this year and concluded 13 days later.

Announcing the results 68 days after the conclusion of exams, the West Bengal Council of Higher Education authorities confirmed that 89.98 per cent of the students have cleared the test this year.

The performance is a mar ginal jump over last year's pass percentage which stood at 89. Addressing a press conference, **Council President Chiranjib** Bhattacharva said that while 88.18 per cent of girls passed the exams, the corresponding figure for boys stood at 92.12 per cent. This year 7,55,324 students appeared for the Class XII exams.

He said that the Council will look into the reasons behind the success rate of girls dipping by almost four percentage points compared to the boys. Bhattacharva said that 56 per

cent of girls and 44 per cent of boys wrote the papers this year which was a noteworthy change in comparison to the gender ratio a decade ago where 55 per cent boys and 45 per cent girls had appeared for the HS exams.

Of the 58 students who fea tured in the top 10 ranks, 23 were girls, he said, adding that 42.9 per cent of students secured 60 per cent marks or above while 1.23 per cent examinees shone with 90 per cent marks or more in the top bracket. Bhattacharva stated that Purba Medinipur topped the chart among all districts of Bengal in terms of the number of successful candidates

Council President Chiraniib Bhattacharya said that while 88.18 per cent of girls passed the exams the corresponding figure for boys stood at 92.12 per cent

with 95.77 per cent passouts. Avik Das from McWilliam Higher Secondary School in north Bengal's Alipurduar district emerged as this year's HS topper, Bhattacharya declared.

Das, an aspiring astrophysicist. obtained 496 marks out of the maximum 500 which translates to 99.2 per cent. Soumyadip Saha of Narendrapur Ramakrishna Mission Vidyalaya in South 24 Parganas secured the second rank with 495 marks while Abhishek Gupta of Ramakrishna Vivekananda Mission Vidyamandir of Malda clinched third rank with 494 marks, the Council president said.

New Delhi, May 8: The Supreme Court Wednesday said it will not allow either the Centre or the West Bengal government to raise any political issue during the arguments on the state's lawsuit which alleged that the CBI is going ahead with its investigations despite withdrawal of general consent by the state.

A bench of Justices B R Gavai and Sandeep Mehta said it was only deciding a legal issue and the court will not permit either of the parties to make political arguments.

The bench reserved its verdict on the maintainability of the suit filed by the state government.

Senior advocate Kapil Sibal, appearing for West Bengal, argued that once the state had withdrawn its consent November 16, 2018, the Centre can't allow the probe agency to enter the state for investigation.

Solicitor General Tushar Mehta, appearing for the Centre, said the Union government or its departments don't exercise any supervisory control over CBI investigations.

Mehta said while advancing his submissions in the matter May 2, he never went into the political part of it. "We are only on a technical issue, why should

we go into political part," the bench said. The top law officer said this

was a suit and arguments can't go beyond the pleadings. He said Sibal, while arguing the matter May 2, had said once the CBI goes to a state, the Enforcement Directorate (ED) enters, too.

Mehta said ED goes for "counting cash" recovered dur-ing a probe. "We are only deciding a legal issue," the bench observed, adding, "We will not permit either of the parties to raise any political issue".

During the arguments, Sibal referred to the provisions of the Delhi Police Special Establishment (DPSE) Act, 1946 and said, "We (state) have informed your lordships of the cause of action. You can't enter my state without my consent and you can't do it suo motu (on your own)". He said consent of the state government must be obtained for the exercise of power by the CBI."Once I have withdrawn consent. the Union can't allow its investigating agency to come to my state without my consent," Sibal argued.

He said granting consent was a privilege and the power to allow that privilege was vested in the state. In his rejoinder, Mehta said there was no cause_ of action against the Centre in this matter.

with a lesser vote share in the saffron camp kitty.

Some pollsters, though, attribute Congress-backed Chakraborty with the tag of 'dark horse' having "reasonable potential" to wrest this prestigious seat in the northern fringes of Kolkata from the Trinamool if anti-Mamata Banerjee voters chose to tilt towards the Left in larger numbers than expected.

"Dum Dum is among 20 Lok

BJP, BJD in neck and neck fight amid party hopping

Chhatrapur, May 8: BJD and BJP are locked in a close fight for the Chhatrapur Assembly seat in Ganjam district with over 10 candidates in the fray from the constituency even as party hopping sees no let-up.

The Chhatrapur Assembly constituency comprises Chhatrapur and Ganjam blocks as well as the areas under Chhatrapur, Ganjam and Rambha NACs in Ganjam district. The election will be held in this constituency May 13.

BJD's Privanshu Pradhan had won in 2014 election while party nominee Subhash Chandra Behera won in 2019 election from here.

BJD nominee Subhash received 74.594 votes while BJP nominee Prasant Kar garnered 53,543 votes in the 2019 election. CPI nominee Pradip Sethy received 12,766 votes. Subhas was declared the winner with a margin of 21.051 votes.

A total of 1.48.633 voters cast their votes in the 2019 elections out of which 50 per cent went to BJD, 36 per cent to BJP and 8.59 per cent to CPI.

In the 2014 election, a total of 1.38.855 voters cast their votes out



of which BJD's Priyanshu Pradhan received 38.33 per cent of votes, while CPI's Krushna Chandra Nayak and BJP's Dharanidhar Behera received 22.47 and 19.81 per cent votes respectively.

The BJD received a jolt in the NAC election after BJP candidates won the posts of chairperson in Chhatrapur and Rambha NACs. An independent candidate then, who has now joined the BJP, won the post of chairperson in the Ganjam NAC election.

It is evident that the two rivals from BJD and BJP are locked in a close fight. While the BJD aims to score a hat-trick by winning from this seat again, the BJP is pulling out all stops to win this seat after a long gap of 24 years.

The saffron party had last won from this seat in 2000. Long back, the Chhatrapur Assembly constituency was a citadel of leftist Communist Party of India (CPI). However, the Left party slipped to third position in 2019 elections while BJP improved its performance and moved to second spot.

This time BJD has re-nominated its sitting MLA Subhash Chandra Behera. In a surprise

turn of events, BJP has fielded Krushna Chandra Nayak, who was defeated in the 2014 election as a CPI candidate. Prasant Kar defected to BJP from BJD and was fielded as the saffron party nominee in the 2019 elections.

BJP nominated Krushna Chandra Nayak as its candidate after he joined BJP leaving CPI in the presence of Union Minister Dharmendra Pradhan. In this election, Congress has fielded Bhagirathi Behera while Gurunath Pradhan is the nominee of CPI. Lesser known parties like Aam Admi Party (AAP), Kalinga Sena and Bahujan Samaj Party (BSP) have fielded one candidate each while three are contesting as independents from

this seat. However, the political climate here is different from other parts of Ganjam district. Meanwhile, former deputy speaker Rama Chandra Panda has defected from BJD to BJP while the Ganjam NAC chairperson who won as an independent is also now in BJP.

New Delhi, May 8: The Supreme Court Wednesday said cloud seeding or "depending on rain god" is not the answer to the raging forest fires in Uttarakhand and that authorities will have to take preventive measures to tackle the problem.

HD Revanna SC to hear Kejriwal remanded to bail plea tomorrow judicial custody

Bangalore, May 8: Karnataka Home Minister Dr G Parameshwara Wednesday ruled out a CBI probe into the sexual abuse case against the JD(S) MP Prajwal Revanna, who is the NDA candidate from Hassan.

Revanna, son of former Prime Minister HD Deve Gowda, was produced before the court after the completion of four days' police custody.

Also, his bail petition before a sessions court has been posted for Thursday.

Revanna was arrested in the alleged case of kidnapping a woman, based on a complaint by her son, who alleged that the MLA's son and MP Prajwal Revanna had sexually assaulted her. The woman was subsequently rescued, according to police.

The alleged sexual abuse of several women by Prajwal has raised a political storm with the ruling Congress and BJP-JD(S) engaged in a slugfest.

Alleged explicit videos involving Prajwal started making the rounds ahead of the first phase of Lok Sabha elections in Karnataka April 26.

Mumbai, May 8: "What's in a name", the Bombay High Court Wednesday said dismissing a bunch of petitions challenging the Maharashtra government's decision to rename Aurangabad district as Chhatrapati Sambhajinagar and Osmanabad as Dharashiv.

A division bench of Chief Justice Devendra Kumar Upadhyaya and Justice Arif Doctor said the petitions were bereft of merits and the notification issued by the state government (for renaming) does not warrant any interference.

'We have no hesitation to hold that the notification issued by the state government renaming Aurangabad and Osmanabad does not suffer from any illegality or any legal vice,' the bench said.



Quoting William Shakespeare's play Romeo and Juliet, the bench in its judgement said, "What's in a name? That which we call a rose by any other name would smell as sweet.

The bench said Shakespeare made a profound observation on the nature of names, and that a name does not change anything and calling a rose something different would not change the essence of the flower.

The bench in its judgement said the Maharashtra Land Revenue Code permits the state government to abolish any revenue area and to name/rename and alter the name of the area.

The court said it has no hesitation to conclude that the government followed the statutory provisions before taking the decision to rename the two districts and cities.

The HC said it was of the opinion that the issue of alteration of name of a revenue area or even a city or town is not justiciable as courts lack the requisite tool to adjudicate such an issue.

"As to by what name a particular object or place is to be known cannot be judicially reviewed unless the name so proposed is atrocious," the high court said.

In 2022, the Maharashtra cabinet headed by Chief Minister Eknath Shinde approved the name of Aurangabad as Chhatrapati Sambhajinagar and Osmanabad as Dharashiv.

A Government Resolution was passed July 16, 2022 by the two-member cabinet for changing names and then forwarded

to the central government.

In February 2023, the Union Home Ministry gave a no objection letter for changing the names of the cities and districts and thereafter, a gazette notification was issued by the state government changing the names of Aurangabad and Osmanabad.

Several petitions were then filed by Aurangabad residents challenging the government's decision to rename the place as Chhatrapati Sambhajinagar.

Another PIL was filed by 17 residents of Osmanabad against the government's decision to rename it as Dharashiy. Both the petitions termed the government's decision as "politically motivated".

The Maharashtra government had opposed the pleas, claiming the two places were renamed due to their history and not for any political reasons.

Hyderabad, May 8: As many as nine persons, including a four-year old child, were killed in two rain- related incidents here, police said.

Seven persons, including the child, were killed when a retaining wall at an underconstruction apartment came crashing down due to heavy rains in Bachupally area here, police said Wednesday.

C Ramaiah, the Begumpet police inspector, said the deceased were natives of Odisha and were suspected to have fallen in the drain in SR Nagar.

He said the bodies were shifted to a government hospital for autopsy

The country received over \$111bn in remittances in 2022, first country to ever reach that figure, says UN

United Nations. May 8: India received over \$111 billion in remittances in 2022, the largest in the world, becoming the first country to reach and even surpass the \$100 billion mark, the United Nations migration agency has said.

International The Organisation for Migration (IOM), in its World Migration Report 2024 launched Tuesday, said that in 2022, India, Mexico, China, the Philippines and France were the top five remittance recipient countries.

"India was well above the rest, receiving more than \$111 billion, the first country to reach and even surpass the \$100 billion mark. Mexico was the secondlargest remittance recipient in 2022, a position it also held in 2021 after overtaking China, which historically had been the second-biggest recipient after India.'

According to the report's data, India was the top country receiving remittances in 2010 (\$53.48 billion), 2015 (\$68.91 billion), and 2020 (\$83.15 billion), with the remittances crossing the \$100 billion mark to reach \$111.22 billion in 2022

It noted that with a very large number of migrant workers from the subregion, Southern Asia receives some of the largest inflows of remittances globally. Three countries in Southern



Asia - India, Pakistan and Bangladesh, rank among the top ten recipients of international remittances in the world, underscoring the significance of labour migration from the subregion. 'With India estimated to have

received more than \$111 billion in 2022, it is by far the largest recipient of international remittances in the world and the first country to ever reach that figure.' the report said

Pakistan and Bangladesh were the sixth and eighth largest international remittance recipients in 2022, receiving nearly \$30 billion and \$21.5 billion respectively. The report however noted that

while remittances remain a lifeline for many people in the subregion, migrant workers from these countries continue to face a myriad of risks, including financial exploitation, excessive

financial debt due to migration costs, xenophobia and workplace abuses.

The Gulf States remain significant destinations for migrant workers from around the world, and the 2022 football World Cup further underscored the importance of migrant labour to the subregion as well as rights violations.

Migrants continue to comprise high proportions of the total populations in many Gulf Cooperation Council (GCC) States In the United Arab Emirates,

The report added that nearly 18 million or 1.3% of the total population, India is also the origin of the largest number of international migrants in the world, with large diasporas living in countries such as the United Arab Emirates, the United States and Saudi Arabia

Kuwait and Qatar, migrants made up 88 per cent, nearly 73 and 77 per cent of the national populations, respectively.

Most migrants - many of whom come from countries such as India, Egypt, Bangladesh, Ethiopia and Kenva – work in sectors such as construction, hospitality, security, domestic work and retail. India came in 13th as the destination country for immigrants, with 4.48 million.

India – United Arab Emirates, India-US, India-Saudi Arabia and Bangladesh - India were among the top 10 international country-to-country migration corridors, the report said.

Khan's wife moved to jail from house arrest

Islamabad: A court in Pakistan granted a request Wednesday by the wife of former Prime Minister Imran Khan to be moved to jail, her lawyer said, instead of the house arrest ordered by the government. In her petition to the Islamabad High Court, Bushra Bibi had accused authorities of violating her privacy and serving contaminated food in her home cell, which she and her lawyers said was dominated by men, a charge the prison staff has denied. The court ordered authorities to shift her to Adyala jail in the garrison city of Rawalpindi, where Khan, 70, a former cricket superstar, is serving his 14-year sentence, his party said in a statement. Khan was ousted from power in 2022, which he blamed on a conspiracy backed by the military after he had fallen out with powerful army generals.

The US is the largest destination country for international mobile students in the world (more than 833,000), followed by the UK (nearly 601,000), Australia (around 378,000), Germany (over 376,000) and Canada (nearly 318,000). China is also an important

destination for international students, especially those from the Republic of Korea, Thailand, Pakistan and India.

The report said that there are more female than male international migrants in destination countries in Europe and Northern America, such as the US, Canada, France, Spain and Italy, but also in India.

India has a slightly higher share of female immigrants than males. Countries with a significantly high proportion of male emigrants include India, Bangladesh and Pakistan. Irregular migration to the US

remains an ongoing challenge and major policy issue, with increasing numbers of arrivals from atypical origin countries. There were 2.4 million encounters at the United States-Mexico border in 2022, the highest on record.

Ottawa, May 8: Three Indian nationals accused of killing Khalistan separatist Hardeep Singh Nijjar last year have appeared before a Canadian court through video for the first time to face homicide charges in a case that has soured Canada-India relations.

Cairo, May 8: Hamas said it was battling Israeli troops on the outskirts of the Gaza Strip's crowded southern city of Rafah Wednesday after a US official said Washington had halted a shipment of powerful bombs that Israel could use in a fullscale assault.

The United States, which is seeking to stave off an Israeli invasion of Rafah, said it believes a revised Hamas ceasefire proposal may lead to a breakthrough in an impasse in negotiations, with talks resuming in Cairo Wednesday.

Israel has threatened a major assault on Rafah to defeat thousands of Hamas fighters it says are holed up there, but Western nations and the United Nations have warned a full-scale attack on the city would be a humanitarian catastrophe.

Hamas said its fighters were battling Israeli forces in the east of Rafah, where hundreds of thousands of Palestinians have sought refuge from combat further north in the enclave. Residents said the fighting was still on the outskirts

A senior US official said President Joe Biden's administration paused a shipment of weapons to Israel last week in an apparent response to the expected Rafah offensive. The White House and Pentagon declined to comment.

The official, speaking on condition of anonymity, said Washington had carefully reviewed the delivery of weapons that might be used in Rafah, and as a result paused a shipment consisting of 1,800 2,000lb bombs and 1,700 500-lb bombs. This would be the first such

delay since the Biden administration offered its "ironclad" support to Israel after Hamas' October 7 attack. Washington is Israel's closest ally and main weapons supplier.

Israeli forces seized the main border crossing between Gaza and Egypt in Rafah Tuesday, cutting off a vital aid route.

Israel's offensive has killed 34.789 Palestinians, most of them civilians, the Gaza Health Ministry said.

The war began when Hamas militants attacked Israel October 7, killing about 1,200 people and abducting 252 others, of whom 128 remain hostage in Gaza and 36 have been declared dead, according to the latest Israeli figures.

Pro-Palestinian arrests: 33 held

Police began to clear a pro-Palestinian tent encampment at George Washington University early Wednesday and arrested 33 protesters, hours after dozens left the site and marched to President Ellen Granberg's home. Officials at the university in Washington, DC, had warned of possible suspensions for students engaging in protest activities on University Yard. "While the university is committed to protecting students' rights to free expression. the encampment had evolved into an unlawful activity, with participants in direct violation of multiple university policies and city regulations," the university said in a statement.

The ruling comes amid what critics say is an erosion in Hong Kong's rule of law and individual rights in the middle of a sweeping national security crackdown by Beijing that has jailed scores of opposition democrats and shut down liberal media outlets

Hong Kong, May 8: Hong Kong's Court of Appeal Wednesday granted an application by the government to ban a protest anthem called "Glory to Hong Kong", overturning a lower court judgment that had rejected such a ban because of its possible "chilling effects" on free speech.

The case has implications for internet freedoms and the operations of firms including internet

platform operators (IPOs) and technology firms such as Google. Court of Appeal judges Jeremy Poon, Carlye Chu and Anthea Pang wrote that the composer of the protest song had intended it to be used as a weapon.

"In the hands of those with the intention to incite secession and sedition, the song can be deployed to arouse anti-establishment sentiments," the judges wrote.

The judges added that "an injunction is necessary to persuade



Mumbai. May 8: Indian banks' plan to increase their technology spending to around 10% of their operating expenses to keep up with the surge in digital transactions as the central bank intensifies scrutiny on frequent outages, more than half a dozen bankers said.

Banks were earlier spending between 6%-8% of total operating expenditure on technology, sharply below the global average of 10%-12%

However, increased scrutiny of banks' IT systems by the Reserve Bank of India (RBI) over the past year and the recent sanctions imposed on Kotak Mahindra Bank due to technology-related deficiencies are forcing lenders to take the regulator's concerns more seriously.

The RBI has frequently directed banks to reduce tech-related glitches that disrupt customers' ability to transact, five bankers said, declining to be identified as they are not authorised to speak to the media.

As operating expenses have grown over the years, Kotak Mahindra Bank spent "significantly" more on technology, Ashok Vaswani, MD and CEO of Kotak Mahindra Bank, said in a post-earnings press conference.

However, "what is evident, is that our efforts have fallen short

actions. "Please refer to provisions of Section 269SS of Income Tax Act, 1961, which stipulates that no individual can receive more than ₹20.000 as loan amount in cash." the letter showed.

The letter has been sent in the aftermath of action against non-bank lender IIFL Finance. which was found to be in violation of several rules, including those on disbursal and collection of loans in cash in excess of the statutory limit.

India now world's 3rd largest solar power generator

INDIA RANKED NINTH IN SOLAR ENERGY DEPLOYMENT **IN 2015**

New Delhi, May 8: Rapid solar energy deployment in India pushed the country past Japan to become the world's thirdlargest solar power generator in 2023, according to a new report.

The report by global energy think tank Ember said India ranked ninth in solar energy deployment in 2015. Solar produced a record 5.5

per cent of global electricity in

2023. In line with the global trend, India generated 5.8 per cent of its electricity from solar last year, as reported in Ember's "Global Electricity Review'

India saw the world's fourthlargest increase in solar generation in 2023 (+18 terawatt hour or TWh), behind China (+156 TWh), the United States (+33 TWh) and Brazil (+22 TWh). Together, the top four solar growth countries accounted for

75 per cent of growth in 2023. Ember said the global solar generation in 2023 was more than six times larger than in 2015. Solar's contribution to elec-

tricity generation in India increased from 0.5 per cent in 2015 to 5.8 per cent in 2023 According to the International

Energy Agency's (IEA) "Net Zero Emissions" scenario, solar would increase to 22 per cent of global electricity generation by 2030.

With electricity generation accounting for nearly half of India's annual carbon dioxide emissions (1.18 gigatonne in 2023), accelerating the transition to cleaner generation sources is imperative for the country to meet both its developmental and climate goals.

As part of its national plan to fight climate change, India has committed to achieving 50 per cent cumulative electric power installed capacity from non-fos-

sil fuel-based energy resources by 2030.

At the United Nations' COP28 climate change conference in December last year, world leaders arrived at a historic agreement to triple the global renewable energy capacity by 2030.

The IEA says tripling the global RE capacity and doubling energy efficiency are crucial to limiting the average temperature rise to 1.5 degrees Celsius, a political target set in 2015 to prevent further worsening of climate impacts.

India is one of the few countries planning to triple renewable capacity by 2030. According to Ember's analysis, annual capacity additions need to significantly increase for India to meet this capacity target.











DORTMUND END PARISIANS' LONDON DREAMS Mbappe trudges off after aspirations of CL title with PSG ends

German club march into Champions League title clash

Paris, May 8: London's calling, but not for Kylian Mbappe. When Borussia Dortmund's players rushed over to their fans wearing yellow "London 24" T-shirts and joined in the celebrations after knocking out Paris Saint-Germain to reach the Champions League final Tuesday, Mbappe had long left the field.

Wembley Stadium June 1 is the final stop on Dortmund's quest for the Champions League trophy, by which time Mbappe will have played his last game for PSG having failed to win the trophy the club's cash-rich Qatari owners so crave.

Central defender Mats Hummels headed Dortmund into the final as the German team won 1-0 at PSG. Moments after Warren Zaire-Emery missed an open goal for the Parisians. Hummels rose unchallenged to head in Julian Brandt's corner from the left in the 50th minute. Dortmund advanced 2-0 on ag-

gregate and largely contained Mbappe, who is leaving at the end of the season. PSG exerted late pressure. Goalkeeper Gregor Kobel palmed away Mbappe's low shot, then pushed Mbappe's deflected close-range effort onto the crossbar with a superb onehanded save. The Parc des Princes crowd groaned when midfielder Vitinha's thumping 25-meter strike rattled the woodwork.

Coach Edin Terzic's team will play either record 14-time champions Real Madrid or six-time winners Bayern Munich June 1 at Wembley Stadium.

Coach Luis Enrique's players seemed nervous, playing cautiously and defending too deeply in the first half, allowing Dortmund to settle into a comfortable rhythm. Mbappe was ineffective in attack when PSG lost the first leg and, despite their speed, Mbappe and Ousmane Dembele struggled to find space behind a well-organised Dortmund defence.

PSG president Nasser Al-Khelaifi pointed to the amount of times PSG hit the post or crossbar over both legs. But in reality PSG again fell short, despite boasting one of the world's best players in Mbappe.

Paris, May 8: Kylian Mbappe leaned forward with his head bowed and hands on his thighs. Another Champions League dream with Paris Saint-Germain was over, ruined by the ruthless efficiency of a Borussia Dortmund team that stopped him scoring in both legs of their Champions League semifinal and recorded a 1-0 win in each.

PSG coach Luis Enrique consoled Mbappe, and then his star striker trudged off the field and toward a new destination next season.

Mbappe didn't address questions about his future. Most observers expect his next club to be Real Madrid, which leads PSG 14-0 in European Cup trophies and could add a 15th should it get past Bayern Munich Wednesday in the other semifinal.

Madrid has tried to lure Mbappe before. In 2021, PSG turned down a bid of 180 million euros (USD 194 million) from Madrid for the 2018 World Cupwinning forward, who went on to sign a new contract with PSG — on which he didn't take up the option for an extra year. Earlier this year he told PSG he's leaving at the end of the season.

Seven years ago, he joined amid huge hype as the best young player in France and maybe the world. PSG paid a fee of 170 million euros (USD 183 million) when Mbappe joined from Monaco in the summer of 2017 along with Neymar, who cost a world record 222 million (USD 239 million).

Others once on the list of PSG stars included Zlatan Ibrahimovic (156 goals for the club), Edinson Cavani (200 goals for PSG) and Lionel Messi (the men's record eighth-time Ballon d'Or winner). None could win the Champions League with PSG, despite huge investment and massive wages.

We always want to win at PSG, we feel sad. I tried to help my team the best I could. It wasn't enough. When you're talking about efficiency at both ends, I think I'm the first in question. I'm the one who should score the goals and make the difference. I have no problem with that, the first person who should have scored tonight is me

'Tweet' revenge exacted

B orussia Dortmund have used PSG's social media post from four years ago to mock the French club after knocking them out of the Champions League at the semifinals stage. After confirming their place in the final, Dortmund evidently hadn't forgotten PSG's tweet after the round of 16 clash between the two sides in 2020. In that tie Dortmund won 2-1 in the first leg but PSG won 2-0 in the second leg in Paris to prevail with a 3-2 aggregate victory. Following PSG's win in 2020 they posted a tweet which included the caption 'and breathe' accompanied by a picture of the PSG squad including Kylian Mbappe mimicking Erling Haaland's famous meditation celebration. After their win Tuesday night, Dortmund had the last laugh as they quoted the tweet and posted: 'Tastes like fine wine'.

New Delhi, May 8: Olympic and World Champion javelin thrower Neeraj Chopra will compete at home for the first time in three years after confirming participation in the National Federation Cup to be held in Bhubaneswar from May 12 to 15.

The 26-year-old superstar is expected to travel to India from Doha after opening his season in the first leg of the prestigious Diamond League series May 10. "As per entries @Neeraj_chopra1 and Kishore Kumar Jena will compete in domestic competition starting May 12 in Bhubaneshwar," the Athletics Federation of India tweeted.

Chopra's coach Klaus Bartonietz also confirmed to PTI that his ward is taking part in the Bhubaneswar event. As per the schedule that came out Wednesday, the men's javelin qualifying round will be held May 14 and the final will take



place May 15.

The 28-year-old Kishore Jena, who won a silver in the Hangzhou Asian Games where Chopra won gold, will also be competing in the Doha Diamond League May 10. Chopra last took part in a domestic competition at the same event March 17, 2021, when he won a gold with a throw of 87.80m.

Since then, Chopra has won a historic gold in the Tokyo Olympics, became Diamond League champion in 2022, World Champion in 2023 and defended Asian Games gold in China. He also won three individual legs of Diamond League and claimed a silver in the 2022 World Championships.

Hyderabad, May 8: The remorseless domination of Travis Head and Abhishek Sharma, who carved lightning fast fifties, helped Sunrisers Hyderabad mount the fastest chase of a 160plus target en route their convincing 10-wicket win over Lucknow Super Giants in the IPL match here Wednesday.

Chasing a modest target of 166, Head (89 n o, 30b, 8x4, 8x6) and Sharma (75 n o, 28b, 8x4, 6x6) toyed with LSG bowlers, finding boundaries and sixes at will to canter home in just 9.4 overs.

The win propelled SRH to the third position in the standings with 14 points from 12 games, while LSG are struggling at the sixth spot with 12 points from the same number of matches.

The result also meant that five-time champions Mumbai Indians, currently ninth with eight points from 12 matches, are out of the playoff race. The Head and Sharma show came after SRH bowlers started bril-



liantly before losing the plot a bit. Ayush Badoni (55 n o, 30b, 9x4) and Nicholas Pooran (48 n o, 26b, 6x4, 1x6) stitched crucial 95-runs off 55 balls for the unbeaten fifth-wicket stand to guide LSG to a competitive 165/4 on a sluggish pitch.

But the Head and Sharma took any hint of competition out of the match once they bludgeoned 107 runs in the powerplay. It was an awesome hitting display from the IndoAustralian pair as they didn't spare a single LSG bowler, clobbering them to all parts of the ground.

Earlier, LSG were struggling at 27/2 at the end of the powerplay after opting to bat. The visitors lost Quinton de Kock off Bhuvneshwar Kumar (2/12) in the third over.

Bhuvi struck again in the fifth over, dismissing the dangerous Marcus Stoinis but the credit for the dismissal should go to

stunning diving catch just inches from the ground at mid-on.

The pitch also didn't help LSG's cause as the ball was coming on to the bat a bit slow, as their batters found it difficult to find the timing. Skipper KL Rahul (29) struggle came to an end in the 10th over off Pat Cummins. Then Cummins' direct throw from mid-on sent Krunal Pandya (24) packing soon before Badoni and Pooran stitched together 99 runs taking LSG to what looked like like a competitive total.

Paris, May 8: Diego Maradona's Golden Ball trophy from the 1986 World Cup has resurfaced. The award, which had been missing for decades, will be auctioned in Paris next month, the Aguttes house said.

Maradona, who died in 2020 at age 60, was awarded the trophy for his scintillating play at the tournament, where he captained Argentina in their 3-2 win over West Germany in the final in Mexico City. The auction house said it expects the trophy "to fetch millions due to its uniqueness.

Maradona received the award -given to the tournament's best player — at a ceremony at the Lido cabaret on the Champs-Élysées in 1986. It subsequently disappeared, giving rise to rumors.

Some say it was lost during a wild poker game, or sold to pay off debts, Aguttes said. Others said Maradona had stored it in a safe in a Naples bank that was robbed by local gangsters in 1989, when he played in the Italian league. According to the story told by a reformed member of the mafia, the trophy was then melted down into gold pieces.

"A far-fetched theory, given that it was made of a gold-copper alloy," Aguttes said in its auction catalogue. Aguttes said the trophy reappeared in 2016 among other lots that were acquired from a private collection at auction in Paris. "It was thoroughly investigated and authenticated as Diego Maradona's Adidas Golden Ball trophy," Aguttes said. Bidders will be asked to make a deposit of 150,000 euros to participate in the June 6 auction.

Fans now have a day to celebrate world's most popular sport, May 25

United Nations, May 8: Football fans around the world will now have a day to celebrate the world's most popular sport every year -May 25. The United Nations General Assembly adopted a resolution Tuesday proclaiming May 25 as 'World Football Day'

The day marks the 100th anniversary of the first international football tournament in history with the representation of all regions which took place May 25, 1924 during the summer Olympic Games held in Paris, according to the resolution. The 193-member General Assembly adopted the resolution by consensus with a bang of

the gavel by its president, Dennis Francis, to applause from diplomats in the assembly chamber. It was co-sponsored by more than 160 countries.

Libya's UN Ambassador Taher El-Sonni, who introduced the resolution, told the assembly, "Football or football as others call it is the number one game played and followed around the globe." But he stressed that football is more than just a game played by all ages on streets, in villages, schools and courtyards for fun and in competitions.

Because of its "unparalleled position" in the world of sports, El-Sonni said, "football serves as a universal language spoken across the globe, cutting across national, cultural and socio-eco-

nomic barriers."

He said the game has become "a pivotal platform" championing gender equality and social inclusion, "a common ground where individuals from varying backgrounds converge, promoting mutual understanding, tolerance, respect and solidarity.

The resolution acknowledges "the global reach of football and its impact in various spheres, including commerce, peace and diplomacy, and recognizing that football creates a space for cooperation.'

It also recognizes "the fundamental role" of football's international governing body, FIFA, and the important role of regional and national football federations, as well as relevant as-
