Waqf fire spreads

(Amendment) Act spread to newer territories in the country Sunday as hundreds fled West Bengal's strifetorn Murshidabad district, where three persons have already been killed in clashes so far, to take shelter in the adjoining Malda by crossing a river. Bengal police claimed to have arrested a total of 150 persons in connection with the communal riots amid demands by Opposition BJP to declare four districts as 'disturbed area' under AFSPA. The spiral of violence hit Assam during the day when around 400 protestors pelted stones at and clashed with the police during a rally against the Act in Cachar district, prompting police to resort to lathi-charge. Meanwhile, the All India Muslim Personal Law Board (AIMPLB) announced to conduct a protest meeting against the Act in Hyderabad April 19. The protests stem from the fear that Act would dilute the rights of Muslims to manage religious endowments of lakhs of acres of prime land across the country.

Bhubaneswar, April 13: Hundreds of people affected by communal violence in West Bengal's Murshidabad have crossed the Bhagirathi River and taken shelter in adjoining Malda as 12 more people were arrested in connection with the violent protests over the Waqf (Amendment) Act in the district Sunday where three people have died

Paramilitary forces patrolled parts of Murshidabad district which witnessed violent protests Friday and Saturday over the issue as the situation remained tense but under control, while political parties



traded charges for aggravating the situation.

West Bengal Governor CV Ananda Bose said he is holding regular discussions with Chief Minister Mamata Banerjee while the Centre is monitoring the situation in the district.

"The situation in Suti, Dhulian, Samserganj and Jangipur areas of the district is peaceful. Raids continued overnight, and 12 more people were arrested. With this, 150 people have been arrested so far," a senior police officer said.

Prohibitory orders under Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) have been imposed in the violence-hit areas, and the internet has been suspended, he said.

Following the exodus of hundreds of people to Malda, the local administration has arranged for accommodation and food for the riot-hit families and sheltered them in schools, while deploying volunteers at the river bank to assist those arriving in boats.

BJP's Purulia MP Jyotirmay Singh Mahato has written to Union Home Minister Amit Shah urging the Centre to declare select bordering districts of West Bengal as 'disturbed areas' under the Armed Forces (Special Powers) Act (AFSPA), alleging repeated attacks on the Hindu community.

Meanwhile, protestors threw stones while the police used batons at a protest rally in Cachar district of Assam.

A senior official said that several hundred people hit the streets in Berenga area of Silchar town without permission to protest the recently enacted legislation.

"Around 300-400 people were protesting by blocking the road. When we tried to clear the path, a few of them threw stones at us. We had to use mild lathi-charge to disperse the crowd," he added.

The All India Muslim Personal Law Board (AIMPLB) said it will conduct a protest meeting against the Act in Hyderabad April 19, AIMIM president Asaduddin Owaisi said Sunday.







8 killed in AP cracker unit blast

Visakhapatnam, April 13: Eight people, including two women, were killed and at least seven others injured in a powerful explosion at a firecracker manufacturing unit in Anakapalli of Andhra Pradesh Sunday.

The explosion occurred around 12.45pm at Kotavuratla village and the injured were shifted to hospitals.

Prime Minister Narendra Modi expressed grief over the incident. In a post on 'X', he said, "Deeply saddened by the loss of lives in a factory mishap in Anakapalli district of Andhra Pradesh. Condolences to those who have lost their loved ones. May the injured recover soon.

The local administration is assisting those affected".

He said, "An ex-gratia of Rs 2 lakh from PMNRF would be given to the next of kin of each deceased. The injured would be given Rs 50,000."

"Eight people, including two women, died and seven others were injured in the fire accident." Andhra Pradesh Home Minister V Anitha told PTI.

The blast ripped through the licensed crackers manufacturing unit functioning under an asbestos roof, where 15 people were reportedly present. Charred body parts were scattered around, making identification difficult, an eyewitness said. Meanwhile, postmortem of the five deceased is underway at a local hospital in Nar sipatnam and three more at Anakapalle district hospital, said an official statement.

Out of the six injured persons referred to King George Hospi tal (KGH) in Vizag, four have recovered, while two remain in critical condition. Two more are recovering at a Narsipatnam hospital, it said.

AP Chief Minister N Chandrababu Naidu expressed shock over the incident and directed Home Minister Anitha and district officials to ensure proper medical care for the injured.

He also ordered a probe into the incident. The state government has announced an ex-gratia of Rs 15 lakh to each of the deceased family.

Toddler abducted from mother in City

Bhubaneswar, April 13: In a shocking incident, a 19-month-old toddler was abducted from his visually-challenged mother by unidentified miscreants from a place outside Ram Mandir here in the early hours Sunday.

Significantly, the incident occurred just 200 metres away from the Kharvelnagar police station. IIC of the police station, Rajanikanta Mishra, said they were still to make any headway in the case or establish the identity of the abductors.

The child's mother, Jayanti Mallick, 25, who survives by begging and lives at a shelter home in

Niladri Vihar, lodged an FIR at Kharvelnagar police station later in the day. In the FIR, she said Saturday night she failed to return to the shelter home owing to severe body weakness. "Therefore, I decided to sleep near the temple along with my son, Subham, who I was carrying with me,' she said.

Jayanti said when she woke around 1.20am, she found her son missing from her arms. "I suspect some miscreants loitering in the area had taken him away," she said in the FIR.

Jayanti, a widow, is also the mother of a seven-yearold daughter. She lost her husband a few years ago to an accident.

Meanwhile, Mishra said that a case has been registered under Section 137(2) of the BNS. "We are scanning CCTV footage from the surrounding areas, and a hunt is on to trace the accused and rescue the toddler," he said.





SENATE COMPRISING 68 MEMBERS WILL BE REINTRODUCED IN UNIVERSITIES

Bhubaneswar, April 13: With Governor Hari Babu Kambhampati giving his assent, the Odisha University (Amendment) Act, 2024 has come into effect from Sunday marking a significant reform in the state's higher education

The Bill was passed April 2 after extensive deliberation in the Odisha Assembly and got the Governor's assent April 12.

Expressing his gratitude to the Governor, Higher Education Minister Suryabanshi Suraj described the development as a 'new dawn' for higher education in the state. He said the Act will bring transformative changes aimed at strengthening the education system, addressing longstanding challenges and enhancing academic excellence.

"The Act aims to bring about substantial reforms, ensuring

The new Act also ensures the reintroduction of the senate in universities. The senate is the highest advisory body of a university, comprising educationists, faculty, students and administrative staff and plays a vital role in the development of the university and the higher education sector.

As per the Act, each university will have a senate that will meet at least twice a year. The senate will consist of 68 members, out of which a minimum of 37 members will be from among teachers, educationists, and student representatives, ensuring a balanced and inclusive representation.

The minister said distance education system will be introduced in every university to provide access to quality higher education for all and to enhance the Gross Enrolment Ratio (GER) in the state.

A finance committee will be constituted for strengthening financial management in universities. Proposals have been made to establish building and construction committees for reviewing and monitoring infrastructure development

All funds received or acquired by the universities will be audited by the Comptroller and Auditor General of India. and detailed financial reports will be presented before the Odisha Legislative Assembly, he said.

The Higher Education minister said that the Act also ensures a robust foundation and strengthened education system. "The Act will also contribute to the growth of a knowledge-driven economy in the state," he said.

rogation that the NIA learnt about Rana. And the corroboration came during Headley's virtual deposition in the special NIA court in Delhi from inside a US prison, where he is serving a 35-year jail term following his plea bargaining in the 26/11 case.

"Even if we had known about Rana during our probe, we couldn't have done much to facilitate his extradition as Central agencies like NIA are better placed to handle global hunts," Mahale admitted.

Asked if the circumstantial and oral evidence would be enough to prove Rana guilty in

material proof, Mahale said, "I think, we have gathered enough to nail him. The investigators just need to join the dots.'

Interestingly, Mahale preferred to leave it to destiny when asked if the agencies would ever succeed in bringing the masterminds of the carnage, Hafiz Saeed and Zaki-ur-Rehman Lakhvi, to justice. "It appears difficult given the fact that Pakistan cared little about sharing Dawood Ibrahim with us in the last 40 vears. However, on the brighter side, there are possibilities they could meet the same fate like the Khalistani terrorists in Canada, or other anti-India forces elsewhere in the world, these days.'

Rana is said to have collab orated with others, including key conspirator David Coleman Headley alias Dawood Gilani, in the criminal plot aimed at carrying out the terrorist attack. Investigators have found that Rana had visited Mumbai and lived in a hotel, where he held several rounds of discussions with Headley, ostensibly to further the 26/11 attack plans. They are also said to be in possession of the minutes of Rana's visit, including some crucial CCTV footage of the hotel lobby where he met Headley.

Rising divorces reflect changing societal norms

Bhubaneswar, April 13: Divorce, which was once considered a taboo subject in Indian society, has become increasingly common, particularly in urban areas. Over the last decade, a combination of shifting societal attitudes, heightened legal awareness, and evolving gender dynamics has contributed to the growing prevalence of marital separations. According to the National

Family Health Survey (NF-HS-5), while divorce and separation rates are still relatively low compared to global standards, they have seen a noticeable increase in metropolitan cities, with rates more than doubling in the past ten years.

Sangita Majhi, an advocate and mediator who serves as the state head of the Mediators Council of India in Delhi, explained that the perception of divorce has undergone a significant transformation. "In the past, divorce was often seen as a last resort, something that

people would only consider in extreme circumstances. Today, however, it is increasingly viewed as a way to reclaim emotional well-being and personal freedom," she said.

She further added that couples are now less willing to compromise, and small, unresolved disputes tend to snowball into larger issues, ultimately leading to separation. Factors such as growing financial independence, a lack of communication, and the burden of ego play significant roles in these developments.

This shift in attitudes has also been reflected in the high-profile separations of well-known personalities, which further underscore the

change in public perception. For instance, recent speculations about the personal life of boxer Mary Kom have garnered considerable attention. "When prominent celebrities, from cricketers to actors, publicly experience divorces, it sends a strong message to society. This has made many



men apprehensive, especially about the potential for false allegations and hefty alimony, remarked Ramesh Jaiswal, a businessman

Legal experts are increasingly vocal about the implications of the existing legal framework surrounding divorce. Byomakesh Tripathy, an advocate at the Orissa High Court, highlighted that while the awareness of women's rights has increased, there are also concerns about the misuse of

legal provisions.

'The legal landscape is evolving, and women's empowerment is a positive development. However, there has been an uptick in the misuse of certain provisions, which complicates matters," Tripathy said.

Another High Court advocate Sejal Nayak added that divorce in India can be filed on various grounds such as cruelty, adultery, or prolonged separation. While mutual consent divorces under Section 13B are generally smoother, issues like alimony continue to raise concerns.

For younger generations, especially women, the growing trend of divorce is closely tied to the rise in women's empow-

Postgraduate student Gayatri Das from Bhubaneswar noted, "Today, women place a higher priority on their independence and self-respect. If a marriage becomes abusive or unsustainable, divorce is often viewed as the best option.'

However, while divorce has become more common, Sangita Maihi cautioned against normalising it as a trendy solution. "Marriage requires effort and emotional maturity. Many of the cases I counsel stem from misunderstandings or ego clashes that could be resolved with proper communication,' she remarked.

"Divorce should never be seen as a fashion statement. It not only affects the couple but also their families and children" she concluded.

Middlemen exploit tribal mahua flower harvesters

Bhawanipatna, April 13: Tribals in Kalahandi district continue to be exploited by middlemen who buy mahua flowers at significantly lower prices than the government approved minimum support price (MSP), a report said.

Despite the official MSP of ₹25 per kg, desperate members of various tribal communities often resort to distress sale. They settle for half the rate due to a lack of proper market access and storage facilities, and absence of intervention by the district administration and the government, reports added.

The Union Ministry of Tribal Affairs has fixed MSPs for 72 minor forest produce items, including mahua flowers. Accordingly, the panchayat authorities have also fixed the MSP at ₹25 per kg.

However, in the absence of a regulated market system in Kalahandi district, tribal collectors are forced to sell their harvest for as little as ₹10 to ₹15 per kg. Limited storage infrastructure and the absence of procurement by women's self-help groups (SHGs) exacerbate the issue.

Government guidelines mandate SHGs to purchase mahua flowers at MSP, but its implementation remains lacking in the district. Additionally, authorities have not taken ac-

tion against middlemen who stockpile the produce without facing inspections from the excise department.

For many tribal families, collecting mohua flowers is a primary source of livelihood. Yet, without fair compensation, their sustenance remains precarious and uncertain. The lack of government intervention has left them vulnerable to exploitation. Villagers have expressed frustration over the unregulated practices that benefit middlemen while they continue to struggle for survival.

Local residents are calling on authorities to enforce MSP regulations, ensure timely procurement by SHGs, and conduct regular inspections to curb illegal hoarding by middlemen. Until then, tribal communities remain at the mercy of a system that undermines their economic well-being, it is alleged.

The Odisha government earns billions in revenue from alcohol, with a sharp increase in liquor shops in Kalahandi district. The district has emerged as the state's top contributor in revenue earned from liquor sale. However, the surge in alcohol sales comes at the expense of local tribal communities who collect and sell mahua flowers, a key ingredient in traditional liquor production.

Tribals in Junagarh, Golamunda, Thuamul Rampur,

Madanpur Rampur, Koksara, Jaipatna, Lanjigarh, Kalampur, and Narla blocks, and also in the hilly terrains, hundreds of tribal families rely on mahua collection for their livelihood during the three-month harvesting season. Despite their efforts, they often fall victim to predatory pricing by local alcohol brewers who purchase mohua at minimal rates, local social activists alleged.

These illicit brewers employ intermediaries to buy large quantities of mohua at low prices, exploiting the absence of regulated markets. While government records may show lawful procurement, the reality is often different, with paperwork used to cover up unethical practices, they added.

Furthermore, the quality of locally produced liquor has declined, as brewers frequently use synthetic substitutes instead of authentic mahua, eroding the traditional essence of the drink.

Although there have been discussions about forming committees comprising panchayat representatives and government officials to regulate the procurement and sale of mahua, implementation remains elusive. The establishment of a fair pricing mechanism and licensing system for buyers is yet to materialise.

Social activists like Pratap Biswal and Saul Mangaraj emphasied the need for immediate government intervention to protect tribal livelihoods. They urged the administration to enforce fair trade practices and ensure that mahua collectors receive a just price for their labour.

Without prompt action, the unchecked growth of alcohol revenue will continue to come at the cost of the state's marginalised communities, they claimed.

Guv watches seaward journey of turtle hatchlings

Berhampur, April 13: Governor Hari Babu Kambhampati witnessed the rare sight of Olive Ridley turtle hatchlings making their way to the sea at Rushikulya river mouth during his visit to Ganjam district Sunday. He also reviewed various developmental projects being implemented in the district.

Kambhampati, along with his wife Jayasree, visited Sipakuda near Rushikulya River mouth early in the morning and witnessed thousands of hatchlings emerging from sandy pits and crawling towards the sea.

He was apparently amazed to see the baby turtles break out

the sea without parental care.

Female Olive Ridley turtles return to the deep sea after laying eggs in the rookery, while hatchlings emerge after 50 days. "Visited Sipakuda in Ganjam district, a key nesting site for the endangered Olive Ridley turtles. Witnessing the mass nesting and hatching truly awe-inspiring experience," the Governor said in a post on X.

During his visit, he reviewed conservation efforts with local officials and emphasised the importance of community involvement to ensure the species' long-term survival.

He also praised the dedication of the district administration, forest staffers and local volunteers for their work in protecting the species.

Mass hatching of the Olive Ridley turtles in the rookery started Thursday along a fivekm stretch of the beach from Podampeta to Bateswar, near Ganjam town.

The mass hatching is expected to continue for the next two to three days, Berhampur Divisional Forest Officer (DFO) Sunny Khokkar said.

Though the exact number of hatchlings emerging from the sandy beach has not yet been estimated by the forest officials, they have expected a record number of hatching as a record 9 lakh Olive Ridley turtles have

laid eggs in the rookery.

While 6,98,698 Olive Ridley turtles had laid eggs on the beach in the first phase of mass nesting from February 16 to 23, over 2.05 lakh turtles had laid eggs along the same stretch in the second phase of mass nesting from March 22 to 27.

Elaborate protection measures have been taken to save the baby turtles, while local volunteers have extended their helping hands to the forest staffers, Assistant Conservator of Forests, Khallikote range, Dibva Sankar Behera, said.

Volunteers were seen collecting baby turtles, which lost their way on the beach and released them into the sea.

THAI SACBROOD VIRUS SPREAD

Horticulture, agri officials inspect beehives in Koraput

Nandapur, April 13: A day after a report in this newspaper highlighted alarming death of honeybees due to the outbreak of Thai Sacbrood Virus (TSBV) in Koraput district, the district administration has launched a swift response to tackle the spread of the virus.

The report titled "Honeybees disappear from Plateau" appeared in April 13 edition of **Orissa POST**, highlighted the growing presence of TSBV in honeybee colonies – whether kept in manmade hives or naturally found in tree hollows and rocky crevices. The bees are vanishing at an unprecedented rate due to spread of TSBV, a highly contagious viral disease.

Directed by Koraput Collector V Keerthi Vasan, horticulture and agriculture officers visited several villages including Nandapur, Bisapur, Marada, Nalachua, Debagandhana,

Banamaliput, Malipungar, and Kandhapungar villages to assess the condition of the infected beehives Sunday.

The Collector has reportedly informed state-level officials and OUAT authorities in Bhubaneswar about the concerns raised by the farmers. A delegation is expected to visit the district soon to inspect the infected bee boxes and discuss solutions with local beekeepers, he said.

The officials examined the affected hives, spoke to the affected farmers, and investigated the source of the disease and possible import of infected bees.

The team included Horticulture Officer M Suresh Pattnaik, Assistant Horticulture Officer Archana Priyadarshini, and Agriculture Officer Sabita Kuldeep, among others. They held consultations with several farmers and provided them with necessary guidance to contain the spread of the disease.

Further monitoring by state entomologists and the Collector is expected shortly.

The farmers also submitted a memorandum containing their three-point charter of demands to the visiting team demanding immediate steps to prevent the spread of the infections.

In the memorandum, the farmers urged officials to ban the import of bees, bee boxes, and related equipment from coastal areas for the next three years in light of rising infections. They also called for restrictions on institutions that have distributed infected bees in the past.

History-sheeter hurt in encounter

Sambalpur, April 13: A man with criminal antecedents was injured in an encounter with police in Sambalpur district Sunday, an officer said.



Sex ratio of newborn turtles tilts towards females: Study

Kendrapara, April 13: Sex ratio of newborn turtles at Rushikulya nesting site in Ganjam district tilts towards females, according to a research work on Olive Ridley sea turtles.

The research work titled 'Monitoring Sea Turtles in India 2008- 2024' was a joint endeavour of the Indian Institute of Science (IIS), Bengaluru and Dakshin Foundation, Bengaluru.

The research paper recently published throws light on such biological attributes and gender ratio of turtles sighted on the Odisha coast, said BC Chaudhury, turtle biologist and former scientist of Wildlife Institute of

India (WII), Dehradun.

The newborn gender ratio at Rushikulya nesting site was found to be



heavily tilting towards females at 71 per cent. The research is, however, yet to cover the turtles at the Gahirmatha nesting site, widely regarded as the world's largest rookery of Olive Ridley sea turtles.

The study on the migratory behavioural instinct of sea turtles along the Odisha coast has found that these delicate marine animals, which are

conferred endangered status because of dwindling population worldwide, do not travel far off as it was being speculated.

While some of the turtles remain in the offshore sea waters of Odisha, others migrate to Sri Lanka and the Gulf of Mannar as per the post-nesting migration study of Olive Ridley sea turtles in India initiated by WII and Odisha Forest department, Chaudhury stated.


The mass-nesting of Olive Ridley sea turtles, otherwise called arribada, is an annual ritual that takes place at Gahirmatha, Rushikulya and Devi river mouth beaches in Odisha.

Unlike humans, sea turtles do not have sex chromosomes. Their sex is determined by the temperature of the sand where their eggs incubate, a phenomenon called temperature-deendent sex determination (TSD).

Being polygamous male sea turtles can mate with a maximum of two to three female turtles for which falling numbers of male turtles will be a disaster for the turtle population, he said.

An Olive Ridley usually lays about 120 to 150 eggs from which hatchlings emerge after about 45 to 50 days. But not all eggs remain intact as predators devour it. Besides, eggs are also washed away by sea waves during high tide. The eggs are incubated in the nest and grow, sans mother, to emerge as hatchlings.

This year, more than six lakh turtles had invaded the beach at Gahirmatha to lay eggs while the rookery at Rushikulya in Odisha played host to seven lakh turtles for en-masse nesting.

Aadhaar Again

he Government of India is testing a new Aadhaar app that combines face ID authentication with artificial intelligence (AI), enabling citizens to access digital Aadhaar services on their mobile devices. Developed by the Unique Identification Authority of India (UIDAI), the app features QR code-based instant verification and real-time facial recognition for authentication.

Aadhaar, which was launched fifteen years ago, assigns Indian residents a unique 12-digit ID number linked to biometric data, including fingerprints and retinal scans. Aadhaar was introduced by the Congress-led UPA government with the goal of streamlining the distribution of welfare benefits to those in need. Initially marketed as a voluntary programme, it has effectively turned into a forced necessity for anyone wanting to lead a normal life in India. Today, the ubiquitous Aadhaar is required for almost all activities -- opening a bank account, obtaining a SIM card, checking into a hotel, travelling or even shopping. Most people are unaware that there exist alternatives so everyone takes the 'easy path' and falls into the trap. However, the problem with linking a diverse range of services to a single ID number is that it increases the risks associated with security breaches, a specialized threat about which most educated Indians are completely ignorant since privacy has never, historically, been an issue in our society.

Critics argue that Aadhaar is fostering a digital economy primarily designed to benefit businesses. While unsuspecting individuals are often willing to share their information in exchange for convenience, it is important to recognise that they are also sacrificing their privacy. This leads to surveillance over almost all aspects of their lives. The most vulnerable members of society are particularly affected, as they may lose access to benefits due to issues like fingerprint mismatch or their own name or even their father's name misspelt, leaving them with little recourse for assistance. Those affected are particularly among the uneducated, manual labourers and senior citizens struggling to confirm their fingerprints and retina scans. Add to this the loss of a mobile phone that could put the person concerned to great hardships. And God help if the mobile number linked to a citizen's Aadhaar is somehow deactivated! Then of course there always looms the danger of internet or simply power outages which could throw the lives of millions into a downward spiral. A very recent case was observed on 26 March, 2 April and 12 April when the nation was pushed into a limbo because the UPI system of money transaction dropped dead throughout India.

Concerns over data breaches aren't unfounded. A recent survey by LocalCircles, a leading community social media platform, found that 87 per cent of Indian citizens believe that some of their personal data is already in the public domain or has been compromised in databases. This marks a significant increase from 72 per cent in 2022. Among those who think their personal identification data has been leaked, more than 50 per cent specifically cite their Aadhaar or PAN card details, or both, as being at risk. The survey also indicated that citizens attribute responsibility for this situation to various entities, including government agencies, telecommunications companies, banks, and e-commerce platforms. Earlier, a report published in the Tribune newspaper in 2018, disclosed that an online database containing every Aadhaar number, along with the personal information of more than a billion Indians, could be bought for as little as \$7. A 2022 audit of the UIDAI conducted by the CAG of India highlighted issues related to privacy and data security, as well as problems in the enrolment processes that resulted in duplicate entries and inaccurate biometrics. These are bound to happen in a country like India where everyone works in a lackadaisical manner and with complete

The government asserts that the new app streamlines Aadhaar verification, boosts user privacy, and safeguards against misuse. However, concerns persist regarding the security of citizens' personal data. While Face ID offers convenience, it also poses much greater security risks, including data breaches, serious privacy infringements bordering on life threats, and the possibility of being circumvented by deepfakes or other techniques. These are not fabricated ideas but instead such dangers have already been felt in other countries with much stricter privacy laws.

Unauthorised access to facial recognition data can result in identity theft and widespread surveillance. When facial data is stored on a cloud server, it may be susceptible to unauthorised third-party access. Unlike passwords or credit card details, facial data is challenging to alter, making it a particularly sensitive type of information that requires robust protection, which India is not even attempting to

in labour walk five hill to reach a clinic at night? What nutrition advice do you give to the family of a severely malnourished young losis, who cannot afford to buy milk or eggs? What happens to a sick child when the nearest health facility is 20 km away and there is no transport? How do you counter malaria, diarrheal diseases, cholera, exacerbated by poor sanitation, flooding and malnutrition in remote and rural areas? These are often seen as situations in rural India, but they are not limited to this country. These stories are from across the globe. Despite the huge differences between developing and developed countries, access is a major issue in rural health around the world. Resources are usually concentrated in the cities. All countries have difficulties with transport and communication, and they all face the challenge of shortages of doctors and other health professionals in rural and remote areas, Doctors from India, Australia, America, New Zealand, Norway, Nepal and Sri Lanka discussed these problems at the three-day World Rural Health Summit in Bangalore that end-

ed on 6 April. Typical medical conferences are restricted to doctors and do not include nurses and public health professionals unless it relates to their areas. Such conferences definitely do not include midwives. This rural health summit opened with a panel of midwives and nurses. The midwife, a healthcare professional trained to support women throughout pregnancy, childbirth, and the postpartum period, plays a key role in low and middle-income countries (LMICs) where access to skilled healthcare providers is often limited. World Health Organization (WHO) figures for 2024 show that there are an estimated 29 million nurses worldwide and 2.2 million midwives. WHO estimates a shortage of 4.5 million nurses and 0.31 million

midwives by the year 2030. This poses a major problem as nurses and midwives play a pivotal role in rural healthcare.

Worldwide lack of access to healthcare services and coverage is as high as 56% in rural areas as compared to 22% of the population in urban areas. Two thirds of the deficit of 10.3 million healthcare workers in the world is in rural and remote areas, says a report by the International Labour Organization (ILO). The report, "Global evidence on inequities in rural health protection: New data on rural deficits in health coverage for 174 countries," dated May 2015, reveals major health access disparities between rural and urban areas. The disparity is particularly pronounced in Africa, where a large percentage of the rural population lacks access to healthcare.

The deficit though felt everywhere, is much higher in low-income countries and those with disparate distributions of wealth. For instance, Nigeria's GDP is the largest in Africa, but its per capita income of about \$2,000 is low. It is Africa's most populous country with 206 million people and has a highly inequitable distribution of income making it both wealthy and very poor. About 40% of the country lives in poverty and in social conditions that create ill health which is addressed with devastatingly high health expenditure from out-of-pocket

spending. Nigerian healthcare spending, roughly 80%, is out-of-pocket expenses. This means individuals directly pay for healthcare services, rather than relying on health insurance or government funding. In India, the ministry of health and family welfare says that a steady decline in out-of-pocket expenditure as a percentage of total health expenditure has been observed in five years from 48.8% in 2017-18 to 39.4% in 2021-22.

Developed countries also face problems with health care coverage in rural areas. For example, the Netherlands is a small and a developed country with a higher population density and should not have a problem because of milder access issues in rural areas compared to other countries on account of the relatively shorter distances. But the differences in population densities in urban and rural municipalities are large and with increasing migration by youngsters from rural to urban areas, the problems of the rural greying population are mounting. This is mainly because of the demands of the growing healthcare needs of those left behind. which are not being met.

Since 1992, WONCA, the World Organization of Family Doctors, has developed a specific focus on rural health. This is mainly through the WONCA Working Party on Ruattention to rural health issues through World Rural Health Conferences and WONCA Rural Policies. The WHO has a Memorandum of Agreement with WONCA which includes the Rural Health Initiative.

Australia and India have their own solutions. In Australia doctors working in rural areas are called "rural generalists," a protected discipline like a cardiologist. They receive incentives to work in rural areas and have in turn contributed to development and changes in the local economy. In India, where rural healthcare issues are starker than those of other countries, there are initiatives underway like sensitising young doctors to the problems in villages and remote areas. In October this year, a group of young doctors from across India will meet at Iswal, a village 25 km from Udaipur, to participate in a Rural Sensitisation Programme (RSP) organised by Basic Healthcare Services, a Rajasthan-based non-profit that runs primary healthcare centres in the state. RSP is a three-day field programme that hopes to expose this group to well-functioning primary health facilities on the one hand, and day-to-day lives and struggles of rural, tribal communities on the other. RSP emerged in response to the growing disillusionment among many young doctors who graduate into a real world of corporate hospitals, pharma companies and commissions. Which way should they go? Rural India can provide the answers as it struggles to come out of its healthcare problems. We will need health services models based close to the community that practice ethical and high-quality healthcare. Rural sensitising maybe the way forward for the rest of the

Nowhere has this been more obvious than in California, where wildfires have become more frequent and intense – the Los Angeles conflagration in January being only the latest in a series of devastating blazes. And it's not just wildfires: the Golden State is also prone to large, damaging floods.

This poses an extremely complex and difficult challenge for insurance companies, which have understandably been struggling to cope. In recent months, a number of major insurers have paused new home policies in California.

But the problem is not confined to a few unlucky places. The world is facing a perfect storm of accelerating climate change, economic instability, political unrest, cybercrime, and supply-chain shocks. These interconnected threats are causing natural disasters to become both more frequent

ver the past year and and more costly. Insurers are decades-old historical data, frantically trying to continue providing coverage to their clients, as the traditional methods of assessing and pricing risk break down and the 'protection gap' - the difference between insured and uninsured losses - widens. While there are no easy answers, insurers must evolve or risk becoming

According to the European Investment Bank (EIB), every euro spent on prevention saves 5-7 in recovery costs. This points to a strong economic argument for insurers to shift their approach. By becoming active risk managers. rather than passive payers of claims, insurers would go a long way toward closing the protection gap.

The tools to do this already exist. Perhaps the most powerful is geospatial technology, which tracks risks in real time by using AI-powered tools to analyze data from satellite imagery and drones. Instead of relying on outdated models that are often based on

insurers can use this technology to pinpoint which properties, businesses, or assets are especially vulnerable to natural disasters A significant obstacle to

prevention-based insurance is cost. Critics claim that the technology is too expensive, and that its data infrastructure is too complex, to integrate into insurance systems. They are not entirely wrong: such a pivot will require significant investment. But the cost of doing nothing is even greater. If insurers abandon high-risk areas, the protection gap will turn into a vawning chasm. Local businesses might find it impossible to secure financing. Entire regions could suffer economically. Governments may face pressure to step in with public insurance schemes, diverting resources from other priorities.

Insurers that embrace prevention, however, will have a clear advantage that goes beyond the savings projected by the EIB. They will be able

to offer lower premiums to cligation measures, reduce their own claims costs, and help create a more resilient world. After all, insurance is not merely for loss compensation (as important as that is), but for the protection of human lives and livelihoods. By embracing a risk-management approach based on geospatial technology, insurers would be fulfilling

their purpose. The rapidly escalating climate crisis has already upended the insurance industry. Simply retreating from risk is not a viable long-term option - insurers would be condemning themselves to irrelevance. Instead, they must adapt to the new normal by evolving the mindset they need to create a forward-thinking, technologically sophisticated sector that can play a crucial role in building a safer, more stable world.

Mumbai, April 13: Helpline number 1930 is becoming a potent weapon in Mumbai police's fight against Cybercrime in the last three years, with the number of complaints crossing the one lakh figure this week and the amount saved on behalf of victims standing at a whopping Rs 241 crore, an official said

The helpline, which is being used by Mumbai police's cyber wing since May 17, 2022, started with six lines but has since



posse of constables and officials working round the clock every day to ensure citizens of the metropolis do not fall prey to online fraudsters, he added.

As financial frauds and Cyber crimes increase every passing day, especially in the last two years, Mumbai police is taking the fight to those involved with an array of advanced technology and equipment, the senior official

"We also have a strong follow-up team that coordinates with all stakeholders, including banks, financial institutions, Reserve Bank of India, law enforcement agencies of various states etc to tackle Cybercrime. We receive around 1500 complaints on 1930 every day. This Friday, the cumulative figure of complaints crossed one lakh," he said. "As Saturday, the figure stands at 1,01,069. The amount saved due to timely ac tion is Rs 241,42,11,827," Cyber Wing Deputy Commissioner of Police Datta Nalawade informed. Amid a rise in cyber frauds, including promising high returns on share trading, rewards for tasks, digital arrest as well as phone and email hacking, the Mumbai police has permanently blocked 8,214 mobile phone SIM cards used for such activities, he said.

"Even highly qualified people like senior bank personnel, doctors, engineers, government officials are losing lakhs of rupees in such frauds. We are taking all efforts to sensitise Mumbaikars to not fall prey to such modus operandi. As cas es increase, Cybercrime has become the biggest challenge of our times," the DCP asserted

In the last three years, Mumbaikars have lost Rs 1.922 crore to cyber fraudsters, Nalawade pointed out. However, the silver lining is that the ratio of money of victims being saved is also rising, he said.

Another official said a major tool in the fight against the menace is the National Cyber Crime Reporting Portal created by the Union Home Ministry, to which all banks and financial institutions are connected.

Tadoba tiger reserve attracts rare birds in village-free area

Mumbai, April 13: Grassland bird species are thronging the Tadoba Andhari Tiger Reserve (TATR) in Maharashtra's Chandrapur in the natural meadows created due to the relocation of six villages from its core area, an exercise which began 19 years ago, as per officials.

The Bombay Natural History Society (BNHS) has taken up a conservation breeding project focused on restoring some of the endangered bird species in Maharashtra, including the Lesser Florican that has been sighted in and around TATR in the last three to four years.

The Mumbai-based wildlife research organisation is currently assessing the potential of the tiger reserve, located in the Vidarbha region, for the conservation project, especially post-relocation of villages.

Talking to PTI, BNHS director Kishor Rithe described TATR as one of India's most successful and biologically rich tiger landscapes. Spread

over 1,700 square kilometres including buffer and 625 sq km core area, the reserve is home to more than 100 individual tigers, making it one of the most important conservation landscapes in central India he said.

The reserve is characterised

by dense bamboo dominated forest, rich prey base and a network of perennial water bodies which offer ideal conditions for the survival of tigers Rithe said. After the relocation of half-a-dozen villages from the core zone, a process which began in 2006, an area spread across 926 hectares, which once comprised settlements and ag riculture fields, has now turned into meadows, where there is no presence of human beings or domestic animals, he said.

According to Rithe, the Lesser Florican inhabits dry grasslands and scrublands. It has also adapted to some ag ricultural landscapes having short crops. It often lays eggs on ground and feeds on insects. seeds and berries.



Assam launches Northeast's first robotic surgery facility

Guwahati, April 13: The first robotic surgery facility of Northeast India was inaugurated on Sunday at the State Cancer Institute of Gauhati Medical College and Hospital in Assam, Chief Minister Himanta Biswa Sarma said.

At an official function here, Sarma dedicated the robotic surgery unit, equipped with all modern functionalities for advancing

cancer care in the region. "Assam is beginning Bohag celebrations by dedicating North East India's first ever onco-robotic surgery facility at the Guwahati Medical College. Our government hospitals will now offer low-cost, highly precise and least invasive oncological surgical procedures through MADE IN INDIA machinery," he said in a post on X after the event. Similar facilities are coming up



in Silchar and Dibrugarh towns also, the CM said.

"At a project cost of Rs 14.99 crore, the system has been procured by the state government under the NPCDCS scheme of the Government of India. Robotic surgery offers enhanced precision, superior control and 3D visualisation. enabling better outcomes in cancer care," an official said. Sarma also announced that to ensure adequate manpower to operate high-end medical technology, the government is in the process of beginning nursing colleges in all cancer hospitals.

Devotees divided on new attire guidelines

DRESS CODES

Mumbai, April 13: Temples across Maharashtra are gradually adopting dress codes for visitors, as trusts managing these places of worship have issued guidelines urging devotees to wear modest, tradi-

tional clothing. While temple trusts have emphasised that dress codes are needed to maintain the sanctity of religious places, visitors have had mixed reactions to the development. Temples managed by the Chinchwad Devasthan Trust, including those at Morgaon and Theur in Pune district. Siddhatek in Ahilyanagar and the Morya Gosavi Sanjivan



in Pimpri Chinchwad and Khar Narangi in Raigad, Friday, issued advisories requesting visitors to wear "appropriate" attire.

The trust clarified that the dress code is not mandatory but is a respectful appeal to maintain decorum in these temples. The latest advisory appears to be part of a trend gradually emerging across the state.

Aditi Kane, a resident of Pune, said, "These days, people don't plan ahead to visit temples but club them with their holidays to certain destinations. I have visited temples while holidaying and observed that barring a handful of visitors, most people wear decent attires.

There is nothing wrong with temple managements expressing their expectations about dress codes, but they should not enforce it." In January this year, Mumbai-based Shree Siddhivinavak Ganpati Temple Trust announced a dress code for the prominent temple that sees thousands of visitors, including celebrities. Last year, dress codes were introduced for visitors at 50 temples in Ratnagiri, with signboards at entrances urging people to be fully clothed and avoid garments that exposed body parts.

The Maharashtra Temple Federation held meetings in 11 locations in Ratnagiri, and in these discussions, trustees of the temples decided to enforce a dress code of traditional Indian attires.

At least 16 temples have introduced similar restrictions in Ahilyanagar district and have barred entry to visitors wearing jeans, skirts, shorts, or other "revealing" clothing.

Chennai, April 13: Tamil Nadu Governor R N Ravi's reported remarks asking students of a college to chant "Jai Shri Ram" have trigered a controversy with SPCSS-TN, a body of educationists, alleging he violated his oath of office and secular principles and urged President Droupadi Murmu to remove him from his post. The State Platform for Com-

mon School System-Tamil Nadu (SPCSS-TN), said Ravi failed to abide by the Constitution, respect its ideals and institutions. "Ravi should be removed from the office of Governor of Tamil Nadu forthwith for deliberately violating Article 159 (oath by governor) of the Constitution of India," SPCSS-TN General Secretary, PB Prince Gajendra Babu, said in a statement.

Ravi was invited by a government-aided college in Madurai as chief guest to distribute prizes to the winners in a literary contest. Delivering his address April 12, he had asked the students to chant the name of a God of particular religion (Jai Shri Ram) thrice.

According to the Constitution, India is a secular country, education is a secular activity and it shall be the fundamental duty of every citizen to abide by the Constitution and respect its ideals and institutions, the national flag and the national anthem and also to develop scientific temper, humanism and the spirit of inquiry and reform.

However, Ravi failed to preserve, defend and protect the Constitution by chanting the name of the God of a particular religion and asking the students to repeat the same thrice, Gajendra Babu alleged. Instead of obeying the Governor, had the students protested against him for violating his oath, unnecessary embarrassment would have been caused to the management and staff of the college. Sibal slams govt over ED notices



Govt may challenge apex court order on **President Bill deadline**

New Delhi, April 13: The government is likely to file a review petition on the Supreme Court judgement setting a timeframe for the President and the governors to decide on giving assent to Bills passed by state legislatures.

Sources aware of the development said that besides seeking a review of the timeline, the government may seek a review of the apex court's order that the state governments can directly approach it if the President withholds assent to a Bill sent by a governor for consideration.

There are active consider ations at the highest echelon of the government on the issue and, in all probability, a review petition will be filed in the Supreme Court, the sources said

The grounds on which the review petition will be filed are being considered and will be known once the government approaches the apex court.

If the government approaches the Supreme Court, the review petition will have to be filed before the same bench of Justices J B Pardiwala and R Mahadevan that pronounced the verdict, the sources said.

After the April 8 judgement. the Tamil Nadu government notified 10 pending bills as Acts in the government gazette, citing the Supreme Court's ruling that they were "deemed" to have re ceived assent. In its order, the Supreme Court has prescribed that the President should decide on the bills reserved for her consideration by the governor within three months from the date on which such reference is received.

New Delhi, April 13: In January last year, the government decided to shut down 199 District Agrometeorological Units (DAMUs), which provided farmers with crop and location-specific advice, even though these centres were meant to operate until at least 2026 under a pilot project.

Despite this, around 130 emplovees chose to stay on -- unpaid but unwavering -- because farmers still depended on them and they had two years of service left. They went to court, secured a stay and kept working, helping farmers navigate worsening weather and rising

climate risks.

salaries were finally released following court intervention. But no paycheck can undo a year lived without medicine, without school fees, without peace of mind. One DAMU employee from Rajasthan, requesting anonymity, said he could not pay his daughter's school fees and had to fold his hands before school authorities."I kept my head down, but inside, I was breaking," he said. His voice quivered as he recalled how his family had to cut back on food.

Another DAMU staffer from Rajasthan, who is soon to become a father for a second time. told PTI his family has been surviving on the kindness of others. "Every month, I tell my landlord the same thing: 'Abhi salary nahi aayi hai'," he said, his tone conveying more than his words.

Each unit supports farmers across 5-?6 districts. In 2012, the government launched the Gramin Krishi Mausam Sewa to expand the reach of these advisoto set up 530 DAMUs as part of a pilot project. But due to the Covid pandemic, only 199 were established. Each DAMU employed two contract workers -- a Subject Matter Specialist (Agrometeorology), earning ₹93,000 to ₹1.04 lakh per month including allowances, and an

Agromet Observer, earning

SC dismisses adoption deed in property dispute

The top court upheld the high court verdict of not accepting the adoption deed, saying mandatory conditions like that a person who adopts a child must have the consent of his wife were not followed



New Delhi, April 13: The Supreme Court has refused to interfere with an order of the Allahabad High Court discarding the adoption deed of a man in a property dispute case, saying it was a calculated move to deny the daughters of their rightful inheritance of their father's estate.

In the protracted legal battle, the petitioner Ashok Kumar had referred to his adoption deed of August 9, 1967, to claim the inheritance of properties of Bhuneshwar Singh who had two biological daughters-- Shiv Kumari Devi and Harmunia. The plea claimed Bhuneshwar Singh, a now-deceased UP resident, had adopted Ashok in a ceremony.

Putting an end to the legal dispute, the top court upheld the high court verdict of not accepting the adoption deed, saying mandatory conditions like that a person who adopts a child must have the consent of his wife were not followed. The high court also apologised for the delay of over four decades in deciding the question of the validity of the adoption deed

Petitioner Ashok Kumar had claimed that he was adopted by Singh from his biological father Subedar Singh in a ceremony and a photograph was produced before the court. A bench of Justices Surva Kant and N Kotiswar Singh rejected the plea filed by Kumar against the December 11, 2024, order of the high court that refused to accept the validity of the August 9, 1967, adoption deed.

The top court said, "Having heard senior counsel for the petitioner at a considerable length and on carefully perusing the material placed on record, we are satisfied that the Adoption Deed dated August 9, 1967, was nothing but a calculated move to deprive Shiv Kumari and her elder sister Harmunia - of their legally vested right to inherit the estate of their father."

During the hearing, Justice Surya Kant said, "We know this is a methodology adopted in rural areas to oust the daughters from rightful inheritance. We know how these adoption proceedings are carried out. The high court has rightly dismissed the adoption deed. The bench, in its order passed

recently, said the consolidation authorities as well as the high court have rightly discarded the said document, which has no legal sanctity.

The high court said, "In the aforesaid circumstances, the court is of considered opinion that there is no reason to interfere with reasoned order passed by the Board of Revenue as the mandatory require ments for valid adoption were not followed, therefore, this writ petition is dismissed." It had said that the findings returned by the Board of Revenue are in terms of earlier verdicts. Also, there is evidence that has not been contradicted that adoption proceedings were conducted without the consent of the wife of the person who adopted the child.

Therefore, the mandatory requirement was not fulfilled as well as nature of the evidence has also not proved beyond reasonable doubt that the ceremony of giving and taking was undertaken. The high court had said it could be held without any doubt that the wife of the adoptive man had not signed the adoption deed as well as the photographs also indicate that she had not participated in the ceremony.

The counsel for the daughters contended that the adoption deed has to be proved in terms of provisions provided under the Maintenance and Adoption Act 1956 and consent of the wife of a male who adopts a child was mandatory as well as there must be proof of ceremony of actual giving and taking adoption.

Police shoot dead man accused of killing 5-yr-old girl in Hubballi

Hubballi (Karnataka), April 13: A man who allegedly murdered a five-year-old girl earlier Sunday was killed in police firing in the evening while attempting to escape, police said.

The accused has been identified as 35-year-old Ritesh Kumar, a native of Patna, Bihar.

He was booked on charges of murder under the POCSO Act and also for attacking and attempting to murder police personnel.

The girl was reportedly kidnapped and killed by the accused in the morning within the Ashok Nagar police sta tion limits. Her body was later found in an abandoned build ing, police said.

Outraged by the murder, a large number of residents gathered in front of the Ashok Nagar police station and staged a protest demanding justice.

"Based on CCTV footage and leads from locals, the accused was taken into custody and interrogated for three to four hours. He shared very little information and failed to establish his identity conclusively. However, the CCTV footage clearly captures him committing the crime," Police Commissioner of Hubballi-Dharwad N Shashi Kumar told reporters here.

He further stated that the accused had been away from home for several years, taking up work wherever available.

'To verify his identity and collect any documents, he was taken to his place of stay. Suddenly, he threw stones at the police vehicle and attacked the officers before trying to flee. Our woman officer, PSI Anna purna, fired a warning shot in the air. When he did not stop. two to three rounds were fired at him. One bullet struck his leg, and another hit his back,'

Accused found hanging in jail

Thane, April 13: A man accused of raping and murdering a minor girl in Kalyan town here, a case that had hit national headlines, allegedly committed suicide at Taloja Central Jail in neighbouring Navi Mumbai early Sunday,

The accused, Vishal Gawli (35), was found hanging in the prison toilet at around 3.30 am, an official said. "Gawli went to the toilet and allegedly used a towel to hang himself. The prison authorities later found the body. A panchnama (spot inspection) was conducted. The body has been to the government-run JJ Hospital in Mumbai for post mortem," the Kharghar police station official said.

Gawli's lawyer Sanjay Dhakane said he and the deceased's kin suspect foul play. "Vishal's family believes he didn't commit suicide. They fear he met the same fate as the accused in the Badlapur school case (Akshay Shinde) who was killed in an encounter (on September 23 last year). We had previously requested security for Vishal, knowing his life was in danger. A detailed inquiry into his death is necessary," Dhakane said.

Gawli was accused of raping and murdering a 12-year-old girl in Kalyan in December

The child went missing from Kolsewadi locality December 24, and her body was found later at Bapgaon village in Padgha under Thane Rural police jurisdiction.

MGNREGS: Parl panel recommends independent survey

The panel stressed on a need to revamp the scheme and said while at present, the provision is to provide 100 days of *employment, there are* demands from various quarters to increase the number of days

New Delhi, April 13: An independent survey of the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) should be held to assess its effectiveness, a Parliamentary panel has suggested, stressing on revamping the scheme keeping in view

emerging challenges In a report tabled in Parliament during the last week of the recently concluded Budget Session, the Parliamentary Standing Committee on Rural Development and Pancha-

vati Rai have recommended increasing the number of days of work under the scheme to 150 from the current 100, and also suggested that wages be increased to at least ₹400 per day.

The panel, which has been expressing concern over stagnation in allocation to the flagship rural employment scheme, has also stressed on social audits to ensure its proper implementation.

"The committee believes that a comprehensive national survey should be conducted to assess the effectiveness of MGNREGS," the panel headed by Congress MP Saptagiri Sankar Ulaka, said. It said the survey should

focus on worker satisfaction, wage delays, participation trends and financial irregularities within the scheme. "The committee recommends independent and transparent survey across the country to gain valuable insights about the programme's shortcomings and introduction of necessary policy reforms accordingly to increase the effectiveness of MGNREGS," the report said.

The panel also recommended that for climate mitigation and disaster relief, the current work limit of 150 days under the Drought Relief Provision must be increased to 200 days.

It said while directive has been issued to provide 150 days of wage employment un-

der MGNREGA for Scheduled Tribe households living in forest areas, work limit under the Forest Rights Act should also be extended from 150 to 200 days to ensure income stability for vulnerable communities.

Expressing concern over the failure of wages to keep up with inflation, the committee said base wage rates under the MGNREGS should be revised

to ensure they align with the current economic realities and provide "respectful wages" to rural workers.

Saying that there are "chronic delays in wage payments" the report recommended an increase in compensation rate for delayed wage.

The panel observed that social audits should be increased to improve transparency and accountability and urged the Rural Development Ministry to come up with a Social Audit Calendar. Noting the high number of job card deletions, the panel said in 2021-22 approximately 50.31 lakh job cards were deleted due to minor spelling errors or mismatches in Aadhaar details. Since then, the figures have not come down significantly and thousands of eligible workers are regularly being denied work under MGNREGS, it said. The Rural Development Ministry, in January this year, circulated a Standard Operating Procedure (SOP) with guidelines regarding deletion and restoration of job cards.

Puniab LoP Baiwa quizzed over '50 bombs' claim

Earlier in the day a two-member team of Punjab Police reached the residence of Bajwa and questioned him over his claims even as Chief Min ister Bhagwant Mann asked the Congress leader to reveal the source of his information. questioning if he "had direct

links with Pakistan". Sticking to his statement, Bajwa said he cooperated with the police team but refused to

divulge his sources. The Congress accused the AAP government of trying to "intimidate him out of sheer political vendetta" and asked it not to divert the public attention from the "serious threat that has been posed to peace and harmony in Punjab"

Bajwa said, "It is deeply unfortunate that Mann is running the government not with the intent to serve the people of Punjab but to carry out per sonal vendettas. Today's events stand as clear testimony to the AAP government's misuse of power." Earlier, Mann lashed out at Bajwa over his claims. saying neither Punjab Police Intelligence nor a Central in telligence agency has shared any such information.

The Chief Minister said strict action will be taken if Bajwa's statement was meant only to "create panic".

The plane, a Mitsubishi MU 2B, was reported down at noon Saturday in Copake, New York around 48 kilometres from its destination at the Columbia County Airport.



All six people who were aboard the plane were presumed dead, according to an official familiar with the crash who could not discuss details of the investigation publicly and spoke to the AP on condition of anonymity. Columbia County Under-

Saturday confirmed the crash was fatal but declined to reveal how many people died. "It's in the middle of a field and it's pretty muddy, so accessibility is difficult," Salvatore

Bangladesh reintroduces 'except Israel' inscription on passports

Dhaka, April 13: Bangladesh has reintroduced "except Israel" inscription on passports debarring its citizens from travelling to the Jewish state as public anger mounted against Israeli attacks on the Gaza Strip, officials said Sunday.

The home ministry issued a directive asking the passport and immigration department to reinstate the sentence "THIS PASSPORT IS VALID FOR ALL COUNTRIES OF THE WORLD EXCEPT ISRAEL" in the official travel permits for citizens visiting abroad, the state-run BSS news agency reported.



The phrase "all countries except İsrael" was dropped in 2021 during the Awami League government led by now-deposed prime minister Sheikh Hasina. The authorities at that time said it was dropped from the passport to maintain international standards of the

"We issued the letter (directive) on April 7," Nilima Afroze, Deputy Secretary of Home Ministry's Security Services Division, told the news agency.

The disclosure, however, came a day after thousands of protesters rallied in the capital to condemn Israeli actions in the Gaza Strip, carrying hundreds of Palestinian flags and chanting slogans like "Free, Free Palestine.

The main protest was held in central Dhaka's Suhrawardy Udyan near the premier Dhaka University and many among them beat the images of US President Donald Trump and Israeli Prime Minister Benjamin Netanyahu, accusing them of backing Israel.



FPIs withdraw ₹31,575cr from equities in Apr on tariff jitters

New Delhi, April 13: Foreign investors have pulled out Rs 31,575 crore from the country's equity markets so far this month, in the wake of turbulence emanating from sweeping tariffs imposed by the US on most nations, including India

This came following a net investment of Rs 30,927 crore in the six trading sessions from March 21 to March 28. This infusion helped reduce the overall outflow for March to Rs 3,973 crore, according to data from the depositories. Compared to previous

months, this marks a notable improvement. In February, foreign portfolio investors (FPIs) took out Rs 34,574 crore, while in January, the outflow was even higher at Rs 78.027 crore. This shift in investor sentiment highlighted the volatility and evolving dynamics in global financial markets. According to the data, FPIs

pulled out Rs 31,575 crore from Indian equities between April 1 and April 11.

With this, the total outflow by FPIs has reached Rs 1.48 lakh crore so far in 2025. "The turbulence in global

Banks for freezing accounts in illicit transactions cases

New Delhi, April 13: To check cyber fraud through mule accounts, banks are seeking authority to freeze accounts involved in channelling illicit transactions without wasting precious time in seeking permission from authorities.

Banks freeze/block accounts based on internal triggers, however, as per the Prevention of Money Laundering Act (PMLA), they do not have the authority to freeze or block customer accounts without proper authorisation from a court or law enforcement agencies (LEAs).

"In light of this, we may propose this as a suggestion for further consideration by the RBI,' a working group constituted by the Indian Banks' Association said in a report.

Mule accounts are used by fraudsters to move illegal funds through the banking system. Although banks freeze thousands of these accounts every year, fraudsters quickly create new accounts using loopholes in the system.

Besides, it said, banks may look to verify and restrict accounts most vulnerable to misuse as 'mule' accounts for channelling illicit money.

The fight against mule accounts demands a dynamic, technology-driven approach. By integrating Artificial Intelligence (AI) and Machine Learning (ML) into transaction monitoring systems, banks can address existing gaps, anticipate criminal strategies, and protect the integrity of the financial ecosystem, it suggested.

A concerted effort involving investment in technology, staff training, and collaboration among stakeholders will ensure a more secure financial landscape.

The report represented a blueprint for curbing money mule activities, it said, adding that implementing these measures will require dedication and cooperation from financial institutions, regulators, law enforcement agencies and technology providers.

Together, it said, banks can safeguard the financial system against evolving threats and the menace of money mule accounts.

'Zero-for-zero' tariff strategy with US unlikely: Official

NEW DELHI: A 'zero-for-zero'

tariff strategy under the proposed bilateral trade agreement between India and the US is unlikely, as the two countries are at differer levels of economic development, official sources said. Certain trade experts have suggested that India can propose a 'zero-for-zero' tariff strategy to the US for addressing America's reciprocal tariff hikes. An official said that zero-for-zero tariffs can be possible between the US and the European Union (EU) as both are developed and advanced nations. The India-US agreement will always be a "package" deal that could include issues such as goods and non-tariff barriers, the official said adding "it does not happen like this that if he will do 'zero' in electronics, we will also do in electronics. Trade agreements do not happen like this. It is a wrong thinking".

Kolkata, April 13: As the US-China tariff war intensifies, the Indian tov industry leaders are calling the situation a 'golden opportunity' to position India as a major export hub for toys, especially to the United States, a trade body official said

The US recently imposed a steep 145 per cent tariff on toy imports from China — a move that could reshape the global

China, which previously accounted for nearly 77 per cent of US toy imports, is expected to see a significant drop in exports due to the high tariff, opening up space for alternate suppliers, an official said.

Akshay Binjrajka, President of the Toy Association of India, told PTI that India is well-positioned to fill the emerging vacuum.

"The US toy market, valued at around USD 41.7 billion, offers a massive opportunity for Indian manufacturers," he said, adding that Indian products can now compete with Chinese offerings on both quality and price.

India's toy exports have al-

ready witnessed a steady rise from USD 40 million in 2014-15 to an estimated USD 152 million in 2023-24. More notably, toy imports from China to India have plunged from USD 235 million in FY20 to just USD 41 million in FY24, after India imposed strict control norms on imports and boost in domestic sourcing.

'The Indian toy sector, once import-dependent, is now transforming with local manufacturers scaling up to meet domestic demand and aiming for global markets," said Binjrajka, who also chairs the Toy sub-committee at the Bharat Chamber of Commerce

Despite policy tightening, he warned that "cheap, unregulated Chinese toys continue to flood the Indian market, and might get intensified after US tariffs," hurting domestic capacity and profitability.

He urged the Centre to enforce stricter checks at ports and called on the Bureau of Indian Standards (BIS) to curb the entry of substandard toys. Biniraika also appealed to

and two 9s, but faltered with a pair of 8s that proved costly.

The Chinese team of Li Zhongyuan, Kao Wenchao, and Wang Yan stepped up in the second set, hitting four 10s to take

India, meanwhile, again slipped into the red ring with another 8, losing the set 55-58.

Needing to win the third set to stay alive, the Indian team once again stumbled, managing only 54 as China edged them out 55-54 to seal the gold. China also bagged the bronze.
