China faces up to 245% retaliatory tariff: White House

Washington, April 16: China now faces tariffs up to 245 per cent on imports to the United States due to its retaliatory actions, the White House has said, as the trade war escalated between the world's two largest economies.

Separately in a post on Truth Social, President Donald Trump said Tuesday that China just reneged on the big Boeing deal, saying that they will "not take possession" of fully committed to aircraft. He appeared to be confirming reports that China has asked its airlines not to take deliveries of planes from American aircraft manufacturer Boeing.

In the post, he also vowed to protect the US and its farmers in a trade war with its adversaries, such as China.

In a fact sheet issued Tuesday, the White House said President Trump signed an executive order launching an investigation into the national security risks posed by US reliance on imported processed critical minerals and their derivative products.

On Day One, President Trump initiated his America First Trade Policy to make America's economy great again, it said.

More than 75 countries have already reached out to discuss new trade deals. As a result, the individualised higher tariffs are currently paused amid these discussions, except for China, which retaliated, it



China now faces up to a 245% tariff on imports to the United States as a result of its retaliatory actions, the fact sheet said, without giving details. China is the only country to have retaliated with tit-fortat levies.

China Friday raised its additional tariffs on imports from the US to 125 per cent in retaliation to the Trump administration's 145 per cent levies on Chinese exports. China also filed a lawsuit with the WTO following the US tariff hikes.

China earlier retaliated with 84 per cent levies and imposed restrictions on imports of some US films, expressing its interest in holding dialogue with Washington to resolve the issue.

The fact sheet accused China of banning exports to the US of gallium, germanium, antimony, and other key hightech materials with potential military applications.

Justice Gavai to be next CJI

New Delhi, April 16: Chief Justice of India Sanjiv Khanna Wednesday recommended to the Centre the name of Justice Bhushan Ramkrishna Gavai as the next CJI.

Justice Gavai, the second se nior-most Supreme Court judge after the incumbent CJI Khanna, is set to become the 52nd CJI May 14 after the retirement of CJI Khanna May 13. He will

be the second Dalit to head the country's iudiciary, after Justice KG Balakrishnan.

Justice Gavai, who was elevated as

a judge of the Supreme Court May 24, 2019, would have a tenure of over six months as the CJI. He is due to retire Novem ber 23, 2025. CJI Khanna, who was sworn

in as the 51st CJI November 11 last year, recommended to the Union Law Ministry to appoint Justice Gavai as the next CJI. The retirement age of Su

preme Court judges is 65 years. Born November 24, 1960 at Amravati, Justice Gavai has been a part of several Constitution benches in the apex court which delivered path-breaking verdicts. including upholding Centre's abrogation of Article 370

Waqf Act: SC proposes stay on key provisions

The Supreme Court, while hearing pleas against the Waqf (Amendment) Act, 2025, raised serious concerns over its constitutional validity. It questioned the exclusion of 'waqf by user', a long-standing and judicially recognised practice, warning that undoing such endowments would erase genuine religious history. The bench stated that the legislature cannot nullify past judicial decisions and emphasised the risk of rewriting history. It also questioned the Centre on whether Muslims would now be allowed in Hindu religious trusts, highlighting concerns of religious parity. The court criticised the provision requiring individuals to prove five years of Islamic practice to create a waqf, calling it arbitrary. The bench further expressed concerns on the wide-spread violence during protests terming it as "disturbing"

New Delhi, April 16: In a significant development, the Supreme Court Wednesday proposed to stay certain key provisions of the contentious Waqf (Amendment) Act, 2025, including the power to denotify properties declared as waqf by courts and inclusion of non-Muslims in central Waqf councils and boards.

The top court proposed to pass the order, which was opposed by the Centre as it sought a detailed hearing before any such interim order.

The hearing relating to 72 petitions against the constitutionality of the Waqf (Amendment) Act, 2025 took place before a bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and KV Viswanathan.

The bench, which will continue with the hearing Thursday. was miffed over the inclusion of non-Muslims in the central waqf councils and boards and asked the Centre whether it was willing to include Muslims in Hindu religious trusts.

After hearing solicitor general Tushar Mehta for the Centre and senior lawyers including



Abhishek Singhvi, CU Singh for Muslim bodies and individual petitioners, the CJI proposed to issue the notice and to pass an interim order, saying it will balance the equities.

Observing some provisions could have grave ramifications, particularly those that potentially undermine judicially recognised waqf properties, the CJI proposed the order.

The properties declared as wagfs by the courts should not be de-notified, whether they are by waqf-by-user or waqf by deed while the court is hearing the challenge to the Waqf Amendment Act 2025, the CJI proposed.

The bench also hinted to stay a provision of the amended law,

which says a waqf property will not be treated as waqf during the inquiry of the collector to decide if the property is a government land.

All members of waqf boards and the central waqf council must be Muslims, except the ex-officio members, the CJI said.

The bench took note of the provision-wise objections to the Act and expressed reservations on several aspects of the legislation, including the inclusion of non-Muslims in the central wagf council and state wanf boards.

It also objected to empowering district collectors to adjudicate disputes related to waqf properties and the provisions allowing de-notification of properties declared as waqf by competent courts.

Ordinarily, courts do not interfere at the admission stage when a law is passed. But this case may warrant an exception. If a property declared as want by user is denotified, it can have grave ramifications, the

Custodial death of UTP sparks outcry

Rourkela, April 16: Tension prevailed after an undertrial prisoner (UTP) in Rourkela Special Jail died under mysterious circumstances Wednesday.

The deceased was identified as Rakesh Kujur. 45. of Dalki Dungaghat village under Raiboga police limits in Biramitrapur of Sundargarh district. Police registered a case of unnatural death over a complaint lodged by the jail authorities and started an investigation.

The incident triggered a protest as the deceased's wife Amrita Kujur lodged a complaint with Raghunathpali police. She alleged that her husband was beaten to death in the custody. She demanded a high-level probe into the matter and justice for the bereaved family.

Hundreds of villagers and the deceased's relatives staged a protest outside the RGH mortuary, refusing to receive the body until their demands are met.

Amrita alleged that Biramitrapur excise officials had picked up her husband from their house in a fake liquor case early Tuesday morning. he left home," she stated. It was around 10pm Tuesdav

when the jail authorities informed the family over phone that Rakesh had fallen ill. By Wednesday morning, the family reached RGH only to discover Rakesh dead.

His body reportedly bore multiple injury marks and blood stains. His torn clothes raised suspicions of custodial torture. Amrita, in her complaint, al leged that he was either beaten up brutally in the excise police station or inside the jail and demanded a high-level inquiry into the incident.

Rourkela Special Jail official Ratikant Shukla said Rakesh had been arrested by the Excise department and produced before a local court Tuesday. He was remanded to judicial custody after his bail plea was rejected.

Shukla stated that Rakesh was examined at the jail's health centre at around 8:30pm Tuesday after he complained of uneasiness. As his health condition deteriorated, he was shifted to RGH, where he was declared dead at around 5:45am Wednesday.

DARA SINGH AIDE FREED AFTER 25 YRS

Keonjhar: Mahendra Hembram, one of the convicts in the highprofile murder case of Australian missionary Graham Staines and his two minor sons, was released from Keonjhar jail Wednesday after serving 25 years. Now 50 years old, Hembram was released from prison on grounds of good behaviour during his incarceration. Hembram and Dara Singh, alias Rabindra Pal Singh, were convicted for the brutal murder of Staines and his sons, who were burnt alive by a mob allegedly led by Singh on the night of January 21, 1999. "I spent 25 years in jail after being falsely implicated in an incident related to religious conversion. Today, I have been released," Hembram told reporters outside the jail. P4

CM UNVEILS ₹7K-CR INVESTMENT PLAN

Baripada: Chief Minister Mohan Charan Majhi announced Wednesday that the state would be the recipient of a massive boost in industrial development with ₹7,000 crores set to be invested in 10 new industrial projects in Mayurbhanj. Speaking at the PM Vishwakarma - National SC-ST Hub Conclave held at Maharaja Sriram Chandra Bhanja Deo University in Baripada, Majhi also revealed that the PM Vishwakarma Scheme has already benefited 1,05,361 artisans from 18 traditional trades in Odisha, including blacksmiths, carpenters, potters, and weavers. artisans and small entrepreneurs from the SC/ST communities.

This is only the second time in the WHO's 75-year

history that member countries have reached a binding agreement - the last being a tobacco control accord in 2003

Geneva, April 16: Members of the World Health Organization reached a landmark agreement Wednesday on how to learn from COVID-19, which killed millions of people in 2020-22, and prepare the world for future pandemics. Sticking points on the road to the deal included how to share drugs and vaccines fairly between wealthy countries and poorer ones.

The legally binding pact is widely seen as a victory for the global health agency at a time when multilateral organisations like the WHO have been battered by sharp cuts in US foreign funding. "After more than three years of intensive negotiations, WHO member states took a major step forward in efforts to make the world safer from pandemics," the health body said in a statement.

US negotiators left the discussions after President Donald Trump began a 12-month process of withdrawing the US - by far the WHO's largest financial backer from the agency when he took office in January. Given this, the US would not be bound by the pact.



"This is a historic moment and a show, that with or without the US, countries are committed to working together and to the power of multilateralism," Nina Schwalbe, the founder of global health think tank Spark Street Advisors, told Reuters. The agreement,

still subject to adoption by the World Health Assembly in May and ratification by members, addresses structural inequities about how drugs or vaccines and health tools are developed.

Its article nine requires governments to establish national policies setting access conditions in research and development agreements and to ensure that pandemic-related drugs therapeutics and vaccines are globally accessible -- for the first time in an international health agreement.

"The deal essentially gives WHO members more teeth in terms of their preparedness, re sponse and prevention of future pandemics," Ricardo Matute, Pol icy Engagement Advisor with the Governing Pandemics Team at the Global Health Centre, Geneva Graduate Institute, told Reuters

Measures include allowing the WHO to have an overview of global supply chains of medical materials such as masks and vac cines. It will also enable more local production of vaccines and other treatments during a pandemic.







Keonjhar, April 16: Mahendra Hembram, one of the convicts in the 1999 high-profile triple murder case of Australian missionary Graham Staines and his two minor sons, was released from Keonihar jail after 25 years Wednesday.

Hembram, now 50, was released from the prison on grounds of good behaviour during his incarceration.


"Hembram has been released following a decision by the State Sentence Review Board. The prison directorate informed about it in a letter Tuesday. He has been released after 25 years because of good behaviour in accordance with the rules,' said Jailor Manaswini **MURDER**

incident took place, triggering national and international outrage. It was alleged that the Staines had spread straw over the vehicle to shield themselves

from the cold, and the straw caught fire. When they tried to escape the mob — armed with lathis prevented them from getting out, leading to their deaths.

Their skeletal remains were later recovered. A total of 14 persons, including Singh and Hembram, were accused in the case. However, 12 of them were acquitted, while Singh and Hembram were sentenced to life impris onment.

Hembram, hailing from Manoharpur village, was arrested in 1999, while Dara Singh was picked up January 31, 2000 by then Mayurbhanj SP YB Khurania, who is now the DGP.

Initially kept as an undertrial prisoner at Jharpada Jail in Bhubaneswar, Hembram was sentenced to life imprisonment September 22, 2003.

Over the years, Hembram was incarcerated in several facilities, including Jharpa da, Jamuihari Open Air Jail (Bhubaneswar), and jails in Cuttack, Berhampur, Baripa da, Anandpur Sub-Jail, before being transferred to Keonjhar Jail September 28, 2011. He remained there until his release.

During the trial at the CBI court in Bhubaneswar Febru

edly lost mental composure and declared himself the sole culprit and claimed that others were innocent.

Trial started March 1, 2001 at the District and Sessions Court in Khurda, which was designated as a CBI court.

Evidence against Dara Singh was confirmed when one of the accused, Dayanidhi Patra, told the trial court that he was present when he (Dara Singh) set fire to the vehicle.

The trial concluded August 18, 2003, with Judge Mahendra Patnaik sentencing Dara Singh and 12 others, while acquitting Anirudha Dandapat, alias Andha Nayak, for lack of evidence On September 22, 2003, the

court awarded Dara Singh the death penalty and sentenced 12 others to life imprisonment. However, in 2005, the Orissa High Court commuted Singh's death sentence to life imprisonment, a decision later upheld by the Supreme Court.

Dara Singh, currently serving a life sentence, filed a mercy petition in the Supreme Court in August 2024 seeking release. Another mercy plea was also submitted to the President of India.

Meanwhile, March 19, 2025, the Supreme Court directed the state government to take a decision on the remission plea of a 'repenting' Dara Singh, who continues to serve his sentence for the murders of Staines

Milk prodn up in state, poor show in 13 dists

Bhubaneswar, April 16: Livestock plays a crucial role in strengthening the national economy. Especially in rural areas, many families rely on milk production for their livelihood. India has established itself as the world's largest milk-producing country. According to the recently released data by Ministry of Fisheries, Animal Husbandry and Dairying, milk production in the country during the financial year 2023-24 stood at 239.3 million metric tonnes (MMT). Odisha -- nestled on the eastern coast of India and which blends tradition with agriculture-- contributed 1.1 per cent to it, placing the state at the 16th position nationally.

While milk production in Odisha had been steadily increasing since 2009-10, recent data reveals a decline in 13 districts during 2023–24 compared to 2022–23. A drop in milk output in 43 per cent of the districts reflects the fragile condition of the rural economy. However, the recently implemented Mukhyamantri Kamdhenu Yojana by the state government is expected to improve the situation.

In 2023-24, Uttar Pradesh had the highest milk production in the country with 38,780 thousand metric tonnes (TMT), whereas Odisha produced 2,636 TMT. These two states contributed 16.21 per cent and 1.1 per cent respectively to the national figure. Following Uttar Pradesh, Rajasthan pro-

In the 2022–23 fiscal, Odisha's milk production was 2,476.42 TMT. It increased by 159.58 TMT in 2023-24. However, milk production decreased in 13 districts— Angul, Balasore, Bhadrak, Boudh, Gajapati, Jharsuguda, Kalahandi, Keonjhar, Koraput, Mayurbhanj, Nuapada, Sambalpur, and Subarnapur.

Cuttack district recorded the highest milk production of 391 TMT from 14,03,204 milch animals. On the other hand, Kandhamal recorded the lowest, producing only 11.11 TMT from 4,73,199 animals. In Mavurbhani, despite having the highest number of milch animals at 3,761,128, milk produc-

The presence of more indigenous cows, which produce less milk, in these 13 districts is cited as the main reason for the decline.

Animal Husbandry and Veterinary Services Director Vijay Amruta Kulange said, "Omfed currently collects 5.14 lakh litres of milk daily, out of which 2,500 litres come from indigenous cows. Private companies also collect around 2.74 lakh litres of milk daily from the state. In total, Odisha produces nearly 8 lakh litres of milk per day. Of this, Omfed collects 5–6 lakh litres, private companies purchase some, and the rest is used for household

consumption. To encourage dairy farmers, the state government is considering giving an incentive of ₹2

To double daily milk production and meet the per capita milk requirement, the state government has launched Mukhyamantri Kamdhenu Yojana. Under this, 2,000 beneficiaries will annually receive two crossbred cows each to establish small dairy units. Additionally, 20,000 dairy farmers will receive subsidised cattle feed, and 1 lakh farmers will receive assistance for cattle insurance.

Kulange further mentioned that though various private companies from outside the state are selling milk in Odisha, they are not collecting milk from Odisha's farmers. He also informed that Omfed is exporting milk and milk products to states like Chhattisgarh, West Bengal, Assam, and the northeastern states.

Experts like Sabyasachi Behera, a farming consultant, pointed out that bank loans for farmers remain insufficient and payment rates from Omfed have not been as lucrative as farmers expect, "The financial system needs to work more efficiently to provide the necessary support to the dairy community. This includes fairer compensation and access to credit to upgrade their farms,'

Behera explains. Soubhagya Ranjan Pradhan, General Manager of Omfed, said, "The government is focusing on Artificial Insemination (AI) services, which can significantly enhance milk production.

KHURDA ROAD-BOLANGIR NEW RAIL LINE PROJECT

TUNNEL T-4 DAY LIGHTING MARKS MAJOR PROGRESS

Bhubaneswar, April 16: A major milestone in the Khurda Road-Bolangir new rail line project was achieved Wednesday, with the successful breakthrough (day lighting) of the 4.185-metre-long tunnel T-4 between Adenigarh and Charich hak stations in Boudh district.

This marks the completion of the longest tunnel not only in the entire project but also in the state of Odisha. In the ongoing project, so far 226km of the total 301km stretch has been commissioned—from Khurda Road up to Daspalla on one end and from Bolangir up to Purnakatak on the other. The remaining 75km stretch between Daspalla and Purnakatak, which includes seven tunnels are currently under con-

struction and is progressing steadily. The successful day lighting of Tunnel T-4 is a significant achievement that will bring the project closer to its goal of connecting Odisha's coastal region with its western hinterland.

Fugitive husband held nine months after wife's murder

Gopalpur, April 16: Nine months after allegedly murdering his newly-wed wife, 32-year-old Lakshmikant Moharana, alias Laxmi, was arrested Wednesday by Golanthara police. The accused, a resident of ODRP Colony in Jagannathpur, Ganjam district, had been on the run since the incident. His arrest was confirmed by Berhampur SP Saravana Vivek M.

According to sources, Lakshmikant married Rani Moharana of Aruapalli village under Gopalpur police limits March 11, 2024. While the initial months were reportedly peaceful. Lakshmikant later began harassing Rani over dowry. both physically and mentally.

July 15, Rani was found hanging, and Lakshmikant claimed it was a suicide. He informed her family, who arrived to find her unresponsive on the bed. She was rushed to MKCG Medical College and Hospital in Berhampur, where she was declared dead.

Rani's brother, Rajesh Kumar Moharana, lodged a complaint at Golanthara police



station, accusing Lakshmikant of murder. A case (No. 291/24) was registered, but Lakshmikant fled the hospital and went into hiding.

Despite continuous search operations, the accused remained untraceable. Meanwhile, Rajesh received threatening voice and video messages from Lakshmikant, urging him to withdraw the case. This led to a second complaint and the registration of a fresh case (No. 154/25) for criminal intimidation.

Acting on a tip-off, a special police team traced Laksh mikant to Visakhapatnam Andhra Pradesh. He was ar rested in a morning raid and produced in court the same evening.

Police also revealed that Lakshmikant has four prior cases against him.

SI arrested for taking bribe to register case

Bhubaneswar, April 16: A sub-inspector (SI) posted at Sarankul police station in Nayagarh district was arrested by Vigilance sleuths on charges of taking ₹4,000 as a bribe for registering a case, an official release said Wednesday. The accused officer was identified as Rajesh Kumar Srichandan.

Acting on a complaint, a trap was laid and the accused policeman was nabbed by the Vigilance team in front of Sarankul police station Tuesday.

The bribe money was recovered from the possession of Srichandan and seized in presence of witnesses, it said.

He was forwarded to the court after demanding and accepting a bribe, the release said.

Later, simultaneous searches were conducted on the residential house of Srichandan at Bhubaneswar and his office room. A case was registered under Section 7 of the Prevention of Corruption (Amendment) Act, 2018. Srichandan entered into the government service as SI of police in 2017 and was posted in various police stations in Nayagarh district.

Borewells go dry for open-pit mining

Jajpur, April 16: Residents of Dharmasala block in Jajpur district are facing a severe water crisis due to unregulated extraction of minor minerals such as sand, granite, and morrum, in blatant violation of Odisha Minor Minerals Concession (Amendment) Rules, 2016.

With the onset of summer, the groundwater table has receded sharply, leaving many borewells dry. In various hills, open-pit mining operations have reportedly reached depths of up to 150 feet, accelerating the depletion of groundwater. While regulations mandate the backfilling of mines post-extraction, nearly 50 mining pits have been abandoned as it is. Some of these pits resemble large ponds. The activities of local author-

ities, who are supposed to ensure enforcement of rules, are limited to collecting data on active mines. Consequently, over a hundred villages at the foothills are now struggling to access clean water.

According to existing regulations, "long hole drills" should not exceed a depth of six metres, and "short hole drills" are restricted to 1 to 1.5 metres. However, many operations have breached these limits, drilling all the way to the water table.

The gravity of the situation can be gauged from the status of groundwater table in villages like Dankari, Madhupurgarh, Kukudakhali, Bhubanpur, Panturi, Ragadipasi, Chadheidhara, Paitara, Daulatpur Gogarsara, Barada, Jhatiapada, Kurikana, Batijoda, Baramana, Chadakamara, Sahanidiha, Antia, Kamagada, Bharatpur, Pachhukhundi, Ichhapur and Bedha.

In some areas, piped water supply schemes have become non-functional. While the local MLA has arranged water tankers for affected regions the assistance is reportedly insufficient to meet the rising demand in the summer.

Meanwhile, iron contamination in groundwater has come as a double whammy for several villages near mining zones. This has led to a surge in kidney-related ailments, with many reported cases of hospitalization, said locals.

Close shave for 50 passengers

BALASORE: At least 50 passengers of a Kolkata-bound bus had a close shave following a head-on collision with a truck in Balasore Wednesday, police said. The incident took place near Soro College Chhak on National Highway-16. "It was a lucky escape for passengers of the bus. Some of them suffered only minor injuries," a police officer said.

Nandapur, April 16: Direct benefit transfer (DBT) scheme might be providing relief to those who are digitally literate and able to visit banks/ ATMs to withdraw money, but it has turned out to be a burden on Shukra Pangi, 79, a differently-abled elderly man of Khadakpur village under Nandapur block in Koraput district who has to spend ₹1,000 on transport to withdraw the same amount as monthly pension.

Reports said Shukra, who lives alone in a dilapidated mud house with no close family to support him, has made an emotional appeal to the administration to provide his monthly pension in cash rather than transferring it to his bank account. Meanwhile, a few of his

relatives have placed a bed on the verandah where he stays all the time as he is unable to move inside. Often, the relatives come, feed him and help him return to the bed, which has become his permanent resting place.

Shukra receives ₹1,000 under Indira Gandhi National Old Age Pension Scheme through State Bank of India in Balda. Since he is unable to register his fingerprints due to old age, and is illit-



erate, he is unable to use an ATM for which the bank has not given him a debit card. Without biometric access or assistance, he is forced to hire an auto-rickshaw to travel from Khadakpur to Balda branch of the bank, which costs him the entire pension amount.

As a result, he can only afford to make the journey once every six months with the help from his relatives. essentially rendering the pension ineffective for his

regular needs, Shukra said. He has appealed to the government to transfer his name to a state-run Madhu Babu Pension Yojana (MBPY) scheme where the money can be delivered to his home via the panchayat-level distribution. Local officials from the block's social security department



Resisting Techno-Fascism

ig Tech's massive encroachment upon the levers of state authority under US President Donald Trump is creating a dangerous new power structure – one not confined to its homeland. Trump's threats against countries – US allies and adversaries alike – that dare to regulate their digital markets and communications systems are not merely a case of economic bullying. Rather, they are an attempt to export this power structure and undermine the rule of law and democratic governance worldwide.

For example, America's European allies risk tariffs and retaliation for enforcing much-needed digital regulations, as do countries, like the United Kingdom and Brazil, that impose a digital-services tax. But these challenges also create strategic opportunities for democracies. If they collectively refuse to submit to US pressure, it is less likely that any one government will bear the brunt of retaliation. These countries must therefore unite against the tech giants that mine their citizens' data, control key information and commercial infrastructure, and refuse to pay taxes or even acknowledge the jurisdiction of national governments.

Of course, defending national interests while fostering genuine innovation is a difficult balancing act. But the unprecedented alliance forged between Big Tech and the Trump administration underscores the urgency of this task. As head of Trump's

"Department of Government Efficiency," Elon Musk, the world's richest person, has gained access to government data systems, fired thousands of federal workers, and taken aim at regulatory agencies. Musk has also used the Federal Trade Commission as a cudgel against businesses that are reticent to advertise on his social-media platform X, which he has turned into a megaphone for right-wing extremists and a tool for disinformation and political interference.

Musk is not the only tech boss to have bent the knee. When Mark Zuckerberg announced in January that Meta, which owns Facebook and Instagram, would end its fact-checking programme, he repeated Trump's talking points. More recently, Instagram concealed results when users searched for "Democrats," and Facebook amplified posts from Trump and Vice President JD Vance.

These are only the most prominent examples of how the world's most powerful tech CEOs have aligned themselves with an authoritarian leader, shaping public discourse to his (and their own) benefit. When tech interests capture the US government to this extent, other countries must stand up to Trump's threats to avert a global slide into techno-fascism.

Some will argue that by taking a strong regulatory stance, these countries risk losing access to technological innovation. But this fundamentally misreads the situation. Given the extraordinary protections and privileges they have secured at home, US tech giants don't need more favourable treatment from other countries. They need access to these countries' markets. Advanced economies

with skilled workforces, including the UK, Japan, and those in Europe, are highly valuable, as are middle-income and emerging economies like Brazil, Indonesia, and India.

The revelation that China's DeepSeek developed a large language model comparable to those of dominant American AI firms at a fraction of the cost has underscored this point. It belies the narrative that only the biggest tech companies with the most advanced chips and the least restrictive regulatory environment can develop the best AI, and shows that alternatives to the Silicon Valley model exist.

So far, Brazil is the only country with the courage and conviction to challenge Musk (albeit before he joined the Trump administration). It is less clear whether Europe, which has recourse to its digital markets and AI directives, will defend its right to regulate and rein in the

Because enforcing competition policy has implications beyond traditional market concerns, more countries should regulate digital services, focusing not just on market dominance, but also on a corporation's ability to shape public discourse, control information flows, and leverage data advantages in order to entrench its power. Allowing Big Tech to pursue unfettered AI development that is environmentally and culturally destructive - or, worse, subsidising such innovation - could pave the way for techno-fascism on a global scale.

Clear rules for protecting competition and intellectual property are far more likely to foster innovation than would enabling dominant players to strengthen their monopoly power. For example, the EU's General Data Protection Regulation has, despite initial resistance, become a global standard, spurring privacy-enhancing innovation and acting as a safeguard against corporate overreach, especially with regard to data mining.

Similarly, requiring credit and compensation for the use of copyrighted materials for AI training is not just about protecting creative industries. It is about integrating the development of these transformative technologies into the fabric of our economies and societies, before a handful of US companies get a chance to "move fast and break things" like democracy and the rule of law – that are not easily repaired.

Instead of accepting a false choice between innovation and regulation, the world's democracies have an opportunity to create the conditions for genuine innovation, not imitation, and show how democratic oversight can enable technological progress while preserving fundamental rights. But this requires recognising that tech policy has become integral to resisting authoritarian tendencies.

Such a stance is not anti-American. In fact, it reflects concerns about the fusion of Big Tech and political power in the US that many Americans share. That makes it all the more important for other governments to ensure that digital technologies serve democracy and protect human dignity.

ighty-two per cent of the persons with disabilities in the country do not have any healthcare protection despite the tall claims of the government to the contrary. Forty-two per cent of them are not even aware of the central government's flagship programme for people's health, Ayushman Bharat Pradhan Mantri Jan Arogya Yojana, according to a recent national survey by the Centre for the Promotion of Employment for Disabled People.

The number of persons with different kinds of disabilities in the country is enormous, 26.8 million or 2.21% of the population, as per 2011 Census. While the next census, which was due in 2021 but postponed to this year, can provide the most dependable update since it covers the entire population, other studies, which, too, cannot be ignored since they are based on scientific statistical sampling methods, have shown a marked increase in this number; the NFHS-5 (2019-21) reported it to be 63.28 million, equivalent to 4.52% of the population.

This is not to say that those already covered under some government-sponsored schemes are getting hassle-free healthcare. No. The overall health of the health sector is not well. The experience of the enrolled suggests that many of the empanelled hospitals refuse the treatment with great impunity: the needy have either to pay, if they can, out of pocket or go without treatment if they can't, live or die with the disease.

Coming to healthcare in general, the pure commercial interest and market force's philosophy takes precedence over the public health responsibility of the government. The health infrastructure is neither adequate nor suitable for the masses. It encourages private profits and helps private insurance. It has a poor 1:15,00 doctor-to-patient ratio and 1.7 nurses to 1,000 people as per Indian Brand Equity Foundation's (IBEF) observation.

The dimensions of the health

sector neglect are multifold. The healthcare public spending in India as a percentage of GDP is set at 1.9% in 2026, whereas other countries are already spending between 5 to 12.5% of their GDP. The US, for instance, spent 16% in 2023, and OECD countries spent 9.2% in 2022.

The private sector in India dominates healthcare in many ways. It accounts for 58% of hospitals. The sector employs 81% of the medical professionals. By 2022-23, there were 43,186 private hospitals with 1.18 million beds and 29.631 ventilators.

The macro data doesn't reflect the true picture because there is a wide gap between rural and urban areas in availability of hospitals and doctors. Also, there are regional imbalances. For instance, Maharashtra has the highest number of allopathic doctors (2.10 lakh), followed by Tamil Nadu (1.49 lakh) and Karnataka (1.41 lakh), as per 2024 data; that means more than 38% of allopathic doctors in India are concentrated in three states.

The inefficient and inadequate healthcare is deepening and widening poverty in India. Due to heavy out-of-pocket spending, an estimated 7% of population about 10 crore - falls below the poverty line every year, as a Niti Aayog report asserts

Besides high medical costs, people have to put up with unethical medical practices by unscrupulous players in the system because there is no effective mechanism to prevent them.

Unscrupulous hospitals accept patients not based on their severity of disease and urgency for treatment but on their paying capacity; those with disease but no money are kicked out while those with sufficient money but no disease get unnecessary treatment. Doctors prescribe tests lured

more by the kickbacks the diagnostic centers offer than by the need for such tests. They write a battery of tests code named "sink tests" with one or two 'marked tests,' Patients are charged for all the tests and blood samples, for instance, are collected for all of them. But the actual test is conducted only for the 'marked test,'; the fake normal results are given for rest of the tests. The excess blood collected is thrown in the sink, so the name 'sink' tests.

Patients are unnecessarily referred to other doctors just to get a cut from them: those who offer higher commissions get higher referrals. Prenatal sex determination tests are conducted defying the legal ban on it.

Unnecessary surgeries are conducted on gullible patients. The types of procedures to make money include hysterectomies, C-section, cataract, knee replacements, and lower back operations.

Pharmaceutical companies supply expensive gifts and medical equipment to entice doctors to prescribe their drugs. Not only gifts but they also offer foreign trips and five-star accommodations to doctors and their families. Poor and illiterate people are used as guinea

The ambulance services are paid bribes for bringing emergency patients to private hospitals. Hospitals force doctors to generate a monthly targeted revenue to justify their high salaries, whereby doctors play mischief by subjecting innocent people to unnecessary tests and procedures.

The Medical Council of India prohibits all these unethical practices, but they have little impact on the errant doctors and hospitals. The National Health Policy 2017, too, commits itself "to the highest professional standards, integrity and ethics." These goals are not achievable without first halting the ongoing mindless commercialisation of the health sector.

While people are worried about grossly inadequate and inaccessible healthcare, the sector flourishes and provides the best facilities to those who can afford them. The IBEF says the Indian healthcare market, which was valued at \$110 billion in 2016, is poised to reach \$635 billion by end of this year.

Indian medical tourism was worth \$7.69 billion in 2024 and is expected to reach \$14.31 billion by 2029; about 6.34 lakh foreign tourists came for medical treatment in India in 2023.

All this suggests that India has a robust health sector and, given the will, that it can be further strengthened and reformed to meet the comprehensive needs of every Indian. What we need is universal healthcare. What we need is the de-commercialisation of the healthcare industry. What we need is to learn lessons from the damage market forces are causing to the health sector and public health. And what we need to do all this, to tell at the cost of repetition, is the will. Does our government have it? It has to prove it through its actions if it has it. The delay causes further damage, and that damage will be irreparable.

f you've ever watched a kettle come to boil, you know the sound-the shrill whistle that grows louder, sharper, more insistent until someone takes notice, turns off the heat, lifts the lid. But what if no one does?

West Bengal today is that kettle. For years, it has simmered with a complex brew of identity politics, economic stagnation, administrative decay, and ideological clashes. The recent surge in political violence, religious polarisation, and law-and-order breakdown is not a sudden phenomenon; it is the steam escaping from a vessel that's long been under pressure, ignored.

Like steam, unrest doesn't appear from nowhere—it builds. The rising communal tensions in places like Sandeshkhali, or the flare-ups between rival political groups in rural districts, aren't isolated sparks. They're symptoms. And they are linked inextri-

cably to a deeper malaise—a governance model caught between populism and paralysis, between legacy politics and new-age opportunism.

Let's pull back. Bengal, once the cradle of the Renaissance and revolution, finds itself trapped in a cycle of reactive politics. The ruling regime positions itself as the custodian of secularism and cultural pride, while the Opposition, riding a wave of nationalistic fervour, taps into grievances and perceived cultural erosion. Caught in between are ordinary citizens who want jobs, education, safety-and silence from the kettle.

The analogy deepens. In a kitchen, the whistle of a kettle isn't just noise—it's a signal. It says, "Something's happening here. Pay attention." But what happens when those in the kitchen wear earplugs? When governance treats symptoms as sabotage, criticism as conspiracy, and protest as provocation?

Take the suppression of dissent. Activists, students, and even journalists who raise questions are branded as "anti-development" or "divisive." The chilling effect is palpable. But it's not silence that ensures peace. It's dialogue, reform, and accountability. A sealed kettle doesn't stop boiling; it explodes.

And there's another parallel: the quality of water in the kettle matters too. Bengal's social fabric has historically been inclusive, layered with rich traditions of syncretism. But in recent years, divisive narratives have polluted that space. Identity is now weaponised-either as a defence of culture or as a call for reclaiming it. When politics invades pujas, processions, and classrooms, the water turns murky. No tea can be brewed from that. Only bitterness.

The solution? First, acknowledgement. Recognise the unrest not as isolated lawand-order issues but as the fallout of long-ignored systemic stress. Second, recalibrate. Bengal needs less theatrics and more therapy. Investment in jobs, education, decentralised decision-making, and transparent law enforcement isn't glamorous, but it's

grounding. Lastly, someone must lift the lid. Civil society, Opposition parties, the media, and responsible leaders must push for truth, not just triumph. Silence the kettle not by turning away but by turning down the heat. Because here's the thing about pressure cookers and democracies—they both need release valves. Without them, they don't just fail—they burst.

And when that happens, the spill burns everyone.

War on ideas

Sir, This refers to "Trump freezes about \$2.3 in funding to Harvard," Orissa POST, April 16. No government — regardless of which party is in power - should dictate what private universities can teach, whom they can admit and hire, and which areas of study and inquiry they can pursue.

Helping China rise

Sir, US President Donald Trump's trade war, marked by steep tariffs on several countries, has created unintended opportunities for China to expand its influence in Southeast Asia. Nations like Vietnam, Malaysia, Cambodia, and Indonesia—some of which were actively seeking closer ties with the US—have been hit with high tariffs ranging from 24% to 49%. This has strained their economic relationships with the US, even as they sought to diversify away from China by attracting Western manufacturing and investment. In contrast, China is stepping in to fill the gap. President Xi Jinping is touring the region, promoting an anti-tariff, pro-trade message and signing economic agreements with Southeast Asian nations. Janasu (Uttarakhand), April 16: Railway Minister Ashwini Vaishnaw witnessed the breakthrough of India's longest rail tunnel at Janasu in Uttarakhand Wednesday.

Accompanied Minister Pushkar Singh Dhami, Vaishnaw went about 3.5 km inside the tunnel when a boring machine achieved the breakthrough from the other side breaking last layer of rock. The 14.57-km-long tunnel no 8

between Devprayag and Janasu is part of the ambitious 125-km Rishikesh-Karnaprayag Broad Gauge Rail Link Project in Ut-

Vaishnaw called it a historic moment as the breakthrough coincided with the day rail service was started in India April 16. 1853. Rail Vikas Nigam Limited (RVNL), a public sector undertaking under the Ministry of Railways, which is looking after the whole project, achieved this breakthrough using a German-made tunnel boring machine (TBM) named 'Shakti'.

Since Tunnel 8 is a twin tunnel, the work on another parallel one is going on with the help of the second TBM and it is expected to achieve breakthrough by July. The work contractor for this tunnel is L&T

"The remarkable feat was achieved in the presence of

Hon'ble Railway Minister Ashwini Vaishnaw, who visited the site to mark this momentous milestone in Himalayan rail connectivity," a statement from RVNL said.

Earlier, RVNL CMD Pradeep Gaur had told PTI that this is the first time TBM technology has been deployed for rail tunnelling in mountainous regions of the country, and the progress sets a new global benchmark with a 9.11-m diameter single-shield rock TBM.

Gaur has mentioned that the 9.69-m diameter Cabrera tunnel in Spain was built by a double shield TBM at an average rate of 423 m per month while the 14.58-km tunnel between Devprayag and Janasu has just been completed by Single Shield TBM at an average rate of 413 metres per month, becoming the second fastest in the world.

"More than 83% of the 125km alignment passes through tunnels, involving over 213 km of tunnelling across main and escape routes," it added.

The tunnel also lies in tectonically active Seismic Zone IV, requiring sophisticated design and continuous advance geological probing, they added.

Amravati, April 16: Maharashtra Chief Minister Devendra Fadnavis Wednesday inaugurated an airport at Amravati in eastern parts of the state, where he said a pilot training school coming up nearby will be the largest such institution in South East Asia.

Sambhajinagar zoo helping tigers beat the heat with air coolers

Chhatrapati Sambhajinagar, April 16: The tigers at the Siddharth zoo in Maharashtra's Chhatrapati Sambhajinagar are being given multiple showers, and air coolers are being used to help them cope with the rising temperatures, an official said Wednesday.

The zoo has a dozen big cats, which are warm-blooded animals. Dr Neeti Singh, a veterinarian at Siddharth zoo, said that the tigers are being given showers twice a day. The water supplied to the tank for the tigers to sit or drink is changed almost every hour so that it doesn't get hot, said Singh.



The zoo has installed air coolers to help the tigers beat the heat, she said.

According to the India Meteorological Department, the maximum temperature recorded in Chhatrapati Sambhajinagar Wednesday stood at 41.4 degrees Celsius.

The more water the tigers consume, the better hydrated they will be, and their electrolyte balance will be maintained, said the vet.

"Food is being served to the tigers in the morning itself because they are not much interested in eating in the afternoon. Tigers are often less active these days (summer)," Neeti Singh.

Water showers have been also installed for other animals in the zoo, she added.

HC orders removal of debris

Nainital, April 16: The Uttarakhand High Court Tuesday ordered the removal of debris from the Rispana river besides seasonal streams, and the identification of unauthorised constructions on water bodies in the Vikas Nagar area of Dehradun district.

The order was issued by a bench comprising Chief Justice G Narendar and Justice Alok Mehra while hearing three PILs filed by Dehradun residents Urmila Thapa, Renu Paul and Ajay Narayan Sharma.

It was alleged in the PILs that the constant dumping of debris in the rivers and streams has led to encroachment. It was also killing the local and seasonal streams that contribute to the Rispana river, the PILs said.

The court had passed a similar order earlier too saying that the debris should be removed as it is a question of the survival of future generations.

The same bench of the high court had said, "If we continue with this, the future generations will curse us".

The Chief Justice also said these streams help in preventing landslides. If the debris

will go haywire, causing floods land erosion and landslides. RK Sudhanshu, principal

secretary (forest), Nitesh Jha. secretary (urban development) Surendra Narayan Pandey secretary (revenue) also at tended the hearing via video conferencing. In an affidavit filed by the secretaries and the municipal corporation, it was said that by the end of June all structures will be removed subject to the review of the environmental board.

The court said the main issues of the PIL were related to the removal of debris from seasonal streams as well as rivers and identifying the structures that were constructed on water bodies. The High Court asked the officials to conduct a survey to identify such structures built on water bodies and remove

The court also suggested the use of GPS to identify such structures.

While the Advocate General claimed that a similar matter has also been addressed by the NGT, the chief standing counsel pointed out that Namami Gange Project protects water

Authorities order restoration of mangroves by removing encroachments

Mumbai, April 16: The Mangrove Cell of the Maharashtra government has directed the authorities to restore the mangroves by removing encroachments and debris at two locations in Mumbai's Borivali area

after site inspections showed unauthorised reclamation of the protected coastal zone.

Officials of the forest and revenue departments, Mangrove Cell and local administration conducted separate surveys at Chikuwadi and Eksar villages in Borivali west after receiving complaints of encroachments in protected green zones

PTI is in possession of a copy of the order dated April 15. The first inspection was carried out April 11 following a complaint filed by former BJP MP Kirit Somaiya, it said.

He accompanied officials to survey land parcels at Chikuwadi. The inspection team found encroachment, landfilling and use of green zone land for film shooting and construction of temporary film sets without



prior approval, the order said. The inspected area was located within 50 metres of the mangrove zone as marked in the Maharashtra Remote Sensing Application Centre (MRSAC) maps of 2005 and 2018. These maps confirmed the presence of mangroves and mudflats in the concerned regions earlier, it added.

Officials cited violations under the Environment (Protection) Act, 1986, and recommended removal of unauthorised structures and restoration of the affected sites. The report was submitted to senior authorities for further legal action.

In the second inspection conducted last week at Eksar

village, officials examined two private plots following complaints from residents regarding alleged land reclamation. The complaint, filed by Somaiya with the Mumbai Suburban Collector, alleged that approximately 30 acres of mangrove buffer zone had been illegally reclaimed through dumping of debris.

The collector's office submitted a report stating that the first plot, owned by a private developer, was surrounded by tin sheets and filled with debris to reclaim the land. Satellite imagery and maps from 2005 and 2018 showed the presence of mangroves and mudflats, confirming that the plot falls within the designated 50-metre buffer zone. The mangroves in the area were found to have been removed.

The second plot was also found to have been reclaimed using mud, murum and debris Mangroves at this location were found to have been similarly af fected. The site also lies within the 50-metre buffer zone as per of ficial records and satellite maps.

As per the order, this plot is owned by Niranjan Lakhuma Hiranandani, a prominent re al estate developer in the state capital. In the order, the Mangrove Cell has recommended a detailed inquiry under the En vironment (Protection) Act by the state environment depart ment and the Brihanmumbai Municipal Corporation (BMC) Officials have also been advised to register appropriate offences under relevant environmental regulations.

Kabirdham collectorate gets bomb threat

Kawardha (Chhattisgarh): The Kabirdham district collectorate in Chhattisgarh Wednesday received a bomb threat, which turned out to be a hoax after a thorough search of the premises, an official said. The threat message was received on the official email ID of the Kabirdham collector, following which police were alerted, Additional Superintendent of Police Pushpendra Singh Baghel told PTI. The email, sent by an unidentified person, stated "an improvised explosive device was planted in the Collectorate office and we will blow it up by 2.30 pm", he said.

Low-intensity blast triggers panic

Imphal/ Churachandpur: A low-intensity explosion triggered panic in Manipur's Churachandpur in the early hours of Wednesday, officials said. The blast happened at Elim Veng near the Jamsuan-Sahei roads junction, they said. No one was injured in the explosion, they added. Locals claimed that some persons came to the area around 1 am on a twowheeler, hurled the bomb and left. Police said an investigation was underway to identify those behind the blast.

Four kids killed in cylinder explosion

Muzaffarpur: Four children were killed in a fire triggered by the explosion of multiple cooking gas cylinders in Bihar's Muzaffarpur district Wednesday, officials said. The incident happened in Rampurmani village in the Barivarpur police station area in the morning, they said. The deceased were identified as Vipul Kumar (5), Beauty Kumari (8), Hansika Kumari (3) and Shrishti Kumari (4). they added. "Prima facie. it appears that the fire was caused by cylinder blasts. Four children were charred to death in the incident." District Magistrate Subrata Sen said.

AAP councillors stage protest

New Delhi: AAP councillors, led by Mayor Mahesh Kumar, staged a protest outside the MCD Commissioner's office Wednesday, demanding implementation of proposals to regularise 12,000 employees. LANGUAGE NOT RELIGION: SC ON URDU

Dismissing a plea challenging the use of Urdu in the signboard of a municipality in Maharashtra, a bench of Justices Sudhanshu Dhulia and K Vinod Chandran Tuesday also said "language is not religion"

New Delhi, April 16: Urdu is born in this land, the Supreme Court has said while describing it as the finest specimen of 'Ganga Jamuni tahzeeb' and stating that considering it a language of Muslims is a "pitiable digression" from reality and unity in diversity Dismissing a plea challeng-

ing the use of Urdu in the signboard of a municipality in Maharashtra, a bench of Justices Sudhanshu Dhulia and K Vinod Chandran Tuesday also said "language is not religion". "Language is culture. Language is the yardstick to measure the civilisational march of a community and its people. So is the case of Urdu, which is the finest specimen of Ganga-Jamuni tahzeeb, or the Hindustani tahzeeb, which is the composite cultural ethos of the plains of northern and central India...We must respect and rejoice in our diversity, including our many languages," the bench said.

The top court was hearing an appeal filed by Varshatai, a former councillor of Patur in Maharashtra's Akola dis-



trict, who challenged the use of Urdu, along with Marathi, on the name board of the municipal council. According to her, the work of the municipal council can only be conducted in Marathi. The use of Urdu in any manner is impermissible even though it may just be a writing on the signboard of the council, she said in her plea.

The apex court court noted that the municipal council had retained Urdu on the name board because many local residents understood the language.

"All the municipal council wanted to do was to make an effective communication," it

said. Urdu developed and flourished in India due to the need for people belonging to different cultural milieus who wanted to exchange ideas and communicate amongst themselves, the court stated.

The top court said the language used by the masses is replete with Urdu even if one is not aware of it. "It would not be incorrect to say that one cannot have a day-to-day conversation in Hindi without using words of Urdu or words derived from Urdu. The word 'Hindi' itself comes from the Persian word 'Hindavi'," the bench said. The court said the fusion of Hindi

and Urdu met a roadblock in the form of the puritans on both sides and Hindi became more Sanskritised and Urdu more Persian. "A schism exploited by the colonial powers in dividing the two languages on religion. Hindi was now understood to be the language of Hindus and Urdu of the Muslims, which is such a pitiable digression from reality; from unity in diversity; and the concept of universal brotherhood," it said.

The court said a municipal council provides services to the local community and caters to their immediate day-to-day

"If people or a group of people, residing within the area covered by the Municipal Council are familiar with Urdu, then there should not be any objection if Urdu is used in addition to the official language i.e. Marathi, at least on the signboard of the Municipal Council. Language is a medium for exchange of ideas that brings people holding diverse views and beliefs closer and it should not become a cause of their division." the court said.

Murshidabad riots pre-planned: Mamata

Kolkata, April 16: West Bengal Chief Minister Mamata Baneriee Wednesday termed the communal violence in Murshidabad as "pre-planned", accusing BSF, central agencies and the BJP of orchestrating tension by allegedly facilitating outsiders and enabling cross-border influx from Bangladesh.

Addressing a meeting with Muslim clerics, Banerjee urged PM Narendra Modi not to implement the "atrocious" Wagf (Amendment) Act, warning that it would divide the country, and requested him to rein in Union Home Minister Amit Shah, whom she accused of "harming the nation most for his own political agenda".

The TMC supremo claimed that despite the volatile situation in Bangladesh, the Centre rushed through the Act and allowed cross-border infiltration, both of which, she alleged, contributed to the unrest in Bengal. The Opposition BJP, however, dismissed the allegations as baseless and demanded Baneriee's resignation, accusing her of being more focused on

"appeasement politics"

Banerjee also alleged that a section of the BSF and certain central agencies under the home ministry played a "role in facilitating the violence", and ordered a probe into the role of the border force. "I came across news quoting home ministry sources claiming the role of elements from across the bor der in the Murshidabad unrest Is it not the role of the BSF to guard the border? The BSF is under the MHA. The state gov ernment does not guard the in ternational border. The Centre can't evade responsibility," the chief minister said.

"I will find out whom the BSF had financed in the border areas by paying money to local youths to pelt stones during the violence," she alleged. Baneriee announced compensation of ₹10 lakh each for the families of the deceased and instructed the chief secretary to initiate a formal inquiry into the BSF's actions, including the alleged opening fire during the violence. The CM accused Shah of misusing central agencies and orchestrating a systematic propaganda campaign to malign the image of Bengal.

HC reserves order on Kamra plea against FIR

Mumbai, April 16: The Bombay High Court Wednesday reserved its order on comedian Kunal Kamra's petition seeking the quashing of an FIR registered against him for allegedly making defamatory remarks against Maharashtra deputy Chief Minister Eknath Shinde, and granted him interim protection from arrest.

A division bench of Justices S Kotwal and S Modak, after hearing arguments from both sides, reserved its order.

It directed the Mumbai police not to arrest Kamra till the order is passed in the matter. A First Information Report has been registered at Khar police station here against the stand-up comedian for allegedly calling Shinde "gaddar" (traitor) during a show in the $metropolis.\ Workers\ of\ Shinde's$ party, Shiv Sena, also vandalised the studio where the show had been recorded.

Kamra's lawyer Navroz Seervai pointed out that opposition leaders hurled the traitor slur at Eknath Shinde during the 2024 Maharashtra assembly polls campaign, but no action was taken. But the comedian has been terrorised and victimised, and in the process a stern message has been sent to artistes, through the police, that "if we don't like it, this is what we will do to you", he said.

During the show. Kamra sang a parody version of a song



from the film "Dil To Pagal Hai" which used the word "gaddar". He then went on to joke about how Shinde rebelled against Uddhav Thackeray and split the Shiv Sena in 2022.

Seervai submitted that in the past, NCP leader Ajit Pawar, now deputy chief minister. had commented that `it's time to teach a lesson to the traitor who halts the good work of the government'. But no complaint was filed, the lawyer added.

Aiit Pawar was then part of the Maha Vikas Aghadi government, consisting of the undivided Shiv Sena, NCP and Congress, before Shinde broke away and joined hands with the BJP.

Seervai further highlighted that the opposition's entire campaign during the 2024 assembly elections was fought on this issue, with a booklet tilted "Panchanama (inspection report) of the traitor Eknath Shinde government" being released.

As she was on the ventilator, she could not speak and was in a semi-conscious state, she claimed. "...I could hear all the sounds and proceedings there. The man asked for inventory from both the nurses. The nurses started giving their details." "Then I heard the man asking the nurse about the size of my waistband and said that he would check it himself. In the meantime. I felt that the man had put his hand under the bedsheet from my right side," she said and described how the man allegedly carried out digital rape on her in the presence

"After that, he covered the sheet up to my nose and asked if it was okay, I nodded," the victim said in her statement, adding she was scared and unable to move or speak at that point. "Soon after a nurse came and asked how there was blood on the sheet while she had just changed the sheet. The other nurse said that maybe the periods have started but she was afraid and didn't tell anyone anything," the woman was quoted as saying in the FIR."

"On April, 13 the hospital discharged me in the evening and I came to the hotel with my husband. On the next day, I told it to my husband and he dialled 112 and called the police. This is very wrong that happened to me during my treatment in the hospital and I want strict action against the hospital staff," the woman said. The woman, in her complaint, stated that she came to Gurugram for training on behalf of her company. While staying in a hotel here, her health deteriorated following a drowning incident, after which she was admitted to a private hospital for treatment and then shifted to Medanta.

Gurugram police spokesperson Sandeep Kumar said, "A probe is underway and we are trying to identify the accused first." Following the complaint, an FIR was registered against unidentified staff members of the hospital at Sadar police station Monday.





The action is being taken against the Surana Group and Sai Surya Developers. The raids are being undertaken at premises located in Secunderabad, Jubilee Hills and Bowenpally, the sources said.

Stubble burning: 770 farmers booked

Indore: The Indore district administration in Madhva Pradesh has imposed fines of ₹16.7 lakh on 770 farmers for allegedly burning stubble, an official said Wednesday, Farmer organisations have objected to the action, demanding alternative arrangements. "We are taking strict action under the rules and regulations against those who burn stubble in the fields," Indore Collector Ashish Singh told reporters. He said that the burning of stubble in the surrounding villages is affecting the air quality of Indore, which has the status of the cleanest city in the country. Another administration official said that a total fine of ₹16.71 lakh has been imposed on 770 farmers within the last four days for burning stubble in the district.

TREE FELLING IN HYDERABAD

SC: Will go out of way for protection of environment

New Delhi, April 16: The Supreme Court Wednesday questioned the Telangana government over its "tearing urgency" to fell trees on a land parcel next to the University of Hyderabad and said it would go "out of the way" for the protection of the environment.

Making it clear that the apex court's first concern was restoration of the environment, a bench of Justices BR Gavai and Augustine George Masih said not a single tree more should be felled on this land. "If you want your chief secretary or the secretaries to be saved from any severe action, you have to come out with a plan as to how you are going to restore that 100 acres," Justice Gavai told senior advocate Abhishek Singhvi, who was appearing for Telangana.

The bench said it was surprised to see videos in which herbivore animals were running for shelter. It said it was also told that some of these animals were bitten by stray dogs. "We direct the wildlife warden of the state of Telangana to examine and put into effect immediate steps that are required to be undertaken for protecting the wildlife which has been affected on account of deforestation of 100 acres," the court said.

Justice Gavai said, "You can' have high rises in the company of the deer." The bench said rather than justifying it, the better course for the state would be to come up with a plan on restoring the tree cover. "What was the tearing urgency to do it in three days of holidays?" Justice Gavai asked. The bench said it was only bothered about the environment and how the state would restore

it. "For the protection of the environment and ecology, we will go out of the way," it said, adding that under Article 142 of the Constitution, the top court can "do anything". Article 142 of the Constitution provides broad powers to the apex court to pass any order to ensure "complete justice" in any matter before it. Singhvi said all activities in the area in question have been stopped.

He said fake images of elephants were being circulated. The bench observed it was only concerned with how a large number of trees were felled without the permission of the competent authority and how bulldozers were used for erasing the 100-acre area.

Highlighting the importance of sustainable development and protection of the environment. the bench said that even for important projects like the Chardham project in Uttarakhand, the Centre had to fight for years in court. At the outset, Singhyi told the bench that the Central Empowered Committee (CEC) has filed a voluminous report in the matter and the state needed some time to respond to it.

The bench granted four weeks to Telangana to file its response to the CEC's report and posted the matter for next hearing May 15. The bench asked whether the state had the permission of the tree authority for the felling of trees.

When the bench was told that some of the trees were exempted by self-certification, the court referred to an order passed by it in December 1996. which dealt with the meaning of the word "forest", and asked, "Are they above the orders of the Supreme Court?'

Senior advocate K Parameshwar, assisting the court as an amicus curiae, said according to the CEC report, the state had mortgaged the land in the area to a private party for ₹10,000 crore. Singhyi said the state wanted both employment and development without any harm to the environment.

The apex court asked whether the bulldozers have been removed from the site. Singhvi said there were "unemployed bulldozers"

US VP Vance to visit India early next week



New Delhi, April 16: US Vice President JD Vance and his wife Usha, the first Indian-American Second Lady. are set to visit India early next week that will see him hold talks with Prime Minister Narendra Modi.

The US vice president will travel to Italy this week and then to India, a spokesperson of Vance told CBS News. The Vances are expected to bring their three young children -Ewan, Vivek, and Mirabel -- to India and the family is expected to travel to Jaipur and Agra besides visiting New Delhi.

The US vice president is travelling to India against the backdrop of Trump's policy on tariffs that triggered massive trade disruptions and fears of a global economic recession. Days after his reciprocal tariff kicked in this month. Trump announced a 90-day pause on it on all countries, except China as countries around the world wilted under the impact of the seismic action.

US National Security Adviser Michael Waltz had also planned to visit India early next week but the trip has been postponed, people familiar with the matter said. Vance's visit is likely to be more of a private trip though it will have official components. the people cited above said.

It is learnt that the US Vice President will hold talks with Prime Minister Modi April 21 which will cover various aspects of India-US ties including the issue of tariff and the ongoing negotiations between the two sides for a bilateral trade agreement. CBS News said Vance is undertaking a seven-day visit to Italy and India that will begin Thursday.

Govt bans production of 35 combination drugs

New Delhi, April 16: Apex drugs regulatory body CDSCO has directed drug controllers of all states and Union territories to stop manufacture, sale and distribution of unapproved 35 fixed-dose combination drugs that include painkillers, nutrition supplements and anti-diabetics.

They have also been asked to review their approval process for such fixed dose combination drugs (FDC) and ensure strict compliance of the provisions of the Drugs and Cosmetics Act 1940 and rules.

FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio

The regulator issued the directions after it found that certain FDC drugs have been licensed for manufacture, sale,

evaluation of safety and efficacy, posing a serious risk to public health and safety. In a communication sent April

11, Drugs Controller General of India (DCGI) Dr Rajeev Raghuvanshi referred to the letter issued by his office January 2013 where concerns were raised regarding the grant of manufacturing licenses for sale of FDC drugs that fall under the definition of a

"New Drug" in the country without due approval from DCGI. The same concern has been

raised from time to time and multiple letters have been issued to the respective state licensing authorities that granted permission for manufacturing and marketing of unapproved FDCs. The most recent such letter was issued in February this year.

"It has come to the notice

FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio

of this directorate that certain FDC drugs have been licensed for manufacture, sale, and distribution without prior evaluation of safety and efficacy as per the provision of NDCT Rules 2019 under the Drugs and Cosmetics Act 1940. This poses a serious risk to public health and safety," the letter stated.

The approval of such unapproved FDCs compromises patient safety and may lead to adverse drug reactions, drug interactions, and other health hazards due to the absence of scientific validation, the letter

underlined. Upon issuance of show cause notices to the manufacturers, they have stated that these licenses were granted by the respective drug licensing authorities and have not violated any rules, it said.

"In view of the above, all state and union territory drug controllers are requested to review their approval process for such FDCs and ensure strict compliance of the provisions of the act and rules," the letter said.

The letter also listed out 35 unapproved FDCs which were earlier licensed by state/ UT drug controllers for manufacture, sale, and distribution without evaluation of safety and efficacy by Central Drugs Standard Organisation (CDS-CO) and later on cancelled by Drug Licensing Authorities (SLAs) or voluntarily surrendered by manufacturers following the issuance of show cause notices for reference.

YouTuber kills hubby with help of friend; dumps body in drain

Chandigarh, April 16: A 28-year-old YouTuber allegedly murdered her husband with the help of a male friend, also a content creator, after he object ed to their "intimacy" and her social media activities. The duo carried the body on a motorcy cle and dumped it in a drain in Haryana's Bhiwani, where it was found three days later. police said Wednesday.

"Both the accused -- Ravina and Suresh -- have been arrested and further investigations are on," the Station House Officer of Sadar Bhi wani, Inspector Narender, said. The police said that they found CCTV footage where the two accused were seen riding a motorcycle purportedly car rying the body on a deserted road road late in the night. The victim, identified as

Prayeen (32), was murdered March 25 after he had an argument with his wife Ravina in Suresh's presence at their home. "Ravina used her dupatta to strangle Praveen and he was also hit on the head by the two accused," the SHO said.

The woman returned to her home after the two threw the body in a drain. Concerned about Praveen's whereabouts his family filed a complaint with the Bhiwani police March 26. A police official from Bhiwani said the couple got married eight years ago and have a six-year-old son.

It is claimed that arguments used to break out frequently between Ravina and Praveen, who objected to her posting videos on social media and de voting a lot of her time to such activities, the official said. The police said during the past few months their marriage had be come strained over Ravina's "intimacy" with Suresh, whom she met on Instagram nearly two years ago.

Maldives bars Israeli passport holders

Male: The Maldives has changed its immigration law to bar Israeli passport holders from the country over the war in Gaza. The amendment was passed by Parliament Monday and approved by President Mohamed Muizzu Tuesday, according to a statement from the president's office. It was not immediately clear whether the law would apply to dual nationals who have passports from both Israeli and another country. The Cabinet took the decision nearly a year ago but the government did not formalise it until this week. "The ratification reflects the government's firm stance in response to the continuing atrocities and ongoing acts of genocide committed by Israel against the Palestinian people," the statement said.

Plane with Indians makes emergency landing

Kathmandu: An aircraft with 12 Indians on hoard Wednesday made an emergency landing at the Kathmandu airnort here after experiencing a hydraulic system failure. Private airline Sita Air plane from Lukla, the gateway to Mount Everest region, to Ramechhap, about 140 kilometres southeast of Kathmandu, was diverted to the Tribhuvan International Airport after the technical fault was detected, an airline official said. The RCP welcomed her as the "first Indo-Asian Muslim president" and the fifth woman to lead the physicians' group dating back to the 16th century. The voting in the presidential contest concluded Monday and the official start date for her four-year term is yet to be confirmed. "As president, I will lead the RCP to be the best organisation it can be, supporting our members throughout every career stage to deliver the best possible healthcare for our patients,"

New Delhi, April 16: India is ramping up efforts to become a global arms supplier, targeting countries that have traditionally relied on Russian weaponry. Prime Minister Narendra Modi's government is offering long-term, low-cost loans through the state-owned Export-Import Bank (EXIM) to attract new buyers, including nations considered too risky for traditional financing.

This push is part of a larger strategy to transform India into a defense manufacturing hub, adding helicopters, missiles, and battleships to the country's growing exports of iPhones, pharmaceuticals, and ammunition.

India, now the world's largest arms importer after Ukraine, is increasing its diplomatic footprint with more defense attachés posted in Africa, South America, and Southeast Asia. These officials will help identify potential buyers and promote Indian-made arms directly to



like Algeria, Morocco, Guyana, and Cambodia are being targeted for their long-standing

defense ties with Russia. India's move comes amid a global rearming trend and changing geopolitical alliances. Russia's invasion of Ukraine disrupted traditional arms supply chains, pushing countries that relied on Moscow and Washington to seek

One standout example is Armenia, a former Russian ally now shifting toward Indian suppliers. From 2022 to 2024, India supplied 43% of Armenia's imported arms, up from nearly nothing earlier.

With EXIM-backed financing, a growing export portfolio, and geopolitical timing, India is fast becoming a serious player in the global arms trade challenging Russia in markets where it once held near-monop-

Xi to Asian nations: Reject conflict, protectionism

Kuala Lumpur, April 16: Chinese President Xi Jinping called Wednesday for Asian nations to unite in resisting geopolitical confrontation, unilateralism and protectionism, as he aims to consolidate ties with some of China's closest neighbours amid a deterioration of relations with the US.


Xi is in Malaysia as part of a three-nation Southeast Asian trip that includes Vietnam and Cambodia.

China and Malaysia reached a consensus on deepening cooperation in various fields. Xi said after witnessing the exchange of 31 agreements with Malaysian Prime Minister Anwar Ibrahim, ranging from trade and tourism to railway transportation and agriculture. No details were provided for the agreements.

"In the face of shocks to the current international order and economic globalisation, our two nations will stand united with other countries in the region to jointly resist the undercurrents of geopolitical and camp-based confrontation, overcome the countercurrents of unilateralism and protectionism, and safeguard the promising prospects for development in our shared Asian home," Xi said at a function

with Anwar. Xi's comments come after US President Donald Trump, who took office in January, shocked markets by imposing sweeping tariffs on countries across the world. While some of the tariffs have since been delayed, Beijing faces 145% duties.

As part of his "America First" policy, Trump has also pulled the US out of the World Health Organization, hollowed out USAID and halted international aid.

London, April 16: The United Kingdom's highest court ruled Wednesday that the definition of a woman under equality legislation referred to "biological sex", but it said trans people would not be disadvantaged by its landmark decision

The Supreme Court's judgment related to whether a trans woman with a gender recognition certificate, a formal document that gives legal recognition of someone's new gender, is protected from discrimination as a woman under Britain's Equality Act.

The landmark case is the latest example of the wider debate around transgender rights ending up before the courts. Campaign group For Wom-

en Scotland had argued rights under the Equality Act should only apply based on a person's biological sex. It had challenged guidance issued by the devolved Scottish government that ac-

companied a 2018 law designed to increase the proportion of women on public sector boards.

After For Women Scotland had lost in the Scottish courts, the Supreme Court ruled in the campaign group's favour after an appeal last November, a decision greeted by cheering outside the building.

India eyes ending import tax on US ethane and LPG

New Delhi, April 16: India plans to end taxes on US eth ane and liquefied petroleum gas (LPG) imports under broader negotiations with Washington as it looks to reduce its trade surplus and ease its tariff bur den, three sources familian with the matter said.

The proposal to get rid of duties for the products used for cooking gas and petrochemical production comes as India mulls scrapping import tax for US liquefied natural gas (LNG) and boosting purchases of the fuel from the United States.

As President Donald Trump's sweeping duties rattle economies and markets, several Asian countries running trade surpluses with Washington are looking to import more US energy in hopes of avoiding heavi er tariffs.

India levies import taxes of 2.5% on ethane, mainly used as a feedstock for producing pet rochemicals, and propane and butane, which are used for LPG used mostly as cooking fuel. In the 2023-24 fiscal year

India imported 18.5 million metric tons of LPG worth \$10.4 billion, according to Indian gov ernment data, mostly from the Middle East.

It is the No 2 buyer of US ethane after China, according to the US Energy Information Administration, importing 65,000 barrels per day last year. compared with 227,000 bpd for China. However, the US-China trade war has sent tariffs surg ing and is likely to curtail Chi na's imports.

New Delhi and Washington agreed in February to work on the first phase of a trade deal to be concluded late this year with a view to growing bilateral trade to \$500 billion by 2030 and reducing India's \$45.7 billion trade surplus.

From EVs to deceit: BluSmart-Gensol scandal shocks startup world LOANS, BOUGHT FLAT IN DLF CAMELLIAS, SAYS SEBI ORDER **BLUSMART PROMOTERS DIVERTED EV**

Mumbai, April 16: In a shocking revelation, Gensol Engineering Limited (GEL) promoters Anmol Singh Jaggi and Puneet Singh Jaggi have been found to be diverting funds meant for electric vehicle (EV) procurement to buy a luxury apartment in Gurugram's upscale residential project -- The Camellias by DLF.

The findings were part of an interim order issued by the Securities and Exchange Board of India (SEBI) April 15, which has led to a major crackdown against Gensol Engineering Limited (GEL) and its promoters

The SEBI has barred both Jaggi brothers from holding any directorship in the companv and restricted them from accessing the securities market. According to the regulator, loans taken to buy EVs for the ride-hailing service BluSmart were routed through multiple entities and ultimately used for personal gains. "Funds availed by Gensol as

loans for procuring EVs were. through layered transactions, partly utilised for buying a high-end apartment in The Camellias, Gurugram, in the name of a firm where the MD of Gensol and his brother are designated partners," the market regulator said in its interim order. "It was separately noted that

Rs 5 crore, which was initially paid as booking advance by Jasminder Kaur, mother of Anmol Singh Jaggi, was also sourced from Gensol. Further, it was noted that once DLF returned the advance to Kaur, the funds did not go back to the Company but were instead credited to another related party of Gensol,"

the SEBI added.

The market regulator found that Gensol Engineering had Finance Corporation (PFC).

Out of this, Rs 664 crore was

allocated specifically for buying 6.400 EVs, which were supposed to be leased to BluSmart.

However, the company revealed in a stock exchange filing in February 2025 that only 4,704 EVs had been procured so far.

saying that the total cost of these vehicles was Rs 568 crore. This left a gap of around Rs

262 crore, which, the SEBI noted, remains unaccounted for, even a year after the company received the last tranche of loan funds.

The SEBI's investigation showed that once the funds were transferred from Gensol to Go-Auto -- allegedly for purchasing EVs, the money was often routed back to Gensol or to entities closely connected to the Jaggi brothers.

In one such case, a large part of the loan amount received from the IREDA in 2022 was transferred to Capbridge, a related party.

Capbridge then sent Rs 42.94 crore to DLF for an apartment in The Camellias project. DLF confirmed that the money was used to buy the property in the mol and Puneet Singh Jaggi are designated partners. Gensol Engineering's shares







In the bronze medal contest, India's Manu Bhakar and Ravinder Singh (6) missed out on a podium finish after losing to Chines pair of Qianke Ma and Yifan Zhang (16).

The duo of Suruchi and Saurabh made the gold medal match at the Las Palmas range with a combined 580 in qualification, with the former outscoring her more experienced partner by a couple of points. The Chinese pair of Yao Qianxun and Hu Ka topped the qualification with 585.

In the decider as well, the Chinese pair got a head-start, running off to a 2-6 and 4-8 advantage, before a time out called by coach Samaresh Jung brought a change in the momentum of the match.

Suruchi shot splendidly throughout and the couple of times she missed the 10-ring, her Tokyo Olympian partner made up with high 10s, including a 10.9 for his first hit of the match.

The pair regained the lead they had lost after the first series of single shots, in the 10th series, going ahead 11-9 after a tied eighth series had levelled the scores at 9-9. They did not



look back thereafter and needed just the next three series to wrap up the win as the Chinese misfired first under pressure.

They did it in style too, closing out with 10.6 (Suruchi) and 10.5 (Saurabh) with both the Chinese failing to hit the 10-ring.

Earlier Tuesday, Suruchi produced a sterling performance in the 10m air pistol event to clinch her second consecutive ISSF World Cup gold, while Paris Olympics medallist Manu Bhaker bagged the silver to ensure India's domination in the competition.

The Jhajjar-based Suruchi. 18, who had won her maiden

World Cup gold in the season's inaugural global event recently, tallied 243.6 in the 24-shot final, to leave Manu 1.3 points behind her. China's Yao Qianxun took the bronze.

Suruchi and Manu's podium finish meant that India collected one medal of each colour on the day, with men's 10m air pistol marksman Saurabh Chaudhary earlier winning a bronze.

There were clear indications during the 60-shot qualification round that the Indian duo would comfortably make it to the finals from a 28-strong field. Suruchi took the second spot with a regulation 582, while Manu was fourth with 578. Sainvam, the third Indian in

the fray, was 11th with 571. Suruchi was at a different level in the final, carrying on her superb form in the last few months to quickly move to second after the first series

of five shots. Yao had taken an early lead and Manu was fourth with Uruguay's Julieta Jimenez, who shot a good final, in third at that stage.

The teenager scored better on the last two shots to beat the more experienced Manu and extend a sensational run of form. which began with the nationals in December last year.

DC beat RR in thrilling Super Over

BID TO HOST 2030 CWG

India face competition from Canada, Nigeria

London, April 16: India will face competition from Canada, Nigeria and two other countries in its bid to host the centenary Commonwealth Games in 2030, Commonwealth Sport (CWS) announced Wednesday.

The confirmation from CWS comes less than a month after PTI, quoting a top sports ministry source, reported that India, also aiming to host the 2036 Olympics, submitted its bid to organise the 2030 Commonwealth Games in Gujarat.

CWS said that it had received 'Expression of Interests' (EOIs) from Canada and Nigeria, besides two more unnamed countries, to host the 2030 edition of the Games.

In all, seven countries have expressed interest in hosting future Commonwealth Games with five of those focused on staging the centenary edition. CWS also added that New Zealand are one of two nations that want to host the 2034 edition.

"Africa, Americas, Asia, and Oceania make up the regions from which the EOIs have been submitted. Canada, India, and Nigeria have already publicly confirmed that they

have lodged an EOI for the 2030 Commonwealth Games, with two additional nations also confirming their interest in 2030. Two EOIs are focused on the future Games pipeline, includ ing New Zealand who have pre viously signalled their interest in hosting 2034, Commonwealth Sport said in a statement.

Commonwealth Sport CEO Katie Sadleir said the CWS is "thrilled with the incredible interest" in hosting the Games "This positive response from four of our six regions un derlines the importance and significance of the Common wealth Games and its position as the major multi-sport event in the world sporting calendar alongside the Olympic Games and Paralympics and shows the strength and appeal of our reimagined Games model."

The future of CWG had looked uncertain in recent years with the Australian state of Victoria withdrawing as hosts for the 2026 Games due to budget constraints. Glasgow stepped in to salvage the event but after making many alter ations to the games programme

The initial estimate for host ing the Games in Victoria was 2.6 billion Australian dollars. All the bids are single rather
