Maharashtra: Next anti-Hindi stir

A row is simmering in Maharashtra over the state government's decision to make Hindi a mandatory third language for students of Classes I to V in Marathi and English medium schools across the state, in a departure from the practice of studying two languages. Terming the move as an effort to undermine Marathi, the Opposition Shiv Sena (UBT) and the NCP (SP) have vowed to vehemently oppose the three-language policy. The controversy also seems to have brought closer warring cousins Uddhav and Raj Thackeray nearly two decades after their bitter fallout. The estranged first cousins have indicated their willingness to join forces in the larger interest of the Marathi community. If things go this way, it may spell trouble for the BJP-led ruling Mahayuti government in the state at a time when Tamil Nadu is already engaged in a battle with the Centre over the alleged imposition of Hindi in the southern state.

Putin announces surprise Easter ceasefire in Ukraine

Moscow, April 19: Russian President Vladimir Putin announced a temporary Easter ceasefire in Ukraine, the Kremlin said Saturday. The ceasefire will last from 6 pm Moscow time (1500 GMT) Saturday to midnight (2100 GMT) following Easter Sunday.

"Guided by humanitarian considerations, today from 18:00 to 00:00 from Sunday to Monday, the Russian side declares an Easter truce. I order that all military actions be stopped for this period," Putin said at a meeting with Chief of the General Staff Valery Gerasimov, the Kremlin's Press Service quoted him as saying.

"We assume that the Ukrainian side will follow our example. At the same time, our troops must be ready to repel possible violations of the truce and provocations from the enemy, any of its aggressive actions," Putin said.

In a first, robots race with humans in China marathon

Beijing, April 19: China Saturday held the world's first marathon of humanoid robots running together with human runners, showcasing progress in AI technologies amid Beijing's deepening rivalry with the US in robotics.

Twenty-one humanoid robots, accompanied by their tech handlers from top universities and firms ran over a 21-km race through Beijing's Economic-Technological Development Area.

The robots in different shapes and sizes running along with humans created a spectacle, drawing greetings from large crowds gathered on the sidewalks. The robots were launched sequentially

at intervals exceeding one metre, confined to dedicated tracks where battery swaps mirror Formula 1's pit stops.

In the end, awards were distributed not just for speed but for categories like Best Endurance, Best Gait Design, and Most Innovative Form - celebrating both athletic performance and engineering ability.

State-run Xinhua news agency, which described it as the world's first such race, also released a video footage in which several robots including one wearing a black sun hat and white gloves ran in along with the competitors.

However, videos posted on social media showed that it was not a smooth race as some robots experienced

plex terrains like slopes and turns which demanded exceptional stability, reliability, and battery life, Xiong Youjun, CEO of the Beijing Humanoid Robot Innovation Centre told Xinhua.

The China Electronics Society forecasts that China's humanoid robot market could reach approximately 870 billion yuan (about USD

119 billion) by 2030. "Robots completing the race isn't the finish line. It's the starting point for industrial growth and cross-disciplinary learning," said Liang Liang, Deputy Director of Yizhuang's Administrative Committee. "Their small steps today will become giant leaps for human technological progress tomorrow," Liang added.

Given that the humanoid robots on the track differ in height and weight, they are intended for future deployment in designated fields, including manufacturing, healthcare, and education, said Zhao Fuming, director of the Bei jing Marathon Association.

"Robots highlighted the race indeed. More cities may learn from such experience to integrate new concepts into marathon. However robots may not necessarily participate as runners. They can also give a hand in secu rity checking or other operation tasks," Zhao said.

China's robot race was seen as an attempt to show case its progress in AI tools amid its intensifying race with the US in the new emerging technologies.





Bhubaneswar, April 19: The state government will soon establish 'Odisha Pushti Mission' with an allocation of Rs 100 crore to intensify focus on nutrition, Chief Minister Mohan Charan Majhi announced

Addressing the gathering during the state-level 'Poshan Pakhya 2025' celebration at State Institute for Women and Children in Laxmisagar area here, Majhi emphasised the importance of making the nutrition programme a success in order to create a healthy human resource base.

Odisha launches mega mangrove mission to protect coast, empower fisherfolk

Astaranga, April 19: In a landmark initiative to safeguard Odisha's vulnerable coastline, a large-scale mangrove plantation drive has been launched at the Devi River estuary in Astaranga block under Puri district Saturday, with an ambitious target of planting one million mangroves by 2030. The initiative, which has gained massive community support after years of awareness campaigns, aims to revive wetlands, protect marine biodiversity, and secure the livelihoods of fisherfolk.

The inauguration ceremony, initiated with great enthusiasm, was followed by a mass mangrove plantation drive with the participation of distinguished guests and local community members. Hundreds of volunteers joined hands to plant the first saplings, marking the beginning of this crucial ecological restoration effort.

Spearheaded by the Odisha Paribesh Surakhya Abhiyan (OPSA) Trust, in collaboration with local organisations like Sabuja Sakha Astaranga, the mission will employ both hypocotyl (propagule) and seedling plantation methods to restore the ecologically-sensitive region. SC to hear plea on uniform hate crime compensation



The top court, in April 2023, had issued notices to the Centre, states, and Union Territories (UTs), seeking a status report on the implementation of such compensation schemes.

According to the court's updated cause list, a bench of Justices BR Gavai and Augustine George Masih will take up the matter April 23.

During the earlier hearing, the petitioner's counsel pointed out that while some states had indeed framed schemes, the criteria and amounts varied significantly. Many states had yet to introduce any scheme, leading to unequal and sometimes negligible relief for victims.

The petition criticizes what it calls a "whimsical, discriminatory and arbitrary" approach in awarding ex-gratia payments.

Petition highlights arbitrary and unequal compensation practices across states, calls for court-mandated guidelines to ensure fair treatment for all victims of mob lynching and hate crimes

media attention, political influence, and the religious identity of the victim often determine the compensation, rather than the actual gravity of the incident or the suffering caused.

In many instances, the plea claims, victims from minority communities have received far lower compensation than others in similar circumstances.

The petitioner has urged the court to direct all states and UTs to establish fair, reasonable, and constitutionally compliant compensation mechanisms under Articles 14, 15, and 21.

By standardising compensation practices, the petitioner hopes to ensure justice and equal treatment for all victims of hate crimes and mob violence, regardless of their background or the region where the

Upon receiving the complaint, Rajnagar police arrived at the scene but found that the victim's in-laws had fled. Following raids at various locations, police arrested Deepak Das, the accused husband of the victim, and his uncle Ajay Das. A case (130/2025)has been registered at Rajnagar police station, with charges under Sections 85, 80(2), 351/4, and 103 of the Bharatiya Nyaya Sanhita

Rajnagar IIC Naresh Kumar Sahu stated that a scientific team has been deployed to assist in the investigation. The body has been seized and sent for post-mortem. The exact cause of death will be confirmed upon receipt of the autopsy report. The shocking incident has triggered widespread outrage in the Rajnagar area.

Kesari Kund declared prohibited zone after 2 students' drowning

Champua, April 19: A day after two students drowned at Keshari Kund of Baitarani river on the fringes of Keonjhar and Mayurbhanj districts, the Ke onihar district administration has declared the spot located at Sarei village under Champua police limits as a prohibited zone Saturday.

Authorities have reportedly begun fencing the area to pre vent public access to the site.

Due to repeated drowning accidents at the site, Sub-Collector Umakant Parida declared the area as a prohibited zone and instructed officials to install warning signage during his visit to the place Saturday

The Sub-Collector directed Karanjia Revenue Inspector Chinmaya Mohanta to use a loudspeaker system to spread awareness and inform the public on the development.

According to reports, Pari da visited the mishap site with Champua police IIC Debaki Nayak, tehsildar Sajat Marke, Assistant Collector Samar endra Das, and Champua RI Sampad Pradhan.

Local resident Dasharu Nay ak, who helped recover the bodies, was commended for his efforts. Officials interacted with him to understand how the incident unfolded.

HONOUR KILLING OF PREGNANT MINOR

Parents sentenced to life imprisonment

Jajpur Town, April 19: In a widely discussed honour killing case from Binjharpur area in Jajpur district, a fast-track court here Saturday sentenced a couple to life imprisonment for the brutal murder of their 15-year-old pregnant daughter. The court also imposed a fine of ₹10,000 on each of the convicts, with an additional six months of rigorous imprisonment in default of payment.

The incident occurred in Laxminarayan Sahi under Biniharpur police limits February 14, 2016. The victim, a three months pregnant minor, was allegedly beaten to death by her father Nakula Jena, 50, and mother Sanju Jena, 48. According to reports, the couple,

attempted to destroy evidence by cremating the body and disposing of the remains in the Kharasrota river.

A key eyewitness, Matajee Jena, wife of a local resident Bira Jena, had heard the girl's cries while passing by the couple's residence. The victim was reportedly screaming, "Don't kill me, I'm going to die." When Matajee returned along the same path an hour later, all

It later emerged that the girl's parents had cremated her body behind their house with the help of a few villagers. Some burnt bones and ashes were collected in a plastic sack and dumped into the Kharasrota river to erase evidence.

After hearing rumours about



case (45/2016) and launched an filed a formal complaint with Binjharpur police February investigation. A plastic sack 16, 2016. Based on her comcontaining charred remains embankment and forensic tests later confirmed they belonged to the deceased minor.

Three SDPOs were assigned to investigate the matter. Following the probe, police arrested the parents and 20 villagers, presenting them in court.

Judge Bijaya Kumar Jena of the Ad-hoc Fast-Track Court delivered the final verdict Saturday. Relying on the testimonies of 30 witnesses, the court found Nakula and Sanju guilty of murder and evidence destruction and sentenced them to life imprisonment

Due to lack of sufficient evidence, the court acquitted 20 other accused villagers.

The case was prosecuted by Special Public Prosecutor Raiendra Prasad Navak.

Gangadigad village, located within the Sunabeda Wildlife Sanctuary close to the Chhattisgarh border, was established in 1956. The seven associated hamlets — Bhalupani, Baunsadongri, Gondalabahara, Mahulpada, Khaliapada, Santoshpada, and Banjipanipada — have long awaited recognition as revenue villages

Although a government notifica-

tion (No. 2183/2020) issued September 21, 2020 proposed village recognition, no concrete action followed. Many villagers have received forest land titles, but the pattas mention only land area — lacking details like plot and khata numbers — rendering them legally ineffective.

Due to this administrative gap, residents are unable to access caste and residence certificates, preventing their children from enrolling in schools and barring them from government schemes like PM-Kisan, CM-Kisan, and housing programmes. Without registration, farmers also cannot sell paddy to government mandis, often selling at lower rates to middlemen. Protesters demanded updated pattas, formal recognition of all hamlets, groundwater restoration, and action against timber mafias and negligent forest officials. Key community leaders, including committee president Ghasiram Majhi and others were present during the protest.

Ancient Jain statue found in Fakirpur

hankara of the Jainism, was discovered during pond excavation on the land of Ranjan Kumar Raut in Balipada of Fakirpur village under Anandapur Municipality, sparking interest among historians and

cultural enthusiasts. The statue, estimated to be 1,500 years old, stands approximately 3

feet tall and 1.5 feet wide. Weighing over a quintal, the figure has been carved in the 'Kayotsarga' posture — a meditative standing pose often associated with Jain iconography. Deities are depicted on both sides of the statue, which resembles the Bahubali statue in the Gomateshwara Temple at Shravanabelagola,

Trilochan Sahoo, a local social worker and Sanskrit scholar, informed officials from the State Museum, along with historians and university professors, who confirmed the statue's cultural and historical value. Given the rarity and significance

of the artifact, the Fakirpur Sanskrutika Parishada — led by President Saroj Kumar Sahu and Secretary Trilochan Sahoo — has requested the Keonjhar district collector, Anandapur sub-district collector, and the state's Department of Culture to take immediate steps to preserve the statue at the State Museum.

Sahoo emphasised the need for further research, noting that a deeper study could reveal valuable insights into the statue's origin and the region's ancient Jain heritage.

China's Ascent

hina's crime is that in the next few years, perhaps as soon as 2035, it will be the world's largest economy. Its Gross Domestic Product (GDP) will be larger at that point than that of the United States, if the average growth rates of both nations over the last 15 years hold.

This is unacceptable to the US, because it has been the dominant global power for the last century. This power has come mostly because of its economy, which is poised to go from number one to number two. That is China's offence and that is the reason for the tariff tantrum President Donald Trump is throwing.

What is called 'the West,' meaning Europe and its settler colonies in North America, Australia, and Israel, has no memory of a world where it has not been the ruler and the rest of us the ruled. What they refer to as the 'international rules-based order' is the manner in which what was once direct rule through colonialism and its forms has been replaced by institutions such as the UN Security Council, the International Monetary Fund, and the World Bank. Informal groupings such as the G7 are used to further coordinate action.

In the 18th century, the two largest global economies were China and India. This was a function of a world without many machines, in which national productivity and output depended on population

and most people were occupied in agriculture. The more people a nation had, the larger its economy. The Industrial Revolution changed that, and productivity began to separate itself from physical human input. From the 1800s to the present, 'the West' has been at the forefront of this technological change. China has caught up. China will soon surpass. Citigroup published a paper in January 2023 titled 'When Will China's GDP Surpass the US? And What Will It Mean? which concluded:

"Across a range of parameters, catchup is likely to occur sometime during the 2030s, probably during the middle of the decade. When it eventually does occur, it will be widely noted in the press and, likely, in political discourse. It may be largely symbolic, but there may also be some geopolitical heft and prestige that accrues to the largest country in terms of GDP. For example, an economy's overall size enters the IMF's quota formula and helps determine voting shares. Also, certain activities-Olympic teams, space programs, and (most important) the military—are funded at the national level, and a larger economy means increased resources. In each of these endeavors, the world's largest economy may reap non-linear influence, strength, and other benefits.'

Much of this has already happened. The Chinese navy has more ships than the US navv. China built and operates an independent space station

that rivals the International Space Station led by the US and Russia. China, including Hong Kong, won more gold medals (42) than the US (40) in the Paris Olympics last year. Even before its ascension as the largest economy, China has, for the last decade, rolled out the biggest infrastructure project in the world, the Belt and Road Initiative, and it is the largest trading partner for 120 nations, as opposed to 70 for the US.

A series of internal reports resembling Citigroup's have crossed the desks of Presidents Obama, Trump in his first term, and then Biden. Their response has been to try and handicap China, first by restricting its access to Taiwanese-made semiconductor chips designed in the US. The aim was to preserve the US lead in artificial intelligence, seen by many as a technology that will be as transformational as electricity.

This has not worked, as DeepSeek, the elegant AI produced by an obscure Chinese firm, showed. For good measure, the Chinese firm made DeepSeek open-source, meaning free, stymieing US efforts to monopolize the technology.

Huawei was banned by the West in 2019, denied access to markets and hardware, but it went into manufacturing and is, by some estimates, only a few years behind the two leaders in the semiconductor field, Taiwan's TSMC and Dutch firm ASML, in making the most advanced chips. What is required here is industrial design and manufacturing, and these are the two things Chinese companies have shown themselves to be superior at, so we should not be surprised if they

The tariff war, trying to totally decouple the West and its economies from China, is the latest and perhaps last attempt to try and stop the East. If this fails, the only option will be to use military power, and many in Washington are talking about this casually.

Chinese ships have begun to turn away from US ports after the raising of tariffs to an absurd 145 percent. In less than two weeks' time, on May 2, the duty-free exemption granted to packages from China under \$800 ends. At that point, with trade at a standstill, the impact of few intermediate and finished goods arriving from China will be felt throughout the US economy. Yes, China will be hurt by this, but not much: exports to the US are 2% of its GDP. The US will be hurt more. Say's Law of Markets tells us that supply creates its own demand. Meaning that an economy focused on producing goods will ultimately find some market for sale, including an internal market, because the workers producing the goods can buy them. That is China, the world's largest producer of goods and the sole manufacturing superpower. The US is a consumer. It has the hard task of now beginning to produce what it wants to consume, and going through economic pain and uncertainty in doing so, all because it cannot bear to see someone else as number one.

finally unleashed his long-threatened tariff blitz, the scale and scope were far worse than most governments expected. It came as no surprise that China would be the hardest hit, but the punishing duties imposed on most Asian countries were a profound shock. Fortunately, with financial markets reeling, Trump announced a 90-day pause on most of these 'reciprocal' tariffs just hours after they took effect. Asian governments benefiting from this reprieve must now use the time they have gained to forge a more unified response and take bold initiatives that give them more leverage with the United States.

Consider that the tariff rate initially imposed on my country, Sri Lanka, which is only a few years removed from a political and economic crisis that forced our president to flee and pushed the economy to the brink of collapse, was a whopping 44%. Given that the US is Sri Lanka's largest export market by far, Trump's 'Liberation Day' tariffs would deliver a massive blow to the country's recovery when (I hesitate to say "if") they are imposed.

Other Asian countries fared little better, and a few were hit even harder, with rates of 49% for Cambodia, 48% for Laos, and 46% for Vietnam. So onerous were these proposed duties that one might wonder whether Trump is compensating for his avoidance of military service in the Vietnam War by waging economic warfare on the countries of Indochina that were involved in that conflict. Now that the Vietnamese government—which swiftly raised the white flag by offering to eliminate all tariffs on US imports-has agreed to start trade talks during the pause, Trump must already

think that he has won.

Vietnam's attempt to appease Trump will yield few, if any, benefits for the country, because Trump never negotiates in good faith. Worse, the country's actions are setting a high bar—at least in the eyes of the US administration's trade negotiators-for what its partners in the Association of Southeast Asian Nations (ASEAN) will now be expected to deliver.

But the current ASEAN chair, Malaysian Prime Minister Anwar Ibrahim, can still marshal the full power of the bloc to present a unified front and develop policy initiatives that can help shield members from the economic disruption caused by Trump's tariffs. This would be consistent with Anwar's efforts as ASEAN chair to deepen economic integration within the bloc and forge closer commercial links with the Gulf Cooperation Council and with other Asian economies

The ASEAN Summit that Anwar is hosting in May will provide a venue for advancing this agenda. The assembled leaders will likely talk about diversifying trade partnerships—one of the best things any country or bloc can do when facing the kind of pressure that the US is applying. But they should also look for other ways to advance regional cooperation and enhance their economies' resilience.

Here, ASEAN can take a page out of the European Union's playbook, despite not pursuing the same goal of an 'ever closer union': expansion as a way to enhance stability along its borders. Perhaps the clearest example is the EU's 'big bang' enlargement of 2004, when it admitted ten countries, mainly in Central and Eastern Europe. The bloc's continued outreach to the Balkan countries and Ukraine, as well as its efforts to stimulate economic development in North Africa, are of a piece with this strategy.

ASEAN has already embarked on accession negotiations with Timor-Leste, which, if admitted (as many expect), would be the bloc's poorest member by far. But membership would help Timor-Leste diversify its economy and allow it to work with new partners. It would also diminish

Indonesia, which occupied Timor-Leste for more than 20 years following independence from Portugal.

Anwar and his diplomats have already made impressive headway on accession talks with Timor-Leste, and a breakthrough during Anwar's chairmanship would boost ASEAN's international prestige at a pivotal moment and help strengthen regional stability and security. But if Anwar wants to be even bolder, he should look outside the bloc's immediate vicinity for a new member: Sri Lanka.

True, Sri Lanka's GDP per capita would rank it in the bottom half of ASEAN members. But its location in the Indian Ocean would provide ASEAN businesses with access to the region's burgeoning economy. With the Indo-Pacific destined to become the world's economic center of gravity in the twenty-first century, Sri Lanka's strategic position can be a powerful fillip to trade and investment. And Sri Lanka itself offers plentiful investment opportunities for ASEAN construction, logistics, and tech companies.

Standing up to Trump-or any other superpower bully that may come along-requires engaging from a position of power. ASEAN enlargement—quickly accepting Timor-Leste and opening talks with Sri Lanka—would advance this goal. In Trump's notorious Oval Office meeting with Ukrainian President Volodymyr Zelensky, he repeatedly told his guest, 'You don't have the cards.' ASEAN, for its part, does have cards to play when dealing with the US administration, so long as it sticks together. Expanding the bloc would only strengthen its hand.

amarkand hosted the first-ever high-level meeting between the European Union and five countries of Central Asia, on April 3-4, opening a new chapter in relations between the regions. It highlighted the strong interest of both sides in developing cooperation and strengthening

The intensification of cooperation between both sides in recent years has been acquiring a sustainable, systemic, and mutually beneficial character.

Since the emergence of new independent states in Central Asia, the EU began to establish bilateral partnership. From 1991, EU's strategy has gone through several important stages, which are conditioned by the dynamics of European integration, and role of Central Asia in world politics.

The first large-scale cooperation programme was "Technical Assistance to the Commonwealth of Independent States", 1991-2006, which provided support to countries in the region in conducting political and economic reforms, transitioning to a market economy, and strengthening the rule of law. Over 3,000 projects were implemented

totaling over 7 billion euros. In the 90s, the EU policy in

Central Asia had a pronounced resource-oriented character, with the former viewing the region primarily as a source of energy resources, actively promoting transport and logistics projects aimed at ensuring hydrocarbon supplies to Europe. After 2001, the focus shifted

towards security cooperation: combating terrorism and drug trafficking from Afghanistan and launching of programmes such as Border Management and Drug Precursor Control in Central Asia. The next important stage was adoption of first EU Strategy for Central Asia, 2007 and the beginning of perceiving Central Asia as a single region.

Central Asia is no longer iust a bridge between East and West, as was traditionally perceived, but an independent actor in international ties.

Today, countriesare interested in attracting European investments, technologies, and innovations to address priority tasks of ensuring stability and sustainable development in areas such as economy, industry, energy, transport, human capital, and climate change.

Strengthening political di-

alogue opens new opportunities for expanding trade and economic ties and developing industrial cooperation.

Implementing the "Global Gateway" strategy in transport and logistics sphere is also gaining importance. The region is transforming into a key transit node of Eurasian communications, where the Trans-Caspian International Route plays a special role. Among infrastructure projects aimed at developing the region's logistics potential, the China-Kyrgyzstan-Uzbekistan railway construction project is vital.

A new impetus was provided by the first investment and transport forum of Central Asian and EU countries, in January 2024 in Brussels, wherein 10 billion euros were announced for modernising the Trans-Caspian International Transport Route connecting Asia with Europe.

Another vital partnership has been digital integration into the global economy. In March 2025, the TEI Digital Connectivity project was launched, focusing on developing satellite communications, expanding broadband internet access, supporting digital innovations, and enhancing cybersecurity.

Climate change is another area. Key initiatives, such as "Team Europe" strategy, "Green Central Asia" are aimed at effective water resource management, developing environmentally friendly energy, and adapting to climate changes.

The EU-Central Asia summit in Samarkand, chaired by UzbekistanPresident, Shavkat Mirziyoyev, brought together leaders of Kazakhstan, Kyrgyzstan, Tajikistan, and Turkmenistan, alongside President of European Council, Antonio Costa, and President of European Commission. Ursula von der Leven.

"The EU is taking Central Asia particularly seriously in the context of current geopolitical turbulence' - declared Margaritis Schinas, Vice President of European Commission before the summit "At a time when the world is becoming increasingly unstable and insecure, Central Asia remains a region of positive changes. Our cooperation with Central Asia is not a one-time event; we are focused on a long-term perspective"

New Delhi, April 19: Fourthterm BJP MP Nishikant Dubey, one of the more vocal party members in the Lok Sabha, launched a broadside against the Supreme Court Saturday, saying Parliament and state assemblies should be closed down if the apex court has to make the laws. He first made a terse post in

Hindi on X and later, in remarks to PTI, accused the court of arrogating to itself Parliament's legislative powers by striking down laws passed by the legislature and even giving directions to the President who, Dubey noted, is the appointing authority of Supreme Court judges.

"Kanoon yadi Supreme Court hi banayega to Sansad Bhavan bandh kar dena chahiye," the BJP MP said on X. His comment came following the Centre's assurance to the court that it would not be implementing some of the contentious provisions of the Waqf (Amendment) Act till the next day of hearing after the court raised questions over them. It is hearing several pleas challenging the constitutionality of the Act, which was passed by Parliament in the

first week of this month.

Dubey appeared to question the court's critical observations on the Act's dilution of the "Waqf by use" provision, saying it has sought documentary proof in cases involving temples, including Ram Mandir in Ayodhya, but has chosen to ignore the similar need in the ongoing case. Citing Article 368 of the Con-

stitution, he said that law-making is the job of Parliament, and the Supreme Court is meant to interpret the laws. The court can order the government but not Parliament, he asserted.

Dubey cited the court's earlier decisions to decriminalise

consensual homosexuality, which was covered under Section 377 of the erstwhile Indian Penal Code, and to strike down Section 66(A) of the IT Act to target its alleged overreach. He claimed that the court decriminalised homosexuality despite all religions considering it wrong and that Section 66(A) was required to curb the increasing misuse of online platforms to send objectionable contents.

Two major terror modules busted

Chandigarh, April 19: Punjab Police has nabbed 13 alleged members of two major ISI-backed Khalistani terror modules that were being run from abroad and seized two rocket-propelled grenades, two hand grenades, IEDs and RDX along with other munitions, a senior officer said Saturday.

These modules were being controlled by proscribed terrorist outfit Babbar Khalsa International (BKI) from abroad through France-based Satnam Singh alias Satta and Greecebased Jaswinder alias Mannu Agwan, Director General of Police Gaurav Yadav said. Officials said more arrests are likely in the coming days.

With the busting of these modules, Punjab Police has foiled a conspiracy masterminded by Pakistan's spy agencv Inter-Services Intelligence (ISI) to disturb peace and harmony in the border state, the DGP said.

Counter Intelligence (CI) Jalandhar and District Police Batala dismantled the modules in two separate operations and 13 accused including a minor were held, the officials said.

ED chargesheet a lie-sheet: Cong

New Delhi, April 19: The Congress Saturday denounced the Enforcement Directorate's chargesheet against its leaders in the National Heald case as a "lie-sheet" and asserted that it is not a legal but a political battle which it will fight in the coming days, as the party's top leaders discussed the issue and evolved its strategy.

The Opposition party also expressed confidence that it would win the battle against the central government on the Waqf (Amendment) Act and alleged that the BJP was deliberately targeting the Supreme Court "which was only telling the ruling party not to frame laws that went against the basic structure of the Constitution".

Congress general secretaries and in-charges in various states met here to chalk out strategy in the wake of the Enforcement Directorate naming former party chiefs Sonia Gandhi and Rahul Gandhi in its chargesheet in the National Herald case of alleged money laundering.

Asserting that no crime has been committed by the Congress leadership in the case,



the party said it would hold press conferences across the country from April 21 to 24 to counter the "misinformation" being spread by the BJP.

"No matter whose name they put (in the chargesheet), we are not going to be afraid,' Congress chief Mallkarjun Kharge said at the meeting, with the party insisting that political vendetta was behind the ED action.

Slamming the Centre, Congress general secretary Jairam Ramesh claimed that people holding constitutional positions, ministers and BJP MPs were speaking against the Supreme Court in their bid to weaken the institution.

"They (BJP) are busy weakening the Supreme Court...

Those holding Constitutional posts, ministers and even BJP MPs are all speaking against the Supreme Court, which is only saying that while making laws, don't go against the basic structure of the Constitution,' the Congress leader said at a press briefing after the meeting. This is being done as the Supreme Court has spoken about electoral bonds and the Waqf law while the Election Commission issue is pending

before it, Ramesh said. The Congress also announced its plan to hold 'Samvidhan Bachao rallies' at the state level from April 25 to 30 and then at the district level from May 3 to 10 and finally launching a door-to-door campaign to take the party's message to every household in the country from May 20 to 30.

In a social media post, External Affairs Ministry spokesperson Randhir Jaiswal said the "brutal killing" of Bhabesh Chandra Roy follows a "pattern of systematic persecution" of Hindu minorities in Bangla-"We have noted with desh. distress the abduction and brutal killing of Shri Bhabesh Chandra Roy, a Hindu minority leader in Bangladesh," he said. The killing has

sparked fresh outrage among human rights groups and diaspora communities

"This killing follows a pattern of systematic persecution of Hindu minorities under the interim government even as the perpetrators of previous such events roam with impunity," Jaiswal said.

We condemn this incident and once again remind the interim government to live up to its responsibility of protecting all minorities, including Hindus, without inventing excus es or making distinctions," he added. There has been a sharp downturn in India-Bangladesh relations after deposed prime minister Sheikh Hasina fled Dhaka in August last year in the face of a massive anti-gov ernment protest. The relations nosedived dramatically after the interim government headed by Muhammad Yunus failed to contain attacks on minorities, espe cially Hindus, in that country. The killing has sparked fresh outrage among human rights groups and diaspora communities, who have repeatedly raised concerns over the safety of religious minorities in Bangladesh.

JEE main: 24 candidates



New Delhi, April 19: Twenty-four candidates secured a perfect 100 in the engineering entrance JEE (Main), the results of which were announced by the National Testing Agency Saturday.

Seven toppers are from Rajasthan, three each from Telangana, Uttar Pradesh and Maharashtra; two each from Delhi, West Bengal and Gujarat; and one each from Karnataka and Andhra Pradesh. Two of the toppers are women.

While 21 top-scoring candidates are from the General category, the list includes one candidate each from the Scheduled Caste (SC), Scheduled Tribe (ST) and the Other Backward Classes (OBC) categories. More than 9.92 lakh candidates had appeared for the second edition of the crucial exam. In the first edition, 10.61 lakh candidates appeared.

According to National Testing Agency (NTA) officials, NTA scores are not the same as the percentage of marks obtained but normalised scores. NTA scores are normalised scores across multi-session papers and are based on the relative performance of all those who appeared for the examination in one session, a senior official explained.

The marks obtained are converted into a scale ranging from 100 to 0 for each session of examinees, the official added. Based on the results of JEE (Main) Paper 1 and Paper 2, the candidates will be shortlisted to appear for JEE (Advanced).

The second edition of JEE (Main) was conducted at 531 unique examination centres in 300 cities, including 15 outside India in Manama (Bahrain), Do ha City (Qatar), Sharjah, Abu Dhabi and Dubai (United Arab Emirates), Muscat (Oman) Riyadh (Saudi Arabia), Singa pore, Kuwait City (Kuwait) Kuala Lumpur (Malaysia) Kathmandu (Nepal), West Java (Indonesia), Washington (US) Lagos (Nigeria) and Munich (Germany)

In the first edition, the NTA scores of 39 candidates were not declared as they were found to have indulged in unfair practices. During the second edition 110 candidates were found to be involved in unfair means including forgery of documents related to the examination, and consequently, their results were not declared.

"Besides these candidates, the results of 23 candidates have been withheld due to discrepan cies in their photographs, biometric details or other personal information for identity verification. These candidates have been asked to provide a valid proof of their photographs duly attested by a gazetted officer to the NTA within a specified date for their results to be declared. the senior NTA official said.

Rishikesh to Karnaprayag rail journey in two hours

n a major engineering milestone, Indian Railways has successfully completed the country's longest railway tunnel-Tunnel T-8-on the Rishikesh–Karnaprayag rail line. Spanning 14.577 km between Devprayag and Janasu, the tunnel was inaugurated April 16, 2025, by Union Railway Minister Ashwini Vaishnaw and Uttarakhand Chief Minister Pushkar Singh Dhami.

This breakthrough marks a turning point in Himalayan infrastructure, reducing travel time between Rishikesh and Karnaprayag from 6-7 hours to just two hours.

The tunnel was built using advanced Tunnel Boring Machine (TBM) technology—its first application in India's mountainous terrain. TBMs 'Shiv' and 'Shakti' set a national record by excavating over 1,080 meters in a single month in Au-



gust 2024, showcasing unprecedented speed and precision.

Part of the larger 125.2 km Char Dham Rail Project, this broad-gauge corridor aims to link Uttarakhand's four sacred shrines—Yamunotri, Gangotri, Kedarnath, and Badrinath—to the national rail network. The route is dominated by tunnels. with 83% of the line passing underground. Out of 38 planned tunnel breakthroughs, 28 have been completed, with a total of 193 km of tunnels already excavated.

Strategically vital, the railway will connect five districts-Dehradun, Tehri Garhwal, Pauri Garhwal, Rudrapray ag, and Chamoli-enhancing connectivity for towns like Rishikesh, Devprayag, Srinagar, Rudraprayag, and Karnaprayag. This will drastically improve access to healthcare, education, employment, and markets for remote hill communities.

Beyond infrastructure, the project is poised to boost tourism across Uttarakhand. With easier access to Char Dham sites and destinations like Haridwar, Auli, and Rishikesh, the local economy, hospitality sector, and transportation services are expected to thrive.

With full operations slated for mid-2027 and a total project cost of RS 16,000 crore, this rail line is more than an engineering feat—it's a transformative lifeline for the people and pilgrims of the Himalayas.

Govt study suggests incentives to tackle Ganga's 'ghost gear' crisis

New Delhi, April 19: In a bid to combat escalating plastic pollution in the Ganga, a government-funded study has proposed a "cash-for-nets" scheme aimed at incentivising fishers to return worn-out or abandoned fishing nets.

These abandoned, lost or discarded synthetic nets -- referred to as "ghost gear" -- pose a severe, long-term threat to aquatic ecosystems. Conducted over five years by the Wildlife Institute of India, the study forms part of the long-term conservation initiative -- Planning and Management for Aquatic Species Conservation and Maintenance of Ecosystem Services in the Ganga River Basin for a Clean Ganga.

Based on extensive riverine and socioeconomic surveys, the study recorded 72 incidents of aquatic species becoming entangled in fishing gear -- both active and abandoned. The researchers documented fishing gear and materials every five kilometres along the river.

For the socioeconomic survey, 150 key informant interviews, 10 focal group discussions with fishers, and personal observations were used. The 'vulnerable' Indian flapshell turtle accounted for the highest number of entanglements with 21. followed by the 'critically

endangered' gharial with 11. However, the study cau-



tioned that these figures likely underrepresented the actual scale as it was limited to incidents observed during the

brief survey window (30 days per year) or reported by local communities. Approximately 40 per cent of the respondents

reported witnessing aquatic species trapped in ghost gear.

Low level of education among fishing communities was identified as a key barrier to awareness and access to information about the environmental and economic impact of ghost gear. The report also pointed out systemic shortfalls -- none of the 20 block and panchayat offices surveyed across Uttar Pradesh, Bihar, Jharkhand and West Bengal had the infrastructure to collect, store or recycle ghost gear.

The abandoned nets can take up to 600 years to decompose, continuing to entangle fish, turtles and other riverine species long after their use.

As they degrade, they break down into microplastics, polluting the food chain and further deteriorating water quality. Pollution levels were found to be particularly severe in West Bengal, where more than 4.600 abandoned nets were documented in a single survey area.

Bengal SSC begins process for fresh teachers exam

Kolkata, April 19: The West Bengal School Service Commission has started the process of conducting fresh examination for teachers in state-run and state-aided schools, an official said Saturday.

The process began Friday in the wake of the Supreme Court order April 17 to initiate a fresh recruitment process of teachers of secondary-higher secondary schools by May 31.

The process of recruitment including taking exams and recruitment - will have to be completed by December 31, the official said. Washington: The US military will consolidate its presence in Syria over the coming weeks and months in a move that could reduce the number of troops it has in the country by half, chief Pentagon spokesperson Sean Parnell said Friday. The US military has about 2,000 US troops in Syria across a number of bases, mostly in the northeast.

Christian appeals blasphemy sentence

Lahore: A Christian man accused of blasphemy in the eastern Pakistani town of Jaranwala will appeal against a death sentence handed down by an anti-terrorism court, his lawver said Saturday. The 36vear old man was convicted of blasphemy over allegations he had desecrated the Muslim holy book, the Koran, claims that fuelled attacks on a Christian neighbourhood in 2023 in which hundreds of houses and churches were torched and thousands of people forced to flee their homes.

Iran, US hold N-talks

Dubai, April 19: Iran and the United States agreed Saturday to task experts to start drawing up a framework for a potential nuclear deal, Iran's foreign minister said, after a second round of talks following President Donald Trump's threat of military action.

At their second indirect meeting in a week, Foreign Minister Abbas Araqchi negotiated for almost four hours in Rome with Trump's Middle East envoy Steve Witkoff, through an Omani official who shuttled messages between them.

Trump, who abandoned a 2015 nuclear pact between Tehran and world powers during his first term in 2018, has threatened to attack Iran unless it reaches a new deal swiftly that would prevent it from developing a nuclear weapon.

Iran, which says its nuclear programme is peaceful, says it is willing to discuss limited curbs to its atomic work in return for lifting international sanctions.

Speaking on state TV after the talks, Araqchi described them as useful and conducted in a constructive atmosphere.

"We were able to make some progress on a number of principles and goals, and ultimately reached a better understanding," he said.

"It was agreed that negotiations will continue and move into the next phase, in which expert-level meetings will begin

Since 2019, Iran has breached and far surpassed the 2015 deal's limits on its uranium enrichment, producing stocks far above what the West says is necessary for a civilian energy programme.

A senior Iranian official, who described Iran's negotiating position on condition of anonymity Friday, listed its red lines as never agreeing to dismantle its uranium enriching centrifuges, halt enrichment altogether or reduce its enriched uranium stockpile below levels agreed in the 2015 deal.

Indian student killed by stray bullet in Canada's Ontario

New York/ Tarn Taran, April 19: A 21-year-old Indian student was killed in Canada after being struck by a stray bullet while waiting at a bus stop, as shots were fired from a passing car.

Harsimrat Randhawa, a student at Mohawk College in Hamilton, Ontario, was on her way to work Wednesday when the incident occurred. Hamilton Police, which is investigating the case as a homicide, called her an innocent bystander.

Back in Punjab, from where she hailed, her family has urged the Indian and state government for their assistance in bringing back her body.

In a statement, police said they received reports of a shooting near Upper James and South Bend Road streets at around 7.30 pm local time and found Randhawa there with a gunshot wound to the chest. She was rushed to a hospital but succumbed.

Randhawa was struck by a bullet after a passenger in a black car opened fire on a white sedan, it said. Shortly after the shooting, the vehicles left the scene.

She hailed from Dhunda village in Goindwal Sahib in Punjab's Tarn Taran district.

Her grandfather Sukhwinder Singh in Tarn Taran said Randhawa had gone to Canada two years ago for studies.

US SC temporarily halts deportations of Venezuelan migrants under wartime law

Washington, April 19: The US Supreme Court early Saturday temporarily barred President Donald Trump's administration from deporting Venezuelan men in immigration custody after their lawyers said they were at imminent risk of removal without the judicial review previously

mandated by the justices.
"The Gov-

ernment is directed not to remove any member of the putative class of detainees from the United States until further order of this Court," the justices said in a brief, unsigned decision.

The White House Saturday did not immediately respond to a request for comment.

Conservative Justices Clarence Thomas and Samuel Alito publicly dissented from the decision, issued around 12:55 am. Lawyers for the American

Civil Liberties Union filed urgent requests Friday in multiple courts, including the Supreme Court, urging immediate action after reporting that some of the men had already been loaded onto buses and were told they were to be deported.

The ACLU said the rapid developments meant the administration was poised to deport the men using a 1798 law that historically has been employed on-

ly in wartime without affording them a realistic opportunity to contest their removal - as the Supreme Court had required.

Anti-Israel protest: 20 attacks on American fast food outlets in Pak Lahore: Pakistan government Saturday disclosed that at least

20 outlets of American fast-food chains across the country were attacked by religious extremists this month during the anti-Israel protests. Israeli strikes on Gaza kill more than 90 in last 48 hours

Deir Al-Balah (Gaza Strip): Israeli strikes in Gaza have killed more than 90 people in the last 48 hours, Gaza's Health Ministry said Saturday, as Israeli troops ramp up attacks to pressure Hamas to release its hostages and disarm. The dead include 15 people who were killed overnight, among them women and children, some of who were sheltering in a designated humanitarian zone, according to hospital staff. At least 11 people were killed in the southern city of Khan Younis. several of them in a tent in the Mwasi area where hundreds of thousands of displaced people are living, hospital worker said. Israel has designated it as a humanitarian zone. Four other people were killed in separate strikes in Rafah city, including a mother and her daughter, according to the European Hospital. where the bodies were brought. Israel has vowed to intensify attacks across Gaza and occupy large "security zones" inside the strip. For six weeks Israel also has blockaded Gaza, barring the entry of food and other goods.

Auto sales in Odisha skid despite festive tailwinds and EV subsidies, revealing a stark urban-rural divide. As four-wheelers stagnate and two-wheelers falter, the electric push shows signs of early fatigue



FROM FESTIVE HOPES TO FALTERING SALES

ODISHA'S AUTO SECTOR HITS A

SPEED BUN


n a setback to the sales target set by the Federation of Automobile Dealers' Associations (FA-DA)—the apex body of the automobile retail industry in India-for the first quarter of 2025, Odisha recorded a 2.87 per cent year-on-year dip in total vehicle sales. The decline came despite a festive-packed quarter that included Holi, Mahashivaratri, and Vasant Panchami, which typically drives up demand.

The slump has impacted thousands of automobile dealers across the state, with the two-wheeler segment bearing the brunt. In March alone, motorcycle and scooter sales dropped by over 4,000 units compared to the same month in 2024. February had lready shown signs of distress, with many dealers struggling to meet last year's sales figures. Meanwhile, the three-wheeler (passenger) category continued to stagnate, with just 78 more vehicles sold in Q1, in comparison to 2024

Commenting on the trend, Mansur Baksh, Managng Director of MSB Bajaj—which operates over 20 showrooms in Odisha—described the decline as "unprecedented," especially during what should have oeen a high-demand marriage season, "Western Odisha was the worst hit in terms of two-wheeler sales. Baksh said. "For Bajaj, our entry-level models—110 cc, 125 cc, and 150 cc—took the biggest hit. However, our premium offerings like Dominar and Triumph managed to stay afloat.

The commercial vehicle segment also mirrored this subdued trend. In March, just 606 three-wheeler (goods) units were sold, a marginal drop from 616 units the previous year. February saw 482 units sold, down from 495 in 2024. The only minor reprieve came in January, with a modest uptick of 85 units over

VEHICLE OWNERSHIP LANDSCAPE IN STATE




According to data available in Vahan portal. around 87.97 lakh two-wheelers and 8.47 lakh cars ply on Odisha roads. Similarly, the state has 187 two-wheelers and 18 cars per 1,000 population. While Odisha outpaces the national average of 185 two-wheelers per 1,000 population, the eastern state struggles to catch the pace of four-wheeler ownership at national level. India has 34 cars for every 1,000 population – nearly double than that of the state.

RURAL-URBAN DIVIDE IN FOUR-WHEELER SALES


To decode the shifting sales dynamics between urban and rural Odisha, Orissa POST analyzed vehicle registration data from 38 Regional Transport Offices (RTOs) for Q1 of 2025. The data revealed a stark disparity in four-wheeler registration patterns.

Seven RTOs across urban centres like Bhubaneswar, Khurda, Cuttack, Puri, Rourkela, and Sambalpur accounted for 64 per cent of all four-wheeler registrations—totaling 12,411 units. Among rural and semi-urban districts, Balasore, Bargarh, and Ganjam led the charts with 766, 564, and 452 units respectively.

Surprisingly, urban hubs witnessed stagnation in four-wheeler sales. Bhubaneswar (Ekamra and Central), Rourkela, Khurda, and Puri reported lower sales than in 2024. Specifically, Bhubaneswar RTO-1 (primarily covering Bhubaneswar North) reported 5,593 four-wheeler registrations in 2025 Q1, down from 6.252 in 2024




Shedding light on this shift, Aditya Patra, Managing Director of Aditya Group—authorised dealer for Hyundai and Mahindra—said, "Despite seemingly strong consumer sentiment, high inflation, volatile fuel prices, and tighter financing in Tier 2 and Tier 3 towns have curbed conversions. Customers are also waiting for upcoming model launches, which has created a temporary lull in purchases.



However, the year-on-year percentage (2025 v/s 2024) change tells a different story, with several rural districts recording double-digit growth rates and urban centers face declining numbers.Rural areas like Balasore, Bargarh, and Ganjam have seen growth rates exceeding 15%, while traditional urban centers are experiencing negative growth ranging from 2% to over 10%. This reversal challenges longheld assumptions about vehicle ownership patterns in the state. The trend indicates improving rural infrastructure and rising disposable incomes in agricultural regions, potentially reshaping Odisha's economic landscape if the pattern continues

Rural Odisha saw a 33.45% surge in January 2025 sales compared to 2024, and a 15.76% rise in March, signaling growing rural demand. Urban Odisha, conversely, showed volatility, with a modest 9.12% increase in January, a sharp 16.1% decline in February, and a near-flat 0.96% rise in March. This disparity underscores uneven economic growth, with rural areas catching up despite lower baseline ownership. Policymakers and automakers must address this gap to balance mobility access across Odisha.

TWO-WHEELER MARKET: MIXED SIGNALS



While two-wheeler sales mirrored the overall slowdown—dropping from 1.73 lakh units in Q1

2024 to 1.69 lakh in 2025—their distribution remained more balanced across rural, semi-urban, and urban Odisha


In contrast to low four-wheeler ownership, several districts displayed a robust uptake of two-wheelers registration. Kalahandi reported 8,320 units of two-wheelers, compared to just 419 four-wheelers: Balangir followed closely with 8,422 two-wheelers and 491 cars. Similar patterns emerged in Balasore (10,104 and 766), Koraput (6,602 and 435), and Sambalpur (5,768 and 860).

Unlike four-wheelers-where urban RTOs accounted for 64 per cent of sales—the urban share for two-wheelers stood at just 28 per cent. Bhubaneswar led the charts with 20,330 two-wheelers registered in Q1 2025, followed by Cuttack (12,071) and Sambalpur

ODISHA'S TRYST WITH EV

Aiming for adoption of electric vehicles (EVs) by 20 per cent in 2025 end, Odisha government, September 1, 2021, announced 'Odisha Electric Vehicle Policy, 2021'. The move was aimed at creating a conducive-environment for electric vehicle sales in the state. Accordingly, it declared a 15 per cent subsidy on two-wheelers, extending to a maximum of ₹5,000. The subsidy remained same at 15 per cent for three-wheelers and four-wheelers, with maximum discount benefit of ₹10,000 and ₹15,000,

Nineteen months later, the state government observed stagnant EV sales. It observed just 4.48 per cent electric vehicles got registered by the end of 2022. Following this, the state government in April 26, 2023 made the formal amendment to the 'Electric Vehicle Policy', thereby hiking the subsidy provided on two-wheelers purchase from ₹5,000 to ₹20,000. The subsidy for three-wheelers and four-wheelers was also raised to ₹30,000 and ₹1.5 lakh, respectively.



Significantly, the amendment ushered in a wave of EV purchases in Odisha before taking a dip in FY 2024-25. Data sourced from 38 RTOs stated that 29,079 two-wheelers, 2,643 three-wheelers, and 497 four-wheelers were registered in FY 2022-23. The vehicle registration numbers saw a whopping rise in FY 2023-24, recording registration of 44,389 two-wheelers, 5,447 three-wheelers, and 1,648 four-wheelers.

The numbers dipped in FY 2024-25, clocking registration of 26,101 two-wheelers, 5,884 three-wheelers, and 1,385 four-wheelers.

SUBSIDIES TO EV OWNERS

In response to a question on subsidies lent to EV owners in Odisha, Commerce and Transport Minister Bibhuti Bhusan Jena informed the Assembly in September 2024 that the highest amount of ₹54.83 crore was provided to two-wheeler owners in 2024. This was followed by ₹35.50 crore in FY 2023-24 and ₹6.46 crore in FY 2022-23.

Minister Jena said in the three-wheeler segment, the highest ₹10. 45 crore was given to owners in 2024. This was trailed by ₹9.03 crore in FY2023-24 and ₹96.45 lakh in FY2022-23.

Similarly, in four-wheelers, he said the state government distributed the highest of ₹22.94 crore to owners in 2024, followed by ₹12.76 crore in FY 2023-24, and ₹1.40crore in FY 2022-23.

Dealers remain cautiously optimistic, with FADA projecting modest growth across two-wheelers and passenger vehicles in 2025.

Electric vehicle sales in Bhubaneswar have gained notable momentun

The slowdown in Odisha's commercial vehicle segment was largely due to the election transition, which delaye project execution and affected the mining sector amid lease renewals. Retail buyers, especially first-timers, held back due to weak market sentiment, even as fleet operators continued purchases. In contrast, the tractor market saw nearly 9% growth, driven by strong government subsidies and favorable MSPs. Passenger vehicle growth was modest at 1.5%, with hatchbacks and sedans declining, offset by over 8% growth in utility vehicles. With the new government now settled, I'm optimistic about a strong rebound in FY'26.

TEJINDER S. BHUMBER | Director. Paramou Typically, corporate and individual buyers boost purchases before fiscal year-end to leverage depreciation benefits and preempt price hikes. However, in March FY'25, higher discounting, inventory pressure, weak rural sentiment, and a lack of major ICE launches led to only mild growth. Demand remains strong for SUVs, especially hybrids like the Toyota

Hyryder, Going forward, hybrid incentives, lower interest rates, good monsoons, and new launches will drive a shift from volume-led to value-driven, premium-focused growth.

The Indian auto sector's slowdown stems from high ownership costs, regulatory shifts, poor EV infrastructure, and weak rural demand. To revive growth, we need targeted policy support, affordable financing, and a faster EV ecosystem rollout. Strengthening rural outreach, supporting MSMEs. and skilling the workforce are crucial. Additionally, encouraging foreign OEMs like BYD, Citroën, and Vinfast to thrive in India will boost consumer choice, employment, and GDP, helping position India as a global auto manufacturing hub.

policy, skilling, and Make-in-India incentives, the sector can rebound and emerge as a global mobility leader.

The Indian automobile industry is at a critical juncture, navigating the shift from traditional ICE vehicles to an emerging EV landscape amid ongoing macroeconomic challenges. FY'25 has shown signs of recovery, with the two-wheeler and passenger vehicle segments registering healthy growth. Yet, electric vehicle adoption-especially in the 2W segment-remains

moderate, held back by infrastructure gaps, pricing, and range anxiety. Odisha reflects this broader trend, showing resilience in personal mobility but a notable dip in commercial vehicle sales due to freight and financing constraints. EV penetration across all segments has improved modestly, signaling a growing consumer shift. However, dealer concerns over aggressive OEM targets highlight the need for more collaborative planning. Moving forward, the industry must focus on boosting rural demand, expanding charging infrastructure, and fostering OEM-dealer synergy. While the recovery is underway, sustained transformation will require policy support, strategic investment, and a customer-first approach to ensure the sector's long-

term resilience and growth. SHAMSHER SINGH HURA | CEO and Founder, Jas Motors

The Indian automobile sector is lagging in innovation and needs a stronger focus on research and development, especially when compared to Western countries. To revive growth, it's essential to encourage greater investment in R&D and technological advancement. Additionally, rationalising taxation can significantly boost the industry's prospects. Offering better scrappage incentives for end-of-life vehicles

would also help stimulate demand and modernise the vehicle fleet.

Ahmedabad, April 19: Jos Buttler braved cramps to rustle up a tempestuous unbeaten 97 to guide Gujarat Titans to a wonderful seven-wicket win over Delhi Capitals here Saturday.

After the impressive Prasidh Krishna-led (4/41) Gujarat pacers limited Delhi to 203/8, the home side paced their chase impeccably to reach 204/3 in 19.2 overs as Buttler played the protagonist role during his 54-ball innings

There were mini-hiccups for the Titans in the form of early dismissals of skipper Shubhman Gill and B Sai Sudharsan (36), who helped Buttler add 60 runs for the second wicket.

But Buttler batted around them with collectedness in the company of Rutherford (43) until the left-hander was dismissed in the penultimate over. The English-West Indian pair

milked 119 runs for the third wicket that pushed GT closer to the shore.

Buttler's batting is aesthetically violent as he exploited a pitch on which the ball came fluently on to the bat. The Somerset man has all the shots in the book but plays them in the calmest of ways.

Instead of moving around the crease like modern T20 batters, Buttler often relies on a strong body core and quick hands to unfurl his shots

There was a telltale example of his methods when he biffed Mitchell Starc for five boundaries in a row in the 15th over.

Buttler did not move towards the ball but reached out with a feet firmly rooted on the ground as the ball sped to the ropes between covers and point regions.

Suryavanshi: Youngest cricketer to play in IPL

Vaibhav Suryavanshi, a 14-year-old baby-faced cricketer with oodles of confidence and determination, on Saturday became the youngest player to feature in the Indian Premier League as he turned out for Rajasthan Royals against Lucknow Super Giants here. At just 14 years and 23 days, Suryavanshi was the darling of the crowd the moment he walked alongside Yashasvi Jaiswal to open the Rajasthan Royals innings. With determination writ large on his face, the left-handed batter sent the Sawai Mansingh Stadium crowd into



a tizzy when he smacked the first ball he faced -- fourth delivery of the first over from LSG pacer Shardul Thakur -- for a huge six. Suryavanshi, born March 27, 2011 -- the year when India won the Cricket World Cup under MS Dhoni -- has played just five First-Class games for Bihar in the 2024-25 season. He had made history in the IPL 2025 auction when, as a 13-year-old, became the youngest to get an IPL contract, being bought by the Royals for Rs 1.1 crore. Before Suryavanshi, Prayas Ray Barman was the youngest cricketer to play in the IPL at 16 years and 157 days. Barman had played for RCB against SRH in 2019. By hitting a first-ball six, Survavanshi joined an elite club that has the likes of Rob Quiney (RR), Kevon Cooper (RR), Andre Russell (KKR), Carlos Brathwaite (DD, now Delhi Capitals), Aniket Choudhary (RCB), Javon Searles (KKR), Siddesh Lad (MI), Mahesh Theekshana (CSK) and Sameer Rizvi (CSK).

ICC WOMEN'S ODI WORLD CUP Pak won't travel to India

Lahore, April 19: Pakistan Cricket Board (PCB) Chairman Mohsin Nagyi Saturday announced that their women's team will not travel to India for the ICC ODI World Cup later this year and play their matches at a neutral venue, following the hybrid model accepted earlier this year

When Pakistan hosted ICC Champions Trophy recently, BCCI had refused to send Indian team across the border due to diplomatic tension between the two nations and their matches were held in Dubai. A hybrid model was agreed upon that allowed both India and Pakistan to play their matches at neutral venues if one of the two coun-



tries was to host an ICC event.

"Just like India didn't play in Pakistan in the Champions Trophy and were allowed to play at a neutral venue, whatever venue is decided, we will play. When there is an agreement it has to be adhered to," he said.

The PCB chief said India and ICC being the hosts of the tournament would decide on the neutral venue.

India will host the tournament from September 29 to October 26 with Australia being the defending champions.
