PM Modi cuts short visit to Saudi Arabia

New Delhi, April 22: Prime Minister Narendra Modi abruptly ended his two-day visit to Saudi Arabia and decided to return to New Delhi Tuesday night following a deadly terrorist attack in Jammu and Kashmir, government sources said.

Modi, who held bilateral talks with Saudi Crown Prince Mohammed bin Salman in Jeddah, skipped an official dinner hosted Tuesday to address the crisis, they added.

He was originally scheduled to return to India Wednesday night.

Modi, who arrived in Jeddah Tuesday afternoon, delayed a scheduled meeting with the Saudi Crown Prince by at least two hours Tuesday evening to assess the situation in Kashmir.

The attack prompted an urgent internal meeting at the Ritz Carlton hotel in Jeddah, attended by Modi, National Security Adviser Ajit Doval, and other senior officials.

External Affairs Minister S Jaishankar and National Security Adviser Doval visited the Royal Palace earlier to brief the Saudi leadership on the sudden change in plans, sources said.

GOLD BREACHES ₹1 LAKH-MARK

New Delhi: Gold prices surged by ₹1,800 to zoom past the crucial ₹1 lakh-mark for 10 grams in the national capital Tuesday amid buying rush by local jewellers and stockists in anticipation of increased demand during Akshaya Tritiya and wedding season even as global macroeconomic uncertainties continued to fuel safe-haven chase. According to the All India Sarafa Association, the precious metal of 99.9 per cent purity climbed ₹1,800 to hit the lifetime peak of ₹1,01,600 per 10 grams from Monday's closing level of ₹99,800 per 10 grams. Gold of 99.5 per cent purity also jumped by ₹2,800 to hit a record high of ₹1,02,100 per 10 grams in the local markets on Tuesday. It had settled

Pahalgam, April 22: Terrorists opened fire at a famed meadow here at Baisaran in J&K Tuesday afternoon, killing 26 people, mostly tourists. in what is the deadliest attack in the Valley since the Pulwama strike in 2019.

The 26 dead included two foreigners and two locals, a high ranking official said. The toll is still being ascertained, J&K CM Omar Abdullah said while describing the terror attack as "much larger than anything we've seen directed at civilians in recent years"

Baisaran, about six kilometres from the resort town of Pahalgam, is an expansive meadow ringed by dense pine forests and mountains and a favourite with visitors from across the country and the world.

Armed terrorists came into the grassland, dubbed 'mini Switzerland', and started firing at tourists milling around eateries, officials and eyewitnesses said.

As news of the terror attack targeting tourists in Kashmir spread, The Resistance Front (TRF), shadow group of the banned Pakistan-based Lashkar-e-Taiba (LeT) terror group, claimed responsibility. Officials said it was possible the terror group could have crossed over from Kishtwar in Jammu and reached Baisaran through Kokernag in south Kashmir.

Union Home Minister Amit Shah briefed Prime Minister Narendra Modi, who is on a

"I strongly condemn the terror attack in Pahalgam, Jammu and Kashmir. Condolences to those who have lost their loved ones. I pray that the injured recover at the earliest. All possible assistance is being provided to those affected," the PM said on X.

"Those behind this heinous act will be brought to justice...

they will not be spared! Their evil agenda will never succeed. Our resolve to fight terrorism is unshakable and it will get even stronger," he added.

The terrorists blamed them for supporting PM Modi, after which they made some statements to deny that Kashmiri militants kill innocent people, women and children. she said.

London, April 22: US President Donald Trump's administration intends to press India to give online retailers such as Amazon and Walmart full access to its \$125 billion e-commerce market, the Financial Times reported Tuesday, citing industry executives, lobbyists and US government officials.

The US plans to push Prime Minister Narendra Modi's government for a level playing field

on e-commerce in wide-ranging talks on a US-India trade agreement set to also cover sectors from food to cars, the newspaper reported. It did not mention what measures the Trump administration expects from the Indian government.

The murderer whose skin binds a book

he cover of a book held at a Suffolk museum was recently found to be made from the skin of a man hanged for a notorious murder almost 200 years ago

William Corder was convicted of killing a woman in 1827, which shocked Georgian Britain and became known as the Red Barn Murder.

Curators at Moyse's Hall Museum in Bury St Edmunds realised the book, which was on a bookshelf in an office, had been overlooked but it has now gone on display.

It had been donated decades ago by a family with close connections to the surgeon who anatomised Corder's body.

William was from a middle-class family of tenant farmers in the village of Polstead,



between Ipswich and Sudbury, at the turn of the 19th Century. At the age of 22, when he and Maria Marten became lovers, he was the head of the Corder family and had a reputation as a ladies' man. Maria, who was

24 and lived at home with her

off to Ipswich to get the banns for their wedding.

Maria was not seen again and William disappeared.

William eventually left Suffolk and wrote to the Marten family to say he had eloped with Maria to the Isle of Wight.

In reality, he was holed up just outside London and Maria was buried at the lovers' rendezvous, having been shot in the neck.

and found guilty after a two-day trial, and in a final confession said he had accidentally shot Maria during an argument.

Public intrigue in the Red Barn Murder sparked books, plays and music, and it permeates the true crime culture to this day. After two centuries, it has become a ripping yarn, the true story clouded in legend.

It is probably fuelled, in part, by being able to stand face-toface with Corder's image, his eves shut and his nostrils flared. His death mask is held at Moyse Hall and Norwich Castle.

For many years, until it eventually began to fall apart, his skeleton was used to teach medical students at West Suffolk Hospital.

Disturbingly, two books were covered in his skin and part of the man's scalp, with ear included, was kept as a gruesome ornament. All are at Moyse Hall.

Moyse's Hall said it would redress the focus on Corder with a future exhibition which will shine a light on woman victims in Suffolk history, including Maria







Rahul: Very clear EC is compromised

Boston/New Delhi, April 22: Congress leader Rahul Gandhi has once again criticised Indian democratic institutions abroad. The recent remarks came Sunday, when he delivered a speech at an event in Boston, United States (US), Congress' overseas president Sam Pitroda was seen accompanying him on stage.

The Election Commission (EC) is "compromised", said Gandhi, citing voter turnout figures in Maharashtra Assembly election. Gandhi noted that he had been raising the issue earlier also and alleged that "there is something wrong with the system".

However, the BJP linked his criticism to the Enforcement Directorate's action in the National Herald case, alleging he had not only "insulted' the country's institutions on foreign soil but had also indulged in corruption, and said he and his mother will be "sent to jail"

for "embezzlement".

Gandhi arrived in the US Saturday and made the remarks at an event in Boston Sunday.

The Leader of Opposition in Lok Sabha claimed that, in simple terms, more people voted in Maharashtra Assembly elections than there were adults in the

state. "The EC gave us a voting figure for 5:30pm, and between 5:30pm and 7:30pm, 65 lakh voters voted. This is physically impossible to happen. For a voter to vote, it takes approximately three minutes, and if you do the math, it would mean that there were lines of voters till 2am, but this did not happen," he said.

"When we asked them for the videography, they not only refused but also changed the law so that now we are not allowed to ask for the videography." Gandhi said.

"It is very clear to us that the EC is compromised, and it is very clear that there is something wrong with the system. I have said this multiple times." he said.

The BJP-Shiv Sena-NCP coalition Mahayuti had trounced the Maha Vikas Aghadi (MVA) alliance of the Congress, NCP (SP) and Shiv Sena (UBT) in Maharashtra polls in November last year. Taking exception to Gandhi's remarks against the EC, BJP MP and national spokesperson Sambit Patra alleged that Gandhi was venting his ire over the Enforcement Directorate's action in the National Herald case on the EC.

New Delhi, April 22: Election Commission (EC) sources Tuesday refuted Rahul Gandhi's allegations of abnormal voter turnout in Maharashtra polls asserting that any "misinformation" being spread was a sign of disrespect towards the law and hurt the efforts of political workers and polling personnel.

They also said such claims brought disrepute to the thousands of representatives appointed by political parties and demotivated lakhs of election staff working untiringly and transparently during elections. After any unfavourable verdict by voters. trying to defame the EC by saying that it had been compromised is completely absurd, the poll body sources said.

Rejecting the Gandhi's claims about alleged abnormal voter turnout, the EC sources underlined that 6,40,87,588 (6.40 crore) electors who reached the

polling stations from 7am to 6pm voted in Maharashtra polls. About 58 lakh votes were polled per hour on an

average, they said. Going by the average trend, nearly 1.16 crore voters could have voted in the last two hours, they added.

"Therefore, casting of 65 lakh votes by electors in two

average hourly voting trend," an EC functionary pointed out. The sources noted that voting progressed in the presence of polling agents formally appointed by candidates or political parties in every polling booth. The Congress' nominated candidates or their authorised agents had not raised "any substantiated allegations" regarding any kind of abnormal voting at the time of scrutiny before returning officers and election observers the next day.

On the issue of alleged fudging of electoral data, the sources said voter lists in India, including Maharashtra, were prepared according to the Representation of the People Act, 1950, and the Registration of Electors Rules, 1960.

According to the law, either just before the elections or once every year, special summary revision of electoral rolls is conducted and its final copy handed over to all national or state political parties.

After the finalisation of electoral rolls for Maharashtra polls, as against 9,77,90,752 (9.72 crore) electors, only 89 appeals were filed before the first appellate authority -- the district magistrate concerned -- and only one before the second appellate authority -- the state chief electoral officer.

Bhubaneswar, April 22: Odisha's industrial town of Jharsuguda Tuesday emerged as the hottest place in the country with mercury level reaching 46.2 degrees Celsius while 15 places in the state recorded maximum temperature at or above 40 degrees Celsius, the India Meteorological Department (IMD) said.

Chandrapur in the Vidarbha region of Maharashtra was the second hottest place in the country recording 45.8 degrees Celsius, followed by Brahmapuri of the same region boiling at 45.2 degrees Celsius, the IMD said.

Jharsuguda in the state's western region, recorded an all-time high April temperature of 46.2 degrees Celsius amid the severe heatwave warning prevailing across the region.

"The previous highest temperature since 1953 was 46.1 degrees Celsius, recorded on April 19, 2010," senior weather scientist Umashankar Dash said in a post on X.

Meanwhile, the IMD issued an orange warning (be prepared to take action) of heatwave conditions for one or two places in Boudh, Bolangir, Sundargarh and Sambalpur districts till 8.30am Wednesday. It also issued a yellow warning (be aware) for the districts of Nuapada, Bargarh, Kalał andi and Subarnapur. Hot and humid conditions were forecast for one or two places in Balaso re, Bhadrak, Jajpur, Kendrapa ra, Cuttack, Jagatsinghpur, Puri, Khurda, Nayagarh, Ganjam and Gajapati and warm night at one or two places in Sambalpur Sundargarh and Bolangir.


The IMD also said that the severe heatwave condition will continue in Jharsuguda till April 24.

CM to start distribution of new ration cards April 24 AGENCIES

Bhubaneswar, April 22: Chief Minister Mohan Charan Maihi will launch distribution of new ration cards among 5.90 lakh beneficiaries April 24, Food Supplies and Consumer Welfare (FS&CW) Minister Krushna Chandra Patra said Tuesday.

Patra said 9 lakh people have applied for ration cards, and of them, nearly 5.90 lakh were found eligible to be covered under the food security scheme.

"The chief minister will launch the distribution of new ration cards on National Panchayati Raj Day (April 24) from Puri. After the event, the new ration cards will be distributed in other parts of the state," Patra told reporters.

The minister said new ration cards will be distributed among the beneficiaries at the block level.

Nearly 25 lakh ration card holders have not completed their e-KYC (electronic know your customer) process till now, he said, adding that a field-level verification of these beneficiaries is in progress.

Bhubaneswar, April 22: The Opposition BJD Tuesday sought the intervention of the National Commission for Scheduled Tribes (NCST) into the death of a tribal man during a recent eviction drive conducted by the administration in Rourkela.

A 35-year-old tribal protester, identified as Ettua Ekka from Barkani village in Sundargarh district, died allegedly after coming under an excavator engaged in the construction of a railway line to the Rourkela Steel Plant (RSP).

The deceased was among the villagers who were protesting their eviction for the railway line construction.

As many as 19 people, including 16 policemen, were injured in stone pelting by the agitators.

A BJD delegation submitted a memorandum to the NCST, through its regional office in Bhubaneswar, and sought its intervention into Ekka's death.

The memorandum highlights the 'grave violation of tribal rights' and the 'alarming administrative apathy that led to Ekka's death' April 20. "Ekka was crushed to death by an

excavator in the presence of the police, law enforcement and RSP officials who were trying to prevent the encroachment of community land. The incident has sparked grief, anger, and fear across the region, with serious concerns raised regarding police conduct, misuse of force, and criminalisation of peaceful protesters," the BJD memorandum said.

The regional party urged the NCST to direct an inquiry by an independent agency into Ekka's death and the role of local authorities, and demanded FIRs against officials responsible and RSP personnel, protection of tribal land rights and review of past acquisitions, withdrawal of FIRs lodged against tribal protesters and a structured process of dialogue and mediation between the administration and tribal communities.

'This is not merely a law and order issue but a matter of tribal dignity, justice, and constitutional protection," the BJD memorandum said and called upon the commission to act decisively to ensure accountability and prevent such 'state-sponsored injustices' to the common man in general and tribals in particular in future.

Cops rescue kidnapped boy; 7 held XIM varsity hosts 11th PG convocation WEATHER

Bhubaneswar, April 22: The police Tuesday rescued a kidnapped minor in a six-hour operation and arrested seven people, including the boy's private tutor, in connection with the crime, an officer said. The accused were identified

as Subhrakant Mohapatra, 22 - the boy's private tutor, Somnath Das, 21, Chinmaya Kumar Nayak, 22, Sandip Routray, 22, Sagar navak. 21. Sujata Jena. 19, and Nibedita Das, 20. At around 10:30am, a com-

plainant from Panchagaon village reported the kidnapping of his nine-year-old son at Airfield police station here, the officer of Bhubaneswar–Cuttack Police Commissionerate said.

The boy went to the school. where the miscreants kidnapped him and demanded the ransom, said police commis-

sioner S Dev Datta Singh. "As there is a risk to the life

of the kidnapped person in such an incident, we carried out a six-hour-long intense operation without registering the FIR and were able to rescue the victim safely from Nirakarpur area in Khurda," the police commissioner said.

Seven people involved in the crime were arrested, he said.

The police teams conducted raids at various places within the limits of the Airfield police station in Bhubaneswar, Nirakarpur PS in Khurda and Ranpur police station area in Nayagarh to apprehend the culprits and rescue the kidnapped child,

Singh said. 'The victim was in good health as he is a brave boy," he added

Bhubaneswar Deputy Commissioner of Police (DCP) Jagmohan Meena said the boy's

mother received a call from an unknown person, who told her that they had kidnapped her son. The kidnapper demanded a ransom to release the boy. The caller also instructed the parents not to inform the police about the kidnapping, the DCP said.

After getting information. four teams were formed to rescue the boy without waiting for the formal report. The kidnapped boy was rescued from a rented house at Nirakarpur, he said, adding that the boy's private tutor is also a resident of the same village

Recently, the complainant received a handsome amount of money after selling a patch of land. To get the money. Subhrakant orchestrated the plan with his associates, he said.

As per the plan, they executed the kidnapping for ransom. The car used in the incident has been seized, the DCP added.

3 held for killing 15-yr-old roommate Kotia: CM for panel to study situation Villagers seek Andhra Pradesh identity

Keonjhar, April 22: A 15-yearold student living in a hostel of a private residential college in Keonjhar was allegedly suffocated to death by three fellow roommates - all minors- following a brief altercation Tuesdav morning. The accused have been arrested, police said.

The victim was identified as Jaladhar Mahanta, son of Jagabandhu Mohanta of Tangarpada village of Tangarpada village under Jali panchayat in Champua block of Keonjhar district. Jaladhar was staying at the hostel of Gayatri Residential College at Dangarpada under Town police limits in Keonjhar town to pursue a summer course after passing his matriculation exams.

Preliminary investigation by police indicated that three students allegedly pinned Jaladhar down and strangled him using a napkin (gamchha) and smothered him with a blanket after a minor argument turned violent. He was found lying unconscious on a bed in the firstfloor hostel room at around 2 am Tuesday by another student



who had gone to fetch water from a water purifier. He suspected something fishy and informed the hostel Warden, police said. The Warden, in turn, in-

formed the college authorities who rushed the boy to the Keonjhar District Headquarters Hospital where he was declared dead on arrival by doctors.

The deceased student's father later filed a complaint with the Keonjhar Town police station, alleging his son had been murdered in the hostel. He said the college authorities called him at around 3 am informing that his son was unwell, and urged him to arrive quickly. Upon arrival, he was informed of his son's death. He allegedly told the police that Jaladhar was healthy and had no prior med-

ical conditions. Following this, police launched an investigation in the presence of family members and sent the body for post-mortem. Preliminary findings revealed a scuffle between Jaladhar and three of his roommates who allegedly choked him using a towel, resulting in death

by asphyxiation.

Keonjhar Town Police Station in-charge Srikant Sahoo said a case has been registered (Case No. 227/2025) and the three accused students have been arrested. "They are presently interrogated. They will be produced before the Juvenile Justice (JJ) Board," he said.

Ranjit Kumar Goud, a member of the college managing committee, said that ₹7 lakh compensation has been offered to the bereaved family. Around 100 students are currently attending the summer coaching program at the college.

Sources claimed that the college hostel in Keonjhar has been operating for several years without approval from the state Education department. Despite lacking proper permissions, the facility continues to house students in cramped conditions.

In many cases, six to three students are being accommodated in small rooms without adequate ventilation. Basic necessities such as clean drinking water, ORS (oral rehydration salts), and other essential health provisions are missing sources added.

Bhubaneswar, April 22: Chief Minister Mohan Charan Majhi Tuesday ordered the setting up of a committee to study the prevailing ground situation in Koraput district's Kotia gram panchayat over which the neighbouring Andhra Pradesh also makes its claim.

An official release issued by the Chief Minister's Office (CMO) said that the committee Pottangi: More than a hundred villagers from Dhulipadar, Nereduvalasa, and Tadivalasa – three key villages under Kotia Panchayat -approached former Andhra Pradesh Deputy Chief Minister Peedika Rajanna Dora at his residence in the Salur Assembly constituency Monday



afternoon. They reportedly expressed their anguish, stating they continue to suffer due to the ongoing territorial dispute between Odisha and Andhra Pradesh. They emphasised that they are currently residing in Andhra and wish to remain under its administration. Following this, Dora reportedly called a press conference at his residence in the evening, where he expressed solidarity with the villagers' demands. He stated that during his tenure in government, the state had never hesitated to extend basic services — including education, healthcare, pensions, transport, and housing — to people in these border areas. He urged the current Andhra Pradesh government to take the matter seriously, calling upon Deputy Chief Minister Pawan Kalyan to take immediate steps towards resolution.

Three held for Sundargarh minor tribal girl's gangrape

Rourkela, April 22: Three persons were arrested in connection with the alleged gangrape of a minor tribal girl that took place in a forest in Talasara area of Sundargarh district Monday, police said Tuesday.

The incident occurred when the minor was returning home at around 10pm along with her two friends after attending a community feast, a senior officer said.

As per the preliminary investigation, Sundargarh SP Pratyush Diwaker said, the girls got scared on noticing a four-wheeler following them and hid themselves near a bush. However, they found two vouths, familiar to them. passing by the road on a motorcycle and asked them for help.

All five, including the three girls, rode the two-wheeler and tried to escape from the place, but they were intercepted by the accused persons in the car, the officer said.

Peace Window

ood news is emerging from Moscow and Kyiv and US President Donald Trump's new strategy of mixing diplomacy with threat seems to be paying off. For the first time since the Russian invasion of Ukraine three years ago, Russian President Vladimir Putin on 21 April announced he is open to the possibility of bilateral talks with Ukraine. This could be an outcome of the pressure from the US on both sides to agree to a quick peace deal. At the same time Putin's climbdown from his earlier stated position setting conditions for the removal of Ukrainian President Volodymyr Zelenskyy before any talks for peace could be the outcome of an assurance from the US administration for a favourable deal.

US, European and Ukrainian officials are set to meet 23 April in London after Washington warned that it could abandon its efforts on ending the conflict if there were no signs of progress. Dramatically, 48 hours before the meeting Putin said it could be possible to discuss the halting of strikes against civilian infrastructure directly with Kyiv. As an evidence of his new gesture he also referred to Russia's decision to implement a surprise 30-hour Easter truce – which both sides accused each other of violating. Putin had previously demanded Zelenskyy be replaced before any peace initiatives could be taken up. What comes as a relief is that Zelenskyy said Ukraine is prepared for any discussion to halt attacks on civilian targets. In his nightly video address he said his country was expecting a clear response from Moscow. "We are ready for any conversation about how to achieve this," he insisted.

What is interesting is the tone both Putin and Zelenskyy are using to claim that they had all along "talked about" peace initiatives, even though Putin had previously stipulated that elections must be held in Ukraine to elect a new President. Obviously, Russia was calculating to install a puppet President in Ukraine to accept its terms for peace.

Drone attacks and other offensives by both parties are still continuing. However, the willingness being shown by Putin and Zelenskyy to begin a ceasefire leading to end of the conflict appears to be a response to Trump's demand that they show the "enthusiasm" to end their hostilities so that the US does not have to walk away from the peace initiatives.

A Ukrainian delegation is to reach London 23 April for talks with Britain, France and the US. The talks are a follow-up to a Paris meeting last week where the US and European states discussed ways to end the war and the US Secretary of State, Marco Rubio, reportedly presented Washington's plan for ending the war. Putin is apparently trying not to push Trump further and make his task as a peacemaker too difficult. Leaks suggest the Trump administration is now working out a peace deal that heavily favours Russia which is why Putin has responded to the peace initiative with such alacrity as had never been shown before. There are indications that the deal would include a pause to the conflict along the existing 1,000-km frontline, recognition that Crimea belongs to Moscow and a veto on Ukraine's NATO membership. There are also unconfirmed reports that the Zaporizhzhia nuclear power station - which Russia seized in 2022 – would be part of a "neutral" zone. Russia has maintained that Ukraine cede all the land Putin claims to have annexed and accept permanent neutrality. Ukraine says that would amount to surrender and leave it undefended if Moscow attacks again.

Zelenskyy had a taste of bullying by both Trump and US Vice President JD Vance in Washington a few weeks back for not agreeing to US terms. He would certainly not provoke them further, but at the same time he would not be alone in defending his country's interests as his European allies have rallied behind him through funds and arms since the humiliation Trump and Vance heaped on him. Peace does have a chance if Putin and Zelenskyy can find common grounds to safeguard their respective interests. However in the long term interest of peace, it is essential that the Trump administration does not bend over backwards to please Putin and instead keeps Europe and the rest of the world in view for a better future where no powerful nation bullies a smaller country for whatever reason.

GOVTS ARE NOT STARTUPS

round the world governments are trying to reinvent themselves in the image of business. Elon Musk's DOGE crusade in the US is quite explicit on this point, as is Argentina's chainsaw-wielding president, Javier Milei. But one also hears similar rhetoric in the UK, where Cabinet Office Minister Pat McFadden wants the government to foster a "test-and-learn" culture and move toward performance-based management.

The problem is that governments and businesses serve vastly different purposes. If public policymakers start mimicking business founders, they will undermine their own ability to address complex societal challenges. For startups, the highest priority is rapid iteration, technology-driven disruption, and financial returns for investors. Their success often hinges

on solving a narrowly defined problem with a single product, or within a single organization. Governments, by contrast, must tackle complex, interconnected issues like poverty, public health, and national security. Each challenge calls for collaboration across multiple sectors, and careful long-term planning. The idea of securing short-term gains in any of these areas doesn't even make sense.

Unlike startups, governments are supposed to uphold legal mandates, ensure the provision of essential services, and enforce equal treatment under the lawmore important today than ever. Metrics like market share are irrelevant, because the government has no competitors. Rather than trying to "win," it should focus on expanding opportunities and promoting the diffusion of best practices. It must be longterm minded, while achieving nimble and flexible structures that can adapt.

Introducing a new digital health app within a weak health-care system may offer incremental improvements, but it will not address underlying systemic issues, like a shortage of medical workers or geographic challenges. Worse, if startup logic is applied to public services, it could lead

to piecemeal solutions that exacerbate existing inefficiencies. For example, a city might create an app to report potholes, gaining quick wins in citizen engagement. However, this doesn't help the city to consider more sustainable transportation systems and lower carbon emissions that impact citizens' health.

The process by which governments learn to deliver better outcomes is profoundly different from that of a startup. Rather than blindly embracing startup culture, governments should examine past efforts to modernize and reform public services. There are several lessons to be learned.

First, the public sector needs a new foundation in economics. The prevailing model's emphasis on "efficiency" too often confuses outputs with outcomes, and it rests on an overly simplified public-private dichotomy. The result is an overreliance on superficial heuristics like cost-benefit analysis, which does not necessarily measure progress toward desired systemic outcomes

Governments also need to improve how they account for the long-term value of public investment. For example, UK Chancellor of the Exchequer Rachel Reeves is right to shift the focus from the public sector's net debt to its net financial liabilities, which better recognizes the return on public investments by including illiquid assets (government loans) and other financial liabilities (monetary gold). But Reeves' scheme still does not reflect the value of non-financial assets (like government ownership of infrastructure and housing), and its shortterm horizon prevents it from creating an incentive structure for longer-term investments.

A second lesson is that diversity is an asset, not an exercise in political correctness. Over the past century, the public sector strived for universality and uniformity: services should be as good and as accessible in small towns as they are in wealthier cities. But how those services are delivered also matters. Creating an adaptive, outcomes-focused public sector requires a more diverse workforce, ongoing training, multiple analytical perspectives, and a portfolio of interventions (since there are no silver bullets).

Third, the public sector needs to strike a balance between its political, policymaking, and implementation capabilities. Governments are more than administrative machines; they require political leadership, a sense of purpose, and the ability to adjust policies. Too often, public-sector reform focuses on technocratic efficiency, while neglecting the need to articulate and execute on a vision that will win public support.

Some municipal leaders have been pioneering new models. Rather than focusing on the politics of grievance, for example, mayors from Barcelona to Bogotá have been elected on platforms of urban transformation. Their success underscores the importance of balancing political vision with feasible implementation.

More broadly, to equip the public sector with the capacity it needs to address contemporary challenges, governments – and what one of us has called "entrepreneurial states" must cultivate six capabilities that will enable them to learn, adapt, and adjust. The first is strategic awareness: an ability to identify emerging challenges and opportunities proactively. The second is agenda adaptability, so that priorities can be balanced while responding to crises. The third is coalition-building and partnerships, so that the public sector can foster collaboration across sectors and with communities.

The fourth capability is self-transformation: the continual updating of public agencies' skill sets, organizational structures, and operational models. This presupposes a fifth capability: experimentation and iterative problem-solving in public-service delivery. And, lastly, the public sector needs outcomes-oriented tools and institutions

Governments should not be run like startups, because they serve vastly different purposes, answer to different constituencies, and operate on entirely different timelines. Rather than chasing a Silicon Valley mirage, policymakers should focus on building the structures and capabilities that enable governments to be responsive, resilient, and effective. Reform must be rooted in a deep understanding of public-sector dynamics, rather than in the desire to mimic unicorns chasing the next big disruption – too little too late. And yes, we are learning in real time that disruption alone is a recipe for disaster.

In every given occasion, Francis would remind the world of the uncomfortable comparisons about the fate of the poor and the indulgences of the rich. The Pope consistently questioned the logic of capitalism and its promise of trickle-down economics. He demolished the excuses of its apologists by showing them the mirror of reality: "The promise was that when the glass was full, it would overflow, benefiting the poor. But what happens, instead, is that when the glass is full, it magically gets bigger; nothing ever comes out for the poor." The Pope embraced the refugees and asked the West, where most of his faithful lived, to give them shelter at a time when they were growing suspicious of the influx. The world has been, for sure, rendered much poorer by the passing of Pope Francis.

Even if I could afford a firstclass ticket, I wouldn't do it. If I'm going to spend that much on a ticket, I'd rather get a frontrow seat at a Rihanna concert. Spending \$50,000 might even get me a backstage pass to meet her.

Most of us aren't privileged enough to throw our money at everything. We have to make choices. Some people choose to live frugally, but donate generously to charity. Others drive fancy cars, but live in tiny apartments.

Whatever your choice, make sure you're getting something special out of it, not just trying to impress other people or feel superior. Don't make a Bass out of yourself.

Surat records 1,866 suicides in 3 years

Surat, April 22: As many as 1,866 suicide cases were reported in Surat city in the last three years, with domestic disputes emerging as the biggest reason for people taking the extreme step followed by chronic illness and financial distress, police said Tuesday.

Alarmed by the rising number of suicides in the Gujarat's diamond hub, police have launched two dedicated helplines to provide emotional support besides counselling to people in distress and prevent them from taking their own lives.

The survey revealed a majority of the suicide cases were reported in areas with the highest concentration of factory workers.

"A committee formed around three months ago under two DCPs to suggest steps to prevent suicides carried out a study of 1,866 suicide cases that were reported in the city in the last three years (2022 to 2024). The committee listed various reasons that drove people to take the extreme step, said Surat Commissioner of Police Anupam Singh Gahlaut.

The study revealed that a majority of these individuals -- 490 or 26 per cent of total suicides -- killed themselves due to domestic disputes.

Chronic illness accounted for 452 cases or 24 per

cent, emerging as the second biggest reason for suicide, he said.

The study further highlighted that financial distress and debts, problems in love relations, depression, academic or career failure and job loss were among other main reasons that drove people to commit suicide, noted the

IPS officer. To prevent the increasing number of suicides, the police launched three helpline numbers, which will be operational 24 hours from Tuesday, with two policemen and a counsellor in attendance, he informed.

A distressed person or those looking to prevent suicide can dial 100 (regular number for police assistance) or use two other helpline numbers launched for the purpose: 8128369100 and

8128308100, he said. The detailed break-up of suicides was based on First Information Reports (FIRs), suicide note, family statements. phone logs and health-re-

lated aspects of victims, officials said.

The study showed as many as 355 individuals (19 per cent) who committed suicidal self-harming acts were driven by financial distress and debts, with usury and monetary pressure being the main reasons.

The survey linked 228 suicide cases (12.2 per cent) to depression, 200 (11 per cent) to academic or career failure, failure in exams or getting jobs, and 104 (5.6 per cent) to stress in romantic relationships.

In addition, 37 people (2 per cent) killed themselves after becoming a victim of cyber fraud or blackmailing, it showed. The survey revealed a majority of the suicide cases were reported in areas with the highest concentration of factory workers. Surat is the country's largest hub for diamond polishing and cutting work and is also a major textile centre, with lakhs of workers employed in these two sectors.

Pahalgam (J&K), April 22: Shrieks for help pierced the skies of Baisaran meadows in this south Kashmir resort as more than a dozen tourists lay motionless in pools of blood following one of the deadliest terror attacks on civilians in recent years in J&K.

Heavily armed terrorists walked out of the woods of Baisaran, a meadow atop a hill here, and surrounded a group of around 40 tourists. The terrorists started firing on the tourists indiscriminately, leaving 26 people dead and injuring at least 20.

Eyewitnesses claimed that as soon as the bullets started flying, the handful of locals who earn a livelihood from tourism ran for safety, leaving the tourists as sitting ducks.


"My husband was shot in the head... he was shot for not being a Muslim. Seven others are injured in the attack." a woman survivor told PTI over phone. The woman, who did not identify herself, pleaded for help in evacuating the injured to the

hospital. "Bhaiyya please mere husband ko bacha lo (Brother, please save my husband)," the woman pleaded frantically with this reporter. As the famed meadows are only accessible by foot or ponies, authorities had to summon choppers for the evacuation of the injured, officials said.

However, before the helicopter arrived at the scene, some of the injured were brought down by local people on their ponies. The local tourist guides and ponywallahs consoled the survivors even as they summoned more people to evacuate the injured tourists on their shoul-

who was in the national capital. Union Home Secretary Govind Mohan, Director of Intelligence



Bureau Tapan Deka and a few senior officials accompanied the home minister. Union Tourism Minister Gajendra Singh Shekhawat said the perpetrators of the terror attack will face the "harshest consequences".

SC to examine if TN verdict covers issues raised by Kerala

PRESS TRUST OF INDIA

New Delhi, April 22: The Supreme Court Tuesday said it would examine whether the recent judgement on a plea of Tamil Nadu, fixing timelines for the grant of assent to Bills, covered the issues raised by the Kerala government in its pleas

A bench comprising Justices P S Narasimha and Joymalya Bagchi agreed to hear May 6 the pleas of the Kerala government against Governor over the delay in approving Bills passed by the state assembly.

"We will look into that judgement and see whether issues raised here are covered," the bench said when Attorney General R Venkataramani and Solicitor General Tushar Mehta, appearing for the Centre and the Governor's office, said the recent judgement delivered by a bench headed by Justice J B Pardiwala did not cover the issues raised by the Kerala government.

A bench comprising Justices Pardiwala and R Mahadevan April 8 delivered a significant verdict on the plea of Tamil Nadu and set aside the reservation of the 10 Bills for President's consideration in the second round holding it as illegal, erroneous in law. The bench, for the first time, also prescribed that President should decide on the bills reserved for her consideration by Governor within a



period of three months from the date on which such reference is received.

Kerala seeks similar directions in its case. On Tuesday, senior advocate K K Venugopal, appearing for Kerala, said the pleas of the state were covered by the recent judgement. "What is the timeline for making a reference to the President by the Governor and this issue is dealt with by that judgement and there are

no other questions," he said. He urged the bench to allow the

pleas of the Kerala government in terms of the Tamil Nadu judgement. Mehta, however, insisted on making submissions saying the case of Kerala was not covered by the Tamil Nadu judgement. The bench asked Venugopal to mention the third and subsequent plea of the state government, challenging the withholding of assent by President, before the CJI so that it can also be referred to it.

Venugopal said the Chief Justice of India directed listing of the petition May 13. The bench said a mention had to be made before the CJI for tagging the other petition with the present one.

In 2023, the top court expressed displeasure over the then Kerala Governor Arif Mohammed Khan "sitting" for two years on Bills passed by the state legislature. Khan is currently Governor of Bihar.

The top court, July 26, last year, agreed to consider the plea of opposition-ruled Kerala alleging the denial of assent to bills passed by the legislative Assembly.

The Kerala government alleged that Khan referred certain bills to President Droupadi Murmu and those were yet to be cleared.

China urges UK, EU to uphold multilateral trade in face of US tariffs

Beijing, April 22: Chinese Foreign Minister Wang Yi urged Britain and the European Union Tuesday to safeguard multilateral trading systems, as Beijing seeks to rally support from trading partners to counter US tariff measures.

China and the United States have remained locked in a deepening trade war, with titfor-tat tariff hikes that have significantly disrupted bilateral commerce.

The United States has weaponised tariffs to launch indiscriminate attacks on countries. openly violating WTO rules and undermining the legitimate rights and interests of others,' China's foreign ministry cited Wang as saying in a phone call with British Foreign Secretary David Lammy.

China and Britain had a responsibility to uphold international order in the face of "rampant unilateral bullying", Wang told Lammy.

China was ready to work with Britain to "eliminate all distractions", Wang said, adding that the onus was on both countries to safeguard multilateral trading systems.

In a separate call with Austrian Foreign Minister Beate Meinl-Reisinger, Wang called on the EU to defend multilateral trade and said China was willing to further strengthen high-level exchanges with the bloc.

Washington has raised tariffs to 145% on Chinese goods, prompting Beijing to retaliate by slapping duties of 125% on items imported from the US.

Wang's phone calls came after Beijing Monday warned countries against striking a broader economic deal with the US at its expense, and threatened countermeasures if they did so.

Bangladesh denies India's claim over Hindu leader's death


Dhaka, April 22: Bangladesh has rejected New Delhi's charge that the recent killing of a Hindu leader was part of a "pattern of systematic persecution" of minorities in that country.

Body of Hindu community leader Bhabesh Chandra Roy, 58, a resident of Basudebpur village of Dinajpur district in north Bangladesh, was recovered Thursday night. His son has claimed Roy was allegedly abducted from his home in the village, about 330 kilometres northwest of Dhaka, and beaten to death.

"It is unfortunate that the death of Mr Bhabesh Chandra Roy has been described as part of a 'pattern of systematic persecution' of Hindu minorities under the interim government," interim government chief Muhammad Yunus' press secretary Shafiqul Alam told the state-run Bangladesh Sangbad Sangstha (BSS) news agency late Monday.

Alam, who is currently accompanying Yunus to an international conference in Qatar, said Bangladesh is not a country where one would find government-sponsored systematic discrimination against minorities. Rather, he claimed, the Bangladesh government protects the rights of all of its citizens irrespective of religious denominations.

The Bangladesh reaction came days after India condemned the alleged abduction and killing of the Hindu minority leader in Bangladesh and called on the interim government in Dhaka to live up to its responsibility of protecting the minorities.

ANCIENT RITUALS

In a break from tradition, Francis confirmed in his final testament released Monday that he wished to be buried in Rome's Basilica of Saint Mary Major and not St Peter's, where many of his predecessors were laid to rest.

Francis' death has set in motion ancient rituals, as the 1.4-billion-member Church started the transition from one pope to another, including the breaking of the pope's "Fish erman's Ring" and lead seal used in his lifetime to seal doc uments, so they cannot be used by anyone else.

As Catholics worldwide mourned Francis, all cardi nals in Rome were summoned to a meeting Tuesday to decide on the sequencing of events in the coming days and review the day-to-day running of the Church in the period before a new pope is elected.



Djoko returns to Madrid

Madrid: Former champion Novak Djokovic has returned to the Madrid Open for the first time in three years in hopes of achieving his 100th tour-level title. Djokovic is seeded fourth in the same half of the draw as second-seeded Carlos Alcaraz, the home favorite who arrives at the Caja Magica this week with fitness concerns after reaching consecutive clay-court finals. The 37-year-old Djokovic, a three-time champion in Madrid, hasn't played in the Spanish capital since losing to Alcaraz in the 2022 semifinals, their first meeting. Djokovic won his 99th title last August at the Paris Olympics. He has lost four finals since then, most recently last month in Miami. The 100-title club features only Jimmy Connors (109) and Roger Federer (103). Over the last two weekends, Alcaraz has won the Monte Carlo Masters and lost in the Barcelona Open final, where he needed treatment on his upper right leg Sunday.

Buenos Aires, April 22: Pope Francis' passion for soccer was evident throughout his pontificate. A lifelong supporter of Argentine club San Lorenzo, he agreed with those who describe soccer as the most beautiful game in the world. But Francis, who died Mondav at 88, also turned to the sport for anecdotes about camaraderie, fellowship and teamwork in an increasingly individualistic society.

"Soccer is a team sport. You can't have fun alone," the pope told a crowd of Italian youth, soccer players and coaches at the Vatican in 2019. "And if it's lived like that, it can do good for your mind and your heart in a society that is exasperated by subjectivism," he said. Like most Argentine chil-

dren, young Jorge Mario Bergoglio grew up with soccer. He played for hours with friends on sidewalks or dusty pitches known as "potreros" in his

native Flores neighborhood of Buenos Aires. According to his own assess-

ment, he was not that good. In his recently published autobiography "Hope," Francis

said his skills were so poor that he was nicknamed "hard foot." Like many in his family, he became a supporter of San Lorenzo, a club founded by priest Lorenzo Massa in 1908. Its fans are nicknamed "the crows" due to the black cassock of its

founder. As a boy, he became fascinated by the colorful style of play of the team that won the local title in 1946. Until his death he remembered the entire lineup. San Lorenzo won its first Copa Libertadores, the top club tournament in South America, in 2014 — a year after he became pope. The club's board of directors and a group of players took the trophy to the Vatican. Later, club executives decided to name their planned future stadium after Pope Fran-



cis, who until the end paid his dues to the club as member No. 88,235

The greatest of all time?

In an interview with Italy's RAI television in 2023, Francis weighed in on the debate about who is the greatest soccer player of all time. Asked to choose between his compatriots Diego Maradona and Lionel Messi, World Cup winners from different generations, Francis' answer was unexpected.

"I will add a third," he said. "Pelé."

He met the Brazilian great, a devout Catholic and three-time World Cup winner, before he was elected pope. Francis later met Messi and Maradona at the Vatican as pontiff.

"Maradona, as a player, was great. But as a man he failed," Francis said about the 1986 World Cup winner, who struggled with cocaine use and health issues and died in 2020 at 60. Maradona was celebrated by people who in the end didn't help him, the pope added.

He described Messi, who lifted the World Cup trophy in 2022, as "very correct" and a gentleman.

"But for me, among those three, the great gentleman is Pelé," the pope said.

In a message read during a tribute to Pelé in Rio de Janeiro a year after his death in 2022, Francis said "many of the necessary virtues to perform a sporting activity, such as perseverance, stability and temperance, are also part of Christian virtues. Pelé was undoubtedly an athlete who manifested these positive characteristics of sport in his life.'

The World Cup final he didn't watch

Despite being a big soccer fan, Francis didn't watch any games on television. He said he avoided watching TV altogether because of a promise he had made to the Virgin of Carmen in 1990.

The radio became his means to stay informed and listen to soccer matches until he moved to Rome.

Once in the Vatican, members of the Swiss Guard, who took care of his security, informed him about San Lorenzo and Argentina match results.

That's how he found out that Argentina had won their third World Cup title in Qatar after a penalty shootout against France. While he was enthusi astic about the game, he spoke out against the fanaticism and violence that sometimes over shadow it. He called on top-level players to show humility and always remember their origins.

"Don't forget where you came from. Those pitches in the outskirts, that place for praver that small club," he said in his 2019 speech.

"I hope you can always feel the gratitude for your story, which is made of sacrifice victories and battles." Francis added.

RBI to banks: Migrate to '.bank.in'

Mumbai: The Reserve Bank Tuesday directed banks to start migration of their existing domains to the '.bank in' domain and complete the process by October 31 this year, aimed at combating increasing instances of fraud in digital payments. In the wake of fraud in digital payments, the Reserve Bank of India (RBI) has decided to introduce the 'bank.in' exclusive internet domain for Indian banks. The initiative aims to reduce cybersecurity threats and malicious activities like phishing; and, streamline secure financial services. thereby enhancing trust in digital banking and payment services. "It has now been decided to operationalise the '.bank.in' domain for banks through the Institute for Development and Research in Banking Technology (IDRBT), which has been authorised by National Internet Exchange of India (NIXI), under the aegis of the Ministry of Electronics and Information Technology (MeitY), to serve as the exclusive registrar for this domain," it said in a statement. Banks may contact IDRBT at sahvog@idrbt.ac.in to initiate the registration process. IDRBT shall guide the banks on various aspects related to the application process and migration to the new domain.

IMF cuts India's growth forecast **GOLD BREACHES**

Global economic outlook worsens due to Trump tariffs

Washington, April 22: The International Monetary Fund (IMF) Tuesday cut its economic growth forecast for India for the current fiscal year, citing increased trade tensions and global uncertainty.

The IMF lowered its forecast for the country to 6.2% from the 6.5% it had forecast in January for the fiscal year that started April 1.

"For India, the growth outlook is relatively more stable at 6.2% in 2025 supported by private consumption, particularly in rural areas," the IMF said in its World Economic Outlook report, where it slashed its forecasts for growth for most countries, citing the impact of U.S. tariffs

For India, it said it was cutting its forecast due to "higher levels of trade tensions and global uncertainty.'

The outlooks for the US and global economies have significantly worsened in the wake of President Donald Trump's tariffs and the uncertainty they have created, the IMF said.

The IMF said that the global economy will grow just 2.8 per cent this year, down from its forecast in January of 3.3 per cent. And in 2026, global growth will be 3 per cent, the fund predicts, also below its previous 3.3 per cent estimate.

US economic growth will come in at just 1.8 per cent this year, down sharply from its



previous forecast of 2.7 per cent and a full percentage point below its 2024 expansion. The IMF doesn't expect a US recession, though it has raised its odds of one this year from 25 per cent

to 37 per cent. The forecasts are largely in line with many private-sector economists' expectations, though some do fear a recession is increasingly likely. Economists at JPMorgan say the chances of a US recession

are now 60 per cent. The Federal Reserve has also forecast that growth will weaken this year, to 1.7 per cent. 'We are entering a new era,'

Pierre-Olivier Gourinchas. chief economist at the IMF. said. "This global economic system that has operated for the last eighty years is being reset.' The IMF is a 191-nation lending organisation that works to promote economic growth and financial stability and to reduce global poverty.

Gourinchas said that the heightened uncertainty around the import taxes led the IMF to take the unusual step of preparing several different scenarios for future growth. Its forecasts were finalised April 4, after the Trump administration announced sweeping tariffs on nearly 60 countries along with nearly-universal 10 per cent duties. Those duties were paused April 9 for 90 days.

Gourinchas said the pause didn't substantially change the IMF's forecasts because the US and China have imposed such steep tariffs on each other since then.

The uncertainty surrounding the Trump administration's next moves will also likely weigh heavily on the US and global economies, the IMF said. Companies may pull back on investment and expansion as they wait to see how the trade policies play out, which can slow growth.

China is also forecast to grow more slowly because of US tariffs. The IMF now expects it will expand 4 per cent this year and next, down roughly half a point from its previous forecasts.

While the US economy will likely suffer a "supply shock," similar to what hampered during the pandemic and which pushed up inflation in 2021 and 2022, Gourinchas said, China is expected to experience reduced demand as US purchases of its exports fall.

Inflation will likely worsen in the United States, rising to about 3 per cent by the end of this year, while it will be little changed in China, the IMF forecast

The European Union is forecast to grow more slowly, but the hit from tariffs is not as large, in part because it is facing lower US duties than China. In addition, some of the hit from tariffs will be offset by stronger government spending by Germany.

The economies of the 27 countries that use the Euro are forecast to expand 0.8 per cent this year and 1.2 per cent next year, down just 0.2 per cent in both years from the IMF's January forecast.

New Delhi, April 22: Gold prices surged by ₹1,800 to zoom past the crucial ₹1 lakh-mark for 10 grams in the national capital Tuesday amid buying rush by local jewellers and stockists in anticipation of increased demand during Akshaya Tritiya and wedding season even as global macroeconomic uncertainties continued to fuel safe-haven chase.

According to the All India Sarafa Association, the precious metal of 99.9 per cent purity climbed ₹1,800 to hit the lifetime peak of ₹1,01,600 per 10 grams from Monday's closing level of ₹99,800 per 10 grams.

Gold of 99.5 per cent purity also jumped by ₹2,800 to hit a record high of ₹1,02,100 per 10 grams in the local markets on Tuesday. It had settled at ₹99,300 per 10 grams in the preceding session. Akshava Tritiva, which is considered the most auspicious day to buy gold, falls on April 30. The ongoing wedding season will continue till May end. The yellow metal has spurted by ₹22,650 per 10 grams, or nearly 29 per cent, since December 2024, Meanwhile, silver prices remained flat at ₹98,500 per kg on Tuesday. "The new all-time-high at-

tained by the yellow metal is primarily influenced by the rising tensions between President Trump and US Fed Chair Jerome Powell regarding the interest rate cut. Additionally, weakness in the US dollar following the tensions between



Trump and Fed Chair Powell and uncertainties around the US-China trade war are another crucial factors that has pushed gold price to a record high," Colin Shah, MD, Kama Jewelry, said.

While the gold price is on an upward trajectory, the fall in US dollar will make gold affordable in other currencies, keeping the demand-price dynamics balanced, Shah said.

"In the domestic markets. it is observed that gold price witnesses a slight rise around festive season like Akshaya Tri tiya, in reflection to the spike in demand. The sentimental and cultural value attached towards investing in yellow metal on auspicious occasions like this will keep the demand upbeat, irrespective of the price trend,' he added.

In the futures trade on the Multi Commodity Exchange (MCX), the most-traded June contract of the precious metal surged by ₹2,079 or 2.14 per cent to reach a record high of ₹99,358 per 10 grams.

Later, it pulled back from the record level to trade at ₹98,450 per 10 grams, up by ₹1,171 or 1.2 per cent with a interest of 21,899 lots.

"These ongoing talks will help achieve balance and rec iprocity by opening new mar kets for American goods and addressing unfair practices that harm American workers India's constructive engage ment so far has been welcomed and I look forward to creating new opportunities for workers, farmers, and entrepreneurs in both countries." he said. Vance is in India on a fourday visit. The two countries are aiming to finalise the first phase of the pact by the fall (September-October) this year. 'India to benefit from supply chain realignments'

Mumbai, April 22: India is poised to benefit from supply chain realignments, diversified FDI sources, and engagement with global investors seeking resilience and scale, given its already established trade linkages, said the RBI's April bulletin.

Moreover, India's consistent strength in services exports and remittance inflows continues to provide a vital buffer for the current account, said an article on 'State of the Economy' in the bulletin.

"Calibrated policy support can help India turn global volatility into an opportunity and strengthen its position in the emerging world economic landscape," it said.

It also noted that escalation of trade and tariff tensions and the resultant financial market volatility have raised concerns regarding the weakening of global growth in the near term.

"Although the dampening global economic outlook could impact India's economic growth through weaker external demand, the domestic growth engines, viz., consumption and investment, are relatively less susceptible to external headwinds," the article said.

Prospects for the farm sector have been boosted by the forecast of an above normal southwest monsoon for 2025, which could augment farm incomes and keep food prices under check, it noted.

The Reserve Bank of India (RBI), however, said the views expressed in the bulletin article are of the authors and do not represent the views of the central bank.

The Indian economy continues to remain resilient on strong domestic growth impulses and sound macro-fundamentals despite strong global headwinds emanating from trade tensions. Consumers and businesses remain optimistic regarding the economic outlook, the article stated.

High frequency indicators suggest that aggregate demand remained broadly resilient during Q4:2024-25. Indicators such as E-way bills and toll collections recorded robust y-o-y growth in double digits in March 2025, despite a sequential moderation in the latter.

The article further said that global growth outlook remains downcast, as uncertainty surrounding tariffs and the individual policy responses of different countries could result in lower investments spending, subdued consumer confidence. and a slowdown in global trade.

"The long-term effects of these developments on the course of the global economy remain highly uncertain as there is still no clarity regarding the scope, timing and intensity of tariffs," the article said.

Going forward, it said global financial conditions are likely to remain volatile and EMEs are vulnerable to feedback loops and spillovers which may lead to reigniting of global inflation.

Decline in global commodity prices, however, could ease pressure on inflation in commodity importing countries, although currency pressures could partly offset such benefits.

"India's strength to withstand these headwinds stem from its robust growth fostered by a strong macroeconomic framework and moderating inflation, with strong domestic engines of growth,² the article said.

The agricultural sector in India is poised to sustain its momentum, supported by bumper kharif and rabi harvest and higher summer sowing amidst comfortable reservoir position.

Risks emanating from the rise in temperature above normal levels and likelihood of heatwaves in the current summer season (April - June), however, needs to be monitored, it added.
