State govt approves industrial projects worth ₹3,898 crore

Bhubaneswar, May 2: The state government Friday approved 19 projects worth ₹3,898 crore, which are expected to generate employment for over 7,400 people.

According to an official statement, the State Level Single Window Clearance Authority (SLSWCA) meeting, chaired by Chief Secretary Manoj Ahuja, has given its nod to the proposals spanning various sectors such as steel, iron & ferro alloys, industrial gases, logistics, food and beverage, agro-processing, tourism and hospitality, chemicals, metal downstream, and apparel and textile.

The projects are proposed to be grounded in Angul, Balasore, Cuttack, Dhenkanal, Ganjam, Jajpur, Keonjhar, Khurda, Koraput, Sambalpur and Sundargarh districts, it said.

The state has approved the proposal of Sree Metaliks Limited to expand its integrated steel plant in Keonjhar with an investment of ₹885 crore, it

The proposal of Tata Steel to enhance its crude steel capacity from the proposed 6.5 million tonne per annum (MTPA) to 7.1 MTPA with an additional investment of ₹700 crore was also green-lighted by the panel.

Lal Baba Seamless Tubes Pvt Ltd proposed to establish a precision tube manufacturing facility in Cuttack with an investment of ₹200 crore while Surlon India Ltd will set up a railway component manufacturing unit in Sundargarh for

Both projects were approved by the Odisha government, the statement said. Among others, the SLSWCA also approved the proposals of Linde India Ltd (₹425 crore), Bhuvaneshwari Foods & Beverages Pvt Ltd (₹300 crore), ACME Clean Energy Pvt Ltd (₹366.50 crore), and Vasanth Vihar Constructions (

Kharge: No strategy from govt after Pahalgam attack

New Delhi, May 2: Congress president Mallikarjun Kharge Friday said the government had not come out with any clear strategy to deal with the situation arising out of the Pa halgam terror attack, even as he asserted that the entire opposition was with the Centre on the issue.

In his remarks at the Congress Working Committee (CWC) meeting at the party's 24, Akbar Road office, Kharge also said the government had accepted the party's demand for a caste sur vey but the timing 'surprised us' He, however, raised doubts over the government's intentions and asked party leaders to remain alert to take the caste survey to a logical conclusion.

The Congress president credited former party chief Rahul Gandhi for the government's decision to conduct a caste survey, saying the Opposition leader in the Lok Sabha had again proved that if "we raise the issues of the people with honesty, the government has to bow down.

Noting that the party had extended all possible support to the Centre in the fight against terrorism at the last CWC meeting, Kharge said no clear strategy had come from the gov ernment even several days after the Pahalgam attack.

Puri: The only Jagannath Dham 96% students clear

West Bengal's naming of a newly-built Jagannath temple at Digha as 'Jagannath Dham' has come in for severe flak from devotees, priests and researchers, who have called for the removal of this 'self-styled' title as it hurts the sentiments of millions of devotees of Lord Jagannath across the world. They assert that only Puri should be referred to as 'Jagannath Dham' as is mentioned in scriptures and has been the practice over centuries. Scholars contend that it was Adi Shankaracharya who established four 'Dhams' in four corners of India – Puri in east, Dwarka in west, Badrinath in north and Rameswaram in south-- and renaming any other temple as 'Dham' goes against the tradition and tenets of Hindu beliefs

Bhubaneswar, May 2: Amid a row over the West Bengal government's portraval of the newly inaugurated Digha temple as 'Jagannath Dham' and alleged use of surplus wood of the Puri shrine in the construction of idols there, state Law Minister Prithivirai Harichandan Friday asked the Shree Jagannath

Temple Administration (SJTA) to inquire into the matter.

The state government's move came after local media reported that some Puri servitors had attended the consecration ceremony at the Digha temple and used leftover 'neem' wood from the 2015 'Nabakalebara' to make the idols for the shrine in the neighbouring state.

Devotees, priests, scholars

and pundits have demanded the removal of the 'Jagannath Dham' label from the Digha temple. Keeping in view the statewide outrage over the twin issues, Harichandan wrote a letter to SJTA Chief Administrator Arabinda Padhee and asked him to conduct an internal investigation into the entire incident and make arrangements to bring the truth to the public. "If anyone is found guilty in this incident or is knowingly causing such an incident, the temple's chief administrator may take steps to punish them with the permission of the state government,

Harichandan said that the recent incidents have hurt the religious sentiments of devotees and the 4.5 crore people of Odisha.

the minister said in the letter.

An accusing finger is being



pointed at Ramakrushna Dasmohapatra, the secretary of 'Daitapati Nijog', a group of servitors who serve the Lord during Rath Yatra. He rejected the charge.

"I had attended the consecration ceremony at Digha temple following an invitation from my disciple Mamata Banerjee. I have monitored the entire procedure. But I never said that the wood from the Puri temple was used for idol making at Digha," Dasmohapatra said.

Addressing a press conference at Puri, Dasmohapatra admitted that he had taken wooden idols from Puri, but not used the leftover 'neem' wood of Puri temple. "I have also not talked

about it to any television channel in the Bengali language. I have also not told anything regarding the installation of 'Brahma'," he clarified. Local television channels showed Dasmohapatra speaking to a Bengali news channel that he had used leftover neem wood from the 2015 Nabakalebara to make the idols at the Digha temple.

Deputy Chief Minister KV Singh Deo said Chief Minister Mohan Charan Majhi is aware of the development, but urged everyone to "not jump the gun."

"I know there are four Shankaracharvas in four Dhams. I have limited knowledge and am not as wise as her (Banerjee). I know there are four Dhams in India. Let her justify why she called the Digha temple a 'Dham'." he said. There can be several Jagannath temples in the country, but Puri is the only Jagannath 'Dham', the deputy CM asserted.

The issue gradually snow balled into a major controversy after many priests, researchers. servitors and scholars rejected calling the Digha temple a 'Dham'. While most critics welcomed the establishment of the temple in Digha, they opposed linking the term 'Dham' with it.

Class X board exams

Cuttack, May 2: More than 96 per cent of the students who appeared for the Matriculation (Class-10) examinations-2025 under the Odisha Board of Secondary Education (BSE) cleared the exams, School Mass Education Minister Nityananda Gond said Friday.

The 10th Board examinations in Odisha are conducted under three streams - the High School Certificate Examination for Regular students, Madhyama Examination for Sanskrit students, and the State Open School Certificate (SOSC) examination for school dropouts.

Chief Minister Mohan Charan Majhi congratulated the students who passed the High School Certificate Examination. In an X post, he also said, "I advise the children who have not got promising results not to get discouraged and to continue working hard with strong willpower and self-confidence regardless of the results. I wish everyone a bright future and further success.

Expressing satisfaction over the conduct of the examinations and the timely publication of the results, Gond congratulated the successful students for registering better grades than those in previous years.

"More students have passed securing higher grades," the minister said, adding that all candidates in 3,273 schools cleared the exams and not a single institute has the dubious distinction of registering not a single pass among the candidates. In all three streams of examination, a total of 5,19,728 students had filled up their appli cation forms this year to appear for the tests. Of them, 5,10,925 students appeared for the tests in all the subjects, of which 5,10,925 students (96.27 per cent) passed

Among regular students, 1812 passed in A1 grade, securing more than 90 per cent. While 12,200 students passed in A2 grade, getting between 80 and 89 per cent marks. 38,831 students passed in B1 grade (between 70 and 79 per cent), and 84,971 students passed in B2 grade, securing marks between 60 and 69 per cent.

Failed launch to Venus: Soviet-era spacecraft to fall to Earth

Cape Canaveral, May 2: A Soviet-era spacecraft meant to land on Venus in the 1970s is expected to soon plunge uncontrolled back to Earth, possibly within the first two weeks of May.

It's too early to know where the half-tonne mass of metal might come down or how much of it will survive reentry, according to space debris-tracking experts.

Dutch scientist Marco Langbrock predicts the failed spacecraft will reenter around May 10. He estimates it will come crashing in at 242 kph, if it remains intact.

'While not without risk, we should not be too worried.' Langbroek said in an email. The object is relatively small and, even if it doesn't break apart, "the risk is similar to that of a random meteorite fall, several of which happen each vear. You run a bigger risk of getting hit by lightning in your lifetime," he said.

The chance of the spacecraft actually hitting someone or something is small, he added. "But it cannot be completely excluded."

The Soviet Union launched the spacecraft known as Kosmos 482 in 1972, one of a series of Venus missions. But it never made it out of Earth orbit because of a rocket malfunction.

Most of it came tumbling down within a decade. But Langbroek and others believe the landing capsule itself — a spherical object about 1 metre in diameter — has been circling the world in a highly elliptical

orbit for the past 53 years, gradually dropping in altitude.

It's quite possible that the nearly 500-kg spacecraft will survive reentry. It was built to withstand a descent through the carbon dioxide-thick atmosphere of Venus, said Langbroek of Delft University of

Technology in the Netherlands. Experts doubt the parachute system would work after so many years. The heat shield may also be compromised after so long in orbit.

It would be better if the heat shield fails, which would cause the spacecraft to burn up during its dive through the atmosphere, the Harvard-Smithsonian Centre for Astrophysics' Jonathan McDowell said in an email. But if the heat shield holds. "it'll reenter intact and you have a half-ton metal object falling from the sky.

The spacecraft could reenter anywhere between 51.7 degrees north and south latitude, or as far north as London and Edmonton in Alberta, Canada, almost all the way down to South America's Cape Horn. But since most of the planet is water, "chances are good it will indeed end up in some ocean, Langbroek said.

India blocks Pak PM's YouTube channel

New Delhi: Pakistan Prime Minister

Shehbaz Sharif's YouTube channel was blocked in India Friday amid ongoing tension between the two countries following the deadly terrorist attack in Jammu and Kashmir's Pahalgam. "The content is currently unavailable in this country because of an order from the government related to national security or public order. For more details about government removal requests, please visit the Google Transparency Report," read a message on the blocked channel The government had earlier this week blocked 16 Pakistani YouTube channels for allegedly disseminating "false, provocative and communally sensitive content" about India and has also strongly objected to the BBC's reportage on the Pahalgam attack. The government's move follows recommendations from the Ministry of Home Affairs in the wake of the Pahalgam terror attack.





State govt inks pacts with 4 corporations for agri devpt

Bhubaneswar, May 2: The Odisha government Friday signed MoUs with four corporations for the development of agriculture and support to farmers for the 2025-26 finan-

The MoUs were signed by the Agriculture and Farmers' Empowerment department with Odisha Agro-Industrial Corporation (OAIC), Agriculture Promotion and Capital Investment Corporation Limited (APICOL), Odisha State Seed Corporation Limited (OSSC) and Odisha State Cashew Development Corporation Limited (OSCDCL) in the presence of Deputy Chief Minister Kanak Vardhan Singh Deo.

The partnership with OSSC aims to strengthen the seed production and supply chain.

The Agriculture department

will further strengthen farmers

by ensuring a timely supply of

certified seeds, an official said. Under the collaboration, both parties will work together to promote seed replacement and varietal improvement through a coordinated farmer

awareness campaign. For this, a turnover target of ₹56 crore has been set, the official said.

Similarly, OAIC has set a target of purchasing 45,000-tonne fertiliser, ₹20 crore worth pesticides, 7,000 tractors, 1,000 power tillers and other agricultural machinery.

The corporation will set up 5,200 electric-powered small lift irrigation projects, 4,800 solar-powered water tanks, and 1,000 shallow tube well

It will also spend ₹30 crore

current financial year, and a total turnover of ₹1,000 crore has been targeted for the corporation, the official said.

The MoU with APICOL was signed to create 6,500 business enterprises and provide subsidies worth ₹250 crore, of which ₹200 crore is meant for Mukhvamantri Krushi Udvog Yojana (MKUY) and ₹50 crore for a cold storage support scheme, he said.

Similarly, in the 2025-26 financial year, the OSCDCL will take up 500-hectare of hybrid cashew replanting programme and maintenance of trees over 1336.22-hectare to strengthen the cultivation in Odisha, the official said.

In addition, it has a target to produce 35-lakh hybrid cashew grafts from its existing 20 nurseries, he said.

During the programme, Singh Deo felicitated the managing directors of OAIC and APICOL for their outstanding performance in the last finan-

Presenting the letter of appreciation, the Deputy CM said that all the affiliated corporations have shown excellent performance, and the path of progress should continue further.

The Agriculture and Farmers' Empowerment department is one of the prominent departments that has spent 94.7 per cent of the approved budget, Singh Deo said.

"We are fully committed to the progress and development of farmers," he added.

Metro rail to run till SCB in Cuttack: Min

Bhubaneswar, May 2: State Housing and Urban Development minister Krushna Chandra Mohapatra has said that the metro rail project will be extended up to SCB Medical College and Hospital (SCB-MCH) in Cuttack with support from the Centre.

Speaking to media persons Thursday, Mohapatra said the previous BJD government

had planned to roll out metro rail from Biju Patnaik International Airport (BPIA) in Bhubaneswar to Trisulia, a square in between Cuttack and Bhubaneswar. "What will people do after arriving at Trisulia?" he asked.

"So, we have decided to expand it to Cuttack covering the bus terminal and SCB Medical College and Hospital where a large number of people are visiting daily," he said.

A special committee of top officials including Principal Secretary Usha Padhee and exa priority basis. perts has been formed to study the best possible route for the extension, Mohapatra said.

Based on their findings, a new Detailed Project Report (DPR) is being prepared to include the expanded metro line, he said. The minister said the Central government will now also help fund the project. He assured that the new state government, led by CM Mohan Ma jhi, will execute the project or

The previous BJD government had planned to take up the phase-I metro project of the 26-km-long stretch between BPIA in Bhubaneswar to Tri sulia at a cost of ₹6,225 crore.

Work on the Bhubaneswar Metro project officially began November 20, 2023. The first phase was targeted to be completed by 2027.

Greenfield airport to come up at Paradip; heliports in 14 dists

Bhubaneswar, May 2: In a bid to strengthen aviation infrastructure in the state, the Odisha government has decided to establish a Greenfield airport at the port town of Paradip, expedite the development of the Shree Jagannath International Airport in Puri, and construct heliports in 14 districts.

These decisions were taken during an 'Aviation and Network Construction Management' meeting chaired by Chief Minister Mohan Charan Majhi

here Thursday. WORLD PRESS FREEDOM DAY 2025

'AI has its advantages, but human touch still vital in journalism'

Bhubaneswar, May 2: The advent and adoption of Artificial Intelligence (AI) has redefined newsroom dynamics, and emerged as a major force reshaping reporting style and content presentation.

As the world marks the World Press Freedom Day - celebrated globally to underscore the evolving relationship between technology and journalism - May 3, the spotlight this year falls on the timely and complex theme: 'Reporting in the Brave New World: The Impact of Artificial Intelligence on Press Freedom and the Media'.

Orissa POST spoke to a cross-section of journalists to explore how AI's growing influence is affecting journalistic practices, and the freedom of press at large.

"Print journalism is unlikely to be significantly affected by AI.' opined veteran journalist Pradip Das. Explaining, Das said while AI can enhance storytelling, it cannot generate story ideas or determine the news value of an event. "Human empathy, intelligence, and ethical judgment are essential. The core principles of journalism—neutrality, an unbiased approach, and a sense of responsibility toward people and society—cannot be upheld by machines," he said.

Prakash Panda, another media professional, took a more balanced view. "AI has its own specialty. If used correctly, it can be a tool for journalists to enhance productivity and efficiency," he noted.

Laxmikant Dash, known as 'Nabin' in the state's digital journalism circle, acknowledged AI's fluency and speed, but highlighted its limitations. 'AI has certainly made an im-

pact in news writing, but it still lacks the emotional depth and nuanced understanding needed for storytelling. After all, it is a

machine," he said. Meanwhile, a state-level photo exhibition on the theme, 'Press for Planet', on the eve of World Press Freedom Day 2025 was organised at Soochana Bhawan where different environment-related photographs clicked by photo journalists

were put on display. World Press Freedom Day, proclaimed by the United Nations General Assembly in 1993, is a time to reflect on the principles of press freedom. evaluate its global status, and pay tribute to journalists who have lost their lives in the line of duty. The day also calls on governments to uphold their commitment to an independent and free press.

FRESH STUDENT SUICIDE AT KIIT

Nepal launches diplomatic initiatives to probe death

Bhubaneswar, May 2: Concerned about the safety of Nepalese students at KIIT in Odisha, the government of the neighbouring country Friday initiated diplomatic efforts to ensure a high-level probe into the death of the 18-year-old girl studying here, a day after she was found hanging in the tech nology institute.

The body of the BTech computer science student, Prisa Sah, was recovered from her hostel room at Kalinga Institute of Industrial Technology (KIIT)

Thursday evening, police said. The incident comes 74 days after Prakriti Lamsal, another Nepalese student of the same institute, died by suicide February 16. There are around 1,000 Nepalese students in KIIT, according to officials.

The Nepal Embassy also took up the matter with Odisha Chief Minister Mohan Charan Maihi and Chief Secretary Manoj Ahuja, who assured them of all kinds of safety and security for students from the neighbouring country. The embassy also contacted officials of KIIT, a statement issued by the Nepal government said.

In New Delhi, the Ministry of External Affairs (MEA) said it was 'deeply saddened' over Prisa's death. MEA said it has been in constant touch with the Odi-

ID liquor packaged at City 'water bottling unit'; 4 held

Bhubaneswar, May 2: In a major crackdown, the Bhubaneswar Excise Department sleuths raided an illegal country liquor (ID liquor) storage and distribution unit operating clandestinely under the guise of a water bottling and packaging factory in the forest area of Mund jungle near Daruthenga village on the outskirts of the Capital City, Friday.

Superintendent Raj Sekhar Swain, who led the raiding team, said four persons were arrested and 9,510 litres of ID liquor, estimated to be of ₹19 lakh, were seized from the illegal unit. The sleuths also recovered around 28,000 plastic bottles, 7,000 empty pouches, one sealing machine, along with three four-wheelers, and a two-wheeler used for transporting the contraband, Swain

He identified the arrested accused as Sukanta Sahoo, Bharat Sahoo, Pankaj Mansingh, and Sunil Kumar Swain. However, the fifth accused in the case managed to escape as he ran away minutes before

Pathan seeks Shah's intervention over 'attacks' on Bengal workers in Odisha

Kolkata, May 2: TMC MP Yusuf Pathan has written to Union Home Minister Amit Shah, seeking urgent intervention into alleged attacks on migrant workers from West Bengal in Odisha, particularly those hailing from Murshidabad district.

In a strongly-worded letter, Pathan claimed that several labourers in Odisha's Berhampur and nearby areas have fled the BJP-ruled state fearing for their lives, following a spate of 'brutal attacks, intimidation,

looting, and threats to vacate

"I write to you with grave concern regarding the alarming rise in incidents of violence against migrant workers from West Bengal, particularly those hailing from my constituency Baharampur, Murshidabad and surrounding districts, who have recently returned from Odisha after being subjected to targeted attacks," the letter dated April 27 stated.

Citing multiple reports, the TMC MP alleged that the attacks began after the formation of the BJP-led government in Odisha,

with 'several organised groups launching 'systematic assaults' on labourers from Bengal. "Manv have been assaulted at night robbed of their mobile phones and earnings, had their Aadhaar cards destroyed, and forcibly evicted from their accommodations," Pathan said, "Disturbing ly, similar incidents occurred in August-September 2024 as well. The letter also flagged concerns over the targeting of Bengali workers based on regional identity, with Pathan claiming that Muslims were being particularly singled out.

Sahajog to link urban poor with govt schemes

A mobile app will soon be developed to connect eligible beneficiaries directly to the schemes, says H&UD Minister KC Mahapatra

Bhubaneswar, May 2: The state government Thursday launched Sahajog, a first-ofits-kind initiative aimed at facilitating access to various government welfare schemes for the urban poor.

Housing and Urban Development (H&UD) Minister Krushna Chandra Mahapatra officially launched the programme in Bhubaneswar.

Designed to ensure last-mile delivery, Sahajog focuses on identifying eligible beneficiaries in urban poor communities and connecting them to appropriate schemes through mass awareness, doorstep delivery of services, and strengthened

implementation mechanisms at the urban local body (ULB) and district levels, officials said.

Officials said housing support under Pradhan Mantri Awas Yojana (Urban) would serve as the entry point for delivering other benefits to eligible families.

Launching the initiative, Mahapatra said the programme will run in campaign mode from May 1 to June 20, turning the effort into a mass movement. He added that eight District Collectors have been directed to form coordination committees and that a mobile app will soon be developed to connect eligible beneficiaries directly to the schemes.

He said after covering urban

areas, the initiative will be extended to rural beneficiaries.

The minister said that at present, over 15 lakh people across 44 ULBs in eight districts are included in the programme's first phase. The districts are: Khurda, Cuttack, Ganjam, Sundargarh, Sambal pur, Keonjhar, Mayurbhanj and Bhadrak.

The initiative will initially focus on 14 priority schemes, including Pradhan Mantri Awas Yojana (Urban) ration cards under NFSA, Ayushman Bharat card, Labour and E-Shram cards, Subhadra Yojana, PM Vishwakarma Yojana, Madhubabu Pension Yojana, Sukanya Samriddhi Yojana Pipe Water Supply, PM Suraksha Bima Yojana, Garima Scheme, and others.

Housing benefits under PMAY (U) will act as the entry point, with other schemes being layered in to ensure comprehensive benefit delivery.

H&UD principal secretary Usha Padhee said, "We are taking initiatives for the weaker sections of society. As land, house, water, electricity are the basic needs of economically weaker sections, the department will function as the nodal agency of the initiative.

NHRC: Take steps to protect the vulnerable from heatwave

New Delhi, May 2: In view of soaring temperatures in several parts of the country, the National Human Rights Commission (NHRC) has asked 11 states, including Odisha, to take "immediate preemptive measures" to protect the vulnerable sections of society. who are at a risk of suffering heat-related illnesses

The apex rights body, in a statement issued Thursday, highlighted data from the National Crime Records Bureau (NCRB) about the "reported death of 3,798 persons between 2018 to 2022 due to heat and sun strokes", and emphasised the urgent need for "integrated and inclusive measures".

The NHRC, in its letter sent

to chief secretaries of Puniab. Haryana, Uttar Pradesh, Bihar, Jharkhand, West Bengal, Odisha, Andhra Pradesh, Telangana, Maharashtra, and Raiasthan, called for provisioning of shelters, supply of relief material, amendment of working hours and availability of standard procedures for treating heat-related illnesses.

These states have been asked to "submit action-taken reports" to protect the lives of those vulnerable to heatwaves, especially the economically weaker ones, as per the existing SOPs or guidelines issued by the National Disaster Management Authority (NDMA) to mitigate the impact of heatwaves, it said.

In view of the heatwaves during summer, particularly in the northern, central and west ern parts of the country, the NHRC has asked the 11 states to take immediate preemptive measures to protect the outdoor workers, the elderly, children and the homeless, who are at risk due to lack of adequate shelter and resources

In its communication to the states, the rights panel has reiterated the guidelines of the NDMA to mitigate the impacts of heatwaves

These guidelines include establishing and implementing SOPs for treating heat-related ailments and treatment protocols; activating public spaces such as schools, Anganwadi centres, and community halls with adequate ventilation, fans, drinking water, and basic medical supplies.

Bengal woman found dead in City

The reason behind Sarina taking the extreme step is ve unclear as no suicide note was found from the spot. Sarina's younger sister found the body hanging from the ceiling of the apartment when she returned from shopping around 9pm, and alerted the cops, Rao said.

He added that Sarina had parted ways with her husband a few years ago, and is survived by her six-vear-old daughter. A UD case has been registered and the body sent to Capital Hospital for post-mortem.

Oppn claims credit; BJP says not under pressure

Bhubaneswar, May 2: The ruling BJP in Odisha has firmly rejected allegations that it acted under pressure from Opposition parties like BJD and Congress in approving the inclusion of caste enumeration in the upcoming national census. In separate press conferences, leaders from both the BJD and Congress claimed that the Centre's decision was the result of their longstanding demands.

Congress workers, led by OPCC president Bhakta Charan Das, celebrated the development with a 'Vijay Utsav' at the party's state headquarters Thursday evening.

Both parties took credit for Wednesday's decision by the Cabinet Committee on Political Affairs (CCPA) to include a caste survey in the next census. They maintained that the Centre had "bowed to pressure"

"Our leader Rahul Gandhi has been advocating for the caste-based census since a long time, both in Parliament and outside. They (BJP) criticised our leader and dismissed his arguments. But, now they have been forced to accept our demand," OPCC president Bhakta Charan Das said.

He criticised the NDA for taking a decade to take the decision. Das also took aim at the previous BJD government, which remained in power in Odisha for 24 years.

He noted that although the OBC population in the state is around 54 per cent, they receive only 11.27 per cent reservation

in government recruitment. He further expressed concern over the lack of OBC reserva-

tion in the education sector. In a separate presser, BJD leaders Sanjay Das Burma, Arun



Kumar Sahoo, and Snehangini Chhuria emphasised that former Chief Minister Naveen Patnaik had been demanding a castebased census since 2010.

"The recent decision of the Centre to go for caste enumeration is a result of our leader's consistent efforts," the BJD said in an official statement.

BJD MLA and former minister Arun Kumar Sahoo said Patnaik had first envisioned the idea of conducting a caste

enumeration in the country. 'The Centre was finally forced to go for caste enumeration only because of the pressure mounted on them," Sahoo said.

Chhuria said, "Although the Central government has agreed for the caste-based census, it should not be used as an election stunt. Everyone knows that the Union government had opposed it earlier. Now that it is announced, there should be sincere steps to use it to ensure

She said a caste-based census can ensure proper reservation not just for SCs and STs, but also for OBCs, thereby helping establish social justice in the country.

However, senior BJP leader and Bhubaneswar MP Aparajita Sarangi rejected the allegations of the Congress and the BJD. "There is no pressure on Prime Minister Narendra Modi. Everybody knows that the BJP government does not work under pressure from anybody. The decision to go for a caste enumeration is taken at the appropriate time," Sarangi said.

Addressing questions about the timing of the announcement ahead of the Bihar elections. Sarangi said, "There's nothing political about the timing. Look at it positively. If elections were the motive, the BJP could have made this move before the 2019 or 2024 general elections.'

Although the Baripada forest division had submitted a proposal to declare an area of 0-5 km radius around the protected forest as a restricted zone, it remains stalled due to a lack of response from the state government. Sources said the Union Ministry of Environment, Forest and Climate Change (MoEF&CC) has directed the state government to clarify details regarding the buffer zone of the Similipal sanctuary, but no formal communication has vet been made.

As a result, unregulated settlements and illegal activities are reportedly on the rise in the areas meant to be environmentally protected. Forest officials said the aim is to curb human activities that may harm the ecosystem and protect the biodiversity in and around the national park.

Labourer thrashed to death on Labour Day

Jajpur, May 2: A 22-year-old labourer identified as Arijit Jena from Jaraka village, died on Labour Day after allegedly being thrashed and tortured by the owner and staff of a private stone crusher unit in Jajpur district.

According to the complaint filed by Arijit's father, the incident occurred at Padmabati Crusher in Rahadpur under Jenapur police limits. Arijit, who had been working there for past three months, went missing April 27. His family traced him to the crusher unit owner's residence, where they found him

chained and severely injured. Arijit had suffered burn wounds from hot iron rods and multiple blows to his chest and groin area. His captors allegedly recorded videos of the torture and threatened his family. Despite being taken to a hospital later that morning, Arijit succumbed to his injuries at 3:30am May 1.



A draft notification was issued proposing the declaration of 1,765.29 sq km area around Similipal and Hadagarh wildlife sanctuaries as eco-sensitive zone in January 2019. The draft suggested a boundary ranging from 0-10 km from the protected areas. However, after legal challenges were raised in the Orissa High Court, the proposed ESZ was scaled back to an area of 0-5 km radius.

Local residents had filed a petition in the Supreme Court seeking to restrict activity within 0-1 km radius around the area in question. In response, the previous state government had submitted documents to the court proposing that the area be declared as an ESZ. The Supreme Court, however, sought clarification on why this specific zone should be declared eco-sensitive.

As the case remains sub judice, reports suggest that illegal stone quarries and crushers continue to operate in the proposed eco-sensitive areas around Similipal. More than 50 unauthorised stone crusher units and over 100 illegal quarries are reportedly operating between Thakurmunda on the foothills of Similipal and Bangiriposhi in Mayurbhanj

Forest officials said that the proposal to declare the area as ESZ was aimed at limiting illegal activities such as mining, stone quarrying, and the establishment of polluting industries. The Forest department's intent was to use this declaration to help curb unlawful practices, given the region's ecological sensitivity.

However, a few individuals and groups with vested interest have opposed the initiative. Moreover, no final notification has been issued even after six years.

The MoEF&CC has indicated that it is awaiting a final and clear response from the state government. Environmental experts have expressed concern

over the continued delay. Moreover, the proposed ESZ declaration does not involve the displacement or relocation of local communities. Agricultural activities in the region will also remain unaffected.

When contacted, former wildlife warden and independent director of the Odisha Forest Development Corporation, Bhanumitra Acharva, said that a prompt clarification from the state government to the Supreme Court would help establish the ESZ as a protective shield for Similipal.

Cobras used in dance during wedding procession, rescued

Bhadrak, May 2: The Forest department rescued three live cobras which were used in a dance performance during a wedding procession, an official said.

The incident took place at Chhedak village under Dhamra police station limits late Wednesday night.

A snake charmer and two performers - a man and a woman – entertained wedding guests (baraatis) by dancing to a popular 'Nagin' song as they were walking along Dhamra-Chandbali road.

The performers danced to the tune of drum beats and other musical instruments while carrving the snakes either keeping the reptiles inside baskets or

holding them in their hands. Acting on a tip-off, a team of the Bhadrak Wildlife Division intercepted the procession and rescued the snakes.



"We have seized the snakes and are trying to identify the snake charmer involved. The Special Task Force (STF) has been asked to assist in the investigation," said Soubhagya Kumar Sahu, Divisional Forest Officer (Wildlife).

However, nobody has been arrested in this connection, the $\,$ DFO added

The use of wild animals like cobra is a punishable offence under the Wildlife Protection Act, 1972.

2 held for murder of 17-year-old girl

Berhampur, May 2: Police Friday arrested two persons for the murder of a 17-year-old girl in Ganjam district, an

The accused were identified as Muna Khan (20) of Antarabatia village, near Gopalpur, and a 16-year-old boy from Khurda district, police said.

The deceased, a student of the Industrial Training Institute (ITI), Berhampur, was in a relationship with Khan for the past few years, which ended recently for unspecified reasons, according to police.

On Thursday morning, both the accused went to the victim's house in Kara palli, under the jurisdiction of Gopalpur police station, while she was alone. An argument broke out between Khan and

During the confrontation, Khan allegedly threatened to harm himself if she did not agree to rekindle their relationship, police said.

"He then cut his hand with a blade. The girl attempted to intervene and tried to take the blade from him. She also tried to call her father. Khan then attempted to snatch the phone from her, leading to a struggle," police added.

At that point, the juvenile allegedly struck the girl on the head with a crowbar, causing her to collapse, police said, adding that Khan then cut the girl's hand before fleeing the scene.

Police recovered a crowbar, two razor blades, a motorcycle, and two mobile phones used in the crime.

The accused were apprehended while trying to flee from Berhampur, said Berhampur SP Saravana Vivek M.

Govt officer alleges assault by BJD MLA

Jajpur, May 2: A government officer has lodged a police complaint alleging that BJD MLA Biswa Ranjan Mallick slapped him and also made a casteist slur against him.

Mallick, the MLA of Bari Assembly constituency, rejected the allegation levelled by Junior Revenue Assistant Amar Ranian Navak.

Police said they have started an investigation into the allegations.

In the complaint, the officer said that the MLA called him to the Bari block office at 12.45pm Monday.

"When I reached, MLA Mallick was sitting there along with the chairman and vice chairman of the block and some of his supporters. The MLA enquired about a specific file and then slapped me, besides abusing me about my caste,' he alleged.

Minor girl molested at SSD hostel in Koraput

Nandapur/Lamtaput, May 2: A serious allegation

of molestation has surfaced from a girls' hostel run by the Scheduled Tribes and Scheduled Castes Development department in Lamtaput block under Nandapur police sub-division in Koraput district.

According to reports, an unidentified youth entered the hostel and allegedly molested an 8-year-old girl student April 13 night. The incident came to light 17 days later, April 30, when the student was sent back home by the hostel authorities.

Observing her deteriorating health, her family questioned her and learned about the alleged incident. They subsequently lodged a complaint at the Machkund police station.

The incident has stirred political unrest in Lamtaput block. Superintendent of Police Rohit Verma, SDPO Debendra Mallik, and a special investigation team visited the hostel in Guneipada Thursday to probe the matter.

Machkund police have registered a case (33/2025), and Sub-Inspector Sukra Madhi has begun the investigation. The victim underwent medical examination, and her statement was re-



corded before a magistrate.

Despite the gravity of the incident, no arrest has been made so far. Public anger has intensified due to the delay in action and the lack of accountability on part of the hostel superintendent, who allegedly failed to report or act on the matter during the 17-day period.

The victim's family, accompanied by local political leaders and activists, staged a protest march to the Lamtaput police outpost Friday evening. They submitted a memorandum to Officer in-Charge Srikant Ghosh. demanding the immediate arrest of the accused and strict action against the hostel authorities.

Due to the sensitivity of the case, SDPO Debendra Mallik declined to provide further comments regarding the ongoing investigation. Meanwhile, a few

local youths were detained for questioning as part of the inquiry.

Clock's Ticking

even years ago, the NSE International Exchange (NSE IX) was launched with much fanfare at GIFT City—India's glittering bet on becoming the next Singapore or London in global finance. Fast forward to today, and it's safe to say the hype hasn't quite matched the hustle. Despite a carefully crafted framework and political will, NSE IX has slowly taken off. Enter Neeraj Kumar Gupta.

The former Union Finance Secretary and disinvestment czar has now become Chairman and Public Interest Director of NSE IX. With his decades of bureaucratic battle-hardened experience, from handling PSUs and equity ETFs to shepherding big-ticket policy reforms, Gupta's appointment is considered a make-or-break moment for NSE IX.

What's holding the exchange back? For starters, Indian companies still look outward—Singapore, London, New York—when it comes to raising capital. Global investors don't see enough reason to shift their gaze inward. And GIFT City's "unified regulator," IFSCA, hasn't yet lived up to the promise of being a true one-stop shop. It still leans heavily on the older regulatory machinery of SEBI and RBI, and frankly, that's not going to cut it.

If NSE IX is to become the financial magnet it was meant to be, it must offer transactional ease that beats Singapore, not just mimics it. That means faster approvals, lighter compliance, and a smarter, investor-first playbook. Gupta knows how to break silos and get regulators to speak the same language—now's the time to prove he can do just that. The clock is ticking.

CPC's snail pace

It has been almost four months since the government initially approved the establishment of the 8th Central Pay Commission (CPC), and there have been no updates since then. Now, whispers are emerging that the gears are finally turning. But even those seem more like the creaking of bureaucracy than the hum of decisive action.

The government is inching toward finalising the terms of reference and picking the chairperson and members. That's right—we're still talking about forming the team. Not drafting a report. Not consultations.

Just assembling the crew. The usual 10-year ritual of reviewing salaries and pensions of Central government employees is supposed to factor in cost of living, economic conditions, and inflation. Fair



enough. But when you consider that this affects nearly 50 lakh Central employees and 60 lakh pensioners, you'd think urgency would be

Instead, we get the classic slow burn. An internal circular last week invited applications to fill 35 posts on a deputation basis—so yes, the office is still under construction.

If all goes well (and that's a big if), the 8th CPC will submit its report $\,$ by mid-2026. Retroactive salary and pension adjustments may follow in 2027-28. That's a full decade since the last revision in 2016. And with inflation nibbling away at paychecks, that's a long time to ask people to wait. Do remember that people don't spend "in principle". They pay in reality. Time to pick up the pace.

Few blink when the government shuffles its babus. It's like musical chairs—routine, rhythmic, and mostly unremarkable. But now and then, a tune changes. And this time, it did.

The latest round of administrative reshuffles has given us more than just a list of who's where. It's given us a clear frontrunner: the IAS batch of 1994. In an unusually bold sweep, nine officers from this cohort have been elevated from Additional Secretary to Secretary, and two more named Special Secretaries. That's eleven heavy-hitters from the same batch, now occupying the highest bureaucratic perches in India. It matters because this isn't just paperwork. It's a power play.

Many of these officers have previously served in high-trust zones like the Prime Minister's Office and the Cabinet Secretariat—roles that tend to groom officers not just in governance but also in the government's thinking. Arvind Srivastava, now Revenue Secretary, was with the PMO until recently. Anuradha Thakur, the incoming Economic Affairs Secretary, has spent time in the Cabinet Secretariat. Their current postings put them at the heart of India's financial and economic policy engine.

The rise of this batch signals more than seniority or coincidence. It suggests consolidation, perhaps even calibration, of administrative leadership around a cohort closely aligned with the Centre's priorities.

It's not unprecedented for a batch to rise together. But the scale and the strategic positioning make this one worth watching. The batch of '94 isn't just stepping up—they're stepping in, shaping what

FOCUS TRUMP'S 100 DAYS

GLOBAL CHAOS

President Donald Trump's term, but much is already clear. Trump 2.0 is starkly different: more confident and surrounded by a team determined to implement a far more sweeping agenda. Those staffing the administration - amplifiers more than restrainers, enablers more than guardrails spent the past four years preparing for this moment.

Trump 2.0 is an activist, imperial presidency, at home and abroad. He seems to be everywhere, dominating public space and private conversations alike in much of the world. The contrast with his predecessor President Joe Biden could not be starker.

The administration's principal policy goal thus far has been to make good on Trump's campaign pledge to secure the United States' southern border. But import tariffs –an across-the-board 10% baseline levy, plus additional country-specific tariffs, reaching $145\,\%$ in China's case – have become the defining initiative of his presidency.

Foreign policy is also substantially changed. The US has shifted from being a steadfast supporter of Ukraine to tilting decidedly in Russia's favor. The shift appears to be motivated by a clear dislike for Ukrainian President Volodymyr Zelenskyy and an embrace of Russian President Vladimir Putin for reasons unknown.

Trump, who boasted during his campaign that all he needed was a day to end the war, which he regularly blames on Biden and Zelenskyy, is now talking about walking away from diplomacy to end the war entirely. He is finding it difficult to make good on his campaign promise, in no small part because his pro-Russia

policy fails to give Putin any incentive to compromise or Zelensky the confidence to do so. The agreement to establish a US-Ukraine Reconstruction Investment Fund should help, but, to achieve a cessation of hostilities, much more will need to be done to assist Ukraine.

Europe and America's other traditional allies receive no special treatment, either. This is certainly the case with tariffs, which tellingly spared Russia but severely hit Japan, South Korea, and Taiwan. Vice President JD Vance traveled to Munich in February to ignite a cultural clash with Europeans, while Defense Secretary Pete Hegseth openly raised doubts about the US commitment to Europe at NATO headquarters. This has spurred European preparations to support Ukraine if American assistance wanes and to achieve strategic self-sufficiency more broadly.

In the Middle East, the administration launched what could well prove to be a promising negotiation with Iran. The stage was set by Israeli military action against Iran and its proxies, the fall of the Assad regime in Syria, and Iran's worsening economy, all of which makes backing away from its nuclear program to avoid military attack and secure sanctions relief particularly attractive. If the Trump administration is willing to allow Iran limited uranium enrichment - a concession that may be required to secure a deal -it can expect criticism from some in the US and Israel. But Trump is strong enough to weather the pushback if it comes.

Otherwise, the Trump administration has essentially given Israel's government a free hand to do what it wants in both Gaza and the West Bank. It seems to have lost interest in extending the Hamas-Israel ceasefire, as this would put it at odds with Israeli Prime Minister Binyamin Netanyahu, who appears to prioritize his coalition's survival, through continuing military operations in Gaza, over freeing the remaining hostages.

The most unexpected dimension of US foreign policy, one neither previewed in Trump's first term nor during the campaign, has been the focus on the Western Hemisphere. Canada and Mexico were singled out for early tariffs over alleged failures to control their borders. There were also heavy-handed calls to assert US sovereignty over the Panama Canal, Greenland, and Canada. More than anything else, these goals have triggered an anti-American backlash -even flipping the outcome of Canada's recent federal election.

The biggest foreign-policy uncertainty remains China. On one hand, Trump granted TikTok waivers that allowed it to remain on Americans phones, despite uncertainty about whether he has the authority to do so. He continues to speak highly of Chinese President Xi Jinping and expresses confidence that the US and China will reach a deal.

But the massive tariffs he has levied on China mean that the US and Chinese economies will increasingly separate, if not actually decouple. Whether the tariffs are an attempt to gain bargaining leverage or are ends in themselves remain perhaps the biggest question in Sino-US relations.

Overall, Trump 2.0's foreign policy is more unilateralist than isolationist. This will remain the case. Less clear is the extent to which Trump will move to reduce tariffs, rethink his pro-Russian stance on Ukraine, and press Israel to modify its approach to Gaza and the West Bank -policies that could revive US and global economic growth and bring peace to two regions that have known little of it. Much will depend on the choices of a man who, for better or worse, is already among the most consequential of US presidents.

n a conference in Hyderabad on 24 and 25 April, I was asked by a fellow academic from Japan, if India was going to retaliate against Pakistan. I asked her a counter-question if some innocent tourists were killed anywhere in Japan by terrorists, what would have Tokyo done? She was evasive. But she seemed to persuade me that New Delhi should not take military action against Pakistan. That apart, to attack or not attack is the question I wouldlike to evaluate here. The issue of military con-

frontation is engaging the thinking of the Indian strategists, observers, onlookers and world leaders. The last segment of stakeholders is concerned mainly because of the perilous prospect of use of nuclear weapons possessed by both countries. Let us evaluate this option or threat already issued by Pakistani media and leadership.

Since the Hiroshima and Nagasaki episodes, nukes have not been used by any country for over seven decades. Use of nukes spells disasters for the entire world including those who unleash

it. So, nukes were conceived as deterrents, not for actual use in years. Now, since the applicability of nukes is the remotest, even the deterrent effect is minimal. But one cannot rule it out by megalomaniacs, autocrats, rogue states and suicidal and self-destructive forces. One could rely on the collective wisdom of the world leadership, at least in their self-interest, to prevail upon the nuclear powers to desist from its use. If, in this case, the world leaders fail to prevent their client states, and allies, may God save this planet. That said, what should

New Delhi do? Should it take on Pakistan! But let us refine this formulation and make it politically correct. That is, India is not declaring a war on Pakistan. India has never invaded any country

Many may contest the parallel between the 22 April massacre at Pahalgam and 7 October mayhem by Hamas in Israel. It is just because of the history of the controversial conflict between Israel and Palestine. But if you look only at these two pathetic events. the action-reaction continu-

um in both cases is comparable. New Delhi has the right and legitimacy to hunt down the terrorist manufacturing agencies and infrastructure in Pakistan.

Unless the Pakistani army dismantles the terrorist infrastructure and transparently delinks from terrorism, Pakistan is a target. India has been impressing upon the world that Pakistan should be pressed to stop breeding and harbouring terrorists. But the world leadership has not responded as they should have asked no country could be immune to this menace. On the contrary, vested interests like China have shielded Pakistan and its terrorists.

not give away POK. And Pakistan does not exist without lighting and stoking the fire in Kashmir. Pakistani leadership vows 5,000 years of conflict with India on Kashmir. So, India is back to square one. Make diplomatic moves to counter and isolate Pakistan. Tried, tested and exhausted. There will always be leaders like Xi Jinping and Erdogan who will prop up a failed state like Pakistan. So, India has to carry its own cross. Cowing down Pakistan to stop its nefarious actions against India is New Delhi's call. It is the call of Atmanirbhar Bharat.

The scam unravelled after the MBVV police registered a case April 20 and launched a probe, he said.

Pandey said the prime accused, Sandeep Suresh Kandalkar, alias Raju Rajiy Joshi, persuaded investors to purchase pickup tempos and four-wheelers and promised to pay monthly returns of Rs 55,000 to Rs 75,000 if they al lowed them to use the vehicles for rental purposes

The accused told the inves tors that the vehicles bought in their names would be deployed at airports and the Jawaharlal Nehru Port Trust for commer cial use, said Pandey.

"The agreements were executed on Rs 100 stamp papers, and the payments were collect ed online. Initially, Kandalkar made the promised payments but later defaulted, leading to the IPS officer.

Kandalkar, a native of Pisa village near Dapoli in Ratnagiri district, was arrested April 25, a day after his accomplice, Sachin Sunil Tetgure, also from Dapoli, was taken into custody, the official said. At least seven more persons are

Patil said Friday. Patil, who underwent treatment at the army hospital in Pahalgam, returned to his home in Kamothe in Navi Mumbai Thursday night along with his

Speaking to reporters, he became emotional recounting the incidents of that day, and thanked the pony ride operators who helped the injured after the

"I was unconscious due to a bullet injury in the neck. When I regained consciousness, I found dead bodies around me. After seeing me moving, a group of pony ride operators came up and offered me water," said Patil.

"The pony ride operator we had hired was among them. He said I should not worry about my wife, she was safe.

"Another man helped me stand up, offering me his shoulder for support, and asked if I could walk." Patil recalled, adding they kept telling him not to



be scared.

The pony ride operators took him outside the compound and gave him a cot to sit on.

"After some time they brought a vehicle, and took me to the medical facility of the Indian Army. From there I was flown out in a helicopter and shifted to the army hospital,"



Patil said.

Narrating how the attack unfolded, he said the terrorists asked all the Hindu tourists, in-

cluding him, to stand in a line. Some of them pleaded with the terrorists, but to no avail. Whoever tried to resist was shot

immediately. A bullet grazed his neck, caus-

ing an injury.

Patil also remembered Desale, a resident of the nearby New Panvel township, who was one of the six Maharashtrian tourists killed in the attack that day.

'We both had arrived at the site together," he said.

Desale opted for a ropeway ride, and he and his wife also had their pictures taken in the traditional Kashmiri attire, Patil recalled. When the terrorists opened fire, Patil and others in his group did not take notice immediately. "After some time the sound of gunfire increased, and we turned back and saw people were running to save their lives," he said.

Everything happened in a span of five minutes but he would never be able to forget those five minutes, said Patil.

"In the peculiar facts and circumstances of this case, authorities may not take coercive action till an appropriate decision is taken. If petitioners are dissatisfied by the final decision, they can approach J&K&L HC. Order not to be treated as precedent," the bench said.

The family, which lives in Kashmir and whose sons work in Bengaluru, faced deportation to Pakistan following the Pahalgam terror attack in which 26 people lost their lives. Observing that the issue involves a human angle, the bench gave the family the liberty to approach the Jam-



mu and Kashmir high court in case they are aggrieved by the document verification order.

Advocate Nanda Kishore, appearing for the family, claimed they had valid passports and Aadhaar cards. He said the family members in Srinagar were bundled into a jeep and ferried the Wagah border and now were at the "threshold of being thrown out of the country".

The bench while directing the authorities to verify all the documents said that a decision be taken at the earliest, though no time limit was fixed

Justice Kant asked the petitioner's counsel, "How did the father come to India? You have said he was in Pakistan.' Kishore said he came to India in 1987 on a valid visa and surrendered the Pakistani passport at the border.

One of the sons, who was appearing virtually, claimed the father came to India from Muzaffarabad, from the other side of Kashmir. Solicitor general Tushar Mehta, appearing for the Centre, said it would be appropriate that the petitioners approach the authorities concerned first so that their claims were verified.

"Let them approach the authorities," Mehta said while assuring the bench that no coercive action would be taken against them till a decision was was arrived at on the documents. "It was a case, where these people have overstayed the visa," he submitted.

The bench, however, said the oral undertaking might pave way to uncertainties

New Delhi, May 2: The Congress Friday urged the Centre to act with firmness and clarity to penalise Pakistan for its continued export of terror to India, asserting that the neighbouring country must be taught

The assertion was made in a resolution passed unanimously at the meeting of the Congress Working Committee (CWC), the highest decision-making body of the party. The Congress also said the government should initiate a process for conducting a caste survey in a time-bound manner.

The CWC chaired by party chief Mallikarjun Kharge was attended by the top Congress leadership, including former party presidents Sonia Gandhi and Rahul Gandhi, and party general secretaries Jairam Ramesh, K C Venugopal and Priyanka Gandhi Vadra, among others. "This is the time for demonstrating our collective will as a nation to teach Pakistan a lesson and curb terrorism decisively. The masterminds and perpetrators of the cowardly attack (in Pahalgam) must face full consequences for their actions," the CWC resolution said. The Congress urged the Centre to act with "firmness, strategic clarity and international coordination to isolate and penalise Pakistan for its continued export of terror into our territory", the resolution said. "The entire country



awaits accountability, answers and justice. In the face of such an unforgivable provocation, the Congress believes this is not a time for politics but a moment that calls for unity, strength and national resolve, the resolution added.

In another resolution, the party demanded time-bound and transparent implementation of a caste survey, hoping it doesn't end up like another BJP "jumla" and meet the same fate like the Women's Reservation Bill. The Congress raised the demand after the Narendra Modi government Wednesday announced that caste enumeration will be included in the next census exercise in a "transpar-

ent" manner. The resolution also pointed out that no details have been provided as to what the government intends to do, while no financial allocations have been made either for conducting the caste survey. The CWC asked the government to announce a "clear timeline" for every stage of the caste survey and reiterated its demand for removing the "arbitrary ceiling" of 50 per cent on reservations for SCs, STs and OBCs.

The Congress also demand-

ed the urgent implementation of Article 15(5) of the Constitution, which enables the provision of reservations for OBCs, Dalits and tribals in private educational institutions. "After 11 years of continued opposition and stubborn refusal, the Modi government has finally conceded to the demand of the Congress to collect caste-wise population data, as part of the next census. For 11 years, the prime minister attacked the Congress leadership for raising this demand," the CWC said in the resolution

"All political parties must be taken into full confidence and Parliament must immediately have a debate on this issue. The government must immediately allocate the necessary funds and announce a clear timeline for every stage of the census, from the preparation of the questionnaire and methodology to the actual enumeration, classification and eventual

publication of the data," it said. It added that the collected data should serve as the basis for a wide-ranging review of public policy, especially in the areas of reservations, welfare schemes, educational access and employment opportunities.

WATER SHARING WITH HARYANA

Chandigarh, May 2: Amid escalating tensions between Punjab and Haryana over sharing of water, an all-party meeting called by the Aam Aadmi Party government in Punjab here Friday saw parties putting up a united stand on the issue.

A fresh row had erupted over the issue of water sharing between the two neighbours, with the Punjab government refus ing to release more water to the BJP-ruled Harvana. While the Bhagwant Mann government has convened a special Vidhan Sabha session Monday on the issue, it was mulled during the all-party meeting that the parties could meet Prime Minister Narendra Modi in the coming days

35K lives lost to extreme temperatures during 2001-19: Study

New Delhi, May 2: At least 35.000 lives were lost in India due to exposure to extreme hot and cold temperatures between 2001 and 2019, a new study has

In 2015 alone, it estimated 1,907 deaths due to a heatstroke and 1,147 because of cold exposure. Data for analysis was taken from the India Meteorological Department and National Crime Records Bureau, among other datasets. Findings, published in the

journal Temperature, show an upward-moving, increasing trend in deaths due to a heatstroke and exposure to cold temperatures. Lead author Pradeep Guin from O P Jindal

Global University, Haryana, said that deaths due to exposure to extreme temperatures are avoidable and that measures to mitigate health impacts need to be put in place. "With an intense heatwave

forecast to hit most of the country this summer and extreme weather events becoming more frequent around the globe as the world warms, there is no time to be lost in raising awareness about the dangers of extreme temperatures and putting in place measures to reduce their impact," Guin said.

He added, "Support systems exist, but more needs to be done." Deaths due to extreme temperatures were found to be more common among men of working age. During

Data for analysis was taken from the India Meteorological Department and National Crime Records Bureau, among other datasets

the study period of 2001-2019, deaths due to extreme heat were three to five times higher

among men, while those due to extreme cold were four to seven times higher, compared to women, the researchers said. State-wise, Andhra Pradesh, Uttar Pradesh, and Punjab were found to record the most deaths due to a heatstroke, whereas the most deaths due to exposure to extreme cold came from Ut-

tar Pradesh, Punjab, and Bihar.

The authors wrote, "Between 2001 and 2019, India reported 19,693 and 15,197 deaths due to heatstroke and cold exposure, respectively." Guin said, "Deaths due to heatstroke is more significant, compared to deaths due to cold exposure, albeit recording an upward trend."

Co-author Nandita Bhan from the school of public health and human development at OP Jindal Global University, said the results highlight the urgent need of heat and cold action plans for vulnerable states Previous studies have large ly looked at health impacts of extreme temperatures in developed countries and one-off events, such as a heatwave rather than looking at low- and middle-income countries, the researchers said. They added that with India experiencing temperature extremes each year, it is important to know places most at risk, which can help in designing measures to keep population safe. A recently published study in

the journal Nature Communica tions showed that 'rapid flips' in temperatures -- a switch between hot and cold extremes in a relatively short time - have increased in 60 per cent of the world's areas over the past 60 years.



The incident took place around 3 am near Lateri town when a jeep carrying the marriage party was returning to Sironi from Indore, said Collector Anshul Gunta, One of the injured persons, who was in serious condition, was referred to Bhonal, while the rest are being treated in hospitals in Vidisha and Lateri.

Security tightened in Manipur

Heavy rains kill seven across north India; flights delayed

New Delhi/Gurugram/Chandigarh/Lucknow/Shimla. May 2: Torrential rain lashed north India, including the Delhi-NCR region, early Friday, killing at least seven people, uprooting over 100 trees, and delaying more than 200 flights.

The Jammu-Srinagar National Highway was blocked after the rain caused a landslide. A 28-year-old woman and her three children were killed when their house in southwest Delhi's Najafgarh area collapsed after a tree fell on it.

"Police and fire department officers pulled the family out of the rubble and rushed them to a nearby hospital in Jaffarpur Kalan, where four of them were declared dead," an officer said. In Uttar Pradesh, three people were killed and several injured in lightning strikes.

Two of them were labourers working on a road project under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in Firozabad. A family trying to cover a havstack with a tarpaulin sheet was also hit. Diksha, 17, was struck dead

by a lightning strike in Etah district's Bhagwantpur village. Her sister, Sapna, suffered burns, so did her father and brother.

In Firozabad again, a lightning strike killed Satyendra, 35, and Vishnu, 25 on the spot on the Shikohabad-Nanemau road. A third, Devendra, 30, was injured and rushed to a hospital, police said.

Roads in Delhi, Gurugram, Faridabad, and Mathura were inundated with water as commuters remained stuck in slow-moving traffic for hours. Between 100 and 200 trees were unrooted in Delhi alone, according to civic authorities.

In Faridabad, people were seen trying to pull out a half-submerged car stuck in waterlogged areas. Rows of vehicles were caught in a traffic jam in Ghaziabad. Delhi's Minto Bridge, ITO, Major Somnath Marg in RK Puram, and Khanpur were flooded with rainwater, causing heavy traffic jams in the areas. Traffic crawled on the Delhi-Gurugram Expressway while congestion was also seen at Hero Honda Chowk, Rajiv Chowk, and IFFCO Chowk.

Delhi received 77 mm of rain in just three hours beginning around 5 am. The India Meteorological Department (IMD) issued a red alert for the city, urging people to remain vigilant. Three flights were diverted and more than 200 flights were delayed at the Delhi airport as thunderstorms and gusty winds disrupted operations.

An official said two flights scheduled to land at the Delhi and one to Ahmedabad. Delhi Fire Services received around 100 calls of rain-related incidents during the 3-4 hours of storm and heavy showers.

In the Lutyens' Delhi area, at least 25 tree fall cases and 12 complaints related to waterlogging were received. Tata Power Delhi Distribution Limited (TPDDL) spokesperson said it received 22 power cut complaints, which were restored within a few minutes to one hour.

Distribution Company BSES said that in a few low-lying and waterlogged areas, the electricity supply had to be cut temporarily as a precautionary measure. The majority of Gurugram, a hub of scores of multinationals housed in swanky skyscrapers, was waterlogged

The Jammu-Srinagar National Highway was closed after the rain triggered mudslides in the Union Territory's Ramban district, a traffic police officer said.

Flash floods were triggered in the Chenab River, prompting the authorities in the Reasi and Akhnoor sectors to issue warnings against venturing near the riverbank. UP Chief Minister Yogi Ad-

ityanath directed officials to visit affected areas, assess damage to crops and livestock, and ensure that relief is distributed immediately to those affected by lightning strikes, and rainor storm-related accidents.

According to the IMD, west Uttar Pradesh is likely to witness rain and thundershowers at a few places May 3 and 4, accompanied by strong surface winds of 25-35 km/hr and gusty winds reaching 40-50 km/hr at isolated locations.

In east Uttar Pradesh, isolated rains are expected May 3 and more widespread showers May 4.

Thunderstorms with lightning and gusty winds (30-50 km/hr) are also likely during this period. Himachal Pradesh capital Shimla and the surrounding area of Jubbarhatti were lashed by a hailstorm and rain, the weather office said.

Court issues notice to Sonia, Rahul Gandhi



New Delhi, May 2: A Delhi court Friday issued notices to former Congress president Sonia Gandhi and leader of opposition in Lok Sabha Rahul Gandhi in the National Herald money laundering case. Special judge Vishal Gogne

said their "right to be heard" was available at the time of cognisance of the chargesheet. 'Right to be heard at any stage breathes life into fair trial," the judge said, posting the matter May 8. The judge also issued notice to Congress leader Sam Pitroda and Suman Dubey, and "Young Indian", Dotex Merchandise Pvt Ltd and Sunil Bhandari.

The chargesheet was filed under Sections 3 (money laundering) and 4 (punishment for money laundering) of Prevention of Money Laundering Act (PMLA).

In a 14-page order, the judge observed the "prosecuting agency ED does not come to any detriment if the accused is permitted to make submissions on the question of cognisance". "In this adherence to the principles of fair hearing, the right to be heard is not inconsistent with any of the powers vested in the ED for investigation or the presumptions as well as burden of proof stipulated under the PMLA," the order said.

During a brief hearing, additional solicitor general S V Raju, representing the ED, said the probe agency was "not opposing such a notice precisely because it is votary of fair trial". The court further said, "Besides, the proviso to Section 223 of BNSS (Bharati ya Nagarik Suraksha Sanhita) is a salutary provision in furtherance of the right to be heard, as a part of fair trial. It is designed to protect accused persons against improper implication by permitting them to make submissions prior to the court taking cognisance of the offences in question."

The BNSS, the court noted, was therefore a progressive legislation and recorded among its objectives and reasons a "citizens centric criminal procedure" being the "need of the hour". Section 223 of BNSS grants an accused the right to be heard on the aspect of cognisance.

This "benevolent intent" of the BNSS should be read in favour of accused persons rather than the investigation agencies when a right to be heard is to be accorded at any stage of the proceedings, the court added.

"To summarise, the court finds that notice is required to be issued to the proposed accused persons for hearing on the question of cognisance upon the present complaint in terms of the proviso to section 223 BNSS. It is thus directed that notice be issued to the proposed accused persons in order that they may be heard on the question of cognisance upon the present complaint, the judge said.

The ED, which filed its chargesheet recently, began its probe in 2021 after a mag istrate court took cognisance of a private complaint filed by BJP leader Subramanian Swamy June 26, 2014.

'India asks IMF to review loans, grants to Pakistan'

Law aids vigilant, not those who sleep over their rights: SC

New Delhi, May 2: The law aids the vigilant, not those who sleep over their rights, the Supreme Court Friday said and upheld a high court verdict over a property-related dispute in Bengaluru.

A bench of Justices J B Pardiwala and R Mahadevan was hearing the issue over the forfeiture of ₹20 lakh paid as the first tranche of the total consideration of a property.

The bench, which elaborated on "earnest money" and "advance money" for being relevant to the matter, said the Karnataka High Court denied the relief of refund of advance

money to the appellant as he did not seek an alternative prayer for a refund in the suit.

The top court said it was a settled position of the law that the plaint might be amended at any stage of the proceedings to enable the plaintiff to seek an alternative relief, including that of the refund of earnest money, and the courts were vested with wide judicial discretion to permit such amendments.

It referred to a provision of the Specific Relief Act, 1963 and said the courts couldn't grant such relief suo motu. The provision of the Act, the bench said, was adequately broad and flexible to allow the appellant to seek an amendment of the

plaint for the said relief, even at the appellate stage.

The top court went on, "Here, it would be redundant to state that the law aids the vigilant. not those who sleep over their rights." The apex court deliv-

ered its verdict on an appeal challenging the high court's August 2021 order. The bench noted the dispute

arose from a claim for specific performance of a July 2007 agreement of sale with respect

Charlie Andreasson, who has been involved with the Freedom Flotilla for more than a decade, told The Associated Press that he had spoken to people on board who said there were two explosions and a fire broke out.

Vance says trade deal soon with India

New York: US Vice-President ID Vance has called Prime Minister Narendra Modi a "tough negotiator" and accused New Delhi of taking advantage of America, while predicting that India could be among the first countries to strike a trade deal to avert reciprocal tariffs. In an interview with Fox News Thursday, Vance said "good negotiations" were now on with India on tariffs, India is among the countries negotiating with the US to avoid the high import taxes. most of them on pause right now, announced by President Donald Trump, "Modi, the Prime Minister, is a tough negotiator, but we're going to rebalance that relationship, and that's why the president's doing what he's doing," Vance said during the interview.

Russia downs 121

Ukrainian drones Moscow: Russia has downed 121 Ukrainian drones overnight in Crimea, the Black Sea, and other southern parts of the country, according to a media report Friday. "The Russian military repelled a series of Ukrainian drone raids overnight Thursday, downing a total of 121 UAVs," rt.com news website reported, quoting Defence Ministry officials. The ministry said 89 fixed-wing drones were intercepted over Crimea's Sevastopol, which is home to Russia's Black Sea Fleet. Another 23 drones were shot down over the Black Sea. The ministry said there was no damage on the ground. Sevastopol Governor Mikhail Razvozhayev said it was a massive raid which was foiled with the combined efforts of the naval and ground based air

defence forces.

Washington, May 2: President Donald Trump said Friday he planned to strip Harvard University of its tax-exempt status, setting up another potential legal fight with the Ivy League school amid his wider crackdown on elite universities and the US education system.

"We are going to be taking away Harvard's Tax Exempt Status. It's what they deserve!" Trump said in a post on his social media platform, without specifying when he might take action Representatives for the Inter-

nal Revenue Service did not immediately respond to a request for comment on Trump's post and whether it was revoking the university's tax-exempt status.

Harvard, in a statement, said the move would be unlawful and unprecedented. "There is no legal basis to

rescind Harvard's tax-exempt status," the Boston-area school said. "The unlawful use of this instrument more broadly would have grave consequences for the future of higher education in America.' It would also cut money

available for student scholarships, medical research and technological advancements that drive economic growth, Harvard added. Since taking office in Janu-

China 'evaluating' US offer to negotiate tariffs



Beijing, May 2: Beijing is "evaluating" an offer from Washington to hold talks over US President Donald Trump's crippling tariffs, China's Commerce Ministry said Friday, signalling a potential de-escalation in the trade war that has roiled global markets.

The United States has approached China to seek talks over Trump's 145% tariffs and Beijing's door was open for discussions, the commerce ministry said.

The US should be prepared to take action in "correcting erroneous practices" and cancel unilateral tariffs, the commerce ministry said in a statement, adding that Washington needed to show "sincerity" in negotiations.

"The US has recently taken the initiative on many occasions to convey information to China through relevant parties, saying it hopes to talk with China," the statement said, adding that Beijing was "evaluating this".

"Attempting to use talks as a pretext to engage in coercion and extortion would not work,' it added

China has repeatedly denied it is seeking to negotiate a way out of the tariffs with the United States, appearing instead to be betting that Washington makes the first move.

Trump's decision to single Beijing out for import duties of 145% comes at a particularly difficult time for China, which is struggling with deflation due to sluggish economic growth and a prolonged property crisis.

Beijing has expressed its anger at the tariffs, which it says are tantamount to bullying and cannot stop the rise of the world's second-largest economy.

Alongside leveraging its propaganda machine to hit back at the duties, China has quietly created a list of U.S.-made products it will exempt from its retaliatory 125% tariffs - including select pharmaceuticals, microchips and jet engines - Re-

Israel strikes near Syria's presidential palace

Damascus/Sweida, Syria, May 2: Israel bombed an area near the presidential palace in Damascus early Friday in its clearest signal yet of hostility toward the Islamist-led Syrian authorities and a preparedness to ramp up military action in the name of Syria's Druze mi-

Israel has escalated military operations in Syria since rebels ousted Bashar al-Assad in December, with bombings across the country and ground forces entering its southwest, while calling for Syria to remain decentralised and isolated.

It has framed its stance around its suspicion toward interim President Ahmed al-Sharaa, who once headed a branch of al Qaeda, and the desire to protect the Druze, a minority sect that is an offshoot of Islam with followers in Svria. Lebanon and Israel.

Early Friday, Israel's military said it struck an area "adjacent" to Sharaa's palace in Damascus, without further details. There were no immediate reports of casualties.

The strike was "a clear message to the Syrian regime: We will not allow (Syrian) forces to deploy south of Damascus or

But incidents of sectarian violence, notably the killing of hundreds of pro-Assad Alawites in March, have hardened fears among minority groups about the now-dominant Islamists and sparked condemnation from global powers.

Farage's Reform UK Party wins mayoral, parliamentary post

Widnes, England, May 2: Britain's right-wing Reform UK party won a vacant parliamentary seat, a mayoralty and control of three councils Friday in early results from elections that its leader Nigel Farage said proved it was now the real op

The populist Reform, led by the veteran campaigner for Brexit, hopes Thursday's local elections in England will mark the breakdown of a century of domination of British politics by the governing Labour Party and Opposition Conservatives.

In the most closely watched contest, for the vacant parlia mentary seat of Runcorn and Helsby, Reform won by just six votes after a full recount, giving Farage's party its fifth seat in the House of Commons Labour had won the seat in last year's national election with a majority of almost 15,000.

"It's been a huge night for Reform," Farage told reporters. "This is heartland Labour Party, their vote has collapsed and much of it has come to us.

The Conservatives - histori cally one of the most successful parties of any modern democra cy - were now "toast", he said.

"You're witnessing the end of a party that's been around

Andrea Jenkyns, a former Conservative minister who defected to Reform after losing her seat last year, became mayor of Greater Lincolnshire, which covers about a million people, making her the party's most powerful elected politi cian yet.

Reform also took control of Staffordshire county council, winning 32 seats, and Durham county council.

It was leading all parties in the initial tally of councillors elected, with nearly half of the more than 1,600 seats up for grabs on local authorities declared.

S&P cuts India's FY26 GDP growth forecast

New Delhi, May 2: S&P Global Ratings Friday cut India's growth projections by 0.2 percentage points to 6.3 per cent for the current fiscal year citing uncertainty over the US tariff policy and downside risks from its spillover to the economy.

In its report titled "Global Macro Update: Seismic Shift In US Trade Policy Will Slow World Growth", S&P Global Ratings said "we reiterate that there are no winners in a scenario of escalating protectionist policies.

S&P said among Asia-Pacific's major economies, China is expected to see its growth drop by 0.7 percentage points in 2025 to 3.5 per cent and in 2026 to 3 per cent. S&P projected India's GDP

growth to be 6.3 per cent in 2025-26 and 6.5 per cent in 2026-27 fiscal year.

In March, S&P had lowered the FY'26 GDP growth forecast to 6.5 per cent, from 6.7 per cent.

"The risks to our baseline remain firmly on the downside in the form of a stronger-than-anticipated spillover from the tariff shock to the real economy. The longer-term configuration of the global economy, including the role of the US, is also less certain," S&P said.

That may be starting to change, as goods shipments from China have recently begun to decline, S&P noted.

Forex kitty jumps to \$688.13 billion

Manufacturing growth touches 10-month high

New Delhi, May 2: The growth momentum in the Indian manufacturing sector improved in April, with output increasing at the fastest pace since June 2024, on the back of another strong expansion in order books, a monthly survey said Friday.

The seasonally adjusted HS-BC India Manufacturing Purchasing Managers' Index (PMI) rose from 58.1 in March to 58.2 in April, indicating the strongest improvement in the health of the sector for ten months.

In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

A key factor contributing to the latest improvement in output growth was a sharp rise in new business. The manufacturing sector's rate of expansion was supported by better domestic and international demand. According to the survey, the

SEBI accuses Adani nephew in insider trading case

Mumbai, May 2: India's markets regulator has alleged Pranav Adani, director of several Adani group companies and the nephew of the billionaire founder, shared price sensitive information and breached regulations aimed at preventing insider trading, according a document reviewed by Reuters

Adani, the nephew of Gautam Adani, was sent a notice by the Securities and Exchange Board of India (SE-BI) last vear which alleged he shared information about Adani Green's 2021 acquisition of SoftBank-backed SB Energy Holdings

with his brotherin-law before the deal was announced. according to a source and the document.

The matter has not been previously reported.

In an e-mailed response sent to Reuters. Pranav Adani said he was seeking to settle the charges "to put an end to the matter, without admission or denial of the allegations" and that "he has not violated any securities law".

Settlement terms were being discussed, said the source with direct knowledge of the matter, who declined to be named as the matter is confidential.

The scrutiny is the latest challenge for the Adani group. US authorities last year indicted Gautam Adani and two Adani Green executives for allegedly paying bribes to secure Indian power supply contracts and misleading US investors. The group has denied the charges and called them "baseless".

ITR-3 form simplified for AY 2025-26

New Delhi, May 2: The Income Tax department has notified ITR form 3 to be filed by individuals and HUFs having income from business or profession.

The tax department in a post on X late Thursday night said ITR-3 for Assessment Year 2025-26 has been notified April 30. ITR-3 is filed by indivi duals and HUFs having income from profits and gains of business or profession.

The threshold for reporting assets and liabilities under 'Schedule AL' has been raised from ₹50 lakh to ₹1 crore, thus reducing the disclosure burden on middle-income taxpayers.

of the ITR, capital gains must now be split based on whether they arose before or after July

In the Budget presented on July 24, 2024, the government had proposed to lower longterm capital gains tax on real estate to 12.5 per cent without indexation benefit, from 20 per cent with indexation. Indexation benefit allows

taxpayers to arrive at the cost price of the property after adjusting for inflation.

With this, individuals or HUFs who purchased houses before July 23, 2024, can opt to pay Long Term Capital Gain (LTCG) tax under the new scheme at the rate of 12.5 per cent without indexation or claim the indexation benefit and pay 20 per cent tax.

Tax consultancy firm AKM Global, Partner-Tax, Sandeep Sehgal said the Central Board of Direct Taxes (CBDT) has made key updates to ITR Form 3 for AY 2025-26, easing compliance for individuals and HUFs with business or professional income. "Dropdowns for deduc-

tions like Section 80C and section-wise TDS reporting have also been introduced, enhancing transparency, accuracy, and ease of filing. Overall, these changes reflect the CBDT's ongoing efforts to promote ease of compliance improve data accuracy, and align reporting with emerging policy developments, Sehgal added. Earlier April 29, the govern-

ment had notified the income tax return (ITR) forms 1 and 4 for assessment year 2025-26 and made it easier for individ uals with long term capital gains of up to ₹1.25 lakh from listed equities to file returns.

Liverpool title celebration shook Earth THE SEISMOMETER RECORDED ACTIVITY INSIDE THE STADIUM FROM THE CROWD OF 60,415

- MOST NOTABLY ITS REACTION TO THE SIX GOALS SCORED DURING THE GAME

Liverpool, May 2: Liverpool's clinching of the Premier League title on Sunday produced an actual seismic event, scientific data shows. Arne Slot's side secured the club's 20th top-flight championship on an unforgettable day at Anfield when they beat Tottenham Hotspur 5-1.

With the help of the University of Liverpool, the club was able to install a seismometer an instrument that measures ground movement - in the Main Stand for the historic occasion in L4.

The seismometer recorded activity inside the stadium from the crowd of 60,415 - most notably its reaction to the six goals scored during the game. It shows Alexis Mac Allister's stunning strike in the 24th minute that put the Reds 2-1



ahead produced a peak magnitude 1.74 on the Richter scale.

The second-biggest tremor within Anfield was caused by the goal Mohamed Salah scored in front of the Kop in the second half at a magnitude of 1.60. Cody Gakpo's effort measured in at 1.03, the own goal from Destiny Udogie 1.35 and Luis Diaz's initially disallowed equaliser 0.64.

The data was processed and analysed inside the laboratory of the university's department of Earth, Ocean and Ecological Sciences by research associates Dr Antoine Septier and Dr Farnaz Kamranzad.

Explaining the science behind the experiment, Ben Edwards, professor of engineering seismology at the University of Liverpool, said, "This experiment gave us a unique opportunity to use seismology to capture a scientific record of the magnitude of Liverpool's historic title-clinching win.

"Using state-of-the-art, seismic-monitoring equipment – normally deployed in earthquake zones like Chile and Italy - we recorded the incredible energy released both at the surface and below. Much like natural seismic events. these goals produced bursts of ground-shaking, triggered by the sheer passion of Liverpool fans. Their enthusiasm was literally powerful enough to move the Earth.

A statement issued by ECB said that it is announcing a change to its regulations on the eligibility of transgender players after an "updated legal position" following the recent Supreme Court ruling.

"With immediate effect, only those whose biological sex is female will be eligible to play in women's cricket and girls' cricket matches. Transgender women
