Bhubaneswar, May 3: Seeking global recognition for local

games, chief minister Mohan Charan Majhi Saturday said Odisha will continue to ensure that indigenous sports get their rightful place on the world stage. Majhi said this in his keynote address at the WAVES (World Audio Visual & Entertainment Summit) 2025. held at the Jio World Centre in

Mumbai, a CMO release said.

Speaking at the special ses sion titled 'Indigenous Sports -From India to the Global Stage. the Chief Minister spotlighted the cultural, social, and global significance of India's traditional sports. "We will continue to work with the Government of India and global federations to ensure that indigenous sports get their rightful place on the

world stage," Majhi said. Drawing from his own upbringing in Keonjhar, a tribal-dominat ed hinterland district of Odisha. the chief minister reflected on his early sporting experiences with 'kabaddi' and 'kho-kho'. "These

were more than games," he said,

adding that they were expressions of teamwork, resilience, and identity rooted in the soil of our communities. Majhi informed the gathering that Odisha is the first state in India to establish a dedicated High-Performance Centre (HPC) for an indigenous sport like Kho Kho, in collaboration with a steel company

This landmark initiative redefines the narrative around traditional sports, recognising them as professional disciplines worthy of structured training, infrastructure, and innovation, he said and highlighted the success of Odisha Juggernauts.

Odisha is the only state government-owned franchise in the Ultimate Kho Kho League, which won the league's inaugural season in 2022, he said.



Addressing a presser to announce the detection, twin police commissioner Suresh Dev Datta Singh said the activities of the racket spanned across three states -Jharkhand, Odisha and Bihar. Two four-wheelers, documents pertaining to the purchase of two plots of land in Arugul, a forged NRI certificate, and three bank cheques totalling ₹90 lakh have been seized from the foursome following their

Singh identified the arrested as Priyadarshi Kumar, Arvind Kumar, Sunil Samantray and Rudra Narayan Behera, While Priyadarshi and Arvind are natives of Jharkhand and Bihar,

are from Odisha. The racket has been active for quite some time, he said.

Giving details of the racket's modus operandi, Singh said, "The hoodlums, with help from a few local scouts, would procure the identification details of NEET aspirants. Once the admit cards were obtained on the basis of these details, they would share those with dummy candidates, who would sit for the test after forging admit card details.

The commissioner said the syndicate charged each candidate anything between ₹20-30 lakh for the service. "The local scouts received ₹4-5 lakh as remuneration," he said.

The syndicate was busted following a tip-off by a local informer in Jharkhand, leading to the arrest of Priyadarshi and Arvind. "The Jharkhand Police's information helped us nab Sunil and Rudra from their hideouts in the City," Singh added.







SJTA begins probe into 'use' of sacred wood from Puri Srimandir to craft Digha idols

Bhubaneswar, May 3: As tensions rise over the West Bengal government's portrayal of a newly-constructed temple in Digha as 'Jagannath Dham', the Shree Jagannath Temple Administration (SJTA) has launched an official probe into allegations that sacred wood from Puri Srimandir was secretly used to craft idols at the Digha shrine

State Law Minister Prithiviraj Harichandan, who ordered the internal inquiry, said, "Chief Minister Mohan Charan Majhi, who is currently touring Mumbai, will return to Bhubaneswar Sunday and raise the issue with his West Bengal counterpart, Mamata Banerjee. The people of Odisha do not accept the misuse of the title 'Jagannath Dham' by anyone. The term 'Dham' holds deep spiritual significance and cannot be used arbitrarily."

He added that the Odisha government has no objection to the construction of Jagannath temples across the country.

"But it is unacceptable for the Lord's devotees to recognise Digha as 'Jagannath Dham'. Moreover, I personally have reservations about allowing people from all religions to enter the Jagannath temple," Harichandan said.

Deputy Chief Minister Pravati Parida, without directly naming Mamata Banerjee, said, "Those who have misused Lord Jagannath's name have paid a heavy price in the past. Now,



someone [referring to Banerjee] is set to suffer.

Puri MP and BJP national spokesperson Sambit Patra also voiced strong opposition to the use of the 'Jagannath Dham' title for the Digha temple.

There is only one Jagannath Dham in the world, and it is in Puri. One should know that there are four Dhams in the country, and Puri is one of them. There should be no doubt that no other place can be called Jagannath Dham, Shreekhetra or Purusottama Kshetra exists only in Puri, where the Lord

However, Dasmohapatra has denied the allegation, asserting that he crafted the idols from neem wood in Puri before transporting them to Digha.

As the controversy deepened, SJTA convened meetings with various Nijogs (servitor associations) of Srimandir.

In the first phase, Padhee held discussions with key functionaries—Deulakaran, Tadaukaran, and Pattajoshi Mohapatra. Further meetings will include the four Badagrahis (bodyguards of the deities during the Rath Yatra) and three chief carpenters who construct the chariots.

On Saturday, SJTA issued notices to the presidents and secretaries of all Sevayat Nijogs (servitor bodies) of Srimandir, seeking their views on the Digha

temple controversy. The servitor bodies were asked to submit their opinions by 5pm Sunday.

Ramkrushna Dasmohapatra secretary of Daitapati Nijog and at the centre of the controversy for attending the Digha temple inauguration, has also been issued a notice to appear before the SJTA Sunday morning.

Meanwhile, Gajapati Dib-yasingha Deb Saturday said appropriate steps would be taken regarding the use of the term 'Dham' by the West Bengal government for the recently inaugurated temple.

The Gajapati, who is the Chairman of Shree Jagannath Temple Managing Committee in Puri, said this while responding to a request by Padma awardee sand sculptor Sudarsan Pattnaik. He has urged the Gajapati to come forward and protect dignity of the Jagannath Dham.

'The act of the West Bengal Chief Minister has deeply hurt the religious sentiments of millions of Lord Jagannath's devotees around the world. According to our sacred scriptures (Shastras), there is only one organised Jagannath Dham, and it is in Puri. ### Mediation offers more holistic solution to disputes: C the ailment and bane remain.

New Delhi, May 3: Observing that mediation is not a 'lesser form of justice' but it's 'wiser form', Chief Justice of India (CJI) Sanjiy Khanna Saturday said mediation offers a more holistic solution to disputes as compared to courtroom adjudication.

Speaking at the National Conference on Exploring the Efficacy and Reach of Mediation. Khanna said that in courtroom adjudication, one party emerges the winner and the other the loser leading to relations becoming strained

The CJI said mediation, on the other hand, can heal relations and the solutions offered by it are less traumatic and more humane.

"Court litigation and adjudication are, in a way, grim and shallow. At times, the root cause remains unaddressed and

The relationships are strained, if not broken. There is a winner, there is a loser," he said.

"Mediation does the opposite. It seeks to identify and remedy the root cause. It goes deeper into the issue, the cause of the misunderstanding. It addresses the primordial and underlying concerns that are the cause of the dispute," he said.

"It allows a more holistic solution that not only resolves the legal issue but goes beyond that. It heals and restores the relationship. This is true justice, not coerced and forced by what third parties dictate," he added.

The CJI said over the past two decades, mediation has played a critical role in resolving disputes.

"Between 2016 and early 2025, a staggering 7.57 lakh cases were settled through mediation. Yet, I must acknowledge,



mediation is yet to reach the villages. India, in one way, therefore, has been slow in arriving at mediation and understanding its importance," he pointed out.

"Our goal must be to show ev-

ery litigant, every citizen, every businessman and every person that mediation is not a lesser form of justice but a wiser form of it." he said.

"Institutions such as NALSA have already taken a commendable step by conducting training programs in mediation and advanced commercial mediation for lawyers. However, to truly manifest mediation, we need to scale up and diversify these efforts. It is at this juncture that the establishment of the Mediation Association of India assumes critical significance,' Gavai said.

# Prez backs legal role for village mediators

President Droupadi Murmu stresses the need to legally empower local mediators to resolve village disputes and ease the burden on higher courts

New Delhi, May 3: President Droupadi Murmu Saturday called for legally empowering mediators at the village level to resolve disputes locally, preventing them from escalating to higher courts. She was addressing the inaugural National Conference on Mediation held in the capital.

Highlighting the critical gap between traditional village mediation practices and the modern legal framework, the President said, "In villages, people who resolve disputes—especially those related to family or land—may have social respect but lack legal authority. This undermines their ability to settle matters ef-



fectively." She emphasised that disputes often go unresolved at the grassroots because parties involved are aware that mediators hold no legal power, and thus do not accept their deci-

Murmu underlined the urgent need to create a robust mechanism that supports grassroots dispute resolution, ensuring that conflicts do not spiral and disturb the harmony of rural communities. "We need to strengthen local mediation systems to preserve peace and reduce the burden on formal courts," she said.

The President also reflected

judicial mechanism extending from the village to the Supreme Court, "Despite our rich tradition of village mediation, modern systems have not formally integrated these into the judicial structure," she noted, suggesting this may have been due to oversight or lack of time.

Union Law Minister Arjun Ram Meghwal also addressed the gathering, describing mediation as both a reform and a collective societal responsibility. He urged a shift from litigation to dialogue, saying, "More mediate, less litigate should be our guiding principle." He cited Indian epics, referencing Angad from the Ramayana and Lord Krishna from the Mahabharata, as ancient examples of mediators

Chief Justice of India Sanjiv Khanna, along with CJI-designate Justice BR Gavai, also attended the event, CJI Khanna launched the Mediation Association of India, which is expected to facilitate the formation of the Mediation Council of India under the Mediation Act, 2023.

## Rare pancreatic surgery saves migrant worker

After undergoing treatment in Qatar, a migrant worker's journey from coma to comeback has been remarkable

Bhubaneswar, May 3: A 27-year-old migrant worker from Berhampur has defied the odds after undergoing life-saving treatment at Manipal Hospitals, Bhubaneswar, Rohit (name changed), who had moved to Qatar to secure a better future, experienced severe abdominal pain just three months into his job. He was diagnosed with necrotising pancreatitis and a pseudoaneurysm, both life-threatening conditions that led to his hospitalisation in Qatar for six months.

Rohit's condition worsened and he slipped into a coma for three months, requiring multiple surgeries, including the removal of part of his pancreas and colon. He was left reliant on a tracheostomy, feeding tube, and stoma. As his insurance coverage ended, his family brought him back to India in search of further treatment.

## Global temp may rise by 2.7°C by century's end

Bhubaneswar, May 3: If the emission of greenhouse gases (GHGs) is not reduced urgently, the Earth's temperature may rise by 2.7 degrees Celsius by the end of the current century, warned Centre for Environment and Climate (CEC) director Sarat Chandra Sahu— an eminent meteorologist and

According to him, the GHG emissions increased by 47 per cent and Carbon Dioxide emissions by 80 per cent between 1990 and 2020.

Citing data from the World Meteorological Organisation (WMO). Sahu noted that the Paris Agreement on climate change, adopted in 2015 was aimed to limit global warming to well below 2 degrees Celsius. However, current trends indicate that the temperature is

likely to exceed that threshold, he said.

Sahu made these remarks while speaking at a two-day 'International Workshop on Water, Waste Management and Climate Change' organised by the CEC, in collaboration with Rivers of the World (ROW), USA here recently.

He further stated that the concentration of Carbon Dioxide in the atmosphere has risen by 149 per cent compared to pre-industrial levels. This



surge poses significant threats to human health, the planet's well-being, and the future of coming generations.

While atmospheric Carbon Dioxide levels stood at 400 parts per million (ppm) in 2015, they had increased to 413.2 ppm by 2020.

Methane and Nitrous Oxide levels have also seen dramatic increases of 262 per cent and 123 per cent respectively, compared to their levels in 1750, when human activities began disrupting the Earth's natural balance.

The WMO observed that Earth last experienced similar levels of Carbon Dioxide 3 to 5 million years ago, during which global temperatures rose by 2 to 3 degrees Celsius. However, the global population was not 7.8 billion at that time—underscoring the heightened danger posed by current GHG concentrations.

"According to the latest findings of the Intergovernmental Panel on Climate Change (IP-CC), the temperature may rise by 2.7 degrees Celsius by the end of the century if the increase in GHG emissions is not curtailed soon," Sahu warned.

Sahu, a former Director of the India Meteorological Department in Bhubaneswar, emphasised the growing concern over the link between airborne particulate matter and a wide range of adverse health effects highlighting the urgent need

for air quality improvement.

He explained that Aerosols—tiny particles produced by human activity, industrial effluents, volcanic eruptions forest fires, and natural phe nomena-are ever-present in the air we breathe and are toxic to human health.

"Aerosols, formed from both natural and anthropogenic processes, play a significant role in climate change," Sahu said "An increase in air pollution from power plants, construc tion, and other activities leads to a rise in Aerosols, which can affect cloud formation and result in thicker clouds, ultimately causing a decrease in temperature," he added.

#### Student hangs self over poor scores in exam

Champua, May 3: A 15-year-old girl, who had recently appeared for the High School Certificate (HSC) exams, reportedly committed suicide over poor results in Shankarpur village under Champua police limits in Keonjhar district.

The deceased student has been identified as Truptimayee Mahanta, daughter of Kamal Mahanta and a student of Naradpur High School. She had appeared for this year's Class X board examination and secured 253 marks out of total 600. According to family members, she was distressed after learning that she had scored fewer marks than her peers. Though she had passed the exam, the marks were below her expectation.

The results were published Friday and Truptimayee came to know about her scores through a phone conversation with fellow students at her tuition class. Learning that her marks were significantly lower than those of her classmates, she reportedly



went into severe mental stress Truptimayee had dinner Friday night and slept as usual

with her younger sister. However, the next morning, her grandfather found her hanging inside the room.

She had reportedly used a scarf to hang herself from a wooden beam of the thatched house. Her father, who has been bedridden for years due to illness, was unable to report the incident. Instead, her uncle. Sudarshan Mahanta. reported the incident at Champua police station.

Champua police recovered the body and sent it for post-mortem. Following the procedure. the body was handed over to the family. An unnatural death case (16/2025) has been registered, and an investigation is underway.

Champua police station Officer-in-Charge Debaki Nayak confirmed the development and said preliminary findings suggest that the girl took the extreme step due to mental stress stemming from poor scores.

The incident has cast a pall of gloom over the village.

Krushna Chandra works at a company in Ahmedabad, Gujarat, while Ganesh is employed in Rourkela. Only Labani and Monalisa were living at home



at the time of the incident.

Neighbours alleged that a fight broke out Friday night between the two women and they informed Ganesh of the situation over phone. Ganesh rushed to his house Saturday morning and found Labani lying dead in the house, bleeding from the mouth. He immediately informed the police.

Redhakhol SDPO Prashant Kumar Meher and IIC Chandra Mohan Singh, accompanied by a scientific team, visited the spot and launched an investigation. The body was sent for post-mortem to the Redhakhol Sub-Divisional Hospital and later handed over to the family members for cremation.

## Man sentenced to 20-yr RI for sodomising minor boy

Baripada: A local court in Mayurbhanj district Saturday sentenced a 25-year-old man to 20 years of Rigorous Imprisonment (RI) after finding him guilty of sexually assaulting a seven-year-old boy. The verdict was delivered by Judge Santosh Kumar Nayak of the Fast Track Special Court under POCSO Act. The court also imposed a fine of ₹50,000 on convict Raghunath Murmu, said Special Public Prosecutor Manaranjan Pattnaik. If the convict fails to pay the fine, he will remain in jail for another year, the court said. The court also directed Mayurbhanj District Legal Services Authority (DLSA) Secretary to pay ₹1 lakh compensation to the victim's family. The judgment was based on the statement of the victim, five witnesses and medical report, Pattnaik said, adding that the incident took place January 12, 2025, when the child was alone in his house. According to police, Murmu lured the child with chocolates and took him to a nearby forest where he sexually assaulted him.

### Police crack double murder, nab one

Bargarh, May 3: Police have cracked the double murder case that occurred Thursday in Baghapali village under Bheden police station and arrested Nepal alias Naama, 28, the son of one of the deceased Magha alias Madhusudan Bhue, 55. Bodies of two men had been found from a house in the village Thursday.

According to Bheden IIC Sushant Kumar Das, Nepal confessed during police interrogation that he killed Tarani Bag, 35, to avenge the murder of his father Magha. Tarani allegedly killed Magha following a dispute, prompting Nepal to retaliate.

Police have seized several weapons used in the crime, including a bamboo stick, a steel rod, a piece of wooden cot, and a knife. Nepal was produced in



court Saturday. As his bail plea was rejected, he was remanded to Bargarh sub-jail.

A murder case (100/25) has been registered against Nepal based on a complaint filed by Tarani's elder brother, Ni-

Sources said that a wedding ceremony was underway in Baghapali village on the day of the incident. Magha and his family were attending the event, as was Tarani. A verbal altercation broke out between the two during the function, after which Tarani went to Magha's residence. There, he allegedly attacked Magha inside the house, killing him on the spot.

Upon learning about the attack on his father, Nepal rushed to the scene and launched a counterattack on Tarani, who also died at the spot. After confirming both deaths, Nepal fled from the village.

Later, police arrived at the scene and found both Magha and Tarani lying in pools of

swiftly, Bolangir SP J Abhilash (then in-charge of Bargarh), Bargarh Additional SP In durekha Paschim Kabat, SD-PO Padarabinda Tripathi, and Bheden IIC Sushant Kumar Das reached the spot with a scientific team.

Both bodies were seized and sent to Bargarh hospital for post-mortem. After the autopsy, the bodies were returned to the village Friday. As Nepa was absconding, Magha's funer al rites were performed by his daughter Yajnaseni. Tarani's last rites were carried out by his nephew Rakesh.

Tarani was known to be a habitual offender and had an active arrest warrant against him. It is widely speculated that he had returned to the village on the day of the incident despite being on the run from the law.

## Defamation case registered against Raja Chakra's lawyer

Balasore, May 3: A defamation suit has been filed against senior advocate Sitanshu Mohan Dwivedi for reportedly making baseless allegations in connection with a multi-crore corruption case involving Gandhamardan Loading Agency and Transporting Co-operative Society Ltd.

BJP state president Manmohan Samal filed the defamation complaint Saturday before the SDJM court in Balasore (Case No. 25/25). The suit follows Dwivedi's recent remarks alleging that Samal's party workers had demanded ₹1.3 crore under the pretext of a "state head" to allow business operations to continue. Samal has dismissed the allegations as "false and malicious.'

Dwivedi is the legal representative of BJD leader Soumyashankar alias Raja Chakra, a key accused in the ongoing investigation by the Crime Branch into financial misconduct.

Accompanying Samal at the court were several BJP leaders and legal professionals, including deputy chief whip and Remuna MLA Gobinda Chandra Das, district BJP president Ishwar Chandra Behera, former district president Umakanta Mohapatra, Bar Association president Keshab Acharya, senior advocates Harekrushna Das, Lambodar Nayak, Bailochan Das, Ashish Ghosh, and Shobhana Mohanty, along with

Speaking to the media, Samal said, "About a month ago, Sitanshu Mohan Dwivedi levelled a baseless allegation against me. He claimed that my work ers demanded ₹1.3 crore under the guise of a state head and threatened to halt business operations if the amount wasn't paid. These statements were made with malicious intent to tarnish my image and the reputation of the BJP in the state.'

He said that the complaint was filed to counter a "fabricated and unfounded narrative," and stated, "If anyone has any allegations against me, show me the proof. These are completely baseless claims made solely for publicity or to defame me and the ruling party." Samal also urged the media

to verify the truthfulness of claims before publishing them, especially when political or reputational stakes are high.

The allegation has triggered political uproar across the state. particularly as it relates to a broader corruption case involving crores of rupees misappropriated by the co-operative society, in which Raja Chakra is reportedly the principal accused.

## Blind school achieves 100% pass rate for 42nd year

Berhampur, May 3: The Red Cross School for the Blind in Ganjam district has again achieved 100 per cent pass percentage in the High School Certificate (HSC) examination, the results of which were announced Friday.

All 11 visually impaired students, including four girls, who appeared for the exam this year passed, principal Priva Ranjan Mahakuda said. "Two boys secured A2 grades

by scoring above 80 per cent, while two other students received B1 grade (over 70 per cent). Three students got B2 grade (over 60 per cent), and four secured C grade over 50 per cent)," Mahakuda said.

Since its first batch in 1983, the residential school has consistently achieved a 100 per cent success rate in the matriculation examination. "The teaching staff takes ex-

tra care of the students, which is a key reason behind our success." Mahakuda added.

Bikram Giri and Binayak Patra, who secured A2 grades, expressed their desire to pursue higher education.

"We want to pursue Plus II in college," they said. Earlier, students faced challenges in Plus II education due to the lack of



Braille textbooks. However, in the past three years, that gap has been addressed.

"We have been printing Braille textbooks for Plus II Arts students and supplying those to different institutes free of cost, as directed by the government," said Prakash Narayan Rath, manager of the government-run computerised Braille press. Three schools in Berhampur have also reported 100 per cent success rates.

While Saraswati Vidya Mandir at Nilakantha Nagar has achieved 100 per cent success rate for the last 33 years. Saraswati Sishu Vidya Mandir at Ramahari Nagar, Goshaninuagan has been achieving 100 per cent results for the past 23

## Hyphen in Geopolitics

hrough the 1990s and up until fairly recently, India insisted on something called de-hyphenation. The hyphen referred to was the one in the term 'Indo-Pak', which is how the world saw South Asia. Neither country was seen from the outside without the shadow

American diplomats visiting India, like Robin Raphel, an official in the Clinton administration, would make it a point to visit Pakistan when visiting India to 'balance' the relationship. President Clinton himself when he visited India in March 2000 also stopped over in Pakistan for a few hours on his way back to assure Islamabad that it

India chafed at hyphenation because it saw itself, legitimately, as the bigger power, the world's largest democracy and in many ways similar to the West, as opposed to our terror-exporting, failed-state neighbour. Others did not always see it quite that way. The world was fixated on the hyphenation of Indo-Pak especially in 1998 when India under Atal Behari Vajpayee detonated nuclear devices in mid-May and then Pakistan under Nawaz Sharif also did the same on 28 May. The world was concerned about instability and recklessness and this was heightened with the Kargil War of 1999, which was not officially war — because war had not been declared by either nation — though over 1.000 soldiers were killed.

 $Pakistan\ and\ India\ fought\ in\ conventional\ fashion\ with\ artillery\ and$ air force on the unsaid assumption that escalation to nuclear exchange would not materialise, the first time that such a conflict between nuclear states had been witnessed in the world. The media and the public on both sides were mobilised with the sort of frenzy that we are familiar with. The world was alarmed and Clinton stepped in and forced Pakistan to pull back its forces from Kargil. Two things came after

this which removed the hyphen. The first was the attack of 11 September 2001 which took down the World Trade Center towers, leading America to declare a war on terrorism. Karachi was required for the US invasion of Taliban-controlled Afghanistan and almost all of the fuel, ammunition and spares the US/NATO military needed were shipped through Pakistan, for a fee. Like Gen Zia-ul-Haq in 1979 after the Soviet invasion of Afghanistan, Gen Pervez Musharraf suddenly found himself acceptable and his coup against Nawaz Sharif was overlooked.

India's government was initially anxious, irritated and perhaps even jealous of all the attention Musharraf got on the global stage, but Vajpayee wisely stayed away from the adventure. The Americans coined the term 'Af-Pak'. The Indo-Pak hyphen became blurred.

The second reason is best exemplified by the term 'India Shining', the advertising campaign launched on the assumption that India was the next China in terms of economic growth. In 2004, UPA minister Jairam Ramesh came up with the term 'Chindia' in the hope that "India and China could cooperate and work

together to face challenges ahead.' India wanted to be seen relative to its larger neighbour on the northeast and to de-hyphenate itself from the one on the northwest. The term Chindia did not stick, unfortunately. China's spectacular

rise meant that economically there was no contest. India showed some promise, but offered mostly bluster instead of performance. Truth be told this flopping of Chindia was not necessarily all bad.

You see, India's annoyance at being clubbed with Pakistan was purely out of resentment. We wanted to be seen as being superior and not associated with the poor cousins. However, the reality was and is that India is most comfortable when in a match-up with Pakistan because that comes naturally to us, unlike dealing with China or even with The passion India shows in for alike the United Nations when our

diplomats speak on Pakistan we do not display for other nations. The speeches we have presented, such as those by the late foreign minister Sushma Swaraj, ostensibly for the benefit of the General Assembly but actually aimed at a particular nation are a good example of this.

Taking on Pakistan is the position that is most satisfying and where the Indian establishment finds itself most comfortable. This is particularly true of India under the BJP, for whom Pakistan is the external manifestation of its primary enemy. Our 'strategic affairs community' including retired military officers is instinctively enthusiastic about prosecuting war against Pakistan as we can observe. Their unfiltered views on social media and TV debates are revealing.

Even the Indian public's participation is at peak when it is mobilised against Pakistan. The scenes of Indians abroad screaming abuse and making gestures outside embassies might appear off-putting to some but are pleasing to the many.

We may not want the world to focus on Indo-Pak, but we certainly want to wallow in it. This is the paradox of Indo-Pak de-hyphenation. We are too important to want to be paired with Pakistan but too intensely connected to it to successfully detach ourselves


The late scholar Stephen Cohen offered insight into this: "Structurally, the India-Pakistan relationship is toxic. It is a classic case of what I call a Paired Minority Conflict. In these situations both sides see themselves as vulnerable, threatened, encircled, and at risk. They have a minority or small-power complex, which also means that conventional morality does not apply to them" and that "Pakistan remains deeply embedded in Indian thinking.

Cohen thought Sri Lanka (Sinhala v Tamil) and the Middle East contained similar relationships.

Cohen died in 2019 and the world for many years has not used the hyphen. But every so often events give us the opportunity to attach

## **OCEAN'S TIPPING POINT**

has absorbed more than 90 per cent of the excess heat caused by human-generated climate change, pushing it to the brink of collapse. The fact that the world is currently experiencing the largest coral-bleaching event on record is a warning sign of the dangers ahead. In fact, without urgent action. the ocean will soon cross a tipping point, threatening the extinction of marine life and millions of livelihoods.

Fish are a key source of protein for about 3.3 billion people. More than 270 million workers are employed in the tourism sector, making it one of the world's largest industries, with seaside holiday destinations, such as the Bahamas and Seychelles, having a particularly high concentration of workers in tourism. Coral reefs alone provide goods and services valued at roughly \$2.7 trillion per year. Biodiversity collapse and climate-related disasters could cost trillions of dollars in lost productive capacity, and have wide-reaching consequences for public health, economic stability, and global security.

The international community has started to recognise the growing threats posed by ocean warming and acidification. The 2022 United Nations Biodiversity Conference (COP15) adopted the Kunming-Montreal Global Biodiversity Framework, which sets the ambitious target of conserving at least 30 per cent of the world's land and seas by 2030, with a focus on areas that offer important ecosystem services. This "30-by-30" pledge reflects scientific consensus on the minimum level of protection needed to halt and reverse biodiversity loss. But efforts to meet this target have so far fallen far short: only 17.6 per cent of land and 8.4 per cent of seas are currently protected,

with the latter increasing by just 0.5 per cent since COP15.

Increased investment in marine conservation would bring profound benefits: healthy oceans support resilient economies and communities by strengthening food and water security and generating sustainable livelihoods. Without marine reserves, overfishing and other unsustainable extraction practices will continue to escalate, potentially leading to the collapse of fish stocks and the industries that depend on them. Moreover, pollution - from oil spills to industrial and plastic waste - will destroy marine habitats, creating a negative feedback loop.

One of the best ways to protect these ecosystems is by establishing and maintaining marine protected areas (MPAs) - often called the "national parks of the sea." Indigenous peoples and coastal communities, in particular, should participate in the management and governance of MPAs. Their knowledge, cultural connections to nature, and traditional practices are essential

to preserve biodiversity and ecological connectivity.

Many countries lack the governance frameworks and financial resources to create or enforce MPAs. The High Ambition Coalition for Nature and People (HAC, of which I am director) can help here. This intergovernmental group of 120 countries, co-chaired by Costa Rica and France (with the United Kingdom as the oceans champion), was created to support member countries in their efforts to achieve the 30-by-30 target. The HAC has developed tools, expertise, and partnerships to help governments identify their needs, access resources, and implement effective solutions, whether through peer-to-peer exchanges, capacity-building workshops, or other avenues.

These efforts to mobilise new commitments and maintain momentum toward the 30-by-30 target are starting to bear fruit. Portugal approved legislation to create the largest MPA network in the North Atlantic Ocean, covering 287,000 square kilometers (111,000 square miles) – approximate

surrounding the Azores. The Dominican Republic became the first Caribbean country to achieve the 30 per cent-protection target by designating a new MPA and expanding an existing sanctuary. And Australia has protected more than half of its ocean area by expanding two already-existing marine reserves around Heard Island and McDonald Islands. Other HAC members must follow their lead.

Of course, developing countries often lack the capacity to mobilise domestic resources. To address this problem, we just launched the rapid deployment mechanism, which offers small grants for the development and implementation of 30-by-30 plans, at the Our Ocean Conference in Busan, Korea. This mechanism will provide seed funding to HAC members to fast-track the establishment of new MPAs, enhance existing ones, and galvanise political support for ocean conservation.

Human well-being depends on a healthy ocean, and safeguarding at least 30 per cent of this critical ecosystem is the minimum requirement for ensuring a thriving future for people and planet alike. As we kick off a year of high-level decision-making on marine conservation, with this week's Our Ocean Conference and both the United Nations Ocean Conference and the Blue Economy and Finance Forum in June, we must remember that preserving the world's seas for current and future generations is our collective responsibility. Part of that responsibility is providing a lifeline for those countries that have the will, but not the resources, to act.

aste is back with rigour in a supposed casteless society envisaged at Independence. Even Babasaheb Bhim Rao Ambedkar was for a harmonious non-caste based constitutional society. His opposition to caste division was so vehement that he never wanted reservation even for the scheduled castes (SC), one that he belonged, now called Dalit. With utmost reluctance he agreed for 10-year job reservation for their supposed economic uplift.

The new trend of the Central government agreeing to order a caste-based census, since the last one in 1931, is the dynamics of the non-creation of jobs with the First Five Year Plan. Though it led to industrialisation of the country, it never could have enough jobs to keep the burgeoning numbers of youth engaged. The unemployment rate hovers now around 6 to 9 per cent as per estimates of CMIE. In February 2025 it was 7.9 per cent or 44.85 million jobless. Ambedkar had never envisioned that the Indian society and politician would turn that 10-year-term into an eternity. Nor anybody had ever dreamt that it would be the resurgence of caste society after 78 years of freedom. Ambedkar was not alone. All of his compatriots - Mahatma Gandhi, Pt Jawaharlal Nehru, CR Rajagopalachari, the founding fathers, and who not in the Indian National Congress, were for a casteless society. Gandhi argued for the equal status of all occupations, challenging the traditional hierarchy within the varna system. Lakhs of families discarded their surnames in cosmopolitan Uttar Pradesh. And by mid 1960s, in many states like Uttar Pradesh even schools and colleges with caste tags were told to change the names. No wonder the Congress, as a party, and its leaders for their egalitarian views today are castigated for ignoring the "need for a census on caste basis." Was the Congress alone? No. Even the propagator of "integral humanism", Jan Sangh leader Pandit Deendayal Upadhyaya, who met an unfortunate violent death in 1965, envisioned a casteless society as part of his philosophy. No wonder Jan Sangh's successor Bharativa Janata Party was neither in favour of Mandal Commission report implementation by the then Prime Minister VP Singh in 1989 nor agreed to a caste census till April 30, 2025. What about a prominent so-

cialist leader, Ram Manohar

Lohia, often quoted by caste census propagators? Lohia viewed the caste system as a major obstacle to social progress and equality, advocating for its abolition. Lohia emphasised the need for a "new caste policy" that promoted "horizontal solidarity" among marginalised groups, including Dalits, Adivasis, minorities, women, and the working class.

It started changing during the 1967 Lok Sabha and state Assembly elections. The emerging prosperous mid-segment castes, later called other backward castes, under Chaudhurv Charan Singh, who defected from the Congress to lead the so-called first non-Congress government vocally demanded sharing of power and job reservations for the mid-segment castes. He emerged as a champion of the middle peasant communities across various castes in North India. His advocacy for the socio-economic upliftment of these communities laid the groundwork for the Mandal Commission.

Caste is taking deep roots again all over the country even in supposedly elite West Bengal or Kerala. Possibly India would do without religions but not castes. The fresh caste-based census transcends religions, like Islam or Christianity, where caste formally does not exist.

The question stalking the people is how the various castes would have the benefit of numbers in terms of job quota. The country is losing on jobs with the abandonment of public sector units, freeze in job recruitments and lack of investment in the private sector. Even army jobs are shortterm contracts like Agniveers.

The caste census could be an albatross with the ensuing Bihar elections. India faces a significant job scarcity, particularly for young graduates, with a notable skill gap hindering employment. A new report, India's Graduate Skill Index 2025 by Mercer-Mettl, reveals that only 42.6 per cent of Indian graduates are considered employable, while 57.4

If after the census the aspiring castes do not get jobs, it could lead to social tensions. The issue is not singular to the ruling party at the Centre. It engulfs all political parties. They must sit together, may consider reviving Planning Commission and create summary jobs. No alibi would satisfy the voters. Yes, days are critical for all. Would there be a solution?

#### Hiding behind brothers

Until then, its calls for "de-escalation" will remain hollow, and its credibility further eroded. Peace cannot be begged from the world; it must be earned through consistent, lawful conduct.

## **Cloud-seeding trials in Delhi** may cost ₹1.5cr each: Official

New Delhi, May 3: The Delhi Environment Department is likely to table in the next cabinet meeting a proposal to conduct cloud-seeding trials with each test estimated to cost around Rs 1.5 crore, according to a senior official.

If the proposal is approved, the government is expected to transfer the funds directly to the Indian Institute of Technology (IIT) Kanpur, which will lead the initiative. "The entire operation -- from planning to execution, including aircraft, chemicals and other logistical requirements -- will be handled by IIT Kanpur. The government will only provide funding for the trials," a senior official privy to the development told PTI.

Before tabling in the next cabinet meeting, the draft proposal will be sent to finance and legal departments, he said. He said the department is planning to conduct the first trial during peak summer at

the outskirts of the national capital. Each trial, which will involve artificial rain through cloud-seeding, is expected to cost Rs 1.5 crore. After the initial test run, scientific evaluations will be conducted.

The official said the decision to proceed with the experimental method comes after extensive studies and preparations undertaken by IIT Kanpur.

"They have already worked on the technical aspects. If the proposal gets cabinet nod, no-objection certificates (NOC) will be sought from the 13 de-

partments whose permissions are required to conduct the trial," the official said.

A total of 13 NOCs will be required from key agencies such as the Directorate General of Civil Aviation; Ministry of Defence; Ministry of Home Affairs; Ministry of Environment, Forest and Climate Change, and the Airports Authority of India.

Earlier, in an interview with PTI. Delhi Environment Minister Manjinder Singh Sirsa confirmed that the proposal is in its final stages and will be tabled at the upcoming cabinet meeting.

"Once approved, it will be shared with all relevant departments for no-objection certificates. We aim to conduct the first trial during peak summer on the outskirts of Delhi," Sirsa said.

He added that the government is actively ramping up its pollution control measures using advanced technologies such as digitisation, artificial intelligence-based monitoring, and 24x7 surveillance at pollution hotspots

"If everything goes without hurdles, we will consider cloud-seeding as a contingency option during critical pollution periods," Sirsa said. Air pollution in the national capital worsened during last winter and resulted in record air quality rankings, both in the country and globally.

Last year, according to the Central Pollution Control Board, Delhi's Air Quality Index crossed the maximum limit and reached above 450, falling into the severe-plus category.

## New housing projects in UP soon

Lucknow, May 3: New housing projects will be launched soon in 12 districts including Jhansi, Bareilly, Aligarh, Agra, Kanpur, Mathura, Lucknow, among others, the UP government said Saturday.

Chief Minister Yogi Adityanath was apprised of this during a high-level meeting with the Housing and Urban Planning Department here Saturday. "The CM was informed that under the Mukhyamantri Urban Expansion/New City Promotion Scheme, the approved projects will be launched in phases between June and December 2025," an official statement said.

Cities covered under the scheme are Jhansi, Bareilly, Aligarh, Saharanpur, Agra (Kakua), Kanpur (New Kanpur City Plan), Mathura (Transport Nagar), Moradabad (Didauzi), Bulandshahr, Ghaziabad. Meerut, and Lucknow

The CM directed the officials that all these projects must strictly adhere to timelines and maintain quality standards.

Adityanath also directed officials to review the pending building map approval cases, stressing that repeated objections are inappropriate and the process must be streamlined for



single-instance resolution. He further instructed that all such pending cases must be resolved within a deadline.

He emphasized an integrated approach to urban planning, residential safety, infrastruc ture, and digital management He also directed that the GIS

based master plans for cities which are yet to be approved. must be sanctioned before the end of the current month.

While discussing the prog ress of metro projects, the chief minister was informed that the construction of the 6.7 km underground section between Motijheel and Kanpur Centra Station under the Kanpur Met ro has been completed. Corri dor 1 and 2 of the Kanpur Metro are scheduled for completion by the end of this year.

Chandigarh, May 3: The stand-off between Punjab and intensified Saturday as an all-party meeting in Haryana asked the AAP government in the neighbouring state to unconditionally release the water from Bhakra dam and the Punjab government skipped a Bhakra Beas Management Board meeting on the issue. This came a day after an

all-party meeting in Punjab backed the state government's refusal to release more water to BJP-ruled Haryana. Union Home Secretary Govind Mohan had chaired a high-level meeting Friday in Delhi and advised to carry out the BBMB's decision to release 4,500 cusecs of extra water from Bhakra dams to Haryana for the next eight days to meet the state's urgent water requirements.

The BBMB regulates water distribution from Bhakra, Pong and Ranjit Sagar dams and de-

cides the annual quota of water supply to the three partnering states -- Punjab, Haryana and Rajasthan -- for a yearly cycle from May 21 to May 21 each year.

The Board called a meeting Saturday evening to work out the modalities for the release of extra water to Haryana but the Punjab government sought an adjournment citing an Assembly session May 5 to discuss the water row. Haryana Chief Minister Nay-

ab Singh Saini, after chairing the all-party meeting on Saturvarious parties who attended the meet. A resolution was passed at

the meeting in which an appeal was made to the Punjab government that the decisions of Bhakra Beas Management Board's (BBMB) technical committee dated April 23 and April 30 should be implemented

While vowing to protect the state's rights, Saini asserted that "our path is not of confrontation, but of cooperation" and urged the Bhagwant Mann government to "understand the pain of the neighbour". "They should immediately remove the inhuman, unconstitutional, illegal and inappropriate bar on the release of water. We resolve to ensure it and the construction of the SYL canal. We are ready to fight any legal battle,' Saini said.

"They have cut drinking water. All parties have expressed a strong reaction to this. All parties said they will work unitedly to protect state's

interests, not just as Haryana political parties, but as Indians who have deep faith in federal structure and brotherhood, said Saini and urged the people of both states to maintain

Among the leaders present in the meeting were Haryana's Water Resources and Irrigation Minister Shruti Choudhry, Agriculture Minister Shyam Singh Rana, Energy Minister Anil Vij, State BJP chief Mohan Lal Badoli, Congress's Bhupinder Singh Hooda, state Congress chief Udai Bhan, JJP's Dushyant Chautala, IN-LD's Rampal Majra and AAP's Sushil Gupta.

It seems that they are trying to avenge the people of Delhi and also trying to harass the Haryana people, he alleged.

The Bhagwant Mann government "is stopping Haryana's water in an unconstitutional manner. Mann has taken oath under the Constitution, but he is doing unconstitutional work," Saini alleged.

## in Goa temple stampede



Panaji, May 3: Six persons including two women were killed and more than 70 sustained iniuries after a stampede broke out during a temple festival at a village in North Goa district in the wee hours of Saturday, officials said.

The Goa government ordered a magisterial inquiry into the tragedy at Shirgao village, and also transferred five officials including the district collector and superintendent of police.

The stampede occurred at around 3 am when thousands of devotees thronged the narrow lanes leading to the temple of Goddess Sree Lairai Devi for

an annual festival, police said. The village is located 40 km away from Panaji. "At least 30,000 to 40,000 people had gathered, and some were standing on a slope. A few persons fell, causing others to tumble and fall on each other," Director General of Police Alok Kumar told PTI.

About 50 people fell on the slope, and the stampede was confined to that spot, he added. Thousands of devotees from Goa. Maharashtra and Karnataka attend the annual festival.

### Flight searched in SL for 'Pahalgam attack suspects'

Colombo, May 3: Sri Lankan police Saturday searched a flight arriving here from Chennai after being tipped off that a suspect linked to the Pahalgam terror attack could be on board. a police spokesperson said.

A statement from the national carrier SriLankan Airlines said that its flight arrived at Colombo's Bandaranaike International Airport from Chennai at 11:59 am and underwent a comprehensive security inspection upon arrival. "The search was carried out in coordination with local authorities following an alert from the Chennai Area Control Centre regarding a suspect wanted in India who was believed to be on board", the statement said.

The aircraft was thoroughly inspected and subsequently



cleared for further operations, it said, adding, however, the next scheduled service to Singapore was delayed. "No one has been arrested by the Katunayake police after the search was conducted at the airport," police spokesperson and Senior Superintendent Buddhika Manatunga told PTI.

Katunayake police station is the local police point covering the general area of the international airport. Terrorists killed 26 people, mostly tourists, in Jammu and Kashmir's Pahalgam on April 22.

Initially, Indian authorities identified five terrorists - in cluding three Pakistani nation als - behind the massacre in Pahalgam. Citing "cross-border linkages" to the horrific attack, India has promised severe punishment to those involved in the strike. ## Pak's missile test 'blatant' act of provocation: Sources

This prompted a heightened security presence in these areas with top police brass camping in Srinagar to oversee combing operations around Dachi-

gam, Nishat, and adjacent areas. These gained areas attention and security forces increased patrolling because of terrorist attack on a construction site in Gangangir, Sonamarg in

#### **CRPF** jawan dismissed for hiding Pak marriage

New Delhi, May 3: The Central Reserve Police Force has dismissed from service its jawan Munir Ahmed for "concealing" his marriage with a Pakistani woman as his action was found to be detrimental to national security, official sources said Saturday.

The jawan was last posted with the 41st battalion of paramilitary CRPF, the lead internal security force of the country. He was "dismissed from service" under the rules that do not require conducting an enquiry, official

sources told PTI. "Munir Ahmed has been dismissed from service with immediate effect for concealing his marriage to a Pakistani national and knowingly harbouring her beyond the validity of her visa. "His actions were found to be in violation of service conduct and detrimental to national security," CRPF spokesperson Deputy Inspector General (DIG) M Dhinakaran said.

Ahmed's marriage with Menal Khan came to light after India asked Pakistani nationals to leave the country as part of diplomatic measures taken in the wake of the Pahalgam terrorist attack in which 26 persons were killed.

### Congress seeks fresh elections in Manipur


New Delhi, May 3: The Congress Saturday targeted Prime Minister Narendra Modi for his silence and alleged failure to uphold "Rajdharma" in Manipur and demanded fresh elections in the strife-torn state.

The Opposition party also alleged the ground situation was far from normal despite the imposition of President's rule in Manipur.

More than 260 people have been killed, 1,500 injured and over 70,000 displaced since ethnic violence broke out between the Meteis and the Kukis May 3, 2023.

President's rule was imposed in Manipur February 13 and the assembly put under suspended animation, days after N Biren Singh resigned as chief minister. The Manipur Assembly has a tenure till 2027. Congress president Mallikarjun Kharge said Modi, by not visiting Manipur even once during this time, had failed to uphold "Rajdharma".

In a post on X, he said Manipur was observing two years of violence without the prime minister setting foot on its soil. "Just two days ago, 25 people were injured in a violent clash



in Tamenglong district. More than 260 people have died. 68,000 people displaced and thousands are still living in relief camps. Kharge noted.

The leader of Opposition in the Rajya Sabha tagged the Prime Minister in his post and asked three "pointed questions". 'Since January 2022, your last election rally in Manipur, you have made 44 foreign visits around the globe and 250 domestic visits across the nation, yet you have not spent a single second in Manipur. Why this apathy and disdain for the people of Manipur? Where is the political accountability?" the Congress chief asked. He questioned why the double-engine government failed in its constitutional duty to provide security and safety for its citizens.

#### S'pore goes to polls

Singapore: A total of 2,758,846 registered heading into polling booths for the 19 General Election 2025 (GE2025) to elect the next government which is set to face strong global headwinds caused by trade tariffs announced by the United States, the biggest trading partner of the Southeast Asian city-state. Voting began at 8 am Saturday at 1,240 stations set up island-wide, with polling polling booths set to be be closed at 8 pm and results expected late at night. Prime Minister Lawrence Wong, completing nearly a year in office, is seeking a fresh mandate for the ruling People's Action Party (PAP), which has governed the citystate since independence and steered its development into a global financial hub

#### Min quits over fraud

Sao Paulo: Brazil's social security minister resigned Friday amid a police probe into a hillion-dollar fraud scheme involving pension payments by the National Social Security Institute. President Luiz Inácio Lula da Silva's administration said in a statement he accepted Carlos Lupi's resignation Friday during a meeting in the president's office. The nresident invited former lawmaker Wolney Queiroz, the current Social Security executive secretary, to take over as minister. On April 23, police said they were investigating a scheme that diverted over 6 billion reais (\$1.05 billion) from pensions paid by the National Social Security Institute, Police said they seized 1 billion reais (\$175.8 million) in assets and also issued arrest warrants for six people.

# Historic win for Albanese

Australia's Prime Minister Anthony Albanese wins second 3-year term, riding anti-Trump wave

Sydney, May 3: Australia's Anthony Albanese claimed a historic second term as prime minister Saturday in a dramatic comeback against once-resurgent conservatives that was powered by voters' concerns about the influence of US President Donald Trump.

Peter Dutton, leader of the conservative Liberal party, conceded defeat and the loss of his own seat - echoing the fate of Canada's conservatives and their leader whose election losses days earlier were also attributed to a Trump backlash. Supporters at Labor's elec-

tion party in Sydney cheered and hugged each other as Albanese claimed victory and said his party would form a majority government.

Albanese would be the first Australian prime minister to



win a consecutive term in two decades. He said Australians had voted for fairness and "the strength to show courage in adversity and kindness to those in need

The Australian Electoral Commission website projected Labor would win 81 of 150 seats in the House of Representatives, increasing its majority in parliament, with 68% of the

Dutton - whose Liberals had been leading in opinion polls as recently as February until he became dogged with comparisons to Trump - said he had phoned Albanese to congratulate him.

"We didn't do well enough during this campaign. That much is obvious tonight, and I accept full responsibility for that," Dutton said in a televised speech.

a reputation for being tough on crime and immigration said he had spoken to Labor's candidate in the seat of Dickson he had held for two decades, and congratulated her on her success.

'We have been defined by our opponents in this election which is not the true story of who we are" Dutton said, promising the party would rebuild.

#### TRUMP COMPARISONS

Cost-of-living pressures and concerns about Trump's volatile policies had been among the top issues on voters' minds, opinion polls showed.

"If you sling enough mud it will stick," said Liberal Senator for the Northern Territory Jacinta Price, whose comments that her party would "make Australia great again" had fuelled comparisons to Trump's own "Make America Great Again" slogan.

Earlier, as counting got under way, Labor Treasurer Jim Chalmers said the government had been "in all sorts of trouble" at the end of 2024 but got back into the contest because of Albanese's strong campaign performance, policies that addressed concerns about the cost of living, and the Trump effect.

As the results started emerging, he told ABC the projected victory was "a win for the ages". Albanese "has pulled off one of the great political victories since federation," he said.

The results were "absolutely unbelievable", Labor supporter Melinda Adderley, 54, said through her tears at the election party.

#### **US reports 216 child** deaths this flu season, most in 15 years

New York, May 3: More US children have died this flu season than at any time since the swine flu pandemic 15 years ago, according to a federal report released Friday.

The 216 pediatric deaths reported by the Centers for Disease Control and Prevention eclipse the 207 reported last year. It's the most since the 2009 2010 H1N1 global flu pandemic It's a startlingly high num-

ber, given that the flu season is still going on. The final pediatric death tally for the 2023-2024 flu season wasn't counted unti autumn. "This number that we have now is almost certainly an undercount, and one that when the season is declared over, and they compile all the data — it's almost certain to go up," said Dr Sean O'Leary, of the American Academy of Pe-

There are likely several contributors to this season's severity, but a big one is that fewer children are getting flu shots. added O'Leary, a University of Colorado pediatric infectious diseases specialist.

The flu vaccination rate for US children has plummeted from about 64 per cent five years ago to 49 per cent this season.

### SK's conservatives pick hardline Moon-soo as Prez candidate

Seoul, May 3: South Korea's conservative People Power Party Saturday picked former labour minister Kim Moon-soo as its candidate for the June 3 presidential election, which was called after the removal of Yoon Suk Yeol over his failed attempt to impose martial law.

Kim will face liberal Democratic Party candidate Lee Jae-myung, who has led each

of the declared conservative candidates by large double-digit margins in polls.

Kim, 73, who was a labour activist in his university days but later turned hardline conservative, served as labour minister under Yoon and has pledged to implement business-friendly policies if elected. He laid out a sweeping con-

servative vision for the country in his acceptance speech, yowing to take a hard line against North Korea and implement incentives for businesses and for innovation and science.

He also pledged to strengthen policies to support young workers and the underprivileged, recounting his experience as a labour and democracy activist while in university for which he was jailed and expelled from school. "I have never abandoned the weakest among us in the lowest of plac-

### Prince Harry seeks family reconciliation



London: Prince Harry said that he wants to reconcile with his family after losing a court battle Friday over his publicly funded security that he said led his father, King Charles III, to stop talking to him. "I would love reconciliation with my family. There's no point in continuing to fight anymore," Harry told the BBC. "I don't know how much longer my father has." But Harry took aim at Buckingham Palace officials after the court of appeal rejected a bid to restore his police protection detail that was stripped by a government committee when he stepped away from his royal duties and moved to the US. The Duke of Sussex said that he was devastated to lose the case that was a source of friction with his 76-year-old father, who is being treated for an undisclosed cancer. Harry has met with him once briefly since his diagnosis early last year. "He won't speak to me because of this security

stuff," Harry said in the interview that aired three hours after the ruling. Harry, who is estranged from his family since departing the UK and writing a tell-all memoir with embarrassing details about the House of Windsor, said Friday's court verdict meant it would be impossible to safely bring his family back to the UK.

### **PAHALGAM ATTACK**

### Pakistan test-fires Abdali missile amid strained relations with India

Islamabad, May 3: Pakistan Saturday conducted a successful training launch of the Abdali weapon system – a surface-to-surface missile with a range of 450 kms - amid heightened tensions with India following the Pahalgam terror attack.

The launch was aimed at ensuring the operational readiness of troops and validating key technical parameters, including the missile's advanced navigation system and enhanced manoeuvrability features," Inter-Services Public Relations (ISPR), the media wing of the army, said in a statement. The army said the missile

launch was part of "Exercise INDUS" but gave no details about it.

Pakistan's missile test-firing comes about 10 days after terrorists killed 26 people, mostly tourists, in Jammu and Kashmir's Pahalgam April 22.

Initially, Indian authorities identified five terrorists - including three Pakistani nationals — behind the massacre in Pahalgam. Citing "cross-border linkages" to the horrific attack, India has promised severe punishment to those involved in the strike and took a raft of punitive measures.



Saturday's training launch was witnessed by the Commander Army Strategic Forces Command, senior officials from the Strategic Plans DiviCommand, as well as scientists and engineers from Pakistan's strategic organisations.

President Asif Ali Zardari, Prime Minister Shehbaz Shar if and services chiefs extended their congratulations to the participating troops, scientists, and engineers.

They expressed complete confidence in the operational preparedness and technical proficiency of Pakistan's Stra tegic Forces to ensure credible minimum deterrence and safeguard national security against any aggression.

#### Pak defence minister warns India it would strike any structure built on Indus River

Pakistan's Defence Minister Khawaja Asif has warned India that it would strike any structure that is built on the Indus River in "violation of the Indus Waters Treaty", which was suspended following the Pahalgam terror attack. Ties between the two neighbouring countries plummeted following the April 22 Pahalgam terror attack that killed 26 people, mostly tourists, India, among other punitive actions, announced the suspension of the 1960 accord, which governs water sharing between the two countries. Speaking on a Geo News programme Friday, the defence minister said, "Certainly, if they attempt to build any kind of structure, we will strike it." Asif said that building any structure on the Indus River would be seen as "Indian aggression" against Pakistan. "Aggression is not just about firing cannons or bullets: it has many faces. One of those faces is [blocking or diverting water], which could lead to deaths due to hunger and thirst," he added. The defence minister said, "If they make any architectural attempt, then Pakistan will destroy that structure, "But for now, we are heading to forums available to us, starting from the IWT [Indus Waters Treaty]. We will pursue this matter."

#### SBI profit declines as margins fall

Mumbai: State Bank of India Saturday reported an 8.34 per cent decline in its consolidated net profit to ₹19,600 crore for the January-March quarter compared to ₹21.384 crore a year ago, impacted by a decline in net interest margins. On a standalone basis, the net profit of the country's largest lender declined to ₹18,642 crore in the March guarter from ₹20,698 crore in the year-ago period. The core net interest income of the bank increased 2.69 per cent to ₹42.775 crore despite a loan growth of over 12 per cent due to a lower net interest margin. NIM declined by 32 basis points year-on-year to 3.15

#### Indian Bank profit soars 32%

New Delhi: State-owned Indian Bank Saturday reported a 32 per cent jump in net profit to ₹2,956 crore for the March quarter of 2024-25, helped by a decline in bad loans and a rise in core income. The Chennaibased lender had earned a net profit of ₹2,247 crore in the year-ago period. During the quarter, the bank's total income increased to ₹18,599 crore from ₹16,887 crore a year ago, Indian Bank said in a regulatory filing. Interest income grew to ₹15,856 crore from ₹14,624 crore in the fourth quarter of the previous financial year. Net Interest Income (NII) in the quarter also improved to ₹6,389 crore from ₹6,015 crore in the same period a year ago.

#### Kotak Mahindra Bank standalone profit falls

New Delhi: Private sector lender Kotak Mahindra Bank Saturday reported a 14 per cent fall in standalone profit to ₹3,552 crore for the January-March quarter of 2024-25 compared to ₹4,133 crore in the last quarter of 2023-24. The bank's total income increased to ₹16,712 crore in the quarter from ₹15,285 crore in the same period a year ago, Kotak Mahindra Bank said in a regulatory filing. During the quarter the bank earned interest income of ₹13,530 crore as against ₹12,307 crore in the same period a year ago. Net Interest Income (NII) rose to ₹7,284 crore, from ₹6,909 crore in Q4FY24, registering a

modest increase of 5 per cent.

## Mobile, electronics makers to self-declare Repairability Index

New Delhi, May 3: The government Saturday said that the committee constituted for the Framework on Repairability Index (RI) in mobile and electronic sector has submitted its report, to help consumers who witness issues while seeking repair for their devices

The panel has submitted its report to Nidhi Khare, Secretary, Department of Consumer Affairs. The committee's recommendations have been framed in alignment with the best global practices without causing any impediment to the industry with regard to innovation and ease of doing business.

The original equipment manufacturers (OEMs) are required to self-declare the Repairability Index based on a standard scoring criteria provided in the framework with no additional compliance burden, said Ministry of Consumer Affairs.

Further, the committee recommended that the Repairability Index should be displayed at the point of sale/purchase, E-commerce platforms and in form of QR code on packaged products to enable consumer to make informed choices.

In September 2024, the Department of Consumer Affairs constituted a committee under the chairmanship of Bharat Khera, Additional Secretary for developing the framework of the Repairability Index (RI).

Repairability Index aims



to create an ecosystem where consumers choose options that align with the ethos of 'mindful utilisation' of their products over 'wasteful consumption'.

By empowering consumers with ease and hassle-free repair options, the Department said it is reaffirming its commitment to a self-reliant, sustainable, and consumer-friendly econ-

An analysis of grievances received at National Consumer Helpline (NCH) indicates that there has been significant rise in complaints in mobiles and tablets product category from 19,057 in 2022-2023 followed by 21.020 in 2023-2024 and further to 22,864 in 2024-2025, which also highlighted a pressing need to improve repair accessibility and ensure greater transparency of repair and post-sale service-related information to

### RBI seeks lifting of cap on vostro account investments

New Delhi, May 3: India's central bank has sought the government's approval to remove the cap on foreign banks with so-called vostro accounts buying short-term sovereign debt, to boost rupee-denominated investment and trade, according to two sources and a letter seen by Reuters.

Vostro accounts are typi cally held by a domestic bank on behalf of a foreign bank in which trading partners can hold rupee-denominated balances emerging from trade transactions.

The Reserve Bank of India (RBI), in 2022, allowed overseas banks to open Special Rupee Vostro Accounts (SRVAs) to settle trade transactions in the rupee as part of its efforts to boost the currency's 'internationalisation'.

The holders of such accounts can invest in Indian government debt without registering as foreign portfolio investors (FPIs), as overseas investors have to. However, the government slapped a limit of using only 30% of account balances to buy securities with residual maturity under one year, including treasury bills.

"The restriction was intended to encourage long-term capital flows and ensure financial stability. (But) the 30% limit is a major roadblock for entities looking to use SRVAs. especially for managing shortterm liquidity," said one of the sources familiar with the matter.

Based on the feedback from



vostro account holders, this cap should be removed, the RBI recommended to the federal finance ministry in a letter last month.

Although this limit serves as a prudential measure for FPI investments, it is a significant obstacle for SRVA holders as their investments are typically short-term in nature and meant to be used or repatriated quickly, the RBI said. The final decision rests with

the ministry. The second source said a tar-

geted relaxation could incentivise broader participation in the SRVA framework and help advance India's goal of 'internationalisation' of the rupee. The central bank and the

finance ministry did not respond to an email from Reuters seeking comment. The two sources declined to be identified as the discussions are private. The RBI has approved 123 correspondent banks from 30 trading partner countries to open 156 SRVAs with 26 Indian banks to promote bilateral trade in local currencies, a junior trade minister told Parliament earlier this year.

### India-UK investment treaty lets companies sue govt

London, May 3: An investment treaty between Britain and India will contain a provision that allows companies to sue either government if they believe policy changes unfairly harm their investment or profits, two sources familiar with discussions told Reuters.

The Investor-State Dispute Settlement (ISDS) mechanism is aimed at protecting companies against possible unfair treatment under local laws, and will be included in an investment treaty that is expected to be struck alongside a free trade agreement shortly.

The mechanism has been criticised in recent years, including by Britain's previous Conservative government, for blocking efforts to fight climate change because fossil fuel producers can use it to protect their assets.

Britain has not included ISDS in any of the bilateral free trade deals it has struck since it left the European Union, though it is a feature of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) it has signed up to. India has also moved to limit ISDS in its treaties.

One of the sources said London had pushed for its inclusion in a deal with India as British businesses wanted reassurance that they would be treated fairly under the Indian

The Indian government declined to give an immediate response to a question about the current talks.

A spokesperson for Britain's trade ministry declined to comment on the matter but said any deal needed guarantees for businesses that they would be treated fairly. The two sources said govern-

ment officials on Tuesday told a meeting of businesses interested in the deal that ISDS was included.

Britain has never lost an ISDS claim by a company but according to UN data, of 30 ISDS cases brought against India since 2003, 8 were brought by UK-based companies under a previous agreement.

"We are determined to improve access for UK businesses, ensure their fair treatment, cut tariffs, and make trade cheaper and easier," the UK trade ministry spokesperson said.

Britain's left-of-centre Labour Party won power last year, and has been keen to stress that it is now the party of business as it restarts various trade negotiations.

Britain and India have been locked in trade talks, on and off, since January 2022, and are expected to strike a full trade deal soon. The Indian Commerce Minister Piyush Goyal was in London earlier this week for late-stage talks, and returned Friday for further discussions.

Mumbai, May 3: Even as India's creator economy is rapidly transforming the digital landscape, it has the potential to unlock \$100-125 billion in direct ecosystem revenue in the next five years, according to a report released Saturday.

The report by the Boston Consulting Group (BCG), launched at the mega 'WAVES 2025' event here, showed that creators in the country today influence more than \$350 billion in consumer spending annually. The number is expected to triple to over \$1 trillion by

At the same time, the creator ecosystem's direct revenues are projected to expand to \$100-125 billion in 2030 from the current \$20-25 billion.

"India's creator economy has the potential to significantly influence consumer spending, with creator-led spending set to account for 25-30 per cent of India's total consumer spend by 2030," said Vipin Gupta, Managing Director and Partner, BCG.

What began as a Gen Z and metro-focused phenomenon is now resonating across age groups and smaller cities, unlocking new avenues of influ-

ence and engagement. Categories like fashion, beauty, and

entertainment are leading the charge, while emerging monetisation models -- such as live commerce and virtual gifting are redefining how creators and brands drive value together," he added.

Further, the report showed that short-form video dominates content consumption with comedy, movies, daily soaps, and fashion being the top genres.

It called on brands to adapt faster content creation, greater creative freedom, enable diversified targeting, always on outcome testing, and build specialised teams essential to

win with creators. Monetisation avenues are diversifying with new consumer funded revenue streams gaining ground e.g. virtual gifting, live commerce and subscrip-Creator marketing is increas-

ingly becoming a cornerstone of brands' marketing strate gy, with budgets towards creator-led marketing expected to increase 1.5 to 3 times over the next 2-3 years.

"To fully leverage this po tential, brands must trust creator-led outcomes, streamline decision-making, embrace agile content strategies, and invest in long-term creator partnerships," Gupta said.

# FC Goa crowned champions RCB beat CSK in thriller

THE GAURS RIDE BORJA'S BRACE TO WIN SECOND KALINGA SUPER CUP TITLE WITH 3-0 WIN OVER JAMSHEDPUR FC

Bhubaneswar, May 3: FC Goa Saturday became the first team to win the Super Cup title twice with a 3-0 win over Jamshedpur FC in the final here as they also booked a slot for the preliminary round in the AFC Champions League Two.

Borja Herrera (23rd and 51st minute) scored a brace while Dejan Drazic struck the other goal in the 72nd minute to complete a dominant win for the Goan club, which has India head coach Manolo Marquez at the helm of affairs.

FC Goa had earlier won the Super Cup title in 2019, and they will return to continental football after four years.

Their only appearance in Asia came in the 2021 AFC Champions League group stage. The victory marked FC Goa's first trophy under Manolo, whose chapter at the club came to a perfect end.

The match was billed as a battle between FC Goa's attacking firepower and Jamshedpur's unbreached defence, yet by full-time, it was clear which team had stamped its authority.

Jamshedpur, known for their compact shape and counter-attacking style, who had also not conceded a single goal until the final, simply couldn't cope with FC Goa's expansive play.

While Jamshedpur did show some early promise with Javier Hernandez forcing a sharp save from Hrithik Tiwari in the third minute, the momentum quickly swung in FC Goa's

With Aakash Sangwan and

Dejan Drazic tearing down the wings and Carl McHugh and Borja pulling the strings in midfield, FC Goa dominated both possession and territory.

The opening goal arrived in the 23rd minute. Sangwan made a blistering run down the left and unleashed a powerful drive that Albino Gomes could only parry. Borja was first to the rebound, his first shot was blocked, but he coolly slotted the second into the roof of the net.

Jamshedpur's best chance came late in the first half when Lazar Cirkovic's header rattled the crossbar, but their lack of attacking thrust was evident throughout.

FC Goa doubled their lead in the 51st minute in a moment of brilliance. Borja, picking the ball up near midfield, surged

forward and unleashed a ferocious 25-yard strike that arrowed into the top corner, leaving Gomes helpless.

Khalid Jamil's men from Jamshedpur tried to claw their way back with Jordan Murray setting up Javier Siverio, but the forward blasted over from close range.

The third and final goal came in the 71st minute and showcased FC Goa's poise and precision. McHugh dissected the defence with a perfectly weighted through ball, and Drazic latched on, rounded the keeper, and tapped home into an empty net.

The rains came towards the end of the match, and the mood turned celebratory as FC Goa players danced to cap off a fine performance and embrace their moment in history.

Mhatre had an astute partner in veteran Ravindra Jadeja (77 not out off 45 balls), as they together milked 114 runs for the third wicket.



### Long distance runners Hemraj, Anjali handed 4, 6-year bans

New Delhi, May 3: Long distance runners Hemraj Gurjar and Anjali Kumari have been banned for four and six years respectively by the NADA's Anti-Doping Disciplinary Panel after they failed done tests last year.

The 25-year-old Gujar, who had won a 5000m bronze in the 2023 National Inter-State Championships and gold in the National Cross Country Championships in 2023 and 2024, has been banned for four years beginning from April 20, the date of the decision.

Gujar had also represented the country in the World Athletics Cross Country Championships last year.

Last year, Gujar was handed provisional suspension by the National Anti-Doping Agency (NADA) after finding prohibited substance Darbepoetin (DEPO) in his dope sample.

Anjali's six-year ban period begins from March 31, according to the latest update on the



NADA website, which does not give further details.

She had also represented the country in the World Athletics Cross Country Championships last year.
