

PAK ARMY VIOLATES CEASEFIRE

New Delhi/Washington, May 10: India and Pakistan Saturday reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect after four days of intense cross-border drone and missile strikes that brought the two countries teetering on the edge of full scale war.

Barely hours after this development first announced by US President Donald Trump who claimed that the two countries have agreed to a "full and immediate" ceasefire after US mediation, Jammu and Kashmir was shaken by a series of drone sightings in the night followed by explosions, prompting security personnel to engage air defence systems to bring them down.

Top government sources, however, clearly said that the bilateral understanding was the result of a direct engagement between the Indian and Pakistani sides and that Islamabad agreed to it with "no pre conditions, no post conditions and no links to other issues.'

India late in the night accused Pakistan of breaching the understanding.

At a media briefing, Foreign Secretary Vikram Misri called upon Pakistan to take appropriate steps to address these violations and deal with the situation with "seriousness and responsibility'

"For the last few hours, there have been repeated violations of the understanding arrived at earlier this evening between the Directors General of Military Operations of India and Pakistan," he said.

"This is a breach of the understanding arrived at earlier today." "The armed forces are giving an adequate and appropriate response to these violations and we take very very serious note of these violations," Misri said.

The decision that India and Pakistan reached an understanding was first made public by President Trump in a surprise announcement in a post on Truth Social.

"After a long night of talks mediated by the United States, I am pleased to announce that India and Pakistan have agreed to a FULL AND IMMEDIATE CEASEFIRE," he said.

Thank you for your attention to this matter!" Trump added.

In a short announcement after Trump's remarks, Foreign Secretary Misri said the directors general of military operations of India and Pakistan agreed on the understanding during a call this afternoon.

"The Director General of Military Operations of Pakistan called the Director General of Military Operations of India at 1535 hours IST earlier today," Misri told the media at around 6pm. "It was agreed between them that both sides would stop all firing and military action on land and in the air and sea with

effect from 1700 hours Indian Standard Time today," he said. The foreign secretary said instructions have been given on both sides to give effect to

the understanding and that the DGMOs of the two sides will talk again May 12 at 1200 hours. The understanding by India and Pakistan on stopping military actions came hours after

The operation was launched in a strong retaliation to Pahalgam terror attack April 22 in which 26 people, mostly tourists, were killed.

The India-Pakistan decision came following diplomatic overdrive by the Group of Seven (G7) and several countries including the US, China and Saudi Arabia, urging both sides to deescalate the conflict.

OMAR QUESTIONS CEASEFIRE

Srinagar: As a series of blasts rocked the city after sundown, Chief Minister Omar Abdullah questioned the "ceasefire" announcement. Blasts could be heard after an interval of 15 minutes as the flares lit up the night sky in the city. A drone was detected flying over Baramulla town in north Kashmir around 8.20pm, the officials said. They said the drone was destroyed by the anti-drone system. WAR IS NOT INDIA'S CHOICE, **DOVAL TELLS CHINESE FM YI**

n a high-level diplomatic exchange, National Security Advisor (NSA) Ajit Doval Saturday held a telephonic conversation with Chinese Foreign Minister Wang Yi and reaffirmed that "war was not India's choice" and emphasised India's commitment to ceasefire and restoring peace with Pakistan. The talks between India and China were held following the deadly terrorist attack in Jammu and Kashmir's Pahalgam that claimed the ives of several Indian personnel. During the call, Doval reportedly conveyed that the recent terrorist attack in Pahalgam resulted in serious casualties and necessitated counter-terrorism actions by India. The conversation, disclosed by China's Ministry of Foreign Affairs, focused on regional stability and the imperative of maintaining peace amid escalating India-Pakistan tensions.

J&K govt official, 3 security officers among 8 killed in Pak shelling

Jammu, May 10: A senior Jammu and Kashmir government official and three security officers were among eight killed while more than 25 people were injured amid intense mortar shelling and drone strikes by Pakistan in the Jammu region Saturday, officials said. The casualties were reported hours before India and Paki stan agreed to end hostilities which soared after the Indi an Armed Forces hit terror launchpads in Pakistan and Pakistan-occupied Kashmir (PoK) earlier this week in response to the Pahalgam attack. Chief Minister Omar Abdullah visited the affected residential localities and announced Rs 10 lakh ex-gratia for the next of kin of each person killed in the cross-border shelling while police issued helpline numbers and asked people to stay away from debris of fallen UAVs. Additional District Develop ment Commissioner (Rajouri) Raj Kumar Thapa and his two staff members were seriously injured when an artillery shell hit his official residence in Ra jouri town, the officials said They were rushed to the Gov ernment Medical College where Thapa succumbed, they said. The others include Subedar Major Pawan Kumar, sub-inspector Mohammed Imtevaz of the BSF, two-year-old Aisha Noor Mohd Shohib, Rashida Bi and Zakir Hussain. Meanwhile, a sol dier identified as Surendra Singh Moga, a native of Rajasthan, was killed when he was hit by a frag ment of a Pakistani drone, which was successfully intercepted by the Army Air Defence at an air base in Jammu and Kashmir's Udhampur district Saturday officials said. 

'Legal system must evolve to govern AI tech responsibly'

New Delhi, May 10: Supreme Court judge Manmohan Saturday said the country's legal system must evolve to responsibly govern recent technologies, such as artificial intelligence (AI), and that cybersecurity was the foundation of a digital economy.

The SC judge was speaking at the 'International Legal Conference 2025' on the theme 'India's Legal and Regulatory Framework: Navigating International Trade Opportunities' organised by the Services Export Promotion Council (SEPC), Society of Indian Law Firms (SILF) and Indian National Association of Legal Professionals (INALP).

Speaking about AI, data privacy and cybersecurity, Justice Manmohan said that AI could compose music, design products, or write books, but the ownership of these creations was a serious intellectual property question with no easy answers. 'Someone once compared AI

to a brilliant but unpredictable teenager, full of potential, but still learning the rules. Our legal system must evolve to govern such technologies responsibly," he said.

"Data privacy, too, is critical. In an age where data is the new oil, the Supreme Court has rightly affirmed privacy as a fundamental right and the Digital Personal Data Protection Act is a landmark effort toward establishing a rightsbased data regime," he added.

He said that cybersecurity was the foundation of any digital economy and that a secure digital environment was non-negotiable for global trade and investment.

"Our laws must impose strong penalties and, just as importantly, promote a culture of cyber resilience. Internation-

al cooperation is essential, as cyber threats rarely respect borders.

"As a member of the judiciary, I reaffirm our commitment to upholding the rule of law, which is the bedrock of a fair and thriving market economy. For trade and investment to flourish, businesses need certainty, predictability, and an efficient legal system. Our courts are evolving to meet these needs," Justice Manmohan said.

He said that in an increasingly borderless world where technology was evolving at an unprecedented pace and intellectual property disputes were rapidly increasing, the mechanisms for resolving international disputes needed a 'significant overhaul'.

"Let me illustrate this point by referring to something as ubiquitous as the mobile phone each of us carries. Every phone today contains about 3,000 to 4,000 patents. These phones use standardised technology so they can work seamlessly across India, China, the US, anywhere. This brings us to the concept of Standard Essential Patents (SEPs)," the SC judge said.

"I realised that an infringe

ment suit involving such patents could be filed in any jurisdiction. The dispute between a patent holder and a manufacturer is global by nature. So, should royalties be adjudicated country-by-country? Or should there be a uniform global rate? These are complex questions that underscore how much the concept of ease of doing business is under strain," he said. Justice Manmohan also said

that the country was a global leader in the FinTech revolution and its Unified Payments Interface (UPI) has been widely recognised for its scale and efficiency.

"Beyond payments, FinTech is revolutionising insurance, wealth management, and financial inclusion. But rapid innovation brings new regulatory challenges. Legal frameworks must enable innovation while protecting consumers, ensuring data privacy, maintaining financial stability, and curbing illicit activity. It's a delicate balance that regulators and the legal community must strike,' he said. He said that the country was standing at a defining moment, having vast opportu-

nities to grow its international trade footprint. "Yes, challenges exist, from shifting geopolitics to fast-evolving technologies, but

I remain deeply optimistic. At times, international law may feel like that storm (in a sea). But with a sturdy vessel, our constitutional values, a skilled crew, all of you here, and a compass called the rule of law, we will find our way," Justice Manmohan said.

SILF president Lalit Bhasin also spoke at the event. The conference also applaud-

ed the Indian armed forces and offered homage to those who lost their lives in the recent terror attack in Pahalgam.

On the run since 2019, man held for sexual assault

Bhubaneswar, May 10: A 36-year-old man, who was on the run after sexually assaulting one of his female colleagues at a hotel in Patia area of the City in 2019, has been arrested by the Mahila police, an official said Saturday.

The accused – Debabrata Mishra – has been taken into custody from Niali area of Cuttack district Saturday, Mahila police inspector incharge (IIC) Bhagyashree



Swain told the media.

About the case details, the Mahila IIC said Mishra, a native of Kendrapara district, and the woman came closer while

working in a private firm in the Capital City in 2018.

The duo had a visit to Puri October 10, 2018 when Mishra expressed his desires to marry her. The woman, however, declined it and started avoiding Mishra since then," Swain said. The duo later was in talking

terms after Mishra apologised her for his act, the IIC said. "It was March 19, 2019 when Mishra invited the lady to a ho-

tel in Patia area where he sexually assaulted her and later fled the scene." Swain said, adding

that since then he was on the run fearing arrest.

Soon, the victim approached the police which registered a case under Sections 376 (2), 294 354 (a) and 506 of the IPC and launched a manhunt.

New Delhi, May 10: The southwest monsoon is likely to reach Kerala May 27, earlier than the usual date of June 1, the India Meteorological Department (IMD) said Saturday.

If the monsoon arrives in Kerala as expected, it will be the earliest onset over the Indian mainland since 2009, when it began May 23, according to IMD data.

The arrival of the main rain-bearing system over the Indian mainland is officially declared when it reaches Kerala, usually around June 1.

The monsoon typically covers the entire country by July 8. It starts withdrawing from northwest India around September 17 and completes by October 15.

The monsoon had set in over the southern state May 30 last year; June 8 in 2023; May 29 in 2022: June 3 in 2021; June 1 in 2020; June 8 in 2019; and May 29 in 2018.

An IMD official said there is no direct relationship between the onset date and the total rainfall over the country during the season.

"The monsoon arriving early or late in Kerala does not mean it will cover other parts of the country accordingly. It is characterised by large-scale variability and global, regional and local features," the official said. The IMD had, in April, forecast above-normal cumulative rainfall in the 2025 monsoon season, ruling out the possibil ity of El Niño conditions, which are associated with below-nor mal rainfall in the Indian subcontinent.

"India is likely to see above-normal rainfall in the four-month monsoon season (June to September), with cumulative rainfall estimated at 105 per cent (with a model error of 5 per cent) of the long-period average of 87 cm," M Ravichan dran, secretary in the Ministry of Earth Sciences, had said.

According to the IMD, rain fall between 96 per cent and 104 per cent of the 50-year average of 87 cm is considered 'normal'

Rainfall less than 90 per cent of the long-period average is considered 'deficient'; between 90 per cent and 95 per cent is 'below normal'; between 105 per cent and 110 per cent is 'above normal'; and more than 110 per cent is considered 'excess' pre cipitation.

The monsoon is crucial for India's agriculture sector. which supports the livelihood of about 42.3 per cent of the population and contributes 18.2 per cent to the country's GDP It is also vital for replenishing reservoirs critical for drinking water and power generation across the country.

Illegal shrimp farms threaten agri, Bhitarkanika biodiversity

Spanning over 20,000 acres, unauthorised prawn gheries have become a growing environmental and legal concern in Kendrapara district, threatening Bhitarkanika National Park's biodiversity and fuelling land disputes with local farmers

Kendrapara. May 10: Illegal shrimp enclosures, spreading across more than 20.000 acres. in this district have emerged as a major threat to the local agriculture and the biodiversity of Bhitarkanika National Park, apart from creating law and order issues.

entering through canals into these shrimp enclosures has raised concerns among local farmers.

Earlier, the Orissa High Court had taken suo motu cognisance of the matter and ordered the demolition of unauthorised farms. Advocate Mohit Agarwal was appointed amicus curiae to monitor the situation. However, administrative inac-

Reports said saline water

tion has delayed the implementation of the court order.

Social worker Jvotiranian Patri said the district administration initially took limited action, but legal hurdles ensued as three separate counter petitions were filed by shrimp enclosure owners asserting that their operations were lawful.

In the first case, nine petitioners argued that they were farming shrimp on their own land for livelihood purposes without causing environmental damage. In the second petition, 17 applicants claimed that they were using modern techniques in line with current aquaculture practices. Likewise, the third petition, involving 17 farmers, stated that their operations complied with all the

legal requirements. With the legal status of many enclosures under question, the administration has been tasked with verifying which are legal and which are not.

Social activist Biren Kumar Das said shrimp enclosures pose a dual threat - endangering Bhitarkanika's biodiversity and salinising nearby farmland. This has led to frequent conflicts between local farmers and enclosure owners.

Law and order issues have been reported in Mahakalapada, Rajnagar and Rajkanika blocks. In Rajnagar's Kurunti pancha-

yat, a shooting incident occurred in connection with shrimp farming disputes. In Petchela revenue village of Mahakalapada tehsil, villagers clashed with enclosure owners over 39 acres of forest and pasture land converted for shrimp farming. Rajkanika has seen disputes over saltwater inflow through canals built for shrimp farms. **Environmentalist Hemanta**

Kumar Rout said wastewater and air pollution from the enclosures are harming the local ecosystem. He cited Jagatjora in Bhitarkanika as a clear example where toxic wastewater from shrimp farms is damaging marine life and nearby mangrove forests.

Rout attributed the presence of these farms to non-listing of Bhitarkanika as a UNESCO World Heritage Site. A UNES-CO team had visited the park in 2016 and raised concerns about the shrimp enclosures. The team urged the district administration to immediately remove enclosures built on forest land.

However, shrimp farm owner Satvendra Das countered that the district lacks effective employment schemes. He noted that many migrant workers returned home jobless after the Covid-19 pandemic and turned to shrimp farming, which has received support from both the Union and state governments.

Das argued that since the farming is conducted under Coastal Aquaculture Authority Act, the administration should identify appropriate zones to support livelihoods in the coastal belt.

Additional District Magistrate Rabindra Mallik confirmed that demolition work is under way in line with the court's order. He said some owners have approached the court, and investigations are ongoing to determine the legality of their farms. Local officials have been directed to remove illegal enclosures.

Kali Mandir premises in Jharsuguda NHRC for ATR on poor living condition in Bagapatia colony

Kendrapara, May 10: The National Human Rights Commission (NHRC) has sought an Action Taken Report (ATR) from the district administration here over the alarming lack of basic amenities at Bagapatia resettlement colony in Rajnagar block.

plaint filed by human rights advocate Radhakanta Tripathy who raised concerns over the 'deplorable' living conditions faced by families relocated from the coastal village of Satabhaya, which has been steadily eroded by the sea over the past several decades.

The NHRC held a hearing May 5. Acknowledging the gravity of the situation, the rights body directed the district authorities to submit an ATR within four weeks.

According to Tripathy, the phased relocation of displaced Satabhaya residents began in 2008. By 2020, a total of 571

families had been shifted to Bagapatia. However, despite the passage of years, the relocated population continues to suffer from an acute lack of basic infrastructure and services.

He alleged that roads in the area become impassable to use with even moderate rainfall, there is no reliable source of drinking water, educational facilities are either absent or inadequate, and health services remain large ly inaccessible. Moreover, the surrounding environment is reportedly neglected, com-

pounding the challenges faced by the resettled families.

Tripathy's petition urged the NHRC to take urgent steps to address what he described as 'prolonged administrative apathy' and to ensure that the displaced people are provided with the minimum standards required for a dignified life.

It is believed that the NHRC's intervention will help address the long-pending issues in Bagapatia and provide some relief to the families who have waited years for stable and humane living conditions.

Cracker godown blast: Three women under treatment succumb

Mom's kidney gives boy a second life Acting on a tip-off, a special

Berhampur, May 10: A mother's love is often described as boundless, and for a family in Berhampur, it has become the reason for a boy's survival.

On the Mother's Day, today, the story of S Sarada of Jaydurga Nagar, near Engineering School Road in the Silk City, is one of extraordinary sacrifice. She donated her kidney

to her 17-year-old son, S Sai Biswanath, giving him a second chance at life after he was diagnosed with severe

kidney failure. Biswanath, whose father S Sai Gopal is a local businessman, showed no signs of illness in early childhood. However. after turning 15, his health began to decline. He lost his appetite, ate less, and suffered from frequent fevers. He also experienced mental stress during

Concerned by their son's deteriorating condition, his parents sought treatment at a private hospital in the City. After a diagnostic evaluation, doctors November 22, 2023 revealed that 95 per cent of Sai's kidneys were damaged. This news left both parents devastated.

Doctors advised the family to consider a kidney transplant and referred them to a private hospital in Visakhapatnam. There, they were told to seek out a suitable do-

nor. Without hes-**MOTHER'S** itation, Sarada offered one of her kidnevs to save her son's life.

Her selfless act is a poignant reminder of the strength and unconditional love mothers embody, making the impossible possible for their children. Due to the family's financial struggles, Gopal initially volunteered to donate a kidney to save his son. However, doctors

prioritised the mother, Sarada. and conducted a thorough health and kidney evaluation. "As my health was suitable, I



agreed to donate one of my kidneys to my son," Sarada said.

Doval Doctrine

ndia's Defence Planning Committee was set up on 19 April 2018. It was chaired by national security advisor Ajit Doval and included the foreign secretary, defence secretary, chief of defence staff, the three service chiefs and secretaries of the Ministry of Finance.

It set itself the enormous tasks of looking after 'national defence and security priorities, foreign policy imperatives, operational directives and associated requirements, relevant strategic and security-related doctrines, defence acquisition and infrastructure development plans, national security strategy, strategic defence review and doctrines, international defence engagement strategy', and so on. It met once, on 3 May 2018, and does not appear to have met after that.

In the absence of a national security doctrine India has presumably relied upon what is informally referred to as the Doval Doctrine. This doctrine may not be out yet in print but it is available on video. In February 2014, a few weeks before he was appointed national security advisor, Doval spoke at the Sastra University in Thanjavur. During his speech, he made the following points:

Terrorism was a strategic threat to India because it was an international phenomenon; because Pakistan fed and promoted it; and because India has a large Muslim population.

However, terrorism could not be fought because it was an idea, a word. Only terrorists could be fought (or 'degraded' in capacity), because only a tangible enemy could be defeated, not a word

India thus had to name its threat, in this case, Pakistan. Having identified the enemy, Doval asked the question, 'How do you tackle Pakistan?' and then proceeded to explain.

The problem of India's national security strategy was Pakistan's ability for sub-conventional warfare (cross-border terrorism and militancy) and India's inability to escalate militarily in response because of the nuclear threat.

Doval said: 'I talked about their having the nuclear threshold, having the strategic weapons systems, missiles, strategic partnership with China. How do we tackle this?'

It was simple. He said: 'You know we engage an enemy in three modes. One is a defence mode. Chowkidars and chaprasis. That if somebody comes here we will prevent him (from entering). One is defensive-offence. To defend ourselves we will go to the place from where the offence is coming. (The) third is the offensive mode where you go outright. Nuclear threshold is a difficulty in the offensive mode, but not in the defensive-offence.

At the moment, he said, meaning under Manmohan Singh's government, 'we work only in the defensive mode'. What he was recommending was that

India attack Pakistan in various wavs

short of conventional war. In his words: '... working on the vulnerability of Pakistan. It can be economy, internal security, it can be political. International isolation. I am not going into details. But ... you change the engagement from defensive mode.

He implied that there was no option but to do this since the offensive mode was closed because there was no control of escalation leading up to the nuclear threshold. Similarly, for him, the defensive mode was useless.

'You throw hundred stones on me, I stop ninety but ten still hurt me. I can never win. Either I lose or there is a stalemate. You start war at your time, throw the stone with what you want, you talk when you want, you have peace when you want. 'If you have defensive-offence we will see where the balance of the equilibrium is. Pakistan's vulnerability is many, many times higher than that of India. Once they know that India has shifted its gear from defensive to defensive-offence they will find that it is unaffordable for them. You can do one Mumbai, you may lose Balochistan. There is no nuclear war involved. There is no engagement of troops. If you know the tricks we know the tricks better than you.'

magine having a super-smart assistant that can gather information, write drafts, generate videos, clone voices, et al. Incredible possibilities that artificial intelligence (AI) offers in the media. Yes, it's transforming journalism by handling routine tasks, analysing vast data sets, and enhancing content delivery. And like any powerful tool, AI comes with its own set of ethical and legal dilemmas.

The power and peril of AI has sparked a heated discussion in the media, often referred to as the Fourth Estate--wielding influence, shaping public opinion and a watchdog of democracy. Will it help safeguard or play mischief? At the same time, AI's rapid development has sparked fears among journalists whether they would

become obsolete! AI won't replace journalists-it will replace journalists who don't use AI. Good journalism relies on human traits that AI lacks: empathy, curiosity, and the ability to ask hard questions in real time. AI won't meet informants, uncover hidden documents, or attend a press conference and challenge a prime minister. When disaster strikes, it's human journalists who head to the scene to speak with witnesses and capture the raw, emotional truth.

While AI offers substantial benefits, it also poses serious threats to privacy, identity, and intellectual property. There's a need to strike a balance between embracing innovation and safeguarding citizens' rights. AI use should never infringe on reputation, privacy, or image rights. It's not just about creating regulations-education, awareness, and continuous research are vital to establishing ethical boundaries

In early March in China's 'Two sessions', most significant political meetings many



To shape the future responsibly, journalists must learn how AI works, understand both its risks and rewards, and continuously update the frameworks-legal, ethical, and professional

lawmakers and experts called for deeper research and clearer AI legislation. Globally, this conversation is intensifying, particularly around copyright issues and fair use of journalistic content

In the US, The New York Times has filed a lawsuit against OpenAI over alleged copyright infringement, and similar concerns are growing in South Korea. The Korean Newspaper Association (KNA) initially determined that Naver, dominant web portal and search engine, often referred to as "Google of Korea" had incorporated news content from media outlets into its AI services without proper authorisation. It plans to file formal complaints against both domestic and international tech companies, including Google and OpenAI, for using news content in AI training without proper authorization.

The KNA argues this unauthorized use violates copyright laws and constitutes an abuse of market dominance under the Monopoly Regulation and Fair Trade Act. Without clear legal frameworks, the unchecked use of news content by AI could severely impact journalism's sustainability by eroding its economic foundations and remain a persistent challenge. In Poland, in July 2024 there was a nationwide media protest wherein hundreds of editorial offices participated calling for changes to the copyright law. They called for a mechanism to negotiate payment for content used by global tech companies and that it shouldn't remain a legal fiction but become a real tool. Eventually a compromise was reached, albeit unsatisfactory. Negotiations are ongoing between publishers and Google, and if an agreement isn't reached, the state administration would need to step in.

Besides, in Poland, where the political and media landscape is polarised, the ethical use of AI becomes particularly important. But this problem affects practically every country especially the global geopolitical situation-- the war in Ukraine, the tense situation on the Korean Peninsula, or the massive changes in US politics. AI algorithms, which are based on data patterns and user behaviour, can deepen media fragmentation, leading to creation of information bubbles, which will only further intensify existing political divides

The EU was the first to adopt a comprehensive AI Act, followed by South Korea. These regulations include provisions to label AI-generated content

He continued: 'Our only difficulty has been we have been in the defensive mode. If we had been in defensive-offence mode we could have reduced the casualties we have suffered.'

This was the Doval Doctrine. It posited India's strategic threat as terrorism from Pakistan, and its response was to do unto the enemy what was being done to you.

It is unclear whether this unwritten doctrine was adopted by the government, but Doval's decade as NSA means that it must have had a strong influence.

In 2020 India was faced with a challenge on the other front. In assessing this situation former general Prakash Menon noted that, for several decades, India's political guidance to the military had been oriented towards Pakistan as the immediate threat. But now that the Chinese threat was at the doorstep, this would have to change. The political objectives expected to be achieved by the military resided in a document called the 'Raksha Mantri's Directive' (which dealt with how much ammunition and spares the armed forces must keep in stock in anticipation of conflict) drawn up under the UPA. That directive, Gen Menon said, 'continues to lack parentage for the lack of a coherent National Security Strategy. The Defence Planning Committee, headed by the NSA, was assigned this task two years ago. Nothing has emerged so far.' That was in 2020.

After Pahalgam the situation has again shifted to the western front. It has now been five years since the clash with China and seven years since the Defence Planning Committee was formed. Perhaps recent events will encourage the government to put in place a national security doctrine on the basis of which we can proceed to act when we are attacked whether conventionally or through acts of terrorism.

What happened to American Catholics, who were once regarded as a relatively liberal Christian community? In 1960, nearly 80% of Catholics voted for John F. Kennedv not just because he would be the first Catholic president of the United States, but also because they liked his politics. Some evangelical Protestants, on the other hand, regarded him as the Antichrist. In 2020, only 49% of Catholics voted for Joe Biden, a far more devout Catholic than JFK was.

Of course, there is no such thing as a "Catholic vote," any more than there is a "Jewish vote." Any religion's adherents tend to divide into conservative and liberal camps. But there has been a remarkable shift toward more radical right-wing politics among many American Catholics.

This trend is partly a response to a decades-long decline in organized religion in the US.

class. The Democrats used to rely on the votes of less-educated white Christians, especially in the southern states. Despite being culturally conservative, they supported socially progressive economic policies that were in their interests.

Then came the 1960s, with Vatican II, sex, drugs, and - perhaps most importantly – civil rights for Black Americans. Again, these divisions are not absolute. There are still progressive American Catholics, including prominent cardinals and bishops. The Christian counter-revolution is partly driven by theology. Catholics care deeply about abortion because of their belief that human life begins at conception. Evangelicals used to care less about this. Equally important, evangelicals and Catholic conservatives have increasingly found common ground in the culture wars that have raged since Nixon's 1969 appeal to the silent ma-

The connections made be tween different causes in the culture wars are not always logical, but that does not make them less powerful. In 2020, Trump – who is far from a devout Christian - claimed that Biden was 'against God' and 'against guns.' To an ultra-conservative culture warrior, the connection is clear: we love guns, so God must, too. That such warriors now include many Catholics is, well, deplorable.

Cong seeks all-party meet chaired by PM

New Delhi, May 10: The Congress Saturday demanded an all-party meeting chaired by Prime Minister Narendra Modi to brief political parties on recent developments, while invoking the legacy of former Prime Minister Indira Gandhi's leadership during the 1971 war. The party also called for a special session of Parliament to discuss the past 18 days, including the Pahalgam terror attack and the recent ceasefire agreement, which they claimed was announced via a tweet by US President Donald Trump.

Congress general secretary communications in-charge Jairam Ramesh stated on X that in light of "unprecedented announcements" from Washington DC, the prime minister must take all political parties into confidence. He emphasized the need for Parliament to debate the developments and reaffirm national unity.

Highlighting India's current diplomatic posture, the Congress questioned the role of the United States in brokering the ceasefire, with Ramesh referencing a historic letter from Indira Gandhi to then-US President Richard Nixon. In the 1971 letter. Gand-

hi rejected foreign interference, asserting that India would not accept orders from distant powers. "She ensured there was no 'neutral site'—which has now been agreed to," Ramesh added, drawing a contrast with the present situation.

Congress general secretary (organisation) KC Venugopal also quoted Gandhi's firm words to Nixon: "Being a developing country, we have our backbone straight, enough will and resources to fight all atrocities." He added, "India terribly misses Indira Gandhi ji today.' Congress media head Pawan Khera shared photos of Gandhi

with the armed forces, echoing the sentiment: "India misses Indira." Speaking to reporters, Khera criticized the Modi government for a lack of transparency and repeated calls for a special parliamentary session to assess the impact of recent events and honor victims of the

Pahalgam attack.

Congress MP Shashi Tharoor welcomed peace but stressed the need for more clarity. "India never wanted a long-term war but wanted to teach terrorists a lesson. I believe that lesson has been taught," he said. Senior leader Manish Tew-

ari, sharing a statement by US Secretary of State Marco Rubio, noted the ceasefire's linkage with future talks at a neutral venue. suggesting this constituted third-party mediation. "Call it what you want-this is third-party mediation," he asserted.

Across its social media platforms, the Congress party and its state units paid tribute to Indira Gandhi, celebrating her courage, conviction, and "Remember the strength. name-Indira Gandhi," posted the Kerala Congress unit. Spokesperson Shama Mohamed recalled, "Under her leadership, Pakistan was split into two despite a US threat. The nation truly misses her decisive leadership today.'

The Congress' collective messaging underscored a contrast between past assertiveness and present ambiguity, calling for greater transparency and unity in the face of external and internal challenges

STUBBLE BURNING Punjab, Haryana, UP asked to set up 'Parali **Protection Force'**

New Delhi, May 10: The Commission for Air Quality Management (CAQM) has directed Punjab, Haryana and Uttar Pradesh to set up a "parali protection force" at district and block levels to prevent incidents of stubble burning.

In an order issued on Friday, the CAQM, which formulates air pollution control strategies for Delhi-NCR and the adjoining areas, asked authorities to map all farms in villages in these states to determine the most suitable methods for managing paddy stubble.

These methods include crop diversification, in-situ manage ment and its use as fodder.

Stubble burning in these states is among the main reasons for air pollution in Delhi-NCR region. The CAQM asked the states to constitute a "dedicated 'Parali Protection Force' at the district/ block level"

This force will include police officers, agricultural officers, and other officials who will monitor and prevent the burning of paddy straw. There will also be intensified patrolling, particularly during late evening hours when farmers may attempt to evade satellite monitoring.

Farmers found burning stubble will face penalties, with "Red Entries" in farm records and imposition of environmental compensation, it said. A dedicated nodal officer should be assigned to groups of 50 farmers in each district for effective monitoring and assistance, the CAQM said

Completed in three and a half years, the BrahMos production unit in Lucknow stands on 80 hectares of land provided free of cost by the Uttar Pradesh government.

The UP Defence Industrial Corridor, announced by Prime Minister Narendra Modi in 2018. has six nodes — Lucknow. Kanpur, Aligarh, Agra, Jhansi, and Chitrakoot — where major investments are being made to boost defence manufacturing, according to the statement.

Uttar Pradesh is the second state after Tamil Nadu to establish a Defence Industrial Corridor, it added.

Pune, May 10: Scientists at the Defence Research and Development Organisation (DRDO) are working on a humanoid robot that can be part of frontline military mission, an official said Saturday.

The Research and Devel-

opment Establishment (En-

gineers), a key lab under the

ments, the official said.

Talking to PTI, SE Talole, group director at the Centre for Systems and Technologies for Advanced Robotics within the R&DE (Engineers), said the team has been engaged in the project for four years.

"We've developed separate prototypes for the upper and lower body and have successfully achieved certain functions during internal trials," he said, adding that the humanoid will be able to function on tough terrains like jungles.

The robot was recently showcased at the National Workshop on Advanced Legged Robotics



DRDO scientists develop humanoid robot for military missions

held in Pune.

Currently in its advanced development phase, the team is focusing on refining the robot's ability to understand and execute operator commands.

The system relies on three key components: actuators that generate movement like human muscles, sensors that collect real-time data from the surroundings, and control systems that interpret this information to

Talole said, "One of the biggest challenges is ensuring the robot can carry out desired tasks smoothly, which requires mastering balance, rapid data processing, and ground-level execution.

Researchers are concentrat-

ing on these aspects as they move towards completing the project by 2027, said Kiran Akella, a scientist leading the design team.

DRDO officials said legged robots, both bipedal and quadrupedal, offer immense potential in defence and security and sectors like healthcare, domestic assistance, space exploration, and manufacturing.

However, creating autonomous, efficient-legged robots comes with significant technological hurdles, they said.

Scientists explained that the humanoid's upper body would feature lightweight arms with a spherical revolute joint configuration, offering 24 degrees of freedom — 7 in each arm, 4 in the gripper, and 2 in the head.

The robot will be able to perform complex autonomous tasks with closed-loop gripping and manipulate objects

by turning, pushing, pulling, sliding doors, opening valves and overcoming obstacles, especially in high-risk environments, they said.

Both arms will work collaboratively to safely handle hazardous materials such as mines, explosives, and liquids

The system will operate seamlessly day or night, indoors or outdoors, and incorporate proprioceptive and exteroceptive sensors, data fusion capabilities, tactical sensing, and audio-visual perception.

The humanoid biped will include features such as fall and push recovery, real-time map generation, autonomous navigation, and path planning through simultaneous locali sation and mapping (SLAM) enabling it to carry out com plex autonomous operations in challenging, high-risk environments.

Arms revenue increases were seen in all regions, with particularly sharp rises among companies based in Russia and the Middle East. Overall, smaller producers were more efficient at responding to new demand linked to the wars in Gaza and Ukraine, growing tensions in East Asia and rearmament programmes elsewhere.

US companies' arms revenues rise, but production challenges remain

The 41 companies in the top 100 based in the United States recorded arms revenues of \$317 billion, half the total arms revenues of the Top 100 and 2.5 per cent more than in 2022. Since 2018, the top five companies in the top 100 have all been based in the USA.

Of the 41 US companies, 30 increased their arms revenues in 2023. Howev



er, Lockheed Martin and RTX, the world's two largest arms producers, were among those registering a drop.

"Larger companies like Lockheed Martin and RTX manufacturing a wide range of arms products often depend on complex, multi-tiered supply chains, which made them vulnerable to lingering supply chain challenges in 2023," said Dr Nan Tian, Director of SIPRI's Military Expenditure and Arms Production Programme. "This was particularly the case in the aeronautics and missile sectors."

European arms industry trails rest of world in revenue growth

The combined arms revenues of the 27 Top 100 companies based in Europe (excluding Russia) totalled \$133 billion in 2023. This was only 0.2 per cent more than in 2022, the smallest increase in any world region.

However, behind the low growth figure the picture is more nuanced. European arms companies producing complex weapon systems were mostly working on older contracts during 2023 and their revenues for the year con-



sequently do not reflect the influx of orders

"Complex weapon systems have longer lead times," said Lorenzo Scarazzato, "Companies that produce them are thus inherently slower in reacting to changes in demand. That explains why their arms revenues were relatively low in 2023, despite a surge in new orders."

At the same time, a number of other European producers saw their arms revenues grow substantially, driven by demand linked to the war

in Ukraine, particularly for ammunition, artillery and air defence and land systems. Notably, companies in Germany, Sweden, Ukraine, Poland, Norway and Czechia were able to tap into this demand. For instance, Germany's Rheinmetall increased production capacity of 155-mm ammunition and its revenues were boosted by deliveries of its Leopard tanks and new orders, including through war-related 'ring-exchange' programmes (under which countries supply military goods to Ukraine and

Middle East arms producers see revenue growth linked to Gaza, Ukraine conflicts

Six of the top 100 arms companies were based in the Middle East. Their combined arms revenues grew by 18 per cent to \$19.6 billion. With the outbreak of war in Gaza, the arms revenues of the three companies based in Israel in the top 100 reached \$13.6 billion. This was the highest figure ever recorded by Israeli companies in the SIPRI top 100.

The three companies based in Türkiye saw their arms revenues grow by 24 per cent to \$6.0 billion, benefiting from exports prompted by the war in Ukraine and from the Turkish government's continued push towards self-reliance in arms production.

"The biggest Middle Eastern arms producers in the Top 100 saw their arms revenues reach unprecedented heights in 2023 and the growth looks set to continue," said Dr Diego Lopes da Silva, Senior Researcher with the SIPRI Military Expenditure and Arms Production Programme. "In particular, as well as taking in record arms revenues in 2023, Israeli arms producers are booking many more orders as the war in Gaza rages on and spreads."

In 2023, many arms producers ramped up their production in response to surging demand. The total arms revenues of the top 100 bounced back after a dip in 2022. Almost three quarters of companies increased their arms revenues year-on-year. Notably, most of the companies that

IMF UNDER FIRE FOR \$1BN LOAN TO PAK

he International Monetary Fund (IMF) is facing sharp criticism for approving a \$1 billion disbursement to Pakistan just days after a deadly terrorist attack in Kashmir's Pahalgam and amid escalating hostilities between India and Pakistan.

The disbursement, approved Friday under the Extended Fund Facility (EFF), raises total payouts under the programme to \$2.1 billion. Additionally, the IMF cleared \$1.4 billion under the Resilience and Sustainability Facility (RSF), ostensibly aimed at helping Pakistan tackle

climate-related vulnerabilities. But the timing of the announcement has provoked a fierce backlash, not just from Indian officials and strategic experts, but also from voices in the region and beyond who say the move could undermine efforts at de-escalation.

India abstained from voting at the IMF Executive Board meeting, reflecting its opposition within the limitations of IMF protocol. Unlike the United Nations, where countries can cast a 'no' vote. IMF board members can only vote in favour or abstain — there is no mechanism for a formal rejection. It is pertinent to note that, the voting is based on economic size, and as the largest financial contributor to the IMF, the US receives the largest share of voting power amongst all participating countries at 16.49 percent of the total fund.

the vote, the Finance Ministry said the Fund's processes "lacked moral safeguards," warning that fungible inflows from multilateral institutions like the IMF could be diverted to fund military or terrorist activities.

The ministry further stated that these concerns were "shared by several member countries," suggesting broader discomfort within the global community.

Indian diplomats and foreign policy voices argue that the loan approval sends the wrong

signal at a critical mo ment. Former foreign secretary Kanwal Sibal called the de cision "terrible op tics," adding that the IMF's governance is skewed in favour of Western powers and lacks accountability. Yashwant

Deshmukh, a well-known psephologist, went further, saying the IMF "has blood on its hands.

Similarly, Sushant Sareen of the Observer Research Foundation said the fund was "emboldening" Pakistan's military establishment, rather than curbing its influence or encouraging reform.

India has long argued that IMF support to Pakistan is routinely misused. Over the past 35 years, Pakistan has entered 28 IMF programmes, including four in just the last five years, with little to show by way of structural reform or lasting economic stability. Jammu & Kashmir Chief Minister Omar Abdullah also questioned the global community's logic, asking how de-escalation can be expected when the IMF is "essentially reimbursing Pakistan" for attacks on Indian cities

Global military expenditure touches new peaks

n 2024, global military expenditure reached a record \$2.443 trillion, a significant increase from the previous year. This surge was driven by increased spending in Europe and the Middle East, with countries like the United States, France, and the UK leading in defense spending.

The United States remained the largest arms exporter, while Ukraine emerged as the largest importer. largely due to the conflict in Ukraine. Here's a more detailed breakdown:

Global Military Expenditure:

The Stockholm International Peace Research Institute (SIPRI) reported that global military spending in 2024 reached \$2.443 trillion, the highest ever recorded by SIPRI. This was a significant increase from the previous year and the steepest year-on-year rise since 2009.

Leading Exporters:

The United States was the largest exporter of major arms between 2020 and 2024, accounting for 43% of global exports. France and Russia followed, with 9.6% and 7.8% of global exports, respectively.

was the second-largest arms importer during the same period.

Regional Trends:

ers, with India also experiencing a shift in its arms supply relations towards Western suppliers

He was serving in the 25 Punjab Regiment and was set to retire August 31. 2025 with his last official posting in Ambala. However, he had voluntarily opted for a posting on the border, they said.

Kumar is survived by his parents, wife, son and a daughter. His father, Garaj Singh is a retired Havildar of the Indian Army. New Delhi: The government decided Saturday that India will treat any future act of terror on its soil as an "act of war" and respond accordingly, top official sources said in a warning to Pakistan that came ahead of the announcement of an understanding between the two countries to end the military action which started after the terrorist attack in Pahalgam.

With this decision, the government headed by Prime Minister Narendra Modi has sought to draw a red line against terror incidents and makes clear that it will follow a similar military response as it has after the Pahalgam incident if terrorists linked to Pakistan target India again.

The government's decision formalises India's firm response to any future act of terror.



A top government source said, "Any future act of terror in India will be considered an act of war against the country and will be responded to accordingly.

An "act of war" under international law refers to a country's hostile action against another, giving the aggrieved nation a legitimate ground to target the aggressor. Soon after the assertion,

India announced that the directors general of military operations (DGMO) of India and Pakistan have agreed to stop all firings and military action on land air and sea with effect from 5 pm Saturday.

The DGMO of Pakistan called the DGMO of India at 3.35 pm earlier this afternoon, Foreign Secretary Vikram Misri said

The brief announcement by the foreign secretary came shortly after US President Donald Trump said India and Pakistan have agreed to a "full and immediate" ceasefire after talks mediated by the US.

Modi has chaired a number of high-level meetings, including with the security establishment, since the hostilities broke out between the two countries.

India has blamed Pakistan-based terror groups for a series of violent incidents targeting soldiers and civilians inside its territory for a long period of time, with the April 22 killing of 26 civilians at Kashmir's famous tourist site only the latest in such acts.

The Modi government, since coming to power in 2014, has drastically amped up its response to terror incidents linked to Pakistan, with the armed forces, in their most expansive strike against terrorist organisations, targeting nine terror sites in the neighbouring country and Pak-occupied Kashmir on May 7 under Operation Sindoor.

Pakistan has since then attempted to attack a number of military installations and civilian population along India's northern and western borders. India has said it has responded hefittingly

Every Pakistani misadventure will invite decisive response: Indian military

New Delhi: Every misadventure and future escalation by Pakistan will be responded to with strength and decisive action, Indian military said Saturday. The remarks came shortly after the two neighbours reached an understanding to stop military actions. "While we will be adhering to the understanding reached today, we remain fully prepared to defend India's sovereignty," Commodore Raghu Nair said. We remain fully operationally ready to launch whatever operations may be required in defence of the nation, he said at a media briefing. 



Ukraine, allies push for 30-day truce

Kyiv, May 10: Ukraine and its allies are ready for a "full, unconditional ceasefire" with Russia for at least 30 days starting Monday, Ukrainian Foreign Minister Andrii Sybiha said Saturday.

His remarks came as the leaders of four major European countries visited Kyiv to push for Moscow to agree to a truce and launch peace talks on ending the nearly three-year war. They followed what Sybi-

ha said was a "constructive" phone call between them, US President Donald Trump and his Ukrainian counterpart, Volodymyr Zelenskyy.

Saturday also marked the last day of a unilateral threeday ceasefire declared by Russia that Ukraine says the Kremlin's forces have repeatedly violated.

In March, the United States proposed an immediate, limited 30-day truce, which Ukraine accepted, but the Kremlin has held out for terms more to its liking.

The leaders of France, Germany, Poland and the United Kingdom arrived together at the train station in Kyiv, and met Zelenskyy shortly after to join a ceremony at Kyiv's Independence Square marking the 80th anniversary of the end of World War II. They lit candles at a makeshift flag memorial for fallen Ukrainian soldiers and civilians slain since Russia's invasion.

The visit marked the first time the leaders of the four countries had travelled together to Ukraine, with Friedrich

At least 20 people killed in Sudan after drone strike hits prison

Cairo, May 10: A suspected drone strike launched by Sudan's paramilitary Rapid Support Forces hit a prison in the southern region of Kordofan Saturday and killed at least 20 inmates, authorities said.

Fifty other detainees were wounded in the attack on the main prison in Obeid, the capital city of North Kordofan, Information Minister Khalid Aleiser said in a statement.

Aleiser, who is also the spokesman of the military-allied government, accused the Rapid Support Forces for the attack, which came as the militia escalates drone strikes on the military-held areas across the country.

Sudan plunged into civil war April 15, 2023, when simmering tensions between the military and the RSF exploded into open warfare in the capital Khartoum and other parts of the country. Obeid is 363 kilometres south of Khartoum.

There was no immediate comment from the RSF, which earlier this month launched multi-day drone attack on Port Sudan, the Red Sea city serving as an interim seat for the Sudanese government. The strikes hit the city's airports, maritime port and other facilities including fuel storages.

The military earlier struck Nyala airport in South Darfur, where the RSF receives foreign military assistance, including drones. Local media say dozens of RSF officers were killed in last week's strike.



B'desh bans deposed PM Hasina's Awami League

Dhaka/New Delhi, May 10: Bangladesh's interim government led by Muhammad Yunus Saturday evening banned deposed prime minister Sheikh Hasina's Awami League under

an anti-terrorism law. The announcement to ban Hasina's Awami League came after the student-led newly-floated National Citizen Party (NCP) activists rallied since Thursday and carried out blockades across Dhaka demanding the ban.

"The official gazette notification will be issued in this regard on the next working day," Yunus's office said, describing it as a "statement of the Council of Advisers" or the Cabinet.

The statement said the Council decided that the ban would remain effective until the completion of the "trial of the Awami League and its leaders in Bangladesh's International Crimes Tribunal in the interest of protecting the country's security and sovereignty".

It said the decision was also taken for the security of the leaders and activists of the July 2024 uprising that eventually led to the ousting of the Awami League regime alongside the complainants and witnesses of the trial in the International Crimes Tribunal (ICT). The meeting chaired by Yunus simultaneously amended the ICT law allowing the tribunal to try any political party, its front organisations and affiliated bodies.

Hasina's 16-year-long Awami League regime was toppled on August 5 last year in a student-led violent mass uprising prompting the 77-year-old former prime minister to flee to India.

Three days after her ouster Yunus took charge as the chief adviser of the interim govern ment. Hasina and many of her party leaders have been facing 100s of cases, including that of mass murder and corruption, since then. Most of her party leaders and ministers in her government are either arrested or fled abroad. A large part of Students against Discrimination (SAD), which led the last year's movement that ousted Hasina. crystalised as the National Citi zen Party (NCP) earlier this year

Formed in 1949, the Awami League led the movement for the autonomy of Bengalis in the then East Pakistan for decades and eventually led the Liberation War in 1971.

The announcement to ban Awami League came as Bangladesh Saturday witnessed an escalating tension as NCP supporters marched towards Yunus's official residence to mount pressure for the ban.

Pope Leo XIV outlines papal vision, cites AI as key challenge

Vatican City, May 10: Pope Leo XIV laid out the vision of his papacy Saturday, identifying artificial intelligence as one of the most critical matters facing humanity and vowing to continue in some of the core priorities of Pope Francis.

In his first formal audience, Leo repeatedly cited Francis and the Argentine pope's own 2013 mission statement, making clear a commitment to making the Catholic Church more inclusive, attentive to the faithful and a church that looks out for the "least and rejected."

Leo, the first American pope,

told the cardinals who elected him that he was fully committed to the reforms of the Second Vatican Council, the 1960s meetings that modernised the church. He identified AI as one of the main issues facing humanity, saying it poses challenges to defending human dignity, justice and labour.

In another hint to his priorities, the Vatican revealed that Leo, a member of the Augustinian religious order, would retain the motto and coat of arms that he had as bishop of Chiclayo, Peru. The motto, "In Illo uno unum," was pronounced by St Augustine in a sermon to explain that "although we



Christians are many, in the one Christ we are one."

Identifying with Pope Francis

Leo referred to AI in explaining the choice of his name: His namesake, Pope Leo XIII, was pope from 1878 to 1903 and laid the foundation for modern Catholic social thought.

He did so most famously with his 1891 encyclical Rerum Novarum, which addressed workers' rights and

capitalism at the dawn of the industrial age. The late pope criticised both laissez-faire capitalism and state-centric socialism, giving shape to a distinctly Catholic vein of economic teaching.

In his remarks Saturday, Leo said he identified with his predecessor, who addressed the great social question of the day posed by the industrial revolution in the encyclical.

"In our own day, the church offers everyone the treasury of its social teaching in response to another industrial revolution and to developments in the field of artificial intelligence that pose new challenges for the defence of human dignity, justice and labour," he said.

Toward the end of his pontificate, Francis became increasingly vocal about the threats to humanity posed by AI and called for an international treaty to regulate it.

He warned that such powerful technology risks turning human relations into mere algorithms. Francis brought his message to the Group of Seven industrialised nations when he addressed their summit last year, insisting AI must remain human-centric so that decisions about when to use weapons or even less-lethal tools always remain made by humans and not machines.

The late Argentine pope also used his 2024 annual peace message to call for an international treaty to ensure AI is developed and used ethically, arguing that a technology lacking human values of compassion, mercy, morality and forgiveness is too perilous to develop unchecked.

Donald Trump imposes 'minimum' 10% tariff

Baseline tariff announcement has changed perspective of global market, tax uncertainty is around

New Delhi, May 10: US President Donald Trump has reaffirmed his administration's minimum 10 per cent baseline tariff on US imports, but raised the possibility of an exception as South Korea and other countries are striving to avoid or minimise the impact of new US levies.

Trump made the remarks as he responded to a question over whether the baseline tariff will continue to be in effect even if countries offer zero tariffs on US exports in pursuit of reciprocity.

"You are going to always have a baseline. I mean, there could be an exception at some point. We'll see if somebody does something exceptional for us. It is always possible, but basically, you have a baseline of a minimum of 10 percent and some of them will be much



higher 40 percent, 50 percent and 60 percent as they have been doing to us over the years," Trump said

He pointed out that there will be four or five more trade deals coming immediately, but he did not specify which countries will reach those deals with US

The baseline tariff went into effect on April 5, while Trump paused higher country-specific reciprocal tariffs, including 25 percent duties on South Korea, until July 8 to allow for negotiations over tariff- and non-tariff barriers and other related issues


India must ensure balanced, fair terms in trade deal with US: GTRI

New Delhi, May 10: India should take cues from the US-UK trade pact and exercise caution while negotiating an agreement with US to ensure that the deal is reciprocal, balanced, and not driven solely by political considerations, the Global Trade Research Initiative (GTRI) said Saturday.

The limited trade deal announced between the US and UK on May 8 offers clues about the kind of trade arrangements Washington may pursue with other major partners, most notably India. A closer look reveals that UK has made sweeping tariff concessions to US, whereas, US offered less in return

"If the UK-US deal sets the template, India can expect growing US pressure to finalise a mini-deal of its own - focused on tariff cuts and key strategic commitments rather than a full free trade agreement (FTA) that may come much later," the



think tank said.

It also cautioned that India may be asked to reduce tariffs on a basket of sensitive agricultural products, including

soybeans, ethanol, apples, almonds, walnuts, raisins, avocados, spirits, many GM (genetically modified) products and meat and poultry.

Tariff concessions on automobiles are also expected, as India has already agreed to reduce duties on select UK vehicles from 100 per cent to 10 per

cent under its recent agreement announced May 6.

"As with the UK, the US is also expected to push India for large-scale commercial purchases. These could in-clude Oil, LNG, military and civilian aircraft from Boeing, helicopters, or even nuclear reactors," GTRI founder Ajay Srivastava said, adding that India must tread cautiously while negotiating the proposed bilateral trade agreement (BTA) with the US.

The UK has agreed to cut tariffs on over 2,500 US products ranging from olive oil to ethanol, signalling a deep market opening. In sharp contrast, the US has cut tariffs on fewer than 100 British items, and even then, most of the reductions stop at a baseline 10 per cent rather than full elimination, he said.

"India must not walk into a similar trap. Any trade deal with the US must be reciprocal and equitable, not one-sided or politically driven. India must insist on a balanced, fair, and sovereign approach to negotiations. If that balance cannot be achieved, India is better off walking away from the deal,' Srivastava said.

A team of senior officials from India is expected to again visit Washington this month to hold discussions with their US counterparts on the proposed BTA.

Shanghai, May 10: Capping a dream comeback, Madhura Dhamangaonkar clinched her maiden individual World Cup gold to headline India's glittering medal collection in the compound section -- two gold, one silver and two bronze at the Archery Stage 2 showpiece here Saturday.

Unranked for being in the sidelines for three years, Madhura produced a sensational upturn in the final, edging out USA's Carson Krahe 139-138 to seal the top podium.

The 24-year-old from Amravati, Maharashtra, had earlier bagged a team silver and a mixed team bronze, completing a fine three-medal haul. However, Madhura's individual final was a roller-coaster affair.

She opened with a perfect 30, including two Xs, but faltered with two 8s in the second end and a costly 7 in the third, trailing 81-85.

Krahe, ranked 52nd and a World Cup team bronze medallist last year, capitalised with a perfect 30 in the third end.

Undeterred, Madhura showed nerves of steel, shooting a near-flawless 29 in the fourth to level the match at 110-all. In the decisive final end, she fired two Xs and a 9, while Krahe managed only 28, sealing Madhura's dramatic one-point win. Earlier, India's medal tally

began with a gold in the men's team event, where the trio of

multiple World Cup gold med alist Abhishek Verma, Ojas Deotale, and Rishabh Yadav defeated Mexico 232-228 in a tense final.

The top-seeded Indian team started strong with a 59 to Mexico's 57, but saw the match level at 115-115 by the halfway mark.

India regained control with a 58 in the third end and sealed the victory with a brilliant 59 in the final end, as Mexico managed only 56.

The 22-year-old Yadav went on to claim his maiden individual World Cup medal, defeating South Korea's Kim Jongho 145-145 (10*-10) in a dramatic shoot off for bronze.

Having led after the first end, Yadav lost the next two but bounced back with a perfect 30 to level scores at 115-115.

Both archers shot flawless 30s in the final end, but Yadav's arrow was closer to the centre in the shoot-off. Yaday earlier lost to world No. 1 and multiple world champion Mike Schloess er of the Netherlands 144-147.

Madhura, who topped Indian qualifiers to earn the third seeding, began her individual cam paign by knocking out Turkey's world No. 13 Hazal Burun -- a double World Cup team medallist -- with a composed 143-141 win built on two flawless opening ends. In the women's team final, Madhura partnered with Jyothi Surekha Vennam and Chikitha Taniparthi to take silver after a 221-234 loss to a strong Mexican outfit.
